Dhaka: At least 32 people were drowned and many were missing Monday when a ferry carrying over 100 passengers capsized in Buriganga river after it was hit by a bigger vessel in the Bangladeshi capital here, officials said, "It appeared to be an accident caused by negligence of the drivers," an official of the Bangladesh Inland Water Transport Authority (BIWTA) told reporters. Rescuers feared several passengers were trapped inside the ferry which sank at around 9:30 am with nearly 100 passengers on board in the Buriganga river along the Shyambazar area of Old Dhaka.

Delhi, June 29: The Ministry of Electronics and Information Technology Monday banned 59 mobile apps, saving they are engaged in activities which are "prejudicial to the sovereignty and integrity of India, defence of India, security of state and public order. The list of apps included TikTok, Weibo and others. The ministry said it has received many complaints

from various sources including several reports about misuse of some mobile apps available on Android and iOS platforms for stealing and surreptitiously transmitting users' data in an unauthorized manner to servers which have locations outside India.

"The compilation of these data, its mining and profiling by elements hostile to national security and defence of India, which ultimately impinges upon the sovereignty and integrity of India, is a matter of very deep and immediate concern which requires emergency measures," the ministry further said in a statement.

ment said, it is "invoking its power under section 69A of the Information Technology Act read with the relevant provisions of the Information Technology (Procedure and Safeguards for Blocking of Access of Information by Public) Rules 2009 and in view of the emergent nature of the threats it has decided to block 59 apps since in view of information available they are engaged in activities which is prejudicial to sovereignty and integrity of India, defence of India, security of state and public order.""This decision is a targeted move to ensure safety and sovereignty of Indian cyberspace,' said the ministry. This move comes amid a face-off be-

tween India and China in Ladakh's Galwan Valley. The Indian Cyber Crime Coordination Centre, Ministry of Home Affairs, has also sent an exhaustive recommendation for blocking these malicious apps.

The ministry said it also received representations from people on "security of data and risk to privacy" regarding certain apps. "Likewise, there have been similar bipartisan concerns, flagged by various public rep-

First lot of Remdesivir, Favipiravir reaches state

Bhubaneswar, June 29: The state government Monday received the first consignment of Remdesivir and Favipiravir medicines for the treatment of COVID-19 patients.

Additional Chief Secretary, Health and Family Welfare, PK Mohapatra said Remdesivir medicine will be used only in the treatment of moderate to severely ill COVID-19 patients. "The Remdesivir medicines have been sent to all COVID hospitals in the state", he said.

The drugs will help reduce fatality rate (which is 0.39 per cent in Odisha), Mahapatra said, adding that it is a nucleoside analogue prodrug having inhibitory effects on pathogenic animal and human coronaviruses, including severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in vitro. Mohapatra

State Covid toll 23, fresh cases 245

BHUBANESWAR: The state's COVID-19 tally climbed to 6,859 Monday as 245 people, including two NDRF personnel, tested positive for the disease, while the toll rose to 23 with two more fatalities, a health official said. The latest fatalities were reported from the state's worst-hit Ganiam district. which alone accounts for 12 of the 23 deaths so far, a health department statement said. The deceased include two men aged 48 and 52, it said.

vein of the patient," he said.

Meanwhile, State Drugs Controller Mamina Patnaik said, Odisha has also received 1,200 strips (each strip containing 34 tablets) of Fabi Flu (Favipiravir) tablets to cure patients with mild to moderate coronavirus.

She explained that Remdesivir injection is meant for the moderate to severe cases, while Fabi Flu for mild to moderate patients. This apart, Patnaik said: "The state presently has a stock of two lakh tablets and two lakh injections of Dexamethasone.

Dexamethasone is used to treat conditions such as arthritis, blood/hormone/immune system disorders, allergic reactions, certain skin and eye conditions, breathing problems, certain bowel disorders, and certain cancers. It is also used as a test for an adrenal gland disorder.

Terrorists attack Pak bourse; 11 die

Karachi, June 29: Four heavily armed militants, believed to be from a banned Baloch terror group, Monday made a brazen attempt to take over the Pakistan Stock Exchange building here, killing four security guards and a police officer before being shot dead by security forces. The militants, who



Liberation Army (BLA) linked Majeed Brigade claimed responsibility for the attack. The group is banned in Pakistan, the UK and the US.

The BLA has carried out several terrorist attacks in the past, including a suicide attack in August 2018 that targeted Chinese engineers in Balochistan

General Omer Ahmed Bokhari, addressing a press conference in Karachi, said the attackers intended to not only enter the building but also carry out violence and hold people hostage. "Every terrorist was armed with weapons

that included AK-47s, hand grenades, rocket launchers. They were also carrying food and water," he said. He continued, "The PSX is an important symbol of economic activity hence the objective of these militants was to increase casualties here and hold hostages. "It was an attempt to send a message to the

world that Pakistan is not safe. They wanted to damage Pakistan's economic activity and harm investors' confidence," DG Rangers said. The police and Rangers' officials killed all the four terrorists near the entrance gates, he said.



6 Rafale jets to fly in by July 27



New Delhi, June 29: India is likely to receive by July 27 the first batch of six Rafale fighter jets which are expected to significantly boost the combat capability of the Indian Air Force, people familiar with the development said.

The IAF has been on a high alert for the last two weeks in view of escalation in tension with China following clashes between troops of the two countries in Galwan Valley in eastern Ladakh in which 20 Indian Army personnel were killed. The two armies are locked in a bitter standoff in the region for seven weeks.

On June 2, Defence Minister Rajnath Singh held a telephonic conversation with his French counterpart Florence Parly during

the Rafale jets will be delivered to India as scheduled notwithstanding the coronavirus pandemic in France. Military officials, on the

condition of anonymity, said the arrival of the Rafale jets will significantly enhance the IAF's overall combat capability and will send a clear message to India's "adversaries". When asked about the matter, the IAF did not comment. The first squadron of the aircraft will be stationed at Ambala air force station, considered one of the most strategically located bases of the IAF.

India had signed an intergovernmental agreement with France in September 2016 for procurement of 36 Rafale fighter jets at a cost of around ₹58.000 crore.

Srinagar, June 29: Senior hardline separatist leader, Syed Ali Shah Geelani Monday said he is distancing himself from the separatist platform -- the All Party

Hurriyat Conference. In a press statement the octogenarian separatist leader, Geelani said he is distancing himself completely from the All Party Hurriyat Conference.

"He has written a detailed letter to Hurriyat members in which he said, given the present situation within the Hurriyat Conference, he is completely dissociating himself from the platform", the statement said. In his detailed letter to

the members of the Hurrivat Conference, Geelani has said that henceforth he shall not be answerable in any manner about the future conduct of the constituent members of the platform. Hurriyat Conference was formed

March 9, 1993 as a united political platform of the separatist parties in Kashmir. Ten years after its formation, the Hurriyat Conference split into the

moderate group headed by Mirwaiz Umer Farooq and the hardline group headed by Syed Ali Shah Geelani. Not keeping good health, Geelani has mostly remained under house arrest in his Srinagar uptown of Hyderpora area residence for the last four years.

mation with its member states. Interpol has no requirement for making any of the notices public, though some do get published on its website. It is unlikely Interpol would grant Iran's request as its guideline for notices forbids it from "undertaking any intervention or activities of a political" nature.

The US killed Soleimani, who oversaw the Revolutionary Guard's expeditionary Quds Force. and others in the January strike near Baghdad International Airport. It came after months of incidents raising tensions between the two countries and ultimately saw Iran retaliate with a ballistic missile strike targeting American troops in Iraq.

Modern Book Depot: Despite Covid the fight is on

ifty six years ago, in 1964 when he cleared the test for the 33rd batch of the National Defence Academy (NDA). Om Prakash thought he was about to realise his adolescent passion – of becoming a Fauji and donning the camouflage. However, much to everyone's surprise, he stayed back.

"For several nights, there was an intense battle between my dream and childhood love (books). Ultimately, the latter overpowered the former," Om reasons.

While many of his Bhubaneswar's Sainik School friends rose in ranks in the Army - one of them, the veteran of many wars (1971, Kargil) retired Lieutenant General KP Dhal Samanta, passed away recently. Om pursued his studies, earned a degree certificate and LLB from the Calcutta University, before setting out on a lifelong tryst with books

Set up in 1970, his Modern Book Depot, at Bhubaneswar's Master Canteen near Railway Station Square has turned 50 this year. "It's been fascinating, I cherish each moment of the long journey," Om, 71, says.

This store offered a completely new

experience to Odisha's book connoisseurs - they could step inside the 220 sq feet area, browse through the books before picking one. Though, earlier it dealt with all types of books, from early 2000, the shop rebranded into a standalone 'non-text books' outlet.

According to Om, all books sell. But, classics, biographies, political commentaries, thrillers, fictions including the scifi ones have more takers.

However, after the pandemic, dynamics have altered. As Om says, the global health hazard has set in a sense of insecurity.

Incidentally, last month, Full Circle, the famous book store at New Delhi's classy sites hampered reading habits of the youths, the digital libraries impacted buying habits. Young readers found it convenient to read books available online.

And then, there's the mushrooming of e-commerce ventures which begun offering decent price discounts and delivering books at the door step. Result: the customer base shrank fur-

ther and footfalls at stores lessened. Mumbai's iconic Strand Book Stall, which shut shop last year, was a casualty of these

Khan Market, hit the headlines. Unable to cope with heavy losses and with an unsure

future ahead, it downed shutters, permanently. "The saddest part is that I could not deliver books to my customers who needed them the most, then (lockdown days)," rues Om. However, he promises to try his best and meet this challenge. "Hopefully, I will be able to see it through," he declares. A little streak of a fighter is still left

It's not the first time that he is confronting odds. While the surge in the use

Om's father Dewan Chand, who had a brief stint with the Colonial army, and his two brothers, set up book shops on either side of the Independence, first - in the city of the magnificent Tai Mahal - Agra. in 1946. In 1949, came the other, at the most happening address of Kolkata, across the Lighthouse cinema near New Market in Chowringhee. It was followed by the one

of smart phones and social networking let was the fourth in the chain. All the shops, though, carry the same name.

Om's memory is still fresh about the few years he spent in the Kolkata shop before moving to Bhubaneswar. A host of well-known personalities including noted filmmaker Satyajit Ray frequented the outlet, he recalls

'Those days, Lighthouse screened only English movies. During the intervals of night shows people would step out,

come to our shop, pick books and return for the remaining part of the movie. Vikram Seth had visited the store during the release of his classic: A suitable boy," Om's brother, Prem Prakash who manages the Kolkata shop, informs.

The Bhubaneswar shop has been patronised by, among others, the who's who of Odisha's intelligentsia – artists, writers, politicians and bureaucrats etc. Former Odisha Chief Ministers, Biju Patnaik, JB Patnaik, Giridhar Gamang, Jnannith Award recipient U R Ananthamurthy and celebrated cook book author, Tarla Dalal had visited this counter.

"In a book store you get to meet and interact with the best of minds. I should have kept a visitors' book, which I haven't. It's my biggest regret," Om says apologetically.

Whenever he is in Bhubaneswar, Gamang, a regular at Om's shop, quietly bags his favourite copies. "I love this shop. Most of the valuable books I get there are not available elsewhere," claims Gamang.

"The feel at home ambience is always an attraction," believes former bureaucrat, Aurobindo Behera, another loyal buyer of over four decades. Incidentally, the day the COVID lockdown was relaxed last month. Behera with his daughter Ananya. 32, in tow, visited Om. Flashing one of the two purchases, a book on poetry, 'Letters to the person I was' by Sama Abuleil, Ananya intones, "There you find a rich collection of books on a range of subjects

suiting every age group and taste.' An avid reader; Om says, his reading habit has helped him run the venture. Once he spots a customer is having a doubt, he pitches in with an advice. The reader is happy. The salesman too is equally elated as his effort has paid off


"Holding a book with hands has its own charm, one can't experience the feeling from online buying," former Odisha finance minister, Panchanan Kanungo, also known as the 'intellectual politician' believes. "Om knows my taste and suggests what all should I buy, which makes my tasks a lot easier," Kanungo adds.

However, excessive exposure to tiny letters in millions of pages, has taken a toll on Om's eye sight. Today, on the arrival of new releases, enthusiastically he flips through the pages, but can't complete one. 'But, I am not tired, yet," Om says.

However, with his daughters married and son, who is happy with his corporate job and lacks interest in carrying the family legacy forward, perhaps the last page of the fascinating tale of the Modern Book Depot and Om is being penned. As Om says, 'With me, Modern Book Depot will live. And end, as well.'

After all, everything has to end,







Modi govt profiteering from misery: Cong on fuel price hike

Bhubaneswar, June 29: With the Union government taking no steps to control the unprecedented fuel price hike, the state unit of Congress Monday staged a demonstration here and demanded immediate rollback of the hike by the Centre.

14.58L cases pending with judiciary in state

New Delhi, June 29: The pendency of cases in High Court and subordinate courts in Odisha is humongous as over 14.58 lakh civil and criminal cases have remained sub judice in the state judiciary.

According to the National Judicial Data Grid, which monitors performance of courts across the country, as many as 12,98,243 cases -10.32,279 criminal and 2.65,964 civil cases - are pending in all the districts and taluka courts in Odisha.

While 1,60,070 cases, including 69,906 writ cases, are pending in the Orissa High Court, the state iudiciary has an overall backlog of 14.58.313 cases.

Significantly, as many as 1,28,252 cases have been pending in the High Court for more than one year. In lower courts, 3,50,956 cases have been pending from 1 to 3 years while 4.606 cases are pending for more than 30 years. Similarly, 30,274 cases have been pending for more than 20 years in lower courts.

Out of the pending cases in subordinate courts, as many as 70.018 were filed by senior citizens and 76,353 by women.

The Supreme Court had June 15 asked the Orissa High Court to submit a detailed action plan for deciding on criminal appeals pending before it for a long period of time. As

If such appeals are not taken up for hearing within a reasonable time frame, the right of appeal itself would be illusory, inasmuch as incarcerated convicts (who are denied bail) would have undergone a major part- if not whole of the period of their sentence," the Supreme

The apex court had also asked the High Court to co-ordinate with the Director General, Prisons, in the state to compile data with respect

to convicts in jails, who are await ing hearing of their appeals.

'While compiling such data, a suitable questionnaire, eliciting information with respect to appeal numbers, (of such convicts); the provisions under which the prisoners have been convicted: the period(s) of sentence undergone, the age(s) and gender of the prisoner/convicts, their health conditions (which of them are suffering from serious/illnesses, shall be obtained. The state legal service authorities shall assist the DG Prisons in drawing up suitable questionnaire, which shall be compiled and compared with the pendency of appeals," the Supreme Court said.

Similarly, the number of road accidents has decreased from 2,107 in 2019 to 836 this year. The number of injuries also decreased.

NHRC demands compensation for victim of polio vaccination

Bhubaneswar, June 29: The National Human Rights Commission (NHRC) has issued a showcase notice to the chief secretary asking why monetary compensation should not be awarded to relatives of Kamalini Sahho, a 2-month-old child, who died few hours after polio vaccination at Balabhadrapur village in Nayagarh in 2014. The Commission has delivered the notice while hearing a complaint filed by one RTI activist.

As per the complaint, one infant was died while 11 other children at Balabhadrapur village in Ranpur Block of Nayagarh District were taken ill just few hours after being administered polio drops on July 2, 2014. The RTI activist moved the NHRC seeking monetary compensations for the deceased Kamalini Sahoo and other infants who suffered illness

The Commission after going through the reports of the Secretary of the Health & Family Welfare Department found that the allegations about the administration of Polio vaccine as the reason behind the death and illness of the children. It opined that state government is responsible for the negligence committed by its officers.

"Show cause why a monetary compensation of Rs.4, 00,000 will not be recommended to be paid to the NOK of deceased Kamalani Sahoo and further a monetary compensation of Rs.1, 00,000 be not recommended to be paid to each of the 11 surviving victim children," the Commission mentioned in the notice to the state Chief Secretary.

Kendu leaves rot as govt yet to issue transit permit for sale

Junagarh, June 29: The coronavirus-induced lockdown in the state has heaped lots of miseries on people coming from various walks of life.

Kendu leaf collectors of Kaliakundal and Atigaon panchayats in this block in Kalahandi district are a case in point.

Over 50 families in these two panchayats earn their livelihood from kendu leaf collection. SDCCB to give interest-free loan for migrants, landless

Sambalpur, June 29: The Sambalpur District Cooperative Central Bank (SDCCB) has launched a special drive to bring in improvement in the financial condition of returnee migrant labourers and landless people.

As part of this initiative, the bank will provide interest free loan to migrant returnees and landless people. The loanees will not be charged any interest for one year. However, they will have to pay interest after completion of one year. The SDCCB having its head-

quarters at Bargarh has 46 local area multipurpose cooperative societies (LAMPS) and other cooperative societies under its jurisdiction. As part of this drive, the bank has planned to lend ₹400 crore in the current Kharif season out of which ₹50 crore has been earmarked for landless people and migrant re-



As per the plan, the migrant returnees and landless people have to form a five to 10 member group in order to avail the loan. Each group will be loaned ₹50,000 to take up vegetable cultivation or enter into a business.

The bank has sanctioned ₹1.15 crore to 203 joint livelihood groups in this district so far and ₹58 lakh to 131 landless people.

Lingaraj Nayak, deputy registrar, cooperative societies, said the loan scheme is part of a state government plan to rehabilitate migrant returnees and landless people. The loanees can repay the loan after improvement in their financial condition for which the moratorium period is one year.

Our parliamentary system has also been tailored in such a manner that the government comes up with prepared legislations that are unflinchingly set in style and content. The idea of Discuss, Debate and Decide is only a ruse to pacify a certain section that is agitated by the actions of the government. Legislations moved by the government come printed and are presented to state assemblies or to the Houses of Parliament in such a manner that no amount

of amendments filed by non-government parties can be taken into consideration. That means, the Decide factor is already taken care of before any new law is brought before the legislative houses. All that is discussed and debated holds no value whatsoever. This form of governance has created an environment of complete inefficiency and total corruption at every level.



The ability or the desire to question is something inherent for a healthy democracy.

In a society like the one we see in India, the desire to question needs to be protected and also nurtured. For long centuries, we have been ruled by kings and landlords whose abilities to govern should have been questioned during their lifetimes. With our feudal mindset, we not only accepted but also adored those perverted rulers and made them look attractive to the common man's eyes. This has altered the very DNA ingrained in our existence. Similarly, when the problem with China is discussed, the ruling party informs the nation that a Congress led Foundation had received funds from the Chinese embassy and the government. While it is perfectly sensible to expose the wrongdoings of the previous governments, it is also equally important for the government to create an atmosphere of transparency. Had the BJP-ruled Union government wanted to be transparent, it could easily have come out open with data on how much the PM-Cares Fund has received from various sources including Chinese corporates. Had the government not taken PM-Cares out of the ambit of CAG Audit and RTI queries, needles of suspicion would never point towards that fund. This has created opportunities for the Opposition to allege that massive donations have come into the PM-Cares Fund from Chinese companies. When a modern democratic government constantly shrouds its activities under a cloak, it is but natural that questions will arise. Whenever any individual or group questions, that is being labeled as Opposition or even anti-national. Those in power must remember that the very essence of democracy is change. DEFICIT IN OPTIMISM

ompiling data and communicating it in a transparent manner to the public are an important part of the government's response to a pandemic, apart from refining the tactics as the disease evolves and spreads. This however is an area that reflects the failings of the government in the thick of fighting COVID-19 that will likely leave India as one of the worsthit nations on the globe. Take the simple case of numbers

released under various heads that are not defined anywhere by the government. Every day, the Ministry of Health and Family Welfare issues numbers under three heads: active cases, cured/discharged, and deaths. We do not know how "active cases" are defined. In clinical medicine, a case is of someone with significant symptoms consulting a doctor. If this is the definition, then an "active case" would likely be a symptomatic person who has not fully recovered, has not succumbed to the disease and continues to be under the care of a physician. This is a person who has a) tested positive for SARS Cov-2 virus infection; b) has symptoms that require medical intervention; and c) continues to suffer from COVID-19. The 'D' in COVID stands for disease, not merely an infection detected through a positive test result. Many will contract the virus, become infected but not all will de velop the disease. They are called infected. Those who contracted COVID-19 are a subset of the infected, and are, in medical parlance, known as cases.

Given this, there is the risk that India's Infection Fatality Rate (IFR, number of deaths divided by total number of positives, ie, those proven to be infected) is being mistaken for Case Fatality Rate (CFR, which should be number of deaths divided by total number with the disease COVID) Clearly, CFR by definition has the denominator lower than in the case of IFR, and CFR is therefore always higher than IFR.

What are these numbers in the case of India? COVID cases are subsumed within the total number of infections – but dissected data

That's a bad picture

of disease cases and asymptomatic infections are just not available. So, the valid denominator for CFR is unknown. There is either no transparency from officialdom, or the data collection system does not separate infections from cases of disease. We can only deduce from the data available.

Take the data for the last Saturday of June, three months into the lockdown. The MoHFW reported a cumulative total of 1,97,387 "active cases" alongside 2,95,881 "cured/discharged" and 15,685 deaths (June 27 figures). The grand total comes to 5,08,953, which actually is the number of samples that tested positive and is officially described as "confirmed". Official accounts have it that the Case Fatality Ratio (or Rate) (CFR) is 3.1 per cent as of June 26, which is the number of deaths divided by the total number reported "confirmed". But we can see that these are not strictly cases as defined in medical parlance - they are infections. Thus, 3.1 is Infection Fatality Ratio (or Rate) (IFR) rather than CFR. A reasonable view of CFR is to divide the number of deaths by those "cured/discharged", plus the deaths. This is because those who were cured, discharged or died clearly had the disease and their files are closed. This way, CFR is 5.0 per cent, which is significantly higher than 3.1 per cent presented as CFR. We must note that in an epidemic that is prevalent, these are mere estimates because, a) the total number of the infected will inevitably be larger than those tested, and b) cases of today come from infections acquired up to 14 days (incubation period) in advance.

Currently, the MoHFW updates data once a day, at 8am. A reading of the releases from MoHFW and the optimistic analysis of numbers would indicate that India is putting up a good response to the pandemic. One of the datapoints released repeatedly and stressed again the last Saturday of June is that "recoveries fast outpace the

active COVID-19 cases" across the nation. According to the ministry statement of June 27: "While the number of active cases stands at 1.97.387, the number of cured cases is 2,95,880. With this encouraging status, the recovery rate is touching 58.13 per cent among COVID-19 patients.

The recovery rate is presumably the percentage of those who have recovered from among the total number of "confirmed" cases, but the reported number is nothing to celebrate because it is widely accepted that only a small percentage have severe symptoms and most recover. In fact, all cases minus deaths are recovered - so 100 minus CFR must be the recovery rate.

So how exactly is India coping with the challenge? And how justified is the optimism, if only to ramp up morale and keep up the fight against what still remains a potent threat?

Looking at the way the virus is spreading and numbers are growing, there is no room for complacency or optimism at this stage of the pandemic. We are staring at the spectre of a huge numbers of COVID-19 deaths - the wages of not investing in a proper health management system, and of not planning the epidemic response well. If we take a very conservative view in which, say, only 20-30 per cent of just the urban population (377 million, 2011 census) is infected before we can expect some level of herd immunity to kick in, even then we could lose (at the current reported IFR of 3.1 per cent), between two and 3.5 million lives. That's a bad picture. The number may well be different, but to map that better, India will need scientifically-led randomised sample testing for antibodies (IgG titres) to reach a fair estimate of how many were infected and didn't even know about it because they were asymptomatic and fought off the infection.

Across the board, a large number of employees has been thrown out or been told to wait for better days. About 12 crore workers are in distress in India, according to World Bank (WB) figures. In fact, physical distancing too has its cost and that global lost income from school closures could amount to \$13 trillion, says the Bank. McKinsey says the physical distancing is to cost ₹96 to 231 trillion for India.

The climate is changing. Many more new diseases or various mutants may emerge. The procedure for tackling such situations has to be worked out. The production lines have to remain open. Prime Minister Modi is right in his assertion that India is set to bounce back. He notes the coal block auctions are likely to generate ₹33.000 crore. There must be a discussion on this. The Supreme Court guide-

lines for Niyamgiri in Odisha provide a good base. The recent lockdown has also revealed how it has helped restoration of nature, reduction of pollution, dust and cleaning of river waters.

The UPA government committed such follies over a long period and came under severe criticism. If prices of essentials continue to rise and cash transactions are not eased, it can cause serious problems. The housing sector is facing a crisis due to job losses, pay cuts and surge in home loan defaults. The delinquencies at India Mortgage Guarantee Corporation (IMGC) have doubled in a year at ₹8500 crore and it guarantees 20 per cent of the loan amount, which covers EMIs for two years.

The excise duty was hiked in May of ₹10 per litre on petrol and ₹13 on diesel (unwise) a litre to mop up ₹1.6 lakh crore till next March. This is in addition to gains of ₹39,000 crore in March 2020. The daily hike is to add to a similar amount to the government's kitty. But, this is hitting the economy badly.

As space is thrown open, this Chennai start-up is flexing muscles for 2022

Chennai, June 29: With the government opening up the space sector for private investments, Chennai-based rocket making start-up Agnikul Cosmos Private Ltd is expecting to have its rocket ready by 2022, said a top company official.

"We have realised the engine for the upper stage or third stage and work is on for the first and second stage engines of the rocket. We hope to have the engines in seven months' time. Depending on how the Covid-19 lockdown progresses, we expect the rocket to be ready by later part of 2022," Co-founder and CEO Srinath

Ravichandran told IANS. Agnikul, he said, is developing a threestage (three-engine) rocket, powered by kerosene or semi-cryogenic fuel with a carrying capacity of 100 kg to low earth orbit.

The rocket height will be 18 metres and

it would weigh about 13 ton at liftoff. According to Ravichandran, the company will buy commercially-available navigation systems and modify them to

The company, which has 50 employees is currently working out of the National Centre for Combustion Research and Development located at Indian Institute

of Technology-Madras. Ravichandran said that Agnikul has raised about Rs 26 crore till date from various investors and the promoters have also put in their own funds.

Agreeing that the money in rocket launch services is very low compared to that in satellite application service and ground equipment, Ravichandran said: 'The estimated market for small satelyear. This market will grow when there are rockets available for putting into orbit small satellites.

Chennai, June 29: Chennai and Madurai will continue to be under intense lockdown till July 5 and the current relaxations and curbs shall be in force till July 31 for the rest of Tamil Nadu, the government said.

Schools, colleges, malls, resorts, lodges, cinema halls, and bars would continue to be shut and religious congregations and prayers in places of worship in urban regions are banned.

Travel to tourist places like Nilgiris, Kodaikanal and Yercaud for non-residents and for tourism purposes is not allowed, an official release said. While restrictions for Chennai, Madurai and other nearby areas of these two cities would ease from July 6, in other parts of Tamil Nadu, the current relaxations and curbs shall continue to be in force till July 31. As many as 3,949 more persons tested

positive for coronavirus while 62 such patients died in Tamil Nadu in the last 24-hour cycle, the Health Department said Monday. The two figures are new highs for the state in a single day. The total active cases in Tamil Nadu now are 37,331. In a statement issued here, the department said the total case tally had climbed up to 86,224 and the death toll till date to 1,141.

A total of 30,039 more samples were tested, taking the state's total to about 11.40 lakh.

The number of Covid-19 patients who got cured went up to 47,749 as 2,212 more persons were discharged from various hospitals Monday.

The number of corona-infected children in the state in the age group 0-12 went up to 4,225.

State capital Chennai continued to lead Covid-19 infection table at 2,167 more positive cases, and a total tally of 55,969. The active cases in the city now are 21,681.

HC orders Revenue Dept to 'take over' Sathankulam PS

The court, hearing the custodial death of father and son, also said it was for the Tamil Nadu government to transfer the case to the Central Bureau of Investigation

P. Jeyaraj and J. Bennicks, the father and son duo, had been booked for not closing their mobile shop in time June 19 by the Sathankulam police. They were remanded to judicial custody and lodged in Kovilpatti jail June 21.

Jeyaraj died June 22 night and Bennicks June 23 morning in the judicial custody, allegedly due to the police torture.

The court took suo moto cognizance of the case.

The court also asked the forensic team to collect all the materials to protect the evidence after the Principal District and Sessions Judge, Tuticorin, who was monitoring the case, submitted that the Sathankulam police were not cooperating with the probe being conducted by the Kovilpatti Judicial

When the government counsel asked for permission to transfer the probe to the CBI, the court said it was a policy decision and its permission was not needed.

CCTV EXPOSES COPS' LIES

The Sathankulam police's version of events in the Jevarai and Bennicks custodial deaths case has been inconsistent with eyewitness accounts, sources said. And now, CCTV visuals have emerged which testify the real version of events is much closer to what evewitnesses had said. While the police claimed that the father-son duo had 'rolled on the ground' causing internal injuries to themselves - no such thing happened, the footage reveals.

CCTV footage from a shop, King Electricals, next to Bennick's mobile shop in Sathankulam, shows many discrepancies in the police's version of events. The visuals start

at 21.33 hrs (as per the time stamp on the footage) and show a portion of the entrance to Bennick's shop and the road in front of the shop. According to sources, the CCTV

timer is 1 hour and 40 minutes fast. According to the FIR, the police constable went on their regular pa trolling in the area of Bennick's shop around 21.15 hrs June 19. "APJ mobiles shop was open beyond the curfew time, violating the lockdown rules. In front of the shop, Jeyaraj, Bennicks and a few others were standing. We told them not to crowd and go back to their homes. Others listened to us and went home but Jeyaraj and his son Bennicks sat on the ground and refused to go home, used obscene language at us and rolled on the ground. They got internal injuries because of that," read the FIR registered by the police June 19.

CM Yedi allays fear but asks to beware



BANGALORE: Coronavirus cases doubled in the Karnataka capital in just five days, from 1,556 Tuesday to 3,419 by Sunday evening, said Medical Education Minister K.

Sudhakar, here Monday Banaglore now accounts for 26 per cent of Covid-19 cases in Karnataka. It has 2,692 active cases and has reported 88 deaths, the highest in both cases

However, Karnataka's mortality rate was low at 1.56 per cent against 3 per cent at the national level, he said. The state's recovery rate stood at 57 per cent with 7,507 discharges, he added.

After testing 5.95 lakh people, the state's positivity rate stands at 2.21 per cent. Till Sunday evening, of the 13,190 Covid-19 cases in the state, 5,472 were active.



Foreign inmates of Tihar turn violent, attempt jailbreak

New Delhi, June 29: The Tihar Jail authorities have informed the Delhi High Court Monday that that "some foreign prisoners forced their way out of the ward and also damaged the locks of gates.3

"On 16.06.2020 morning, 15-20 foreign inmates created problem in the iail. They forced their way out of the ward and also damaged the locks of gates of Ward No. 9 and Chakkar."

'Sensing trouble and having no other alternative, alarm was sounded in the jail at around 8.30 a.m., reinforcements called and these inmates were physically controlled by minimum use of force," the jail authorities said in a status report filed before a single judge bench of the high court presided by Justice C Harishankar.

This comes days after Pinjra Tod activist Natasha Narwal, who is currently in judicial custody in the Tihar Jail in a case relating to Delhi riots, told the Court that the video conferencing facility in jail was suspended after "large scale violence" took place.

"In the process, 15 inmates and 10 jail staff have suffered minor injuries. They have been given treatment in the jail dispensary by the jail doctors. Punishment as per jail rules will be made against the defaulting inmates,: Tihar said in its response.

A day before the incident took place; some of foreign inmates came to the Deodhi of the jail in the morning on some pretext and refused to leave till late evening, despite repeated counseling/persuasion by the jail officers. Since the jail has to be locked up in the evening, they had to be physically removed to different cells in the jail by the jail staff where they were locked.

India seeks extradition of 'project manager'

INDIA AND THE US HAVE BOTH INDICTED SAJID MIR OF PAKISTAN-BASED LET GROUP FOR THE THREE-DAY ATTACKS ON HOTELS, A TRAIN STATION AND A JEWISH CENTRE

New Delhi, June 29: India is seeking the extradition of a top Pakistan militant suspected to have planned the 2008 Mumbai attacks after the United States said last week he was living freely in Pakistan, government officials said Sunday.

India and the United States have both indicted Sajid Mir of the Pakistan-based Lashkar-e-Taiba group for the three-day attacks on hotels, a train station and a Jewish centre in which 166 people were killed including six Americans.

While Pakistan took action against the Lashkar founder Hafiz Saeed last year, it continued to provide safe harbour to other top militant leaders, the US State MUMBAI ATTACKS



Department's 2019 country report on terrorism said.

One of them was Sajid, the "project manager" of the Mumbai attack, believed to remain free in Pakistan, the US report said.

An Indian official said the government has repeatedly asked Pakistan to hand over Sajid who is charged with serving as chief planner of the attacks, directing preparations and reconnaissance and was also named as one of the Pakistan-based controllers during the attacks.

"We have asked before, and are demanding again, he needs to be handed over," the official dealing with regional security issues said.

Pakistan's foreign office did not immediately respond to a Reuters request for comment. Pakistan has repeatedly rejected

US allegations that it is a safe haven for militants and said it has prosecuted the leadership of several proscribed groups

Another Indian official said the lack of action against Sajid was in conflict with Pakistan's assurances to international organisations including the Financial Action Task Force, the global watchdog on terrorism financing. Pakistan is trying to get off the FATF grey list of offending nations.

The FBI has posted a reward of \$5 million for information leading to the capture of Sajid who is also wanted for a 2008/2009 plot against Denmark's Jyllands-Posten newspaper to avenge its publication of cartoons of the Prophet Mohammad that enraged many Muslims.

Guwahati, June 29: Heavy flooding triggered by monsoon rains has forced more than a million people to flee their homes in the northeast Indian state of Assam, authorities said Monday, warning that the crisis was becoming more critical by the hour.

The Brahmaputra River, one of the largest rivers in the world which flows from Tibet into India and then into Bangladesh, burst its banks in Assam over the weekend, inundating more than 2,000 villages, and it was still raining Monday.

'Two people have died in separate incidents of drowning in the



million people have been affected, with the flood situation turning critical by the hour," a state government flood bulletin said.

Torrential rain hit at least 23 of Assam's 33 districts and the federal water resources body said water levels in the Brahmaputra were expected to rise, with more rain forecast over the next three days.

"The flood situation remains extremely grave with several embankments breached," Assam Water Resources Minister Keshab Mahanta told Reuters. Most of the Kaziranga National Park, home to the rare one-horned rhino, was

19,459 new COVID-19 cases takes India's tally to 5,48,318 THE DEATH TOLL CLIMBED TO 16.475 WITH 380 NEW FATALITIES

New Delhi, June 29: A single-day spike of 19,459 COVID-19 cases took India's tally to 5,48,318 Monday, while the death toll climbed to 16,475 with 380 new fatalities, according to the Union Health Ministry data.

This is the sixth consecutive day that coronavirus infections have increased by more than 15,000. The country has seen a surge of 3,57,783 infections from June 1 till date.

The number of active cases stands at 2,10,120, while 3,21,722 people have recovered, and one patient has migrated, according to the updated data. "Thus, around 58.67 per cent of patients have recovered so far," an official said.

The total number of confirmed cases includes foreigners.

According to the Indian Council of Medical Research (ICMR), a cu-



mulative total of 83,98,362 samples have been tested up to June 28, with 1,70,560 samples tested Sunday.

Of the 380 new deaths reported, 156 are from Maharashtra, 65 from Delhi. 54 from Tamil Nadu, 19 from Guiarat, 16 from Karnataka, 12 from Andhra Pradesh, 11 from Uttar Pradesh, 10 from West Bengal, eight from Rajasthan, seven from Madhya Pradesh, five each from Haryana and Punjab, four from Telangana, three from Odisha and one fatality each was reported from Jammu and Kashmir, Assam, Goa, Uttarakhand and Bihar.

Of the total 16,475 deaths reported so far, Maharashtra tops the tally with 7.429 deaths, followed by Delhi with 2,623, Gujarat with 1,808, Tamil Nadu with 1,079, Uttar Pradesh with 660, West Bengal with 639, Madhya Pradesh with 557, Rajasthan with 399 and Telangana with 247 deaths.

The COVID-19 death toll reached 223 in Haryana, 207 in Karnataka, 169 in Andhra Pradesh, 133 in Punjab, 94 in Jammu and Kashmir, 60 in Bihar, 38 in Uttarakhand, 22 in Kerala and 21 in Odisha.

Chhattisgarh has registered 13 deaths, Jharkhand 12, Puducherry and Assam 10 each, Himachal Pradesh nine, Chandigarh six, Goa three and Meghalaya, Tripura, Ladakh and Arunachal Pradesh have reported one fatality each, according to the Health Ministry.

More than 70 per cent deaths took place due to comorbidities, it said.

7.97L STUDENTS FAIL IN HINDI IN UP BOARD EXAMS

'Women under-represented or stereotyped in textbooks'

New Delhi, June 29: Women and girls are under-represented in school textbooks or when included are depicted in traditional roles in many countries across the globe, according to the Global Education Monitoring Report by UNESCO.

The fourth edition of the annual report launched recently, points out that not only the number of images of female characters included in the textbooks is very less in comparison to images of males, women are also represented in "less prestigious" occupations and as introverts and passive.

While showing men as doctors and women as nurses, only portraying women in subjects pertaining to food, fashion or entertainment, showing women in voluntary roles and men in paid jobs are among the gender stereotypes pointed out in the report, it also takes note of attempts by few coun-

to reflect more gender balance. "In Afghanistan, women were almost absent from Grade 1 textbooks published in the 1990s. Since 2001, they have been more present but in passive and domestic roles as mothers, caregivers, daughters and sisters. They are mostly represented as dependent, with teaching being the only career open to them," the

report said. "Similarly, a review of 95 primary

tries to revise the textbook images

and secondary compulsory education textbooks in the Islamic Republic of Iran showed that women accounted for 37 per cent of images. About half the images showing women were related to family and education, while work environments appeared in less than 7 per cent. There were no images of women in about 60 per cent of textbooks for Farsi and foreign language, 63 per cent for science and 74 per cent for social science." it added.

The report also takes note of the

revision of many textbook images to remove gender stereotypes by the Maharashtra State Bureau of Textbook Production and Curriculum Research in 2019.

"For instance, Grade 2 textbooks show men and women sharing household chores, along with a female doctor and a male chef. Students are asked to note these images and talk about them," the report said.

The Global Education Monitoring Report (GEM Report) is developed by an independent team and published by UNESCO. It has the official mandate of monitoring progress in meeting the Sustainable Development Goal on education.

The report provides an in-depth analysis of key factors for exclusion of learners in education systems worldwide, including background, identity and ability, gender, age, location, poverty, disability, ethnicity, indigeneity, language, religion, migration or displacement status, sexual orientation or gender identity expression, incarceration, beliefs and attitudes.

"The share of females in secondary school English language textbook text and images was 44 per cent in Malaysia and Indonesia, 37 per cent in Bangladesh and 24 per cent in Punjab province, Pakistan. A Malaysian primary school textbook suggested girls risked being shamed and ostracized unless they protected their modesty. The Ministry of Education acknowledged weaknesses in quality control and sent a sticker to cover the graphic in question in 2019.

"Respondents to a public consultation on gender discrimination in textbooks in the Republic of Korea pointed out that doctors and scientists were shown as mainly male, dancers, housewives and nurses as mainly female. Early childhood education textbooks depicted rabbits and foxes as female and lions and tigers as male," it said.

Monkey hanged to death

Hyderabad, June 29: In a case of extreme brutality a monkey was hanged to death from a tree by three people in a bid to scare other simians in Khammam district of Telangana, about 275 KM from here, forest department officials said Monday.

"The perpetrators, who admitted their guilt, are being booked under the Wildlife Protection Act," Sathupalli Forest Range Officer A Venkateswarlu said. The incident happened June 26 in

Vemsoor village and the video of the primate being hanged using a rope went viral, prompting the officials to investigate. The accused wanted to scare

other monkeys by hanging the one which was caught. We found the carcass in a decomposed state. The accused are being booked under the Wildlife Protection Act," the official said. According to Venkateswarlu, people at Sathupalli and surrounding areas are suffering from monkey menace with the simians raiding the orchards giving sleepless nights to the locals. The official said as per a Telangana government directive 30 per cent of the area in Sathupalli forest range during afforestation will have edible wild fruit species to enhance the food base of monkeys and other wild animals so that when they are rehabilitated, there will be sufficient food available.

Hunger brought migrants home, now drives them back

Patna, June 29: Hunger and hopelessness drove tens of thousands of migrant workers from cities of their dreams, vibrant and pulsating with life and activity, to languorous villages in Bihar during the lockdown.

It's hunger and hopelessness again that is pushing them back to the cities in Gujarat, Maharashtra, Karnataka and Telangana, and the sprawling farms of Punjab, disregarding the threat of the coronavirus disease that had brought

them to their knees. Their employers, many of whom had virtually abandoned them, are sending them train and even flight

tories whir back to life, construction activity picks up, and the sowing season has started. Mail and express trains to places like Ahmedabad, Amritsar, Secunderabad and Bangalore, from where these workers hurried back home, walking, cycling and travelling on trucks and even the hollow of container trucks and concrete mixing plants, are running to capacity.

According to sources in the East Central Zone of the railways, the average occupancy in Muzaffarpur-Ahmedabad Special is 133 per cent, Danapur-Secundrabad special (126 per cent), Jaynagar-Amritsar special (123 per cent), Danapur-Bengaluru city special (120 per cent), Patna-Ahmedabad special



(117 per cent), Saharsa-New Delhi special (113 per cent) and Danapur-Pune special (102 per cent).

Chief Public Relations Officer (CPRO), ECR, Rajesh Kumar, said that the railways is closely monitoring the waiting lists and quickly

updating reservation status to facilitate travel. "If need arises, more trains can be run on routes witnessing heavy traffic," he said.

ECR includes Danapur, Sonepur, Deendayal Upadhyaya, Samastipur and Dhanbad railway divisions. A

report from north Bihar's Darbhanga district said luxury buses and other vehicles with Maharashtra, Punjab, Haryana and Andhra Pradesh number plates could be seen transporting migrants back to their places of work.

Several companies in the manufacturing, industrial goods and real estate sector have even chartered aircraft to bring back their skilled and semi-skilled employees. "Whatever money I had has been spent. I don't know when I will get the job card for working in MN-REGA projects. We may die of hunger staying here and protecting ourselves from coronavirus, said Kusho Mandal of Anandpur village, who worked as a farm hand in

The fields of Punjab are beckoning Rajeev Chaupal of Ratyari-Khirikpur village, too. "I am returning to the farm of my employer in Punjab. He has promised me handsome cash," he said. They said they are being offered Rs 5,000 for planting paddy saplings on an acre of farmland instead of Rs 3,500 that was the going rate before the outbreak. Their families \rightarrow are also getting paid Rs 15,000-20,000 advance. People like Mandal and Chaupal are leaving for their old places of work despite the launch of Rs 50,000 crore 'Garib Kalyan Rojgar Abhiyaan' by Prime-Minister Narendra Modi to give a fresh impetus to rural livelihood.

Rainstorms batter southern China

Beijing: Torrential rains Sichuan province, killing at least 12 people and leaving 10 missing, authorities said. The island nation was initially planning to open its international airports to tourists on August 1, but has now decided to give priority to repatriate stranded Sri Lankans.

Kartarpur reopens

Lahore: Pakistan Monday reopened the Kartarpur Corridor more than three months after it was temporarily closed due to the COVID-19 pandemic, but no Indian pilgrim visited the Gurdwara Darbar Sahib, a top official said. India temporarily suspended the pilgrimage and registration for the Kartarpur Sahib Gurdwara in Pakistan March 16 in view of the coronavirus outbreak.

PANDEMIC PUSHES MILLIONS INTO HUNGER

Johannesburg, June 29: Millions of people have been pushed into hunger by the coronavirus pandemic, the UN World Food Program said Monday as it appealed for nearly \$5 billion to help feed the growing numbers in poor and middle-income countries.

'The frontline in the battle against the coronavirus is shifting from the rich world to the poor world," said David Beasley, WFP's executive director. "Until the day we have a medical vaccine, food is the best vaccine against chaos.'

He said without access to enough food, the world could see "increased social unrest and protests, a rise

The number of hungry people in the countries where it operates could increase to 270 million before the end of 2020 - an 82% increase from before the pandemic took hold, said WFP. The fallout from the pandemic is being felt hardest in Latin America, which has seen an almost three-fold rise in the number of people requiring food assistance, and among urban communities in low- and middle-income countries, which are being dragged into destitution by job losses and a precipitous drop in remittances. At this time of year, many farmers are awaiting crops from new harvests. Hurricane and monsoon seasons are getting underway while record locust invasions

in East Africa and outbreaks of conflict are adding to an already challenging outlook for the world's hungry. "This unprecedented crisis requires an unprecedented response. If we do not respond rapidly and effectively to this viral threat, the outcome will be measured in an unconscionable loss of life, and efforts to roll back the tide of hunger will be undone," said Beasley.

The new challenge requires a big increase in the use of cashbased transfers. Over half of WFP's new response plan will be delivered in cash and vouchers — allowing urban communities to purchase their food needs in local markets, which boosts local

China forces birth control on **Uighurs to curb population**

EVEN WHILE THE USE OF IUDS (INTRAUTERINE CONTRACEPTIVE DEVICE) AND STERILIZATION HAS FALLEN NATIONWIDE, IT IS RISING SHARPLY IN XINJIANG

Beijing, June 29: The Chinese g ernment is taking draconian measures to slash birth rates among Uighurs and other minorities as part of a sweeping campaign to curb its Muslim population, even as it encourages some of the country's Han majority to have more children.

While individual women have spoken out before about forced birth control, the practice is far more widespread and systematic than previously known, according to an investigation based on government statistics, state documents and interviews with 30 ex-detainees, family members and a former detention

camp instructor. The campaign over the past four years in the far west region of Xinjiang is leading to what some experts are calling a form of "demographic genocide."



The state regularly subjects minority women to pregnancy checks, and forces intrauterine devices, sterilization and even abortion on hundreds of thousands, the interviews and data show

The population control measures are backed by mass detention both as a threat and as a punishment for failure to comply.

Birth rates in the mostly Uighur regions of Hotan and Kashgar plunged by more than 60% from 2015 to 2018, the latest year available in government statistics. Across the Xinjiang region, birth rates continue to plummet, falling nearly 24% last year alone - compared to just 4.2% nationwide, sta-

tistics show For decades, China had one of the most extensive systems of minority entitlements in the world, with Uighurs and others getting more points on college entrance exams, hiring quotas for government posts and laxer birth control restrictions.

China to impose visa ban on Americans

Beijing, June 29: China said Monday that it would retaliate against US moves to punish officials tied to political crackdowns in Hong Kong by imposing visa restrictions on Americans it considers to have "performed badly" on matters regarding the semiautonomous Chinese territory.

Foreign ministry spokesman Zhao Lijian gave no details in making the announcement at a daily briefing. It wasn't clear if the measure targeted only US government officials or those in the private sector as well. It comes as China's legislature is expected to pass a national security law for Hong Kong Tuesday that critics say will severely limit opposition politics and freedom of speech in the city. The US says it will respond by ending favourable trading terms granted to the former British colony after it passed to Chinese control in 1997.

French ex-PM, wife found guilty of fraud

Paris, June 29: A Paris court Monday found French former prime minister Francois Fillon guilty of having used public funds to pay his wife and children for work they never performed.

The work had brought the family more than 1 million euros (\$1.13 million) since 1998. The couple's lawyers immediately announced an appeal. Fillon, 66, was sentenced to five years in prison, three of which were suspended, and a 375,000 euro (\$423,100) fine. He is also banned from seeking elected office for 10 years. He remains free pending appeal.



His wife, Penelope Fillon, 64, was found guilty as an accomplice. She was given a three-year suspended sentence and fined the same amount. The scandal broke in the French media just three months before the country's 2017 presidential election, as Fillon was the front-runner in the race. It cost him his reputation. Fillon sank to third place in the election, which was won by Emmanuel Macron. Fillon, who was France's prime minister from 2007 to 2012, and his wife have denied any wrongdoing and can appeal the decision. Penelope Fillon's role alongside her husband drew all the attention during the February-March trial, which focused on determining whether her activities were in the traditional role of an elected official's partner - or involved actual paid work. Prosecutors denounced "fraudulent, systematic practices." Fillon was accused of misuse of public funds, receiving money from the misuse of public funds and the misappropriation of company assets.

Cape Town, June 29: For months, experts have warned of a potential nightmare scenario: After overwhelming health systems in some of the world's wealthiest regions, the coronavirus gains a foothold in



poor or war-torn countries illequipped to contain it and sweeps through the population.

Now some of those fears are being realised. In Sudan's war-ravaged Darfur region, where there is little testing capacity, a mysterious illness resembling COVID-19 is spreading through camps for the internally displaced. Cases are soaring in India and Pakistan, together home to more than 1.5 billion people and where authorities say nationwide lockdowns are no longer an option because of high poverty.

In Latin America, Brazil has a confirmed caseload and death count second only to the United States, and its leader is unwilling to take steps to stem the spread of the virus. Alarming escalations are unfolding in Peru, Chile, Ecuador and Panama, even after they imposed early lockdowns.

The first reports of disarray are also emerging from hospitals in South Africa, which has its continent's most developed economy. Sick patients are lying on beds in corridors as one hospital runs out of space. At another, an emergency morgue was needed to hold more than 700 bodies.

Worldwide, there are 10.1 million confirmed cases and over 501,000 reported deaths, according to a tally by Johns Hopkins University of government reports.

Experts say both those numbers are serious undercounts of the true toll of the pandemic, due to lim-

ited testing and missed mild cases. South Africa has more than a third of Africa's confirmed cases of COVID-19 with 138,000 as of Monday. It's ahead of other African countries in the pandemic timeline and approaching its peak. So far its facil-

ities have managed to cope, but if

they become overwhelmed, it will

be a grim forewarning because South Africa's health system is reputed to be the continent's best.

Some, like Uganda, which already had a sophisticated detection system built up during its yearslong battle with viral hemorrhagic fever, have thus far been arguably more successful than the US and other wealthy countries in battling coronavirus.

But since the beginning of the pandemic, poor and conflict-ravaged countries have been at a major disadvantage, and they remain so.

South Africa leads Africa in testing, but an initially promising program has now been overrun in Cape Town, which alone has more reported cases than any other African country except Egypt.

Critical shortages of kits have forced city officials to abandon testing for anyone under 55 unless they have a serious health condition or are in a hospital.

China to centralise command over military reserve forces

Beijing: China's military reserve

forces will be formally placed under the centralised and unified command of the Communist Party of China (CPC) and Central Military Commission (CPC), both headed by President Xi Jinping, from July 1 to ensure the ruling party's "absolute leadership" over it and build a world-class army. Currently, the reserve forces are under the dual leadership of military organs and local Communist Party committees and they would be brought under the control of the ruling party and the CMC from July 1, the state-run Xinhua news agency reported.

Starbucks' dine-in facility to resume

New Delhi: Tata Starbucks Monday said the company will resume dine-in services in seven cities across India, with elevated cleaning and sanitising protocols. Stores will operate with 50% seating capacity to allow for social distancing between customers and employees, said Tata Starbucks in a statement. The selected Starbucks stores are in Delhi, Bangalore, Hyderabad, Kolkata, Ahmedabad, Surat and Vadodara.

China's industrial profits drop 19 pc

Beijing: The profits of China's major industrial companies dropped by 19.3% y-o-y between January and May this year due to the impact of the COVID-19 pandemic, the National Bureau of Statistics (NRS) said. According to the NBS, industrial profits stood at 1.84 trillion yuan (\$260 billion) for the first five months of the year. The figure is less than the projections offered by analysts, who had predicted a 22% fall in profits during this period.

IOC to set up tech centre

New Delhi: Indian Oil Corp (IOC), the nation's biggest oil firm, Monday said it will set up a new technology development centre focussed on clean and alternative energy solutions. The new centre at Faridabad on the outskirts of the national capital will be the second R&D campus of IOC, the company said in a statement. Oil Minister Dharmendra Pradhan and Haryana CM Manohar Lal laid the foundation stone of the Technology Development and Development Centre.

Realtors resort to layoffs, pay cuts

Mumbai: Hit by the coronavirus pandemic, real estate developers have resorted to lavoffs and pay cuts and are focusing on cost control measures as sales are likely to remain muted in the coming months, according to industry experts. The real estate sector has been facing headwinds since the past three-four years following demonetisation, RERA and GST rollout as well as delays in approvals. The COVID-19 crisis has further impacted market sentiment and sales.

GOVT PLANS INCENTIVES FOR AUTO FIRMS TO BOOST EXPORTS

New Delhi, June 29: The government is drawing up an incentive scheme for the auto-sector aimed at doubling exports of vehicles and components in the next five years, four sources with direct knowledge of the matter told Reuters.

The Department of Heavy Industries (DHI) has sought feedback from auto industry groups on the initial proposal, which suggests giving incentives over five years to increase local production and procurement for export, the sources said.

Auto exports slump 73 pc in May

Mumbai: The auto exports plunged 73% last month to \$230.3 million (about ₹1,736 crore) as compared to the year-ago period with shipments to key markets like the US and Mexico registering a sharp decline owing to supply-chain issues due to lockdown, EEPC India said Monday. The exports of auto components too suffered a major setback during the month with important markets including the US, Mexico, Germany and Japan reporting "de-growth in the range of 34-68%", the Engineering Exports Promotion Council (EEPC) India said in a release. "COVID-19 public health crisis has taken a massive toll on exports of India's automobiles in May 2020 with as much annualised erosion as 98% and 65% in shipments to key markets like the US and Mexico, respectively," it said.

In a big boost to the state's metal downstream sector, M/s Reliable Sponge Pvt. Limited is looking at setting up Iron Ore Beneficiation plant of 2.5 MTPA and Pellet Plant of 2.0 MTPA, with an investment of ₹250 crore and with providing employment to about 250 people.

In the logistics & Infrastructure sector, M/S Sravan Shipping Services Pvt. Ltd will be setting up a logistics park at Jadupur (Mahakalapada Block) Kendrapada district. The company will invest ₹100 crore in this regard. The project will provide employment to around 250 people.

Grain-based distillery plant will be coming up in Odisha. M/s Chilika Distilleries Pvt. Ltd will set up a 110 Kilo Litre per day (KLPD) distillery plant with an investment of ₹99.97 crore. Around 170 people will be employed through this project. Similarly, M/s SOM Distilleries

Mumbai, June 29: The gross state domestic product (GSDP) of all states is likely to contract up to 14.3 per cent in the current financial year due to the impact of COVID-19-induced lockdown on economic activities, says a report.

States such as Assam, Goa Guiarat and Sikkim are likely to witness a double-digit contraction in FY2021, India Ratings and Research said in a report Monday.

'We expect the gross state domestic product (GSDP) of all states in India to contract in FY21. The contraction will be in the range of 1.4 per cent-14.3 per cent," the report said.

The top five major states where the impact of lockdown was the most pronounced are Karnataka. Jharkhand, Tamil Nadu, Kerala and Odisha. The five major states where the impact of lockdown was the least pronounced are Madhya Pradesh, Punjab, Bihar, Andhra Pradesh and Uttar Pradesh, the report said.

Despite the nation-wide lockdown enforced March 25, 2020, several economic activities defined as essentials remained operational. The impact of the lockdown on sec-

tors namely agriculture, industry and services was differently, it said. "Since agricultural activities were less impacted, the states hav-

ing a higher share of agriculture are expected to have suffered less compared to the one where the share of agriculture is low," the report said. Some sub-sectors especially in the

'Global economy to witness extended span of instability'

London, June 29: World's top economies like the US, the UK and Germany should prepare for a long slow recovery with prolonged periods of instability in the wake on COVID-19 pandemic, a new research has warned.

The team from University of Surrey's Centre for Understanding Sustainable Prosperity (CUSP) found that even before the COVID-19 crisis, many of the world's leading economies were experiencing larger slower growth cycles (recession cycles), suggesting precisely such a period of critical slowing down in the economic system.

The average growth in gross domestic product (GDP) per capita fell from over 4 per cent in the mid-1960s to little more than 1 per cent

in the pre-pandemic years. The International Monetary Fund (IMF) expects global GDP to decline by 5% this year alone with a contraction of 3% likely even in the emerging and developing market economies. "It's time to rethink and remake

the economic models that have been failing us for decades. The challenge is enormous. But so is the prize. CSD theory suggests that a resilient, sustainable economic system which protects the health of people and planet is now within our grasp," Jackson noted.

The overall number of global COVID-19 cases crossed the 10 million mark on Sunday, with deaths nearing 500,000, according to the Johns Hopkins University.

The US accounted for the world's highest number of infections and fatalities with 2,510,323 and 125,539, respectively, according to the CSSE.

Brazil came in the second place with 1,313,667 infections and 57,070

Real go 2-point clear of Barca

Brilliant Benzema no-look pass sets up Casemiro goal as Los Blancos edge past Espanyol to move ahead of their arch rivals

Barcelona, June 29: A brilliant back-heeled pass by Karim Benzema helped Real Madrid take a step toward reclaiming the Spanish league title with a 1-0 win at Espanyol.

Karim Benzema's back-heel pass goes through the legs of an Espanyol defender as Casemiro (No.14) makes a run to complete the good work done by the Frenchman with a goal

With Espanyol about to make it to halftime with a clean sheet, Benzema cleverly unlocked the hosts' defense Sunday He used a no-look pass with his heel to poke the ball through the legs of defender Bernardo Espinosa and met Casemiro's move into the heart of the box.

Casemiro's resulting goal and some flawless defending were all Madrid needed to win and move ahead of Barcelona by two points at the top of the table.

Zinedine Zidane's team took advantage of Barcelona's 2-2 draw at Celta Vigo Saturday by securing a fifth straight win since the league resumed following a three-month stoppage as Spain contained its COVID-19 outbreak.

The title rivals have six games left. Madrid holds the tiebreaker on head-to-head results in the event

they finish level on points. The runin seems tougher for defending champion Barcelona, which faces third-place Atletico Madrid Tuesday at Camp Nou.

Last-place Espanyol appears headed for the second division after falling 10 points from safety. Sunday's matches continued to be closed to fans due to the coronavirus pandemic, like all games in Spain since the competition resumed two weeks ago.

An accelerated schedule has games every three days in order to inish the season by July 19.

Espanyol hung on in the match until Benzema and Casemiro combined to decide the contest between a trophy-chasing powerhouse and a team needing a miracle to avoid

The biggest weapon of the Barcelona-based Espanyol was China forward Wu Lei, whose speed produced two promising attacks early on. Madrid defender Dani Carvajal blocked a strike by Sergi Darder three minutes into the game when Wu found him with a low cross.

But Madrid proved the more dan-

gerous side throughout. Casemiro forced goalkeeper Diego Lopez to palm his lob from Madrid's own half over the bar before Benzema tested him with a powerful shot in the 36th.

Lopez was helpless in the 45th when Benzema set up Casemiro, and the hosts never gave signs of recovering in a second half dominated by Madrid's high ball pos-

Espanyol was coached by sports director Francisco Rufete, a former player who stepped in after the club fired Abelardo Fernandez Saturday. Rufete is the team's fourth coach this season.

Paco Alcacer and Gerard Moreno scored two superb goals to help Villarreal beat regional rival Valencia 2-0 and stay in the fight for a Champions League spot.

Moreno passed for Alcacer to execute an excellent volley and give Villarreal the 14th-minute lead. Moreno added a second goal just before halftime off a brilliant pass from Santi Cazorla in an impressive team move. Cazorla used a subtle touch to cushion a long ball lobbed forward by his goalkeeper and kept it aloft for Moreno to smash home.

Villarreal is one of the hottest sides in the league since play resumed in Spain. Javier Calleja's team has earned 13 of a possible 15 points since the restart and is now three points from fourth place and the last Champions League place. Villarreal has kept a clean sheet in those four wins.

Valencia is among the worst performers since the resumption of the league. Valencia has won four of 15 points, and is eight points from fourth-place Sevilla.

Coach Albert Celades, who has had run-ins with players recently, said he did not fear for his job despite the bad run of results.

Eibar's 2-1 win at Granada moved the Basque Country club further away from the drop zone and the trio of clubs staring at relegation.

Celta is the last team in safety, with an eight-point advantage over the bottom three of Mallorca, Leganes and Espanyol, Levante also beat Real Betis 4-2. Both teams remained in the middle of the standings.

Setien's sacking inevitable!

Barcelona, June 29: Quique Setien is on verge of losing his job at Barcelona as the Catalan giants are all prepared to sack the manager, suggests a report by 'Goal'. However, the report also says that the former Real Betis manager can save his job if the results drastically improve and they win La Liga or Champions League.

The veteran coach, who only took the Camp Nou job in January as replacement for Ernesto Valverde, has lost the confidence of the dressing room, while the club's board is also unhappy with recent per-

Unless Barca's displays for the remainder of the 2019-20 campaign have a significant upswing, it is understood that it is inevitable Setien will leave his post in the summer.

Setien was given a two-and-a-halfyear contract, however as things stand he will not be able to see out more than a few months of this deal.

Player power at Barcelona is strong – led by stars such as Lionel Messi and Gerard Pique - and the dressing room has turned against Setien due to confusion at his tactics and unhappiness at his comments in the press.

They are also unhappy with

Setien being too hands-on in training – similar to how Real Madrid's stars turned against Rafael Benitez before he was sacked and replaced by Zinedine Zidane - while the assistant manager, Eder Sarabia, is also a very unpopular figure.

Setien has also lost the confidence of the board, who hoped the coach would help smooth things over after Valverde's departure however poor results and negative football has ensured this has not

What could save his job, however, is the fact that Barcelona could still end the season as La Liga and Champions League winners - they are only two points off league leaders Real Madrid, and have a round of 16 second-leg clash with Napoli to come in August, having drawn 1-1 in the first game before the cup was suspended due to the pandemic.

Notably, Setien was never the first choice after Valverde's sacking, with Ronald Koeman and Xavi Hernandez both turning down the job before the 61-year-old was appointed.

Former Barca star Xavi, now coach of Qatari club Al Sadd, has admitted he is preparing to manage his old club in the future and the Camp Nou board may try and persuade him to return this summer.

Quique Setien's side returned to



Menon eclipses Llong feat

Dubai, June 29: India's Nitin Menon Monday became the youngest ever to be included in the International Cricket Council's (ICC) Elite Panel of Umpires for the upcoming 2020-21 season, replacing England's Nigel Llong.

The 36-year-old, who has officiated in three Tests, 24 ODIs and 16 T20Is, is only the third from India to make it to the prestigious group after former captain Srinivas Venkatraghavan and Sundaram Ravi, who was axed last year.

"To be officiating regularly along with the leading umpires and referees of the world is something that I always dreamt of and the feeling has yet to sink in," Menon was quoted as saying in an ICC statement.

Menon quit playing competitive



cricket at 22 and by 23, he had become a senior umpire, officiating in BCCI accredited matches.

A selection panel comprising ICC General Manager (Cricket) Geoff Allardice (Chairman), former player and commentator Sanjay Manjrekar, and match referees Ranjan Madugalle and David Boon, picked Menon, who was earlier part of the Emirates ICC International Panel of Umpires. While standard of Indian um-

piring has copped a lot of criticism globally, performance of Menon over the past few years has been a silver lining The qualification in Elite Panel

makes Menon eligible to officiate in next year's Ashes in Australia in case ICC revokes the local umpires for home series policy which has been approved owing to the COVID-19 pandemic.

But Menon's elevation certainly makes him a candidate to stand for all five Test matches that India will play against England at home

early next year. Menon is confident that the rapport he has built with senior umpires over the years, having officiated in two ICC tournaments (2018 and 2020 Women's T20 World Cup), will keep him in good stead.
