Flip-flop: VSSUT students test neg

Bhubaneswar, March 2: The 25 students of the Veer Surendra Sai University of Technology (VSSUT), Burla, who had reportedly tested positive for Covid-19 three days ago, were declared negative Tuesday after a fresh round of tests.

Health Secretary Pradipta Kumar Mohapatra termed the earlier tests carried out on the students 'false'.

"None of the students of the university have been infected by the Covid-19 virus. The antigen kits used in testing were faulty. When the students' RT-PCR tests were done, the reports came out to be negative.

Sources said the test kits will be withdrawn and the health department will take necessary steps to prevent recurrence of such events.

Sources said the precautionary measures adopted after the first round of tests will now be withdrawn. The district administration had declared 11 hostels on the varsity premises as 'Containment Zones'

These hostels are Pulaha, Pulastya, Atri, Kratu, Vasistha, Marich, Anuradha, Arundhati, Rohini, Visakha and Vasundhara. The adjacent area of Pulaha hostel was also



nfected by the Covid-19 virus.

declared as a buffer zone. This apart, the varsity authorities had also postponed the exams scheduled to begin from March 1 till further orders.

This revelation has shocked the local people. "What about the mental

stress the 25 students and their parents must have undergone during these days," they asked.

The developments have raised serious questions on the efficacy of rapid antigen tests and the manufacturers from whom the government procured the kits in bulk. In the current case, the kits were provided by some New Delhi-based suppliers. According to government documents, the faulty antigen testing kits were supplied to VIMSAR Medical College. The same kits were used to screen the students of VSSUT which showed the misleading results.

Notice slapped on testing kit supplier

BHUBANESWAR: The Odisha State Medical Corporation Limited (OSMCL) Tuesday issued a show cause notice to the New Delhi-based firm for supplying faulty Covid-19 antigen testing kits. The state government said the kits were inaccurate and it was asked why action should not be initiated against them. It has asked the firm to reply within three days. The notice was issued by the General Manager (operations-equipment) of the OSMCL seeking response from the erring firm which has its registered office at Okhla

Industrial Estate. "I am to state that it has been brought to the notice that the batch of Rapid Antigen Detection kits for SARS CoV-2 (Covid19) having batch no CAF-0008 supplied to VIMSAR, Burla is showing false positive results of Covid19 suspects, which is a matter of serious concern," the notice said. "You are hereby called upon to showcause as to why OSMCL shall not take action against your firm for supply of defective/non-standard Rapid Antigen Detection kits for SARSCoV02 (Covid19) within three days from the issue of the notice," the department said.

OSMCL has been entrusted with the task of procurement, storage and distribution of medical equipment needed for Covid19 testing and kits for healthcare workers during the pandemic. The department had procured several diagnostic kit and other materials from different manufacturers from across the country to cater to the needs of Covid19 management. The department was earlier under radar in the wake of allegations of PPE kit scam. The department was also red-faced when several trucks loaded with essential Covid 19 items like PPE kits, masks and others from manufacturers from other states were not accepted by them.



Food testing: State lags way behind

Bhubaneswar, March 2: The state seems to be faltering on food testing exercise meant to detect adulteration, contamination and misbranding in consumable food and beverages used by the public.

Latest available data from the Food Safety Standards Authority of India (FSSAI), New Delhi claim that Odisha is among the worst performers in the country when it comes to testing food sam-

FSSAI records of all Indiafood testing statistics claim that while several states were able to test more than 10,000 food samples in a year, Odisha was not able to test even 1000 samples in a year, hinting at the apathy of the government on food safety.

The central food safety monitoring agency, formed after the Food Safety Standards Act 2006, claims that Odisha was also one of the states with the least number of penal cases against adulterators. This comes at a time when states like Madhya Pradesh has made food adulteration a crime eligible for punish-

ments like life imprison-

ment.

The last published FSSAI data of 2018-19 claimed that Uttar Pradesh proved to be the best performing state in terms of testing. It examined 13,567 samples in a year and found 5663 samples adulterated. The state also filed 5101 civil cases and 375 cases against erring units. It also saw convictions in 1273 such cases.

Gujarat analysed 11,329 samples and found 839 cases of adulteration/misbranding and filed cases against 559 persons. Similarly Maharashtra was able to test 10,003 samples and found 2529 samples adulterated/misbranded and it filed cases against 1256 persons.

Several other states like Andhra Pradesh, Bihar, Jammu and Kashmir, Karnataka, Kerala, Chhattisgarh, Haryana and_ others tested samples between 5000 and 1300.



Classes X, XII timings change again

Bhubaneswar, March 2: Yielding to public demand for wrapping up classes before noon, the school and mass education department Tuesday rescheduled the timing of Classes X and XII as a precautionary measure to tackle the heatwave situation in the state.

As per the new timings, Classes X and XII timings were rescheduled to a bracket of 8 am to 12 noon. Earlier, it was from 9am to 1pm. Timings of Classes IX and XI have not been changed and they will continue as scheduled from 7am to 9am.

On February 26, as a precautionary measure to tackle the heatwave situation, the school and mass education department Friday rescheduled school timings for Class IX. X. XI and XII with effect from March 1. As per the guidelines, Class IX and XI timings were rescheduled to 7am to 9am while Class X and XII timings were rescheduled to 9am to 1pm.

But the Congress party Sunday had opposed the state government's plan to continue classes in schools post noon in the wake of the rising mercury level in the state. Congress leader Santosh Singh Saluja Sunday said classes should start by 6:30 am and end before noon.

He expressed concern that school kids may suffer illness due to scorching sun and demanded withdrawal of the state government's plan to continue classes till 1 pm.

"The state government has announced rescheduling of the classes but that is not good enough. Classes must start from 6am or 6:30am everyday and end by 11am or 11:30am. The mercury level is rising day-by-day. If any kid falls ill due to sunstroke, the school and mass education minister should be held liable for the same," Saluja said.

Bhubaneswar, March 2: The special CBI court Tuesday allowed the Central Bureau of Investigation (CBI) to take prime accused in Anjana Mishra gangrape case on a two-day remand for further investigation into the issue. The court also permitted the central agency to conduct a Test Identification (TI) parade of Bibekananda Biswal alias Biban to be held in Jharpada Jail Wednesday.

Sources revealed that the victim, Anjana Mishra, will be asked to identify the accused Biban among several others in the presence of JMFC Srujalin Mohanty Wednesday. The CBI sleuths from Kolkata office will take Biban on remand Thursday for interrogation. Legal experts have opined that the fate of the case hinges mostly on the outcome of the TI parade. As there is a lapse of 22 years since the incident happened and there are substantial changes in Biban's looks, it may prove to be a difficult task for the victim to identify Biban. More so because the accused will be shown as part of a group of people.

Earlier, the CBI sleuths had met Police Commissioner Sudhanshu Sarangi at his office here to discuss the issue immediately after the arrest of Biban last month.

Sarangi had announced the arrest of Biban from Aamby Valley in Lonavala of Maharshtra at a presser in Cuttack February 22. A joint team of commissionerate police of the twin city, Lonavala and Navi Mumbai in Maharshtra nabbed the accused who had been staying at Aamby Valley with a false name. Mishra was gangrapedby Biban and two others near Baranga in 1999.

Govt pension to terrorists in Pak: India

New Delhi, March 2: India Tuesday exposed Pakistan for hosting the largest number of terrorists proscribed by the United Nations and providing them pensions out of state funds. The first secretary of Permanent Mission of India to the UN, Pawan Kumar Badhe said this in India's right of reply to statements made by Pakistan and the OIC under oral update by the high commissioner of human rights at

human rights, has remained a constant, Badhe said.





SC relief for DGP, Commissioner

New Delhi. March 2: The Supreme Court has stayed an order of the Calcutta High Court that directed the state DGP, Commissioner of Bhubaneswar and Cuttack and Jajpur SP to personally appear before it in connection with a cheque bounce case wherein the police failed to arrest the accused.

A two-judge bench of the apex court comprising Justices AM Khanwilkar and Dinesh Maheshwari stayed the order with certain condition and also issued notice to the West Bengal government returnable in four weeks.

There shall be stay of operation of the impugned order on condition that the petitioners will approach the High Court on their own through counsel and produce relevant information/document for the perusal of the High Court in reference to the issue noted in order

dated 10.02.2021," the bench said. The apex court observed that the larger question is whether the High Court can exercise the jurisdiction beyond its territorial jurisdiction

In a special leave petition filed through advocate Shovan Mishra,

the DGP contended that the Calcutta HC erroneously assumed jurisdiction in this case whereas it has chosen to ignore that no part of the cause of action arose within the jurisdiction of Calcutta High Court.

"A plain reading of Article 226 makes it abundantly clear that the high court can issue directions in a writ petition only when the person or the authority against whom the writ is issued is located outside its territorial jurisdiction, only if the cause of action wholly or partially arises within the court's territorial jurisdiction,' the petition reads.

TWO DUPED BY CYBER CROOKS OF ₹65 LAKH

Bhubaneswar, March 2: Cyber criminals duped one person from Puri – Subojit Mukherjee, 52, of over ₹23 lakh promising to provide the former with a loan worth Rs10 crore.

In 2017, Mukherjee came across

an advertisement on Facebook regarding a loan offer by one Eduard Private Lending. Subsequently, he contacted the lender via the email address mentioned in the advertisement seeking a loan of ₹10 crore for some business.

On their part, the 'lenders' sent

various loan related documents to Pradhan through email. They also demanded different amounts under various pretexts like ₹63,850 as insurance fee. Mukherjee deposited ₹23,02,350 in various accounts of the accused between 2017 and 2018.

However, he smelt a rat when the accused continued demanding more money from him. In January 2021, He received a call wherein



the caller asked him to pay ₹75,000 for cancelation of the loan.

Similarly, a 41-year-old government official lost ₹39 lakh to the fraudsters who fooled him on the pretext of helping poor people affected by Covid-19 pandemic. The victim identified as Anil Kumar Pradhan hails from Kandhamal and works as the Panchayat Executive Officer in Nimapara area of Puri.

Pradhan alleged that he received a friend request from one lady, identified as Seun Edward from Auckland in New Zealand on Facebook, June 4, 2020. Thereafter, he frequently chatted with the fraudster on Facebook and later on Whatsapp.

Meanwhile, the lady expressed her desire to help poor people affected by Covid-19 pandemic. The accused told Pradhan that she wanted to send \$1 lakh for various charity works for the poor.

On 8 June, 2020, Pradhan received another call from a person who had allegedly gone to Delhi Airport to receive a packet containing the money sent by Edward. He asked Pradhan to pay ₹49,000 to release the packet. Subsequently, Pradhan deposited ₹39,68,830 in various accounts of the accused from time to time.

The state crime branch has now started investigations into both the cases by registering two separate cases in this regard.

Balasore, March 2: A day after Revenue officials and scientists of Odisha and West Bengal carried out land measurements at disputed sites of Subarnarekha river here in Balasore district, they held a meeting Tuesday. They agreed to sort out interstate border dispute on the basis of 35 ground control points (GCPs) in the Odisha side and 53 points in the West Bengal side.

Meanwhile, a technical team visited the disputed sites Tuesday to determine ground control points. Identification of the 12km-long course of Subarnarekha will be finalised within two days, it was decided.

Ground control points (or GCPs) are points on the ground with known coordinates. In an aerial mapping survey, GCPs are points which the surveyor can precisely pinpoint. GCPs are defined as points on the surface of the earth of known location used to geo-reference Landsat Level-1 imagery. Ground

> coordinates can come from a variety of sources such as the Global Positioning System (GPS), ground surveys. geo-coded images, vectors, geographic information systems (GIS), topographic maps, chip databases, or by using photogrammetric processes to extend the number of GCPs in your images.

Patana, March 2: Timber mafia has been on a looting spree in some reserve forests under Patana range of Keonjhar district while wildfire has being raging in some other forests, reports said.

According to the reports, 16 Sal trees were found cut down in Gadheibhola reserve forest. Each log was measured about 12 ft in length. Such incident has taken place just two kilometres away from the Saharapada forest office.



Contacted, Ranger Pabitra Mohan Nayak said that the logs have been handed over to a local Vana Surakhva Samiti. Locals questioned how the Forest department has failed to catch such illegal activities under their nose.

They added that if mafia was allowed to operate at their will, the valuable trees in the reserve forest will vanish soon.

On the other hand, wildfire is spreading in some forests under this range. Scores of Sal and other valuable trees have burnt to ashes in Saradharpur forest, Suam reserve forest and Barigan Khesera

Forest officials brought the fire under control. Locals said that due to wildfire, wild fauna has been at risk in summer.

Lifer for murder of woman on court premises

Sambalpur, March 2: A local court Tuesday sentenced a man to life imprisonment and slapped a penalty of Rs 10,000 after convicting him for the 2018-murder of a woman Sangita Choudhury in the family court premises in this town.

The district and sessions judge Bibhuti Narayan Mohanty pronounced the order in the presence of the lawyers of the plaintiff and defendant in the court premises, cadre public prosecutor Dipti Ranjan Sandha said. The convict Ramesh Kumbhar, 25, of Sindurapanka village lodged in the Sambalpur Circle Jail was informed of the order through video

In case of default, Ramesh has to undergo an additional two years of imprisonment. The money collected from penalty will be given as compensation to the deceased Sangita's mother Lalita Choudhury.

According to the case diary, Sangita and Ramesh were in love and eloped in 2017. Later, they came back after three months and staved at Sindurapanka. The girl's family members managed to convince her and bring her back to their house and her father lodged a complaint of kidnapping against Ramesh. Police arrested Ramesh for which he had to stay for three months in jail.

Meanwhile, the girl's family members fixed her marriage elsewhere for which Ramesh approached the family court. The court had called both the groups for counseling when Ramesh attacked Sangita with a sword and rendered her critical April 23, 2018. She died during treatment at VIMSAR, Burla.

Angul launches 'low-achiever classes' ahead of HSC exams

Angul, March 2: Amid relaxation in Covid-19 norms, the district administration has launched lowachiever classes in the high schools to help the mediocre and weak students improve in their studies and come out with flying colours in the HSC examination scheduled for May 3, a report said.

Over 6,985 students studying in 248 schools are being imparted special coaching in these classes being held in over 95 per cent of the schools. The low achiever classes starting from February 15 will continue till April 15.

The aim is to better the HSC (High School Certificate) examination results in the district this year and create a new record by surpassing the past year's result. The response has been very well while



the teachers are catering to the weak students in a healthy atmosphere and clearing their doubts.

The students are being imparted step by step instructions in their subjects to improve their learning skills and extra help in the lessons when required. They are also being motivated all the time to better their performance.

The pass percentage of the district was 73 per cent last year which the district administration aims to beat this year. Reports said that over 18,996 stu-

dents studying in 248 schools in the district will sit for the matriculation/HSC examination this year. However, the students have failed to attend regular classes due to closure of their schools following Covid-19 induced lockdown and shutdown in the state. The students were having online classes during the lockdown period but started attending regular classes after lifting of the restrictions.

As a result their studies have suffered immensely which has become a cause of concern for the district administration and the district education department. The authorities apprehend that this might impact their result which forced the district administration to launch the low achiever classes

Bhawanipatna, March 2: The state government has been pushing rural development on a priority basis, but its efforts seem to have faltered in Kalahandi district. There are hundreds of villages in this district which are still inaccessible by ambulance in emergency cases, a report said

According to the report, the state government has given push to the agriculture sector in the district by executing the Indravati irrigation project. Hundreds of hectares of farmlands are being provided irrigation facility under it. But communication has been a hurdle for development in 523 villages where healthcare has been a dream for people. Official report said these tribal-dominated villages are extremely remote and inaccessible.

As ambulances do not get access to these villages, patients are carried on cots for kilometers. It is said that crores of rupees are being spent for road connectivity, healthcare, education and livelihood, but these facilities are almost missing in 14 remote villages under Kalahandi block.

Spying Dragon

isturbing reports have surfaced about suspected Chinese hackers doing cyber espionage to ferret out information about Covid-19 vaccines being produced in India and also the supply and distribution chains of vaccines in the US. Now Chinese hackers are also credited to have wreaked havoc on the Mumbai power grid in October, 2020 causing a severe power failure in decades in the country's finance capital through a malware at the height of the border standoff in Ladakh between India and China.

The reports emanated from cyber intelligence firms based in Singapore, Tokyo and the US. The Federal Bureau of Investigation (FBI) has also alerted the world against such attacks by hackers in China, North Korea and Russia on researchers of Covid vaccines. Goldman Sachs-backed Cyfirma, based in Singapore and Tokyo said in a report Chinese hacking group APT10, also known as Stone Panda, had identified gaps and vulnerabilities in the IT infrastructure and supply chain software of Bharat Biotech and the Serum Institute of India (SII). The main motive is to get competitive advantage over the Indian companies producing Covid vaccines. This report carries weight as the Chief Executive of Cyfirma has an impeccable record in counter-intelligence having been a top cyber official with British foreign intelligence agency MI6. In the case of SII, the hackers have found a number of their public servers running weak web servers and weak content-management system.

Cyfirma told news agency Reuters the Chinese state-backed hacking group had, in recent weeks, targeted the IT systems of two Indian vaccine makers whose shots are being used in the country's immunisation campaign. China and India are trying to capture the global Covid vaccine market. Both have already sold or donated vaccine shots to many countries. Incidentally, India produces more than 60 per cent of all vaccines sold in the world.

This is no longer in the realm of speculation and conjecture. India's staterun Computer Emergency Response Team (CERT) has acknowledged the threat mentioned by Cyfirma. Its technical analysis and evaluation verified the threats and attacks. US drug-maker Pfizer and its German partner BioNTech SE have also stated documents on the development of their Covid vaccines were unlowfully accessed.

Director of the US National Counterintelligence and Security Centre, William Evanina, revealed on March 1 that US adversaries were trying to interfere with the US government operation distributing the vaccines. He pointed the accusing finger at China and Russia.

China's response has, so far, been on predictable lines. Its Foreign Ministry spokesman Zhao Lijian is smart enough to claim China itself has been investing enormous time, energy and money on research on Covid treatment and vaccine. As such, it would be immoral to target his country with rumours and slanders in the absence of any tangible evidence. This is typical Chinese obfuscation as is being done regarding the spread of the Covid-19 pandemic from Wuhan. A World Health Organisation (WHO) experts' team is, probably, still trying to find out whether China played a nefarious role in the pandemic. China deliberately delayed the investigation on one pretext or the other apparently destroying, in the process, much evidence of the origin of the virus from Wuhan.

Another US company, Massachusetts-based Recorded Future, has claimed in its latest study that a Chinese government-linked group of hackers targeted Mumbai's critical power grid system through malware causing massive power outage that threw the city's train and hospital services and academic activities out of gear during two hours' power shutdown in October, last year. China's aim appears to warn India not to rub it the wrong way or else it would make its vital sectors fall like nine pins.

All these point to a sordid and alarming state of affairs. If China has been able to infiltrate India's cyber space at will, Indian counter-intelligence and foreign service establishment, as usual, are always caught with their pants down. This has become a set pattern. So long China has been sneaking in and out of Indian territory as is evident in Doklam and Ladakh. All this while an Union minister who was earlier the Chief of the Indian Army has publicly said in Tamil Nadu that India has transgressed more number of times into Chinese territory than China has into Indian territory. This kind of brave talk without any basis may help create a false sense of nationalism that could help the BJP but it makes India the aggressor and China becomes the affected nation.

The Indian government, on the other hand, persistently remained in a denial mode about the Chinese incursions. In the same breath it engaged in protracted negotiations on disengagement in Ladakh which is an admission that encroachment had taken place.

Now, it turns out Chinese hackers can invade Indian cyber space as well to cause incalculable harm to its vital infrastructure and steal intellectual property as the People's Liberation Army (PLA) has entered into Indian territory without much resistance. Chest-thumping policy by the government is not the answer to the grave threat from Chinese cyberspace and land invasions. The government needs to get rid of its false bravado displayed in the slogan of building "atmanirvar" (self-reliant) India adding to empty verbiage of "make in India" and "start-ups." Coining catchy terms, acronyms and slogans is not the weapon to fight a shrewd, crafty and powerful advergary such as China.

The government ought now to find out what China has done in Indian territory during the showdown in Ladakh. It's not in keeping with China's character to agree to disengagement in Ladakh so easily after remaining inside Indian borders for months. Seeds of big mischief like cyber attack may have been sown during the occupation of Indian territory by China's PLA. This seems to be a distinct possibility now that the hackers' designs are no longer a secret.

■ Maundy

On the Thursday before Easter each year, Her Majesty Queen Elizabeth II distributes the Royal Maundy in a cathedral somewhere in England. Men and women to the number of her age each receive that number of pence in specially minted Maundy coins (pennies, twopences, threepences and fourpences), plus a sum in ordinary money. The Queen spent her 85th birthday honouring pensioners at the Royal Maundy Service in Westminster Abbey yesterday. Each of the 85 men and 85 women who received the Maundy Money from the Queen ... was given a purse containing 85p in commemorative coins, a £5 coin celebrating the Duke of Edinburgh's 90th birthday in June, and a 50p coin marking the London 2012 Olympics (Daily Telegraph, 22 Apr. 2011), These days, the monarch no longer ceremonially washes the feet of the poor — the last one to do so was James II — but this, and not the giving of money, is the origin of the strange word Maundy, which never appears anywhere except in reference to the Thursday before Easter. This day commemorates the Last Supper, in which, after the ceremony of washing their feet, Jesus gave a new commandment to his disciples that they should love one another. In Latin "new commandment" is mandatum novum (the first word is also the origin of mandate); on Maundy Thursday in Roman Catholic churches the anthem Mandatum novum do vobis ("a new commandment I give to you", the start of verse 13:34 in St John's gospel) would be sung, in particular following the royal ceremony of washing feet and giving alms. As a result, the ceremony became known as mandatum. The Old French version of that word is mandé and over time it became corrupted into maundy.

FOCUS ODISHA

IMPEDED BY CENTRE'S APATHY

disha Finance Minister Niranjan Pujari, presented the State Budget for fiscal 2021-22 at a critical juncture when the economy is being ravaged by the pandemic-induced recession and central assistance is dwindling. The Budget has evoked mixed reactions. Chief Minister Naveen Patnaik described it as pro-people, pro-growth, and transformative, while the Opposition dubbed it disappointing. The finance minister said that the State Budget aimed to create an aspiration for "New Odisha Empowered Odisha" with an agenda to transform health, agriculture, education, livelihoods infrastructure as well as industries to the next level with adequate safeguard for vulnerable sections of society

Normally, the budgetary outlay is decided in tandem with an expected rise of nominal GDP growth. Due to pandemic-induced recession, in 2020-21, nominal GSDP would shrink to negative 2.24 per cent against the projected rise of 11.7 per cent, while real GSDP at constant prices (2011 12) is likely to shrink to negative 4.92 per cent against the projected rise of 7 per cent.

However, according to the State Economic Survey, the pandemic's blow has been cushioned by the state government's effective financial management and governance and the contraction in Odisha's real GSDP growth is much lower than the 7.7 per cent decline projected for the national

While estimating the total outlay for 2021-22, the finance minister has assumed that nominal GSDP will grow at 10.5 per cent to reach ₹5.86 lakh crore, still behind the estimated value of ₹5.96 lakh crore in the previous fiscal. However, the nominal GSDP estimated to be ₹5.96 lakh crore in 2020-21 has collapsed to ₹5.095 lakh crore in a revised estimate due to the pandemic. This shows how one years' GSDP has been lost due to the pandemic.

The total budgetary outlay has been pegged at ₹170,000 crore in 2021-22 up from estimated outlay of ₹150,000 crore in the previous

fiscal, which was also revised downward to ₹135,000 crore. It means the outlay has been increased by 13.33 per cent in 2021-22 against the budgeted outlay and 25.92 per cent against the revised outlay of the previous fiscal. This is much higher than projected nominal GSDP growth. The total size of the State Budget has increased from 16 per cent to 26 per cent of GSDP between 1999-2000 and 2020-21 and is likely to rise around 29 per cent in 2021-22. This is a welcome feature.

Hence, in terms of outlay, the Budget seems to be too expansionary. But if loan repayments of ₹23,581 crore are considered, then outlay is as usual. But the rise in outlay is far better than that of Uttar Pradesh which saw only a 7.3 per cent rise in its recent Budget.

The administrative expenditure (earlier non-planned) is estimated at ₹85,000 crore up from the budgeted estimate of ₹65,655 crore in 2020-21, which was reduced to ₹63,150 crore in revised estimate. The programme expenditure (planned) is estimated at ₹75,000 crore, higher than the budgeted estimate of ₹74,000 crore and revised estimate of ₹62,000 crore of previous fiscal. The administrative expenditure does not normally create assets directly But as proportionate of total outlay, it is estimated to increase to 50 per cent in 2021-22 from 44.12 per cent in previous fiscal. This does not augur well.

The total State Sector Schemes is estimated to be ₹42874.92 crore in 2021-22 lower than the budgeted outlay and revised outlay of previous fiscal. It was pegged at ₹44988.10 crore but was revised downward to ₹36000 crore in 2021-22. This decline is due to a plunge in Centre's assistance. Similarly, Central Sector Schemes is estimated to be ₹357.58 crore, down from the budgeted estimate of ₹456.20 which was revised upward to ₹480.90 crore.

A total sum of ₹9,164 crore is allocated for public healthcare with an increase of about 19 per cent over previous year. There was a massive investment of ₹12,000 crore for piped drinking water. What is shocker is that the agricultural outlay has been reduced in the last few years. From an outlay of ₹20.717 crore in 2019-20, it was reduced to ₹19,408 crore in 2020-21. The allocation for the year 2021-22 has been slashed by over 9 per cent to be estimated at ₹17,468 crore in 2021-22 despite the agriculture sector witnessing negative growth of 6.54 per cent in 2020-21.

The tax/GSDP ratio is estimated at 6.40 per cent in 2021-22 as against 6.43 per cent estimated in previous fiscal. Similarly, the non-tax/GSDP ratio is estimated at 3.41 per cent in 2021-22 against 3 per cent estimated in previous fiscal. This in-

cludes the withdrawal of ₹2,000 crore (0.34 per cent of GSDP) from Consolidated Sinking Fund (CSF) for repayment of OMB, which is shown as interest receipt in accounting terms.

Thus, the total own revenue (both tax-non tax) as a percentage of GSDP is estimated at 9.80 per cent in 2021-22 as against 9.4 per cent estimated in previous fiscal. So, no attempt is made to augment additional revenue which is a great impediment to development. What is disconcerting is that tax revenue pegged at ₹67636.68 core in 2021-22 is lower than the budgeted estimate of the previous fiscal (i.e., ₹74649.74 crore).

The Centre's apathy is reflected from the fact that State's share in Union tax is ebbing. It has been pegged at ₹30136.68 crore, lower than the budgeted estimate of previous fiscal (Rs 36299.74 crore) which was further reduced to ₹24549.63 crore in the revised estimate. Further, all states including Odisha are deprived of their due share from the divisible pool as the Centre is collecting around ₹3 to ₹4 lakh crore through cesses and surcharges which doesn't go to the divisible pool.

But what is disconcerting is that the percentage share of Odisha from net proceeds of the central taxes and duties has declined from 5.16 per cent (12th FC) to 4.77 per cent (13th FC) and further to 4.64 per cent in the 14th FC. It has further declined to 4.528 per cent as per 15th FC.

While the Union finance minister presented a Budget having unfettered fiscal profligacy and mounting debt burden despite having the capacity to raise resources Niranjan Pujari remained within the 'Lakshman Rekha' and fiscal prudence is being adhered to. However, revenue surplus and huge amount spent towards debt repayment are unwarranted in the present crisis. Money should have been spent more on creating jobs, providing financial assistance to those who have lost livelihood.

If that makes you lose your appetite, it might also ensure that you don't get too big for your house.

Tiny homes are so popular that IKEA, the Swedish home furniture and décor retailer, has created a Bolo XL model. Among its many features, it boasts a walkaround queen bed. Yes, the home is spacious enough that you can actually walk around your bed!

The Bolo XL is too big to fit on top of an auto-rickshaw, but you can't have everything in life, can you?

Kolkata, March 2: With the stage set for high-octane polls in West Bengal, key stakeholders here asserted that the state, in a departure from the tradition, will be witnessing a communally charged election this time, largely driven by identity politics.

According to data released by the Union home ministry in 2018. communal violence increased sharply since 2015 in West Bengal.

Although opposition parties pinned the blame on the TMC for this surge in religious fervour in the state, which has 30 per cent Muslim electorate, a quick look at Bengal's socio-political history will reflect how communalism has always had an impact on the state's political culture, with hundreds of people having borne the brunt of riots in 1946-47.

Both the Hindu right and fringe Muslim outfits had wielded considerable influence in violence-hit

West Bengal in the aftermath of Partition, before waning considerably over the years. During the first assembly polls in 1952, the Hindu Mahasabha, along with Bharatiya Jana Sangh, had won 13 seats and garnered around eight per cent of the total votes. Later, Jana Sangh's influence ebbed, as it ended up with only one seat in 1967 and 1971. Similarly, Muslim outfits such as

the Progressive Muslim League (PML) and the Indian Union Muslim League (IUML) had established their presence in pockets, with the PML winning three seats in 1969 assembly polls, and IUML bagging a single seat during 1972 and 1977 assembly polls. "Although parties like the IUML, PML and the Bharatiya Jana Sangh managed to bag a few seats till the seventies, poll campaigns did not bank on communal narrative. Development issues and anti-state or anti-Centre plank always took precedence," veteran Congress leader Abdul Mannan Said. During the early sixties, however, the rise of Left parties, which fought for rights of refugees from Bangladesh, ended the consolidation of rightwing forces in the state. Noted Historian Sugata Bose contended that refugees from Bangladesh felt cheated both by the Congress and the Hindu Mahasabha when the country endured Partition. and they took solace in the Left's fold

"Refugees from Bangladesh and Bengali Muslims were more aligned to the Left. Therefore, the communal rhetoric never gained momentum in Bengal," Bose, Gardiner Professor of oceanic history at Harvard University, told PTI.

Cong will bring law to nullify CAA: Priyanka

Tezpur, March 2: Senior Congress leader Priyanka Gandhi Vadra Tuesday asserted that her party, if voted to power in Assam, will bring a new law to "nullify" the Citizenship Amendment Act (CAA) in the state.

Priyanka, during a public meeting in Tezpur, launched the 'Five Guarantees' campaign, and said her party, if given a chance to form government in the northeastern state, will dole out Rs 2,000 every month to homemakers across the state, and provide free electricity up to 200 units to all households.

The All India Congress Committee (AICC) general secretary, who is in poll-bound Assam on a two-day visit, also claimed that her party will hike daily wages of tea garden workers to Rs 365 from the existing Rs 167, and provide at least 25,000 government jobs to youth.

"People of Assam were cheated by a party (BJP) five years ago that promised them 25 lakh jobs but gave them CAA instead. Our party is not making empty promises but undertaking five guarantees," the Congress leader, who sported a traditional 'gamocha' around her neck with the letters CAA crossed out on it, said. At Bishwanath, Vadra slammed the BJP-led government at the Centre for not paying heed to farmers' concerns over the new agricultural laws, and said its policies are designed to benefit only the rich. Interacting with women workers of the Sadharu Tea Estate near Bishwanath, she said farmers have been protesting in and around the national capital for months, but Prime Minister Narendra Modi is vet to meet them and end the im-

Guwahati, March 2: A rights body has approached the Gauhati High Court seeking apposite legal aid for those left out in the Assam's National Register of Citizens (NRC) list, released on August 31, 2019.

The Mumbai based Citizens for Justice and Peace (CJP) after conducting a survey of 10 District Legal Services Authority (DLSA) establishments in Assam filed a petition to the court saying that DLSAs were short-staffed with under-trained para legal volunteers and poor infrastructure. The Supreme Court monitored NRC published lists August 31, 2019, excluding the 19.06 lakh people. A total of 3,11,21,004 names were included in the NRC lists



A majority of those left out from the list are believed to be Bengali Muslims and Hindus besides Gorkhas. CJP secretary Teesta Setalvad said her organisation has been writing letters to the National Legal Services Authority and the Assam State Legal Services Authority (ASLSA) since April last year after the Union Home Ministry's statement August 20, 2019, that legal assistance would be given to those people excluded from the

NRC list, if they need legal support. The ASLSA in November last year said that it has enough machinery to deal with any action taken by the government with regards to NRC and that legal camps would be organised after rejection slips are handed out to the 19.06

were not included in the NRC list. The CJP conducted a study of the functioning of the DLSAs in the 10 districts of Assam's 34 districts and found they have 273 active advocates appointed for legal aid and 333 para legal volunteers whose educational qualifications varied from district to district.

"No training on citizenship, immigration, NRC, Foreigners' Act and related issues was given to the concerned persons in any of these 10 DLSAs. Seven Foreigners' Tribunal (FT) cases were handled by the counsel of the DLSA in 2019 and three in 2020 in Dhubri district, no FT cases appeared to have been dealt with by the counsel of the other nine DLSAs," the CJP said.



The protesting farmers will also block the KMP (Western Peripheral) Expressway March 6 as the antifarm law protest at Delhi borders completes 100 days. The expressway will be blocked at various points for five hours from 11 am March 6, SKM leader Yogendra Yadav said.

He said SKM leaders will hold a public meeting in Kolkata March 12 to appeal to the farmers of pollbound states to punish the BJP.

SKM leader Balbir Singh Rajewal said that SKM teams will visit pollbound states, including West Bengal and Kerala, to appeal to farmers to defeat the BJP. "We will not seek votes for any party. We will appeal to them to vote for those candidates who can defeat the BJP which has

The one side of the road which goes towards Ghaziabad from Delhi was opened for traffic in the morning. Haryana to give 75% quota to state people in pvt jobs

Chandigarh, March 2: Haryana Governor Satyadeo Narain Arya has given assent to the Bill providing 75 per cent reservation in the private sector to job seekers from the state, Chief Minister Manohar Lal Khattar said here Tuesday

The Haryana Assembly had late last year passed the Bill, a key poll promise made by the ruling alliance partner Jannayak Janta

"The Harvana Governor today gave his assent to the Bill entailing 75 per cent reservation in the private sector to job seekers from the state. The government will notify it soon," the CM told reporters at a press conference here.

The Haryana State Employment



of Local Candidates Bill, 2020 provides quota for local people in priof less than ₹50,000 a month.

The quota will initially apply for 10 years, according to the Bill.

Apart from tackling unemployment among local people, the state government said the law will discourage the influx of migrants seeking low-paid jobs, which has a "significant impact" on local infrastructure and leads to the "proliferation of slums".

The Bill covers private companies, societies, trusts and partnership firms in the state. It provides for training to eligible local candidates when qualified people are not available. It defines local candidates as those domiciled in the state. For the domicile status, a person should be born in Haryana or have lived there for at least 15 years.

Giving 75 per cent reserv private sector jobs was a key poll promise by Dushyant Chautala's JJP which is the BJP's coalition partner in the state.

Chautala described the assent given by the Governor as "happiest moment for the youth of Haryana.

"The rules on this new law will be framed soon and published," he said at Faridabad.

Can't use language like 'Tom, Dick, Harry': HC

New Delhi, March 2: The Delhi High Court has expressed displeasure over usage of sentence like "Tom, Dick and Harry" in a petition raising grievance relating to National Company Law Tribunal (NCLT) and said such "slang language" is not permissible in the pleadings before a court of

The high court, which declined to entertain the petition, said it was refraining from imposing costs at this stage since the petitioner was appearing in person.

Justice Prathiba M Singh said the petitioner appeared to have drafted the petition on his own and perusal of a paragraph showed that "there is slang language being used in the petition"

before the court. Accordingly, this petition is liable to be dismissed,' Justice Singh said.

The petitioner, in his plea, has raised a grievance against the NCLT and the National Company Law Appellate Tribunal (NCLAT) alleging that wrong procedures

are being adopted by the said tri-

The high court said if the petitioner was aggrieved by any order of the NCLT or NCLAT, he may draft a proper petition and only then file the same.

"At this stage, the petitioner wishes to withdraw the present petition. The petition is dismissed as withdrawn with liberty to avail of his remedies in accordance with law. Since the petitioner is appearing in person, this court is refraining from imposing costs at this stage," the court said.

Aurangabad, March 2: Ayesha Shaikh, who became the eight croreth beneficiary of the national scheme to provide LPG connections to BPL women and received Ujjwala certificate by Prime Minister Narendra Modi September 2019, is finding it difficult now to pay for a cooking gas cylinder in view of the frequent hike in rates.

Like Shaikh, another beneficiary Mandabai Pable, who hails from Lohgaon in Aurangabad district of Maharashtra, is also struggling to buy the cylinder for cooking gas.

Videos of Shaikh and Pable using firewood for earthen stoves in their respective kitchens are being aired by a Marathi news channel they spoke to.

The cost of an LPG cylinder has exceeded my room rent now. I pay ₹600 in rent whereas the price of the cooking gas cylinder has crossed ₹700. What should we do? Should



we pay for the gas cylinder or take care of the household expenses Shaikh asked in anguish while

speaking to ABP Maza. Shaikh, a daily wager and the mother of five, is a resident of Indiranagar in Ajanta village of Aurangabad district

For Shaikh, the new gas connection had proved to be a boon as it spared her the labour of gathering firewood for her earthen stove. She had also started spending some more time with her children.

However, the frequent hike in the rates of cooking gas seems too much for Shaikh.

Monday, cooking LPG price was hiked by ₹25 per cylinder across all categories, including subsidised fuel and those availed by Ujjwala scheme beneficiaries - the fourth

increase in rates in a month's time. LPG prices have gone up by ₹125 per 14.2-kg cylinder since the beginning of February, as per price data from state-owned oil marketing companies.

A 14.2-kg cooking gas cylinder now costs ₹828 in Aurangabad while the rate of a 19-kg commercial gas cylinder is ₹1,642, a gas agency official said.

We had received the new gas

connection for free. But the gas was free only for the namesake. After using the cylinder for a month, we failed to refill it. After one month, we compromised on our room rent and somehow managed to buy the gas cylinder, Shaikh said. She said her room owner asked her family members to vacate. as they failed to pay the monthly rent.

We then stayed at our sister's place, she added.



9 get life term for double murder

ALL PRIVATE HOSPS PERMITTED TO GIVE **COVID VAX: CENTRE**

The Centre urged the states and the UTs to ensure adequate allocation of COVID vaccines to all hospitals, government as well as private, for the entire duration for which vaccination sessions have been planned

New Delhi, March 2: The Centre Tuesday permitted all private hospitals to give COVID vaccine if they adhere to the laid down norms and also asked the states and union territories to utilise the optimum capacity of private medical facilities empanelled under three categories.

The states and Union territories were also urged not to store, reserve, conserve or create a buffer stock of the COVID-19 vaccines, the Union Health ministry said in a statement, a day after the start of the second phase of India's inoculation drive in which the coverage has been expanded to include everyone above 60 and those over 45 with specified co-morbidities.

At an official review meeting with the states, the Centre reiterated there is no shortage of the vaccines and hence, adequate vaccine doses should be allocated to the COVID Vaccination Centres(CVCs)

'The central government has adequate stock and will provide the required vaccine doses to the states and UTs," it said.

It asked them to utilise the optimum capacity of all private hospitals empanelled under the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), the Central Government Health Scheme (CGHS) and the state health insurance schemes to enable them to effectively function as CVCs.

The states and UTs were asked to regularly collaborate with the private hospitals to ensure that their optimum capacity for vaccination is utilised. "Private hospitals not



tioned three categories have also been permitted to operate as CVCs if they have adequate number of vaccinators, adequate space for observation of the vaccinated, adequate cold chain arrangement and adequate arrangement for management of Adverse Events Following Immunisation(AEFI)," the statement said

In addition to all the government health facilities, all private hospitals empanelled under the CGHS, the AB-PMJAY and the state health insurance schemes can function as CVCs, subject to them mandatorily adhering to certain norms, the statement said

All private vaccination centres should have effective crowd management protocols in place, along with facilities for seating, water, proper signage etc.

They should also ensure adherence to a COVID-appropriate behaviour among the beneficiaries. The state and district administrations would proactively facilitate

BJP sweeps local body elections in Guj

Ahmedabad, March 2: The ruling BJP recorded a massive victory in the local body polls in Gujarat Tuesday by winning clear majority in all 31 district panchayats as well as in 196 out of 231 taluka panchayats and 74 out of 81 munici-

The Congress, the main opposition party in the state, won a clear majority in only one municipality and 18 taluka panchayats, while AIMIM and AAP also made their presence felt. In six municipalities and 15 taluka panchayats no party has got clear majority. The BJP's success followed its victory in all six municipal corporations where polls were held in the first phase of local elections February 21.In the second phase where polling was held for district and taluka

panchayats as well as municipalities February 28, the BJP again left the Congress far behind by winning 6,236 out of 8,470 seats for which results were declared. The position was not yet clear on four remaining seats. The Congress could win 1.805

seats, while the new entrants Aam Aadmi Paty (AAP) and All India Majlis-e-Ittehadul Muslimeen (AIMIM) won 42 and 17 seats, respectively. Asaduddin Owaisi's AIMIM won nine seats in Modasa municipality in Aravalli district, one in Bharuch, and seven in Godhra in Panchmahal.The AAP won 31 seats in taluka panchayat, two in district panchayat and nine in municipality bodies.

The dairy farmers have also announced that from March 6, they will sell milk at Rs 100 per litre. At present, their supply is sold at Rs 35 per litre. State president of Bharativa Kisan Union (BKU) youth wing, Digambar Singh, said, 'We have not invoked the farmers to stop the milk sale. Farmers are doing so of their own to protest against farm law. Agitation is not confined to us, it has reached ground level and is now getting support from other farmers and common man too." According to reports, Monday, dairy farmers of three villages -- Rasulpur Mafi, Chuchaila Khurd, and Shahzadpur in Amroha district -- put their milk vessels upside down refusing to supply milk to cooperative societies. The tankers of the societies returned empty.

According to Dinesh Kumar, a dairy farmer, "We are doing this to show solidarity with our brothers who are sitting on the Ghazipur border protesting against the farm laws. We fully support them and shutting down the milk supply is our way of protesting.'

to weaken the Congress". The protest against Azad came days after a rally addressed by some "G-23" leaders, ostensibly to felicitate the former Jammu and Kashmir chief minister on his retirement from the Rajya Sabha. It was seen as a show of strength to convey a message to the Congress leadership.

The group of 23 leaders wrote to interim party president Sonia Gandhi in August last year, urging her to ensure a "full-time" and "visible" leadership. The group has since come to be known as the "G-23". Chief spokesperson of the Jammu and Kashmir Congress Ravinder Sharma said the party had no prior knowledge of the two protests in the city and will do

a protest against Choudhary and whatever necessary in its interest. Raising slogans in support of Azad, Chopra said, "Azad is a Congressman by heart and does not need a certificate from anyone. He strongly raised the issue of Jammu and Kashmir in Parliament to disapprove of the August 5, 2019 development (when the Centre revoked the erstwhile state's special status and bifurcated it into Union territories) and his long innings in the service of the nation drew praises

About 5K Indians stalking their partners via mobile spyware

STALKERWARE APPS ARE GENERALLY DISGUISED UNDER A FAKE APP NAME WITH SUSPICIOUS ACCESS TO MESSAGES, CALL LOGS, LOCATION, **AND OTHER PERSONAL ACTIVITY**

New Delhi, March 2: As some people try to digitally control the lives of their intimate partners, nearly 4,627 mobile users in India have been found to be the victim of stalkerware -- a secret surveillance software used in the field of domestic violence, a new report revealed on Tuesday. This figure would have had been much higher in absence of lockdowns and the pandemic that led millions stay indoors in the country.

Stalkerware apps are generally disguised under a fake app name with suspicious access to messages, call logs, location, and other personal

For example, an app called "Wi-Fi" that has access to your geolocation is a suspicious candidate, according to cyber security firm Kaspersky. "We see the number of users affected by stalkerware has remained high and we detect new samples every day. It's important to remember that there is somebody's real life story behind all these numbers, and sometimes there is a silent call for help," said Victor Chebyshev, Research Development Team Lead, Kaspersky. "It is clear that we all need to share what we are finding so we can further improve detection and protection for



the benefit of those affected by cyberviolence," comments Victor Chebyshev, Research Development Team Lead, Kaspersky

Stalkerware is a form of cyberviolence, and a global phenomenon that affects countries regardless of size, society, or culture.

In 2020, a total of 53,870 mobile users were affected globally by stalkerware. In 2019, Kaspersky discovered 67,500 affected mobile

users. "It is unsurprising that the yearly curve of users affected by stalkerware globally shows a decline in reports from March to June 2020, before numbers began to stabilise thereafter. This coincides with the beginning of worldwide lockdowns, and later when many countries around the world began to ease restrictions," the report mentioned.

Mobile users can check if their mobile device has stalkerware installed. "Delete apps that are no longer being used. If the app has not been opened in a month or more, it is probably safe to assume it is no longer needed; and if this changes in the future, it can always be reinstalled," the report mentioned. Check "unknown sources" settings on Android devices. If "unknown sources" are enabled on your device, it might be a sign that unwanted software was installed from a third-party source.

"To download stalkerware, the abuser will have to visit some web pages the affected user does not know about. Alternatively, there could be no history at all if the abuser wiped it." it added. Do not rush to remove stalkerware if found on the device as the abuser may notice. "It is very important to consider that the abuser may be a potential safety risk. In some cases, the person may escalate his abusive behaviour in response", the company suggested.

In 2019, Kaspersky co-founded, along with nine other organisations, the 'Coalition Against Stalkerware' which now has 30 members from five continents.

In November last year, the company released a free antistalkerware tool called TinyCheck in order to help nonprofit organisations support victims of domestic violence and protect their privacy.

China's electoral reform set to upend HK politics 'systemic' racism

Hong Kong, March 2: China's plan to dramatically reform Hong Kong's electoral system, expected to be unveiled in a parliamentary session in Beijing starting this week, will upend the territory's political scene, according to more than a dozen politicians from across the spectrum.

The proposed reform will put further pressure on pro-democracy activists, who are already the subject of a crackdown on dissent, and has ruffled the feathers of some pro-Beijing loyalists, some of whom may find themselves swept aside by a new and ambitious crop of loyalists, the people said. "It will be an earthquake shaking up local political interests," said one person briefed on the impending changes.

The measures will be introduced at the annual meeting of the National People's Congress, China's rubberstamp parliament, which starts Friday according to media reports.

The plan was signalled last week by senior Chinese official Xia Baolong, who said Beijing would introduce systemic changes to only allow what he called "patriots" to hold public office in Hong Kong.

In a full transcript of his remarks published this week by the pro-Beijing Bauhinia Magazine, Xia said Hong Kong's electoral system had to be "designed" to fit with the city's situation and shut out what he called non-patriots, some of whom he described as "anti-China agitators" that would bring destruction and terror to the city - a reference to pro-democracy campaigners who took to the streets in sometimes violent demonstrations

Xia did not announce any specifics,

Biden admin 'undecided' on ending H-1B visa ban

Washington, March 2: The Biden administration has indicated that it is still undecided on ending the Trump-era ban on issuing new H-1B visas, with the Homeland Security Secretary Alejandro Mayorkas asserting that the US government's top priority is the acute needs of individuals fleeing persecution.



The H-1B visa, the most sought after among Indian IT professionals, is a non-immigrant visa that allows US companies to employ foreign workers in specialty occupations that require theoretical or technical expertise.

Technology companies depend

on it to hire tens of thousands of employees each year from countries like India and China.

In January, then-Pres Donald Trump had extended the ban on issuing new H-1B visas till March 31, arguing that the country is having a very high unemployment rate and the US cannot afford to have more foreign workers.

"His successor President Joe Biden has revoked dozens of the executive orders of Trump including several of those related to immigration like the lifting the Muslim visa ban or those related to Green Card, the one that imposed ban on issuing H-1B has still not been lifted. It will expire on March 31, if Biden does not issue a fresh procla-



Copenhagen, March 2: In the tenth century, Erik the Red, a Viking from Iceland, was so impressed with the vegetation on another Arctic island he had found he called it "the green land." Today, it's Greenland's rocks that are attracting outsiders - superpowers riding a

green revolution. The world's biggest island has huge resources of metals known as 'rare earths,' used to create compact, super-strong magnets which help power equipment such as wind turbines, electric vehicles, combat aircraft and weapons systems.

The metals are abundant globally, but processing them is difficult and dirty - so much so that the United States, which used to dominate production, surrendered that position to China about 20 years ago.

Geological Survey (USGS) calls the

world's biggest undeveloped deposits of rare earth metals.

China produced about 90% of them, according to Toronto-based consultancy Adamas Intelligence. As US-China tensions mount, President Joe Biden's administration said last month it will review key US supplies, including rare earths, to ensure other countries cannot weaponise them against the United States.

Each Greenland mine would cost about \$500 million to develop, the companies say. Both plan to send mined material away for final processing, an activity that is heavily concentrated in China. The only rare earth mine now operating in the United States - Mountain Pass in California - is partly owned by a Chinese state-backed company that currently sends material mined in the US to China for processing.

The Greenland sites are less than 16 km from each other at the southern tip of the island.

Imports grew 6.98% to \$40.55 billion during the month, the data showed. The trade deficit stood at \$10.16 billion in February 2020.


Exports during April-February 2020-21 were \$255.92 billion compared with \$291.87 billion during the same period of last year, exhibiting a negative growth of 12.32%.

Spectrum auction ends; Jio becomes top buyer

New Delhi, March 2: Billionaire Mukesh Ambani's Jio cornered more than half of the telecom spectrum auctioned by the government over the past two days, offering about ₹57,123 crore to consolidate its holding of the scarce resource that are used to carry mobile call and data signals.

Telecom giant Bharti Airtel bid ₹18,699 crore to pick up 355.45 megahertz (MHz) out of the 855.60 MHz of radiofrequency, giving it "most formidable" spectrum holding in the

Vodafone Idea Ltd, which is facing a huge liability of unpaid statutory dues of past, bought spectrum worth ₹1,993.40 crore, Telecom Secretary Anshu Prakash told reporters here.

In all, some 60 per cent of the spectrum offered was sold, according to Prakash, who said the bids came at the floor price - or minimum price that was acceptable to the government. In the first auction of radio airwayes in five years, the government offered 2,308.80 MHz of spectrum in seven bands, at a reserve price of nearly ₹4 lakh crore. However, airwaves in the premium 700 MHz and 2,500 MHz bands went

The telecom secretary said 855.60 MHz of spectrum was bought for



₹77,814.80 crore in the two-day auc tion. Spectrum refers to the radio frequencies allocated to the mobile industry and other sectors for communication over the airwaves. This includes FM or AM radio broadcasts and even other wireless forms of communication like Bluetooth and Wi-Fi.

Mobile phones also use these same radio waves to transmit voice calls and data. These frequencies come in different bands, supporting specific technologies as well as governing speed of transmission. While AM or FM radio channels are all spread around 100MHz 200MHz, telecom spectrum starts from a higher frequency. The quantum of spectrum in each band too is measured in MHz.

Reliance Jio Infocomm Ltd said it acquired the right to use spectrum in all the 22 circles or zones across India. In all, it won 488.35 MHz of spectrum, taking up its spectrum footprint by 55 per cent to 1,717 MHz (uplink + downlink).

India woos Tesla by offering cheaper production costs

New Delhi, March 2: India is ready to offer incentives to ensure Tesla Inc's cost of production would be less than in China if the carmaker commits to making its electric vehicles in the south Asian country, transport minister Nitin Gadkari told

Gadkari's pitch comes weeks after billionaire Elon Musk's Tesla registered a company in India in a step towards entering the country, possibly as soon as mid-2021. Sources familiar with the matter have said Tesla plans to start by importing and selling its Model 3 electric sedan

'Rather than assembling (the cars) in India they should make the entire product in the country by hiring local vendors. Then we can

give higher concessions," Gadkari said in an interview, without giving details of what incentives would be on offer.

The government will make sure the production cost for Tesla will be the lowest when compared with the world, even China, when they start manufacturing their cars in India. We will assure that," he said.

India wants to boost local manufacturing of electric vehicles (EVs), batteries and other components to cut costly imports and curb pollution in its major cities. This comes amid a global race by carmakers to jump-start EV production as countries work towards cutting carbon emissions

But India faces a big challenge to win a production commitment from Tesla, which did not immediately respond to an email requesting



comment about its plans in the India's fledgling EV market ac-

frastructure and the high cost of EVs deterred buyers.

In contrast, China, where Tesla already makes cars, sold 1.25 million new energy passenger vehicles, including EVs, in 2020 out of total sales of 20 million, and accounted for more than a third of Tesla's global sales.

India also doesn't have a com-

prehensive EV policy like China, the world's biggest auto market, which mandates companies to invest in the sector.

Gadkari said that as well as being a big market, India could be an export hub, especially with about 80% of components for lithium-ion batteries being made locally now.

"I think it's a win-win situation for Tesla," Gadkari said, adding he also wanted to engage with Tesla about building an ultra high-speed hyperloop between Delhi and Mumbai.

4TH TEST PITCH WILL **BE TURNER: RAHANE**

Vice-captain slams critics of Indian pitches saying Team India never complain of damp wickets abroad

Ahmedabad, March 2: India's Test vice-captain Ajinkya Rahane on Tuesday said there is no need to take criticism of the spin-friendly pitches in the country 'seriously' as not a word is spoken about the 'damp' tracks elsewhere and England can expect another turner in the fourth Test.

There has been a lot of talk about the spinning tracks in the second Test at Chepauk and the pink ball game at Motera which ended inside two days. The fourth and final Test starts March 4.

"I think the wicket will be similar to the second Test match in Chennai, spinning track. Yes, pink ball made the difference and it came much quicker off the wicket compared to red ball and we had to make adjustments," Rahane said during a virtual media conference here. "Wicket will be a lot similar to last two Test matches." he added.

Rahane, for the first time in many years, shed his reticence when asked to respond to the criticism from former England players that the pitches have not been ideal. Some have even urged the ICC to act against India for preparing a turner.

"See, let people speak what they want to. The wickets, when we tour abroad, no one speaks about how seaming they are. They always sneak about the technique of the Indian batsmen, I don't feel we need to take seriously what people say, Rahane was sharp in his response.

'You see, when we tour abroad, the first day wicket is damp. When wicket becomes grassy and behaves up and down, then the pitch becomes dangerous but we haven't complained about it or we have



never spoken about it."

On spinning tracks, it's imperative to play the line, Rahane said. 'When you play on spinning tracks, you have to play the line. If ball is spinning too much, you don't have think too much.

While playing the line, the footwork plays a more significant role and how to use that is an individual batsman's choice.

"Everyone's game is different. One player may love to come on front-foot while others like to stay on the back-foot but either way, it is important to use your footwork. trust your defence on a track that offers turn," he explained.

Also another key aspect is communication between a player who has just come in and one who has been batting for some time.

When a new batsman comes to the crease, the communication between the two batters is important-like how the pitch is behav-

ing, how much turn on offer, which kind of game is suited, all these points are important. Yes, spinning track was a challenge but we overcame it well.

Despite the humiliation that India inflicted on England in the third Test, Rahane was respectful of England's chances on another turner. "Pitch looks similar but I don't know how it's going to play. We have to wait and see," he said.

"We respect the England team. They are a very good team. We played good cricket in last two Tests and England played really well in the first game. We are not taking them lightly, and both teams will go out there and look to give their best to win the Test match," he said.

He also hinted that veteran pacer Umesh Yadav might get a look in. "Umesh is ready to go. Looking good and had a good session at the nets. We are really happy that he is back." Rahane said
