BJP MP found dead at home



Bhubaneswar, March 17: The stalemate continued in the Odisha Legislative Assembly for the fifth successive day Wednesday over the suicide attempt by a BJP lawmaker Subash Panigrahi and alleged mismanagement in paddy procurement.

Soon after the House assembled for the day, BJP and ruling BJD members stormed into the well and created noisy scenes. Congress and BJP members demonstrated displaying banners over mismanagement in paddy procurement. On the other hand, BJD MLAs demanded apology from Panigrahi.

Speaker Surya Narayan Patro, who was unable to transact any business, adjourned the House first till 12.00 noon and later till the postlunch session. Both Opposition and Treasury bench members continued to disturb the proceedings in the second half also.

Later, Patro said that members off all parties had suggestions to offer to end the continuing impasse. However, no logical conclusion could be reached. He informed that another all-party meeting will be held Thursday.

Meanwhile, BJD lawmakers walked to the Raj Bhawan and submitted a memorandum to Governor Ganeshi Lal over the suicide attempt made by Panigrahi last Friday.

Mumbai top cop shunted for hand in Ambani fiasco

Mumbai, March 17: Under fire over the handling of the bomb scare outside industrialist Mukesh Ambani's house here, the Maharashtra government transferred Wednesday, Mumbai Police Commissioner Param Bir Singh to the low-key Home Guard section. Senior IPS officer Hemant Nagrale, holding additional charge of the state's DGP post, will be the new Mumbai Police Commissioner, Home Minister Anil Deshmukh

Singh's transfer came even as the case of recovery of gelatin sticks near Ambani's residence turned murkier with the National Investigation Agency (NIA) claiming there were 'other players' who had been allegedly instructing arrested policeman Sachin Vaze. NIA sources said the case had virtually been cracked and soon the 'entire conspiracy' behind would be unravelled.

"Big decision of the government. Shri Hemant Nagrale will be the new Mumbai Police chief, Deshmukh said in a tweet.

The Maha Vikas Aghadi (MVA) government's decision to transfer Singh follows a series of meetings among the ruling Shiv Sena-NCP-Congress alliance leaders.

Singh's transfer follows Tuesday's talks between Thackeray and NCP chief Sharad Pawar. Sources said the latter wanted Singh to be transferred.

COVID-19 THREATENS AGAIN

India records highest daily spike since Dec

New Delhi, March 17: India registered its highest daily tally of coronavirus cases this year with 28,903 new infections in the last 24 hours. The new infections took the total COVID-19 tally to 1,14,38,734, according to the Union Health Ministry data updated Wednesday. The death toll increased to 1,59,044 with 188 new fatalities, the highest in around two months, the data stated. The last time when more than 28,000 new infections were registered was December 13, last year. On that date, 30,254 new cases were reported.

The number of people who have recuperated from the disease surged to 1.10.45.284, while the case fatality rate dropped to 1.39 per cent, the data stated. The 188 new fatalities include 87 from Maharashtra, 38 from Punjab, 15 from Kerala and 12 from Chhattisgarh.

The Health Ministry also said that five states -Maharashtra, Punjab,

Karnataka, Gujarat and Tamil Nadu account for 71 10 per cent of the new infections. The sixth state with the highest number of infections is Kerala. However, it has been reporting a consistently declining trend over the last month. With Kerala added to the list, the six states account for 83.91 per cent of the new cases, the ministry said.

Maharashtra reported 17,864 new cases in the last 24 hours. It is followed by Kerala (1,970) and Punjab (1,463), the ministry







Treat scribes as frontline workers: State to Centre

Bhubaneswar, March 17: The state government, Wednesday, urged the Centre to include some more categories of people who were engaged in ensuring essential services and Covid-19 surveillance & containment as frontline workers (FLWs) for Covid-19 vaccination.

In a letter to Ministry of Health & Family Welfare, state H&FW department Additional Chief Secretary PK Mohapatra stated that government officials who were engaged in Covid-19 surveillance and containment measures are being vaccinated as FLWs in Odisha since February 2021.

However, many categories of persons who are at risk of exposure to infection due to the nature of their work have not been included as frontline workers. These categories included journalists and personnel of the print and electronic media, staff engaged in maintenance of essential services, members engaged at airports, railway stations and port, and servitors of Jagannath and Lingaraj temples. "I request you to kindly consider the above categories for Covid vaccination on priority and communicate necessary approval at an early read," the letter said.

Bypoll: Pipli to have 348 booths to keep Covid at bay

Bhubaneswar, March 17: As some parts of India are experiencing a second wave of Covid-19, the office of the State Chief Electoral Officer (CEO) announced Wednesday an increase in the number of booths in the poll-bound Pipli constituency to ensure social distancing.

Odisha CEO Sushil Kumar Lohani said at a presser here that Pipli bypolls will be conducted with strict adherence to the Covid-19 norms. "We have increased the number of polling booths for Pipli bypolls. Last time voting was done in 271

will be increased to 348. We will also ensure the presence of not more than 1,000 voters at one polling station. Suspected Covid-19 patients will be provided tokens and they will cast their votes in the last two hours," said Lohani. "All voters will be thermally screened before they enter the booth," Lohani added. Lohani also stated elderly people can avail of postal ballots. "Those above 80 years, differently-abled and Covid-19 patients and suspects can opt for postal ballots,' he informed. Lohani also said

Swain seeks Goyal's intervention in paddy row

Bhubaneswar, March 17: State Food Supplies and Consumer Welfare Minister Ranendra Pratap Swain wrote to Union Consumer Welfare, Food and Public Distribution Minister Piyush Goyal seeking his intervention in issues pertaining to paddy procurement in Odisha.

In his letter, Swain cited the extreme shortage of funds at the Odisha State Civil Supplies Corporation (OSCSC) and slow evacuation of grains from Food Corporation of India (FCI) godowns which have reportedly affected the paddy procurement process in the state.

"Odisha is expected to have a surplus of 30 lakh MT rice which needs to be evacuated by FCI in the current kharif season. The FCI has so far evacuated only 6.80 lakh MT of rice from Odisha. For the current month, FCI, Odisha Region has received an extremely low quantity movement plan for evacuation from the state, Swain said.

He also said that such slow pace can lead to lesser evacuation of expected quantum of rice from the state as set by the government.

Procurement from open market or private dealers will only be permitted when the concerned ULBs will be unable to cater to demands. The exception will also take into account the communication period by the ULBs and the department allowing a reasonable

It can be mentioned that the ULBs are processing solid waste in a decentralised manner vis a vis micro composting centres (MCCs) and materials recovery facilities (MRF). Parvo, the pup killer

n 1987, a street litter of a month old puppies, being fed by me, started dying at an alarming rate. The splotches of blood in their stool were diagnosed A as parasitic worms. The ill-informed vet immediately gave them deworming tablets (which is a poison) and there was a rapid decline. All the pups died within 3 days, consumed by severe gastroenteritic haemorrhaging. The killer was the deadly Canine Parvo Virus (CPV).

First recognised in the 1970s, CPV is now in epidemic form. Outbreaks have been reported from all over India. Thousands of pups have died. Since government refuses to give the vaccine and government hospitals do not treat parvo cases, the animal welfare shelters are full and the mortality of these young pups crowded together is extremely high. Animal feeders simply do not have the money to give vaccines to the pups and we all stand by helplessly as they die. In a normal year only one street pup survives a litter. The rest are run over, die of starvation, poisoned or thrown away in plastic bags. This year, even that one is unlikely. A majority of pups sold by pet shops and dog breeders have parvo. There are two reasons: the puppy has been taken away from its mother at 3 weeks of age, by breeders and sellers, to supply customers who want really small pups. If it had been nursed by the mother the pup would have developed an immunity, which would have helped his little body fight off the virus. No pet shops vaccinate puppies, and they put pups from different breeders into one cage. The dogs are bred in slummy filthy conditions. The dogs, being bred at the breeding establishments, have low immunity due to constant abuse and minimal nourishment and, are the first victims of CPV. Typically, buyers write to me when they go to get a refund and are refused, because the entire puppy trade is illegal and done in cash with no receipts.

There are two prominent strains of the canine parvovirus (CPV-2a and CPV-2b) from the genus family of Parvoviridae. It spreads through infected faeces, vomit, blood, touch, surfaces, clothing etc. Shelters, kennels, clinics,

public parks are prime locations where the virus lurks. Its favourite victim is the young pup, but unvaccinated dogs in general are vulnerable. Undetected, or diagnosed at a later stage, it is almost always fatal within 48-72 hours.

Parvo virus attacks the cells in the small intestine, making the intestinal wall vulnerable to bacteria in the center of the gut. The bacteria cross over into the blood stream leading to sepsis which causes organ failure. Parvo also attacks the bone marrow, causing dangerously low white blood cell counts. This denies the body the one thing it needs to fight off the sepsis. Parvovirus is extremely contagious. It takes 10-14 days to show symptoms after contraction. The basic clinical signs of CPV are fever or low body temperature (hypothermia), appearance of blood in vomit and stool, abdominal pain, nausea, dehydration and lethargy. Persistent vomiting

and diarrhoea cause rapid dehydration, and damage to the intestines and immune system cause septic shock.

Parvo kills by dehydration and exhaustion, as the constant attack on the intestinal tract pushes out water and electrolytes before they can be absorbed, and the vomiting and diarrhoea keep the dog from getting any rest.

This is what you need to do if you have a pup with parvo:

Parvovirus causes life threatening dehydration and anaemia. They are basically bleeding out internally while also losing the fluids/nutrients they desperately need to fight it off.

Rush to a vet. The only thing your vet can do to treat this virus is to give IV fluids (50 ml twice a day), antivomiting and antidiarrhoea medications, often along with a sedative to buy their immune system time to fight the virus, and antibiotics to fight secondary infections. The fluid therapy can be Loparamide, Metronidazole augmented with antibiotics Cefotoxin, Cefazolin, Ampicillin, Gentamycin, Tamiflu

Home treatment, of pushing fluids and feeding nutritional broths, isn't always enough in one so young. It only takes a day or two for a 9-week-old puppy to become fatally dehydrated. Gently pull the pup's loose skin between and behind the ears on the neck and release. If the scruff falls back into its normal position within a second, he's not dehydrated and treatment is going well, so far. If it takes two or three seconds to fall back into place, he's starting to become dehydrated, the longer it takes the more dehydrated he is. If the scruff doesn't fall back into place, even after a few seconds, you have a life or death situation on your hands. His gums will be pale as well. He needs intravenous fluids and electrolytes, and FAST!

If there are absolutely no vets, or even compounders, who know how to give an intravenous injection, do this: Hydration is what may help to keep your pup alive. Focus on it. Keep your pup warm and give fluids every half hour. If he won't drink on his own, you'll have to syringe feed the fluids. Don't give plain water as he needs electrolytes to continue his survival, and pushing straight water can decrease his survival chances by flushing out the electrolytes he already has. Give clear Pedialyte. He will also need calories to fight the infection. If he can tolerate it, you can give chicken or vegetable broth with a bit of added salt (sodium will help him to retain water) mixed with a bit of puppy milk replacer (NOT COW MILK). Mix the milk to broth in a 1:3 ratio. Too much milk will also increase diarrhoea. But he needs those calories. Kaopectate can be given for diarrhoea. It usually goes by weight (mg per kg). He may also need subcutaneous fluids, which is sterile saline injected just under the skin and which can be absorbed through the microscopic vascular system, bypassing the digestive tract. Find a human doctor who may be able to help with this.

Someone has suggested that you give the pup boiled and finely mashed egg volk once a day, and increase the amount slowly. Avoid water for an hour after feeding. Don't give egg white or else the pup will vomit. Days three to six are usually the most touch and go. If you can help him past that, he is on the road to recovery. When the dog stops retching bile he is probably improving. The lack of blood in his stool is another marker. His activity level will go up. However, recovery from parvo takes weeks. If the pup survives, most will need to eat small, frequent meals of a bland diet and continue taking anti-nausea medications until they are able to hold down their normal food (usually a week or two). Give your dog the full course of any antibiotics that have been prescribed, even if he or she appears to be back to normal. A CPV survivor will continue to shed the virus for weeks, even months. This is why strict isolation of infected animals, and quarantine wards at veterinary hospitals/clinics and animal shelters, is important. It can live in the ground for more than six months.

Shelters, clinics and houses with CPV patients must maintain strict hygiene protocols to prevent cross contamination. Shelters and clinics must necessarily have isolation kennels.

If you are feeding a litter of street pups, stay vigilant for appearance of any parvo-related symptoms. Wash hands after handling a CPV patient, keeping it away from other dogs/pups.

The golden rule for combating the disease is timely and regular vaccination. Puppies need at minimum three Parvo vaccines given at 3-4 week intervals, between 6 and 16 weeks of age. Some veterinarians use variations on this protocol.

In the case of unvaccinated dogs, 2 vaccination shots are recommended (first dose followed by a booster after a month). For vaccinated dogs, an annual booster vaccine is sufficient.

RATINGS AGENCIES DO NOT BEAR APPROPRIATE RESPONSIBILITY **FOR THE ENORMOUS POWER THEY WIELD**

n March 10, the creditrating agency Moody's placed Ethiopia on review for a downgrade The problem isn't violence and repression in Ethiopia's embattled Tigray region. Rather, Moody's has concluded that the Ethiopian government's commitment to engage with private creditors, as part of the G20 Common Framework for Debt Treatments beyond the Debt Service Suspension Initiative, raises the risk that those creditors will incur losses. For that, the country ap-Whereas the DSSI aims to pro-

vide immediate relief to low-income countries during the pandemic, the Common Framework was designed to help debt-distressed sovereigns reschedule or reduce their liabilities. For many countries, it offers the best chance of making their debt burdens sustainable. But now, the threat of ratings downgrades is casting a shadow over these countries' prospects.

This points to a systemic problem in international finance: the extraordinary - and undeserved power wielded by a few private credit-rating agencies. Just three Moody's, S&P Global Ratings, and Fitch Ratings – control more than 94 per cent of outstanding credit ratings. And there is significant cross-shareholding among them.

These oligopolistic firms are market movers and makers, influencing financial portfolio allocations, the pricing of debt and other financial instruments, and the cost of capital. Bolstering their authority, the US Securities and Exchange Commission has recognised them as official statistical rating organisations. And many institutional investors, required by law to hold only "investmentgrade" assets in their portfolios, must abide by the rating agencies' verdicts.

Concerns about ratings agencies were first widely expressed during the Enron scandal in 2001. Enron, an energy-trading company, had been using accounting tricks and

complex financial instruments to mislead investors, creditors, and regulators about its value. The ratings agencies were certainly fooled: The Big Three all issued Enron investment-grade ratings just days before the company collapsed.

Credit-rating agencies have also been accused of enabling the United States' subprime-mortgage bubble, which triggered the global financial crisis when it burst in 2008, and of exacerbating the bust through rapid reversals and downgrades. And they have been known to adjust ratings in ways that seem to reflect ideological positions, such as a commitment to fiscal austerity

And yet, as Yuefen Li, the United Nations Independent Expert on Foreign Debt and Human Rights, points out in a new report, ratings agencies face no accountability for their mistakes or damaging behaviour. Their ratings are legally described as "opinions," which are protected under freespeech laws, and they do not disclose their methodology. In short, ratings agencies do not bear appropriate responsibility for the enormous power they wield.

Moreover, as Li also notes, conflicts of interest abound. Ratings agencies are private businesses. funded largely by the institutions they rate. And they are players in the markets they purportedly assess, meaning that self-interest inevitably shapes their decisionmaking. Ratings agencies have for example, been involved in the creation of financial products that they were then responsible for rating - including the mortgage backed securities that, flush with AAA ratings, helped bring about the 2008 crisis.

And yet, even as regulators work to limit conflicts of interest among most financial-market players, they seem content to leave creditrating agencies to police themselves. The lack of regulatory action partly reflects the lobbying power of the Big Three. And it is generating serious risks, which the coronavirus pandemic has intensified.

For example, procyclicality in rating – another issue Li highlights in her report – is making financial-market conditions inhospitable for developing countries whose economic prospects have been undermined by the COVID-

19 crisis. Furthermore, the threat of a ratings downgrade is preventing many governments from pursuing sufficient fiscal expenditure. Now, with the latest move from Moody's, developing-country governments must fear entering into debt-restructuring negotiations with private creditors, even as part of multilateral programmes aimed at providing debt relief.

If the G20 countries are serious about improving developing countries' debt positions during the COVID-19 crisis, they should begin by supporting the temporary suspension of credit ratings. In the medium term, regulators must take action to ensure that rating agencies are fulfilling their intended market-stabilising role. Tackling conflicts of interest such as by limiting agencies' dependence on payments from those they rate – is essential.

But regulating private ratings agencies may not be enough. The UN Conference on Trade and Development has long argued that the world needs an independent public ratings agency to conduct objective evaluations of the creditworthiness of sovereigns and companies. Such an agency is also necessary to assess the instruments used to finance new public investment, which will be in high demand in the coming years.

A global agency makes sense, be cause credit ratings, especially for sovereign debt, are international in scope. Perhaps more important, it would provide a muchneeded counterbalance to unaccountable private agencies. It might even force the Big Three to embrace reforms that they have long resisted.

This not only points out why its privacy policy does not attest to the same as also how an individual's right to data protection and privacy right cannot be compromised even whilst communicating with a business account. Experts feel WhatsApp's move to delay the implementation of its updated privacy policy by three months is not sufficient to alleviate the concerns raised by the plan or the larger issue of data sharing and privacy breach.

millions shifting to alternate messaging apps, Facebook-owned WhatsApp is reaching out to users reiterating that it is committed to protecting users' privacy as it does not access or read anyone's messages or location. But then, why is the company not providing relevant options for those who do not wish to provide such information?

All of this data is stored and leveraged by companies to better target advertising to their users. Sometimes, companies share users' data with third-party entities, often without

ocial networking has elevated alarm about the safety of user data platform that is open-source, enusers' knowledge or consent.

What are social media users wortified? Typically, these concerns stem from the ubiquitous presence of social media in people's lives. Forty-five per cent of the world's population use social networks. These connections can leave users vulnerable in several ways. When personal information falls into the wrong hands, the consequences can be damaging. Different types of frauds, hacking, spyware, malware etc. have been in practice for capturing private data of user(s). Such hacks can result in stolen information and forced shares that redirect followers to malware, among other things. With the advent of new approaches in web technologies, connectivity of heterogeneous devices and sharing of data among them may cause new dimensions of privacy risks along with safety and security aspects. Social networking is actually a need of the time, where its usage needs a responsible behaviour. It is the user, who is solely responsible for his data and the user himself has to take strong measures for the protection of privacy.

Save elephants

Sir, Elephant was accorded the 'National Heritage Animal' status in 2010. Many projects are in place in India to save the magnificent creature from extinction. The number of elephants in the country, as per the 2017 data, stands at 29,964. But these numbers do not reflect the stark reality: between 2014 and 2019 as many as 23,000 elephants were killed in India. Odisha's Karlapat wildlife sanctuary in Kalahandi district was gripped by a mysterious disease---that was later termed as haemorrhagic septicemia-- resulting in the death of seven female elephants over two weeks. The authorities of the sanctuary which houses as many as 22 elephants woke up from their slumber to go into a damage control mode by disinfecting water and soil that were contaminated by the faeces of cattle, from the nearby Tentulipada village. Pasteurella multocida, the bacteria responsible for the septicemia, infects herbivores like bison, buffaloes and cattle which in turn infects the elephants by soil and water contamination. In January, 40 buffaloes had died in another sanctuary due to haemorrhagic septicemia. Therefore, the forest department should keep track of the situation in other sanctuaries. More so, the health of animals like elephants and cattle beg for a constant vigil. The state forest department is learnt to have directed the Karlapat sanctuary authorities to expeditiously immunise the cattle in the tiny hamlets within the sanctuary. The movement of elephants is being monitored. This should have been done before. The 'mass deaths' of elephants is described as the 'largest ever' elephantdeaths in Indian forests. 

Night curfew back in Bhopal, Indore

Bhopal, March 17: With the number of coronavirus infections increasing rapidly in many parts of Madhya Pradesh, the state government has imposed a night curfew in Bhopal and Indore from Wednesday night. The government has also directed that those people who commute by buses must wear face masks to protect against the pandemic.

As many as 264 Covid-19 patients have emerged in Indore and 199 in Bhopal. The number of Covid patients has surpassed 800 in a single day in the state. Bhopal and Indore have reported the maximum number of Covid cases. At the same time, there are eight more districts where Covid cases are increasing and where special precautions would be taken. The markets in Jabalpur, Gwalior, Ujjain, Ratlam, Chhindwara, Burhanpur, Betul and Khargone districts would close at 10 p.m. The Madhya Pradesh government has decided that the thermal screening of persons coming from Maharashtra would continue Such passengers would have to stay in home quarantine for a week.

During a review meeting of the Transport Department, Govind Singh Rajput, the Madhya Pradesh Transport and Revenue Minister, said in view of the increase in Covid-19 cases, wearing masks should be made compulsory for bus passengers. If any passenger is found without a mask in the buses, then legal action would be taken against the bus owner, driver and the bus conductor.

Talking about road accidents, Rajput said one of the major reasons behind this is buses not plying with enough of a time gap. An interval of one to two minutes after being issued permits increases competition among buses, forcing the drivers to drive at high speed under pressure to arrive on time. Due to this, there is a constant possibility of accidents taking place.

To rectify this, it is necessary that before issuing the permits, the transport department officials should ensure that there is sufficient time gap between the buses.

Rajput said that a commercial driving license is an important step taken by the Madhya Pradesh government in the direction of making women 'Aatmanirbhar' or 'Self-reliant'. In this connection, a driving training centre for women has been opened in Indore. Apart from this, women would also be imparted training for commercial driving.

Chennai, March 17: Loaded with doles and freebies to woo the electorate ahead of the April 6 Assembly polls in Tamil Nadu, archrivals DMK and AIADMK's populist agenda driven election manifestos are also being debated for the financial implications on a state already burdened with high debts.

With late DMK chief M Karunanidhi's 'hero' manifesto of 2006 that promised among others, free colour TV sets, virtually setting the trend for similar races in the future, Tamil Nadu has seen it all—free laptops, milch cows, mixer-grinder and gold for thali (mangal sutra) among others.

In 2021 too, the Dravidian majors chose to dish out a slew of promises that carry the free of cost tag, a more politically correct term used to describe freebies by the proponents of such largesse.

The two parties--AIADMK seeking a record third term and the DMK planning a strong comeback after a decade in opposition, have converged not only on such freebies, but also on other contentious issues like the repeal of Citizenship Amendment Act and release of seven convicts in the Rajiv Gandhi



assassination.

Free washing machine, housing for all, solar cookers, education loan waiver, government jobs to families without anyone in state service etc are AIADMK's promises to the voter while that of DMK includes Rs 4,000 relief to COVID-19 hit rice ration card holders, laws to reserve 75 per cent jobs for locals and waiver of various loans and provision of various assistance.

Both have promised phased prohibition in a state whose coffers are largely filled by liquor sales, even as DMK's ally Congress promised to implement the dry regime soon after the 'new government', apparently headed by DMK, is installed post polls.

However, on the economic front, experts feel the new government will inherit the mantle of huge fiscal debt and the onus of balancing developmental programmes and sourcing new funds for poll assurances

It will encounter several challenges, especially amidst apprehension of second Covid-19 wave

post-election, while both the AIADMK and DMK argue their assurances will get transformed into government schemes when elected to power.

"In my personal view the freebies announced by both the parties are phenomenal. I wonder if anybody has done any financial burden calculation if the party were to implement all its promises when it comes to power," MR Sivaraman, former Union Revenue Secretary, said.

In an apparent reference to the AIADMK, he said "one party" has promised government job to one person from every family without anyone in service. "This was apparently announced without a reality check on the number of households in the state. Imagine the fiscal commitment which the government would accrue in terms of salaries to all government employees if lakhs of households are accommodated," he told PTI.

KR Shanmugam, director and professor of Madras School of Economics, argues that one-time freebies may not strain the economy in the long run.

"Recurring expenditure in the form of implementing the populist schemes may require huge volume of funds and could leave the government hardly any time and resources to devote to other development activities," he said.

When the poll promises become government schemes, the government would evolve a funding pattern in order to improve the lives of the people, he said.

The state government has performed commendably well to improve the situation during the pandemic and made conditions operational to revive the economy, he noted.

"Tamil Nadu's economy is expected to register a positive growth rate of 2.02 percent in 2020-2021 at a time when the country is facing a negative growth rate of 7.7 percent", he said.

Agreeing there were apprehensions of second COVID-19 wave, he said its effect on economy is debatable.

Maintaining that many of and increasing tax revenue.

AIADMK's poll assurances are part of the ongoing welfare schemes, former minister and party spokesman S Vaigaiselvan claimed that funding will never be a constraint for the party-led government.

"The performance of the Palaniswami government, the election manifesto and our achievements will ensure us a third successive victory," Vaigaiselvan, also party candidate from Aruppukottai assembly constituency, said.

The DMK is also confident of meeting the financial requirements for implementing its slew of populist promises.

"Our leader M K Stalin and election manifesto are the two heroes in this assembly election. Our poll assurances are doable," DMK spokesperson A Saravanan said.

On Tamil Nadu's huge debt burden of about Rs 5.70 lakh crore by March 2022, he said "the debts and borrowings are because of financial mismanagement by the government. It lacks administrative efficiency. Corruption too played a huge role."

Incidentally, the DMK manifesto, released on March 13, said that im-

Bhopal, March 17: Despite being out of power in Madhya Pradesh, there are enough indications that the Congress is once again witnessing an internal discord. This was evident while giving party membership to Hindu Mahasabha leader Babulal Chaurasia. This decision by the party did not go down well with senior party leader Manak Agarwal, who attacked the party for which he has



been expelled for six years.

The identity of the Congress in Madhya Pradesh has always been known for factionalism, but the situation changed after the party handed over the leadership to Kamal Nath before the state Assembly elections and this was the reason it won the 2018 Assembly elections.

In a span of just 15 months, the situation within the Congress deteriorated and the Kamal Nath government collapsed because former Union Minister Jyotiraditya Scindia rebelled and joined the BJP along with

22 former Congress MLAs.

After being out of power, the
Congress has been continuously

strengthening its presence at the ground level. Meanwhile, the voices of dissent have started rising after Babulal Chaurasia was inducted into the party. Senior party leader and former Union Minister Arun Yaday, former MP from Mandsaur Meenakshi Natarajan, MLA from Chachoura constituency, Laxman Singh, former minister Subhash Kumar Sojatia, and several other party leaders questioned Chaurasia's inclusion in the party.

Everybody in the party, Everybody in the party opposed the entry of Babulal Chaurasia into the Congress. Manak Agarwal, former Congress Media Cell President and close aide of former Chief Minister Digvijaya Singh, launched a direct attack on Kamal Nath. The matter went to the party's Disciplinary Committee and Agarwal was expelled from the party for six years.

pelled from the party for six years. Political analysts believe that by taking action against Manak Agarwal, the party has given a clear message to those leaders who raise questions and has also instructed them to remain within the ambit of discipline.

It won't be surprising if this decision deepens the discontent within the party since Agarwal is said to be close to Digvijaya Singh. In such a situation, Digvijaya Singh's supporters and Kamal Nath supporters may even confront each other.

State Home Minister Narottam Mishra has taken a dig at Manak Aggarwal's expulsion from the party and said, "Action was taken against Congress leader Manak Aggarwal for inducting a Nathuram Godse supporter in the party making him 'irrelevant'. The party did not even dare to say anything against Arun Yadav who was also against inducting the Godse supporter in the party. It seems that Congress is accepting pro-Godse supporters in its fold."

Madras HC rules criminal proceedings against civic chiefs for manual scavenging

43 PEOPLE LOST THEIR LIVES IN THE LAST FIVE YEARS IN TAMIL NADU WHILE THEY WERE ENGAGED IN MANUAL SCAVENGING

Chennai, March 17 (IANS): Manual scavenging continues to haunt Tamil Nadu. The Safai Karmachari Andolan (SKA), an umbrella body working for the welfare of manual scavengers, moved the Madras High Court after the state witnessed the second highest number of deaths of manual scavengers.

Forty-three people lost their lives in the last five years with 14 losing their lives in 2020 while they were engaged in manual scavenging, a figure which is second only to Uttar Pradesh which stands at 52 in the past five years. The first bench of the Madras high court represented by Chief Justice Sanjib Banerjee and Justice Senthilkumar Ramamurthy ruled that criminal proceedings will be initiated against the civic body chiefs like municipal commissioner or corporation commissioner if people die due to manual scavenging. The judges observed that "Even after passing stringent orders people are dying in pits. It is really painful to hear that 6 people have lost their lives after the dawn of this year."

The court observed, "It is high time that the heads of civic bodies are personally held liable to deaths owing to manual scavenging in their territories." It said that if any manual scavenging work is reported in

Tamil Nadu, the concerned commissioner or civic body chief must February 14, 2021 three people had lost their lives owing to asphyxiation while they were cleaning the sewage pit of a catering unit at Kancheepuram. When Murugan, who entered the pit was not responding to calls, his co-workers Bhagvarai and Arumugam entered the pit to rescue him but all three lost their lives after inhaling toxic fumes. On February 17 also one person died due to asphyxiation while trying to clean a 30 feet deep well in a residential premises at Saidapet, Chennai whose water was mixed with sewage water following a leak in a sewage pipe line. Workers Ravi and Kasi who entered the well fell unconscious and Ravi succumbed later while Kasi survived

Samuel Raj, Secretary of the Tamil Nadu Untouchability Eradication Front while speaking to IANS said, "Every year more than 20 people die while working as manual scavengers but the figure may go up as there is no proper data available and unless a door to door survey is conducted there will be no proper data."

The Safai Karmachari Andolan reports that the figures of 43 deaths for the past five years is wrong and that according to the data available with them 69 people have lost their lives.

Political parties, including the

ruling AIADMK, opposition DMK and Congress, have pitched for a complete ban on liquor, albeit in a phased manner, making the promise in their respective manifestos for the April 6 assembly elections. Total prohibition was in force

in the state from 1937 to 1971 when the then DMK government headed by M Karunanidhi lifted it first. The AIADMK and DMK have

both bet on phased re-introduction of prohibition and closure of liquor outlets in a staggered manner in their manifestos. PMK, an ally of AIADMK, and

PMK, an ally of AIADMK, and MDMK, a partner in the DMK-led front, have also made an assurance to ensure liquor-free Tamil Nadu.

While the DMK has also promised de-addiction centres, its ally Congress has presented a detailed roadmap for implementation of prohibition in its separate manifesto.

Gandhiya Makkal Iyakkam chief Tamizharuvi Manian, who has been in the forefront of anti-liquor campaign for years, is not impressed

much by the promises.
"The mention of bringing pro-

hibition in the manifestos of AIADMK and DMK is just a passing reference which indicates there is no commitment to implement it," he told PTI. Manian, a Gandhian and former

Congress leader who has held several campaigns against liquor, said he would continue to fight for the dry law in the state.

In their manifestos for the 2016 assembly elections too the two

assembly elections too the two Dravidian parties besides the Congress had assured to enforce ban on liquor, sale of which is a major revenue earner for the government contributing around Rs 30,000 crore annually. Introducing complete prohibi-

tion, which encompasses closure of liquor outlets and a halt to production and storage of spirits, was a hotly debated topic during the 2016 assembly polls unlike the present election.

In 2015, the demand for prohibi-

In 2015, the demand for prohibition peaked with the death of Gandhian Sasi Perumal during a protest against liquor outlets. Perumal championed the cause of a complete ban on production, storage and consumption of alcoholic products.

As part of implementing the AIADMK's promise, then chief minister J Jayalalithaa had issued an order closing down around 500 Indian Made Foreign Liquor shops



Total prohibition was in force in the state from 1937 to 1971 when the then DMK government headed by M Karunanidhi lifted it first Rajaji, who was by then steering the Swatantra party, personally visited the DMK patriarch and requested him not to revoke the ban

Though the DMK regime did not heed to his counsel, the party re-introduced the ban three years later

The state Congress recalled that
till 1967, when it held the reins of

office, a high-level committee comprising experts and officials would be formed to work towards imposing a complete ban on liquor.

While mulling a ban on alcoholic beverages, the panel would work on ensuring that the proposed move does not lead to brewing of illicit liquor and also look into ways to offset the loss of revenue -from liquor sale- to the government due to the move, it said.

He called for taking quick and decisive steps for stopping this "second peak" of Covid-19 virus, in the meeting held via video conference.

Stressing the importance of solving problems of local governance, he warned that the confidence which came from the achievements in the battle against Covid-19 should not turn into negligence as he expressed concern about the high positivity rate in Maharashtra and Madhya



Pradesh with 70 districts witnessing a 150 per cent rise in the last few weeks.

"Stop this emerging second peak of corona immediately," he urged the Chief Ministers. At the same time. Modi stressed that the public should not be brought to panic mode.

The Prime Minister noted the need for provision of micro containment zones and to be serious about 'Test, Track and Treat' as "we have been doing

for the last one year". "It is very important to track

every infected person's contacts in the shortest time and keep the RT-PCR test rate above 70 per cent. More RT-PCR tests should be done in the states like Kerala, Odisha, Chhattisgarh, and Uttar Pradesh, which give more emphasis to Rapid Antigen Tests.

The Prime Minister urged to increase testing and to pay special attention to the "re-

ferral system" and "ambulance network" in small cities.

"This is because now the whole country has opened up for travel and the number of people travelling has also increased. There is need for a new mechanism for sharing information among people," he said, focussing on responsibility of following SOPs for surveillance of the contacts of the travellers coming from abroad

Vax wastage in India is 6.5%

The average of COVID-19 vaccine wastage in India is 6.5 per cent, with Telangana and Andhra Pradesh recording 17.6 and 11.6 per cent wastage respectively, the Centre said Wednesday as it called for optimal utilisation of the jabs. Addressing a press conference, Health Secretary Rajesh Bhushan said that 3.51 crore vaccine doses have been administered till now in the country, which include 1.38 crore beneficiaries aged 45-60 years with specific co-morbidities and those above 60 years who have been given the first dose. On March 15. 8.34 million COVID-19 vaccine doses were administered worldwide, of which India alone administered 36 per cent of doses, he said.


Man sentenced to death for raping a minor

Jaipur, March 17: A special POCSO court in Rajasthan's Jhunjhunu district Wednesday awarded death penalty to a man for raping a 5-year-old girl 26 days ago and appreciated the swift action by the police in the case.

According to the police, the 21year-old man abducted the girl who was playing in an agriculture field near her house on the evening of February 19. Other children informed the girl's parents about it following which police were alerted.

The girl was found in an injured state at an isolated place. The accused was identified and arrested five hours later. Investigating officer in the case Suresh Sharma, who is the circle officer of Chirawa, said the court convicted the man Tuesday and pronounced the death penalty under the Protection of Children from Sexual Offences (POCSO) Act Wednesday.



"Swift action was taken in the case and all evidence collected. The charge sheet was filed and the court pronounced the judgment today," he said. The court also appreciated the investigation conducted by the police, saying it was an example of an ideal investigation which contained direct, scientific, electronic and circumstantial evidence.

It was observed that the circumstantial evidence collected by the police was enough to prove the case. Hailing the judgment, Rajasthan Chief Minister Ashok Gehlot said the police filed the charge sheet within nine days and the court delivered judgment within 26 days of the incident.

Mamata releases TMC manifesto

Kolkata, March 17: Trinamool Congress supremo Mamata Banerjee on Wednesday unveiled a "development-oriented" manifesto for the upcoming assembly polls in West Bengal, promising an income scheme for all families, a student credit card and constitution of a task force to examine the inclusion of several communities under the OBC category.

Claiming that her government has reduced poverty in the state by 40 per cent, the manifesto also promised to increase annual financial aid to farmers from Rs 6,000 to Rs 10,000. "For the first time, every family in Bengal will be extended a minimum basic income. Under this, 1.6 crore general category families will get Rs 500 a month, whereas SC/ST category families will get Rs 1,000. The money will be directly transferred to the woman head of a family," Banerjee said.

A new student credit card scheme will be introduced with a credit limit of Rs 10 lakh and an interest rate of only 4 per cent will be

charged, the West Bengal chief minister said. "We will set up 10 lakh new MSMEs and 2000 new big industrial units in the next five years,"

"We shall appoint a Special Task Force to examine and propose OBC status to all the communities which are not recognised as OBCs like Mahishya, Tili, Tamul and Sahas. We will also ask the Government of India to grant ST status to____ Mahatos," the TMC chief said.

A Special Development Board would be set up for the development of Terai and Dooars region

in north Bengal, she said.

No concerns yet: Govt on AstraZeneca safety fears

New Delhi, March 17: Amid reports of possible side-effects of Oxford-AstraZeneca's COVID-19 vaccine and its suspension in some European countries, the government on Wednesday said there is "no signal of concern" regarding its use in the country as of now.

Asked about the suspension of the AstraZeneca COVID-19 vaccine in some European countries, Dr VK Paul, NITI Aayog member (Health) told a weekly press conference here that it has only been done as a precautionary measure.

Concerns about AstraZeneca's vaccine relationship with thrombotic events in people who received the vaccine have come to light and



as a result, about 10 European countries have paused their AstraZeneca vaccination pro-

gramme, he said. "The European medical agency

says it is a precautionary measure and there is no data to believe, as of now, the causal relationship between the vaccine and the adverse events. The assessment is still being done," Paul added. He said the World Health Organization (WHO) has said as a precaution, investigation should go on and has categorically said not to suspend the vaccination.

"India's own committee that looks at adverse effects is seized of this issue. For the last few days, it is tracking the information that is available to us in a very systematic manner and again I assure you that we have no signal of concern in this regard. Therefore, clearly our vaccination programme with Covishield will go on with full vigour. "We are mindful of the fact to address this concern, based on the emerging situation. As of today, there is no concern at all with regard to Covishield," Paul said.

Pakistan sending weapons through drones: Govt to RS

New Delhi, March 17: The government Wednesday said some instances of supply of weapons through drones from Pakistan have come to light and security agencies were taking action on it.

Union Minister of State for Home G Kishan Reddy said this in Raiva Sabha, while responding to a question on whether the central government is aware that Pakistan has started supplying weapons to infiltrators via drones. "Certain instances of supply of weapons via drones from across the Pakistan border have come to the notice of security and law enforcement agencies," he said in



his written reply.

Reddy said the government has been taking various steps to meet such challenges, which include round the clock effective surveillance, streamlining the intelligence set up, capacity building of forces, patrolling on the borders along with sensitization of local population in border areas, establishment of observation posts, border fencing, flood lighting, deployment and use ofmodern and hi-tech surveillance equipments, etc.


'Passengers not wearing masks properly to be de-boarded'

New Delhi, March 17: The DGCA informed the Delhi High Court on Wednesday that action is being taken against passengers not wearing masks properly despite repeated warnings and they will be deboarded from planes before departure and treated as "unruly pas-

The high court expressed satisfaction over the steps being taken by the Directorate General of Civil Aviation (DGCA) and said it hoped that the action would continue in the same spirit considering the safety of passengers from COVID-19 in-

A bench of Justices Navin Chawla and C Hari Shankar observed that the court was initially planning to keep the suo motu case open to con-



tinue monitoring the implementation of directions issued by the

court earlier However, after noticing the proac-

tive action by the DGCA, the court decided to close the case and observed that initiation of punitive action against the violators is a welcome step, the bench said.

Justice Shankar had March 8 taken suo motu cognisance of the situation after witnessing passengers not wearing masks properly during transportation from airport to the flight and their stubborn re-

luctance to wear masks properly. The court, which had issued various guidelines to DGCA and all other airlines for immediate compliance, said it was constrained to pass the order because of an alarming situation which was witnessed by the judge himself during the Air India flight from Kolkata to New Delhi March 5.

DGCA, represented through Additional Solicitor General (ASG) Chetan Sharma and advocate Anjana Gosain, informed the court that following its directions, it is sued a circular March 13 relating to strict guidelines to be followed in the airports.

"On board the aircraft, in case any passenger does not adhere to wearing of mask properly even after repeated warning, he/she should be de-boarded, if need be, before departure," the circular stated. "In case, any passenger on board an aircraft refuses to wear mask or violates the 'COVID-19 Protocol for passengers' even after repeated warnings, during the course of the fight, such passenger may be treated as 'Unruly Passenger' as defined... Civil Aviation Requirements (CAR)...And the procedure in respect of handling such unruly passenger, as provided in above mentioned CAR, shall be followed by the concerned airlines," it said. Advocate Gosain also informed

the court that in a Jammu to Delhi flight, March 16, four passengers were declared unruly for not properly wearing masks and were handed over to the security officials. She said the authorities have also decided to conduct surprise checks.

When the counsel for Air India said they have also issued a circular with necessary guidelines, the bench asked the DGCA to ensure that other airlines also follow the guidelines

The DGCA has also said in its circular that passengers shall wear masks and maintain social distancing norms at all times during air travel. The mask shall not be moved below the nose except under exceptional circumstances, it said.



DELHI WOMAN DIES AFTER SON SLAPS HER

New Delhi, March 17: A 76-yearold woman died after she was slapped by her son following an argument between them in Dwarka, the police said Tuesday.

In the CCTV footage of the incident that occurred Monday afternoon, the woman, Avtar Kaur, can be seen being slapped by her son on the face, after which she became unconscious and fell on the ground.

After the video emerged, the police registered a case against her 45-year-old son under section 304 (punishment for culpable homicide not amounting to murder) of the Indian Penal Code (IPC) at the Bindapur police station and arrested him.

According to the police, before the incident, there was an argument between the woman and

one of her neighbour over parking vehicles. A PCR call was also made by the neighbour, but when the police reached the spot, the complainant told them that the issue was sorted out and she did not want to pursue the matter anymore. Subsequently, Kaur's son confronted her about "picking up a fight" with the neighbours. During the ensuing argument between the two, the son slapped his mother on her face, a senior police officer said. The CCTV footage showed that after the dispute over parking of vehicles was sorted, another argument broke out between the woman, her son Ranbir and his wife.

The woman was taken to a nearby hospital, where she was declared "brought dead" by the doctors, senior police official (Dwarka) Santosh Kumar Meena said.

WATER RESOURCES ISSUES

INDIA, BANGLADESH T EXPAND COOPERATI

The Indian delegation was led by Pankaj Kumar, Secretary (Water Resources, River Development and Ganga Rejuvenation). The Bangladesh delegation was led by Kabir Bin Anwar, Senior Secretary,



Ministry of Water Resources.

Noting that India and Bangladesh share 54 common rivers which directly impact the livelihood of people in the two countries, both sides commended the close cooperation that exists between them in the matter.

Gunmen kill 58 in Niger market

Niamey: Gunmen on motorcycles attacked a group of civilians returning from market day in a volatile corner of Niger, leaving at least 58 people dead and then burning granaries to the ground, the government has said. There was no immediate claim of responsibility for Monday's massacres, though extremists belonging to the Islamic State in the Greater Sahara group are known to be active in the Tillaberi region where the villages were attacked.

Oz to give vax to PNG

Canberra: Australia will send COVID-19 vaccines from its own supply to its nearneighbour Papua New Guinea and will ask AstraZeneca to send more to try to contain a concerning wave of infections, Australia's prime minister has said. Prime Minister Scott Morrison said 8,000 AstraZeneca doses would be sent next week for Papua New Guinea's frontline health workers and he and his Papua New Guinea counterpart James Marape would ask AstraZeneca to send another 1 million doses as soon as possible.

7 killed in Pak coal mine blast

Karachi: At least seven Pakistani miners were killed after an explosion at a coal mine in the troubled Balochistan province, the second such incident in the province in a week. The explosion took place Monday night after the accumulation of methane gas in the mine in Torghar gas field in Hanai district, Balochistan Coal Mines Workers Federation president Sultan Muhammad Lala said. Last week, six miners were killed after an explosion in a coal mine in Marwar district of the province.

Hong Kong, March 17: The US sanctioned an additional 24 Chinese and Hong Kong officials over Beijing's ongoing crackdown on political freedoms in the semi-autonomous city, just ahead of the Biden administration's first face-toface talks with China.

The step reflects Washington's "deep concern" about the erosion of Hong Kong's autonomy following changes to its election system endorsed by China's ceremonial legislature last week, Secretary of State Antony Blinken said in a statement Wednesday.

Foreign financial institutions that deal with the 24 officials would be subject to US sanctions, the State Department said.

The planned changes to Hong Kong's electoral law give a pro-Beijing committee power to appoint more of Hong Kong's lawmakers. The move will reduce the proportion of those directly elected and ensures that only those determined to be truly loyal to Beijing are allowed to run for office - effectively shutting opposition figures out of the political process.

The US announcement was made during a visit by Blinken and Defense Secretary Lloyd Austin to Japan and South Korea, both of which are wary of China's growing

While in Tokyo, the Blinken and Austin delivered a joint statement with their Japanese counterparts expressing concern about Beijing's human rights violations in the western Xinjiang region against ethnic minorities and China's determination to alter the status of a group of uninhabited islands administered by Tokyo but claimed by Beijing. The two arrived in Seoul on Wednesday for talks.

SARKOZY GOES BACK ON TRIAL INDO-ASIAN NEWS SERVICE

Paris, March 17: Former French President Nicolas Sarkozy is on trial over accusations of illegal campaign financing starting Wednesday, two weeks after he was sentenced on separate charges of bribery.

Sarkozy is accused of exceeding the legal threshold for campaign expenses by 20 million euros (23.8 million dollars) during his re-election campaign in 2012, dpa news reported.

An additional 13 people are also accused of fraud or aiding and



The so-called Bygmalion affair, after the name of a communications agency involved in the case, regards fake invoices issued to keep Sarkozy's campaign expenses under the legal threshold of 22.5 million euros. A verdict is expected in mid-April.

According to media reports, the trial might however be delayed immediately after opening, as one of the defendants' lawyers has fallen ill.

Sarkzoy, who ruled France between 2007 and 2012, is facing one year in prison and a fine of 3,750 euros. At the beginning of the month, the former leader was already sentenced to three years in prison, two of them suspended, in a corruption case.

Political role under fire in AstraZeneca vaccine suspension

Berlin, March 17: The decision by more than a dozen European countries to suspend AstraZeneca's COVID-19 shot faced deepening scrutiny Wednesday, amid concerns the step could undermine public confidence and delay efforts to beat the coronavirus pandemic.

The role of Germany, and in particular Health Minister Jens Spahn, is in the spotlight after a chaotic round of telephone diplomacy at the start of the week ended with the EU's biggest states agreeing to put AstraZeneca on hold.

Spahn says he acted on expert advice after Germany's vaccine watchdog reported on what it described as a statistically significant number of cases of a rare brain blood clot. AstraZeneca says it has found no evidence that the blood clots were caused by the vaccine. The World Health Organization called on countries not to delay lifesaving vaccine programmes.

Germany's actions have been interpreted as political both at home and abroad, with opposition leaders calling on Chancellor Angela Merkel to sack Spahn. Officials in

The fire broke out at around 8 am, causing dense smoke inside the ICU unit-2 of DMCH, the state owned biggest hospital of the country Three patients who were in life support in ICU, died during shifting to CCU of the Dhaka Medical College.

Pak poll body summons PTI on foreign funding

Islamabad, March 17: The Election Commission of Pakistan (ECP) has issued notices to the Pakistan Tehreek-i-Insaf (PTI) and its own scrutiny committee to appear before it March 22 to explain their stance over secrecy of scrutiny in the PTI foreign funding case.

This follows a complaint by petitioner Akbar S Babar against the scrutiny committee's decision to keep PTI documents secret.

The decision was taken by a threemember bench headed by ECP member from Khyber Pakhtunkhwa retired Justice Irshad Qaiser after hearing Babar's complaint Tuesday, Dawn reported. Babar's lawyer, Ahmad Hassan Shah, challenged the scrutiny committee's decision and invoked the Right to Information Act to seek access to the documents.

The lawyer argued that access to PTI documents is a right of the petitioner in light of Article 5(4) of the Political Parties Order, 2002 and Section 203(5) of the Election Act, 2017, Geo tv reported. By keeping the documents secret, the ECP scrutiny committee is violating the terms of reference of scrutiny that clearly demands scrutiny in the presence of both parties, the petitioner's

He said the scrutiny process would be a sham and mere attempt to rubber stamp fake documents. The lawyer said a secrecy order

of the committee is illegal. About the performance of the committee, Shah regretted that other than writing a letter to the SBP to seek PTI accounts, there has been no investigation into the credible evidence provided regarding illegal funding from across the globe.

Mars may be hiding most of its 'missing' water underground

Washington, March 17: Vast amounts of ancient water may have been trapped beneath the surface of Mars, according to a NASA-funded study which challenges the current theory that the Red Planet's water es caped into space.

 $Evidence \, found \, on \, the \, surface \, of \,$ Mars suggests that abundant water flowed across Mars billions of years ago, forming pools, lakes, and deep oceans, and where did all that water go has been a matter of investigation.

The new study, published in the journal Science, shows that a significant portion of Mars's water - between 30 and 99 percent -- is trapped within minerals in the planet's crust.

The researchers from California

Institute of Technology and NASA's

Jet Propulsion Laboratory (JPL) found that around four billion years ago. Mars was home to enough water to have covered the whole planet in an ocean about 100 to 1,500 metres deep. However, a billion years later the

planet was as dry as it is today. Atmospheric escape doesn't fully explain the data that we have for how much water actually once existed on Mars, said Caltech PhD candidate Eva Scheller, lead author of a paper on the research.

The team studied the quantity of water on Mars over time in all its forms - vapour, liquid and ice - and the chemical composition of the planet's current atmosphere and crust. They did so through the analysis

of meteorites as well as using data

provided by Mars rovers and or-

biters, looking in particular at the

ratio of deuterium to hydrogen. Water is made up of hydrogen

and oxygen. Not all hydrogen atoms are created equal, however. There are two stable isotopes of hydrogen deuterium to hydrogen.

The lighter-weight hydrogen has an easier time escaping the planet's gravity into space than its heavier counterpart, according to the re-

searchers.

Because of this, the escape of a planet's water via the upper atmosphere would leave a telltale signature on the ratio of deuterium to hydrogen in the planet's atmosphere, and there would be an outsized portion

of deuterium left behind, they said. However, the researchers noted that the loss of water solely through

the atmosphere cannot explain both the observed deuterium to hydrogen signal in the Martian atmosphere and large amounts of water in the past.

The study proposes that a combination of two mechanisms -- the trapping of water in minerals in the planet's crust and the loss of water to the atmosphere -- can explain the observed deuterium-to-hydrogen signal within the Martian atmosphere. The researchers said that when water interacts with rock, chemical weathering forms clavs and other hydrous minerals that contain water as part of their mineral structure, a process that occurs on Earth as well as on Mars.

Mars, however, is mostly tectonically inactive, and so the drying of the surface, once it occurs, is permanent, according to the researchers.

Uber under pressure on 'UK minimum wage'

London, March 17: Uber drivers in Britain should receive the minimum wage for the whole time they are logged on to the app, two former drivers said Wednesday after winning a court battle which could reshape the gig economy.

Following a UK Supreme Court defeat last month, the Silicon_ Valley-based company reclassified its more than 70,000 drivers in Britain as workers, meaning they are guaranteed entitlements such as holiday pay. Uber said drivers will be at least 15% better off after the changes, if they opt into the pension plan.

On the minimum wage, which stands at 8.72 pounds (\$12.13) per hour for those aged 25 and over, Uber said it would apply "after accepting a trip request and after expenses" and that on average drivers earn an hourly 17 pounds in London.

Drivers will not receive it during the time they spend waiting for a passenger request, which can account for as much as a third of the time drivers are behind the wheel with the app turned on, according to several U.S. studies.

James Farrar and Yaseen Aslam, the two lead drivers in a 2016 employment tribunal case that Uber unsuccessfully contested all the way to Britain's top court, criticised the move.

NPAs likely to increase in H1 2021, says survey

Mumbai, March 17: Asset quality of banks, which saw some improvement in the second half of 2020, is expected to worsen during the first six months of 2021, according to a survey. The findings are part of the 12th round of bankers' survey carried out by FICCI-IBA between July and December 2020.

The survey was conducted on 20 banks, including public sector, private sector and foreign banks, representing about 59% of the banking industry, as classified by asset

In the current round of the survev. half of the respondent banks reported a decline in NPAs during the second half of 2020. About 78% of participating state-run banks have cited a reduction in NPA levels. "However, in terms of outlook, nearly 68% of respondent bankers expect the NPA levels to be above 10% in the first half of 2021," the survey showed.

Close to 37% of respondents expect NPA levels to be upwards of 12%. The Reserve Bank of India's Financial Stability Report, released in January this year, showed that gross non-performing assets (GNPAs) of banks may rise to 13.5% by September 2021, under the baseline stress scenario

Some of the high NPA risk sectors identified by majority of respondent bankers in the current round of survey include tourism and hospitality, MSME, aviation and restaurants, the survey showed.

Around 55% of respondents believe NPAs to rise substantially in the tourism and hospitality sector, while another 45% reported that NPAs are likely to increase moderately in this sector.

Another high NPA risk sector reported in the current round of survey is the MSME sector, with 84% respondents expecting an increase in NPAs in this sector.

Close to 89% respondents also expect the restaurant sector to see an increase in NPAs, though only 26% expect NPAs to increase substantially in this segment, it showed.

The survey revealed that there was a significant increase in the requests for one-time restructuring for MSMEs, announced by the RBI in August last year. "An overwhelming 85% of the respondent banks have cited an increase in requests for restructuring of advances as against 39% in the last round," it said.

The long-term credit demand has been growing for sectors such as infrastructure, pharmaceuticals and food processing, the findings showed

Particularly for the pharma sector, 45% of the respondents have indicated an increase in long term loans in the current round of survey as against 29% in the previous round," it showed.

The study also found that 49% of respondents were focused on building entrepreneurial skills with an interest in setting up their own business. PwC said respondents included workers, business owners, contract workers, students, unemployed people looking for work, and those on furlough or who were temporarily laid off

The survey involved 19 countries: Australia, Canada, China, France, Germany, India, Japan, Kuwait, Malaysia, the Netherlands, Poland, Qatar, Saudi Arabia, Singapore, South Africa, Spain, the UAE, the UK and the US. The survey also found that 50% of workers "say they've faced discrimination at work which led to them missing out on career advancement or training".

As per the study, 13% reported missing out on opportunities as a result of ethnicity and 14% of workers experienced discrimination on the grounds of gender, with women twice as likely to report gender discrimination as men.

'De-risking biz top priority of industries'

New Delhi, March 17: De-risking business from impacts of climate change and becoming environmentally sustainable is one of the top priorities alongside increasing worker productivity and production, a new survey has said.

The survey of over 400 industrial companies in Maharashtra by Climate Trends revealed that a majority of 65% would prioritise reducing dependence on non-renewable resources, water harvesting/recycling and switching to renewable energy.

"A majority of Maharashtra's industrial sector (more than 70%) believes that climate change is a real issue, however, some nuances exist," the survey said. "Those associated with largest industries have a stronger acknowledgment of the issue compared to those working with MSMEs.'



Nearly half of those surveyed believe that climate change impacts their industries and business "by a lot". The direct impacts to the businesses are productivity, expenditure and profits and supply chain of the business, it said.

"A majority (65%) of the industrial sector ranks 'de-risking business from climate change' as one of the top priorities for their business," it said.

Other priorities being increasing worker productivity, raising output, strong preparedness for any situation, more efficient chainsupply management and decrease worker attrition rate.

The team's No.1 spinner Yuzvendra Chahal has leaked runs both times India have set a target. Hardik Pandya's return as a bowling all-rounder has been promising but he is yet to take a wicket. Bhuvneshwar Kumar has kept things tidy in his comeback series but the team expects him to provide regular breakthroughs with the

Offie Washington Sundar has been the stand out bowler for India with four wickets at an impressive economy rate of 6.95. Despite India being 1-2 down, no major changes are expected in the playing eleven.

SA add salt to eves' wounds

Visitors seal ODI series 4-1, giving India plenty to think about ahead of World Cup

Lucknow, March 17: South Africa added salt to India's wounds by registering a five-wicket win over the hosts in the low-scoring fifth and final women's ODI to seal the series 4-1 here, Wednesday.

Mithali Raj played a captain's knock by hitting a well-crafted 79 not out (104b, 8x4, 1x6) but it was only enough to take India to 188 all out. South Africa then rode on Anneke Bosch (58, 70b, 8x4) and Mignon du Preez's (57, 100b, 4x4) half centuries to chase down the target in 48.2 overs.

The series marked India's return to international cricket after



12 months. They were naturally rusty to start with and by the end of the series, it seemed that they have a lot of work to do if they want to be title contenders for the World Cup early next year.

The batting needs more firepower and bowling concerns too need to be addressed as spinners. traditionally India's strength, struggled against South Africa.

South Africa's chase got off to a disastrous start as the visitors lost their top three batters including skipper Sune Luus (10) for just 27 runs.

Du Preez and Bosch then stabilised South Africa's run chase with a 96-run partnership for the fourth wicket before Indian bowlers pulled things back, dismissing both the set batters in quick succession.

At that stage South Africa were 131/5, still needing 58 runs in 13 overs for a win. Marizanne Kapp (36 n o) and Nadine de Klerk (19 n o), however, ensured there was no further hiccups as the duo shared un-

beaten 58 runs for the sixth wicket to guide South Africa home. For India, left-arm spinner Rajeshwari Gayakwad (3/13) picked up three wickets in her 10 overs.

Earlier, Mithali steered India's innings after India lost three early wickets with the scoreboard reading 53 in the 13th over. Together with Harmanpreet Kaur (30), who retired hurt due to an injury, Mithali shared 71 runs for the fourth wicket before the former left the ground in the 31st over. Mithali didn't get much support from the remaining batters as they were bowled out in 49.3 overs. Nadine de Klerk was the pick of the bowlers for South Africa with figures of 3/35.

Real, City in Champions League last 8



Madrid, March 17: Real Madrid took advantage of Atalanta's costly goalkeeping change to make it back to the Champions League quarterfinals as the Spanish giants defeated the Italian club 3-1 and 4-1 on aggregate.

Premier League leaders Manchester City also made it into the last eight stage, for a fourth straight season, after sweeping aside Borussia Monchengladbach 2-0 at the Etihad Stadium and 4-0 on aggregate.

Karim Benzema led the way to victory for the Los Blancos after a first-half blunder by Atalanta goalkeeper Marco Sportiello, who was among the changes made by coach Gian Piero Gasperini from the 0-1 first-leg loss in Italy.

Sportiello tried to play from his area but misplayed his shot and the ball went directly to Luka Modric, who entered the box and made a low pass for an easy goal by Benzema from near the penalty



spot in the 34th minute.

It was the 70th Champions League goal for Benzema, making him only the fifth player to reach the mark in the competition after Cristiano Ronaldo, Lionel Messi, Robert Lewandowski and Raul Gonzalez.

Only Ronaldo, Messi and Lewandowski reached the milestone quicker than the French striker's 126 matches.

Captain Sergio Ramos and Marco Asensio sealed Madrid's victory by scoring a goal each in the second

half. Atalanta's goal came from a free-kick converted by Luis Muriel late in the game.

Madrid had reached the semifinals or better in eight straight seasons between 2010-11 and 2017-18 before losing to Ajax in the last 16 in 2019 and to Manchester City last season.

In Manchester, the celebrations at the full-time whistle were as business-like as the performance. For City, it felt the competition now starts for real. Yet the expectations have proved too much for Guardiola and his team in successive quarterfinal exits, to Liverpool, Tottenham and then — so painfully Lyon last season.

This looks to be City's best chance of becoming European champion_ for the first time, though. Thanks to a blistering 12th-minute strike in off the crossbar by Kevin De Bruvne and Ilkay Gundogan's goal six minutes later after a flowing team move, City racked up a 24th win in its last 25 games in all competitions and a seventh straight clean sheet in the Champions League.
