3 BJP MLAs suspended

The MLAs, Jaynarayan Mishra, Bishnu Charan Sethi and Mohan Charan Majhi, were suspended for hurling shoes and headphones at the Speaker's podium

Bhubaneswar, April 3: Three senior BJP MLAs have been suspended from the ongoing Budget session for hurling shoes and headphones at Speaker Surjya Narayan Patro's podium during the House proceedings Saturday.

The suspended legislators are Opposition chief whip Mohan Charan Majhi, deputy Leader of Opposition Bishnu Charan Sethi and senior BJP member Jayanarayan Mishra. The Speaker suspended the three leaders after examining the video footage.

The House Saturday witnessed ugly scenes as BJP MLAs hurled shoes, earphones and papers at the Speaker's podium during the proceedings. One of them also threw dustbin inside the House.

As the Speaker rejected an adjournment motion brought by Congress members on the mining issue, both BJP and Congress members alleged that the Speaker doesn't want to conduct any debate on the mining issue in the House. If the Speaker has any objection on the notice why did he not clarify it earlier, the Opposition leaders questioned.

Soon, BJP and Congress members rushed to the well of the House and created ruckus. Unable to run the House, the Speaker called an all-party meeting and later allowed debate on passing of the Odisha Lokayukta (Amendment) Bill and the Societies Registration (Odisha Amendment) Bill.

Night curfew back in 10 dists

Bhubaneswar, April 3: In view of rising COVID-19 cases, the state government Saturday announced night curfew in 10 districts between 10 pm and 5 am from Monday.

"In the interest of the general public and to prevent transmission of infection, it is directed that night curfew will be in force in the districts of Sundargarh, Jharsuguda, Sambalpur, Bargarh, Balangir, Nuapada, Kalahandi, Nabarangpur, Koraput and Malkangiri from April 5 till further orders," said an order issued by Chief Secretary Suresh Chandra Mahapatra.

As per the order, all shops, commercial establishments. offices, institutions and movement of individuals will be restricted or prohibited between 10 pm and 5 am in these districts. Only essential activities will be allowed during the curfew period.

Collectors and Municipal Commissioners will issue orders for their respective jurisdictions for clamping restrictions under Section 144 of CrPC, and ensure strict compliance. Collectors may also impose any further retivities as felt appropriate considering the local situation, it says.

The government has, however, kept emergency services pertaining to health, electricity, police, fire service, water supply, telecom, railway and airport out of the purview of restrictions. Employees of the Information Technology and media houses have been exempted from the curfew restrictions. Home delivery services have been allowed to function during the curfew hours.

Odisha has been consistently reporting more than 400 new COVID-19 cases daily for the past two days. While 452 more people were found COVID positive Saturday, 461 had tested positive Friday. The districts which share borders with Chhattisgarh are especially vulnerable to rapid rise in infections.

The highest – 77 – fresh cases were reported in Khurda district, while western Odisha districts such as Nuapada (71), Sundargarh (75), Kalahandi (29) and Bargarh (19) too had high caseloads. The spurt in infections is attributed to movement of infected people from Chhattisgarh.

Covid effect: Srimandir to remain closed on Sundays

Bhubaneswar, April 3: In view of the rising number of COVID-19 cases, the Shree Jagannath Temple Administration (SJTA) issued fresh Standard Operating Procedure (SOP) Saturday as per which the 12th century shrine will remain open for all days of the week except Sunday for public darshan.

There will be complete sanitisation of the temple premises on every Sunday, officials said.

A meeting held with all stakeholders under the Chairmanship of SJTA chief Krishan Kumar had a detailed discussions on the implementation of guidelines laid down



"It was discussed that a number of suggestions have been received for making changes in the SOP in view of the increasing trend in number of COVID-19 cases," Kumar said, adding that the matter was also discussed in the Chhatisha Nijog (servitor bodies) March 23.

According to new SOP, the temple will remain open on all days of the week except Sundays. This will be as per the schedule of Niti (ritual) on different days. The public darshan of Lords will start latest by 6 am unless notified

There will be complete sanitization of the temple premises on every Sunday. Night time sanitization of the temple premises will be conducted twice a week after closure of the temple for public darshan, he said.

There should be strict enforcement for ensuring COVID appropriate behaviour by all concerned.

Police officer killed in US Capitol attack


New York, April 3: A vehicle attack at the US Capitol killed a police officer and the alleged assailant was shot dead by law enforcement, as Washington is still reeling from the violent January 6 riots at the Congress.

The man who allegedly carried out the attack on Friday afternoon was identified as Noah Green, a 25-year-old man from Indiana, who according to his Facebook posts is an adherent of the Nation of Islam sect, which has been denounced by mainstream Muslims and has no connections to the faith despite the sect's name.

Acting Capitol Police Chief Yogananda Pittman said at a news conference that the car rammed two police officers at a Capitol checkpoint, killing one of them and injuring another.

The driver of the car came out wielding a knife and lunged at an officer who shot him, she said. The slain police officer has been identified by Capitol Police as 18-year veteran William

Kerala's first transgender candidate withdraws amid threats, harassment



Malappuram, April 3: All set to be the first transgender person in Kerala to contest the Assembly election, Anannyah Kumari Alex is now withdrawing from the poll fray. Anannyah Kumari Alex alleged that she was mentally tortured and received death threats from leaders of the Democratic Social Justice Party (DSJP) which had nom-

Despite the fact that the last date for withdrawal of nomination papers has gone by, 28-year-old Alex has decided to end her election campaign. She was nominated from the Vengara constituency in the Malappuram district of Kerala against senior leader PK Kunhalikutty of the Indian Union Muslim League representing the United Democratic Front (UDF) and Communist Party of India (Marxist) candidate P Jiji representing the Left Democratic

The DSJP leaders forced me to speak poorly of UDF candidate PK Kunhalikutty and to criticise the LDF government," Alex said. "I was also forced by the party leaders to observe pardah during the election cam-

paign. The harassment came after I said that I would not do anything which would surrender my personality," she stated.

Alex continued, "I was used by DSJP party leaders. They had some plans and reasons for putting me in the front. But I didn't understand that earlier. I have a personality and my own opinions, and I am not ready to surrender that.'

Anannyah Kumari Alex further alleged that DSJP leaders threatened to kill her when she opposed them. They portrayed me as a prostitute and insulted me, she claimed.

"I wanted to contest the election to ensure representation and equality for transgender people in Kerala. But it was the party that instructed me to contest from the Vengara constituency. It was not my decision initially," Alex said.

Anannyah Kumari Alex hails from Peruman in Kollam district of Kerala. She is Kerala's first transgender radio jockey. She is also a professional makeup artist and a news anchor employed at a private channel.

Kerala will go to the polls in a single phase April 6. The counting of the votes will be done May 2.

Gangrape accused shot dead by cops

Meerut/New Delhi, April 3: One of four men accused of the gangrape of a Class X student in western UP's Meerut has been shot by police as he and his accomplice attempted to escape custody while being taken to court. Police said the two accused -Lakhan and Vikas - were arrested earlier Saturday and were being taken to court when they snatched a pistol from one of the policemen guarding them and tried to flee. Police also said that in the encounter that the two were pinned down near a village. Lakhan opened fire, and was then shot in his leg by the cops' return fire.

"Today both accused were being taken to court, when they escaped by grabbing the gun of a Police Inspector. A combing operation was launched... the accused opened fire on police. We returned fire and Lakhan was shot in his leg," Keshav Kumar, the Superintendent of Police (Rural), said. Both accused have been re-captured, and Lakhan is being treated at a local hospital.





Distancing helped tribals keep nCoV at bay: Naidu

Bhubaneswar, April 3: The tribal population in Odisha was largely untouched by the Covid-19 pandemic and their unique customary practices and traditions have helped them keep the infection at bay, Vice President M Venkaiah Naidu said here Saturday while citing a study.

The report by Scheduled Castes and Scheduled Tribes Research and Training Institute (SCSTRTI) noted that by habit, tribal people maintain a reasonable distance from one another when they walk,

and can improve fight hunger, disease, ignorance and every other evil that retard our growth

"Such safe distancing and hygiene norms, rooted in the tribal culture coupled with the natural food. have helped them stay safe during the pandemic," Naidu said addressing the 50th convocation of Utkal University here.

Universities should focus on these positive aspects of tribal communities and include them in their curriculum, he said.

His comment came at a time when India Saturday recorded 89,129 new Covid-19 cases, the highest daily rise in around six-and-halfmonths, taking the nationwide tally of infections to over 1.23 crore.

Odisha is home to 62 tribal communities constituting 23 per cent of the state's total population.

"The development and welfare of these tribal communities should be our priority. We should approach

A paternalistic attitude is wrong. The truth is that we have a lot to learn from tribal communities who live a simple life in harmony with nature," the Vice President said.

He also urged institutions like Utkal University to take up research on issues faced by tribal people and actively contribute to policy formation for their development and well-being.

Naidu also focused on the management of natural disasters that the coastal state faces regularly.

"You have seen regular occurrence of cyclones, floods and droughts in the state. Therefore, it is imperative to make disaster management an integral part of our education from the early days. This would prepare us better to face any such calamity in future. I hope Utkal University will take a lead in this regard," he said.

Naidu, while asking students to be sensitive to the needs of the excluded, said that discipline, honesty and hard work are the keys to success in any field, including public life.

'We have great economic potential and can improve the human development index on all counts. We can fight hunger, disease, ignorance and every other evil that retard our growth," he remarked.

Talking about the rich culture and history of Odisha, the Vice President said the great land of Kalinga taught lesson of peace to Emperor Ashoka

He also lauded the daring seafaring merchants of Kalinga, who established trade links with various countries.

"I want you (students) to take inspiration from their stories and imbibe the spirit of entrepreneurship and innovation. Our universities and educational institutions also have an important role in this. They should equip students with requisite skills so that they can emerge as job creators, not

The elephant also attacked three others, leaving them seriously iniured. The deceased has been identified as Manjulata Behera and the injured as Nityananda Behera, Mamata Bharimalla and Sasmita Bharimalla of Durgaprasad village.

According to a source, the four were working at the backyards of their houses. Suddenly a tusker came from nowhere and attacked Manjulata. The elephant took her by its trunk, thrashed her to the ground and trampled her to death before attacking others

The villagers rushed the injured to Khurda district headquarters hospital. Later, Mamata and Sasmita were shifted to AIIMS in Bhubaneswar as their conditions deteriorated. The incident triggered tension in the village as hundreds of villagers staged a sit-in on the village road, holding the Forest department responsible for the death.

Bhubaneswar, April 3: The Assembly Saturday passed six bills including the Odisha Lokayukta Amendment Bill on the last day of the session. The amendment was made to the Odisha Lokayukta Act, 2014 to allow re-appointment of the chairperson and members of the panel

Now, after completion of the tenure, the chairperson and members of the Odisha Lokayukta can get re-appointed in any other state. In the original Act, the government has restricted re-appointment of the chairperson and members across the country.

Similarly, the House passed a Bill to amend Odisha Fiscal Responsibility and Budget Management Act, 2005 to allow the state government to raise the level of fiscal deficit by another 2 per cent of the Gross State Domestic Product (GSDP).

As per the amendment, additional 2 per cent fiscal deficit includes unconditional borrowing of 0.5 per cent of GSDP and another 0.5 per cent bonus for completion of

As per the amendment, term of office of the vice-chancellor of BPUT has been fixed for four years

instead of the current five years. Also, designation of professor, reader and lecturer will be re-designated as professor, associate professor and assistant professor in line with all-India pattern.

An OAS officer, not below the rank of joint secretary, will now be appointed as registrar of BPUT to ensure better and efficient management of the university. Similarly, an Odisha Finance Service officer will be appointed as finance officer of BPUT. The move is seen as an attempt by the state government to have control in day-to-day univer-

sity affairs. Annual report of the university will be tabled in the Assembly while the vice-chancellor has been authorised to constitute selection committee for recruitment of teaching

and non-teaching posts. Other Bills passed in the Assembly include Xavier University Odisha (Amendment) Bill, Odisha Advocates' Welfare Fund (Amendment) Bill and Societies Registration (Odisha Amendment) Bill. All the five bills were passed without any participation of the Opposition BJP and Congress.

Bhubaneswar, April 3: The Comptroller and Auditor General of India (CAG) claimed, in its report tabled in the Assembly Saturday, claimed that revenue to the tune of ₹1,066.28 crore were under assessed/short levied or lost in 2018-

The audit report stated that the test checks of 170 out of the 352 units under departments dealing with VAT, entry tax, GST, excise duty, stamp duty, registration fees, motor vehicle Tax and other non-tax receipts for 2018-19 were complete.

"Test check of records of tax and non-tax receipts revealed underassessment/short levy/loss of revenue aggregating to ₹1,066.28 crore in 51,182 cases in 2018-19," the report

"Irregular expenditure/payment amounting to ₹74.21 crore in 207 cases were detected. The departments concerned accepted irregularities of ₹0.31 crore in 149 cases pointed out in 2018-19. An amount of ₹0.37 crore was realised in four cases pertaining to audit findings of previous years," the report added.

The CAG report also said that the assessing authority failed to apply appropriate provisions of the Odisha Value Added Act which resulted in short levy of penalty worth

BHUBANESWAR: The CAG report on Social and General Sector claimed several irregularities in the drug procurement and supply between 2016 and 2019.

The reported found several lapses on the part of Odisha State Medical Corporation Limited (OSMCL) in discharging its duties. The audit report said that due to shortage of drug supply, the health institutions were bound to procure drugs locally at exorbitant prices, leading to loss to the exchequer.

'There was inordinate delay of five and seven months in finalisation of annual procurement plans for drugs and medical consumables and six to 17 months in respect of

Equipment, Instrument and Furniture (EIF). Delay in finalisation of procurement plan impacted the procurement process and supply of drugs and medical consumables to health institutions," the report said.

'Out of 3,471 Purchase Orders

(POs) placed for supply of drugs and medical consumables, 791 (23 per cent) POs were partially executed and 252 (7 per cent) POs were not executed at all, which led to less supply of drugs and consumables to the health institutions," the report said.

The report also said, "Deficiencies in stock management led to expiry of 349 kinds of drugs valued at ₹4.18 crore during April 2017 to May 2019. Expiry of drugs was due to ineffective monitoring of indents, distribution, consumption, stock position of drugs through e-Niramaya software," the report said.

"Short supply of drugs and medical consumables by OSMCL led to the health institutions procuring these items locally incurring extra expenditure. During 2018-19, test checked health institutions had incurred extra expenditure of ₹98.12 lakh (44 per cent) in procuring medicines worth ₹2.24 crore," the report said.

Super specialty healthcare at VIMSAR soon



Price of Modi years

finished writing a book called the 'Price of the Modi Years' a few days ago. It should be published later this year. It is a history of India since 2014 and I have examined the facts and the data on various parts of the polity like the economy, national security, governance, the judiciary and so on. do not want to talk about the contents of the book because it has too much detail and in any case some of my views may already be familiar to readers. What I did want to talk about was where some of the material was

Of the sources that have been quoted in the book, the one that has been cited most — 85 times — is a website called TheWire.in. Another website, Scroll.in has been cited 54 times. In comparison, the Times of India has 37 citations. The reason for this is that I have found that the websites have carried more of the sort of reports that I was interested in than the newspaper

The fact is that in the last decade or so these websites and others like them like News Click and The News Minute and Alt News have become as important a source of news as the traditional media like newspapers. Most of these sites were founded by journalists and survive on donations and some grants. They are not owned by big business houses or traditional media houses, and that is one reason why their content is different. Traditional media is dependent on the Central government for several things. For instance, the Modi government spends ₹1,200 crore per year (₹100 crore per month) on advertising. The Central Public Sector Units spends another ₹1,000 crore or so. So roughly about ₹200 crore of money is given to media each month, an enormous sum which comes at a price.

Then there are other things, such as licenses for TV stations, free or subsidised land allotment and customs and import duties on machinery and newsprint (the paper that newspapers are made of). Then there are the various 'summits' that big media houses hold where they invite the Prime

Minister and various ministers to attend and speak. When the PM is displeased with a headline or story he has in the past cancelled his pres ence, leading other ministers to also cancel and leading event sponsors to complain that they did not get the full value of their sponsorship. All these make the traditional media vulnerable to government pressure in a way that the new websites cannot be.

And this is why the Modi government has introduced the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021. This oversight mechanism was created without a law and would function for the Internet as the Ministry of Information and Broadcasting did for TV regulation. The government was giving itself the power to censor and regulate all content on the Internet and even on messaging services.

The rules exempt e-newspapers, meaning that established publishing houses (those which receive money from the government) would be privileged over independent media houses like TheWire.in, Scroll.in and NewsClick.in. If you have a news website and also newspaper then your website will not to be regulated. If you have a news website and do not have a newspaper, vour website will be regulated

The Information Technology Act, 2000 did not extend to news media, and so the guidelines did

not have the legal authority to regulate news media. This change was pushed through by adding powers far beyond those in that parent legislation. The rules gave the government the right to regulate content put out by a "publisher of news and current affairs content", which is open-ended and

The new law also affects you directly as a citizen. It would require messaging services such as Whatsapp, Signal and Telegram to enable the identification of the creator of a piece of content (for example a cartoon criticising the PM that went viral). This requirement of traceability would break end-to-end encryption, which made these messaging services secure. Also, the originator of a message had no control over who forwarded the content, or how many times it was forwarded, or in which fora. Erotic content exchanged by a couple or group of friends could land up in a place where it would be seen differently.

The rules say there will be an "oversight mechanism by the Central government" (censorship) of video content that is published on all web-based platforms. The government can block content and also get platforms to publish scroll apologies. Major platforms took the cue and put out a joint 'self regulation toolkit' that portends self-censorship to align content with what the government wanted and, more importantly, not publish or broadcast what it did not want. Presumably they were encouraged by the fact that the Modi government called their executives in and threatened to jail them.

These developments do not bode well for India. The government is extremely powerful and the Prime Minister is very popular. The Opposition is still finding its feet and not able to strongly push back against the narrative of religious authoritarianism. India needs an independent media that can report what is happening in our country. And the government is attempting everything it can to make sure that this does not happen. India was ranked 142nd on the World Press Freedom Index. I wonder where it will be when the new rankings for 2021 come out next month.

ndia is growing and ought to grow after unplanned devastating lockdown of all economic and social activities. But the growth story for 2021 remains a mystery. The Economic Survey projected it at 11 per cent. RBI 10.5 per cent, International Monetary Fund 11.5 per cent, World Bank in a wide range of 7.5-12.5 per cent, and UN's ESCAP puts it at 7 per cent over a contraction of 7.7 per cent through 2020. The Economic and Social Survey

of Asia and the Pacific (ESCAP) report 2021 states, India entered the pandemic lockdown with subdued GDP growth and investment. "The pace of recovery further moderated in the fourth quarter 2020-21 with estimated year-on-year growth still close to zero." Plus, India's 2021 economic output is expected to remain below the 2019 level or K-shaped. This is almost at par with National Statistical Office (NSO) projection at 8 per cent contraction 2020-21, showing the lock down impact. It estimates that the pandemic has pushed an additional 89 million people in the region into extreme poverty in 2020.

On the other hand, ESCAP praises China for becoming the only major economy worldwide to achieve a positive annual economic growth rate in 2020. But for the rest of the region, including India, the recovery is likely to be K-shaped. The economists use U, V and W to forecast different kinds of financial future. The K-shape is a new symbol and portrays a troubling, divergent economic future, one where the economy rebounds unevenly and where the wealthy benefit while everyone else gets left behind.

This also bares the reality that the pandemic or not lockdown devastated economies like that of India, which were trying to improve their conditions pre-pandemic. The repeated fear psychosis and threatening of partial or complete lockdown again is likely to create more business uncertainties and delayed recovery.

Coupled with high policy quandary, officially-sponsored price rises through heavy taxes on petroleum, other fuels, in-

creasing toll-taxes on roads and consequent rise in fare, freight and rail costs, caused 5.03 per cent inflation in February, 2021, meaning despite wage contraction an individual's expenses increased by over 5 per cent. It may show a 'better' GDP in monetary terms but in reality it will be a regression, where people's purchasing power reduces. This leads to shrinkage in production as is indicated by fall in February core sector output by 4.6 per cent. It is exacerbated by lowering of deposit interest rates, taxes on provident fund and other accumulations, spree on privatisation, including that of giant public sector banks to private swindlers. These add to the market uncertainties and further possible regression.

The flip-flop policy on normalising relations with Pakistan, as the US Defence Secretary visits India and consequent refusal of Islamabad to walk the talk adds to further uncertainties. So does certain Indian companies' truck with Myanmar's military-controlled firms, slapped with UN sanctions.

The recent accidental blockage of the Suez Canal route could add to further inflationary pressures as India's 5 lakh barrels a day of crude import is to become expensive with tanker rates rising at least in the short run.

The disinvestment drive too has not succeeded during the past three years. Even now the policy, though being steamrolled, is raking up issues of how India would manage its future through an oppressive private sector for which all labour and financial policies, including interest rates are being compromised. Had India not accumulated such productive public sector organisations and nurtured banks, how could it have taken to the sales of family diamonds?

It has also raised questions of disposing off assets worth ₹2.10 lakh crore without a public discussion and at the whims of some people at the helms of a few institutions. The powers of money bill and whether this should be put in check or not is being continuously debated. Nobody has answered whether such sales would help the country or pauperise it.

There is no answer either to how the government promising two crore jobs would be able to provide employment to jobless. The unemployment rate in the country declined to 6.52 per cent in March from 6.90 per cent in February, as per think-tank Centre for Monitoring Indian Economy (CMIE). This conceals the real numbers, of job losses during 2020 lockdown and does not included millions of under-employed or semi-employed. The rural sector is in twin-crisis of poor cash flow and glut of agricultural produce. This is giving rise to discrimination, puts brake on industrial and manufacturing recovery and restoration of economic health.

The rising forex reserves to \$582 billion in March are not a very positive sign either. It speaks of contracting imports by 46 plus per cent and notional value increase (of about 21.7 per cent) in gold prices held by RBI since March 27, 2000.

India's taxation system has also drawn ire of the US on retrospective tax and digital service tax, as per a policy restricting imports in tune with Atmanirbhar Bharat. Various income-tax rules, TDS oppression and many other such set of laws like opening up of ten-year old cases is causing havoc of uncertainties

The uncertain Indian growth story, distress of the people due to complicated tax policies or little boost to production tells of a peculiar lack of thought process. The planning process needs to be reactivated for turning the economy to a fast track. The Narendra Modi government has to be proactive in reviewing the policies to regenerate the economic process even thawing its bid for privatisation. India needs to consolidate: the economic growth would be a corollary.

The unfolding tragedy of Tibet

ibet, famously called the roof of the world; a state in the Himalayas neighboured by India and China has for long been in a state of tussle with Beijing. This is among the many conflicts currently brewing in south Asia, probably the worse as far as the power imbalance is concerned. The water tower of Asia has for long witnessed the cold and dark nights under the communist regime of China. The process of democratisation is merely a ghost only if that ghost exists. This makes it imperative for the powers across the globe to play their role in fostering a dialogue between Beijing and Tibet, and only recently we have seen some improvement on that front and some progress will hopefully be on its way.

Tibetan people have struggled under the mighty and brutal fist of Beijing and since the independence of China we have been demanding our separate homeland. The division of Tibet into smaller units and segregating them from the mainland Tibet is a typical example of engineering. Tibet as known today is only a fraction of the historical mainland of Tibet. The Chinese have created a facade by giving the autonomous region of Tibet, which is what is left of Tibet after its repeated geographical divisions, an autonomy nonexistent in practice. People in Tibet demand the unification of all the parts which were historically part of Tibet, and post that want a complete political, economic and religious freedom. People in Tibet have tried to resist the imperialistic control of the communist China in Tibet and have always raised their demand for independent Tibet. The inspiration to the people of Tibet comes mainly from outer Mongolia and Bhutan, both countries are doing quite well in managing their affairs and their foreign policy.

The gross human violations in Tibet is not a new story and is not hidden from anyone despite the media ban and propagandistic approach adopted by Chinese government to have the control of one's destiny is the luxury Tibetans don't have. Young people are abducted from the tribal regions of Tibet and the same are inducted in People's Liberation Army, who are then sent to various regions of mainland China wherein they go

The freedom of religious expression is even more hit. The interference in the elections for Dalai Lama by China is not only protested against, but the proxy Dalai Lama which has been put in place in Tibet is not even revered by the people of Tibet. Tibetans have a strong notion of being separated from their religion and fears of Chinese Buddhism taking over Tibetan Buddhism under the protection of communist China. This is one of the grave situations as far as the freedom to profess and practice of religion is concerned.

The world needs to come together to solve this issue of gross human rights violation among other conflicts.

One wonders whether some head-strong leaders, like Mamata Banerjee, can ever mingle with the rest when it comes to fighting the BJP. However, Sharad Pawar, fresh from his "king-making maneuvers" in Maharashtra, may act as a fulcrum for the third front, if he can bring all non-Congress and non-BJP parties, that are unambiguous in ideology and agree on a common minimum programme, on a single platform. Pakistan's U-turn

Sir, Pakistan's recent overtures to mend fences with India, particularly on resumption of trade, was perceived as a welcome development in normalising the historically strained relations between the two countries. However, political compulsions of Prime Minister Imran Khan's party have ensured that the move was successfully scuttled which does not come as a surprise to India. Reeling under an unfavourable economic climate, Pakistan saw reason in importing at least cotton and sugar, among other things, from India whose prices had skyrocketed in recent days. But far from providing relief to its beleaguered people which resumption of trade with India might have ensured, Pakistan's insistence for resolution of the Kashmir tangle and restoration of Article 370 have, unfortunately, emerged as priorities in its scheme of things. While the Kashmir issue is non-negotiable to India and withdrawal of Article 370 purely its internal matter, India hopes that good counsel shall ultimately prevail leading to restoration of friendly ties between the two neighbours.

Centre withheld funds meant for Maha out of bias: Congress

Mumbai, April 3: The Congress in Maharashtra Saturday accused the Centre of short-changing the Maharashtra government by withholding its "rightful dues" to tide over the Covid-19 pandemic and other disasters like cyclones and heavy rains that had hit the state last year.

State Congress president Nana Patole also accused the BJP of acting irresponsibly amidst the pandemic, a day after Leader of Opposition Devendra Fadnavis said that Maharashtra was the only state in the country that didn't provide any assistance to the people during the crisis.

Film crew members booked for violating Covid-19 norms

Coins add weight to BEST staff salaries in unwanted way

Mumbai, April 3: A banking issue with the civic-run Brihanmumbai Electric Supply and Transport (BEST) undertaking has left around 40,000 of its employees getting a sizable portion of their salaries in the form of coins over the past few months, giving their renumeration an unwanted heft.

The undertaking, which operates a 4,000-bus strong transport system as well as supplies electricity to some 10 lakh consumers in the metropolis' island district, has been getting massive quantity of coins from passengers by way of ticket fare, as well as cash for

power bills. Senior BEST committee member

Sunil Ganacharya said the BEST has a huge amount of money lying in its coffers, but no bank is willing to take it from the undertaking's 100-150 collection points after a contract with a leading private sector bank ended last year.

Some BEST employees, who did not wish to be named, said that getting a small part of the renumeration in coins was always prevalent.

"However, the ratio has grown now. I got ₹11,000 in cash and coins in my last salary, while the coincash amount was ₹15,000 the previous month. We generally get ₹1,000 each, mostly in ₹2, ₹5 coins and ₹10 denomination notes, and some part in ₹10, ₹50, ₹100 and ₹500 notes. The rest is deposited directly into our bank accounts," an



employee said. Ganacharya rued the state of affairs and said this 'coins as salary'

mechanism has even led to some employees defaulting on their EMIs, among other things.

A BEST conductor said they try to tide over this "weighty" problem by exchanging the coins with passengers and shopkeepers, who need it in large numbers to run their daily businesses

"Several BEST employees stay in areas like Ambarnath, Badlapur, Panvel or Virar-Vasai and travel by suburban locals. It is very inconvenient and risky to carry so much cash, that too in coins," he said.

He added that the BEST committee had given its nod in January for an agreement to be signed with

a private bank for cash collection, but some issue was delaying the start of the pick-up mechanism.

A BEST conductor said they try to tide over this "weighty" problem by exchanging the coins with passengers and shopkeepers, who need it in large numbers to run their daily businesses.


Talking to PTI, Shashank Rai, BEST Workers' Union leader, said the mechanism of giving coins as part of salary was unacceptable and the inconvenience caused to the staff had been conveyed to the administration of the undertaking on several occasions.

BEST spokesperson Manoj Varade, meanwhile, said an agreement would be signed with a bank in two to three days, after which the bank will start picking up cash.

Magisterial probe ordered, 3 arrested

Guwahati/Silchar, April 3: The Karimgani District Magistrate (DM) has ordered a magisterial inquiry and the police arrested three people in connection with the Electronic Voting Machine (EVM) found in a BJP candidate wife's vehicle Thursday night, officials said

A district official said that the Karimganj DM Anbamuthan MP (Repeat Anhamuthan MP) has ordered the magisterial inquiry and entrusted Additional District Magistrate Rajeshan Terang to conduct the probe and submit the report within three days.

Meanwhile, the police also arrested three people for attacking the private car in which the polling personnel along the polled EVM were travelling after the completion of the second phase of polling Thursday.

Three more people are also detained for questioning.

Two separate FIRs were also lodged with the police by the driver of the private car and polling personnel. A delegation of Congress and its ally All India United Democratic Front (AIUDF) met the Karimganj District Superintendent of Police Mayank Kumar and demanded the release of six people immediately.

The Election Commission Friday suspended the presiding officer, three other polling officials and an armed escort official and ordered re-polling at the Polling Station no 149 in Indira MV School under Ratabari (SC) assembly constituency after an EVM was found in a BJP candidate's wife's vehicle Thursday night.

"Although the seals of the were found intact, it has nevertheless been decided to do a re-poll at the Indira MV School polling station as an added precautionary measure," the EC in a statement said

The statement had said that after the official car carrying the polled EVM machine to Karimgani broke down, the officials boarded a passing private car which was subsequently surrounded by a mob of about 50 people who started pelting stones at them.

The mob at Kanaishil (under Karimganj district) alleged that the EVM was being taken to be tampered with. The private car was owned by the wife of BJP candidate of the neighbouring Patharkandi constituency, Krishnendu Paul.

4 astronauts to stay on busy training schedule

Chennai, April 3: The four Indian astronauts returned to India last month after completing their training in Russia and will undergo different kinds of training here, Indian Space Research Organisation (ISRO) chief K Sivan said.

They had landed in India March 28. The four astronauts will undergo space mission specific training in India," Sivan told IANS.

The four Indian astronauts were training since February 2020 at the Gagarin Cosmonaut Training Centre (GCTC) belonging to Glavkosmos which is a subsidiary of Russian space corporation

According to Sivan, the four astronauts will continue to train till they board the Indian space module. The Rs 10.000 crore Indian human space flight mission is called Gaganyaan.

Queried about the training regime here, Sivan said, "The astronauts will have their physical fitness training that includes swimming, jogging. They will also have academic/theoretical classes as they have to understand the rocket. and the human space module."

'They will also be trained on simulators. The Gaganyaan module navigation terminals will be

simulated. The astronauts will be trained on various parameters that will be displayed on the terminals,' he added.

The astronauts will later work on the Gaganyaan module as if they are flying. "These apart, the astronauts will

be trained on survival techniques so that they can survive in the sea as their landing module will land on the sea waters." Sivan said. While the astronauts will be

trained in Bengaluru and the survival techniques in Cochin, ISRO will carry out the engineering work related to Gaganyaaan. Glavkosmos had earlier said the

four Indian astronauts were trained in abnormal descent module landing - in wooded and marshy areas in winter; on water surface, and in the steppe in summer. "In June 2020, all Indian astro-

nauts-elect passed training in shortterm weightlessness mode aboard the IL-76MDK special laboratory aircraft, and in July, they were trained to lift aboard a helicopter while evacuating from the descent module landing point," Glavkosmos had said. The Indian fighter pilots were also trained in a centrifuge and in a hyperbaric chamber to prepare their organisms for sustaining spaceflight factors, such as Gforce, hypoxia and pressure drops.

SARADHA CASE

ED attaches ₹3 cr assets of TMC leaders

New Delhi, April 3: The Enforcement Directorate (ED) on Saturday said it has attached assets worth Rs 3 crore of TMC spokesperson Kunal Ghosh, its MP Satabdi Roy and Debjani Mukherjee in the Saradha chit fund money laundering case.

It said a provisional order for attachment of the movable and immovable properties has been issued under the Prevention of Money Laundering Act (PMLA).



The central probe agency said in a statement that the assets belong to Kunal Ghosh, ex-Raiva Sabha MP from Trinamool Congress (CEO of Media Group Saradha), Satabdi Roy, Lok Sabha MP from TMC (brand ambassador in Saradha), and Debiani Mukherjee who is director in Saradha Group of companies in Saradha chit fund case.

Assets worth Rs 600 crore have been attached in this case till now. The ED is probing the money laundering aspect of the alleged ponzi scam since April, 2013.

The Saradha group allegedly cheated thousands of depositors, promising abnormally high returns on investments in its illegal schemes.

Ghosh, who is out on bail in the case, was suspended from the TMC in 2013 for alleged anti-party activities. He has been questioned by the ED in this case apart from others. He was later reinstated as

the party spokesperson.

What is driving mobile gaming amid the pandemic in India?

New Delhi, April 3: Amid the pandemic, especially the everythingfrom-home year, mobile gaming took off spectacularly in India. For consumers trying to deal with the prolonged social isolation, along with all the anxiety and ambiguity of the last year, mobile gaming provided a creative outlet.

From my vantage point, I know of loved ones and peers who took to mobile games more fervently during the past year. As we complete the pandemic anniversary, let us ponder over what is actually driving mobile gaming, and what does the fu-

As smartphones continue to be the central nervous system of human lives, the dependence on phones for work, for learning, and most importantly, for unwinding and socialising through gaming rose during the last year.

Much before the pandemic, mobile gaming was on the upswing, driven by the ubiquitous smartphones and the availability of low-

At CyberMedia Research (CMR), our ongoing research around gaming has thrown some interesting insights. For instance, mobile gaming in India is driven by an array of gamer personas, ranging from the serious to the hyper-casual gamers. The growth in mobile gaming was led not by serious gamers, but rather casual and hyper-casual gamers.

The democratisation of gaming can be traced to the smartphone usage. With smartphones, the need for dedicated gaming hardware devices is not felt. No consoles required. Additionally, mobile gaming apps evoke a sense of familiarity



with consumers. Think Puzzles. Or card games. With ease of access to such 'freemium' gaming apps online, more users than before, who typically do not identify themselves as

'gamers' have taken up gaming. Our research points out the gaming intents vary across consumer cohorts. For instance, serious gamers primarily play to 'relieve stress', while casual and hyper-casual gamers seek to have 'fun'. The choice of games is dictated by recommendations from friends and fam-

ily. Social networking and social messaging platforms are two of the prominent channels for consumer awareness around new games.

Today's gamers have, on an average, close to seven games installed on their mobile phones. Among these, there are at least four games that they play avidly. Interestingly, men prefer to unwind with mobile games in the early evening, while women mostly chose to play during late night. On an average, the duration of gaming play spans close to 90 minutes.

Indians have traditionally enjoyed freemium offerings and seek value. The spike in game time during the pandemic led many gamers

to veer towards paid gaming apps. For instance, six out of 10 serious gamers chose paid gaming apps, while others continued to use 'freemium' apps. Amidst the nationwide lockdown in early 2020, use of paid gaming increased by 15 per cent, while 'freemium' gaming apps increased by a mere 8 per cent. It will be interesting to see how this trend pans out in 2021 and beyond. 'Freemium' will probably

continue to be the mainstay.

When it comes to smartphones, today's gamers seek more -- more RAM, better battery life, increased storage, faster touch response and better processors.

Smartphone brands are responding to the evolving mobile gaming needs. They seek to differentiate themselves with a focus on high refresh rates for smoother performance, enhanced displays, and bigger batteries, among others.


As we look ahead, mobile gaming will only continue to become more mainstream. In doing so, it will become more exciting, more immersive and more social than before.

COVID SURGE India braces for COVID curbs

DAILY CORONAVIRUS CASES HAVE SURGED FROM AROUND 15,000 IN EARLY MARCH TO 88,000 OR SO AT THE START OF APRIL

Mumbai, April 3: India's biggest cities braced for stricter lockdowns and other COVID-19 curbs Saturday as infections hit a six-month high, as a month-long surge continued in the country third-worst hit by the pandemic.

India's richest state, Maharashtra, accounted for more than half of the 89,129 new cases reported by the national health ministry in the last 24 hours, with a record 47,827 infections.

The state's chief minister warned citizens of a lockdown if cases continued to rise at their current rate, saying medical infrastructure would be inadequate in a couple of weeks.

In the southern state of Karnataka, home to India's tech capital Bengaluru, authorities ordered gyms to be closed, barred functions at religious places and told cinema halls, bars, pubs and restaurants to limit the number of people allowed in.

India's capital, New Delhi recorded more than 3,500 cases, its highest this year, but its chief minister ruled out another lockdown for now.Daily coronavirus cases have surged from around 15,000 in early March to 88,000 or so at the start of April.



The south Asian nation recorded 89,129 new infections and 714 deaths, the ministry said. That was the biggest daily rise since Sept. 20 and the most deaths since Oct. 21, according to a Reuters tally.

India follows only the United States and Brazil in infections, with more than 12 million recorded since

the start of the outbreak. The government has intensified its vaccination drive in recent weeks,

but the shots have been slow to reach India's 1.3 billion people.

Prime Minister Narendra Modi has faced criticism for exporting vaccines produced in India when most Indians are yet to get them.

PUNJAB'S UK VARIANT

NEW DELHI: The UK variant of coronavirus found in Punjab is a potential threat due to its efficiency in spreading, while the double mutant found in Maharashtra is a matter of concern. but not a cause to create panic, suggested CSIR-CCMB Director Rakesh Mishra, Speaking with IANS, Mishra said the UK variant has contributed to the surge in cases in Punjab. "Somebody had travelled from the UK to Puniab, possibly in a group, and then people from this group would have gone to several places in Punjab, which has contributed to the surge. said Mishra. When asked why the UK variant has not been found majorly in cases in the neighbouring states of Himanchal Pradesh, Harvana and Delhi, Mishra said that may be those infected with the UK variant in Puniab have not travelled to places outside the state, or there has not been a super spreader event so far. However. it is a matter of time and there is a possibility that cases may show up later. Mishra noted. He added that both vaccines, AstraZeneca and Covaxin, are working well against the Puniab variant and the double mutant found in Maharashtra.

90 re-contesting Assam MLAs' assets grew 76% since 2016

New Delhi, April 3: The average assets of 90 re-contesting MLAs fielded by various political parties in Assam, including Independent nominees, grew by 76 per cent in the last five years between 2016 and 2021 -- a hike of around ₹1.91 crore -- according to the data released by Assam Election Watch and the Association for Democratic Reforms

Of these 90 MLAs, three BJP

leaders are in the top five list showing maximum increase in assets, followed by one from the All India United Democratic Front (AIUDF) and another the from Bodoland People's Front.

Assam **Election Watch** and ADR made

the revelations based on the analysis of the self-sworn affidavits of these 90 MLAs who are contesting the ongoing three-phase Assam Assembly elections which

began March 27. The third and final round of polling will be held April 6, while the results will be declared May 2. The average asset of these 90 MLAs in 2016 was ₹2.52 crore. Now,

their average assets range is ₹ 4.44 crore. The average asset growth for these MLAs, between the Assam Assembly elections of 2016 and 2021 is ₹1.91 crore, the data said.

BJP MLA from the Dhakuakhana (SC) constituency, Naba Kumar Doley, has declared maximum increase in assets with a rise of ₹18.22. crore, from ₹7.30 crore in 2016 to ₹25.52 crore this year.

The assets of Nijam Uddin Choudhury of the AIUDF from the Algapur constituency increased


ISRO ESPIONAGE CASE

Probe panel submits report on Nambi's illegal arrest

New Delhi, April 3: A high-level probe panel appointed by the Supreme Court to take erring cops to task for causing "tremendous harassment" and "immeasurable anguish" to ISRO scientist Dr Nambi Narayanan in the 1994 espionage case has submitted its report to the apex court, sources said.

The SC had September 14, 2018 appointed the three-member panel headed by its former judge D K Jain while directing the Kerala government to cough up ₹50 lakh compensation for compelling Narayanan to undergo "immense humiliation". The scientist was arrested when the Congress was heading the government in Kerala. The panel, after investigation, submitted its report in a sealed cover to the apex court



The CBI, in its probe, had held that the then top police officials in Kerala were responsible for Narayanan's illegal arrest

The case also had its political fallout, with a section in the Congress targeting the then Chief Minister late K Karunakaran over the issue, that eventually led to his resigna-

Over a period of almost two-anda-half years, the panel headed by Justice Jain examined the circumstances leading to the arrest.

The espionage case, which had hit the headlines in 1994, pertained to allegations of transfer of certain confidential documents on India's space programme to foreign countries by two scientists and four others, including two Maldivian women.

The 79-year-old former scientist, who was given a clean chit by the CBI, maintained that the Kerala Police had "fabricated" the case and the technology he was accused to have stolen and sold in the 1994 case did not even exist at that time.

Narayanan had approached the

apex court against a Kerala High Court judgement that said "no action needed to be taken" against former DGP Siby Mathews, who was then heading the SIT probe team, two retired superintendents of police, K K Joshua and S Vijayan, and the then Deputy Director, Intelligence Bureau, R B Shreekumar, who were later held responsible by the CBI for the scientist's illegal arrest. The apex court in its judgement had said, "We think that the obtaining factual scenario calls for constitution of a committee to find out ways and means to take appropriate steps against the erring officials. 'The criminal law was set in mo-

tion without any basis. It was initiated, if one is allowed to say, on some kind of fancy or notion," a bench headed by the then Chief Justice Dipak Misra had said.

'We are of the view that the appellant was arrested and he has suffered custody for almost 50 days. His arrest has been seriously criticised in the closure report of the CBI. From the aforesaid report, the harassment and mental torture faced by the appellant is obvious," the bench had added.

The judgement had said the "entire prosecution" initiated by the state police was "malicious and it has caused tremendous harassment and immeasurable anguish" to Narayanan. "It can be stated with certitude" that the fundamental right of life and personal liberty of Narayanan was "gravely affected"

The CBI, while giving a clean chit to the scientist, had said that Siby Mathews had left "the entire investigation to IB surrendering his duties" and ordered indiscriminate arrest of the scientist and others without adequate evidence.

The case had caught attention in October 1994, when Maldivian national Rasheeda was arrested in Thiruvananthapuram for allegedly obtaining secret drawings of ISRO rocket engines to sell to Pakistan.

Kenya stops import of COVID-19 vax

Nairobi: Kenya has ordered an immediate suspension on private importations of vaccines citing fears that it may lead to counterfeit inoculations getting into the country. Private health facilities have been charging about \$80 for the Russian Sputnik Vaccine, while the governments institutions are giving for free AstraZeneca-Oxford vaccines received from the global COVAX initiative that was created to ensure that low- and middleincome countries have fair access to vaccines.

5 dead in Myanmar, protests continue

Nay Pyi Taw: Five people were killed across Myanmar Saturday as the military continues to crack down on the ongoing protests against the February 1 coup. Despite the threat of violence, people throughout the country turned out to oppose the military takeover, including in Mandalay, Mon and Kayah states and in the Sagaing and Tanintharyi regions.

Islamabad, April 3: Prime Minister Imran Khan decided that Pakistan cannot go ahead with any trade with India under the current circumstances after holding consultations with key members of his Cabinet on importing cotton and sugar from the neighbouring country, a media report said Saturday.

The prime minister after consultations Friday instructed the Ministry of Commerce and his economic team to immediately take steps to facilitate the relevant sectors, value added, apparel and sugar, by finding alternative cheap sources of import of the needed commodities, the Dawn newspaper quoted sources as saying.

Various proposals have been presented to the Economic Coordination Committee (ECC) which considers these suggestions from an economic and commercial point of view. After consideration by the ECC, its decisions are presented to the Cabinet for ratification and final approval, the report said.

The ECC had decided on commercial grounds to recommend these imports for the Cabinet's consideration.

While the decision was not on the formal agenda of the Cabinet meeting, the issue was brought up by Cabinet members and the Prime Minister instructed that the ECC's decision be deferred and immedi-

ately reviewed, the report said. The Cabinet headed by Prime Minister Khan rejected the proposal of the high-powered committee to import cotton from India, with Foreign Minister Shah Mahmood Qureshi asserting that there can be no normalisation of ties until New Delhi reverses its decision in 2019 to revoke the special status of Jammu and Kashmir.

Pakistan's U-turn came a day after the ECC, under newly-appointed Finance Minister Hammad Azhar, recommended importing cotton and sugar from India, lifting a nearly two-year-long ban on its import from the neighbouring country amidst tensions over the Kashmir issue.

India has said that it desires normal neighbourly relations with Pakistan in an environment free of terror, hostility, and violence

India has also told Pakistan that "talks and terror" cannot go together and has asked Islamabad to take demonstrable steps against terror groups responsible for launching various attacks on India.

The ECC's decision had raised hopes of a partial revival of Pakistan-India bilateral trade relations, which were suspended after the August 5, 2019 decision of New Delhi to revoke the special status of Jammu and Kashmir.

In May 2020, Pakistan lifted the ban on the import of medicines and raw material of essential drugs from India amidst the COVID-19 pandemic

India's move to revoke the special status of Jammu and Kashmir in 2019 angered Pakistan, which downgraded diplomatic ties and expelled the Indian High Commissioner in Islamabad. Pakistan also snapped all air and land links with India and suspended trade and railway services

Nepal Oppn seeks Oli's resignation

Kathmandu, April 3: Nepal Prime Minister KP Sharma Oli who is in trouble inside his own party, is likely to face tougher days ahead as the primary opposition, Nepali Congress (NC) has decided to seek his resignation and initiate the formation of a new government under its leadership.

The decisions were taken at a Central Working Committee (CWC) meeting of the NC.

A section of the party led by former Prime Minister Madhay Kumar Nepal is forming parallel party structures within the UML after Oli suspended four senior leaders, including Nepal, for six months.

Oli accused Nepal and other leaders for being involved in antiparty activities and violating rules and norms

After Oli dissolved the House December 20, 2020, a section of party leaders upped the ante against the Prime Minister and sought his resignation.

February 23, the Supreme Court of Nepal reinstated the House but Oli refused to step down.

The apex court March 7 dropped another bombshell invoking the 2018 party merger between Oli's UML and Pushpa Kamal Dahal Prachanda's Nepal Communist Party-Maoist Center.

Nepal, who was earlier close with Prachanda, returned to his mother party but Oli refused to incorporate them for supporting Dahal when the party was united under the banner of Nepal Communist Party.

After Oli refused to welcome Nepal and his faction inside the

old party, the Prime Minister's party has once again landed in

fresh trouble. After the Supreme Court split the Nepal Communist Party into two. the UML and Maoist Center, now, the Prachanda-led Maoist Center is also preparing to withdraw support lent to Oli in 2018 before the party unification.

If Maoist Center withdrew its support, Oli's party will automatically reduce to a minority gov-

In that case, either Oli has to take a vote of confidence or face a no-confidence motion. Nepali Congress's decision to

seek Oli's resignation is a welcome step and time has come to remove Oli, former Prime Minister Baburam Bhattarai said Saturday. Time has come for other opposition parties to play their role, Bhattarai said, adding, today our foremost priority is to remove Oli. Meanwhile, Oli said that he was also aware of what the opposition are doing.

"First withdraw your support to the government. Then I will resign," he said, adding that this is not the first time that his resignation has been sought.

"I cannot resign to meet each and every demand. Meantime, the Nepali Congress'

decision to seek Oli's resignation and unseat him, could create a new political equation in Nepal. If three opposition parties, Nepali

Congress, Maoist Center and Janata Samajbai Party come together, they will easily unseat Oli. And party_ leaders have said that now time has come to expedite talks between the opposition to unseat Oli

BANGLADESH TO IMPOSE WEEK LONG LOCKDOWN

Dhaka, April 3: The Bangladesh government has decided to enforce a one-week lockdown from April 5 to control the new Covid-19 wave in the country, a Minister announced Saturday.

The Police, Crime, Sentencing and Courts bill would toughen measures, officers can take to disperse demonstrations, such as imposing time and noise limits, which campaigners and activists fear would be used to curb dissent.

Demonstrations had not been permitted while a coronavirus lockdown was in place, but restrictions were eased this week, meaning organised rallies can go ahead providing they are "COVID secure".

In London, police warned, "enforcement action will be taken, if needed, in the interests of public health". Some senior officers have said the "kill the bill" tag was deliberately provocative as "the bill" is a nickname in Britain for the police.

New Delhi, April 3: Natural gas production remains a loss-making proposition for most fields for the Indian upstream producers as government-dictated gas price remains at its lowest level, rating agency Icra has said.

The domestic gas price notified at \$1.79 per million British thermal unit for the six months beginning April 1 remains the lowest since the institution of the modified Rangarajan formula.

Additionally, the ceiling on price for gas produced from deep water, ultra deepwater, high temperature and high-pressure fields has also been announced at \$3.62 per mmBtu for April-September 2021-22 which is 10.8% lower than the price ceiling of \$4.06 for October-March 2020-21 which would dampen the development of such projects.

"While this is unfavourable for do-



mestic producers, it will benefit gas consumers. The consumers will also benefit in the long run from the expectations of continued supply overhang." Icra said commenting on the gas price notified by the government earlier this week.

As per an Icra note, at such low gas prices, gas production remains a loss-making proposition for most fields for the Indian upstream producers notwithstanding some decline in oil field services/equip-

However, the depreciation of Indian Rupee against US dollar, would aid the realisations of the gas producers but only to an extent.

Sabyasachi Majumdar, Senior Vice-President & Group Head, Corporate Sector Ratings, Icra, said, "Going forward, the supply glut is expected to keep prices of domestic gas low in the near to medium term leading to poor re-

turns even as domestic gas producers such as ONGC and Reliance Industries Ltd (RIL)-BP ramp up gas production significantly."

The absence of a floor and sustained low prices as has been seen in the past few years post implementation of the modified Rangarajan formula make exploration and production unviable even for benign geologies, Icra noted.

"Accordingly, low natural gas prices remain negative for the upstream sector adversely impacting revenues, profitability and cash accruals and the incumbents have petitioned the Government of India to provide a floor price for gas prices.

Spot LNG prices had breached \$30 per mmBtu in February 2021 due to increase in oil prices, unplanned outages at export facilities in several countries, multiple cold waves, high shipping rates and delays in



These tax filers will now be permitted to declare invoices pertaining to move-

ment of goods and services in **FILERS** their quarterly return form GSTR 1 to be filed in the last month of each quarter.

As per an advisory issued by the Goods and Services Tax Network (GSTN), the taxpayer must ensure that any saved but not Filed/Submitted IFF (Invoice Furnishing Facility) records for the first two months of the quarter i.e. month of Jan-2021 or Feb-2021 must be deleted using RESET button before filing GSTR-1 for Jan-Mar-2021 quarter.

Miami, April 3: Former junior skiing champion Jannik Sinner has joined some fast company at the Miami Open. The 19-year-old Italian Friday became the fourth teenager to reach the Miami men's final. The others: Novak Djokovic, Rafa Nadal and Andre Agassi.

"It's nice, but it doesn't mean anything," Sinner said. "The road to have a big name is long. It's not done in one week of a tournament."

Sinner, who chose tennis over skiing at age 13, is plaving in only his third top-level ATP event. He rallied in the semifinal to beat Spanish counterpuncher Roberto Bautista Agut 5-7, 6-4, 6-4.

Sinner will next face No.26-seeded Hubert Hurkacz of Poland, who advanced to his first ATP Masters 1000 final by beating No.4 Andrey Rublev 6-3, 6-4. Hurkacz, 24, improved to 9-0 in Florida this year, including his second career ATP title in Delray Beach in January.

Djokovic, Nadal and Roger Federer skipped the tournament, creating opportunities for the four semifinalists.

"I have a good team. We knew many players were not coming here, especially the big three," Sinner said. "We approached this tournament to go very, very far."

On the women's side, No.1-ranked Ash Barty will play for her second consecutive Miami title Saturday against No.8 Bianca Andreescu, who edged No.23 Maria Sakkari in a three-setter, Friday. "I love a challenge," Andreescu said, "and I know she's going to challenge me

The lanky Sinner, seeded 21st, has improved his ranking from 78th at the start of last year. He created a buzz by reaching the quar-

terfinals in his French Open debut in September and is projected to climb to at least No.24 next week.

"He has everything, no?" Bautista Agut said. "He has a big serve, he's big, he moves well, he has very good groundstrokes. Mentally he's also great and improving. He has a great future."

Sinner's matchup against the No.7-seeded Bautista Agut was a contrast in styles, with Sinner's overpowering groundstrokes gradually wearing down his dogged opponent.

Sinner caught a break at 3-all in the second set, when Bautista Agut let a ball go on break point, and it landed on the line.

"I thought that ball was going out, and it touches the line by one millimetre," Bautista Agut said. "Tennis, sometimes it's crazy, no? One ball can make a big difference

Sinner went on to hold and broke in the final game of the set to even the match. Down a break in the final set, Sinner rallied again and closed out the win with one last crushing groundstroke to break at

A fist pump was the extent of his celebration. He has an impassive demeanor he attributes to his parents, who make their living at a restaurant in northern Italy—his dad as a cook, his mother as a server.

UMESH STILL DETERMINED

New Delhi, April 3: India pacer Umesh Yadav says he can 'mostly pull his body for another two to three years' and wants to make a match-winning contribution in the World Test Championship final against New Zealand in June.

Umesh has played 48 Tests in a stop-start career and is part of arguably India's best-ever pace attack, which also includes Ishant Sharma, Mohammad Shami and Jasprit Bumrah.

Despite doing well over the last three years, Umesh is not a sure starter in the playing eleven considering the competition which has gotten stiffer with the emergence of Mohammad Siraj.

"I am 33 now and I know that I can mostly pull my body for another two or three years, and there will be some youngsters who will be arriving (to play). I feel this is just healthy, because it ultimately ends up benefiting the team.

When you have five or six fast bowlers on a tour of four or five Tests, you can play each one of them for two games to help reduce their stress and workload, so it helps that pack (of fast bowlers) play for longer," Umesh told 'ESPNcricinfo'.

Umesh has bowled more at home than overseas but feels experience helps him to perform in all conditions. "So I haven't played much overseas, and I haven't had much experience of those kinds of wickets. But I've played a fair amount of Tests so far and learnt with experience how a particular surface will behave.

"As far as the rest of my career is concerned, thank god that relatively I haven't had that many injuries. And that is satisfying as a fast bowler, because once a fast bowler starts getting injured (regularly), he tends to start struggling, which ultimately reduces his (playing) life.

"After an injury, there is the recovery, and then you need a rehab, which consumes a lot of time, which you can never get back. But I have lost very little time to injury periods, which has kind of helped me lengthen my career. So I haven't had to compromise a lot on my

Dada obsessed with 'match-winner' Pant

New Delhi, April 3: BCCI president Sourav Ganguly says he is 'obsessed' with Rishabh Pant's game and calls the swashbuckling India wicketkeeper-batsman 'an absolute match-winner'.

The former India captain added that he loves watching the likes of Virat Kohli and Rohit Sharma bat. "There are some fantastic players and I think as President of the Board I should not say who is my favourite player. All are favourite to me but I enjoy Kohli, I enjoy Rohit Sharma," Ganguly said during an interactive session organised by Classplus, a platform for educators to go digital.

"I am obsessed with Rishabh Pant because I think he is just an absolute match-winner. Jasprit Bumrah is good, Mohammed Shami is good, I like Shardul Thakur a lot because he has got the courage and guts.

"There is immense cricketing talent in India. When (Sunil) Gavaskar was there people used to



think what will happen after him, then came (Sachin) Tendulkar, (Rahul) Dravid, Anil Kumble. When Tendulkar, Dravid left, Virat Kohli, Rohit Sharma, Rishabh Pant took over," he said. "There is so much talent for cricket in India that I think it will produce world beaters in every generation."

Ganguly, who was picked for

India's tour of Australia in 1992 but didn't get a single game, recalled how that experience Down Under and the hard work that followed in the subsequent years made

"I consider my 1992 series as a failure. To be honest I didn't get much opportunities to play and I came back from the tour of Australia,

him a better cricketer.

but I was young. That (series) actually helped me to become a bet-"I came back stronger mentally.

I was not fitter, I understood what international cricket was all about. I started to train myself over the period of 3-4 years not just physically but mentally also on how to handle the pressure," he recalled.

"My series in Australia in 1992 actually helped me become a better cricketer. When I went to England in 1996, I was much stronger. I knew what it takes to score runs in international level.

"I had another four years of domestic cricket under my belt where I kept scoring runs. Those four years I think was a blessing in disguise for me. Failures makes you better cricketer."

Ganguly, who underwent two rounds of angioplasty at a Kolkata hospital in January after complaining of chest pain, said he is hale and hearty now. "I am absolutely fit and fine and back to work, doing everything as I did before."

STRENGTHS

RCB have assembled a strong batting line up on paper. Run-machine Kohli, who enjoys an impressive record as an opener in the league, has already confirmed that he will be opening the in-

Partnering Kohli will be the highly-talented Devdutt Padikkal who impressed everyone last season and is in red-hot form.

Young wicketkeeper-batsman Mohammad Azharuddeen, who had a staggering strike-rate of 194.54 in the Syed Mushtaq Ali Trophy, and New Zealand's Finn Allen are other attacking options at the top. De Villiers and Maxwell add the firepower to the middle-order while Sachin Baby, experienced Daniel Christian and Washington Sundar add to the depth.



RCB possess a potent spin battery and it augers well for them that they will be playing a major chunk of their matches on the slow tracks in Chennai and Ahmedabad.

Leg-spinner Yuzvendra Chahal



has enjoyed a lot of success in the league and will be eager to weave magic with the ball. He will be joined by the immensely accurate off-spinner Washington, who was Kohli's go to man in the powerplays last season.



The two will have assistance from Maxwell, who consistently bowls for Australia in white ball cricket and in the Big Bash League, while Australian Adam Zampa is another available leg spin option.

The RCB pace department does

not inspire confidence. Navdeep Saini and Mohammed Siraj lack the experience of bowling with the white ball and have a propensity of leaking runs.

Jamieson has struggled in T20Is and has no experience of playing in India. Other options include medium pacer Harshal Patel, and the Australian trio of Christian, Daniel Sams and Kane Richardson.

OPPORTUNITY

The presence of several bighitters in the team could go in RCB's favour while chasing big totals. It is also the perfect opportunity for Maxwell to set the tournament ablaze. A proven match winner for Australia, the allrounder has been a disappointment in the IPL.

RCB have two attacking batsmen in the uncapped Azharuddeen and Sachin, who would be keen to grab on to their opportunities.

THREATS:

Maxwell is a vital cog in RCB's grand scheme of things this season. If he tanks with the bat, it could have disastrous consequences for the side.

The over-reliance on Kohli and de Villiers continued last year despite big signings. The Indian batsmen in the team need to step up to avoid going the familiar route.
