India tops global Covid charts

Country surpasses US and Brazil and hits highest average daily tally

New Delhi, April 5: India' daily Covid-19 tally is now the highest in the world, surpassing Brazil and the US, as it recorded over one lakh cases in the last

During the past one day, Brazil recorded 31,359 new Covid-19 cases, while US logged 34,282. Besides this, India, which now recorded an all time high of 1.03.558 new cases, has also surpassed Brazil's average tally of 64,324 and the US's 64,019 to become the biggest hotspot.

It is now recording an average of 78,489 Covid-19 cases per day, based on a 7-day moving average to visualise the number of new Covid-19 cases and calculate the rate of change.

Notably, India, which is witnessing the second wave of the pandemic, added 5,49,423 Covid-19 cases over the last week, while US and Brazil logged 4,42,981 and 4,50,268 cases, respectively.

Daily cases in India had peaked September 16 last year, with 97,894 people testing positive for the virus in a single day

GOVT HINTS AT DAY CURFEW

BHUBANESWAR: Quick on the heels of night curfew in 10 districts, Health Minister Naba Kishore Das Monday said day curfew will be imposed, if required. Speaking to mediapersons here, Das said the state has been witnessing a surge in daily COVID-19 caseload with cases being detected from railway stations, airport and a number of educational institutions. "The state government is closely monitoring the situation and will take a decision on imposition of day curfew, if need be. As of now, District Collectors have been asked to closely monitor the situation," he said. Night curfew has been enforced in 10 districts from Monday. The districts included Sundargarh, Jharsuguda, Sambalpur, Bargarh, Balangir, Nuapada, Kalahandi, Nabarangpur, Koraput and Malkangiri. Speaker SN Patro Sunday said the Chief Minister is reviewing the COVID-19 situation and a decision on day curfew is likely to be taken in 4-5 days. Later, the

SRC said there was no such plan.

Covishield crunch

BHUBANESWAR: While Covid-19 cases are rapidly rising in the state, the government is headed for an acute shortage of Covishield vaccine. Bijay Panigrahy, Director of Health and Family Welfare, said there is a stock of about six lakh doses of Covishield that will last for two days. The government has sought supply of more vaccines. It has requested the Centre to supply minimum 15 lakh Covishield doses immediately in view of the surge in cases and the heat wave. However, only 3,49,130 doses haev been assured. Keeping in view the heatwave, timings for Covid-19 vaccination at all centres will change with immedi ate effect. Additional Chief Secretary, Health and Family Welfare PK Mohapatra directed officials to conduct vaccination at all sites between 8 am and 12 noon and 3 pm and 6 pm.

New Delhi, April 5: The Supreme Court has set April 19 to hear a petition filed by Saudamini Sahu, the mother of 5-year-old girl, Pari, pleading the Supreme Court to order an independent probe by CBI into the alleged rape and murder of Pari in July last year in

Jadupur, Nayagarh. The case was heard by registrar of the Supreme Court Raiesh Kumar Goel through video conferencing Monday and asked the registry to list the case before the bench of Justice AM Khanwilkar for hear $ing.\,The\,registrar\,observed$ that the state of Odisha has already filed the counter affidavit and the CBI may file

During the hearing, the counsel appearing for Saudamini Sahu, advocate Swastik Dalai, implored the registrar for the urgent listing of the case. The counsel argued that the case pertains to the investigation into the rape and murder of a minor girl as well as the rampant organ trafficking.

Earlier, Odisha Police had filed an affidavit in the case stating that there is no need of directing a CBI probe in the murder and rape of Pari as the Orissa High Court had monitored the investigation done by SIT in the case. The Odisha Police had submitted in the SC that the forensic department of SCB negated the charges of the missing of organs and bones of the victim.

₹50L seized ahead of Pipli bypoll



Bhubaneswar, April 5: Police and special squad Monday seized around ₹50 lakh unaccounted cash from the possession of two persons near Pipli. The two men on a motorcycle were caught at Tarakaj Square when they tried to give the police a slip during a routine check. They were detained for interrogation.

The two men, who hail from Balanga area in Puri district, did not stop at the frisking point. They were chased by the police and intercepted at Tarakaj Square. The seized money was in the denomination of ₹500 in 20 bundles, Pipli tehsildar Sapan Kumar Nanda said.

Later, the amount was seized from them and they were detained. The two were identified as residents of Balanga area. Further investigation by the police was underway to ascertain the source of the money, police source said.

The BJD, in a petition to the Chief Electoral Officer (CEO), alleged that the two men belonged to the BJP. French report claims payment of 1.1 mn euros in Rafale deal

New Delhi, April 5: The Congress Monday sought a thorough probe in the Rafale jet deal and demanded answers from Prime Minister Narendra Modi after a French media report claimed that a payment of 1.1 million Euros was made by the aircraft manufacturer to a "middleman", a charge denied as "completely baseless" by the BJP.

Referring to the report by Mediapart, a French online journal, Chief Congress spokesperson Randeep Surjewala claimed that the report has proved that there was corruption in the biggest defence deal, and asked why action should not be taken against those involved, including Dassault Aviation, for violating the defence procurement procedure, which clearly entails that there will be no middlemen.

Hitting back at the Congress, BJP leader and Union minister Ravi Shankar Prasad dismissed as "completely baseless" the allegations of corruption in the Rafale deal and said the opposition party made a big issue of the defence deal in 2019 Lok Sabha polls but lost badly.

India's backward states lead power demand recovery

Chennai, April 5: India's less industrialised states have led a recovery in electricity demand that began in September, a Reuters analysis of government data showed.

Power use in less industrialized states such as Bihar and Chhattisgarh in the east, and Uttar Pradesh and Punjab in the north, grew at over 10% each compared with the previous year, both for the quarter and the six months ending on March 31, the data showed.

All these states - which have high agricultural and residential power consumption - consumed more electricity than in the previous year, though India's annual power demand fell for the first time in at least 35 years in 2020/21.

The imposition of coronavirus lockdowns resulted in a fall in electricity consumption for six straight months through August, but consumption has since risen for seven consecutive months, with usage in March rising at the

fastest pace in 11 years. Industries and offices account for half the country's annual electricity consumption. Senior government leaders including Prime Minister Narendra Modi have cited the recovery in demand for power as a sign that the economy is also beginning to recover from


its worst slump in decades. More industrialised states such as Maharashtra, Tamil Nadu and Guiarat witnessed a decline in annual electricity use during 2020/21, according to an analysis of the federal electricity grid regulator POSOCO's daily load despatch data. Power demand growth in

Maharashtra and Tamil Nadu have lagged the national average in the last seven years, but consumption in Gujarat has grown faster than national average during that period, government data shows.


During the latest quarter, electricity consumption grew 7.3% in Maharashtra, India's most industrialized state.


However, Tamil Nadu - where a large number of major automakers are located - saw its electricity consumption fall 2.8% in the same period. Consumption grew at 9.4% in the western state of Gujarat during the quarter, but it fell marginally in Karnataka - a southern state with a large tech industry.





HE dept under secy show-caused for dereliction of duty

Bhubaneswar, April 5: Higher Education department Monday directed Minati Bhuyan, under secretary of the department, to submit a written statement within 30 days for the alleged dereliction of duty and for violating Rule 3 of Odisha Government Servants Conduct Rules, 1959.

Issuing a memorandum, principal secretary to Higher Education department said, "As per report, Minati Bhuyan, working in University Non-Establishment Section, has not taken proper step in time for release of Rs 9 crore in favour of Rajendra University, Bolangir. The same was put up March 22, 2021 after the deadline for issue of sanction order was over March 20, 2021 which caused a grievous situation.'

Although the government approval was obtained February 24, 2021 for sanction of Rs 9 crore in favour of Rajendra University under ID grant for the current financial year and she had sufficient time to monitor the matter. she failed to do so

The memorandum adds, "If she fails to submit the written statement within the stipulated time, it will be presumed that she has no explanation to offer and strict action will be taken against her as per rules."

Cop in soup for forcing sepoy to arrange girls'

Bhubaneswar, April 5: The twin city Police Commissioner Monday ordered a probe into the allegations levelled by the wife of a sepoy that her husband was forced to attempt suicide after he was threatened with transfers by the Deputy Commissioner of Police (DCP),

In her complaint to the police commissioner, Sunita Lenka, wife of the sepoy, alleged that her husband, Nihar Ranjan Nayak, tried to end his life after DCP Bijay Kumar Sahoo threatened him with transfers when Navak expressed his inability to 'arrange women' as demanded by the senior official.

"I have ordered Additional Commissioner of Police, Rekha Lohani to conduct a thorough probe into the allegations," police commissioner Saumendra Priyadarshi

Earlier in the day, Sunita lodged a complaint before the commissioner alleging that the senior official was illegally forcing her husband to 'arrange women'.

officer and he used to force my husband to provide women to him. When my husband expressed his helplessness, he held a grudge against him and threatened him at regular intervals with transfer and dismissal from service," Sunita pointed out, demanding action against Sahoo.

Dubbing the allegations against him false and baseless, Sahoo said, "False allegations have been made by the sepoy's wife in order to avoid transfer of her husband. I am requesting senior officials to inves-

These villages are the epicenters of five-decade old territorial dispute between the two states.







State to spend ₹2,548 cr under ICDS in 2021-22

CHIEF SECRETARY DIRECTS OFFICIALS TO FOCUS ON DEVELOPING THE AWCs TO NEXT LEVEL

Bhubaneswar, April 5: The State government has decided to spend ₹2,548.37 crore under Integrated Child Development Services (ICDS) in the year 2021-22.

The State Level Empowered Committee headed by Chief Secretary Suresh Chandra Mahapatra approved the Annual Programme Implementation Plan (APIP) of ₹2,548.37 crore for ICDS Monday.

Out of the total estimation, ₹2,341.43 crore is meant for Anganwadi services including supplementary nutrition, uniform, medicine kit equipments etc for children and ₹7.42 crore earmarked for care of adolescent girls in the age group of 11-14 years. ₹199.52 crore is for Poshan programme.

The principal components of adolescent girl care scheme include the nutrition support at the rate of ₹9.50 per girl for 300 days. Besides, ₹1.10 lakh per project is invested



₹2,341.43 crore is meant for Anganwadi services including supplementary nutrition, uniform, medicine kit equipments etc for children

₹7.42 crore earmarked for care of adolescent girls in the age group of 11-14 years. ₹199.52 crore is for Poshan programme

Around 35.08 lakh children are under the fold of Anganwadis. Besides, around 7.32 lakh pregnant and lactating women along with 13,082 adolescent girls are also being served through AWCs of these projects

towards supply of iron folic acid supplement, health check-up and referral services, nutrition and health education, skill training etc.

Mahapatra asked respective officials to develop the Angawadis to the next higher level through district specific plans. He emphasized on facilities for the children like safe electricity, toilet, drinking water and learning through playing. The care of drop-out adolescent girls in the age group of 11 to 14 was also emphasized by the Chief Secretary.

The Women and Child Development (W&CD) department was directed to have Aadhaar linking of all the adolescent girls included under the 'scheme of adolescent girls'.

W&CD Secretary Anu Garg said, "Presently four broad programmes namely Sakshyama Anagnawadi services, Supplementary nutrition, Scheme for adolescent girls and Poshana are being implemented through 338 ICDS projects with fund sharing from state and central governments."

Director Social Welfare, Arabind Agrawala said around 35.08 lakh children are under the fold of Anganwadis. Besides, around 7.32 lakh pregnant and lactating women along with 13,082 adolescent girls are also being served through AWCs of these projects.

573 new cases push Covid tally to 3,43,268

Bhubaneswar, April 5: Odisha's Covid-19 tally Monday mounted to 3, 43, 268 after 573 more people tested positive for the infection, the highest single-day spike this year, a Health department official said.

The new cases were detected in 28 of the state's 30 districts, with 337 cases reported from different quarantine centres, while the remaining 236 were local contact cases, he said. Khurda district of which the state capital Bhubaneswar is a part reported the highest 96 cases followed by Sundergarh (80) and Nuapada (60).

Director of Health Services Bijay Panigrahi said all those entering Odisha from Chhattisgarh in border districts will have to undergo Covid-19 testing. The government

The state's coronavirus death toll remained at 1,922 as no fresh fatality has been reported since Sunday, he said, adding that as many as 53 other Covid-19 patients have also succumbed to the infection so far.

BMC to increase Covid beds

Bhubaneswar, April 5: With an increase in Covid-19 cases in the state capital, the Bhubaneswar Municipal Corporation (BMC), Monday, stated that it will increase the number of beds in the Covid-designated hospitals in a phasewise manner to enhance treatment facilities for patients.

Addressing the media here, BMC Commissioner, Prem Chandra Chaudhary said that the BMC will increase the bed strength from existing 150, depending on the number of patients that would test positive and cannot be home quarantined. The BMC which earlier had about 1,700 beds had surrendered 1,050 of them observing drop in cases between November and December.

"Everyday around 5 to 10 travelers are testing positive for coronavirus infection at the Biju Patnaik International Airport. Presently, about 70 infected patients are undergoing treatment at the designated hospitals under the jurisdiction of BMC till yesterday. The

number is likely to go up. Therefore, we have already started the process to add more beds for accommodating the patients," the BMC Commissioner said.

Responding to a query on sudden cause of Covid cases here, he added that since there are no travel restrictions and people in the city are not adhering to protocols like maintaining social distancing, the number of cases is increasing. Meanwhile, discussing on the possibility of imposition of night curfew in Bhubaneswar, he said that the decision in this regard will be taken by the state government.

The enforcement squad, Monday, sealed a private coaching institute at Jaydev Vihar which was found violating Covid norms by overcrowding and failing to exercise social distancing at the institute. It can be mentioned that a commerce student of BJB Higher Secondary School was found Covid-19 positive. The civic authority had advised those who came in contact with the infected student to isolate themselves for a week

Rajnagar, April 5: Watermelon farmers in the flood-prone areas under this block in Kendrapara district are a worried lot these days as an unidentified disease have affected their crops.

According to a report, the 'mystery' disease has shattered the hopes of these cultivators as it has caused the watermelons to break open and rot much before harvesting. This has come as a double whammy for the farmers who had lost their paddy crops due to flood in the last Kharif season.

The fruits are being affected when they grow to the size of one kg. The farmers have applied pesticides on the advice of agriculture and horticulture experts but that is not helping them in any way.

The unknown disease is affecting their crops when the watermelons grow to the size of 1 to 1.5 kg. They are trying to tide over this crisis by harvesting the watermelons when they are still small, but traders are refusing to pay even \$\frac{75}{25}\$ per kg

Loss of crop due to the 'mystery' disease has pushed the farmer into distress as they stare at a bleak fu-

The 'mystery' disease has shattered the hopes of these cultivators as it has caused the watermelons to break open and rot much before harvesting

The farmers are forced to harvest the watermelons when they grow up to a size of 1 kg, but traders are not ready to pay even ₹5 per kg

The farmers had borrowed heavily from private money lenders and are now unable to repay their loans after the huge crop loss

did not rain in their area. They were planning to harvest their crops from the second week of March but fate decided otherwise.

They were expecting to harvest over 100 quintals from each acre and a total crop of 1,700 quintals from their l 17-acre farmland. This could have helped them to tide over the losses which they faced during their paddy cultivation in the last Kharif season. However, as ill luck would have it, instead of growing big in size, the watermelons cracked and decomposed.

Another farmer Ganesh Sethi said watermelon plants have withered and small watermelons are getting decomposed. When contacted, farmer Bailochan Rout said he has lost his sleep pondering over repayment of loans.

Meanwhile, Residents have demanded that Agriculture department should rush a high-level team to the area to review the crop damage and make provision of financial assistance to the affected farmers.

Ganjam admin directs serving packaged food at weddings

Notably, the Bhubaneswar Municipal Corporation (CMC) and Cuttack Municipal Corporation (BMC) have also put cap on social gatherings by restricting the number of guests in the marriage ceremonies to 100 in their jurisdictions.

Meanwhile, Health Minister Naba Das hinted at the need of day curfew in the state by reiterating an earlier statement Surjya Narayan Patro, the Speaker of the Odisha Assembly

Das said that if need arises the day time curfew might be imposed in the state.

He said that Collectors have been empowered to clamp night curfew if required in their respective regions, while observers have visited the districts bordering Chhattisgarh and other states. The state government has been emphasising on testing and mass vac-

Villagers try to revive dead man in Nayagarh

Nayagarh, April 5: Though humans have achieved giant strides in the field of science and technology, superstition is still ingrained in the minds of people in today's era, especially in rural areas of the state.

According to a report, some villagers tried to breathe life into the body of deceased person at Barasahi village under Sarankul police limits in this district, Sunday night. The villagers tried to resurrect the dead man but their efforts went in vain.

Reports said, a traditional Danda Nacha programme was underway at Barasahi village Saturday night when a performer identified as Rabi Nahak, 45, fell sick due to some reasons. Co-villagers rushed him to the district headquarters hospital in Nayagarh for treatment. However, the doctors at the hospital pronounced him "brought dead".

However, his family members, instead of conducting a post-mortem, took the body back to the village for cremation. There the family members and villagers, with help of sorcerers, performed rituals throughout the night to resurrect the dead man with a belief that the body was possessed by God. As part of tantrik rituals, the villagers poured pot full of water on the body and started rituals to breathe life into the body.

On being informed, police reached the spot and tried to convince the villagers saying it as an 'impossible' act to breathe new life into the dead man. Later, the villagers too realised it and agreed to cremate the body as per Hindu custom and performed his last rites. Sarankul police have registered a case and started an investigation.

POWER GRID REMAINS NON-STARTER

Uninterrupted power supply still a dream for Cuttack villagers

Nischintakoili, April 5: The state government has taken up various projects to supply electricity to the people in rural areas across the state.

Similar steps have been taken to provide high quality and uninterrupted power services to people in villages under this block in Cuttack district. However, due to administrative apathy and delay in implementation of projects the benefits of the projects are yet to be available to the beneficiaries.

The non-functioning of a power grid at Kendilo village under Asureswar panchayat of this subdivision even after its inauguration is a case in point.

According to reports, the state Energy Minister Dibyashankar Mishra in the presence of state Law Minister Pratap Jena inaugurated a 33/11 KV power grid at Kendilo four months back. The power grid was built at an outlay of ₹5 crore. It was expected to provide optimum voltage and uninterrupted power to over 10,000 people living in 67 villages under 10 panchayats of Nischintakoili subdivision.

However, the power supply is yet to resume to the villages as many

of the works in the grid are yet to be completed. As a result, with summer round the corner frequent disruptions in power supply like lowvoltage and load shedding continues to plague the people in the area.

This has happened as the consultancy agency, which had received the contract for the work, left the midway after allegations of substandard works and irregularities surfaced against the firm. The consultancy firm left the project without connecting the grid to the villages. In fact, the power grid was inaugurated in a hurry with most of its works remaining incomplete.

When contacted, executive engineer Pabitra Kumar Jena of Salipur Electricity Division said power supply has not resumed from the grid as works on the 11-KV feeder is yet to be completed. On the other hand, work on the 33-KV breaker is yet to start. Residents have demanded completion of the pending work of the project at the earliest and resumption of power supply to the villages.

Major fire breaks out at RSP; no casualty reported

Rourkela, April 5: A major fire broke out at the Rourkela Steel Plant (RSP) in Sundargarh district in the wee hours of Monday.

The inferno has gutted properties worth lakhs of rupees as a number of machineries and hardware were reduced to ashes.

According to a source, the fire mishap took place at around 3.00am following a sudden explosion of slag boiler at Steel Melting Shop (SMS)-II of the plant. Molten iron was scattered leading to the outbreak of the blaze.

The control Room of the SMS-II was completely engulfed in flames. Some officials who were on blaze and immediately informed fire-fighting personnel about the incident.

On being informed, a team of

fire personnel rushed to the spot and doused the flames after striving for over a couple of hours. No casualty has been reported in the incident, a fire official said.

Meanwhile, the Chief Executive Officer (CEO) of the plant has ordered a probe into the mishap. A four-member team comprising general manager level officials has been formed by RSP authorities to find out the exact cause behind the fire, an official stated. Work at SMS-II has been temporarily halted

after the accident.



Meditated Massacre

The death of 22 security personnel in a deadly Left Wing Extremists (LWE) or Maoist ambush in the jungles of Bijapur in Chhattisgarh on April 3 has brought to the fore not only the inherent flaw in the Centre's handling of the problem but a host of more serious faults that are responsible for causing such unnecessary deaths of Indian jawans. It seems the BJPled NDA-government is more adept in vilifying people with differing opinions by branding them as urban Naxal rather than dealing with the real extremists and the causes that fuel the growth of their activities in tribaldominated regions of Chhattisgarh and other nearby states. It will not be an exaggeration to say that our security personnel are being used as cannon fodder when one considers the fact that in the Dantewada-Sukma-Bijapur area alone some 175 lives of the forces, besides several civilians, have been snuffed out in encounters with the LWE since 2010. According to reports, the LWE used tractors to carry away some of their dead and injured during the ambush at Bijapur. An officer is also said to have gone missing. About 30 other personnel are lying injured after the gunfight. The recent massacre should be a matter of concern to neighboring states of Andhra, Orissa and Telengana. These states, which had relative calm lately, would be certain to see a fresh spurt of recruitments and activities after this success.

What causes concern is the revelation that over 2,000 personnel from at least five camps in Sukma and Bijapur had gone into the forest around Tarrem in Bijapur district. Yet, they were trapped by a LWE squad that was numerically no match for the armed forces. In a proforma reply to media query, Central Reserve Police Force (CRPF) chief sought to gloss over the query whether there was intelligence failure. This is a critical question that needs to be answered as the security build-up clearly showed the operation had been planned on the basis of intelligence inputs. There are questions whether it was sound strategy to mobilise so many personnel in one single encounter, especially when successes had been achieved in the past when small contingents were deployed to tackle the extremists.

The key question is what the government has been doing all these years to eliminate the causes that spawn the growth of LWE activities. It is not only the stark poverty of the tribals and backward communities in the mineralrich areas of those states that force the ill-fed, ill-clothed and ill-treated population to join the ranks of LWEs or support them by providing inputs. It is more so because of the impression that has been created that the government belongs to the rich, the mine owners and industrialists and therefore it is pointless to expect justice from such a system. No doubt there will be strong voices that will try to put the blame of the mission's failure and the needless deaths at the door of the Congress ruled state government. Because of short convenient memories, they need reminding that similar situations had arisen when the BJP was in power in Chhattisgarh couple of years ago.

During the UPA-II government, the operations against the LWEs were carried out with a definite deadline to serve the interests of big industries keen on exploiting the mineral resources buried in these regions. Obviously, the exercise failed in its objective since the root causes of the growth of radical ideas were dealt with too casually. The policy of Salwa Judum to eliminate the LWEs backfired because it was based on the crude principles of treachery and mindless violence.

The NDA government, on the other hand, has busied itself with taking on intellectuals and activists working for the uplift of the people in abject poverty living in those areas. It has chosen the easy option of putting them behind bars, intimidating them and subjecting them to protracted legal proceedings in order to break their will and undermine their physical health. Propaganda on social media and pet television channels against the urban Naxals may help the BJP get good response from its echo chambers, but it simply is not a successful strategy at all to contain the extremists whose popularity seems to be increasing, if their recruitment drives are any indication.

Coining catchy phrases, damning people with progressive ideas and protecting the interests of big money are not the answer. Political parties will come and go. Elections will ensure such passages. However, serious long term damages inflicted on the country will last much longer. That is what is happening now.

■ Butler

There has been some tut-tutting, head-shaking and general adverse comment in the more intellectual British newspapers this past week following the news that the former butler of the newspaper magnate Rupert Murdoch is about to publish his reminiscences of life with the boss. Mixed with a certain quiet schadenfreude over the king of the tabloid exposure being hoist by his own petard, so to speak, the consensus has been that such things are not done, or at least should not be done, and that buttling has sadly come down in the world since the grand days described by PG Wodehouse. It's always Reginald Jeeves that's mentioned in these articles, usually coupled with the name of Bertram Wilberforce Wooster, despite the indubitable fact that Jeeves was not a butler, but a manservant, gentleman's gentleman or valet. Those genuinely holding the job of butler in the Wodehouse canon, such as Silversmith, Bulstrode, Beech, Keggs (and several dozen others) are rotund and magnificently dignified, often with a magisterial presence that was much statelier than their masters'. The butler in the medieval household was nothing like so exalted. He was the yeoman servant in charge of the beer cellar and of the buttery, from where he served out the beer. Since then, he has both literally and figuratively come up in the world. His name derives from the old French bouteillier, the cup-bearer or the one in charge of the bottles. Our bottle and the French equivalent both come from the medieval Latin butticula, a diminutive of buttis, a cask, which is also the origin of our word butt for a large wooden container for liquid; the beer cellar in medieval times would have contained wooden casks, not glass bottles. So the buttery, therefore, had originally nothing to do with butter, but was the place of the butts; only later was the word extended to mean somewhere that provisions in general were stored.

HEALTHCARE CRISIS

pril 7 is World Health Day and we can expect discussions to be largely focused on the second wave of the Sars-Cov-2 pandemic that has hit the nation. When fighting a war, all thinking and resources are naturally focused on the immediate target. But how well we do in war time is a factor of how well we work and prepare in peace time. Sooner rather than later. the nation must come to terms with the simple fact that our healthcare sector is in a crisis that is far deeper than is visible. The poor suffers because they don't get healthcare. The rich also suffers because they may get more than they can take; aggressive intervention and huge bills don't necessarily mean that the sick are taken care of. Between the two. the system is becoming heartless. a place where expertise even if it's available will fail to deliver because it is disconnected from humaneness. Here are two stories known personally to one of the writers here, coming from in and around Thiruvananthapuram, the

capital of Kerala, From his ICU bed a 75-year-old man screamed at his daughter, unhappy about the state he was put in. His arms and legs were tied to the bed with canvas restraints. She heard her father shout at the nurse; she had never expected this behaviour from him. Some 100 kilometers away a housemaid lay ill and alone on a straw mat in a village hut. She could not walk; she had to crawl. On the other side of the mat was a chamber pot into which she had to urinate and defecate. Her granddaughter, on her way back from school, would come and clean up. Her sons and daughters would not come. They had quarreled about the division of her tiny piece of land.

Both patients had received healthcare in the past. Precise diagnosis had been arrived at and treatment did indeed sustain them for a year or two. Now in a state of incurable illness, one was delirious in hospital and tied up while

the other was lying alone in utter helplessness. Both cases are in Kerala, a state with "significantly higher healthcare spending per capita than all other states. Higher spending on healthcare, especially in the public sector is desirable but it must be accompanied by approaches that promote welfare of the sick, not push them out or put them in an assembly line of the infirm and the suffering.

For example, in India, only about two per cent of the needy have access to pain relief. A draconian law passed in 1985 made three generations of doctors unfamiliar with medicines like oral morphine, and the medical curriculum till 2019 did not include pain management. The essential medicines, though inexpensive, are inaccessible to patients in most hospitals.

India grows poppy, produces opium and exports it to the rest of the world. Morphine is extracted from opium. When a major operation, a fracture or cancer causes severe pain, morphine (or one of its derivatives) is essential for relief; no substitute exists in the world for medicines of that class. The scientific world today recognises the principle of balance, which brings in enough restrictions to limit their non-medical or inappropriate use, while at the same time ensuring the access of morphine for pain relief. The necessary modification of the relevant law was made by the Parliament in 2014. However, the relevant rules which were published in 2015 have errors that need correction, and 29 states and six Union Territories have to implement them individually.

Thankfully, though slowly, many positive things are happening. Students who joined medical colleges from 2019 onwards have pain management and most aspects of palliative care built into their curriculum. A growing number of states are implementing the amended law. The National Health Policy of 2017 "recognises the growing need for palliative and rehabilitative care for all geriatric illnesses and advocates the continuity of care across all levels." Currently, healthcare providers all over the country are being trained in palliative care. The national level trainers have already

been trained and as they spread ed ucation, palliative care will be integrated with primary health care up to a point all over the country.

In the future, perhaps, patients will hopefully get more compassionate and necessary medical attention from healthcare providers in their homes and not be only dependent on intermittent visits from family. This will demand the encasing of health care with ideas of service that alone can offer care with quality and compassion, within the reach of the vast maiority.

We will need primary care to be pushed up and then work for the integration of palliative care into primary care. But this will be grossly inadequate without tertiary healthcare institutions including medical colleges following suit. Secondly, there is something for all of us to do. Healthcare will never be complete till the community around the person and family are engaged. The disintegration of the extended family and migration of young men and urbanisation, have all caused a social change resulting in the isolation of nuclear families during an illness. This needs to be alle viated by the participation of the community. To paraphrase a sentence from Dr Vikram Patel: "Healthcare is too important to

be left to professionals alone". The theme for World Health Day, the 7th of April, 2021, is "Building a fairer; healthier world." If that is to make any sense to us people should get the right kind of healthcare. And that means healthcare should not only focus on curing diseases but should also prioritise relief from suffering.

Cleaning up Europe's vaccine mess

COVID-19 HAS CAUSED VAST SUFFERING ACROSS EUROPE, AND THE EUROPEAN UNION'S SLOW VACCINE ROLLOUT THREATENS TO PROLONG THE AGONY

OVID-19 has caused vast suf- 19 vaccination campaign. fering across Europe, and the European Union's slow vaccine rollout threatens to prolong the agony. If the region's leaders do not take decisive action soon, the pandemic could cause irreversible damage to the EU itself.

When the coronavirus hit the region in 2020, EU member states were unable to agree on vaccine deployment - their main line of defense against it. National governments entrusted vaccine procurement to the European Commission, but then failed to harmonize their production and distribution strategies, or reach a consensus on which groups should be vaccinated first. More recently, 13 European countries suspended use of the Oxford-AstraZeneca vaccine after a small number of people who had received it developed atypical vascular thrombosis.

The European Medicines Agency's subsequent conclusion that the Oxford-AstraZeneca vaccine is "safe and effective" has not reassured everyone. While several EU countries have continued or resumed their rollout of the vaccine, Denmark, Norway, Finland, and Sweden have maintained their suspensions, while France has limited its use to people over 55. These continued differences are fueling increasing public mistrust, not only of the Oxford-AstraZeneca vaccine but of the entire COVID-

The EU's first priority for the coming weeks must be to address the vaccine shortage. Here again, member states have failed to agree and some are not hesitating to shop outside the EU for supplies. Hungary is distributing the Russian Sputnik V vaccine, Slovakia has purchased it, and the Czech Republic is considering doing so, while Hungary has also bought hundreds of thousands of doses of the Chinese Sinopharm vaccine. Furthermore, Austria and Denmark recently announced a separate agreement with Israel for the production of next-generation COVID-19 vaccines. This pact notably foresees the establishment of a joint fund for research and development, and collaboration in clinical trials outside regular EU programs. At the same time, Europe must protect people at risk who either are waiting to be vaccinated or will not respond to vaccines because they have a particular disease or are receiving certain treatments. In the United States, monoclonal antibodies have been highly effective in meeting these important needs.

Faced with these challenges, the European Commission established a task force to manage vaccine supply in the coming months. Led by Thierry Breton, EU Commissioner for the Internal Market, the task force aims to mobilize all available European production capacity, with

the ambitious objective of immunizing 70% of European adults by the end of summer.

President Ursula von der Leven announced in February the establishment of the Health Emergency Preparedness and Response Authority (HERA) Incubator, an agency charged with tackling new coronavirus variants. HERA is intended to play a role similar to that of the US Biomedical Advanced Research and Development Authority (BARDA), which has been instrumental in the unprecedentedly rapid development of the Oxford-AstraZeneca, Moderna, and Johnson & Johnson vaccines.

The success of the US government's Operation Warp Speed effort to develop COVID-19 vaccines is due not only to the scheme's budget of more than \$12 billion but also to its integration and coordination of steps throughout the vaccine value chain, from basic research to large-scale production and distribution. This strategy entailed significant risk-taking, shared between the public and private sectors.

Operation Warp Speed's governance, entrusted to a senior pharmaceutical executive experienced in vaccinology and a high-ranking US Army general responsible for the logistics, was another decisive factor in the plan's success. If the EU's ambition is to reproduce

an initiative like this in Europe, it is clear that mobilizing sufficient financial resources will be a sig-In parallel, Commission nificant obstacle-though perhaps not the biggest one.

Instead, the main challenge may be reaching an agreement between member states and the European Commission to grant HERA sufficient autonomy to ensure the agility the agency's operations will need. The European Innovation Council. recently inaugurated by von der Leyen and French President Emmanuel Macron, could offer an interesting model in that regard. Together with the European Investment Bank, the EIC made it possible to maintain a European foothold on CureVac, the next COVID-19 vaccine to hit the market.

Whatever form the new agency takes, European leaders must urgently accelerate the region's COVID-19 vaccine rollout. In addition, they should define an ambitious new strategy to support pharmaceutical innovation in Europe for the benefit of people evervwhere.

On Covid second wave

What is needed is messaging that emphasises the realistic protective abilities from vaccination and physical distancing measures

Yogi vs Kejri over Ganga vs Yamuna issue as much as 760 mgd of sewage water is discharged into Yamuna

Lucknow April 5: It is now Kejriwal versus Yogi Adityanath and the war is over Ganga versus Yamuna.

Uttar Pradesh Minister Siddhartha Nath Singh said, "Even after spending Rs 5,300 crores in the last six years, Delhi Chief Minister Arvind Kejriwal's Yamuna remains toxic. Another surprising thing is that the Delhi government has made a provision of Rs 2,074 crore again in its Budget of 2021-22, to clean Yamuna.

"On the contrary, the Yogi Adityanath government has cleaned the Ganga within two years after the formation of the government in 2017. Crores of devotees took a dip in the holy, hygienic and clean Ganga during the Kumbh-2019 held in Prayagraj, which was highly appreciated across the globe."

He further said that Delhi is the oldest and the first city situated on the banks of Yamuna. As much as



of sewage water is discharged into Yamuna daily through 18 drains, of which 610 MGD alone is from Delhi. When seen from a distance, Yamuna actually looks like a dirty drain and the water has a foul smell too.

In the year 2014, the Kejriwal government had announced to spend Rs 5.300 crores in the name of cleaning the Yamuna and arranged funds for it. But there is hardly any work done and the condition remains miserable.

"It can be easily understood that the Keiriwal government has not been able to revive the Yamuna with so much money in the last six years and the question remains -where is the hard-earned money of the people gone?" he asked.

On the other hand, Yogi

Adityanath in Uttar Pradesh has succeeded in cleaning the Ganga water in the state.

Just two years after the formation of the Yogi government, Kumbh was held in Prayagraj.

During that time, the government had cleaned the dirty water coming from Naini, Jhusi and Prayagraj in Sangam by establishing treatment plants on 46 large sewage and drains.

These drains discharged 270 million litres of dirty water every day. Eight regular and two temporary sewage treatment plants were installed on 46 sewage and drains.

The government also collaborated with the National **Environmental Engineering** Institute (NEERI) for this task. Drainage was treated at levels above 30 Biological Oxygen Demand (BOD). In Kumbh-2019, crores of devotees from all over the world took a dip in the holy, serene and

Srinagar, April 5: Authorities in Kashmir Monday ordered cancellation of leaves of doctors, nurses and paramedical staff in the valley hospitals in view of the spike in COVID-19 cases in the union territory.

In an order issued here, Director Health Services, Kashmir, asked all the chief med-

ical officers/medical superintend-**COVID-19 CASES** ents and other territorial offices falling within the jurisdiction of

the Directorate to cancel the leaves amid upsurge of the pandemic. "All the leaves either sanctioned or under consideration at Directorate level or at respective offices of CMO's and other DDO's in respect of doctors, nurses, paramedical staff and other official of this Department are here by cancelled forthwith except maternity leave and leave taken in view of extreme medical exigencies," the order said.

The director also directed the chief medical officers/medical superintendents and other territorial offices to refrain from forwarding any kind of leave to his office till further orders.

Jammu and Kashmir has been witnessing a spike in daily cases over the last few weeks. The Lieutenant Governor's office Sunday also ordered closure of schools up to class 9 for two weeks and class 10 to 12 for a week.

Villages to go digital in UP

Lucknow, April 5: The Yogi Government in Uttar Pradesh has prepared an action plan to convert all the rural areas into 'smart' villages in order to ensure that the benefits of the welfare schemes are provided to even the last person of the society.

The Chief Minister has planned to make all the Panchayat Bhawans digital. This will not only link the distant regions to the mainstream society but will also ensure effective and transparent implementation of the welfare schemes of the



government at the grassroots level, thereby benefiting the needy.

The Uttar Pradesh government will be linking Gram Panchayats with an 'optical fibre network' to provide broadband internet services in the coming days. The project has been undertaken under the National Broadband Mission to digitalise every village in the country.

The state government has already linked more than 31,149 Gram Panchayats with optical fibre networks and is working on providing internet connectivity to all the villages soon. About 70% of the population of Uttar Pradesh resides in the rural areas.

There are about 2,498 Panchayat Bhawans in the state out of which 206 are multipurpose ones. The government said that the vision of the programme is centred on three key areas: digital infrastructure as a utility to every citizen -- digital identity, mobile phone and bank account, safe and secure cyberspace; governance and services on demand -- services available in real time on online and mobile platform, making financial transactions electronic and cashless, and digital empowerment of citizens - all documents, certificates available on cloud. e-Pathshalas will also be set up at the Panchayat Bhawan where the farmers will also be taught about all the cultivation techniques through digital means. Uttar Pradesh Chief Minister Yogi Adityanath has prioritised radical digitalisation to induce economic inclusiveness through a host of initiatives.

ARCH OF WORLD'S HIGHEST **RLY BRIDGE COMPLETED**

Chenab Rail Bridge: The 1.3-kilometre-long bridge aims to boost connectivity to the Kashmir Valley and it is being constructed at a cost of ₹1,486 crore

Kauri, April 5: The construction of the arch of the world's highest railway bridge that soars 359 metres above the bed of the Chenab river in Jammu and Kashmir was completed Monday, with the Northern Railways terming the achievement a milestone.

The bridge, which is 35-metre higher than the Eiffel Tower in Paris, is expected to be completed within a year, officials said. "It is a historic day for the Northern Railways and a milestone in the completion of the USBRL project, connecting Kashmir with the rest of the country. The project will be completed within two and a half years," Northern Railway General Manager Ashutosh Gangal told reporters at the work site here in Reasi district.Railway Minister Piyush Goyal watched the lowering of the closure segment of the arch by cable crane through a video link from Delhi. Senior of ficers, including Gangal and Konkan Railway Chairman and Managing Director Sanjay Gupta, attended the function here. "The self-supporting arch is an engineering marvel and has brought us closer to our goal of the dream

project. After the completion of the arch, we will move further, and are hopeful of completing the bridge within a year," Gangal said. The Railway Ministry said that the 5.6-metre last piece of metal (closure segment) was fitted at the highest point of the arch Monday. It joined the two arms of the arch that currently stretch towards each other from both banks of the Chenab, it said. "This completed the shape of the arch. After completion of the arch work, removal of the stay cables, filling of the concrete in the arch rib, erection of the steel trestle, launching of the viaduct and track laying work will be taken up," the ministry said.

Gangal said that the construction of the bridge involves fabrication of 28,660 metric tonnes of steel, 10 lakh cubic metres earthwork and 66,000 cubic metres of concrete. The bridge is designed to withstand high wind speed of up to 266 kmph and earthquake forces of highest intensity, Gangal said. For the first time, the Indian Railways used phased array ultrasonic machines and established a NABL-accredited lab at the site for weld testing, he said in a statement.

Handicrafts are available in all styles of the country, such as terracotta, cast, metal, paper mache, textiles and stones and these will be

put on display and sold as sou-

venirs. The Ramayan World Yatra Vithika will showcase the culture of Ram, as it is present in all the countries of the world. Related photographs, videos will be shown virtually. Continuous chanting of the Ram Charitmanas will be done at the centre. The Ram Vanagaman Marg will have videos of 280 sites while there will also be a gallery of paintings of Ramayan in folk style, miniature style and modern paintbe separate plantations of the Ramayan trees in a rectangular keeping in mind arrangements for the stay of the domestic and foreign tourists on the campus.

Large rooms for group passengers, some dormitories and some single rooms will be built. Four large rooms will be built for administrative control. Passengers will have the facility of group hymns in the morning and evening.

Multilevel parking and about two dozen toilets for women and men will be built.

posed by recycling them. KGN Director Sabir Ali said the city collects nearly two tons of polythene waste every day. Apart from this used drinking water bottles are purchased for Rs 25 per kg. After processing this waste, it sells for nearly Rs 32-Rs 38 per kg.

He said plastic buckets, cans, mugs etc. are purchased at Rs 10 per kg which are sold after saving Rs four to five. The bank also takes waste like cardboard etc for recycling. The plastic waste collected in this bank is deposited at the sewage treatment plant at Ashapur. The plastic waste is pressured with the help of a pressure machine.



The plastic is separated im which the polyethylene terephthalate (PET) bottles are pressed with a hydraulic baling machine and collected in the form of a bundle which is sent for

further processing. Other plastic wastes are also separated and are sent for recycling. This waste is then sent to Kanpur and other places, where with the help of a machine,

the plastic waste is used to make plastic pipes, polyester threads, shoe laces and other material. In this initiative by the Municipal Corporation, this bank has been created for the disposal of plastic waste. V.D. Tripathi, Chairman of the Mahamana Malviya Ganga Research Centre, BHU, said the carbon molecules are smaller and lighter on burning polythene which penetrates inside the nose. This reduces a person's ability to breathe. The plastic can't be disposed off easily.

If the burnt plastic waste is swallowed by living organisms, then it results in swollen stomach which ultimately causes death. If this plastic is thrown on the roads and is eaten by cows and other animals, then it is harmful for them. It causes more physical harm than poisoning. There wouldbe a lot of benefits from opening such a waste bank.







Six houses were gutted in the incident, according to the officials. A 40-year-old woman and her six-year-old son were taken to the SMHS hospital, where they were declared brought dead, they said. A case has been registered and investigations are on to ascertain the cause behind the fire, they added.

2 workers die of suffocation

Ahmedabad: Two labourers suffocated to death and another became critical on Monday after inhaling toxic gas while cleaning a septic tank at Vedach village in Gujarat's Bharuch district, police said. The incident occurred in the morning when three labourers were segregating solid waste from the liquid inside the tank. They fell unconscious due to the sudden discharge of toxic gas. They were rushed to a nearby hospital in Jambusar in an ambulance.

3 die in factory roof collapse

Ludhiana: Three people died and seven were injured when the roof of a factory collapsed at Baba Mukand Singh Nagar here Monday, officials said. Forty people, mostly labourers, were rescued from the site. Of the injured, the condition of three were stated to be critical, officials said, adding efforts were on to find out where more people were trapped under the debris.

Covid survivors rush to take the jab

New Delhi, April 5: As India witnesses a surge in Covid-19 caseloads, those who have survived the deadly disease and had antibodies for a certain period (up to six months) are now rushing to take the vital jab in order to avoid reinfections, health experts said Monday.

Reinfection means a person once infected and recovered from the SARS-CoV2 virus -- the virus that causes Covid-19 -- gets infected again, according to the US Centers for Disease Control and Prevention. As is the case with other viruses, a case of reinfection cannot be ruled out, the agency had noted.

If a person gets infected and recovers, the "natural infection immune response" can last for nearly six months, says the World Health Organisation (WHO). However, the "protection may not be lifelong", hence, vaccination is important.

"Emergence of the second wave of Covid in the country also raises questions about longevity of sustained immunity post Covid infection. Hence, it is advisable to take vaccine for people who were earlier diagnosed with Covid," Dr Harshal

Ahead of the PM's interaction with chief ministers, Union Health Minister Harsh Vardhan will Tuesday hold a meeting with health ministers of 11 states and Union Territories, which have been witnessing a surge in coronavirus cases, to review the situation there. These 11 states are Maharashtra, Chhattisgarh, Delhi, Gujarat, Haryana, Himachal Pradesh, Jharkhand, Karnataka, Madhya Pradesh, Punjab and Rajasthan.

PLEA IN SC SEEKS UNIFORM RETIREMENT AGE FOR JUDGES

INDO-ASIAN NEWS SERVICE

New Delhi, April 5: A PIL has been filed in the Supreme Court seeking a uniform retirement age for judges of both the apex court and the high courts.

The plea, moved by advocate Ashwini Upadhyay, sought direction from the top court to the Centre to take steps to make the retirement age of judges of high courts and Supreme Court uniform, as it is irrational to have different retirement age for judges of constitutional courts.

Alternatively, being protector of right to speedy justice guaranteed under Article 21, the Court may use its plenary constitutional power to declare that the judges of high courts shall retire at the age of 65 years until Centre takes steps to reduce the pendency of cases from



15 to 3 years, the plea said. The plea said in developed countries, the retirement age of higher court judges varies from 70-80 years. For example, judges retire at the age of 75 years in the UK and Canada and at the age of 70 in Australia, the Netherlands, Ireland, Belgium, and Norway. Moreover, judges works for lifetime in the US, Russia, New Zealand and Iceland, subject to their physical-mental fitness

The plea contended that uniformity in the retirement age will not only necessary to reduce pendency of cases but it will also attract and retain the best legal talent on the bench. To reduce judicial and procedural errors. India needs more experienced judges, argued the peti-

At present, the retirement age for the apex court judges is 65 years whereas for the high court judges, it is 62 years. The plea argued that the judges of the high court will work independently, without any expectation to move to the top court,

if retirement age is made uniform. Finest lawyers don't want to become judges of the high courts because instead of continuously giving valuable services to the nation, high court judges are compelled to retire at a very early age i.e., 62 years, said the plea.

After Delhi, Tikait threatens tractor agitation in Gujarat PRESS TRUST OF INDIA

Ahmedabad, April 5: Bhartiya Kisan Union leader Rakesh Tikait Monday threatened to start a farmers' tractor agitation in Gujarat after Delhi, and said time has come to gherao the state capital Gandhinagar and also break barricades if needed. Talking to reporters outside the Sabarmati Ashram here, Tikait claimed farmers in Gujarat were

unhappy and suffering. Hundreds of farmers have been camping at Delhi's borders since November last year against the Centre's three agriculture reform laws. They are demanding a repeal of the three laws along with a legal guarantee for Minimum Support Price (MSP) for their produce. The protesting farmers took out a tractor rally in Delhi January 26.

How 'chimpanzee poop' is helping prevent Covid-19?

New Delhi, April 5: The Oxford-AstraZeneca Covid-19 vaccine, a version of which is also being used in India, is made from an adenovirus isolated from chimpanzee poop, which has been genetically changed so that it is im-

possible for it to grow in humans. Now known as Covid-19 Vaccine AstraZeneca, it was formerly called AZD1222.AZD1222 was co-invented by the University of Oxford and its spin-out company, Vaccitech. It uses a replication-deficient chimpanzee

viral vector based on a weakened version of a common cold virus (adenovirus) that causes infections in chimpanzees and contains the genetic material of the SARS-CoV-2 virus spike protein.

After vaccination, the surface spike protein is produced, priming the immune system to attack the SARS-CoV-2 virus if it later infects

The vaccine has been granted a conditional marketing authorisation or emergency use in more than 70 countries across six continents.

The Serum Institute of India



(SII), the world's largest vaccine manufacturer by volume, is manufacturing a version of the OxfordAstraZeneca Covid-19 vaccine named 'Covishield' in India

India is stepping up vaccination

efforts against Covid-19 amid a renewed surge in the number of cases. The country registered 1,03,558 new coronavirus cases in the last 24 hours, the highest ever single-day spike since the onset of the pandemic last year, taking the total tally to 1,25,89,067 Monday.

Monday, the death toll increased

to 1,65,101 with 478 new fatalities. The number of people who have recovered from the disease surged to 1,16,82,136, while the case fatal-

ity rate stood at 1.31 per cent, according to official data. So far, 7.91 crore doses of Corona vaccine have been administered in the country since the drive began on January 16 after the approval for Covishield and Bharat Biotech's Covaxin.

The vaccination drive started for healthcare workers January 16, followed by vaccination for frontline workers from February 2. Later, persons aged 60 years and above and those in the age group of 45-59 years with identified 20 comorbidities were covered from March 1.

Subsequently, from April 1, all persons aged 45 years and above are eligible for Covid vaccination.







Mumbai, April 5: Maharashtra Home Minister Anil Deshmukh has resigned from his post, hours after the Bombay High Court asked the Central Bureau of Investigation (CBI) to probe the corruption allegations levelled against him by former Mumbai Commissioner of Police Param Bir Singh, a top Nationalist Congress Party leader said here Monday.

Chief Minister Uddhav Thackeray has appointed senior Nationalist Congress Party (NCP) leader, ex-Speaker and Labour Minister Dilip Walse-Patil as the new Home Minister.

The CM also tweaked his cabinet by handing over the Labour department to Minister Hasan Mushrif, and State Excise portfolio to Deputy Chief Minister Ajit Pawar.

Among the senior most leaders in the state, Walse-Patil, 65, has been a 6-time MLA from Ambegaon in Pune district, has been a Minister with experience in handling diverse departments, and served as the Speaker of Maharashtra Legisltive Assembly from 2009-2014.

Earlier, the high court verdict triggered off a high-level political drama in the state culminating in Deshmukh's resignation.

Among the seniormost leaders in the state. Walse-Patil. 65. has been a

6-time MLA from Ambegaon in Pune district and served as the Speaker of Maharashtra Legisltive Assembly from 2009-2014

"Soon after the high court directives, Deshmukh met NCP President Sharad Pawar and offered to resign to ensure an impartial probe. After the nod, Deshmukh has gone to meet Chief Minister Uddhav Thackeray to submit his resignation," NCP National Spokesperson and Minority Affairs Minister Nawab Malik told mediapersons.

In his resignation letter to the CM, Deshmukh said: "In the wake of the HC ruling, I feel it would be improper for me to continue in the post on ethical grounds. Hence, I have decided to voluntarily keep away from the post. Kindly relieve me from this responsibility."

The fast-paced development came shortly after a division bench comprising Chief Justice Dipankar Datta and Justice GS Kulkarni directed the CBI to conduct a 'preliminary probe'

against Deshmukh. March 30, the Maha Vikas Aghadi (MVA) government had appointed a high-level committee by a retired Bombav HC judge, Justice K U Chandiwal to probe the matter.



JOINT OFFENSIVE AGAINST MAOISTS

New Delhi, April 5: Unlike other issues, the BJP-led Central government in New Delhi and the Congress-headed state government in Chhattisgarh, are unanimous over their offensive against Maoists in the 'red corridor' of India.

Union Home Minister Amit Shah Monday said that the Centre will intensify counter-insurgency operations against Maoists following the massive loss of CRPF troopers in a gun-battle on Saturday. Though the BJP and the Congress remain national political rivals, the state's Bhupesh Baghel government has reinforced the same view as that of Shah. Eighteen CRPF troopers had

been missing after five security personnel were killed and 30 others injured Saturday in a fierce gun-battle with Maoists in a forest near the border between Bijapur and Sukma districts in Chhattisgarh. Sunday, bodies of 17 of the 18 troopers were recovered from the site, taking the toll up to 22. Shah, who visited the state for the

first time since he assumed charge as Home Minister in the Narendra Modi government, in a review meeting with the Baghel government, said: "I want to assure the country

that this fight will not be stopped, rather it will continue with more intensity till the end. In this fight, our victory is definite in the end.'

In the same vein, Chief Minister Baghel said the government was determined to set up security forces' strategic camps deeper into Maoist

However, there are some who feel otherwise. Take for example, former Director General of Police of UP. and Assam and Director General, BSF, Prakash Singh, whose book "The Naxalite Movement in India" covers the subject comprehensively.

Singh told IANS that both the government and the Maoists need to understand that the last 50 years of violence have not yielded anything. "Both sides can fight this war for another 100 years but it will only result in the loss of lives. It is not a simple law and order problem. Tribals have grievances - real or perceived - which need to be addressed. Some of their misgivings can be dispelled," Singh said.

The Maoist movement, many analysts believe, are an outcome of governmental apathy towards tribals, absence of land reforms, abject poverty, prolonged deprivation, unemployment, and overall, lack of good governance.

IAF to use AI tech for threat monitoring: Chief

New Delhi, April 5: Artificial Intelligence-assisted next-gen technologies would be employed for threat monitoring in the Indian Air Force's captive networks, including the current network upgrades, IAF chief Air Chief Marshal R K S Bhadauria said Monday.

If we intend to utilise AI heavily in combat aviation, we may need to redefine or even abandon some traditional principles. These principles are not strict or templated. Essentially different nations with different threat perceptions would have different requirements and this would have evolved over a period of time and experience, he said, at an E-symposium on Artificial Intelligence for Air Warriors organised by the FICCI here.

AI can give you models with impeccable logic to prove that the proposed solutions are the best, he added. Talking about Artificial Intelligence in air warfare, he said in the way air wars are fought in the aerospace domain.

On Artificial Intelligence in the force, Air Chief Marshal Bhadauria said Our entire inventory management has been computurerised and digitised and we have already started to work on AI based formulation so as to come out with predictive maintenance or predictive threat scenario.

'We have started testing AI and AI-based applications on some projects which are at the different stages," he added.

On training strategy, the IAF chief said We have already working on effective training strategies where data recorders example are being used to identify outliers in pilot performance, be it in operations, exercises using AI techniques to determine the strong and weak points in terms of manoeuvring or overall orientation, etc.

Lifestyle changes alone can control obesity: Experts

Aligarh, April 5: Experts of Ayurvedic, Unani and modern medicines said lifestyle changes were necessary to control obesity and allergies.

They were deliberating upon how to combat obesity - through prevention and medications and therapies commonly used to treat allergies in a multi-disciplinary online seminar on 'Obesity and its Prevention, Allergic Diseases' organised by the Faculty of Medicine, Aligarh Muslim University (AMU).

We need to find ways to combine both the traditional and modern medicine systems for a major role in the fight against lifestyle diseases, said AMU Vice Chancellor, Prof Tariq Mansoor.

Of course, we cannot adopt these procedures for all diseases, but for chronic diseases there is a lot of scope," he added pointing out that since the spread of Covid pandemic,



Vice Chancellor said.

Stressing the need for joint traditional and modern medicine research, Prof Mansoor said that AMU is a multi-disciplinary university and we can take advantage of the facilities for collaborative research.

Speaking on the treatment and prevention of obesity in Ayurvedic medicine, Prof Jonah S (All India Institute of Ayurvedic, New Delhi) recommended lifestyle changes and appropriate modification in daily diet to improve health along with oral medications to help optimizing the metabolism

He elaborated how Ayurvedic plants and herbs help in controlling obesity. "Because Ayurveda focuses on healthy nutrition, stress reduction, and cultivation of a balanced lifestyle, many people look to its

dietary principles and natural remedies when they want to lose weight. People in many Western countries are using the Ayurvedic regimens and remedies as part of their overall healthcare," said Prof Jonah.

Dr Paras Wani (Incharge, GTB and IHBAS Unani Unit, Director of Ayush, GNCT, New Delhi) explained how Siman-e-Mufrit (obesity) is considered as a Phlegmatic (Balghami) disease in Unani medicine. She added that obesity can be

prevented by maintaining Asbabe-Sittah Zarooriyah (essentials of life) namely the proper and balanced diet, physical activity, balanced retention and evacuation.

Dr Paras explained the various modes of treatments with Ilaj bil Ghiza (Dietotherapy) and Ilaj bit Tadbeer (regimental therapies). Dr Uwais Ashraf (Faculty of Medicine, JNMC) described how obesity is the root cause of all lifestyle diseases in modern medicine.

"Obesity leads to coronary artery

disease, hypertension, fatty liver and PCOD among other health problems. Obesity has a strong genetic and biochemical basis and these areas are being looked into for newer therapeutic modalities," he said.

Dr Uwais added that diet, lifestyle and behavioural therapies are necessary in the management of obesity.

He also gave a slide presentation on preventing and treating obesity. Speaking on preventive measures to avoid allergies, Prof Rubi Anjum (Chairperson, Dept of Tahaffuzi wa Samaji Tib, AMU) discussed various Unani therapies

of Ilai-bil-Tadbeer. She spoke about treatments through special regimens and methods to maintain general health through modulation in 'Asbaab-e-Sitta Zarooriya'.

Prof Rubi also shared a list of foods to try to avoid allergies such as ginger, citrus fruits, turmeric, oily fish and onions.

Islamabad: A Pakistan antiterrorism court judge, his wife and two children were killed after unidentified gunmen opened fire at his vehicle in Swabi district, Khyber Pakhtunkhwa province, police sources said. 6.1-magnitude quake jolts NZ

Wellington: An earthquake measuring 6.1 on the Richter scale jolted New Zealand's east sea Monday and was widely felt in the North Island. The quake occurred at 7.37 p.m. (local time) in the East Cape Region, 120 km east of Te Araroa at a depth of 33 km, according to GeoNet, the country's geological hazard information centre. Last month, three strong quakes jolted the sea off the coast of the North Island, which resulted a tsunam warning on the coast.

Cargo vessel collision kills 27

Dhaka: At least 27 people died after a small launch carrying over 100 passengers capsized after colliding with a cargo vessel in Bangladesh's Shitalakkhya river, officials said Monday. The incident took place on Sunday evening at Narayanganj district, about 16 km southeast of Dhaka. While five bodies were recovered on Sunday, rescuers retrieved 22 bodies Monday as a salvage vessel pulled out the launch with the help of a huge crane around midday, rescue officials said.

Iran seeks 'constructive' move from EU members of 2015 nuke agreement

Parties to the Iran nuclear deal have agreed to convene in Austria Tuesday to discuss ways to bring the deal back to life

Tehran, April 5: Iranian Foreign Minister Mohammad Javad Zarif has urged European participants of the 2015 nuclear agreement to maintain a "constructive" attitude in the meeting scheduled to take place Tuesday in Vienna.

Zarif made the demand in a telephone conversation with his British counterpart Dominic Raab, the Ministry of Foreign Affairs said in an online report Sunday.

The two diplomats discussed the latest developments related to the deal, officially known as the Joint Comprehensive Plan of Action (JCPOA) in the call, held at Raab's request

Zarif reiterated Tehran's position that Iran will return to its JCPOA obligations after the "illegal and unjust" sanctions imposed by the US are "completely and definitively" lifted and verified by the Islamic Republic.

Raab said, according to the report, that his country will make efforts for the negotiations to bear fruits. Parties to the Iran nuclear deal have agreed to convene in Austria

Tuesday to discuss ways to bring the deal back to life.

US State Department spokesman Ned Price confirmed that American representatives will attend the meeting, adding that the country remains "open to" direct talks with

But, Iran has ruled out any "direct or indirect" contacts with US representatives in Vienna.

The two countries are in a standoff over reviving the nuclear deal.

The Joe Biden administration has said that if Iran returns to full compliance with the JCPOA, Washington would do the same.

But Iran insists its full compliance will only take place once US sanctions are removed. The deal was reached in 2015 be-

tween Iran and the US, the UK, Russia, France, China, Germany and the European Union.

Iran gradually stopped implementing parts of its JCPOA commitments from May 2019, one year after the administration of former US President Donald Trump unilaterally abandoned the agreement and re-imposed sanctions

Indonesia landslides, floods kill over 100

Jakarta, April 5 : More than 100 people were killed and dozens are missing after floods and landslides hit East Nusa Tenggara province in Indonesia, officials and media reports said Monday.

Volcanic debris from Mount Lewotolo engulfed homes Sunday following heavy rain, killing 20 people and leaving more than 60 missing, Thomas Ola, the head of Lembata district, told dpa news

"Fourteen villages are still totally isolated, with roads inaccessible," he said.

The death toll is likely to increase as information was still being gathered from the villages, he said. Mount Lewatolo has erupted in-

termittently since December. In another part of the province the death toll after flash floods and

landslides hit villages on Adonara

island Sunday rose to 73, Metro TV news channel reported.

Access to the island had been difficult because of high seas, said Raditya Jati, spokesman for the National Disaster Management

'The only way to get there is by sea and strong winds and storms mean that we can't sail," he said.

Furthermore, interruptions to internet access mean limited information is available and the death

toll could be higher.

Meanwhile, on nearby Alor island, similar disasters killed at least 11 people, according to the disaster agency

It said more than 100 homes damaged and five bridges collapsed. The climatology and meteoro-

logical agency predicted that some parts of Indonesia could face extreme weather, with heavy and torrential rain, strong winds and large waves during the week ahead.

The tropical cyclone Seroja may intensify over the coming day and is expected to move south-west away

from Indonesia, it said. President Joko Widodo said he was deeply saddened by the disas-

"I understand the plight of our fellow citizens affected by the dis-

asters," he said. "I'm calling for immediate pro-

vision of health care, food and other basic needs to the affected people and restoration of infrastructure.' Indonesia has recorded nearly

1,000 disasters since January, mostly hydro-meteorological hazards, including flooding and landslides, according to the disaster management agency.

At least 337 people have been killed, 55 are missing and 4.3 million have been affected, with many displaced, it said.

UK launches mass testing programme



London, April 5: British Prime Minister Boris Johnson said Monday everyone in England will be able to take a COVID-19 test twice a week in a new drive to track the pandemic as society reopens and the vaccine rollout continues at its rapid rate. Johnson, who is expected to con-

firm plans to relaunch international travel and open sections of the economy later on Monday, said the new mass testing programme would break the chain of transmissions and spot cases without symptoms. As much of Europe enters new lockdowns to tackle surging cases, Johnson has set out a staggered plan to ease restrictions in the coming months, a huge boost for one of the worst-hit countries during the pandemic.

Myanmar protesters challenge military



Mvanmar. April Demonstrators in Myanmar held protests demanding the restoration of Aung San Suu Kyi's government Monday and called for more coordinated nationwide dissent against the military junta, as regional nations prepared for talks on the crisis

At least 564 people, including 47 children, have been killed by security forces during protests against the Feb. 1 coup, an activist group has said.

The movement has included street marches, a civil disobedience campaign of strikes and quirky acts of rebellion organised on social media.

Activists called for a nationwide clap later Monday in appreciation of those ethnic minority armed groups that are supporting the democractic cause, and young demonstrators who have been at the vanguard of protests, trying to shield or rescue people wounded by security forces.

"Let's clap for five minutes on April 5, 5 p.m. (10:30 GMT) to honour Ethnic Armed Organisations and Gen Z defence youths from Myanmar including Yangon who are fighting in the revolution... on behalf of us," Ei Thinzar Maung, a protest leader, posted on Facebook

Besides the brutal crackdown on street protests, the junta has sought to suppress the campaign by shutting down wireless broadband and mobile data services

Israel PM appears in court to face corruption charges

Jerusalem, April 5: Israeli Prime Minister Benjamin Netanyahu was back in court for his corruption trial Monday as the country's political parties were set to weigh in on whether he should form the next government after a closely divided election or step down to focus on his legal woes.

Between witness testimony in a Jerusalem courtroom and the consultations at the president's office across town, it promised to be a day of extraordinary political drama, bringing into sharp focus on Netanyahu's increasingly des-

perate efforts to stay in power. He is Israel's longest-serving prime minister and has clung to power through four hard-fought elections in less than two years even as he has faced allegations of bribery, fraud and breach of trust.

The March 23 election was largely a referendum on his leadership but produced no clear verdict.

Israel's political parties, meanwhile, began meeting with President Reuven Rivlin to recommend which candidate should be tasked with forming the next government.

After each election, Israel's pres-



a governing majority. That decision is usually clear cut, but Rivlin faces a difficult choice given the fragmented election results that left the Knesset, Israel's parliament, divided between 13 parties with broad ideological differences.

Neither Netanyahu's allies nor his foes secured a governing majority. So his fate could come down to Naftali Bennett, a right-wing former ally with whom he has strained ties, and Mansour Abbas, the leader of a small Arab Islamist party who also has yet to commit to either

the pro- or anti-Netanyahu blocs. At the Jerusalem District Court, Netanyahu sat with his lawyers as lead prosecutor Liat Ben-Ari read out the charges against him. "The relationship between Netanyahu and the defendants be-

vant's judgment." Netanyahu's lawyers sought to make a rebuttal but were cut off by Judge Rivka Friedman-Feldman, who said they had already responded to the charges earlier in the trial.

In a tweet on Sunday, Michel said: "I came to Tripoli in a moment of hope and challenges. The EU stands by the Libyan people and its new leadership. We are ready to increase our support to a unified, sovereign, stable and prosperous Libva.'

Dbeibah's Government of National Unity was approved by the House of Representatives (Parliament) in a major step towards re-establishing stability in the country that has been roiled by conflict for a decade.

The interim government is tasked with preparing for national elections, scheduled for December 24.

Ethiopia currently has the largest number of Covid-19 cases in east Africa, as well as the fifth-highest number of Covid-19 cases in the African continent as a whole. Ethiopia currently has recorded 208.961 Covid-19cases and 2.890 Covid-19 related deaths as of Sunday noon.

New Delhi, April 5: Having successfully managed the first wave of the coronavirus pandemic, India is well prepared to combat the scourge of the second wave, the Finance Ministry's monthly economic report said. The report further said high-frequency data indicates that India is on the path to become better and stronger.

"After battling a historic pandemic in FY 2020-21, the Indian economy is poised to build back better and stronger as is reflected in the movement of several high-frequency indicators.

Instrumental in this resilient comeback will be a strong revival in investment growth supported

by the AtmaNirbharBharat Mission and a massive boost to infrastructure and capital expenditure provided for in the Union Budget 2021-22," the report said.

The rise in daily new cases since mid February marks the onset of second wave of Covid-19 infection in India, the report said, adding the country "has, however, been able to delay the onset of the second wave the gap between the first peak to start of the second wave has been 151 days in India while it was much lower in other countries.

At this juncture of the onset of the second wave, the report said, India is well prepared to combat the scourge of the virus.

"The wheels of India's capex cycle have been set into motion,



signs of which are imminent in the second half of the year. As the vaccination drive continuously upscales in India and guided by the learnings of India's successful management of pandemic during its

first wave, India is now well armed to combat any downside risk posed by the recent surge in Covid-19 cases," the report said.

With the end of a challenging 2020-21, the crest of a brighter and

self-reliant 2021-22 awaits India, the Finance Ministry report said. The fiscal position of the Centre has witnessed improvement in the recent months due to a revival in the economic activities, it said.

"During April 2020 to February 2021, the Centre's fiscal deficit stood at ₹14.05 lakh crore, which is 76% of Revised Estimate 2020-21. Net Tax Revenue of the Central Government for 2020-21 is set to overshoot the RE despite 41% higher income tax refunds this year," it said. To share the revenue buovancy seen in Q4 2020-21 and in the true spirit of fiscal federalism, an amount of ₹45,000 crore has been released as additional devolution to states in 2020-21, an increase of 8.2% over RE, it said

LG Electronics exits from loss-making mobile business



Seoul/New Delhi, April 5: LG Electronics said Monday that it will withdraw from the mobile business after years of money-losing performance amid intensifying competition with bigger rivals.

The South Korean tech powerhouse said in a regulatory filing that its mobile communications (MC) unit will no longer produce and sell handsets after July 31, citing its long slump and fierce competition in the industry.

The decision came two months after the company said its MC division is open to "all possibilities" for its future operations. LG's mobile business has been

in the red since the second quarter of 2015. Its accumulated operating losses reached 5 trillion won (US\$4.4 billion) last year.

LG, once the world's thirdlargest handset maker, reportedly had talks with Vingroup of Vietnam and Volkswagen of Germany to sell the mobile business, but the talks fell through, according to industry insiders.

Manufacturing activities ease in March: Survey

New Delhi, April 5: India's manufacturing sector activities lost further growth momentum and fell to a seven-month low in March as demand was constrained by the escalation of the Covid-19 pandemic, a monthly survey said Monday.

The seasonally adjusted IHS Markit India Manufacturing Purchasing Managers' Index (PMI) fell from 57.5 in February to a sevenmonth low of 55.4 in March.

However, the latest reading was indicative of a substantial improvement in the health of the sector that outpaced the long-run series average, it said. In PMI parlance, a print above 50 means expansion while a score below 50 denotes contraction.

"Production, new orders and input buying expanded at softer rates," said Pollyanna De Lima, Economics Associate Director at IHS Markit.

Lima further noted that "survey participants indicated that demand growth was constrained by the escalation of the Covid-19 pandemic, while the rise in input buying was curtailed by an intensification of cost pressures." "With Covid-19 restrictions expanded and lockdown measures re-introduced in many states. Indian manufacturers look set to experience a challenging month in April," Lima said.

GNPAs of banks may rise to 9.6-9.7% by March-end: Report

Mumbai, April 5: As the impact of various relief measures, including a moratorium on loan repayment and asset classification standstill wanes off, gross non-performing assets of banks may likely rise to 9.6-9.7% by March 31, 2021, says a report. According to Icra Ratings, GNPAs (gross non-performing assets) of banks may worsen further to 9.9-10.2% by March 31, 2022.

The rating agency, in a report, said despite the impact of the Covid-19 pandemic on the debt servicing ability of borrowers, the gross fresh slippages for banks stood much lower at ₹1.8 lakh crore during the first nine months of fiscal 2020-21 as compared to ₹3.6 lakh crore during the financial vear 2020

This has been driven by various relief measures such as the moratorium on loan repayment, a standstill on asset classification and liquidity extended to borrowers under Guaranteed Emergency Credit Line (GECL), the agency said.

"As the impact of these interventions wanes off, the asset quality pressures are likely to resurface. We expect the GNPAs (excluding write-offs) to rise to 9.6-9.7% by March 31, 2021, and 9.9-10.2\$ by March 31, 2022, from 8.6% as on March 31, 2020," the report said.

As of December 31, 2020, the GNPA and NNPA (net non-performing assets) of the banks stood at 8.3% and 2.7% as of

to 8.6% and 3% respectively as of March 31, 2020.

The agency's Anil Gupta, sector head (financial sector ratings), said while the headline asset quality and restructuring numbers are encouraging, these don't reflect the underlying stress on the asset quality of banks.

"The level of loans in overdue categories has increased after upliftment of moratorium and the impact on asset quality will be spread over FY2021 and FY2022 as various interventions and relief measures have prevented a large one-time hit on profitability and capital of

banks," Gupta said. The report, however, said the net NPA position of the banks is expected to be relatively lower because of significant provisions made by banks on their legacy NPAs.





Fakhar Zaman's controversial run out in 2nd ODI vs SA

It's up to umpires to decide if de Kock was at fault: MCC

London, April 5: Pakistan's Fakhar Zaman's contentious run-out in the second ODI against South Africa has sparked a debate on spirit of the game with Marylebone Cricket Club saying it was "up to the umpires to decide" if Quinton de Kock had attempted to mislead the bats-

In a stiff chase of 342, Zaman smashed a spectacular 193 in a losing cause as the batsman was run out in a controversial fashion involving South Africa wicketkeeper

The stumper pointed his finger towards Lungi Ngidi but the ball was, in fact, thrown by Aiden Markram towards the keeper's end and it was a direct hit. Zaman had slowed down his pace at the end of his second run and could not make it back into his crease.

Replays showed that de Kock had seemed to convince Zaman into believing that the throw was going to the non-striker's end.

"Law 41.5.1 states: It is unfair for any fielder wilfully to attempt, by word or action, to distract, deceive or obstruct either batsman after the striker has received the ball," the MCC, custodians of the game,

tweeted. In another, the MCC wrote, "The

Law is clear, with the offence being an ATTEMPT to deceive, rather than the batsman actually being deceived. It's up to the umpires to decide if there was such an attempt. If so, then it's Not out, 5 Penalty runs + the 2 they ran, and batsmen choose who faces next

The debate around de Kock's gesture was whether he was intentionally attempting to deceive Zaman into thinking that the throw was headed for the other end, leading to the batsman slowing down his pace while going for the second run at the Wanderers Sunday.

Many in the Pakistan cricket circles blamed de Kock for "deliberately distracting" Zaman, leading to his dismissal. Former captain
