NZ stops entry of visitors from India

Wellington: Prime Minister Jacinda Ardern announced Thursday that New Zealand will temporarily suspend the entry for all travellers, including its own citizens, from India for about two weeks from April 11 due to a surge in COVID-19 cases among visitors to this country. The ban will begin Sunday and will remain in place until April 28, Ardern said. The travel restriction comes after New Zealand recorded 23 new positive COVID cases in isolation Thursday, of which 17 came from India, said a local media report here.

RT-PCR NEGATIVE TEST REPORT A MUST FOR ALL PERSONS ENTERING ODISHA

Bhubaneswar, April 8: The resurgence of COVID-19 has occurred in many parts of India including some places in Odisha. Hence the Odisha government has put restrictions in place for those coming to the state. Odisha reported Thursday a total of 879 new COVID-19 cases taking the state's tally to 3,45,526. It is the highest singleday rise this year.

'People coming to Odisha by any mode of public transport like train, bus, aircraft or waterways or by any private vehicle will have to produce RT-PCR negative reports obtained within 72 hours of entry/final vaccination certificate (after two doses of vaccine jab)," Chief Secretary SC Mahapatra said in an order issued Thursday. This order will be effective from April 12 (Monday). Those without valid documents will have to undergo seven days mandatory home/institutional quarantine.

In a separate development, the Odisha government also decided to close borders with Chhattisgarh from April 10 to April 30. No public transport will be allowed to enter Odisha through the Chhattisgarh border and vice-versa. The chief secretary has also written a

letter to Railway Board chairman Suneet Sharma to cancel train services from Chhatisgarh to the state from April 10. Passengers arriving in any station of Odisha on trains from any state will also have to produce either a vaccination certificate or RT-PCR negative report.

The state Transport department with help of police and under active guidance of collectors will set up Border Check Points (BCPs) at strategic locations across Odisha to manage entry of incoming persons and vehicles.

District collectors of high caseload districts namely Sundargarh, Jharsuguda, Sambalpur, Bargarh, Bolangir, Nuapada, Kalahandi, Nabarangpur, Koraput, Malkangiri, Ganjam, Gajapati, Rayagada, Keonjhar, Mayurbhanj and Balasore have been authorised to set up and operate Temporary Medical Centres (TMCs)/ **Cluster Temporary Medical Centres** (CL TMCs) to provide institutional quarantine facilities for people coming from other states.

CM SEEKS 10-DAY STOCK OF VACCINES

BHUBANESWAR: Chief Minister Naveen Patnaik urged the Centre to ensure at least 10 days stock of COVID-19 vaccines and he sought ₹300 crore for management of the disease. Naveen raised the demand during the virtual meeting of the prime minister with chief ministers of different states. "We have not been able to ramp up the vaccination due to lack of supplies. We are currently vaccinating 2.5 lakh persons per day and have capability to increase further. We request stock of vaccines for a minimum of 10 days," Naveen said. **MORE P4**

Meanwhile Health Minister Naba Kishore Das informed Thursday that the state is yet to receive fresh stock of Covishield vaccines from the Centre. "We have already written to the Union government. Till Thursday noon the state didn't get new stock for vaccination. The supply of the vaccine lies with the Union government. When we need to give impetus to the vaccine drive, we are struggling due to the shortage of jabs," said Das.

Rural economic corridors on cards

Bhubaneswar, April 8: With and aim to boost rural economy, the Odisha government has decided to develop rural economic corridors in each of its 147 Assembly constituencies.

The decision was taken during a high-level meeting held under the chairmanship of Development Commissioner and Additional Chief Secretary—PK Jena recently. Accordingly, the Rural Development department (RD) has recently asked all executive engineers of the rural works divisions to

identify such roads which have potential to become economic corridors. The engineers have been asked to submit the proposals by April 12 for three roads of 15 to 25km length or more with carriage way width 7.5 metres.

Out of the three, the concerned district collector will shortlist one. After receiving the truncated list from collectors, approval of government will be taken and work will start, sources said. The government has asked the executive engineers to take help of Odisha Space Application Center (ORSAC) if required to select the best three roads in one constituency

Experts blame politicians for 2nd COVID-19 surge

New Delhi, April 8: India's COVID-19 cases have soared 13-fold in barely two months. This second wave has happened due to open disregard for safety protocols in India. Election rallies led by Prime Minister Narendra Modi and other major political figures, as well as crowded festivals and religious gatherings, have characterised the record resurgence of the new COVID-19 cases.

After quelling the first surge late last year, India's leaders let down their guard. Allowing or even encouraging dangerous behaviour at election rallies and religious gatherings, they underestimated the lethal capacity of the virus. As a result, India has seen more than one lakh daily new infections for three days in the ongoing week. Experts also say that Indian leaders

broadly which has led to this calamity. Many of India's 1.35 billion people ignored masks and social distancing, reopened the economy too fast and too while politicians including Modi and were guilty of fostering such behaviour.

"We were really premature to celebrate," University of Michigan epidemiologist Bhramar Mukherjee was quoted as saying by 'Reuters'. "This is a lesson. The really treacherous thing about this virus is how silently it casts its footsteps. By the time you see the cases and deaths, the damage is done," he added

Health Minister Harsh Vardhan told officials of 11 of the worst-hit states this week that 'people largely gave up on COVID-appropriate behaviour, became very careless' as activity resumed.

"There have been elections, religious gatherings, reopening of offices, lots of people travelling, attending social functions, not following rules, little mask-wearing in functions like weddings, even on crowded buses and trains." Vardhan said in a video conference. But then he himself has faced criticism for tweeting dozens

of images and videos of party rallies. Authorities have imposed some curbs on movement, but ministers and industrialists have advised against another national lockdown.

Being in power is of prime importance to all political parties in India. That is why authorities have refused to call off the weeks-long Mahakumbh festival, held once every 12 years on the banks of the Ganga in Uttarakhand. A successfully run 'Mahakumbh', which is expected to draw millions of devotees, is seen as crucial for the campaign of Modi's BJP in the state, which votes next year. "Political leaders are themselves

responsible" for the resurgence by allowing the packed rallies, said Subhash Salunke, a former WHO official who advises the worst-hit state, Maharashtra. "The upward trend is going to be there for another couple of weeks," Salunke added

Bhubaneswar, April 8: The main branch of State Bank of India in this city was sealed again for 96 hours Thursday after it came to the fore that 17 more employees had tested positive for COVID-19. The main branch had earlier been sealed Sunday for 48 hours after seven of its staff was found coronavirus positive. However, work in the branch situated in Unit-I here will remain suspended from April 8 to 11, BMC officials said Thursday. So far 24 employees have tested positive from the branch.

During the period no one shall be allowed to go inside the bank except authorised personnel of BMC.

The employees infected by COVID-19 have been directed to remain in isolation at their respective residence. SBI authorities have been asked to inform BMC officials if they observe COVID-19 symptoms in other staff. If any positive case needs medical attention, the bank authorities are to intimate the 🛁 same to BMC immediately.

"After seven tested positive in the first phase, it was decided to have another round of tests. In the second phase, 17 others were found positive. So it was decided to closedown the branch for 96 hours," said a BMC official.

Bhubaneswar, April 8: In a step forward to empowering women at grassroots level, Chief Minister Naveen Patnaik Thursday directed the district Collectors to hand over unused assets of the state government to Mission Shakti Mahasanghs.

The order applies to unused as sets like government buildings, shops, and ponds. All such unused government properties in the block, panchayat and district levels should be handed over to the local Mission Shakti Mahasanghs within two months, Patnaik said. Mission Shakti members can utilise these for the social and economic development if handed over to them, he said.



No night curfew now, says BMC

Bhubaneswar, April 8: With cases of Covid-19 rising persistently in the Capital city and specula tions doing the rounds about night curfew, the Bhubaneswar Municipal Corporation (BMC) Thursday clarified that it is looking to enhance its enforcement drive rather than enforcing another lockdown.

Addressing the media here, BMC Commissioner, Prem Chandra Chaudhary said while the decision lies solely with the state government, the civic authority is presently focusing on micro-containment zones and closure of the affected areas.

"There is no plan as of now to impose any shutdown or night curfew. We have planned on curbing the spread of virus by enhancing enforcement drives. Thus, we have earlier directed colleges to ask students to leave for home who don't have any exams. We have also restricted access to Bhubaneswar Municipal Corporation and Bhubaneswar Development Authority office that can potentially lead to spread,' Chaudhary stated.

The BMC Commissioner also mentioned that special teams have formed that are effectively looking into intense contact tracing of the affected patients.

Meanwhile, enforcement drives are being done regularly in markets, malls and other public gathering areas.

"Continuous sealing is being carried against any Covid violators that are found violating social distancing and other norms as directed by the BMC," the BMC Commissioner added.

Bhubaneswar, April 8: The Covid-19 tally in Odisha mounted to 3,45,526 Thursday as 879 more people tested positive for the infection, the highest single-day spike this year. Active cases in the state jumped to 4,888 from just 665 March 8 – more than 7 times jump - and 3.38.662 patients have so far recovered from the disease, the official said.

Of the new cases, 518 were reported in quarantine centres and 361 during contact tracing.

Khurda district, comprising the state capital Bhubaneswar, reported

the highest number of new cases at 144, followed by Sundargarh (131), Nuapada (61), Bargarh (53) and Cuttack (50). With the sudden rise of

coronavirus infections in the state, the Health and Family Welfare department has asked the district authorities to strengthen infrastructure in Covid care centres and hospitals.

Active cases in Odisha jumped to 4.888 from just 665 March 8, and 3.38.662 patients have so far recovered from the disease, the official said.

The death toll remained at 1,923 as no fatality due to the infection was reported in the last 24 hours. Fifty-three other Covid-19 patients have died due to comorbidities so far.

The state has so far conducted over 92.75 lakh sample tests for Covid-19, including 31,057 on Wednesday, and the positivity rate stands at 3.73 per cent.

on recommendation of their grades and respective heads of the departments for carrying out dissertation/research work. Hotel mess will remain closed from April 17. However, mess of research hostel will remain open till further notice.

Bhubaneswar, April 8: In an attempt to contain the spread of Covid-19 infection, the state government Thursday decided that no Covid infected person be kept inside the jail premises.

The state government issued a Standard Operation Procedure (SOP) to the superintendents of all jails asking them to implement it in letter and spirit.

The Directorate of Prisons and Correctional Services, Odisha, in the letter asked the Superintendent of all jails to take measures to contain the spread of Covid-19 inside the prisons.

About 200 jail inmates of different prisons had tested positive for the virus last year, an official said, adding that the government then allowed to keep Covid-19 cases in the jail premises separately.

However, this time, the SOP has categorically said that the prison inmates will be sent to the dedicated Covid care centres or Covid hospitals for treatment.

"Anybody found positive in this process, should be sent to the dedicated Covid Care Centre/Covid

Health Centre/Covid Hospital by the concerned remanding agencies like Police, Forest, Excise or Vigilance as the case may be for treatment with the permission of remanding courts," the SOP said, adding that they will be shifted to jails after recoverv from Covid-19.

Other instructions in the SOP as well as guidelines issued during 2020 shall be followed, the letter mentioned.

Last year, in accordance with a court order, the Odisha government had released 16,789 under trial prisoners (UTP) and convicts to decongest prison cells.

The government had also introduced an e-Mulakat system in order to reduce physical interaction between prisoners and their family

IIT STUDY HINTS AT 5-LAYERED MASK TO DEFEAT CO


Bhubaneswar, April 8: Aerosol droplets' reach and leakage from various protective measures like face masks and shields during breathing might trigger the airborne transmission of Covid 19 and other similar diseases, a recent study conducted at IIT-Bhubaneswar said. The study also suggested use of five-layered masks to keep the highly infectious virus at bay.

The study was conducted by Venugopal Arumuru, assistant professor, School of Mechanical Science (SMS), and his team. Director, IIT-Bhubaneswar, RV

Rajakumar, while congratulating the team for conducting a relevant

and relatively unexplored study said, "Breathing as a source of virus transmission is not adequately explored in the past. Our recent study is a step ahead in this direction." He said that the study highlights that commonly used protective measures like face masks and shields are unable to prevent the escape of droplets generated during breathing.

The leaked aerosol particle may contain the virus which may trigger the airborne transmission of Covid 19 and other similar diseases. Under these circumstances, the conventional CO₂ level measurement in confined space for assessing Air Quality Index may not be sufficient to regulate the airflow.

The study highlights that the smaller droplets (diameter < 10µm) expelled during breathing can travel

up to 4ft in 5sec. The study strongly recommends not using a surgical mask during normal conversations.

Surgical mask and face shield combinations are discouraged in hospitals and other places where strict social distancing guidelines are difficult to follow.

A commercial N-95 mask completely impedes the leakage of the droplets in the forward direction. However, the droplets' leakage from the gaps between the mask and nose is observed to be significant, the study said, suggesting that a five-layered mask is observed to be the most effective preventive measure with minimum leakage of the droplets.

Venugopal said that the majority of the past research focuses on understanding droplet generation and transport through the leakage of

the aerosol particle.

The breathing pattern is simulated at the exit of a standard mannequin's nose, using air and fog as tracer particles.

However, breathing, the most common phenomenon, is scarcely studied as a virus transmission source, and the present study goes a step further by evaluating the risks involved with various masks and non-practising of social distancing.

The breathing patterns simulated in the study imitated typical breathing frequencies that include breathing while standing at rest and also slightly longer breaths of healthy adults involved in a moderate activity like walking.

Jajpur, April 8: Police arrested three people involved in the bomb attack on RTI activist Sarbeswar Behura near Imamnagar under Dhamashala block in Jajpur. However, police did not disclose the identities of the accused who were produced in court Thursday. According to SP Rahul PR, four

bombs were hurled at Behura over a past enmity.

Considering the seriousness of the incident, police had formed a special squad under Jajpur Road SDPO Chinmay Kumar Nayak.

All the accused were involved in various illegal activities which came to the notice of the police and the administration. The accused suspecting that Behura was exposing them, attacked him and two of his friends at Imamnagar March 27 night. Behura was critically injured. "Further investigation to find whether others were also involved in the matter is on. The identities of the accused will not be revealed as the investigation is still underway," the SP said.

For the last two decades, black stone is being plundered in various parts of Dhamrashala, leading to huge loss of revenue for the government. RTI activist Behura had drawn the attention of the NGT, the High Court and the Lokayukta towards the rampant black stone mining.

The administration had assessed the loss due to stone quarrying at Dankari hill at ₹58 crore. The NGT had asked the government to recover ₹25 crore as penalty.

6-yrs on, horticulture garden remains a dream

Kendrapara, April 8: Despite the allotment of land and funds, the proposed model horticultural garden project in Kendrapara district has failed to take off.

According to a report, the district administration had identified 60 acres at Nolasahi village under Derabish block for the project, while the state horticulture department had sanctioned ₹2 crore for the construction of a boundary wall of the garden and plantation. However, after the initial euphoria, the project has failed to make any headway.

The establishment of the garden was necessary as severe irregularities were alleged in plantation of coconut saplings in which the district administration has spent over ₹3 crore during last five years under MGNREGS project.

There is no trace of coconut sapling plantation in Garadpur and Derabish blocks even as many beneficiaries have received funds for plantation of saplings. Ironically, many of the beneficiaries have received funds despite having no land for plantation. Residents have demanded a thorough probe into the fraud to unravel the irregularities and punish the guilty.

Local residents claimed that the project would have brought a turnaround in the lives of farmers in Kendrapara district as the mainstay of the people here is agriculture. This district still does not have any industrial activities.

Reports said barring Kendrapara, model horticulture gardens have been established in other districts of the state. The garden is part of a plan of the state government to grow various fruit-based plants such as mango, coconuts, guavas, papaya, pineapple as well as flowers and sell them to the general public. On the other hand, the farmers would receive saplings for plantation at a nominal price.




The district administration had initiated the move to establish the proposed horticulture garden six years back. Farmer leaders and residents have expressed their displeasure over the delay in completion of the project. They alleged that the project has slipped into coma even before it was started. They blamed the apathy of the administrative for the inordinate delay.

Farmer leaders Gayadhar Dhala and Bidhu Bhusan Mohapatra, social activists Manoj Navak, senior citizens Prabhat Parida and Radhakant Mohanty said agriculture is the main occupation of the people in the district as there is no industry or mines in the region. The fertile soil of the district, favourable climatic conditions, presence of seven rivers flowing through the district makes a strong case for establishment of the horticulture garden.

The above conditions are quite favourable for cultivation of cash crops like fruits, flowers and vegetables. However, despite the favourable conditions farmers here are deprived of proper saplings, provision of training in modern agricultural practices and availability of fertilizers and farm tools at subsidized rates. Many of these problems could have been solved if the district administration had taken more initiative to establish the proposed garden, they said.

Contacted, Kandha Jena, Deputy Director of Horticulture, said that the proposed site is under the jurisdiction of the Forest department. The project work can only begin after the Forest department hands over the land to the district administration for which efforts are underway. This apart, he assured to conduct a probe into the irregularities in plantations in the district.

DON'T BANK ON THIS PLEASE!

⁻hy does the govern∙ ment of India want to sell the Public Sector Banks? Are they not serving the public purpose anymore? Will their profitability surely increase under private ownership, and who will apportion that profit? Will the depositor's money be safer under private management? The government has a democratic duty to answer these questions before going ahead with its plan announced in the recent Budget - privatising two PSBs, besides the IDBI, this fiscal. Its privatisation obsession should not blind it to the private banks' fail ures and the PSBs' achievements. The rapid branch network expansion is the foremost of achievement of banks' nationalisation. By September 2020, the number of bank-branches has reached to 1,60,827 from a mere 8,187 before

the bank nationalisation, in 1969. In rural areas, the bank branches increased from a mere 1,443 in 1969 to 52,632 by September 2020, raising rural share from 17.6 per cent to 32.72 per cent. It is another

matter that the rural share has fallen from 58.2 per cent peak of 1990 after the bank 'reforms'. The Scheduled banks' outstandingcredit has increased from ₹3,987 crore in 1969 to ₹1,07,04,649 crore by January 1, 2021 and the deposits have gone up from ₹3,035 crore to ₹1,47,26,753 crore (75.59 per cent of the GDP). The private

banks' deposits, as of March 2020 amounted to ₹40,40,424crore (30.88 per cent share in total) against the PSU banks' ₹90,43,443 crore (69.12 per cent). Their outstanding credit was ₹37,07,435crore (36.79 per cent) against PSBs' ₹63,71,042 crore (63.21 per cent).

The public sector banks' coverage of rural areas was far better than their private counterparts. The PSBs (including RRBs) have 44,397 rural branches (84.35 per cent of total rural branches) whereas the private sector banks have only 8,235 rural branches with a 15.65 per cent rural share. However, the present number of 52,000 rural branches, of both PSBs and private, against more

Also, the private banks are lagging in the deployment of rural ATMs with 6,112 (18.34 per cent) in total rural ATMs of 33,312, as of the end of 2020.

Turning to profits, the private banks can never match the PSBs in their profit earning in its true sense, not only because the public sector banks have higher risk-taking capacity but due to the dual nature of their profitability- social and commercial profits.

Social profit comprises, improving banking services accessibility in the unbanked areas and to the weaker sections of the society; this type of profit is intangible and measured in terms of the increase in incomes, output and employment in the country.

The very need for nationalisation arose due to the failure of the private sector in the area of commercial viability and the protection of depositors' money, let alone any social profit. Many banks failed during British India. One prominent reason for their liquidation was combining trading activity with banking. The trading houses like Alexander and Co., and Ferguson and Co. set up the

₹94,291 crore as of March 31, 2020 (87.25 per cent of the total ₹1.08 lakhcrore) against the private banks' share of a mere 7 per cent.

Three, more important than the preceding two or anything else is the PSBs' support to farming. Their outstanding agriculture credit was ₹4,50,207crore (86.6 per cent in total credit to agriculture) as of March 2020 against the private banks' ₹72,893 crore (13.94 per cent).

Despite wielding higher social responsibility, the PSBs' operating profits during the five years, 2015-16 to 2019-20 aggregated to ₹7,77,043 crore. The huge provi sioning, ₹9,84,415crore towards bad loans turned them red, ₹2,07,372 crore net losses.

The bank unions say that the loan default was willful-meaning those who had the capacity could evade the payment. And they argue that most of these bad loans belong to private corporates. The quantum of bad loans written off from 2001 to 2019 amounted to a whopping ₹6,94,037crore. The NPAs, as can be seen from the economic survey 2020-21, are not exclusively generated in the PSBs. The NPAs, of private banks, up to March 2020 amounted to ₹2,05,848crore against ₹6,87,317 in PSBs.

The loans have become bad due to the corporate customers' default; the written-off sum of 50 corporate customers aggregates to ₹68.607 crore. The idea, therefore, of transferring the bank ownership to the loan defaulters makes no sense.

The right solution for correcting the functioning of the PSBs would be putting in place a better regulation and control mechanism. If the government finds flaws in the PSBs' functioning it has every reason to correct them, but it should not throw the baby out with the bathwater. On the contrary, there is every reason and scope for the nationalisation of private banks, not the other way round if public and government interests converge.


tary review of the law after five years. In addition to a general overview of how the law is working, the review will consider two issues that will help to shape public discussion of assistance in dying. One is whether advance requests should be permitted (for example, by someone in the early stages of dementia who is still capable of enjoying life, but does not want to live beyond the point when that capacity has been lost). The other issue the review will consider is whether assistance in dying should be available to someone whose intolerable and irremediable suffering is caused by mental illness.

The issue of allowing advance requests for assistance in dying will become more pressing as populations age and more people develop dementia. Last year, the Dutch Supreme Court ruled that doctors cannot be prosecuted for carrying out euthanasia on patients who have given written consent, but subsequently lost the capacity to consent.

The overriding reason for permitting this is that it allows patients in the early stages of dementia to enjoy their lives, without fearing that unless they commit suicide while they are still capable of doing so, they will become what Gillian Bennett, a Canadian advocate for advance requests, called "an empty husk." Bennett took her own life, because she had been diagnosed with dementia and did not want to prolong a life she would no longer be able to enjoy, entirely dependent on nurses who should have been using their vocation to care for patients who could benefit from it.

Reverting to the social profit, three other achievements of PSBs. besides their spread in unbanked and rural areas, merit a mention here. One, they operate 97.2 per cent of 41.98 crore Jan-Dhan accounts in the country. Their share of these accounts in rural areas is still higher at 97.50 per cent against the 2.5 per cent share of the private banks.

Two, the PSBs (including RRBs) have bank-linked more than 80 lakh SHGs (78 per cent of the total 1.02 crore). The outstanding amount of SHG loans of these banks was

Canada's 2021 legislation explicitly excludes mental illness as a sole ground for receiving assistance in dying, but the exclusion will automatically lapse in two years. That sets a deadline for parliament to decide what safeguards are needed to ensure that the suffering of mentally ill people who request assistance in dying is truly irremediable.

There can be little doubt that some mentally ill people are not helped by treatment, and do suffer greatly. It is hard to see why, if suffering from an incurable but non-terminal physical illness suffices for assistance in dying, suffering that is as bad or worse from incurable mental illness should not also be sufficient. Moreover, for people who are suffering from untreatable depression or other mental illnesses that do not respond to treatment, merely being judged eligible for euthanasia can in itself make life more bearable

Mental illness is accepted as a ground for euthanasia in Belgium and the Netherlands. A study of 100 psychiatric patients in Belgium who requested euthanasia on the basis of their psychological suffering found that 48 of the requests were accepted, but eight patients postponed or cancelled the procedure, "because simply having this option gave them enough peace of mind to continue living.

The only remaining question might be the reliability of psychiatric assessments of whether a patient's mental illness is incurable and will continue. But in the end, only the patient can judge how unbearable the suffering is, and therefore, how much weight should be given to the possibility that it will end, either with further treatment or on its own.

He cannot claim sole credit, however, for he was preempted by Sir Edward Dering more than three centuries ago.

Communicating its urgency in a clear. fact-based, and responsible manner thus has become crucial. Without hard-hitting, accurate, and compelling reporting and analysis of the problem, voters will not understand it, let alone demand solutions from the policymakers who can mobilise the resources needed to confront it.

Owing to the sheer complexity of the climate challenge, we need experienced, committed, and knowledgeable journalists covering all facets of the problem full-time. As an issue that will affect everything on the planet and all aspects of our own lives, climate change is not just some niche newsbeat. The transition to clean, carbon-neutral energy implies an overhaul of the entire global economy – a transformation that will affect how we work, consume, and care for our families.

Already, almost every important news story today must be understood within the context of the clijournalists best suited to cover the challenge thus will be "systems" thinkers, women and men who excel at drawing connections and then explaining them well. The task calls for a technological perspective, to trace the links between the electric grid, mobility, buildings, and industry, as well as an ecosystems perspective, to identify the links between extreme weather, crop failures, global supply chain disruptions, and financial risk.

Of course, many fine journalists already are covering the climate crisis. It is they who have spread public awareness of the issue and done the hard work of exposing the false and fraudulent arguments advanced by climatechange deniers and backed by the fossil-fuel industry. But there are still plenty of climate-related issues that warrant deeper coverage. When it comes to climate journalism the more the better As the Swedish climate activist Greta Thunberg says, everyone is needed, and everyone is welcome.

Established journalists who focus on other topics need to understand how their areas of expertise fit into the climate challenge. Veteran climate reporters need to support

And influential voices online - whether they are making videos on TikTok or building audiences through Substack or Clubhouse - need to use their platforms to spread the word. Now more than ever, we need foundational public knowledge about clean energy - its business models, technologies, and the policy and regulatory issues it

Without compelling and accessible coverage that reaches a broad global audience, the scale of the challenge - and of the opportunity it represents - will not be recognised in time, and the transformation we need will come too late. We need to cut our emissions by at least 50 per cent by 2030 to hit net-zero targets by 2050. Failing that, we will need to start preparing for worst-case climate scenarios. Human civilization itself will be at risk.

Business leaders who understand this are already moving toward the net-zero future, where they will secure a significant firstmover advantage. As a recent report from the World Economic Forum explains, fortunes will be made and lost according to who takes the climate challenge seriously.

Second wave

Sir, The Union health ministry has stated that the next four weeks would be crucial in terms of containing the Covid-19 spread and stressed that people's participation - meaning strict adherence to health protocols - is of vital importance. It also stressed the tools to control the virus spread remained the same - vaccination, social distancing and wearing of masks in public places. The fact that the last 25 days saw a sharp rise in daily infection rate from just 20,000 to one lakh shows the seriousness of the problem at hand. The worst, it appears, is yet to come. Doctors say the viral strain in the Second Coming is capable of spreading faster than the first one. While many are managing to overcome the virus attack with simple doses of tablets, several of the infected are faced with serious problems like breathing difficulty, organ malfunctioning and other fatal complications. Worldwide, the US, Brazil and India remain the worst affected. Big cities like Mumbai, Pune, Bangalore and Delhi are bearing the brunt while the countryside and small towns are least affected. The scope for physical contacts is more in cities and the social distancing norm is more often than not flouted. Marriage events, where there are close interactions, and the like are helping in the Covid spread mainly because the set norms are not being followed. By doing so, people are inviting harm to themselves. Proof is Bihar and UP, which are reporting larger numbers of daily infections; and this has a direct bearing on the failure on the part of the police in these states to enforce social distancing, mask-wearing and hand-washing norms. The animal-like herding together of migrant workers in chawls in Mumbai and Pune, where the government cared little for them, proved to be the undoing for Maharashtra. Life in Mumbai remains largely paralysed for the past over a year and the government is more busy practising new "extortion" techniques. K Ravi, BHUBANESWAR

According to the government spokesman, there was a sudden rise in the number of people coming for vaccinations and the total number of vaccinations April 5 were 5.01.599

On April 5, due to the sudden rise in the number of vaccinations, Uttar Pradesh became the most vaccinated state. Considering the figures, a highest number of vaccine doses were given in the state April 5, leaving behind Maharashtra, Gujarat, West Bengal Rajasthan, Madhya Pradesh and Bihar.

According to the data released by the Union Health Ministry, on April 5, a total of 2,58,475 vaccine doses were given in Bihar: 3.24.934 in Gujarat; 2,61,057 in Madhya Pradesh 4,74,017 in Maharashtra; 4,75,558 in Rajasthan; 4,11,562 in West Bengal with the maximum being 5,01,599 vaccinations in Uttar Pradesh.

in Gujarat, migrant workers and their families have started leaving Surat and Ahmedabad, two of the state's most severely affected cities.

However, government officials Thursday claimed the number of those leaving was very low and people cannot be stopped from moving from one place to another. "There are no formal reports which suggest that a large number of migrants are leaving. However, we have asked district authorities to ensure that workers do not face any trouble," state Additional Chief Secretary, Labour and Employment,

Vipul Mittra told PTI. Since there is no lockdown and trains are also running, people are free to move anywhere in the country, he said. Mittra said though some people are going back to their native places, "it's not happening on large scale".

In Ahmedabad, a number of migrant workers, mostly hailing from Uttar Pradesh and Bihar, have been rushing to the city's main Kalupur railway station to travel to their na-



tive places, said Yogesh Mishra, member of the Zonal Rail Users Consultative Committee.

The migrants fear they would be stuck here if the government imposes another lockdown, Mishra said, adding that the waiting list for reserved seats in trains is also increasing with each passing day.

"The Gujarat High Court recently suggested that a lockdown should be imposed. This has created panic among the migrant workers, who suffered a lot last year due to the sudden lockdown and travel restrictions," he said. Now, migrants are in a hurry

to reach their native places, said Mishra. "People from UP are leaving in large numbers, mainly because they don't want to miss the panchayat polls, starting from April 15. Many have also planned marriage ceremonies, which were cancelled last year," he said.

People are extra cautious this time and want to leave before any travel restrictions are announced, he added

In Surat, migrant workers belonging to UP, Madhya Pradesh, Bihar and Jharkhand have been leaving in luxury buses, but their number is not very large, Surat

Surat: In the wake of a sudden spike in COVID-19 cases, a 12member central team visited Surat in Gujarat Thursday and collected information about the vaccination process and the number of patients being treated in the district, a senior official said. New wheat varieties high in nutrition, low on sugar

Pravagraj (Uttar Pradesh), April 8: A genetic scientist at Sam Higginbottom University of Agriculture, Technology and Science (SHUATS), in Prayagraj has developed two new varieties of wheat that are very high in nutrition, need less water, are resist ant to extremes of weather and also has a very low sugar content.

Mahabal Ram, 79, professor emeritus, has written to Chief Minister Yogi Adityanath requesting him to ensure more cultivation and wider use of these nutritive-rich super wheat varieties that have already been notified by Central Variety Release Committee of the Union ministry of agriculture and are presently under limited cultivation in the state.

The agro-scientist further said that these wheat varieties can be provided to the poor through the

"Both the varieties can tolerate high temperatures of 40 to 42 degree Celsius against 30 to 32 degrees of regular varieties sown by farmers. They can even withstand water logging for 7-8 days and still flourish," he claimed.

The cost of production of the two varieties is 30-35 per cent less as compared to ICAR-released wheat varieties PBW 343, HD 2967 and DBW 187. he said.

In grain quality analyses, CSIR-Central Food Technological Research Institute Mysuru found SHIATS-W6 having protein (14.31 per cent). zinc (3.44mg/100g), iron (3.54mg/100g), fibre (2.89 per cent) and sugar below detection limit i.e., free from sugar.

The SHUATS-W10 variety contains protein (12.56 per cent), zinc (3.19mg/100g), iron (3.39mg/100g), fibre (2.49 per cent) and sugar (0.2 per cent).



13 yrs after Tata's ouster, Singur seeks industrialisation

Battle lines have been redrawn in Singur, which along with Nandigram shook the foundations of the mighty 34-year-old Left Front regime and propelled Mamata Banerjee to power

Singur, April 8: Thirteen years after a farmers' stir put Singur on India's political map, having forced the exit of Tata's Nano car project, industrialisation has emerged as the main poll plank in this constituency as the land, for which swords were crossed, has been rendered infertile.

Battle lines have been redrawn in Singur, a place that along with Nandigram shook the foundations



of the mighty 34-year-old Left Front regime and propelled Mamata Banerjee to power in 2011, with TMC's sitting MLA Rabindranath Bhattacharya - a front-runner of the anti-land acquisition protest -

shifting his allegiance to the BJP. The ruling camp has field Bhattacharya's former associate, Becharam Manna, from the seat.

Farmers, who had been handed over the land parcels that were initially acquired for the Tata proj-

ect, now depend on government doles and petty jobs to make ends meet. Many of them feel betrayed as the TMC government failed to keep its promise of turning their

arid plots cultivable. Ironically, both the TMC and the BJP have promised industrialisation in Singur this election, having got a whiff of local sentiments, with 'Master Moshai' (the teacher) – as 89-year-old Bhattacharya is commonly referred to - and TMC candidate Manna crossing swords in the area over the issue.

The CPI (M)'s Young Turk, Srijan Bhattacharya, however, hopes that he would have the last laugh in the agrarian constituency, where his party desperately seeks to recover its lost ground.

Rabindranath Bhattacharya, once the eyes and ears of Mamata Banerjee's Singur movement, said, 'We were never against industry; we were against forcible land acquisition. Somehow, things went out of control. The people here now want industry. If the BJP comes to power, we will work to bring investments in the area.

Manna, who is trying his best to keep the TMC flag flying in the constituency, said agro-based industries are best suited for the place.

"A few agro-based industries have already come up in Singur. The TMC dispensation had been putting in efforts to make this area a major hub of agro-industries in the near future," he claimed.

Srijan, the 28-year-old firebrand student leader, mocked both Bhattacharya and Manna over their assertions and said the TMC and the BJP are only repeating what the Left Front had said 15 years ago.

'Both of them are shedding crocodile tears, having sensed the mood of the people. We had missed the bus back then. Only the Left, however, can change things for better," the SFI state secretary said.

Singur - once known for multiple crop farming - hogged the limelight after Tata Motors set its sight on the area to build its cheapest car manufacturing unit, Nano, in 2006. The Left Front government had acquired 997.11 acres along National Highway 2 and handed it over to the company.

Leading from the front, the then opposition leader and TMC supremo Mamata Banerjee had called for a 26-day hunger strike, demanding the return of 347 acres that were ap-

parently forcibly acquired.

The TMC, which had a strong support base in the area with Bhattacharya as the sitting MLA, spearheaded a mass movement against the alleged acquisition.

Despite numerous meetings and consultations between the TMC and the Left Front government, no solution was reached, and Tatas eventually moved out of Singur and built its plant in Gujarat's Sanand. Land acquired for the project was subsequently returned to locals in 2016.

The Mamata Banerjee government, over the last few years, however, failed to turn the barren tracts fertile as it involves huge expenditure, and many farmers ended up selling their plots.

According to agricultural experts, with concrete pillars and cement slabs embedded in the land, at least seven to eight inches of topsoil will have to be removed to make the plots in Singur cultivable.



Islamabad, April 8: Pakistans National Assembly Standing Committee on Interior has approved a Bill that would punish those who intentionally criticise the countrys armed forces.

The committee has approved the Bill to amend the Pakistan Penal Code and Code of Criminal Procedure 1898, sanctioning punishment to those who ridicule armed forces through intended criticism.

As per the details of the Bill, anyone who shall be guilty of said offence could face up to two years imprisonment or fine that may extend to Rs 500,000 or both.

The Bill titled Criminal Law Amendment Bill 2020, which was introduced by the ruling party's Amjid Ali Khan, was approved by the committee despite opposition from the political camps.

The Bill proposes amendment to Section 500 of the Pakistan Penal Code (PPC), which currently states whosoever defames another shall be punished with simple imprisonment for a term which may extend to two years, or with fine, or both.

The amendment proposes punishment for international ridiculing of the armed forces etc.

Whosoever intentionally ridicules brings into disrepute or defames the armed forces of Pakistan or a member thereof, shall be guilty of an offence punishable with imprison ment for a term which may extend to two years, or fine which may extend to five hundred thousand rupees, or both.

Opposition lawmakers from Pakistan People's Party (PPP) and Pakistan Muslim League-Nawaz (PML-N) opposed the proposed amendment, stating that there was no need to introduce the Bill, as it is already covered under Article 19 of the Constitution.

Other than the opposition party's concerns, the home department of the Khyber Pukhtunkhwa (KP) provincial government, which is led by the Pakistan Tehreek-e-Insaf (PTI), also opposed the Bill, stating that its declaration would create conflict among the existing constitutional and stationary provision, adding that its misuse could not be overruled. The KP government also maintained that the Bill would create differences and discrimination between other law enforcement agencies and public offices.

However, the Interior Ministry maintains that the amendment is being proposed because of the increasing criticism against the armed forces in the country

In an operation lasting 10 days during March, the Iraqi Security Forces ground troops cleared ISIS terrorists from the Makhmur mountain region, south-west from Erbil, while RAF and other Global Coalition aircraft carried out a major air offensive in support.

The operation began when ISIS extremists were confirmed to be based in a network of caves

"The British Armed Forces, alongside our Iragi and coalition partners, continue to root out Daesh [ISIS] terrorists from where they hide," said UK Defence Secretary Ben Wallace.

"The UK is committed to defeating Daesh. This operation will prevent the terrorist group and its toxic ideology from regaining a foothold in Iraq and reduce its capability to coordinate attacks around the world," he said. Since the caves were assessed to be a particularly challenging target, three Typhoon FGR4's were tasked to conduct an attack using Storm Shadow missiles, the remote area having first been checked to ensure that no civilians would be placed at risk. The strike on the ISIS target was assessed by subsequent surveillance to have been a success, the RAF said.

Throughout the 10-day opera tion, the RAF used 42 Pavewav IV bombs and 10 Storm Shadow cruise missiles which have been used during the multiple strikes throughout the operation.

an open market.

The grasses also curb the acidity of surrounding waters -- an especially important function as the ocean absorbs more CO2 from the atmosphere and becomes

more acidic. But seagrasses provide some buffer from acidification, which can damage animals' shells and disrupt fish behaviours. In one study published March 31 in the iournal Global Change Biology, scientists at the University of California, Davis, found that seagrasses dotted along the California coast could reduce local acidity by up to 30% for extended periods.

The plants also help clean polluted water, support fisheries, protect coasts from erosion, and trap microplastics, said the study's lead author Aurora Ricart.

'What is even cooler is that these habitats are present everywhere," she said. While most seagrasses fringe coastlines around the world,

the shallowness of Saya de Malha allows sunlight to filter to the seabed, creating an aquatic prairie in the Indian Ocean that provides shelter, nurseries and feeding grounds for thousands of marine species.

The bank's isolation has helped protect it from coastal threats, including pollution and dredging. But even such remote stretches of international waters face increasing incursions from shipping and \rightarrow industrial fishing.

Data on seagrass meadows are patchy, but research so far estimates the grasses cover over 300,000 square km (115,000 square miles), distributed across all continents apart from Antarctica, according to UNEP. That would be an area the size of Italy.

The outlook, she asserted, is brighter because millions of people are benefitting from vaccinations and because of further policy support, especially in the US. Georgieva said this is adding to the exceptional and coordinated actions taken over the past year.

Without them, without those fiscal and monetary measures, the global contraction last year would



have been three times worse. This could have been another Great Depression," she noted. 'We have a good news that there

is light at the end of the tunnel.

After the worst global recession since the Second World War, the recovery is underway. As you know, yesterday we lifted our global growth forecast to 6 per cent for this year,

4.4% for 2022," Georgieva told reporters at the start of the annual Spring Meeting of the IMF and the World Bank on Wednesday.

Yet, while there is light, the crisis continues to cast a dark shadow. Economic fortunes are diverging dangerously. A small number of advanced and emerging market economies, led by the US and China, are powering ahead. Weaker and poorer countries are falling behind in this multi speed recovery, she rued.

'We also face extremely high uncertainty, especially over the impact of new virus strains and potential shifts in financial conditions. And, there is the risk of further economic scarring from job losses, learning losses, bankruptcies, extreme poverty, hunger. Policymakers must take the right actions now by giving everyone a fair shot - not just into people's arms, but also in people's lives and in vulnerable," the IMF MD said.

The Global Policy Agenda released by the IMF, she said, focusses on three things: a fair shot at the vaccine, a fair shot at recovery and a fair shot at the future.

"This is perhaps the most consequential decision that any government can make this year. The focus should be on scaling up public investment in green projects and digital infrastructure, in people's health and education, to ensure that everyone can benefit from the historic transformation to greener, smarter, more inclusive economies, she argued.

Bhubaneswar, April 8: The GST, Central Excise & Customs, Bhubaneswar Zone achieved revenue realisation of ₹39,671 crore during 2020-21 by showing a growth of 14% compared to 2019-20 fiscal, said R Manga Babu, Chief Commissioner of the Zone. Revenue realisation was ₹34,817 crore during FY'20.

The mainstay in the revenue collection for 2020-21was Central Excise duty which registered a collection of ₹24,918 crore over last year's collection of ₹20,531 crore a growth of 21.4%

On the Customs front, ₹6,213 crore was realised over last year's collection of ₹5,042 crore achieving a growth of 23.22% in revenue realisation over 2019-20. The decline in GST revenue collection from the taxpayers under Central Tax iurisdiction from ₹9.245 crore realised during 2019-20 to ₹8,541 crore was narrowed down to 7.62% despite the fact that the pandemic wrecked havoc for some months during the beginning of FY 2020-2021.

As a part of measure to facilitate taxpayers, special refund drives were conducted to clear refund claims. During the year 2020-21, a total of 1,162 claims involving ₹2,709 crore were disposed of. Further, GST Seva kendras, Customs Seva Kendras have been made operational at divisional level to handhold both GST & Customs taxpayers of the Zone.

Tarapore - in his third Olympics - and Cyrus Cama took part in the same 470 class in the 1992 Barcelona Games before Malav Shroff and Sumeet Patel competed in 49er class skiff in the 2004 Athens Olympics.
