# FREE VAX ABOVE 18

Centre forced to change course after Supreme Court order

New Delhi, June 7: The central government will provide free coronavirus vaccines to states and Union Territories (UTs) for inoculation of all above 18 years from June 21, Prime Minister Narendra Modi said Monday. He announced that the Centre will take over the 25 per cent state procurement quota.

Asserting that vaccine supply would be increased significantly in the coming days, the prime minister said the Centre has now decided to buy 75 per cent of jabs from vaccine makers for free supply to states. Private sector hospitals will continue to procure 25 per cent of vaccines but they cannot charge more than ₹150 per dose over the pre-fixed price.

The change in the government's vaccine strategy comes days after the Supreme Court asked June 2 the Centre to place on record all relevant documents reflecting its thinking culminating in the Covid-19 vaccination policy, and states questioning the central government over the alleged shortage of vaccines. Justice DY Chandrachud had questioned the vaccine procurement policy and also



raised the issue of the digital divide questioning the policy of mandatory registration on CoWIN App for jabs.

In his televised address, Modi however, highlighted that it was due to the demands for de-centralisation from many states that his government decided to allow them 25 per cent procurement from May 1.

Sources said a plan for a centralised free vaccination was presented to the PM June 1 on completion of one month of the decentralised model. Modi had given in-principle approval in that meeting and the groundwork for it began June 1 itself before being announced on Monday, they added. "Various voices were raised like

In April, the Centre had announced distribution of free foodgrains for the months of May and June under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY). In his address to the nation, the prime minister announced the government's decision to extend the scheme till Diwali.

#### Rise in fuel prices continues unabeted

New Delhi, June 7: The rise of fuel prices continued Monday with oil companies increasing the rates of both petrol and diesel for the second consecutive day. Accordingly, the retail prices of petrol and diesel were increased by 28 paise and 27 paise per litre to ₹95.31 and ₹86.22 per litre respectively in the national capital.

Kerala became the fourth state in India after Maharashtra, Madhya Pradesh and Rajasthan where premium petrol went past the ₹100-per litre mark. The price of premium petrol hit the century mark at pumps in Thiruvananthapuram, Kollam, Idukki, Palakkad, Wayanad and Kasaragod districts.

In the city of Mumbai, where petrol prices crossed ₹100 mark for the first time ever May 29, the fuel rate reached a new high of ₹101.53 per litre Monday. Diesel price also went up to ₹93.57 a litre, the highest among metros.

Across India, petrol and diesel prices increased between 24-28 paise per litre Monday but its retail prices varied depending on the level of local taxes in different states.

With Monday's price hike, fuel prices have now increased on 20 days and remained unchanged on 18 days since May 1. The 20 increases have hiked petrol prices by ₹4.91 per litre. Similarly, diesel has increased by ₹5.50 per litre in the national capital. In the last 13 months, petrol and diesel have risen by ₹25.72 and

## 18 dead in Pune fire

Pune, June 7: At least 18 persons, mostly women, were killed in a major fire in a sanitiser factory in Pune district Monday afternoon, officials said. The blaze erupted around 3.00pm in private chemical company, 'SVC Ltd', in the MIDC area of Pirangut village. It quickly spread within the enclosed premises, trapping many working

Officials said that other than the 18 already confirmed dead, around 10 other workers are feared trapped or missing in the incident.

Thick clouds of black-grey smoke could be seen billowing out of the factory premises alarming the locals, who rushed to the spot. Fire Brigade teams from MIDC, Mulshi, disaster rescue teams and others rushed to the site of the accident. Pune Collector Rajesh Deshmukh, SP Abhivan Deshmukh and other officials also reached the spot to supervise the relief operations.

A company official said that while the blaze was brought under control by late evening, they were unable to provide any clues on how the fire could have started.

Tehsildar Abhay Chauhan had earlier said that 11 bodies were recovered as rescue operations were going on in full swing. Another six bodies were found later.

Eyewitnesses said that the bodies had been charred to such an extent that it was difficult to ascertain their gender or identity, but co-workers estimate that more than 12 women are among the dead.

Bhubaneswar, June 7: Even as Odisha registered 6,118 new cases of coronavirus infections Monday. health services director Bijay Mohapatra said that the state will witness a further fall in the rate of fresh cases in the next seven to 10 days.

"The present trend of cases in the second wave of Covid-19 shows that the positivity rate will take a downward trend. Odisha currently has a test positivity rate of below 10 per cent," Mohapatra said.

The total fatality in Odisha rose to 3,035 with 41 fresh deaths reported in the last 24 hours according to a Health department official. Mohapatra clarified on the high number of fatalities. He said it can be attributed to a large number of critically-ill patients undergoing treatment at various healthcare centres. These highly critical patients are losing their battle against Covid-19, Mohapatra said.

Mohapatra also pointed out that even though there is no hundred per cent curative medicines for treatment of Covid-19, a task force has been set up

## Antigua police probing Choksi's 'abduction' claim

FUGITIVE DIAMANTAIRE CLAIMS HE WAS BEATEN UP BY 8-10 MEN, IDENTIFIES MYSTERY WOMAN, 2 OTHERS PRESENT AT THE SPOT

New Delhi, June 7: The Royal Police Force of Antigua and Barbuda has started investigations into the alleged abduction of absconding diamantaire Mehul Choksi to neighbouring Dominica on a complaint filed by his lawyers, Prime Minister Gaston Browne told Monday, a local media outlet. Browne said Choksi's lawyers gave the names of people involved in the alleged abduction to the police commissioner in a complaint, the 'Antigua News Room' reported. The Antigua and Barbuda prime minister also said that if the claims are true, then it is a serious matter.

Choksi, earlier Monday, had said through his lawyers that he was abducted and beaten up mercilessly by eight-10 men. They claimed that they were from the Antiguan police force.

Choksi's lawyers have filed an official complaint with the Antigua police. They claimed that Choksi was taken by his abductors 'forcibly' to Dominica. He was then told by his abductors that he was to meet a high ranking 'Indian politician'. In his official complaint, Choksi named 'mystery woman' Barbara Jarabica, Narender Singh, one Gurmit Singh and 'unknown persons' as his abductors.

The Dominica police have claimed in the Eastern Caribbean Supreme Court (ECSC) that Choksi was found seated in suspicious condition on the bayside near the jetty at Toucarie

However, another report in the 'Associates Times' poked holes in the theory of Dominica opposition leader Lennox Linton, who had reportedly claimed that Choksi was brought to Arne' around 10.00pm May 23.

The family of Choksi had claimed that he was in Antigua till 5.00pm May 23 which makes it impossible to cover a 120-mile distance in four to five hours, that approximately takes about 12-13 hours, the publication said. The report said that according to Customs document, the boat had left Antigua at 10.00am May 23. So it clearly proves that Choksi was not on the boat when it left for Dominica.

It quoted unnamed doctors of the Dominica China Friendship Hospital, where Choksi is admitted, that a nail injury cited by his lawyers is an old one while other bruises could be new and could have been caused by even by a 'slight push'.

# Six ECMO units at SCB soon

Bhubaneswar, June 7: Following public outrage over dearth of extracorporeal membrane oxygena tion (ECMO) machines in state run hospitals, the state government has decided to install the critical infrastructure at various government hospitals in a phased manner.

In the first phase, six such machines would be installed at SCB Medical College and Hospital Cuttack, to provide treatment to critically-ill Covid-19 patients, said Director of Medical Education and Training (DMET) CBK Mohanty while speaking to media here Monday. "Earlier, the ECMO treatment

was very limited and the cost was also not very high. But, the need for the machines has increased manifold during the second wave of Covid-19 pandemic. We are making arrangements to install six machines at SCB Medical College and Hospital for critical Covid patients,' said Mohanty.

Later, such units will be opened at various healthcare facilities in other parts of the state, he said.

"Procuring the machines is not an issue. The problem lies with availability of trained manpower to run ECMO machines. After opening of the ECMO units in Cuttack, required trained manpower will be created and accordingly they will be deployed in other places, the director added.

Sources said Odisha State Medical Corporation (OSMC) has formed a



#### What is ECMO?

ECMO is a method in which blood is drawn out of the body into a machine and then oxygen is mixed with blood using a special bypass pumpcircuit. The blood is pumped back into the body. It works as an artificial heart-lungs

six-member technical committee for installation of the machines at SCB. The machines are likely to be installed at the ICU units of Cardiothoracic and Vascular Surgery (CTVS) department of SCB Medical College and Hospital.

It was in August 2019 when the Department of Personnel and Training (DoPT) under the Ministry of Personnel, Public Grievances and Pensions issued a notification to abolish OAT by virtue of the powers vested on the Centre in accordance with the Section 2 of the Administrative Tribunal Act 1985 and Section 21 of the General Clauses Act.

## Tardy probe into OSCB job 'scam'

Bhubaneswar, June 7: The bureaucrats often go scot-free even after committing blatant irregularities while in office. Wielding their clout, the bureaucrats manage to suppress the probe in the alleged corruption cases and Odisha is no different on this count.

The undue delay in completion of the probe into the allegations of irregularities during the appointment of 14 system managers for the Odisha State Cooperative Bank (OSCB) is a glaring example of bureaucratic ruse to sweep such matters under the rug.

An RTI reply exposed that Registrar of Cooperative Societies (RCS) is yet to complete the investigation into illegal appointment of the system managers in 2013-14. The applicant, Pradip Kumar Pradhan, had sought the details regarding the date on which the inquiry was completed and the particular date of submission of the report.

The PIO of RCS office revealed April 28 that the enquiry into the matter is still in progress.

"Inquiry in connection with illegal appointment of 14 system managers by OSCB is under process. Hence, the relevant information as sought cannot be supplied as per Section 8 of the RTI Act," replied the PIO. The RCS in its February 2020 letter had directed the Assistant RCS, Chandrakant Mohanty, to investigate the allegations and submit a

probe report within a month. Notably, OSCB had issued an advertisement seeking application from interested candidates with B Tech / MSc in Computer Sc/MCA degree and 2 years of experience for the appointment of 14 system managers during the incumbency of Sethy in 2013. The state Vigilance directorate too found prima facie evidence in connection with the allegations and reportedly informed the government seeking an open enquiry into the matter.

However, the General Administration (Vigilance) department sidelined the request for open enquiry and instructed the Secretary of department of Cooperation to conduct a departmental inquiry January 1, 2020.

Speaking to Orissa POST, Pradhan alleged that the OSCB officials avoided Institute of Banking Personnel Selection and initiated the recruitment process on their own. Pradhan also accused the officials of showing undue favours to some selected candidates.

## 41 fresh fatalities push **Covid toll past 3k-mark**

Bhubaneswar, June 7: Odisha's Covid-19 toll Monday surpassed 3.000 with 41 fresh deaths, while 6.118 new cases in the coastal state pushed the tally to 8,19,214, a Health department official said.

The total number of fatalities rose to 3,035.

Of the 6.118 new cases, 3.453 were registered in quarantine centres and the rest detected during contact tracing, the official said.

Cuttack reported the maximum number of new cases at 640, followed by Jajpur at 563, Khurda at 495 and Angul at 416. This is the first time since the second wave of the pandemic began that Khurda district reported less than 500 daily cases. Odisha currently has 76,750 ac-

Taking to Twitter, the Health department said, "Regret to inform about the demise of forty one Covid patients while under treatment in hospitals (sic).

Khurda reported six deaths, followed by Sundargarh at four, and Puri and Ganjam three each.

This apart, 53 other Covid-19 patients in the state have died of comorbidities.

As many as 7,39,376 patients, including 7,358 Sunday, have recovered from the highly infectious disease. The coastal state's posi-

tivity rate stands at 6.69 per cent. Over 1.22 crore samples have been tested for Covid-19 thus far, including 67,178 Sunday.

## NGT issues notices to Nayagarh DM, DFO

A PETITION SEEKS STAY ON THE CONSTRUCTION OF A ROAD ON FOREST LAND IN THE DISTRICT

New Delhi, June 7: The National Green Tribunal (NGT) has issued notices to the District Magistrate of Nayagarh and Divisional Forest Officer of Nayagarh on a petition that sought stay on the construction of a road on forest land in the

A bench comprising judicial member B Amit Sthalekar and expert member Saibal Dasgupta held that the matter requires consideration of the tribunal and asked the respondents to file their response within four weeks. The tribunal asked the DM and DFO to file own counter-affidavits before the next date of hearing, June 28.

During the hearing, the counsel for the petitioner, Sankar Prasad Pani, contended in the tribunal that the construction of road through forest land has started without considering the availability of alternative non-forest land. The



native forest land will reduce the distance between the destinations with better connectivity and access to public utilities such as banks, school, hospitals and district headquarters

It may be mentioned here that an

original application was filed in the tribunal by Hemant Kumar Nayak, a resident of Gudupangi village in Nayagarh, district claiming that the Nayagarh DM in connivance with Rural Works department made an illegal and unlawful attempt to construct a 6 km-long road

from Balabhadrapur to Dhipmal of which a stretch of 600 meters is on forest land. The petitioner further claimed that the road is being constructed without obtaining any clearance from the Forest department as required under the Forest Conservation Act, 1980.

The road is being constructed under the Prime Minister Gram Sadak Yojana/Mahatma Gandhi National Rural Employment Guarantee Act. "Any kind of passage through forest land will cause irreparable damage to the forest and wildlife, which have been conserved at the sole effort of Gudupangi villages," the petitioner contended

The petitioner stated that the forest area is also home to a wide range of wild animals such as bear, wild boar, otter, porcupine, rabbit, wild dog, wild cat, monkey, pangolin, jackal, elk, deer, fox, wolf, and various species of

## No let-up in jumbo deaths: Second death in two days

Berhampur, June 7: A day after a tusker was found dead in a mango orchard at Gobindaprasad village under Sadar forest range of Dhenkanal district, another jumbo was found dead in Ganjam district Monday.

The elephant, in all probability, came in contact with a high voltage electric live wire in a cashew orchard near Dhaupalli village under North Ghumsur forest division in Ganjam district.

Confirming electrocution as the reason for the animal's death, local villagers said an 11KV power transmission line passes at a low height above the orchard. Searching for food, a herd of eight elephants were passing through the area Sunday night. One of them could have come in contact with the live wire and got electrocuted. On being informed, Forest department officials reached the spot and started an investigation into the matter.

While locals were of the view that the elephant must have died after coming in contact with solar fencing around the orchard, the Forest department officials were of a different opinion. According to them, the voltage in solar fence is not enough to kill a huge animal like an elephant. The fence must have been charged with high voltage electricity, the officials said.

## sexually assaults mother-in-law opt for shutdown

## Encroachments push Gobari river to brink of disappearance

PROPOSAL TO LINK THE RIVER WITH BRAHMANI REMAINS A NON-STARTER

Pattamundai, June 7: A number of encroachments on Gobari riverbed by influential people under Pattamundai civic body limits in Kendrapara district have pushed the river to the brink of disappearance, a report said.

As a result, a 20-km stretch of Gobari river is slowly getting buried. The Odisha State Construction Corporation (OSCC) has recently started excavation of the riverbed following demands by local residents who are peeved over the vanishing of the river.

Rampant encroachment of the riverbed has hit an ambitious plan to link nearly 20-km-long of Gobari river with Brahmani. For several years, local residents have been demanding that the river be linked with Brahmani river. A public interest litigation (PIL) was also filed before the National Legal Services Authority (NALSA) in this connection.

The judge of the district legal services authority, Malay Kumar Pradhan also intervened into the matter and directed the engineer-in-chief (EIC) of irrigation department to take necessary steps in this regard.

However, despite all hue and cry, some influential persons have allegedly managed to grab land on both sides of the riverbed by manipulating the records during the settlement works in 1930. They managed to obtain hand written notes from the then landlords and their children and fudged the

tehsil records to grab the land. They even managed to get land pattas in their names during the consolidation work in 1984. Consequently, have remained uncultivable due to lack of irrigation facilities.

Locals alleged that the Gobari river is fast turning into a 'dead river' due to the apathetic attitude of the district administration. This has triggered sharp resentment among the residents, local intelligentsia and social activists. The residents have demanded that the river land be cleared

of encroachment. Reports said that residents of riparian villages on both sides of Gobari would be benefitted if it is linked with Brahmani. In past, the river was linked with Brahmani which made it perennial and was useful for carry out marine trade. Gobari river has been losing its water-retention capacity owing to the large-scale encroachments on its banks. The encroachments are more in the urban areas than in rural areas as the Pattamundai to Gandakia stretch of the river is getting buried.

If the river is excavated and linked with Brahmani it would benefit over 50,000 farmers in Pattamundai. Mahakalapara, Kendrapara and Rajnagar blocks, the residents and local intelligentsia said.

However, the connecting point of the two rivers, known as 'Das Hajari bandh', was covered up during the construction of Cuttack-Chandbali

## **US-India Tariff War**

s US President Joe Biden reinvigorates his tariff war with India and gets ready for his European trip later this week, the message that is emanating from Washington is that the President wants to reposition his country in the world stage after having busied himself with fixing internal affairs, including the fight against COVID-19.

It is bad news for India that even before the President wrote a post-edit in Washington Post outlining the purpose of the first foreign trip of his presidency, including a meeting with Russian President Vladimir Putin June 16, the US Trade Representative Katherine Tai had announced June 2 the plan for the 25 per cent increase in the tariffs on 26 items from India. Of course, there is the rider that the hikes will be put on hold till December, but this is more to leave some elbow room to India rather than any real concession. For, President Biden seems to be planning to simultaneously take on China,

Significantly, the Russian President Vladimir Putin has already made it clear that no treaty among countries should be directed against any other country, Putin was referring to the Quad grouping of the US, Japan, Australia and India which ostensibly seeks to checkmate China's ambitions in the South China Sea. That he wants to wean India away from the group and goad it to make peace with China is clear from his apparent praise of Indian Prime Minister Narendra Modi and Chinese President Xi Jinping who, according to him, are both capable of sorting out their areas of differences.

It is precisely this patronising attitude of the Russian President towards India that seems to raise the hackles in the US administration. Maybe because of this that President Biden has written in his article that he wants an alternative force to counter China and Russia. Putin's bid to nudge India not to play ball with the US as part of the Quad group and instead improve its relations with China probably has made the US watch India's reaction.

This may explain the hardening of the US stance on a renewed tariff war with India threatening to increase import duties on a range of imports from prawns and Basmati rice to furniture and jewellery in retaliation against New Delhi's imposition of Digital Services (DS) Tax on tech giants, including Amazon, Google and Facebook. Twitter blocking Donald Trump while he was still POTUS and supporting Biden during the American election in November 2020 is known to all. The recent Indian government effort to scratch Twitter and make it succumb to local political pressure could also be an important secondary story in this scuffle.

Since the European or ASEAN countries are not interested in confronting China in any way, the USA was so happy to get India as a partner country of the Quad. It seemingly secured India's consent taking advantage of the country's continuous diplomatic blunders and the Kashmir tangle. Though the US Trade Representative made the announcement on the tariff war June 2. it was widely reported only after Putin's briefing of international media, including from India, patting both Modi and Xi and encouraging them to iron out their border differences.

On the other hand, the series of European summits that President Biden will hold later this week will signal the reversal of many a crucial policy of his immediate predecessor that antagonised some major allies of the USA.

President Biden is slated to first attend the meeting of the Group of Seven (G-7) nations in Britain. Then he will head to a NATO summit in Brussels where the majority of the European Union leaders will take a relook of the Trump administration's decision to dissociate the US from the NATO. The main purpose of Biden's trip seems to be to check the US' democratic allies whether they and the liberal order they claim to uphold can prove their capacity against modern-day threats and adversaries, including China and Russia and also assess whether they will be able to face the illiberal, nationalist forces gaining ground in many Western societies.

Biden wrote that the US is "back in the chair on the issue of climate change" and will deepen transatlantic cooperation on driving a global cleanenergy transition. He hailed the weekend's agreement between G-7 finance ministers over setting a minimum global corporate tax rate.

It is not yet clear whether many in Europe will fully buy the American view. But, Biden's European counterparts have reasons to be relieved by the drastic change of tone between his administration and that of Trump, who cast long-standing allies as national security threats, questioned the merits of NATO, dismissed the science behind global warming and encouraged autocrats such as Putin.

If your offspring are proving recalcitrant or obstreperous you may like to hurl the epithet nidicolous at them. It will be accurate and tantalisingly unclear: it might even provoke them to crack open a dictionary to discover whether you're insulting them. The term is unlikely to be encountered outside a specialist and rather formal book on zoology or ornithology. It was found in the article on birds in the 1911 edition of the Encyclopaedia Britannica. Latin scholars will recognise that the first part derives from the classical nidus, which is a relative of our nest as well as the source of niche and a component of a number of other specialist words. The second part is from the Latin verb colere to inhabit. However, it's more specialist than just "nest-living". It refers specifically to a bird or other animal that's hatched or born in an undeveloped state and that requires its parents to feed and care for it until it reaches maturity. Some young birds are the reverse of this - they leave the egg at least partially able to fend for themselves. They are said to be nidifugous, nest-fleeing. You may be reminded of newly hatched ducklings waddling after mum from their nest to reach water. Curiously, English has another pair of terms which form an equivalent pair to nidicolous and nidifugous. You may instead use altricial and precocial, two terms introduced by the Swedish zoologist Carl Jakob Sundevall in 1836. He coined the former from classical Latin altrix, a foster mother or wet nurse, and the latter from scientific Latin praecoces, the plural of the classical Latin praecox, premature or early. Why both pairs should stay in use is unclear.



It is powered by agricultural products like cereals, jute and other fibres, by electronic goods, specialty chemicals, iron ore, metal products and textile and clothing. Of course, one needs to examine the data in more granular detail to understand areas of maximum potential and growth momentum.

The engine of economic growth can be revved up by four demand drivers. or rather four sources of spending. These are consumers, investments (i.e. the demand coming from building new factories), government spending (on things like highways, or rural jobs scheme) and exports (i.e. foreigners spending on Indian goods and services) Presently as the country is grappling with the second wave of Covid, both the consumer and investment sentiments are weak. This has been confirmed by the Reserve Bank of India's (RBI's) latest report, as also by the surveys of various industry chambers. One proxy for investment demand is the growth in bank credit, which is barely 5 per cent. This should be growing at around 25 per cent to achieve a healthy growth of 8 per cent. Of course, 'sentiment' is as much a matter of psychology as of economics. It can turn positive quite quickly with the right combination of policy, fiscal stimulus, progress of vaccination, favourable monsoon, and pickup in infra spending. If one looks at

India's stock markets, the sentiment there remains quite bullish and the market is scaling new heights every week. Maybe the stock market is anticipating a strong economy a year from now. But the stock market rally is also due to excessive liquidity induced by a liberal monetary policy pursued by the RBI. With so much liquidity and growth in money supply, it is bound to fuel a stock rally. It is important to note that when stock market zooms, it increases the wealth of those at the higher end of the income spectrum. This might actually worsen inequality, since the incomes of the poor are still stag-

nant owing to the economic slump. The situation overseas is quite different. The two largest economies in the world, the USA and China, are experiencing very strong economic momentum. This is mainly on account of two reasons. One is vaccine optimism. The rate of vaccination is high and the proportion of the population covered is reaching or has crossed critical mass. The second reason is a very strong fiscal stimulus. In the US the stimulus was 15 per cent of the GDP last year, and is expected to exceed that amount this year too. China too has injected strong fiscal support, although its slowdown wasn't as acute. Due to these factors, these two economies, which are about 35 trillion dollars of the world economy, will grow by at least 5 per cent or even more. India's eco-

So, 5 per cent growth of US and China together is equivalent to India's economy growth by 50 per cent! That's the impact of a high base. That's the scale of the aggregate demand that's out there. No wonder there are supply bottlenecks becoming visible. Input costs are rising. The Bloomberg commodity price index is nearly 60 per cent higher than last year. Iron ore prices reached nearly 250 dollars, thanks to the demand from China. Steel prices reached 1000 dollars a tonne, a price never seen before! World trade is also experiencing an adrenaline rush, manifested in shipping costs. Bulk freight prices are 700 per cent higher compared to one year ago.

The question is whether India is ready to tap into this great export opportunity. Even if India's share in world merchandise trade goes from the present 1.5 per cent to 3 per cent, which is eminently achievable, it will mean a doubling of exports to around 600 billion dollars annually. This will be a boon not just to big industry, but also to small and medium enterprises, and employment intensive sectors like garments, footwear, electronic assembly.

For all this to happen, India must ensure that the export incentive schemes are in place. The Return of Duties and Taxes on Export Scheme (RODTEP), which was supposed to replace Manufacturing Export Incentive Scheme (MEIS) and for services (SEIS) has been de layed by six months. GST refund delay is still a problem. High import tariffs and inverted duties are hurting all the export businesses which use imported ingredients. The exchange rate is too strong and hurting export prospects. We need to also aggressively welcome and set up global value chains on Indian soil. All these aspects have to be taken care of and only then can we hope to ride the export opportunity. Otherwise, we will miss the bus once again. Learn from Bangladesh, our neighbour who is enjoying that bus ride

The ocean and humans are inextricably interconnected. Ocean influences human lives by moderating climate, creating job opportunities, boosting national economies and acting as social cultural heritage for people around the world. Studies suggest, by the end of 2030, worldwide maritime industries will employ more than 40 million people. Approximately 3 billion people rely on fisheries and

aquaculture for their livelihoods. Oceans provide the largest living space on earth that supports great diversity of species to flourish. Top ocean predators like blue whales, sharks, all the creatures that live, play important role in the trophic chain of the diverse marine ecosystem. Excessive fishing of a single species or one population in coastal areas leads to trophic cascade eventually leading to fisheries collapse. About 25 per cent of marine fish and small sea creatures find food, shelter and reproduce in pristine marine habitats of coral reef ecosystem. Over half a billion people depend on this coral reef ecosystem for food and income. These coral reefs often sea" act as first line of defence against tropical storms and erosion of coastlines. Scientific evidence clearly points towards anthropogenic activities like burning fossil fuel for energy and industry, deforestation, farming livestock and fertilising crops put thermal stress on sea water causing half of the coral bleaching in tropical sea. Tonnes of wastes from landfills and industries, single use plastics and abandoned plastic fishing nets inevitably escape into the sea and suffocate, starve or kill sea animals damaging sensitive habitats. Micropalstics, chemicals in plastic ingested by seafish and heavy metal concentration in seafood have entered the food chain making it

harmful for humans The ocean and the atmosphere are intertwined as the former sequestered 50 per cent of carbon and absorbed 90 per cent of heat added to the global system in the past 200 years. However, since the industrial revolution, human-induced greenhouse gases are making ocean water too acidic, driving out massive sink of carbon dioxide back into the atmosphere in a dangerous feedback loop. Overheating of massive salty water

of interconnected deep and surface ocean currents drastically changing the world's climate.

These changes in the ocean eventually impact not only the life forms existing in it but also above and beyond. Humans are the prime agent of this dangerous transformation putting their own and others' existence at stake. It is high time we develop sensitivity and duty to protect, save and restore the health of our life supporting system, the oceans. 'Ocean literacy' - introducing fundamental concepts to public about the ocean's influence on human and vice versa will help in protecting mother earth.

One does not need huge missions to contribute to change but easily doable actions such as avoiding single use plastic, reducing toxic household pollutants, saving water, energy, volunteering to clean beaches and using eco-friendly products will make the ocean a better place for life and livelihood.

Famous poet, WH Auden once said: "Thousands have lived without love, not one without water." So act wisely and save oceans.

#### TMC's dynastic turn

Sir, Buoyed by a massive victory in Assembly elections held last month, TMC chief and West Bengal Chief Minister Mamata Banerjee appointed her nephew Abhishek Banerjee as the party's all-India general secretary. With this appointment Abhishek Banerjee became heir of Mamata Banerjee through the dynastic route to the political leadership. Now, the TMC is a new addition to the big list of political parties which have practiced the dynastic route rather than democratic process to choose the parties' leadership. The episode throws up a larger question about the resilience of dynastic politics - where the bloodline determines the political leadership. This isn't just true for the Congress nationally, but the entire gamut of regional parties. While the vast majority of political parties are crowned by dynasts and family members, there is an uncertain future for parties like AIADMK in Tamil Nadu, the BJD in Odisha and Nitish Kumar's JDU. It appears that Mamata has looked at all these experiences and, unfortunately, instead of pioneering a democratic method of leadership selection, picked a family member. While there are complex factors behind the resilience of dynastic politics — the brand recall value of leaders, a quicker route to mass legitimacy, control over finances — it leaves Indian democracy poorer. Mamata has followed, rather than led, this time around.

# Pak pushing narco-terror via Raj

After adopting a similar model in Punjab to turn it into a drug haven, the neighbouring country is making efforts to pave way for narco-terrorism in the desert state

Jaipur, June 7: After the Border Security Force (BSF) recently made one of its biggest drug hauls by seizing 56-kg of contraband in the Bikaner sector on the Rajasthan-Pakistan border and arrested two accused, officials are suspecting the role of Pakistan rangers in this smuggling and are of the opinion that the neighbouring country is making efforts to pave way for narco-terrorism in the desert state after adopting a similar model in Punjab to turn it into a drug

After interrogating the two youths arrested in this case, officials believe that the role of Pakistan rangers is suspicious. Both of them have been sent to remand after they were produced in a court.

Speaking on this, a senior official confirmed, "The matter is under investigation by the NCB. We cannot say it with certainty at the moment, but there is a Pakistani post situated just fifty metres away



from the place where this drug consignment was seized. Soldiers are stationed here round the clock. This indicates that it should be in the knowledge of rangers.

Other officials confirmed that the dossier is being made ready and if required Interpol help will also be taken to reach the last person involved in this case.

Meanwhile, an NCB team was

New Delhi, June 7: In a bid to push inoculation of 45-plus age group, the Delhi government will send booth level officers (BLOs) door to door for allocating slots to eligible persons to get the jabs closer home at their designated polling centres under its 'Jahan Vote, Wahan Vaccination' campaign, Chief Minister Arvind Kejriwal announced Monday.

The exercise will be replicated to vaccinate people aged 18-44 years as well whenever adequate doses of COVID-19 vaccine are available with the government, Kejriwal said in an online briefing.

There are 57 lakh people in Delhi in the 45 plus age group and of them, 27 lakh have been given the first dose of the coronavirus vaccine while 30 lakh are yet to get the jab, he said.

"We have noticed that people in the 45 plus age group are not coming to vaccination centres set up by the Delhi government and vaccines are not being utilised." he said.

There are around 280 wards in Delhi. The BLOs will visit households in 72 wards from Tuesday to identify and send eligible persons

for vaccination at the polling booths by allocating slots, he said.

Delhiites can get vax at polling booths

The chief minister said polling booths are close to the homes of the people so they will not have to travel long distances to get the vaccine. Also, the government has arranged e-rickshaws to ferry people to the vaccination centres.

There are around 2,700 polling stations in Delhi spread across 70 Assembly constituencies.

The BLOs will give slots for vaccination to people in the 45-plus age group at the nearest polling centre. In a cycle of five days, all the eligible persons will be covered.

"After covering all the 280 wards in four weeks, the government will be able to say that all those eligible (45 years and above) have received the vaccine," Kejriwal said, hoping there will be no shortage of doses since the central government is providing the vaccines for 45+ age group.

He said a similar drive will be conducted again for their second dose vaccination after three months.

## Doorstep diesel delivery picks up pace in Rajasthan

Jaipur, June 7: Doorstep diesel delivery is a new revolution in the field of energy distribution in Rajasthan which is easing the lives of end-consumers without the hassles of diesel procurement.

Four fuel entrepreneurs are bringing change in the fuel industry in Rajasthan with this door-todoor delivery model which includes Bikaner-based Hiralal Bhattar Petroleum. It has started the facility of doorstep diesel delivery through its mobile petrol pumps. This new fuel startup is run by Suresh Bhatter, who owns a Bharat Petroleum Corporation Limited (BPCL) retail outlet.

"While having discussion with BPCL officials, they gave me the information so I thought this should be done for the welfare of the society," Suresh said.

Barmer-based Shree Mahadev Petroleum has also started the facility of doorstep diesel delivery. The startup is run by Mahendra Kumar, who is in the fuel business since 2011 and is also a dentist by profession. They have recently acquired a mobile fuel pump and will deliver within a 40 km radius.

"There is a gas terminal near my petrol pump and so I saw a constant demand for diesel and thought of delivering it at people's doorsteps and to other bulk consumers, too, said Mahendra Kumar.

Pali-based Manish Kishan Filling Station has also started the facility of doorstep diesel delivery. Manish Kishan Filling Station is run by Manish Choudhary who owns a Hindustan Petroleum Corporation Limited (HPCL) outlet. He has recently acquired a mobile fuel pump -- which will go around Pali to meet the demand for diesel by various end-users at their doorsteps.

## Delhi's test positivity rate dips to 0.36 pc

New Delhi, June 7: The national capital reported 231 new instances of the COVID-19 infection, the lowest since March 2, with the positivity rate dipping to 0.36 per cent, according to the health bulletin released Monday.

Thirty-six more people succumbed to the disease in a day, pushing the death toll here to 24,627.

Sunday, Delhi had recorded 34 fatalities, the lowest in around two months, and 381 cases with a positivity of 0.5 per cent.

Saturday, the city registered 60 fatalities and 414 new cases of COVID-19 with a positivity rate of 0.53 per cent. The day before, it had recorded 50 deaths and 523 new cases with a positivity rate of 0.68 per cent. Chief Minister Arvind Kejriwal had Saturday said the coronavirus situation in Delhi was under control. "Bringing back the economy on track is crucial as the situation of coronavirus is improving," he had said.

The national capital started the unlocking process from Monday after remaining under lockdown since April 19 in view of a massive ond wave of the pandemic. Since April 19, both daily cases and

single-day death count had been spiralling up. April 20, the city had reported 28,395 cases, the highest in the city since the beginning of the pandemic. April 22 the case positivity rate was 36.2 per cent, the highest so far. The highest number of 448 deaths was reported May 3.

However, the number of cases has shown a downward trend of late. The positivity rate too has been shrinking in the last several days.

The national capital had recorded 623 cases and 62 deaths last Tuesday, 576 cases and 103 fatalities Wednesday, and 487 cases and 45 deaths Thursday. A total of 63,610 tests, including 50.139 RT-PCR ones. were conducted a day ago, according to Monday's health bulletin.

The total number of cases reported in the city so far stood at\_ 14,29,475, while over 13.9 lakh patients have recovered from the virus. The city now has 5.208 active cases, down from 5,889 a day before, the bulletin said. The number of people under home isolation dipped to 1,932 from 2,327



## A special police station to check water theft!

A staff of 60 policemen will be deputed to take immediate action on water theft cases reported frequently in this area. The new police station coming

headed by a CI and will have a staff of 5 sub-inspectors, 8 head constables and 40 constables, said Nohar MLA Amit Chachan, adding that "Influential and dominating

the first time that a police station has been started to stop water theft in any state.

Recently, 12 new police stations

were sanctioned in the state and this unique police station is one amongst them. In the last four years, 74 cases of water theft were registered in Hanumangarh district

alone. Of these, 28 have been reg-

istered in Bhirani police station. Additional SP (Hanumangarh)

Jassaram Bose says that the theft incidents are higher in Nohar and Bhadra Vidhansabha areas as there is no 'chakbandi'. "A few people from Haryana steal water leading to water crisis in the tail areas here. People caught stealing water are booked under IPC section 397,'

Water theft cases have also been reported from Sriganganagar district. In such a situation, the number of such police stations will in crease in future as the Canal Department also wants the police to be stationed at a certain distance from the canal. Police sources say a long pipe is inserted into the canal and water is taken into the field, surreptitiously.

Indira Gandhi Canal is the longest canal of India which traverses through seven districts of Rajasthan -- Barmer, Bikaner, Churu, Hanumangarh, Jaisalmer, Jodhpur and Sriganganagar.

Around 650 km long, it starts from Harike Barrage in Punjab and terminates in irrigation facilities at the Thar Desert in Rajasthan.

#### **Kerala extends** lockdown

Thiruvananthapuram: The lockdown in Kerala, which was to have ended June 9, has been extended by a week, while the Covid death toll in the state crossed 10,000 Monday. In a statement issued here, Chief Minister Pinarayi Vijayan said that 9,313 people turned positive after 70,569 samples were sent for testing in the past 24 hours, taking the total active cases to 1,47,830.

#### **Chopper makes** emergency landing

New Delhi: A Dhruv helicopter of the Indian Air Force made an emergency landing at a forward helipad in eastern Ladakh Monday, sources said. Two pilots and another personnel onboard the advanced light helicopter were safe, the sources said, adding they have already been evacuated. The incident took place around 9:30 am, they said, adding the three personnel sustained minor injuries. The reason for the emergency landing is not immediately known.

#### Matter of concern

Amaravati: A Task Force of medical experts, particularly paediatric care, has projected that Andhra Pradesh might see a staggering 18 lakh cases in what could be the third Covid wave affecting at least 4.50 lakh children. The Task Force, however, noted that the timing for the third wave would remain unknown since variations in the (corona) virus were unpredictable. Of the total cases reported in the first and second waves in the State, 2.72 per cent were children in the 0-9 age group and 8.35 per cent in the 10-19 age group.

New Delhi, June 7: The Covishield vaccine produces more antibodies than Covaxin though both generate a "good immune response", says a pan-India study of healthcare workers who had received both doses of the preventives

The yet-to-be-published study, posted on the preprint repository MedRxiv June 4, covered 515 healthcare workers (HCW) -- 305 men and 210 women -- from 22 cities in 13 states

Covishield, from the Oxford-AstraZeneca stable, is manufactured by the Serum Institute of India in Pune. Covaxin is the in-

cine by Hyderabad-based Bharat Biotech in collaboration with ICMR and National Institute of Virology (NIV). The blood samples of those participating in the study were tested for the quantity of antibodies produced and levels of specific antibodies that are directed to the spike protein of the virus, which is regarded as a proxy for protection.

"Both vaccines elicited good immune response after two doses, although seropositivity rates and antibody levels were significantly higher in Covishield compared to Covaxin," Awadhesh Kumar Singh, lead author of the study and consultant endocrinologist, G D



Hospital and Diabetes Institute, Kolkata, said in a tweet. higher number of people vaccinated with Covishield as compared to those immunised with Covaxin.

"Among the 515 HCW, 95 per cent showed seropositivity after two doses of both vaccines. Of the 425 Covishield and 90 Covaxin recipients, 98.1 per cent and 80 per cent respectively, showed seropositivity," said the study authors.

Seropositivity refers to the production of antibodies in an individual. The study was conducted by researchers from various institutes, including Ahmedabad's Vijayratna Diabetes Centre, Kolkata's GD Hospital and Diabetes Institute, Dhanbad's Diabetes and Heart Research Centre and the Rajasthan Hospital and Mahatma Gandhi Medical College and Hospital in Jaipur. The rise in anti-spike antibodies was also "significantly higher in Covishield vs Covaxin recipient" at 127 absorbance units per milliliter (AU/mL) and 53 AU/mL respectively, the authors noted. AU is the unit of measuring antibody levels. Apart from finding higher seropositivity among Covishield recipients, the study found that seropositivity rate was "significantly more" in participants with an age of 60 or less compared to those above 60. While factors such as gender, body mass index (BMI) and other comorbidities didn't make any difference, the seropositivity rate or antibodies in people with type 2 diabetes was found to be significantly lower.

Punjab Chief Minister Amarinder Singh said the move will bring "much-needed pricing parity." The chief minister said, 'Good that Centre has decided to take over vaccine procurement & distribution for the whole country for all age groups. I had personally written to @narendramodi ii on this issue twice suggesting this as the only solution to managing #CovidVaccine crisis.'

Captain Amarinder Singh added that" The move will help Punjab & other states facing problems in sourcing vaccine to ensure early vaccination of their people. It'll also bring much-needed pricing parity - a necessity in pandemic times. I am glad PM @narendramodi has conceded our request."

DK Shivakumar, President of Congress's Karnataka wing welcomed PM Modi's announcement on vaccine procurement. He said. "Better late than never. The central government's decision to take responsibility for vaccine procurement is welcome.

Thanks to the Supreme Court which forced the central govt to see reason. Karnataka government needs to focus on equitable distribution of the vaccines." Delhi's Deputy CM Manish Sisodia, however, attributed the free vaccine announcement to the Supreme Court's intervention. He said, "We express our gratitude to the Hon'ble Supreme Court that after his intervention, free vaccine will be available to all age groups across the country. If the central gov-

ernment wanted, it could have done this long ago, but due to the policies of the center, neither the states were able to buy the vaccine nor the central government was giving it.'

The Communist Party of India (Marxist) said the move to provide free vaccine for all came as a result of the Supreme Court's criticism as well as push back from several states former Congress President Rahul Gandhi Monday questioned him saying if vaccines are free for all, why should private hospitals charge for them.

"One simple question - If vaccines are free for all, why should private hospitals charge for them?" Rahul Gandhi, who is a Lok Sabha MP from Kerala's Wayanad said in a tweet. The top court had pointed out the changing nature of the pandemic and asked the Centre to review its vaccination policy.

However, BJP leaders were all praise after the prime minister's announcement.

## India reports over 28K mucormycosis cases till date: Govt

New Delhi, June 7: A total of 28,252 cases of mucormycosis have been reported in India so far from 28 states in which 86 per cent have a history of Covid-19 infections and 62.3 per cent of diabetes, the Central government said Monday. Union Health Minister Harsh

Vardhan said this while chairing the 28th meeting of the high-level Group of Ministers on Covid-19 through a video-conference, here.

"So far, 28,252 cases have been reported from 28 states. Out of these, 86 per cent (24,370 cases) have a history of Covid-19 infection and 62.3 per cent (17,601) have a history of diabetes.

Maharashtra has reported the maximum number Mucormycosis cases (6,339) followed by Gujarat (5,486). Till May 25 night, over 768 mucormycosis cases were being treated in Andhra Pradesh followed by Madhya Pradesh (752), Telangana (744), Uttar Pradesh (701), Central institutions (592), Rajasthan (492), Karnataka (481), Haryana (436), Tamil Nadu (236), Bihar (215), Punjab (141), Uttarakhand (124). Delhi (119), Chhattisgarh (103), Chandigarh (83), Kerala (36), Jharkhand (29), Odisha (15), Goa (10), Jammu and Kashmir (5), Himachal Pradesh (3), Puducherry (2) and Tripura (1).

Mucormycosis is one of the rapidly spreading infections observed in patients recovering from Covid-19.

Mucormycosis is a serious but rare fungal infection caused by a group of molds called mucormycetes that has been developing in Covid-19 patients.

The fungal disease is commonly being observed in patients who were given steroids for a long time, who have been hospitalised for a long time, were on oxygen support or ventilator, faced poor hospital hygiene or those who have been taking medication for other illnesses such as diabetes.

The Prime Minister's Office said in a tweet, "PM @narendramodi has approved an ex-gratia of Rs. 2 lakh each from the PMNRF for the next of kin of those who have lost their lives due to lightning in various parts of West Bengal. Rs. 50,000 would be given to the injured." Union Home Minister Amit Shah also condoled the deaths due to lightning strikes and prayed for the speedy recovery of those who were injured.

Thunderstorms with lightning and gusty wind occurred in several districts of south Bengal in the evening after a sweltering day, the Met department said.

## India among top 3 Asian nations affected by DNS cyber attacks

ASIA RECORDED AN INCREASE OF 15 PER CENT IN AVERAGE COST OF A DNS ATTACK, INCURRING A COST OF \$908,140, UP FROM \$792,840 THE PREVIOUS YEAR

New Delhi, June 7: India is among top three countries in Asia which experienced highest cost of DNS (domain name system) attacks in 2021 to date, as nearly 90 per cent of organisations globally experienced DNS attacks, with the average cost of each attack around \$950,000, a new report

showed Monday. Asia recorded an increase of 15 per cent in average cost of a DNS attack, incurring a cost of \$908,140. up from \$792,840 the previous year. Countries which saw signifi-

cant increase in damages included Malaysia which increased by 78 per cent, the sharpest increase, as well as India which saw a significant increases of 32 per cent from past year, according to the report by EfficientIP, a leading provider of network security and automation solutions.

The report, conducted in collaboration with the IDC, showed that organisations across all industries suffered an average 7.6 attacks this past year amid the pandemic.

Around a quarter of companies have suffered a DNS attack abus-



ing cloud misconfiguration, with almost half of companies (47 per cent) suffering cloud service down-

time as a result of DNS attacks. The threat report, now in its seventh year, also found a sharp rise in data theft via DNS, with 26 per cent of organisations reporting sensitive customer information stolen compared to 16 per cent in 2020's Threat Report.

"As workers look to more permanently transition to off-premise sites, making use of cloud, IoT, edge and 5G, companies and telecom providers should look to DNS for a proactive security strategy,"



# 30K kids orphaned amid Covid, SC told amid Covid, SC told

New Delhi, June 7: As many as 30,071 children were orphaned, lost a parent or abandoned mostly due to the Covid-19 pandemic as per data submitted by different states till June 5, the National Commission for Protection of Child Rights (NCPCR) informed the Supreme Court Monday.

Of the total, 26,176 children have lost a parent, 3,621 have been orphaned and 274 have been abandoned, the NCPCR.

The commission further said that the state-wise data received regarding children who have lost either their mother or father or both parents from April 1, 2020 to June 5, 2021, irrespective of their reason of death (not only death due to Covid-19), was uploaded on its 'Bal Swaraj' portal and collated by it. It said Maharashtra has been worst affected with 7,084 children being orphaned, abandoned or have lost a parent mostly to the deadly virus since April 1 last year.

In its affidavit filed in the suo motu matter taken up by the apex court, the NCPCR said other states where children are most affected include Uttar Pradesh (3,172), Rajasthan (2,482), Haryana (2,438), Madhya Pradesh (2,243), Andhra Pradesh (2,089), Kerala (2,002),

Bihar (1,634) and Odisha (1,073). It said that in Maharashtra out of the total 7,084 children, 6,865 have lost one parent, 217 have been orphaned and two children have been abandoned, while Madhya Pradesh tops the chart where 226 have been abandoned.

The NCPCR said that among the affected, boys are 15,620, girls (14.447) and transgender (4), with most children falling in the category of 8 to 13 years of age (11,815).

The commission clarified that the total data given in the present affidavit includes the data already submitted to the court till May 29, which said that 9.346 children were abandoned, orphaned or lost a parent mostly to the Covid-19 pandemic. It said that data uploading is an ongoing process, which is for identification of the CNCPs (Child in Need of Care and Protection) and the real time tracking to ensure welfare for those children.

The NCPCR once again flagged concern that it has been receiving many complaints in the past month or so alleging that there are private people and organizations involved in data collection of such children stating that they want to provide assistance to the children and the families. #### **Top court gives Centre more time**

The Centre told the Supreme Court Monday that it needed some more time to apprise the court of the modalities on the recently launched 'PM-CARES for Children' scheme for kids orphaned by Covid-19. A bench of Justices L N Rao and Aniruddha Bose was informed by Additional Solicitor General Aishwarva Bhati, annearing for the Centre, that they are in consultation with states and ministries to work out the modalities of the 'PM-CARES for Children' scheme. "We need some more time to apprise the court about the modalities of the scheme as the consultation is still going on. We have made district magistrates directly responsible for the children who have been abandoned or have been orphaned," Bhati said. The bench said that it is inclined to give some more time to the Centre to formulate the modalities of the scheme and how they will implement it.

"The Act, besides providing for an extensive procedure for children who have lost family support or are in need of assistance, also provides for an exhaustive procedure for adoption of orphan/abandoned/surrendered children."

### UDID card now acceptable for vaccination: Govt

New Delhi, June 7: To further facilitate access to vaccination for persons with disability, the government has decided to include the UDID card in the list of prescribed photo ID documents for Covid vaccination and the necessary provisions for the same are being made and would be available in Co-WIN shortly, the health ministry said Monday.

The ministry has advised the states and Union territories to widely publicise the use of the UDID card as a permissible photo ID for accessing Covid vaccination.

The Centre has been supporting the efforts of the states under the "whole of government" approach for ensuring a smooth and effective vaccination drive since January 16. It has developed the CoWIN digital platform to streamline the process of vaccination for various categories of beneficiaries across the country. CoWIN provides the technological backbone to effectively roll out and scale up the mechanism for the Covid vaccine distribution system, the ministry said in a statement.

It has been the Centre's constant endeavour to streamline the vaccination process for its universalisation. In this backdrop, the health ministry wrote to the states on Monday to include the Unique Disability Identification (UDID) card as a photo ID while registering on Co-WIN 2.0. According to the guidance note for Co-WIN 2.0 issued March 2, seven photo IDs were specified and prescribed for the verification of beneficiaries prior to their vaccination.

## ISRO develops three types of ventilators

Bangalore June 7: The Indian Space Research Organisation has developed three types of ventilators, and has come forward to transfer the technology to industry for clinical usage as the country battles the second wave of Covid-19 pandemic.

A low-cost and portable critical care ventilator, 'PRANA' ("Programmable Respiratory Assistance for the Needy Aid') is based on the automated compression of an AMBU (Artificial Manual Breathing unit) bag. The system has a sophisticated control system that includes airway pressure sensor, flow sensor, oxygen sensor, servo actuator as well as expiration and PEEP (Positive End Expiratory Pressure) control valves, according to an interest exploration note posted on the website of Bengaluruheadquartered space agency.

The clinicians can select the ventilation mode and set the required parameters through a touch

screen panel and monitor various parameters like pressure, flow, tidal volume and oxygen concentration on the same screen. The ventilator can deliver the required flow of oxygen-air mixture to the patient's lung at a desired rate set by the clinicians.



A robust algorithm for controlled and safe ventilation of the patient is implemented which



raises alarm and opens safety valves to prevent barotrauma, asphyxia and apnoea during the ventilation. Alarm is also raised in case of wrong or improper connection of the ventilation circuit or inadvertent disconnection of the hose or sensors.

There are also provisions to attach bacterial viral filters at each interface to prevent cross-infection and the contamination of air. The ICU grade positive pressure mechanical ventilator titled 'VaU' (abbreviation of Ventilation assist Unit) can assist or replace the spontaneous breathing in patients under respiratory distress, ISRO said.

VaU is based on a centrifugal blower which draws in filtered ambient air, compresses it and delivers it to the patient to achieve ventilation and can therefore operate without a compressed pneu-

Provision is also given in the ventilator to connect a high pressure oxygen source, from which

oxygen is metered automatically, to achieve the desired oxygen concentration (FiO2) in the inspiratory flow. Microcontroller based control module in the ventilator acquires signals from an array of sensors and commands the electropneumatic components to effect closed loop control. VaU also comes with an intuitive Human Machine Interface (HMI) System running on a medical grade touch screen PC, which allows the operator to set and monitor various ventilation parameters in real time

A power supply unit, which can operate with 230VAC or an internal battery pack, is used to power the electro-pneumatic components, controller, and the HMI system of the ventilator. VaU has been configured to operate in a variety of patient/ventilator triggered invasive and non-invasive ventilation modes and has provisions to detect fault conditions and raise alarms through the HMI system to alert the operator.

#### 119 killed in 2 days in Afghan

Kabul: As the level of violence remains high in Afghanistan despite efforts to jumpstart the stalled peace process, a total of 119 people were killed in clashes and security incident in just two days, June 3-4, an official said here. The official, on the condition of anonymity, said that 196 security personnel were injured also during this period. According to the official, 54 people were killed June 3, while there were 65 casualties the next day. Of the 119 victims, 102 were members of the security forces.

#### Six killed in knife attack in China

Beijing: A deadly knife attack in eastern China has killed at least six people and left 14 wounded, local officials have said, in what was the third such indiscriminate assault on civilians by the disgruntled citizens in recent weeks. A 25year-old unemployed man, Wu from Huaining county attacked the civilians Saturday to vent out his anger as he was going through family problems, local officials in Anging city in Anhui province said. "He killed out of anger, because of family troubles and pessimism," the municipal government said in a statement.

#### **Global Covid cases** top 173.1mn

Washington: The overall global Covid-19 caseload has topped 173.1 million, while the deaths have surged to more than 3.72 million, according to the Johns Hopkins University. In its latest update Monday morning, the University's Center for Systems Science and Engineering (CSSE) revealed that the current global caseload and death toll stood at 173,197,944 and 3,726,107, respectively. The US continues to be the worst-hit country with the world's highest number of cases and deaths at 33,362,471 and 597,627, respectively, according to the CSSE.

#### Three dead in **US shooting**

Miami: At least three people were killed and multiple others injured during a shooting at a graduation party in Miami-Dade County located in the US state of Florida, police said. A barrage of gunfire broke out in Kendall at around 2 a.m. Sunday when two cars pulled up into a strip mall where a graduation party was underway at a hookah lounge restaurant. Someone from inside one of the vehicles opened fire on people leaving the restaurant following the graduation party, he said.

Beijing, June 7: Chinese birth control policies could cut between 2.6 to 4.5 million births of the Uvghur and other ethnic minorities in southern Xinjiang within 20 years, up to a third of the region's projected minority population, according to a new analysis by a German researcher.

The report also includes a previously unreported cache of research produced by Chinese academics and officials on Beijing's intent behind the birth control policies in Xinjiang, where official data shows birth-rates have already dropped by 48.7% between 2017 and 2019. Adrian Zenz's research comes amid growing calls among some western countries for an investigation into whether China's actions in Xinjiang amount to genocide, a charge Beijing vehemently denies.

The research by Zenz is the first such peer reviewed analysis of the long-term population impact of Beijing's multi-year crackdown in the western region. Rights groups. researchers and some residents say the policies include newly enforced birth limits on Uyghur and other mainly Muslim ethnic minorities, the transfers of workers to other regions and the internment of an estimated one million Uyghurs and other ethnic minorities in a network of camps.

"This (research and analysis) really shows the intent behind the Chinese government's long-term

plan for the Uyghur population," Zenz told Reuters.

The Chinese government has not made public any official target for reducing the proportion of Uyghur and other ethnic minorities in Xinjiang. But based on analysis of official birth data, demographic projections and ethnic ratios proposed by Chinese academics and officials, Zenz estimates Beijing's policies could increase the predominant Han Chinese population in southern Xinjiang to around 25% from 8.4% currently.

This goal is only achievable if they do what they have been doing, which is drastically suppressing (Uyghur) birth rates," Zenz said. China has previously said the cur-

rent drop in ethnic minority birth rates is due to the full implementation of the region's existing birth quotas as well as development factors, including an increase in per capita income and wider access to family planning services.

The new research compares a population projection done by Xinjiang-based researchers for the government-run Chinese Academy of Sciences based on data predating the crackdown, to official data on birth-rates and what Beijing describes as "population optimization" measures for Xinjiang's ethnic minorities introduced since 2017.

the new birth prevention policies. That compares to 13.14 million proiected by Chinese researchers using data pre-dating the implemented birth policies and a current population of around 9.47 million.

Zenz, an independent researcher with the Victims of Communism Memorial Foundation, a bipartisan non-profit based in Washington, D.C., has previously been condemned by Beijing for his research which has been critical of China's policies on detaining Uyghurs, mass labour transfers and birth reduction in Xinjiang.

China's foreign ministry has accused Zenz of "misleading" people with data and, in response to Reuters' questions, said "his lies aren't worth refuting."

Zenz's research was accepted for publication by the Central Asian Survey, a quarterly academic journal, after peer review June 3.

Reuters shared the research and methodology with more than a dozen experts in population analysis, birth prevention policies and international human rights law, who said the analysis and conclusions were sound.

Some of the experts cautioned that demographic projections over a period of decades can be affected by unforeseen factors. The Xinjiang government has not publicly set official ethnic quota or population size goals for ethnic populations in Southern Xinjiang, and quotas used in the analysis are based on proposed figures from Chinese officials and academics.

#### **Boko Haram leader** is dead, says ISWAP militant group

Abuja, June 7: The Islamic State West African Province (ISWAP) militant group said in an audio recording heard by Reuters Sunday that Abubakar Shekau, leader of rival Nigerian militant Islamist group Boko Haram, was dead.

Shekau died around May 18 after detonating an explosive device when he was pursued by ISWAP fighters following a battle, a person purporting to be ISWAP leader Abu Musab al-Barnawi said on the audio recording.

"Abubakar Shekau, God has judged him by sending him to heaven," he can be heard saying.

Two people familiar with al-Barnawi told Reuters the voice on the recording was that of the ISWAP leader. A Nigerian intelligence report shared by a government official and Boko Haram researchers has also said Shekau is dead.

Last month, Nigeria's military said it was investigating Shekau's alleged death, also reported in Nigerian and foreign news outlets. The audio statement is ISWAP's first confirmation that its arch rival in the Lake Chad region has

## No 'Biden bounce' to US image in France, Germany

The US' reputation as the leading global power has suffered in France and Germany because of Washington's handling of the Covid-19 pandemic

Paris, June 7: The United States' reputation as the leading global power has suffered in France and Germany because of Washington's handling of the Covid-19 pandemic that has killed nearly 600,000 Americans, a poll showed Monday.

On the eve of President Joe Biden's trip to Europe, the survey by the German Marshall Fund and the Bertelsmann Foundation said he had not won back the standing of the United States as it was before Covid-19 struck. China's reputation had risen slightly. According to US research pa-

pers released March 26, the United States under Biden's predecessor Donald Trump could have avoided nearly 400,000 deaths with a more effective strategy. 'The first three months of the

Biden administration have not affected French and German views of US influence in the world," the study of views in 11 countries said.

"These numbers are in line with the results of the 2020 survey, which had fallen by about 10 points from the pre-pandemic numbers, to the advantage of China.'

That compares with the perception within the United States that US influence abroad has risen, the survey found.



Biden embarks on his first European tour as president Wednesday to attend G7, NATO and European Union summits. He faces the challenge of repairing transatlantic ties damaged by Trump, whose withdrawal from international agreements and sharp criticism of NATO undermined European faith in Washington.

Only 51% of Germans see the United States as a reliable partner, rising to 60% in France, 67% in Britain and 76% in Poland. Less than a quarter of Turks trust the United States. Most Americans regard the European Union as a reliable partner, the study said.

A majority of respondents surveyed still think that the United States should be involved in the defence and security of Europe. except in Sweden, where views are divided, and Turkey.

## 'Businesses struggling with rising cost of raw materials'

New Delhi, June 7: As the nation tries to fight the second wave of the pandemic, which has brought with it a record number of infections and fatalities, the PHD Chamber of Commerce and Industry conducted a quick survey to assess the impact of the current situation on industry.

The survey, which was conducted across 34 sectors, revealed that 73% of the respondents were struggling with the rising cost of raw materials as restrictions in many parts of the country have impacted the pace of economic recovery with an uncertain economic environment, disruptions in supply chains and contraction in demand.

Other key challenges faced by businesses are availability of working capital (64%), Maintaining price-cost margins/profitability (63%), Weakening of demand (62%);



Retaining of the full workforce (61%), Costs of deployed workforce (60%), Payment of wages/salaries to workers/employees (55%),

"Going ahead, a substantial stimulus to create effective strides for futuristic growth trajectory for Indian Economy and for diminishing the daunting impact of the second wave of the pandemic on economy, trade and industry would be crucial to support the economicmomentum in this extremely difficult time," said Aggarwal.

Paris, June 7: A day after Serena Williams was eliminated from the French Open, 17-year-old Coco Gauff showed the future in tennis for American women is bright.

Gauff served superbly to reach her first Grand Slam quarterfinal with a 6-3, 6-1 victory over Ons Jabeur Monday.

Gauff lost only nine points on her serve and was also highly effective at the net, winning 13 of 17 points when she came forward which was especially impressive against a player who is known for her shot-making skills.

"I feel like this has been the most consistent tennis I have played at this level," Gauff said. "Hopefully I can keep that going.'

Gauff also had a quick match in the previous round, when Jennifer Brady retired due to injury left foot after Gauff won the opening set. It wouldn't be the first time Gauff claims a title at Roland Garros. having won the girls' singles title

Gauff will next face Barbora Krejcikova, who also reached her first quarterfinal at a major by beating 2018 French Open runnerup Sloane Stephens with a similarly lopsided score — 6-2, 6-0.

"I'm only going to be 17 once, so you might as well talk about it while I'm 17." Gauff said. Gauff has not dropped a set in Paris this year. She won both the singles and doubles titles at a warm-up tournament in Parma before coming to Paris. That came after a run to the semifinals of the Italian Open. In

In the men's draw, Novak Djokovic won the first 16 points of the fourth set and pulled even at two sets apiece against 19-year-old Lorenzo Musetti of Italy at the French Open.

Musetti took the first two sets in the fourth-round match 7-6(9-7), 7-6(7-2). Djokovic won the next two 6-1, 6-0 while losing only 14 points. Diokovic is seeded No. 1 and trying to overcome a two-set deficit for the fifth time in his career. He is seeking his second French Open title and his 19th at a Grand Slam.

Musetti is ranked 76th and participating in his first Grand Slam tournament. He has played only one five-setter in his career. Djokovic is 33-10 in five-setters.
