Dutee qualifies for Tokyo Games

Bhubaneswar, June 30: Odia sprinter and national record holder Dutee Chand has qualified for the upcoming Tokyo Olympics in both the 100m and 200m races via the world rankings quota declared Wednesday. Twenty-two spots were available in 100m and 15 in the 200m through the world rankings route. Currently Dutee is ranked 44th in the world in the 100m and 51st in the 200m. It was enough for her to get a direct entry to the Tokyo Games. Dutee failed in her last race to se-



cure a direct Olympic qualification spot. She finished a disappointing fourth in the women's 100m final at the ongoing 60th National Inter-State Senior Athletics Championships.

Last week, Dutee scripted a new national record in the women's 100m with a time of 11.17 seconds.

Reacting to the new development Dutee said from Patiala, "It is a proud moment for me to compete in back-toback Olympics. In Rio, I could not do well because of the gender controversy. This time I hope to do better."



Bhubaneswar, June 30: As Covid-19 cases continue to remain high in some districts of Odisha, the government Wednesday extended the partial lockdown in the state for 15 more days till 5.00am July 16. Giving this information, Chief Secretary SC Mahapatra said that while extending partial lockdown, an effort has been made to strike a balance between life and livelihood.

The state government has divided the 30 districts in Odisha into two categories, 'A' and 'B'. The districts

APEX COURT DIRECTS NDMA TO FIX AMOUNT AND GUIDELINES

New Delhi, June 30: Families of Covid-19 victims must get financial compensation, the Supreme Court said Wednesday. The apex court also said that the National Disaster Management Authority (NDMA) must decide within six weeks on the amount

and frame the guidelines. A special bench of Justices Ashok Bhushan and MR Shah said the apex court cannot direct the Centre to fix a particular sum of financial help but the government can fix the minimum amount of compensation to be paid as ex-gratia to family members of those who lost their lives

due to Covid-19 while keeping various aspects in mind. The apex court observed that the NDMA can determine the amount taking into consideration the requirement/availability of the fund under the NDRF/SDRF for other relief compensations.

"There shall not be any justification to provide for the same/similar amount that two public interest litby way of ex-gratia assisigations were filed in the tance as provided in the Supreme Court seeking directions to the Union and case of other disasters/natural disaster, i.e. ₹4 lakh," the state governments to probench stated. The Supreme Court also directed authorities to issue guidelines for simplifying the process of issuing death certificates for Covid-19 fatalities. "The Appropriate Authority is directed to issue simplified guidelines for issuance of Death Certificates/official documents stating the exact cause of death, i.e., 'Death due to Covid-19', to the family members of the deceased who died due to Covid-19," the court ruled.

where the test positivity rate (TPR) is less than five per cent are in 'A' category, while the remaining 10 coastal zones, where the number of cases is high, are in 'B' category, informed Mahapatra.

The districts in 'Category A' are: Sundargarh, Jharsuguda, Bargarh, Sambalpur, Deogarh, Kalahandi, Bolangir, Nuapada, Sonepur, Ganjam, Gajapati, Kandhamal, Boudh, Koraput, Nabarangpur, Malkangiri, Rayagada, Angul, Dhenkanal and Keonjhar. The districts in 'Category B' are: Nayagarh, Cuttack, Puri, Khurda, Jagatsinghpur, Jajpur, Kendrapara, Bhadrak, Balasore and Mayurbhanj.

There will be no weekend shutdowns in districts that are in Category A. Shops will remain open from 6.00am to 6.00pm. Buses will be allowed to ply with passengers not exceeding seating capacity. Also taxis and autorickshaws will be allowed to operate with a maximum of two passengers. In the 'A' category districts, daily markets and small salons will be allowed to open. Outdoor and indoor



shooting of films and TV serials have also been permitted in these districts, informed the chief secretary.

In the 'B' category districts, the existing restrictions including weekend shutdowns will continue.

Night curfew from 6.00pm to 6.00am shall remain in force across the state but people and services in essential and emergency segments will be permitted to function during the restricted hours, Mahapatra informed.

Religious places, educational institutions and cinema halls shall continue to remain closed in the state. The ban on public gatherings, trade fairs, exhibitions, theatre and jatra will continue. Restrictions on weddings and funerals shall also continue as im-

HIGHEST SINGLE-DAY FATALITY IN ODISHA

BHUBANESWAR: Odisha's Covid-19 death toll breached the 4,000-mark Wednesday as the state reported 48 more fatalities due to the infection. It is the highest single-day count recorded in the state, a Health department official said. The new fatalities raised the toll to 4,018, the official informed. A total of 3,371 new Covid-19 infections pushed the tally to 9,09,800. The current active caseload in the state now stands at 31,422. MORE P4

Family allowed to perform last rites

Bhubaneswar, June 30: Families of patients who tested Covid-19 negative but died due to other complications, can now take the bodies for the last rites, the Odisha government said Wednesday. These patients during admission to the hospital were Covid-positive, but at the time of their death had tested negative. However, due to other health complications they failed to survive while undergo-

ing treatment. Chief Additional Secretary, Health, PK Mohapatra has issued instructions to all the collectors. municipal commissioners and chief district medical

officers in this regard. As per existing norms, the dead body of a patient who died during treatment

due to Covid-19 are disposed of by the local authorities, in consultation with family members. It was done in a dignified manner and in observance of all Covid-19 protocols.

Family members of deceased will have to give an undertaking that they will not open the body bag or touch the deceased

However, if at the time of death, the patient is found to be Covid-19 negative, then the body can be handed over to the deceased's relatives in a sealed body bag with safety advice.

However, before taking the body the relatives will have to sign an undertaking stating that the bag will not be opened. They will have to vouch that the body will not be touched and the last rites will be performed following Covid appropriate behaviour, Mohapatra said in 🗎 his letter.

The district and municipal authorities have been asked to sanitise and pack the body as per government guidelines before handing itover to the deceased's family members.

Brazil suspends 20mn Covaxin deal

Health ministry points out alleged irregularities during finalisation of contract

Hyderabad, June 30: The Brazilian government Wednesday announced the temporary suspension of its 20 million doses Covid-19 vaccine contract with Bharat Biotech. This development came about following allegations of irregularities in the deal. However, the Indian drug maker insisted that it has not received any advance payments.

The city-based firm said that it has followed a 'similar approach' in Brazil towards contracts, regulatory approvals and supplies in several countries worldwide where Covaxin is being supplied.

Announcing the Brazil government's decision, its Health Ministry said in a statement that 'with the rec-

WASHINGTON: Covaxin, developed by Bharat Biotech in collaboration with the Indian Council of Medical Research (ICMR), effectively neutralises both Alpha and Delta variants of coronavirus, the US National Institute of Health has said. The NIH said results of two studies of blood serum from people who had received Covaxin suggest that it generates antibodies that effectively neutralise the B.1.1.7 (Alpha) and B.1.617 (Delta) variants of SARS-CoV-2, first identified in the UK and India, respectively. Bharat Biotech responded to Brazilian health ministry's statement

and said it has not broken any rules. "As of 29th June 2021, Bharat Biotech has not received any advance payments nor supplied any vaccines to MOH Brazil. Bharat Biotech has followed a similar approach towards contracts, regulatory approvals and supplies in several countries worldwide, where Covaxin is being supplied successfully," the company said in a statement.

'Precisa Medicamentos' is Bharat Biotech's partner in Brazil. It provides assistance, guidance and support with regulatory submissions, licensure, distribution, insurance, conduct of phase III clinical trials, etc.

The Covaxin contract to Brazil landed in controversy after the South American country's Attorney General reportedly launched a probe into the deal. The minister of the CGU, Wagner Rosrio, explained that the suspension is a preventive measure. He said the CGU began a preliminary investigation June 24 into possible irregularities in the contracting of Covaxin. "By recommendation of @CGUonline, we decided to temporarily suspend the Covaxin contract," Rosrio said.

Bharat Biotech Ltd had earlier said February 26 it entered into an agreement with the Brazilian government for the supply of 20 million doses of Covaxin during the second and third quarters of 2021.

It should be stated here that the deal has put Brazilian President Jair Bolsonaro under fire with critics stating that he has turned a blind eve to possible corruption issues in the deal.







Cuttack, June 30: In the wake of recent surge in cybercrimes in the state, the Crime Branch (CB) Wednesday issued a set of advisories for the social media users and cautioned people against financial transactions in free wi-fi zones.

Through the advisories, the CB has advised the people to check the privacy policy and third party application of any social media site before opening their personal accounts.

The advisory said that social media users should not click on unknown links and download anything from unknown mails. Similarly, people should be cautious while logging in their social media accounts in free wi-fi zones.



"People should not do financial transactions online in free wi-fi zones. Hackers may steal details regarding bank accounts and other personal information in free wi-fi zones," said the advisories.

Besides, people have been advised not to share their personal information on social media. This apart, people should crosscheck doubly before accepting friend requests from unknown persons.

"Social media users must not accept friend requests from unknown men/women. People should avoid opening multiple social media accounts in one name. One should not believe in any social media post without checking the facts. Similarly, people should check the facts before posting anything on social media and sharing others' posts," said the CB in its advisories. The CB has asked people not to promote nudity, hatred and fake information on social media. These types of activities are regarded as crimes, said the CB.

"People should not forward any message on social media without checking the facts. This may invite legal action. Social media users should sign out their accounts properly after every single use," added the CB.

Bhubaneswar, June 30: Odisha's Covid-19 death toll breached the 4,000-mark Wednesday as the state reported 48 more fatalities due to the infection, the highest single-day count, a Health department official said.

The new fatalities raised the toll to 4,018, he said. At least 3,371 fresh coronavirus cases pushed the tally to 9.09.800.

Taking to Twitter, the Health and Family Welfare department said, "Regret to inform the demise of forty-eight Covid positive patients while under treatment in hospitals."

Of the 48 fatalities, seven were reported from Khurda, five each from Cuttack and Nayagarh and four each from Ganjam and Sundargarh districts.



Bhubaneswar, June 30: There is a popular saving in India that doctors are second to god on this earth. During the last two Covid 19-affected years, this adage has come true as doctors had put their lives at risk to serve patients and saved them. Apart from treating patients, the doctors carried out a lot of frontline tasks such as Covid testing and vaccination of people.

As per an official report by the Indian Medical Association (IMA), 798 doctors have died during the second wave of Covid-19 across country

Doctors form an essential part of an effective response to the Covid-19 pandemic. They have a duty to participate in pandemic response due to their special skills, but these skills vary between different doctors, and their duties are constrained by other competing rights

Dr Veena Panda, a gynecologist,



said during Covid-19 times the challenges are to remain safe and follow the norms and guidelines and to not avoid any patient. We have to be extra cautious by wearing double medical masks and other es-

sential protective gear. She said that during this time the system of tele-medicines has increased. But as a gynecologists my job demands handling pregnant women personally. Our job teaches us to serve the patients without bias. Dr Bishwajit Mishra, a pae-

diatrician of Jagannath Hospital, said Covid-19 has increased the workload and the consequent stress factor. He said the main challenges was to put the family in safety because as doctors we are in front exposing ourselves to the virus daily He said that the government should try to increase vaccination as the vaccination rate in the state

and country is very low. We must increase that. Dr Amrit Pattojoshi, a psychiatrist at Hi Tech Medical College and Hospital, said everyone is stretched and more so the doctor community during this Covid times-

-financially, physically and mentally. Many are swamped with lots of patients while most have very few patients. Burnout is prominent and lots of doctors having PTSD, anxiety, depression and sleep issues are coming up for consulta-



tions. The number of deaths and sufferings all around as well as the fact of having to face death of colleagues and family members has been too overwhelming. Add to it the Google experts, Whatsapp taught patients and the misinformation campaigns running against doctors. They have played a huge role in building stress during this trying times.

Dr Subasish Behera, a den-



tist, said the potential transmission of the virus through dental procedures and in dental settings has attracted much attention leading to either mandatory or voluntary suspension of routine dental care.

The concern about dental practice spreading coronavirus transmission has been widely recognised around the world. Dentistry was the most at-risk profession for Covid-19 com-

state

pared to other occupations. Based on the nature of the dental procedures, and the proximity of the dental team with patients, the disease could readily spread from infected patients to the dental team, and vice versa, and subsequently to other patients, if appropriate protective infection control measurements are not undertaken

It's mandatory to strike a balance between the safety of the healthcare professionals yet providing optimum dental care to the patients requiring emergency intervention

Dr Braja Kishore Behera, a pae-diatrician of IMS & SUM Hospital, said due to a sudden surge of patients during the pandemic, within the previously structured healthcare system, it becomes difficult to discharge regular services for eight to 10 hours every day at a stretch. With face masks on all the time, it becomes a cumbersome task to tackle the hurdle. At one end we



have to treat the patients and save their lives, while at the same time we are exposing our families and kids to a deadly virus.

Dr Viyatprajna Acharya Department of Biochemistry, KIMS & PBH, Bhubaneswar, said the pandemic has been affecting us equally from different directions. I as a diagnostician, face the threat of being exposed to infected samples being run in our lab. The hope and despair is reflected on our computer screen in the form of lab reports. From laboratory end, we are the first ones to get first hand information about

Carcass of rare dolphin species on Paradip shore POST NEWS NETWORK

Paradip, June 30: Local fishermen found the carcass of a rare species of dolphin Wednesday morning on the shore at Paradip.

According to sources, the species is usually known as long-snouted spinner dolphin 'Stenella' which is a genus of aquatic mammals in Delphinidae. The family is informally called oceanic dolphins.

The male dolphin was around 4.5 feet in length and would weigh around 20 to 25 kilogram. The dolphin had already died when it was spotted by local fishermen near gate No 5 of Paradip Port.

Some youths buried the carcass after it was found on the beach. Later, Kujang forest officials

reached the spot after getting in-



formation about it. The officials seized the recovered dolphin's carcass and sent it for postmortem. Reason behind the death of the aquatic animal can be ascertained only after the report comes in, a forest official said.

Notably, the Stenella dolphins are rarely found in the Bay of Bengal. The species are usually seen in temperate and tropical oceans.

Doctor said there will be special precautions for those having pacemakers like keeping cellphone at least 6 inches (15 centimeters) away from your pacemaker and hold it to the ear opposite the side



Hospital, Bhubaneswar, stated that the pacemaker, a small device that's placed under the skin in your chest to help control heartbeat, is very useful if the patient's heart's natural pacemaker is not fast enough, or because there is a block in the heart's electrical conduction system and also in some cases of heart failure associated with electrical abnormality of heart

Ghadei explained that pacemaker can do two functions—pulse generator and leads (electrodes). Pulse generator is a small metal container that houses a battery and the electrical circuitry that regulates the rate of electrical pulses sent to your heart. While leads (electrodes) is one to three flexible, insulated wires each placed in a chamber or chambers, of your heart and deliver the electrical pulses to ad just your heart rate.

According to the doctor, there are six types of pacemakers—single chamber pacemaker, sual chamber pacemaker, implantable cardioverter defibrillator (ICD), biventricular pacemaker, physioelectrical impulses to the right ventricle and the right atrium of your heart to help control the timing of contractions between the

the heart, therefore avoiding the need for pacing leads.

Ghadei highlighted that there could be risks during pacemaker implantation like infection where the pacemaker was implanted, swelling, bruising or bleeding at the generator site. especially if you take blood thinners. damage to your blood vessels or nerves near the pace-

where your pacemaker was implanted.

Also, certain medical procedures, such as magnetic resonance imaging, cancer radiation treatment, electrocautery to control bleeding during surgery, and shock wave lithotripsy to break up large kidney stones or gallstones could interfere with your pacemaker. He advised to stand at least two feet (61 centimeters) from welding equipment, highvoltage transformers or motor generator systems.

He explained that cardiac electrophysiologist decides the types of pacemaker that gives benefit to patients; they implant the pacemaker in the body and programme the software of pacemaker.

"After implantation pts should check the pacemaker software, battery status every 3-6 months. If the patient develops difficulty in breathing, swelling of legs, abnormal heart beat, transient black out of vision, loss of consciousness, they should immediately consult a doctor," he said.

Rourkela, June 30: Hundreds of dissident labourers and employees of the Rourkela Steel Plant (RSP) staged a sit-in in front of the gates of the plant Wednesday morning at around 5 am, a source said. According to sources, under the

banners of several labour unions, they have been on a 24-hour agitation seeking an early adoption of their eight-point charter of demands including revision of wages.

With the support of most of the trade unions, the dissidents had been protesting at Birsa Munda Square in Rourkela Tuesday. The agitation assumed larger proportions and a huge congregation of the RSP labourers and employees got down to the streets at SAIL Square, Hirakud Square as well as Fertilizer Gate here, the source added.

"We demand release of arrears, implementation of nine per cent pension, 15 per cent growth in minimum guaranteed benefit (MGB) on basic pay, perks and other benefits with withdrawal of action against the laid off labourers. Our demands include job to one of the family members of employees who died of Covid-19,' an agitator stated.

Thousands of children, across all age groups from across the country, have tested positive for Covid-19 during the second wave, creating panic among parents. Dr Narendra Kumar Arora, a paediatric gastroenterologist and a senior member of the National Covid-19 Task Force, tells us how to treat and care for children who have contracted Covid-19. Excerpts from an interview


If a child is affected by Covid-19 but parents are not, how to take care of the child?

This can happen if the child has contracted the infection from someone outside the family. So, firstly, each member of the family should get oneself tested for Covid-19. The caregiver should wear full protection gear-double masks, face shield. gloves-while nursing the child. Care should be provided under the guid-

ance and supervision of a doctor.

Are children more prone to the disease this time?

A vast majority of children either remain asymptomatic or develop a mild disease. In a household, if several adults are diagnosed with Covid-19 infection, there is a high possibility that the children will also be infected. Fortunately, in most such cases, the children particularly those



below 10 years are usually asymp tomatic or have mild, common cold like symptoms, or diarrhoea. However, children with congenital heart disease, diabetes, asthma, or those suffering from childhood cancers, or on immune-suppressants

are at a higher risk of developing hydration fluids and plenty of fluid. In moderate to severe cases, the severe disease

How is the treatment for children different from that for adults?

We don't recommend any medicine for asymptomatic children. In mild cases, we prescribe simple paracetamol to manage fever and other mild symptoms. Similarly, diarrhoea is managed with oral re-

treatment is the same as that for adults. Immediately consult a doctor if you observe respiratory distress, increased respiratory rate, severe cough that is interfering with feeding, hypoxia, uncontrolled fever, or any other unusual symptoms like skin rash, excessive sleepiness in children.

Post-Covid Education

s many countries cautiously reopen classrooms, schools remain crucial barometers of our progress toward ending the Covid-19 crisis. We need to keep children healthy while protecting their right to education, but the pandemic has hit the most vulnerable children hardest and exposed the worsening inequality of learning opportunities. We must now heed these harsh lessons and transform education systems to make them more equitable, effective, and resilient.

School closures have been one of the many measures that governments have adopted to contain a virus that so far has claimed 3.4 million lives. At their peak, over 1.6 billion children were cut off from education - half of them in low and lower middle-income countries.

Although we cannot yet fully grasp the long-term implications of this lost learning for the hundreds of millions who are still missing out on school, it clearly will have a life-changing impact on the most vulnerable children, especially girls. An estimated 20 million girls may never set foot in a classroom again because they have been sent to work to help provide for their families. As many as 13 million could be forced into early marriage and thus forego their education altogether. For millions of others, school closures have increased their risk of teenage pregnancy or of becoming victims of domestic violence.

Given this grim reality, each school reopening is a victory that can potentially change children's lives permanently for the better. But rather than simply return to pre-crisis approaches to learning, we must transform education systems entirely. We cannot go back to a status quo of unequal opportunities and poor learning outcomes, in which a quarter-billion children were already out of school and over half of all 10-year-olds in lower-income countries lacked basic reading skills.

Together, we must deliver a global recovery built on a foundation of education systems that deliver quality learning to all children, no matter where they live, how prosperous or poor their families might be, or who they are. And we need to begin by ensuring that children can return safely to schools that offer a clean environment with effective ventilation, sufficient toilets, and other basic amenities.

Countries can also use distance-learning tools to reach children outside the classroom. opening up new possibilities to educate those who were previously cut off from formal education. School closures due to Covid-19 have only hastened the need for alternative delivery methods so that every child can continue to learn.

Even before the pandemic, organisations like the Global Partnership for Education (GPE) were helping to enable learning beyond the traditional classroom. In Afghanistan, for example, advanced learning centres and more accessible and equitable community-based education have proven successful. These options give children in remote areas – especially girls,

who had often been excluded from education altogether – a chance to learn. In Pakistan's Balochistan and Sindh provinces, we have seen how technology, including smartphone applications like WhatsApp, can support teachers in serving children in less accessible areas. And Sierra Leone, drawing on its experience during the 2014-16 Ebola outbreak, has emphasised radio learning during the current crisis, with GPE support enabling children to benefit from education programmes that were broadcast while schools were shut.

Initiatives like these can be woven into education systems to make them more inclusive, so that they deliver learning at the scale needed to address past inequities. That in turn can help to bridge the education gaps left not only by the Covid-19 pandemic, but also by conflicts, poverty, natural disasters, or the effects of climate change.

By channeling support through partner-country governments to national ducation systems, the GPE has so far helped to get 160 million more chil dren into school, more than half of them girls. Moreover, GPE funds attract other donor contributions to multiply the organisation's financial support, in line with national education priorities. This approach is fundamental to catalysing necessary change and delivering it at the scale demanded by today's education emergency. To date, 97 per cent of GPE-backed education sector plans include strategies to reach the most marginalised children in lower-income countries, particularly girls and children with disabilities. In the wake of the pandemic, governments also must find the funds to shockproof their education systems for the future. That means not only developing and integrating distance-learning options, but also ensuring that schools have proper sanitary facilities and are teaching basic hygiene. Teachers need training in new methods, and we need to ensure that children who rely on their school for at least one meal a day don't go hungry during a crisis. To achieve all of this, we must immediately help governments in lowerincome countries to ensure that their education budgets are protected from any belt-tightening resulting from the pandemic's economic fallout. Domestic resources account for the vast majority of education funding, but international support can play a bigger role to help insulate and expand existing resources. That will allow governments to start reshaping learning even before their countries' economic rebounds are underway. This year, the GPE is asking governments to pledge at least \$5 billion toward transforming education for children in 90 countries and territories where schools are not only essential for learning but also critical to children's welfare and security. Safe, inclusive, and quality education can be a springboard for recovery from the pandemic, and a buffer against the next crisis.

Take cryptocurrency - central banks across the world are highly concerned about it as it is beyond their control and its availability and value are dependent completely upon demand and supply - not within national boundaries but across the world.

There are other issues as well - the process of generating or mining cryptocurrency is highly power intensive. As more and more of it is created, the mining process becomes more complex, requiring enormous amounts of computing power which in turn requires enormous amounts of electricity.

By its very nature, the ownership data of cryptocurrency is spread across thousands of computers through what is called blockchain, which essentially stores the ledger in a serverless peer to peer environment. The advantage is that even if one (or many of the computers) where the ledger is stored crashes or is hacked, the data still remains safe.

However, the blockchain system is also highly power intensive and in a recent study conducted at Cambridge University, it was found that Bitcoin consumes 121.36 terawatt-hours annually - more than Argentina (121 TWh) and the Netherlands (108.8 TWh). According to Digiconomist, a platform dedi-

cated to exposing the unintended consequences of digital trends, typically from an economic perspective, one Bitcoin transaction requires about 707.6 kilowatt-hours of electrical energy, the amount across the world. of energy the average US household consumes in 24 days. To put it in an Indian context, the annual per capita consumption of electricity in 2019-20 was 1.208 kilowatt-hours In other words, the average amount

one Bitcoin transaction. This completely virtual existence of cryptocurrency has another facet - forgetting the password to the wallet containing the cryptocurrency can mean that it is lost forever. The core attraction of cryptocurrency lies in its anonymity. But that is also one of the reasons it facilitates crime, both digital as well as physical, with criminals demanding payment in cryptocurrency to evade law enforcement agencies. An example of this is the rise in ransomware events

Cryptocurrency's anonymity is due to its use of the darknet - a private network built upon the traditional internet. To access it. one uses a web browser called The Onion Ring or Tor for short.

Tor has two basic features - it can be used to access websites with a .onion domain, which cannot be accessed by regular browsers. Secondly, when accessing a website, the browser uses a unique Tor network that hides the user's IP address from the server on which the website resides. Everytime we use the Tor browser, it generates a unique set of hops, or servers spread throughout the world. For example, it may first connect with a server in France, then to one in Indonesia, from there to a server in Brazil and then to one in the US. Now, when we access any website, the IP address that the

web server would see and record

would be the IP of the server in the

US - not our actual IP address Similarly, even if our internet service provider tracks our browsing it wouldn't know which websites we visited.

This anonymity, while ensuring individual privacy, comes at a great cost as it is used by criminals. Practically every type of illegal activity is thriving on the darknet drugs, rape and child pornography, sale of fake identity documents and currency and even murder for hire. All paid for in cryptocurrency.

With it being available easily, cryptocurrency can wreak havoc on ordinary citizens too. With the amount of any cryptocurrency that can be mined being limited, as the limits are approached, there is a rise in its value due to higher cost of mining. This causes the impression that it has value by itself and can be an investment. This tempts people to buy, not to purchase something with it, but in the hope of profiting by selling it when its value increases. Like the housing bubble of the USA, where people bought houses, not to live but to sell at a higher price, it is just a matter of time before this bubble bursts too.

The darknet, despite the anonymity it offers, is highly dangerous for the ordinary user. There are many predators who constantly lookout for newbies, and by offering apparently free access to illegal content, infect the users' computers with a variety of dangerous malware that could lead to identity theft, monetary loss or even legal prosecution.

It needs to be kept in mind that the Tor network is funded by the US government along with other governments like that of Sweden. While the management of the net work says it is independent and ensures privacy, what remains to be seen is how strong it can remain if put under pressure.

Economics needs a climate revolution

owhere are the limitations of neoclassical economic thinking-the DNA of economics as it is currently taught and practiced – more apparent than in the face of the climate crisis. While there are fresh ideas and models emerging, the old orthodoxy remains deeply entrenched. Change cannot come fast enough. The economics discipline has failed to understand the climate crisis - let alone provide effective policy solutions for it - because most economists tend to divide problems into small, manageable pieces. Rational people, they are wont to say, think at the margin. What matters is not the average or totality of one's actions but rather the very next step, weighed against the immediate alternatives. Such thinking is indeed rational for small discrete problems. Compartmentalisation is necessary for managing competing demands on one's time and attention. But marginal thinking is inadequate for an all-consuming problem touching every aspect of society. Economists also tend to equate rationality with precision. The discipline's power over public discourse and policymaking lies in its implicit claim that those who cannot compute precise benefits and costs are somehow irrational. This allows economists - and their models – to ignore pervasive climate risks and uncertainties, including the possibility of climatic tipping

points and societal responses to them. And when one considers economists' fixation with equilibrium models, the mismatch between the climate challenge and the discipline's current tools becomes too glaring to ignore.

Yes, a return to equilibrium getting 'back to normal' - is an alltoo-human preference. But it is precisely the opposite of what is needed - rapidly phasing out fossil fuels to stabilise the world's climate.

These limitations are reflected in benefit-cost analyses of cutting emissions of carbon dioxide and other greenhouse gases. The traditional thinking suggests a goslow path for cutting CO2. The logic seems compelling: the cost of damage caused by climate change, after all, is incurred in the future, while the costs of climate action occur today. The Nobel prize-winning verdict is that we should delay necessary investment in a low-carbon economy to avoid hurting the current high-carbon economy.

To be clear, a lot of new thinking has gone into showing that even this conventional logic would call for significantly more climate action now, because the costs are often overestimated while the potential (even if uncertain) benefits are underestimated. The young researchers advancing this work must walk a near-impossible tightrope, because they cannot publish what they believe to be their best work (based on the most defensible assump-

to introduce new ideas into the peer-reviewed academic literature is to follow something akin to an 80/20-rule: stick to the established script for the most part; but try to push the envelope by probing one dubious assumption at a time. Needless to say, this makes it extremely difficult to change the overall frame of reference, even when those who helped establish the standard view are looking well bevond it themselves.

Because equilibrium thinking underpins the traditional climateeconomic models that were developed in the 1990s, these models assume that there are tradeoffs between climate action and economic growth. They imagine a world where the economy simply glides along a Panglossian path of progress. Climate policy might still be worthwhile, but only if we are willing to accept costs that will throw the economy off its chosen path.

Against the backdrop of this traditional view, recent pronouncements by the International Monetary Fund and the International Energy Agency are nothing short of revolutionary. Both institutions have now concluded that ambitious climate ac-

Sir, Pakistan has again failed to come out of the grey list of the Paris-based Financial Action Task Force (FATF), an inter-governmental organisation that is seized of the policies to monitor and fight global money laundering and terror financing. Keeping Pakistan's history of terror financing in mind, and its old game of providing fertile ground for terror breeding, the latest FATF decision appears justified. However, as expected, Islamabad has accused India of jeopardising its chances to come clean. In reality, Islamabad has consistently been given some leeway by the watchdog. In hindsight, it has to thank the FATF for not keeping it in the black list. The top watchdog committee said that Pakistan's inability to fulfil one of the 27 remedial actions it had to undertake following its failure to comply with the same last time was striking. The one action was quite major - prosecution of terror group leaders banned by the United Nations. The supreme leaders of major terror groups like LeT and JeM are still free birds. Without their prosecution nothing much can be achieved on the terror front in the region. The FATF does not want Pakistan to stop short of exemplary steps to put brakes on terror activities on its soil. The Imran Khan dispensation should be a worried lot because the country is on the grey list since 2018, after being removed from the list in 2015 when it was on the list for seven years beginning 2008. A positive nod from the widely respected FATF means a lot to the Pakistan Prime Minister who finds himself in a tightrope, harrowed by the relentless attacks of the opposition parties of Pakistan.

Work on Lower Suktel project resumes

Bolangir, June 30: Works on the Lower Suktel irrigation project got a fillip as the district administration launched an eviction drive in the project affected Pardhiapalli village for the first time, 20 years after the start of the project, Tuesday, a report said.

Tuesday marked an important day for the project as the district officials accompanied by nine platoons of police supervised the demolition of eight houses in the village. Similarly, houses of 50 villagers were demolished on the second day, Wednesday. The project which was launched with an outlay ₹217 crore has now reached ₹3000 crore.

However, for the first time, villagers did not oppose the demolition drive and only sought some more time in evacuating the village. They urged the district and police officials not to evict them from the village during the Covid pandemic and rainy season.

However, the officials informed them that the houses of only those persons will be demolished who have received the ex-gratia and second installment of compensation. Later, the houses of Seshadev Gadatya, Dagar Biswal, Sabitri Bariha, Netaji Gadatya,

Durga Dharua, Pitambar Bag, Laba Barik and a club building were demolished with the help of a JCB earth mover during the drive.

The displaced villagers carrying their belongings in the vehicles arranged by the district administration and accompanied by their family members soon left the village for elsewhere. People have been cooperating in the displacement drive as they have been provided with compensation, subcollector Lambodar Dharua said. As a result, the first phase demolition drive concluded peacefully

Later, some works started but it soon got mired in a controversy due to a land scam and other problems. Similarly, parallel agitations also took place to finish the project works at a faster pace as it is an important project for the district.

The project works only moved ahead after a high-powered committee formed by the state government intervened and appointed various officials for the project. The project work moved only after the problems of the displaced villagers were resolved in public hearing camps and ex-gratia paid to them.

Harley Crabs may soon become a thing of past

RELEASE OF MASSIVE INDUSTRIAL EFFLUENTS AND TOXIC CHEMICALS TO SEA WATER. ENVIRONMENTAL IMBALANCE. MUSHROOMING ILLEGAL PRAWN GHERIES IN THE RESTRICTED ZONES HAVE TAKEN A HEAVY TOLL ON THE LIFE OF THESE RARE MARINE CREATURES

Mahakalapara, June 30: The contribution of Harley Crabs to maintenance of local bio-diversity and fertility of land along with environmental balance is significant. These marine crabs dig holes of one inch wide and 10-ft deep each in the sandy land and alluvial soil adjoining the sea beaches.

These holes facilitate land aeration and allow nutrients to go inside the land raising its fertility. These crabs prefer to make their habitats in the mangroves area and under trees and bushes on the saline lands.

They feed on marine reptiles, small creatures, small fish, wastages and decomposed material that collect around their habitats or wash into these holes. As oxygen enters these holes during stormy activities in the sea, these crabs indirectly help in the growth of mangroves and lead to a raise in the number of the wildlife creatures.

The vellow colour of their bodies and black stripes on their back make them look wonderful. The Harley Crabs live in hoards and rush inside their holes at the slightest perception of external threats. While normal crabs have 10 legs each, these coloured crabs have nine legs. Their two main legs are relatively large and t help them in gathering food and defending

against enemies. These crabs are largely seen in hordes in the vast sand beds ad-



Gahirmatha in joining Mahakalapara block of Kendrapara district. Lunchghola, Shola Muhana. Hukitola and Tandabaluka sea beaches are their

main habitats. However, discharge of tonnes of industrial effluents and illegal prawn gheries have jeopardized their existence leading to a steady decline in their number now.

It's noteworthy to mention that tourists and local visitors throng these sea beaches during winter to enjoy the natural sight of these yellow Harley Crabs moving in hordes. They click selfies with these crabs. Jackals, wild cats, stray dogs, eagles and kites eat these crabs.

The rare Harley Crabs enrich the land fertility by adding nutrients to soil. They also help in maintaining the bio-diversity and ecological balance of the area. Their mating season starts in June and July. An interesting aspect of their nature is that they could sense the arrival of natural calamities such as cyclones at least 24 hours in advance. During such times, they leave their natural habitats and move in file to upper reaches of the land and sand before the calamities strike

Environmentalist and convener of the conservation of marine life Samarendra Mahali says, Harley Crabs are a very old marine species and their number has been fast dwindling over recent years. Release of massive industrial effluents and toxic chemicals, environmental imbalance, mushrooming of illegal prawn gheries in Gahirmatha restricted waters have taken a heavy toll on the life of these rare marine creatures, he added. There is an urgent need to create local awareness to protect Harley Crabs before they go com-pletely extinct, said local environmentalists.





Cops begin house-to-house probe days after drone strike

A TEAM OF THE ELITE NATIONAL SECURITY GUARD VISITED THE IAF BASE. BUT IT WAS IMMEDIATELY NOT KNOWN WHAT ACTIONS IT TOOK

Jammu, June 30: Police began a house-to-house verification drive in residential colonies near the Jammu airport, three days after an Indian Air Force (IAF) station there was targeted in a first-of-its-kind terror attack using drones, officials said Wednesday

In the drive that began from Peer Baba in the Chatta area, police personnel collected details of residents, including their contact numbers

The IAF also deployed an unmanned aerial vehicle (UAV) fitted with camera that hovered over its station and nearby residential areas for several hours in the af ternoon, the officials said.

They said additional floodlights have been installed at the IAF base and more lights on high masts are being set up.

A team of the elite counter-terrorism unit National Security Guard (NSG) visited the IAF base, but it was immediately not known what actions it took.

In what was the first instance of Pakistan-based terrorists deploying drones to strike vital installations, two bombs were dropped at the IAF station in the early hours of Sunday, causing minor injuries to two airmen.

The explosions took place around 1.40 am within six minutes of each other. The first blast ripped off the roof of a single-storey building at the technical area of the airport



manned by the IAF in Satwari on the outskirts of Jammu. The second one was on the ground.

The aerial distance from the Jammu airport to the international border is 14 km. There were also reports of sight-

ing of unidentified drones over vital military installations during the previous three nights.

The Army Monday had confirmed the presence of drones over its brigade headquarters at the Ratnuchak-Kaluchak station and said a major threat was thwarted by the alertness and proactive approach of the troops who engaged the unmanned vehicles after being spotted twice at 11.45 pm and 2.40 am Sunday night.

Both the drones disappeared after firing by the troops but no debris was found during the subsequent search operation in and

around the camp. Reports also claimed sighting

of drones over Ratnuchak and Kaluchak around 1.08 am and 3.09 am Tuesday and again over the Kunjwani garrison around 4.19 am. Suspected drones were also spot-

ted over army installations at Miran Sahib at around 9.32 pm Tuesday and Kaluchak and Kunjwani at 4.40 am and 4.52 am Wednesday, respectively, the officials said, adding that there was no reaction from the Army troops on the ground as the drones were flying at a high altitude.

An Army officer, when contacted. neither confirmed nor denied the sighting of drones over the past few days

The Kaluchak Army station was attacked by terrorists in 2002, in which 31 people including 10 children were killed. Six soldiers and a civilian lost their lives in another terrorist attack at the Sunjwan military station in February 2018.

Madras HC directs state govt to vaccinate homeless

Chennai, June 30: The first bench of the Madras High Court, comprising Chief Justice Sanjib Banerjee and Justice Senthilkumar Ramamoorthy, has directed the Tamil Nadu government to vaccinate the homeless and pavement dwellers without any identity cards.

The court was hearing a petition moved by a petitioner Karpagam Wednesday, urging it to direct the authorities to ensure that the homeless and pavement dwellers without any identity cards are protected against the virus through vaccination.

New Delhi, June 30: Tamil Nadu has emerged as the top state in its overall handling of the second Covid wave.

As per a survey by LocalCircles, on an aggregate basis, 59 per cent of Tamil Nadu residents rated the state government's handling of the second wave as effective or higher.

Tamil Nadu was followed by Andhra Pradesh as on an aggregate basis, 54 per cent of Andhra Pradesh residents rated the Andhra Pradesh government's handling of second wave as effective or higher.

DELIMITATION PANEL TO VISIT J&K FROM JULY 6-9

New Delhi, June 30: The delimitation commission on Jammu and Kashmir will be on a four-day visit there from July 6-9 to interact with political parties, their leaders and government officials to gather "first hand" inputs on the ongoing process of redrawing the boundaries of electoral constituencies there, a statement said Wednesday.

The decision was taken after a meeting of the commission Wednesday at the poll panel headquarters here which was chaired by commission head Justice (Retd) Ranjana Prakash Desai and also attended by Chief Election Commissioner (CEC) Sushil Chandra. The Jammu and Kashmir chief electoral officer is another member of the three-member committee who was not in attendance. "During the visit period, the commission will interact with political parties, public representatives and Union Territory administration officials including district election officers/deputy commissioners of 20 districts of the UT to gather first hand information and input concerning the ongoing process of delimitation as mandated under the Jammu & Kashmir Reorganisation Act, 2019," the delimitation commission said in a statement.

The commission, it said, expects that all stakeholders will "cooperate" in this endeavour and provide their valuable suggestions so that the task of delimitation is completed timely, it said.

It is understood that the commission will hold its first series of meetings in Srinagar before going to Jammu July 8.

The statement added that the commission already has had a series of meetings on data/map of the districts and constituencies related to census 2011.

Sasikala forms war

room at home, calls AIADMK functionaries

Chennai, June 30: VK Sasikala, former interim general secretary of the AIADMK, has set up a war room at her home in T Nagar here and is calling party cadres and middle level functionaries with 20-30 calls per day

Sasikala, who was a close aide of late Chief Minister J Jayalalithaa, is using her contacts across the state and is carefully choosing the cadres she should address and is mainly concentrating on the turfs of AIADMK leaders Edappadi K. Palaniswami and O. Panneerselvam.

Sasikala's sister-in-law Ilavarasi, her personal assistant Karthikeyan and four assistants manage the war room at her residence which has high-tech digital facilities, and proper data of the lower and medium-level functionaries of the party.

Sources in Sasikala's team told IANS that she is abreast of all the English, Tamil newspapers as also several YouTube channels which are focusing on developments in Tamil Nadu politics.

She is receiving 50 to 80 letters a day from AIADMK and AMMK cadres who are disgruntled at the leadership of the functioning of their party leaders, they claimed. The war room was instrumental in releasing recorded audiotapes of her conversation with the AIADMK functionaries to the media.

Karthikeyan is the key person who puts her through to the AIADMK cadres and he connects her to these leaders only after a thorough background check. The

'No impact on party'

Salem: Seeking to play down expelled general secretary V K Sasikala's purported interaction with party workers, AIADMK cocoordinator K Palaniswami Wednesday said her telephonic conversations will not impact the 1.5 crore cadre based organisation a wee bit. Jammu, June 30: The Jammu and Kashmir administration Wednesday cancelled residential accommodations of 'darbar move' employees in Jammu and Srinagar, davs after Lieutenant Governor Manoj Sinha announced an end to the age-old practice.

The officials have been asked to vacate their quarters in the twin capital cities within three weeks.

Sinha had June 20 announced that the Jammu and Kashmir administration has completely transitioned to e-office, thereby ending the practice of the bi-annual 'darbar move'.

"Now both the Jammu and Srinagar secretariats can function normally for 12 months. This will save the government ₹200 crore per year, which will be used for the welfare of the deprived sec-

tions," he had said. In an order issued by Commissioner Secretary, Estates



Department, M Raju said sanction had been accorded to the cancellation of allotment of residential accommodation of officers and officials in Srinagar and Jammu. Employees from Jammu had been allotted residential accommodation in Srinagar and those from Srinagar in Jammu.

The estates department has 4,678 dwelling units in the Union Territory, comprising 3,200 units in

Jammu and 1,478 units in Srinagar. Many of the employees are also having private accommodation provided by the government. Releasing the list of the em-

modation has been cancelled on the basis of their location orders issued by the General Administrative Department, the order asked these officers and officials to vacate their governmentallotted residential accommodation in the twin capital cities within 21 days.

There are over 10,000 employees working in the civil secretariat and the order covers all the move employees who were provided government accommodation, an official said, wishing anonymity.

As part of the 'darbar move', the Raj Bhavan, the civil secretariat -- the seat of the Jammu and Kashmir government -- along with many other offices used to shift between Jammu and Srinagar twice a year.

The practice, under which the administration used to function in Jammu during the six months of winter and in Srinagar during thesummer, was started by Maharaja Gulab Singh in 1872.

Pressure mounts on Twitter

THE NCW HAS ASKED THE MANAGING DIRECTOR OF TWITTER INDIA TO REMOVE ALL PORNOGRAPHIC AND OBSCENE CONTENT FROM THE PLATFORM WITHIN A WEEK

New Delhi, June 30: Taking suo moto cognisance of pornographic content on Twitter, the National Commission for Women (NCW) Wednesday directed the microblogging platform to remove "all pornographic and obscene" content within a week while instructing Delhi Police to investigate and take appropriate legal action.

The NCW move comes a day after Delhi Police registered a case against Twitter for child pornographic content following a complaint by the National Commission for Protection of Child Rights (NCPCR). The police action was taken amid ongoing tussle between the Centre and Twitter over the new IT rules and according to officials the NCPCR complaint pertains to alleged display of child pornographic content on the social media site.

NCW Chairperson Rekha Sharma wrote to Twitter India's Managing Director Manish Maheshwari for immediate removal all such pornographic and obscene content from Twitter platform within a week. She also wrote to Delhi Police Commissioner to investigate and take appropriate legal

"The National Commission for Women (NCW) has taken suo motu congnisance of several profiles on Twitter sharing pornographic content," the NCW said in a statement. "The commission earlier upon receiving a similar complaint had brought the matter to Twitter's notice for immediate action; however, no action was reportedly taken by the platform."

"The Commission is disturbed with the fact that despite knowing of the availability of such banned content which not only violates Indian laws but also Twitter's own policy, no action has been taken till date towards removing it," said the statement.

The statement further said that the Commission has shared with Twitter details of few profiles sharing pornographic content on Twitter and has directed to remove all such content within one week.

New Delhi, June 30: As the European Union relaxes travel restrictions under its 'Green Passport' scheme, India has requested the members of the 27-nation grouping to individually consider allowing Indians who have taken Covishield and Covaxin vaccines to travel to

The sources said India has requested the EU member nations to accept the vaccination certificate issued through the CoWIN portal.

Covid certificate framework to facilitate free movement during the Covid-19 pandemic is to come into effect Thursday. Under this framework, persons who have taken vaccines authorised by the European Medicines Agency (EMA) will be exempted from travel restrictions within the EU.

The individual member states have the flexibility to also accept vaccines that have been authorised at the national level or by the World Health Organisation. "We have requested EU member states to individually consider extending similar exemption to those persons who have taken Covid-19 vaccines in India, that is Covishield and Covaxin, and ac-



cept the vaccination certificate issued through the CoWIN portal," said a source. The sources said the genuineness of such vaccination certification can be authenticated on the CoWIN portal. "We have also conveved to EU

member states that India will institute a reciprocal policy for recognition of the EU Digital Covid Certificate," the source said.

Dehradun, June 30: The Uttarakhand government Wednesday moved the Supreme Court, challenging the High Court's stay on the Char Dham Yatra.

tricts from July 1. "We have gone to the apex court against the High Court's stay on the yatra," Cabinet Minister Subodh Unival told reporters. The Cabinet had decided to open the yatra for people from the districts where famous four Himalayan temples are located on the condition of strict adherence to Covid protocol, including bringing a negative RT-PCR or rapid antigen test report.

Claiming that all arrangements had been made for the yatra, Uniyal said the decision was taken by the



Cabinet after carefully thinking over all aspects. Last year, when the yatra was allowed for devotees from all over the country, 70 people visited Gangotri per day, 40 visited Yamunotri, 180 Kedarnath and around 400 turned up daily at Badrinath. "Keeping it in mind, it was decided to open the yatra strictly for locals with a daily cap on the number of devotees to visit the temples. It was decided that not more than 750 people will be allowed to visit the four Himalayan temples in a day," Unival said.

THE HEALTH EFFECTS IN TERMS OF MORTALITY DUE TO BLACK CARBON AEROSOL EXPOSURE HAVE NEVER BEEN EVALUATED IN INDIA Black carbon could lead to premature mortality: Study

4 killed in LPG blast

New Delhi: A 45-year-old woman, two of her sons and a daughter died of suffocation Wednesday when a fire broke out at their Shahdara residence following an LPG cylinder explosion, Delhi Fire Service (DFS) officials said here. According to the DFS, a call about a cylinder blast in Shahdara's Farsh Bazaar area was received around midnight Tuesday, and nine fire tenders were rushed to the spot. A portion of the roof had collapsed due to the explosion, the fire officials said.

New Delhi, June 30: Black carbon could lead to premature mortality, said a study conducted by the Department of Science & Technology-Mahamana Centre of **Excellence** in Climate Change Research (MCECCR) at the Banaras Hindu University.

Black carbon has significant adverse effects on human health and leads to premature mortality said the new study, which could help in the estimation of future burden of mortality associated with air pollutants more accurately.

The study explored the individual as well as the cumulative impact of BC aerosol, fine (PM 2.5) and coarse (PM 10) particulates, and

trace gases (SO2, NO2, O3) on premature mortality in Varanasi. The findings have recently been published in the journal 'Atmospheric Environment'.

The Indo-Gangetic plain is exposed to black carbon with serious implications on regional climate and human health. However, most of the pollution-based epidemiological studies essentially relate exposure to particulate mass concentration (PM 10 and/-or PM 2.5) that invariably generalise all particulates with equal toxicity without distinguishing individuals by its source and composition, which genuinely have different health

consequences. Importantly, the health effects in terms of mortality due to black



carbon aerosol exposure have never been evaluated in India.

A typical urban pollution hotspot in the central Indo-Gangetic plain (IGP), Varanasi experiences very high aerosol loading and trace gas concentration throughout the year due to the prevalence of a subsidence zone and observed decadal increasing trends both in aerosol

optical depth and black carbon aerosols.

The scientists from the MCECCR, supported by the climate change programme of the Department of Science and Technology, utilised daily all-cause mortality and ambient air quality from 2009 to 2016 to clearly establish a significant impact of black carbon aerosols, NO2 and PM2.5 exposure on mortality.

The inclusion of co-pollutants (NO2 and PM 2.5) in the multi-pollutant model increased the individual mortality risks for black carbon aerosols.

The effect of pollutants was more prominent on males in the 5-44 age group, especially during winter.

They found that the adverse effect of air pollutants is not limited to the current day of exposure, but can extend as high as up to five days. They further showed that mortality rises linearly with an increase in air pollutant levels and shows adverse impact at higher levels

Inclusion of black carbon as a potential health hazard inspires and provides a background for more epidemiological studies to provide evidence of health effects of air pollutants from different parts of the country. RK Mall led the team of scientists who conducted the study, including Nidhi Singh, Alaa Mhawish, Tirthankar Banerjee, Santu Ghosh and RS Singh from the BHU.

Asked if the events could have triggered World War III, Putin responded that the West wouldn't risk a full-scale conflict.

"Even if we sank that ship, it wouldn't put the world on the brink of World War III because those who do it know that they can't emerge as winners in that war, and it's very important," Putin said during his annual live call-in show.

"It was clearly a provocation, a complex one involving not only the British but also the Americans," he said, adding that Moscow was aware of the US intentions and responded accordingly to avoid revealing sensitive data.

"We are fighting for ourselves and our future on our own territory,'



Putin charged that the **US aircraft's apparent** mission was to monitor the Russian military's response to the British

China certified malaria-free after 70-year long fight: WHO

Geneva, June 30: China was certified as malaria-free Wednesday by the World Health Organization, following a 70-year effort to eradicate the mosquito-borne disease.

"We congratulate the people of China on ridding the country of malaria," said WHO director-general Tedros Adhanom Ghebreyesus.

"Their success was hard-earned and came only after decades of targeted and sustained action. With this announcement, China joins the growing number of countries that are showing the world that a malaria-free future is a vi-

able goal." Countries that have achieved at least three consecutive years of zero indigenous cases can apply for WHO certification of their

malaria-free status. They must present rigorous evidence -- and demonstrate the capacity to prevent transmission re-emerging.

China becomes the 40th territory certified malaria-free by the Geneva-based WHO.

The last countries to gain the status were El Salvador (2021), Algeria and Argentina (2019), and Paraguay and Uzbekistan (2018).

China's pioneering malaria battle In the 1950's, Beijing started

working out where malaria was spreading and began to combat it with preventative anti-malarial medicines, said the WHO.

The country reduced mosquito breeding grounds and stepped up spraying insecticide in homes. In 1967, China launched a scientific programme to find new

malaria treatments, which led to the discovery in the 1970's of artemisinin -- the core compound of artemisinin-based combination therapies (ACTs), which are the

available. In the 1980's, China was among the first countries to extensively test the use of insecticide-treated nets to prevent malaria. Bv 1988. more than 2.4 million had most effective antimalarial drugs been distributed nationwide.

China reported 30 million cases of malaria annually in the 1940's but has now gone four consecutive years without an indigenous case

By the end of 1990, the number of malaria cases in China had plummeted to 117,000, and deaths had been cut by 95 percent.

"China's ability to think outside the box served the country well in its own response to malaria, and also had a significant ripple effect globally," said Pedro Alonso, director of the WHO's global malaria programme.

Southern border surveillance

From 2003, China stepped up efforts across the board that brought annual case numbers down to around 5,000 within 10 years.

After four consecutive years of zero indigenous cases, China applied for WHO certification in 2020. Experts travelled to China in May this year to verify its malaria

free status -- and its plans to prevent the disease from coming back.

The risk of imported cases remains a concern, not only among people returning from sub-Saharan Africa and other malaria-hit regions, but also in the southern Yunnan Province, which borders Laos, Myanmar and Vietnam, all struggling with the disease. China has stepped up its malaria surveillance in at-risk zones in a bid to prevent the disease re-emerging, said the WHO.

RBI expects the economy to grow at the rate of 18.5 per cent in April-June. 7.9 per cent in the second quarter, 7.2 per cent in December quarter and 6.6 per cent in the fourth quarter.

Beijing, June 30: Elon Musk's EV maker Tesla will remotely update the Autopilot software in about 285,000 of its cars in China to prevent drivers from mistakenly activating the Autopilot feature while driving. According to GizmoChina. this is after the country's regulatory agency investigated claims that drivers inadvertently switch to Autopilot when driving.

The remote update is understood to affect both cars made locally and those from abroad. The state regulator, China's State Administration for Market Regulation, believes there are safety concerns if the Autopilot is not firmed up.

When the Autopilot turns on accidentally, the vehicle may accelerate rapidly or quickly slow down. Sudden acceleration or slowing down could, in extreme cases, cause a collision.

According to the state regulator, Tesla had already commenced the process of updating the software since Saturday. The bulk of the vehicles affected are the locally produced Model 3 and Model Y models, while more than 35,000 imported Model 3 will also be updated.

Retail inflation for industrial workers rises marginally to 5.24%

New Delhi, June 30: World Bank Wednesday said it has approved a USD 500 million (about ₹3,717.28 crore) loan programme to support India's informal working class to overcome the current pandemic distress. The loan will create greater flexibility for states to cope with the ongoing pandemic, future climate and disaster shocks, World Bank said in a statement.

Of the USD 500 million commitment, USD 112.50 million will be financed by its concessionary lending arm International Development Association and USD 387.50 million will be a loan from International Bank for Reconstruction and Development (IBRD). The loan has a maturity period of 18.5 years including a grace period of five years.

World Bank said its total funding towards strengthening India's social protection programmes to help the poor and vulnerable households since the start of the pandemic stands at USD 1.65 billion (about ₹12,264.54 crore).

The first two operations approved

last year provided immediate emergency relief cash transfers to about 320 million individual bank accounts identified through pre-existing national social protection schemes and additional food rations for about 800 million (80 crore) individuals, World Bank said.

States can now access flexible funding from disaster response funds to design and implement appropriate social protection responses. The funds will be utilised in social protection programme for urban informal workers, gigworkers, and migrants, it said.

Amazon started in 2013 as a marketplace but faced issues on FDI. In 2014, it entered into a partnership with Catamaran Mgmt.

Services (promoted by Infosys cofounder Narayana Murthy), which owned 51% while Amazon owned 49% in Prione Business which owned Cloudtail India, the key vendor on Amazon India platform. However, the 2018 regulation pushed Amazon to reduce its stake to 24%

While B2B & single brand retail have a stable framework, FDI in inventory-led e-comm is prohibited. 100% FDI is allowed in marketplace but regulations are evolving

with Catamaran now at 74%. FDI in any form of retail was banned in India until 1996. However, 100% FDI was allowed in wholesale cash & carry in 1997 which was also extended to B2B e-commerce in 2000. In 2006, 51 % FDI was allowed in single-brand retail which was made 100% in 2012 with some restrictions (30% local sourcing etc.). Single brand retailers have been also been allowed to run B2C ecommerce from 2015. In 2013, FDI was allowed in multi-brand retail (with some restrictions). However, the final approval was left to individual states and today, around 11 states and one UT allow FDI, while rest do not.

e-Commerce models: In 2016, the e-commerce policy allowed 100% FDI in marketplace but banned the Inventory-led model. Over the years, the marketplace regulations have evolved covering aspects like control over inventory and direct/indirect investments in vendors.

2018 regulations: The industry managed to create alternate structures in order to adhere to the regulations until 2017. This prompted lawmakers in 2018 to tighten their grip by restricting control over inventory which covered cases where -(a vendor buys more than 25% of its products directly or indirectly.





England shed agonising past

London, June 30: As the Wembley Stadium announcer roared the final score — "England 2, Germany 0" — Gareth Southgate's vision was momentarily diverted from his victorious players to the big screen.

Shown beaming from the VIP seats, reveling in England's passage to the European Championship quarterfinals Tuesday, were David Beckham and Ed Sheeran. Prince William, wife Kate and 7-year-old Prince George were also there celebrating, as fans just like their subjects rather than royalty.

But it was the sight of David Seaman that caught Southgate's eyes and made him pause, to think back — in one of his greatest moments as England coach — to the pain of 25 years ago.

It was Southgate's penalty miss at the old Wembley that denied an England side with Seaman in goal the

"For the teammates who played with me, I can't change that — so that's always going to hurt," Southgate said. "But what this group of players has been able to do is give a new generation a lot of happy memories and another afternoon where they have made a bit of history.'

England are finally unburdened by the weight of their agonising history against the Germans. This was a day more reminiscent, albeit with a long way to go in Euro 2020, of the 1966 World Cup final win over them on the same site.

Not that it came easily. Just like in England's two group wins, Raheem Sterling was on the scoresheet, breaking the tense deadlock in the 75th minute. But this time Harry Kane finally scored his first goal at Euro 2020, easing the pressure on the 2018 World Cup Golden Boot winner's shoulders.

It was England's second-ever win in the knockout stage of the European Championship. The last such triumph came on penalties against Spain at Euro '96 before the hosts were denied a place in the final by Germany in that shootout.

It was on penalties that Germany also beat England in the 1990 World Cup semifinals. Then there was the English goal wrongfully disallowed as Germany knocked the English out of the 2010 World Cup.

Now England will play Ukraine in the Euro 2020 quarterfinals Saturday in Rome, eying a return to Wembley for the semifinals and the final.

It marked the end of the 15-year reign of Joachim Loew as the 2014 World Cup-winning coach takes time out to consider his next steps. "We were not clinical enough," he said. "The team need to mature to be more successful.

about Southgate's team selection and persistence with Kane when he managed only one touch in the opposition penalty area in the first half. And it was a bad one, taking a ball too far past Manuel Neuer while trying to go around the goalkeeper.

But while Sterling's goals are spearheading England's progress at this largely-home tournament, the saves of Jordan Pickford are proving vital, too, including using one hand to push over Kai Havertz's shot at the start of the second half.

The clamor to introduce Jack Grealish was growing in the second half. It's what got fans chanting inside Wembley, with a crowd of about 40,000 the biggest in Britain since the pandemic began in March 2020.

The winger finally entered with about 20 minutes to go and played a role in the opening goal. Sterling first took on the defenders, going past Antonio Rudiger before passing to Kane, whose lavoff to Grealish

was the left back's cross that Sterling connected with, shooting past Neuer with his right boot.

"We knew the intensity we can play at," Sterling said, "and not

many teams can deal with it." For all the experience in Germany's side compared to the youth of England, it was World Cup winner Thomas Muller who squandered a chance to equalise in the 81st minute. Clean through with only Pickford to beat, Muller put the ball wide.

Kane showed him how it's done, heading in a cross from Grealish in the 86th minute to get the 35th England goal that eluded him in the group stage. "When you're a center forward it doesn't matter what else you're doing in the game," Southgate said. "You need those goals."

England has yet to concede in its four games. Just like at the 1966 World Cup — and that ended well. "This," Kane said, "will give us

Zinchenko, Dovbyk fashion Ukraine win

Shevchenko's side stun Sweden with a late extra-time goal to enter Euro 2020 quarters

Glasgow, June 30: Ukraine had reached the round of 16 at the Euro 2020 with two losses and the worst record of the advancing teams. And now the quarterfinals, too.

Ukraine eliminated previously unbeaten Sweden 2-1 Tuesdav with a goal in stoppage time at the end of extra time from a player who was left on the bench for the entire group stage. Substitute Artem Dovbyk stooped low to guide a header from Oleksandr Zinchenko's cross past goalkeeper Robin Olsen.

It was the 24-year-old forward's first goal for the national team. Ukraine's greatest ever forward, current coach Andriy Shevchenko, ran down the sideline to celebrate his players, who will now head to Rome to face England Saturday.

Zinchenko also scored a goal on a day when Manchester City teammate Raheem Sterling got one in England's 2-0 win over Germany. Zinchenko gave Ukraine the lead in the 27th minute when he rifled in a low shot set up by a crafty pass from captain Andriy Yarmolenko.

Emil Forsberg's deflected shot from outside the area in the 43rd minute equalised for Sweden. It was his fourth goal at Euro 2020, but a tournament lead-tying fifth eluded him in the second half despite curling shots off the post and the crossbar.

Sweden coach Janne Andersson cited the momentum shift in extra time when Sweden defender Marcus Danielson was sent off in the 98th minute for following through on a challenge with a raised boot on substitute Artem Besedin.

The Ukrainians had needed a favor from Sweden just to advance after losing two group games and having a negative goal difference. After losing to Austria last week, Ukraine would have been out if Poland had beaten Sweden two days later. Sweden won that game 3-2 with Forsberg scoring twice.


Neither team had ever won a knockout game at a European Championship in a combined eight previous tournaments. Both oftencautious teams played more freely in a wide-open 90 minutes, trying to seize a chance for a deep run in the arguably weaker half of the draw.

Ukraine's key creator had been Yarmolenko. To set up Zinchenko's goal, Yarmolenko used the outside of his favored left foot to drift a curling pass across seven defenders toward their blind side in the penalty area.

After scoring with a first-time shot, Zinchenko ran away with a finger to his lips in a gesture he said was telling critics to be quiet. Yarmolenko looked exhausted long before he was taken off for the final period of extra time - making way for Dovbyk to come on.

Low end to Loew's tenure

Berlin, June 30: Joachim Loew's 15-year tenure as coach of Germany's national soccer team is over, and many think it should have ended a long time ago.

The Germans at least advanced from the group stage this time, unlike three years at the World Cup when they were defending champions, but then lost to England 2-0 at Wembley Stadium Tuesday in the round of 16 of the European Championship.

Loew led Germany to the World Cup title in 2014, and a semifinal appearance at Euro 2016, but his team never recovered from their early exit at the last World Cup.

An attempted reboot after the tournament in Russia failed to yield the desired results. First there was the embarrassing 0-6 loss to Spain last November, and then a 1-2 loss to North Macedonia in World Cup qualifying in March.

Shortly before the second of those two surprising results. Loew announced that Euro 2020 would be his last tournament. And with no need to personally to persevere with the team's rebuilding process, he recalled veterans Thomas Muller and Mats Hummels for the pandemic-delayed tournament

Both Muller and Hummels played key roles in helping Germany ad-

vance from a difficult group that included World champions

France,

European champions Portugal and a well-organized Hungary team. But Germany's chances at the tournament were ultimately undone by a failure to make more of their opportunities.

Essentially, Germany still haven't found a replacement Miroslav Klose and his goals. The World Cup's all-time leading scorer with 16 goals retired after winning the title in Brazil seven years ago

Against England, Muller and Timo Werner failed to convert the best of Germany's chances. Kai Havertz also went close, but England forwards Raheem Sterling and Harry Kane scored

a goal each to show the Germans how it's done. Loew's 198th match in charge was his last. It was only the second time

Germany had failed to reach the quarterfinals of a major tournament since Loew took over as coach after the 2006 World Cup. The problem for Loew is that it was right after the first. Hansi Flick, Loew's former

assistant, will take over for World Cup qualifying. Flick, who had a very successful spell in charge of Bayern Munich, will inherit the problems Loew faced - most notably the lack of an out-and-out scorer — but he has some excellent young players to work with.

AIFF nominates Sunil Chhetri

New Delhi, June 30: Talismanic India captain Sunil Chhetri has been recommended for this year's Rajiv Gandhi Khel Ratna, the country's highest sporting honour, by the All India Football Federation.

National women's football team striker Bala Devi, who is currently playing for Rangers in the Scottish Women's Premier League, has been recommended for the coveted Arjuna Award.

"We have recommended Sunil Chhetri for the Khel Ratna and Bala Devi for Arjuna Award," an official source told this agency on condition of anonymity. "We have also recommended Gabriel Joseph for Dronacharya Award," the source added.

The 36-year-old Chhetri has played 118 international matches, scoring 74 goals, both Indian records. He scored twice against Bangladesh in the recent World Cup Qualifiers in Qatar to become the second highest international goal scorer among active footballers, ahead of Argentine maestro Lionel Messi. He is, however, currently in the fourth spot with United Arab Emirates' Ali Mabkhout (76) and Messi (75) having overtaken him. Chhetri is a recipient of Padma Shri (2019), the country's fourth highest civilian honour, and the Arjuna Award (2011).

Since making debut in 2005, Chhetri has been part of Indian team that won the AFC Challenge Cup (2008), SAFF Championships (2011, 2015), Nehru Cup (2007, 2009, 2012), Intercontinental Cup (2017, 2018).

Big W: Djokovic dispatches for Khel Ratna Anderson to enter 3rd round

Wimbledon, June 30: Novak Djokovic slid, slipped, skidded and stumbled into the third round on Wimbledon's slick grass Wednesday by beating Kevin Anderson 6-3, 6-3, 6-3. Djokovic didn't face a break point and committed just six unforced errors, including one with his forehand.

But footing continued to be an issue on the third day of the tournament, and Djokovic went sprawling several times, as did players in other matches and at least one ball kid.

"I didn't slip just once; I slipped like six times," Bianca Andreescu said after losing her first-round match.

"The courts are super slippery. I have only played here once before, but they weren't like this at all. I spoke to a couple other players, and they said it's not that normal. But this is something we can't really control.'

Seven-time champion Serena Williams retired from her firstround match Tuesday with a leg injury after she slipped. Roger Federer's opponent, Adrian Mannarino, had to call it quits after he fell and twisted his knee.

Persistent rain the first two days of play created slick conditions. The weather also caused a scheduling backlog, with 27 first-round matches pushed into Wednesday. The retractable roof was open when the top-ranked Djokovic was first on Centre Court for his rematch against Anderson, who also lost when they played in the 2018 final. While Djokovic endured an up-



and-down performance on the slippery surface and rose from one spill muttering in frustration, he had little trouble with Anderson. The preternaturally limber Djokovic extended one rally by hitting a forehand while down on his knee — and won the point.

Djokovic seeks his sixth Wimbledon title and third in a row. By winning the championship, he would also match the record total of 20 majors shared by Roger Federer and Rafael Nadal, and would need only a title at the U.S. Open to sweep all four Grand Slams in 2021.

Andreescu made another early Grand Slam exit when she lost to Alice Cornet 6-2, 6-1. The Canadian won the 2019 Open but is 2-5 in majors since, including three opening-round defeats.

Andreescu, who has battled injuries but was seeded fifth, committed 34 unforced errors to seven for Cornet. "I tried to stay positive the whole match," Andreescu said. "I tried to figure it out, how I can play her better. But honestly, she played really well.

Yoshihito Nishioka overcame a 15-inch height disparity to beat 6foot-10 John Isner 7-6 (5), 2-6, 6-3, 6-7(7), 6-4. The match took place on Court 18, where Isner won a record fifth set 70-68 in 2010.

Also advancing was Queen's Club tournament champion Matteo Berrettini, who hit 20 aces and pulled away from Guido Pella 6-4, 3-6, 6-4, 6-0, American Sam Querrev upset No. 11 Pablo Carreño Busta 7-6 (6), 6-4, 7-5.

Former US Open runner-up Kei Nishikori ousted Alexei Popyrin 6-4, 6-4, 6-4 for his 100th Grand Slam match win. No. 10 Denis Shapovalov moved into the third round when Pablo Andújar withdrew because of a rib injury. In other women's play, French Open runner-up Anastasia Pavlyuchenkova beat Ana Bogdan 6-2, 6-2.
