### US EASES TRAVEL ADVISORY FOR INDIA

**WASHINGTON:** The US eased its travel advisory for India Monday, lowering it to Level 2: Moderate. The new travel advisory of Level 2 – which is considered as safe – came in the wake of the significant improvement in Covid situation in India. Early this year, the US had put India in Level 4, asking its citizens not to travel to India, which at that point of time was experiencing an unprecedented second wave of COVID-19. The Centre for Disease Control and Prevention (CDC) has now issued a Level 2 Travel Health Notice for India due to COVID-19, indicating a moderate level of COVID-19 in the country.



### INDIA EVACUATES STAFF FROM KABUL

**NEW DELHI:** India Tuesday brought back home the Indian ambassador and its staff at the embassy in Kabul in a military transport aircraft in view of the deteriorating security situation in the Afghan capital, two days after its takeover by the Taliban. The C-17 heavy-lift aircraft of the Indian Air Force (IAF) landed at Jamnagar in Gujarat at around 11:15 am en route to the Hindon airbase near the national capital. Indian Ambassador to Afghanistan Rudrendra Tandon said the situation in Kabul is complex and "quite fluid" now and that Indians stuck in the city will be brought back home when the commercial flight services resume.

## State's Covid-19 toll goes past 7K

**Bhubaneswar, August 17:** State's Covid-19 tally rose to 9,96,153 Tuesday as 720 more people, including 96 children, tested positive for the infection – the lowest daily spike in four months – while 68 fresh fatalities pushed the coronavirus death toll to 7,021, a health official said.

The daily test positivity rate, however, witnessed a slight increase to 1.41 per cent from 1.39 per cent Monday, he said. As many as 421 new cases were reported in quarantine centres, while 299 fresh infections were detected during contact tracing, the official said. Khurda district, under which state capital Bhubaneswar falls, recorded the highest number of new cases at 279, followed by Cuttack (91). Gajapati did not register any fresh infection, while 27 remaining districts reported less than 100 new cases each. Cuttack registered the highest number of fatalities at 14, followed by Angul and Jagatsinghpur (eight each) and Jajpur (seven). The state has 9,672 active cases, while 9,79,407 people have thus far recovered.

Odisha has tested over 1.71 crore samples for Covid-19 so far, including 50,727 Monday, he said, adding that the cumulative positivity rate stood at 5.81 per cent. The state has so far inoculated over 1.96 crore people, of whom 45.24 lakh have received both doses.

## SPCB No-1 in transparency index

**Bhubaneswar, August 17:** The State Pollution Control Board (SPCB) has been rated No-1 in transparency index rating done by the Center for Science and Environment (CSE), New Delhi. SPCB Member Secretary K Murugesan has informed Chief Secretary Suresh Chandra

Mahapatra about this during a meeting, sources said Tuesday. Congratulating the board, Mahapatra advised the officials to involve different stakeholders in environment management that would be helpful for the board in the enforcement of regulatory compliances for environmental governance.

Murugesan said CSE did the assessment as per the provisions made under the Water Act, Environment Protection Action Act and Waste Management Rules. The assessment focused on putting out data regarding continuous emission monitoring, consent to establish and operate,

public hearings for environmental clearance, show-cause notices, directions and closure notices, among others on public domain about 17 categories of industries, he said.

The rating was done on the basis of 18 parameters relating to these focus areas. The performance of all 31 State Pollution Control Boards and Pollution Control Committees operating in the country from 2016-2021 was taken into the assessment process.

The outcome of the assessment placed OSPCB at the top with 67 percentage points. Telangana Board scored at par with Odisha followed by Tamil Nadu and MP.

## Govt erects barricades in Kotia

**Pesky highhandedness of Andhra in Kotia has brought govt and Oppn parties in the state on a common platform. A spirited state govt has vowed to fight back the nagging misadventures of AP in border villages of Koraput. Better late than never**

**Koraput/Vizianagaram, August 17:** The state government has deployed police and erected barricades at disputed Kotia gram panchayat after the Andhra Pradesh administration attempted to launch



several schemes in the area claimed by both states. Andhra Pradesh said Odisha's action was in clear violation of the Supreme Court directive to both sides to maintain the status quo and said that the mat-

ter would be brought to the notice of the apex court.

The Koraput administration said Andhra Pradesh's Salur MLA Peedika Ranjan Dora had issued a press release stating that 500 peo-

ple from the southern state would enter Kotia to implement several programmes including laying the foundation for a few government buildings, distributing land patas (documents) and launching a plantation drive.

"These measures could have led to unrest in the area as MLAs of Koraput district were opposing those. So, the administration erected barricades and deployed adequate forces along the inter-state boundary on Monday to prevent the entry of officials and politicians from Andhra Pradesh," Koraput ADM Deben Kumar Pradhan said.

## Woman hacks father-in-law to death in Jajpur

**Jajpur, August 17:** A woman hacked her father-in-law to death at Ranpal village under Panikoili police limits in Jajpur district late Monday night. The deceased has been identified as Pabana Hati and the accused as Rupa Hati.

Preliminary investigations revealed that Rupa attacked and killed her father-in-law over some family issues.

Sources said Rupa, her husband and her father-in-law were working on a farmland, Monday. Rupa and her husband had an argument over some family issues. When her father-in-law intervened Rupa picked up a quarrel with him. In the evening, Rupa asked her husband to drop her at her parental home. When he refused, a bitter argument broke out between the two. Oblivious to the latest development, Pabana was playing the 'mrindanga', sitting on the verandah of their house.

He was caught unawares when Rupa attacked him with an axe. Rupa hit Pabana multiple times with the axe on his neck resulting in profuse bleeding. A severely wounded Pabana died on the spot, while Rupa fled the spot.

Panikoili police came to know about the incident Tuesday morning and reached the spot with a forensic team. They recovered the body and sent it for post-mortem.

## Afghanistan's illegal drug trade a boon for Taliban

**Afghanistan accounts for 80% of global opium and heroin supplies—a solid source of revenue for whoever controlled the country. The US spent big to choke this line, but failed. Now that Taliban is back in the saddle, it is likely to count on the country's opium and heroin trade**

**Washington, August 17:** The United States spent more than \$8 billion over 15 years on efforts to deprive the Taliban of their profits from Afghanistan's opium and heroin trade, from poppy eradication to airstrikes and raids on suspected labs. That strategy failed. As the United States wraps up its longest war, Afghanistan remains the world's biggest illicit opiate supplier and looks certain to remain

so as the Taliban is on the brink of taking power in Kabul, said current and former US and UN officials and experts.

Widespread destruction during the war, millions uprooted from their homes, foreign aid cuts, and losses of local spending by departed US-led foreign troops are fueling an economic and humanitarian crisis that is likely to leave many destitute Afghans dependent on the narcotics trade for survival. That dependence threatens to



bring more instability as the Taliban, other armed groups, ethnic warlords, and corrupt public officials vie for drug profits and power. Some UN and US officials worry Afghanistan's slide into chaos is creating conditions for

even higher illicit opiate production, a potential boon to the Taliban.

"The Taliban have counted on the Afghan opium trade as one of their main sources of income," Cesar Gudes, the head of the Kabul office of the UN Office of Drugs and

Crime (UNODC), told Reuters. "More production brings drugs with a cheaper and more attractive price, and therefore a wider accessibility."

With the insurgents entering Kabul Sunday, "these are the best moments in which these illicit groups tend to position themselves" to expand their business, Gudes said. The Taliban banned poppy growing in 2000 as they sought international legitimacy, but faced a popular backlash and later changed their stance, according to experts.

Despite the threats posed by Afghanistan's illicit drug business, experts noted, the United States and other nations rarely mention in public the need to address the

trade - estimated by the UNODC at more than 80% of global opium and heroin supplies.

"We've stood by on the sidelines and, unfortunately, allowed the Taliban to become probably the largest funded non-designated terrorist organization on the globe," said a US official with knowledge of Afghanistan's drug trade.

Afghan farmers weigh myriad factors in deciding how much poppy to plant. These range from annual precipitation and the price of wheat, the main alternative crop to poppy, to world opium and heroin prices.

Yet even during droughts and wheat shortages, when wheat prices rocket, Afghan farmers have grown poppy and extracted opium gum.

ACK was founded in 1967 by the legendary Anant Pai and the combined sales of its comic books are said to add up to more than 1.5 million copies in 20+ languages.

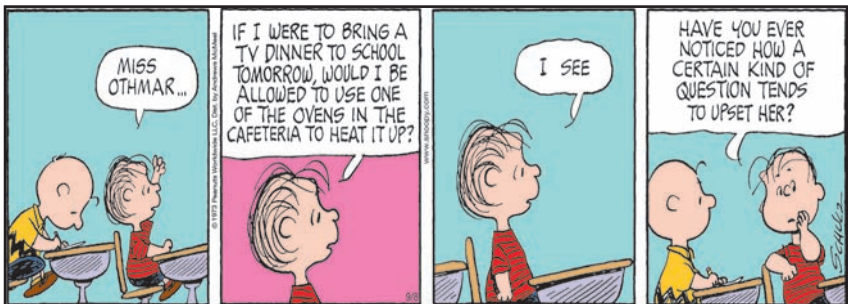

# Schedule for Plus III admissions out

**Bhubaneswar, August 17:** The Higher Education (HE) department Tuesday released the timeline for admissions to Plus III courses for 2021-22 academic session. The last date for applying online through the websites is September 4 (11:45pm). The first merit list would be published September 9. As per the timeline, students would deposit admission fees online through SAMS portal between

## Promotion for 63.5K teachers by Sept 30

**Bhubaneswar, August 17:** School and Mass Education (S&ME) department principal secretary Satyabrata Sahu Tuesday said more than 63,500 primary teachers of various levels will be promoted by September 30. Sahu said this while holding a review meeting with district education officers (DEOs) and district project coordinators (DPCs) here Tuesday. Sahu said that from now onwards the DEOs will look after the problems at Odisha Adarsh Vidyalayas in their respective districts and will act as per the department's direction. Sahu informed the meeting that more than 32,447 schools have been included under Mo School Abhiyan and more than 1,233 schools have undergone transformation. Under this initiative, the schools have smart classrooms, e-Library, laboratory and other modern infrastructure facilities. He said that by September 30 more than 63,500 primary teachers will be promoted in different categories. Sahu also directed the officers to prepare for the Odisha Secondary School Teacher Eligibility Test examination to be held September 1.

# Two arrested for duping realtor of ₹20 lakh in City

**Bhubaneswar, August 17:** The Commissionerate Police Tuesday claimed to have arrested two persons for duping a realtor of Rs 20 lakh on the pretext to help the latter to buy a plot in the city. The accused were identified as Ranjit Parida, 41, of Matha Sahi and Rasa Bihari Barik of Patna Sahi at Janla on the city outskirts, police said. According to sources, the accused duo had assured complainant Dharendra Kumar Patra of helping him

in arranging a large piece of land in the Capital city. They told Patra that one Arati Mishra was the owner of a plot at Nuagaon village on the outskirts of the city. They further told Patra that Mishra had legally authorised them to sell her plot valued at Rs 1.76 crore. Subsequently, Patra had signed an agreement with the duo November 11 last year. Patra had paid Rs 5 lakh as advance to the duo and requested them to provide the details of the land for verification. The duo pro-

vided some documents to the realtor and told him to pay another Rs 15 lakh which would be adjusted during the execution of the sale deed. However, the realtor later came to know that the duo had provided him some forged documents. Subsequently, the accused had agreed to return the amount received from Patra. But, they did not return the money to the complainant despite repeated requests. They also assaulted Patra when he went to their home to get back his money.

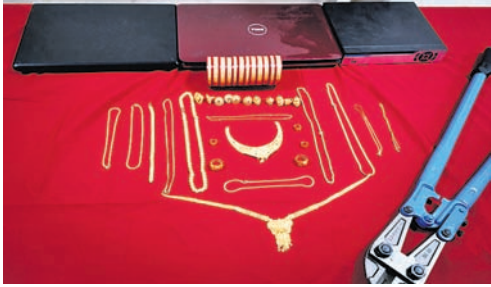

# Burglars' gang busted; 6 held

**Cuttack, August 17:** The Commissionerate Police Tuesday claimed to have busted a gang of notorious burglars with the arrest of four of its members and two others for buying stolen items from them here. The accused were identified as Prasant Palai alias Chotu, 23, of IB Road, Biswajit Sahu alias Lipu, 19, of Pradhan Sahi, Anil Kumar Behera alias Chiku, 26, of Ranihaat Sagadia Sahi, Guruba Marndi, 18, of Shanti Nagar in Jagatpur, Prasant Kumar Sahu alias Nilu, 55, of Mangalabag Nuapatna and Laxmidhar Tudu alias Jogi, 26, of Jagatpur Baikuntha Vihar. About the crackdown, additional deputy commissioner of police (DCP) Pramod Kumar Rath said that they zeroed in on the gang while investigating a burglary under Choudwar police limits here. Manoj Kumar Baral of Mangarajpur under Choudwar police limits here ap-

proached the police July 28 last alleging that they (Manoj and his family) were away for some family function July 27 when unknown miscreants made away with cash and jewellery after twisting open the door locks, the additional DCP said, adding that a case (322/21) was registered on the basis of Baral's complaint. Acting on a tip-off, the police managed to nab Chotu and Chiku, the gang's masterminds. "Following leads from the duo, we arrested Lipu and Guruba who confessed to have sold the booty to Nilu and Jogi.

Later, Nilu and Jogi were also taken into custody. Around 165 gram of gold jewellery, two laptops, a digital video recorder, a metal cutter and two two-wheelers were recovered from their possession," the additional DCP said. The senior police official said that while Chiku has at least 13 cases against him, Chotu has around nine cases in several police stations across the state. Last year, Chiku suffered injuries in a police encounter. Recently, he managed to walk out on bail. If required, they would be brought on remand for further investigation.

# SC warns states of penalty for failure to file affidavit

**New Delhi, August 17:** While hearing a suo motu case on safety of judges, the Supreme Court (SC) Tuesday warned the state governments that it would impose Rs 1 lakh penalty if the latter fail to file counter affidavits detailing measures taken for the protection of judges. A three-judge bench of the apex court headed by Chief Justice NV Ramana granted 10 days' time to the state governments and Bar Council of India to file counter affidavits in the matter. The apex court said that chief secretaries of the states would remain present during the hearing in case affidavits are not submitted. "Costs of Rs 1 lakh to be imposed on states who fail to file a counter affidavit within 10 days," the bench said. During the hearing, Solicitor General Tushar Mehta submitted that the Union Home Ministry issued guidelines for the safety of judges in 2007. According to the guidelines, the state governments have to create special units for safety of judges. The Solicitor General also argued that a national-level security force for protection of judges is not possible. Instead of creating a specialised police force, there is a need to ensure fuller implementation of guidelines issued by the Ministry of Home Affairs to the states.

The bench also comprising Justices Surya Kant and Aniruddha Bose observed that it is the responsibility of the Union government to ensure the implementation of these guidelines. "Question is whether these guidelines are followed or not for protection of judges, courts etc. Burden of implementing the guidelines is on the Supreme Court now. You are the Central government. You can call DGPs. You are the best person to get this done. States are now saying

they don't have funds for CCTVs etc. These issues you have to resolve," the bench observed. Significantly, the SC July 30 registered a suo motu case on safeguarding courts and ensuring protection and security of judges after the killing of District and Sessions Judge-8 of Dhanbad court in Jharkhand Uttam Anand. Anand was out on morning walk July 28 when he was mowed down by an auto-rickshaw at Randhir Verma Chowk near the district court in Sadar police station area.

## Pari case: SC tags SLP with writ petition

**New Delhi, August 17:** The Supreme Court (SC) Tuesday tagged a special leave petition filed by the father of a 5-year-old girl, who was allegedly kidnapped, raped and killed in July last year at Jadupur in Nayagarh, along with the writ petition filed by her mother seeking CBI enquiry into the matter. The apex court posted the matter for hearing to Monday. Earlier, the SC had asked the petitioner, the mother of the victim, to file a petition under Article 136 of the Constitution challenging the High Court order. A two-judge bench of the apex court comprising Justices AM Khanwilkar and Sanjiv Khanna had observed that the matter doesn't lie under Article 32 and asked the petitioner to file a special leave petition challenging the order of the Orissa High Court. Significantly, Pari's mother Saudamini Sahoo had filed a writ petition under Article 32 seeking directions to the CBI to investigate the death of her daughter at Jadupur in Nayagarh. The petitioner submitted that the preliminary investigation undertaken by the state police, the Crime Branch and SIT illustrates that all of them have made attempts to sabotage the investigation into the alleged incident and attempted all kinds of subversion tactics to influence the complainant and her relatives to discard the aforesaid allegations as false and frivolous. The petitioner also contended that the SIT has not investigated the role of local IIC, who was hand in glove with the accused and was shielding the real culprit.

# HC: Proof of active role must to prove abetment of suicide

New Delhi, August 17: Stressing that active role is required to hold a person liable for abetment of suicide, the Orissa High Court has granted bail to a person who was allegedly in a relationship with a woman died by suicide.

A single-judge bench of Justice SK Panigrahi held that the nature of evidence that has been forthcoming in the case does not meet the standards required to prove that the petitioner abetted the suicide.

“To hold a person liable for abetting suicide, active role is required which can be described as instigating or aiding in doing the thing,” the bench said.

Justice Panigrahi observed that in order to prove the accused abetted commission of offence, it has to be established that the accused by his acts or omission or by a continued course of conduct, created such circumstances that the deceased was left with no other option except to commit suicide.

“There is no answer as to why suicides occur because it is impossible to ever fully comprehend or analyze what goes on inside a person’s mind,” Justice Panigrahi said.

## HC seeks govt reply on Srimandir panel

Cuttack, August 17: The Orissa High Court Tuesday sought replies from the state government, Shree Jagannath Temple Administration chief and Puri Collector in connection with a case that had challenged the validity of Srimandir Managing Committee.

In its interim order, the single-judge bench of Justice CR Dash made it clear that the future of the temple managing committee will depend on the final verdict on the case.

The state government has recently reconstituted the Srimandir Managing Committee. Challenging the validity of the newly-constituted committee, Srimandir Khuntia Niyog president Krushna Chandra Khuntia had filed a case in the HC. The petitioner informed the HC that though Khuntia servants usually perform at least 19 rituals of the shrine daily, none of them has been included in the temple managing panel. However, members of some other Niyogs were included in the committee repeatedly.

## SIDBI, UIL set up silai school in Kendrapara

Bhubaneswar, August 17: Small Industries Development Bank of India (SIDBI), in partnership with Usha International Limited (UIL), launched the third phase of setting up of 750 Swavalamban Silai Schools in 20 districts of 10 states including one in Odisha. The third phase of the program has been flagged off from Kendrapara.

The initiative aims at empowering women by making them independent while pursuing entrepreneurship culture and evolve as ‘Homepreneurs’. Training on stitching along with maintenance and repairing of sewing machine is provided to aspiring women entrepreneurs by expert trainers of UIL.

The women, upon successful completion of the training program, are provided sewing machines, training kit and a Swavalamban Silai School signage board.

Sivasubramanian Ramann, Chairman and Managing Director, SIDBI said, “SIDBI is glad to announce that through this joint initiative, 1,700 Swavalamban Silai Schools have so far been set up in 24 districts across 7 states in the country. SIDBI has set a target to open 15,000 such schools across India. The initiative shall give fillip to the agenda of taking the current 20 per cent enterprises owned by women to at least 50 per cent.”

of Uttar Pradesh, wherein the apex court had ruled that the freedom of an individual cannot be curtailed for indefinite period, Justice Panigrahi held that some of these basic principles appear to have been lost sight of as a result of which more and more persons are being incarcerated for longer periods.

“An important facet of our criminal jurisprudence is that the grant of bail is the general rule and putting a person in jail or in a correction home (whichever expression one may wish to use) is an exception,” the SC had laid down.

## ‘Immunity level in kids up 50%’

Bhubaneswar, August 17: Odisha State Commission for Protection of Child Rights (OSPCPCR) Tuesday organised a panel discussion on impact of a probable third wave of the pandemic on children and the measures needed to ensure their safety.

On the occasion, OSCPCR chairperson Sandhyabati Pradhan said that safety of children during third wave must be the top priority for everyone and this discussion will be helpful in this regard.

Regional Medical Research Centre (RMRC) director Sanghamitra Pati said that in recent serological survey it was found that immunity

# Issue norms for erection of info boards: CS told

Bhubaneswar, August 17: The National Human Rights Commission (NHRC) has directed the state Chief Secretary to issue guidelines for the erection of information boards across the state, so as to prevent any mishaps causing death and injury to anyone.

The commission Monday issued the order while hearing a plea filed by human rights activist Dillip Kumar Das in connection with the death of a 13-year-old minor due to the collapse of an information pillar at Kodala block in Ganjam district March 7, 2018.

The Chief Secretary has been asked to submit his response in this regard within six weeks of the receipt of the order.

This apart, the commission has asked the Housing and Urban Development department to pay Rs 3 lakh as compensation to the family members of the deceased minor. The department has been asked to submit details regarding the same.

Notably two minors of Gola Sahi area climbed up an information pillar erected to show all the details regarding the reconstruction work

of RCC drain. The 4-feet-tall pillar was erected near a culvert, without plinth and any solid foundation.

That fateful day, the sudden collapse of the pillar caused death of one minor while seriously injuring the other.

The district Collector of Ganjam in its report to the NHRC confirmed to the aforesaid facts as well.

The commission observed, “From the perusal of report, it is apparent that the board was erected without taking any specification, construction, support and plan-

ning. It is accepted fact that there was scope for children to utilise the surface area available in the culvert for playing purpose and there was no plinth, durability and strength in the information board which led to this unfortunate incident and death of a child.”

“These facts reveal that there was negligence on part of officials while erection of information board by the NAC, Kodala Administration, and this act of negligence has violated human rights of the deceased victim for which the State Government is vicariously liable,” the commission added.

# Very heavy rainfall likely in state today

Bhubaneswar, August 17: The regional office of the India Meteorological Department (IMD) Tuesday warned that heavy to very heavy rainfall may be seen in different parts of the state Wednesday. The department said that very heavy rainfall could be seen in nine districts whereas 14 districts could witness heavy rainfall.

“Heavy to very heavy rainfall are very likely to occur Wednesday at one or two places over the districts of Ganjam, Nayagarh, Cuttack, Kandhamal, Malkangiri, Koraput, Jagatsinghpur, Mayurbhanj and Kendrapara,” the department said in its warning.

It also said, “Heavy rainfall is very likely to occur at one or two places over the districts of Khurda, Puri, Boudh, Jajpur, Bhadrak, Dhenkanal, Keonjhar, Rayagada, Gajapati, Balasore, Nuapada, Nabarangpur, Angul and Kalahandi.”

The department stated that the possibility of water logging Wednesday is high for Malkangiri in some places of low lying areas. The department warned of “pos-

CUTTACK: The Orissa High Court Tuesday granted anticipatory bail to the wife of former private secretary to Odisha Staff Selection Commission (OSSC) member in connection with a disproportionate assets (DA) case.

The Vigilance sleuths had arrested Biranchi Narayan Sahoo, the former private secretary to OSSC member, in connection with the DA case July 31 last.

Subsequently, Sahoo’s wife Sudhanshubala had moved the HC for anticipatory bail.

The court, however, directed Sudhanshubala to cooperate in the investigation.

The Vigilance sleuths had raided the residences of Sahoo and a few of his relatives in Bhubaneswar and Cuttack July 30 and seized properties worth crores of rupees.

Sahoo was also selling insurance policies under his wife’s name since 2009.

A special court in Bhubaneswar had earlier rejected Sahoo’s bail plea.

# Panel to probe sand mining at Brahmani: NGT

The panel will comprise members from the Ministry of Environment and Forest, Jajpur Collector, State Pollution Control Board and the State Environment Impact Assessment Authority

**Bhubaneswar, August 17:** The eastern bench of the National Green Tribunal (NGT) has issued a notice to the Jajpur district administration on allegations regarding illegal sand mining in Uttarprat Mouza in the district.

The NGT has also asked for formation of a joint committee to investigate the matter relating to illegal sand mining along Brahmani river in the region.

The tribunal in its written order, said, "Issued notice to the respondents returnable within four weeks. Considering the allegations made in the O.A., we deem it appropriate to constitute a committee to investigate the allegations made in respect of illegal sand mining in the district Jajpur, Odisha."

The panel will comprise members from the Ministry of Environment and Forest, Jajpur Collector, State Pollution Control Board and the State Environment Impact Assessment Authority (SEIAA).

The department claimed that the panel has to inform the NGT within one month about their observations based on their findings



at the ground level.

"The committee shall submit its report within one month with regard to illegal sand mining as alleged in the petition, damage caused to the environment; assess the environmental compensation and the penalty to be imposed against the respondent and persons who are involved in illegal sand mining as well as loss of revenue/royalty to the government exchequer due to excess

sand mining," the NGT order said.

The tribunal, in its interim order, asked the Jajpur Collector to ensure that the illegal mining activities are ceased. This comes after a petition was filed by one Alok Malik and others on the issue. The petition claimed that the local government had allegedly failed to curb the menace of illegal sand mining at Uttarprat Mouza under Dhamasala tehsil in the district along the Brahmani river.

It was further alleged that the actions of the erring miners there were in violation of the Standard Environment Clearance Conditions, Consent To Operate (CTO) Conditions, Sustainable Sand Mining Guideline 2016 and Enforcement and monitoring of sand Mining Guidelines 2020 and others.

The allegations related to the use of machines in sand mining (against norms), operations even during monsoon despite prohibition of the same, excess mining, non-maintenance of the daily mining register, no pillar demarcation of the leased areas and polluting local villages due to movement of uncovered trucks transporting collected sand and others.

# As spectre of drought looms large, Kalahandi farmers seek loan waiver

**Koksara, August 17:** Basic agricultural activities have been severely affected in various parts of Koksara block in Kalahandi district owing to deficit rain in July and the first half of August.

"As farmlands have no water, preparing the ground for paddy transplantation is yet to be started in our area," farmers lamented. They feared that they may see a drought-like situation this year owing to shortage of rainfall.

Though the Indravati mega lift irrigation point has been commissioned, not a drop of water is available from it to Podaguda panchayat. There is need for extension of the canal to this area, they added.

Apprehending the possibility of a drought-like situation, farmers have met Koksara tehsildar and submitted a memorandum, seeking fulfillment of some of their

demands.

"Initially, when it rained enough, farmers had started some work, but later rain played truant, leaving the farmlands dry. All agricultural activities have come to a standstill since then. Farmlands

have cracked for lack of sufficient rainfall," they pointed out.

As there are no signs of rain in coming days, farmers fear a spectre of drought in the region soon. Telltale signs of drought were found at several places where farmlands have cracked for want of rain. Farmers expressed concern over the scanty rainfall that has badly affected the farming activities. They demanded that the government should pay input subsidy to the affected farmers.

Their demands include loan waiver, electricity connection to deep bore wells and assessment of crop damage.

In some areas, several hectares have been left fallow. Farmers demanded that the state government should initiate welfare measures and damage assessment in the area. Hundreds of farmers led by local sarpanch submitted a memorandum to the tehsildar Tuesday.

## Disrespect to Tricolour at school

As per Constitutional norms, the Tricolour has to be 'un-hoisted' before sunset.

Seeing the flag fluttering on its mast, some villagers clicked pictures and uploaded it on various social media platforms.

Koksara block resource centre head, Tophan Majhi said that the matter has come to his notice. Talking to the media Tuesday, he promised disciplinary action against the teachers after probing the matter.

# Sundargarh admin launches e-Swasthya for rural people

**Sundargarh, August 17:** The district administration here launched three important public welfare programmes for the people with a focus on the rural healthcare.

Collector Nikhil Pavan Kalyan inaugurated the programmes at a special event organised on the occasion of Independence Day at Vikash Bhawan in Sundargarh.

Among the programmes, e-Swasthya is a major step towards providing preventive health check-up facilities free of cost to the urban as well as rural population. Similarly, block-level integrated physiotherapy and therapeutic unit for various modern therapies and safety kits for protection and well-being of workers were also launched.

Meanwhile, a special nutrition programme for young children completed one year. Under it, kids are distributed ragi laddu mix and spirulina-fortified chiki and sugar through the Anganwadi centres. The initiatives are supported by the District Mineral Foundation (DMF).

This special nutrition programme has turned out to be beneficial in preventing malnutrition among small children and usher in overall growth in them.

The e-Swasthya and physiotherapy services are expected to be immensely useful to the people of Sundargarh.

These new initiatives launched by the district administration will provide various health facilities free of cost to the people in rural areas through the community health centres and public health centres, informed Collector Nikhil Pavan Kalyan.

The e-Swasthya initiative is a



comprehensive diagnostic test package where residents can now get various tests free under the programme. The beneficiaries can avail over 76 types of test reports from a single sample, including record of vitals.

Lab-in-the-bag, an advanced mobile lab facility introduced under this programme, is available at 12 CHCs across the district. Moreover, sample collection points have been set up in various locations of the district to connect people with the services.

Digitisation of the 'Matrujyoti' data under e-Swasthya will now help the system to record and access the health history of pregnant women digitally. The database will be operated through Web portal and mobile applications, which was launched on the occasion.

With the implementation of Integrated Physiotherapy and Therapeutics unit, rural people from over 150 villages under 11 blocks will benefit from this free service.

The district administration provides a special kit to protect workers of mines, factories, construction and other sectors. The kit containing shoes and socks, goggles, helmet, hand gloves, gum boots,

special mask to protect from dust, safety harness, jacket, first-aid kits, rain coat and other essential equipments, was also launched on this occasion. **Chhatrapur, August 17:** At the same time as the state government has taken up a host of measures to financially empower women and make them self-reliant through the Odisha Livelihood Mission and Mission Shakti, many women in Ganjam district have scripted success in flower farming and set an example for others, a report said.

Apart from flower cultivation, they have been earning from other activities like mushroom farming, pisciculture, poultry and satttu preparation. Some of them are also earning from collection of electricity bills from consumers.

However, flower cultivation has earned them accolades from various quarters and the government as well. According to reports, scores of

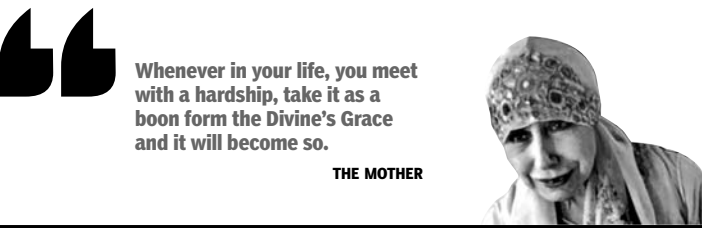

# Fall of Kabul

The world has been shocked and numbed to see the spectacle of a humanitarian crisis of huge magnitude unfolding in Afghanistan that became the starkest reality minutes after the Taliban brandishing weapons and their firepower entered Kabul August 16 morning. It was funny, to say the least, how the Afghan government forces just melted away into thin air as the Taliban leaders and foot soldiers took possession of the country, province by province, till they reached the capital Kabul and eventually the presidential palace without the slightest of resistance. Video footage went viral showing Taliban soldiers enjoying the comfort and food inside.

On the other side of the world, in Washington DC, President Joe Biden held a press conference and unequivocally stated that he stood 'squarely' behind his decision of withdrawal of American combat forces from Afghanistan. He did not forget to mention that the 20 long years of engagement of American and NATO forces in Afghanistan had been the longest war fought in recent American history. He reminded his voters about his pledge during his presidential campaign in 2020 that he would withdraw American troops from Afghanistan if elected. His predecessor Donald Trump was the third president to have presided over the Afghan war and was instrumental in starting a dialogue with the Taliban, keeping bringing back US forces home as the top agenda. When Biden spoke, he reminded not only Americans but also his allies that the US had entered Afghanistan not for a nation building experiment. The world knows that the US had been excessively violent in its reactions against the Al-Qaeda which claimed responsibility for the 9/11 attacks on the World Trade Centre in New York City and the Pentagon in Washington DC. It was obvious that the attack on Afghanistan and the de-throning of the Taliban government was a pure act of revenge and reprisal. To expect Americans to have stayed on even longer, after two decades and trillions of dollars spent and thousands of Americans dead is definitely expecting too much from any country.

Biden's decision cannot be faulted if one observes the manner in which the Afghan politicians and especially former President Ashraf Ghani fled the country with tons of cash and how the armed forces capitulated without firing a single shot. A nation which is not committed to protecting itself will never be ready to face enemies within and without. The financial and social corruption that had set in among the government and armed forces of Afghanistan under the protection of American cover was evident at how quickly they caved in and deserted ranks. It seems like the Afghan men were not concerned about the security and future of their own womenfolk. The Taliban rule will probably bring in a dark era for the common citizens of Afghanistan, especially young girls and women.

On the other hand, the success of Taliban will bolster other Islamist extremist organizations worldwide which will look up at this victory as an indication of changing times. Apart from the West, countries neighboring Afghanistan will now have a lot to worry about. It can be a lesson to all corrupt societies that they can no longer depend on their armies alone to protect them. Afghanistan has demonstrated that in spite of modern equipment, arms, ammunition, helicopters and plenty of funding, the armed forces will be as strong or weak as the government and society that is behind them.

### ■ Ostrobogulous

The word is weird not only because it looks strange and is rather rare but because it can refer to something weird (or a strange, bizarre or generally unusual happening). To increase its peculiarity, it can also mean something mildly risqué, indecent or pornographic. “*Ostrobogulous*” was Vickybird’s favourite word. It stood for anything from the bawdy to the slightly off-colour. Any double entendre that might otherwise have escaped his audience was prefaced by, “if you will pardon the ostrobogulosity” (*Magic my Youth*, by Arthur Calder-Marshall, 1951). It was coined by Victor Neuburg (Vickybird in the quotation), a gay British Jewish poet and writer and a close friend of the occultist Aleister Crowley, whose sexual magic practices he helped develop. Neuburg said that the word was formed, highly irregularly as you might expect, from Greek ostro, rich, plus English bog, dirt, from the schoolboy slang sense of the toilet, and ending in Latin ulus, full of. So “full of rich dirt”. The Oxford English Dictionary doesn’t agree, arguing that the first part is from the adjective oestrous. But we ought to let Victor Neuburg have the last word, as it was his creation, even though he was a bit shaky on his etymology — the Greek word was ostreon, a type of mollusc (it’s the source, via Latin, of English oyster) that was harvested to obtain a rare and expensive purple dye, hence figuratively something rich. Another meaning of ostrobogulous turns up occasionally. *I started out making toys because it was something I could do with no money, an artistic family and a Victorian sewing machine. In the evenings I made “ostrobogulous” toys, a term my mother used to mean harmlessly mischievous, and sold them in Heal’s, where I worked by day (The Times, 8 Nov. 2003).* This matches a sense known to reader Graham Hill: “When I was at secondary school in the late 1960s ostrobogulous was used as an alternative name for a gonk.” (For those too young to remember, or who live in a country in which they never caught on, a gonk was a small furry soft toy, popular at the time.)

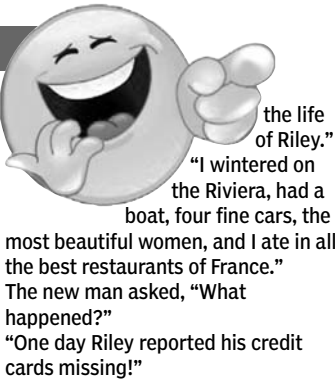

BEST KEPT SECRET

A t a time when India is commemorating the 125th birth anniversary of Netaji Subhas Chandra Bose, and his passing away is still shrouded in mystery, it is worth a while to revisit a seminal work, *Verdict from Formosa: Gallant End of Netaji Subhas Chandra Bose*, authored by Harin Shah, a veteran journalist who visited Taiwan, then called Formosa, one year after the tragic plane crash in which Netaji was believed to have died 18 August 1945. The book was published in 1956, and this article is based on the book, which the author claims was “the eyewitness account from the crash to cremation collected on the spot in Formosa.” The book has a foreword from Dr Harekrushna Mahatab, then Governor of Bombay.

Shah writes in his book that he was “the only Indian having had the good fortune to visit Formosa after the end of the war” and “the bearer of conclusive eyewitness collected in Formosa, checked with Netaji’s co-victim in the air crash Col. Habibur Rehman and upheld by leaders like Sardar Vallabhbhai Patel.” He opines that “Netaji Subhas Chandra Bose embraced heroic martyrdom at Taipei.” Although a number of books have been written about the mystery surrounding the disappearance and passing away of Netaji and also a number of enquiry commissions appointed by the government have submitted their reports, Shah’s book is arguably the earliest one based on interviews with informed and knowledgeable people in Taiwan.

The author takes the readers to the hoary era of Asian resurgence during and after the Second World War when leaders like Chiang Kai-shek, Aung San and Dr Sukarno dominated the emerging Asian firmament. The misrule of KMT and misreading of the ground situation by the US contributed to the failure of the KMT in assuming power in China. In early 1946, Harin Shah was at Nanking, the headquarters of the KMT regime in China, heading the Free Press of India News Service launched by Sadanand. From there, he flew to Taipei (now Taipei) via Shanghai along with a battery of foreign correspondents. As unravelling the mystery of Netaji’s disappearance was his

main objective, he talked to a cross section of people about this immediately after his arrival in Taipei 30 August 1946. Shah was pleasantly surprised that the first question they shot at him was about ‘Chand la Bose’, and voluntarily added that they knew he had died in Taipei. He talked to a cross section of intelligentsia in Taipei who were knowledgeable about Netaji. Shah was gratified to find that some of the Formosan newspaper friends had genuinely undertaken to piece together available evidence about Netaji’s death in the plane crash.

Shah discussed the issue with as many people as possible while in Formosa. An important personality whom he met in Formosa and who threw light on Netaji’s life and times there was Prof KS Wei of Taipei University. Culling out from the notes in his diary after meeting Prof Wei, Shah writes in his book attributing to the former, “... he died in August 1945... News published in Formosa papers... But no photos... He came by a bomber. Bomber was taking off. Gasoline tank leaked. He died in Japanese hospital... He was very brave. I was not in Taihoku at the time of his death. Whenever any accident occurred at the airport, Japanese used to cordon off. So probably, no eyewitness except Japanese military officers... I shall ask my friends to find out more...”

Prof Wei meant his words and sent across a book written in Japanese through Ms. Noliko, the hotel attendant for Shah’s room. The Professor’s covering letter, scribbled on the blank back page of the contents in the book, said, “... please find page 107 of this book... That will give you some information. Yesterday, I called on a Japanese Professor of Taipei University, who was with the Japanese Military Headquarters as an interpreter when Bose’s death was made known. The exact date was August 1945, 19 at 1.30a.m.” The name of the Japanese book was *20 years of Pacific Hurricane*. It mentioned the death through air crash at Taipei.

Yet one more inference that Shah drew was from Dr Lee wan-chu, who was the editor of the Chinese-language newspaper *Shin Sheng Jir Pao*, published from Taipei. Dr Lee wan-chu was also the Deputy Chairman of the Provincial Assembly of Formosa. Dr Lee personally went through the files in his office of the closed-down Japanese newspaper *Taiwan Nichi Nichi Shimbun*, published from Taipei and found the 22 August, 1945 edition of the newspaper carrying an official press-note on Netaji’s death through plane crash at Taipei. Dr Lee gave a copy of the original Japanese newspaper carrying the news. It said, “A press-note issued at 2 pm

on 22nd inst. (August 1945) by the Intelligence Bureau of the Japanese Garrison Commander, Taihoku, states that Chandra Bose, Leader of the Provisional Government of Free India set out on a plane from Singapore on 16th August en-route Tokyo. He was proceeding to Tokyo to discuss with the Imperial Government. At 14 hours on 18th, the plane met with an accident in the vicinity of Taihoku airfield and Chandra Bose was heavily wounded.”

The news further said, “Although he was given treatment at the ‘South Gate’ Military Hospital, it proved of no avail, and he passed away on 19th August at zero hour.” Shah visited the South Gate Military Hospital which was under Japanese control at the time of the crash. With the cooperation of the Chinese Head of the Hospital Col. Wu Kuo Hsing, Shah could meet sister Tsan Pi Sha who was working with the military hospital from the Japanese time. She dropped a bombshell, to quote the author, when she said, “He (Netaji) died here. I was by his side.” She further told Shah that Netaji had received injuries from burning. “He was burnt as a result of the crash which took place at the Taihoku airfield just before he was brought to the hospital. It was about the noon time August 18, 1945 that he was brought to the hospital. He was very severely burnt. He died the same night at 11,” she added. Shah also met Japanese people and ascertained vital facts. One such person was Dr Kunio Kawaishi, then Professor of Surgery at the University Hospital in Taipei. When Netaji arrived on his last trip to Formosa, Dr Kunio was the Director of the University Hospital. Dr Kunio believed that Netaji probably died at the airport itself, so serious was the burning injury.

The book has so many startling revelations which only an authentic and objective investigation can confirm or contradict or one does not know if the mystery of Netaji’s death will remain a best kept secret.

In my next life, I want to be farmer. Farming is hard work, with no guarantee of making a good living, but let me tell you something from personal experience: there is something magical about sowing seeds, watching them germinate and eventually harvesting something that looks somewhat like food.

Whether it looks like food or not depends partly on your gardening skills, as well as your ability to keep pests away. But here’s something I can assure you: no vegetable will taste better on your plate than a vegetable you grew yourself.

I know this because I get immense pleasure from the small vegetable garden behind my home. This year, I’m *trying* to grow lettuce, coriander, basil, tomatoes, cucumber, chili peppers, brinjal, zucchini and watermelon.

I use the word ‘trying,’ because I haven’t been successful with a few of these vegetables or herbs. My lettuce plants look so miserable,

even the rabbits have taken pity on them. “Oh, you poor things,” they say. “We’ll be praying for you at church this Sunday.”

My coriander plants are just as pitiful. They’re growing so slowly, they must be missing some important nutrients. Should I pour a glass of Horlicks on them? Maybe Boost will do the trick, or perhaps Complan.

Most of my other plants are doing fairly well. The brinjal plant has grown quite big and healthy. And who knows, one of these days it may decide to produce an actual brinjal. Perhaps I need to talk to it. According to a British study, plants respond favourably to low levels of vibrations from our voices. This means that you should always speak nicely to your plants. Even if they’ve done something naughty, like dropped all their leaves in public, you should never yell at them.

While I sometimes have the urge to scold a few of my plants, the watermelon plant isn’t one of them.

This is the first time I’ve tried to grow watermelon, so I was quite excited when the vine produced its first fruit: a tiny watermelon that is now the size of a golf ball. I’ll be watching it closely over the next few weeks, hoping it grows as large as a beach ball. If the plant produces a few more watermelons, I might invite some friends over for a special watermelon party. I’ll get them all to sit around my garden and admire my watermelons.

“I grew those myself,” I will tell them, as I serve them some store-bought watermelon.

“Aren’t we going to eat any of yours?” one of my friends may ask.

“Oh no,” I’ll say. “They’re not for eating. They’re just for admiring.”

This is exactly how I felt about one of the tomatoes I grew last year: This tomato was huge—twice as large as any other tomato I grew. It was the Giannis Antetokounmpo of tomatoes. Giannis, a 6-foot-11 forward from Greece, is a two-time MVP (Most Valuable Player) in

the National Basketball Association. If all the tomatoes got together and formed their own professional league, mine would undoubtedly be the MVT (Most Valuable Tomato).

I admired my tomato for a couple of weeks—while it was still green on the vine and after it turned red. I took photos of it: portrait shots of the tomato by itself and group shots of the tomato with its fellow tomatoes, while trying unsuccessfully to get them to smile. I debated whether I should create a Facebook page for my tomato. What about Instagram and Twitter? But I decided not to do so, because I did not want other gardeners to start following my tomato. I didn’t want them to get too envious.

Other gardeners may not be able to grow a tomato as big as mine, but that doesn’t mean they should hang their heads in shame. After all, their lettuce plants probably look much healthier than mine, and their brinjal plants are probably producing actual brinjals.

**Paralakhemundi, August 17:** In a major development in the death case of Paralakhemundi assistant conservator of forest (ACF) Soumya Ranjan Mohapatra, a watchman Tuesday revealed that the District Collector of Gajapati had visited the official quarters of the divisional forest officer when the former died

in a fire mishap on that day. The watchman, Santosh Biswal, deployed at the main gate of the Divisional Forest Officer (DFO)'s quarters, said the district Collector visited the DFO's quarters at around 8 pm on the fateful day. The Crime Branch team interrogated six persons in two phases, Tuesday. The team got some vital leads during the interrogation. The district Collector

had visited the DFO's quarters when the deceased Soumya Ranjan Mohapatra sustained critical burn injuries in a fire mishap. Biswal, whose statement was recorded for about four hours Tuesday by the Crime Branch team, said the Collector was even present when ACF Soumya Ranjan was rescued with critical burn injuries and shifted to a hospital. After the shocking revelation by the watchman, Crime Branch DSP Gyana Ranjan Mishra said, if needed, the allegations will be probed. The Crime Branch team interrogated the watchman at the main gate of DFO's quarters and a gardener Ajay Kumar Behera in the same quarters for around four hours. "The entire investigation now focuses around the incident which happened on the fateful night. We are questioning everyone associated with the case about the circumstances on that night," Mishra said.

# Farmers sore over black marketing of fertilizers

**Malkangiri, August 17:** At a time when Covid-induced restrictions have affected all activities, black-marketing of fertilizers and its short supply have added to the woes of the farming community, especially the tribal populace of Siadimal, in Malkangiri. Taking advantage of short supply of fertilizers, some unscrupulous traders are exploiting these farmers.



Local famers said that the district administration and the Agriculture department should conduct raids on dealers and traders resorting to black marketing of fertilizers in the district.

Like in previous years, farmers in many parts of the district have been facing difficulties in availing fertilizers amid allegation of black marketing.

At this time, paddy farmers require urea and other fertilizers for agriculture. "Urea is not available with the dealers and the primary agricultural co-operative societies sufficiently. Some dealers are deliberately creating artificial shortages of fertilizers," farmers alleged.

# Juanga village far from development

*Despite huge amounts being sanctioned for the development of tribal villages, Gudinarda in Keonjhar remains far from development – thanks to apathy of officials*

**Keonjhar, August 17:** Though crores of rupees are being pumped into a host of schemes and welfare measure for tribal people, many tribal villages in Keonjhar are far from development. Gudinarda is a Juanga-dominated village tucked away in the hilly terrains of Talapada panchayat under Telkoi block. It is among the villages that has been a victim of government apathy.

This village was once a hotbed of Maoists. However, given the sorry state of the villages and its Juanga residents, it is apparent that development has certainly taken a back seat in this tribal village.

As there is no provision of safe drinking water, the tribals have to feed on water from pits or streams.

"The sarpanch hails from our village, but it is an irony that the village development has been given a short shrift. There is no proper road to the village while people walk miles to get rations and pension from the panchayat office,"

locals said.

The panchayat office is 10 km from the village. Elderly people are unable to trek to such a long distance to get their entitlements.

As the village road is in bad shape, emergency services are not available to the villagers. "Access of ambulance and fire tenders to the village is almost impossible. Those who have visited the village once will never want to revisit it," lamented Birabar Nayak, a social activist.

In 2016, 35 families received housing units under Indira Awas Yojana,

but most of these houses are left at different stages of construction. "Many have not received housing benefits. They are compelled to

live in misery, enduring the sun and rain. Contractors have left the work halfway," laments Sabitri Juanga, sarpanch.

"Though we have appraised the panchayat and the block authorities of the problems faced by the villagers in the past, no step has been taken to redress them," she added.

There is special provision of development plans in the villages under Forest Rights Act. Under this Act, 13 types of development and welfare activities can be taken up for the tribals – such as Anganwadi centres, school buildings, road connectivity, drinking water, solar-powered lighting systems and irrigation, the sarpanch said.

The gram sabha, on behalf of panchayat, will decide on project proposals. The BDO is supposed to send the proposals through the range officer to the DFO. On his part, the DFO sends the proposals to the Collector for approval. Then, the Collector decides how the works will be undertaken, explained Ananda Charan Sethi, another social activist.

# GANJA TRADE: 3 RAJ MEN HELD

**Koraput, August 17:** In a major success, Koraput police seized over one quintal of ganja from an SUV near Tikaput Chowk in the district Tuesday. Three persons, identified as Mohammad Azharuddin, Jitendra Singh and Bantesh Kumar, have been arrested in this connection. It was learnt that all of them are natives of Rajasthan.

Acting on a tip-off, a joint team of Jalaput and Lamataput police carried out a raid at the Tikaput Chowk area. During the raid, the cops intercepted an SUV and following a thorough search, they found 108 kilograms of ganja concealed in the vehicle. When the occupants of the vehicle failed to produce any valid documents in support of possessing such huge quantity of cannabis, they were arrested. Four mobile phones were seized and a case under NDPS Act was registered against them.

The consignment was being smuggled from Jalaput area to Rajasthan. The cops have launched an investigation into the case.

# 20 yrs on, sexagenarian waits for a pucca house

**Kesinga, August 17:** 'Patience is bitter, but its fruit is sweet.' This time-tested adage does not seem to hold any sense for a wizened Chatur Majhi. The 60-year-old resident of a village in Kesinga block of Kalahandi district has been waiting for over two decades now to get a pucca house under any 'awas yojana'.

Chatur's family is presently living in a shack with four mud walls and a thatched roof covered by a polythene sheet.

A resident of Guhriapadar village of Kikia gram panchayat, Chatur's family comprises five members – his wife, three sons and himself.

His first and second sons are married and are staying in another house nearby due to shortage of space. Chatur, his wife and his younger son are living a wretched



life in the shack. Their sufferings multiply in their rainy season.

While the roof leaks during rainy season, rain water seeps through the mud walls and the floor becomes damp. They somehow spend the daytime, but at night they are left with no option but to sleep on the wet ground.

For a pucca house, Chatur has been doing rounds of Kikia panchayat office since last 20 years but has not got joy as yet.

"If only a polythene sheet is

given, my family can at least sleep well," said a wizened Chatur.

There are ten other people in the village whose names are in the SC beneficiary list. Like Chatur, they are also waiting for fortune to smile on them.

According to local residents, Kikia gram panchayat sarpanch is allegedly saying that he will not award pucca houses to any beneficiary of Guhriapadar village in the next five years because they did not vote for him in the last election.

When contacted, Kikia gram panchayat executive officer (PEO) Subhranshu Mishra said there are many genuine beneficiaries in Guhriapadar village. "As many as 220 beneficiaries had applied for pucca houses in February 2020. But, we are yet to start the survey as we have not received any direction from the government in this regard," he added.

# Drug trade increasing in Bargarh district

**Bargarh, August 17:** Absence of proper supervision by the police and Excise department in dealing with drugs and contraband items is evident in Atabira, Bhetada, Rusuda, and Godabhaga localities in Bargarh district. The lure of quick money is attracting youths into this illegal trade giving rise to law and order problems in the district. On both sides of State Highway-54 and National Highway-53 a number of illegal eateries (dhabas) have sprung up. They have turned into safe haven for selling foreign and local liquor as well as drugs. Most of these dhabas have employed underage kids who work and also supply drugs and liquor to interested customers. Locals have blamed the police and Excise department for the flourishing drug trade in the region. They alleged that instead of ar-



resting the kingpins of drug trade, only small fries are being targeted. This has helped the contraband business to grow over time. They also alleged that officials regularly visit the eateries to collect their share of 'payments'. In case they do not get the payment on time, the conduct raids on the dhabas. Protesting against such nefarious activities, local residents have written to the SPs of Baragarh and Sambalpur towns. When asked to comment on the issue, police said that an investigation has been launched and the culprits will be punished soon.

# Freedom Fighters' Museum cries for attention

**Sambalpur, August 17:** Freedom fighters were remembered on the occasion of 75th Independence Day celebrations across the nation, Sunday. However, freedom fighters are yet to get due regard in western Odisha.

For instance, the western Odisha Freedom Fighters' Memorial Hall and Museum at Gourisankar Sahani Park in the city is in a dilapidated state due to lack of maintenance.

With an objective to glorify the role of western Odisha in the freedom struggle and to make the present generation aware about the freedom fighters from this region, the memorial and museum was set up and a park was developed to contribute to the beauty of the building, spending a whopping ₹3.5 crore.

When it was announced that the memorial and museum was coming up, people welcomed it, hoping it will go a long way in informing



the youths about the freedom fighters of western Odisha of the like of Veer Surendra Sai, Nrusingha Guru, Bhagirathi Pattanaik and Chandra Sekhar Behera and their sacrifices. Many of them went to jail and kissed the gallows.

Spread over 1.28 acres, the memorial hall and museum was in-

augurated by Chief Minister Naveen Patnaik February 27, 2016. There is a 20 feet high pillar in front of the two-storied building in memory of the martyrs. As per plan, portraits of freedom fighters with brief history about them were supposed to be installed in the museum. Besides this, it was sup-

posed to have the articles they used so that the visitors, particularly those belonging to the present generation, are aware of the freedom fighters from the region.

Five years have passed since the inauguration of the museum, but it continues to remain locked, triggering resentment among local people.

The building has nothing but a sign board to inform people that it is memorial hall and museum. There is nothing inside the mu-

seum – not even a single portrait of a freedom fighter.

Since the building is lying unused and neglected for long, anti-social elements are using it as their favourite haunting ground. With no one there to guard the building, electrical equipment and other articles are also missing, resulting in the building losing its beauty. While the outer walls of the building have a thick layer of dust, liquor bottles, used plastic glasses, empty guthka sachets and piles of garbage are piled on the premises. The memorial pillar is also covered with grass and bush.

It is learnt that the administration is just wriggling out of its responsibilities attributing the present condition of the building to shortage of staff. Residents of the town residents condemned the way the administration is trying to shuffle off its responsibilities. They have urged the administration to take steps for early opening of the memorial hall and museum and maintain it properly.



# UP Law Commission submits draft population control Bill

BJP-RULED UTTAR PRADESH'S MOVE FOR A POPULATION CONTROL LAW HAS REIGNITED THE DEBATE ON THE ISSUE IN THE COUNTRY

**Lucknow, August 17:** The Uttar Pradesh State Law Commission has submitted to Chief Minister Yogi Adityanath the draft population control bill and made a slew of recommendations, including additional incentives to public servants for adopting the one-child norm and banning those who violate the two-child policy from contesting local bodies' polls.

The recommendations were made in the 19th report on Population Control, Stabilisation and Welfare which, along with the draft of The Uttar Pradesh Population Control, Stabilisation and Welfare Bill, 2021, was handed over by Uttar Pradesh Law Commission chairperson Justice (ret'd) AN Mittal to the chief minister.

However, it is still unclear whether the Bill will be tabled in the current Monsoon session of the state legislature.

Brijesh Pathak refused to comment on this issue.

According to the salient features of the report, the Commission recommended that a specific card should be issued to the person adopting two-child or one-child norm that should be valid proof to obtain the incentives so that the beneficiary is not required to run from pillar to post to prove eligibility

Specific law should be enacted regarding control and stabilisation of population in Uttar Pradesh, the report said, adding that the proposed legislation should have an overriding effect on other laws that are in force in the state.

It is also proposed that the subject of population control be included in the school curriculum so that proper education, as well as guidance, may be provided at the school age.

The success of any policy depends upon incentives and disincentives. Therefore, to control the population certain incentives to public servants who adopt the two-child norm and additional incentives to those who adopt the one-child policy should be provided, according to the report.

Special benefits should be provided to married couples having only one child in the shape of a one-time lump sum amount as may be notified by the state government, it said.

There should also be a provision for revocation of benefits and disincentives for those who do not follow the two-child norm.

There should be a provision for bar on contesting election to local bodies on who-so-ever breaches the two-child norm or has children in excess of the two-child norm and they shall be ineligible for being chosen as, or for being a member of any elective office under any local authority or public corporation, according to the report.

In the proposed law, various incentives and disincentives and bars are being provided, which may be in contravention of some laws in force in Uttar Pradesh. Therefore, in the opinion of the Commission, the provisions of this proposed law should have an overriding effect, the report said.

# 41 KERALALITES STRANDED IN KABUL

STATE GOVT SEEKS CENTRE'S INTERVENTION FOR THEIR SAFE EVACUATION

**Thiruvananthapuram, August 17:** The Kerala government Tuesday said at least 41 Malayalis including women and children have been stranded in Taliban-controlled Kabul and requested the Centre to make necessary arrangements for their safe evacuation to the home country.

In the wake of panic calls from the stranded people received at the Department of NORKA, the state-run welfare agency of non-resident Keralites, the government sent letters to the External Affairs Ministry seeking immediate steps for their repatriation.

As directed by Chief Minister Pinarayi Vijayan, K Elangovan,



Principal Secretary to the state government and Harikrishnan Nambuthiri K, the CEO of the NORKA, sent separate letters to the Ministry detailing the plight of

the stranded Keralites there.

An estimated 41 Malayalis including women and children working in various companies have requested the government to arrange

for their safe evacuation immediately to India, Elangovan said in the letter. Some of the messages received by the state government even stated that the Taliban were verifying the identity of the stranded Indians and taking away their passports and other important documents, he said. The letter also said that a huge threat is hanging on the life of the Malayalis.

Earlier, Nambuthiri contacted some of the stranded Malayalis in Kabul and said steps were on to trace whether more Keralites were trapped in the Afghanistan capital. The NORKA has already passed the information they received to the External Affairs Ministry, government sources added.

# With 23 lakh jabs a day, UP keeps adding records

**Lucknow, August 17:** Uttar Pradesh administered 23 lakh doses of Covid-19 vaccine to people across the state in a single day, creating a record of sorts, officials said Tuesday.

After 29.52 lakh doses August 3, this is the second highest number of vaccinations undertaken in the state in a single day Monday, officials said. With this, Uttar Pradesh became the first state to have more than five crore people who have taken at least one dose of the Covid-19 vaccine.

As per CoWin portal update till 11 pm Monday, as many as 23,01,031 doses of the vaccine were administered in the state on the day taking the total number of doses to 5.97 crore. In Maharashtra, Uttar Pradesh's nearest contender, 5.01 crore doses have been administered so far.

Officials at the state health department claimed that nearly 35 per cent of the total eligible population of 14 crore has now taken at least one dose.

Among districts, Lucknow (23.12 lakh) tops the list of total doses administered while Chitrakoot (2.95 lakh) ranks lowest.



Gautam Buddha Nagar, Ghaziabad, Meerut and Gorakhpur are districts where more than 15 lakh doses have been given.

Uttar Pradesh also recorded its lowest ever case of Covid-19 in the past 16 months.

Additional Chief Secretary (Health) Amit Mohan Prasad said only 17 persons have tested positive in the past 24 hours while 36 persons recovered from the infection in the same duration.

The official bulletin indicated that the 17 cases were reported from 13 districts while 45 districts saw no new entry.

The daily Covid test positivity rate (TPR) - the number of positive cases against the total tests done - came down to 0.01 percent, the lowest in the country.

# Now, plans to rename Aligarh, Mainpuri

Zila panchayat members of Aligarh claimed that it was a long pending demand

**Aligarh, August 17:** After Firozabad, it is now the zila panchayat of Aligarh that has passed a resolution seeking to rename Aligarh as Harigarh.

The resolution was passed Monday and the members claimed that it was a long pending demand.

The proposal was passed in the first meeting of the panchayat without any opposition with 50 out of 72 members in attendance.

Vijay Singh, zila panchayat chairman for Aligarh, said, "It was a long pending demand to rename Aligarh as Harigarh."

The zila panchayat approved the proposal unopposed. It would now be forwarded to the state government for approval.

Earlier, the local BJP leaders had passed a proposal to name the Aligarh airport after BJP leader Kalyan Singh.

Kalyan Singh is a resident of Aligarh and was the Chief Minister of Uttar Pradesh during the Ram Janambhoomi movement.

In Mainpuri Monday, the zila panchayat passed a resolution, seeking to rename Mainpuri as Mayan Nagar after sage Mayan who founded



the present day Mainpuri.

One of the zila panchayat members had moved the proposal for renaming Mainpuri as Mayan Nagar and the proposal was passed Monday with 23 members supporting the motion and two opposing it, said Archana Bhadoria, zila panchayat chairperson of Mainpuri.

Mainpuri is the stronghold of Samajwadi Party (SP) patriarch Mulayam Singh Yadav, who won five elections from the constituency.

Earlier this month, the Firozabad district panchayat had passed a resolution demanding that Firozabad be renamed as

Chandra Nagar. Locals believed that King Chandrasen lived in Firozabad and because of this it was earlier known as Chandravat Nagar till about 1560 AD.

Later, a representative of Emperor Akbar, Firoz Shah, visited the area and the place was named after him as Firozabad. The demand to rename Firozabad as Chandra Nagar has been raised time and again, said a local BJP leader.

The Yogi Adityanath government has already changed the name of Allahabad to Prayagraj, Faizabad to Ayodhya and Mughalsarai to Deen Dayal Upadhyaya Nagar.

# BJP slams Covid-19 mgmt, law & order situation in Kerala

**Kozhikode, August 17:** BJP National President JP Nadda Tuesday flayed the Covid management and the law and order situation in Kerala and blamed the Left government's political attitude for the crimes against women, alleged operation of terror cells and increasing coronavirus cases in the state.

Nadda began his speech at the event by stating that despite all the support given to the southern state by Prime Minister Narendra Modi, Kerala was not functioning as it was supposed to.

## TPR rises above 15%

Even as festivities for the hugely popular Onam were set to begin, the Covid test positivity rate in Kerala stayed high, reaching 15.48 per cent Tuesday. A statement issued here by Chief Minister Pinarayi Vijayan said 21,613 people turned Covid positive after 1,39,623 samples were tested in the past 24 hours. The three-day Onam festivities begin Friday and the state government has banned all public activities and has asked people to maintain absolute caution.

He said there was no Covid management, but only mismanagement in the state, which on an average has been seeing about 20,000 fresh cases every day and was accounting for more than half of the country's caseload of new infections each day. He said that the burden of Covid mismanagement in the state has become a burden of the country and asked where the Kerala plan of Covid management has gone.

Comparing the percentage of people infected in the state till date with that of Uttar Pradesh and Madhya Pradesh, Nadda said the northern states fared very well in their Covid management.

One of the reasons for the high number of Covid cases in Kerala was that the state initially went for Rapid Antigen Testing (RAT) and it was much later that it opted for

RTPCR tests, he said.

On the law and order situation in Kerala, the BJP president said it has gone haywire in view of the number of rape cases, targeting of women and children, presence of terror modules and the alleged involvement of the Chief Minister's Office (CMO) in the gold smuggling through diplomatic channels case.

He also alleged the CMO has not been able to come out of the shade of the gold smuggling case.

Nadda further claimed that Kerala was now being identified by terrorist modules operating in various shapes, gold smuggling and as an ISIS recruitment centre.

Apart from these, the other problems in the state were - Kerala's development being hampered and coming to a standstill by the political culture prevailing here for the last 30-40 years and the huge economic debt of around ₹3.5 lakh crore that the state was under, Nadda alleged.

Claiming that various central government schemes were also not being utilised by Kerala, Nadda expressed hope that the ₹267.35 crore allocated to the state for strengthening its healthcare infrastructure and preparing for any third wave of Covid-19 would be properly utilised.

# Praying, waiting for God: Mother of jailed IS recruit

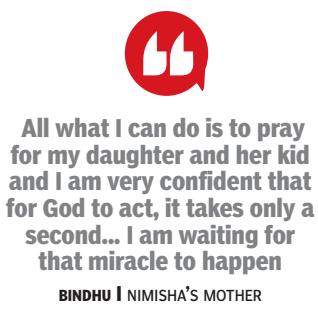

In June, Bindhu, who lives in the state capital, was dismayed at reports that the Indian government is unlikely to bring back four women, including Nimisha, jailed in Kabul for links to the IS.



## MAROONED IN AFGHANISTAN

The other three women are Soniya, Merin, and Raheela, all Keralites.

The news of a number of Keralites joining the IS surfaced after the Kerala government contacted various central agencies, including the IB, the NIA, and the

RAW, in 2016 about the veracity of reports about 19 missing people from the state have gone to Afghanistan, where they, according to some of the relatives, were believed to have joined the IS.

These 19 comprised 10 men, six women and three children and of

these, most hail from Kasargode and a few from Palakkad. They also include Christian and Hindu converts to Islam.

In the past three years, some of them who had joined IS were reportedly killed, according to their relatives, and these included the husbands of these four women.

The state government had acted after Bindhu, who is settled near Manacadu in the state capital, approached Chief Minister Pinarayi Vijayan in 2016 and sought his help to locate her daughter who had gone missing.

It later came to be known that Nimisha has got married to her friend Eeza, a Christian who had converted to Islam. Further to this, the news came that she had left for Afghanistan and the last contact the mother and daughter had was in November 2019.

**New Delhi:** India saw a single-day rise of 25,166 new Covid-19 cases, the lowest in 154 days, taking the tally to 3,22,50,679, while the national recovery rate was recorded at 97.51 per cent, the highest since March 2020, according to the Union health ministry data updated Tuesday.

**■ 45 villagers hospitalised**

**Yavatmal:** At least 45 people have been hospitalised after allegedly suffering from food poisoning in a village in Maharashtra's Yavatmal district, an official said Tuesday. Residents of Anjinaik village in Arni tehsil consumed food at a funeral Monday, following which they complained of stomach ache, diarrhoea and vomiting, he said. The affected villagers were taken to Bhambora primary health centre, from where a few of them were shifted to a rural government hospital after their condition deteriorated, while a woman and a child were shifted to Yavatmal government hospital, the official said, adding that more details are awaited.

**■ Woman kills self**

**Mahoba (UP):** The 30-year-old woman, who was allegedly set on fire by parents of a man booked by her in a molestation case lodged by the victim, died during treatment in a hospital Tuesday. The police said that the woman has been admitted to the Jhansi medical college in a critical condition. The mother of the accused has been taken into custody and the matter is being probed.

**India brings back its envoy, officials**

**New Delhi, August 17:** India Tuesday rushed back home its ambassador and staff from the embassy in Kabul in a military transport aircraft in the wake of escalating tension, fear and uncertainty gripping the Afghan capital after its take over by the Taliban two days back.

The C-17 Globemaster aircraft of the Indian Air Force carrying around 150 people, including diplomats, officials, security personnel and some stranded Indians, landed at the Hindon airbase near the national capital at around 5 PM after a brief halt at Jamnagar in Gujarat. It is the second evacuation flight as another C-17 aircraft brought back around 40 people from the Hamid Karzai International (HKI) Airport in Kabul Monday as part of India's emergency evacuation mission that was carried out following coordination with relevant authorities including US officials handling security at the airport in the Afghan capital.

Indian Ambassador to Afghanistan Rudrendra Tandon told media persons in Jamnagar that the situation in Kabul is complex and "quite fluid" now, and the remaining Indians stuck in the city will be brought back home when the commercial flight services resume.

"Happy to be back home safely and securely. We are a very large mission. We are a mission of 192 personnel who were evacuated from Afghanistan literally within a period of three days in a very

orderly fashion in two phases," he said. Tandon, who assumed charge as Indian ambassador in Afghanistan in August last year, said the embassy provided assistance and even shelter to many distressed Indians following the fast-changing situation in Kabul.

"We are continuously monitoring the situation because there are still some Indian citizens who are there. That is why Air India will continue to run its commercial services to Kabul as long as the airport in Kabul functions," Tandon said. Tandon said India will remain in contact with the Afghan people and will continue to work for their welfare. "It's not that we

have abandoned the people of Afghanistan, their welfare and our relationship with them is very much on our minds. We will try and continue our interaction with them. I can't say in what form as the situation is changing," he said in a statement.

Tandon also thanked the Indian Air Force for the evacuation flights. "Your welcome has an impact on all of us. Thank you to the Indian Air Force who flew us out under conditions that are not normal," he said. Asked about the stranded Indians, he said the embassy extended help to many of them.

The people who have returned on board the aircraft included two Delhi-based journalists who had gone to Afghanistan to cover the unfolding developments after the Taliban began capturing key provincial capitals.

In the morning, External Affairs Ministry Spokesperson Arindam Bagchi said it was decided that the ambassador and his Indian staff will move to India immediately considering the circumstances in Kabul.

**J&K POLICE LATHICHARGE JOURNALISTS**

**Srinagar, August 17:** Police Tuesday lathicharged and thrashed a group of journalists covering a Muharram procession here, evoking criticism from various quarters. Police also detained a few Shia mourners at Jehangir Chowk in the city as they tried to take out a procession to mark the eighth day of the 10-day Muharram mourning period. The traditional Muharram procession used to pass through the areas of Abi Guzar, Lal Chowk and Dalgate areas, but has been banned since the eruption of militancy in 1990 as authorities maintain that the religious gathering has been used for propagating separatist politics.

Inspector General of Police, Kashmir, Vijay Kumar said police respects the religious sentiments of the public, but at the same time, it is their joint responsibility to defeat the ill designs of vested interests who try to disturb the peaceful atmosphere. As the media personnel, mostly photo and video journalists, were discharging their professional duties, police swung into action and lathicharged them, the scribes said. They said the policemen, armed with batons, also thrashed some of the journalists and caused damage to their equipment. The pictures and the videos of the incident were uploaded on various social media forums as the journalists protested the police action.

**Not compelling to divulge sensitive issues: Apex court**

**New Delhi, August 17:** The Supreme Court Tuesday issued a notice to the Centre on the petitions seeking a probe into alleged use of Pegasus to snoop on civilians. However, the top court clarified that it will not ask the Centre to divulge sensitive issues connected with national interest, instead it is the limited issue of alleged snooping of civilians and some eminent persons.

A bench headed by Chief Justice NV Ramana and comprising Justices Surya Kant and Aniruddha Bose noted the court will not ask the Centre to divulge sensitive issues connected with national interest. "None of us would want to compromise the security of the nation or defence of the nation. Here the issue is very limited, civilians alleging interception of their phones. Interception can be done with permission of competent authority. This authority should file an affidavit before us", observed the bench, adding that the affidavit may not contain anything about national security. The top court said it will issue notice and let the com-

petent authority choose the next course of action. Solicitor General Tushar Mehta, representing the Centre, vehemently argued that the government has nothing to hide, however the information on purchase or whether Pegasus spyware was used or not, involves national security issues.

He added that senior advocate Kapil Sibal, representing journalists N. Ram and Sashi Kumar, agreed that there is a statutory mechanism allowing interception, which is necessary to combat terrorism. Mehta said software are used for national security and anti-terrorism purposes, and a software for this purpose is purchased by every country. "No government will make public what software it is using to allow terror networks to modify its systems and escape tracking", said Mehta. He said the government is ready to place all information before an expert technical committee, comprising independent members, which can submit its report to the top court. He added details are connected with national security and it can't be divulged through affidavits for public debate.

**Nearly two million terrorist watchlist records leaked online**

**New Delhi, August 17:** A cyber security researcher has discovered nearly two million terrorist watchlist records, including "no-fly" list indicators, which were left exposed online last month.

The US Department of Homeland Security (DHS) did not remove them until three weeks later. Cyber security researcher Bob Diachenko came across a plethora of records that were exposed online.

"On July 19, I discovered a terrorist watchlist containing 1.9 million records online without a password or any other authentication required to access it," Diachenko said in a LinkedIn post Monday.

"The TSC maintains the country's no-fly list, which is a subset of the larger watchlist. A typical record in the list contains full name, citizenship, gender, date of birth, passport number, no-fly indicator, and more," he wrote. The cyber se-

curity researcher reported the matter to the Department of Homeland Security, which acknowledged the incident. "The DHS did not provide any further official comment, though," he said.

The files were indexed by multiple search engines in an easily readable format. The exposed server was taken down about three weeks later, on August 9. The list was left accessible on an Elasticsearch cluster that had no password on it.

"If it falls in wrong hands, this list could be used to oppress, harass or persecute people mentioned on the list and their families. It could cause any number of personal and professional problems for innocent people whose names are included in the list," Diachenko said in a statement.

There have been several reports of US authorities recruiting informants in exchange for keeping their names off the no-fly list. Some past or present informants' identities could have been leaked.

**77% Indians recognise earth close to tipping points: Survey**

**New Delhi, August 17:** Seventy-seven per cent of the Indians recognise the earth is close to tipping points in terms of global warming and they are worried about the state of nature today, a survey of the G20 nations said Tuesday.

Following an alarming IPCC climate report that outlines an alarming future, IPSOS Mori and the Global Commons Alliance released a set of new and extremely detailed research on public attitudes towards tipping points, planetary stewardship and necessary economic and societal transformations.

The results provide some of the most granular insights to date on these critical issues from the G20 countries.

Across the world's largest economies, 73 per cent of people believe the earth is approaching potentially abrupt or irreversible tipping points because of human action. The survey also found that the majority of people (58 per cent) living in G20 countries are very concerned or extremely concerned about the state of the global commons, and 83 per cent of people are willing to do more to become better "planetary stewards" and protect and regenerate the global commons.

People in developing economies showed greater willingness to do more to protect nature and climate than those in advanced economies: Indonesia (95 per cent), South Africa (94 per cent), China (93 per cent), Mexico (93 per cent), Brazil (91 per



cent), compared with Japan (61 per cent), Germany (70 per cent), and the US (74 per cent).

"The world is not sleepwalking towards catastrophe. People know

we are taking colossal risks, they want to do more and they want their governments to do more," said Owen Gaffney, the lead author of the report 'The Global

Commons Survey: Attitudes to planetary stewardship and transformation among G20 countries', and director of communications for the Global Commons Alliance.

The survey highlighted significant discontent with the dominant economic systems across G20 countries. Among G20 countries, 74 per cent of people support the idea that their country moves beyond a singular focus on profit and economic growth and focus more on human wellbeing and ecological protection and regeneration.

This view is consistently high among all G20 countries. It is particularly high in Indonesia (86 per cent), Turkey (85 per cent) and Russia (84 per cent), but even the lowest scoring countries score highly: the US (68 per cent), the UK (68 per

cent) and Canada (69 per cent).

The survey revealed that people are less aware of the scientific consensus that sweeping systemic transformations needed in the next decade to protect the global commons and meet climate targets set out in the UN's Paris Agreement.

While 59 per cent of people in G20 countries know scientists acknowledge a very rapid energy transition is needed in the next decade, just right per cent of people think this is about a need for broader economic changes in the next decade, including dietary change, price of goods and services to include environmental costs and moving to circular economies.

However, 28 per cent of people are aware that scientists think significant change is needed.

### Wildfires spread in Southern France

**Marseille:** Thousands of people, including tourists in campsites, have been evacuated as a wildfire raged near the plush resort of Saint-Tropez in southern France, the fire service said Tuesday. Around 750 firefighters and water-dropping aircraft were battling the blaze in difficult conditions, with high temperatures and strong winds. "Thousands of people have been evacuated as a precautionary measure, but there are no victims," a fire service spokeswoman said, adding that the blaze was "still very fierce".

### China holds assault drills near Taiwan

**Beijing:** China carried out assault drills near Taiwan Tuesday, with warships and fighter jets exercising off the southwest and southeast of the island in what the country's armed forces said was a response to "external interference" and "provocations". In a brief statement, the PLA's Eastern Theatre Command said warships, anti-submarine aircraft and fighter jets had been dispatched close to Taiwan to carry out "joint fire assault and other drills using actual troops".

### Malaysia's king in search for new PM

**Kuala Lumpur:** Malaysia's king is set Tuesday to meet the heads of political parties as he swiftly began the task of finding a new prime minister amid a worsening Coronavirus pandemic. The resignation Monday of Prime Minister Muhyiddin Yassin after less than 18 months in office followed mounting public anger over what was widely perceived as his government's poor handling of the pandemic. The monarch has ruled out a general election as many parts of the country are Covid-19 red zones and health facilities are inadequate.

### Thai protesters clash with police

**Bangkok:** Police in Thailand used water cannon to break up a demonstration at the national police headquarters Tuesday, a day after clashes during which a young protester was left in a coma with a bullet lodged in his head. Protesters gathered in central Bangkok for a third successive day to demand Prime Minister Prayuth Chan-ocha resign amid rising anger over his handling of the country's Covid-19 epidemic, which saw a record 239 deaths Tuesday.

## Taliban promise rights to women under Islamic law

**Kabul, August 17:** The Afghan Taliban said Tuesday they wanted peaceful relations with other countries and would respect the rights of women within the framework of Islamic law, as they held their first official news briefing since their shock seizure of Kabul.

The Taliban announcements, short on details but suggesting a softer line than during their rule 20 years ago, came as the United States and Western allies evacuated diplomats and civilians the day after scenes of chaos at Kabul airport as Afghans thronged the airfield.

As they rush to evacuate, foreign powers are assessing how to respond to the changed situation on the ground after Afghan forces melted away in just days, with what many had predicted as the likely fast unravelling of women's rights.

During their 1996-2001 rule, also guided by Islamic law, or sharia, the Taliban stopped women from working and administered punishments including public stoning. Girls were not allowed to go to school and women had to wear all-

He also said families trying to flee the country at the airport should return home and nothing would happen to them.

### Afghan ex-Vice President vows new fight

**Panjshir:** Afghanistan's defiant vice president made one thing clear as the Taliban seized control of the capital following the collapse of his government - he will not surrender. It appears he has retreated to the country's last remaining holdout: the Panjshir Valley northeast of Kabul. "I won't dis-appoint millions who listened to me. I will never be under one ceiling with Taliban. NEVER," he wrote in English on Twitter Sunday, before going underground. A day later, pictures began to surface on social media of the former vice president with the son of his former mentor and famed anti-Taliban fighter Ahmed Shah Massoud in Panjshir -- a mountainous redoubt tucked into the Hindu Kush. Saleh and Massoud's son, who commands a militia force, appear to be putting together the first pieces of a guerilla movement to take on the victorious Taliban, as fighters regroup in Panjshir.

## NZ thrown into lockdown

**Wellington, August 17:** Prime Minister Jacinda Ardern put New Zealand under strict lockdown Tuesday after the country's first Coronavirus case in six months was reported in the largest city of Auckland.

Ardern's "go hard, go early" strategy has helped curb Covid-19 but her announcement left people struggling to stack up essentials, businesses shutting abruptly and schools and offices making last-minute changes to go online.

All New Zealand will be in the toughest, level-four lockdown for at least three days from Wednesday. Auckland and Coromandel, a coastal town where the infected person also spent time, will be in lockdown for seven days.

"The best thing we can do to get out of this as quickly as we can is to go hard," Ardern told a news conference.

"We have made the decision on the basis that it is better to start high and go down levels rather than to go low, not contain the virus and see it move quickly."

Schools, offices and businesses will close and only essential services will be operational.



Shoppers crowded supermarkets as news of the new case and the imminent lockdown spread.

Ardern said authorities were assuming the patient, a 58-year-old man from Auckland who was not identified, had contracted the highly contagious Delta variant of Covid-19 although genome sequencing was yet to be completed.

There may also be other cases, she said. The Auckland Regional Public Health unit is interviewing the patient for contact-tracing purposes and Covid-19 vaccinations are to be suspended for at least 48 hours.

## Quake-struck Haiti lashed by storm

**Les Cayes, August 17:** Heavy rains lashed Haiti Tuesday night, complicating rescue efforts and drenching thousands left homeless by a devastating earthquake that killed at least 1,419 people, as hopes dimmed for survivors.

Tropical Depression Grace churned over the regions of southwest Haiti worst-hit by Saturday's quake of magnitude 7.2, whipping devastated towns with high winds and torrential rains, causing flooding in at least one area.

Several major hospitals were severely damaged, hampering humanitarian efforts, as were the focal points of many shattered communities, such as churches and schools.

As hopes began to dim of finding significant numbers of survivors among the wreckage, the storm impeded rescuers in the seaside city of Les Cayes, about 150 km (90 miles) west of the capital Port-au-Prince, which bore the brunt of the quake.



The storm is expected to dump up to 15 inches (38 cm) of water on parts of Haiti, creating a risk of flash floods, according to the US National Hurricane Centre.

Rescue workers from across Haiti were digging alongside residents through the rubble Monday evening in a bid to reach bodies, though few voiced hope of finding anyone alive. A smell of dust and decomposing bodies permeated the air.

## Sudoku creator departs at 69

**Tokyo, August 17:** Maki Kaji, the creator of the popular numbers puzzle Sudoku whose life's work was spreading the joy of puzzles, has died, his Japanese company said Tuesday. He was 69 and had bile duct cancer.

Known as the "Godfather of Sudoku," Kaji created the puzzle to be easy for children and others who didn't want to think too hard. Its name is made up of the Japanese characters for "number" and "single," and players place the numbers 1 through 9 in rows, columns and blocks without repeating them.

Ironically, it wasn't until 2004 when Sudoku became a global hit, after a fan from New Zealand pitched it and got it published in the British newspaper The Times. Two years later, Japan rediscovered its own puzzle as a "gyakuyunyu," or "reimport."

Kaji was chief executive at his puzzle company, Nikoli Co, until July and died August 10 at his home in Mitaka, a city in the Tokyo metro area.

Maki traveled to more than 30 countries spreading his enjoyment of puzzles. Sudoku championships have drawn some 200 million people in 100 countries over the years, according to Tokyo-based Nikoli.

"Kaji-san came up with the name Sudoku and was loved by puzzle fans from all over the world. We are grateful from the bottom of our hearts for the patronage you have shown throughout his life," the company said in a statement.

Originally, Sudoku was called "Suji-wa-Dokushin-ni-Kagiru," which translates to, "Numbers should be single, a bachelor." In recent years, Sudoku, believed to be the world's most popular pencil puzzle, has come out in digital versions.

**Los Angeles, August 17:** Legendary singer-songwriter Bob

Dylan has been sued by a woman who claims he sexually abused her in 1965 when she was 12, an allegation the Nobel Prize winner has called untrue.

The lawsuit filed last week on behalf of JC (initials of the unnamed lady), now a 68-year-old woman living in Greenwich, Connecticut, alleges that Dylan, then 23 or 24-year-old, exploited his status as a musician to provide (the plaintiff) with alcohol and drugs and sexually abused her multiple times. The survivor, claimed that the traumatic incident left her "scarred and psychological damaged to this day."

A spokesperson for Dylan, now 80, said the the 56-year-old claim is untrue and will be vigorously defended.

According to Deadline, in the papers filed at the New York Supreme Court under the state's Child Victims Act, JC said the abuse took place at Dylan's apartment in New York's Chelsea Hotel for over a six-week period



from April-May 1965.

As per the complaint, JC claims that Dylan established a "connection" with her to "lower her inhibitions with the object

of sexually abusing her, which he did, coupled with the provision of drugs, alcohol and threats of physical violence".

The lawsuit cites causes including assault, battery false imprisonment and intentional infliction of emotional distress, and seeks compensatory, punitive and exemplary damages.

Dylan, whose real name is Robert Allen Zimmerman, was already a popular name in the New York music scene during 1960's, performing and writing songs that gave voice to the anti-war and Civil Rights movements.

Since then he has been honoured with multiple Grammys, the Presidential Medal of Freedom and the Nobel Prize for Literature.

Govt unveils sops to boost exports

Rates of tax refunds announced under the export promotion scheme RoDTEP for 8,555 products

**New Delhi, August 17:** To boost exports, the government Tuesday announced rates of tax refunds under the export promotion scheme RoDTEP for 8,555 products, such as marine goods, yarn, dairy items. The government has set aside ₹12,454 crore for refunds under the Remission of Duties and Taxes on Exported Products (RoDTEP) scheme for the current fiscal, a top official said.

Under the RoDTEP, various central and state duties, taxes, and levies imposed on input products, among others, will be refunded to exporters.

Commerce Secretary BVR Subrahmanyam said that ₹19,400 crore would be available for 2021-22 for both the RoDTEP and the Rebate of State and Central Taxes and Levies (RoSCTL). The RoSCTL scheme was announced for the export of garments and apparels.

For the RoDTEP scheme, the amount is ₹12,454 crore and the remaining ₹6,946 crore for RoSCTL.

As the RoDTEP scheme came into effect from January 1 this year, additional funds will be provided at pro-rata basis for the period January to March.



"Today we have notified the rates. RoDTEP is going to be a long-lasting scheme and it is going to be a flagship scheme of the commerce ministry. It is also compliant to the World Trade Organisation," the secretary told reporters here.

He added that both the schemes together would cover 95 per cent of the tariff lines or goods and exports. However three sectors of steel, chemicals and pharmaceuticals would not get the benefit of RoDTEP as they have 'done well without' incentives.

The reimbursement of taxes

such as duty on power charges, VAT on fuel in transportation, farm sector; captive power generation, mandi tax, stamp duty and central excise duty on fuel used in transportation would make Indian products competitive in global markets, he said.

The tax refund rates range from 0.5 per cent to 4.3 per cent for various sectors.

The rebate under the scheme would not be available in respect of duties and taxes already exempted or remitted or credited.

RoDTEP support will be available

RBI says inflation is on track to meet projections

**Mumbai, August 17:** Inflation is likely to remain within the Reserve Bank of India's (RBI) projected levels for the rest of the year, it said Tuesday while highlighting that inflation containment comes at the cost of economic growth.

Earlier this month the RBI raised its 2021/22 inflation forecast to 5.7% from 5.1% and reiterated that it will continue to keep monetary policy accommodative as long as necessary to revive and sustain growth on a durable basis.

The retained stance and increased inflation forecast started a debate over whether monetary policy has forsaken its primary mandate of price stability in the face of the continuing COVID-19 pandemic.



The RBI is mandated to bring down retail inflation to 4% over the medium term while keeping it within a range of 2-6%, a band it has breached twice this year. Inflation is on the central bank's envisaged trajectory and likely to stabilise over the rest of the year, the RBI said of what it described in Tuesday's bulletin as "a credible forward-looking mission statement for the path of inflation".

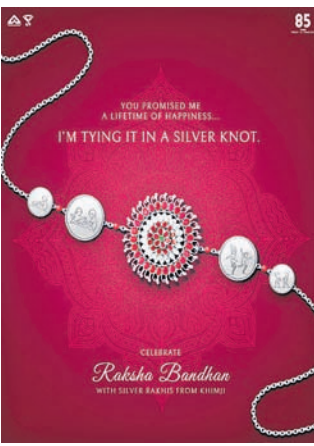

India asks US court to reject Cairn's \$1.2bn suit

**New Delhi, August 17:** The Indian government has asked a federal court in Washington to dismiss Britain's Cairn Energy suit seeking enforcement of a USD 1.2 billion arbitral award, saying it had sovereign immunity under US law.

Cairn had in May asked a US federal court to force Air India to pay a USD 1.26 billion arbitration award the firm had won in December.

The government August 13 filed a 'Motion to Dismiss' petition in the US District Court for the District of Columbia, saying it lacked subject matter jurisdiction in the dispute between Cairn and the Indian tax authority, according to a filing seen by PTI.

This comes a week after the government enacted legislation to scrap a tax rule that gave the tax department power to go 50 years back and slap capital gains levies wherever ownership had changed hands overseas, but business assets were in India. That rule had been used to levy a cumulative of ₹1.10 lakh crore of tax on 17 entities, including ₹10,247 crore on Cairn.

Officials said rules for withdrawal of such tax demands are in the process of being framed.



"One of the requirements for the dropping of the retrospective tax demands is that the parties concerned have to give an undertaking for withdrawal all cases against the government/tax department. So, while all this is in process, the government is obligated to respond in any legal matter where there is a time bar for doing so," an official explained.

Cairn had challenged the tax demand before an international arbitration tribunal, which in December last year overturned the same and ordered the government to refund the money collected. The government initially refused to return USD 1.2 billion, forcing Cairn to take action to recover that money through a seizure of Indian assets overseas.

Serum buys 50% stake in country's largest vial maker

**Bangalore, August 17:** Serum Institute of India has bought a 50% stake in vials maker Schott Kaisha, the companies said Tuesday, as the world's largest vaccine maker aims to secure pharmaceutical packaging to meet rising demand due to the pandemic.

"Securing this supply chain is of strategic importance," said Adar Poonawalla, chief executive officer of Serum Institute. "As a longtime customer, we use (Schott's) vials, ampoules and syringes to store our vaccines including (COVID-19 vaccine) Covishield."

Serum and Schott did not divulge any financial details on the deal in their joint statement. A representative for Schott India in an email said that the two partners have decided not to disclose the value of the deal. Serum did not immediately respond to a Reuters request for comment.

Schott Kaisha is a joint venture between specialty glass makers Schott AG from Germany and India's Kaisha, producing the highest number of ampoules and vials in the country at around 2.5 billion units per year.

In May, a Schott Kaisha executive told Reuters that the company expected to sell 380 million vials for COVID-19 vaccines in 2021-22, up from 113 million a year earlier.

Coronavirus cases in India have sharply dropped from the devastating peak of the second wave in April and May. The country Tuesday administered a near record number of vaccination doses in the last 24 hours.

Safe-haven currencies supported on signs on weakening sentiment

DISAPPOINTING ECONOMIC DATA FROM CHINA, THE SPREADING DELTA VARIANT AND POLITICAL TENSION IN AFGHANISTAN WEIGHED ON RISK APPETITE

**Tokyo, August 17:** Safe-haven currencies such as the yen held firm against riskier currencies Tuesday as disappointing economic data from China, the spreading Delta variant of the coronavirus and political tension in Afghanistan weighed on risk appetite.

The dollar eased to 109.24 yen, having lost about 1% over the past two sessions while the euro slipped to as low as 128.50 yen, touching its lowest level since late March.

The Swiss franc also held on to

latest gains at 0.9124 franc per dollar. On the euro, it stood at 1.0745 franc to the euro, staying near its nine-month high of 1.0720 set earlier this month.

The US dollar, which is also often seen as the ultimate safe-haven currency, held firm against many other rivals, including the euro and commodity-linked currencies. The euro changed hands at \$1.1785.

"The moves seem to reflect deterioration in market sentiment. You could say the impact of Delta variant is behind this," said Yukio Ishizuki, senior strategist at Daiwa



Securities. The New York Federal Reserve said Monday its barometer of manufacturing business activity in New York State declined more than expected in August after growing at a record-setting pace in the month before.

That came after the University of Michigan's survey Friday showing US consumer sentiment dropped sharply in early August to its lowest level in a decade.

In China, data published Monday showed July retail sales, industrial production and fixed asset investment were all weaker than ex-

pected as the latest COVID-19 outbreak weighed on the world's second-biggest economy.

Investors' risk mood was also curtailed by developments in Afghanistan after the Taliban seized the capital, though direct impacts on markets have been limited so far, traders said.

The risk-sensitive Australian dollar stood at \$0.7333, near the low end of its narrow trading range around \$0.73-74. In cryptocurrencies, bitcoin was trading at \$46,133, not far from Saturday's three-month high of \$48,190. Ether stood \$3,190.

And Indians eventually got the job done in 51.5 overs with pacers producing a high quality show to dismiss England for 120.

“Super proud of the whole team. The way we stuck to our plans after being put in. The pitch didn’t offer much in the first three days. First day was the most challenging,” said Kohli at the post-match presentation.

“The way we played in the second innings after being put under pressure - Jasprit and Shami were outstanding. We had the belief we can get them out in 60 overs. The tension in the field in our second innings, what happened there, helped us,” Kohli, who had sledged Ollie Robinson during the fag end of the second innings, said.

India set England a 272 run target following an 89-run stand between tail-enders Jasprit Bumrah and Mohammad Shami. The duo’s special was applauded by the entire team which came down from the dressing room to welcome them.

“Putting their hand up was something we were really proud of and we wanted to let them know (standing ovation for Bumrah-Shami). Batting coach has worked really hard with the boys.

“They have the desire in them to do well for the team. We know how priceless those runs are. The belief (from lower-order) was missing for a while but now it is back,” said Kohli.

It was India’s third Test win at Lord’s and Kohli called it a special one.

# India to face Pak in campaign opener

India's remaining two Super 12 matches are against the winner of Group B (November 5 in Dubai) and second placed side of Group A (November 8 in Dubai).

## ICC T20 WORLD CUP

The tournament's first round kicks off October 17 in Oman, with the hosts taking on Papua New Guinea and Bangladesh playing Scotland.

Group A consists of 2014 champions Sri Lanka, Ireland, the Netherlands and Namibia, while Group B has Bangladesh, Scotland, Papua New Guinea and Oman.

The top two teams from each group will qualify for the Super 12 stage.

The Super 12s – round two of the tournament, with two groups – will begin October 23, with Australia facing South Africa in Abu Dhabi and England up against title holders and two-time champions West Indies in Dubai.

The first semifinal will be played in Abu Dhabi November 10, while the second will be played in Dubai November 11. The final will be held in Dubai November 14 with November 15 marked as reserve day. The tournament is being hosted by India in the United Arab Emirates (UAE) and Oman since a third wave of the COVID-19 is being anticipated at that time of the tournament.
