# BJP guns for Jena's scalp

Both the BJP and the Congress created a din in the Assembly over various issues. The BJD blamed the Opposition for disrupting proceedings

**Bhubaneswar, Sept 2:** The Odisha Assembly witnessed noisy scenes Thursday, leading to several adjournments. It happened as members of both the BJP and the Congress created a din over different issues.

The BJP sought immediate dismissal of Law Minister Pratap Jena for his alleged involvement in the Mahanaga double murder case. The Congress on the other hand tried to highlight the condition of the people in drought hit districts. Due to repeated disruptions, Speaker Surjya Narayan Patro first adjourned the House for an hour and then twice till 4.00pm. Later he



called an all-party meeting to end the imbroglio.

As soon as the House assembled on the second day of the Monsoon Session, BJP MLAs flocked to the Well of the House with posters demanding removal of Jena for his alleged involvement in the murder of saffron party leader Kulamani Baral and his associate Dibyasingh Baral in January at Mahanaga near Salipur in Cuttack district.

"The law minister's name was mentioned in the FIR, but the police submitted a charge-sheet

against 12 persons, excluding Jena. The court of judicial magistrate first class in Salipur has directed the police to look into his involvement in the murder of two elderly BJP leaders in Cuttack district's Mahanga area," Opposition Chief Whip Mohan Majhi told reporters.

"We brought up the issue and demanded his resignation. We have asked for immediate removal of Jena from the House. We will continue to stage protests in the Assembly till our demand is met," Majhi added.

Congress MLAs meanwhile stated that they are not happy with the answers given Wednesday by Agriculture Minister Arun Sahoo regarding the drought situation in Odisha.

"We were not satisfied with the answers given by Arun Sahoo. We wanted a statement from the revenue minister, but a proxy responded on the issue. He turned the attention of the House to other issues. A total of 27 districts have been hit by drought in the state. We want relief for the people in these districts," pointed out Congress lawmaker Suresh Routray.

BJD meanwhile accused the BJP of sticking to rhetoric and depriving others to discuss pertinent issues during the Monsoon Session. "BJD leaders are often seen talking about criminal cases and announcing 'verdicts' as if they are judges. Every session they are adopting the same policy and depriving others from discussing important topics," BJD leader Pramila Mallick told reporters.

# Self-styled godman arrested for murder

**Bhubaneswar, Sept 2:** Khurda police arrested Thursday self-styled godman Manas Das for his organisation's alleged involvement in various criminal activities. Also called 'Guruji', Das is the head of 'Manavbad Sanghathan' which he and his followers call a 'humanitarian' body.

Das was picked up from his Saheed Nagar residence by a team of Khurda police led by SDPO, Sushil Mishra. They were helped by the personnel of Commissionerate police. Das has been booked for murder, attempt to murder, kidnapping and criminal intimidation.

Addressing the media, IG Police Central Range, Narasingha Bhol said that Das is allegedly involved in hatching a criminal conspiracy leading to the kidnapping and murder of 45-year-old farmer, Satyabrata Nayak of Abhimanpur village under Begunia police limits, August 1. Six people were arrested August 3

for their alleged involvement in the crime. They were later produced before the court the next day. Nayak was killed for not attending a meeting held to promote tribal rights. They also forced the victim's nephew to cremate the deceased to destroy evidence.

Bhol informed that Das was taken into custody after three of the six who were earlier arrested mentioned his involvement in the crime during interrogation. He stated that Das and another person were also named in the FIR as accused. He informed that the police had been collecting evidence against Das.

Bhol also added that a former close associate of Das had Thursday lodged a complaint against the 'Guruji' and his son Manoranjan for life threats.

He informed that Manoranjan has been arrested by Begunia police for his alleged involvement in the torture of a tribal person and his son. The video of the entire incident has gone viral.

# ₹323cr GST fraud unearthed

**Bhubaneswar, Sept 2:** The State Goods and Services Tax (GST) Enforcement Wing Thursday busted a racket involved in evasion of GST worth ₹323 crore through fake invoicing of ₹1,819 crore.

The sleuths arrested two persons – Amit Kumar Agrawal, a chartered accountant, and Satindra Kumar Yadav, a Bhubaneswar-based businessman.

While Agrawal is the partner at a CA firm in Jharsuguda - Amit Kanheyala and Co, Yadav is the owner of M/s SS Syndicate.

According to the enforcement wing, the duo had collected PAN cards, Aadhaar cards, bank passbooks, voter IDs and photographs from several people, mostly from Kolkata, on the promise of jobs.

Later, they created around 13 fake firms by obtaining GST and value added tax (VAT) registration using the identity documents collected from the victims.

“Out of 13 fictitious firms, the proprietors of three firms are found

to be jute mill workers or sweepers in Dalhousie Jute Mill located at Champdani in West Bengal,” claimed sources.

Similarly, 10 fictitious firms were shown functioning on a barren land without any building or infrastructure in Jharsuguda and Samablpur. The house rent agreements, consent letters and other certificates uploaded for registration under the VAT and GST Act are found to be forged. Same photograph and one mobile number have been used for three different persons in the GST documents.

Meanwhile, the accused persons illegally obtained GST registration for the ghost firms in West Bengal, Jharkhand, Madhya Pradesh and Delhi in the names of the applicants whose registration certificates have already been can-

celled by the state authorities including in Odisha.

The duo, in collusion with other accused, has availed and later passed on bogus input tax credit (ITC) worth ₹323 crore by submitting fake purchase and sale invoices to the tune of ₹1,819 crore in the name of the fictitious business entities. “Actual loss to the government stands at ₹58.14 crore - the ITC passed on to the recipient of outside Odisha. The culprits took advantage of simplification of GST norms,” the GST enforcement wing revealed.

The wing unearthed the massive fraud with the help of authorities in states like West Bengal, Jharkhand, Chhattisgarh and Delhi.

The state GST wing has so far arrested 23 persons and cancelled the GST registration of 29,002 dealers.

## House passes three crucial Bills

**Bhubaneswar, Sept 2:** The state Assembly Thursday passed three important Bills including the Odisha University of Health Sciences Bill, 2021 amid ruckus by Opposition BJP and Congress.

Health Minister Naba Kishore Das said several medical and paramedical institutions affiliated to different universities in the state are granting degree or diploma or training certificates.

“These universities have no specialization on the study of medical and paramedical sciences adoptable in new methods of teaching, learning and research to achieve excellence in healthcare and overcome the incidence of new diseases,” the minister said.

He said establishment of University of Health Sciences will not only address the serious lacunae but also bring about the much needed coordination. It will help achieve the educational objectives of the faculties and individual training programmes.

“To have uniformity in various academic programmes in medical and allied subjects, it is felt expedient to establish and incorporate a university exclusively as an affiliating

## OTDC earned ₹2.39 lakh by selling air tickets: Minister

The Odisha Tourism Development Corporation (OTDC) has sold air tickets worth ₹31.89 crore during past three financial years and earned ₹2.39 lakh from the venture.

In a written reply to the Assembly, Tourism Minister Jyoti Prakash Panigrahi Thursday said the OTDC has sold tickets worth ₹17.09 crore in FY 2018-19, ₹13.88 crore in FY 2019-20 and ₹91.65 lakh in FY 2020-21.

The corporation has earned commission to the tune of ₹2.39 crore for selling the tickets during the three

years, he said.

The operational expenditure stood at ₹65.09 lakh, ₹57.81 lakh and ₹50.20 lakh in 2018-19, 2019-20 and 2020-21, respectively, the minister added.

He further informed the House that the OTDC has earned net profit of ₹66.63 lakh during the three years.

The corporation earned ₹51.44 lakh in 2018-19 and ₹34.32 lakh in 2019-20. However, the state PSU has borne a loss of ₹19.13 lakh during last financial year, he added.

The air-ticketing unit of OTDC provides tickets to all major government and corporate houses of the state in addition to the general public. Most of the tickets are booked by government offices only, sources said.

In retaliation, around 50 inmates from Ambedkar hostel attacked Kharavela hostel inmates.

The students went berserk and ransacked tables, chairs and window glasses in Kharavela hostel.

Police sources said that the college authorities have assured strict action against the students responsible for the incident.

**Bhubaneswar, Sept 2:** Amit Rohidas, a key player of Indian National Men's Hockey team, which recently won bronze medal by defeating Germany at Tokyo Olympics, has joined East Coast Railway (ECoR) as senior sports officer.

# Odisha sees highest rain deficit in 23 yrs

**Bhubaneswar, Sept 2:** Odisha recorded its highest rainfall deficiency in over two decades this monsoon amid fears that the dry spell could trigger a drought in the state, said the Meteorological (MeT) Centre here.

The coastal state received only 661.1 mm of rain between June 1 and August 31 this year against a normal of 935.8 mm, a deficiency of 29 per cent, the MeT Centre said.

This was the sixth occurrence in the last 120 years when the south-west monsoon rain during the period has been deficient by 29 per cent or more, an official release said Wednesday. The previous rain-deficient years were 1924 (636.2 mm), 1954 (646.8 mm), 1974 (658.7 mm), 1987 (641.4 mm) and 1998 (657.5 mm), the department said.

The seasonal deficit is mainly due to a large deficiency in the month of August. Rainfall over the state during the month was 204.9 mm against a normal of 366.4 mm, recording a deficiency of 44 per cent. There were only three times in the last 120 years that the August

## Sahoo's missive to Pradhan on admission in central varsities

**Bhubaneswar, Sept 2:** State Higher Education Minister Arun Sahoo Thursday wrote to Union Education Minister Dharmendra Pradhan asking him to instruct the central universities to allow students to submit their undergraduate (UG) final semester results/marksheets by September-end so that no one is deprived of admission for post-graduate (PG) courses during this session.

In his letter to Pradhan, Sahoo highlighted the problems of UG final year students of Odisha who are unable to take admission to postgraduate (PG) courses in central universities due to delay in publication of final semester results by universities and autonomous colleges in the state.

In view of the Covid-19 situation, The University Grants Commission (UGC) has issued a set of guidelines in July this year and instructed that all UG final year ex-

aminations must be completed by August 31 and admission for the PG courses should be completed by September 30, Sahoo said.

As per UGC guidelines, UG final year examinations have been completed by August 30 and the results are expected to be declared by September 15, he added.

However, it seems that some central universities have deviated from the UGC prescribed schedule and completed their admission process in August itself, thereby depriving students of Odisha from taking admission due to their failure in submitting the UG final semester marksheets, Sahoo pointed out.

“Therefore, I request you to kindly instruct central universities to allow PG applicant-students to submit their UG final semester results by September-end. As a result, no students would be debarred from taking admission in central universities,” Sahoo said in his letter to Pradhan.

# Lowest Covid-19 fatalities since July

### INFECTION RATE AMONG CHILDREN DIPPED TO 14.32 PER CENT FROM 17.38 PER CENT WEDNESDAY

**Bhubaneswar, Sept 2:** Odisha's Covid-19 tally rose to 10,09,223 Thursday as 754 more people tested positive for the infection, a Health department official said.

Six more patients, including a 104-year-old man from Cuttack, succumbed to the disease, taking the state's coronavirus death toll to 8,028, he said, adding that the sin-

gle-day spike of six fresh fatalities was the lowest since July.

As many as 438 new cases were reported in quarantine centres, while 316 infections were detected during contact tracing. The infection rate among children dipped to 14.32 per cent from 17.38 per cent Wednesday.

Khurda district, under which Bhubaneswar falls, recorded the highest number of new cases at

261, followed by Cuttack (110) and Balasore (43). Gajapati and Subarnapur did not report any new cases.

Khurda recorded four more deaths, while Cuttack and Jajpur registered one each, the official said, adding that the coastal state's case fatality rate (CFR) of 0.79 per cent is one of the lowest in the country.

The state now has 7,241 active

Four districts - Jajpur, Bhadrak, Bolangir and Angul - saw a deficiency of 40 per cent or more, the MeT Centre said.

In August, only four districts recorded normal rainfall, while 18 were under the deficient category. Eight districts - Boudh, Sambalpur, Subarnapur, Angul, Bolangir, Kandhamal, Bargarh and Jajpur - are under the large deficient category, it said.

Apparently, the absence of depression and less number of low-pressure areas - only two observed - over the Bay of Bengal during August caused less amount of rainfall, the weatherman said. The monsoon trough was also located north of its normal position on most days in August, causing subdued monsoon activities, it said.

The India Meteorological Department has forecast that the state would receive normal rainfall of 226.6 mm in September. Tuesday, Chief Minister Naveen Patnaik had directed officials to prepare a contingency crop plan and take measures to mitigate farmers' problems.

# No public gathering during Ganesh Puja

**Bhubaneswar, Sept 2:** The Bhubaneswar Municipal Corporation (BMC) Thursday prohibited any kind of public gathering during Ganesh Puja celebrations while issuing a set of guidelines for the festival scheduled to be held September 10.

As per the guidelines, congregations shall not be allowed within BMC Jurisdiction on the occasion of Ganesh Puja.

However, the puja committees/organisers can conduct the puja at mandaps/pandals by adhering to Covid-19 protocol and obtaining permission from the Commissionerate Police.

“Ganesh Puja shall be conducted in indoor-like conditions only for observance of rituals without any public participation and grandeur. The public address system shall not be used during the festival,” read the guideline.

It adds, “At any point of time,

there shall not be more than 7 persons including the organisers/priests/support staff at the pandal/mandap.”

Moreover, the BMC also instructed puja committees to worship Ganesh idols of less than 4 ft in height.

The mandaps/pandals are also to be covered from three sides while only one side would remain open for use of the priest for rituals.

The fourth side should also be covered properly for preventing any public view/darshan of the idols.

“There shall be no immersion procession. The idols shall be immersed in artificial ponds to be created by the BMC. The festival would be observed with only 20 participants in educational institutes/coaching centres. The head of the educational/coaching institutes shall ensure that those above 18 years of age are fully vaccinated to be present on this occasion,” said the order.

The officials informed that Rajesh managed to break the wire fencing after being fed. The fencing wires had become weak due to rusting. So, Rajesh was able to break it and step out into the open.

Zoo authorities immediately swung into action and raised the alarm. All the visitors were safely evacuated out from the premises and all the gates secured. Later, after a long and thorough inspection, the zoo employees finally spotted Rajesh roaming inside the safari and heaved a big sigh of relief. The big cat was brought back to the enclosure, which was being repaired immediately.

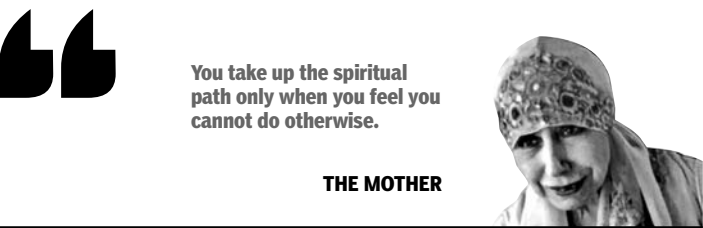

Prosecuting Ecocide

As floods, wildfires, record-high temperatures, and zoonotic disease make the climate and ecological crisis impossible to ignore, the world may be moving closer to agreeing that serious damage to our natural environment is more than just a matter for goodwill agreements. It may amount to an international crime.

The last time a new international criminal offense was introduced was after World War II. The Nuremberg and Tokyo Charters added crimes against humanity to the existing war crimes and crimes against peace (“aggression”), enshrining the idea that certain acts are so egregious that, whoever the immediate victim may be, they concern us all. Soon after, in 1948, a particular crime against humanity – genocide – was incorporated in a new treaty.

We may be witnessing an equivalent moment in our relationship to the environment. Last month, a diverse independent panel of international lawyers issued the draft text defining the crime of “ecocide,” to be proposed for inclusion in the Statute of the International Criminal Court (ICC). The parallels are clear: adopting ecocide as an international crime acknowledges that severe damage to our environment is a crime against all of us, and that we can no longer leave it to regulation by individual States.

The panel, convened by the Stop Ecocide Foundation, defined the crime as follows: unlawful or wanton acts committed with knowledge that there is a substantial likelihood of severe and either widespread or long-term damage to the environment being caused by those acts.

Two thresholds must be met for acts to constitute the crime. First, there must be a substantial likelihood that they will cause severe and either widespread or long-term damage to the environment. Severity is necessary in all circumstances, and the likely damage must be either widespread (extending beyond a limited area, crossing State boundaries, or affecting an entire ecosystem or large number of people), or long-term (irreversible or irremediable through natural recovery within a reasonable period of time). This would cover situations such as the toxic pollution of a population center – a large number of people, but a relatively limited geographical area – or the destruction of a marine ecosystem, which might be limited in size but permanently lost.

To meet the second threshold, the damage must be either “unlawful or wanton.” Ideally, the environment would be adequately protected by national laws, and extreme violations would be international crimes.

“Unlawful” deals with those situations. But national legislation varies, and international environmental law contains few outright prohibitions. And some legally permitted acts that harm the environment are socially desirable: consider desperately needed housing, transport, or infrastructure projects. In such cases, international environmental law sets out principles – above all the principle of sustainable development – according to which States should behave. The term “wanton” in the ecocide definition serves an equivalent purpose, addressing legally permitted acts that are reckless, owing to the disproportionate level of likely harm.

To be recognised as an international crime alongside genocide, crimes against humanity, war crimes, and aggression, the crime of ecocide will need the support of at least two-thirds of ICC member States (currently there are 123 States in total). It will then become effective for any State that ratifies it. Individuals in positions of responsibility whose actions meet the definition will be subject to prosecution at the ICC, or by any national courts with jurisdiction, and sentenced to prison if convicted.

This is a major shift from the status quo, where criminal sanctions are lacking, at the international level and often at national level too, for many of the worst cases of mass environmental destruction. In most jurisdictions, individuals or corporations only face financial penalties.

Criminalising ecocide could have a stronger deterrent effect than the prospect of genocide or war crimes charges do, because it is largely a corporate offense. Because a company’s value depends heavily on its reputation and investor confidence, managers would have much to lose by finding themselves in the same dock as a war criminal (the ICC prosecutes individual offenders rather than corporations). Even the risk of appearing to have committed an international crime may steer corporate decision-makers toward safer and more sustainable methods of operation. The hope is that the deterrent will take effect long before the law does, as the prospect of legislation becomes visible.

There are, of course, challenges to moving forward. The ICC is already navigating difficult waters, and it is clear from developments in France that domestic ecocide legislation can be problematic.

But broad international support for the crime of ecocide can and must be garnered. Governments – including those of Vanuatu, the Maldives, France, Belgium, Finland, Spain, Canada, and Luxembourg – are already expressing interest. And parliamentary motions or draft laws have been submitted in a number of countries, including Belgium, Portugal, Brazil, France, Bolivia, Bangladesh, the United Kingdom, and Chile. Countries must not wait for catastrophe to stop the international crime of our time.

BY ENHANCING RESERVATION IN THE HEALTH SECTOR, THE EDGE OF EFFICACY IS BLUNTED. IN MATTERS OF HEALTHCARE, MERIT SHOULD BE PARAMOUNT

Acting on the Prime Minister's insistence, the Union government has decided that medical colleges across the country will now have 27 per cent reservation for the Other Backward Castes (OBC) and 10 per cent reservation for the Economically Weaker Sections (EWS). The idea of reservation is inclusive, which aims to incorporate the excluded sections of the society. I do not intend to question the purpose and efficacy of reservations. However, I would argue that the recent development hints at the anomaly of the system by contrasting two disparate sectors: sports and health.

Reservations were primarily introduced with a bid to uplift the socially excluded castes and to undo the effects of “the history of oppression”. Reservation was synonymous with affirmative action. Dr Ambedkar was instrumental in safeguarding the interests of the weaker sections of the society. In fact, that was the need of the hour then to allow the weaker sections to gain access to opportunities of education and employment. Even after seven decades, reservation, which was initially adopted as a temporary measure, has not been withdrawn either partially or fully. In contrast, it has been bloated from time to time, largely riding on political and populist agendas. The Supreme Court in 1992 had set a limit to reservations at 50 per cent though different states have tinkered with the boundaries to allow leverage to regionally-deprived communities. In what follows, I will attempt a cross-sectoral contrast between sports and health vis-a-vis reservations and demonstrate the anomaly in the system therein.

Sports has been a common pastime in the country since Independence. People venerate and worship sports stars. Dhyan Chand, Milkha Singh, Sachin Tendulkar, PT Usha, Sania Mirza and Saina Nehwal are some notable poster-boys and poster-girls of inspiration. There are other glamorous sportspersons too who

are adored and adorned as pin-ups. Despite the significance attributed to sports, let me put it clearly that sports do not amount to national duty. In the recently concluded Border-Gavaskar trophy, there was a hue and cry over Virat Kohli's decision to leave the series midway in order to attend the birth of his first child. While many commentators hailed his decision, some lambasted him for privileging his personal interests over professional duties. For the latter, sports was tantamount to national duty. Sadly, that is not the case. A nation obsessed with sports, mainly cricket, lives under the vague construct of national pride. Sports work as, what Louis Althusser calls, Ideological State Apparatuses in fomenting nationalism. Sports, if I put it curtly, is simply another mode of entertainment. It is, in other words, just another profession. Interestingly and fortu-

nately, sports has been insulated from reservations in India, unlike some other countries like South Africa. The only criterion for selection here is merit.

Health, on the other hand, goes beyond entertainment. It dwells on matters of life and death. To be honest, it is far more important than sports. We won't die in the absence of sportspersons. But we will obviously succumb to diseases and accident if there is a dearth of doctors. The horrendous display of COVID-19 is the latest example of the importance of health workers in the sustenance of life and activity. Sports is attached to the myth of national pride. Not more than that! Health is necessary for the existence of mankind. In scientific parlance, health is the core while sports is, at best, an auxiliary wing.

Health and sports, however, are not entirely alien to each other. Even sportspersons get ac-

cess to the best physiotherapists, who are preferably the best in the trade. In most cases, physiotherapists of the national teams are of foreign origin. They are chosen on the basis of merit. Even doctors attending the sportspersons are people who excel in their profession. Sportspersons are undoubtedly important. Nevertheless, the common citizens of the country are also important as far as access to better health facilities is concerned. In a country like India, the bulk of the population relies on public health centres for everything that goes between birth and death. It is not a matter of choice but circumstantial compulsion due to their economic status. The United Nations estimated that the number of poor in India was 364 million in 2019, or 28 per cent of the population. The pandemic has only worsened the situation and pushed a large chunk of population into poverty.

By enhancing reservation in the health sector, the edge of efficacy is blunted. In matters of healthcare, merit should be paramount. The concept of merit is itself ambiguous. The advocates of reservation speak of equitable distribution of resources which is ensured by reservations. Nevertheless, we ought to have the best hands for healthcare. Accommodating persons from weaker sections by compromising with merit in the name of affirmative action puts millions of lives at risk. That should never be the case. If sports is insulated from reservations, healthcare deserves the same treatment. Carl Jung rightly says, “Medicines cure diseases but only doctors can cure patients”. For the sake of the country, let us strive for doctors who can cure patients in the best possible manner.

IN THE FIRST WEEK OF PMJDY'S IMPLEMENTATION, THE DEPARTMENT OF FINANCIAL SERVICES, GOVERNMENT OF INDIA, MADE A GUINNESS WORLD RECORD BY OPENING 18,096,130 BANK ACCOUNTS

The 'Pradhan Mantri Jan Dhan Yojana' (PMJDY) launched by the Central government on August 28, 2014 has completed seven years of successful implementation. In the first week of its implementation, the Department of Financial Services, Government of India, made a Guinness World Record by opening 18,096,130 bank accounts. During the last seven years the accounts have grown three-fold from 14.72 crore in March 2015 to 43.04 crore as on August 18, 2021. The deposits in the Jan Dhan accounts have also grown sharply from ₹22,901 crore in March 2014 to ₹1,46,230 crore in 2021.

These figures speak volumes about the success of the Jan Dhan Yojana which contributed significantly to the financial inclusion and inclusive growth in the country. Around 67 per cent of the Jan Dhan accounts are from rural areas of the country and 55 per cent are women. In Odisha, there are 1.76 crore beneficiaries of which 1.38 crore were issued RuPay cards. Around 79 per cent of the beneficiaries belong to the rural areas, whereas 21 per cent are in urban and metro areas. Nobody can deny the fact that unless and until the lowest strata of the society is given access to the finan-

cial services like banking and insurance, the country cannot develop. The Jan Dhan Yojana proved government's efficacy in reaching the unreached.

In the beginning, the scheme envisaged universal access to financial literacy and financial services like access to credit, insurance and pension with at least one basic banking account for every household. The basic features of the scheme are - no requirement to maintain any minimum balance in PMJDY accounts, interest is earned on the deposit in PMJDY accounts, RuPay debit card is provided to PMJDY account holder, accident insurance cover of ₹1 lakh is available with RuPay card issued, overdraft (OD) facility up to ₹10,000 to eligible account holders and eligibility for Direct Benefit Transfer (DBT), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana (APY), Micro Units Development & Refinance Agency Bank (MUDRA) scheme.

The government launched the PMJDY 2.0 in 2018 with new features and enhanced the benefits. In PMJDY 2.0, the government shifted the focus from 'Every Household' to 'Every Unbanked Adult' and

free accidental insurance cover on RuPay cards doubled to ₹2 lakh for PMJDY accounts opened after August 28, 2018. At the same time overdraft (OD) limit was also doubled to ₹20,000 and the facility of overdraft up to ₹2,000 without conditions were introduced.

The programme has made a significant impact on the lives of the people of unbanked and unreached clusters who were brought into the folds of financial inclusion. Bank statistics say that the average balance in these accounts which is hovering around ₹3,000 to ₹3,500 is an indication of regular usage of the beneficiaries. The massive financial inclusion is visible and it is supported by the revelation of the Global Findex data base of the World Bank. As per the Index, the number of people above 15 years in the lower middle income group reached 80 per cent compared to 53 per cent in 2014.

Opening a bank account is not enough, but operation of the account is important. Until the beneficiary realises the need to keep the account active and utilises it prudently, the fruits of financial inclusion may not be available. In August, the Finance Ministry informed Rajya Sabha that 5.82 crore PMJDY accounts are inoperative, which is around 13 per cent of the

total beneficiaries. As per the guidelines of the RBI, an account is assumed to be inoperative or dormant if there are no transactions in the account for a period of two years.

However, the benefits of financial literacy can be achieved when the beneficiaries will have access to formal credit facilities. The pandemic exposed the difficulties one can face when there is no financial planning to meet the emergencies. Apart from that, it highlighted the usage of digital banking which is to be taken to the nook and corner of the country. As time and distance matters much to the people of the rural areas, digital banking will be of much help, provided network is available. Proper credit delivery models are to be found out to suit the beneficiaries. Appropriate data related to the income and expenditure of the Jan Dhan beneficiaries is collected to come out with the right strategy. Apart from financial inclusion, these steps will help the beneficiaries to attain financial empowerment.

Reopening primary schools

Doc crunch cripples healthcare in Balasore

Balasore, Sept 2: Healthcare services are in tatters in Balasore district with over 159 posts of doctors lying vacant in various hospitals of the district, a report said.

This has sparked anger among denizens who visit the hospitals for healthcare services. It is apprehended that the simmering discontentment might give way to an agitation. Various outfits including Fakirmohan Medical College and Hospital (FMMCH) Action Committee have repeatedly demanded fulfillment of the posts. However, their pleas are yet to be addressed.

The establishment of the medical college and hospital in the town had led to development of big infrastructure and more equipment for the facility but shortage of adequate number of doctors and technicians has hit the healthcare services.

The number of patients visiting the hospital has increased manifold over time but the authorities have not taken care to fulfill the vacant posts. As a result, patients visiting the hospitals with serious ailments are referred to Cuttack and Bhubaneswar on a regular basis.

Reports said the district has 373 sanctioned doctor posts at various departments for the district headquarters hospital and 17 community health centres. Meanwhile, 214 doctor posts are working in the hospitals while 159 posts of doctors are lying vacant.

In this situation, healthcare services in the CHCs, district headquarters hospital and Fakirmohan Medical College and Hospital have been severely hit. The number of patients visiting the district headquarters hospital has increased after the establishment of a medical college and hospital in the town. The hospital unit of the FMMCH does not have its own wards and it operates from the district headquarters hospital. A new hospital building is being constructed at Remuna Golei.

Things have greatly improved in the DHH after the hospital unit of the FMMCH started operating from its premises. However, it is building up pressure on the DHH authorities to cater for the needs of its



patients due to shortage of doctors.

People with minor ailments and requiring simple surgery visit the district headquarters hospital but people requiring specialized medical care visit the FM Medical College and Hospital.

The hospital has 61 doctors out of 96 sanctioned posts while 35 posts are lying vacant.

Over 2,500 patients from various parts of the district and Mayurbhanj as well as West Bengal visit the outdoor of the district headquarters hospital. They get their health checked with the doctors and take medicines or undergo tests as per their advice.

Over 400 patients with debilitating condition are admitted to the indoor wards of the hospitals. While the hospital is struggling for want of doctors, the major issue here is that departments of cardiology, neurology, cancer and urology do not have doctors.

The absence of specialized doctors has hit healthcare services in the hospital as the doctors working here often refer the kin of the patients to take them to specialised hospitals in Cuttack and Bhubaneswar. An estimate says that 6,500 patients are referred to Cuttack and Bhubaneswar in a year.

Many of them without getting proper treatment visit the private nursing homes in the town and end up losing their hard earned money. The FM Medical College and Hospital which is in its fourth year was a dream come true for the locals due to longstanding demands of residents. However, it is struggling with doctor shortage. Various outfits have regularly voiced their demand over the shortage of doctors but their demands are yet to be fulfilled.

When contacted, Dr Dulalsen Jagdev, chief district medical officer said he has drawn the attention of the authorities on doctor shortage and hoped the problem would be resolved soon.

‘60 acres enough for world class varsity’

Bolangir, Sept 2: Even as land shortage has come in the way of expansion of the Rajendra University in Bolangir, principal secretary of the higher education department Saswat Mishra visited the university Thursday. He said 60 acres is enough to make the varsity world class. He assured that the state government would provide funds if the central government fund is not available to this premier educational institution in western Odisha.

He interacted with Collector Chanchal Rana, Vice Chancellor Prof Umaballabh Mohapatra and other staff of the university.

Talking to reporters, he said the university has 40 to 45 acres of land under its possession while an additional 10/15 acres of land has been identified. The administration is in the process of registering the land in the name of the university. About 55/60 acres of land will be available for the university, he added.

“A master plan for the university’s development has been drawn up. To make it a world class university, 60 acres of land is enough,” he claimed.

Mishra also stated that a patch of 20 acres of land is behind the university which can be used as a playground. As for appointment of staff in the university, Mishra said OPSC will do the recruitment.



By December, 80 to 90 posts out of a total of 126 posts in the university will be filled up, he added.

“It is wrong to say that development of the university can’t be carried out without central funds. The state government, the WODC and the DMF will provide fund the university, Over last three years, the state government has provided ₹1034 crore to state universities while the UGC has provided only ₹10 crore,” he observed.

Notably, Rajendra University is one of the oldest educational institutions in western Odisha. But its development has been hampered by lack of land, teachers and

Farmers seek action against fert hoarding

Khaira, Sept 2: Farm activities are in full swing in Khaira block of Balasore district, but shortage of urea has affected farming, locals alleged.

They stated that despite raids by officials, some licensed outlets and dealers have resorted to massive hoarding and black marketing of urea. An artificial shortage of urea and growmore fertilizer is being created by some dealers who sell a packet of urea at double its normal price,” they said.

Although despite deficit rainfall, farmers have managed to save the paddy, but black marketing of urea at this time has compounded their problem.

A packet of DAP is officially priced at ₹1200; urea at ₹266.50; growmore at ₹1450 and potash at ₹1000. “Dealers say urea is not supplied to them sufficiently. They sell a packet of DAP for ₹1600; urea



at ₹350 and growmore at ₹1700,” they pointed out.

Black marketing of fertilizers has created discontent among farmers. Various farmer organizations demanded that the agriculture department and the administration take up step to rein in fertilizer black marketing

There are two wholesalers and 72 licensed retailers of fertilizers in Khaira block. It is alleged that 60 per cent of the licensed dealers sell fertilizers to other traders in rural areas while farmers are deprived of getting the fertilizers directly from dealers.

Bideshi’s ‘red tea’ is as good as it gets

Keonjhar, Sept 2: With the outbreak of the Covid-19 pandemic, demand for red masala tea has increased manifold. Many tea stalls in Keonjhar town are now serving this tea to customers. But Bideshi Nayak’s red tea is as good as it gets.

Bideshi’s tea stall is located close to a cinema hall. At first look, his tea stall seems nondescript, but after a few sips, one will realise why the joint is so famous in this part of the town.

While enjoying the tea, one can feel the ingredients like black pepper, ginger and lemon juice that go into the making of this red masala tea.

Bideshi has loyal customers from different age groups and different strata of society. Even though the stall remains open from morn-



ing to evening, most customers visit the stall in morning and evening hours. Bideshi charges ₹5 for a cup of his red masala tea and the customers have no hesitancy paying the amount.

Bideshi, now 71 years old, has been running this stall for 50 years. Initially, he sold snacks and sweets. As he grew older, he stopped selling those items and started selling tea only.

“I no longer have the strength to prepare all those items. I am happy with my tea business. As per customers’ demand, I prepare milk or red tea. There was a time when people looked down on red tea, terming it poor man’s beverage. But after the outbreak of Covid pandemic, more people have been asking for red tea,” observed Bideshi, adding that he would continue to serve the people till his last breath.

He resides in Gourtoota Sahi with his family – comprising his wife and himself. He had two sons but lost them long ago. While he is receiving old-age pension, his wife is yet to get this benefit. This is why he

has to run his tea stall even at this advancing age.

He says the stall is earning him money as well as some well wishers. People, some known faces and some unknown ones, visit his stall and he spends time gossiping with them.

“My customers also include people owning four-wheelers. If my shop is closed for some reason, they return unhappy,” he added.

Jaykrushna Panda, a local journalist, says they have been noticing Bideshi working at the stall since their childhood days. “He has been very punctual. He keeps time even at this age. His amiable behaviour, honesty and hard working nature earn him customers. He is good at preparing sweets. Even today, if he gets orders for sweets, he prepares them and delivers them at the customers’ door step,” added Panda.

# Restive Kashmir under lockdown after burial of separatist leader

**Srinagar, Sept 2:** Veteran separatist politician of Kashmir Syed Ali Shah Geelani was laid to rest early Thursday in Srinagar, as authorities blanketed the region with troops and clamped down on communications to prevent protests.

Geelani, 91, was buried in a graveyard near his home before dawn with only a few hundred people, including his family and neighbours, allowed to attend the funeral, a government official said.

“There was heavy security at the funeral, including plain clothes policemen,” the official said.

Geelani, who died Wednesday, had been unwell for some time, his family said.

Among the most prominent political leaders in Kashmir, Geelani for years led an umbrella alliance of secessionists known as the Hurriyat Conference.

But the group split in 2003, when hardliners led by Geelani, who advocated Kashmir’s merger with Pakistan, walked out after moderates decided to hold talks with New Delhi. He was kept under house arrest more than a decade after leading several anti-India protests.

Around Geelani’s home and elsewhere in Srinagar, armed troops lined main roads and manned checkpoints, a Reuters witness said, as authorities sought to prevent protests in the wake of his passing.

The city’s main business area remained deserted, with most shops closed, and the movement of vehicles restricted, the witness said. The clamp down echoes restrictions that were imposed in August 2019 when Indian Prime Minister Narendra Modi split Jammu and Kashmir - then the country’s only Muslim majority state - into two federally-administered territories.

The shock move was opposed within Kashmir, including by the likes of Geelani who quit his hard line Hurriyat Conference faction, saying that it had failed to counter New Delhi’s efforts to tighten its grip on the disputed region.

# CBI nabs ‘insider’ for fake ‘clean-chit’ to Deshmukh

**Mumbai, Sept 2:** In a massive embarrassment, the Central Bureau of Investigation (CBI) said that it has raided and arrested its own sleuth for allegedly conniving to prepare a ‘purported’ clean-chit to former Maharashtra Home Minister Anil Deshmukh, here Thursday.

The raids took place in New Delhi and Allahabad while the arrest took place early Thursday, hours after the CBI had swooped on Deshmukh’s son-in-law Gaurav Chaturvedi and his Nagpur-based lawyer Anand Daga late Wednesday evening, from Worli in Mumbai.

The Chaturvedi-Daga duo was detained and their statements recorded till the wee hours when the complicity of an inside hand, the CBI’s own official -- a Sub-



Inspector Abhishek Tripathi - was also confirmed.

The CBI said in a terse statement this morning that it has registered a case against its own SI, the Nagpur-based lawyer (Daga) and other unknown persons for certain allegations, including corruption.

During the investigations of the said case, CBI has today arrested the SI (Tiwari), while the lawyer (Daga) is being questioned, the agency said, even as raids were carried out in New Delhi and Allahabad and his personal lockers in the CBI offices here.

It may be recalled that last weekend, media and political circles were rocked by a report purportedly giving a ‘clean-chit’ given

to Deshmukh in the Bombay High Court-ordered preliminary enquiry (PE).

Rattled by the alleged leak, the CBI had issued two strong rebuttals on the issue, and quietly launched a probe into the matter which culminated in the nabbing of an ‘inside hand’ in the sordid episode.

The unsigned-undated-unattributed alleged PE report triggered a fresh political row with the Nationalist Congress Party and Congress demanding that the CBI should comment on the authenticity or otherwise of the report.

As a fallout of the incident, the CBI picked up Chaturvedi and Daga Wednesday and early

## Leaked CBI report genuine, says NCP

The Nationalist Congress Party (NCP) Thursday claimed that a leaked CBI report which purportedly gave a clean chit to former Maharashtra home minister Anil Deshmukh in a corruption case was genuine. The Central agency has now claimed that the report was leaked after a bribe was paid and it has registered a criminal case in this regard, NCP leader and Maharashtra minority affairs minister Nawab Malik told reporters here. But the Central Bureau of Investigation is not stating that the report itself was fake, he said. “To save its face, it is saying that the report had been managed,” Malik alleged. “If the report is presented in the court, Anil Deshmukh will get reprieve. Whatever is happening is all politically motivated,” he added.

# Navlakha seeks medical check-up & house arrest instead of prison custody

**Mumbai, Sept 2:** Activist Gautam Navlakha, an accused in the Elgar Parishad-Maoist links case and currently lodged in Talaja prison, moved the Bombay High Court Thursday seeking that he be placed under house arrest as part of his judicial custody, owing to his advanced age and medical ailments.

In his plea, Navlakha, 69, also sought that the HC direct authorities of the Talaja prison in neighbouring Navi Mumbai to get him medically examined for a lump developed in his chest.

His counsels, Yug Chaudhry and Payoshi Roy, told a bench of Justices S S Shinde and N J Jamadar that Navlakha wished to be examined medically to rule out cancer.

In his plea, Navlakha cited the Supreme Court’s order issued in May this year, whereby the apex court had dismissed his default bail plea, but found merit in treating house arrests as an alternative form of detention, especially

for such undertrials who are aged or suffering from serious medical ailments.

Navlakha’s counsels also told the HC that they had already written to the Talaja prison authorities, seeking a medical check-up for the lump in his chest, but they were yet to hear anything from the authorities.

They further told the HC that Navlakha also suffered from hypertension that he developed while in prison, and several other ailments.

Navlakha was arrested by Pune police from Delhi on August 28, 2018 in connection the Elgar Parishad case. He was initially kept under house arrest, but subsequently sent in judicial custody.

As per Navlakha’s plea, he has spent one year and three months in prison. The HC will hear the plea further later in the day.

The case relates to the Elgar Parishad conclave held in Maharashtra’s Pune district December 31, 2017.

# Geelani’s end leaves a void in ‘separatist movement’

**Srinagar, Sept 2:** The death of hardline senior separatist leader Syed Ali Shah Geelani has left a void in the separatist camp that might not be easy to bridge in near future.

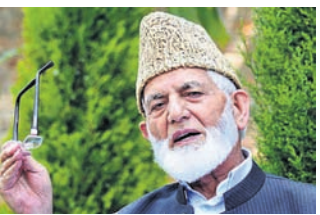
Geelani had broken away from the Jamaat-e-Islami in 2008 when he formed his own political party called the Tehreek-e-Hurriyat.

Ashraf Sehrai was his deputy in the Tehreek-e-Hurriyat and most supporters of Geelani looked upon Sehrai as his logical successor. Sehrai died of Covid infection while he was in prison May 5, 2021.

His death left the question of Geelani’s succession, as an icon of the separatist movement, wide open

with apparently no successor in sight. Geelani had senior colleagues and friends in the Jamaat, but after he broke away from them, the possibility of any senior leader of that organisation succeeding Geelani was over. Interestingly, when he broke away from the Jamaat, Geelani had taken away hardliners like him to Tehreek-e-Hurriyat, but none among them except Sehrai could claim succession.

In 2003, Geelani split the All Party Hurriyat Conference into the hardline faction headed by him and the moderate faction headed by Mirwaiz Umer Farooq. Geelani worked with other separatists like Yasin Malik of the JKLF, Mirwaiz Umer Farooq of Awami Action Committee,



Professor Abdul Gani Bhat of the Muslim League, Molvi Abbas Ansari of J&K Itihaadul Muslimeen and Bilal Gani Lone of Peoples Conference during his association with All Party Hurriyat Conference.

Yet, there is no denying the fact that he continued to live in total mistrust of his Hurriyat colleagues and vice versa.

Among his two sons, Nayeem

Geelani is a doctor and Naseem Geelani is an assistant professor in the local agricultural university. Both of them have announced that they are not in the race to succeed their father in the separatist camp. These developments rule out the possibility of anyone in the present day separatist camp to succeed Geelani as an icon of separatism in Kashmir.

Would his death further dampen the spirits of the separatists or would his death give another lease of life to the separatist sentiment in Kashmir? Time alone holds a firm answer to this question and yet there is no doubt that the kind of hawkish approach adopted by Geelani cannot be matched by any of his rivals in the separatist camp.

# Bombay HC refuses to hear Anil’s plea against ED summons

**Mumbai, Sept 2:** The Bombay High Court Thursday refused to hear a petition filed by former Maharashtra Home Minister Anil Deshmukh seeking to quash the Enforcement Directorate (ED) summons issued against him, among other reliefs.

When the matter first came up Thursday, Justice Revati Mohite-Dere recused herself from hearing the plea without assigning any reason, saying, “Not before me.”

The plea was filed on Wednesday by Deshmukh seeking to quash the ED summons for recording his statement, setting up an SIT comprising officers from outside of Mumbai Zone, record his statement in electronic mode, attendance through an authorised agent, and other reliefs as directions.



The ED has been probing an alleged money-laundering case against Deshmukh since April following a CBI FIR arising out of the corruption allegations levelled by former Mumbai police chief Param Bir Singh in March.

The ED has till now issued five summons to Deshmukh, asking him to appear before it for questioning.

However, Deshmukh skipped all the five summons, saying he would be seeking appropriate remedy available under law.

# Fisherman nets ₹1.33cr fortune from Arabian Sea

**Palghar, Sept 2:** This catch was beyond the wildest imagination of Palghar fisherman Chandrakant Tare - who pulled in a net-full of 157 ‘Ghol’ (Croaker) fish, worth an astounding ₹1.33 crore!

The good fortune struck Tare when he resumed his fishing activity on his trawler ‘Harbadevi’ with 10 others, after the two-month-long monsoon ban ended August 15.



Tare, a resident of Murbhe coastal village, and his team set sail to Wadhwan, around 45 kms off Palghar shores, casting their nets with prayers and hopes for a good catch. Their prayers were answered a few days later when they pulled in the nets - and found the 157 ‘Ghols’ (Protonibe Diacanthus) struggling to break

free from the tough nylon strings.

Tare and his crew were stunned to find such a huge quantity of ‘Ghols’ - also known as the sea gold - since the fish is in huge demand as a culinary delicacy and for its internal organs in south and south-east Asia.

Even before they touched shore this week, word of the mega-catch

‘Ghols’ - also known as the sea gold - are in huge demand as a culinary delicacy and for their internal organs in south and south-east Asia

had spread like wildfire and many eager buyers had already queued up to net a bargain with Tare and his team. Finally, he sold it to a consortium of the highest bidders from Bihar and Uttar Pradesh - at ₹1.33 crore - considered the highest-ever price for ‘Ghol’ in the entire Konkani region.

Coveted in Singapore, Malaysia, Indonesia, Thailand, Hong Kong and other countries, the ‘Ghol’ fish fins are said to have huge medicinal value, and are used by pharma companies to make soluble stitches,

and for wine purification, while its bladder cures kidney stones, and its heart boosts sex power and immunity, say locals.

According to fisherman Jitendra Patil, in recent years, there has been a big drop in the fish population around the coastal areas owing to rampant marine pollution. We are forced to venture far into the Arabian Sea for a decent catch adding to the costs and time... We rarely net one or two ‘Ghols’, and once a fisherman had caught around a dozen in his nets. But, such a huge quantity (157) in a single catch is like God’s blessing, said Patil.

On his part, Tare gave a thanks-giving glance to the skies and said with the income he netted, all his financial problems - piled up during the two-year pandemic period - are resolved at one shot, even as he has become a hero among the fishing communities of the state.

**SC concerned over fake and communal news**

**New Delhi, Sept 2:** The Supreme Court Thursday expressed deep concern over web portals, and YouTube channels publishing fake news, slandering reputations in the absence of a regulatory mechanism, and also broadcast of communal news by a section of media. The top court emphasized if this were to continue unchecked then it may get a bad name for the country.

A bench headed by Chief Justice NV Ramana said: "On web portals, there is no control of anybody; they can publish anything...If you go to YouTube, you will find how fake news is freely circulated and anyone can start a channel on YouTube."

The bench also comprising Justices Surya Kant and A.S. Bopanna observed that the content shown in a section of private media bears a communal tone. "The problem is that everything in this country is shown with a communal angle by a section of the media..." noted Justice Ramana. He told Solicitor General Tushar Mehta, "Ultimately, this country is going to get a bad name. Have you made an attempt for a self-regulatory mechanism (for these private channels)?"

Mehta submitted before the bench that Centre has come out with new Information and Technology rules, which address concerns flagged by the top court. He added that many petitions have been filed challenging the new rules in various high courts.

Mehta contended that the Centre has filed a plea to transfer all these petitions to the Supreme Court. Mehta added: "Not only communal but also planted stories. These portals can even put fake news".

The Chief Justice added that the social media platforms do not respond if an issue is raised in

connection with the content.

"I have not come across any public channel, Twitter, Facebook or YouTube ... they never respond to us and there is no accountability, about the institutions they have written badly about, and they don't respond and say this is their right," said the Chief Justice. He further added this is the condition of institutions and forget the individuals.

Mehta replied, "This is what is taken care of under the IT rules".

**New Delhi, Sept 2:** India Thursday said its immediate focus relating to Afghanistan is to ensure that Afghan soil is not used for terrorist activities against it, two days after the Indian envoy to Qatar held talks with a top Taliban leader in Doha and conveyed similar concerns.

To a volley of questions at a media briefing on whether India was ready to recognise a Taliban regime in the backdrop of the Doha meeting, spokesperson in the

Ministry of External Affairs Arindam Bagchi said it is too early to talk about it.

"Let's treat the Doha meeting for what it is. It was just a meeting. I think these are very early days," he said. "We used the opportunity to convey our concerns whether it is in getting people out (from Afghanistan) or on the issue of terrorism. We received a positive response," he said.

Asked about India's engagement with the Taliban and whether it is not a terrorist organisation, Bagchi said: "That's not our focus. Our

**Avoid mass events if not fully vaccinated: Govt**

**New Delhi, Sept 2:** Mass gatherings should be discouraged but if attending it is essential then full vaccination should be a prerequisite, the Union government said Thursday and urged people to get the jabs and follow Covid-appropriate behaviour, especially during the festive season.

In a press conference, it warned the second wave of coronavirus infection in India was not yet over even though the weekly positivity rate was showing an overall declining trend.

Union Health Secretary Rajesh Bhushan said 39 districts in the country reported over 10 per cent weekly Covid positivity rate in the week ending August 31 while in 38 districts it was between 5 and 10 per cent.

He asserted that 16 per cent of India's adult population have received both the doses of Covid-19 vaccine while 54 per cent have been administered at least the first dose.

"In Sikkim, Dadra and Nagar Haveli, and Himachal Pradesh all the adult population have got at least one dose of Covid-19 vaccine," Bhushan said. In view of the upcoming festive season amid the



**MANDATORY RT-PCR TEST FOR FLYERS ENTERING INDIA FROM 7 MORE COUNTRIES**

**A**mid fear of new Covid-19 strains, RT-PCR test is compulsory for passengers arriving from seven more countries, including South Africa, Bangladesh and China, the Centre said Thursday. In a letter to all states and Union territories (UTs), the government said considering reports of new mutations in SARS-CoV-2 and rising number of Variants of Concern (VOCs) and Variants of Interest (Vols) globally, seven countries have been added in the list of countries whose travellers will have to get another RT-PCR test done upon landing at Indian airports apart from the one they need to get before embarking on the flight. These seven countries are South Africa, Bangladesh, Botswana, China, Mauritius, New Zealand and Zimbabwe. In earlier guidelines issued in February, passengers from only the United Kingdom, Europe and the Middle East had to get the RT-PCR test done again upon landing at Indian airports.

**CBI files case over JEE (Mains) scam, raids 20 locations**

**New Delhi, Sept 2:** The Central Bureau of Investigation has registered a case on the allegations of irregularities being committed in the ongoing JEE (Mains) Exams 2021 in a private engineering college.

The agency also carried out searches at around 20 locations in various cities including at Delhi, Pune, Bengaluru, Jamshedpur and other places.

It has registered a case against a private company and others including its Directors and three employees, private persons (conduits), and other unknown persons.

It was alleged that the said company and its directors were manipulating the online examination of JEE (Mains) and facilitating aspiring students to get admission in top NITs in consideration of huge amount by solving the question paper of the applicants, through remote access, from a chosen examination centre in Haryana's Sonapat.

It was also alleged that the accused used to obtain Class 10 and 12 mark sheets, the user IDs, passwords, and posted dated cheques of aspiring students in different parts of country as security and once admission was done, they used to collect heavy amount ranging from ₹12-15 lakh per candidate.

**Can't lodge 5 FIRs in one case, says HC**

**New Delhi, Sept 2:** The Delhi High Court has held that police cannot lodge five FIRs for the same incident and quashed four of them registered for the alleged offences of looting and setting on fire a compound during the north-east Delhi riots last year.

There cannot be a second FIR and fresh investigation for the same cognisable offence, the high court said.

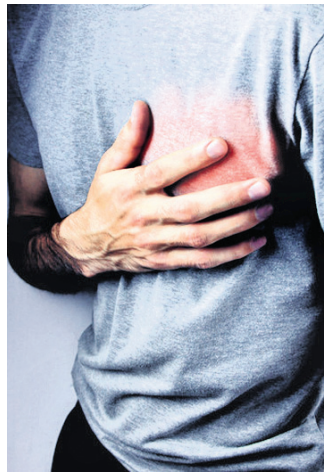
Five separate FIRs cannot be registered for the very same incident as it is contrary to the laws laid down by the Supreme Court, it said. While maintaining one FIR, the high court quashed the other four lodged against the same accused in March last year at Jaffrabad Police Station and all the proceedings emanating therefrom.

"It cannot be said that the incidents were separate or the offences are different. As stated earlier, a perusal of the charge sheets filed in the respective FIRs show that they are more or less identical and the accused are also same," Justice Subramonium Prasad said.

The court's order came while allowing four petitions filed by accused Afir, facing prosecution in five FIRs lodged by Delhi Police on complaints by different members of the same family that when they reached their home in Maujpur area on the evening of February 24, they saw their house was set ablaze which caused a loss of articles worth ₹7-10 lakh.

**New Delhi, Sept 2:** The demise of television actor Sidharth Shukla, 40, due to a heart attack early this morning, has opened many questions on the health and lifestyle among young people.

"Generally cardiac issues are considered to be associated with obesity, old age or unhealthy lifestyle, but the fact is even a healthy young person apparently following a fitness regime can also suffer heart attack," Dr Anand Kumar Pandey, Director and Senior Consultant, Cardiology, Dharamshila Narayana Superspeciality Hospital said. "We can never have insight into a

person's lifestyle, which includes hectic schedule, stress - they also have so much to do with heart health," he added.

Stress plays a major role, the experts noted.

"The youth of India has adopted bad lifestyle habits to deal with the stress they are facing due to their high-pressure jobs and while ambition is good there is an urgent need for balance," Dr TS Kler, Chairman, Fortis Heart and Vascular Institute, Fortis Memorial Research Institute, Gurugram said. But can exercise, often touted as a preventive measure, also affect heart health? "While high levels of cholesterol may cause blockages in

arteries, going extremely beyond the capacity of the body for exercises or workout puts extra pressure on blood vessels, and the same condition may potentially result in cardiac attack," Pandey said. Further, the experts noted that young people no longer go for bi-annual or annual check ups and therefore, do not have an idea of what is going on in their body.

"Sometimes, you do not get warning signs. But one thing to notice is if you are getting breathless and having chest, arm, or jaw discomfort while exercising or physically exerting yourself," Kler said.

Moreover, Covid infection as well as its long-lasting effects are

also known to affect heart health.

Abnormal antibody response may raise blood clot risk in Covid patients, resulting in heart attacks and strokes, according to a recent study published in the journal Blood.

"In prevailing times Covid infection may also aggravate the cardiac problems in a cardiac patient, even in post-Covid syndrome cardiac problems are majorly being seen. We need to broaden the perspectives about heart health," Pandey said. The experts added that genetic predisposition or family history is also a factor.

"If you have a family history of heart disease and are above the

age of 25... For example, if someone has a brother who passed away at the age of 35 due to a heart attack, it is imperative that they start going for regular check ups after they turn 25. The body changes and responds differently as we grow, and we need to ensure that we are aware of what is happening inside," Kler said.

However, this does not mean the conventional risk factors including diabetes, high blood pressure, high cholesterol, and smoking does not play a role.

The experts suggested regular health checkups after the age of 30 to detect and reduce risk factors.

### ■ S Korea making powerful missiles

**Seoul:** South Korea is in the final stages of developing a ballistic missile that can carry a warhead of up to 3 tons, Yonhap news agency reported Thursday, as the country unveiled budget proposals aimed at bolstering its defences against North Korea. In its defence blueprint for 2022-2026, the defence ministry said it would develop new missiles "with significantly enhanced destructive power," upgrade missile defence systems and deploy new interceptors against long-range artillery.

### ■ 1st electric train line in Egypt

**Cairo:** Egypt has signed a contract to establish the first line of the electric express train in the country, which will link the Red Sea and the Mediterranean Sea, according to a government statement. Prime Minister Mostafa Madbouly attended the signing ceremony of the contract on the line from Ain Sokhna to Matrouh Wednesday, reports Xinhua news agency. "The 660-km-long line will be designed and implemented with maintenance operations for 15 years valued at \$4.45 billion," the statement added.

### ■ Irish watchdog fines WhatsApp

**London:** Ireland's privacy watchdog has fined WhatsApp a record 225 million euros (\$267 million) after an investigation found it breached stringent European Union data protection rules on transparency about sharing people's data with other Facebook companies. The Data Protection Commission said Thursday that it was also ordering WhatsApp to take "remedial actions" so that its data processing complies with the EU rules. WhatsApp said the fine was out of proportion and it would appeal the decision.

### ■ Rebels surrender in Syria's Daraa

**Damascus:** A new deal to defuse the tension in Syria's Daraa province has come into force, starting with a number of armed rebels surrendering to the authorities, according to state news agency SANA. A number of armed men from the Daraa al-Balad area started a reconciliation process with the Syrian authorities Wednesday, handing over their weapons as part of a new Russian-mediated deal to end months-long tension in that province.

## China bans reality talent shows

**Beijing, Sept 2:** China banned reality talent programmes Thursday and ordered broadcasters to promote more masculine representations of men, in a wide-ranging crackdown on "immoral" pop culture Beijing believes is leading young people astray.

Talent shows that put hundreds of aspiring young performers through rigorous boot camps and subject them to public votes have become massively popular in China, sparking criticism over obsessive fans and poor role models.

"Broadcast and TV institutions must not screen idol development programmes or variety shows and reality shows," China's broadcast regulator, the National Radio and Television Administration said, in a raft of new regulations.

The regulator ordered broadcasters to resist "abnormal aesthetics" such as "sissy" men, "vulgar influencers", stars' inflated pay



and performers with "lapsed morals".

Faced with falling birth rates, Chinese authorities have tried to instill traditional masculine values in the country's youth by ramping up gym classes and criticising male entertainers who model the effeminate looks of Korean pop idols.

Instead, broadcasters were urged to "strongly promote outstanding traditional Chinese culture... and advanced socialist culture."

Video streaming site iQiyi last week said it would cancel all future idol talent shows that are in de-

## Nepal forms team to study boundary dispute with China

**Kathmandu, Sept 2:** In a surprise move, the Nepal government has formed a team to probe the boundary dispute with China.

Shai, who was the elected member of the provincial assembly, raised the voice first about Chinese land encroachment.

Humla shares the long border with Tibet. Indian nationals who visit Mansarovar have to go via Humla district.

## Princess rejects \$1.2M payout before marrying commoner

JAPAN'S IMPERIAL SUCCESSION RULES MEAN THAT 29-YEAR-OLD MAKO WILL LOSE HER TITLE AFTER MARRIAGE TO A COMMONER

**Tokyo, Sept 2:** The course of true love never did run smooth, but after public controversy and a wedding delay Japan's Princess Mako is reportedly set to tie the knot and move to America.

The daughter of Japan's crown prince and niece of Emperor Naruhito has endured years of sniping and stalling over her plans to marry sweetheart Kei Komuro.

The pair have now decided to wed without some traditional ceremonies and reject a payout that usually goes to female royals marrying out of the royal family.

Komuro has still been heavily scrutinised over allegations that his mother borrowed money from a former fiancé and failed to repay it. After tabloid reporting on the claims, a furor erupted around the young couple in a country where the royal family is held to an exacting standard.

The pair postponed their wedding, and Komuro moved to the US for law school in a move that was widely seen as a bid to defuse the negative attention.

Crown Prince Akishino last year said that he supported his daughter's marriage, but that she needed to win the public's "understanding".



But she has apparently decided to get around the issue by marrying without the usual ritual cere-

monies that accompany a royal wedding, and declining a lump sum payment given to female roy-

als who marry commoners.

The size of the payment is unknown, though reports put it at 137 million yen (\$1.2 million) or more.

She is also said to be planning to move to the United States after her wedding, drawing inevitable comparisons with another controversial royal couple: Britain's Prince Harry and Megan Markle.

Mako is sister to Prince Hisahito, 14, currently the only eligible male heir to the throne other than his father as Japan's Chrysanthemum Throne can pass only to male members of the family, and the children of female royals who marry

commoners are not included.

There has been no official confirmation of Princess Mako's plans, but reports have topped news bulletins and sparked a social media frenzy.

Opinion online was split, with some insisting it was still "too early" for the marriage to go ahead.

"I think there are very few Japanese who can celebrate this marriage from the bottom of their heart. I'm so worried about Princess Mako," wrote one Japanese Twitter user. But others lauded the pair's determination, with the Mainichi Shimbun saying their "strong will bore fruit".

**New Delhi, Sept 2:** The oil price rise may have hit the fuel consumers hard, but it is the oil companies that have made the most from the current situation, strengthening their margin on the sale of petrol and diesel and jacking up profits.

At the current prevailing high fuel price levels in the country, the marketing margin taken by the oil marketing companies (OMCs) on retail sale of petrol and diesel has touched a high of around ₹3 per litre.

What this means is that while rising fuel prices earlier burned a bigger hole in the consumers' pockets, the OMCs have increased their



earnings and are getting a lift in the current difficult environment created by the Covid-19 pandemic.

According to a research report from ICICI Securities, oil marketing

companies are expected to strengthen their earnings in July-September quarter of FY22 on the back of rising marketing margin and improved gross refining margin.

The brokerage said that auto fuel net marketing margin has surged to ₹3.08 per litre in Q2FY22-till date from ₹1.43 per litre in Q1FY22 on hefty price hikes and international price fall. Net margin is at ₹2.06 a litre in FY22-TD, at ₹4.42 per litre at latest domestic and international prices, and on track to be in line with, or even higher, than our estimate of ₹2.5 a litre in FY22E, the brokerage said.

The margins for oil companies have risen as diesel and petrol prices were hiked by ₹9.3-11.4 per litre respectively since May 3. The fall in international prices from peak also boosted auto fuel net marketing margin that rose above ₹3 per litre in Q2 of FY22 till date.

ICICI Securities report said though petrol and diesel prices have been cut by ₹0.50-1.25 per litre since August 18, still companies net margin is on track to be in line with or even higher than estimated ₹2.5 per litre.

For all the OMCs, the gain is coming in wake of regular revision of retail price of petrol and diesel since the beginning of the financial year. Since then, the pump price of petrol had increased on 41 occasions. This as per analysts may have hurt fuel consumers but has pushed up marketing margins for OMCs back to about ₹3 a litre. This means companies are gaining from the rise more than expected

India, UK sign up to new climate finance initiative

**London, Sept 2:** The Indian and UK governments Thursday agreed a new tie-up to finance inclusive, resilient and sustainable infrastructure in India by harnessing public and private capital to meet the country's low-carbon goals.

Climate Finance Leadership Initiative (CFLI) India initiative, which is backed by the City of London Corporation and led by Bloomberg's CFLI, was announced at the 11th UK-India Economic and Financial Dialogue (EFD) held via video conference between finance minister Nirmala Sitharaman and her British counterpart Rishi Sunak.

"Supporting India's green growth is a shared priority so I'm pleased that we've announced a USD 1.2 billion investment package, and launched the new CFLI India partnership, to boost investment in sustainable projects in India as the UK gears up to host COP26," said Sunak.

"We expect that the platform would be able to mobilise private capital, at scale, into climate and environment sectors, particularly green and resilient infrastructure," noted Sitharaman.

The aim of the CFLI India project is to drive capital into India through public, private, and multilateral initiatives to help the country meet its 2015 Paris Agreement commitments, which include a pledge to reduce emissions intensity of GDP by 33-35 per cent by 2030.

Apple hit with antitrust challenge in India: Report

**New Delhi, Sept 2:** Apple Inc is facing an antitrust challenge in India for allegedly abusing its dominant position in the apps market by forcing developers to use its proprietary in-app purchase system, according to a source and documents seen by Reuters.

The allegations are similar to a case Apple faces in the European Union, where regulators last year started an investigation into Apple's imposition of an in-app fee of 30% for distribution of paid digital content and other restrictions. The case was filed by a little-known, non-profit group which argues Apple's fee of up to 30% hurts competition by raising costs for app developers and customers, while also acting as a barrier to market entry.

"The existence of the 30% commission means that some app developers will never make it to the market... This could also result in consumer harm," said the filing, which has been seen by Reuters.

Unlike Indian court cases, filings and details of cases reviewed by the Competition Commission of India (CCI) are not made public. Apple and the CCI did not respond to a request for comment.

In the coming weeks, the CCI will review the case and could order its investigations arm to conduct a wider probe, or dismiss it altogether if it finds no merit in it, said a source familiar with the matter.

'Cumbersome regulations forcing startups to leave India'

**Mumbai, Sept 2:** India added three 'unicorns' per month in 2021 to nearly double the overall number of startups valued at over USD 1 billion to 51 as of end-August, a report said Thursday. Even as, cumbersome regulations are forcing startups to leave India and settle in other countries where they enjoy better treatment, as per the Hurun India, which prepared the list.

It can be noted that over the last few years, dedicated efforts have been undertaken to hone the start-ups ecosystem by the government through flagship initiatives like 'Startup India'.

Hurun said the number of gazelles, which are valued over USD 500 million can turn unicorn

in two years, was pegged at 32, while there are 54 cheetahs commanding a tag of over USD 200 million, who can achieve the coveted status in four years, as per the



Hurun India Future Unicorn list. The future unicorns are valued at USD 36 billion, it said, adding that the leap to being a unicorn can also happen swiftly, as seen in five 'cheetahs' which directly jumped into the unicorn club during the last eight months.

Anas Rahman Junaid, managing director and chief researcher at Hurun India, said preparing the list of such companies which get private placements was a difficult task and added that inputs have been taken from venture capital funds. "India is home to more than 600

million internet users and is expected to have 900 million users by 2025. The adoption of the internet in rural areas will further compliment the rise of technology startups. Fintech companies operating in mobile payments, insurance, blockchain, stock trading and digital lending will grow further to capitalise the internet penetration," he said.

At present, India is the third in the list of countries having the most unicorns, trailing the US (396) and China (277), but ahead of UK (32) and Germany (18), it said.

Rahman, however, hinted that the number could have been higher in India because some startups have left the country after achieving a certain scale for better regulations and capital availability.

"Some of the best enterprise SaaS (software as a service) companies are born in India but 'flipped' to the USA. This is a lost opportunity for India and it is important that these start-ups are incentivised to stay back in the country," he said.

Among the future Unicorns, e-commerce player Zilingo leads the list, followed by Mobile Premier League and Rebel Foods.

At a time when debates rage over the importance of pedigree, the list said IITs and IIMs are the biggest bases to churn out successful entrepreneurs, while IIM-Ahmedabad was the favourite post-graduation school with 13 founders in the list.

Bangalore is home to 31 startups in the list, followed by Delhi NCR at 18 and Mumbai trails with 13.



# Pramod sails into semis

"I was in the groove today and playing really well. Oleksandr Chyrkov is a good player and played some good strokes in the match. I am very happy that I have reached the semifinals," Bhagat said.

"Things are going to be tough from here as the knock out stages start. My focus is on one match at a time and also the last league game of the mixed doubles which is a do-or-die situation for us."

Bhagat and Palak Kohli will play Siripong Teamarrom and Nipada Saensupa in mixed doubles class SL3-SU5 Friday.

Other Indian shuttlers, including Suhas Yathiraj, Tarun Dhillon and Krishna Nagar also had a good day in office as they opened their men's singles campaign impressively.

While Suhas and Tarun notched up easy victories over Germany's Jan Niklas Pott and Thailand's Siripong Teamarrom in SL4 class respectively, second seed Krishna outwitted Malaysia's Taresoh Didin in SH6 class. Young Palak also overcame Turkey's Zehra Baglar in her second women's singles match of group A.

The 38-year-old Suhas took just 19 minutes to see off Pott 21-9, 21-



3 in a lopsided group A clash, while Tarun, 27, too didn't break a sweat, beating Teamarrom 21-7, 21-13 in a group B match that lasted 23 minutes.

Krishna then prevailed 22-20, 21-10 over Didin in a 33-minute group B match. While Suhas will

face Indonesia's Hary Susanto and then France's top seed Lucas Mazur Friday, second seeded Tarun will be up against Korea's Shin Kyung Hwan and Indonesia's Fredy Setiawan. The 22-year-old Krishna will take on Brazil's Vitor Goncalves Tavares Friday.

# Shardul saves India the blushes against England

Mumbaikar scores counter-attacking half century to help visitors reach 191 before Bumrah, Umesh reduce the hosts to 53/3 at stumps

**London, Sept 2:** Shardul Thakur's (57, 36b, 7x4, 3x6) counter-attacking half century wasn't good enough to save the Indian batting from another embarrassment before Jasprit Bumrah's (2/15) menacing opening spell kept the visitors on an even keel against England on the opening day of the fourth Test.

At stumps, England were 53/3 in response to India's 191, having lost openers Rory Burns (5) and Haseeb Hameed (0) to the extra pace and bounce generated by Bumrah.

Umesh Yadav (1/15) then bowled an off-cutter in his second spell to breach in-form Joe Root (21)'s defence which helped the visitors end the day on a high note.

That Indian shoulders didn't droop after being reduced to 127/7 was all because of a man playing only his fourth Test.

Justifying his tag as a bowling all-rounder, Shardul smashed a half century and added 63 for the eighth wicket with Umesh to take the total closer to 200 which had looked improbable after another 'brain fade' dismissal for Rishabh Pant.



India lasted just 61.3 overs with Cheteshwar Pujara (10) and especially Ajinkya Rahane's (14) failures becoming glaring enough and couldn't be papered over by skipper Virat Kohli (50, 96b, 8x4), who played some gorgeous strokes en route his half century. Save couple of half-centuries, none of the Indian batters crossed the 20-run mark.

For England, Chris Woakes (4/55) was splendid in his comeback game and no praise would be enough for the fast-rising Ollie Robinson (3/38), who bowled a couple of beauties to get rid of KL Rahul and Kohli.

Anderson bowled one of his classic 'in-out' (swinging in and slapping out) delivery to send Pujara back and Rahane was Overton's victim with Moeen Ali not even

required to bowl a single over.

With Ravichandran Ashwin being sidelined for the fourth time, the logic of playing Ravindra Jadeja as a batting all-rounder has partially backfired after team management promoted him to No.5 ahead of Rahane and the move flopped big time.

For Rahane, the time is simply running out after yet another failure and the fact that he needed to be hid behind Jadeja under the pretence of having a left-right combination, said it all.

As far as Pujara is concerned, an expert of Sunil Gavaskar's stature has pointed out that his dismissals are a result of technical problems with hands moving towards the ball with minimal feet movement.

Anderson got one to nip back in the air as the batsman shaped to play an inswinging and by the time it landed it moved a shade away to take Pujara's outside edge. The balance was all awry and result was a simple catch to Bairstow behind the stumps.

The skipper was the only one among the three middle-order big guns who looked like batting with some purpose. But when Robinson came back for his post-lunch spell and bowled one on the length which climbed as well as moved inward forcing Kohli to close the bat face for a shot towards mid-wicket. But all it did was to clip the outside edge into Bairstow's gloves.

If promoting Jadeja was a poor call from captain, it's about time that his young turk Pant (9) gets a rap on the knuckles for his distinct lack of game awareness which has been visible throughout this English summer.

Just when the situation needed some discretion from him, he was regularly charging out without much results and the wily Woakes got his number with a slower delivery, keeping the mid-off back.

It was then left to Shardul, who just trusted the bounce and hit through the line just when the pitch got a bit better. A six over long-off, one over deep mid-wicket and best – a pull-shoot off Robinson to bring up his second half-century had the crowd in raptures.

In women's singles class SU5 class, Kohli beat Zehra 21-12, 21-18 in 27 minutes. She had lost her opening match to Japan's Ayako Suzuki.

Earlier in the day, the 19-year-old Kohli and her partner Parul Parmar, 48, went down 7-21, 5-21 to second seeded Chinese pair of Cheng Hefang and Ma Huihui in a group B women's doubles SL3-SU5 class match. The Indian pair will square off against the French duo of Lenaig Morin and Faustine Noel Friday.

Parmar, who competes in SL3 class, was no match for China's Cheng Hefang, losing 8-21, 2-21 in 18 minutes in a women's singles group D match at the Yoyogi national stadium here.

Parmar gave a better account of herself in her next match against Katrin Seibert but the German managed to grind out a 21-23, 21-19, 15-21 win to shut the doors on the Indian.

### Prachi qualifies for Canoe sprint semis

**TOKYO:** India's Prachi Yadav on Thursday qualified for the semifinals of canoe sprint event in women's Va'a single 200m at the Tokyo Paralympics here. The 26-year-old from Bhopal recorded a time of one minute, 11.098 seconds - 13.014 seconds behind leader Great Britain's Emma Wiggs (58.084s) in class VL2 heat 1 at the Sea Forest Waterway here. The semifinal will be held Friday. Yadav, who has paralysis below her waist, has competed in Para swimming at the national level as well but took up canoeing on the recommendation of her coach Virender Kumar.



### INJURED ARUNA OPTS OUT OF REPECHAGE



**TOKYO:** India's Aruna Tanwar was Thursday forced to withdraw from the repechage round of the Paralympics women's taekwondo K44-49kg class here because of severe injuries sustained during her opening bout of the Games despite which

she fought in the quarterfinals. Aruna was scheduled to feature in the repechage round later in the evening after she lost to fourth-seeded Espinoza Carranza of Peru in the quarters. But it turned out to be an anti-climax for the 12th seeded Indian as a possible hit on her right foot during her opening round 29-9 win over fifth seed Danijela Jovanovic of Serbia drew curtains to her campaign. "Sorry to inform that our Tigress has got injured in her bout. Suspected hair line fracture. She won her first match with a great margin but we could notice the energy missing in second one. Swelling has increased and needs medical attention," said Paralympic Committee of India President Deepa Malik.

### RAHUL ENDS 5TH IN MIXED 25M PISTOL

**TOKYO:** Indian shooter Rahul Jakhar signed off fifth in the P3 mixed 25m pistol SH1 event of the Paralympics here Thursday. The 35-year-old Jakhar was eliminated at the end of the seventh series in the finals after qualifying second with a score of 576, which included 284 in precision and 292 in the rapid stage. It is by far his best international performance. Athletes in SH1 pistol competitions have an impairment affecting one arm and/or the legs, resulting from amputations or spinal cord injuries. The other Indian in fray, Akash, could not qualify for the finals after ending 20th in the qualifications with a score of 551 (278 in precision and 273 in rapid). The mixed event features both male and female shooters with the top eight qualifying for the finals.



### Arvind finishes 7th in shot put event

**TOKYO:** India's Arvind ended seventh in the men's shot put F35 event of the Paralympics here Thursday. Making his debut at the Games, the 28-year-old's best effort was a 13.48m throw in the eight-strong field. The gold medal in this event went to Uzbekistan's Khushniddin Norbekov, who produced a season's best effort of 16.13m. Argentina's Emanuel Urrea claimed the silver with a 15.90m throw, while the bronze went to China's Fu Xinhan (15.41m, season's best). The F30 classes are for athletes with coordination impairment (involuntary movements, uncoordinated movements and/or muscle tension) often due to cerebral palsy or brain injury. In F35 category of this classification, athletes compete in standing position. Arvind had lost use of his left leg after he was hit on his head by a ball as a child leading to nerve damage.

# STEPHENS OVERPOWERS GAUFF

**New York, Sept 2:** Three years ago, a reporter asked Sloane Stephens to point out a younger tennis player most fans might not have heard of yet, someone she thought could become a household name some day. Stephens paused to ponder, but not for long, before responding: Coco Gauff, then 14. Stephens had first met Gauff several years earlier and clearly knew what she was talking about. The world would quickly discover Gauff, too.

The pair of friends met in an official match for the first time Wednesday night at the US Open, and it was Stephens, the 2017 champion now ranked 66th, who pulled away for a 6-4, 6-2 victory over Gauff, now 17 and seeded 21st.

Afterward, the pair met at the net for a warm hug, before Stephens praised the player — and person — Gauff has become.

With the Ashe roof shut during a heavy downpour — a tornado warning was in effect in the region — the thump-thump-thump of the

rain created a bass beat that drowned out the usual sounds of a tennis match. It was so loud Stephens could barely hear the questions during her on-court interview.

Only one other court at Flushing Meadows can be covered during bad weather, but even that was an issue Wednesday evening, because

wind helped push rain through the space between the concourse and the retractable cover at Louis Armstrong Stadium.

So the match between two-time major finalist Kevin Anderson and Diego Schwartzman was delayed for nearly a half-hour at 5-all in the first set while workers used

air blowers to dry the playing surface. Scheduled for later in Armstrong was three-time Slam champ Angelique Kerber against Anhelina Kalinina, with the winner taking on Stephens. And last in Ashe was French Open runner-up Stefanos Tsitsipas against Adrian Mannarino, looking to join other men who moved on such as No.2 Daniil Medvedev and No.5 Andrey Rublev.

The conditions didn't matter at all to defending champion Naomi Osaka, who advanced earlier in the day when her second-round opponent, Olga Danilovic, pulled out of the tournament because of what she said was a viral illness — but not COVID-19.

Other past major title winners Simona Halep, Garbine Muguruza and Victoria Azarenka moved on more conventionally with straight-set wins. Muguruza next faces Azarenka, who in addition to a pair of Australian Open trophies is a three-time runner-up at the US Open, including when she lost to Osaka in the final a year ago.

# Record-breaker CR7 lifts Portugal

**Faro (Portugal), Sept 2:** Cristiano Ronaldo missed a penalty but still broke the men's international scoring record before adding a second goal as Portugal beat visiting Ireland 2-1 in World Cup qualifying.

Ronaldo grabbed his 110th goal in the 89th minute Wednesday to move ahead of former Iran striker Ali Daei. Six minutes into stoppage time, Ronaldo made it 111 in 180 games to break Irish hearts after defender John Egan gave his nation the lead in the 45th.

"I'm very happy, not only because I beat the record but for the special moments that we had,"

Ronaldo said. "Two goals at the end of the game is so tough, but I have to appreciate what the team did. We believed until the end."

But Ronaldo, who has returned to join Manchester United, is still 76 goals behind the game's most prolific international scorer, Christine Sinclair, who is 38 years old, scored her 187th goal for Canada last month at the Tokyo Olympics.

Ronaldo's night had been frustrating until the late heroics. His 15th-minute spot-kick was well saved by goalkeeper Gavin Bazunu, who was just two years old when Ronaldo scored his first for Portugal as a skinny winger at the 2004 European Championship.
