1 dead, 20 missing in Assam boat mishap

Jorhat/Guwahati: One person was killed and 20 others have gone missing Wednesday after private boat 'Ma Kamala' with over 120 people on board sank in the Brahmaputra river. The disaster took place when the boat collided with government ferry 'Tripkai' near Nimati Ghat in Jorhat district of Assam, officials said. The boat capsized and sank," informed an official of the Inland Water Transport (IWT) department. He also informed that even though 20 are still missing, many others have already been rescued.

MINING SCAM ROCKS ASSEMBLY

Bhubaneswar; Sept 8: Opposition BJP and Congress stalled Assembly proceedings and gheraoed Speaker Surjya Narayan Patro in his chamber for rejecting an adjournment notice on mining scam, here Wednesday, The Congress had moved the notice for a discussion on the mining scam in Odisha. However, the speaker turned it down. The pre-lunch session saw no business as the Congress and BJP members rushed to the Well of the House protesting against the Speaker's refusal to allow the adjournment motion. Their actions forced the Speaker to adjourn the Assembly twice till 4 pm. As soon as the House assembled for the day at 10.30am, Congress members protested against the rejection of the adjournment notice. BJP members also stood up on their seats and created ruckus on

Suicide bid before **House turns fatal**

The victim alleged he was denied treatment under BSKY due to apathy of the hospital authorities after he was injured in an accident last year

Bhubaneswar, Sept 8: Odia youth Dusmanta Das, who attempted suicide Wednesday in front the Odisha Assembly, died in the evening while undergoing treatment at the SCB Medical College and Hospital (SCBMH) in Cuttack. Dusmanta had slit his wrist and consumed poison over alleged denial of treatment under Biju Swasthya Kalyan Yojna (BSKY). He belonged to Kujang locality of Jagatsinghpur district.

Dusmanta had alleged medical negligence at various hospitals where he went for treatment. He said that his life had turned into a living hell after he suffered grievous injuries to his left leg in an accident. This incidentally is the first time that a suicide attempt in front of the Odisha Assembly has turned fatal. In the morning, an injured

use my BSKY card to get treatment up to Rs 5 lakh, I went to a private hospital February 2 this year. There I was informed that the surgery on my leg was incorrect," he added.

Dusmanta also said that the private hospital told him to get a written consent from the Health department so that he could avail treatment under BSKY. Dusmanta then wrote to Chief Minister seeking his assistance for treatment.

Coming to know about his plight. the Health and Family Welfare department directed SCBMH authorities to readmit Dusmanta and start his treatment under BSKY. But he again faced official apathy.

Bhubaneswar, Sept 8: Para shuttler Pramod Bhagat, who won a gold medal in the SL3 category of the Tokyo Paralympic Games will be presented with a cash award of ₹6 crore. He will also be eligible for a Group-A state government job, the Sports and Youth Services department announced Wednesday. Bhagat will be handed over the cheque by Chief Minister Naveen Patnaik on his arrival in the state Capital, the department added.

"The Odisha government is committed to support sportspersons and para sportspersons to achieve their potential. Chief Minister Naveen Patnaik had announced cash awards for achieving medals in the Olympics and Paralympics – ₹6 crore for gold medal, ₹4 crore for silver medal and ₹2.5 crore for bronze medal," the department said in a statement.

Covid cell to monitor NDA doors finally open for women schools

Bhubaneswar, Sept 8: With the number of Covid-19 infections rising in some schools across the state, the Odisha government has constituted a special cell to monitor the cases, officials said Wednesday. The Odisha School **Education Programme Authority** (OSEPA) has issued an order for this purpose. As per the order, a Covid-19 monitoring cell has been constituted in the office of the state project director (SPD), OSEPA with the command control centre.

The officials engaged in the cell will collect the daily attendance of the Classes - IX, X, XI, XII and monitor various Covid-19 related incidents in the districts. They will then submit reports on a daily

basis to SPD, OSEPA. The government has also asked all district education officers (DEOs) to constitute a Covid-19 monitoring cell at the district-level as soon as possible. All the DEOs have been asked to appoint a senior person as Covid compliance officer. These officers will ensure implementation of Covid-19 protocols in the schools.

OVER 69K TEACHING POSTS LYING VACANT

BHUBANESWAR: A total of 69,369 teaching posts are lying vacant in various Government schools and colleges across Odisha. Among them, 68,362 belong to primary, upper primary and secondary schools alone, the concerned Ministers informed the House during the Monsoon Session of the Odisha Assembly. Replying to a question raised by MLA Amar Satpathy, School and Mass Education Minister Samir Ranjan Dash said 14,125 sanctioned posts in secondary schools and 54,237 in upper primary schools are lying vacant.

New Delhi, Sept 8: In a historic move, the Centre told the Supreme Court Wednesday that women will be admitted into the National Defence Academy (NDA) for permanent commission into Armed Forces. The government, however, said it needs some time to frame guidelines to pave the way for women to take NDA courses. The Supreme Court has told the centre to file its reply by September 20.

"We are extremely glad to know that the Armed Forces took the decision to induct women into the NDA. We know that reforms cannot happen in a day. The government will place timelines of the process and the course of action," a Supreme Court bench comprising Justice SK Kaul and Justice MM Sundresh, said. The bench was hearing a petition for allowing women to take NDA and Naval Academy exams.

Additional Solicitor General Aishwarya Bhati, appearing for the Centre, told the bench that a decision has been taken at the highest level of the Armed Forces as also the government that females will be inducted for permanent commission through the NDA.

The ASG sought the apex court's permission to place the details on record through an affidavit and sought status quo in this year's exams as they need procedural and infrastructural changes.

"I am happy that the heads of Armed Forces have taken a positive decision. Put on record, we will take up the matter. We are happy

Wednesday's announcement comes less than a month after the Supreme Court, in a landmark interim order, said women can sit for the NDA admission exam, which has been rescheduled for November 14.

The apex court was hearing a plea filed by advocate Kush Kalra which raised the issue of exclusion of eligible and willing female candidates from joining the prestigious National Defence Academy (NDA) solely on the ground of sex which allegedly is a violation of fundamental right of equality.

The plea said the authorities allow unmarried male candidates having adequate 10+2 qualification to take the 'National Defence Academy and Naval Academy' examination'. However, eligible and willing female candidates are not allowed to take the examination on the sole ground of their sex and without any reasonable or justifiable explanations within the Constitution.

It alleged that this act of discrimination is a 'dishonour committed' by the concerned author-ities to the Constitutional values of equality and non-discrimination.


Puri, Sept 8: The Shree Jagannath Temple Administration (SJTA) Wednesday decided to extend the 'darshan' timing by two more hours and allow devotees to visit the 12th century shrine Saturday.

While the devotees were allowed to have darshan of the sibling deities - Lord Balabhadra, Devi Subhadra and Lord Jagannath - from 7 am to 7 pm earlier, now the closing timing will be 9 pm.

As the state government has lifted the weekend shutdown provision from Puri town, the SJTA decided to keep the temple open Saturday also, However, the shrine will remain closed Sunday for sanitisation in view of the Covid-19 situation.

The temple reopened for the people August 23 after remaining closed for about four months in view of the second wave of the pandemic.

The decisions were taken at a meeting held here under the chairmanship of Srimandir chief administrator Krishan Kumar to review and revise the SOP notified August 11 for reopening of the shrine. The meeting was attended by the senior officials, including Puri Collector and SP. and servi-

"The new SOP will come into force from September 13. The issue will be reviewed again for the month of November 2021 or as required from time to time" Kumar said.

As per the decisions, the temple will also remain closed on major festivals in order to avoid any spike in transmission of Covid-19 on account of large gathering, the new SOP said.

The SJTA also urged the devotees not to touch statues or idols inside the temple. Lighting of deepas (lamps) inside the temple at the designated place by the devotees will be permitted and the devotees were permitted to carry flowers/ bhoga inside the temple but such items shall be placed at predesignated places as earmarked by the temple administration.

The new SOP also allowed devotees to partake Mahaprasad at a designated place inside Ananda Bazar while it banned carrying polythene bags inside the temple. A fine of Rs 100 will be levied for each violation.

There will be a separate queue for differently-abled devotees, for darshan of the Lords, it said, adding that senior citizens, children, persons having co-morbidities and pregnant women are advised not to visit the temple in view of the prevailing Covid-19 situation.

"All devotees visiting the temple will have to produce the final certificate for Covid-19 vaccination (of having taken two doses) or Covid-19 negative certificate (RT-PCR) obtained within 96 hours prior to their visit to the temple,' the SOP said, adding that all devotees will be required to bring their photo ID card.

Bhubaneswar, Sept 8: Amid uproar by Opposition BJP and Congress members for rejecting an adjournment motion on mining the scam, the Assembly Wednesday passed four Bills including the Odisha Panchayat Laws (Amendment) Bill, 2021.

The Odisha Grama Panchayat Act, 1964, the Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991 have been amended to reserve maximum 50 per cent seats in Panchayati Raj Institutions (PRIs) for SC, ST and Backward Class of Citizens (BCC).

As per provisions in the old Acts, in some of the PRIs, the reservation for SC, ST and Backward Classes exceeded 50 per cent. However, the Orissa High Court, in accordance with the judgement by the Supreme Court, had directed the Odisha government to cap reservation within 50 per cent.

"In view of the above decisions of the courts, the Odisha govern-



ment is left with no other option but to amend the relevant provisions of the Odisha Grama Panchavat Act, 1964, the Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991," Panchayati Raj and Drinking Water Minister Pratap Jena said in a statement.

Therefore amendments of the above three Acts have been made to fix the upper ceiling of reservation of seats for SC, ST and BCC to 50 per cent and the upper limit of reservation of seats for BCC

The reservation ceiling will not be applicable for the areas coming under **Panchayat Extension to Scheduled Areas Act**

not to exceed 27 per cent, Jena added. However, the reservation ceiling will not be applicable for the areas coming under Panchayat Extension to Scheduled Areas (PESA) Act.

The House had passed Tuesday the Odisha Municipal Laws (Amendment) Bill 2021 to keep the overall reservation in the urban local bodies (ULBs) up to 50 per cent.

The state Assembly has also passed the Odisha Government Land Settlement (Amendment) Bill, The Indian Stamp (Odisha Amendment) Bill and the Odisha Housing Board (Amendment) Bill without participation of the BJP and Congress members.

AAI likely to stall City airport expansion plan

Bhubaneswar, Sept 8: A plan to expand the Biju Patnaik International Airport (BPIA) here in view of increasing traffic is likely to be scrapped due to non-availability of land as demanded by the Airport Authority of India (AAI).



As per sources, the city which had been haning 40 lakh passengers annually during pre-Covid period was slated to increase its capacity to meet the increasing traffic. After formulating a blueprint for expansion, the AAI informed the BPIA authorities that the plan would need an additional 64 acres of land. "After several rounds of talks with the state government, we had placed our demands for additional land. The plan included extension of the runaway from 9,000 feet to 10,500 feet. This would have catered to operation of special cargo planes and bigger passenger jets like Boeing 777 and Boeing 747," a BPIA official said.

However, the state government in 2017 had clarified that it would only be able to provide 47 acres under the possession of Odisha University of Agriculture Technology (OUAT). Meanwhile, the government also proposed to AAI to develop an alternative Greenfield International Airport on City outskirts as the BPIA did not have scope for expansion due to rapid urbanisation in surrounding areas.

Following this, the AAI examined three sites within 20-25 km radius of state capital. The state government had identified land at Malipada, Jankia, Tangiapada and Badasahi in Khurda district for establishment of the Greenfield Airport project. However, the feasibility test conducted by the AAI found that these suggested sites are not suitable.

Meanwhile, with the availability of about 1,500 acres of land in Girala village of Puri the authorities have decided to drop the state capital's airport expansion plan. "AAI is now prioritising development of the existing infrastructure and improving passenger serv ice at the BPIA. A parallel taxi track construction is underway. We will also recarpet the existing runway very soon," the official added. It can be mentioned here that presently the BPIA which operates about 47 flights a day can handle arrival and departures of 12 to 13 aircraft in an hour. Once the parallel taxi track is built, the capacity will go up to 25 aircraft per hour. This will result in flights not waiting on the runway for take-off for long periods

Decision on Durga idol height likely in 2 days

Bhubaneswar, Sept 8: The Odisha government Wednesday assured Durga Puja committee representatives of Cuttack that it will reconsider its earlier decision on restricting the height of idols, according to a BJD leader. While the decision regarding the height of idols will be taken in two days, the decision for covering puja pandals will be made in October, said sources.

The government will decide on this by Ganesh Puja which falls September 10 this year, Cuttack Mahanagar Puja Committee secretary and BJD leader Pravat Tripathy The opposition wondered how restricting the height of Durga idols to four feet will help contain the Covid-19 spread

said after a meeting with the state administration comprising Chief Secretary S C Mahapatra and Special Relief Commissioner (SRC) P K Jena here.

The opposition parties had criticised the puja guidelines, wondering how the restriction on the maximum height of Durga idols to four feet in community pujas will help contain the spread of Covid-19.

On the other guidelines which asked the puja committees to cover three sides of pandals, Tripathy said, a decision in this regard will be taken in October based on the Covid-19 situation then.

'The outcome of the discussions was positive. While the decision over the height of idols will be taken in two days, the decision for covering puja pandals will be made in October," said Debendra Sahu, secretary, Cuttack Peace Committee.

The opposition Congress Tuesday created a ruckus in the House over the state government's decision to restrict the maximum height of Durga idols.

Speaker Surjya Narayan Patro had said that the government may reconsider the demands made by puja committees.

Covid recovery nears 10L-mark

Bhubaneswar, Sept 8: The state registered 762 fresh Covid-19 cases and eight fatalities in the last 24 hours, a senior Health official said Wednesday.

Of the new Covid patients, 102 are in the 0-18 age group. However, the infection rate among the children slightly dipped to 13.38 per cent Wednesday from 14.57 per cent on the previous day

While the fresh infections reported in 29 of the 30 districts pushed the state's caseload to 10,13,567, eight new deaths took the state's toll to 8,070.

The second wave of the pandemic has claimed the lives of 39 children, with 13 deaths being reported between August 10 and 31.

Of the 762 new cases, 443 were reported in quarantine centres, while 319 infections were detected during contact tracing.

Khurda district, under which Bhubaneswar falls, registered the highest number of new cases at 314, followed by Cuttack (119). Boudh did not report any fresh infection.

Dhenkanal and Khurda districts registered two fresh fatalities each. while one death each was reported in Angul, Balasore, Keonjhar and Koraput. Fifty-three patients have

CUTTACK: The Orissa High Court has pointed out several discrepancies in a government affidavit regarding the deaths due to the coronavirus pandemic. Government figures showed

that the state recorded 3.097 deaths only in 47 days between July 15 and August 31 this year. "Earlier, it was reported that

there were 4,925 deaths as of July 15, 2021," the court said Tuesday.

"(But) the affidavit of September 6, 2021, shows there were 8,022 deaths in Odisha due to the pandemic as on August 31, 2021," it said. The court questioned the manner in which these figures have been arrived at.

BJP hits streets over power tariff hike

Bhubaneswar, Sept 8: The BJP staged a protest in front of the Assembly Wednesday against the "unreasonable" hike in electricity prices in the state.

Hundreds of BJP members -some of them on motorcycles and atop cars - marched from the Master Canteen in Bhubaneswar to the Assembly, where the monsoon session is underway.

Carrying party flags, the BJP activists raised slogans against the BJD government and demanded rollback of the hike. Some of them even scuffled with the police as they tried to break through the barricades.

"For the past one year, the state government has been burdening the consumers through subsequent tariff hikes of 20 paise and 30 paise," Bhubaneswar BJP presi-

dent Babu Singh told reporters. The Odisha Electricity Regulatory Commission (OERC)

had raised the power tariff by 20 paise in October and 30 paise per unit in April.

Singh said it was unfortunate that Mishra could not write to the OERC even after four months, wondering why the minister was "so helpless" in standing with the people.

Singh warned that they would take the agitation to a logical conclusion if the hike was not rescinded.

BJP leader Dilip Mohanty said they came on the streets to protest against the "economical torture' of the BJD government, adding that the party would not tolerate "loot" of the poor people's money. Mohanty asserted that agitation

would be taken to every ward and panchayat, and there would be a 'satyagraha" until the government restored the old rates.

MGNREGS FRAUD Dead drawing wages in Malkangiri

Malkangiri, Sept 8: Dummy job cards were made in the names of deceased persons indicating massive irregularities in the implementation of rural job scheme at Padmagiri and Udupa panchayats under Sadar block in this district, a report said.

Parimal Biswas, a native of MV-102 village in Padmagiri panchayat, passed away in 2007. However, a job card still exists in his name and in the names of Premadasi Biswas and Rekha Biswas. two of the surviving members in his family

Locals Ashok Vaidya, Krushna Madkami and Debashis Majumdar alleged that some people who are no more still figure in the muster rolls and wages are being drawn against their names. A vested interest group comprising unscrupulous officials and political persons are behind this racket. They alleged that the officials instead

of employing needy persons in the area had taken out job cards in the names of deceased people and are depositing their wages in the accounts of their relatives which is later withdrawn by them. They demanded a high level inquiry into the irregularities and action against the guilty.

Reports said Parimal Biswas, a native of MV-102 village in Padmagiri pan-



chayat, passed away in 2007. However, a job card still exists in his name and in the names of Premadasi Biswas and Rekha Biswas, two of the surviving members in his family.

The wages in the name of Parimal Biswas are processed every month and deposited in the account of Rekha Biswas (job card no-6471). The three have been shown working under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).

Similarly, another villager Mukund Haldar in the same village died February 17, 2015. It was found that wages accruing to his job card no-6465 have been deposited in his bank account at Utkal Gramya Bank branch at Padmagiri May 25, 2021.

Moreover, water conservation proj-

ects are being implemented on shallow land in both the panchavats. Job card holders are required to dig up 1,400 pits measuring 10/3 feet width and 2.5 feet depth. The officials have prepared bills of 1,400 pits while only 400 pits have been dug up. It is alleged that this work is being implemented

by involving non-labourers. Notably, both the Centre and the state are spending crores of rupees to provide jobs to the rural populace under the MGNREGS through one job card to each family.

However, due to lack of proper utilization of funds, genuine beneficiaries are deprived of jobs forcing them to migrate to other states for work

Reports said over 30,000 people from the district migrate to neigh-

Andhra Pradesh bouring Chhattisgarh, Maharashtra and Telangana every year due to lack of employment opportunities. They go with hope of getting jobs, but end up being tortured.

The district administration has been making all efforts to provide employment to these people and spending funds for the purpose. Jobs can be created in plantation work and water and soil conservation projects.

However, due to unscrupulous officials, vested interest groups reap the benefits of the job schemes.

When contacted, Malkangiri BDO Ajay Kumar Pradhan said the allegations will be investigated and action will be taken against the officials concerned if charges against them are found true.

Balasore admin halts unlawful construction by West Bengal

Bhograi, Sept 8: After a hiatus, the West Bengal government reportedly intruded into Odisha borders near Udaypur beach under this block in Balasore district. It has unlawfully constructed a boundary wall

Meanwhile, officials of the district administration took stock of the situation and stopped the work Wednesday. ADM Bhabesh Nayak, Bhograi additional tehsildar Santosh Panigrahi and some people's representatives visited the area and directed Bengal people to halt construction work.

Notably, parts of a watch tower and a boundary wall on the Udayapur beach collapsed during cyclone Yaas. The WB government started construction of the boundary wall by intruding almost 50 feet into



Odisha's territory.

When locals opposed it, both sides mutually agreed in 2011 that no government will construct anything in the disputed area. But this time around, the West Bengal government violated the agreement and intruded almost 50 feet into Odisha's border, locals said.

As for the issue, ADM Bhabesh Nayak, said, 'Construction was halted. We will take up the matter with our counterparts in East-Midnapore district. The dis-

pute has to be resolved through talks."

He added that any unauthorised construction in the disputed area will not be allowed. West Bengal has made several attempts in the past to encroach upon fringe areas near Udaypur. In February this year, a meet-

ing of top officials of Odisha and West Bengal governments was held at West Medinipur to discuss modalities for settling the disputes arising in several bordering villages in Jaleswar and Bhograi blocks.

FAULTY BENEFICIARY LISTS **Over 8K families** left out of PMAY POST NEWS NETWORK

Bari, Sept 8: Poor families are provided with housing units under the Pradhan Mantri Awas Yojana(PMAY) and the Biju Pucca Ghar Yojana. However, many such families in Bari block of Jajpur district have been deprived of these entitlements due to faulty lists of beneficiaries prepared by the administration, a report said.

According to the report, officials in the panchavats have been asked to ensure provision of housing units to eligible people. In many cases, rich people have grabbed dwelling units while the poor keep waiting for them.

Bari BDO had issued a letter (2417, dated July 14, 2021) to officials looking after implementation of the rural housing schemes to check if 8085 families in 29 panchayats are eligible to get PMAY housing units.

When officials made field visits as prt of the investigation, people alleged many eligible people had been left out of the lists. Later, people approached the block administration and sought inclusion of their names in the lists. The block administration made it clear that people eligible for getting housing benefits can apply again. Many also applied for housing units. It was learnt that Umar Ali of Milimilapur in Bainsiria panchayat, Madhabananda Mallick of Balibili panchavat and Shibabrata Jena of Rampa panchayat among hundreds of people have been left out of the beneficiary lists even though they are eligible to get houses.

Biden's Nightmare

t is far from clear that President Joe Biden deserves the obloquy heaped on him for the US evacuation from Afghanistan. This is especially true given the endings of other American wars, and the nearly impossible situation confronting him - in particular, that the Kabul airport is located within a city of millions which had just come under Taliban control.

The repetitive airing of scenes of panicked Afghans clinging to C-17 cargo planes after this was no longer happening made for far more dramatic scenes than the smooth take-offs that followed during the next 17 days of evacuation, yet news programmes kept rerunning those chaotic images, creating an impression of Biden as hapless. Yet, some 120,000 US people - including troops of US allies as well as Afghans who had helped the US cause - were evacuated by air from Kabul, a logistical triumph.

Since Biden chose to end the evacuation by August 31, the date he had set, a few hundred Americans – some not ready to depart, many unable to reach Kabul airport-as well as hundreds of Afghans who had worked with the United States, were left behind. (A few have been evacuated since.) But Biden faced only bad choices. Had he prolonged America's presence, US troops and those of allies would have been put at more risk, especially from the murderous Islamic State (ISIS) offshoot that had begun a campaign of suicide bombings.

The retreat from Afghanistan has revealed much about the nature of the government that Biden is running and how he runs it. Although Donald Trump - who also wanted to get out of Afghanistan - left Biden with an unworkable settlement with the Taliban, Biden's decisions on withdrawal were mostly buttressed by his longheld belief that, when al-Qaeda was driven out of Afghanistan and Osama bin Laden killed, America's strategic needs had been met. Despite his deep convictions about the correctness of his decisions. Biden brought trouble on himself by offering cheery predictions – such as that the Afghan government wouldn't fall any time soon. When that proved unrealistic, Biden became defensive, even belligerent, which dented his reputation as a nice guy.

Another factor that may have played a role in shaping Biden's Afghan policy is the striking difference in the nature of the president's foreign and defence policy team and his team of domestic policy advisers. The latter is comprised of former mayors, governors, members of congress, and at least one business executive – people of independent standing. But Biden's

national security team is dominated by former aides. The soft-spoken Secretary of State Antony Blinken is a loyal, longtime Biden adviser. National Security Adviser Jake Sullivan, a youthful-looking 44, was Biden's national security adviser as vice president. Biden often cites the concurrence of his advisers as confirmation of the wisdom of his decisions, but one gets the strong impression that he makes clear to them what advice he wants.

Secretary of Defense Lloyd Austin does carry an aura of independence and gravitas. Austin speaks slowly and carefully, and with that authority that comes almost naturally to a former four-star US Army general. He projects confidence without drama, and holds his views tight. A senator said, "I wouldn't want to play poker with him." Austin managed the draw-down of American troops in Iraq, where he had worked closely with the president's deceased son Beau, both qualifications that undoubtedly stood him well with the president. (Biden's continuing, and maudlin, invocations of Beau, occasionally at truly awkward moments, are beginning to worry even some of his close allies.)

Republicans, who had been frustrated in their search for an effective means to attack Biden, have seized the opportunity provided by the chaotic withdrawal despite the fact that the decision to end America's 20-year Afghan war was widely popular. Despite this inconsistency on the part of the US electorate, for the first time since the inauguration Biden's job-approval ratings have dipped below 50 per cent. Even some Democrats, their fingers held up to the wind, are planning to ask awkward questions of Biden and his team.

But what, exactly, is Biden to be blamed for? His administration is widely charged with not having planned for an evacuation, but Senator Tim Kaine of Virginia, a Democrat and member of the Senate Foreign Relations Committee, who deals with the White House a lot, told me, "[The administration] had a plan; they just didn't expect to have to implement it so quickly.' Biden's administration, although less rancorous and leaky than most (thus far), does follow in the tradition of military and intelligence leaders differing markedly in their assessments of the quality of the Afghan army. Having spent \$83 billion on training and equipping the Afghan army, the military has tended to view its efforts as a success. The intelligence agencies have been more skeptical. Kaine said, "For years we heard conflicting assessments about the Afghan military. Previous US presidents tended to relay to the public the bright side of America's efforts in Afghanistan. In a ground-breaking series published in 2019, The Washington Post exposed the lies that presidents George W. Bush, Barack Obama, and Trump all told the country, such as how wonderfully the war in Afghanistan was going. Thus, most Americans were unprepared for the sudden collapse of the Afghan army or the flight of Afghan President Ashraf Ghani (with bags of money) when the Taliban strolled into Kabul. Defense Department officials insist that no one warned them that the Afghan army would collapse within 11 days, but this could be a failure of imagination as well as of intelligence. In any event, there is intelligence and then there is how intelligence is interpreted. For example, Bush's administration had received ample evidence that al-Qaeda was preparing to attack the US, even the World Trade Center, but leading figures brushed off the warnings. France, acting on the same intelligence about Afghanistan that the US government had, began to withdraw its troops in 2014.

Reliable access to water became a political imperative, an instrument in state-building.

Most countries that could afford to do so started transforming their water landscapes in the service of the consumer economy and a widening polity. Reclamation projects added cultivable land and broadened economic opportunity. Then came hydroelectric power, the first source of electricity that could be fully scaled to support industrialisation and mass employment. Rivers became blueprints for development.

As cities grew, floods – a tragic fact of life up to that point – became politically intolerable. Unsanitary conditions were swept away by near-universal access to clean water supplies. The shape of the modern landscape slowly

changed as it filled with levees, flood defences, dams, canals, and reservoirs. These were invariably financed by the new economic power of the state and supported by the aspirations of a broadened electorate.

America led the way, delivering some of the twentieth century's most iconic water projects, from the Hoover and Fort Peck Dams to the Army Corps of Engineers' management of the Lower Mississippi River and the Tennessee Valley Authority.

Investments in modern water infrastructure spread around the world, driving planetary-scale transformation. At the beginning of the twentieth century, humanity had virtually no water storage and practically no large dams; yet by the 1970s, infrastructure could catch roughly one-fifth of all runoff on the planet. As people replumbed the landscape-leaving a wide trail of unintended environmental consequences in their wake – a modernist dream was nurtured: finally people could be fully insulated from the effects of a difficult climate.

Over time, many of those living in rich countries simply forgot about all the water flowing behind the dams and levees. Having long since been normalised to the uninterrupted rhythm of the consumer economy, Californians and Germans this year were duly stunned by the violent return of nature. The ca tastrophes they have witnessed had become simply unthinkable for affluent modern societies.

Though floods and droughts routinely afflict hundreds of millions of poor people around the world, these events seldom make the news (the main exceptions being in rich counties, as when Hurricane Katrina devastated New Orleans' poor, mainly African-American. Lower Ninth Ward in 2005). In an echo of the Malthusian fallacy that treats poverty as a symptom of moral failure, the disasters that strike developing countries are dismissed as an inevitable consequence of under development.

But water security is not simply a product of development and political stability. Rather, it contributes to both. Modern economies and stable political institutions were built on the promise of water security and the opportunities that it furnished. Our institutions' increasingly evident failure to fulfill that promise thus poses a direct threat to the civic compact that binds citizens and the state.

The supposedly permanent solutions of the twentieth century are proving inadequate. This century's climate disasters are harbingers of a new relationship with our environment, raising questions that we have not had to ask for many generations. What do we want our landscape to look like? What risks are we able to tolerate? What should we expect of the state when it comes to our environmental security, and what authority does that entail?

These are not technical questions. They are political ones, and they will increasingly occupy center stage in the twenty-first century.

The word moved into late Latin in the sense of something soothing or consoling; at one time it was used for any medicine that had that effect. Later it was applied specifically to a tincture (a solution in alcohol) of opium flavoured with camphor, aniseed and benzoic acid. It was a flavoured – and usually less potent – form of laudanum, a simple tincture of opium. It was used as a medicine to treat diarrhoea and coughing, especially in children.

Allahabad High Court has recently stirred a hornet's nest by observing that "fundamental right is not only the prerogative of beef eaters, rather, those who worship the cow and are financially dependent on cows also have the fundamental right to lead a meaningful life... The right to life is above the right to kill and the right to eat beef can never be considered a fundamental right." He has implored the government to declare the cow as the national animal and make strict laws against those who harm cows. Quoting scientists, the judge further observed that "cow is the only animal that inhales and exhales oxygen."

Cow slaughter is an emotive issue in India because of the animal's status as an endearing and respected living being among Hindus, Sikhs, Jains and Buddhists. When the Constitution was being drafted most of the Hindu members were strongly supportive of a ban on cow slaughter. Mahatma Gandhi was in favour of such a law, while Jawaharlal Nehru was opposed to it. Because of the sharp schism in views, the framers of the Constitution decided to keep the prohibition on slaughter of cow, calf and other milch and draught animals as a directive principle under Article 48, which is not enforceable in the court of law. The preservation, protection and improvement of livestock are the prerogative of the state governments, as they figure as item 15 in the State List. Accordingly, the legal provision of different states widely varies. In Andhra Pradesh, Goa, Kerala, Tamil Nadu, Mizoram, Meghalaya, Manipur, Nagaland, Tripura and West Bengal, where there are sizable Muslim and Christian populations, there is no ban on cow slaughter.

The Supreme Court has been seized of this contentious matter since 1958. The first major case. Mohd Hanif Quareshi & Others vs the State of Bihar came up in 1958, when the Bihar government passed the Bihar Preservation and Improvement of Animals Act, 1955. putting a complete ban on slaughter of cow and her progeny including bulls. The petitioners had prayed before the court that a total ban on cow slaughter would infringe their fundamental rights under Article 19(1)(g), which gives them the right to carry on any

trade or business and Article 25 which protects their religious rights. In a unanimous judgement, the court tried to strike a balance between the fundamental rights and the directive principles. The court prohibited slaughter of cows and calves and other milch cattle which were still having useful life. However, those which were not useful the court felt "maintenance of such useless cattle involves a wasteful drain on the nation's cattle feed." Further it had observed that a total ban will bring about a serious dislocation of the business of butchers, hide merchants and a large section of society.

The Quareshi judgement remained valid till the Gujarat government came up with an Act to completely ban cow slaughter. The matter came up before the Supreme Court in Mirzapur Kasab vs. State of Gujarat in 2005, when the court upheld the Act. The judges focused on the utility of cows and their progeny. Then Chief Justice of India RC Lahoti had famously observed "the value of dung is much more than even the famous Kohinoor diamond." However, justice Mathur in a dissenting note had observed that "if an enactment is made for advancement of directive principles and it runs counter to fundamental rights, an attempt should be made to harmonise the same if it promotes larger public interest.

Ever since the BJP government came to power at the Centre, efforts are being made to divide the people on communal lines. When the government came up with a law in 2017 to confiscate animals of traders, the Supreme Court came down heavily on it. Then Chief Justice of India SA Bobde while asking the government to amend the law had observed "animals are a source of livelihood. People live on the basis of their animals. You cannot confiscate them before the man is convicted. Your rules are arbitrary."

Justice Yadav's call for cow protection as a fundamental right will run contrary to the pluralistic and multi-religious character of India and the right to freedom of what we eat and what trade we take up. Cultural homogenisation is anathema to a liberal democratic society like ours.

Save emperor penguins

Sir, In 2016, the world's second largest colony of penguins in Antarctica lost more than 10,000 emperor penguin chicks. Climate change is threatening emperor penguins with extinction. The penguins live much of the year on the Antarctic sea ice, which is disappearing or breaking apart because of the heattrapping gases released by humans' use of fossil fuels. The penguins need the ice to breed, raise their young ones and escape predators. If listed as threatened, the birds would join two dozen species, including polar bears, two kinds of seals and 20 coral varieties, which the US federal government considers threatened by climate change. A study found that if the sea ice continues to disappear at the rate predicted by climate models given the world's current energy trends and policies, more than 80 per cent of emperor penguin colonies would in effect become extinct by the year 2100. If the world takes swift and drastic actions to reduce greenhouse gas emissions in line with the Paris Climate Agreement enough sea ice will be left to support a reduced, but still viable, population of emperor penguins, the study found. We need to act now, before it's too late. If the sea ice disappears before the young penguins exchange their fluffy baby feathers for the sleek adult ones, they cannot swim in the frigid waters and will perish.

Farmers up in arms over fake fert sold at premium

Mahakalapara, Sept 8: Sale of sub-standard fertilizers at exorbitant prices in this block of Kendrapara district has sparked anger among farmers even as they are facing a crop loss due to scanty rainfall, a report said.

Reports said a drought like condition is prevailing in the block due to scanty rainfall. The farmers have planted saplings and were expecting rain to save their crops. However, lack of rain has seriously hit their cultivation. As they are trying to salvage whatever is left on their farmlands, inflated prices of fertilizers have hit them hard.

Farmers alleged that they have purchased Gromor fertilizers from the open market. But it was found to be of sub-standard when they mixed it with water to apply it on their crops. The fertilizer instead of getting dissolved is floating in water which has made them doubt its quality.

Farmers held the agriculture department responsible for their problem. They alleged that farmers had to buv fertilizers at very high prices due to negligence by the department. This has emboldened unscrupulous traders to carry on with their work with impunity.

On the other hand, farmlands under the block are lying uncultivated due to poor rainfall. Farmers said the only way to save their crops is rain due to low-pressure. However, the block agriculture officials do not visit the villages and take stock of the cultivation when farmers are fighting hard to save their crops.

Agriculture officials and Krushi Sathis (farm consultants) spend their whole day in office for Balaram Yojana that aims at providing financial help up to ₹1.6 lakh each to landless farmers. However, getting a loan under the Balaram Yojana is still a far cry for the share-croppers and landless farmers.

They alleged that they neither have land of their own nor money for which the department officials are neglecting and ignoring them. The only beneficiaries are big land owners and influential persons who have grabbed the benefits of the scheme through manipulation. They alleged most of the lower rung of ficials are involved in fraud.

When contacted, Antarjyami Dhir, block agriculture officer of Marshaghai, said a squad has been formed. The squad members raid fertilizer stores in various areas and collect samples for examination. Action will be taken against store owners if the fertilizer is found to be of substandard quality.

Flood threat in Balasore as Jalaka is in spate

Balasore, Sept 8: Rain triggered by a low-pressure system has been pounding Balasore over past few days, causing the Jalaka river to rise Wednesday morning. Because of the continuous showers in the upper catchment, water levels are expected to rise by 6 pm. This has given rise to a flood like situation in Balasore district.

According to a senior official, the Jalaka river flewat Mathani under Basta block in the district slightly above 5.7 metre early in the morning as against the danger level at 5.5 metre. The river water has been constantly increasing, the senior official said.

People residing in riparian areas of Jalaka river are in panicky. If the present situation continues for a day or two, the entire region will be affected by flood, some locals feared.

If at all a breach occurs in the Jalaka river embankment, as many as five panchavats under Basta block and two panchayats under Sadar block will be inundated, the villagers expressed.

It is pertinent to mention that another low pressure area has been forming over the Bay of Bengal. The regional centre of Meteorological India Department (IMD) has predicted heavy rainfall and thunderstorm activities in several parts of Odisha in the coming days.

Mumbai, Sept 8: The Mumbai civic body has issued fresh guidelines for the Ganpati festival beginning from Friday and has banned physical darshan for devotees at public pandals as well as imposed restrictions on the number of participants in processions during the celebrations.

For bringing the idols of the deity and during their immersion, there will not be more than 10 people in the processions of public mandals and not more than five for the household Ganpatis, the Brihanmumbai Municipal Corporation (BMC) in the guidelines issued Tuesday.

All devotees should wear masks and observe social distancing. Also, the 10 participants should have taken both the doses of Covid-19 vac cine and completed 15 days after taking the second dose, the guidelnes said.

In the wake of a rise in the number of new coronavirus infections and fear of a third wave, the BMC

has banned physical darshan for devotees at the public Ganpati pandals and appealed to citizens to celebrate the festival with simplicity. Considering the potential danger of a third Covid-19 wave, devotees are strictly forbidden from taking darshan. It has been decided that Ganeshotsay mandals should provide darshan facility to devotees through cable network, website, Facebook or (other) social media, the civic body said. The mandals falling in Covid-19 containment zones will have to

make arrangements for the immersion of the Ganpati idols in the pandal premises or postpone it. Similarly, in sealed buildings, devotees will have to make arrangements for the immersion of idols at home, it said.

If a housebuilding is declared a containment zone, the rules for it should be followed during the festival, the BMC said.

The cap on the height of Ganpati idols and restrictions on celebrations have been imposed for the second year in a row.

Vaze and Sharma discussed the implications and decided to 'eliminate' Hiran, and the latter hired a contract killer Shelar who along with the other accused met March 2, and Hiran's presence was ensured to identify him before the prospective killers. 

Bizman turns burglar, blames lockdown-losses

Mumbai, Sept 8: A 45-year-old cloth trader from Solapur allegedly took to committing burglaries and thefts after suffering losses in his business due to the coronavirus-induced lockdown, police said Wednesday.

He was arrested last week in Maharashtra's Solapur city in connection with eight such cases, they said. The accused, identified as Anand Kodam, a resident of Vajreshwari Nagar in Solapur, located about 400 km from Mumbai. was nabbed September 2 when he was on way to sell some ornaments allegedly stolen by him, a police official said.

Kodam was earlier into his familv's cloth business and they used to run a factory in Solapur, he said. In 2018, he parted ways with his family due to some reasons and started living separately with his wife and children.

He then started an independent business of sale and purchase of towels, which was running well, the official said.

However, last year, a businessman allegedly cheated him of ₹8 lakh, due to which he had to take loans and after a few days, had to shut his business in the wake of the lockdown imposed to curb the spread of Covid-19, he said.

After being unable to repay the loans, Kodam allegedly started committing burglaries since August 1 this year, the official said.

His modus operandi was to commit thefts between 11 am and 2 pm and he used to target houses having cast iron locks which could be broken easily, said Solapur Jail Road police station's sub-inspec-



tor Alfaz Shaikh, who nabbed the accused.

According to the official, Kodam had allegedly committed at least but as the accused wore a mask while committing the offences, it was difficult to identify him.

However, in one of the CCTV footage, he was found without the mask and identified, the official said. Accordingly, the police laid a trap September 2 and apprehended him when he was on way to a jewellers' market to sell some of the stolen ornaments, he said.

The official said the accused initially told the police that he had committed only one theft, but later, during questioning, he informed about other six burglaries committed by him in the Jail Road area and one in the MIDC (Maharashtra Development Industrial Corporation) area.

The police have so far recovered gold worth ₹7.60 lakh and ₹1 lakhcash allegedly stolen by him, he said.

Flood situation improves in Assam

Guwahati: The flooding in Assam's Brahmaputra valley receded as rivers running through and into the valley from the Himalayas reported lower water levels. However over 16,000 people remained affected by the current flood in nine districts of the state, according to a bulletin issued by the Assam State Disaster Management Authority (ASDMA). The death toll from the ongoing floods remained static at eight as no fresh casualties were reported Wednesday.

New Delhi, Sept 8: A new report analysed 10 disasters from 2020-21, including Cyclone Amphan in the border region of India and Bangladesh, and found that even though they occurred in vastly different locations and did not initially appear to have much in common, they were interconnected with each other.

The report, Interconnected Disaster Risks 2020/2021 was released Wednesday by the United Nations University - Institute for Environment and Human Security (UNU-EHS)

As shown by the key findings of the recent IPCC Sixth Assessment Report, extreme events,

such as droughts, fires and floods, are increasingly compounding each other, likely as a consequence of human influence. Viewed through a lens of interconnectivity, this new report shows in detail how not only climate disasters, but human-made disasters in general build on the impacts of the past and pave the way for future disasters. The frequency of severe weather events, epidemics and human-made disasters is increasing globally, and it is becoming ever more challenging to keep pace with the corresponding changes and impacts.

In 2020-21, the world witnessed a number of record-breaking disasters: the COVID-19 pandemic spread across the globe, a cold wave



crippled the state of Texas, wildfires destroyed almost five million acres of Amazon rainforest, and Vietnam experienced nine heavy storms in the span of only seven weeks.

By analysing past events through the lens of interconnectivity, both the disasters that are happening right now and those that will happen in the future can be better understood. "When people see disasters in the news, they often seem far away," said UNU-EHS Senior Scientist Zita Sebesvari, a lead au-

thor of the report. "But even disasters that occur thousands of kilometres apart are often related to one another and can have consequences for people living in distant places." An example of this is the recent heatwave in the Arctic and cold wave in Texas

In 2020, the Arctic experienced the second-highest air temperatures and second-lowest amount of sea ice cover on record. The increasing temperature in the Arctic destabilizes the polar vortex, a spinning mass of cold air above the North Pole, allowing colder air to move southward into North America. Thus, changes in Arctic temperature influence locations far away from the Arctic and likely also contributed to the belowfreezing temperatures in Texas, a state that is used to year-round warm weather. Around four million people were without electricity as the power grid froze up, and 210 people died.

Disasters also often occur simultaneously and compound each other, as happened with the COVID-19 pandemic and Cyclone Amphan in the border region of India and Bangladesh. In an area where almost 50 per cent of the population is living under the poverty line, the Covid-19 pandemic and subsequent lockdowns left many people without income options, including migrant workers who were forced to return to their home areasand were housed in cyclone shelters while under quarantine.



Emergencies Min dies during military exercise in Russia

Moscow, Sept 8: Russian **Emergencies Minister Zinichev** has died after he jumped off a cliff trying to save a cameraman who fell during training exercises in the Arctic city of Norilsk, officials and reports said Wednesday.

Yevgeny Zinichev was a member of the KGB security service in the last years of the USSR and his career took off after he served in Putin's security detail between 2006 and 2015

The head of the emergencies ministry, Yevgeny Zinichev, tragically died saving a person's life at inter-agency drills in the Arctic, the ministry said in a statement carried by Russian news agencies.

Margarita Simonyan, editor-inchief of the state-funded news out let RT. said the 55-year-old minister had died as he tried to save a cameraman who fell off a cliff.

About Zinichev, she wrote on Twitter. He and the cameraman were standing at the edge of a cliff. The cameraman slipped and fell... Before anyone even figured out what happened Zinichev jumped into the water after the fallen person and crashed against a protruding rock.

Zinichev was a member of the KGB security service in the last years of the USSR.

He held a number of high-profile jobs, briefly serving as acting governor of Russia's exclave region of Kaliningrad and then as deputy head of the Federal Security Service (FSB).

As head of the emergencies ministry, he held one of the highest-profile cabinet jobs, dealing with natural and man-made disasters and other rapid-response situations across the vast country.

The two-day drills he was participating in across several Arctic cities including Norilsk, kicked off Tuesday and involved over 6.000 people.

Fire kills 41 inmates in Indonesian prison

Jakarta, Sept 8: A massive fire raged through an overcrowded prison near Indonesia's capital early Wednesday, killing at least 41 inmates, two of them foreigners serving drug sentences, and injuring 80 others.

Firefighters battled through the early morning hours to extinguish the flames as black smoke billowed from the compound of the Tangerang prison on the outskirts of Jakarta. After the blaze was extinguished.

ambulance after ambulance filled

with body bags containing the victims were driven by Red Cross workers to the morgue of a local hospital, where they were stacked wall-to-wall on the floor of a room awaiting transport to a larger facility for identification. The cause of the blaze appears

to have been an electrical short circuit, according to initial findings. Relatives of prisoners trickled in to the prison throughout the day to check and see whether their loved

ones were among those killed. Most of the 41 killed were drug convicts, including a man from South Africa and a man from Portugal. while other victims included a terrorism convict and a murderer. Indonesia's Law and Human Rights minister Yasona Laoly told reporters.

"This is a tragedy that concerns all of us," Laoly said. "We are working closely with all relevant parties to investigate the causes of the fire.'

London, Sept 8: The UK and India are in a "sweet spot" of global trade dynamics as negotiations for a free trade agreement (FTA) begin in the coming weeks, according to Britain's trade minister in charge of the bilateral talks.

Liz Truss, UK Secretary of State for International Trade, revealed that the public consultation process ahead of the trade negotiations attracted "huge interest" from businesses across the UK and its completion last month means that FTA negotiations can now begin. Addressing a special reception

hosted by the Lord Mayor of London to celebrate the UK-India Economic Partnership Tuesday evening, the minister confirmed that both sides will "hammer out" the details during the upcoming visit of Commerce and Industry minister Piyush Goyal to the UK and Europe

next week "We just completed our consul-



tation on an Indian trade deal which saw huge interest from businesses across the country. We are

now going to begin negotiating a free trade agreement," said Truss. "I see the UK and India in a

sweet spot of the trade dynamics that are building up... We are looking at a comprehensive trade agree ment that covers everything, from financial services to legal services to digital and data, as well as goods and agriculture. We think there is strong possibility for us to get an early agreement, where we lower tariffs on both sides and start to see more goods flowing between our two

countries," she said. Pointing to the post-Brexit scenario as the UK's chance to set out an independent trade policy outside the European Union (EU), the senior Cabinet minister flagged India as the "big, major opportunity" ahead following 68 trade deals clinched by Britain since leaving the economic bloc.

She also referenced her visit to India earlier in the year, including a tour of the Serum Institute of India (SII) in Pune which is in

a UK tie-up to produce the Oxford University and AstraZeneca Covid-19 vaccines, as she highlighted collaboration in the field of science and tech as a sign of things to come as that trade route between the UK and India is deepened. "Like the UK, India is a science

and tech superpower...the Serum Institute of India provides twothirds of the vaccines that inoculate children around the world. That is truly a tremendous achievement," said Truss.

Govt sticks to Sept 15 deadline for putting financial bids for AI

New Delhi, Sept 8: The government will stick to the September 15 deadline for investors to put in bids for buying national carrier Air India, an official said. This is in stark contrast to the extension of deadline for preliminary bids five times.

Salt-to-software conglomerate Tata Group was among the "multiple" entities that had put in preliminary bids for buying loss-making Air India in December last year. After analysing the preliminary bids, eligible bidders were given access to the Virtual Data Room (VDR) of Air India for doing due diligence, following which investors' queries were answered.

Following that, in April the government had initiated the process for inviting financial bids and fixed September 15 as the deadline for putting in bids.

The official said once the bids come in by September 15, the government will decide on the reserve price. The deal is expected to be closed by December-end. In July, Minister of State for Civil Aviation VK Singh had informed Parliament that financial bids for the carrier will be received by September 15. The government is selling its

'India to post strong GDP growth in coming quarters'

New Delhi, Sept 8: India is expected to post strong economic growth in the coming quarters, even as inflation, led by food prices, is likely to remain elevated. S&P Global Ratings said Wednesday. The economy is expected to clock 9.5% growth in the current fiscal year, followed by 7% expansion in the next year, it said, adding high nominal GDP growth would be important for ensuring fiscal consolidation going forward.

"Given India's weak fiscal settings and high stock of debt around 90%

of GDP, the nominal GDP growth is going to be very important to prevent any further erosion of fiscal settings in the country and to enable some degree of fiscal consolidation going forward," S&P Global Ratings Director (Sovereign) Andrew Wood said.

He said the fiscal deficit would remain elevated over the next two years but debt/GDP ratio is expected to stabilise or flatten out. Wood further said India's ex-

ternal position has strengthened in the context of the pandemic and India has been generating forex reserves at record pace.

"India's external position is very strong and this is quite supportive of India's sovereign rating

despite the fact that we have had this deterioration in fiscal position concurrently," he said. Speaking at the 'India Credit

"The outlook is mixed and energy prices are likely to remain elevated. But the real influential element in the inflation basket is going to be food," Rana said.

Centre hikes MSP of wheat by ₹40 to ₹2,015 per quintal

New Delhi, Sept 8: The government Wednesday hiked the minimum support price for wheat by ₹40 to ₹2,015 per quintal and for mustard seed by ₹400 to ₹5.050 per quintal for the current crop year in order to boost crop area as well as income of farmers.

The decision to increase the MSPs (Minimum Support Prices) was taken at a meeting of the Cabinet Committee on Economic Affairs (CCEA) chaired by Prime Minister Narendra Modi. MSP is the rate at which the government buys the grain from farmers. Currently, the government fixes MSPs for 23 crops grown in both kharif and rabi seasons.

Sowing of rabi (winter) crops begins from October immediately after the harvest of kharif (summer) crops. Wheat and mustard are major rabi crops

According to an official release, the CCEA has approved increase in MSPs for six rabi crops for the 2021-22 crop year (July-June) and 2022-23 marketing season.

Wheat MSP has been increased by ₹40 to ₹2,015 per quintal for this crop year from ₹1,975 per quintal in the 2020-21 crop year. The cost of production of wheat is estimated

at ₹1,008 per quintal, the release said.

The government has procured a record of over 43 million tonnes of wheat during 2021-22 rabi marketing season, as per official data.

The support price of barley has been hiked by ₹35 to ₹1,635 per quintal for the 2021-22 crop year from ₹1,600 per quintal in the previous vear.

Among pulses, the MSP for gram has been increased by ₹130 to ₹5,230 per quintal from ₹5,100 per quintal while that for lentil has been hiked by ₹400 to ₹5,500 per quintal from ₹5,100 per quintal

The banking regulator found that the state-run lender was not in breach of its rules on regulatory capital, bad loans, and leverage ratio, according to a statement released by the **RBI Wednesday, September** 8. In 2017, UCO Bank was placed under PCA framework restrictions due to its poor financial health, when several other lenders in the country battled unsecured assets.

'IGI's ECT to be ready by 2022'

New Delhi: About 60% of Delhi airport's elevated eastern cross taxiway (ECT) has already been constructed and it would be ready by 2022-end, according to a statement Wednesday. Once the ECT is commissioned, the aircraft taxiing distance will significantly go down from 9 km to just 2 km as it will taxi along the taxiway parallel to runway 11/29 and use the ECT to take a straight path to Terminal 1 or vice-versa, said the statement by the Delhi International Airport Limited.

"It will make India a key player in the global textile value chain with focus on high value MMF products. The focus of the PLI scheme would be for the development of man-made fibre and technical fibre segments that are in high demand in advanced economies where India already has a big presence with its technical products.

But the latest events have raised concerns among business leaders about whether Modi is now taking a hardline approach towards domestic giants as well, five industry sources said.

One venture-capital executive said the criticism was akin to "harassment" of businesses and risks souring investor sentiment. Another executive working at a global consultancy said "everyone is scared" as businesses don't want to run foul of the government.

"The frontal attack on iconic elements of Indian businesses have only buttressed the need for companies to ensure they are conforming, not just with tax issues, but with other government initiatives," said Dilip Cherian, an image guru and co-founder of leading Indian PR firm Perfect Relations.

RC Bhargava, chairman of Maruti Suzuki, defended Infosys, saying it had played a key role in building India's software reputation globally. "It needs to explain the glitches, but it doesn't mean there is a conspiracy to damage the country," he told Reuters.

A senior member of RSS, however, said there's nothing wrong in the way the companies have been criticized, saying they must be thick skinned and held accountable.

"Why should questions not be raised, have corporates become a holy cow?" said the RSS official who declined to be identified. Infosys and Tata didn't respond to a request for comment.

The T20 World Cup starts October 17 in the UAE and Oman. The 'Men in Blue' will open their campaign October 24 by taking on arch-rivals Pakistan.

The big names to be dropped were opener Shikhar Dhawan and leg-spinner Yuzvendra Chahal. Rahul Chahar has been preferred over Chahal who was a certainty in India's limited over squads until now.

Dhawan has been overlooked with KL Rahul, Rohit Sharma and Kishan picked as the three openers.

New Delhi, Sept 8: Veteran India speedster Mohammed Shami has recovered from his niggles and is fit to play the final Test against England in Manchester, starting September 10.

Shami and fellow senior pacer Ishant Sharma were rested from the Oval Test that India won by 157 runs to take 2-1 lead in the fivematch series as the duo was nursing niggles.

It is learnt that Shami had joined the team's training session Wednesday, two days before the commencement of the final Test. Shami's fitness status will certainly help captain Virat Kohli and only available coach Vikram Rathour to mull on available options ahead of the fifth game.

As of now among the Indian bowlers, Bumrah is way ahead in terms of quantum of overs with 151 of them sent during the seven innings across four Tests which is effectively more than 21 overs per innings.

Bumrah has 18 wickets to his credit but with a T20 World Cup to play and before that an Indian Premier League where he has commitments towards Mumbai Indians. it will be interesting to see how his body holds up during the last five days of this long series.

India, who are again eyeing a series win in England after 14 years, would ideally want their best eleven to be on the park but at the same time also needs to be aware of the workload management of the pacers.

In case that Bumrah is rested, keeping in mind the next two months of continuous T20 cricket. then Shami will straightaway replace him.

But if Bumrah plays the last Test which he would want to as India need to close in on the series win, then Mohammed Siraj will have to make way as both Umesh Yadav (6 wickets in the game) an Shardul Thakur (two fifties and 3 wickets) can't be dropped.

According to many experts, Manchester is one of the venues, which despite its pacer-friendly nature could provide some assistance for a second spinner in which case the till-now ignored Ravichandran Ashwin can fit in. Rohit, Pujara fitness

Lyon, Sept 8: Antoine Griezmann played chief tormentor as France sprung back into life to end a fivegame winless streak by beating visitors Finland 2-0 in a World Cup Group D qualifier Tuesday.

He has now scored 41 international goals to become France's joint third all-time top scorer alongside Michel Platini, only behind Olivier Giroud (46) and record holder Thierry Henry (51).

Griezmann struck in each half after his partnership with Karim Benzema bore fruit in satisfying fashion to put the world champions on 12 points from six matches at the top of the group.

Finland, who had a decent opening half, are third on five points but have two games in hand of the French. Bosnia are fourth on three points from four games after a 2-2 draw with bottom side Kazakhstan, who also have three points. Ukraine are second on five points from as many matches. After two 1-1 draws against

Bosnia and Ukraine, Deschamps' tinkering paid off as France started in an usual 5-2-3 formation with Leo Dubois and Theo Hernandez
