Bhubaneswar, Sept 14: With record-breaking rainfall in several parts of the state for the third day, thousands of people were marooned in 20 districts of the state Tuesday.

The Special Relief Commissioner office said over 20.46 lakh people in 111 blocks and 27 urban local bodies of 20 districts were affected by rainfall. They included Angul, Bargarh, Balasore, Boudh, Cuttack, Deogarh, Jagatsinghpur, Jajpur, Ganjam, Kalahandi, Kandhamal, Kendrapara, Keonjhar, Khurda, Koraput,

Nayagarh, Nuapada, Puri and Sonepur.

The government has evacuated 13,534 people from affected areas in seven districts while 2870 houses have been damaged. With the death of another person due to wall collapse in Ganjam district, the toll rose to five. Meanwhile, SRC PK Jena

asked all District Collectors to submit damage reports within a week.

Though water level in the Mahanadi river is rising, it is flowing below the danger level. The SRC ruled out any flood in the Mahanadi river system. However, due to heavy rain in the upper catchment areas of the river, six to seven gates of the Hirakud reservoir would be opened to keep the reservoir safe. Jalaka river is flowing above the danger mark and so is Baitarani but the situation is not grave.

Bhubaneswar, Sept 14: Odisha Police Tuesday arrested four contractual employees of the Defence Research and Development Organisation (DRDO), Chandipur in Balasore district on charge of leaking classified defence secrets to foreign agents, police said

crets to foreign agents, police said.
"We have credible inputs that a few

people are sharing sensitive information, which is important in view of national security, to foreign agencies. The Balasore police have apprehended four persons and interrogation is on," Inspector General of Police (eastern range) Himanshu Lal told media.

A case has been registered at Chandipur police station (76/21) Tuesday under Sections 120-B (punishment for criminal conspiracy), 121-A (conspiracy to wage war against India) and 34 (act done with common intention) of the IPC and Sections 3, 4 and 5 of the Official Secrets Act, the police said. The case was registered for the offence of causing serious harm to the security, sovereignty and in-

tegrity of the nation. Further interrogations of the detainees and some others will unearth more evidence in the case, police said.

"In this case, we got credible intelligence that some persons are wrongfully and willfully communicating classified defence secrets to foreign agents, appearing to be Pakistani agents, being contacted from various ISD phone numbers and in exchange, they were getting monetary benefits from them," the police further said.

Based on these inputs, multiple police teams were formed to apprehend the culprits. During raids, the police have recovered several incriminating materials. Sources said the accused were working as manual operators at the defence installation. While answering to queries, DGP

Abhay Tuesday refused to share details in this regard keeping in view the national security related issues. He informed the press that revealing further details could hamper the probe which is at a nascent stage now.

In January 2015, a former DRDO

In January 2015, a former DRDO worker, Iswar Chandra Behera, a videographer, was held on charge of spying for ISI. He was convicted with life imprisonment in February this year. Behera was held following a 10-month long probe. He had confessed to have shared defence secrets with Pakistani spying agents.







At 112.9, Odisha tops in rate of crimes against women

Bhubaneswar, Sept 14: Odisha is in news again though for wrong reasons as the rate of crimes against women in 2020 is stated to be the highest in the country. This was revealed by the annual report released by National Crime Records Bureau (NCRB) Tuesday which pegged the overall crime rate against women at 112.9 for 2020.

The Odisha police registered 25,489 cases on charges of crimes against women in 2020 while it stood at 23,183 in 2019, the NCRB data claims.

As per the report, Odisha police registered 12,605 cases for assault on women, with intention to outrage the modesty which includes sexual harassment.

Similarly, Odisha recorded registration of 3,232 cases on the allegations of disrobing women in 2020.

The NCRB report also revealed that the state with 615 cases stands third when it comes to cases related to insult to the modesty of

Meanwhile, the state with 3,775 cases also figures among the top 10 states of the country in kidnapping and abduction of women last year. Odisha recorded third highest rate of kidnapping among all the states in 2020.

Similarly, 526 cases related to cybercrime offences against womenfolk were registered in the state which is also highest in the country.

With 292 cases for publishing sexually explicit material, the state stood at second place in the country in 2020.

GENETIC ANALYSIS

The researchers combined genetic analyses of other tiger populations from India and data from computer simulations to show that the Similipal black tigers may have arisen from a very small founding population of tigers

The researchers noted that this has important implications for tiger conservation as such isolated and inbred populations are prone to extinction over even short periods of time

Ramakrishan's lab and lead author of the paper, told PTI.

"We used whole genome sequencing from a pedigree (family tree) that includes pseudomelanistic (false coloured) and normally striped individuals to find the mutation responsible for the phenotype," he explained.

The abnormally dark or black coat in such tigers is termed pseudomelanistic or false coloured. The most recent sightings of this rare mutant tiger in Similipal, long considered mythical, was reported in 2017 and 2018.

Since the late 1700s, reports of black tiger sightings and supposed captures in central and northeast India have been recorded by locals

"There are several camera trap pictures. In fact, camera trapping was carried out in 2021 in Similipal, Ramakrishnan told PTI

and British hunters.

According to the 2018 tiger census, India has an estimated 2,967 tigers. Photos captured from Similipal in 2018 showed eight unique individuals, three of which were 'pseudomelanistic' tigers, characterised by wide, merged

The researchers at NCBS teamed up with tiger experts nationally and in other countries and found out that pseudomelanistic coat came down to the genes.

They found the black tigers are mutants and are Bengal tigers with a single base mutation.

Different mutations in this gene are known to cause similar changes in coat colour in several other species of cats, including cheetahs.

Further genetic analyses and comparisons with a total of 395 captive and wild Indian tiger populations indicate that the mutation in Similipal tigers is very rare. The only other black tigers outside of Similipal in India exist at the Nandankanan Zoological Park

in Bhubaneswar, Ranchi Zoo and

Chennai's Arignar Anna Zoological Park, where they were born in Within Similipal, the mutation is present at a high frequency of 0.58: this means that if you pick any

tiger from Similipal, the chance that it carries the mutant gene is almost 60 per cent. Researchers also carried out in-

vestigations to understand why this mutation occurred at such a high frequency in Similipal alone. One hypothesis is that the darker

coat colour of the mutants offers them a selective advantage when hunting in the dense closed-canopy and relatively darker forested areas of Similipal as compared to the open plains of most other tiger However, the results of addi-

tional genetic analyses coupled with computer simulations indicate that a small founding population and prolonged isolation from other tiger populations in India is likely to be the main reason for the occurrence of these black tigers Due to this geographic isola-

tion, genetically related individuals have been mating with each other for many generations in Similipal, leading to inbreeding, the researchers noted. A combination of these inter-

related factors is the likely evolutionary forces that have created Similipal's unique population of black tigers.

"It is amazing that we could find the genetic basis for such a striking pattern phenotype in wild tigers, and even more interesting that this genetic variant is at high frequencies in Similipal," said Ramakrishnan.

The drastic change in patterning and colouring of the black tigers' coat is caused by just one change in the genetic material DNA Alphabet from C (Cytosine) to T (Thymine) in position 1360 of the Taqpep gene sequence, the researchers said.



Temple debris removed from Mahanadi riverbed, NGT told

New Delhi, Sept 14: In deference to a direction issued by the National Green Tribunal (NGT), the Cuttack administration has removed the debris of Panchamukhi Hanuman Temple, which was demolished from Mahanadi riverbed September 2 following the order of the tribunal.

In an affidavit filed Tuesday, the Collector-cum-District Magistrate of Cuttack submitted that pursuant to the direction of the tribunal, the officials of the district were directed to take immediate action to remove the muck, construction and demolition waste from the embankment of river Mahanadi at Ratilo under Kishan Nagar tehsil of Cuttack.

This is humbly submitted that muck, construction and demolition waste from the embankment of river Mahanadi at Ratilo were completely removed and the riverbed has been restored to its original state," the Collector submitted to the NGT.

Honey bees to prevent elephants from straying into villages

Bhubaneswar, Sept 14: In a bid to reduce man-elephant conflict, the state government has decided to use honey bees to prevent the pachyderms from straying into human habitations, a senior Forest official said Tuesday.

Principal Chief Conservator of Forests (Wildlife) Sashi Paul said that the RE-HAB (Reducing HumanElephant Attacks Using Bees) project will be launched in Athmallik forest division of Angul district in the first phase.

routes usually taken by elephants to enter human habitations. A wire will be tied to the boxes. When the pachyderms pass through the routes and stamp on the wire, the honey bees will attack and drive them back into the forests,' he said.

The joint project of the Forest and Environment department and the Khadi and Village Industries Commission was

years due to several factors including poaching, the official said. Similar projects have succeeded in South Africa and

other countries, and in states like Uttarakhand and Karnataka, he said. A meeting was organised with residents of three villages lying on the periphery of Athmallik forest and they are ready to cooperate with the government for the successful implementation of the project, the official said.

Paul said that human-elephant conflicts mostly happen during the harvest season from September to March and the project will be launched in this period. "The government will closely monitor and study the impact of the project on the elephants," he said.

The administration also plans to fit radio collars on specific

marauding elephants that create nuisance in human habitations on the periphery of Chandaka Sanctuary, Badampahar Forest Range and Similipal National Park.

The Indian Institute of Science (IISc), Bengaluru has been assigned the job of putting radio collars on three elephants this week, he said.

Paul said that the Forest department has also decided to commence 'Gaja Sathi Yojana' (Friend of Elephants) programme by involving volunteers of Van Suraksha Samiti to provide early inputs on the movement of the pachyderms.

Five members of each samiti will be engaged as Gaja Sathi and will be provided with firecrackers, lights and other equipment to track and drive elephant herds away from the human habitations. Each Samiti will be provided with an annual assistance of ₹25,000, he said

According to sources, the web portal was regularly publishing reports on Dusmanta three days prior to his death. Besides, the city reporter of the portal had reportedly dialed Dusmanta September 8.

"We have summoned the reporter and input coordinator of the portal as part of our investigation into the case. We will record the duo's statements," said Mangalbag police in-charge Amitabh Mahapatra.

Das, a resident of Jagatsinghpur district, had slit his wrist and consumed poison in an attempt to end his life to protest against the alleged denial of treatment under Biju Swasthya Kalyan Yojana (BSKY). As per reports, he died while being treated at SCB Medical College and Hospital in Cuttack.

The Kujang police in Jagatsinghpur had registered a

murder case in connection with the incident on the basis of a complaint lodged by Das's mother Basanti Das In her complaint, Basanti had al-

leged that an unidentified person, who took her son to Bhubaneswar, might be involved in the incident. The murder case registered at

Kujang police was transferred to Mangalabag police station as Das's death occurred under the latter's Notably, Das had met with an

accident March 22, 2020 and sustained grievous injuries on his left leg. He was admitted to SCB Medical College and Hospital. Das underwent surgeries March 23 and June 19, 2020. However, the doctors allegedly discharged him from the hospital July 15 in the wake of Covid-19 situation.

Das had alleged that the authorities of SCB refused to admit him when he visited the hospital again. However, the hospital authorities denied Das's allegations.

Tribal couple makes hay from red okra farming

Cultivation of red okra has changed the lives of Baidhar Samal and wife Benga Samal of Kendrapara for the better

Mahakalapara, Sept 14: Okra, commonly known as lady's finger, is one of the popular and nutritious vegetables relished by foodies. This vegetable is on the menu of every household as it is a rich source of antioxidants and vitamins A and C.

But now, a tribal couple from Baraja village under Ramnagar panchayat of Mahakalapara block in Kendrapara district has given a new twist to the vegetable by growing red lady's finger or 'lal bhindi' on their farmland, a report said. The cultivation of red lady's finger has helped them reap good profit and improve the financial health of their family

The cultivation of this new variety of the vegetable is special for the couple. There is high demand for red

okra in the market as the vegetable offers high resistance power against various diseases.

While normal okra is available at ₹20 per kg in the state, this variety of the vegetable is sold at a very high price in various parts of the country. It is sold at prices between ₹400 and ₹800 per kg in the international market. It is reportedly being sold at ₹75-80 to ₹300-400 per 250 gram/500 gram even in some malls in the country

The couple, Baidhar Samal and wife Benga Samal, claims that the red variety of okra is healthier compared to the natural variety. It is said to be more beneficial and nutritious than the green lady's finger. According to some studies, red okra is highly beneficial for people with diabetes, blood pressure and high cholesterol levels.

To start with, the couple pur-



chased the seeds of red okra from Kolkata. Initially, they planted 200 saplings on 10 decimal of sandy soil and harvested around 10 kg of okra daily from their farmland. They sold their produce at ₹40 per kg at

the local Ramnagar market.

The couple claimed that some traders visit their house to buy the vegetable at a lower price and sell it at a premium by transporting it to Kolkata for sale. Many people

Myanmar Offensive

t is an irony of history that when the world has responded with alarm, alacrity and legitimate concern to the humanitarian crisis gripping lacksquare Afghanistan following the Taliban's return to power, the sufferings of Myanmar nationals persecuted and hounded out by the military junta are not getting the global sympathy they deserve. This is all the more unfortunate since the Tamtadaw - the military rulers of Myanmar - not only staged a coup February 1, but have given tell-tale evidence of their ruthless repression through indiscriminate firings and bombings. The crisis in Myanmar has once again attracted headlines after a few hundred people from the country's Chin state crossed over to Mizoram in the past few days following airstrikes by the military. This has ominously given rise to fears of another spell of influx of Myanmar nationals into Mizoram which began enrolling some 400 refugee children in schools over a week ago.

The current military offensive in Myanmar is believed to be the fallout of the call for a nationwide uprising given by the country's National Unity Government in exile. According to reports emanating from Myanmar, the military junta used fighter jets to bomb a village called Lungler near the Mizoram-Myanmar border. The information was shared by Mizoram's Home Minister Lalchamliana. He expressed fear that more refugees would pour into Mizoram if the airstrikes and other military actions continue. Six districts of the state - Champhai, Siaha, Lawngtlai, Serchhip, Hnahthial and Saitual — share a 510-km long porous border with Myanmar. Official reports suggest about 10,000 refugees have already sought shelter in four of these districts since March. They are lodged in community and public halls and school buildings. Local villagers are providing shelter to the refugees and taking care of their daily needs as the Mizos and Myanmarese people share deep cultural bonds that don't admit of citizen-refugee divide.

Since Myanmar's military coup early this year, over a hundred thousand Myanmar nationals have fled the country either to India or Thailand to escape the brutal crackdown by the junta. Among them are politicians, police and military personnel, with the latter two refusing to carry out the junta's orders to suppress the popular revolt with an iron hand. According to unofficial reports, over 16,000 Myanmar nationals have crossed over to the four Indian border states of Manipur, Mizoram, Nagaland and Arunachal.

The Indian government's response to the human tragedy unfolding in Myanmar is mired in ambiguity, prevarication and even confrontation with the state government of Mizoram. This is because of multiple factors, including the BJP-led Union government's narrow politics of bias against the Rohingya Moslems bearing the brunt of the genocide in Myanmar. The situation has become even more complicated with the Mizoram government defying the Centre's fiat not to give shelter to Myanmar nationals fleeing the country so as not to rub the junta the wrong way. The Centre's argument is that India can ill afford to antagonise the rulers of Myanmar for security and trade reasons, especially when China wields far greater influence on the running of Myanmar. Incidentally, China has refused to call the military takeover of Myanmar a 'coup'. That only legitimises the blatant subversion of the democratic process by the junta. Though Myanmar has embraced a sort of hybrid democracy where the military has a big say in the country's management and governance under a constitutional system, the last election gave an overwhelming mandate to the NLD to rule. But, the junta did not allow the NLD to form its government fearing that the latter might adopt constitutional reforms that would minimise the junta's role in governance and weaken the huge financial clout that families of the top military rulers enjoy.

India's reaction to refugee influx falls far short of the need in the absence of a proper legal framework that is followed by most countries in this regard. As per the latest estimates of United Nations High Commissioner for Refugees (UNHCR), India has more than 200,000 legally documented refugees, including Tibetans, Bangladeshis, Chakmas and Tamils from Sri Lanka. In fact, refugees have come to India from all over the world, including Afghanistan, Somalia, Congo, Eritrea, Iran, Iraq, Sudan and Syria.

But, India's reaction to every refugee situation has always been guided by political considerations and not by any constitutional policy. India is not a signatory to the UN Refugee Convention or the UN Convention on Statelessness. As such, it is not obliged to provide rights laid down in the conventions to refugees. Its decisions on granting long-term visas to refugees are merely ad hoc measures. The legal status of any 'foreigner' in the country is governed by two pieces of legislation, the Foreigners Act 1946 and Passports (Entry into India) Act 1920 and the rules issued subsequently under these acts. The absence of a proper legal framework for refugees has led to a situation where India can neither accord wide-ranging benefits to refugees nor get funds from the UN for maintaining refugees.

The exodus from Myanmar once again lays bare the inadequacy of the Indian system and the scope for bias by the government of the day against the hapless people fleeing their native land for their life.

e are in the company of Messrs Pumpkinskull, Sweedlepipe, Bumble, Tappertit, Honeythunder, Pumblechook, and Muddlebranes, whose names all came out of the mind of Charles Dickens. His ability to create memorable and frequently sarcastic names for his characters, his villains in particular, is surely unmatched in literary history. Pecksniffian derives from his Martin Chuzzlewit of 1844, in which Seth Pecksniff is a land surveyor and architect, though the author remarks that the only surveying of land he did was of the view of the countryside from his windows and that "of his architectural doings, nothing was clearly known, except that he had never designed or built anything." In truth, Mr Pecksniff, though in appearance the most upright of men who prated about high moral principles and benevolence, was an awful hypocrite, full of meanness and treachery Dickens remarked scathingly that "Some people likened him to a directionpost, which is always telling the way to a place, and never goes there." In common with some other Dickens' characters, including Gradgrind, Micawber, Podsnap, Scrooge and Uriah Heep, Pecksniff has become an archetype. He was turned into an adjective, meaning unctuously hypocritical, as early as 1851 and later became a noun, Pecksniffery.



WORLD BANK'S WRONG TURN

√he International **Development Association** is the part of the World Bank that is meant to help the world's poorest countries. Its explicit mission is "to reduce poverty by providing zero to lowinterest loans and grants for programmes that boost economic growth, reduce inequalities, and improve people's living conditions." The IDA provides around a quarter of its financing in grants, and the rest in concessional loans that can be repaid over 30-40 years, including a grace period of up to 10 years

In the fiscal year ending June 30, 2020, the IDA committed nearly \$30.5 billion to low-income countries. Next month, the IDA's 173 member states will meet to agree on its latest disbursal of funds, estimated at \$94 billion for the two-year 2021-23 period. In annual terms, this is not much of an increase, especially given the massive economic devastation that the COVID-19 pandemic has caused

in low-income countries. Developing countries have been ravaged by a combination of the pandemic-driven health crisis, collapsing exports, rising global food prices, domestic economic contraction, falling fiscal revenues, and external debt overhang. The World Bank estimates that 97 million more people - many of them in Africa – will fall into extreme poverty in 2021. This could well be an underestimate, because it does not take into account higher food prices, increasing inequality, and the impact on the poor in South Asia.

Providing even the most basic support to people in increasingly precarious circumstances in the poorest countries will take a lot more than \$47 billion per year. Researchers at the International Monetary Fund estimate that lowincome countries will need around \$200 billion over the four years until 2025 simply to recover from the pandemic and a further \$250 billion to catch up with advanced economies. But even a smaller amount of IDA financing could provide some relief, especially in terms of governments' fiscal space, and is important because of the low-interest terms.

But how much of this money will actually go to governments that desperately need to increase public spending on health and social protection, and to promote economic recovery? Unfortunately, there is a high risk that IDA funds will be used in part to favour private-sector actors, instead of enabling governments to support

poor people directly. This is because the World Bank Group, in line with its 2017 'Cascade' approach, introduced a 'private finance-first' model that prioritises private financing options over the use of public resources in development projects. As part of this broader strategy, the IDA launched its own Private Sector Window (PSW) in 2017 to mobilise private investment in recipient countries.

The PSW places donor aid resources under the direct control of the World Bank's private-sector investment arm, the International Finance Corporation (IFC), and its private-sector guarantee arm, the Multilateral Investment Guarantee Agency (MIGA). This means IDA funds are being used to subsidise private-sector projects supported by the IFC and MIGA in low-income countries and fragile and conflict-affected states.

This redirection of development funds can be criticised on several counts. For starters, some have accused the World Bank Group of a lack of transparency for subsidising firms through a non-competitive process on the basis of unsolicited proposals. The bank has also failed to demonstrate sufficient development impact, because the criteria for evaluating the PSW and demonstrating the 'additionality' of private-sector finance are complex and technical and do not explicitly consider development effects. In fact, the PSW's effectiveness appears to be limited to its role in underwriting risks associated with IFC and MIGA operations, rather than demonstrating private finance's contribution to economic growth and sustainability. Lastly, some have criticised the PSW's poor targeting of development-related projects in the context of responses to COVID-19.

Even the World Bank's own PSW mid-term review noted that "the question of whether a project can take place without PSW support does not always have a simple answer." The basic goal of introducing the PSW in developing countries - to bring private finance into development projects - also has not been realised. The 2021 assessment by the World Bank's Independent Evaluation Group shows that, on the whole, the PSW has mobilised even less private capital than other blendedfinance instruments like the MIGA Guarantee Facility.

The World Bank's persistence with a private finance-oriented strategy – despite the glaringly obvious need for increased public spending - may in part reflect the IDA's governance structure. The body's establishment in 1960 represented a compromise accepted by developing countries, many of which had instead demanded a United Nations multilateral fund operating on the basis of "one country one vote" to help meet development needs. The United States' influence in the World Bank prevented that, and the IDA's 74 recipient countries now have less than 16 per cent of the voting power. This democratic deficit at the multilateral level, along with a lack of accountability at evaluation stages, further reduces developing countries' scope to influence decision-making.

The ongoing pandemic-induced reversal of positive development trends needs to be addressed through stable financing channels in developing countries. These channels should emphasise grants supporting essential public services like health and education, as well as infrastructure. Given the PSW's inherent limitations, subsidising the private sector to invest in public goods and services through the IDA will only exacerbate the pandemic's harmful consequences

As long as the IDA can be an important source of recovery funds for the poorest economies, those resources must be used effectively. This will require closing the PSW and, instead, providing resources directly to governments and developing alternative approaches to strengthen public finances and public services. We can no longer afford solutions that worsen the problem. Jayati Ghosh is Professor

illions of people around the world were forced to work from home during the COVID-19 pandemic. Many of them normally work in an office, but took advantage of Zoom, Skype and other online platforms to work remotely. Some have already returned to work, but others are still at home, enjoying their last days of

Yes, even if there's a lot of work to be done, doing it at home means enjoying a lot of freedom: the freedom to take breaks whenever you want, the freedom to watch TV while you work, and best of all, the freedom to put your boss on mute.

If you don't believe me, just look at some of the results of a recent online survey of 1,000 remote workers who wished to continue working remotely. Commissioned by the website Digital.com, the survey uncovered some of the reasons these workers preferred working at home.

I was surprised to find that 75 per cent of remote workers want to stay home so they can spend more time with their pets. I wonder how the pets feel about this. Pets like to have a little freedom too. Our dog, for example, tries to look depressed when we're leav-

ing her alone at home. But the moment we leave, the party begins. She explores the kitchen, tries to open the refrigerator, then sniffs the houseplants to see if any of them is edible. She finally sits on the couch and tries to squeeze some flavour out of an object she found in the bedroom: one of my socks.

It's less surprising to me that 72per cent of remote workers want the freedom to nap or exercise during the day. I like to do both: take a nap and dream about exercising. I totally understand this desire. Most workers have very short lunch breaks, barely enough time to eat lunch, let alone take a nap or exercise. The only exercise you might get, if you're lucky, is walking to a restaurant and back. It would be wise for companies to give workers extended breaks, so they can do a little yoga after lunch, for example. Flexible hours for flexible workers.

It's also not surprising that 73 per cent of remote workers say they want to watch TV while working. Most workplaces, unfortunately, do not have enough TVs. Employers do not seem to understand how important it is for workers to keep up with cricket. It's not just cricket, of course. It's also other sports, as well as TV shows. Not every employer is like Verve Logic, the Jaipur-based IT company that recently gave employers a holiday so they could enjoy the release of Money Heist 5 on Netflix.

You may believe that watching cricket while working means that the work will suffer. But not watching cricket while working means that the worker will suffer.

Another major reason for workers preferring to stay at home is appearance. Concerned about their own appearance, they're reluctant

to make an appearance at work. Sixty-two per cent of workers cited this reason in the survey. Some have gained weight during their home stay and are concerned that they might not fit in the office cubicle. Others are concerned that their work attire of the past yearseldom-washed floral-patterned pajamas—will not be acceptable in the office.

When workers were asked for the most important factors in their desire to stay at home, two were most prominent: spending time with children, and saving time and money on the daily commute to work. These are quite understandable. Employers need to be more flexible. Perhaps they can allow workers to bring their children to work Mondays, their pets Tuesdays, their TVs Wednesdays, their exercise bikes Thursdays, and their pillows Fridays.

Daringbadi, Sept 14: Low pressureinduced rain during the last three days has thrown life out of gear and wreaked havoc in various parts of the state, a report said

Daringbadi in Kandhamal district is no exception, as traffic on National Highway-59 was severely disrupted after a transit bridge on a bypass road at Sulumaha here was washed away due to incessant rain. Monday. The highway connects Gopalpur in Ganjam district with Raipur in Chhattisgarh.

Reports said that the National Highway Authority of India (NHAI) has taken up the expansion of the highway for which a small bridge and bypass roads are being constructed at different points of the highway. However, residents have a different opinion as they alleged that the bridge was washed away due to sub-standard works.

Twenty-four hours have passed since then but traffic on the route continued to remain disrupted even Tuesday. The low pressure has re-



sulted in heavy rainfall Sunday and Monday and continued in various parts of the state even Tuesday.

As the bridge was washed away, vehicular service from Baliguda via Daringbadi. Berhampur, Bhanjanagar and Sorada has snapped. Some passenger buses have taken up different routes to reach their destinations, while the passenger bus service from Daringbadi to Simanbadi in the district has been discontinued. A disruption in bus service from Daringbadi and to Simanbadi has left the students worried as they could not attend their classes in

schools and colleges.

The disruption in traffic continues as the highway authorities are yet to repair the bridge or open any alternative route for the vehicles. The consultancy agency, in the past, had repaired the bridge on various occasions but the frequent collapses of the bridge has sparked concerns among the local residents. Meanwhile, the local administration and police reached the spot and tried to control the situation. The NHAI has also started repairing of the bridge but it is not vet clear when it will be open

Hirakud dam to open 6 sluice gates to release rain water

Sambalpur, Sept 14: Dam authorities in Odisha's Sambalpur district have announced that the sluice gates of the Hirakud dam will be opened Tuesday to release surplus water from the reservoir following incessant rain in the upper catchment areas.

Six gates will be opened in total, but phase-wise. Siren will be blown from 3 pm and the water will be released at 5 pm.

People have been urged by the authorities not to enter the river during this time. The water released from the dam is expected to reach Mundali in Cuttack within 36 hours.

Following considerable rainfall across the state due to a depression in the Bay of Bengal, water levels in major rivers of Odisha are rising. Water level in the Jalaka river has already crossed the danger mark, resulting in flood-like situation in various regions.

According to latest information, Jalaka was flowing at 6.22-mark and rising at Mathani in Balasore district at 9 am against the danger level of 5.50 metres. Similarly, Baitarani river was flowing at 17.84mark and rising at Akhuapada at 9 am against danger level of 17.83 meters, Mahanadi, Devi, Brahmani, According to the relief code,

Ib, Budhabalanga, Subarnarekha, Vansadhara and Rushikulya are among the other rivers which experienced rising water level.

e-Mulakat a boon for prison inmates, their relatives

Malkangiri, Sept 14: Online mulakat or e-mulakat is becoming increasingly popular among the family members and relatives of the prisoners as the facility has made it easy for them to hold meetings with their near and dear ones lodged behind bars.

This novel facility is being provided through the National Prisons Information Portal (NPIP). The Malkangiri sub-jail, where this facility has been launched recently, has so far received numerous requests through the portal from the family members and relatives of the prisoners lodged there.

Informing this, the superin tendent of Malkangiri sub-jail said that so far they have received over 100 applications through the portal. "With the introduction of the e-facility, the family members and relatives of the inmates are no longer visiting the sub-jail. This way, they can not only save money but also save their valuable time. Sitting in their homes, they



can now interact with their friends and relatives who are behind the bars with the help of laptops, computers or smart TV. This facility has proved to be a boon for the prisoners as well as their relatives as presently face-to-face meetings have been restricted due to the Covid-19 pandemic. This service is being provided two days in a week.

Notably, the Odisha government had launched the service at Jharpada jail in Bhubaneswar and Choudwar jail in Cuttack district July 26. The Prisons Directorate had then said in a statement that the facility would be started at all district jails and circle jails from August 15 and subsequently, it would be extended to all sub-jails.

Sonepur, Sept 14: With the only industry in Subarnapur district -Sonepur Spinning Mill remaining closed since January this year, the labourers and workers of the mill are spending their days in penury. Keeping their fingers crossed, they are hoping that the mill would reopen soon and alleviate their problems.

The mill was established in the year 1982 during the tenure of Janaki Ballabh Patnaik as the Chief Minister of Odisha. Being the only industry in the erstwhile undivided Bolangir district, people were hopeful that it would make a difference in providing employment to the youths of the region and help eradicate poverty. Set up at a cost of ₹5,00,00,000, the industry, as per expectation of the people, had provided employment to over 1,000

people from the locality. In the initial years, everything was going well. But later on, the plant started incurring losses owing

to alleged mismanagement and the lackadaisical attitude of the staff.

Initially, the mill was managed by the Industrial Development Corporation of Odisha Limited alongside two other spinning mills at Baripada and Aska. In 1990, the mill was handed over to ABS Spinning Orissa Limited with the hope of better management and higher production.

Surprising everyone, the mill was handed over to traders in 1992. Cotton traders would supply cotton and in turn procure threads. From 1992 to 2001, the mill was run by signing agreements with KK Spinner, OSM, HR International and ODMPL. These arrangements proved profitable for the companies but not for the mill. Its condition started deteriorating and its earning was not in commensurate with its production. The situation came to such a pass that the workers did not receive their salaries on time. Nor could electricity bills be paid on time. At one



point of time, the electricity connection was cut off after the outstanding bill amount touched ₹1,20,00,000. Many employees were forced to take VRS.

Sonepur Spinning Mill in urgent need of succour

Eventually, the mill was closed down in 2001. Following the closure of the mill, employees as well as the local people resorted to agitations and strikes demanding

the reopening of the mill. Consequently, Vijay Agarwal, owner of Firoza Spinning Mill of Kolkata, was entrusted with the responsibility to run the mill in 2007 and production resumed in 2010. The mill's name was also changed to Balaji Ganapati Spinning Mill. The number of employees was downsized and there were only 150 regular

workers and 100 trainees. It has been alleged that the present owner has shifted several costly machineries from the mill to elsewhere. And since outstanding electricity bills are not being paid regularly, the plant's power connection has been snapped again, forcing the closure of the plant at regular intervals. At present, the mill is running with only 60 workers the mill is running. Talking to this correspondent, Jogendra Prasad Panda and Dhabaleswar Kumbhar of the mill's workers' union said that the plant authorities have deducted EPF amounts from their salaries but not deposited it in their accounts. "We have informed this to the mill authorities and district administration in writing," they added.

Meanwhile, it has been alleged that the present owner is not interested in running the mill but is actually eyeing on the 100 acres of land adjacent to the plant. A petition has been filed in the court in this regard.

'Govt by-passing crucial clause of Assam Accord while bringing in CAA'

Guwahati, Sept 14: The Assam Jatiya Parishad (AJP) Tuesday accused the Assam government of sidelining the "crucial" clause 5 of the Assam Accord, which deals with cut-off date for identification of illegal foreigners by bringing in the Citizenship (Amendment) Act (CAA).

AJP president Lurinjyoti Gogoi and general secretary Jagdish Bhuyan, in a press statement, alleged that the BJP party-led government was working to reduce the Assamese people to a minority status in their own state in order to appease "foreigners" who will be turned into voters through provisions of the Citizenship

(Amendment) Act. "Clause 5 of the Accord specifies the cut-off date for identifying foreigners. But it will become irrelevant when the CAA is implemented. It will tantamount to killing the Assam Accord and its spirit," they said.

This vital clause has been ignored by the government when it recently formed a committee to implement the Accord, they added.

The state government had September 7 announced a committee with its ministers and representatives of the All Assam Students' Union (AASU), which was a signatory of the Accord as member to prepare a roadmap within three months to implement the Assam Accord

The Chief Minister's Office in a statement the same day had said that the meeting decided to prepare an "implementation framework to implement the provisions of Assam Accord with special reference to Clause 6,7, 9 and 10".

Clause 5 of the Accord sets March 25, 1971, as the cut-off date for detecting and deporting illegal aliens

from Assam. The AJP alleges that the contentious CAA violates the Assam Accord as it seeks to provide Indian citizenship to Hindus, Jains, Christians, Sikhs, Buddhists and Parsis who came to India on or before December 31, 2014 from Bangladesh, Pakistan and Afghanistan after five years of residence here.

The AJP leaders also alleged the percentage of Assamese-speaking population will decreased by 10 per cent over a 20 year period.

"The percentage of Assamese speaking population in Assam was 47 per cent as per 2011 Census. It is predicted to come down to 37 per cent by 2031. Once the Assamesespeaking population becomes a minority, it will be no good trying to protect their identity," they said.

They demanded action from the government in the form of proper implementation of clause 6, which deals with Constitutional, legislative and administrative safeguards to protect, preserve and promote the culture, social, linguistic identity and heritage of the Assamese people, before it is too late.

The AJP leaders also said the recommendations of the Justice Biplab Kumar Sarma-led Committee on implementation of clause 6 are being ignored by the government.

February 25 last year, the Justice Sarma-led High-Level Committee of the Ministry of Home Affairs had submitted its report to the then Chief Minister Sarbananda Sonowal for handing it over to the Union Home Minister Amit Shah, but no action has been taken on it yet. Gogoi and Bhuyan also alleged that the BJP party has grabbed power by playing communal politics but is keeping mum on the matter of the Assamese speakers being on the verge of losing their mother tongue.

Pledging intensified agitations to protect the identity of the Assamese people, the AJP leaders said the 'Jatiya Garjan' programme observed by the party and its supporters across the state Tuesday was a part of this plan.

UP suffers worst dengue outbreak in yrs; 60 dead

New Delhi, Sept 14: An outbreak of dengue fever is suspected of killing dozens of people in the northern state of Uttar Pradesh since the start of September, and authorities have launched a campaign to destroy mosquito breed-

Dinesh Kumar Premi, the chief medical officer in Firozabad, the most affected district in the state. said that 60 people, many of them children, had died in his district alone, raising fears that Uttar Pradesh is in the midst of its worst dengue outbreak in years. "We are taking preventive meas-

ures and 95 health camps across the district have been operating in order to contain the spread of this fever," Premi said.

A government official said on the condition of anonymity that many children may have died as their poor parents first took them to fake medical practitioners, or quacks, before their condition worsened.

While mosquito-borne dengue is the suspected cause of the deadly viral fever outbreak in Uttar Pradesh, it has only been confirmed as the cause of death in three cases, but an audit is underway to determine if it is to blame for more, Ved Vrat Singh, Uttar Pradesh's top public health officer, said.

Authorities in Firozabad have formed teams to check households for water logging, and fumigate areas at risk, while they have also released thousands of Gambusia, or mosquitofish, into water bodies to eat the mosquito larvae.

Proposed ammendments in tobacco law likely to increase illegal trade: Survey

Agartala, Sept 14: After languishing for over four-and-a-half years in Bangladeshi jail, Assam youth Mukul Hazarika returned to India Monday after a series of diplomatic and administrative efforts.

Assam man returns home after 56 months

in Bangladesh custody

Hazarika, a resident of Hodapara village in western Assam's Darrang district, returned after he was handed over to the Border Security Force (BSF) and Belonia police by the Border Guards Bangladesh (BGB) through Tripura's Belonia checkpost on the India-Bangladesh border.

A rickshaw puller by profession and father of three children, Hazarika (35) inadvertently went to Bangladesh in February 2017, where he was arrested by security forces. A local court then sent him to imprisonment in Feni jail. "Bangladesh jail police tortured me in prison. They did not give me food regularly. After completing a three-year jail term, they did not allow me to come back to mv home in Assam," Hazarika told the media at the border.

Hazarika's presence in Bangladesh first became known in 2019 after the officials of the Indian High Commission in Bangladesh informed the Assam government that he was lodged in Feni jail.

Assam organisations up in arms against NHPC project

Guwahati, Sept 14: More than 22 organisations in Assam have threatened to launch a joint movement against the mega 2,000 MW capacity hydropower project being set up by the state-owned National Hydroelectric Power Corporation (NHPC) along the Arunachal Pradesh-Assam border from September 20

Asom Jatiyatabadi Yuba Chatra Parishad (AJYCP) leader, Palash Changmai on Monday said more than 22 organisations have decided to launch a series of protests, including blockade of the project site, against the NHPC

The AJYCP, an anti-Bharatiya Janata Party organisation, Saturday organised a public meeting where various experts, including geologists and hydrologists, had high-

lighted a threat to downstream areas of the Subansiri river. The AJYCP leader said work on the project was resumed without consulting 965 villages across four districts in the downstream of the hydroelectric project.

These districts in eastern Assam adjoining Arunachal Pradesh include Biswanath, Dhemaji, Lakhimpur and Majuli. The 22 organisations, which are opposing the mega power plant, include the influential All Assam Students' Union and All Assam Adivasi Students' Association whose leaders had attended the Saturday meeting.

Commissioning of the 2,000 MW Subansiri Lower Hydroelectric project at Gerukamukh was started in 2006 but work had been stopped in 2011 following agitations fearing ecological damage and loss of livelihood

Guwahati, Sept 14: The proposed amendments in the law regarding cigarettes and other tobacco products are more likely to increase illicit trade as a country-wide survey conducted by a consumer rights organisation revealed that over 77 per cent of the respondents prefer untaxed tobacco products, even if

they are of low quality. Regulating unorganised tobacco trade and bringing in "enabling laws" instead of "punitive and aggressive legislation" are more needed, claimed the survey report prepared by Consumer Online Foundation (COF), a not-for-profit organisation.

The proposed COTPA (Cigarettes and Other Tobacco Products Act) Amendment Bill, 2020, seeks to disallow retail sale of loose sticks of cigarettes, prohibits sale of tobacco products to persons below 21 years, put controls on in-shop advertising and promotion, among

In a statement, COF said it conducted the survey among 5,116 people across the country between April and July to analyse ground realities, opinions, concerns and



voice of consumers.

On the findings of the study, COF founder trustee Bejon Misra said it "brings to the fore that the proposed amendments in the tobacco control law are more likely to increase illicit tobacco trade in the country thereby encouraging tobacco consumption instead of discouraging it.'

As many as 77.50 per cent of the respondents indicated a preference for smuggled but untaxed and low-quality tobacco, as per the report. The illicit tobacco trade is a major cause of concern for the government and law enforcement

agencies, with a significant amount of this trade happening through the unfenced border that the Northeastern states have with countries such as China, Myanmar and Bangladesh, it said.

"There is a strong need to regulate unorganised tobacco trade and bring equitable taxation policies to safeguard Indian consumers from inferior quality tobacco products. We need enabling laws and not punitive and aggressive legislations that can cause mental agony and depression," Misra said.

The focus of the Bill is mainly on cigarettes while the World Health

Organisation (WHO) has said the most prevalent form of tobacco consumption in India is smokeless tobacco and commonly used products are 'khaini', 'gutkha', betel quid with tobacco, and 'zarda', the

report added. It said the survey findings also revealed that 'beedi' and chewable tobacco comprise over 75 per cent of tobacco consumption in India, followed by cigarettes at 20.89 per cent. The report said though the Bill proposes to enhance punishments for failure to adhere to the law and envisages tackling black marketing and smuggling of tobacco products, it does not assign any guidelines for the law enforces in this regard. As per the survey, 66.50 per cent of the respondents feel in convenienced by second-hand smoke (a mixture of the smoke from the burning tip of a cigarette and the smoke exhaled by a smoker) and 64.40 per cent think that designated smoking rooms are indeed helpful.

This implies that the proposal to shut down designated smoking areas in airports, restaurants and hotels will increase the exposureof people to second-hand smoke, the statement said.

No reopening ruling on promotion quota for SCs/ STs, says SC



New Delhi, Sep 14: The Supreme Court Tuesday said it would not reopen its decision on granting reservation in promotions to Scheduled Castes (SCs) and Scheduled Tribes (STs) as it was for the states to decide how they implement it.

Taking up various pleas pertaining to alleged hurdles in granting reservation in promotions to SCs and STs in various states, a threejudge bench headed by Justice Nageswara Rao directed the Advocate on Records of state governments to identify issues peculiar to them and submit those within two weeks.

We are making it very clear that we are not going to reopen Nagraj or Jarnail Singh (cases) because the idea was only to decide these cases in accordance with the law laid down by the court," said the bench, also comprising Justices Sanjiv Khannna and B R Gavai.

The top court noted that in its earlier order, the state governments were directed to finalise the issues which are peculiar to them so that court can proceed in the

The issues framed by the Attorney General KK Venugopal and the ones circulated by others are enhancing the scope of cases, that. There are certain issues which are already decided in Nagraj that also we are not going to take up. We are very clear that we are not going to permit any arguments for reopening of cases or arguing that law laid down from Indira Sahney is wrong because the very scope of these cases is to apply the law as laid down by this court." the court said.

Venugopal submitted before the apex court that nearly all these issues have been covered by judgements of the top court and he would give a background of all the cases on issue of reservation since the Indira Sawhney case. Senior advocate Indira Jaising contended that the issue which remains open is benchmarks for adequacy on how a state will decide on which groups are backwards.

"It is not a question of disputed facts any more. In some cases HCs have struck down on the ground that backwardness has not been shown. How any state will establish that representation is adequate and in that sense there will have to be benchmarks for adequacy which will require detailed consideration. she said. Responding to the submission, the bench said, "We are not here to advise the government what they should do. It's not for us to tell the government how to implement policy. It has been specifically held as to how the states have to implement it and consider backwardness and representation. States have to decide what to do subject to judicial review." Senior advocate Rajeev Dhavan said he does not want to get into the question of representation as Indira Sawhney judgment is clear that it's not proportionate representation.

She appeared for the national test Sunday and had told her parents that some questions were tough and that she was concerned about the outcome, he said adding "investigation is still on.

Another official told PTI that police received information early today and the body was sent for post-mortem to a government hospital and later handed over to the family.

In a major step against the National Eligibility cum Entrance Test (NEET), the Tamil Nadu government Monday had passed a bill in the State Assembly seeking exemption from the centralised exam, and making Class 12 exam marks the basis for medical admissions for undergraduate courses.

All parties, with the exception of the BJP, supported the new Tamil Nadu Admission to Undergraduate Medical Degree Courses Bill, 2021. In the statement of objects and reasons, the Tamil Nadu government has said this bill is being moved as the National Eligibility cum-Entrance Test is not a fair or equitable method of admission, and that it favours the rich and elite sections in society.

27 offices of defence ministry to move to new buildings

New Delhi, Sept 14: Over 7,000 employees belonging to 27 different offices of the defence ministry and the three services will move from and around the Raisina Hills area to two new swanky buildings, officials said Tuesday.



Prime Minister Narendra Modi is expected to inaugurate the two office complexes Thursday, they said. The two new multi-storey buildings, one at the Kasturba Gandhi Marg area and another at_ Africa Avenue, have been constructed at a cost of Rs 775 crore by the defence ministry, the officials said. The two buildings have a total space of 9.60 lakhs sq feet as against 9.22 lakh so feet vacated by the 27 offices in various hutments and office complexes, they said.

Fourteen offices are being relocated to the KG Marg complex having a built-up area of 4.52 lakh sq feet while 13 offices are being relocated to the Africa Avenue building that has a total built-up area of 5.08 lakh sq feet, the officials said.

The process to shifting the existing offices to the new buildings will start in the next few days, they said. The new buildings, constructed by the Ministry of Housing and Urban Development as part of its Central Vista project, provide a modern eco-friendly, green building environment, the officials said.

The total land parcel required for the new office complexes is 13 acres as against 50 acres where the existing offices are spread across.

PAK BASED TERROR MODULE BUSTEI

New Delhi, Sept 14: The Special Cell of Delhi Police said Tuesday that it has busted a Pakistan-based terror module and arrested six persons, including two people who were trained in Pakistan.

Furnishing details of the multistate operation, a Delhi Police Special Cell official said that they had received inputs from the central agencies that a conspiracy was being hatched to conduct terror strikes in major cities of the

After receiving this input, the Special Cell constituted a team under the supervision of DCP Pramod Khushwaha and ACPs Hridya Bhushan and Lalit Joshi.

"After analyzing human and

technical inputs, we realized that it was a very big network that was spread in different states. On Tuesday morning we concluded this operation by conducting multiple raids in different states," Special Commissioner of Police, Special Cell, Neeraj Thakur, said at a press briefing.

The first person named Sameer, hailing from Maharashtra, was arrested from Kota while he was travelling in a train while two other were nabbed in the national capital. From more human and technical inputs, the Special Cell in close cooperation with the Uttar Pradesh Anti Terrorist Squad (UP-ATS) conducted raids in the state and arrested three more people.

Thakur said of the six arrested,



two had been taken to Pakistan via Muscat where they were trained to use explosives and firearms, including AK-47. "The training con-

tinued for 15 days after which they returned to Muscat. They revealed that during their training in Pakistan, there were also 14-15 Bengali speaking persons in their group," the special cell official said.

Thakur said that it seems like the terror operation was closely coordinated from across the border. He said the module was divided into two teams. "One team was given to the underworld which was being coordinated by Dawood Ibrahim's brother, Anees Ibrahim. Their task was to get the arms from across the border into India and keep them concealed. The second team was asked to arrange funds via Hawala," the officer said.

The Special Cell informed that one person out of the six arrested was given the task to identify locations in major cities of the country where they could carry out the terror attacks during the forthcoming festival season.

The Special cell is interrogating the suspects and a further probe is on," the official added.

The underworld operative Sameer, a close contact of Anees Ibrahim, who is brother of Dawood Ibrahim, was tasked by a Pak-based person connected with underworld operatives hiding in Pakistan, to ensure smooth delivery of improvised explosive devices (IED), sophisticated weapons and grenades to different entities in India.

Anees Ibrahim, who is presently based in Pakistan, is stated to be the underworld connect of this module, police said.



Uneasy calm prevails in BJP

An uneasy calm prevails in the BJP as many prominent leaders of the party in UP, Haryana, Rajasthan, Punjab and elsewhere are pressing for an amicable solution to the demands of the agitating farmers. These voices were earlier confined within the four walls of the party but are now finding their way in the public. At least two prominent leaders of UP, including a Union Minister and Lok Sabha MP, have expressed the view that talks with the farmers should be held. A number of BJP leaders belonging to Western UP have conveyed to the party high command that a deadly combination of MJGAR (Muslim, Ahir, Jat and Gujjar) once created by late Chaudhary Charan Singh in the 1970s may resurface. This may create a political havoc

in the Assembly polls in February-March next year. A recent internal survey conducted by the BJP has not painted a rosy picture either despite Modi-Yogi leadership remaining invincible. Haryana Deputy Chief Minister in the BJP-led NDA government, Dushyant Chautala has publicly sided with the agitating farmers. Similar sentiments have been expressed by party leaders in Punjab where the BJP has already lost a crucial ally in Shiromani Akali Dal. In Rajasthan, the BJP got its biggest jolt when it suffered a huge defeat in Panchayat Samiti polls at the hands of the Congress after seven years. The BJP could get only 550 Panchayat Samiti seats compared to Congress' 670 seats. The BJP is already facing its waterloo in Rajasthan as it is split between the pro and anti Vasundhararaje factions.

Delhi tops in bankruptcy

Maharashtra may have the maximum registered and functioning companies in India. But when it comes to companies going bust, Delhi tops the list It is learnt that under the Insolvency and Bankruptcy Board of India (IBBI), 283 firms were admitted to the corporate insolvency resolution process (CIRP) until December 2020. Of these 283 companies, as many as 189 were sent for liquidation under the Corporate Insolvency Resolution Process (CIRP). Surprisingly, Delhi topped the ladder with 58 companies followed by Maharashtra (37) and Gujarat with 36 companies. There were none in Odisha, while just 3 in West Bengal. If Haryana had 1 company to be liquidated, Punjab had 4. In the case of 128 companies, the cases were closed due to withdrawal or settlement. Even here, 38 belonged to Delhi, while the number of companies in Maharashtra was 20. There were 76 companies where issues were resolved through a mutually discussed mechanism. Even here, Delhi topped with 19 companies followed by Maharashtra with 16 companies. In addition to 283 companies, 30 corporations were dissolved and went under liquidation process or sold as going concern while 59 corporations were dissolved under voluntary liquidation process. The number would have run into thousands had the government not raised the thrash-hold limit of NPAs and default. The Ministry of Corporate Affairs (MCA) raised the threshold of default under the Insolvency and Bankruptcy Code, 2016 to Rs 1 crore from the existing threshold of Rs 1 lakh to aid the functioning of corporates which might face default

owing to the economic slowdown and unprecedented situation due to Covid-19.

BJP not to project **Dhami as CM face**

f the Congress is witnessing public spat In some of the states, the ruling BJP is also facing its waterloo in a couple of poll bound states. Of the five states that are scheduled to go for polls in March next year, it is comfortably in power in four barring Punjab. But the party is facing a peculiar situation in Uttarakhand where it changed three Chief Ministers in the past six months beginning with Trivendra Singh Rawat in March and Tirath Singh Rawat in July to install Pushkar Singh Dhami. It now transpires that Dhami will not be projected as the BJP's Chief Ministerial face in the ensuing Assembly polls. Instead, the BJP will go to the polls in the state under the sole leadership of Prime Minister Narendra Modi. Of course, there will be campaign posters of several prominent state leaders including Trivendra Singh Rawat, Tirath Singh Rawat, Pushkar Singh Dhami and BJP state chief too. But there may be a new name in the posters i.e. BJP's media department head Anil Baluni. The low-profile leader who is a member of the Rajya Sabha and works from behind

the scenes. Some of the recent poll surveys conducted by TV channels showed him more popular in the state than any of the leaders. The BJP also conducted its own surveys and decided that it should fight elections under the "collective leadership formula".

Nadda looks to fill vacancies

BJP president JP Nadda has a huge problem in hand to accommodate 11 of the 12 sacked ministers, including 6 Cabinet Ministers, in the organisation. Of the 12. Thaawar Chand Gehlot had already been appointed Karnataka Governor. Others are cooling their heels. No party work has been allotted to them though none of them attained the retirement age of 75. What is important is that newly annointed minister Bhupendra Yadav continues to hold two important portfolios and also the post of the party general secretary. Now he is in charge of Manipur too. But Nadda who recently underwent a knee procedure, could not get his own team of general secretaries and office bearers. It is now becoming clearer that he may not get his own team at least until the Assembly elections in UP and 4 other states are over.

Zhao said, China is not only a major engine of economic growth in the Asia-Pacific, but also a staunch defender of regional peace and stability, he said

Kabul, Sept 14: The Taliban have denied that one of their top leaders has been killed in a shootout with rivals, following rumours about internal splits in the movement nearly a month after its lightning victory over the Westernbacked government in Kabul.

Sulail Shaheen, a Taliban spokesman, said Mullah Abdul Ghani Baradar, former head of the Taliban political office who was named deputy prime minister last week, issued a voice message rejecting claims he had been killed or injured in a clash.

"He says it is lies and totally baseless," Shaheen said in a message on Twitter.

The Taliban also released video footage purportedly showing Baradar at meetings in the southern city of Kandahar. Reuters could not immediately verify the footage.

The denials follow days of rumours that supporters of Baradar had clashed with those of Sirajuddin Haqqani, head of the Haggani network that is based near the border with Pakistan and was blamed for some of the worst suicide attacks of the war.

The rumours follow speculation over possible rivalries between military commanders like Haggani and leaders from the political office in Doha like Baradar, who led diplomatic efforts to reach a settlement with the United States.

The Taliban have repeatedly denied the speculation over internal divisions.



Baradar, once seen as the likely head of a Taliban government, had not been seen in public for some time and was not part of the ministerial delegation which met Qatari Foreign Minister Sheikh Mohammed bin Abdulrahman Al-Thani in Kabul Sunday.

The movement's supreme leader, Mullah Haibatullah Akhundzada, has also not been seen in public since the Taliban seized Kabul August 15, although he issued a public statement when the new government was formed last week.

Speculation over Taliban leaders has been fed by the circumstances surrounding the death of the movement's founder, Mullah Omar, which was only made public in 2015 two years after it happened, setting off bitter recriminations among the leadership.

Opposed to UNHRC initiatives: Sri Lanka

Colombo, Sept 14: Sri Lanka Tuesday said that it is opposed to the UNHRC initiatives adopted through its latest resolution on the country's human rights accountability, stressing that any such move will polarise the society.

Foreign Minister GL Peiris made the comments during an oral submission at the ongoing 48th session of the UNHRC, which got underway in Geneva Monday.

He was responding to the oral update on Sri Lanka's human rights situation presented United Nations High Commissioner for Human Rights Michelle Bachelet. She had raised several concerns on the island nations rights accountability.

The UN Human Rights Council had in March adopted a strong resolution against Sri Lanka's rights record, calling upon the (Sri Lankan) government to ensure prompt thorough and impartial investigation, if warranted, pros-

ecution of all alleged crimes relating to human rights violations and serious violations of international human rights law.

He said that the council must adhere to its founding principles and external initiatives, such as the UNHRC, without Sri Lanka's cooperation cannot achieve the desired goals and will be subject to politicisation.

Peiris warned that the resources expended on the UNHRC resolution on Sri Lanka were unwarranted, "especially when they are urgently needed for humanitarian and other constructive purposes in many parts of the world"

He said that Sri Lanka has made progress in rights accountability through its own mechanisms such as establishing the office on missing persons and office for reparations.

Dutch police believed the 54-year-old, referred to as 'Mark L' by his lawyer, was Sicilian crime lord Matteo Messina Denaro (59) and he was nabbed in a restaurant in The Hague by armed cops. according to sources

Denaro is accused of several murders and has been at large since 1993. Italy has issued a European arrest warrant for the mafia boss who remains one of the most wanted criminals in the world. An old picture of what the

suspect could look like has been widely circulated by both Italian and Dutch media outlets.

The lawyer said it had been a case of mistaken identity. It has now been established that the man is not the wanted Italian fugitive and has since been released, according to the public prosecution service in the Netherlands.

Putumayo Province, Sept 14: An environmental activist in southern Colombia's steamy jungle province of Putumayo was preparing to run some errands earlier this year when she received a warning from a contact, she said.

He wrote me a message saying, "It's better I don't go outside...They've sent someone to kill you three times already, she recalled, referring to crime gangs operating in her village." Reuters could not verify the content of the message.

The woman, who has protection from government bodyguards, is one of scores of activists under threat in Colombia, the world's most dangerous country for environmentalists.

She fled her village last October after her activism and opposition to drug crops that damage the Amazon rainforest made her a target for crime gangs.

An Indian court last year ordered the mobile carrier, a joint venture between the Indian unit of Britain's Vodafone Group (VOD.L) and Aditya Birla Group's Idea Cellular, to pay just over \$8 billion to the government to settle longstanding dues. Vodafone has a stake of about 44% in the company and Aditya Birla owns nearly 27%.

In June, Vodafone Idea's then non-executive chairman Kumar Mangalam Birla warned that without a government reprieve the Indian mobile carrier's "financial situation will drive its operations to an irretrievable point of collapse".

Vodafone Idea's gross debt as of June 30 was 1.9 trillion rupees, comprising of deferred spectrum payment obligations of 1.06 trillion rupees and an adjusted gross revenue liability of 621.8 billion rupees, its latest stock exchange filing in June showed. The mobile operator also reported that it owes 234 billion Indian rupees (\$3.18 billion) to financial institutions.





INTER TEST AWAITS REAL

Madrid, Sept 14: Thirteen-time Champions League winners Real Madrid travel to the San Siro Wednesday evening for their opening Group D clash against Serie A champions Inter

This is the second consecutive campaign in which these two European giants, along with Ukrainian outfit

Shakhtar Donetsk,

have been drawn in the same group of the tion; Los

Blancos beat the Nerazzurri home and away last season, including a 2-0 victory in Milan.

Since their triumphant 2009-10 Champions League campaign under Jose Mourinho, Inter have only ever progressed from the group stage on two occasions, and have qualified for the competition just five times.

The Nerazzurri had previously endured a difficult period in the 2010s with new ownerships and a plethora of managers at the helm, though stability and progress has clearly been noticed in recent seasons and the club are now hoping to reach the heights that they did over 10 years

After winning their first Scudetto in over a decade last season, Inter have begun their title defence with impressive 4-0 and 3-1 victories against Genoa and Hellas Verona respectively, before playing out an entertaining 2-2 draw away at Sampdoria last weekend

Simone Inzaghi's side were in front on two occasions, with first-half strikes from Federico Dimarco and Lautaro Martinez, though the hosts pegged them back twice to ensure the spoils were shared at the Luigi Ferraris Stadium.

Inter now turn their attention to Europe's elite club competition with an opening fixture against the team who will likely be their toughest opponent in the form of Real Madrid, a club they have actually beaten in four of their six competitive meetings on home soil.

Despite this impressive home record, the Nerazzurri have in fact lost four of their last five games against Los Blancos in a European competition, and will likely be in for a challenging evening Wednesday, Claiming points in midweek.

however, would be highly beneficial for Inter's quest to reach the knockout stages and for them to potentially qualify as group winners.

Seeking their 14th Champions League crown and their first since 2017-18, Real Madrid remain as one of the tournament's favourites, though the competition around them has improved greatly and success this campaign could prove to be a challenge.

Under the tutelage of former boss Zinedine

Zidane, Los Blancos finished top of their group last season - ahead of both Inter Milan and Shakhtar Donetsk - before beating Atalanta and Liverpool in the knockout stages. Real were ultimately sent packing by eventual champions Chelsea, losing 1-3 on aggregate in the semi-finals.

Los Blancos head into Wednesday's opening group-stage clash on the back of a 5-2 La Liga victory against Celta Vigo, which was the first game played at the Santiago Bernabeu in over 18 months.

Around 25,000 supporters certainly got their value for money, as they saw talisman Karim Benzema score a hat-trick, while Vinicius Junior and summer signing Eduardo Camavinga were also on the score-

Real, who have now climbed to the La Liga summit with 10 points from their opening four matches, have an impressive record against Italian opposition, winning 12 of their last 13 matches in the Champions League, including their previous two against Inter last season.

Head coach Carlo Ancelotti, who won the Champions League with Los Blancos in 2013-14, has the greatest win percentage (76) of any manager at a single club in the competition's history who has managed at least 20 games.

The Italian will return to familiar territory on Wednesday night, with expectations from the board and supporters high, as they aim to kickstart their campaign with all three points.



No Mbappe, no issue, we have Vinicius: fans

Madrid, Sept 14: Vinicius Junior is quickly helping the Real Madrid faithful to forget about Kylian Mbappe. Madrid fans were frustrated with the failed negotiations to bring in Mbappe at the transfer deadline last month, but a few matches into the new season they have found that they can count on Vinicius.

The fans have embraced Vinicius, and did that literally on Sunday when the young Brazilian jumped into the stands to celebrate with the crowd after scoring in the 5-2 win over Celta Vigo in the Spanish league in the reopening of the Santiago Bernabeu Stadium after more than 18 months.

Vinicius was engulfed by fans, who profusely hugged him before stewards and police officers helped him back onto the field. The visit to the stands earned him a yellow card but was a big hit with fans who hadn't been at the Bernabeu since it was closed because of the pandemic and a massive renovation project.

The 21-year-old Vinicius got off to a great start this season, scoring four goals in the first four matches and being a crucial part of Madrid's attack alongside Benzema.

The Brazilian had been often criticised for his lack of goals but has clearly improved, becoming an even greater threat as he continues to display amazing speed and uncanny skills.

Vinicius, who arrived in 2018 as a teenager from Brazilian club Flamengo for nearly 45 million euros (USD 53 million),

will be even more important to Ancelotti in the near future forward Gareth Bale will be sidelined for a while because of a muscle injury.

"Hanging up my T20 shoes and retiring from all forms of cricket! Thankful to all those who supported me in my journey, and looking forward to sharing my experience with young cricketers in the years to come," Malinga tweeted.

Malinga had retired from Test and ODI cricket in January this year but was yet to call it quits from T20 internationals

"I am looking forward to help youngsters and guide them in the coming years," he said as he thanked his national team and all the franchises that he has played for, including IPL team Mumbai Indians

"I want to give 100 per cent rest to my T20 shoes. While my shoes will rest, my love for the game will never ask for rest," a smiling Malinga added in the video.

Washington, Sept 14: Patrick Cantlay was voted PGA Tour player of the year on the strength of his four victories, including a one-shot advantage at East Lake that made him the FedEx Cup champion.

Tuesday's announcement was another big step for Cantlay, a 29vear-old Californian who went from being the No. 1 amateur in the world to being unable to play for some three years because of a career-threatening back injury.

Now he has the Jack Nicklaus Award after a big finish to his best season. Cantlay won four times this season, capped off by the FedEx Cup. No one else won more than twice.

The PGA Tour does not release vote totals or how many players even voted. It presumably was a tight race between Cantlay and Jon Rahm, the No. 1 player in the world.

Rahm finished one shot behind Cantlay at the Tour Championship, where the Spaniard started the tournament four shots behind. He picked up his first major this year rookie of the year, the first player in 20 years to receive the award without being a full **PGA Tour member**

at the U.S. Open with a birdie-birdie finish. Rahm also had a six-shot lead going into the final round of the Memorial until having to withdraw with a positive COVID-19 test.

Cantlay wound up winning the Memorial for his second win of the season, and then he set himself apart at the end. He won the BMW Championship at Caves Valley with as clutch a putting performance as there has been all year to beat Bryson DeChambeau in a playoff, and then he won the Tour Championship to collect the FedEx

Cup and its USD 15 million prize. Rahm, meanwhile, won the PGA of America award as player of the year. That's based on points, with triple value for winning a major.

'With the World Cup and the Ashes, it would have been too much in a short space of time. I would have loved to have been part of the IPL but something has to give,' Woakes, who will play for Warwickshire this week, said.

Woakes said the T20 World Cup,

set to begin in the UAE and Oman

after the conclusion of the IPL, and the Ashes series assume significance which is no less than England's summer of 2019. "A World Cup and an Ashes tour,

it's almost as big a winter as our summer was in 2019. It's a shame with what's going on Covid-wise that it's not going to be as normal as everyone would like. But, from a cricket perspective, it's very exciting."

Woakes has shown keen interest in travelling to Australia for the Ashes when a lot of British players are unsure of going Down Under due to expected stringent restrictions. It is expected that (Australia will not allow players with their families on the Tour.
