

2 pilots die after Army copter crash-lands

JAMMU: Two pilots were killed when an Army helicopter crashlanded in a dense forest near Patnitop in Jammu and Kashmir's Udhampur district on Tuesday, officials said. "Today, during a training sortie in Patnitop area, Indian Army's Cheetah helicopter crashlanded in Shiv Garh Dhar area in the district," a Jammu-based defence spokesman said. He said that two pilots -- Major Rohit Kumar and Major Anuj Rajput -- were injured in the incident and evacuated to the nearest medical facility but they succumbed later. Army Commander, Northern Command, Lt Gen Y K Joshi paid rich tributes to the slain officers. "Army Commander, Northern Command, and all other ranks salute the bravehearts who made the supreme sacrifice in the line of duty on 21 September 2021 at Patnitop and offer deepest condolences to their families," the Army's Northern Command said in a tweet.

SC collegium India vows action against UK

New Delhi, Sept 21: The Supreme Court collegium, headed by Chief Justice NV Ramana, has recommended elevation of eight judges as Chief Justices of various High Courts (HCs) and transfer of five sitting Chief Justices, including justice AA Kureshi to other HCs.

UP mulls law to curb population

Lucknow, Sept 21: The state government will bring a law for population control "at the right time", Uttar Pradesh Chief Minister Yogi Adityanath said Tuesday.

The government had in July unveiled a policy aimed at stabilising the population in Uttar Pradesh and reducing maternal and infant deaths in a time-bound manner, with Adityanath terming rising population a "hurdle in development".

"Everything is done at an appropriate time. The media earlier used to question the BJP on when it would announce a date for the Ram temple's construction, but the prime minister (Narendra Modi), despite the COVID-19 pandemic, laid the foundation stone of the temple in Ayodhya August 5 last year, and all need to be happy now," Adityanath said at a conclave.

"Similarly, Article 370 was also scrapped by the prime minister and Union Home Minister Amit Shah," he said. On August 5, 2019, the Centre had abrogated Article 370, which gave special status to the erstwhile state of Jammu and Kashmir, and bifurcated it into 🔫 union territories of Jammu and Kashmir, and Ladakh.

At the 'News 24' conclave, when asked about his recent 'abba jaan' remark, the chief minister said,"They (opposition) want the vote of Muslims but are getting irritated with 'abba jaan'.'

Low water levels in dams may hit power generation

Most of the dams in the state have less water than their capacities. The situation, if not taken care of, may scuttle the govt's plan to add 700 MW more electricity to the state's power pool

Bhubaneswar, Sept 21: Though several districts in Odisha have received heavy rains due to a low pressure over Bay of Bengal, major dams in the state are witnessing low water levels in comparison to their water storing capacity.

There is every possibility that the low water level in dams will affect the production of hydroelectricity in the coming days, sources said

It is learnt that all major dams in Odisha except Hirakud dam do not have adequate water to meet the hydroelectricity production requirements. The water level in Hirakud was 629.28 ft Tuesday against its maximum storage capacity of 630 ft.

The water level in Balimela dam was pegged at 1,476 ft against its storage capacity of 1,518 ft. Similarly, the water level in Rengali dam was measured at 122 metre against its maximum capacity of 124 metre. According to sources, the depth of water in Upper Kolab dam was

measured at 850 metre against its storing capacity of up to 858 metre.



At present, the Upper Indravati dam has 632 ft of water against its capacity of 643 ft. Similarly, the water level in Machhkund dam was measured at 2.726 ft Tuesday while the dam can hold water up to 2,750 ft.

"Most of the dams in Odisha are now witnessing up to 25 per cent less water storage than their normal capacity. The south-west monsoon will leave the state within a few days. There is very low possibility of improvement in the water level in these dams. So, the production of hydroelectricity may get affected in the coming days," said a source familiar with the issue.

According to sources, the average electricity demand in Odisha hovers around 4,500 MW while the state usually produces 2,063 MW of hydroelectricity from its dams. As per the available data, the state produces 275 MW electricity from Hirakud at Burla, 600 MW from Indravati, 510 from Balimela, 300 MW from Rengali, 320 from Upper Kolab and 36 MW from Machhkund.

"Many places in the state are witnessing outage during the monsoon. The shortage of electricity may aggravate during summer," added the source.

There were reports that the state government was planning to construct six more hydroelectricity projects in Odisha and produce around 700 MW more power.

'The amount of monsoon rain is decreasing over the years due to change in the climate condition. In this context, the future of the proposed hydroelectricity projects has been pushed into uncertainty. The state government should take note of the situation and act accordingly to meet the power shortage in future," said All Odisha Electricity Workers' Association general secretary Akhaya Kumar Tripathy.







Bhubaneswar, Sept 21: The state government has approved developmental projects worth ₹640.65 crore for seven mining-affected districts under Odisha Mineral Bearing Areas Development Corporation (OMBADC) funds.

The board of directors of OM-BADC has approved the projects during its meeting held under the chairmanship of Chief Secretary Suresh Chandra Mahapatra here on virtual mode.

The projects have been approved in the sectors of education, environment and sports for the mineral bearing districts.

Chief Executive Officer (CEO) of the OMBADC, Uma Nanduri, said projects to the tune of ₹533.40 crore have been approved for 889 secondary schools in Angul, Dhenkanal, Deogarh, Jajpur, Jharsuguda, Mayurbhanj and Sundargarh districts

Mahapatra asked the officials to provide world-class education and exposure to the students under the secondary school development programme.

Since the smart classroom, e-library, science lab and ICT lab would be developed through the new project, the teachers must focus on providing the best education to the students with global exposure, he said

As many as five committees have been created to prepare separate action plans for both short and long terms which will be implemented successfully in the jails across the state.

"It has been decided to undertake long term and short term measures towards transformation of prisons by adoption of best practices prevalent in various states and countries and extensive use of technology for transparent administration of prisons. Accordingly, following committees are constituted herewith to undertake studies of best practices/technology and formulate suggestions/guidelines for im-



plementation in jails of Odisha,' read the circular.

These committees will be headed by senior officials including two DIGs.

They will comprise five nodal officers and 21 jail officials as members.

The directorate also asked the nodal officers of the committees to take suggestions and opinions from other jail officials including jail guarding staffers who are not included in above commit-

The nodal officers have been asked to hold regular meetings

with members and senior offi cials heading committees on a virtual mode every week.

'Nodal officers of each committee shall take steps for holding regular meetings (online mode) on weekly basis involving respective heads of committees and other members of the committees. However, opinions from other officers of prisons/correctional services as well as guarding staff) may be taken, if volunteered"

The 5T monitoring committee headed by Tapan Kumar Patra, accounts officer of the directorate will prepare an action plan to install low cost and effective technological tools in the jails over next five years

Similarly, the R&D and e-governance committees will suggest installation of advanced technical gadgets in the jails by engaging various organizations having expertise in the field. Other committees include magazine and publication, welfare of women prisoners and transgenders and reforms, correc-

Khurda accounts for 43% fresh Covid-19 infections

Bhubaneswar, Sept 21: Khurda district continued to report the highest number of new cases in Odisha, registering over 43 per cent of the total 462 fresh infections Tuesday, which pushed the state's caseload to 10,21,216, a Health department official said.

Odisha's coronavirus death toll surged to 8,146 as five fresh fatalities were reported. One casualty each were reported from Khurda, Puri, Cuttack, Angul and Balasore districts. A total of 268 new cases were reported in quarantine centres, while 194 infections were detected during contact tracing, the official informed. Seventy patients of the total new cases were children and adolescents. The rate of infection in the 0-18 age group slightly dipped to 15.15 per cent from 15.49 per cent Monday.

As many as 201 new patients, or 43.50 per cent of the total daily spike, were reported from Khurda alone, the district under which Bhubaneswar falls. Jagatsinghpur trailed distantly with 31 infections

followed by 30 in Cuttack.

Khurda currently has 2,351 of the 5.351 active cases in Odisha. It is the only district in state marked yellow zone as it has less than 2,500 active cases

It has also registered 1,488 fatalities so far, including 1,015 in Bhubaneswar alone.

As many as 10,07,666 people have recovered from the disease so far, including 600 in the last 24 hours. Fifty-three patients have died due to comorbidities so far. The state has administered over 2,79,34,744 Covid-19 vaccines so far. Among the beneficiaries, 73.77 lakh have been fully vaccinated.

"#Odisha reached a new milestone in #Covid-19 by administering 4,16,454 does in a single day! Many congratulations to Team Health Odisha for making it possible," the Health Department tweeted. Odisha has thus far tested over

1.93 crore samples for Covid-19, including 57,135 Monday.

Woman tonsured for duping villagers; 10 detained

Kendrapara, Sept 21: A 40-yearold woman was allegedly tonsured and paraded on the street with her face blackened in Kendrapara district by locals, most of them women, for allegedly duping them after promising to get their loans sanctioned from a cooperative bank, a police officer said Tuesday.

The disturbing episode took place a couple of days ago at a village under Pattamundai block, the officer said.

A video of the incident has gone viral on social media. Meanwhile, the victim pleaded with the angry mob to spare her and handed over her debit card to them. She even promised that her husband would repay the money taken from them. However, the irate women refused

to listen and went on assaulting her. 'We have initiated steps after the victim lodged a complaint. At least 10 women have been detained on the basis of the videographic evidence," Pattamundai model police station inspector Tapan Rout said.

The Bhograi tehsildar invited the officials of the Revenue and Irrigation departments of West Bengal to discuss the issue on the Bhograi tehsil premises. However, no official from the neighbouring state cooperated till the last report came in. Meanwhile, Marine police were mobilised at the place amid tension among people.

It may be noted here that since 1978 the neighbouring state has intruded into Odisha seven times.

Local villagers of Udaipur in Bhograi block have been strongly opposing the intrusion bids by the West Bengal government.

Why Bhitarkanika was denied World Heritage status

Kendrapara. Sept 21: Bhitarkanika has been given the status of a national park and has been declared a RAM-SAR site by the UNESCO. However, it has been denied the prestigious World Heritage Site status

Sensitive zone monitoring committee member Srikant Nayak, environmentalist Hemant Kumar Rout, social activists Sanjay Kumar Behura and Pradeep Kumar Tarai recently alleged that the status was denied to the Bhitarkanika National Park (BNP) due to several downsides of the national park.

They said that the meeting of International Union for Conservation of Nature (IUCN) held at Krakow in Poland July 2017 turned down the request to confer the World Heritage Site status to BNP. Besides the negative aspects, the dossier submitted to the IUCN included certain misinformation regarding

the park. They further alleged that no

assessment has been done so far as to why the prestigious status was denied to the national park. They said the mangrove trees are the life of the BNP. While these trees serve as a protective wall during natural disasters, they also help provide a safer environment to the wild animals, birds and marine creatures

According to them, a report was prepared by M Doak and Remko Van Merm, the

two members of the technical evaluation team of IUCN deputed by UNESCO in November, 2016. In the report, they stated that the Indian Wildlife (Protection) Act, 1972 has already been implemented in the BNP and despite this, there are personal land holdings inside the park. Moreover, people are moving freely, farming activities are being carried out, cattle grazing and prawn gheries are active inside the park.

Similarly, in their report,

Doak and Van Merm expressed their concern saving that the boundary line of the park lacks proper management. Over 400 villages inside the park along with its proximity to Dhamra port and missile testing range at Wheeler Island pose threats to the park. Similarly, fresh water is essential for the sustenance of mangrove trees and animals. However the fresh water flow is gradually decreasing. On the other

A technical evaluation team observed that existence of villages inside the park along with its proximity to Dhamra port and missile testing range pose threats to BNP

hand, lack of funds is hampering effective management and to initiating measures to check erosion.

Most importantly, the guidelines related to eco-sensitive zone are not being implemented properly at the park, the report stated.

The negativities mentioned in the report along with other similar issues were discussed at the IUCN meeting, and taking them into consideration, the meeting concluded that the BNP is not eligible for the World Heritage Status.

The sensitive zone monitoring committee member

Nayak, environmentalist Rout, social activists Behura and Tarai demanded that all the negative aspects of the BNP should be analysed and necessary steps should be taken to solve the issues.

When contacted, Rajnagar DFO Jagyandatt Pati said that the issues working against BNP in achieving the World Heritage Site status are being studied and efforts are being made to get it enlisted again as one of the World Heritage Sites.

CORPORATE CAPTURE OF FOOD

hen I visited my parents in Bogotá last month, I witnessed how people in their neighbourhood went up and down the streets begging for help to survive. Since the end of April, Colombia has experienced one of its biggest waves of social unrest in recent times - and hunger is at the core of the protests. South Africa experienced similar turmoil in July.

Growing hunger is creating volatility in many countries, compounding the devastating social and economic impact of the COVID-19 pandemic and the climate crisis. According to recent United Nations figures, the pandemic has increased the number of hungry people by as many as 161 million, to 811 million. Nearly one in three people almost 2.4 billion - lack access to adequate nutrition.

Given the lack of progress toward ending global hunger and malnutrition by 2030, the UN secretary-general, António Guterres, will convene a Food Systems Summit in New York September 23. The meeting has been billed as an opportunity to discuss bold new measures that will transform the way the world produces, consumes, and thinks about food.

But the summit has been marred by controversy from the outset, largely owing to the influence of corporate interests in framing the agenda in what critics have described as an attempt to privatise decision-making. The UN set the presummit agenda in partnership with the World Economic Forum, placing key corporate players in leading roles. For example, the Global Alliance for Improved Nutrition (GAIN), a Swiss-based foundation, leads the summit's work on eradicating hunger: One of GAIN's donors is the pesticide producer BASF, which seeks to portray itself as a 'Food Systems Hero."

UN human rights experts have been damning in their criticism of the process, which has sidelined the UN's Committee on World Food Security (CFS). Discussions at the CFS include hundreds of representatives of smallholder farmers, fisherfolk, indigenous people, and civil-society groups. Michael Fakhri, the UN special rapporteur on the right to food, has echoed the complaints of grassroots farming groups - more than 500 of which are boycotting the summit -likening corporations' excessive influence over the gathering to "inviting the fox right into the The increasing corporate capture of food should concern us all. Smallholder farmers, peasants, fisherfolk, pastoralists, and indigenous people feed most of the world's population with little or no access to corporate supply chains. About 80 per cent of farms are smaller than two hectares, and cover about 12 per cent of the world's farmland, while the largest 1 per cent of agribusiness firms control more than 70 per cent of farmland.

Transnational corporations have a clear conflict of interest when it comes to preventing land grabbing, malnutrition, tax avoidance, and pesticide overuse. The same is true of addressing demands for a move away from intensive farming toward more socially equitable, resilient, and sustainable agroecology. Because these firms are accountable to their shareholders, profit is a more important interest than protection of the common good. But food is a common good, and access to it is a fundamental human right. That is where discussions should begin.

The increasing corporate capture of food should concern us all. If left unchecked, we will face a grim future where a handful of large firms control what we eat and how it is produced. The increased consumption of ultra-processed edible products - a major contributor to the pandemic of obesity, type 2 diabetes, and related diseases - exemplifies the danger.

nutrition. These people need a government capable of taxing large firms properly in order to generate enough revenue to sustain a robust social safety net. And they need a government determined to reverse the extreme inequality in access to land that disadvantages peasants, Afro-descendants, and indigenous people.

Instead of looking to global corporations to solve the growing hunger and malnutrition crisis, the UN and national governments must end the corporate capture of food and promote a transition to agroecology. They should start by ensuring that multinational firms pay their fair share of taxes and are held accountable for the environmental and human-rights consequences of their activities.

In 1948, the UN recognised that food is a human right. Sadly, the UN summit is more likely to feed corporate profits than provide hope to hundreds of millions of hungry people.

Wise abstention

he Supreme Court dismissed a petition outright September 20 filed by a class XII student seeking direction to the Centre and states to physically reopen schools in a time-bound programme and conduct offline teaching. The refusal to entertain the plea has certainly absolved the judiciary of appropriating a task reserved for the executive, but it hardly offers any remedy to a serious socio-economic problem caused by the COVID-19 pandemic. A Bench headed by Justice DY Chandrachud said it can't direct states to reopen schools for physical teaching. It has pertinently observed the apex court can't take over governance and left it to the governments to take a call on the burning issue.

The apex court's ruling cannot be faulted as it lacks the scientific data or knowledge of the magnitude of the pandemic afflicting the country as a whole and states individually. The Court has logically presented its difficulty to consider the plea as it is in the dark about where the COVID-19 spike is happening or in which district the incidence is high. Justice Chandrachud did admit the need for children going back to school. At the same time, without elaborating, the court pointed out the experience in some countries which reopened schools and the consequences of which were not pleasant.

However, it is also undeniable that because of the prolonged closure of schools, both mental and physical health of school-going children are getting seriously affected. More so for millions of poor children who depended for at least one square meal a day on mid-day meals for which physical attendance in schools is required. The indecision and hesitancy on the part of the Centre and several state governments and Union Territories in the matter of reopening of schools and resumption of physical classes with adequate safeguards are being perceived by many as an abdication of responsibilities. On the other hand, the ground realities are complex. No government, Central or state, should take a decision to open schools without 100 per cent vaccination of students, faculty and other staff. The rollout of vaccination for schoolgoing children needs to be worked out and put in place. There is yet no timeline on this from the government.

Those who advance the argument that schools should reopen also plead that to begin with a hybrid mode of schooling in the states which have decided to reopen educational institutions with the option of online and offline education should be tried. This would enable students whose parents don't want to expose them to any risks not to attend school physically.

The pandemic has played havoc with children's education in every aspect. Schools have been shut due to the lockdown from March 25, 2020 and formal education has stopped. Since then, schools have either never opened for some age groups, or opened intermittently. According to a UNICEF report, in India school closures impacted 247 million children in elementary and secondary education and 28 million children in pre-schools and Anganwadi centres.

The Supreme Court in a case (Avinash Mehrotra v. Union of India) held that the right to education includes the right to education in a safe environment. The State cannot renege on its commitment to education. It is legally obligated to find ways to deliver education safely ensuring the health of children. However, such rules may apply under normal circumstances but these are abnormal times. Most private schools, accessible mostly to well-to-do families, have been able to continue education online, but others have been left behind. Many budget private schools are on the verge of closure over financial constraints due to the pandemic. In some states, including Punjab and Haryana, government schools have been regularly admitting students from budget private schools assuring that they won't have to pay for education. This has been possible because parents of these children cannot afford any longer to pay tuition fees in private schools as the pandemic has put financial stress on families

Lockdown and school closures have their justification, which is to ensure public health. A temporary closure of educational institutions is also desirable, but a prolonged failure to provide schooling will definitely damage the future of millions of children But this situation is not limited to India alone. The apex court has correctly abstained from passing an allencompassing judgement that could have impacted health and lives of children across the country.

Percontation

question is just a question, right? Not according to one idea dating from ancient times, according to which there were two sorts of questions those intended to obtain information, and those designed to elicit confirmation or denial. A nineteenth century writer explained it like this: Between a percontation and interrogation, the ancients made this distinction - that the former admitted a variety of answers, while the latter must be replied to by "yes" or "no" (The Dark Ages, by Rev Samuel Maitland, 1844). The two types continue to be recognised today, but by terms such as openended questions or wh-questions (who, what, why, when, which, where, whose, plus how) for the percontation sort and closed questions or yes-no questions for the other. Though the term percontation might be useful to linguists and psychologists today, it was never popular and shortly after Maitland's time vanished from the active language. Its source is the Latin noun percontatio, the action of questioning. Curiously, its root is contus, a long pole, either a boat-pole or a spear, lance or pike, prefixed with permeaning "through" in this case. It appears that percontatio was so vigorous or uncivil that it was like being pierced with a pole. In the late sixteenth century, the printer Henry Denham (some say his client, the translator Anthonie Gilbie) invented a punctuation mark to differentiate the open-ended question from the yes-no sort, called the punctus percontativus or percontation mark. In shape it was a reversed question mark. (Henry Denham was a pioneer in typography: he also advocated the semi-colon, an Italian invention.) Since a percontation question could admit of many answers, it might also mark a rhetorical question, one that didn't require an answer at all. There seems to be no evidence that Denham employed it in this way but the playwright Thomas Middleton did so early in the following century. Nobody else has since bothered with it, mainly because the character has never been available in standard type fonts. As rhetorical questions are often sarcastic or ironic in tone ("What was the use of sending you to school?"), it has been suggested that the mark would be useful to express such emotions in online forums. Its advocates have given it new names, such as snark and irony mark. The old name is never used - it would seem percontation mark is too long, unfamiliar or hard to spell to be acceptable.

"It is built like a Tai Mahal." Sorabiee told CNN. "The western manufacturers just don't think frugal.

It may be built like a Taj Mahal, but Ford unfortunately could not make any money from tourists. All it could do was churn out cars that were too pricey for most car buyers. The Aspire and Freestyle cost twice as much as the Maruti Alto 800, but didn't bring out twice as much envy from the neighbours.

Decline in car sales sends Ford packing

After 25 years in India, Ford managed to capture only 2 per cent of auto sales in India, far behind the 45 per cent market share of Maruti Suzuki and the 17 per cent share of Hyundai.

'Despite investing significantly in India, Ford has accumulated more than \$2 billion of operating losses over the past 10 years and demand for new vehicles has been much weaker than forecast," Ford CEO Jim Farley told CNN

The car market in India is not growing as fast as auto manufacturers had hoped. Annual sales were once projected to be 5 million cars, but have remained at about 3 million, and the growth rate has dropped from 12 per cent a decade ago to 3.6 per cent today, according to Reuters.

If you live in a big city and have to travel on roads that are already congested, you're probably happy that auto sales are increasing at a slow pace.

Driving in Mumbai, for example, is stressful enough without having more cars on the roads. According to a recent survey by UK car-sharing company Hiyacar, Mumbai is the most stressful city in the world for driving.

Paris is second, Jakarta third, Delhi fourth and New York City fifth. Among those five cities, the only one I've driven in is New York City. That was quite stressful for me, partly because of all the drivers trying to get past me on both sides of the road, some of them signaling their intentions with their middle fingers.

As for Mumbai, I've watched videos of people driving in the city.

Mumbai, I would hire not just a driver, but also a doctor. The doctor would monitor my vital signs, make sure I don't suffer a heart attack. Considering the congestion on city roads, it makes sense that many Indians prefer small cars. Not only do they occupy less space, they use less fuel and produce less pollution. And most importantly, they cost far less than the cars Ford is trying to sell.

If I ever need to travel by car in

While a car is often seen as a symbol of success, I see it mostly as a mode of transportation. It's nice to have luxurious features in your car, but you have to pay extra for them, and it's not always a wise investment, considering that cars don't usually appreciate in value they depreciate.

If you can afford to buy a luxury car, good for you. But don't expect to get to your destination any faster than your friend driving a Maruti Alto 800.

Sir, A new travel advisory by the UK that says that people from India and a few other countries will be considered 'unvaccinated' even after two doses of AstraZeneca's Covishield has sparked off a controversy over freedom of international travel during the pandemic. Asking fully vaccinated Indians to quarantine is offensive to them. Given that Covishield was originally developed in the UK and the Serum Institute of India has supplied it to that country too, this suggests racism. India has not yet been included in the 'green' list - countries whose vaccines are recognised by the UK. As per the new directive, passengers not vaccinated as per the rules in the UK, Europe, or the US will have to self-quarantine for 10 days and pay for two COVID tests. It is ironic that these rules exclude a few countries where the AstraZeneca vaccine is used. Covishield is widely used in India. What is the logic of its non-recognition by the UK when the UK government is using the same vaccine under a different name? The new advisory is a cause of concern for India as it will hinder the travel plans of a large number of people in India. It should be recalled that in July there was a controversy over Covishield's recognition by the European Union as well. The governments of such countries must understand that only recognised vaccines are used by countries. People lose sleep over jumbo menace in Angul villages

Boinda, Sept 21: Farmers living in Handapa and Bamur ranges in Angul district have lost their sleep over persistent elephants menace. Over last two months, the animals have wreaked havoc on paddy and vegetables in hectares of land, causing resentment among the locals.

According to reports, 15 panchayats under Handapa range are affected by elephant menace. "In last one month, elephants have damaged crops in 50 acres, 7000 cauliflowers, 3000 maize plants, and brinjals in five acres,' locals asserted.

They accused the forest department of doing little to contain the menace.

The forest department has not taken any step to drive away the animals while locals have been driving them out with crackers and fire brands

Meanwhile, two outfits including Jeeban Jibika Krushi Jami Surakhya Committee have called for agitation against the forest department September 22. Bhograi, Sept 21: Every monsoon, the Subarnarekha river plays havoc in north Balasore, causing massive floods in its basin. Recurrent floodings batter the agrarian economy of downstream areas such as Bhograi, Baliapal, Jaleswar Basta and six panchayats of Mayurbhanj district.

Galudihi Khadkhai and Bankhal barrages. These have helped the neighbouring state in containing floods in the upstream areas.

During floods, the neighboring state has an edge over Odisha. It releases floodwater from the Chandil dam and the barrages, leaving the downstream areas in Odisha to face the fury of flood, they said. In the past, there were several instances of floods in north Balasore after Jharkhand released water from the Chandil dam. Many villages in the downstream areas have vanished or suffered irreparable damages.

The UPA government planned flood control measures in Subarnarekha river to protect the lives and properties of people living in downstream areas. Subsequently, the Central government asked the state government to draw a detailed project report on its renovation. The Odisha government has submitted a project report on Subarnarekha renovation at an estimated cost of ₹900 core.

However, the Central government found the report faulty and returned it to the state. Since then, it has been in cold storage.

The Odisha Livelihood Mission helped these women to get loans, which they used to take up vegetable farming. Today, it has become a source of livelihood for them.

According to reports, prolonged pandemic situation has broken the economic backbone of people minimising the scope of earning a livelihood in various sectors, especially in tribal-dominated dis-



tricts like Malkangiri. "During this time, finding a livelihood was of most important to us. We looked for ways to make a living. Eventually, we took up vegetable cultivation,' said some women of Goudaguda panchayat.

A group of 20 women in the panchayat formed an SHG and applied for loans to raise vegetables with help of OLM. "We have now realised that it is our confidence that has taken us thus far. We put in hard labour and the result is before everyone to see," a member of the SHG said.

"After finishing our household chores, we venture out into the fields with spades and other farming tools every day. There we take care of the vegetables," they said.

These women have grown a variety of vegetables on their farmlands – lady's finger, brinjal, chili and plantain. "We are selling the produce every day and earn something to supplement our family incomes, they said.



in the Indo-Pacific to keep the region stable, rules-based and free of any hegemony, the French president's office said Tuesday after Emmanuel Macron held a telephonic conversation with Prime Minister Narendra Modi amidst Paris' strong criticism of AUKUS (Australia-UK-US) partnership.

According to a statement released by the Prime Minister's Office here, Modi and Macron reviewed the increasing bilateral collaboration in the Indo-Pacific region and the important role that the India-France partnership plays in promoting stability and security in the region.

After his conversation with Macron, Modi tweeted, "Spoke with friend President @EmmanuelMacron on the situation in Afghanistan. We also discussed closer collaboration between India and France in the Indo-Pacific." "We place great value on our strategic partnership with France, including in the UNSC," Modi said. The French president's office also issued a statement over the Modi-Macron talks which was tweeted by

France's Ambassador to India Emmanuel Lenain. "They reaffirmed their shared commitment to act jointly in an open and inclusive Indo-Pacific, including in the framework of the Europe-India relationship and European initiatives in the Indo-Pacific. This approach aims to promote regional stability and the rule of law while precluding any form of hegemony," the French president's office said.

Meanwhile, replying to a query, Foreign Secretary Harsh Vardhan Shringla said the AUKUS is neither relevant to the Quad nor will have any impact on its functioning, and they are not groupings of a similar nature, in the first reaction from India on the contentious alliance. Shringla said while the AUKUS is a security alliance among the three countries, the Quad is a plurilateral grouping with a vision for a free, open, transparent and

inclusive Indo-Pacific. The telephonic conversation between Modi and Macron comes days after the launch of a historic security partnership called 'AUKUS' that aims to provide for deeper cooperation in the Indo-Pacific and ensure greater sharing of defence capabilities within the trilateral alliance.

ED sources said the agency will investigate the people or syndicate behind this heroin smuggling, identify proceeds of crime, and may also attach assets of the accused if required. Official sources said the consignment was imported by a trading company registered in

HOW INDIA FLIPPED ITS VACCINE FORTUNES

VACCINATION IN INDIA: THE HEALTH MINISTER, ONLY MONTHS AGO, HAD TO CONSTANTLY BATTLE OPPOSITION CRITICISM ON SOCIAL MEDIA

New Delhi, Sept 21: Only months ago, India ran so short of Covid-19 vaccines that computer experts wrote software code to help people snag scarce immunisation slots and the then health minister had to constantly battle opposition criticism on social media.

The minister later quit and in came a little-known but hands-on politician, Mansukh Mandaviya, who, according to a person close to him, communicates with vaccine producers on a near-daily basis and tries to resolve their problems promptly.

Vaccine supplies have surged.

Government officials say they are confident of fully immunizing nearly all adults by December, giving it the confidence to announce

a gradual restart of vaccine exports in the October quarter, for the first time since April when a second surge in infections overwhelmed hospitals.

That will help the sputtering global COVAX vaccine-sharing programme, which is far behind its pledge to deliver 2 billion doses this year following supply problems and India's export curbs.

The GAVI vaccine alliance, which sponsors the programme along with the World Health Organization, UNICEF and the CEPI, this month cut COVAX's supply target by nearly 30% to 1.425 billion doses.

"This could have an immense positive impact on both health security within India as well as globally," a GAVI spokesperson said. "Our priority right now is to engage with the government of India



and Serum Institute of India (SII) to understand the impact this will have on our supply schedule."

The turnaround is chiefly thanks to the SII, which is cranking up more doses of AstraZeneca's Covid-19 shot than the government's most optimistic projection.

SII would supply 200 million doses of the vaccine, branded Covishield, to the government this month, compared with about 150 million the previous month, said a government source who declined

to be identified. New production lines

The government said in May that Covishield output could reach 750 million doses between August and December, but the actual output could be more than 900 million, said two other sources with direct knowledge of the matter.

It now has five production lines making Covishield, up from just two in April, according to the source. The person said Serum Institute of India's monthly output could go as high as 215 million doses.

Bharat Biotech, the producer of India's first domestically developed shot, Covaxin, told Reuters its

monthly output would nearly treble to 100 million doses by the end of the vear. India is the world's biggest vaccine maker and its companies including Serum Institute of India,

Over 80 cr vax doses provided

The cumulative number of Covid-19 vaccine doses administered in the country crossed 82 crore Tuesday, the Union health ministry said. More than 68 lakh (68,26,132) vaccine doses were administered till 7 pm, it said. The daily vaccination tally is expected to increase with the compilation of the final reports for the day by late night.

Bharat Biotech and Biological E, which does bottling work for Johnson & Johnson's Covid-19 shot, have trebled their capacity to make nearly 3 billion doses a year, muchof which could be available for overseas sale from next year.

Washington, Sept 21: A CIA officer, who travelled to India with CIA Director William Burns this month, reported symptoms consistent with Havana syndrome, a mysterious affliction that has struck US diplomats, spies and other government workers at home and abroad, US media reports said Tuesday.

The official, who was not identified. had to receive medical attention, CNN reported, citing three unnamed sources. The incident set off alarm bells within the US government and left Burns "fuming" with anger, one source explained. Some officials at the CIA viewed the chilling episode as a direct message to Burns that no one is safe, including those working directly for the nation's top spy, the report quoted two other sources as saying.

The circumstances of the incident are still being investigated. and officials have not yet determined whether the CIA officer was targeted because the officer was travelling with the director William Burns, or for other reasons. If the incident was caused by an adversarial intelligence service, it may not have known the officer was travelling with Burns, The New

York Times reported. A CIA spokeswoman declined to confirm the case in India but said the US government and the agency are taking every incident seriously. "Director Burns has made it a top priority to ensure officers get the care they need and that we get to the bottom of this," the NBC News quoted a spokeswoman as saving.

"We've strengthened efforts to determine the origins of the incidents, including assembling a team of our very best experts - bringing an intensity and expertise to this issue akin to our efforts to find [Osama] bin Laden," she said.

Toronto, Sept 21: Prime Minister Justin Trudeau's Liberal Party secured victory in parliamentary elections but failed to get the majority he wanted in a vote that focused on the coronavirus pandemic but that many Canadians saw as un-

necessary. Trudeau entered Monday's election leading a stable minority government that wasn't under threat of being toppled — but he was hoping Canadians would reward him with a majority for navigating the pandemic better than many other leaders

Still, Trudeau struggled to justify why he called the election early given the virus, and the opposition was relentless in accusing him of holding the vote two years

before the deadline for his own personal ambition.

In the end, the gamble did not pay off, and the results nearly mirrored those of two years ago. The Liberal Party was leading or elected in 158 seats — one more than they won 2019, and 12 short of the 170 needed for a majority in the House of Commons.

The Conservatives were leading or elected in 119 seats, two less than they won in 2019. The leftist New Democrats were leading or elected in 25, while the Bloc Québécois were leading or elected in 34 and the Greens were down to

"You are sending us back to work with a clear mandate to get Canada through this pandemic,' Trudeau said. "I hear you when you say you just want to get back to the things you love and not worry about this pandemic or an election.

Hours after the results came in, Trudeau greeted commuters and posed for pictures at a subway stop in his district in Montreal on Tuesday morning — a post-election tradition for the Prime Minister. But experts noted that it was


not the victory Trudeau had hoped for. "Trudeau lost his gamble to get a majority so I would say this is a bittersweet victory for him. said Daniel Béland, a political science professor at McGill University in Montreal

"Basically we are back to square one, as the new minority parliament will look like the previous one. Trudeau and the Liberals saved their skin and will stay in power, but many Canadians who didn't want this late summer, pandemic election are probably not amused about the whole situation.' he said.

Trudeau bet Canadians didn't want a Conservative government during a pandemic, playing up his own party's successes. Canada has one of the highest vaccination rates in the world, and Trudeau's government spent hundreds of billions of dollars to prop up the economy amid lockdowns.

Trudeau argued that the Conservatives' approach, which has been skeptical of lockdowns and vaccine mandates, would be dangerous. Trudeau supports making vaccines mandatory for Canadians to travel by air or rail, something the Conservatives oppose.

Kabul, Sept 21: The newly-established Taliban caretaker government in Afghanistan has named the remaining ministers and members, the group's spokesperson Zabihullah Mujahid said Tuesday.

"The newly introduced members of the cabinet are professional personalities including doctors and highly educated persons, also from minorities," Mujahid told reporters at a press conference. The newly introduced cabinet members have been appointed in line with the decree of Taliban supreme leader Mullah Haibatullah Akhundzada, Mujahid said.

The spokesman said that a veteran businessman, Hajji Nurudin Azizi, has been appointed as acting minister for commerce, and Qalandar Ebad as the acting minister for public health. Mujahid also expressed hope that the international community would give recognition to the Islamic Emirate. At the press conference, he re-

jected the presence of the Islamic State, Al Qaeda or any other terrorist groups in Afghanistan, saying the Islamic Emirate is capable enough to smash any extremist organisation and won't allow any Afghanistan soil to be used against any country.

The spokesman also announced that the inauguration ceremony for the new government has been cancelled due to their focus on providing service to the people at this point, TOLO News reported. Regarding the country's economic situation, he said that the domestic revenues might be enough for basic needs.

Plan for tighter e-commerce rules faces internal govt dissent

New Delhi, Sept 21: India's plan to tighten rules on its fast-growing e-commerce market has run into internal government dissent, memos reviewed by Reuters show, with the Ministry of Finance describing some proposals as 'excessive' and 'without economic rationale.'

The memos offer a rare glimpse of high-stakes policy-making governing a market already featuring global retail heavyweights from Amazon to Walmart, plus domestic players like Reliance Industries and Tata Group. The sector is forecast by Grant Thornton to be worth \$188 billion by 2025.

It's not clear how the objections from the finance ministry - a dozen in total - will ultimately be reflected in the proposed rule changes, first floated in June. But watchers of the influential government arm say its complaints won't fall on deaf ears in the upper echelons of Prime Minister Narendra Modi's administration.

'The ministry of finance raising such concerns would likely spur a rethink of the policy," said Suhaan Mukerji, managing partner at India's PLR Chambers, a law firm that specialises in public policy issues.

Telecommunications (DoT) Tuesday issued an order that enables customers to apply for a new mobile connection online and get the SIM delivered at their doorsteps after verifying themselves by using Aadhaar or any other eligible document stored in Digilocker.

The move from the DoT is part of the telecom reforms approved by the Cabinet September 15.

Customers will have to pay Re1 for the process of authentication through Aadhaar-based e-KYC services of UIDAI for getting new mobile connections, according to the new rules.

The government already amended the Indian Telegraph Act, 1885, in July 2019, for the re-introduction of Aadhaar-based e-KYC process for issuing new mobile connections.

"The telecom service providers shall implement a process...For issuing of new mobile connections using Aadhaar-based e-KYC," the DoT said. The government has issued an

order allowing conversion of prepaid to postpaid and vice-versa using a one-time password (OTP)-based process.

"The issuing of mobile connection to the customers is done through an app/portal-based online process wherein a customer can apply for mobile connection sitting at home/office and gets the SIM delivered at his doorstep using documents electronically verified by UIDAI (Aadhaar) or Digilocker," the DoT's order said.

Currently, to obtain a new mobile connection or conversion of mobile connection from prepaid to postpaid or vice-versa, a subscriber has to undergo the KYC process that entails a visit to the retail shop along with the original documents of identity and address proof.

PLCP likely to reach ₹1.34L cr in next fiscal

Sept 21: India's crude oil imports rose to a four-month high in August, recovering from the near one-year low in July, with refiners buying incremental barrels mainly from Latin America and the United States, tanker data from trade sources showed The world's third-biggest oil importer and consumer bought 4.2 million barrels per day (bpd) last month, as some refiners plan to boost runs in anticipation of pent-up demand around the festival season. The two regions, the US and Latin America, accounted for about a fifth of India's August imports as refiners booked long-haul crudes in end-May and June to gain from arbitrage. That led to a decline in the share of Middle East and Africa oil, the data showed. India's imports from Latin America, led by a boost in Mexican supplies, increased to 414,450 bpd oil in August, the highest since December, while shipments from the US rose to a five-month high of 419,100 bpd, the data showed. The sources declined to be identified as they are not authorised to speak to the media. "Long haul WTI-linked oil from Americas was economical to Indians as arbitrage economics were favourable. In the end of May, WTI-linked crudes were trading at a discount of about \$3/barrel to Brent," said Ehsan Ul Haq, an an-

Indian refiners curbed crude processing in August as they had high inventory of diesel and exports were not profitable.

Domestic refiners have resumed exports of diesel as prices in overseas markets improved due to higher demand from the West. This would free up diesel stor-

age and help in raising crude runs and imports in the coming months, said a source at one of the state-run refiners.

The share of Middle Eastern grades in India's August oil imports declined to 61.8% from 64.7% in the previous month, while that of African oil dropped to 14.1% from 16.7%.

That dragged down the share of OPEC's oil in India's overall imports to 67.7% from 77.6%. For April-August, the first five months of this fiscal year, the group's share declined to the lowest.

Last month, Iraq stayed as the top oil supplier to India, followed by Saudi Arabia. The United States climbed four notches to emerge as the third-biggest supplier while Kuwait rose to No.5 from No.6 in July. The United Arab Emirates staved at the fourth position while Nigeria tumbled by three notches to No.6.

Amazon pays \$1.2 bn as legal fees in India to remain operational

New Delhi, Sept 21: Amazon India has spent a staggering over \$1.2 billion in legal expenses in the last two years to maintain its presence and relevance in one the largest markets globally. As per the official data from the

public account filings made by the company in India, all of Amazon's India focused companies together have spent ₹8,546 crore as legal fees in the financial years 2018-19 and 2019-20. This is almost a fifth or 20 per cent of its two-year revenue of ₹42,085 crore.

"Despite India moving high on ease of doing business, it continues to be a highly regulated market and compliance to regulations has its own costs. But Amazon is not the only one having high legal

expenses, it's competitors Flipkart may be having similar level of expenses and so are several large corporations," said an industry expert asking not to be named due to his association with e-commerce companies. A legal expert also pointed out

that most of the expenses shown as legal fees may not actually be going towards compliance and lit-



igations but also towards facilitating operations in the country.

An Amazon India spokesperson did not offer any comments on the

issue. "We do not have any comments to offer on this as of now,' an email from the company said.

A report by Morning Context has said that Amazon has launched a probe after a whistleblower raised a complaint of the company's legal representative having a role in bribing Indian officials. While the company has not commented on this specific allegation, it has said that action is taken promptly for all improper actions.

While the role of the legal representatives has been highlighted in the report, the focus has come back on vast expenses Amazon makes as legal fees.

Amongst the highest legal fees reported are two entities of e-commerce player's Indian companies -- Amazon India Ltd (holding company) and Amazon Seller Services Pvt Ltd. -- the two together spent close to ₹8,000 crore as legal fees in the past two financial years (FY19 and FY20).

The other entities of Amazon in India -- Amazon Retail India, Amazon Transportation Services, Amazon Wholesale and Amazon Internet Services -- also have highlevels of legal charges commensurate with their size.

VIRAT KOHLI: We were 42 odd for one and then lost about five wickets within 20 runs, which is a very difficult situation to come back from. Bit of a collapse there for us, bit of a wake-up call and might as well have this at the start of the second leg so that we know exactly what we need to work on. You can't afford to lose four or five wickets within 20 runs. by Bayern in the team's first defeat since losing Lionel Messi to PSG, and added pressure on coach Ronald Koeman and club president Joan Laporta.

Granada came to Barcelona winless in four matches and coming off two consecutive losses, including at home against Real Betis in the Andalucia derby last week. It defeated Barcelona at Camp Nou the last time they met in April.

The draw left Barcelona in seventh place, five points from leader Real Madrid with a game in hand.

Coached by former Spain manager Robert Moreno, Granada opened the scoring two minutes into the match with a header by Domingos Duarte off a set-piece.

Barcelona squandered two great chances to equalise before halftime – Sergi Roberto hit the crossbar from inside the area and Araujo's header was brilliantly saved by Granada goalkeeper Luis Maximiano.

Memphis Depay and Luuk de Jong also failed to capitalise on scoring chances in the second half, but Araujo finally broke through with a close-range header in the 90th.

Koeman couldn't count on several players because of injuries, including Jordi Alba and Pedri. London, Sept 21: England Monday called off next month's men's and women's tours of Pakistan, three days after New Zealand abandoned their white-ball series in the South Asian country over security concerns

The England and Wales Cricket Board (ECB) arrived at the decision to withdraw after deliberating over the weekend, pulling out of what would have been the country's first tour of Pakistan since 2005.

"The ECB Board convened this weekend to discuss these extra England Women's and Men's games in Pakistan and we can confirm that the Board has reluctantly decided



October trip," the ECB said in a statement.

It added, "The mental and physical well-being of our players and support staff remains our highest priority and this is even more critical given the times we are currently living in.

"We know there are increasing concerns about travelling to the region and believe that going ahead will add further pressure to a playing group who have already coped with a long period of operating in restricted Covid environments." Minutes before their first match

in Rawalpindi Friday, New Zealand pulled out of their limited-overs tour of Pakistan because of a "security alert" from their government -a decision that came as a setback to the host nation, which has not seen much international cricket since the terrorist attack on the Sri Lankan team bus in 2009.

The development was bound to have an impact on England's scheduled tour of the country. "The ECB has a longstanding commitment to tour Pakistan as part of the Men's Future Tours Programme in 2022

"Earlier this year, we agreed to play two additional T20 World Cup warm-up games in Pakistan in October, adding a short women's tour with double headers alongside the men's games," the ECB said.

"There is the added complexity for our Men's T20 squad. We believe that touring under these conditions will not be ideal preparation for the ICC Men's T20 World Cup, where performing well remains a top priority for 2021.

Pakistan Cricket Board's (PCB) new chief Ramiz Raja was left disappointed with the ECB's decision. "Disappointed with England, pulling out of their commitment & failing a member of their Cricket fraternity when it needed it most. Survive we will inshallah. A wake up call for Pak team to become the best team in the world for teams to line up to play them without making excuses," Raja tweeted.
