Bhubaneswar: The Odisha government has put the auction of Karlapat iron ore and bauxite block on hold till further notice following a court order. As the block lies near the Karlapat Wildlife Sanctuary, a designated elephant corridor in Kalahandi district, environmentalists were opposed to the mining operation in the area. The Directorate of Mines, under the Steel and Mines department of the Odisha government, in a notice Tuesday put the auction on hold 'till further notice'. Karlapat was among the 11 mineral blocks, put up for auction by the state government for

which the bidding process began Saturday.

TRIPATHY SET TO BE NEW ODISHA CIC



Bhubaneswar: Retired Tamil Nadu cadre IPS officer and former DGP of Tamil Nadu, Jalad Kumar Tripathy is all set to be the new Chief Information Commissioner (CIC) of Odisha. Sources said that the name of Tripathy was finalised at a virtual meeting Tuesday presided over by Chief Minister Naveen Patnaik. Once the appointment is approved by Odisha Governor Ganeshi Lal, a gazette notification will be issued. The post of the CIC has fallen vacant with Sunil Mishra retiring August 15 this year.

Police are baffled to find nail marks on the neck of the deceased woman, who worked as a daily wager

Jharsuguda, Sept 22: The bodies of a woman and her two children were recovered Wednesday by the police in their house at Fatakpada under Ganganagar area in Brajrajnagar locality of Jharsuguda district. The husband of the woman, Narayan Poddar, has since been missing, police informed. The deceased woman has been identified as Soni Poddar (28). Among the two deceased kids, one girl is five years old while the other is a three year-old, police stated.

Sources also informed that the woman and her husband were natives of Chhattisgarh. Both worked as daily wagers and were staying in a rented house in Fatakpada. They also informed that when the bodies were recovered, the police found nail marks on the neck of the woman while the two kids were oozing blood from their mouth. Neighbours spotted the three dead bodies from a window of the house Wednesday morning and informed the police.

Police reached the spot and sent the bodies for post-mortem. A forensic team was also pressed into service and conducted an examination. Police have also questioned the relatives and neighbours regarding the incident.

Soni's father, who arrived after getting the tragic news, blamed the absconding husband for the death of his daughter. He alleged that the two were not in good terms.

Jharsuguda SP who also rushed to the spot for investigation, said that post-mortem reports will ascertain the exact cause of the death and further details of the incident will be known after a proper probe.

New Delhi, Sept 22: The families of those who die of Covid-19 will get an ex-gratia of ₹50,000, the Centre told the Supreme Court here Wednesday. It said that the National Disaster Management Authority (NDMA) has recommended the amount.

Significantly, compensation will be paid against not only for deaths that have already occurred but for future ones, too, the court was informed.

The Centre also told the apex court that the ex-gratia assistance will also be given to the kin of those who died of the virus due to involvement in Covid-19 relief operations or activities associated with the preparedness for dealing with the pandemic.

The ex-gratia will be paid by the respective state governments, sourced from their respective disaster response funds, and will be channeled through the district dis-



aster management authority or the district administrations, the government said in an affidavit filed before with the Supreme Court. Since the pandemic broke out in January 2020, India till now has registered over 4.45 lakh Covidrelated deaths.

"The ex-gratia assistance...will continue to be provided for deaths that may occur in the future phases of the Covid-19 pandemic as well, or until further notification," the affidavit by the Centre said.

"Compensation will be given to families of even those deceased who were involved in Covid-19 relief operations or associated in activities related to prevent the spread of Covid-19 and preparedness activities. The cause of death needs to be certified as Covid-19 in accordance with Health Ministry guidelines," it added.

The concerned families will submit their claims through a form issued by the state authorities along with specified docu-

Pradhan seeks Jagan's assistance

Bhubaneswar, Sept 22: Union Minister Dharmendra Pradhan has sought the intervention of Chief Minister YS Jagan Mohan Reddy for amicable resolution of border disputes over villages between Odisha and Andhra Pradesh. The minister termed the entire development as 'unfortunate' and said that the skirmishes, which started in 20-odd villages under Kotia gram panchayat in Pottangi block of Koraput district, have now spread to other bordering villages in Gajapati district.

'Such disputes pose a threat both to the security as well as developmental aspirations of villagers staying in border villages of Odisha and Andhra Pradesh,' Pradhan said in his letter.

Pradhan requested both the AP chief minister and his Odisha counterpart to withdraw armed police forces in the disputed villages and also cases registered against local representatives and government officials of both states.

BMC to rectify 75 weak points

2 days after the death of the 15-year-old student, the municipal body wakes up and promises action

Bhubaneswar, Sept 22: The Bhubaneswar Municipal Corporation (BMC) said Wednesday that it has identified 75 vulnerable waterlogging spots in the state capital. This disclosure came two days after an open storm water drain claimed Monday the life of 15-year-old student Jyoti Prakash Behera

Speaking on the issue, BMC Commissioner Sanjay Kumar Singh said that the municipal body is trying to rectify the vulnerable points. He however, blamed construction violations due to which these 75 points have been exposed. He also added that at present it will not be able to repair all the weak points, so BMC will press into service as many pumps required to clear places affected due to waterlogging.

leading to severe waterlogging this monsoon.

Residents of the 'smart' city however, have alleged that such claims are made every year but precious little is done. The Odisha capital has now witnessed seven deaths including those of three minors since 2015 due to open drains.

It should be mentioned here that the government in June this year had issued a mandatory checklist to all ULBs directing them to install signages or cover open drains to avoid mishaps. Locals alleged that the BMC ignored their pleas of constructing a permanent drain at the site where the boy slipped and met his watery grave, Sunday

Singh while admitting that BMC regretted the loss of life, said that measures will be put in place to avoid such accidents in future. "Natural drains cannot be concretised or covered with slabs because of Supreme Court and NGT guidelines. However, such incidents are regretful and will not be repeated. We have decided to expand drainage channels 7 and 10 on a pri-



"The main cause behind increase in waterlogging spots is due to violation of construction guidelines. encroachment on drains and the land around those and destruction of recharge points. The entire drainage system will be redesigned and revamped to make it more robust. This will be implemented as quickly as possible so that in future we will be able to deal with heavy rainfall," Singh informed.

It should however, be stated here that the Odisha government had earlier sanctioned ₹750 crore for widening, covering, and cleaning of drains in the city. However, the civic body could de-silt only 383km of its 625km of drainage system ority basis to prevent waterlogging in New Forest Park and Bairagi Nagar areas," Singh said.

Meanwhile, the Odisha Assembly House Committee, after taking a serious note of the death of the minor boy decided to hold a meeting with top civic officials of Bhubaneswar and Cuttack over the issue, "The committee has taken serious cognizance of the incident. A decision has been taken to hold discussions with commissioners of both the BMC and Cuttack Municipal Corporation, chief engineers of drainage division and other authorities October 5," MLA Mohammed Moquim, a member of the panel said.

Covid-19 hits IPL again, event to continue ■ BCCI had suspended the tourney in May when a number of players had tested positive. This time however, it is not ready to incur huge losses due to another suspension

Dubai, Sept 22: Sunrisers Hyderabad (SRH) pacer T Natarajan has tested positive for Covid-19. but even then the team's IPL game against Delhi Capitals will go ahead Wednesday as scheduled, the BCCI said. Six persons, who had come in close contact with Natarjan, have also put in isolation including India all-rounder Vijay Shankar.

The decision of the BCCI to go ahead with the event is not surprising. The BCCI earns approximately ₹67 crore from television rights of each IPL match. A second suspension may well lead to the cancellation of the tournament as no more windows are available this year. It means a loss of approximately ₹2,000 crore for the BCCI and the franchises. It should be stated here that last season, amid crowd-less stadiums at the UAE, the BCCI had earned revenues of over ₹4,000 crore from TV rights of the tournament.

The income generated from the event is transferred to the BCCI's central pool. Then the entire amount is shared between the eight franchises and the BCCI. The cancel-

lation of IPL-2021 at this stage would mean the franchises losing out on sharing of approximately ₹2,000 crore. Also each franchise has individual sponsors. Not having a game means losing out also on sponsorship money

The 2021 edition of the IPL was suspended May 4, after a number of players like Wriddhiman Saha (SRH), Varun Chakravarthy (KKR) and L Balaji (CSK, bowling coach) had tested positive for Covid-19. However. even then while announcing the decision to suspend the tournament, the BCCI and the IPL governing council had said that they would try and conduct the remaining part of the tournament later in the year. Hence the tournament was again shifted to the UAE.

"Sunrisers Hyderabad player T Natarajan tested positive for Covid-19 at a scheduled RT-PCR test. The player has isolated himself from the rest of the squad. He is currently asymptomatic," a BCCI release stated. "The rest of the contingent including the close contacts underwent RT-PCR tests at 5.00am local time this (Wednesday) morning and the test reports are negative. "As a result, tonight's (Wednesday's) game between Sunrisers Hyderabad and Delhi Capitals will go ahead at the Dubai International Stadium," it further stated.

As per the IPL's standard operating procedure, Natarajan will now have to isolate for 10 days and test negative twice before being allowed back into the bubble.

were last year, reports *variety.com*. This year's roster could be significantly different from ones in recent years, as the Academy has eliminated the 'secret' nominating committees of artistes, creators and industry experts that curated the final lists over the past couple of decades.

A bench of judicial member B

Amit Sthalekar and expert member Saibal Dasgupta granted three weeks time to the state government to file a comprehensive affidavit stating the condition of the areas affected by illegal mining in Ghasipura tehsil of Keonjhar the recovery of compensation.

The tribunal noted that the Keonjhar Collector was simply dragging his feet in the matter of identification of the wrongdoers and recovery of environmental

compensation from them. The green body observed that the joint inspection, conducted by the Central Pollution Control Board, Kolkata, Odisha State Pollution Control Board, district mining officer and the divisional commissioner in December 2019, had es-

timated environmental compensation of ₹7.3 crore to be recovered from the wrongdoers.

"But even after two years of the inspection nothing has happened with regard to the recovery of this amount from the wrongdoers," the tribunal observed.

During the hearing, the state government's counsel submitted that illegal mining was going on for almost 20 years in Keonjhar and identification of the illegal miners is a time-taking process.

An affidavit filed by the assistant conservator of forests (ACF) of Keonihar district mentioned that forest conservation and reclamation were being carried out in Madanpur mouza of Ghasipura tehsil, the bench noted.

However, petitioner's counsel Sankar Prasad Pani submitted that nothing has been placed on record before the tribunal to show whether rehabilitation and reclamation of the land has been done in Keonjhar district.

ministration and Hindalco refused to comment on the matter. Bauxite mining at Mali Hills

to develop aluminium was awarded to Hindalco in 2005. However, the company was forced to stop operations due to opposition by local villagers who started protesting under the aegis of Mali Parvat Surakhya Samiti (MPSS). 'We don't want to destroy our

Mali Hills. We worship Mali Hills and will not allow mining there at any cost," MPSS member Dasi Nandibali said. He claimed that over 36 water

sources will get dry and farmland of more than 40 villages of Semiliguda block will be affected if mining operations start at Mali Hills.

Efforts to extract bauxite from nearby Niyamgiri Hills were stopped following protests by local people a few years ago.

Mining major Vedanta had signed a deal with state-owned Odisha Mining Corporation to mine over 900 million tonnes of recoverable bauxite deposits from Niyamgiri Hills that are also regarded by local tribal people as the abode of their reigning deity.

Experts skeptical about radio collars for jumbos

Bhubaneswar, Sept 22: The Wildlife Society of Odisha (WSO) has raised concerns over the effectiveness and longevity of radio collars proposed to be fitted on elephants in Odisha to monitor their movement, citing failure of similar measures in other states.

In a letter to the state government the WSO mentioned that the effort to closely monitor the jumbos is laudable. However, it said, the available radio collar technology may not deliver expected results as the initiatives like this by Chhattisgarh government have not been fruitful. The experts stated that out of seven collars fitted on the elephants, only one remained active since 2018.

"It is a fact that elephants are extremely intelligent animals and also playful in nature. A radio collar fitted on a tusker attracts the at-



tention of the rest of the herd and some adventurous animals try to tug it with its tusk pulling it off in the process. Though the pre-charged battery is expected to last for at jumbos. least five years, it is a pity that six transmitters were lost within a short span of time. Some fell off within five days too," said WSO

secretary Biswajit Mohanty. Stating that a radio collar costs around ₹5 lakh, Mohanty also said that there are additional costs of at least ₹5 lakh per annum to track the satellite signals and monitor the

"We feel it is of utmost importance to carefully assess the effectiveness and durability of the collars keeping in view the fact that the project failed in Chhattisgarh. Now, the elephants there are being

What is a radio collar?

A radio collar is a lightweight belt fixed on an elephant's neck. The collar is fitted with a GPS device and the data is relaved real time on a computer or mobile app. The real-time monitoring of data helps in early warning whenever the elephant is in the vicinity of a human settlement

visually monitored by ground tracking teams. Odisha Forest and Environment department has also engaged elephant trackers who follow the herds and report their position on a regular basis." he added.

It can be mentioned here that the wildlife wing of Odisha has already initiated the process of radio collaring of elephants of Chandaka sanctuary after which more elephants would be radiocollared in Sundargarh division and other parts of the state.

On Tuesday, the CB, which has been probing the alleged espionage case, claimed that the woman had sent ₹38,000 from an account in Dubai to one of the accused and that she was using a mobile phone with a United Kingdom (UK) number.

Balasore police had September 14 arrested four contractual employees-Basanta Behera, Seikh Musafir, Tapas Ranjan Nayak and Hemant Kumat Mistry— and a regular staffer Sachin Kumar on charges of sharing highly sensitive defence information with unknown foreign agents, suspected to be from Pakistan. Later, the CB took over the investigation from Balasore police and is currently interrogating the accused in their custody in Cuttack.

Dang's income, expenditure, and assets were calculated, and he was found in possession of disproportionate assets worth ₹1.64 crore, constituting 166 per cent of his known sources of income, ac-

cording to the statement. A case was lodged under the Prevention of Corruption (Amendment) Act and Dang was arrested, it said.

During the raid, the state anticorruption wing found Sethy had two double-storeyed buildings in Keonjhar, four plots, three twowheelers, bank deposits of ₹24.63 lakh, insurance deposits over ₹24 lakh, and other movable and immovable properties. VILLAGERS TREK 18KM FOR PDS STUFF, WARN OF STIR

Chitrakonda/Malkangiri, Sept 22: The government has made provision for delivering rations under public distribution system(PDS) near people's doorsteps and emphasised streamlining the system so that people do not face inconvenience.

But scores of beneficiaries in Dhuliput panchayat in Swabhiman Anchal of Malkangiri district have to trek 18 km from their village to get rations, a report said.

Locals were sore over such inconvenience. They alleged that though they had drawn the attention of the block administration to sort out the issue, no step is being taken to ease the PDS disbursal difficulties. They suffer from trekking to Hataguda in Janbai panchayat, 18 km from Dhuliput panchayat.

Flood brings croc fear to Rajnagar

Rajnagar, Sept 22: As if being marooned in floodwater for seven days was not enough for the people of 13 villages under Rajnagar block in Kendrapara district, now crocodiles are being sighted in villages. The villagers are presently living in fear and apprehension.

The villagers of Belapala, Dandi, Chakibanka, Govindpur, Santhapada, Tanganatoila, Ostia. Nagad, Katakana, Naladia, Bandhapatana, Rajpur and Balichandrapur are these days facing a double whammy. They are struggling with the woes of waterlogging and living with the fear of crocodile attack.

With the flow of water in the rahmani basin increasing. the water level in the flood-affected areas in Rainagar block

was also rising. At the same time, adding to the woes of the flood hit villagers, crocodiles from the Brahmani river started entering the villages.

The villagers said they had seen a crocodile in floodwater at Belapala Kalipadia Tuesday. "To bring drinking water or get vegetables, we have been wading through the water for last three days. But we are now in fear and apprehension. There is every possibility of crocodile attack," they added. Fear of crocodile attack has gripped the villagers so much that yesterday some villagers who came to Madanpur square to buy vegetables were seen returning homes in the trailer attached to a tractor.

Around 40,000 people in Bandhapada, Ostia, Belapal and Rajpur panchayat have been

marooned. The floodwater in Rajnagar block started increasing from September 15 night. Even though the paddy fields were completely submerged, there was no water on village roads from September 17 to September 19 morning. But the floodwater suddenly came gushing into the village after September 19 morning and the water level kept rising.

These four panchayats are now cut off from the district headquarters. Knee-deep floodwater is still stagnant in Ostia-Bandhapatna High School.

wo days before the Normandy landings in June 1944, Charles de Gaulle demanded the right to govern France after it was liberated by the Allies. Franklin D. Roosevelt, who detested de Gaulle, had no intention of agreeing to this. Winston Churchill, who rather admired de Gaulle's illusions of grandeur, sided with Roosevelt. He told the Free French leader that if he had to choose between de Gaulle and Roosevelt, he would always choose Roosevelt.

Churchill's attitude was entirely understandable. Europe was occupied by Nazi Germany. The Free French were largely a symbolic force. And Britain was one of the three major Allied powers. Later, however, Britain's choice to cling to the United States come what may (with one or two exceptions, including the Suez crisis in 1956 and the Balkan war in the 1990s) came with a heavy price

Flush with wartime victory, Britain turned down every opportunity to shape European institutions in the 1950s, and when Prime Minister Harold Macmillan concluded in the early 1960s that Britain could remain a serious country only within the European Economic Community, de Gaulle stood in his way. British membership of the EEC was vetoed by the general in 1963, and again in 1967.

De Gaulle hadn't forgotten Churchill's words in 1944. He saw Britain as a Trojan Horse for American domination of Europe. France, in his view, was Europe's natural leader. And, because Germany had no desire to assert leadership, and other Europeans had had quite enough of German power, this arrangement was widely accepted.

Britain finally joined the EEC in 1973, but even so, British prime ministers, except for Edward Heath in the 1970s, hung on to their socalled (especially by the British) 'special relationship' with the US. This was largely a matter of shared nuclear secrets, intelligence, and military cooperation. Britain hoped that the special relationship would allow it to remain a formidable global player, even long after its empire was lost.

Now, once again, Britain has opted to side with a historical rift among the US, this time in a new defence pact with Australia to counter China. AUKUS is its unlovely name. A long-standing agreement

with France to supply diesel-powered submarines to Australia was broken in favour of Anglo-American nuclear-powered boats. France is understandably furious. The three AUKUS countries didn't even bother to notify the French of their impending deal. France recalled its ambassadors from Canberra and Washington, but not from London; Britain was not deemed to be important enough.

There may be good reasons why Australia decided American submarines would be more suitable as a defence against China. It might also be argued that it makes sense to strengthen US alliances in the Indo-Pacific region, not just with Australia, but also Japan and India. Quite what British interests in the region are, apart from puffing up a self-image of 'global Britain' after Brexit, is less clear. France, with 1.5 million people, 8,000 troops, and island territories in the Indian and Pacific Oceans, has more at stake there than Britain does

But there is more to AUKUS than submarine deals, lucrative though they are. US President Joe Biden has decided to confront China's expanding power in East Asia with a show of military force. He has often expressed his wish that American allies would join him in this effort, even as Japanese and Europeans worry about damaging trade interests in China and being sucked into a potential war. But by undercutting France, the US. with the connivance of Britain, has widened a historical rift among European allies. It is as though de Gaulle's suspicion of les Anglo-Saxons

in 1944 has been proven right. There is of course another way of looking at this. Wartime nostalgia plays an important part in Britain's instinctive fondness for the special relationship. Like former Prime Minister Tony Blair in the run-up to the invasion of Iraq in 2003, some British politicians might believe that the United Kingdom is the only European country with serious armed forces and the political will to use them. Prime Minister Boris Johnson, like Blair before him, seems to fancy himself a modern-day Churchill.

Unfortunately (or not), Britain's military power is insignificant compared to what Churchill could command in 1944. Wartime nostalgia has drawn Britain into several foolish American wars, which other European countries were wise to avoid. The question is whether provoking China's wrath by supporting Biden's sabre-rattling is justified nonetheless, even if it doesn't involve direct British interests. Is the alternative of backing off and doing business as usual with China a form of cowardly appeasement? Or might there be other options?

Fear of repeating Neville Chamberlain's appeasement in 1938 is one reason why the US and Britain have gotten themselves entangled in unnecessary wars in the decades after World War II. This is why French leaders have called for greater 'strategic autonomy' for the European Union. Europe should beef up its own military force and wean itself from dependence on the US. The EU High Representative for Foreign Affairs and Security Policy Josep Borrell announced that Europe, too, would help to limit China's power. The bloc would seek a trade deal with Taiwan while still engaging with China. Even the pro-European, left-leaning newspaper Le Monde called this 'deficient in backbone.

As long as the EU has no common foreign policy and sufficient armed forces of its own, talk of strategic autonomy is just that. Only the full cooperation of Britain, and far greater military participation by Germany, might one day give Europe some chance of autonomy. But the combination of Germany's historical baggage and Britain's fixation on its special relationship stands

As a result, the fate of the Indo-Pacific region, and perhaps many places beyond, will remain in the hands of the increasingly aggressive authoritarians in Beijing and whoever happens to be sitting in the White House. Either way, neither Britain nor Australia, much less France and the EU, will have much to say in the matter.

GLOBAL NORTH'S TEST

ACCORDING TO A MAJOR STUDY BY THE **RESEARCH FIRM AIRFINITY, THE NUMBER OF UNUSED DOSES WILL REACH ONE BILLION BY** THIS DECEMBER

ith low-income coun tries in Africa and elsewhere still imploring rich countries to stop stockpiling millions of unused COVID-19 vaccines, there are still real doubts as to whether the United States and Europe will honour the promise made at this year's G7 summit to vaccinate the world by the end of 2022.

US President Joe Biden's administration has said that the Global North can deliver enough doses for everyone by next September's United Nations General Assembly. But the gulf between the vaccine-rich and vaccine-poor has grown so vast that under 2 per cent of adults in lowincome countries are fully vaccinated, compared to over 50 per cent of adults in most high-income countries. Worse, millions of doses in high-income countries are now being wasted because they are not being used in time.

For many months earlier this year, Western governments could at least say that there was not enough vaccine supply to meet global demand. But, we are now producing 1.5 billion vaccines every month. As I write this, around 300 million doses of vaccines are lying unused, hoarded in warehouses or on their way to fulfill delivery contracts that have been monopolised by Western countries. As a result. the World Health Organisation's September 2021 goal of vaccinating at least 10 per cent of the population in every low-income country – the basic level needed to cover health workers and the elderly-remains unrealised.

According to a major study by the research firm Airfinity, the number of unused doses will reach one billion by this December. To put that staggering figure into perspective, it is enough to meet our year-end goal

of vaccinating 40 per cent of the African population.

Making matters worse, Airfinity shows that if we do not act, 100 million unused vaccine doses will have passed their expiration dates by the end of this year. And if we cannot airlift surpluses to where they are needed on a schedule that preserves a two-month shelf life. this figure could rise to 241 million. Either way, that is near-criminal wastage.

Exaggeration comes easily to politicians. But it is no overstatement to say that unless more vaccines, diagnostics, and treatments are made available to the Global South, there could be at least one million more COVID-induced deaths over the next year.

We know that more than 100,000 $\,$ lives have been saved in Britain, owing to the administration of fewer than 100 million vaccine doses. Allowing 200 million or more doses to be wasted is thus tantamount to condemning hundreds of thousands of unvaccinated people in low-income countries to unnecessary suffering or death.

The upshot is that at Biden's vaccine summit this week, more lives hang in the balance than at any other peacetime gathering that I can recall. If the West does not deliver the necessary supply of vaccines to the rest of the world, low-income countries will have little reason ever to trust it again. Failing to transfer millions of surplus doses to those in desperate need would be a grotesque failure of the most basic test of human solidarity and decency.

And so for world leaders convening at the UN this month, the stakes could not be higher. We are at a make-or-break moment to mitigate the monstrous, unforgivable vaccine inequality that has prevailed so far

The data compiled by Airfinity suggests that 200 million doses can be transferred immediately to the COVID-19 Vaccine Global Access (COVAX) facility and the African Vaccine Acquisition Trust for distribution across Africa and other low-income countries. That would be enough to meet the WHO's 10 per cent target for every country. Moreover, Western countries can send the same amount of addi tional doses – around 200 million -to COVAX each month thereafter. That would be enough to address Africa's deficit of nearly 500 million doses, ensuring that some 40 per cent of the continent's population is vaccinated by the end of the year, in line with the WHO's goal.

We have seen how vaccine nationalism leads to inequality, wastage, and far too many avoidable deaths. Not only is this approach self-serving; it is self-defeating. The longer the disease is allowed to spread in low-income countries, the greater the likelihood that it will develop new variants that will come back to haunt even the fully vaccinated.

This basic truth lies at the heart of pleas that have been building this week from African leaders, former heads of state and government. the Pandemic Action Network, and groups like The Elders. NGOs and faith leaders in the Global South have issued statements calling for immediate action to prevent an epic moral catastrophe.

In a global health crisis born of a highly infectious and communicable disease, there is no alternative to collective global action. This week's vaccine summit represents the rich world's best chance to show that it means what it says.

elhi University enjoys the stature of an 'institute of eminence' in the Indian educational set-up. In less than a year from now the university established in 1922 with just four colleges, will celebrate its 100th foundation day. Its motto is "Nishtha Dhriti Satvam", which translates to mean dedication, steadfastness and truth. With some 6.5 lakh students (conventional and distance mode) enrolled across more than 500 programmes and over 90 colleges affiliated to it, DU stands out as a premier institute of higher learning.

It is this prestigious university that has now decided to drop some inconvenient truths from its syllabus. Among those erased from the syllabus of BA (Honours) is the late Mahashweta Devi. who is a winner of the Jnanpith award, the Padma Vibhushan, the Indira Gandhi award for National Integration, the Sahitya Akademi award for Bengali writers and the Ramon Magsaysay Award for Journalism, Literature, and Creative

Communication Arts. The axe has fallen on Mahashweta Devi's short story 'Draupadi', which is a raw, chilling and explicit story of a tribal woman brutalised by Indian security forces. The English translation of the original in Bengali by post-colonial theorist Gayatri Chakravorty Spivak has now been dropped from the BA (Honours) course, stirring a controversy after 15 academic council members have protested but a

rival group has endorsed the change. The changes were ordered by DU's oversight committee, which also dropped from the syllabus the works of two Dalit writers, Bama Faustina Soosairaj and Sukirtharani. The changes and their enthusiastic endorsement by the DU administration have led to new fears of political control on academia and what this might mean for an education sys tem that is already under strain.

This is not the first time that political considerations will determine what universities should teach, or which books may be banned. Chandrabati who lived in what is now Bangladesh is believed to be the first Bengali woman poet. Chandrabati wrote a womancentric version of the Ramayana which has been translated into English by noted academic Nabaneeta Dev Sen. Very little is known about the author except that her version of the Ramayana is believed to be sung even today by peasant women in Bangladesh. Chandrabati's work is a unique example of looking at the Ramayana from Sita's point of view and it also comes well before works that questioned the undisputed place of Lord Rama in

India. Nineteenth century Bengali poet Michael Madhusudhan Dutt who followed some 300 years after Chandrabati, challenged the position of Lord Rama over Ravana. The Lankan monarch is the hero of Dutt's works and not portraved as a demon king. His 'Meghnad Badh Kavya' about the killing of Ravana's son Meghnad, while he is unarmed and worshipping at a Lankan temple, is portrayed as an act of cowardice by Lakshmana.

Lionising Ravana is not new in India. While his effigies are burnt across the country on Dussehra, his devotees worship at the five temples dedicated to Ravana in India. The village Ravangram in Vidisha has one of the most famous temples of Rayana whose wife Mandodari is believed to be from the place. There is also a temple at Mandsaur where they are believed to have been married.

In her original introduction to the collection of stories of which 'Draupadi' is one, Mahashweta Devi wrote: "Life is not mathematics and the human being is not made for the sake of politics. I want a change in the present social system and do not believe in mere party politics." It is the misfortune of DU to show that the system isn't changing and politics will rule, more forcefully and blindly than ever before.

Sir, After two unsuccessful attempts to find a buyer for Air India, the Centre seemed to have found one. In 2001 and 2018, reputed private airliners backed off from final stages after showing initial interest in Air India. Two prominent companies have been making the final moves on owning the state-run aviation giant that has been incurring huge losses for the last 14 years - approximately to the tune of ₹80,000 crore. The two have submitted their financial bids. In another three weeks, the name of the buyer will go public although the actual transfer of assets will take another four to five months. A 100 per cent stake in Air India, 100 per cent stake in Air India Express and 50 per cent stake in Air India Airport Services Private Limited are being sold by the government in contrast to its earlier stand of retaining 24 per cent stake in Air India. A smooth disinvestment take-off was hindered by the huge 'monkey on its back' -- massive debts. No buyer would risk pumping money into a loss-making venture, and then spend his/her entire time in struggling to pay off the debts. Left with a Hobson's choice, the government had to yield to the requests of the private players for a cent per cent stake in Air India and 50 per cent stake in AISATS.

Khaira, Sept 22: Even as 80 days have passed, job card holders under the poverty alleviation scheme MGNREGS under this block in Balasore district are yet to receive their incentives, a report said.

This has sparked resentment among the beneficiaries who are reeling from financial stress due to non-payment of incentives so far. They have warned of launching an agitation if immediate steps are not taken to pay their incentives.

The district administration had unched various projects under the Mahatma Gandhi Rural **Employment Guarantee Scheme** (MGNREGS) to provide livelihood opportunities to the migrants returning home during the Covid-19 pandemic.

Many people, including the migrants, enrolled their names for a job card and worked under various projects implemented by the state gov-

ernment from April 1 to June 30. The state government had then announced to provide ₹50 per day to all the beneficiaries during the period by July 30. The government had also earmarked an additional

8,500 beneficiaries or job card holders benefited by the scheme

However, though 80 days have passed since then, the block administration is yet to make the incentive payments to several beneficiaries. Many of the beneficiaries from Kurunta and Saradanga panchayats have alleged that they are yet to receive payments towards

their incentives. Namita Barik from Kurunta panchayat has alleged that delay in payment of incentives has derailed the purpose of the govern-

ment behind the implementation of the scheme. Anadi Parida of Saradanga panchayat alleged that it is quite un-

fortunate that money towards incentives is yet to be transferred to the bank accounts of beneficiaries even after over two months.

When contacted, Prashuram Parida, block development officer of Khaira block, said delay has been inordinate as several posts of MGNREGS staff are lying vacant in the block. The remaining beneficiaries will receive their incentives soon and over ₹43 lakh has been transferred to the accounts of many beneficiaries so far.

Malkangiri: ₹7cr to boost healthcare

6 govt employees sacked for terror links

25 government servants have been dismissed from service over the last 6 months for their alleged links with terrorists in the UT

Srinagar, Sept 22: Six government employees, including two policemen, were Wednesday dismissed from service for their alleged links with terrorists in Jammu and Kashmir, taking the total number of employees sacked in last nearly six months to 25, officials said.

Among those dismissed from service earlier, there were two sons of Pakistan-based Hizbul Mujahideen chief Syed Salahuddin and tainted Deputy Superintendent of Police Davinder Singh who was caught along with a wanted terrorist and two others early this year.

The six employees who were dismissed by the government, include constable Showkat Ahmad Khan, a resident of Budgam who was involved in the looting of service weapons from the house of a member of legislative council in Srinagar with whom he was posted as a Personal Security Officer in 2018 The policeman was arrested and subsequently detained under the Public Safety Act (PSA) August 8 last year, the officials said.

They said constable Jaffer Hussain Butt of Kishtwar was arrested in a case that is presently under investigation of the National Investigation Agency (NIA).

The probe has revealed that Butt provided his car to Hizbul



Mujahideen terrorists and facilitated their safe movement in his hometown, the officials said, adding that he is currently on bail since August 30.

Teacher Abdul Hamid Wani of Bijbehara in Anantnag district was also among those dismissed from service. It is alleged that before joining government service, he was a district commander of terror group Allah Tigers and propagated secessionist ideology, the officials said.

They said he had reportedly secured the employment without any selection process by leveraging Jamaat-e-Islami (JeI) influence. He was a key speaker and organ-

iser in the 2016 agitation follow-

ing the killing of terrorist com-

mander Burhan Wani. A junior assistant in the Roads and Buildings Department, Mohd Rafi Butt of Kishtwar, is accused of having provided logistical support to Hizbul Mujahideen terrorists in Kishtwar, besides providing a safe environment to them to execute terror plans. He figures in an FIR registered by the NIA and is presently on bail after being arrested, the officials said. They said teacher Liyaqat Ali Kakroo of Baramulla was appointed in government service in 1983 and was arrested in 2001 with an explosive substance. The probe against him revealed that he was a locally-trained terrorist.

A cache of arms was recovered from his possession in 2002 and subsequently, he was detained under the PSA for two years. However, he was acquitted by court in both the cases, the officials said, adding that two grenades were recovered from his possession again in 2021.

Range officer Tariq Mehmood Kohli of Poonch was allegedly involved in smuggling of illegal arms, ammunition and explosives, including hard drugs and fake Indian Currency Notes from Pakistan, they said.

They said Kohli, who was ar rested in a case registered against him in 2010, had remained in touch with active militants and was mentioned as an overground

worker in police records. In an identical order about the dismissal of the six employees, the General Administration Department (GAD) said the Lt Governor was satisfied after considering the facts and circumstances of the cases and on the basis of the information available that the activities of these employees were such as to warrant their dismissal from service.

...The Lieutenant Governor is satisfied under sub-clause (c) of the proviso to clause (2) of Article 311 of the Constitution of India that in the interest of the security of the State, it is not expedient to hold an enquiry in the case of... Accordingly, the Lieutenant Governor hereby dismisses. From service, with immediate effect," the order said mentioning the name of each sacked em-

July 11, as many as 11 employees, including two sons of the Hizbul Mujahideen chief, were dismissed from service.

Earlier in April-May, the administration dismissed seven employees, including DSP Davinder Singh.

Idrees Jan, a teacher from North Kashmir's Kupwara district was the first government employee to be sacked from service for antinational activities May 1.

His dismissal came barely a week after the Union Territory administration constituted a Special Task Force (STF) empowered to look into allegations against government employees of involvement in anti-state activities and recommend dismissal of those

Assam burns rhino horn hoard to highlight they have no medicinal value

Bokakhat (Assam), Sept 22: Assam Wednesday consigned to flames 2,479 rhino horns, world's largest stockpile destroyed in a single day, to bust a myth that the horns have miraculous medicinal properties.

The move by Chief Minister Himanta Biswa Sarma is part of an effort to curb poaching of the endangered one-horned Indian rhinoceros.

'We want to give a strong message to the world that the rhino alive with the horn on its head is precious to us, and not a dead animal with its pride removed

by poachers or those kept in the government treasuries," the Chief

The ritualistic burning of the rhino horns was done publicly at Bokakhat on the occasion of World Rhino Day in the presence of the Chief minister, some of his cabinet colleagues including Forest and Environment Minister Parimal Suklabaidva and local AGP MLA and Agriculture Minister Atul Bora, senior forest department officials and conservationists in a first of its kind exercise in the country. Indian laws as well as international conventions forbid sale of body parts, whether of humans and animals, both by individuals and governments and Assam committed to follow it. Sarma said.

"A section of people have questioned us why we are burning the horns when it can be sold and the government could earn revenue...

Lask them is it right to sell kidneys when people are ready to pay huge amounts for them," he asked.

The chief minister argued that since the horns have no proven medicinal values, allowing them to be sold tantamounts to cheating people and encouraging poaching.

'Just like all communities. whether they are Hindus, Muslims or Christians, send away their beloved ones with rituals and prayers, we also decided to send our beloved to the other realm in the same manner," he said.

Strike protesting 'anti-trade' policies hits life in Jammu

Jammu, Sept 22: Normal life was hit across the Jammu region Wednesday amid a day-long strike call given by the Jammu Chamber of Commerce and Industries (JCCI) to protest against the alleged 'directionless anti-trade policies' of the



The strike, which evoked wideoread support from almost all opposition political parties and social groups, remained peaceful with no untoward incident reported from anywhere, officials said

The work in courts was affected by the strike, which was also supported by the Jammu chapter of the J&K High Court Bar Association.

The main markets in the city wore a deserted look as shops and business establishments including retail chemist shops were closed, while the movement of public and private transport was thin.

Protests and rallies at various places by traders, activists of National Panthers Party (NPP), Peoples Democratic Party (PDP). Aam Aadmi Party and Dogra Front in the city marked the strike, which was the first of its kind in the Jammu province after the abrogation of Article 370 in 2019.

ASSAM ORDERS PROBE INTO BODOLAND ENCOUNTER

Assam has witnessed a series of 'encounters' since the present BJP government, led by Chief Minister Himanta Biswa Sarma assumed office May 10, with many alleged militants and criminals being shot dead or injured while allegedly trying to flee from custody

Guwahati, Sept 22: Assam government has ordered an inquiry into the killing of two alleged United Liberation of Bodoland (ULB) militants by policemen, a day after a 12-hour bandh to protest the death brought life in the four districts of the Bodoland Territorial Region (BTR) to a standstill.

An order issued by the Assam government said the Divisional Commissioner of Lower Assam Jayant Narlikar has been directed to inquire into the circumstances leading to the death of two suspected ULB militants in an encounter with the police at Ultapani in Kokrajhar district September 18.

Narlikar was tasked to submit the report within 15 days.

The killing of the two suspected



militants evoked wide-spread protests in the BTR with a 12-hour bandh called by All Bodo Peoples (ABP) shutting down normal life in the region Monday.

Several political and non-political organizations and leaders have strongly condemned the killings, claiming the encounter was 'staged' and the youths killed were innocent.

Bodoland Peoples' Front (BPF) Chief Hagrama Mohilary Tuesday appealed to Chief Minister Himanta Biswa Sarma to initiate a high level probe by the CBI into the encounter in the "interest of peace and tranquility" in the BTR.

He also appealed to the ULB leadership to refrain from violent activities to prevent loss of life and property.

"I appeal to the UBL leadership to restrain from retaliatory activities or planting of bombs, which might further escalate the situation in Bodoland region," the former Bodoland Territorial Council (BTC) Chief said.

The police had claimed Saturday that two suspected militants of a newly formed outfit, United Liberation of Bodoland (ULB) had been killed and their camp busted while two pistols and grenades were recovered from the encounter site.

Assam has witnessed a series of "encounters" since the present BJP government, led by Chief Minister Himanta Biswa Sarma assumed office May 10, with many alleged militants and criminals being shot dead or injured while allegedly trying to flee from custody. The opposition has alleged the state police has become "triggerhappy". The Chief Minister however, has supported police action and said Assam police had 'full operational liberty' to fight criminals

"within the ambit of law". In all, 26 accused have been killed so far and 42 others injured when police fired on them claiming that they had tried to escape from custody in the last four-and-half-months.

Cop enters temple, killed in case of mistaken identity

Srinagar, Sept 22: A policeman died in Kupwara district Wednesday after being shot at by his colleague in a case of mistaken identity,

officials said. Ajay Dhar, a follower in the police department who was posted at Handwara, was shot at by a sentry guarding a temple around 2 am after he failed to stop when asked, they said

According to preliminary investigation, Dhar was going from the Handwara Police Station to sleep at the temple which is lo-

cated in main Handwara town. "The victim was using headphones on his mobile phone. When he reached near the temple, the guard there observed suspicious movement and signalled him to stop. Dhar apparently could not hear the sentry, prompting him to open fire," the officials said.

They said Dhar was rushed to a hospital here but succumbed to his injuries during treatment.



This is the second incident of fratricide in Kupwara district in three days. An Army soldier died in a firing incident on Monday following an argument with his colleague during a break from patrolling.

Naga Framework Agreement (NFA), signed between the government of India and the Isak-Muivah faction of the National Socialist Council of Nagalim (NSCN-IM) in 2015, Assam Congress President Bhupen Kumar Borah has asked the Centre to clear at what capacity Assam CM has been involved in the peace talks in Nagaland. "As a Chief Minister of Assam can he (Sarma) hold talks with NSCN (IM) without discussion in the state Assembly and without taking Cabinet into confidence? The NSCN (IM) has been demanding for 'Greater Nagalim' (integration of Naga dominated areas of neighbouring states) and for all we know it is supposed to include parts of Assam. Congress Party is committed to keeping its state intact and under no circumstances will allow any part of its land into Greater Nagalim," the Assam Congress chief told the media.

He asked: "Can the people of Assam trust Sarma to defend the state's interests when he had miserably failed to do so in the recent Mizoram-Assam border issue? He (Sarma) had publicly said that he is ready to give the whole of Barak



Valley (southern Assam) and even Guwahati to Mizoram? Can Sarma be trusted to defend Assam's interests in his talks with NSCN (IM) when his blind allegiance to the Delhi BJP high command's diktat is well known to all?"

Borah said that it has been reported that Nagaland and Manipur Chief Ministers have also been asked to be part of the talks along with Assam CM but it was learnt that Manipur CM has decided not to participate due to differences

on 'Greater Nagalim issue'. In 2015, Prime Minister Narendra Modi had announced the Nagaland Framework Agreement of Government of India with NSCN (I-M) by declaring that this marks the end of a problem. However, the Framework Agreement was not publicly divulged and "though the Congress had demanded at that







SC REFUSES TO DEFER 1ST NDA EXAM FOR WOMEN

New Delhi, Sept 22: The Supreme Court Wednesday rejected the Centre's plea to defer the first National Defence Academy (NDA) exam for women candidates, and directed they should be allowed to sit for the upcoming exam November 14.

A bench headed by Justice Sanjay Kishan Kaul said: "This won't send the right signal to women after having given them the aspiration. Let's begin from this year." As Additional Solicitor General Aishwarya Bhati, representing the Centre, submitted "your lordships may allow us to skip this examination (November 14) which is going to take place, for which your lordships had passed the interim order", the bench said: "Let us see the result -- how many will take it

and how many women will clear the exam", as it emphasised that it finds it difficult to postpone everything by a year. "Having given some hope to the women to take the examination in November, we don't want to belie that hope now..," it said.

The bench said the planning can go on and appreciated Centre's endeavour to develop a curriculum and infrastructure for the women cadets, as it reiterated that the Armed Forces should allow women to appear for the NDA exam in November this year, and not wait till May 2022.

Bhati contended that in the very next exam, the first exam of 2022, the girls can participate. "Your Lordships will appreciate that there is a fixed number of every course of NDA - the standards will have to be fixed to start with the medical standards etc," she said

Top court rejects Shree

New Delhi, Sept 22: The Supreme Court Wednesday rejected a plea filed by Shree Padmanabha Swamy Temple Trust (SPSTT), run by the Travancore royal family, seeking it be exempt from the special audit of 25 years as ordered by the top court last year.

The special audit should be completed as early as possible, preferably within three months, the apex court said. A bench headed by Justice U U Lalit said it had initially directed special audit of the temple and its properties be conducted by Vinod Rai, former CAG, in response to the report of the senior advocate Gopal Subramanium, who was appointed amicus curiae in the case April 24, 2014.

The amicus had suggested an audit in his report from the financial year 1989-90 to 2013-14. Later, the order of May 5, 2015 recorded the submissions of senior advocate Arvind P Datar, appearing for SPSTT that it would not have any difficulty in cooperating with Rai in undertaking scrutiny of the audit reports and in conducting a fresh audit.

"It is quite clear that the audit contemplated by said direction was not intended to be confined to the Temple but was also with respect to SPSTT. This direction has to be seen in the light of the report dated April 15, 2014 of the amicus curiae and the submissions of Datar. Thus, the first prayer made in Miscellaneous Application No.1465 of 2021 deserves to be reiected," said the bench.

The apex court however refrained from passing any order on the plea of the Trust to exempt it from the administrative supervision of Administrative Committee constituted by it saying that it requires factual analysis.

Air pollution biggest environmental threat: WHO

New Delhi, Sept 22: Air pollution is one of the biggest environmental threats to human health alongside climate change, the World Health Organisation said Wednesday as it released its new air quality guidelines for the first time since its last global update in 2005.

"New World Health Organisation Global Air Quality Guidelines provide clear evidence of the damage air pollution inflicts on human health, at even lower concentrations than previously understood," it said in a statement.

The guidelines recommend new air quality levels to protect the health of populations, by reducing levels of key air pollutants, some of which also contribute to

climate change. AQG is an annual mean con-



centration guideline for particulate matter and other pollutants. "Since WHO's last 2005 global update, there has been a marked increase of evidence that shows how air pollution affects different aspects

of health. For that reason, and after a systematic review of the accumulated evidence, WHO has adjusted almost all the AQGs levels downwards, warning that exceeding the new air quality guide-

WHO's new guidelines recommend air quality levels for six pollutants -- particulate matter (PM) 2.5 and PM 10, ozone (O3), nitrogen dioxide (NO2), sulfur dioxide (SO2) and carbon monoxide (CO)

The 2021 guidelines stipulate that PM 10 should not exceed 15 μg/m3 (micrograms per cubic metre of air) annual mean, or 45 μg/m3 24-hour mean. According to the



INDIAN TRAVELLERS MUST FOLLOW NON-VACCINATED RULES, SAYS UK officials in Kabul

Under new international travel norms that come in force for England from October 4, India is not yet on a list of 17 countries on an approved vaccinations list and therefore not exempt from quarantine rules

London, Sept 22: The UK government Wednesday issued an updated international travel advisory to include AstraZeneca Covishield among the eligible COVID-19 vaccine formulations but kept India out of the 17 countries on an approved vaccinations list, requiring Indians to follow rules set out for non-vaccinated travellers.

Under new international travel norms that come in force for England from October 4. India is not yet on a list of 17 countries on an approved vaccinations list and therefore not exempt from quarantine rules.

There was widespread condemnation of the Serum Institute India manufactured Oxford/AstraZeneca vaccine, Covishield, not being covered under the reviewed international travel norms and fully vaccinated travellers from India being subjected to the compulsory 10-day quarantine in line with non-vaccinated

'We are engaging with the government of India to explore how we could expand UK recognition of vaccine certification to people vaccinated by a relevant public health body in India," a British High Commission spokesperson said on Wednesday.

"The UK is committed to opening up international travel again as soon as is practicable and this announcement is a further step to enable people to travel more freely again, in a safe and sustainable way, while protecting public health," the spokesperson said.

It came amid much confusion over the process for Indian travellers as the advisory states: "Formulations of the 4 listed vaccines, such as AstraZeneca Covishield, AstraZeneca Vaxzevria and Moderna Takeda, qualify as approved vaccines.'

However, UK government officials have indicated that Indian travellers to the UK must follow the "non-vaccinated rules", which means Indian passengers must take a COVID test three days before departure and book in advance for two COVID tests to be taken upon arrival in England.

On arrival in England, the passengers must self-isolate in the place they have confirmed on their passenger locator form for 10 days. A privately paid-for "Test to Release" option does exist at day five, which allows an early end to the 10-day

These rules are effectively unchanged from India's current amber list status, even though from October 4 England's traffic light system of red, amber and green countries based on levels of COVID-19 risk is to be officially scrapped. However, despite Covishield being one of the main vaccines being administered in India and falling within the UK's eligible formula tions, it would not offer any ad-

China, Russia, Pak envoys meet Taliban

Beijing, Sept 22: Special envoys of China, Russia and Pakistan have met the top officials of the Taliban's interim government as well as Afghan leaders Hamid Karzai and Abdullah Abdullah in Kabul and discussed the formation of an inclusive government, combating terrorism and humanitarian situation, a top Chinese of-

ficial said Wednesday. The three special envoys visited Kabul from September 21 to 22 and held talks with acting Prime Minister Mohammad Hasan Akhund, Foreign Minister Amir Khan Mutaqi, Finance Minister and other high-level officials of the interim government, Chinese Foreign Ministry spokesman Zhao Lijian told a media briefing here.

Significantly, they also met with former President Karzai and Abdullah Abdullah, President of the Council for National Reconciliation under the previous government. "We exchanged views on the current developments in the country, & welcomed the role of AFG's neighbours in achieving peace, stability & inclusive government," Abdullah Abdullah tweeted.

"They emphasised on formation of an inclusive government acceptable to all, peace, stability, moderate policy, respecting women rights, equal right of education for all Afghans & regional cooperation," he said.

This is perhaps the first time that the foreign diplomats met Karzai and Abdullah who stayed put in Kabul after the Taliban seized power in Afghanistan last month ahead of the withdrawal of the US and NATO troops.

'The Taliban underscored special attention to advancing relations with Russia. China and Pakistan and stressed the major role of the three countries in strengthening peace and security in Afghanistan," Russia's TASS news agency reported, citing Russian government news release on the three envoys' visit to Kabul.

All three countries kept their embassies open in Kabul while the US, India and the EU countries have closed their missions after Taliban's takeover of Kabul.

Besides coordinating closely with Russia on Afghanistan, Pakistan and China, who are playing a lead role after the Taliban seized Kabul, are trying to establish a new grouping of countries sharing borders with Afghanistan. The new grouping includes China,

Pakistan, Iran, Tajikistan, Turkmenistan and Uzbekistan, all of them Afghanistan's neighbours. The Foreign Ministers of the group held a virtual meeting September 7. Highlighting its significance,

Pakistan Prime Minister Imran Khan said Tuesday that the new group will jointly decide about extending recognition to the Taliban's

Nepal to recall its envoy to India

Kathmandu, Sept 22: Prime Minister Sher Bahadur Deuba led Nepal government has decided to recall ambassadors from 12 nations appointed by former premier K P Sharma Oli, including envoy to India Nilamber Acharya, according to a media report.

With this decision, out of 33, Nepal's 23 diplomatic missions abroad will remain vacant from the next three weeks to one month. As many as 11 missions have been headless for a long time, The Kathmandu Post reported.

"A Cabinet meeting today decided to recall the ambassadors appointed under political quotas by the Oli government," said Minister for Law, Justice and Parliamentary Affairs Gyanendra Bahadur Karki.

"Those appointed from among career diplomats will carry on their duties," Karki said. The decision will mean Nepal will not have ambassadors in some key countries, with which it has a "very close" working relationship, including India, China, the United States and the United Kingdom.

Other than Acharya, Mahendra Bahadur Pandey, Yubaraj Khatiwada and Lok Darshan Regmi, who are serving in Beijing, Washington DC and London respectively, now will have to return as per the new decision of the Deuba government.

Acharya was appointed to lead the Delhi mission in February 2019. Earlier on July 18, five days after the new government was formed, Deuba's Cabinet had cancelled 11 recommendations made by the Oli government as ambassadors to different countries.

US COVID deaths topping 1,900 a day

Washington, Sept 22: COVID-19 deaths in the US have climbed to an average of more than 1,900 a day for the first time since early March, with experts saying the virus is preying largely on a distinct group

- 71 million unvaccinated Americans. The increasingly lethal turn has filled hospitals, complicated the start of the school year, delayed the return to offices and demoralized health care workers.

"It is devastating," said Dr. Dena Hubbard, a pediatrician in the Kansas City, Missouri, area who has cared for babies delivered prematurely by cesarean section in a lastditch effort to save their mothers, some of whom died. For health workers, the deaths, combined with misinformation and disbelief about the virus, have been "heart-wrenching, soul-crushing.'

Twenty-two people died in one week alone at CoxHealth hospitals in the Springfield-Branson area, a level almost as high as that of all of Chicago. West Virginia has had more deaths in the first three weeks of September — 340 — than in the previous three months combined. Georgia is averaging 125 dead per day, more than California or other more populous states.

"Tve got to tell you, a guy has got to wonder if we are ever going to see the end of it or not," said Collin Follis, who is the coroner in Missouri's Madison County and works at a funeral home. The nation was stunned back in December when it was witnessing 3,000 deaths a day. But that was when almost no one was vaccinated.

Taliban name Shaheen as Afghan envoy to UN

United Nations, Sept 22: The Taliban have written to Secretary-General Antonio Guterres nominating their spokesman Suhail Shaheen as Afghanistan's new ambassador to the UN and have asked to participate and speak in the high-level 76th session of the General Assembly currently underway here.

The nomination sets up a confrontation between the Taliban and Afghanistan's fallen government envoy, Gram Isakuzai, who has held his post so far. The Taliban swept across the country last month, seizing control of almost all key towns and cities in the backdrop of withdrawal of the US forces that began on May 1. On August 15, the capital city of Kabul fell to the insurgents.

The Taliban claimed victory over opposition forces in the last holdout province of Panjshir on September 6, completing their takeover of

Afghanistan three weeks after capturing Kabul. On September 20, on the eve of the commencement of the high-level UN General Debate, the Secretary-General received a communication with the letterhead "Islamic Emirate of Afghanistan, Ministry of Foreign Affairs" dated September 20, 2021, signed by "Ameer Khan Muttaqi" as "Minister of Foreign Affairs".

In the letter, the Taliban requested to participate in the "76th session of the UN General Assembly on September 21-27." Farhan Haq, the Deputy Spokesman for the Secretary-General, said that the letter also indicates that as of August 15, 2021, "Mohammad Ashraf Ghani is ousted and (countries across the world) no longer recognise him as president".

Ghani, who had fled the country as the Taliban took control of Kabul on August 15, had appointed Isaczai as Kabul's envoy to the UN in June 2021.

Five million Chinese will be working in Pak in next 4 years

New Delhi, Sept 22: There would be around five million Chinese nationals working in Pakistan by 2025, The News has reported.

To meet the health needs of these Chinese nationals, a collaboration between the Pakistani and Chinese medical universities, research institutes and biotechnological firms under the China Pakistan Health Corridor (CPHC) is being enhanced, a senior Pakistani public health expert said on Tuesday.

Vice Chancellor Health Services Academy (HSA) Prof Dr Shahzad Ali Khan told The News: "In order to meet the health needs of millions of Chinese nationals working in Pakistan, Afghanistan and Central Asian States, we need to have specialised health facilities, based on both modern and traditional treat-



"This can only be achieved by enhancing collaboration between Pakistani and Chinese health institutions under the China Pakistan Health Corridor." He said talks were in advanced stages to sign multiple, joint collaborative agreements with different Chinese academic, research institutes and biotechnological firms and added that during the 11th Annual Public Health Conference in Islamabad on September 23-24, 2021, several

Memorandums of Understanding (MoU) would be signed between Pakistan and Chinese institutions.

'We wish to train Pakistani experts in modern medical technologies as well as traditional Chinese medicines, which is a treatment of choice by millions of people in China. These experts would not only fulfill the medical needs of visiting Chinese nationals but also of the Pakistani people, who believe in alternate medicine," Prof Shahzad Ali Khan said.

In the first step, Chairman China Pakistan Health Corridor Dr Lee, also the VC, HSA, will sign an MoU for the HSA's joining into the China Pakistan Health Corridor, he said, adding the Department of Public Health of Wuhan University will sign an MoU for multiple cooperation in the academic partnership between China and Pakistan in the field of public health.



The deal will also ease the pressure that Zee Entertainment Enterprises Ltd was facing from top shareholders who called for a management reshuffle last week - including the removal of CEO Punit Goenka from the board.

SPNI will invest \$1.575 billion in the new entity, which will be publicly listed, the companies said in a statement, without disclosing other financial terms. Shares in Zee soared 35%, taking its market capitalisation to nearly \$4.5 billion.

Dubai, Sept 22: Delhi Capitals (DC) rode on a brilliant fast bowling performance from their South African duo Anrich Nortje (2/12) and Kagiso Rabada (3/37) to pulverise wooden spooners Sunrisers Hyderabad (SRH) by eight wickets as they took a giant leap towards IPL play-offs Wednesday.

Capitals produced top-notch performance in their first match of the second phase of this year's IPL to eke out the easy win in 17.5 overs in their pursuit of a modest 135-run target.

It was only possible after fast furious Nortje bowled at 150 clicks and was ably supported Rabada and Axar Patel (2/21) in a brilliant bowling effort.

Last edition's runners-up are now well and truly in contention for clinching a play-off berth with 14 points from nine games while SRH with two points are all but out of the competition.

DC started their chase on an aggressive note with Shikhar Dhawan (42, 37b, 6x4, 1x6) and young Prithvi Shaw (11) adding 20 runs in 17 balls before the latter was caught by Kane Williamson off the bowling of Khaleel Ahmed as the batsman went for an extravagant shot over mid-wicket.

Orange Cap Dhawan was unperturbed as he continued his attacking batting. While SRH batsmen struggled, Dhawan made batting look easy on the wicket as DC reached 69/1 in the 10th over.

But Dhawan paid the price for being too aggressive when he was holed out by Abdul Samad off the bowling of Rashid Khan (1/26) as the left-hander went for a slog sweep over deep square leg in search of a six.

Shreyas Iyer (47 n o, 41b, 2x4, 2x6), who played the second fiddle when Dhawan was around, then took the onus on himself and upped the ante. Iyer continued to bat freely and in the company of skipper Rishabh Pant (35 n o, 21b, 3x4, 2x6) took DC home with 13 balls to

Pak blames India for NZ withdrawal

Islamabad, Sept 22: Pakistan Wednesday alleged that a threatening email was sent to the New Zealand cricket squad from India, which prompted the Kiwis to call off a tour of the country.

The Kiwis called off their first tour of Pakistan after 18 years last Friday due to a security threat to the team, followed by a decision by the England and Wales Cricket Board (ECB) Monday to cancel a bilateral series scheduled for next month in Pakistan

month in Pakistan.

Pakistan has been claiming that India was behind some of the terror attacks in the country recently. India has dismissed these claims as "baseless propaganda" and asked Islamabad to take "credible and verifiable" action against terrorism proparating from its soil incread.

emanating from its soil instead.

"It is not new for Pakistan to engage in baseless propaganda against India. Pakistan would do well to expend the same effort in setting its own house in order and taking credible and verifiable action against terrorism emanating from its soil and terrorists who have found safe sanctuaries there," Ministry of External Affairs (MEA) Spokesperson Arindam Bagchi said in July.

"The international community is well aware of Pakistan's credentials when it comes to terrorism. This is acknowledged by none other

than its own leadership, which continues to glorify terrorists like Osama Bin Laden as 'martyrs'," he said.

Speaking at a press conference alongside Interior Minister Sheikh Rashid Ahmed here Wednesday, Information Minister Fawad Chaudhry said that a fake post was created in August under Tehreeki-Taliban Pakistan militant Ehsanullah Ehsan's name which told the New Zealand cricket board and government to refrain from sending the team to Pakistan as it would be "targeted".

would be "targeted".

Despite this, the New Zealand cricket team travelled to Pakistan.

However, on the day of the first match New Zealand officials said that their government had concerns of a credible threat and cancelled the tour. Chaudhry said.

"PCB officials, the interior min-

istry security team, everyone went to them and asked them to share the threat... (but) they were as clueless as us," he was quoted as saying by 'Dawn News'.

Ing by 'Dawn News'.

He said that a day later, a second threatening email was sent to the New Zealand team using the ID, Hamza Afridi. He claimed that investigating authorities discovered that the email was sent from a device associated with India.

"It was sent using a virtual private network (VPN) so the location was shown as Singapore," he claimed. He said that the same device had 13 other IDs, nearly all of which were Indian names.

which were Indian names.

"The device used to send the threat to the New Zealand team belonged to India. A fake ID was used but it was sent from Maharashtra," he claimed.

He said that the interior ministry had registered a case and had requested Interpol for assistance and information on the Tehreek-i-Labbaik ProtonMail and the ID of Hamza Afridi.

He said that the West Indies team was travelling to Pakistan in December. "A threat has already been issued to the team," he claimed, adding that this was also issued via a ProtonMail account.

"This is unfortunate. We believe this is a campaign against international cricket. The International Cricket Council (ICC) and other bodies must take notice," he said.

Tuesday, Chaudhry had claimed that his country was paying a price for saying no to the US on allowing American military bases on its soil.

Commenting on England's decision to cancel their tour, Chaudhry said that British High Commissioner Christian Turner had made it clear that the United Kingdom government's advisory for Pakistan was not being changed.

"So if the government has no reservations, who is the ECB (to cancel the tour)? To claim that players are tired is a shoddy excuse," he said. He said that PCB chairman Rameez Raja, foreign ministry and Interior ministry would take up the issue at all concerned forums and Pakistan Television would evaluate the financial losses. "We are working on this and if our legal team permits, we will sue the ECB," he said.

CITY, REDS ADVANCE

London, Sept 22: Bidding to win the English League Cup for a fifth straight season, Manchester City's players fell behind during a game in the competition for the first time in nearly four years.

Among the scorers for City were Kevin De Bruyne and Phil Foden as they build up their match fitness


after early-season injuries.

Southampton and Leeds fared better to overcome teams who were in the top flight last season — Sheffield United and Fulham, respectively. Brentford thrashed Oldham 7-0 and Burnley cruised past another third-tier opponent, Rochdale, 4-1.
