MUMBAI: The Indian equity benchmarks sky rocketed to record highs Thursday. The Sensex rose as much as 1,030 points to hit record high of 59,957.25, within striking distance away from the 60,000-mark and Nifty 50 index closed above its important psychological level of 17,800 for the first time led by gains in

banking, financial services, and oil and gas shares. The Sensex surged 958 points to close at record high of 59,885.36 and the Nifty 50 index climbed MORE P11 176 points to settle at an all-time high of 17,823.

Panchayat poll rules amended

Earlier counting of votes was done in the booth on the same day. However, as per the new rule, the counting will be done on a different date as designated by SEC

Bhubaneswar; Sept 23: The Odisha government has amended rules for the smooth conduct of the elections for gram panchayats, panchayat samitis and zilla parishads, an official said Thursday.

As per the amended rules, the counting of votes will be done on a date fixed by the State Election Commission (SEC). Earlier, the counting of votes was done on the same day of the elections in the booth itself. However, now it will be on a different date as designated by the SEC. The counting of the gram panchayats, panchayat samitis and zilla parishad polls can take place on different dates, but the results will be announced on the same day.

A gazette notification issued in this regard by the Panchayati Raj and Drinking Water department said that the Odisha Grama Panchayat Election (Amendment)



after a visit to the site. The minister informed that the science centre will have an outdoor park displaying concept models of various scientific innovations and other exhibits. The centre will also have digital and physical interactive models on physics, chemistry, biology and mathe-

matics for children. This apart the planetarium will conduct shows on various thematic areas of the universe, evolution and space expedition. Panda added that the establishment of the centre will help to inculcate the inquisitive minds of the students and help them prosper.

Earlier, the Odisha Government had decided to set up six more planetariums and 30 science centres in the state in addition to the existing ones. At present two planetariums are operational in the State capital and Sambalpur while the foundation stone for another one was laid in March this year by Chief Minister Naveen Patnaik at Rayagada. Sources

said that ₹100 crore will be spent on building the new planetariums and district science centres. After remaining out of bounds for visitors for approximately three

months due to the second wave of the Covid-19 in the state, the Pathani Samanta Planetarium in this city and the Dr APJ Abdul Kalam Planetarium in Sambalpur's Burla had reopened August 10. Visitors to the centres however, are only being allowed entry after they show double vaccination certificates.

Cuttack, Sept 23: City Deputy Commissioner of Police (DCP) Prateek Singh filed an affidavit Thursday in Orissa High Court on a case pertaining to the death of a Christ College student in August this year.

In his affidavit, the DCP informed the high court that a case has been filed against the deceased student's friend Shruti Maharana and Jagatpur police is now probing the entire incident.

Tusarkanta Sahu, an undergraduate commerce student of Christ College, had left his home near Chandi Square on a scooter for some work on the evening of August 3. But, he did not return home.

Sahu's family waited for a long time for his return. His father Hrusikesh then lodged a complaint in this regard with Cantonment

Dhanbad judge was intentionally hit: CBI

Justice Anand's death created national furore prompting the Supreme Court to take up the case on its own and seek a report on the matter

Ranchi, Sept 23: District judge Uttam Anand was intentionally hit by an auto-rickshaw and killed, the CBI told the Jharkhand High Court Thursday. The judge was hit by the vehicle on the morning of July 28 in Dhanbad, when he was jogging.

In its update, the probe agency said that reconstruction of the crime scene, examination of CCTV footage and forensic evidence all suggest that the judge was 'deliberately killed'. The reports 'conclusively suggest that the judge was intentionally hit' sources were quoted as saying by 'NDTV'.

The sources also informed that investigation is in the final stage. The CBI is now corroborating forensic reports with physical evidence to complete its case. Investigations into the conspiracy behind the killing are on, the sources said.

The two accused in the case are driver of the vehicle, Lakhan Verma and his helper Rahul Verma. Both were arrested a day after the incident. The three-wheeler they were driving was registered in the name of a woman.

Initially it was thought to be a hitand-run case. However, CCTV footage showed that the auto-rickshaw was intentionally heading towards the judge when he was running. It hit the judge and fled away.

Justice Anand had been handling many cases of mafia killings in Dhanbad and had rejected bail requests from two gangsters. He was also hearing a murder case involving an MLA's close aide. Priorto his death, he had also received a number of threatening calls.

JR HOCKEY WORLD CUP COMES TO TOWN

After successfully hosting senior men's tournaments like the Champions Trophy and the FIH World Cup, Bhubaneswar will now play host to the junior hockey stars of the world

Bhubaneswar, Sept 23: Odisha will host the Men's Hockey Junior World Cup at the Kalinga Stadium here from November 24 to December 5, Chief Minister Naveen Patnaik announced Thursday. A total of 16 teams are expected to take part in the tournament, including India. At a function held here, Patnaik said Hockey India (HI) had recently approached the Odisha government to support them for the men's junior world Cup to be held in two months time

Others present at the function were Odisha Sports Minister, Tusharkanti Behera, FIH president Narinder Batra and HI Secretary-General Rajinder Singh.

"It is a short notice for making the arrangement for such an event, especially during the pandemic period. However, since India's prestige is at stake, we have readily agreed to host it," the CM said. "I hope the reigning Indian team will take advantage of the home conditions and emerge victorious again. Our priority will be to ensure a safe environment to compete during these challenging Covid-19 times," added Patnaik.

PARTICIPATING TEAMS

India, Korea, Malaysia, Pakistan, South Africa, Egypt, Belgium, England, France, Germany, the Netherlands, Spain, USA, Canada, Chile and Argentina.

The Odisha chief minister also also unveiled the logo and the trophy for the event.

Batra thanked Patnaik for hosting the tournament in Odisha and said that the hockey infrastructure in the state is 'world class'.

It should also be stated here that Odisha is the official sponsors of the senior Indian men's and women's hockey teams since 2018 and has extended the deal to 2033. The Odisha government has been in the forefront of promoting hockey in India and that is one of the main reasons, HI decided to request the state to once again host the junior-level tournament.

A robust infrastructure and the state government's support for the game, has made Odisha the 'hockey hub' of India in the last few years. Odisha will also host 2023 senior men's World Cup. The matches of the tournament will be played here and Rourkela in Sundargarh district.

The last time the tournament was held in 2016 at Lucknow. India emerged champions beating Belgium 2-1 in the final. It is however, not yet known whether crowds will be allowed during the matches keeping in mind restrictions imposed due to Covid-19







What are the conditions linked to oral health?

Endocarditis – inflammation of inner lining of heart chambers and valves - and cardiovascular diseases (clogging of arteries and stroke) might be linked to infections caused by oral bacteria. Bad oral health can lead to respiratory diseases. Certain oral microbes can be dragged into lungs, causing pneumonia. It can also lead to pregnancy and birth related complications. For example, severe gum disease (periodontitis) can lead to premature births and low birth weight.



Bhograi, Sept 23: Even as many parts of Basta and Sadar blocks in Barasore are already reeling from floods in the Jalaka river, heavy rains which have been lashing the upstream area of Subarnarekha river in Jharkhand owing to a cyclonic circulation has triggered panic among people in north Balasore. The administration has, meanwhile, sounded possibility of floods in the downstream areas

Reports said, Chandili, Galudihi, Karkai and Bankabal dams have been receiving huge amounts of water for the last few days. Jharkhand has started releasing the water from these dams, which will lead to floods in Subarnarekha river basin areas in Mayurbhanj and Balasore districts.

From July till date, Balasore has witnessed three major floods from Subarnarekha. Most parts of Balasore have been waterlogged amid heavy rains.

On the other hand, most parts of Bhograi, Jaleswar, Baliapal and Basta blocks are reeling from floods from Jalaka river.

The incident occurred Wednesday night when a group of senior students knocked on the door of the complainant's room and asked him to show them his mobile phone, the complaint lodged with the university authorities said.

When the victim refused to comply with their demand, the seniors thrashed him. The student's father has lodged a written complaint with the dean of the students' welfare wing of the institute.

Majhi claimed it was a case of a tussle among students. "However, the disciplinary committee of the university will hold a meeting over the issue Friday," he said.

Sambalpur, Sept 23: In the wake of busting an illegal gun-making unit in Jujumara area in this district, police have launched a special drive to contain crimes with the help of local people.

Acting on information from local people, police have arrested three more people involved in the gun-manufacturing racket Thursday. They have seized four more guns from them.

The three accused were identified as Tarani Pradhan of Basupalli, Ashok Pradhan of Hero village and Sushant Sahu of Ghudapal. Police confiscated four countrymade guns, iron pipes used for making these guns and other materials from them.

Earlier police had arrested Kumar Mirdha and Tarani's wife. Both of them were produced in court. Police revealed that Mirdha and Tarani had been making guns in their houses and sold them in various parts of Angul, Jharsuguda, Sundargarh and Bargarh.

Further investigation into the matter

is underway, said Sambalpur SP Batula Gangadhar here at a presser.

On the other hand, smuggling of corex and drugs, gambling, loot and snatching cases are on the rise in parts of western Odisha.

"Police have started a special drive to contain all such crimes in the district. Police patrolling has been intensified in the district the evening," the SP said.

It was said that many people found involved in drug smuggling at desolate places have been detained while 208 drug addicts had been detained in various police stations and later were released with warning. 21 of them were forwarded to court.

Police are flooded with complaints that women and girls have to face misbehaviour from drug addicts and peddlers at some places. Police are carrying out raids and arresting the miscreants. Three people have been arrested for cyber crime.

After the relaxation of Covid restrictions, gambling and betting cases are on the rise in the district while 14 people have been arrested in connection with gambling.

Galloping on a stretch of under-construction hilly road. raising dust behind them as shown in the video shot on mobile phone camera, the horse-riding skills of these eight to twelve-year-old tribal boys can make anyone envi-

ous. As schools are closed owing to the Covid-pandemic, these kids are seen making full use of their pastime by racing their horses for fun.

Once upon a time, the local tribes used to travel from one habitation to the other and carry their valu-

portation and communication in the hilly and densely forested terrains of this erstwhile Maoist infested 'cut-off' region of Malkangiri district. Now. this region is termed as the Swabhiman Anchal after Gurupriya Setu, the lifeline of this once remote and inaccessible part, was inaugurated by Chief Minister Naveen Patnaik July 26 in 2018.

After the construction of this bridge, 151 villages across the Balimela reservoir were connected with the rest of Malkangiri district paving the way for development and progress in the shape of roads, communication, modern transport and many essential government services.

Economic recovery only by 2030 The UN Conference Trade and Development (UNCTAD) has predicted highly uneven growth despite possibility of a bounce back, but global output trends of 2016-19 would resume not before 2030. The agency notes that growth has been the slowest since the post 2007-8 financial crisis in the 2011-20 decade since 1945. An important UNCTAD recommendation is to revive the public sector as critical instruments of

long-term development. The report observes that the pandemic has seen an emergent consensus around the need for significant public sector intervention. A call India needs to heed amid its move for fast-paced privatisation. It suggests that expansionary fiscal measures that most governments are doing may end up "only as fire-fighting tools" Consolidating these in public sector infrastructure could come up as "critical instruments in long-

term development". The UNCTAD Trade and Development Report 2021 expects India to grow at 7.5 per cent in 2021 and 6.5 per cent in 2022, but it is insufficient to regain the pre-Covid-19 income level. The world may grow at 5.5 per cent, may be the

highest in five decades, but amid too many pitfalls on regional, sectoral and income lines. It does not rule out sharper than accelerated deceleration next year.

It warns policymakers to trudge carefully particularly on deregulation. The developing economies, which as per it include India also have been hit harder than during the global financial crisis, while "new heavier debt burden reduces their own room for fiscal policy"

India's growth despite being next to China "is poised to slow down' because of the inherent fragility in coping with the pandemic and restoring employment and incomes. Even the high growth is insufficient to remove "the widened income and wealth inequalities and rising social unrests'

Even then, in 2022, UNCTAD expects global growth to slow to 3.6 per cent leaving world income still 3.7 per cent below where its pre-pandemic trend would have put it; an expected cumulative income loss of about \$13 trillion, as per 2015 dollar values, in 2020-22. Timid policv or, even worse, backsliding, could pull growth down further. The world is not out of the woods. Indian efforts of four-year ₹96,000

crore reprieve for spectrum dues to telecom companies; ₹25,938 crore production-linked incentive (PLI) schemes for automobile sector ₹120 crore for drone industry, ₹10,683 crore for textiles and others announced for 13 sectors during the last one year is expected to raise minimum production to around ₹37.5 lakh crore over five years and create additional jobs of about one crore.

While the aim is good and incentives should be welcome, the UNCTAD points out the problem of inflation too. Rising prices in India is a constant concern of the Reserve Bank of India. Despite some seasonal moderation in food prices in India, the UNCTAD believes food prices would rise and could pose a serious threat to vulnerable populations in the South, already financially weakened by the health crisis.

The RBI is under pressure to increase its lowest interest rates. This is also affecting yields of depositors and hits the overall economy. The nation has witnessed that higher interest yields in the past had helped the country grow. Interest is mistakenly considered as income where as it is mere hedging against inflation. If inflation is high and interest rates low on deposits, it hits capital building.

It may be a sequel to this that National Crime Research Bureau finds crimes rising during the pandemic - digital crimes and cyber monetary frauds, including internet banking by 11.8 per cent; social disorders rise 21-fold; other IPC crimes four-fold; 12.4 per cent rise in offences against public tranquillity, and 78.1 per cent in environment crimes. Cyber frauds are growing the most in Telangana, Maharashtra, Odisha, Bihar and Assam. It may be a mere tip of the iceberg as there are many cyber crimes that are difficult to investigate like cyber bullying and forcing people to pay money through digital transfers. These hit the growth processes and policing cost is high.

The UNCTAD also wants global reforms to the international economic architecture promised after 2008-09 crises, but abandoned "in the face of 'rentier' class" is now implemented for definite growth worldwide". India needs to take cue for correcting the policies and path for taking the country ahead. INFA

Fortified rice production starts TWO RICE MILLS IN SAMBALPUR AND SONEPUR HAVE GOT APPROVAL FOR SALES OF THE RICE

Sambalpur, Sept 23: In a major development, production of vitamin-laced rice has started in Sambalpur. The rice enriched with minerals and vitamins is aimed at addressing the problem of anaemia and micro-nutrients deficiency among people.

According to reports, IP Rice Industries at Mundoghat in Sambalpur and Lalita Rice Mill in Sonepur had got approval of the state government for production of this rice, which was started from Wednesday.

Now, these mills have got approval for sales of this rice in the market. Following a directive from the government, the vitamin-laced rice will be supplied to consumers under PDS.

The civil supplies department had earlier issued a letter to the district civil supplies officer May 13, 2021 to extend cooperation to the private mill in setting up the rice plant at Mundoghat.

The mill owner has been asked



to complete the work in three months. This plant is capable of producing 500 kg of fortified rice per hour. Under this process, common rice or broken rice is pulverised while Vitamin A, B, C, zinc and minerals are laced with the pulverised rice.

The fortified rice will be sold in the market for ₹60 a kg. As per provision, these two mills will provide fortified rice to other mills in the state. These mills will admix the fortified rice with their own rice and supply it to market and to the gov-

20 migrants tortured in Andhra seek rescue

Gunupur; Sept 23: A scene of migrants' suffering in Andhra Pradesh came to the fore Thursday. A video was found circulating in this regard. According to reports, over 20

migrant workers in Gunupur of Rayagada district were stuck in the nighbouring state while they were working at a prawn processing plant.

The owner of the prawn processing plant at West Godavari district has allegedly threatened the migrant workers to burn them alive. They also alleged that they are being forced to work without wages and are getting tortured.

They lamented that they were confined to a room and beaten up. In the video, the distressed migrant workers have appealed to the administration for rescue. Four of the stuck migrants are women.

The reports said, over 20 people from remote areas like Putasingh. Pindagudi, Padmapur and Muniguda had gone to Andhra Pradesh in search of work three months ago. After facing harassment and torture there, a woman migrant had told her husband over phone about their sufferings in the hand of the prawn processing plant owner.

Thereafter, her husband Trinath Dalei went to Andhra Pradesh and managed to get entry into the plant premises on the plea of looking for work September 9.

Trinath videographed the scene of torture on the migrant workers. But the factory owner and supervisor got to know of his act. Trinath and another migrant were confined to a room and beaten up mercilessly for two hours. They

were threatened of burning to death by the factory owner.

Trinath's wife somehow managed to save the two from the clutches of the factory owner. Fearing threat to their life, the migrants managed to escape from the factory at night Tuesday and fled to a nearby forest. Later, they informed the Andhra police about the incident. Police later rescued them and directed the factory owner to pay off their wages.

The assistant labour officer of Gunupur said the matter will be investigated.

Mirzapur (Uttar Pradesh), Sept 23: The skeletons of three minor girls, who had been reported missing since the past one month, have been found in a forest in the Harra area here.

The girls had left their home with their mother in Belahi village of the Halia area in Mirzapur district a month ago and were missing since then.

The mother is now absconding after the recovery of skeletons that have been sent for autopsy and forensic examination.

Station Officer (SO), Halia Rajkumar Singh said that some local shepherds spotted skeletons in the jungles of Harra Wednesday afternoon and alerted the husband and brother of the girls. They reached the spot and ascertained their identity with the



help of clothes lying there. The police were informed and the skeletons were seized. The SO said that efforts were being made to trace the absconding mother.

Initial investigation revealed that one Devidas Kole of Belahi village had three sons and a daughter from his first wife Falguni, who died a few years ago. He had then married Sima, who had two daughters from her first husband. After marriage, Sima's daughters

also started living with Kole's family. On August 16, Sima left home with the three daughters - Golu, 12, Munni, 10, and Mamta, 8, without

informing her husband. Kole contacted his in-laws to get their whereabouts but failed.

On August 21, Sima contacted her brother Ramakant over phone and said that she was in Indore with her daughters.

On the occasion of Raksha Bandhan, she reached Ramakant's place alone and on being asked about her daughters, she said that she had left them at Indore railway station.

Later, Kole and Ramakant reached Indore and also visited Ujjain to search for the three girls but could not find them.

Sima left her home when she learnt that skeletons of the girls had been found

Chennai, Sept 23: At least 75 vendors from across Tamil Nadu, supplving components to auto major Ford, met state Rural Industries Minister TM Anbarasan in Chennai after the car-maker announced its India exit. Claiming that business with Ford made up 20-40% of their business, the vendors elaborated how the plant's closure - just outside Chennai - will impact their businesses

Ford had cited a drastic fall in market share while announcing its exit from the Indian market.

SFC Solutions, which made fuel and brake systems for the auto giant, is worried about its 300 workers as 80% of the components the company manufactured have been for Ford. The representative of the company told authorities, "At least 200 of the 300 jobs will be lost. We also have imported parts worth ₹25 crore.'

We don't want to send any worker from my company. But if something doesn't work out, we will have to," said S Nargunam, Adviser to industry body TIEMA. The vendors said the carmaker's



exit will translate to huge losses in terms of raw materials that have piled up, imported, and locally made parts, and exclusive machinery.

While some raised concerns over job and financial losses, some offered suggestions to avert an adverse impact. Ellar - another company that makes auto components - has gradually reduced its dependence on Ford from 50% to 10%. Ford Madras HC orders probe into patta transfer

Chennai, Sept 23: Holding that all is not well, the Madras High Court has directed the Commissioner of Land Administration to inquire into the matter of transfer of patta of a piece of land in suburban Chromepet, in favour of a leather factory, said to be owned by a DMK MP.

A division bench of Justices Pushpa Sathyanarayana and Krishnan Ramaswamy gave the direction, while passing interim orders on a writ appeal from Quentin Dawson of Moovarasanpet, challenging the August 24 2020 order of a single judge, passed in a writ petition in favour of the leather factory, represented by its vice-president Vairakumar.

The prayer in the writ filed by the factory was to quash an order dated July 12, 2019 of the Revenue Divisional Officer (RDO) in Tambaram, granting the patta (land deed) in favour of one David Chambers of Anand Nagar in East Tambaram.

We are of the view that all is not well in this case. Hence, a direction is issued to the Commissioner of Land Administration, Chepauk, to enquire into this matter and file a report within a period of four weeks from today. The report shall, inter alia, indicate as to under what authority the impugned order was passed by the then RDO, when the said authority is only an appellate authority and the power only yests with the Tahsildhar, as per Section 10 of the Tamil Nadu Patta Pass Book Act, 1983," the judges said.

The other directions included furnishing the reason for not summoning the appellant for enquiry, before passing the impugned order effecting name change in patta and when and where all the original files were placed/misplaced, since the then RDO asserted that on the date when he passed the order impugned in the writ petition, they were very much available in the office and the further course of action that is proposed to be taken against the errant officials in this regard.

The two spiral bound books presented before this Court today are all photocopies of some documents and the same are now returned to the custody of D Ravichandran, the present RDO, Tambaram. The same shall be produced on the nextdate of hearing October 21, the bench added.

Thousands of shoe workers lose jobs in Agra

Wrong govt policies and inability to keep pace with the latest technology and upgradation led to the closure of 35 shoe-manufacturing units

INDO-ASIAN NEWS SERVICE

Agra, Sept 23: Around five thousand trained shoe workers of Agra are now without work as over 35 leather shoe units have downed shutters following changes in the purchase policy by several government departments few years ago.

Agra is the biggest hub of leather shoe industries in India and exports a major chunk of its production. The industry employs over 2.5 lakh trained hands.

More than 80 per cent of all shoes for the Armed Forces and paramilitary agencies are manufactured in Agra. "Since Mughal times, Agra has been a major supplier of footwear all over India," says an industrial consultant.

Members of the Boot Manufacturing Association said, "The recent changes in the purchase policies by the Directorate

General of Supplies and Disposals (DGS&D) and other government bodies have hit hard the Agra industries. The parameters have changed.

"Preference is now being given to units with higher annual turnover, above ₹20 crore. This excludes the smaller, tiny, and cottage units that till now were able to participate in the tender process."

Association secretary Anil Mahajan said the government policies are now promoting only big business houses and units at the cost of smaller units that employ thousands of workers. Machines are taking over. This has proved detrimental to the interests of smaller units in Agra, Kanpur, and Kolkata, Mahajan added.

Sunil Gupta, the president of the Association said, "Shoes costing only around ₹200 were being purchased for over ₹600 by the gov-



ernment agencies.

Mechanised units were being importance, whereas in terms of quality it does not make any difference. Shoes manufactured by hands are as good as those produced by machines, Gupta claimed. The middlemen or big retailing

giants were taking advantage of the changed policies and supplying shoes manufactured by smaller units, to the government bodies.

'The Union government wants to increase employment potential, on the other hand, faulty policies were compelling smaller labour intensive units to shut down," local shoe manufacturers said.

Washington, Sept 23: The US has ruled out adding India or Japan to the new trilateral security partnership with Australia and Britain to meet the challenges of the 21st century in the strate gic Indo-Pacific region.

On September 15, US President Joe Biden, Australian Prime Minister Scott Morrison and British Prime Minister Boris Johnson jointly announced the formation of the trilateral security alliance AUKUS under which Australia would get a fleet of nuclear-powered submarines for the first time.



Vaccine certification must meet 'minimum criteria,' says UK

London, Sept 23: The UK government has said that COVID-19 vaccine certification from all countries must meet a "minimum criteria" and that it is working with India on a "phased approach" to its international travel norms.

It follows Covishield, the Serum Institute of India manufactured Oxford/AstraZeneca vaccine, being added as eligible to an expanded UK travel advisory on Wednesday.

But with India's vaccine certification not on a list of 18 approved countries, Indian travellers to the UK will continue to be treated as non-vaccinated and therefore required to quarantine for 10 days on arrival.

Following much confusion over this process, UK government sources said on Wednesday night that additions or changes to the approved country listings are being kept under "regular consideration", but there was no further clarity on the required criteria for approving a country's vaccine certification.

Lava spread raises fears

Todoque (Spain): The advance of lava from a volcanic eruption in Spain's Canary Islands has slowed significantly, raising doubts Thursday about whether it will fan out across the land and destroy more homes instead of flowing into the sea. A giant river of lava slowed to four metres (13 feet) per hour after reaching a plain on Wednesday. On Monday, a day after the eruption on the island of La Palma, it was moving at 700 metres (2,300 feet) per hour. As it slowed, the lava grew thicker. In places, it rose up to 15 metres (50 feet) high, authorities said. The lava now covers 166 hectares (410 acres).

Stockholm, Sept 23: The Nobel Prize ceremonies will be reined in and scaled-down for the second year in a row due to the coronavirus pandemic, the foundation behind the coveted prizes said Thursday.

The winners of this year's prizes in chemistry, literature, physics, medicine and economics, as well as the Nobel Peace Prize, are set to be announced between October 4 and October 11. "It is now also clear that this year's Nobel festivities in December - when the laureates are honoured in Stockholm and Oslo - will be a mixture of digital and physical events," the Nobel Foundation said.

The laureates will receive their Nobel Prize medals and diplomas in their home countries, the foundation said. It said the presentation events will be woven together with an awards ceremony at Stockholm City Hall on December 10, which is the anniversary of the death of prize founder Albert Nobel.

Under Taliban, thriving Afghan music scene heads to silence

Kabul, Sept 23: A month after the Taliban seized power in Afghanistan, the music is going quiet.

The last time the militant group ruled the country, in the late 1990s, it outright banned music. So far this time, the government set up by the Taliban hasn't taken that step officially. But already, musicians are afraid a ban will come, and some Taliban fighters on the ground have started enforcing rules on their own, harassing musicians

and music venues. Many wedding halls are limiting music at their gatherings. Musicians are afraid to perform. At least one reported that Taliban fighters at one of the many checkpoints around the capital smashed

his instrument. Drivers silence their radios whenever they see a Taliban checkpoint.

In the alleys of Kharabat, a neighbourhood in Kabul's Old City, families where music is a profession passed through generations are looking for ways to leave the country. The profession was already hit hard by Afghanistan's foundering economy, along with the coronavirus pandemic, and some families now too fearful to work are selling off furniture to get by.

"The current situation is oppressive," said Muzafar Bakhsh, a 21-year-old who played in a wedding band. His family had just sold off part of its belongings at Kabul's new flea market, Chaman-e-Hozari. "We keep selling them ... so we don't die of starvation," said Bakhsh, whose late grandfather was Ustad Rahim



Bakhsh, a famous ustad - or maestro—of Afghan classical music.

Afghanistan has a strong musical tradition, influenced by Iranian and Indian classical music. It also has a thriving pop music scene, adding electronic instruments and dance beats to more traditional

rhythms. Both have flourished in the past 20 years.

Asked whether the Taliban government will ban music again, spokesman Bilal Karimi told The Associated Press, "Right now, it is under review and when a final decision is made, the Islamic Emirate

will announce it." But music venues are already feeling the pressure since the Taliban swept into Kabul on Aug. 15.

Wedding halls are usually scene to large gatherings with music and dancing, most often segregated between men's and women's sections. At three halls visited by the AP, staff said the same thing. Taliban fighters often show up, and although so far they haven't objected to music, their presence is intimidating. Musicians refuse to show up. In the male sections of weddings, the halls no longer have live music or DJs. In the women's section — where the Taliban fighters have less access — female DJs sometimes still play.



While Jasprit Bumrah (3/43) found Gill's stumps in the third over, Iyer went on to play a memorable knock comprising four

boundaries and three sixes. Iyer and Tripathi shared an 88run stand for the second wicket which completely shut the door on MI, who suffered their second

loss since IPL's resumption. Earlier, MI skipper Rohit Sharma (33, 30b, 4x4) got off the innings in scintillating fashion, caressing a Nitish Rana delivery on to the midoff boundary. The skipper, who was in sublime touch in the Tests

The RCB bowlers will also have to forget the underwhelming display against KKR. While pacers



Sharad Kumar hit by heart inflammation

NEW DELHI: Tokyo Paralympics bronze medal-winning high jumper Sharad Kumar has been diagnosed with heart inflammation and has undergone a few more tests, reports of which are still awaited. Kumar, who won a bronze in the T-42 high jump event in the Tokyo Paralympics August 31, was admitted to the All India Institute of Medical Sciences (AIIMS) after experiencing chest congestion last week. "The earlier reports showed that I have an inflammation in my heart," Kumar told PTI Thursday. The-29-vear-old Patna-born athlete was discharged from the medical facility earlier this week but had to come back for some more tests. "I have come back here for more tests. Since I live just 10 minutes away, I had asked the hospital authorities to allow me to go home," he added. Kumar's left leg was paralysed after he was administered a spurious polio vaccine as a toddler.
