Notably, the Narcotics Control Bureau

Sunday arrested Khan, after drugs were seized by its team from a Goa-bound cruise ship off the Mumbai coast. This was claimed to be the first-ever raid of a cruise ship by NCB. Khan along with two others - Munmun Dhamecha and Arbaaz Merchant- are currently under NCB custody on remand till October 7.





Fuel prices at record-high

New Delhi, Oct 5: Petrol and diesel prices Tuesday surged to all-time high levels as rates were increased again after international oil prices hit the highest mark since 2014. Petrol price was hiked by 25 paise a litre and diesel by 30 paise, according to a price notification of state-owned fuel retailers.

This sent the petrol price in Delhi to its highest-ever level of ₹102.64 a litre and to ₹108.67 in Mumbai, Diesel rates too touched a record high of ₹91.07 in Delhi and ₹98.80 in Mumbai



Nayagarh/Daspalla, Oct 5: A Class-VII girl of Adarsha Vidyalaya in Daspalla area of Nayagarh district was deprived of attending online classes after she objected to denial of midday meal rice (MDM), a report said Tuesday.

Rojali Pradhan was removed from her online group in the school and refused permission to attend online classes. The office of the block education officer denied books to her following the incident. The development has sparked resentment among residents who attacked the highhandedness of the authorities and harassment of a young girl. The girl apprised the headmaster of her school, Daspalla

BEO and the District Collector on the development but her plea is yet to be addressed. Left with no options, the girl accompanied by her parents launched a sit-in outside the block education office in Daspalla, Monday. Alarmed over her protest, BEO

Denied MDM, girl stages dharna

Pradipta Behera and Daspalla IIC Jayprakash Parida met her at around 11 pm Monday and assured to look into her demands. Later, the girl and her parents withdrew from the sit-in. However, several hours have passed since then but her name is yet to be re-added in her class online group. According to the complaint, Rojali was ad-

mitted to Adarsh Vidyalaya in Daspalla. The BEO's office gave her books after her admission. After receiving books, the class teacher added her name to her class WhatsApp group so that she could attend her online classes.

However, the unexpected happened when the authorities of Radha Mohan High School refused to give her midday meal rice as her name was not there in the school attendance register September 4. She objected to the denial of rice following which her name was removed from the online group in her school.

With this, the number of officers given compulsory retirement in the state went up to 122. Angul Deputy Collector Janakinath Mishra, an OAS officer, was compulsorily retired as he is facing two corruption cases and nine official proceedings.

OAS officer Akul Mallik, the tehsildar of Nuagarh tehsildar in Gajapati, was issued a notice of compulsory retirement. He is facing one corruption case and two departmental proceedings.

Dhenkanal sub-registrar Lalatendu Satpathy was also asked to go on compulsory retirement as he is under probe in two corruption cases, and two official proceedings are going on against him. Ex-district livestock officer of Nuapada Trilochan Dhal was asked to go on compulsory retirement as well with a corruption case pending against him.

Jury appreciates physical modelling of Earth's climate, quantifying variability and predicting global warming

Stockholm, Oct 5: The Nobel Prize for physics has been awarded to scientists from Japan, Germany and Italy. Syukuro Manabe, 90, and Klaus Hasselmann, 89, were cited for their work in "the physical modelling of Earth's climate, quantifying variability and reliably predicting global warming"

The second half of the prize was awarded to Giorgio Parisi, 73, for "the discovery of the interplay of disorder and fluctuations in physical systems from atomic to planetary scales." The panel said Manabe and Hasselmann "laid the foundation of our knowledge of the Earth's climate and how humanity influences it.

Starting in the 1960s, Manabe demonstrated how increases in the amount of carbon dioxide in the atmosphere would increase global temperatures, laying the foundations for current climate models. About a decade later, Hasselmann created a model that linked weather and climate, helping explain why climate models can be reliable de-

State tech(s) up fight against hemp The state govt will use drones, satellite imagery and remote sensing

technologies to locate and stop hemp farming

Bhubaneswar, Oct 5: Continuing enforcement activities against illegal hemp cultivation in the state, the government destroyed hemp crop across 22,217 acres in 2020-21 as compared to 9,473 acres in 2018-19.

The government has also decided to use drones, satellite imagery and remote sensing technologies to locate such activities in the state.

At a high-level meeting chaired by Chief Secretary SC Mohapatra, it was decided that the police and the excise department will intensify enforcement activity to stop hemp farming in the state.

Mohapatra asked the revenue department officials to check records of land where hemp is cultivated and take action against the



landowners as per provisions of the Narcotic Drugs and Psychotropic Substances Act.

Excise department principal secretary SK Lohani said hemp cultivation was destroyed in 10 districts. "Hemp farming has been contained to a large extent in Angul and Sambalpur districts, but such activity has been detected in Boudh, Deogarh, Gajapati, Ganjam, Kandhamal, Koraput, Malkangiri

and Rayagada," he said. Taking a district wise review of the situation, Mohapatra directed to intensify enforcement activities

through joint action by police, excise and revenue officials. He asked the officials to spot the areas and villages in which illegal hemp cultivation is done through collection of local intelligence.

The Chief Secretary instructed to identify the land record of private persons in whose land hemp is cultivated and proceed against them stringently as per provisions of the NDPS Act.

Collectors have been asked to prepare district-level action plans for prevention of illegal means of earning through targeted alter-

native livelihood interventions. They were asked to identify tribal poor families who are living on this trade and provide them alternative livelihood opportunities through convergence of Odisha Livelihood Mission, National Livelihood Mission, MGNREGS, high return cash crop, agri-business, agro-product aggregation, small food processing units, goatery, poultry, integrated farming and similar other schemes.

Mohapatra asked the Collectors to visit the villages where hemp cultivation was generally found in previous years and talk to people regarding alternative sustainable livelihood options. It was decided to enhance grants under OLM, NRLM and departmental livelihood schemes in the vulnerable areas.

Development Commissioner Pradeep Kumar Jena advised officials to intensify awareness and IEC activities in the identified villages with involvement of village community, PRI representatives, NGOs, SHGs, farmers' clubs and educated youth.

FLYOVER IN LIMBO Will 6 yrs of Jatni locals' dismay end in March '22?

ADMINISTRATION DOESN'T GIVE TWO HOOTS TO HUNDREDS OF VEHICLES PASSING UNDERNEATH THE HALF-BUILT FLYOVER INVOLVING TREMENDOUS LIFE RISKS

Jatni, Oct 5: Locals of Jatni are sceptical about the completion of a flyover, the construction of which began way back in 2015 and was set to be operational by 2017.

The 1,133-metre long and 12-metre wide under-construction flyover lies in the middle of the Jatni main road on National Highway 13, which connects Khurda, Nayagarh and Puri. The state government had begun the construction work in 2015 with an estimated cost of Rs 54.97 crore.

However, six years have passed and the daily commuters of Jatni have been facing loads of difficulties due to the incomplete flyover.

It is pertinent to mention here that owing to land acquisition for the said project, change in contract agencies, and rampant corruption, the total estimated cost has jumped to Rs 100 crore while more than 200 businesses have been displaced, which are yet to be setAlthough many accidents have occurred in the area due to the miserable condition of the passage and innumerable potholes, neither the administration nor any political party seems to be bothered about it

tled by the administration.

On the other hand, allegation of corruption in setting up of vending zones for evicted businesses from Sitaram Square has raised a lot of eyebrows. Locals are in dismay amidst corruption, change in consolatory dates of completion and political mudslinging. The worst part about this conundrum is the absence of a well-planned approach road, which is essential before the onset of any construction work. Hundreds of vehicles are passing underneath the under-construction flyover with tremendous life risks, considering the history of bridge collapses in state and country. Neither the administration nor any political party seems to be bothered about it. Owing to the miserable condition of the passage and innumerable potholes, many accidents have occurred in the area, endangering lives and properties.

Meanwhile, Works Minister Prafulla Kumar Mallik, who visited the site Tuesday afternoon, said the rehabilitation package was delivered three days ago for 23 households evicted during land acquisition for the bridge. He also assured that the construction would be complete by March 2022, and the bridge would be inaugurated April 1.

Jatni MLA Suresh Kumar Routray (Congress) was also present during the minister's visit to the site.

JV formed for floating solar projects

Bhubaneswar, Oct 5: A joint venture has been formed between Green Energy Development Corporation of Odisha (GEDCOL) and National Hydroelectric Power Corporation (NHPC) for implementation of floating solar projects in Odisha.

The joint venture will make Odisha a leading state in terms of solar power generation, particularly from floating installations. The GEDCOL was formed in 2013 to spearhead the renewable energy production and achieve the target of renewable purchase obligation (RPO) of the state.

Keeping in view the impacts of climate change, the GEDCOL has set a target to generate 1,500 MW of power by 2022. The corporation on its own has installed 20 MW terrestrial and 4 MW rooftop solar projects in the state while many other projects are in the pipeline.

Terrestrial solar power plants require large land masses. However, the western and southern parts of Odisha are hilly and forested while the coastal region is prone to cyclone, flood and lower solar radiation. Thus, only a few

districts can host terrestrial installations, sources said. On the other hand, Odisha has several water reservoirs, including Hirakud and Rengali, which can effectively be used to overcome the problem of land scarcity.

Reconnaissance and preliminary study of the reservoirs have been carried out

with the help of experts from European Union, International Finance Corporation (IFC) and Solar Energy Corporation of India (SECI), sources added.

Rengali reservoir was chosen for installation of floating solar plants of 500 MW capacity in phases over the next two years. The joint venture between NHPC and GEDCOL has been accepted by the Department of Investment and Public Asset Management of the Union government.

BHITARKANIKA NATIONAL PARK Wildlife poaching, forestland encroachment raise concern

Kendrapara, Oct 5: Wildlife poaching and encroachment of wetland and forestland inside Bhitarkanika sanctuary in Kendrapara district has become a cause of concern for environmentalists and activists, a report said.

The issue came up for discussion at a webinar on wildlife conservation marking the 67th Wildlife Week. It was organised by Odisha Environmental Society here. The meeting was presided over by the Society's president Sundar Narayan Patra. Experts denounced increasing human intervention in the forests of Bhitarkanika.

They pointed out reports of 'Worldwide Fund for Nature' and 'United Nation Environment

Programme' in which it has been said that due to unnecessary human interference many species of wildlife and plantations would soon become extinct. They cited Bhitarkanika as an example of human interference in the wild.

A two-member team from International Union for Conservation of Nature (IUCN) on behalf of UNESCO had visited Bhitarkanika in 2016 to enlist wetland in the World Heritage list. After assessing the core areas of

Bhitarkanika, the team returned. In 2017, the team pointed out in its report about the unnecessary human intervention in the Bhitarkanika core area. They said that prawn gheries,

farming, poaching and encroachments inside the core area of for according World Heritage status to the Bhitarkanika sanctuary. Besides, modern life style in the eco-sensitive zone has been taking a heavy toll on wildlife conservation, they added.

Prasad Pani, Hemanta Kumar Rout, Samarendra Mahali and Laxmidhar Swain pointed out that illegal occupation of forestland has been a major problem in Bhitarkanika while more humans than wildlife are staying inside the sanctuary area.

on forest land. Entry of people in the prohibited area is common. Poaching of wild animals and marine species are routine," they said.

"Prawn gheries are polluting environment. Forestland has been cleared by illegal settlers inside the park. Rearing of domestic animals is causing infection among the wild animals. Besides, Dhamra port and Wheeler Island have a negative impact on wildlife in Bhitarkanika,' they observed.

They voiced concern over the fact that National Waterway-5 will be executed in future while coastal highway will split the wetland into two parts. This will only impact wildlife conservation, they noted.

Deogarh farmer inspires other villagers

NARAYAN DEHURY OF BHEJIKUND VILLAGE HAS BEEN ABLE TO COMPENSATE LOSSES **INCURRED DUE TO FAILED CROPS BY TAKING UP INTEGRATED FARMING**

Deogarh, Oct 5: Though Narayan Dehury is aged at 65 years, he does not consider himself to be old. He belongs to the village of Bhejikud in Nuadihi panchayat under Riamal block in Deogarh district. While his educational qualification is not much, he is renowned as a popular and progressive farmer in this region.

Inhabitants of this village, located amidst the lush green jungles on the hilly region of this tribal-dominated district, mostly depend on paddy farming and local forest produce.

In such a remote village, Dehury has become a source of inspiration and has given a ray of hope to other villagers. The primary means of his earning/livelihood is integrated farming. He has adopted a self-sufficient farming strategy keeping in view the problems and challenges arising out of climate change in the field of agriculture nowadays.

By doing that, Dehury has been able to compensate the losses incurred due to failed crops by cultivating another crop or taking up some other profitable farming.

Using scientific methods, Dehury cultivates paddy on three acres of his



five-acre farmland, and earns up to ₹48,000 per annum. Just after the paddy harvest of kharif season, he grows mustard on two acres, which is otherwise known as rice and mustard intercropping.

Dehury has also taken up fish farming in two ponds dug on an acre of land. Annually, he catches up to 10 quintals of fish on an average and earns about ₹80,000. Apart from this, he also rears Banraj and Kadaknath poultry and earns ₹15,000

per annum by selling eggs and meat. In addition, he earns around ₹40,000 a year by selling the milk of eight jersey cows

Taking advice of the Krishi Vigyan Kendra and with the help of his son Saniay. Dehury has bought an egg incubator and subsequently become the only farmer in the district to supply Kadaknath chicks to people interested in poultry.

Taking an extra effort, Dehury also rears almost 80 ducks and sells their eggs and meat. By taking up strategic integrated farming, he manages to make up for losses even during drought or flood situations. He earns about ₹3 lakh from integrated farming and, thereby, has scripted an inspiring success story.

Wheels of Injustice

The Uttar Pradesh (UP) police claims to be too busy to arrest the son of a Union Minister of State alleged to have run over two protesting farmers. The brutal killings of farmers at Lakhimpur Kheri, Uttar Pradesh, October 3 under the wheels of the motorcade of Union Minister of State for Home Ajay Mishra Teni has drawn national attention. This retaliatory attack forms a set pattern which the BJP government has been following to stonewall protests against its decisions and policies. As it happened on many a previous occasion, this time also, the BJP government in Uttar Pradesh has made the scene of mayhem inaccessible to Opposition politicians and the media.

What is worse in the case of Lakhimpur Kheri is that the Centre has become so insensitive that it has not yet asked the minister involved in the gruesome incident to step down immediately for the sake of fair investigation and justice.

As facts are emerging, the minister himself appears to have set the stage for the bloody showdown which took an ugly turn after the driver of an SUV that was part of the minister's motorcade mowed down the farmers. The driver, some claim it was the minister's son, seemed to have been unnerved by the gathering crowd of protesting farmers and so drove over them.

As observed in a video that has gone viral, the minister provoked the farmers in the haughtiest manner possible warning them of dire consequences if they did not withdraw their nearly year-long agitation against the three controversial farm laws. His words, as heard in the video, only show the scant respect he has for decency. The tone is threatening, to say the least. "This country is of farmers. I am also a farmer, you are also a farmer. If I got down to action, then you would not even have found a way to run away. If the farm laws were bad, the protests would have spread across the country," Mishra purportedly said.

In a way, the Centre's refusal to act against the minister is understandable. For, his words and actions seem to be in consonance with the thinking of his party. It has, by now, made it an integral part of its strategy while dealing with popular protests. It first contemptuously turns down criticism of its policies and laws that it wants to shove down the throats of the people. Thereafter it adopts an ostrich-like policy not to see the reality when protests become stormy. If that does not work, it shows its muscles by making the protests appear a law and order issue. When protesters behave belligerently even after that, attempts are made to brand them as anti-nationals and draconian laws under the Sedition Rules or the Unlawful Activities (Prevention) Act (UAPA) are invoked to browbeat them into surrender. It could achieve some measure of success in the case of civil rights activists whom the government calls 'urban naxals'. When the effort to paint the agitating farmers as collaborators of Khalistani separatists failed, the government adopted the tactic of total indifference hoping that once the movement is pushed out of media headlines, it would die down. However, the farmers have proved to be hard nuts and that they are neither dependent on the media nor on politicians to champion their cause. They have shown a unique way of asserting their right and voicing their protests against what they believe are anti-farmer laws on their own strength. And that seems to have unnerved the government. The brutality at Lakhimpur Kheri is one such manifestation.

The minister may also have been prompted by the anxiety of his party that the protests may adversely affect the party in the coming UP Assembly elections in this region, which is why he seems to have chosen the option of whipping up a fear-psychosis among the farmers. The BJP won all the eight seats in this district in the 2017 Assembly polls which was a remarkable improvement as it had bagged only one seat in the 2012 polls. This district in UP's Terai belt has strong links with agriculture with considerable Sikh population.

Lakhimpur Kheri's demography shows Brahmins as the dominant group, followed by Muslims and Kurmis among non-Yadav OBCs. The farmers here mainly depend on sugarcane production. There are chances that there will be electoral repercussion on five other districts in this belt which together account for 42 Assembly seats. The BJP won 37 of these seats in the 2017 Assembly polls, the Samajwadi Party that contested in alliance with the Congress got four seats and the BSP one.

The BJP seemingly fears the farmers' agitation against the three farm laws may upset its applecart this time around. Hence, the Union Minister of State for Home appears to have used intimidation as a tool to ensure the BJP can repeat its 2017 performance. The Centre's delay in taking action against him and his son involved in the gruesome incident only strengthens suspicion.

TIME FOR A FOOD REVOLUTION

This year, the United Nations is convening a special gathering to raise awareness and elevate public discussion" about how food-system reform can help us to achieve the Sustainable Development Goals. But the world needs much more than a food-systems summit. It needs a food revolution. With nature's capacity to support human life having already reached a breaking point, changing what we put on our plates has become an urgent priority - one that will play a crucial role in determining the future living conditions on planet Earth.

Across G20 countries, the majority (60 per cent) of people know that we must make a rapid transition to renewable energies this decade. Not only are the necessary technologies increasingly available and affordable; pressure from both civil society and the financial sector is growing. Yet only 41 per cent of people recognise that we also need to transform our food systems in this decisive decade. This glaring gap in awareness shows that we need a wake-up call.

For decades, land-based ecosystems have been absorbing around 30 per cent of excess carbon-dioxide emissions, protecting us from the worst climate shocks. But over the last 50 years, we have obliterated at least half of these natural assets. When forests, for example, are destroyed for industrial food production, they do not just stop absorbing CO2; they start emitting it. Assets that were contributing to the planet's resilience suddenly become liabilities that are undermining it. This doublewhammy is why food production now accounts for over one-third of global emissions.

We are tantalizingly close to being on track for a fossil-fuel-free future. But that achievement will mean little to future generations if we do not also transform our broken food system. Just as we are pushing fossil fuels into retirement (while thanking them for all they have done for us), so too must we phase out industrial agriculture.

Industrial agriculture was designed for the noble purpose of feeding a growing population. But it is no longer fit for that purpose. In addition to its massive contribution to global warming – which

will cause more crop failures, driving up hunger – the current system results in massive levels of food waste, the monopolisation of seeds (which leaves smallholder farmers at the mercy of multinational corporations), the degradation of once-fertile soils, poisoned waterways, and catastrophic biodiversity loss. All this amounts to an injustice that we can no longer tolerate. Ultimately, if we fail nature, we fail on climate, and

we fail ourselves. Many people recognise that we are approaching dangerous climatic tipping points, and most -82 per cent across G20 countries want change that protects nature. So, let's show them what that would look like. This year's Food Systems Summit is an opportunity to build momentum in some of the biggest priority areas of food-system reform. For example, we urgently need to make regenerative farming the dominant model globally. This form of agriculture relies on farming and grazing practices that nurture the soil, rather than killing it.

Furthermore, to continue to meet the nutritional demands of

the world's population, we also need to expand where food is grown. Agriculture can be practiced in every space available, from rooftops, balconies, and converted car parks to fields and home gardens. And, finally, we need to ensure that people understand that what we eat can contribute directly to our own well-being, as well as that of the planet.

The good news is that we're not starting from scratch. The EAT-Lancet Commission has already scientifically defined a diet that would nurture both people and the planet. This diet, which is readily available to people around the world, features a drastic reduction in meat consumption and a commensurate increase in plantbased proteins.

Plant-based proteins are to the food sector what renewables are to the energy sector. Safe, tasty, and increasingly affordable and accessible, these proteins will soon proliferate widely, in part because investors already see their market potential. By 2040, children will be horrified to learn that we used to mass-produce and slaughter animals in factory farms, just as they will be incredulous that we used to drive around in cars that spewed toxic fumes into the air.

Another piece of good news is that we are quickly strengthening our understanding of the relationship between soil health and food production. We already know how to improve crop rotations, and we are expanding the use of water-harvesting systems and conservation-based agriculture. This allows us to move away from ploughing that irritates the soil and releases carbon emissions.

Moreover, the Land Institute is developing new forms of perennial – rather than annual – staple food crops. Instead of having to sow their seeds every year; farmers will be able to harvest the same plant for four, five, or six years in a row. And because these perennial crops have root systems that run deeper than those of annual crops, they are more resilient and absorb more carbon in the soil. They also require much less diesel in the tractor.

We know that we can move quickly as a global community when we need to. The pandemic has taught us that rapid change is possible. Now, we must bring the same urgency (and even more follow-through) to fixing our relationship with food and how we produce it. Our food system is our most essential life-support mechanism. But we won't be able to transform it in time if only a minority of us are even aware of the challenge.

This year's summit is an opportunity to raise awareness. But it should be understood as only one step along the way. We can each take an additional step with every meal we share. Changing what we eat is a radical act that will make us and nature healthier and happier. By making nature-conscious eating choices and helping to spread the word, each of us can contribute to keeping planetary warming within the 1.5° Celsius limit laid out in the Paris agreement. A healthier plate makes for a safer planet.

Pharmacogenomics

t's well known that patients do not all react the same to a given drug. The range is so wide that some do not respond at all, or only adversely, to drugs which are perfectly adequate for others. It seems that much of the variation is due to small differences in our individual genetic make-ups, often on only a single element of our DNA (called single nucleotide polymorphisms, thankfully abbreviated to SNPs, pronounced snips). The new field of pharmacogenomics builds on the detailed research now being conducted to determine the exact sequence of DNA in our bodies (the human genome), and on the advanced genetic tools now becoming available. The aim is to work out what the differences between patients' DNA mean for drug efficiency and to create suitable diagnostic tests Pharmacologists can then produce drugs that are tailored for patients with a particular genetic sequence and ensure that patients who are susceptible to the side-effects of a drug are not given it. The word is a combination of pharmaco-, the prefix that relates to the study of medicines or drugs, with genomics, itself a word too new for most dictionaries, meaning the formal study of the genetic make-up of organisms. Within a decade, pharmacogenomics and DNA-chip technology could provide effective drugs personalised to match patients' symptoms with their individual genetic make-ups (Daily Telegraph, Feb. 1998). The real push toward pharmacogenomics may be driven by managed health care. A diagnostic test, even if it does add cost, could avoid the expense of today's trial-anderror methods of making multiple doctor's visits to have a prescription adjusted (Scientific American, Oct. 1998).

Vaccine rules

'Card-clone' gang busted

Accused from Haryana used to copy details of debit cards and dupe the unsuspecting

Bolangir, Oct 5: Bolangir police arrested Tuesday three members of a high profile ATM looting gang of Haryana. They had been duping depositors with cloned cards.

The accused were identified as Sanjeeb, 42, Sumit, 22, of Rohatak and Kuldip, 34, of Lohchab village in Jind district of Haryana. A skimmer and cloning machine, cash worth ₹37,000, 14 ATM cards and three mobile phones were seized from their possession.

However, another accused in the case managed to give the slip to police. This was stated here by Sadar SDPO Tophan Bag at a press meet held at the Town police station, Tuesday. Town police IIC Privanka Routray and sub-inspector Purnima Oram were present during the press conference.

The three were arrested in a joint operation by the Bolangir and Titlagarh police.

The incidents of duping came to the fore when R Sabyasachi Panda, a resident of Tikrapada in this town was withdrawing money from an Axis Bank ATM near the market, Monday. Panda raised alarm after one of the accused tried to swipe his debit card on a small de-

vice on the pretext of helping him withdraw money from the ATM.

Reports said, Panda had withdrawn ₹10,000 and again tried to withdraw another ₹10,000 which failed. On the pretext of offering help, the accused Sumit, who entered the kiosk, tried to insert Panda's card into a swipe machine which he was carrying. Panda confronted him but

Sumit threatened him and tried to escape. Locals rushed to the spot and and overpowered Sumit. They handed him over to the police. Subsequently, a joint police team tracked the mobile phones of the other accused. One was nabbed from near Deogaon and the third from the Titilagarh

railway station. However, another member of the gang managed to escape, said Bag.

A machine cloning debit cards seized

The SDPO informed the three accused used to steal money from the accounts of people by cloning their cards through skimming machines. "The gang members have sound technical knowledge. They would collect data from the debit cards of people by using another machine connected via Bluetooth With the information, they used to prepare cloned cards," Bag said.

Later, the gang members would manage to obtain the secret PIN and later withdraw money using the cloned cards. Further investigation into the case is underway, police said.

Thiruvananthapuram, Oct 5: The Kerala Assembly Tuesday witnessed trading of charges between the ruling and treasury benches over the now arrested fake antique dealer Monson Mavunkal with Chief Minister Pinarayi Vijayan stating that no one will be spared.

Vijayan added that the Archaeological Survey of India and DRDO have been asked to probe the validity of the antiques which are in possession of Mavunkal.

Vijayan was replying to an adjournment motion moved by Congress legislator PT Thomas, who linked the role of recently retired State Police chief Loknath Behra and a Kerala woman (Anita Pullalyil) hailing from Trissur, now settled in Italy in the fake antique case.

Thomas asked in the House, "How come this lady was present in key conferences of the Kerala Police and also of the Kerala government." He alleged that she was the link between Mavunkal and the government.

Replying to this Vijayan took a dig and without naming anyone. said. "All in Kerala know who was the one who had gone and stayed there for treatment. I am not going into all such details now. Everything is now being probed by the police, said Viiavan.

The divine inter-state journey that keeps alive a century-old tradition

Thiruvananthapuram, Oct 5: The Gods came out of their respective shrines in Tamil Nadu and embarked on a grand journey Sunday to reach Kerala.

The Covid protocols forced them to shun their usual ceremonial vehicles but their procession is expected to reach here this evening as scheduled, covering several kilo metres by road and accepting ritualistic welcome by devotees and the guard- of-honour from the armed police at the borders.

The arrival of these three sacred idols from Tamil Nadu has been marking the beginning of the annual Navratri festivities in Kerala capital for nearly two centuries. For the last over 180 years, the idols of 'Saraswathy', the Goddess of knowledge and art, 'Kurmaraswami', the warrior deity

and 'Munnootti Nanga' who symbolises the power worship, have been travelling the distance to mark the festival here as part of a practice that existed in the erstwhile princely state of Travancore (present south Kerala). The idols atop the decked up vehicles would cover a distance of 100 kms between Kanyakumari and the Kerala capital, to and fro.

This year's nine-day Navratri festivities will get underway here October 6. Adithya Varma, a member of the Travancore royal family, said it was the visionary king Swathi Thirunal who had introduced the practice of bringing the idols here in 1839.

All the three idols were brought from Kanyakumari district of neighbouring Tamil Nadu, which had been part of Travancore during the pre-independence royal era. When Kerala was formed



Girl injured

Srinagar: A girl was injured in an acid attack on Tuesday in J&K's Shopian district, police said. Bahraich/Lakhimpur Kheri (UP): The Uttar Pradesh authorities Tuesday agreed to the demand for a second post-mortem of a farmer killed in the Lakhimpur Kheri incident after his family refused to cremate him, while mortal remains of the three others were consigned to flames at their native places during the day. Family members of Gurvinder Singh (22) of Moharia village of Bahraich had refused to cremate him till a second autopsy is done, claiming that he was shot dead. They received support from farmer leader Rakesh Tikait and Punjabi singer Sonia Maan, who arrived in the village Tuesday evening. Senior district administration officials confirmed that the second post-mortem of Gurvinder will be conducted at the district hospital. They said a vehicle has been sent to bring the body to the hospital post-mortem house. A team of experts has arrived at Bahraich district police line from capital Lucknow by helicopter for the autopsy, they said.

New Delhi, Oct 5: The Election Commission Tuesday assigned new election symbols to the two warring factions of the Lok Janshakti Party (LJP) -- one led by Chirag Paswan and the other by Pashupati Kumar Paras -- days ahead of the Assembly bypolls in Bihar.

The Chirag Paswan-led faction will now be recognised as Lok Janshakti Party (Ram Vilas) with a 'helicopter' symbol while the faction led by Paras will be called the Rashtriya Lok Janshakti Party with a 'sewing machine' symbol. Chirag Paswan and his uncle

Pashupati Kumar Paras have been at loggerheads with each other since June this year over staking claim to the LJP. On Tuesday, the EC made its decision public and settled the matter.

Since June this year the factions led by Chirag Paswan and Pashupati Paras have challenged each other's claims over the party. Both the factions had written to the EC claiming that the 'bungalow' symbol was their respective election symbol. Chirag had told the EC that the Pashupati Paras-led faction had illegally taken charge of the party. Following this, the EC had issued a statement saying "None of the two party factions of the Lok Janshakti Party - LJP (Paswan) and LJP (Paras) -- will be allowed to use the election symbol of the party. At present, both the factions have been given permission as an interim measure with the names of their factions and poll symbols may be allotted to their candidates." Both the factions of the LJP

elections at 284 polling booths. Out of the total booths, four were marked as extremely sensitive, 144 sensitive and 136 normal booths.

Out of the total 2.30 lakh registered voters in the state capital Gandhinagar, approximately over 56 percent exercised their democratic right to elect 44 councillors from 162 candidates across 11 wards of the GMC.

Of the 2.81,897 voters, 1,58,354 exercised their franchise on Sunday. with 86,046 male voters and 72,308 female voters. The least polling was registered in the Panchdev temple ward, in the heart of the city, with approximate 37.41 per cent and the maximum was registered in the Kolawada-Vavol ward with approximate 66.93 per cent polling.

New Delhi, Oct 5: The World Health Organization (WHO) will meet next week with an independent group of experts to take a final decision on whether to grant Emergency Use Listing (EUL) to Covaxin.

The WHO will carry out the risk and benefit assessments next week with the experts and take a final call on granting the muchawaited EUL to Covid vaccine Covaxin.

The global health body said, 'WHO and an independent group of experts are scheduled to meet next week to carry out the risk/benefit assessments and come to a final decision whether to grant Emergency Use Listing to Covaxin.'

It added that the EUL process of WHO and the technical advisory group of independent experts is centred on determining if a manufactured vaccine is quality-as-

sured, safe and effective.

Indigenous vaccine Covaxin. which has been developed by Bharat Biotech, has not received emergency use approval from the WHO.

The Strategic Advisory Group of Expert on Immunization (SAGE) met earlier on Tuesday to decide on Covaxin getting EUL authorisation

However, as no decision could be reached, the global health body will meet again next week to decide on the same

The expert panel started its fourday meet Monday to decide on policy guidance.

The SAGE and the technical advisory group are supposed to go through all the vaccine dossiers submitted to the WHO before deciding on granting EUL to Covaxin.

The WHO has so far included only six Covid vaccines in its EUL list that includes the Oxford-AstraZeneca vaccine, manufactured as Covishield by the Serum Institute of India.

The top court made these observations while quashing an FIR filed against a physical training

teacher of a school on charges of abetment to suicide. A grade 9 student had died by suicide and left a note blaming the teacher. The mother lodged an FIR alleging that her son committed suicide due to mental harassment meted out by the teacher.

"Insofar as, the suicide note is concerned, despite our minute examination of the same, all we can say is that suicide note is rhetoric document, penned down by an immature mind", noted the bench. The bench said a criminal trial is not exactly a pleasant experience and the appellant who is a teacher would certainly suffer great prejudice, if he has to face prosecution on absurd allegations of irrelevant nature.

The teacher had found the boy regularly bunking classes, initially he reprimanded him but on account of repeated acts, brought this fact to the knowledge of the principal, who called the parents on telephone to come to the school. "No further overt act has been attributed to the appellant either in the First Information Report or in the statement of the complainant, nor anything in this regard has been stated in the alleged suicide note", the bench noted, setting aside the Rajasthan High Courtjudgment, which refused to quash the FIR against the teacher.



A SHOCKING FRENCH REPORT '3.3 lakh kids victims of church sex abuse'

Paris, Oct 5: A major French report released Tuesday found that an estimated 3,30,000 children were victims of sex abuse within France's Catholic Church over the past 70 years, in France's first major reckoning with the devastating phenomenon.

The president of the commission that issued the report, Jean-Marc Sauve, said the estimate, based on scientific research, includes abuses committed by priests and others clerics as well as by non-religious people involved in the church. He said about 80 per cent are male victims. "The consequences are very serious," Sauve said. "About 60% of men and women who were sexually abused encounter major problems in their sentimental or sexual life."

The 2,500-page document prepared by an independent commission comes as the Catholic Church in France, like in other countries, seeks to face up to shameful secrets that were long covered up. The report says an estimated

3,000 child abusers — two-thirds of them priests — worked in the church during that period. Sauvé said the overall figure of victims includes an estimated 216,000 people abused by priests and other clerics. Olivier Savignac, head of vic-



tims association "Parler et Revivre" (Speak out and Live again), who contributed to the probe, told The Associated Press that the high ratio of victims per abuser is particularly "terrifying for French society, for the Catholic Church." The commission worked for 21/2 years, listening to victims and witnesses and studying church, court, police and press archives starting from the 1950s. A hotline launched at the beginning of the probe received 6,500 calls from alleged victims or people who said they knew a victim. Sauvé denounced the church's attitude until the beginning of the 2000s as "a deep, cruel indifference toward victims." They were "not believed or not heard" and sometimes suspected of being "in part responsible" for what happened, he deplored.

The report comes after a scandal surrounding now-defrocked priest Bernard Preynat rocked the French Catholic Church. Last year, Preynat was convicted of sexually abusing minors and given a five-year prison sentence.

Dubai, Oct 5: The United Arab Emirates Tuesday announced plans to send a probe to land on an asteroid between Mars and Jupiter to collect data on the origins of the universe, the latest project in the oil-rich federation's ambitious space program.

A successful landing would see the UAE join an elite club of the European Union, Japan and the United States, which have completed the feat.

The probe would remain behind on the asteroid, transmitting back



to Earth information on the composition of the asteroid as long as its batteries remain charged.

The project targets a 2028 launch with a landing in 2033, a five-year journey in which the spacecraft

The spacecraft would need to slingshot first around Venus and then the Earth to gather enough speed to reach an asteroid some 560 million kilometers (350 million miles) away.

It's still under discussion what data the Emirates will collect but the mission will be an even greater challenge that previous ones, given the spacecraft will travel both near the sun and far from it, said Sarah al-Amiri, the chair of the UAE Space Agency and a minister of state for advanced technology.

Power plants left with less than 4 days of dry fuel stocks

New Delhi, Oct 5: Ahead of the festival season, coal supply crisis seems to be deepening as 64 non-pithead power plants are left with less than four days of the dry fuel stocks.

The latest report on coal stocks for power plants from the Central Electricity Authority (CEA) also showed that 25 such power plants had coal stocks for less than seven days as on October 3.

As many as 64 non-pithead thermal power plants had less than four days of stocks of the dry fuel. The CEA monitors coal stocks at 135 power plants that have a cumulative generation capacity of 165 GW on a daily basis.

Overall, total coal stocks of 78,09,200 tonnes were available at the 135 plants as on October 3 and that was sufficient for four days. The daily coal requirement of the 135 power plants with 165 GW of installed capacity is 18,24,100 tonnes. Among the 135 plants, not even a single one had eight or more days

of coal stocks According to the report, there were seven non-pithead plants (where the coal mine is more than 1,500 kilometres away) which had



less than five days of coal (super critical) while one such plant had less than nine days of stocks of dry fuel (critical).

Invest in EVs, charging pods: Govt to Coal India

Chennai, Oct 5: India's coal ministry has asked state-run Coal India to diversify its interests to areas such as electric vehicles and charging stations, according to an agenda document on the ministry's website.

'Coal India must diversify its business and must explore prospects in sunrise industries electric charging pods, electric vehicles etc," the coal ministry said in a document titled "Ministry of Coal's agenda for 2021-22"

Coal India is the world's largest coal mining company by production and accounts for over 80% of India's output of the fuel.

India is the second-largest importer, consumer and producer of coal, and has the world's fourthlargest reserves. It mainly imports from Indonesia, Australia and South Africa.

The federal government-controlled miner has already an-



nounced plans to invest in solar wafer manufacturing and power generation, coal gasification, extraction of coal bed methane and setting up aluminium smelters.

India has also asked the miner to consider participating in foreign tenders seeking coal after meeting domestic demand.

"Traders/coal consumers of the neighboring countries can also participate in the Special Spot e-auction / Spot e-auction windows of Coal India," the document read.

The ministry also said a "robust media campaign" was needed for "perception management in the coal sector," adding that plans submitted by Coal India and its units were being finalized.

Indian utilities are currently scrambling to secure coal supplies as inventories hit critical lows after a surge in power demand from industries and sluggish imports due to record global prices push power plants to the brink

DoT mulls withdrawing cases against telcos

New Delhi, Oct 5: The government is considering withdrawing legal cases against telecom companies, involving disputes of about ₹40,000 crore, according to a source. In line with this, the Department of Telecom has already filed an affidavit before the Supreme Court in a case against Anil Ambanipromoted Reliance Communications to take an informed decision whether to proceed with the present appeal or not, the

source said. DoT has said the telecom sector is passing through a financial stress due to various circumstances and telecom services providers are making losses

It has sighted representation from the Indian Banks' Association that adverse developments in the telecom sector may lead to failures, vanishing competition, duopoly, unsustainable operations and severe loss for the banking system which has a huge exposure to this sector.

...The central government is desirous of reviewing and/or reconsidering its decision to proceed with the present proceedings of appeal. It is submitted that con-



sidering the nature of issue involved, this decision will have to be taken after the scrutiny at various levels which may consumer some reasonable time," the affidavit dated October 4 said. According to the government, the

amount involved in the cases imposes financial liability to the tune of ₹40,000 crore approximately on various telecom operators.

DoT has asked the Supreme Court for three weeks' time to enable "the central government to take an informed decision whether to proceed with the present ap-

peal or not" and requested that the case be adjourned for a period of four weeks. The government September 15 had announced relief for telecom operators by giving them more time to pay dues and interest on penalties in the form of equities.

Cyril Amarchand Mangaldas partner Sameer Chugh said DoT seeking time from the Supreme Court to review and reconsider its decision to proceed with the appeal against the order of the TDSAT in case of RCom seems yet another step to rectify the past anomalies.

Govt amends rules to allow 50% sale of coal from captive mines

New Delhi, Oct 5: The government Tuesday said it has amended rules with a view to allow 50 per cent sale of coal from captive mines.

The move is likely to benefit over 100 captive coal and lignite blocks with over 500 million tonnes per annum peak rated capacity as well as all coal and lignite bear-

ing states. "The Ministry of Coal has amended Mineral Concession Rules. 1960 with a view to allowing sale of coal or lignite, on payment of additional amount, by the lessee of a captive mine up to 50 per cent of the total coal or lignite produced in a financial year, after meeting the requirement of the end use plant linked with the mine," the coal

ministry said in a statement. Earlier this year, the Mines and Minerals (Development & Regulation) Amendment Act had been amended to this effect.

This is applicable for both the private and public sector captive mines. With this amendment, the gov-

ernment has paved the way for releasing of additional coal in the

market by greater utilisation of mining capacities of captive coal and lignite blocks, which were being only partly utilised owing to limited production of coal for meeting their captive needs.

Availability of additional coal will ease pressure on power plants and will also aid in import-substitution of coal.

The allowance for sale prescribed quantity of coal or lignite shall also motivate the lessees to enhance the production from the captive mines

Further, payment of additional premium amount, royalty and other statutory payments in respect of the quantity of coal or lignite sold shall boost the revenue of the state governments.

The government has also made provisions for grant of mining lease to a government company or corporation for coal or lignite for a period of fifty years.

Grant of mining leases for a period of fifty years shall boost seamless continuous production of coal or lignite by the government companies or corporations contributing to the coal/lignite security of the nation.

New Delhi, Oct 5: India Tuesday pulled out of next year's Birmingham Commonwealth Games' hockey competition, citing COVID-19 concerns and UK's discriminatory quarantine rules for travellers from the country, a day after England's withdrawal from the junior men's World Cup in Bhubaneswar over similar reasons.

Hockey India President Gyanandro Ningombam communicated the federation's decision to Indian Olympic Association (IOA) President Narinder Batra in a letter Hockey India reasoned that there

(July 28-August 8) and the Hangzhou Asian Games (September 10-25). HI said it can't risk sending its

players to the UK, which has been one of the worst affected by the coronavirus pandemic.

"You will appreciate that the Asian games is the Continental qualification event for the 2024 Paris Olympic Games and keeping the priority of the Asian Games in mind, Hockey India cannot risk any members of the Indian teams contracting COVID-19 during the Common wealth Games," Ningombam wrote.

"Therefore, Hockey India will not be sending its men and women teams to Commonwealth Games 2022 and are informing you in advance to kindly notify the Organisers to identify reserve teams."

The UK recently refused to recognise India's COVID-19 vaccination certificates and imposed a 10-day hard quarantine on travellers from the country even if they were fully vaccinated.

The discrimination was prominently mentioned in Ningombam's letter to the IOA President, who has issued instructions for co-ordination with the sport's world governing body FIH for the details of the reserve teams. Batra heads the FIH as well.

"Such discriminatory restric-



tions were not imposed on Indian athletes and officials during the recent Tokyo Olympic Games and this 10-day quarantine requirement for vaccinated sports persons will affect their performance," Ningombam stated. "We feel these restrictions are biased against India and term it as very unfortunate," he said.

HI's move comes a day after England pulled out of the junior World Cup to be held in Bhubaneswar next month, citing a number of COVID-related concerns and taking "note" of the Indian government's mandatory 10-day quarantine protocol for all UK nationals. India imposed reciprocal curbs on all British nationals arriving in the country after UK's steadfast refusal to reconsider its restrictions.

Under India's new norms, all British nationals arriving here from the UK, irrespective of their vaccination status, will have to produce the result of the RT-PCR test done within 72 hours before travel.

They will also have to undertake two more RT-PCR tests, one on their arrival at the airport in India and the second one on Day 8 after arrival.

The Birmingham CWG would have been first big event for both the teams after their inspirational performances at the Tokyo Games, where the men's team won a bronze while the women finished a creditable fourth.
