Fuel price hike for 7th day in a row

New Delhi/Bhubaneswar, Oct **9:** There is no respite from skyrocketing fuel prices as the petrol and diesel in the Capital city touched ₹104.75 and ₹100.84 following a 31 paise and 36 paise rise.

The price of petrol in Delhi rose to its highest-ever level of ₹103.84 a litre and ₹109.83 per litre in Mumbai, the notification showed

As per sources, Mumbai Saturday became the first metro city in the country to see diesel prices cross the ₹100 per litre mark after fuel prices were hiked again.

Petrol price was hiked by 30 paise per litre and diesel by 35 paise a litre, according to a price notification of state-owned fuel retailers. The fifth straight day of price hike pushed fuel rates to a new record high.

In Mumbai, diesel now comes for ₹100.29 a litre; while in Delhi, it costs₹92.47. Prices differ from state to state depending on the incidence of local taxes

Shedding the modest price change policy, state-owned fuel retailers have since Wednesday started passing on the larger incidence of cost to consumers. For four days in a row, the price of petrol has been hiked by 30 paise a litre and diesel by 35 paise, the biggest rally in rates.

Accused Ashish Mishra was taken in custody on grounds of non-cooperation and evasive replies, says SIT chief

Lakhimpur Kheri/New Delhi, Oct 9: After intense pressure was mounted on the Uttar Pradesh government starting from Supreme Court's dissatisfaction over the action taken against the accused and relentless agitations by farmer outfits and the opposition, Union Minister of State for Home Ajay Mishra's son Ashish Mishra 'Monu' was arrested Saturday night after over 11 hours of grilling in connection with the Lakhimpur Kheri violence which left eight people, including four farmers, dead.

DIG Upendra Agarwal, who is heading the special investigation team (SIT) of Uttar Pradesh Police probing the case, told reporters that Ashish Misra was not cooperating during the interrogation.

"We are taking him in custody on grounds of non-cooperation and evasive replies. He will be produced in court and sustained custodial interrogation will follow," he said. Ashish was named in an FIR following allegations that he was in one of the vehicles that

mowed down four farmers protesting over UP Deputy Chief Minister Keshav Prasad Maurya's visit last Sunday.

Farmer leaders and opposition parties had been demanding Mishra's arrest but the minister and his son had denied the allegations.

Two BJP workers and their driver were allegedly lynched by angry farmers in the incident. Local journalist Raman Kashyap also died in the violence, which has triggered a political storm and but the BJP government on the back foot in poll-bound Uttar

Mishra appeared before the SIT at around 10:30am after a second summons was served to him the previous day when he did not turn up for interrogation. He was arrested at around 11pm after being grilled by the SIT at the crime branch office in the Police Lines.

Security personnel were deployed in strength and barricades put up in the area around the police line. Mishra is being kept in the interrogation room and will be produced before the court after medical examination, police sources said.

Bhubaneswar, Oct 9: Chief Minister Naveen Patnaik Saturday inaugurated projects worth ₹136 crore and laid foundation stones for other projects worth ₹570 crore (Rs 706 crore in toto) for Deogarh district through videoconferencing from here.

On the occasion, the Chief Minister said 87 high schools in Deogarh district will be modernised under 5T Initiative, while all the three blocks of Deogarh will get piped drinking water under three mega projects.

He laid the foundation for a drinking water project meant for Deogarh municipality and a 300-bed hospital in the district. A budget of ₹115 crore has been earmarked for the hospital project and the people of the district will get quality healthcare services at the hospital, Patnaik said. LOW PRESSURE TO ORM IN 48 HOURS

Bhubaneswar, Oct 9: A low-pressure area (Lopar) is very likely to form over the north Andaman sea during the next 48 hours, said the India Meteorological Department's (IMD) Bhubaneswar Centre here Saturday. "The cyclonic circulation

over north Andaman Sea & neighbourhood persists and now extends upto 5.8 km above mean sea level. **BREWS** Under its influence, a low pressure area is very likely to form over the same region during the next 48hours," the IMD said in a bulletin Saturday.

The system is likely to become more marked and move west-northwestwards towards south Odishanorth Andhra Pradesh coasts during subsequent 4-5 days, it said.

However, the IMD has not revealed whether the low pressure area will be converted into a cyclonic storm or not.

On the other hand, private weather forecasting agency, Skymet said, "A low-pressure area will develop over the North Andaman Sea by October 10 and may become more marked. Conditions are favorable for this weather system to intensify into a cyclone." If the cyclone forms, it will be named as

Jawad and it is expected to move towards the south and north Andhra coast. The agency also pre-

dicted another weather system over South China Sea which will eventually re-emerge in Eastern parts of the Bay of Bengal by October 15 or 16. The second low pressure area will also follow an al-

most similar path and move towards the east coast of the country, the Skymet said. Most of the weather systems which develop in Bay of Bengal usually affect north Andhra Pradesh, Odisha or West Bengal and

Washington, Oct 9: It looks much like the rest of the furniture in the US Senate, but one desk harbours a secret power giving it the unique capacity to unite the deeply-divided chamber - it's full of sugary treats.

The 'candy desk' - replete with chocolates, sticky lollies and other goodies capable of sweetening even the most laborious voting session - has been legislators' guilty pleasure for more than 50 years.

Situated near a busy entrance on the Republican side, this saccharine stockpile requires a storekeeper

of sorts to ensure it's always full. During periods of intense negotiation, like the scrummage over spending and debt that has preoccupied senators in recent weeks. it is a responsibility that the nation's legislators take seriously.

"I can assure you that the candy desk is now, and will continue to be, well stocked," the current incumbent, Pennsylvania's Pat Toomey, told AFP. You'll have to take the Republican senator's word for it, as



pictures of the mahogany bureau, with its writing box, bookshelves and ventilation grills, are extremely rare thanks to a Senate rule pro-

scribing photography. The idea of the candy desk isn't





Daily recoveries keep surpassing new cases

Odisha had registered 524 fresh Covid-19 infections Friday, against which, 598 people recovered from the highly infectious disease

Bhubaneswar, Oct 9: Odisha Saturday registered 526 new Covid-19 cases, just two more than the previous day, which pushed the state's tally to 10,31,044, a Health department official said.

The new cases, which were detected in 25 of the state's 30 districts, included 68 children. The rate of infection among the children and adolescents in the age group of 0 to 18 years was recorded at 12.92 per cent against Friday's 14.31 per cent.

Of the 526 new cases, 303 were reported from different quarantine centres, while the remaining 223 were local contact cases. Khurda district, of which state capital Bhubaneswar is a part, recorded the highest number of new (233) cases, followed by Cuttack (63). Both the districts accounted for 56.27 per cent of the single day new cases, he said.

Five districts - Boudh, Dhenkanal,

Keonjhar, Nabarangpur and Nuapada, did not register any new cases in the last 24 hours. The daily test positivity rate (TPR) of Odisha stood at 0.77 per cent against Friday's 0.78 per cent.

The Health and Family Welfare (H&FW) department informed that the state, during the last 24 hours, reported four fresh deaths which pushed Covid-19 fatalities to 8,242. The latest Covid deaths have been reported from Nabarangpur (2), Jagatsinghpur (1) and Bolangir (1). This apart, 53 other COVID-19 patients have died due to comorbidities, the department said.

The coastal state currently has 5,035 active Covid-19 cases, while as many as 10,17,714 patients including 598 Friday, have recovered from the highly infectious disease.

Thus far, over 2.05 crore sample tests have been conducted, including 68,264 Friday, for Covid-19. The state's cumulative positivity rate stands at 5.01 per cent.

Implement PM SVAMITVA in state pronto: Pradhan urges CM

Bhubaneswar, Oct 9: Union Education Minister Dharmendra Pradhan has sought personal intervention of Chief Minister Naveen Patnaik for the expeditious implementation of the PM SVAMITVA in Odisha.

Friday, in a letter to the CM, Pradhan said that PM SVAMITVA (Survey of Villages and Mapping with Improvised Technology in Village Areas) aims to provide property rights to the residents of rural inhabited areas.

"As you are aware, the survey of rural land and its record of rights in India are age-old. There also remain many inhabited villages in India including the state of Odisha, where survey of land has not been of property in rural areas of the state do not have requisite legal documentation for their property." the Union Minister's letter read.

Even after decades of Independence, true potential of villages, homes and landed properties in rural areas has remained shackled and often lead to uncertainty and mistrust between neighbours due to the absence of a proper documentation, Pradhan mentioned in his letter. To address the issue, Prime Minister launched the SVAMITVA scheme April 24, 2020. The scheme aims to cover around 6.62 lakh villages of the entire country during 2021-2025, the letter read.

Pradhan further said the scheme has already been implemented in 7,565 villages in the states of Maharashtra, Haryana, Karnataka, Uttar Pradesh, Uttarakhand, Madhya Pradesh, Punjab, Rajasthan, Gujarat, Goa, Andhra Pradesh and Andaman & Nicobar Islands. More than 22 lakh property cards have been prepared till date.

Odisha had signed a Memorandum of Understanding with Survey of India in February, 2021 for implementation of the scheme in Rayagada on a pilot basis.

"The swiftness, with which State revenue and rural development departments act, is critical to the effective and fast implementation of the project. The activities need to be ramped up and the state needs to permit the Continuous Operating Reference Stations (CORS) expeditiously in order to facilitate the survey," he urged Patnaik.

Engg student ends life

CUTTACK: An Engineering student consumed poison after his girlfriend allegedly refused to repay the money that she had borrowed from him for her father's treatment. He died while undergoing treatment at a private hospital in Cuttack late Friday night. The boy was identified as Sritam Kumar Swain, a BTech third year student, who hailed from Paradip but was currently residing in Cuttack. According to sources, Sritam had lent ₹2 lakh to his girlfriend when her father was sick. Recently, the youth asked her to return the money, following which the relationship between the couple strained. Furthermore, the girlfriend's elder sibling allegedly physically assaulted Sritam, He was even threatened with dire consequences if he dared to ask for repayment of loan, Under tremendous stress over the issue. Sritam decided to take the extreme step.He booked a hotel room in Badambadi October 6, where he reportedly consumed poison.

NGT halts setting up of steel plant in Rourkela

New Delhi, Oct 9: The National Green Tribunal (NGT) has put stay on setting up of a steel plant in Rourkela by KAI International Pvt Ltd over the allegations that the company did not have environment clearance.

A bench comprising Judicial Member B Amit Sthalekar and Expert Member Saibal Dasgupta stayed any activity of construction at the site till the company gets environment clearance from the Union Ministry of Environment, Forest and Climate Change (MoEF & CC).

"Considering the fact that so far environmental clearance has not been granted by the MoEF & CC, we direct that no construction and felling of trees shall be made at the site in question by M/s KAI International Private Ltd including boundary wall etc till all necessary



clearances are granted by the MoEF & CC and other authorities, till further order," the tribunal said.

The NGT also asked Odisha to file an affidavit giving the details of the number of trees felled and the cost of trees which have been felled and the action taken by the state government in this direction.

Mahtab, Moquim for better healthcare at City Hospital

Cuttack, Oct 9: Cuttack MP Bhartruhari Mahtab and Barabati-Cuttack MLA Mohammed Moquim Saturday put emphasis on the development of infrastructure at the Cuttack district headquarters hospital (DHH), popularly known as City Hospital.

The duo along with Cuttack Collector Bhawani Shankar Chayani and Chief District Medical Officer (CDMO) Satyabrata Chhotray participated in a review meeting on the healthcare facilities at the hospital.

The meeting emphasised on the renovation of several old buildings of City Hospital. Earlier, a proposal in this regard had been sent to the state government, sources said.

The meeting also discussed various issues with regard to requirement of additional buildings for the ophthalmology department of the hospital. "The state government has sanctioned funds for renovation of a few vacant staff quarters to arrange additional rooms for the eye care department of City Hospital," said an official of the Health department.

The meeting also deliberated upon the installation of a 250KV power grid for the hospital. The authorities concerned have asked

the Cuttack Development Authority (CDA) to identify a suitable place for the power grid.

"At least 80 doctors' posts and many paramedics' posts are lying vacant in Cuttack district. The issue has been raised with the state government," Mahtab said.

On the other hand, Moquim asked the district administration to upgrade the healthcare facilities at the City Hospital. "Lakhs of people from Cuttack city depend upon the hospital for availing healthcare. The hospital should have better facility to meet the requirement," Moquim said.

Chayani informed the meeting that the state government is taking steps to upgrade healthcare facilities in Cuttack. "The construction work of a new building for the City Hospital has begun after due approval from the state government," he said.

The locals, meanwhile, alleged that the healthcare facility at the hospital has been affected by shortage of doctors and paramedics.

"The hospital is yet to get adequate manpower and infrastructure to provide round-the-clock health-care to the people. Very often, the authorities of City Hospital are referring patients to SCB Medical College and Hospital," alleged former corporator Arun Kumar Sethi.

Cyclist on tour spreads message of peace

NGT spanner in Kharasrota project Women become self-reliant by making organic manure

Kendrapara, Oct 9: A National Green Tribunal's order has thrown a spanner in the works of the mega drinking water project under construction on Kharasrota river at Barunadiha in this district, a report said.

A bench of the tribunal comprising Justice B Amit Sthalekar, judicial member and expert Saibal Dasgupta heard the matter October 4 and directed the Union environment secretary, state chief secretary, principal secretary, water resources department. Kendrapara Collector, Bhadrak Collector and principal chief conservator of forests (Wildlife) to file a detailed report on the projects within four weeks.

The bench, while hearing the matter, raised objections on a previous case (23/2020) filed by Sanjay Behura on the affidavit filed by the principal secretary of the water resources department.

Meanwhile, Section-144, clamped by the district administration at

Barunadiha, Balakati and Bharigada panchayats under Rajkanika block, the site of the mega drinking water project, over last two months, will be withdrawn, Sunday.

The prohibitory order was clamped following people's resistance to supply of water from Kharasrota river to Bhadrak for the mega drinking water project. The order by the tribunal has posed problems for the state government and the district administration which are executing the project while people's opposition to the project is intensifying in the area

The water treatment plant is being constructed at Nuahaat under Chandbali block in Bhadrak district while the intake well is under construction on Kharasrota river at Barunadiha under Rajkanika block. The project site at Nuahaat and Barundiha falls under the eco-sensitive zone of the Bhitarkanika National Park.

Khitish Kumar Singh of Khadianga in Kendrapara had filed



a case in September at the NGT that the project is constructed without environmental clearance. In his petition, he claimed that the district administration, which cited the report of Professor Dr Sashadhar of civil engineering department of IIT-Hyderabad on the social and environmental impact of the project, is false.

He claimed that Prof Sashadhar,

in a reply to Rakesh Mohanty of Rajkanika, said he had submitted the report on the basis of secondary data made available to him. He clarified that he had not undertaken any survey in the area nor had engaged any person to conduct the survey on the social and environmental impact arising out of the construction of the project.

Malkangiri, Oct 9: Members of women self-help groups have managed to become self-reliant by earning livelihoods for their families from recycling of waste generated in this town, a report said.

The women recycle the decomposed waste thrown out by the households into organic manure and sell it to farmers for a price to earn their livelihood.

The manure is being used to increase the fertility of the soil of their farmlands. The manure helps them in reducing their dependence on chemical fertilisers. The move has achieved three objectives in helping the women to earn a livelihood, in checking the use of chemical fertilisers on farmlands and in keeping the environment clean.

Reports said, the district resources centre also known as the waste recycling centre is managed by the Malkangiri Municipality. The centre was launched by the civic body at Mundaguda in the

town during the lockdown at an investment of ₹1.5 crore.

Over 10 SHG women are employed in the unit while 40 volunteers are engaged in the battery driven vehicles. The centre produces three to four quintals of organic manure on a daily basis which is sold at ₹20 per kg to various government and private institutions as well as farmers.

Tthe women volunteers and sanitary workers move in the streets of the town in battery driven vehicles and collect the wet and dry wastes generated by the households. They deliver it at the waste recycling centre where SHG women segregate the wet wastes like vegetables, fruits, grass and wastes of similar nature and turn them into organic manures in the micro composting centre. Wet wastes are segregated first and crushed in a machine. Later, the crushed wastes are kept in 14 large containers for 45 days when a mixture of curd and jaggery are added to it. After 45 days, the mixture dries up and

then is crushed in a machine.

Baripada, Oct 9: A patient undergoing treatment at PRM Medical College and Hospital at Baripada was critically injured Friday night after a patch of plaster from the hospital ceiling allegedly fell on him. He died later. The incident triggered discontent among locals who alleged that the patient died due to medical negligence.

Kishorenagar block of Angul district, Saturday

The deceased was identified as Chakradhar Singh, a resident of Podarastia under Shyamkhunta block. Hundreds of locals blocked the Baripada-Udala road at Chipatastia over the death since 11 pm Friday and till Saturday. Alleging medical negli-

gence, they demanded action against



those responsible for the death. Owing to road blockade, vehic-

ular movement on the route came

to a standstill. Reports said, family members of the deceased and co-villagers laid the body on the road Friday night and demanded compensation. The agitation continued till Saturday morning.

Chakradhar was admitted to PRM Medical College and Hospital when he was down with fever. Unfortunately, a chunk of concrete slab fell on him October 3. He was seriously injured. He wasbeing shifted to SCB Medical College and Hospital in Cuttack but succumbed on the way Friday night.

The agitators demanded adequate compensation for his death as the hospital authorities had not ensured the safety of the patient.

In his speech of 8 August 2019 explaining the move to 'deoperationalise' Article 370 (it has not been revoked or removed as is widely assumed), the Prime Minister said the following:

That the development of Jammu, Kashmir and Ladakh was being held back by Article 370. The problem had now been eliminated and a new era had begun. Article 370 was the root of separatism, terrorism, nepotism and corruption. The future had been secured now by this move.

We should examine what has happened in the two years since. The first aspect is that there is no democracy any longer in Kashmir. It is the only part of India to not have elected government and is ruled directly by Delhi through a governor.

The second is that this direct rule is accompanied by the use of laws that are peculiar to Kashmir, such as the Public Safety Act. Under this law individuals can be detained without a crime. This is a Kashmir-specific law though 'one nation, one Constitution' was used as a reason for the Article 370 move

The third is that the total number of people who have bought land in Kashmir in the last two years is only two. The removal of Article 35, which defined permanent residents of Kashmir, was said to be a big reason for India's action, but it does not appear to have changed the position on the ground. Fourth, Kashmiri Pandits have not returned to the Valley. Why an urban and educated community would want to go back to a place with few jobs and often

no internet is easy to understand. When Union minister Meenakshi Lekhi blamed Pandits recently for not showing an interest to return to the Valley, this aspect may not have been understood by her.

Fifth, the change in the status of Ladakh and the issuance of new maps of the Union territory appears to be the proximate cause for China's aggression there. The government has not acknowledged it, but essentially the Chinese have ensured that their 1959 claim line has been imposed on the ground. India continues to have around 2 lakh soldiers on that front. In January this year, the army changed from having 25 divisions facing Pakistan and only 12 facing China to having 16 now face China.

Sixth, terrorism in Kashmir as measured by fatalities in the last three years under Manmohan Singh averaged 150 deaths a year. In the last three years this number is 250 deaths a year. It appears that terrorism is not going down because we have 'deoperationalised' Article 370.

Seventh, there has been no development in Kashmir for the last two years and this is not unexpected. The economy has been in decline across India for several years now. The pandemic and increased violence recently will hit tourism also. The US magazine Harper's reported that Kashmir's doctor to patient ratio was 1 to 3,060, while its troops to civilians ratio was 1 to 7. It is hollow to talk about 'development' when the world confronts you with such numbers.

Eighth, after five decades, the United Nations Security Council took up the issue of Kashmir. August 16, 2019, the UN website carried a news

Ninth, other global bodies have also begun to criticise India for what is going on in Kashmir after 2019. This year, the United States Commission on International Religious Freedom (a bi-partisan body that had previously banned Modi from entering the United States after 2002) said this in its report: "In Muslim-majority Jammu and Kashmir, restrictions on freedom of movement and assembly negatively impacted religious freedom, including the observance of religious holy days and the ability to attend prayers. The shutdown of the internet for nearly 18 months—the longest-ever shutdown in any democracy—and other restrictions on communications caused significant disruption and limited religious freedom." The USCIRF has recommended sanctions against Indian individuals to President Joe Biden.

Tenth, after China's aggressive moves in Ladakh, India sought a ceasefire with Pakistan, which is today holding on the ground. Our reason for acting in Kashmir was because India said Pakistan was the problem. Now India is turning to Pakistan for the solution because apparently the real problem is China.

The reason for writing on this subject at the current time is that we seem to be reverting to the position that Kashmir was 30 years ago. Then, as now, it was under Governor's rule. Its political leadership was kept locked up and sidelined, its people were forbidden from protesting, there was no development and India was forced to deploy large numbers of security forces internally.

We should consider all this honestly and ask ourselves what the benefit of the action that India took in 2019 has brought to us and to Kashmiris.

■ Pharology

Pharology, the scientific study of lighthouses and signal lights, is first recorded in 1847 in the Transactions of the Royal Society of Arts of London. The author of the paper noted it had been "first introduced by the late Mr Purdy". This otherwise unsung gentleman must have had in mind the famous lighthouse, one of the seven wonders of the ancient world, that was erected around 280BC on the island of Pharos, off the coast of Alexandria. The word is well known among those whose hobbyist or professional interest lies in studying or looking after lighthouses. Now that all the British lights are automated, and the job of lighthouse keeper no longer exists, you might think that pharologists have less to interest them. Not so. Many of the lights are in remote locations that required great determination, skill and endurance to construct and special qualities in the men who were isolated on them for a month at a time. In Britain, the Association of Lighthouse Keepers helps keep knowledge of them alive. A rare appearance of the word in literature is in E Annie Proulx's The Shipping News of 1993: "Pharology. Science of lighthouses and signal lights. Dawn knows elevations and candlepower, stuff about flashes and blinks and buoys. Bore you silly with it."

And yet, as Haugen testified, "Almost no one outside of Facebook knows what happens inside Facebook." The KGB would have been envious.

But tech companies also serve a useful purpose. They have built much of the public infrastructure of the digital age, including search engines, global portals for news and social networking, GPS-based navigation apps, online commercial and job marketplaces, and movie, music, and livestreaming platforms.

To enable digital platforms to continue performing a beneficent role, while minimising their harm, governments should require them to secure "digital operating licenses." There is plenty of precedent for this: from grocery stores to nuclear power plants to pharmaceutical manufacturing facilities, traditional businesses must be granted various licenses and permits before they can begin operations, not least to ensure the safety of workers, customers, the environment, and the local community

Likewise, to be granted a digital operating license, tech companies would have to meet certain conditions. The first would be to obtain users' explicit permission before collecting any personal data, using an 'opt-in' consent system instead of an 'opt-out' system that must be periodically renewed.

Since tech companies first developed their business models, users' private data have become their real cash cow. Companies sell

psychographic profiles of users to advertisers and political operatives, who then target them with manipulative content. There have also been leaks. In 2014, for example, the political consultancy Cambridge Analytica harvested information from the Facebook profiles of more than 87 million users – information that it used to try to sway voters. Five years later, Facebook leaked 530 million users' private data.

Tech executives argue that their data grabs benefit users by giving them personalised ads that cater to their individual desires. But how many times do you need to see ads for hiking boots, especially after you have purchased them? The risks of the surveillance-capitalism business model far outweigh the benefits.

The digital operating permit could also require companies to ensure compatibility with 'middleware,' third-party software that helps users to manage their online experience. Software that blocks online advertisements is one example. Another is a smartphone app that allows users to turn data-collection and locationtracking on and off as needed, with the touch of a button. Want to call a taxi? Turn on location tracking so the driver knows where to find you, and then turn it off no more tracking, and no transaction data retained. If this functionality – a limited version of which is now included in Apple's iPhone iOS – becomes widespread, it could upend Facebook's 'datagrab-for-profit' model.

Other middleware could target 'dark patterns' in platform design: engagement tricks like infinite scroll, autoplay, pop-ups, and automated recommendations, which keep users clicking and viewing. Platforms like Facebook deploy such 'behavioral nudges' to ensure that users continue to see ads – the single biggest source of Facebook's \$86 billion in annual revenue.

The digital permit system could also help address Big Tech's monopoly problem. For example, Facebook, with its 2.8 billion users, owns WhatsApp (two billion users) and Instagram (1.1 billion users). But while the growing call for antitrust enforcement has merit, these three platforms would be behemoths even separately.

A digital permit could help reduce the major social-media platforms' market share by imposing strict limits on audience size: each piece of user-generated content could be served to, say, no more than 1,000 people. That is many more people than most users actually know or have regular contact with, so it hardly constitutes a deprivation. Social-media critic Tristan Harris suggests that Facebook turn off its Share/Reshare button after a piece of content is

viewed two 'hops' away from the originator. Facebook knows this approach works: it deployed a version of it during the 2020 US presidential election.

Of course, there would be exceptions, including legitimate news, information, music, and videos from leaders, artists, and thinkers. Tech platforms already have teams of human moderators - Facebook employs 15,000 - who could be tasked with identifying such 'public-interest content.' This approach would reduce the spread of fake news and disinformation by introducing necessary friction in the information flow, and would be a far better use of moderators' time than continuing to play whack-a-lie.

Such a system recognises that platforms like Facebook, Twitter, and YouTube are not merely 'public squares,' but also publishers and broadcasters. As such, they have much more in common with The New York Times, BBC, and The Sun than many analysts have been willing to admit.

In fact, they operate on a much larger scale than any of those outlets. Facebook is the single largest media publisher in history, and YouTube is the largest visual-media broadcaster. One study found that a mere 100 pieces of COVID-19 misinformation were shared 1.7 million times and viewed 117 million times on Facebook.

Social-media platforms have not hesitated to wield their power as publishers. After the ransacking of the US Capitol January 6, they decided to stop 'publishing' then-US President Donald Trump. Earlier this year, Facebook blocked all of Australia from accessing news on its feeds during a dispute over sharing of advertising revenue. Google did the same to Spain in 2014.

Introducing digital operating permits would allow social-media platforms to remain free-speech agoras for smaller assemblies of networked friends, families, and associates, while drastically reducing the virality of fake news and disinformation. That was how Facebook worked in its early years, when it was still a cool invention.

A disaster in the making

The COVID-19 pandemic had led to a decline of our GDP by about 8 per cent last fiscal. This has led the government to borrow large amounts of money. However, this borrowing is not free. It comes with its costs. The government has to pay interest as well as the principal amount in future. At that time, the future government will have to impose higher taxes on the future people to raise the money to pay the interest and the principal amount on the money borrowed in the past.

The government has two options to avoid making such inter-generational injustice. It can impose high taxes today; or it can reduce its expenditure today.

The government imposes taxes on the present generation for raising additional revenue for facing the pandemic faced by the present generation—perhaps due to its own folly.

The second dimension of fiscal deficit is the use of the borrowed money. It can be used in two ways. This can be explained with the example of a businessperson. A businessperson can borrow money to set up a factory. In this case, the factory would produce goods, the businessperson would make profits in future and she could repay the interest and the principal amount out of those future earnings. In such a situation, the businessperson would not impose any burden on the future generations of his family. Such borrowing is prudent because it enables the family to grow at a faster pace than if she had not borrowed and invested. Say, a businessperson has an income of ₹1,00,000. She can borrow ₹3,00,000 and set up a factory of ₹4,00,000 instead of establishing a factory of only ₹1,00,000. The higher income from the investment of ₹4,00,000 could be used to repay the interest and the principal. This would be a happy circumstance. On the other hand, if a businessperson borrows money and goes on a foreign luxury trip or buys a property for setting up an upscale office, then there would accrue no additional income. The businessperson would have to pay interest and principal in future out of the income from the lesser investment of

₹1,00,000. Her income would be less in the future.

The same logic applies to government borrowing. The future income of the country is more if the government borrows money for building, say, a highway. First of all, demand is generated for cement, steel and machinery. The producers of cement, steel and machinery pay taxes to the government. Secondly, employment is generated in the production of cement. steel and machinery as well as the highway construction. The workers, in turn, buy goods from the market and that leads to an increase in demand. Third, the highway enables the goods to reach the destination quicker and at a lower cost. The cost of goods in the market is less and the economy's growth is boosted. There is more productive activity. The government gets more tax revenue and it can repay the loan with the additional revenue. On the other hand, if the government borrows and buys, let us say, Rafale fighter jets, then the demand is generated in France. The geopolitical benefits of Rafale jets do not cancel the economic costs.

Or, if the government uses the borrowed money to pay increased salaries to government servants, then the demand is substantially generated in buying gold and investing in foreign properties because the consumption needs of the government servants is already met with their current incomes. Such expenditures do not generate additional revenue for the government with which the loans could be repaid. The revenues of the government remain stagnant while the burden of interest and repayment of the principal leads to a decline in income in the future.

It is unfortunate that the government has ignored the consequence of its borrowings on future generations and borrowed heavily for maintaining its consumption which will impact the growth of the economy in the coming time and will delay the government's objective of making India a \$5 trillion economy.

Bargarh, Oct 9: Protesting the inordinate delay in the construction of a bridge over Jira river in Bargarh district, members of the Bharativa Janata Party (BJP) Saturday organised a Jal Satyagraha demanding early completion of the project.

They alleged that the construction of the bridge was supposed to be completed by November 2, 2020, but its work has delayed.

Owing to the delay in the construction, thousands of people in the region have been facing commuting problems in Ambapali town in Bolangir, Sonepur, Bijepur, Barpali, Padampur, Gaisilat, Jharband and Paikmal.

In the absence of a bridge, people have to cover a distance of nearly 10 km to reach the town. According to reports, the project was initially taken up at an estimated cost of ₹14 core. However, the cost of the project has now gone up to ₹20 crore due to the continuous delay.

"Even though we have been raising the issue repeatedly and draw-

ing the attention of the state government about the tardy pace of work, no one is listening to us. Through our Jal Satyagraha, we

An iron bridge was built over river Jira in 1930s to connect Odisha with Madhya Pradesh (now Chhattisgarh). After Independence, when national highway plans came into force, the bridge became a part of NH-6. Later, an alternative road (by pass) was developed as a part of the NH.

Once the alternative road came

up, the iron bridge was used mostly to drive in or out of Bargarh town from Ambapali chhak as it cuts the travel distance down by

almost 10 km. However, decades later, lack of maintenance and apathy of the administration hit the iron bridge hard. Besides, it became a preferable spot for thieves to loot commuters. To avoid crime, especially on the bridge, the local administration installed iron barricade pillars on both ends of the bridge to prevent movement of four wheel-

He had searched the Google Play Store to know how many online games are withdrawn. Many companies have blocked their mobile applications except 'Dream 11'.

Under the new law, online gaming is considered a non-bailable offence with a fine of Rs 1 lakh and imprisonment up to three years. Along with banning games of skills, the Karnataka government has categorised online games using electronic means and virtual currency, electronic transfer of funds in connection with any game as gambling.

The new legislation passed in the Monsoon session by both the Houses of the Karnataka Assembly has been approved by the Governor. Mobile Premier League (MPL) was one of the first companies to stall its operations in Karnataka followed by Paytm First Games.

New Delhi, Oct 9: With the mandate of promoting agri-export from Union Territories of Jammu & Kashmir and Ladakh, the Agricultural and Processed Food **Products Export Development** Authority (APEDA) has scripted 'new success stories' as the export of agricultural products of the regions has picked up.

Under the National Programme for Organic Production (NPOP) for exports, the Union Territory of Jammu and Kashmir exported Geographical Indications (GI) certified product Kashmir Saffron from Srinagar to Dubai and other West Asian markets during March-

A few months after the offices of APEDA, a statutory body under the Ministry of Commerce &

Industry, got functional in Jammu and Srinagar in February, a shipment of Mishri variety Kashmir Valley Cherries was carried out from Srinagar to Dubai for the first time followed by commercial shipments creating international market for Indian Cherries during the month of June-July, followed by repeat orders for Indian Cherries, a release from the Ministry said Friday.

In another major boost to export activities in the Valley, shipments of Kashmir Valley fragrance rice Mushkbudji and Acacia honey have been planned and samples have already been sent during August by the Kashmir Valley Start Ups/new entrepreneurs to Lulu Group FMCG Dubai, Oman and other West Asian markets.

Four killed

Damoh: Two brothers, their minor sister and one more person were killed after a truck rammed into a roadside house in Madhya Pradesh's Damoh, police said Saturday. Body found

Pakur (Jharkhand): The mutilated body of a woman in her early twenties was found in Jharkhand's Pakur district Saturday, police said. She was found dead on Hathigarh Dungri Tola Hill in Littipara police station area by a cattlegrazer, who then alerted the locals, who in turn informed the law enforcers, an officer said. The woman is yet to be identified as her head and face was crushed. Pakur Subdivisional Police Officer Aiit Kumar Vimal said. The body has been sent for postmortem examination to Pakur Sadar Hospital to ascertain the cause of death and whether she was raped, he said, adding further investigation was underway.

NCB let three people go: Malik

Mumbai, Oct 9: NCP leader and Maharashtra minister Nawab Malik Saturday alleged the Narcotics Control Bureau (NCB), which had claimed to have seized drugs onboard a cruise ship off the Mumbai coast last week, had initially detained 11 persons but let off three of them, including the brother-in-law of BJP leader Mohit Bharatiya, a couple of hours after the operation.

Bharatiya hit back saying he will file a defamation suit seeking Rs 100 crore in damages against Malik. Addressing a press conference here, Malik, who is NCP's spokesperson. alleged that Bharatiya's brotherin-law Rishabh Sachdeva was among those three persons.

Two others - Pratik Gabba and Aamir Furniturewala - who had brought Aryan Khan, son of Bollywood superstar Shah Rukh Khan, to the cruise party, were released along with Sachdeva two hours after their detention, he said. "The names of Pratik and Aamir figured in the ongoing hearings in the court," Malik claimed. Based on a tip-off that a party was

to take place onboard the ship, an NCB team led by its zonal director Sameer Wankhede had raided the Cordelia cruise last Saturday and claimed to have recovered banned drugs. A total of 18 persons have been arrested in the case, including Bollywood actor Shah Rukh Khan's son Aryan Khan.

The NCP leader demanded that the call records of these three persons along with that of Wankhede be examined. "Rishabh Sachdeva's father and uncle came to the NCB office and telephonic conversations happened between Wankhede and the BJP leaders in Mumbai and Delhi from the phone of Sachdeva's father," Malik claimed. 'Why were the phones of these three persons not seized?" he asked. According to Malik, the Mumbai police were also given information that 11 persons had been detained from the cruise ship. Malik had alleged that the NCB's

raid on the cruise was "fake, planned and conspired to defame the film industry and the Maharashtra government". "Selective people have been arrested...The matter is serious. CCTV footage should be taken and a detailed inquiry should be conducted," the minority affairs minister alleged. He also hit out at the BJP for attacking him over his allegations."The BJP says that I am attacking the NCB since my son-inlaw was arrested by the agency. I have never supported my son-in-law and he will fight his case. How can I give information I have in this case to the NCB which has framed a false case. If an independent commission is set up to conduct a probe,

New Delhi, Oct 9: Chief of Army Staff Gen MM Naravane Saturday did not rule out the possibility of Afghan-origin foreign terrorists attempting to infiltrate into Jammu and Kashmir once the situation stabilises in Afghanistan as he cited similar instances when the Taliban was in power in Kabul over two decades ago.

At the same time, he said Indian armed forces are prepared to deal with any eventuality as they have a very strong counterinfiltration grid as well as a mechanism to check terrorist activities in the hinterland in Jammu and Kashmir.

Asked at the India Today conclave whether there was any link between the spate of recent killings of civilians in Kashmir and the Taliban's capture of power in Afghanistan, Gen Naravane said it cannot be said whether there was a connection.

"Definitely, there has been a spurt in activities (in Jammu and Kashmir) but whether they can

be directly linked to what is happening in or happened in Afghanistan, we really cannot say,' the Army Chief said. "But what we can say and learn from the past is that when the previous Taliban regime was in power, that time definitely we had foreign terrorists of Afghan origin in Jammu and Kashmir," he said.

New Delhi: India and China will hold another round of high-level military talks Sunday with a focus on making some forward movement in the disengagement process in the remaining friction points in eastern Ladakh, government sources said. The talks are scheduled to start at 10:30 AM at the Moldo border point on the Chinese side of the Line of Actual Control (LAC) in eastern Ladakh, the sources said on Saturday. The Indian side is expected to seek disengagement as soon as possible in the remaining friction points besides pressing for resolution of issues in Depsang Bulge and Demchok.

Girl kidnapped, gangraped

Dakshina Kannada: The Karnataka police have arrested two persons in connection with the kidnapping and gangrape of a 16-year-old school girl in Dakshina Kannada district of Karnataka Saturday. The incident came to light after the school girl came forward to lodge a police complaint. The victim stated that the accused persons came in a car at about 8.15 a.m. on Friday while she was going to the school near the bus stop in Bantwal town. One of the accused got down from the car and told her that he was her friend. When she said that she did not know him, he maintained that they knew each other through social media platforms. While talking he gave her a bar of chocolate and by the time she put the chocolate in her bag, she fell unconscious, the girl told the police. When she woke up, she was in a bed and the accused took turns to rape her. She lost consciousness yet again and when she regained consciousness, the girl found herself in the car. The accused left her near Bantwal town and the victim reached home after calling her mother, the police said. The police have registered a case under the POCSO Act, arrested two persons in this connection and launched a search for others.

'Climate refugee crisis beckons in India if water scarcity continues'

New Delhi, Oct 9: India can face a climate refugee crisis in the next seven years if water scarcity continues to persist in the country, renowned water conservationist Rajendra Singh said.

'Climate refugee" means increasing large-scale migration and cross-border mass movements of people partly caused by such weather-related disasters. Speaking at the India Today Conclave 2021, water conservationist Singh, who is also known as the "Waterman of India" said the country cannot become 'paanidaar' (water self-sufficient) till a balance between discharge and recharge is maintained.

"And forming this balance between discharge and recharge of water is possible only through com-

munity driven decentralised management," he said. Singh said people are already moving from their villages to cities due to water scarcity. "Europe is seeing climate refugees from many African countries. Fortunately, Indians are not called climatic refugees right now but in the next seven years if the water scarcity in India continues to persist then, Indians will also face a similar situation," he warned.

He questioned what will India's future be like if water banks are emptying because of excessive pumping of groundwater." Already, migration due to water scarcity is taking place and everywhere migration is going on from villages to cities and we should actually call it displacement of people. Now, the situation is such that there is such water scarcity that people **WAKE-UP CALL**

are leaving villages and are not able to return.

"In India, migration due to water scarcity is happening. Cities have water. In agriculture, till skill development and efficient use of water under water literacy movement is not started in the country

till then India cannot end water scarcity," he said.


Bharat Lal, Additional Secretary (Water), Department of Drinking Water and Sanitation, Ministry of Jal Shakti, said the government has launched Jal Jeevan Mission and is working towards recharge, supply and reuse and maintenance of water in the country. "Under the Jal Jeevan mission, communities are involved and our aim is that in due course water, sanitation and hygiene enlightened villages and schools are made. Women led water committees are being made and civil society is being involved to spread awareness," he said.

Singh said the water crisis is a "women's crisis" and the government has formed 3.8 lakh women committees but that is only on paper."... 

Dozens die in Congo capsize

Kinshasa: Over 100 people are dead or missing after nine interlocked canoes sank this week in the Democratic Republic of Congo, officials said Saturday. Sixty-one bodies had been recovered from the sinking during the night of Monday to Tuesday, and another 60 are believed to be missing, Nestor Magbado, a spokesman for the governor of the northwestern province of Mongala, told AFP. He said there were 39 survivors.

On this basis, we will decide on next steps," Xinhua news agency quoted the Commission President as saying in a statement.

Brazil tops 600K Covid-19 deaths

Brasilia: Brazil's overall Covid-19 death toll, which is currently the second highest in the world after the US, has topped the 600,000 mark, according to health authorities. As of Saturday, the toll stood at 600,425 after 615 fresh fatalities were reported in the last 24 hours, Xinhua news agency quoted the Health Ministry as saying. At least 18,172 more people tested positive for the virus in the same period, which took the country's overall infection tally to 21,550,730, currently the third highest after the US and India.

55K evacuated as rain lashes Shanxi

Iran's first Prez post revolution, Banisadr, dies

Tehran, Oct 9: Abolhassan Banisadr, Iran's first president after the country's 1979 Islamic Revolution who fled Tehran after being impeached for challenging the growing power of clerics as the nation became a theocracy, died Saturday. He was 88.



Among a sea of black-robed Shiite clerics, Banisadr stood out for his Western-style suits and a background so French that it was in philosopher Jean-Paul Sartre that he confided his belief he'd be Iran's first president some 15 years before it happened.

Those differences only isolated him as the nationalist sought to instill a socialist-style economy in Iran underpinned by his deep Shiite faith instilled by his cleric father.

Banisadr would never consolidate his grip on the government he supposedly led as events far beyond his control, like the US embassy hostage crisis and the invasion of Iran by Iraq, only added to the tumult that followed the revolution.

True power remained firmly wielded by Supreme Leader Ayatollah Ruhollah Khomeini, whom Banisadr worked with in exile in France and followed back to Tehran amid the revolution. But Khomeini would toss Banisadr aside after only 16 months in office, sending him fleeing back to Paris, where he would remain for decades.

"I was like a child watching my father slowly turn into an alcoholic," Banisadr later said of Khomeini, "The drug this time was power." The family of Banisadr in a statement Saturday said he died at a hospital in Paris after a long illness.

Beirut, Oct 9: Ali Atwa, a senior Hezbollah operative who was on the FBI's most wanted list for his role in one of the most notorious plane hijackings in aviation history, has died, the Lebanese militant group said Saturday.

Atwa, who was believed to be in his early 60s, died of complications related to cancer, Hezbollah said.

Atwa was placed on the FBI's Ten Most Wanted Fugitives list in 2001 with two other alleged participants in the 1985 hijacking of TWA Flight 847. The ordeal, which began in Athens, Greece June 14, lasted 16 days and left a US Navy diver on the plane dead.

The hijackers demanded the release of Lebanese and Palestinian prisoners held in Israeli prisons.

The FBI had offered a \$5 million reward for information leading to Atwa's arrest. He was accused of conspiring to take hostages, committing air piracy that led to the slaying of an American, and placing explosives aboard an aircraft.

Atwa was placed on the FBI's Ten Most **Wanted Fugitives list** in 2001 with two other alleged participants in the 1985 hijacking of **TWA Flight 847**

The flight, with 153 passengers and crew members, including 85 Americans, was commandeered by the hijackers after taking off from Athens bound for Rome.

The plane was allowed to land in Beirut, where the hijackers freed 19 American women and children. They then flew to Algeria, where more hostageswere released, before returning to Beirut.

E-commerce firms log \$2.7bn in 4 days

New Delhi: E-commerce platforms, including social commerce and grocery, garnered about \$2.7 billion in sales in the first four days of the festive sale and are on track to achieve the \$4.8 billion gross GMV mark consulting firm RedSeer said Saturday, RedSeer Consulting had last month forecast that online platforms would see 30 per cent year-on-year growth in gross GMV at \$4.8 billion during the first week of festive sale. These platforms are expected to potentially clock over \$9 billion gross GMV (Gross Merchandise Value) during the entire festive season this year.

Forex reserves down to \$637.47 bn

Mumbai: The country's foreign exchange reserves dipped by \$1.169 billion to stand at \$637.477 billion in the week ended October 1, RBI data showed Friday. In the previous week ended September 24, 2021, the reserves had declined by \$997 million to \$638,646 billion.

Biomass pellets to be used in coal-burning thermal power plants

New Delhi, Oct 9: The power ministry has set a revised policy to use biomass pellets in coal-burning thermal power plants, encouraging use of agricultural waste that is otherwise burnt by farmers, causing air pollution.

The decision, announced Friday, makes it mandatory for three categories of thermal power plants to use a five per cent blend of biomass pellets along with coal.

The policy will come into force in October 2022, with a requirement to increase the proportion of biomass to seven per cent within two years for two categories of power plants.



The policy for co-firing of biomass would be in force for 25 years or until the useful life of the thermal power plant, whichever is earlier, the power ministry said in a

Farmers in some northern Indian states burn off vast swathes of paddy stalks and straw during the winter season to prepare the ground for planting, causing severe air pollution.

The sharp spikes in air pollution during that season often lead to a thick blanket of smog over northern India every year.

Global sugar market grateful for India supply

India's sugar policies, which include large subsidies, have been questioned for years at the WTO by competitors including Brazil and Australia



New York, Oct 9: India may be the only country able to fill a looming global supply gap for sugar as the Brazilian crop ends, making the world's sugar market grateful for the Asian country that was once viewed as a threat to the market's stability

Without India filling this gap, from November to March or April, the global sugar market would have a serious problem, said Paulo Roberto de Souza, the Chief Executive of Alvean Sugar SL, the world's largest sugar trader.

In an interview, Souza said sugar buying is about to increase even as the drought-hit crop in top grower Brazil winds down and costs for the commodity, as well as for ocean freight, have increased sharply.

He said that sugar consuming countries have been heavily reliant on available stocks during the year to avoid paying high shipping and sugar values, adding that those stocks are currently at critically low levels.

Now they have no choice, he said, expecting an increase on orders in the market that will have to be met by Indian producers, but at a higher price.

Sugar prices are near their highest since early 2017 mainly due to poor production in top grower Brazil following drought and frosts.

Alvean's research department does not see much improvement in Brazil next season, expecting a cane crop of around 530 million tonne and sugar production at around 32-32.5 million tonne for the center-south region.

The fields have suffered a lot and it seems we will have La Nina next year, which means less rain in the center-south, Souza said.

Alvean projects the global supply deficit to nearly double in 202122 (Oct-Sept) from the previous year to up to 6 million tonne, while it sees global sugar use growing 1.2% in 202122 from 0.7% in the previous season as countries further reopen after the pandemic.

Souza says sugar prices will have to increase further to attract enough Indian selling to fill the market's gap.

He says Indian sugar export parity -- the equivalent to domestic prices -- is currently around 21 cents per pound, already above New York futures

Amid environmental concerns, Tesla's giga fest at German factory

Construction at the plant had begun under an exceptional procedure granted by authorities two years ago, but opposition from locals has held up final approval

Berlin, Oct 9: With a big wheel, music and an appearance by CEO Elon Musk, Tesla is pulling out all the stops Saturday to win over opponents of the electric carmaker's controversial new gigafactory near Berlin.

Long queues of people brought by special shuttle buses were already forming at the Gruenheide site of Tesla's first European factory around 10 am.

Demonstrators were already on the scene Saturday morning, with a few people bearing signs like 'Stop Tesla' and 'water and forest aren't for private profit' gathered around 100 metres from

Mr Musk, expected to appear later at the Giga-Fest, tweeted simply Giga Berlin-Brandenburg fun party today in German Saturday morning.

The company has laid on a big wheel, electronic music and vegetarian food trucks -- an event conceived in the image of Berlin, Europe's party capital. Thousands are expected to attend, with locals given priority for the guest list announced by

ment ministry in Brandenburg where the plant is located, told AFP no date has been fixed for this authorisation. Despite local resistance, construction has been completed in double-quick time. replacing a swathe of pine forest with an enormous concretepaved expanse accessed via Tesla Road. In the event that the factory is not approved, the carmaker will be compelled to dismantle the entire works at its own cost

Dubai, Oct 9: Chennai Super Kings' old guards with an uncanny knack of owning the big stage at right moments, will start as favourites against a solid Delhi Capitals line-up led by 'young pretender' Rishabh Pant in what promises to be an exciting first IPL Qualifier here Sunday.

Capitals were the best team in the league and their 20-point finish at the group stage was an indication of their consistent performances which didn't dip due to the COVID-19 forced break

Similarly, CSK are now back in familiar settings of playoff rounds, something that they have done 11 out of 12 times although losing three matches on the bounce wouldn't have amused their all-powerful skipper MS Dhoni. DC, on the other hand, were

handed a rude jolt by Kona Bharat's last-ball six in their last group league game against RCB. It didn't change their pole position but did enough to shake them from their stupor. CSK, over the years, have been

in final eight times and won on three occasions which speak volumes of the team's ability to lift their game just when it's required most. That's the reason why CSK is

not one of those franchises which unleashes new talent by dozens like other franchises. Ruturai Gaikwad is an exception as he could be called a pure CSK product after more than a decade.

Dhoni has a simple cricketing philosophy – rely on tried and tested individuals who are battle-hard ened and thus he has always punted on the likes of Ravindra jadeja, Ambati Rayudu, Suresh Raina, Dwayne Bravo and Faf du Plessis.

These are players, who have been there and done that. People who can control phases and win pressure situations which more often than not results in victories.

Add Josh Hazlewood or Moeen Ali, who are also international regulars in that mix and the former India captain knows exactly what is the kind of combination that he needs to put on the park

As much as one speaks about



team effort, no one knows more than Dhoni that T20 is perhaps one form of cricket, where individuals win matches.

Dhoni knows that even though his batting form has deserted him years back (since 2015-16) and an IPL legend like Raina is a pale shadow of his once destructive self, he still has Gaikwad (533 runs) and Du Plessis (546), who have more often than not provided solid starts and the menacing Jadeja (227 runs) providing final flourish.

Similarly, Shardul Thakur (18 wickets in 14 games) has given runs at an expensive economy rate of 8.57 but still the breakthroughs have been important. No one knows more than Dwayne Bravo (12 wickets) as to how one can fool the batters by changing the pace.

Hazlewood hasn't found form but Dhoni is banking on that devastating first spell from the Aussie that can wreak havoc.

It could happen against DC, as their batting despite 10 wins, hasn't exactly inspired confidence of highest level. Prithvi Shaw (401 runs) and Shikhar Dhawan (544

runs) have had their share of starts but in the UAE leg, they haven't exactly dominated.

Skipper Pant (362 runs) has been scratchy at best and Marcus Stoinis' absence due to injury did affect their balance as they lack big-hitters at the death save Shimron Hetmyer.

DC's strength has been their bowling attack – Avesh Khan (22 wickets), Axar Patel (15 wickets), Kagiso Rabada (13 wickets) and Anrich Nortje, who has taken nine wickets but an economy rate of 5.59 over six games.

But yes, even Dhoni would admit that Raina and Rayudu in what would be their last season for CSK. would want to make some tangible contribution with the willow. Even skipper himself needs to put his hand up.

Hamilton's record-extending 102nd pole saw him finish 0.13 seconds ahead of Bottas and .33 clear of Verstappen's Red Bull.

Table-toppers India ended the tournament with 30 medals including 13 gold, 11 silver and six bronze. USA finished second with 6 gold, 8 silver and 6 bronze.
