

It said such a course would violate settled judicial principle against bias. The matter would again come up for hearing in eight weeks, the bench stated. The bench took note of the vehement submissions of the Centre on national security and rejected it. "...This does not mean that the State gets a free pass every time the spectre of 'national security' the bench noted. "National security cannot be the bugbear that the judiciary shies away from, by virtue of its mere mentioning. Although this Court should be circumspect in encroaching the domain of national security, no omnibus prohibition can be called for against judicial review," the bench added.

Quoting English novelist George Orwell, the bench said "If you want to keep a secret, you must also hide it from yourself." 'Orwellian' refers to a dystopian, totalitarian state which is destructive to the welfare of a free and open society.

"Members of a civilized democratic society have a reasonable expectation of privacy. It is not the singular concern of journalists or social activists. Every citizen of India ought to be protected against violations of privacy. It is this expectation which enables us to exercise our choices, liberties, and freedom," the apex court order said.

The top court said it was an extremely uphill task to find and select experts who are free from prejudices, are independent and competent, rather than relying upon any government agencies or any private entity.

The apex court was hearing a batch of pleas seeking independent probe into the alleged Pegasus snooping matter. An international media consortium had reported that over 300 verified Indian mobile phone numbers were on the list of potential targets for sur-

veillance using the spyware.

Physical classes of UG, PG students to commence from Nov

Bhubaneswar, Oct 27: The Higher Education department announced Wednesday that physical classroom teaching of 2021-22 first year undergraduate (UG) and postgraduate (PG) students (new admissions) in universities and colleges will commence from November 1 and November 15 respectively.

In a letter to all universities and colleges, Saswat Mishra, secretary of Higher Education department said "Classroom teaching of first year UG and first year PG students (freshly admitted) for the session 2021-22 will start from 01.11.2021 and 15.11.2021 respectively in physical mode by following appropriate Covid-19 prevention protocols.

The protocols that have to be followed are wearing of face masks always, frequent hand santisation and social distancing in classrooms, libraries and laboratories. Also spitting inside the campus has been completely prohibited.

All institutions have also been asked to keep an isolation room as standby in case of emergency. The Higher Education department also said that hostel facilities will be available for students. Similar Covid-19 facilities will be followed in hostels also.

Earlier, the Higher Education department had opened the universities and degree colleges to commence physical classroom teaching for PG first year and UG pre-final year students of 2020-21 from August 16.

It should be stated here that the first round of admissions into PG courses in various universities in Odisha had started from October 23 as provisional allotment of seats (for first-round selection) was published October 22. The spot admission process for UG first year students ends October 28.

UP to get its first drive-in theatre on Diwali

> ttar Pradesh is set to get its first drive-in the atre on Diwali.

> The drive-in theatre in Lucknow, which will be operational from November 2, is expected to draw big crowd on Diwali. The facility, with a capacity of 200 cars, has been set up in Sarojini Nagar area

People can watch movies from the comfort of their cars while enjoying food and other amenities.

Lucknow-based commercial pilot and businessman, Nitish Kanda, 22, who started the venture, said: "This will be a new experience not just for the city but for the entire state as this is the first drive-in theatre in Uttar Pradesh. We nave installed a digital LED screen with 40 by 20 ft dimensions which also works well in sunlight. For the

time being, we will have evening and night shows." The district administration and the municipal corporation have granted permission for the facility and tickets will be available both online and offline.

"The digital LED screen promises better picture quality over a projector. It also gives 180-degree equal view from all angles. The sound system will also be tuned to the frequency of the car's FM and audio will be played inside the vehicle, limiting all noise pollution," he added.

The concept is expected to receive much traction during Covid times since the drive-in theatre will help maintain physical distancing with cars in place of other forms of seating arrangements. IANS

Bhubaneswar, Oct 27: Opposition BJP and Congress continued to mount pressure on the state government for dismissal of Minister of State (MoS), Home, Dibya Shankar Mishra for his alleged involvement in the murder of Kalahandi school teacher Mamita Meher.

BJP Yuva Morcha members Wednesday gathered at several SP offices across the state demanding justice for Mamita. Party activists led by Sundargarh MP Jual Oram took out a rally from Deogaon and submitted a memorandum to Sundargarh SP seeking a CBI probe into the case.

The party workers took out a rally and forcefully entered the Puri SP office after a face-off with the police.

At a presser here, state BJP president Samir Mohanty questioned the Chief Minister's silence on this issue. "Is the Chief Minister aware of the brutal incident? Whether the CM was briefed about the case? If ves, why did he remain silent? questioned Mohanty.

He also raised questions about the police investigation and asked as to how the prime accused, Gobinda

Outfits' memo to DGP for fair probe

Cuttack: Amid clamour for justice in Kalahandi ladv teacher Mamita Meher murder case, several social outfits Wednesday staged a demonstration in front of the office of Director General of Police (DGP) here demanding an impartial probe into the case.

The activists of social outfits All India Democratic Students' Organisation (AIDSO), All India Democratic Youth Organisation (AIDYO) and All India Mahila Sanskritik Sangathan (AIMSS) submitted a memorandum to the DGP in this regard.

"Exemplary punishment must be given to the people involved in the murder case. Stern action should be taken against the policemen who were found guilty. The victim's family must be provided with a compensation of ₹50 lakh," said the memorandum.

CB: Mystery woman also honey-trapped Raj official

Cuttack, Oct 27: The suspected Pakistani woman, who honeytrapped five employees of Defence Research and Development Organisation (DRDO) in Balasore, was also in touch with an employee at the Office of Chief Engineer of the Military Engineer Services (MES) in Rajasthan's Jodhpur, an official said Wednesday.

Addressing the media, Crime Branch (CB) ADG Sanjeeb Panda said the employee has shared some 'vital information' related to the MES with the mystery women and the Rajasthan police has registered special team was constituted to a case in this connection October 15.

"The Crime Investigation Department (CID) of Rajasthan has contacted us regarding the incident. And we had a discussion about the mystery woman as well." Panda added.

The CB ADG also said they have got the details of one of the two money transfers to one of the accused in the DRDO espionage case.

"One of the five accused had received a cash transfer of ₹38,000 in two instalments—₹24,000 and ₹14,000—from a Dubai account. During investigation, we found that ₹24,000 was sent through Dubai's Lulu International Money Exchange Centre. We'll soon come up with the sender details of the ₹14,000

transfer," Panda said, adding the mystery woman's Facebook account is still active.

Sources said the Army intelligence wing in Odisha had in July this year shared details of the antinational activities of the five accused, employees of DRDO's Integrated Test Range (ITR) at Chandipur in Balasore, with the state police.

Acting on the tip-off, the Balasore police busted the spying handiwork and arrested the five on charges of sharing 'classified defence secrets' with the mystery woman, suspected to be a Pakistani, September 14. The CB subsequently took over the probe. During the probe, the CB found

that the unknown woman operative introduced herself with several names and trapped the accused after interacting with them over Facebook Messenger and WhatsApp.

Meanwhile, sources said the employee at the Office of Chief Engineer of the MES in Jodhpur has been arrested.

Wettest Sept, high deficit Aug mark 2021 monsoon Vistara flight shook the soul of flyers: AAP MP

Bhubaneswar, Oct 27: Aam Aadmi Pary (AAP) MP Sanjay Singh Wednesday claimed that a Vistara flight in which he was travelling in narrowly avoided a mishap while landing at Biju Patnaik International Airport (BPIA) here

The flight UK785 that departed from Delhi at 7am reached the BPIA around 9am.

Singh, who was on an official visit to Puri, had boarded the flight from New Delhi. Singh stated that he experienced severe turbulence during the landing which made him uncomfortable

'Today, Vistara flight's landing in Bhubaneswar shook the soul of the passengers and it narrowly avoided an accident. I request the pilot to take some other work otherwise some major mishap may happen. Vistara management and Civil Aviation Minister Jyotiraditya Scindia sir, please take note," Singh said in a tweet said.

Civil Aviation Minister Jyotiraditya Scindia responded by assuring appropriate steps after investigating the matter.

BPIA Director, Pravat Ranjan Beuria, said, "We have been in contact with the Vistara, flight captain and ATC officials, and no such incident has been reported yet. However, we are still looking into the matter." In a statement, Vistara said the flight did encounter strong tailwinds during its approach to land.

"However, the pilots managed to make necessary adjustments, and despite the gusty winds, touchdown was normal. Our pilots are well trained and experienced in handling such situations," it added.

Bhubaneswar, Oct 27: In one of the rare weather phenomena, excess rainfall in September and high deficit rain in August marked this year's southwest monsoon. which has completely withdrawn from the state.

As per the India Meteorological Department (IMD) sources, while the monsoon had set in over Kerala June 3, it entered Odisha June 10 and remained active till September 30. The monsoon rain in Odisha was in normal range as the coastal state received 1,046 mm rainfall

this year, said the IMD. While two districts, Jagatsinghpur and Puri, received 29 per cent and 22 per cent excess rainfall respectively, six districts recorded deficit rain. Jharsuguda recorded 29 per cent deficit rainfall while the shortfall in rain was 28 per cent in Sambalpur, 27 per cent in Nabarangpur, 27 per cent in



Kalahandi, 25 per cent in Bolangir and 24 per cent in Jajpur.

On the other hand, the remaining 22 districts received normal rainfall during this monsoon season, added the MeT department. "An important feature of this

year's southwest monsoon is excess rainfall in September and high deficit rainfall in August. Against the normal figure of 366.4 mm, the state received only 204.9 mm rainfall in August - a deficit of 44 per cent. The state has recorded deficit rainfall in August four times in last 120 years," said the IMD regional centre.

and lesser number of low pressure areas (only two) over Bay of Bengal during August were cited for low rainfall, unfavourable Madden Julian Oscillation (MJO) was stated to be the main reason behind subdued monsoon activities over Odisha during the period.

However, September this year

saw excess rainfall of 169.8 per cent with cumulative rainfall of 384.8 mm which was 70 per cent more than the normal cumulative rainfall of 226.4 mm.

"Odisha recorded the heaviest rainfall of around 155.4 mm in three days between of September 11 and 14, which is 69 per cent of the month's normal rainfall," added the IMD.

Two low pressure areas, one well marked low pressure and a deep depression, and a cyclonic storm (Gulab) consecutively formed in September and caused the excess rainfall. The state had recorded above 384.8 mm September rainfall in 1961 (483.2mm), 1945 (405.9mm) and 2007 (401.7mm) during the last 120 years.

The rainfall observed across Odisha from October 1 to 23, the date of withdrawal of the southwest monsoon from the entirestate, was 76.5mm against the usual rainfall of 88.5 mm.



TECH PANEL TO DECIDE FATE OF MIPs

JAJPUR FARMERS ARE HOPEFUL OF EXPANSION IN IRRIGATION NETWORK TO BOOST THE AGRICULTURE SECTOR

POST NEWS NETWORK

Jajpur, Oct 27: As irrigation is the key to growth of agriculture sector, the state and central governments have given thrust on boosting irrigation system. However, many minor irrigation projects have failed to deliver services to farmers in Jajpur.

Keeping in view the miserable condition of minor irrigation projects(MIPs) across the state, the government has formed a technical advisory committee (TAC) to look into the status of MIPs, explore their capacity expansion and extension of irrigational coverage.

It was learnt that the TAC will examine drawbacks, technical faults in construction of all the projects under minor irrigation department and suggest ways to remove bottlenecks.

Dams, tunnels, sluice gates and power houses will be examined by the TAC. Farmers have alleged that there have been big irregularities in construction of MIPs in Jajpur for which the projects are unable to meet the irrigational targets set by the government. They are hopeful that the



TAC will look into the irregularities and take necessary action.

As per information available from the minor irrigation department, there are 58 MIPs in 9 blocks in the district. The department has claimed that these projects irrigate 8,091 hectares of land. However, in the current year, these

projects have irrigated only 4,479 hectares, the department has said. The district has received fund to the tune of ₹3.50 crore for maintenance of MIPs in 2020-2021.

But it was alleged that such massive fund has not been utilised properly as contractors have allegedly

minted money by compromising with quality work. As a result, many MIPs are unable to deliver water in the targeted areas.

The MIPs at Bhangabandh, Mangalpur, Ranibandh, Dholapathar, Badajuri, Damashala, Gandanala and Bhalukipatala are among the projects which have failed to achieve their objectives. Canals of these projects are choked with siltation and weeds. Though the department is carrying out repair and maintenance at regular intervals, condition of these projects has not improved.

Farmers said, "In urgency, we are unable to get water from these projects to save crops. The hope that we have on MIPs to save crops during drought is vanishing. In case of drought, our economy is broken." They observed that if the TAC works in the larger interest of farmers, capacity of MIPs can be ex-

panded. The TAC comprises the chief engineer of the water resources department, chief engineer of the planning and design department, top engineers of survey and investigation and monitoring wings. G.Ramkrushnan, executive engineer of the MIP, said the department takes steps to ensure targeted



Balasore. Kandhamal man shows way in ginger farming

BANGAR KANHAR BEGAN FARMING WITH ₹10 AND NOW EARNS ₹3 LAKH ANNUALLY

Phulbani, Oct 27: Most people in Phiringia block of Kandhamal district know about farmer Bangar Kanhar. He has carved out a name for himself in ginger farming. He earns in lakhs annually.

Bangar started ginger farming in a small way by investing only Rs10. By dint of his hard work and dedication, he has successfully taken his farming in three years to such a height that it earns him ₹3 lakh per annum.

The story of his ginger cultivation goes like this: Bangar's wife Bhanumati had gone to Phiringia local market three years ago. She had bought vegetables from the market. Among those was a bunch of ginger worth ₹10. She used a major part of the ginger in curries and buried the rest around a cow dung pit. Some days later, ginger sprouted and grew luxuriantly.

The family of Bangar took care of the ginger plants. The family first harvested 5 kg of ginger in 2018. Enthused, the family decided to take up the ginger farming in a bigger way in 2019. In the current year. Bangar has harvested about four quintals of ginger.


"Earlier, ginger was being sold for anything between ₹100 and ₹120 per kg. Due to pandemic-induced market situation, its price has come down," the family said.

However, his ginger is sought after by local people in the market. Bangar has a daughter, who is pursuing Plus Two. With earnings from the ginger farming, he bears the cost of her education. He wants his daughter to pursue higher studies.

He cultivates ginger, vegetables and mango in his three acres of land. "But lack of irrigation facility is a problem here. I have applied for a farm pond," he said. Now, he irrigates his farmland with the water from a nearby creek.

"If I get government help, I will expand the ginger farming," he said. Bangar is exploring farming of various other cash crops with best practices so as to introduce the viable crops in his farmland.

"Bangar's application for a farm pond has been approved. The pond will be dug soon," said Rashmiranjan Mohanta, BDO of Phiringia block.

Wake-Up Call

pidemiologists tell us that COVID-19 was not a 'black swan.' In our life- \dashv time, there will be pandemics that are equally if not more severe. And when the next one comes, China, Singapore, and maybe Vietnam will be better prepared because they have learned from this terrible experience. Pretty much everyone else, including most of the G20, will be just as vulnerable as they were when COVID-19 hit.

But how can that be? After all, isn't the world still battling the worst pandemic in a century, which has now killed almost five million people and forced governments to spend \$17 trillion (and counting) to mitigate the economic damage? And haven't world leaders commissioned top experts to figure out what went so wrong and how we can do better?

The expert panels have now reported back, and they all say more or less the same things. The world does not spend enough on monitoring infectiousdisease outbreaks, despite their potential to become pandemics. We lack strategic reserves of personal protective equipment (PPE) and medical oxygen, or spare vaccine production capacity that could quickly be ramped up. And the international agencies charged with global health security lack clear mandates and sufficient funding, and are not adequately accountable. Simply put, no one is in charge of the pandemic response and so no one is responsible for it.

Moreover, knowing what we need to do is not the same as actually doing it. We seem unable to get our global act together to make the necessary pandemic-related decisions. Instead, policymakers may well end up implementing a series of half measures – in the G20, the United Nations, the World Health Assembly in Geneva, and via unilateral decisions by some countries - and try to fund them on the cheap. These steps will help, but they will never get the job done. Imagine putting a fire alarm on every second floor of an apartment building and hoping for the best

Such an approach is difficult to comprehend. If the United States is happy to pay the cost of maintaining a strategic oil reserve with three months' supply, then surely it is also worth having a strategic reserve of production facilities for PPE, diagnostics, vaccines, and therapeutics. Similarly, the US military alone spends over \$5 billion a year to maintain 189,800 reserve troops, even though it hopes never to have to use them. Would it not be a good deal for the world to spend \$15 billion a year on preventing pandemics in order to avoid spending tens of tril-

lions to respond to one? Of course it would. So, what is holding the world back from doing what

is needed to avert another COVID-19-type catastrophe? First and foremost, most political systems encourage a short collective attention span. Politicians and voters are done with pandemics. Now they want to focus on building back better, and the international agenda has moved on to other topics.

To be sure, national policymakers know they cannot just walk away from the pandemic, so they will delegate it to the World Health Organisation and other agencies. But only a year ago, many were vociferously complaining that these bodies were not equipped to do the job. The fact is that they have not even come close to defeating COVID-19, which is still raging in a majority of low- and middle-income countries, owing to the pathogen's dynamics and the slow pace of vaccination.

The global health agencies are nonetheless happy to take back this agenda, because most of them still believe that pandemic preparedness and prevention are strictly health-sector issues. But COVID-19 has made it clear that they are not. Heads of governments and finance ministers must take ownership of these matters alongside health officials.

Yet, after the unprecedented public spending of the past 18 months, finance ministers are under pressure to cut back. Programmes that involve spending more money now to avert some possible future crisis may look like easy targets. But downsizing them won't look so smart when the chickens come home to roost.

Lastly, there is bureaucratic resistance to an exercise that promises to consolidate or remake organisations and introduce new mechanisms to r fit governance systems for purpose. Instead, they will cobble together a few improvements and declare success. Is this a lost cause? After the tragic wake-up call of COVID-19, will the next pandemic catch us sleeping again? I believe not, but only if G20 heads of government recognise that pandemics are a national and global security threat and expend some political capital to shift the international health-security machinery from its current equilibrium. The bold changes the world needs will not happen unless global political leaders establish a vision. The upcoming G20 leaders' summit in Rome October 30-31 is the right moment to get it done.

The taxation system 661 has tilted toward the rich, and away from the middle class, in the last ten years. It is dramatic, and I don't think it's appreciated. And I think it should be addressed." So said the billionaire investor Warren Buffett 18 years ago. He illustrated his claim by surveying his office staff: although he was then the world's second-richest person, he was paying a lower percentage of his income in taxes than his receptionist was.

Since then, economic inequality has only gotten worse, partly because of the rise of tech stocks that are immensely valuable but do not declare dividends. In 2020, six of the 10 wealthiest Americans Jeff Bezos, Mark Zuckerberg, Warren Buffett, Larry Page, Sergei Brin, and Elon Musk-were major shareholders of corporations that do not pay dividends. Together, they were worth \$500 billion, or 0.5

per cent of total US wealth. Last month, a paper from the White House, co-authored by economists from the Council of Economic Advisers and the Office of Management and Budget, estimated that America's 400 wealthiest families, all of whom had wealth exceeding \$2 billion, paid federal income tax at an average rate of 8.2 per cent if gains in unsold stock are counted as income. The average American taxpayer paid 13.3 per cent of their income in federal tax.

The US budget deficit, as a percentage of GDP, is now at its second-highest level since 1945. In poll after poll, Americans say that they want the rich to pay higher taxes, which would reduce the deficit and improve equity as well. Yet Congress does not raise taxes on the rich.

Consider the egregious 'carried interest' loophole in the US tax code, which permits investment fund managers to pay lower tax on the fees they receive from their clients, as if those fees were capital gains, rather than income.

The conclusion is inescapable: The United States is no longer a democracy. It is a plutocracy. But countries in which money has less influence on legislation are also struggling to tax the rich. The Pandora Papers, released earlier this month by the International Consortium of Investigative Journalists, shows how wealthy people in more than 200 countries and territories are keeping their assets offshore, many of them to avoid taxes.

G20 could do about the tax inequity between the rich and most working people? The economists Emmanuel Saez and Gabriel Zucman of the University of California, Berkeley have suggested a wealth tax of 0.2 per cent annually on the value of all publicly listed corporations' stock. Such a tax, they note, is progressive, because the rich own a lot of corporate stock, and the poor own none. It is also difficult to evade. because the value of a corporation's stock is public.

Moreover, Saez and Zucman point out that a wealth tax would not affect the availability of corporate finance, because publicly traded companies can issue more stock (slightly diluting the value of existing shares) and pay the tax in kind to governments, which can then sell the stock on the market. Extending the tax to large private corporations would also be feasible, using standard methods of valuation.

The opening of the global economy over the past 30 years lifted hundreds of millions of people out of extreme poverty, but it also enriched multinational corporations, which have been able to shift profits to wherever the corporate tax rate is lowest. The G20 can take one step toward remedying that by accepting the proposed 15 per cent minimum rate, but that will leave untouched the wealth that comes from startups that are not making profits but still have soaring stock prices. The G20 countries can meet that problem by adopting a wealth tax along the lines Saez and Zucman recommend.

Placeshifting

his is the spatial analogue to timeshifting, which is the older and better established term for recording a TV programme to watch at a later time. When you placeshift, you instead redirect the TV signal from your cable box, satellite television connection or computer so you can watch a programme on a device somewhere else. That might be in another room in the house or on a mobile phone or a PDA (personal digital assistant) anywhere in the world. The term was invented in 2005 by Sling Media, the makers of the Slingbox, a personal video recorder that provides the service. Placeshifting is mainly restricted to specialist journals, but the concept is getting a lot of attention, not least from mobile operators who see it as a way to get their customers to use the currently under-exploited video facilities on their mobile devices. It is also being watched - but in a more negative light - by broadcasters. who are worried about matters such as copyright infringement. Like so many new technological ideas, it's the focus of a lot of hype at the moment, so it might yet turn out to be a solution to a problem that nobody thinks actually exists. It's quite clear that a wave of placeshifting technologies is on its way. The implications of such a wave at first seem to mean rough seas for wireless carriers. The spread of placeshifting will ultimately put wireless carriers on a crash course to compete with the full suite of video offerings from pay-TV and the Internet (The Online Reporter, 9 September 2006). With placeshifting, you can record the college football game you're missing on Saturday afternoon and then view it on your notebook PC that same night at a hotel hot spot. Once placeshifting becomes a reality for a PC/TV, however, digital entertainment systems will become more compelling (PC Magazine, 5 December 2006).

After almost 25 years, noticing a steady downward trend in quality of education, towards the fag end of the Communist rule they realised their folly and reintroduced English from primary school level upwards However, despite introduction of Hindi medium in Bihar, the stu-

whole world, Indians reaped the fruits because they had mastered the English language, the international language of commerce, which became the international link language of the IT revolution. More industrious and dedicated workers of Malaysia, Indonesia, and China were left behind in the software sector because their students had university education in their regional languages. Howsoever we might be averse to English as a colonial baggage of the past, it remains the international business language which cannot be denied nor can be wiped away. Nationalism or vote bank politics should be kept aside for the sake of future generations of this country. Hence the much touted NEP needs to be revisited by a group of unbiased professionals and educationists not by the voice vote of Parliament where unfortunately intellectual input is steadily declining.

No power supply to 37 tribal villages

Phulbani, Oct 27: Police Wednesday arrested a youth on charge of impregnating a 12-year old girl on the pretext of marriage under Gochhapada police limits and Phiringia block in Kandhamal district

The accused was identified as Ramprasad Kanhar, 22. He was arrested over a complaint lodged by the survivor's father. Malkangiri, Oct 27: The Centre and the state government have launched a host of schemes for the development of the primitive Bonda tribals in Bondaghat under Khairaput block of this district, a report said.

However, the tribe continues to live a life of drudgery and deprivation. The Bondas are a unique tribal community who live in isolated hill regions of Malakangiri district

Reports said the tribals are especially known for their unique types of attires, food habits, habitats and traditional living. Tourists from within and outside of the country visit them to click their photographs and earn lakhs from it. Realizing this, the state government has banned foreign tourists from clicking photographs of

Bondas without permission. The Bonda population has sharply declined. To arrest the fall in their number, the Centre and the state government have taken a host of measures to bring them into the mainstreams. The government is providing them with good roads, healthcare facilities, drinking water, power and education facilities. Realizing the popu-

lation and cultural decline, the state government has formed the Bonda Development Agency (BDA) in 1977.

Various non-governmental outfits, tribal development agencies and voluntary outfits are working for their uplift. However, their problem is far from being resolved as they continue to fall prey to unscrupulous labour agents from Andhra Pradesh. These agents lure them to work in various units in the neighbouring state where they are invariably exploited. The matter came to the fore after

Bonda girls Sangeeta Kirsani, Nandini Kirsani, Muskan Kirsani, Padmini Kirsani and Shanti Batri of Badbel village under Andrhal panchayat of Bonda hill narrated their ordeal before social activist Durvodhan Patra when he visited the village. Patra has filed a complaint in this regard before the district legal services authority which has been registered for a hearing. Sangeeta and Nandini were students of Plus II first year in

Gobindpalli College while Muskan, Padmini and Shanti were studying in Khairaput, Pangam and Kadamguda high schools respectively. They are now living in their villages as their schools and colleges have remained shut for Covid.



Students have online classes. However, they are unable to attend such classes due to lack of internet facilities in their villages.

This is not an isolated case as students living in over 30 villages in Bondaghat are unable to attend their online classes and whiling away their time due to lack of internet facilities in their villages. Aware of the situation, the labour agents from Andhra Pradesh visit the villages and lure the gullible tribals with money to send their wards with them to work in their state.

The labour agents reach the villages of Bondaghat passing via Ankadeli and Lamtaput in Koraput district. They pay some money to the parents of the young labourers as advance and traffic the boys and girls as young as 13 years to Andhra

Madan Mohan Paika, district labour officer (DLO), said he is yet to receive any complaint regarding trafficking of the Bonda youths to neighbouring Andhra Pradesh.

Narayan Das, district child protection officer (DCPO) replied in the same vein but assured to conducta probe and take action on receipt of any complaint.



CM Channi said only 8,000 remaining cases will be settled amicably by asking the concerned traders/ industrialists to deposit only 30 per cent of the total outstanding tax liability, thus saving them from a lot of inconvenience caused to them on this count.

He announced that they will only have to deposit 20 per cent of the tax liability during the current fiscal and the balance 80 per cent by the next.

CM Channi said this industrialfriendly initiative will go a long way in boosting their morale to invest in a big way. He added that the state government will act as a facilitator to promote the industry at new heights of glory.

Assuring of the best air connectivity to boost economic activity in the region, CM Channi also announced to lay the foundation stone of upcoming greenfield (fresh) airport at Halwara (Ludhiana) November 15 and said that the prestigious airport will be completed within eight months.

Reiterating his government's firm commitment to create a conducive ecosystem for the ease of



doing business in the state, CM Channi assured the industry of fulsome support to make Punjab the frontrunner state not within the country but across the globe.

"Was it pity, that a 3 member committee was formed to make you accountable? Why were MLAs against you? Because everyone knew you have collided with Badals ! All you want is to defeat me, have vou ever wanted Puniab to win? Your 75/25 dealings with Badals and BJP are crystal clear," alleged Sidhu.

Sidhu also said the former CM had earlier too formed his own party but he could get just over 800 votes when he contested the elections.

"Last time you formed your own party, you lost your ballot, garnering only 856 votes. People of Punjab are again waiting to punish you for compromising on the in-



terests of Punjab," said Sidhu.

Reacting to it, Amarinder Singh slammed the former cricketer and said, "You do have the knack of putting your foot in your mouth @sherryontopp! The 856 votes you are mocking came even after I withdrew my nomination from Kharar since I'd won unopposed from Samana. So what does that show? Or are you too dumb to understand'.

listic missile project was started over a decade ago. People familiar with the development said it was the first user trial of the missile which can bring the northernmost part of China under its striking range.

The successful test-firing of the missile, built by the Defence Research Development Organisation's (DRDO), came in the midst of a lingering border standoff with China in eastern Ladakh. The first test of the missile was carried out in April 2012 while the previous one was reportedly conducted around three years ago.

Wild Himalayan fig may be used as pain reliever: Study PRESS TRUST OF INDIA

New Delhi, Oct 27: The wild Himalavan fig. commonly known as 'Bedu' in Uttarakhand's Kumaon region, may be used as a safer alternative to synthetic pain relievers like Aspirin and Diclofenac, according to a study conducted on lab rats.

An international team, led by re-

searchers at Lovely Professional

University (LPU) in Punjab, noted

that the popular fruit in the

Himalayan region also has many

other medicinal benefits such as cur-

ing skin diseases and wound

In the study, Psoralen helped to block an enzyme called 'Cyclooxygenase-2' (COX-2), which is also blocked by pain relievers such as Diclofenac while Rutin helped bind the mu-opioid, a major binding site in Morphine.

The research, published in the journal Plants, concluded that the wild Himalayan fig has potential analgesic effects at different doses in general and at a 400 milligrammes per kilogram (mg/kg) dose in particular.

"Wild Himalayan fig aka Bedu are an excellent and safe plant-based alternative to the synthetic pain relievers like Aspirin and Diclofenac,"



said Devesh Tiwari, Assistant Professor at LPU, who led the study. "Our research is the first, to establish wild Himalayan fig as a natural pain reliever. Traditionally,

this fruit was used for curing back-

aches in the rural areas. So far, there was no study available on the analgesic effects of Ficus Palmata," Tiwari said.

The authors of the study noted that the most widely used drugs for

Indian military cannot operate effectively without Russian equipment: CRS report

There has been a considerable drop in India's dependence on arms and equipments from Russia but the Indian military cannot operate effectively without Russian-supplied equipment and will continue to rely on its weapons systems in the near and middle terms, a Congressional Research Service (CRS) report has said. Many analysts in India and beyond conclude that the Indian military cannot operate effectively without Russian-supplied equipment and will continue to rely on Russian weapons systems in the near and middle terms, the independent CRS said in a report 'Russian Arms Sales and Defense Industry'. A graph showed that since 2015, under the Modi government, there has been a consistent drop in import of equipment from Russia. Noting that India's plan to purchase Russian-made S-400 air defense systems, in progress since 2016, could trigger US sanctions under Section 231 of CAATSA, the CRS said Indian planners appear to have concluded that alternatives to the S-400 offered by Washington -- the Patriot and THAAD systems -- lack the purported range and versatility of the Russian equipment.

Cairo, Oct 27: Sudanese security forces detained three prominent pro-democracy figures overnight, their relatives and other activists said Wednesday, as internal and international pressure mounted on the country's military following its coup.

The arrests came as protests denouncing Monday's takeover continued in the capital of Khartoum and elsewhere, and many businesses shut in response to calls for strikes. Security forces kept up their heavy-handed response, chasing demonstrators in several neighbourhoods late Tuesday, according to activists who said some were shot and wounded. At least six people have been killed in protests so far, according to doctors. The coup threatens to halt Sudan's fitful transition to democracy, which began after the 2019 ouster of long-time ruler Omar al-Bashir and his Islamist government in a popular uprising. It came after weeks of mounting tensions between military and civilian leaders over the course and pace of that process The African Union suspended Sudan - an expected move typically taken in the wake of coups. The AU Peace and Security Council tweeted the decision on Wednesday, saying it would remain in place "until the effective restoration of the civilian-led Transitional Authority," as the deposed government was known. The AU plans to send a mission to Sudan to hold talks with rival parties.

The 'One Country, One Law' was an election slogan of Rajapaksa in 2019 when he was elected president with an overwhelming support from the country's Buddhist majority.

The task force, appointed by

Gnanasara's Bodu Bala Sena (BBS) or the Forces of Buddhist Power, was implicated in the anti-Muslim riots in 2013.

The task force also has four Muslim scholars as members but no representation has been allowed for the minority Tamils. It has been entrusted with the job

of preparing a draft for the implementation of the 'One Country, One Law' concept, according to the gazette released Tuesday.

The final report is to be submitted by February 28, 2022 after monthly reports to President

Rajapaksa on its progress. Article 168 (1) of the Constitution provides that all existing law would be read subject to the new Constitution.

However, Article 16(1) provides that all existing law shall be valid and operative, notwithstanding any inconsistency with the chapter on fundamental rights.

Florida teens held for murder of classmate

Miramar, Oct 27: Three Florida teens were arrested last week on murder, conspiracy and evidence tampering charges in connection with the brutal killing of a classmate, police said.

Dwight DJ Grant, an 18-yearold high school student who disappeared Oct 17, was found dead Oct 19 in Miramar, about 20 miles north of downtown Miami. Grant's body was found in bushes behind the apartment complex where he lived, police told NBC South Florida.

In an arrest affidavit, police alleged that the three teens, 16 and 17-year-old girls and a 17-year-old boy, conspired together to lure Grant into a trap and worked together to facilitate the killing.

One girl allegedly held Grant down while the boy beat and stabbed him with a knife and sword while the other girl kept watch. Then, the three teens allegedly worked together to dispose of the weapons and clean up the evidence of the killing.

The three teens arrested Friday and Saturday are not being named publicly because they are minors, police said The motive for the killing was Grant allegedly having sex with an unnamed girl, which infuriated the 17-year-old boy because he had an emotional connection with her, police said an investigation of the teens' text messages revealed.

New Delhi, Oct 27: The country's largest carmaker Maruti Suzuki India Wednesday reported a 66 per cent decline in consolidated net profit at ₹487 crore in the second quarter ended September 30, 2021, impacted by the ongoing semiconductor shortage and increase in commodity prices.

The company had posted a consolidated net profit of ₹1,420 crore in the second quarter of last fiscal, Maruti Suzuki India said in a statement. Consolidated revenue from operations stood at ₹20.551 crore in the second quarter, as compared to ₹18,756 crore in the year-ago period, it added.

Total vehicle sales were down 3 per cent at 3,79,541 units in the second quarter, as against 3,93,130 units in the corresponding period last fiscal, it said. Domestic sales were at 3,20,133 units in the second quarter, as against 3,70,619 units in the year-ago period.

Exports were, however, the highest ever at any quarter in the company's history at 59,408 units in the second quarter, as compared to 22,511 units in the same period last



fiscal. An estimated 1.16 lakh vehicles could not be produced owing to the electronics component shortage mostly corresponding to the domestic models, the company said. Maruti Suzuki India further

said it had more than 2 lakh pending customer orders at the end of the quarter for which it is making all efforts to expedite ,deliveries. "This quarter was also marked

by an unprecedented increase in the prices of commodities like steel, aluminium and precious metals within a span of one year. The company made maximum efforts to absorb

input cost increases offsetting them through cost reduction and passed on minimum impact to customers by way of car price increase," it said adding as a result there was a drop in its net profit.

In the first half of the fiscal year ended September 30, the company sold a total of 7,33,155 units with domestic sales at 6,28,228 units.

Exports in this half year were at 1,04,927 units as compared to 32,083 units in the same period last fiscal, the company said, adding overseas shipments in the first half this year exceeded the full year sales of last year.

'EVs only after 2025

New Delhi: Maruti Suzuki India will launch electric vehicles in the country only after 2025 as demand for such vehicles at the moment is less and it would like to sell around 10,000 units a month whenever it enters the electric mobility space, company Chairman RC Bhargava said Wednesday. Addressing a virtual conference on the company's second quarter earnings, he said under the current circumstances a lot of things in the EV ecosystem such as batteries, charging infrastructure and electric supply are done by other parties and therefore the costing is not in the hands of the company. Also with fuel prices going up, car market leader Maruti Suzuki India is intensifying its focus on more CNG offerings of its models. Stating that launching an EV would depend on market conditions, Bhargava said at present it is difficult to predict the pricing of electric vehicles, batteries, how the infrastructure is built up and the costing is not at all in our hands.

Form 26AS info list to include foreign remittances, MFs

New Delhi. Oct 27: The income tax department has expanded the list of high-value financial transactions which would be available to taxpayers in their form 26AS by including details of mutual fund (MF) purchases, foreign remittances, as well as information in ITRs of other taxpayers.

The Central Board of Direct Taxes (CBDT) October 26 issued an order under Section 285BB of the I-T Act expanding the scope of information reported in new

Form 26AS. Additional information prescribed includes foreign remittance made by any person through an authorised dealer, breakup of the salary with deductions claimed by the employee, information in ITR of other taxpayers, interest on Income Tax Refund, information published in Statement of Financial Transactions.

Also, off market transactions reported by depository registrar and transfer agent, information about dividend of mutual fund reported by RTA, and information about purchase of mutual fund reported by RTA too would be included in Form 26AS.

The CBDT authorized "Director General of Income-tax (Systems) to upload information...in her/his possession, in the Annual Information Statement in Form 26AS in the electronic filing account registered by the assessee in designated portal, within three

Form 26AS is an annual consolidated tax statement that can be accessed from the income-tax website by taxpayers using their Permanent Account Number

in which the information is received by her/him.'

The Budget 2020-21 had introduced a new Section 285BB in the I-T Act, to revamp Form 26AS to an 'Annual Information Statement' which apart from TDS TCS details, would contain comprehensive information of specified fi nancial transactions, payment of taxes, demand refund and pendingcompleted proceedings undertaken by a taxpayer in a particular financial year that has to be mentioned in income tax returns

AMRG & Associates (Director - Direct & International Tax) Om Raipurohit said the additional information to be loaded on the Annual Information Statement in Form 26AS would promote ease of faceless digital assessments.

Even though additional tax contributions from taxpaver's would be insignificant, cumulative effect would be noteworthy. This change will push all the taxpayers towards a precise and accurate_ self-declaration of income earned, Rajpurohit added.

11 ATHLETES RECOMMENDED FOR KHEL RATNA, WHILE 35 FOR ARJUNA AWARD Pramod, Neeraj in contention

New Delhi, Oct 27: Odisha superstar para shuttler Pramod Bhagat and Tokyo Olympics gold medallist javelin thrower Neeraj Chopra are among 11 athletes, who are recommended for Major Dhyan Chand Khel Ratna award, the country's highest sporting honour, Wednesday

Pramod, the reigning World Champion, became the first para shuttler to claim the vellow metal for India. It was a historic moment considering badminton was making its debut at the Paralympics. The World No.1 won the gold in SL3 category at the Tokyo 2020.

Neeraj, on the other hand, became only the second Indian to win an individual Olympic gold at the Tokyo Games. It was also the first medal for the country in athletics at the Summer Games. Olympics silver medallist

wrestler Ravi Dahiya has also been recommended for the Khel Ratna, along with boxer Lovlina Borgohain, who won a bronze at the





Games, seasoned hockey goalkeeper country's first footballer to be se-PR Sreejesh and woman cricket Test skipper Mithali Raj. Iconic lected for the honour.

Shooter Avani Lekhara and Manish Narwal, javelin thrower Sumit Antil and Krishna Nagar, who all have won a gold each in the Tokyo Paralympics, completed the list of those recommended for the Khel Ratna.

Last year, five athletes were picked for the award while four were selected after the 2016 Rio Games

The announcement of the national sports awards was delayed in order to consider the performance of the para athletes in the Tokyo Paralympics (August 24 to September 5).

The committee also picked 35 athletes for the Arjuna award, eight more than last year's number of awardees.

Cricketer Shikhar Dhawan, para TT player Bhavina Patel, para shuttler Suhas Yathiraj and high jumper Nishad Kumar are among those selected for the Arjuna award. Members of the men's hockey team that won a historic bronze in the Olympics will also receive Arjuna award.

Nishant enters 2nd round

Belgrade, Oct 27: Debutant Nishant Dev (71kg) became the seventh Indian boxer to enter the second round of the AIBA men's World Championships with a confident 5-0 triumph over Hungary's Laszlo Kozak here Wednesday.

Dev will next fight Mauritian Merven Clair: who got a bye in the first round, and his victory maintained the unbeaten run of the country's pugilists at the ongoing showpiece. Dev's win was a perfect start to

the day for the country after Sumit (75kg) and Narender Berwal (+92kg) advanced to the second round of their respective categories with fine victories late last night.

Sumit defeated Jamaican Damon O'Neill 5-0 while Narender faced some stiff challenge from Poland's Oskar Safaryan before recording a 4-1 win

Sumit will face Tajikistan's Abdumalik Boltaev in the next round, while Sierra Leone's Mohamed Kendeh awaits Berwal.

Four others, including Asian medal winners Shiva Thapa (63.5kg) and Deepak Bohria (51kg), had made the second round of their categories earlier in the tournament.



Later this evening, Varinder Singh will take on Karen Tonakanyan of Armenia in his 60kg opening bout. Govind Sahani (48kg) and Lakshya Chahar (86kg) are the other two Indians who will be seen in action Wednesday night.

Chahar will face Korea's Kim Hyeonkyu. Sahani, on the other hand, will fight it out against Ecuador's Billy Arias in a round of 32 contest. All three are making their debuts at the global showpiece.

With more than 600 boxers from over 100 countries in fray, a lot of competitors will have to win at least three bouts in some categories to get to the quarterfinal stage.

The gold winners at the showpiece will walk away with a prize money of USD 100,000. The silver medallists are to be given USD 50,000, and both bronze-medallists will be awarded USD 25,000 each. The total prize purse stands at a whopping USD 2.6 million.

After an even contest in the first two sets, the decider started with a high intensity as Momota made it 11-10 at the break. The Indian moved to 19-17 but a couple of errors cost him the match.
