CDS' CHOPPER CRASH DUE TO PILOT ERROR

NEW DELHI: The IAF chopper crash December 8 that killed Chief of Defence Staff Gen Bipin Rawat and 13 others was due to an unexpected change in weather that led to spatial disorientation of the pilot, stated preliminary findings submitted by the triservices court of inquiry. "The tri-services court of inquiry into the Mi-17 V5 accident December 8, 2021, has submitted its preliminary findings," the IAF's statement said Friday. "The accident was a result of entry into clouds due to unexpected change in weather conditions in the valley. This led to spatial disorientation of the pilot resulting in Controlled Flight into Terrain," it stated.



BISHOP ACQUITTED IN NUN RAPE CASE

KOTTAYAM: A court in Kerala Friday acquitted Roman Catholic Bishop Franco Mulakkal of the charges of raping a nun in a convent in the southern state. As the prosecution failed to produce evidence against the accused, the Additional District and Sessions Court I, Kottayam, acquitted the Bishop. Mulakkal, 57, was accused of raping the nun multiple times during his visit to a convent in this district when he was the Bishop of the Jalandhar diocese of the Roman Catholic church. A visibly relieved and emotional Mulakkal, who arrived in the court to hear the verdict, burst into tears, hugged his followers and lawyers, sharing his joy over the verdict.

No. 1 Djokovic double faulted

Melbourne, Jan 14: Novak Djokovic faces deportation again after the Australian government revoked his visa for a second time, the latest twist in the ongoing saga over whether the No 1-ranked tennis player will be allowed to compete in the Australian Open despite being unvaccinated for Covid-19.

Immigration Minister Alex Hawke said Friday he used his ministerial discretion to cancel the 34year-old Serb's visa on public interest grounds — just three days before play begins at the Australian Open, where Djokovic has won a record nine of his 20 Grand Slam titles.

Djokovic's lawyers were expected to appeal at the Federal Circuit and Family Court, which they already successfully did last week on procedural grounds after his visa was first canceled when he landed at a Melbourne airport.

Deportation from Australia car lead to a three-year ban on returning to the country, although that may be waived, depending on the circumstances

Hawke said he cancelled the visa on "health and good order grounds, on the basis that it was in the public interest to do so.

Cops cane protesters



Police resort to lathicharge on protesters at Dhinkia village, Friday

Kujanaga, Jan 14: Tension prevailed at Dhinkia village under Ersama block in Jagatsinghpur district Friday as hundreds of residents including women and children staged protests against a proposed JSW Steel project.

Police resorted to lathicharge to disperse the protesters. Many villagers, including women, were injured in the lathicharge. The scuffle between Dhinkia villagers and the police took place when the latter tried to stop the former at the entry point of the village from taking out a rally against the project.

The police barged into Dhinkia and charged the protestors with batons sparing none, not even women and children forcing them to run helter-skelter.

 $Police\,arrested\,some\,leaders\,such$ as Debendra Swain, Muralidhar Sahu, Narendra Mohanty and Tirtha Mallick. Fifteen platoons of police along with ASP Nimai Charan Sethi have been deployed in the area. Police had allegedly damaged three gates for the village. Since no gov-

ernment ambulance reached the hired to help the injured reach hospital. Tension prevailed in the area while policemen patrolled. It is said that the police will conduct a flag march and set up a camp at Dhinkia village. The eviction drive was carried out without consultation with betel farmers who are likely to be affected due to the proposed project, locals alleged. Demolition of betel plantations was arbitrary and part of the local administration's foul plan to speed up land acquisition, they added. "The only source of our livelihood was destroyed. It has now become impossible for us to eke out our livings. We have been rendered helpless," a betel farmer of Dhinkia village said.

Tension earlier also prevailed in Dhinkia following a violent scuffle between the residents and local police December 20, 2021. Dhinkia villagers had then vehemently opposed the local administration's decision to demarcate its boundary. They were irked over the arrest of two villagers who were leading the people against the project.

Budget Session of Parl begins Jan 31

New Delhi, Jan 14: The Budget Session of the Parliament will commence January 31 with the address of the President to both the Houses, and conclude April 8, sources said Friday citing recommendation of the Cabinet Committee on Parliamentary Affairs.

The Union Budget will be presented February 1. The Economic Survey is likely to be tabled January 31. The first part of the session would conclude February 11. After a month-long recess, the part two of the session would begin from March 14 and conclude April 8.

■ 223 people died due to extreme weather events in Odisha in 2021, according to an IMD report. The state followed Maharashtra which reported 350 deaths

New Delhi, Jan 14: India saw 1,750 deaths due to extreme weather events in 2021, with Maharashtra being the worst-affected state with 350 fatalities, followed by Odisha and Madhya Pradesh, the India Meteorological Department said Friday.

The Met Department said 223 people died due to extreme weather events in Odisha. Thunderstorms and lightning reportedly claimed 787 lives in India last year, while 759 people died in heavy rainfall and flood-related incidents, it said.

Cyclonic storms claimed 172 lives and 32 others died due to other extreme weather events, according to the IMD's annual climate statement.

Heavy rainfall and flood relatedincidents claimed 215 lives in Maharashtra, 143 in Uttarakhand, 55 in Himachal Pradesh, 53 in Kerala and 46 in Andhra Pradesh, according to the report. Thunderstorms and lightning claimed 213 lives in Odisha, 156 in Madhya Pradesh, 89 in Bihar, 76



2021 fifth warmest year since 1901

NEW DELHI: The year 2021 was the fifth warmest in India since 1901, with the country recording its annual mean surface air temperature at 0.44 degree Celsius above normal, the India Meteorological Department said Friday. "The year 2021 was the fifth warmest year after 2016, 2009, 2017 and 2010 since 1901. The annual mean air temperature for the country was recorded at 0.44 degree Celsius above normal," the MeT department's annual climate statement stated. "The winter (January to February) and post-monsoon (October to December) seasons with all India mean temperature anomalies of 0.78 degree Celsius and 0.42 $\,$ degree Celsius respectively mainly contributed to this warming," it said. In 2016, the annual mean surface air temperature for the country was 0.710 degree Celsius above normal. It was 0.550 degree Celsius and 0.541 degree Celsius above the average temperature in 2009 and 2017, respectively. In 2010, the mean annual air temperature stood 0.539 degree Celsius above normal, it said.

in Maharashtra, 58 in West Bengal, 54 in Jharkhand, 49 in Uttar Pradesh and 48 in Rajasthan.

The Met Department said 223 people died due to extreme weather events in Odisha, 191 in Madhya Pradesh, 147 in Uttarakhand, 102 in Bihar, 98 in Uttar Pradesh, 92 in Gujarat and 86 in West Bengal.

Sixty-seven died in Kerala, 62

in Rajasthan, 59 in Himachal Pradesh, 57 in Jharkhand, 50 in_ Andhra Pradesh, 45 in Karnataka, 34 in Tamil Nadu, 32 in Jammu and Kashmir, 25 in Telangana and 14 in Assam. Of the seven deaths recorded in Delhi due to extreme weather events, four occurred because of heavy rainfall and flooding, the IMD data showed.

Containment zones up as Covid surges

Odisha logs 10,273 new Covid-19 cases and four more deaths, while containment zones in Bhubaneswar rise to 160, the most ever since the outbreak of the disease

Bhubaneswar, Jan 14: Amid rising cases of Covid-19 in the state capital, the Bhubaneswar Municipal Corporation (BMC) declared 11 more residential areas as containment zones.

While six micro containment zones have come up under SouthEast Zone in Unit 9, Satya Nagar, Laxmi Sagara, Sriram Nagar; four areas have been demarcated as micro containment zones in Naharkanta, Maitree Vihar, and Patia under North Zone. Moreover, the regional office of a bank has been declared micro containment zone in IRC Village, Nayapalli.

With this, the total containment zones in the state capital have reached about 160. Bhubaneswar now has the most number of containment zones in the state ever since the outbreak of Covid-19. The civic body has increased enforcement squads under its jurisdiction to check the spread of virus.

Odisha Friday recorded 10,273 new Covid-19 cases, 214 more than the previous day, with the tally ris-

ing to 11,11,879, a health department bulletin said.

The death toll mounted to 8,476 as four more persons succumbed to the disease, the highest singleday COVID fatalities in more than two months, it said. The daily test positivity rate (TPR) rose to 13.57 per cent from 12.41 per cent the previous day, the bulletin said. At least 1,065 children were among the newly-infected patients.

Khurda district, which comprises the state capital Bhubaneswar, reported one-third of the fresh infections as 3,496 people were afflicted with the disease. There were 1,049 new cases in Sundargarh, 844 in Cuttack, 529 in Sambalpur and 457 in Balasore.

Health Services Director Bijay Mohapatra stressed on the need to avoid overcrowding in hospitals and urged people with minor symptoms to avail telemedicine services instead of visiting the outpatient departments in health facilities.



London, Jan 14: As Boris Johnson's 'partygate' troubles mount and members of his own Conservative Party demand he step down as the British Prime

Minister, one name is doing the rounds as a frontrunner to take charge - his Indian-origin Chancellor and Downing Street neighbour Rishi Sunak,

The UK-born son of a pharmacist mother and a National Health Service (NHS) general practitioner (GP) father is an Oxford University and Stanford graduate. He is married to Akshata Murty, the daughter of Infosys co-founder Narayana Murthy, and the couple has two young daughters Krishna and Anoushka. The MP for Richmond in Yorkshire first entered the UK Parliament in 2015 and has quickly risen up the Tory party ranks as a staunch Brexiteer, who had backed Johnson's strategy to leave

the EU. "From working in my mum's

tiny chemist shop to my experience building large businesses, I have seen how we should support free enterprise and innovation to ensure Britain has a stronger future," Sunak had said during the Brexit referendum.

He co-founded a 1-billion-pound global investment firm and specialised in investing in small British businesses before his entry into politics. As the first Chancellor of the Exchequer of Indian heritage, Sunak made history in February 2020 when he was appointed to the most important UK Cabinet post. If the Tory party murmurings and bookie betting odds are anything to go by, then the 41-year-old may well be in line to make history as Britain's first Indian-origin Prime Minister.

"No, definitely not. Seeing what the Prime Minister has to deal with, this is a job hard enough for me to do," Sunak said back in October 2020, when asked if he had prime ministerial ambitions. But a lot has happened since, with Sunak leading the charge for the country's economic fightback against the Covid-19 pandemic.

Many of the schemes he put in place as finance minister, including the furlough-based Coronavirus Job Retention Scheme and Covid support grants for struggling businesses over the course of several lockdowns have proved largely popular. However, proposed tax hikes coming up from this April and consistently rising energy and cost of living costs have proved less popular within the Conservative Party base.

The famously lowtax favouring Tories may find his high tax plans to recoup some of the lost economic ground during the pandemic hard to digest when things really come to a leadership scrum. In fact, there is already talk within the party ranks of him having overplayed his hand by not speaking out more firmly in support of 57-year-old Johnson, following his Parliament apology earlier this week over a Downing Street garden party

in apparent breach of lockdown rules. He has also often spoken about himself as a

'proud Hindu', most recently when he unveiled a new 5-pound commemorative coin celebrating the life of Mahatma Gandhi for Diwali last November.

State, WFP to help farmers adapt to climate variability

Bhubaneswar, Jan 14: The United Nations World Food Programme (WFP) and the state government have joined hands to improve the food security of small and marginal farmers by strengthening their resilience to climate change. An agreement was signed by

Agriculture Director Muthu Kumar and WFP Country Director Bishow Parajuli at a virtual programme Thursday, the UN agency said in a release.

In a pilot initiative, advisories will be provided to small farmers of the state, which is particularly prone to cyclones, to help them adapt to the impacts of the climate crisis.

Small farmers, who constitute 90 per cent of the peasant community in Odisha, will be able to select the right agriculture and livelihood options to improve their food security and incomes, it said.

"The impact of climate change disproportionately affects the livelihoods and food security of small and marginal farmers. The WFP and the Department of Agriculture will collaborate on strengthening adaptation to climate variability and management of food systems by building capacity and reducing inequalities in the process," Parajuli said.

The WFP and the Agriculture Department will develop toolkits, modules, and guidelines during the project to provide services to small farmers.

It will help the farming communities in the state make informed decisions for a transformation towards a more productive and resilient agricultural system.

"The partnership will contribute to inclusive growth and resilience in agriculture, thus contributing to improved food security," Kumar added.

Decoding the legal bar in decades old Kotia dispute

New Delhi, Jan 14: In 2020-21, Andhra Pradesh issued a notification to hold local body elections in the state which ignited a fresh spark in the decades old border dispute with Odisha over Kotia group of villages.

The Kotia group of villages, according to Odisha, are under the administrative control of Koraput district. The villages are part of Pottangi Assembly and Koraput Lok Sabha constituencies. In March 2020, Andhra issued a notification for holding local body elections in Kotia group of villages as the state claimed they are part of Salur Assembly and Araku Parliamentary constituency in AP.

In order to stop alleged trespassing by Andhra Pradesh, Odisha in 2021 moved Supreme Court seeking contempt action against Andhra Pradesh for issuing notification for holding elections in three villages of Kotia panchayat.

Odisha argued in the Supreme Court that Andhra violated the Supreme Court judgement dated March 30, 2006 in which the SC had asked both the states to maintain status quo.

However, Andhra Pradesh refuted Odisha's claim and termed the petition grossly misconceived. Andhra submitted that the apex court hadn't passed any order in 2006. It had only recorded the statements of both the states after it dismissed the original suit filed by Odisha on the ground that it was not maintainable under Article 131.

While the contempt petition is pending in the apex court, Odisha has recently filed a fresh suit in the SC under Article 131 over Kotia dispute.



Bone of contention

Odisha had filed the first original suit under Article 131 in the apex court in 1968 against Andhra Pradesh over Kotia dispute. Odisha relied upon several pre-Independence era treaties and notifications to press their claim over the disputed territory.

The notification no. 251/1920 and notification no. 257/1920 passed by the Governor-in-Counsel, Madras Presidency, mandated that the disputed villages fall under the Potangi Taluk of Koraput district of Orissa, Odisha submitted in the court.

However, the apex court dismissed the suit in 2006 saying that it is not maintainable under Article 131 in view of the bar contained in proviso of the Article.

Significantly, Article 131 grants original jurisdiction to the Supreme Court in any dispute between Union and a state or between two or more states. But there is a proviso which reads as, "The jurisdiction shall not extend to a dispute arising out of any treaty, agreement, covenant, engagement, sanad or any other similar instrument which, having been entered into or executed before the commencement of this

Constitution".

The apex court non-suited Odisha on the ground that since the claim of the state is based on notifications, which essentially are in the nature of instruments.

In order to get the border dispute resolved, Odisha filed another original suit in January this year wherein it pleaded the apex court to strike down or read down the Article 131 of the Constitution.

"Indeed the proviso to Article 131 of the Constitution of India misconstrued to render Odisha remediless. Therefore the proviso to the Article 131 is liable to be struck down or read down in the manner by which judicial remedy is provided to the plaintiff for adjudication of the disputed encompassed," Odisha submitted in the fresh original suit.

Odisha contended in the fresh suit that the cause of action arose within the jurisdiction of Supreme Court only to try the present suit under Article 131 of Constitution of India after either declaring the proviso to the said Article unconstitutional or reading down. The suit is yet to be taken up for hearing by the Supreme Court.

4 automobile firm staff held for ₹31L fraud

Bhubaneswar, Jan 14: Laxmisagar police Friday claimed to have arrested four employees of an automobile agency for allegedly misappropriating Rs 31 lakh.

The accused were identified as Deepak Ranjan Rout of Cuttack's Banki, Ganeswar Pradhan of Nuasahi in Nayagarh, A Jagadish Achary of Sriramnanagar in Old Town area here and Santosh Kumar Behera of Banki in Cuttack.

According to sources, Tarini Motors Private Limited general manager Muhammad Sadik had approached the Laxmisagar police January 12 alleging Deepak, Ganeswar, Jagadish and Santosh, who had been working at the accounts section of the agency, of misappropriating Rs 31 lakh by forging the company's cash book January 10, 2022.

"A case (11/2022) was registered under Sections 408 (criminal breach of trust), 420 (cheating) and 34 (acts done by several persons in furtherance of common intention) of the IPC. During investigation, we learnt that the four managed to embezzle around Rs 31 lakh of the company," a Laxmisagar police official exid

CDMOs to verify disability certs

Bhdarak, Jan 14: The disability certificates of 110 students who have taken admission to the Plus-III course in Bhadrak Autonomous College on the basis of 'disability certificates' will be verified. The district administration has ordered for verification of their disability certificates as it has been alleged that they are fake.

It may be noted that students had staged protests January 10 in front of the collector's office, alleging that about 200 students with poor marks have taken admission by furnishing forged disability certificates while many meritorious students have been deprived of admission in the college

Bhadrak Town police registered a case January 12 against five people who had issued death threats to some students who had exposed the illegalities in the admission process through an RTI. IIC Umashankar Nayak has registered a case against the five people under sections 506 and 34 of IPC on the complaint of death threats.

The matter came to the fore after some students identified as Diptiman Jena, Gyanaranjan Parida, Satyajit



Rout and Abinash Ram filed an application in the college under the RTI Act. The complainants have alleged that they were threatened with dire consequences as some ruling party leaders are involved in the scam associated with the admission process.

The controversy came to light January 10 when students staged a demonstration outside the district collectorate office protesting the alleged irregularities in ad-

mission. The students had submitted a memorandum to District Collector Trilochan Majhi demanding an investigation into the 'fake disability certificate' racket which they claimed had been going on for the last four years. They also demanded the arrest of some ex-students who are involved in the act. The RTI revealed that students with 40 per cent marks have got admission by producing fake disabilities (PWD) certificates

Principal Umakant Samal said that the college has no role in the admission process. He added that it is done through SAMS by checking documents of the students.

Following a directive from the Collector, the college authorities have recommended verification of disability certificates of 110 students to the chief district medical officers (CDMO) of three districts Bhadrak, Balasore and Mayurbhanj These students had taken admission in the college by furnishing disability certificates in 2019-20, 2020-21 and 2021-22. The CDMOs have been asked to verify the disability certificates and submit reports.


Omicron cases rising in Mayurbhanj, Nabarangpur

Calls for cooling-off period for babus

alls for a mandatory cooling-off period for babus before joining politics have revived after two senior babus in Uttar Pradesh took voluntary retirement (VRS) and decided to join politics, with an eye on the upcoming Assembly elections in the state.

Hours after the model code of conduct was effected, Asim Arun, the recently named Police Commissioner of Kanpur, sprung a surprise by announcing that he had applied for Voluntary Retirement Scheme (VRS) from the IPS and that the BJP was considering fielding the 1994-batch officer as its candidate from the Kannauj Sadar constituency.

Almost at the same time, the Joint Director of Enforcement Directorate (ED) Rajeshwar Singh has said that his request for VRS has been accepted. It is being hinted that Singh is preparing to jump into the poll fray from the Sahibabad constituency. He joined the ED in 2009 and was absorbed into the ED cadre in 2015. During his stint at ED, he investigated several high-profile cases including the 2G spectrum allocation case, the 2010 Commonwealth

Games scam, and cases against prominent politicians such as former Finance Minister P Chidambaram and others.

Last year none other than the Central Vigilance Commission (CVC) had directed that a cooling-

In the aftermath of the security breach during Prime Minister Narendra Modi's visit to Punjab last week, the state government has transferred seven IPS officers, including SSP of Ferozepur Harmandeep Singh Hans, under whose jurisdiction the security lapse happened in which Modi's convoy was stranded on a flyover for 20 minutes. But the public 'bloodletting' continues amid the politicking and sniping between the Centre and the Charanjit Singh Channi government in Punjab.

Punjab Director General of Police Siddhartha Chattopadhyay has been replaced by Viresh Kumar Bhawra for a tenure of two years, barely weeks before the state Assembly elections, and just before the poll code of conduct came into play. In the dizzy pace of events, Chattopadhyay considered by some to be close to Punjab Congress state chief Navjot Sidhu, was removed and Channi has managed to get his guy in.

The Ministry of Home Affairs (MHA) has constituted a three-member committee led by Sudhir K Saxena, Secretary (Security), Cabinet Secretariat, and

comprising of Joint Director of the Intelligence Bureau (IB) Balbir Singh and IG of the Special Protection Group S Suresh to enquire into what the Centre terms as serious lapses in the security arrangements by the Punjab government during Modi's visit. Meanwhile, Channi who blames the SPG for the incident has formed his

inquiry committee under retired High Court judge Mehtab Singh Gill. But it has been put on hold after the Supreme Court stepped in. Further, the MHA is likely to use the SPG Act against Punjab Police officers and has summoned

In this game of political one-upmanship, some heads will roll - there has to be some accounting after all – and efforts will be made to spin out the controversy for as long as possible for the electoral advantage it offers to the politicians. But equally vital would be to contain the damage swiftly before further harm is done to relations between the border state and the Centre. Not to forget the obvious damage this episode has done to the reputations of the SPG, the MHA, and the IPS.

Storm over. Kerala babu reinstated

The Kerala government has decided to reinstate bureaucrat M Sivasankar, ho was suspended for his alleged role in the high-profile gold smuggling case. An order revoking the suspension was issued by the state Chief Secretary VP Joy after Chief Minister Pinarayi Vijayan approved an official recommendation.

Sivasankar, who was Principal Secretary to Vijayan at the time, was suspended from service in July 2020, after investigators alleged that he was involved in the appointment of the prime accused in the gold smuggling case. It was being said that he had flouted rules in government projects. The case had rocked Kerala's ruling party - CPI(M). He will be back in service now that his suspension is revoked. Sources say that Sivasankar's suspension would have ended in July 2021 but was extended for another six months. He was in jail for 98 days and was later released on bail February 4, 2021. Earlier too, Sivasankar as IT Secretary had been absolved of any wrongdoing about the data transfer of Covid patients by a government committee led by former Law Secretary K Sashidharan Nair.

Clearly, after having got caught in that maelstrom of controversy and given that attempts to nail it on him haven't quite stuck, it looks like he has got a reprieve. But will it hold? No one knows yet. His new posting has not been revealed yet and he has another one year left in his service.

here really is an American bird called the catbird, a member of a group" called the mimic thrushes that also includes the mockingbirds and thrashers, all of them - as their group name suggests - skilled at imitating other birds, animals, and even telephones and other noises. The American species is strictly speaking the grey cathird, which lavs the most beautiful turquoise eggs. It's called a catbird because one of its most impressive imitations is the mew of a cat. Catbird seat (as it is usually written) usually appears in the fuller form in the catbird seat, meaning to be in an advantageous or prominent position, one of ease and favour. Its first appearance in print was in a famous short story of that title by James Thurber, published in the New Yorker on November 14, 1942. The phrase is said to derive from the habit of the catbird of sitting on the highest point it can find to deliver its song, thus suggesting an effortless superiority. SUBMERGED BY COVID

PROBLEMS

he wildfire spread of the Omicron variant adds a new element of uncertainty to the global economy. But when it comes to emerging markets, the consensus view is that these countries' prospects remain bright. JP Morgan Global Research expects their collective GDP to grow by 4.6% this year, faster than its 2015-19 trend. S&P Global Ratings is even more bullish, projecting that emerging economies will expand by 4.8%.

Strikingly, these growth figures are virtually identical to the forecasts for 2022 released by the International Monetary Fund in October 2019 - that is, before the pandemic. It has become a popular trope that COVID changes everything-or, rather, everything except the outlook for emerging markets.

In fact, there are multiple reasons for worrying that this consensus is too rosy.

First, emerging economies are now more heavily indebted. Publicdebt-to-GDP ratios were already rising before the onset of the pandemic. But now they have reached alarming heights, at more than 60% of GDP.

While no one doubts the wisdom of borrowing to respond to a public health emergency and economic crisis, these heavy debts pose management problems. Scarce fiscal resources that might otherwise be devoted to health care. education, and infrastructure will have to be diverted to debt service. And the burden will grow heavier as tighter monetary policy by the US Federal Reserve and capital scarcity worldwide put upward pressure on interest rates.

Moreover, public debt is only part of the problem. Since the onset of the pandemic, the debts of households and nonfinancial corporations have risen nearly as rapidly as the debts of public sectors. It is likely that when some of these private debts go bad, the losses will be socialised and end up on government balance sheets.

The second reason to be skeptical of the consensus on emerging markets is that the risk of working in close quarters has spurred accelerated automation



Major economic forecasters like JP Morgan and S&P Global Ratings are painting a rosy picture of emerging markets' growth prospects this year. But there are multiple reasons to believe that the consensus view will soon prove to be

unsustainable

in advanced economies. Because the need for close hand-eye coordination previously frustrated such efforts, the traditional route to higher incomes for emerging markets and developing countries has run through the export of labour-intensive manufactures. Although these industries do not require heavy investments or highly skilled labour, they familiarise workers with factory discipline, enable learning by doing, accustom firms to competing on global markets, and generate foreign exchange.

The fear is that these manufactures will soon be produced by robots and 3D printers in the same high-wage countries where they are sold. This prospect reinforces established concerns about "premature de-industrialisation" in emerging markets.

The global supply chains so important to emerging economies experienced major disruptions because of the pandemic, leading firms to source inputs closer to home. Developed-country governments, for their part, have cited shortages and economic-

security concerns as justification for creating incentives for firms to onshore more manufacturing production.

For emerging markets, the negative effects are not unlike those of accelerated automation. Many low- and middle-income countries start with simpler assembly tasks before moving into more sophisticated manufacturing operations. These opportunities will be fewer to the extent that advanced economies do more assembly at home.

Mexico may benefit from efforts by the US firms to shorten their supply chains. Eastern European economies may benefit from an analogous desire on the part of EU countries. But South Asia, Africa, and Latin America may find themselves cut off.

Above all, there is the impact of COVID-19 on human capital formation. Though negative everywhere, the effects are likely to be especially severe in emerging markets. Few emerging markets possess the high-speed broadband needed for effective distance learning. A slower pace of vaccina-

tion will mean continuing school closures and absenteeism. According to an estimate by the World Bank, the share of children in emerging markets and developing countries unable to read and understand a simple text by the age of 10 will increase from 53% to 63% as a result of the pandemic.

The most powerful counterargument is that emerging markets will benefit from a supercharged global economy. Productivity growth in the advanced economies, which had been trending downward for several decades, was strong during the pandemic, especially in the United States Technological and organisational changes prompted by the pandemic could now sustain that acceleration. Faster growth in developed countries would then create additional demand for emerging-market exports.

At this stage, this argument is purely hypothetical. The recent pickup in advanced-economy productivity growth is entirely attributable to business-cycle factors - most recently to firms using their resources more intensively as economies bounce back from their 2020 lows. In fact, the productivity trend looks much like it did in earlier cyclical recoveries - meaning that there is no evidence of a durable acceleration.

But all is not doom and gloom In contrast to earlier downturns central banks and governments in emerging markets have been able to respond in stabilising ways, reflecting their success at building credibility. So far, the bank failures and financial accidents that historically punctuated such episodes have been few and far between. Vaccine production and administration are ramping up. That said, downward revisions of growth forecasts are almost certainly coming.

Reserve Bank must prevent capital flight

committee established by the Reserve Bank of India (RBI) has given four arguments to allow free movement of capital from and to India to foreign countries. The first argument given by the committee is that free movement of capital will increase the availability of capital in the country. It will encourage foreign investors to invest in India. However, this alleged benefit is disproved by RBI's own data that shows that the capital account has been continuously negative in the last 2 years. Free movement of capital is leading to the flight of capital from; not be other way around.

The second argument given by the committee is that free movement of capital will reduce the cost of capital. This too is not correct because the outward flow of capital is reducing the availability of capital in India and, accordingly, the cost of capital in India is rising, not falling. The third argument is that it will make it possible for Indian companies to borrow in foreign countries and diversify their borrowing. This is correct. However, the fact that more capital is going out of the country means that diversification is not proving helpful in attracting foreign capital. The fourth argument is that free movement of capital will allow Indian investors to diversify their investment portfolios. At present, Indian investors may be investing in property and share market in India. After free movement of capital the Indian investors can invest in property in New York and in shares in the New York Stock Exchange. This benefit is correct. However, this is only beneficial for the richer section of the society because they alone have the capacity to invest in foreign countries. Outward foreign investment can prove to be beneficial to them but not to India. The arguments given by the committee of the RBI in favour of free movement of capital are certainly not beneficial for the country. Contrary to RBI's harmful policies, the International Monetary Fund has advocated that the developing countries should consider imposing restrictions on free movement of capital to foreign countries in situations such as COVID pandemic. They have referred to the experience of Korea and Peru that have imposed such restrictions with beneficial results.

The policy of the RBI is also against its own recommendations. The committee has said that it is necessary to contain the fiscal deficit along with allowing free movement of capital. We know very well that the fiscal deficit of our country is increasing rapidly since the COVID pandemic. On the one hand, the RBI is saying that free movement of capital should not be allowed if fiscal deficit is not controlled: on the other hand it has increased the limit of the money that an Indian national can remit to the foreign countries for investment under the Liberalised Remittance Scheme despite the increase in the fiscal deficit.

An article in the Journal of Indian Association of Social Science Institutions has given four reasons for the flight of capital from India. First is corruption. The cost of doing business in a country is higher if there is corruption and foreign investors do not want to invest here. Second is increase in government debt. This means that (1) the government will have to borrow more money; (2) the RBI will have to adopt easy money policies to make available the money that is borrowed by

inflation and to the devaluation of Indian rupee: (4) reduce the value of the investment that the foreign investors may have made in India leading to loss for them. Third is negative capital account. A negative capital account leads to more outflow. One foreign investor follows the other in taking capital out of India because negative capital account leads to devaluation. Fourth is the adoption of free trade. Reason is that if our economy is not competitive then we will lose our ground in the global market and this will lead to capital flight. I would like to add a fifth reason which is social conflict in the country. The social atmosphere has become so negative that foreign investors may not like to come. The time is at hand for the RBI and the Government of India to reconsider the policy of free movement of capital, which is leading to capital flight and lower rates of growth in the country.

Digital currency

Sir, For a student of political economy, cryptocurrency means a form of government where the real leaders are hidden. The 'fertile' brains of some shady money dealers comprising industry big shots, business leaders and underworld dons have found a new mode of financial transactions which would exist outside the control of governments. This mode of exchange or so called digital currency is known as cryptocurrency. This decentralised system allows transactions to bypass detection in the prevailing economic set-up. In fact, Internet banking or transactions using debit or credit cards - commonly termed as digital economy - also reflect in the system as valid transactions. On the contrary, the newly discovered cryptocurrency operates outside the system amidst a few digitally connected elements. No doubt this system will generate black money. EC eases norms

New Delhi: The Election Commission Friday announced reducing the notice period for registration of new political parties in the five poll-going states from 30 days to 7 days, keeping in view difficulties caused by COVID-19-induced curbs. In a statement, the EC explained that under the existing guidelines, a party seeking registration has to submit an application to it within 30 days following the date of its formation.

Naxal arrested

Mumbai/Nagpur: A Naxal with Rs 2 lakh reward on his head was arrested Friday in a joint Gadchiroli police-CRPF operation in Maharashtra, an official said. Karan alias Dulsa Narote is a member of the Naxal 'action team' and was originally with self-styled platoon number 14 of Gatta Dalam of the outlawed movement, he said. "Narote was held in a joint operation by Gadchiroli police and the CRPF from Pomke Gatta area in Etapalli. He is involved in 16 serious offences, comprising six murders, four encounters, two robberies, three involving arson and one kidnapping, said Gadchiroli Superintendent of Police Ankit Goyal.

Three killed

Gurugram: Three brothers have been killed in a road accident after the motorcycle they were riding was hit by an unknown vehicle here in Sector-92, the police said Friday. The deceased individuals have been identified as 30-year-old Sudhir Pandit, 28year-old Randhir Pandit and 25vear-old Saniav Pandit -- all from Madhubani district of Bihar.

Over 400 injured during kite-flying

Ahmedabad: At least 451 people sustained injuries in kite-flying accidents during the Uttaravan festivities in Guiarat Friday, an official said, Till late evening, the "108" emergency ambulance service shifted 224 people, mostly commuters on roads, to nearby hospitals after they sustained cuts on their throats and faces due to kite strings hanging in public places, it was stated.

Delhi court junks bail plea

New Delhi: A court here Friday refused to grant bail to engineering student and 'Bulli Bai' app creator Neeraj Bishnoi, who was arrested by the Delhi Police from Assam for creating a platform for defaming women of a particular community. Noting that the accused ran a vilification campaign against the dignity of the women of a particular community containing derogatory material through the app affecting communal harmony of the society, Chief Metropolitan Magistrate of Patiala House Courts, Pankaj Sharma, denied the bail application.

No foul play: Inquiry report

New Delhi, Jan 14: The IAF chopper crash on December 8 that killed Chief of Defence Staff (CDS) Gen Bipin Rawat and 13 others was due to an unexpected change in weather that led to spatial disorientation of the pilot, stated the preliminary findings submitted by the tri-services court of inquiry.

"The tri-services court of inquiry into the Mi-17 V5 accident on December 8, 2021, has submitted its preliminary findings," the Indian Air Force's statement said Friday.

The court of inquiry has ruled out mechanical failure, sabotage or negligence as a cause of the accident, it said. "The accident was a result of entry into clouds due to unexpected change in weather conditions in the valley. This led to spatial disorientation of the pilot resulting in Controlled Flight into Terrain (CFIT)," it stated.

According to US aviation regulator FAA, CFIT is defined as an unintentional collision with terrain -- the ground, a mountain, a body of water, or an obstacle -- while an aircraft is under positive control. The IAF said that the inquiry team analysed flight data recorder and cockpit voice recorder besides questioning all available witnesses to determine the most probable

"Based on its (preliminary) findings, the court of inquiry has made certain recommendations which are being reviewed," the IAF mentioned. Gen Rawat, his wife Madhulika, his defence advisor Brigadier LS Lidder, staff officer to the Chief of Defence Staff, Lt Col Harjinder Singh and decorated pilot Group Captain Varun Singh were among 13 others killed in the crash near Coonoor in Tamil Nadu.

The government is yet to appoint a new CDS. The court of in-

quiry into the crash was headed by Air Marshal Manavendra Singh. Air Marshal Singh, currently heading the Bengaluru-headquartered Training Command of the IAF, is known to be one of the best air crash investigators in the country

Before taking the reins of the Training Command, the Air Marshal was the director general (inspection and safety) at the air headquarters and he developed various protocols for flight safety while serving in the post.

Akhilesh takes a swipe at Yogi

Lucknow, Jan 14: Akhilesh Yadav Friday taunted the BJP for losing "one wicket after the other" and not fathoming the SP strategy as he inducted two ministers and six other MLAs who recently deserted the ruling alliance into his Samaiwadi Party

Apart from the six BJP MLAs mostly from the Other Backward Classes - a legislator from BJP ally Apna Dal (Sonelal) also joined the SP at a large public meeting in the compound of the party office here, defying Covid norms.

An official said the local administration is investigating the "violation". The Election Commission has banned election meetings till January 15. In apparent deference to the EC order, the meeting was called a "virtual rally" and a "press conference", going by the banner behind the dais.

"The BJP wickets are falling one after the other. Our 'baba' CM doesn't know how to play cricket. Even if he knew, he has dropped the catch," the SP president commented on Yogi Adityanath, the face of the ruling party in the UP polls.

Yadav also mocked the chief minister over his "80 versus 20" remark, suggesting that Adityanath should get himself a math teacher. The CM had recently said 80 per cent of the voters will be on the BJP's side and the remaining 20 percent against it in next month's

Plane collision averted in Dubai

The planes had come on the same runway during take-off from the airport. The Directorate General of Civil Aviation (DGCA) has asked UAE's General Civil Aviation Authority (GCAA) to share its investigation report on this incident.

DGCA chief Arun Kumar said on Friday: "Both are their registered aircraft and the place of occurrence is their airport and so, as per ICAO (International Civil Aviation Organisation), it will be investigated by them."

"However, we have asked then to share the investigation report as and when available," he mentioned. The two Emirates jets that had a close shave on January 9 were the Dubai-Hyderabad flight (EK-524) and the Dubai-Bengaluru flight (EK-568), sources said.

Docs' open letter: India overdoing testing, medication

New Delhi, Jan 14: A group of around 35 doctors from across the country have written an open letter to the union health ministry over the unwarranted testing, medication and hospitalisation during the ongoing Covid pandemic and sought urgent intervention for an evidence-based response to the cur-

"While there continues to be much uncertainty amidst the outbreak of this novel disease, there is now substantive high-quality scientific literature that provides unequivocal guidance on the clinical management of Covid-19. Despite the weight of this evidence

The letter says that the vast majority of Covid patients with asymptomatic and mild symptoms will require little to no medication

and the crushing death toll of the delta wave, we find the mistakes of the 2021 response being repeated in 2022", said the open letter.

The doctors have identified three main issues of unwarranted medication, unwarranted tests and unwarranted hospitalisation.

The letter says that the vast

majority of patients with Covid-19, with asymptomatic and mild symptoms, will require little to no medication. "Most prescriptions we have reviewed in the past two

weeks include several Covid-19 "kits" and cocktails. The prescribing of vitamin combinations, azithromycin, doxycycline, hydroxychloroquine, favipiravir,

and ivermectin for treating Covid-19 is irrational practice. Such wanton use of drugs is not without harm as the Delta wave has shown. Outbreaks of opportunistic fungal infections like mucormycosis in India, and aspergillosis in Brazil were attributed to the widespread abuse of inappropriate medications", said the letter.

Dr Anant Bhan, Yenepoya (deemed to be University), Mangaluru, one of the signatories, said that with almost two years of dealing with the pandemic behind us, it's extremely important that we ensure that evidence based medical and policy decisions are made.

5 kg IED recovered near Indo-Pak **border in Punjab** —

Chandigarh, Jan 14: An improvised explosive device (IED) and some Indian currency notes were found Friday concealed in a bag lying on the Attari-Bachiwind road in Punjab's Amritsar, close to the India-Pakistan border, a senior police official said.

The Special Task Force of Punjab Police launched a search operation based on a specific input about drugs and explosives and recovered the bag, just a month before the assembly polls in Punjab.

After the recovery of the IED in Amritsar, the police have cordoned off the area. "...The IED weighing 5 kg...Was found concealed in a bag on Attari-Bachiwind Road. Some Indian currency notes were also found inside," Assistant Inspector General of STF Rashpal Singh, who was present at the site, said over phone.

He said experts and bomb-disposal squad members were called to the site and further investigation is underway. On Thursday, close on the heels of busting a terror module backed by the International Sikh Youth Federation (ISYF), Punjab Police had said it seized 2.5 kg of RDX, besides arms and ammunition, on the disclosure of the prime accused in two recent incidents of

hurling of grenades in Pathankot. Police had also seized a detonator, a detonating cord, five explosive fuses along with wires and 12 live cartridges of AK-47 rifles, Director General of Police (DGP) V K Bhawra said here on Thursday.

The explosive material was to be used in assembling IEDs, police had said."The recovery was made on the disclosure statement of accused Amandeep Kumar alias Mantri of village Lakhanpal in Gurdaspur, who is the prime accused in the two recent incidents of grenade attacks in Pathankot," the DGP was quoted as saying in a statement issued by the state police.

Custody of bride's jewellery for safety is not cruelty: SC

New Delhi, Jan 14: Taking custody of daughter-in-law's jewellery for safety cannot constitute cruelty under Section 498A of the Indian Penal Code, the Supreme Court

A bench of Justices Indira Banerjee and J K Maheshwari said that failure to control an adult brother, living independently, or giving advice to adjust to sisterin-law to avoid retaliation cannot constitute cruelty to the bride within the meaning of Section 498A of the IPC.

Section 498 A refers to husband or relative of husband of a woman

subjecting her to cruelty. The case was lodged by a woman against her husband and in-laws for subjecting her to cruelty.

The apex court's observations came while hearing an appeal against an order passed by the High Court of Punjab and Haryana dismissing a plea by a man seeking permission to return to the US, where he is employed.

The high court had rejected the man's prayer to leave the country as he was arrayed as an accused along with his elder brother and parents under sections Sections 323 (voluntary causing hurt), 34 (common intention), 406 (criminal breach of trust), 420 (cheating) 498A and 506



(criminal intimidation) of the Indian Penal Code.

"Taking custody of jewellery for safety cannot constitute cruelty within the meaning of Section 498A of the IPC. "Failure to control an adult brother, living independently, or giving advice to the

complainant to adjust to avoid vindictive retaliation cannot constitute cruelty on the part of the Appellant within the meaning of Section 498A of the IPC," the apex court bench said in a recent order.

It said the complainant (daughter-in-law) has not given any particulars of the jewellery that had allegedly been taken by her mother-in-law and brother-in-law. There is not a whisper of whether any jewellery is lying with the petitioner, it said.

There is only a general omnibus allegation that all the accused ruined the life of the complainant by misrepresentation, concealment, etc... "The Appellant is not liable for the acts of cruelty, or any other wrongful and/or criminal acts on the part of his parents or brother," the apex court said. The top court said considering the nature of the allegations, it is not understood how and why the petitioner should have been detained in India. "In our considered opinion, the Chief Judicial Magistrate, Kurukshetra, erred in directing the appellant not to leave the country without prior permission of the Court. It said the allegations in the com-

plaint against the petitioner prima facie do not disclose any offenceunder Section 498A of the IPC. which contemplates cruelty.

called and they were heard. Franco had approached the Kerala High Court and also the Supreme Court to quash the FIR against him, but both the courts failed to do so and the trial began.

Meanwhile, the former Kottayam SP of Police Harisankar who oversaw the probe said he was supremely confident that the verdict would be against the accused. "This was the least expected as

the witnesses did a very clean job. An appeal should be filed," said Harisankar. "This is an extremely unfortunate verdict, it is shocking for us. We had expected a conviction fully. We will appeal. We had a lot of corroborative evidence. All the witnesses in the case were ordinary people," investigating officer S Harisankar, former Kottayam SP, told reporters.

The public prosecutor informed the media that an appeal would be filed. Meanwhile, the acquittal of Bishop Franco Mulakkal here triggered emotional reactions Friday as nuns who support the survivor expressed shock and dismay over the verdict and said they would continue the fight till justice is prevailed while the jubilant bishop urged followers to 'praise the lord and be happy'.

A group of nuns of Kuravilangad Convent here, who have been standing with the survivor in her fight, were on the verge of tears when they said they were yet to believe such a verdict came out from the court and they did not know what has happened. Some of his followers were even seen crying out of joy knowing the acquittal of the Bishop. The survivor and her supporters stay in the Kuravilangad convent in this south Kerala district.

Sister Anupama, who was the face of the nun's years-long fight for justice, said they would surely challenge the verdict in the higher court and take forward the fight of their hapless colleague.

"We will continue our stay in the convent and take forward our fight till our sister gets justice. Police and prosecution showed justice to us but we did not get the expected justice from the judiciary," the teary-eved nun told reporters. In a broken voice, she also said the verdict gives them a message that ordinary mortals like them should never break their silence against any injustice and fight a case whatever happened to them in the life.

"Those who are wealthy and influential can do anything in this society. That is what we see around us now. We have never felt anything strange till the time of argument of the case. We believe it was sabotaged after that," she said.

BMC cracks the whip on 'unreported' cases

The commissioner of Brihanmumbai Municipal Corporation issued orders and asked chemists and others to share the data with FDA and BMC's Epidemiology Cell via email every day

Mumbai, Jan 14: Taking a serious view of the massive spike in Covid-19 cases in the past fortnight, the BrihanMumbai Municipal Corporation (BMC) has cracked the whip on "unreported" home tests that prevent tracking of infected persons or their contacts, officials said here Friday.

The BMC has ordered all retail manufacturers/distributors of such home testing kits sold to pharmacies, chemists or dispensaries to inform the Food & Drugs Commissioner and the civic body's Epidemiology Cell of the same.

The civic authorities said that all Covid-19 positive tests either through Rapid Antigen Test Kits or Home Test Kits, were expected to be reported to the ICMR by the concerned laboratory or the individuals who are found infected.

However, there are suspected to be instances of persons testing positive on Home Test Kits which have not been brought to the notice

This has resulted in no tracking of such patients and the infection keeps spreading through their contact, making it difficult to contain the spread of the virus, said BMC Commissioner IS Chahal.

chemists/pharmacies/medical stores/dispensaries to provide details of such Home Test Kits sold to the customers to the FDA and Epidemiology Cell in a prescribed format. The retailers shall also issue a bill to the concerned buyer and maintain a record of such sales.

The FDA Commissioner is entrusted with monitoring the sales and distribution of the Home Test Kits and informing the persons concerned to report the test outcome on a given app.

The Epidemiology Cell will collate the data received through email from the manufacturers/distributors, forward them to the concerned BMC Ward Medical or Health Officers for further actions like monitoring the health of the person/s testing positive and uploading their data on ICMR or app.

The latest BMC orders came as the state remained in the 46K range of daily Covid-19 infections in the ongoing third wave, with the infection spreading at a much faster rate than the two previous waves, despite the vaccination process going on rapidly.

In Maharashtra, Mumbai, Pune, Thane and Nagpur continue to be the worst-hit districts besides the added complications of 1,367___ Omicron cases in the state.



"As technology is advancing rapidly, we should consider how it can be used for giving more and more services to public...Mumbai is number one municipal corporation in the country, ," he said.

Khan said that the witnesses who turned hostile are invoking the names of Bharatiya Janata Party-RSS to "malign the Maharashtra government and ATS" to gain political mileage in the Uttar Pradesh elections next month, and urged the probe agency (ATS) must take note of this.

The September 29, 2008 (Malegaon 2008) bomb blast was allegedly engineered in this minority-dominated Nashik town by Hindu fundamentalists, killing 6 and injuring over 100 others, during Ramadan month when Muslims were breaking their fast.

The Maharashtra Police and then the ATS probed the case and in 2011 it was taken over by the NIA, and the trial is being conducted on a daily basis at the Special NIA Court in Mumbai.

"Of the 223 witnesses examined. 16 have turned hostile, claiming that the ATS tortured them to give evidence against the accused,' Khan added.

Complete projects as per law: HC to Kerala govt

Kochi, Jan 14: Projects of the "magnitude" like that of SilverLine "cannot be hurried" or "completed on war cries", rather they have to be carried out in accordance with the law if they need to have any legitimacy, the Kerala High Court said to the state government.

The remarks by Justice Devan Ramachandran came while hearing several pleas challenging the manner in which the state and the Kerala Rail Development Corporation Ltd (K-Rail) were carrying out land surveys in connection with the LDF government's ambitious semi high speed rail corridor project — SilverLine

"No project of this magnitude can be completed by war cries, it has to be done as per the law. A project of this nature cannot be hurried. It has to be as per the law, and then only will it have any legitimacy. You have to follow the law to the hilt.'

"Such projects cannot be taken forward based on fear by putting up such large poles," the court said and added this was by far the biggest project in the state and hopefully "they (state and Centre) are doing it with their eyes wide open"

The petitioners had opposed putting up of large concrete poles to mark the land surveyed for the SilverLine project saying it was in violation of the Survey and Boundaries Act and these structures were blocking access to various individuals' properties.

The court, December 23 last year, had directed the state and K-Rail to install survey stones of the prescribed standards under the Kerala Survey Rules.

BJP wants Thackeray Issues women face in Kerala cinema to delegate powers

Mumbai, Jan 14: Opposition BJP Friday said Maharashtra Chief Minister Uddhav Thackeray should delegate his powers to someone, who can attend daily meetings and visit places instead of him.

Therefore, Thackeray should delegate his powers to someone who can attend daily meetings and sometimes visit some places in the state.'

"He is like our friend, so I wish him a speedy recovery. However, the task of managing and controlling

the state, which has a population of around 12 crore, cannot be done just by sitting at home. Such responsibilities should be taken more seriously," he said.

Commenting on Shiv Sena leader Sanjay Raut's criticism of the BJP, Patil said, "Raut should understand that his party is losing due to this coalition government. A Sena candidate cannot win the election of Mumbai Bank, while an NCP

candidate becomes its chairman.' If Sena is contesting upcoming elections in Goa and UP, it is merely to win certain number of votes in order to get the tag of a national party.

A government panel will examine Hema Commission's report on problems faced by women in the *Malayalam film industry*

Kochi, Jan 14: The Left government in Kerala recently formed a three-member panel to study and work out a plan to implement the recommendations of the Justice Hema Commission report which delves deep into the problems faced by women in the Malayalam film industry. The move came over two years after the report was submitted to the government in December, 2019.

February 17, 2017, a prominent woman actor was abducted and sexually assaulted for nearly two hours in a moving car near Kochi. Weeks later, Dileep, a leading actor in the Malayalam film industry, was arrested and arraigned as the eighth accused in the case with charges of abduction, conspiracy, criminal intimidation among oth-

ers. The SIT, which probed the case, argued that Dileep ordered the attack on the woman actor as he nursed a grudge against her.

The incident was significant in throwing a spotlight on the safety of women in the state as well as the issues faced by women in the state's film industry, which is largely seen as a male-dominated space operating without a legal framework. In the aftermath of the sexual assault incident, the Women in Cinema Collective (WCC) was founded with the aim of propelling changes within the film industry to make it more gender-friendly. The WCC, consisting of female actors, producers, directors and technicians, appealed to the Pinarayi Vijayan government to appoint a panel to investigate the discrimination faced by women in the industry. In July, 2017, a three-member commission was formed by the government headed by Justice K Hema (retired) with former bureaucrat KB Valsalakumari and veteran actress Sharada as members. It was the first time a commission of this

kind was formed anywhere in India to scrutinise the inner workings of a film industry.

The Justice Hema Commission interviewed dozens of members of the Malayalam film fraternity including both male and female actors, producers, directors and technicians to probe the quality of the work environment and the nature of problems they face on a daily basis. According to reports, several women actors recounted to the commission horror stories of the harassment they faced on sets on the condition that their names are kept confidential. Issues of wagegap on the basis of gender, absence of adequate facilities for women on sets and the lack of a proper forum for grievance redressal were

also brought to the forefront. The Commission submitted a 300-page-long report to Chief Minister Pinarayi Vijayan December 31, 2019, accompanied by a large set of documents, screenshots and audio clips that substantiate the findings of the report. While the report was not made public, the Commission was learnt to confirm the existence of a 'casting couch' within the industry.

New Delhi, Jan 14: The National Security Guard and the Special Cell of the Delhi Police Friday averted a major terror attack in the Ghazipur Flower Market area of the national capital by defusing a 3-kg Improvised Explosive Device planted in the crowded market.

The IED, which was found concealed in an unattended bag at the Ghazipur Flower Market, triggered panic among the residents of the capital less than a fortnight ahead of January 26, Republic Day.

But how did the police find it? The bag was first spotted by a local vendor, however, he did not pay any heed to it and left. When he returned after sometime, the bag was still there after which he informed a civil defence volunteer in the area who then made a PCR call around 10.16 a.m. The Delhi Fire Service (DFS) was also informed at the same time. A DFS official confirmed to IANS that they received a call around 10.20 a.m. about an unattended bag at the Ghazipur Flower Market after which one fire engine was rushed to the spot.

With suspicions mounting the Delhi Police alerted the anti-terror force -- NSG -- about the suspicious object around 11 a.m. which sent its bomb disposal squad equipped with a bomb disposal container called

Containment Vessel (TVC).

The NSG is a world class federal contingency force which deals with anti-terrorist activities in all its manifestations. The Delhi Police deployed its anti-terror unit, the Special Cell, to deal with the situation. Over 30 policemen, wearing a green jacket having 'Special Cell' printed on it, swarmed the entire area. The police cordoned off the area for the safety and security of the people. Heavy police presence in and around the area made things look very serious at that time. The NSG personnel, wearing the Explosive Ordnance Disposal (EOD) suit or bomb suit, were also at the spot.

Then the NSG bomb disposal squad with the help of the police personnel dug an approximately 8 feet ditch in an open ground where the bag carrying the IED was dumped. At sharp 1.30 p.m. a loud thud was heard after which everybody heaved a sigh of relief. The NSG conducted a controlled explosion of the recovered IED in that ditch, saving several lives that could have been snuffed out if the bomb had not been found and defused in time. National Security Guard Director General MA Ganapathy said that the explosives-laden bag contained a mixture of RDX and Ammonium Nitrate. "Prima facie it looks like RDX & Ammonium Nitrate mix weighing around 3 kgs," Ganapathy informed.

Cong faces tough battle in Goa

New Delhi, Jan 14: The Congress is facing a tough battle in Goa while trying to be ahead of the BJP as the Trinamool Congress and the Aam Aadmi Party are spoiling the grand old party's game in the state.

The Trinamool is alleging that the Congress was not been able to form the government in the state in 2017 and could not even retain its flock of MLAs. But, the Congress



BJP TO FIGHT 38 OUT OF 40 SEATS

Panaji: The Bharatiya Janata Party (BJP), which currently rules Goa, has decided to contest 38 out of the total 40 Assembly seats in the state, where elections will be held next month, a senior party functionary said Friday. The office-bearer said that in two constituencies - Benaulim and Nuvem - the party will not field any candidate on its symbol. Traditionally, people in Benaulim and Nuvem constituencies vote for non-BJF candidates. These two are Christian-dominated seats. Currently, Benaulim is represented by Churchill Alemao, who after getting elected on the Nationalist Congress Party (NCP) ticket, shifted to the Mamata Banerjee-led Trinamool Congress (TMC) last month, while Nuvem constituency is represented by Wilfred D'Sa, who had won the last election as a Congress candidate, but later joined the ruling BJP.

has not accepted the open offer and party General Secretary K.C. Venugopal has said that there are no talks with the Trinamool. Congress senior observer P. Chidambaram too has ruled out such a possibility.

Train accident: Toll goes up

Kolkata, Jan 14: The death count in the Guwahati-Bikaner Express train accident in north Bengal climbed to nine and the officials said tracks have been cleared for traffic. Union Railway Minister Ashwini Vaishnaw arrived at the spot Friday.

Twelve coaches of the Guwahati-Bikaner Express derailed in the Domohani area of West Bengal's Jalpaiguri district on Thursday evening. "This is a tragic incident. It is very unfortunate. A statutory enquiry has already been ordered. The Hon'ble Prime Minister has been concerned about the death and the injured passengers and I am continuously in touch with the Prime Minister. I am also in touch with the ground situation and today I have come to find out the root cause of the accident. Once it is detected we will try to solve it so that there is no such accident for similar reasons,' Vaishnaw said after reaching the accident spot.

Nine persons died and another 36 persons were injured in the accident. According to sources in the Railways, the condition of 15 persons is serious.

"The injured people have been sent to Jalpaiguri Super Speciality Hospital and North Bengal Medical College," a senior official of North Frontier Railways said.

India, Japan maritime drill in Bay of Bengal

The exercise was aimed at trengthening bilateral relations. promoting defence cooperation, enhancing mutual understanding and interoperability between the two navies and sharing best practices.

The maritime partnership exercise included a wide range of maritime operations, flying operations, replenishment approaches and tactical

manoeuvres 'The entire exercise was planned and conducted in a non contact mode, thereby adhering to Covid safety norms," Indian Navy said.

Last year India and Japan Maritime Bilateral Exercise, JIMEX, between the Indian Navy (IN) and the Japan Maritime Self-Defence Force (JMSDF) was held in Arabian Sea from October 6 to October 8.

JIMEX series of exercises commenced in January 2012 with special focus on maritime security cooperation. The last edition of JIMEX was conducted in September 2020.

Major rise in bail pleas due to liquor law: Patna HC to SC

New Delhi, Jan 14: The Patna High Court has told the Supreme Court that there is "phenomenal increase" in filing of bail applications due to the enforcement of prohibition in the state and roughly 25 per cent of regular bail pleas are being filed under the Bihar Prohibition and Excise Act alone.

The high court said it is working with less than half of its sanctioned strength and the increase in filing of bail applications is causing delay in disposal of regular bail pleas. It informed the apex court that at present 39,622 bail applications, which include 21,671 anticipatory and 17,951 regular bail applications, are pending before the assigned benches. Further, 36,416 fresh bail applications, including 20,498 anticipatory and 15,918 regular bail applications, are yet to be taken up.

January 11, a bench headed by Chief Justice of India (CJI) N V Ramana had in another matter dismissed a batch of petitions of Bihar government challenging grant of anticipatory and regular bails to accused under the state's stringent liquor law, saying these matters have choked the courts.

A bench of Justices Ajay Rastogi and Abhay S Oka, expressed serious concern over the delay in pendency of bail applications before the high court and the long incarceration of undertrial prisoners due to delay in hearing of their bail applications.

Do-or-die poll battle on cards in Uttarakhand

Dehradun, Jan 14: With the ruling BJP fiercely defending its throne and the opposition Congress desperate to avenge its 2017 humiliation, a do-or-die battle is on the cards on February 14, when the two parties grapple with each other yet again in the Uttarakhand Assembly polls.

The largely bipolar politics of the state involving the two national parties, which have been alternately in power, has got a new twist this time with Arvind Kejriwal's Aam Aadmi Party (AAP) also in the fray, offering itself as an alterna-

tive to the Congress and the BJP. While the Bharativa Janata Party (BJP) has set itself a target of winning more than 60 of the 70 Assembly seats in the state, poll observers feel it is unrealistic on the part of the saffron party, which is totally ignoring the anti-incumbency factor.

According to poll commentator JS Rawat, repeating its tally of 57 seats in the last Assembly polls could be a tall order for the BJP. Even the Modi factor, which was behind the party's comprehensive win in the last polls, is not as strong as it was in 2017, he said.

The rollback of three contentious agriculture laws may have done some damage control, but the farmers in some of the seats in the Kumaon belt, including Chief Minister Pushkar Singh Dhami's Khatima constituency, have been able to keep the issue alive to a great extent, he added.

State BJP spokesperson Shadab Shams expressed confidence that the jinx of the party in power losing at the hustings every five years will be broken this time in Uttarakhand."We did it in the 2019 general election, in which we retained all the five Lok Sabha seats in the state, and we will do it again.

It is not such a big deal," he said. Apart from the Modi magic, which the party feels is intact, another factor that will work in its favour is the "double-engine" government due to which the hill state has seen "unprecedented" development in terms of road, rail and air connectivity, despite prolonged Covid lockdowns, Shams said, in a reference to the BJP being in power both at the Centre and in the state.

Routed at the hands of the BJP in the last Assembly polls and deserted by party heavyweights, a resurgent Congress on the other hand faces the uphill task of avenging its ignominious defeat in 2017.

Former chief minister Harish Rawat, who had lost from both the seats he had contested in 2017, is spearheading the party's poll campaign in the state. But the Congress had no other option as it has no bigger face than Harish Rawat, whose stature among the state party leaders remains unparalleled.



This is the second fire to erupt at the Mina al-Ahmadi oil refinery in as little as three months. In October, the state-owned oil company reported a fire had erupted at the facility, with some workers suffering from smoke inhalation and others being treated for light burns.

Kabul, Jan 14: In Afghanistan's heavily patriarchal, male-dominated society, where women and girls are usually relegated to the home, bacha posh, Dari for "dressed as a boy," is the one tradition allowing girls access to the freer male world

On Wednesday, the governor of the Central Bank Ajith Nivard Cabraal said that the island nation is negotiating a \$1 billion loan from India to import goods from the country. The Indian High Commissioner to Sri Lanka Gopal Baglay met Cabraal Thursday and "expressed India's strong support to Sri Lanka in the wake of RBI extending over \$900 million facilities over the last week". "These comprise deferment of Asian Clearing Union settlement of over \$509 million and currency swap of \$400 million," the tweet said. Cabraal Wednesday said that billion-dollar loan negotiations with India had reached its advanced stage.

Commenting on India's gesture, analysts here said the Indian assistance could have contributed to Sri Lanka's doubling of reserves announced at the end of December.

The central bank said that the reserve position had doubled to \$3 billion from being down to \$ 1.5 billion by December or sufficient for just a month's imports.

Johnson faces fresh 'partygate' allegations

Opposition is keeping up the pressure on Johnson, with Liberal Democrat Leader Ed Davey demanding his immediate resignation

London, Jan 14: British Prime Minister Boris Johnson Friday faced mounting leadership pressure amid further allegations of parties held at his Downing Street office-residence by staff, categorised as a "partygate" scandal due to the apparent serial breaches of lockdown rules in place at the time.

'The Daily Telegraph' reported on two farewell parties made up of about 30 people drinking alcohol and dancing to music until the early hours of April 17 last year, the night before the funeral of Prince Philip - the Duke of Edinburgh's funeral. Downing Street said the timing was "deeply regrettable' and that it had apologised to Buckingham Palace.

"It is deeply regrettable that this took place at a time of national mourning and Number 10 has apologised to the Palace," the UK Prime Minister's spokesperson said. "You heard from the Prime Minister this week, he's recognised Number 10 should be held to the highest standards and take

responsibility for things we did not get right," the spokesperson said. It is understood that a call from the Prime Minister's office was made to the Palace Friday. Restrictions at the time banned indoor mixing between different households and Queen Elizabeth II sat alone during the church ceremony for her late husband in keeping with social distancing rules.

'This event should not have happened at the time that it did. I am deeply sorry, and take full responsibility," said James Slack, the UK Prime Minister's former Director of Communications, at the centre of the farewell that led to the party last April. Slack, now deputy editor-in-chief at 'The Sun' newspaper, apologised "unreservedly for the anger and hurt caused".

While Prime Minister Johnson was not at either of the two gatherings in April 2021 as he was spending the weekend at his Buckinghamshire country estate Chequers, the latest revelations add to the saga around rules being broken at the heart of the UK government



Washington, Jan 14: Disappointed after months of engagement, a US House panel has slammed YouTube parent company Alphabet, Meta (formerly Facebook), online discussion forum Reddit and Twitter for failing to provide additional information on how those platforms were used to organise violent events at the US Capitol January 6 last year.

Chairman Bennie G. Thompson (D-MS) announced that the Select Committee has issued subpoenas to four social media companies as part of its investigation into the January 6 attack on the US Capitol and its causes.

After inadequate responses to prior requests for information, the Select Committee is demanding records from Alphabet, Meta, Reddit, and Twitter relating to the spread of misinformation, efforts to overturn the 2020 election, domestic violent extremism, and foreign influence in the 2020 election.

Cyberattack in Ukraine targets govt websites

Kyiv, Jan 14: A huge cyberattack left a number of Ukrainian government websites temporarily unavailable Friday, officials said.

Ukrainian Foreign Ministry spokesman Oleg Nikolenko told The Associated Press it was too soon to tell who could have been behind the attack.

"But there is a long record of Russian cyber assaults against Ukraine in the past," he said. Moscow had previously denied involvement in cyberattacks against Ukraine.

Cabinet, seven ministries, the Treasury, the National Emergency Service and the state services website, where Ukrainians' electronic passports and vaccination certificates are stored, were temporarily unavailable Friday as a result of the hack. The websites contained a message in Ukrainian, Russian and Polish, saying that Ukrainians' personal data has been leaked into the public domain.

"Be afraid," warned a message on the defaced Foreign Ministry website, a day after talks between the West and Moscow aimed at preventing a Russian invasion hit an impasse

Communication and Information Protection said that no personal data has been leaked.

The country's minister for digital transformation, Mykhailo Fedorov, insisted that personal data was safe, since "the operability of the websites, not the registries," was affected by the hack. Fedorov said that some of the attacked websites were blocked by their administrators in order to contain the damage and investigate the attacks. He added that "a large part" of the affected websites have been restored.

Seoul, Jan 14: North Korea fired two suspected ballistic missiles eastward Friday, after Pyongyang publicly warned earlier in the day of a "stronger and certain" response to the new US sanctions, South Korea's military said.

The Joint Chiefs of Staff (JCS) said the short-range projectiles

were launched from Uiju in North Pyongan Province, a northwestern region bordering China, and that they flew around 430 km at an altitude of 36 km, reports Yonhap News Agency.

It detected one of the missiles at 2.41 p.m and the other at 2.52 p.m. The missiles flew at top speed of around Mach 6, six times the speed of sound, according to officials.



The North's latest firing marks its third show of force this year.

The North fired what it claimed to be hypersonic missiles January 5 and Tuesday. South Korea's military is monitoring related North Korean movements and maintaining a firm readiness posture, the JCS said.

Earlier in the day, Pyongyang

Washington slapped the sanctions on six North Koreans involved in the regime's weapons of mass destruction and ballistic missile programs Wednesday. Meanwhile, the US Indo-Pacific Command said that it is aware of the missile launches, but assessed they do "not pose an immediate threat to American personnel or territory or

killed in battle years ago are rotting in food freezers outside a Libyan city while authorities work out what to do with them, a grim reminder of the disarray a failed election was meant to address.

Instead, Libya's conflict rumbled on, frontlines shifted. governments changed and financial crises came and went. The corpses, meanwhile, began to decompose, as power supplies to refrigerated containers were interrupted.



New Delhi: Tata Consultancy Services promoters - Tata Sons and Tata Investment Corporation Ltd (TICL) - intend to participate in the IT services major's ₹18,000 crore buyback offer by tendering shares worth about ₹12.993.2 crore. On Wednesday, the TCS board approved an up to ₹18,000 crore buyback offer entailing 4 crore shares at ₹4.500 apiece. According to a postal ballot notice by the company, Tata Sons and TICL intend to participate in the buyback offer. Tata Sons, which holds about 266.91 crore shares, intends to tender 2.88 crore shares, while TICL intends to tender 11,055 shares, it added.

PV sales slide 13% in Dec

New Delhi: Passenger vehicle dispatches from factories to dealers declined 13 per cent to the lowest level in five years in December last year as the industry continued to face production issues due to semiconductor shortage, auto industry body SIAM said Friday. Passenger vehicle dispatches last month stood at 2,19,421 units compared to 2,52,998 units in December 2020. As per the latest data from the Society of Indian Automobile Manufacturers (SIAM), twowheeler wholesales also fell 11 per cent to 10,06,062 units in December 2021.

New Delhi, Jan 14: The country's exports in December 2021 surged 38.91 per cent on an annual basis to \$37.81 billion, the highest-ever monthly figure, due to healthy performance by sectors such as engineering, textiles and chemicals, even as the trade deficit widened to \$21.68 billion during the month. government data showed Friday.

Imports in December 2021 also increased 38.55 per cent to \$59.48 billion, on account of an increase in petroleum and crude oil imports, which soared 67.89 per cent to \$16.16 billion. Gold imports expanded by 5.43 per cent to \$4.72 billion.

During April-December 2021-22, exports rose 49.66 per cent to \$301.38 billion. Imports during the period surged 68.91 per cent to \$443.82 billion, leaving a trade

deficit of \$142.44 billion, the data showed. The trade deficit in December 2020 was \$15.72 billion.

Merchandise exports in December 2021 were \$37.81 billion, as compared to \$27.22 billion in December 2020, exhibiting a positive growth of 38.91 per cent. As compared to December 2019, exports in December 2021 exhibited a positive growth of 39.47 per cent, the commerce ministry said in a statement.

New Delhi, Jan 14: The Centre will make it mandatory for carmakers to provide a minimum of six airbags in motor vehicles that can carry up to 8 passengers for enhanced safety of occupants, Union Minister Nitin Gadkari said Friday.

In a series of tweets, the Road Transport and Highways Minister said his ministry had already mandated the implementation of fitment of the driver airbag with effect from July 1, 2019 and front co-passenger airbag with effect from January 1, 2022. "In order to enhance the safety

of the occupants in motor vehicles carrying upto 8 passengers, I have now approved a Draft GSR Notification to make a minimum of 6 Airbags compulsory," Gadkari said. GSR here stands for General Statutory Rules.

He further said that to minimise the impact of frontal and lateral collisions on the occupants seated in both front and rear compartments.



two side curtaintube airbags covering all outboard passengers. This is a crucial step to make motor vehicles in India safer than ever, he said. According to Gadkari, this will ultimately ensure the safety of passengers across all segments, irrespective of the costvariant of the vehicle

His remarks had come against the backdrop of the automobile industry raising concerns that high taxation and stricter safety and emission norms for vehicles have made their products expensive. "Mostly, lower middle-class people buy small economy cars and if their car won't have airbags and when accidents happen, then it may result in deaths. New norms for bank investments

The new bank portfolio classification norms will come into effect from April 1, 2023

Mumbai, Jan 14: The Reserve Bank of India (RBI) Friday proposed new norms for the classification and valuation of the investment portfolio of banks, with a view to align them with the global prudential framework and accounting standards.

According to the proposed norms, the investment portfolio of banks will be divided into three categories — held-to-maturity (HTM), available for sale (AFS), and fair value through profit and loss account (FVTPL). Within FVTPL, held-for-trading (HFT) shall be a subcategory aligned with the specifi cations of 'Trading Book' as per the Basel-III framework.

The new norms propose to bridge the gap between the existing guide-

Commenting on the survey findings, Sanjay Kumar, Partner, Deloitte Touche Tohmatsu India LLP, said, the economy has witnessed a steady recovery during 2021-22. Moreover, most of the business leaders anticipate that the increasing startup activity, coupled with the government's stimulus packages and policies, will push the ease of doing business in India, resulting in a quick economic revival. Kumar added.

As per the survey, about 59 per cent respondents believe that India provides a favourable atmosphere to run a business. Encouraging digitalisation, simplifying tax regimes, and improving land and labour laws would help enhance the ease

of doing business in India, it said. DTTILLP said the survey aimed to analyse the industry's expectations from the upcoming budget, with the standpoint of economicgrowth, the ease of doing busi-

SOUTH AFRICA DENY INDIA THEIR FIRST-EVER SERIES WIN IN THE RAINBOW NATION YET AGAIN WITH A COMFORTABLE SEVEN-WICKET VICTORY IN THE SERIES-DECIDING THIRD AND FINAL TEST

Cape Town, Jan 14: A South African team going through one of its toughest transition phases embarrassed a star-studded Indian team with a clinical seven-wicket victory in the third Test to clinch a memorable 2-1 series triumph here Friday.

The target of 212 wasn't a tough ask and starting the day at 101/2, young pretender Keegan Petersen (82, 113b, 10x4) along with Rassie van Der Dussen (41 n o, 95b, 3x4) added 54 runs for the third wicket to seal the match before Temba Bavuma (32 n o, 58b, 5x4) helped in putting the final touches.

Petersen walked away with both the player of the match as well as player of the series honours.

Sunil Gavaskar termed it as a 'Nightmare for India' as they were not even close to competing in the last two Tests and Dean Elgar's ear to ear grin and the bear hugs that he shared with his teammates said it all.

It was especially sweet for the hosts who lost premier pacer Anrich Nortje to injury before the series and were then hit by Quinton de Kock's sudden mid-series retire-

The Indian team, meanwhile, lost it in their mind after the contentious DRS review of Elgar that went wrong Thursday and their focus on using stump microphone more to take digs at broadcaster Supersport instead of focussing on getting Petersen out spelt their

With this series defeat, India's record of never having won a Test series in the Rainbow Nation for three decades, remained intact. MS Dhoni is the only India captain to have managed a drawn series back in 2010.

It was one of the strongest Indian teams on paper against one of the weakest South African teams on paper. However, the operative word here was 'on paper' as Elgar's unheralded bunch showed a lot of character in punching above their weight and also getting heavily rewarded for their relentless efforts.

The mindless chatter and incessant sledging didn't bother the likes of Petersen and Van der Dussen as they went about their job in a thoroughly professional manner.

India's batters were far too dependant on bowlers to bail them out for the past few years but this series showed that this attack is human too even though they put

India begin campaign against SA at U-19 WC

Georgetown (Guyana), Jan 14: Record four-time champions India will be aiming to maintain their envious record and unearth a plethora of talent along the way when they begin their U-19 World Cup campaign against South Africa here Saturday.

Expectations will be high from the likes of Harnoor Singh, Rajvardhan Hangargekar, skipper Yash Dhull and Ravi Kumar, who have already shown glimpses of their potential in tournaments leading into the World Cup.

India flew into the Caribbean straight after their Asia Cup triumph and tuned up for the ICC event with wins over hosts West Indies and Australia in the warmup games. India have been the most successful team in the tournament's history and getting into the final of the last three editions is a testimony to their remarkable consistency.

to their remarkable consistency.
No player from the 2020 batch,
which finished runners-up to firsttime champions Bangladesh, has
gone on to play for India and only time
will tell if someone from the class of

2022 reaches the highest level.

The current batch doesn't possess prodigies like Prithvi Shaw and Shubman Gill (2018 pass outs) but some of the players have already attracted attention. Jalandhar-born left-hand opener Harnoor is expected to score a bagful of runs in the tour-

nament, much like what Yashasvi Jaiswal did in the previous edition.

The 18-year-old was India's leading run-getter in the Asia Cup with 251 runs in five games and struck an unbeaten 100 against Australia in the team's final warm-up game January 11. Right-arm pacer Hangargekar, who has played senior cricket for Maharashtra, is another player to watch out for. He impressed with his raw pace in the Asia Cup, picking up eight wickets, and is also a handy batter down the order.

Left-arm pacer Ravi Kumar will also be expected to provide timely breakthroughs and he will be high on confidence following a fourwicket haul against the Australians.

Skipper Dhull, who is a highly rated batter in Delhi cricket circles, did not do anything noticeable in the Asia Cup but his backto-back fifties in the warm-up games show he is in good touch. Allrounder Raj Bawa, who bowls right-arm medium pace and bats left-handed, will also play a crucial role for the team.

Sindhu, Sen in India Open semis

New Delhi, Jan 14: Two-time Olympic medallist PV Sindhu and World Championship bronze medallist Lakshya Sen registered contrasting wins to advance to the women's and men's singles semifinals, respectively, at the Yonex-Sunrise India Open badminton here Friday.

Top seed Sindhu, a former world champion, got the better of compatriot Ashmita Chaliha 21-7, 21-18 in 36 minutes, while Sen rallied his way to a hard-fought 14-21, 21-9, 21-14 victory over HS Prannoy in another all-Indian quarterfinals.

The 26-year-old from Hyderabad set up a women's singles last-four clash with Thailand's sixth seed Supanida Katethong, who entered the semifinals after the third seeded Yeo Jia Min of Singapore pulled out of the tournament due to 'high fever'.

Sen, seeded third, will square off against either Malaysia's Ng Tze Yong or Ireland's Nhat Nguyen in the semifinals.

In the other women's semifinal, Aakarshi Kashyap will face second seeded Thai Busanan Ongbamrungphan after the Indian notched up a 21-12, 21-15 win over compatriot Malvika Bansod Friday. Busanan trounced USA's Lauren Lam 21-12, 21-8 in another lasteight clash.

The last time Sindhu was up against Chaliha, at the 83rd Yonex-Sunrise Senior National Championship in 2019, the young-



ster from Assam had produced a spirited performance.

In the men's singles, Sen and Prannoy engaged in a battle of supremacy with the former dominating the proceedings initially to

secure a 6-2 lead.

Prannoy, who had reached the quarterfinals at the last world championships, got his act together in time to turn the tables at 12-10 and then zoomed from 15-14 to

pocket the opening game. Sen roared back into the contest in the second game as he ran up a huge 12-5 lead and didn't look back from that point, as Prannoy

In the decider, Prannoy took the initiative early, opening up a 6-1 advantage but he couldn't sustain it as Sen moved to 11-9 at the interval and then pocketed nine of the next 11 points to seal the match in his favour.

The men's doubles pair of Ishaan Bhatnagar and Sai Pratheek K cut a sorry figure against Malaysian third seeds Ong Yew Sin and Teo Ee Yi, losing 7-21, 7-21 in just 19 minutes.

In the mixed doubles, the Indian pairing of Venkat Gaurav Prasad and Juhi Dewangan, seeded 8th, were no match for Malaysian combination of Chen Tang Jie and Peck Yen Wei, going down 10-21, 13-21 in just 23 minutes.

Another Indian pair of Nithin HV and Ashwini Bhat K lost 15-21, 19-21 to Singapore's Hee Yong Kai Terry and Tan Wei Han to bow out of the USD 400,000 event.
