Andrew Symonds dies in car crash

SYDNEY: Former Australia cricketer Andrew Symonds, one of the finest all-rounders and a two-time World Cup winner, has died in a tragic car accident, leaving the cricketing world in shock. He was 46 and is survived by his wife and two young children. Cricket Australia has now lost three prominent figures in the past two months. Spin legend Shane Warne and former wicketkeeper Rodney Marsh had died within hours of each other in March. According to Queensland police, the accident happened in Hervey Range Road, about 50km outside Townsville in Australia Saturday night.

2 Sikh bizmen shot dead in Pakistan

Bhubaneswar, May 15: With 'Asani' sparing the state a few days back, another low-pressure area is likely to be formed over the central Bay of Bengal (BoB) by May 19, according to the India Meteorological Department (IMD).

"The system is expected to enter South Andaman Sea in a day or two, and develop into a low-pressure area," said the weatherman.

A low pressure may develop in westcentral BoB and southwest BoB, move in the north-northeast direction towards Odisha-Andhra Pradesh in about 24 hours and then towards Myanmar due to strong westerly and southwest monsoon.

The IMD has predicted the early onset of southwest monsoon with the system advancing into the South Andaman Sea and adjoining southeast BoB in the next 24 hours.



At the start of the Covid-19 pandemic two year ago, China worked to export traditional medicine options for the treatment of the disease.

Xi was one of the campaign's leading advocates, said the Daily Mail report. The President has reportedly struggled as a wave of ultra-strict Covid lockdowns across China stretch the nation's economy and the government's ability to suppress dissent.





During investigation, the EOW sleuths came to know that Tarun and Javed would convince their employees and other gullible persons through various inducements to allow the duo to open bank accounts and collect new SIM cards in their names

The EOW, meanwhile, has advised people not to allow anybody to use their bank accounts and SIM cards. "The bank accounts and SIM cards registered in the name of several gullible persons are being used by the fraudsters in various illegal activities," said the EOW.

The EOW once again urged the people not to download and use any illegal loan apps for borrowing

Notably, several people in Odisha fell into the traps of the fraudsters after downloading fake loan applications like COCO and JOJO.

During investigation, the EOW found that the illegal apps were offering loans ranging from Rs 3,000 to Rs 5,000 to its customers through their bank accounts.

After the money was credited to customers' bank accounts, the officials of the two apps were asking the borrowers to return the amounts with high rate of interest within a week.

The officials of the illegal apps used to harass the borrowers if they raise any objection to the high rate of interest. The fraudsters used to hack the phone numbers and social media accounts of the borrowers and send obscene mes-

sages and photos to their contacts. Several borrowers in other states have ended their lives after facing harassment and humiliation for the fraudsters.

"The borrowers must not surrender to abusive/torturous methods of the recovery agents of these illegal apps and report the matter to police," said the EOW in its ad-

Fire safety audit at hotels, hospitals in twin cities

Bhubaneswar, May 15: Acting upon the instructions of Director General of Fire Services, Odisha, Santosh Kumar Upadhyay, the fire services personnel Sunday carried out fire safety audits at different commercial establishments and hospitals in the twin cities of Bhubaneswar and Cuttack.

The fire services officials inspected the premises of Care Hospital and Aswini Hospital in Chandrasekharpur area, Shree Hospital at Lewis Road and Sanjebani Hospital in Samantarapur area in Bhubaneswar. This apart, the team also inspected the Nilaya Hotel in Patia area to check the fire preparedness and status of fire equipment installed in the buildings.

Firemen in Cuttack inspected commercial establishments to check whether they were following the guidelines of Odisha Fire Prevention and Fire Safety Rules, 2017 or not. In the wake of the fire tragedy in Delhi that claimed at least 27 lives, Upadhyay Saturday ordered the audit of all vital establishments including hospitals, industries and market complexes across the state.

New Delhi, May 15: Researchers at the Indian Institute of Technology (IIT), Gandhinagar, have developed a comprehensive framework that can reduce the damage to power transmission systems in coastal areas under cyclone scenario.

The team used damage-cumwind speed data of Cyclone Fani in Odisha to develop a fragility model for towers, which helps assess the functionality of the network and the influence of strategic interventions on the same.

According to the team, they found that the most efficient strategy could be to pick a fraction of towers from the highest wind speed zones (according to the Indian standards) that are associated with substations serving a large population. Strengthening towers nearest to the coast may somewhat help reduce the number of towers damaged during a cyclone, but its resultant impact on the affected population may not be as significant.

The study results revealed that a greater number of reinforced towers or a greater level of strengthening in them based on tailor-made

and efficient reinforcement prioritisation strategies in a particular region leads to better functionality of power transmission systems. The research team also found that strengthening the towers in a transmission line associated with important substations (importance was quantified in terms of population served by the substation) close to the coastline led to maximum enhancement in performance, meaning lesser population is affected, they claimed. "This is a first of its kind re-

search work because here we were able to consider a large-scale network, its relationship with the coastline, a suitable context-specific fragility curve for the towers. and realistic cyclone scenarios in a reasonable manner, which led to interesting insights into strengthening strategies for the power transmission network of Odisha. The framework can be useful for costeffective strengthening of transmission tower networks of other coastal states of India as well, such as West Bengal, Andhra Pradesh, Tamil Nadu, Gujarat, and Maharashtra," said, Manish Kumar, Associate Professor at IIT

MITIGATING CYCLONES

IIT team studied 'Fani' to check damage to power infra

Gandhinagar. "The towers can be prioritised differently if a different performance metric is selected. Structural strengthening that would lead to the shift in the fragility curves considered in this study can be based on wind-tunnel tests and/or computational fluid dy-

namics analyses, which will further optimise the resources. This approach may also be relevant for transmission lines associated with some power plants that may require a shutdown in the event of damage to the lines." he added.

The researchers observed that the

loss in functionality of transmission towers depends considerably on the location of the landfall of the cyclone. The damage was greater if the landfall was close to a region with many substations in the vicinity. This observation emphasises the need to consider the orientation of the network with respect to the coastline and the realistic properties of cyclones. Researchers also noted that the loss of functionality in power transmission could be affected considerably by the path of

a cyclone before making landfall. 'A simulated cyclone trajectory indicated that it could damage towers even up to 300 km apart from each other, which further underscores the need to perform such studies on a holistic scale. The framework developed by the team helps in prioritising the towers that should be strengthened to minimise the overall losses in functionality in a cost-

effective manner," he said The team considered two broad aspects to identify towers for priority strengthening which were identification of a geographical region and basis for prioritisation within that


geographical region. Each intervention suggested by the team is unique from each other in terms of selection of a geographical region, the basis for prioritising the towers, the number of towers to strengthen, and the extent of strengthening considered.

"In post-disaster scenarios, decision-makers always face a constraint on 3Ms--Manpower, Money (budget) and Materials. Hence, there is a need to supplement the bird-eve view with the component level view to identify the right set of components that should be reinforced and strengthened to minimise damage after natural calamities," said Udit Bhatia, Assistant Professor of Civil Engineering at IIT Gandhinagar.

"Changing climate scenarios and upward trend in frequency and magnitudes of cyclones as a consequence of increasing Sea Surface Temperature put our coastal infrastructure at a greater risk. While our understanding of these hazards has increased significantly in recent years, still a lot needs to be done on the adaptation side. Our framework brings us one step closer to possible solutions that stakeholders and infrastructure managers can invest in," added Bhatia.

OTC painkiller in pregnancy ups preterm, stillbirth risks by 50%

aternal use of over-thecounter (OTC) painkillers is about one and a half times more likely to increase the risk of delivering a baby with health issues, finds a study calling for reassessment of medical advice about the use of analgesics during pregnancy.

Researchers at the University of Aberdeen in the UK analysed data from more than 1,51,000 pregnancies over 30 years.

The team looked at medical notes for non-prescribed maternal consumption of five common painkillers i.e. paracetamol, aspirin and non-steroidal anti-inflammatory drugs (NSAIDs), diclofenac, naproxen, and ibuprofen, either as single compounds or in

Among mothers who took parac-

etamol and ibuprofen during pregnancy, the risk of a preterm delivery before 37 weeks was 50 per cent more likely, while the risk of stillbirth was 33 per cent.

Other risks of using painkillers include neural tube defects (64 per cent more likely); admission to a neonatal unit (57 per cent more likely); neonatal death (56 per cent more likely); and birthweight under 2.5 kg (28 per cent more likely) among others, revealed the study published in

Ganjam, May 15: In a shocking incident, locals brutally assaulted two fellow villagers and broke their teeth over suspected practice of witchcraft and sorcery at Gadahuma village under Rambha police limits in Ganjam district, late Saturday night.

The victims were identified as Kishor Das and a woman Ranju Das in the village. They were busy performing some rituals at Satabhauni temple near the village when the villagers caught the two and brutally assaulted them, late Saturday night.

Later, they detained them the whole night. The incident has sparked tension in the area.

On being informed, Rambha police IIC P Swaroop Kishan, his Chhatrapur counterpart Satya Ranjan Pradhan and Huma OIC Debadutta Priyadarshi rushed to the spot and rescued the two from detention and admitted them in Chhatrapur hospital for treatment. Tension was palpable in the area when reports last came in.

The two persons were on the scanner of the villagers after two children of an ex-serviceman died a few months back and the death of a 22-year-old youth, 20 days back. BJD brainstorms for winning strategies

Brajarajnagar, May 15: The political atmosphere is getting warmer by the day in Brajarajnagar Assembly constituency segment as leaders of three major political parties - BJD, BJP and Congressare busy drawing up their own strategies. Electioneering for the bypoll has also intensified with prominent leaders canvassing for

Health Minister Naba Das, party's district observer, Cuttack Mayor Subash Singh and deputy observer Bishnu Prasad Kedia held a meeting and brainstormed on strategies to gain support of voters at Belpahar Sunday

Das reminded the leaders that the party nominee had won the election

by a margin of 70,000 votes in 2019 general elections. He exuded hope that the party nominee Alka Mohanty will win the by-poll by a margin of 50,000 votes.

The 2019 general election had witnessed a tough fight between BJD and BJP here. For quite a long time beforehand, the Assembly constituency was a bastion of CPI. The party candidate and former MLA late Prasanna Panda had won from this seat for six times and represented it in 1961, 1967, 1974, 1985, 1990 and 1995

MEDICO'S DEATH AT BBMCH

Inability to make vulgar jokes took Nishant's life, claims father on Twitter

Bolangir, May 15: In a new twist in medico Nishant Kumar's 'suicide' over 'ragging' at Bhima Bhoi Medical College and Hospital (BBMCH) in Bolangir, his parents and kin have alleged that he was 'murdered' over obscene jokes.

Family members expressed resentment as there has been no arrest in the case. 22 days have passed, but no action has been taken even after Nishant's father Prof Krishan Kumar tried to draw the attention of PM Modi, NHRC, OHRC, CM Naveen Patnaik and the Bolangir SP.

Meanwhile, another WhatsApp chat of Nishant with a friend has gone viral on social media. In the chat, Nishant has shared that he was made to crack vulgar jokes by three senior students from Rajasthan.

They allegedly tortured him mentally and physically when he failed to crack the jokes. Sharing screenshots of the chats on Twitter, Nishant's father has claimed that parents nowadays also have to teach obscene jokes to their children

for them to survive. "Just teaching good manners I want to make all parents awar that there is no value of making your children to learn good anners. If I made my son son to arn bad manners like non-veg



will not help, you should also teach non-veg jokes," tweeted Nishant's father.

It is pertinent to mention that Nishant Kumar, 19, a first year MBBS student from Karnal in Haryana, had taken admission in BBMCH and just joined the hostel 10 days back. He was residing alone in Room-312 of the New Boys' Hostel. After having lunch April 22, Kumar had gone to the roof of the hostel However it is not clear what happened on the roof and how he fell off. He was immediately rescued and rushed to the hospital, where the doctors declared him dead upon arrival.

On the other hand, Sabita Mohapatra, the dean of the medical college, has refuted the allegations of ragging.

As per sources of the RD department, the project is being executed under Biju Setu Yojana at a cost of ₹5.01 crore. According to the agreement signed with the contractor, the bridge con-



struction started from February 7, 2020 and was supposed to be completed by August 6, 2021. Till date, only ₹2.40 crore has been spent and 47.85 percent of the work has been completed.

The RD department is disappointed over the slow pace of its construction and termed it discouraging. The department has already slapped show-cause notices to the construction firm Bhubaneswari Constructions five times.

In the latest notice issued May

clear that the land dispute that existed earlier has been sorted out. Besides, electric lines coming in the way have been shifted. The state government had allowed the construction agency to carry on bridge construction during the pandemic times. Hence, the slow pace of work will not be tolerated, it was said.

The agency has been asked to submit an application for revised work and to finish the work by June 30, 2022. It is clear that if construction work gets delayed, its cost will be revised upward with change in the deadline.

Earlier, costs of two bridge projects under Jaraka RD division had been revised due to construction delay. One project is Bahujanga-Dhaudia bridge across Birupa river and a high level bridge across Sanagenguti river on Shakuntalapur road. Both the projects had inordinately missed deadlines. Construction agencies had applied at the superintending engineer of the RD department for cost escalation to ₹1.61 crore.

There are several other projects getting delayed with escalated costs. Locals alleged that both contractors and engineers used to mint money in the name of construction delay.

Executive engineer of the RD division Biswanath Marandi said the contractor has been asked to finish the work. Its cost has been revised as per official norms.

Healthcare haywire due to docs' crunch in Subarnapur

Sonepur, May 15: Healthcare services in various hospitals of Subarnapur district have been badly affected due to acute shortage of doctors. It is alleged that vacancies have not filled up for a long time, a report said.

According to the report, posts of 74 doctors are lying vacant in most hospitals, leading to people facing a lot of difficulty in availing healthcare services

There are 152 sanctioned posts of specialists and doctors in the district while only 78 of them are rendering their service.

Moreover, healthcare services in four primary healthcare centres (PHC) at Kotsamalei under Ullunda block, Bhimtikira and Digashira under Dunguripalli block and Hariharjora have gone for a toss as now these facilities do not have doctors at all. In such situation, people have no other way but to seek treatment in Bolangir, Burla and Cuttack, it was alleged.

However, chief district medical officer (CDMO) Dr Pradip Kumar Guru said,"Despite limited number of doctors, we are trying to provide good healthcare services to patients. The government is routinely intimated about the need for filling up vacancies at hospitals in the district.

Nayagarh, May 15: Kidney disease has allegedly been taking a heavy toll on Chadeiyapalli and Osamanna villages under Dasapalla block of Nayagarh district. Though the exact reason for rise of such illness is yet to be ascertained, locals suspect that contaminated water is causing the disease.

In the last five years, as many as 10 people have died of kidney disease in these two villages. Currently, four residents of the two villages affected by kidney disease are battling for their lives.

As the disease is on a killing spree, it has triggered panic in the locality.

Locals have demanded that the health department should look into the right cause of the disease and provide free treatment to the people.

Reports said, 15 families of scheduled caste live in Chadeivapalli while 9 families live in Osamanna. There are two tube wells in the village. "But the water available from the tube wells is unfit for drinking. The water is grey and a thin layer comes up on its surface if it is kept in a pot for minutes. The water may be the reason for such kidney disorders," villagers said.

They alleged that though they had drawn attention of the local leaders and the block administration towards their water woes, no



step has been taken till date. Banchhanidhi Nayak (50) of Chadeiyapalli died of the disease April 29 while Chintamani Nayak (50) and Kanhu Charan Navak (45) of the same village have been battling for life. Besides, Chaturbhuja

Nayak (50) of Osamanna has died of the disease while Karunakar Nayak (45) is affected by it. Chintamani Nayak and Karunakar Nayak, local residents, say that tube well water has iron particles.

"We have no alternative source

Locals held that the contaminated tube well water is responsible for the ailment. The water in the area needs a lab test, they observed

of water. We are bound to use it for our daily needs. We suspect that the water may contain fluoride. There is a need for testing of the water," they lamented.

The villagers said that as long as they will be drinking such contaminated water, they would have

to bear the brunt of the disease.

Putin's Problems

he irony of Russian President Vladimir Putin's decision to invade Ukraine in February is that the enemy he wanted to ward off from its border by declaring war against one country is now all set to come closer to its border because of that very invasion. The enemy is obviously NATO whose intention to give membership to Ukraine and thereby deploy its arsenal close to Russia's border was Putin's ostensible reason for invading the country. But, the havoc caused to Ukraine has so unnerved other neighbours that Finland and the country to its western border, Sweden, both democratic countries, have announced their eagerness to join NATO without any further delay. Traditionally, these two countries have always maintained neutrality, refusing to join either the US-led Western forces or the erstwhile Soviet Union or now Russia. Since the formation of NATO in 1949, these two neighbours of the former Soviet Union have been following independent policies. Finland in particular has friendly relations with Russia which supplies to it 10 per cent of its energy needs. It has over 1,300-kilometer (810-mile) border with Russia, the longest by any European Union member. Sweden is not exposed to Russia in the same manner as Finland is, since Finland to its east acts like a buffer. But, Sweden often follows steps Finland takes to formulate its geopolitical strategy. The dramatic change of their position of neutrality has occurred the moment Russia invaded Ukraine. What has caused alarm bells in the two countries is the fact that Russia could actually invade Ukraine, a country with 44 million people, a GDP of 15,392 crore USD (2019), and armed forces of 200,000 active troops. Compared to Ukraine, Finland and Sweden are smaller countries.

Finland therefore is on the cusp of joining NATO within a few days, while Sweden is going to follow suit. Things have been moving fast for the past few days. Finnish President Sauli Niinisto told Putin May 14 his country "will decide to apply for NATO membership in the coming days." He is one of few Western leaders who has held regular dialogue with Putin over the past ten years. In fact, at their first meeting in 2012 Niinisto made his stand clear that "each independent nation would maximise its own security." That position, he told Putin this time, is still the case and that by joining NATO Finland will strengthen its own security and assume its responsibilities. It speaks volumes for the courage and foresight of the Finish President that he did not forget to tell Putin that despite its likely future membership in NATO, Finland wants to continue to deal with Russia bilaterally in "practical issues generated by the border neighbourhood." He said he hopes to engage with Moscow "in a professional manner." However meanwhile, Russian energy supplier RAO Nordic has announced it will suspend deliveries of electricity to Finland from Saturday, citing problems with payments.

Neighbouring Sweden is also moving with right earnest towards deciding on its position on NATO at a meeting of the ruling Social Democratic Party led by Prime Minister Magdalena Andersson scheduled May 15. In a highly significant move US President Joe Biden made a joint call May 13 with both Niinisto and Andersson where, according to a White House statement, he underscored his support for NATO's Open Door policy and for the right of Finland and Sweden to decide their own future, foreign policy and security arrangements. Since the Russian invasion of Ukraine public support for joining NATO in Finland has gone up from around 30 per cent to nearly 80 per cent in some polls. The majority of Swedes also approve of their country joining the alliance, according to opinion polls there.

It appears the USA and the West have realised their mistake of dillydallying over the decision to accord NATO membership to Ukraine. For this, the US President has talked about an arrangement to provide security cover to Finland and Sweden during the 'waiting' period before they are inducted into NATO. It takes months before the crucial decision is taken with the concurrence of all the 30 members of the bloc. Turkey is reluctant to include the two countries into NATO for it suspects the two countries, which have a small segment of Kurds in their population, have been aiding and abetting militant Kurdish groups operating in Turkey against the current regime. It is yet to reveal the basis of its suspicion and for this it has indicated it is willing to talk to the top leadership of the two countries

Viewed in the light of the latest developments, Putin's adventure in Ukraine may prove too costly and counterproductive for Russia. Any country waging war today has to consider the aftermath of such a horrific military experiment. Whatever the final outcome maybe, it is evident that Ukraine has already won a war, the end of which is not visible to anyone. By lasting out from Thursday 24 February 2022 till now, in itself, is victory for a small country like Ukraine against a global military power. Putin has also thoroughly exposed the incapability of the Russian armed forces to achieve decisive victory in a short period of time. The world had forgotten the inefficient Soviet invasion of Afghanistan and how the Communist country was forced to run for its life, with some similarities to what happened to the Americans 15 August 2021. If Putin's adventure fails, as it has started to look now, Russia might go through internal political changes that could affect the global geopolitical situation that has evolved lately, after the invasion of Ukraine.



Swag

Swag has a surprising number of meanings. It has been around for at least 200 years for a thief's plunder or booty, the sense that CS Lewis was using. The idea of give-aways is more recent, but even that has a longer history than one might guess from the comparatively recent American usage you quote. And, of course, among other meanings, swag is also the Australian word for a bundle of personal belongings, especially a bedroll, carried by a traveller, tramp, or swagman. It looks as though all these can be traced back to a word imported into Middle English from Scandinavian svagga, to sway (in fact, it's the origin of sway as well). At first, the verb meant to rock unsteadily or lurch, but evolved into that of hanging loosely or heavily, to sag. Another sense of swag comes from the same idea — for an ornamental festoon, or for fabric fastened so it hangs in a drooping curve; this was first recorded at the end of the eighteenth century. It's also the origin of the American swag lamp sense you mention, in which the lamp's electrical cable hangs in a swag. Originally, a thief's swag was a bag of stolen clothes or the like. This and the Australian swag derive from the idea of a bundle that sags or hangs down. Think of the stereotypical image of a tramp with his swag hanging from a pole over his shoulder; it's not accidental that in cartoons the thief's swag is always shown in a sack. However, there's some suggestion there was another word involved, also Scandinavian, the one that led to a citation for swag in the Oxford English Dictionary from 1303. In that it meant a bulgy bag. The evidence suggests it didn't survive in its own right, but it's possible that it influenced later senses. One early glossary says that swag referred to any stolen goods except money, but the evidence suggests it altered through the nineteenth century until it meant small valuable items that could be easily disposed of, such as silverware. That idea seems to have been picked up in North American youth slang comparatively recently to mean valuables or money. The sense of freebie stuff might seem to be a development of that. However, Jonathon Green, the author of the Cassell Dictionary of Slang, has pointed out to me a book of about 1921 by Tom Norman, a travelling fairground showman in Britain, entitled The Penny Showman. He wrote about a stall that was: "set out with the usual showman's swag, such as fancy cups and saucers, gaudy vases, shaving mugs, etc", that is, the cheap and tawdry prizes that might be won. Eric Partridge, in his Dictionary of Slang and Unconventional English, also gives this showman's sense, suggesting it dates from the end of the nineteenth century. This is not so far distant from the advertising give-aways you mention, and may indeed be its direct ancestor.

alloping inflation needs to be immediately checked. It hurts the government more than the common man, creating a cycle that hits everyone and adding further to the inflation. Retail inflation touches 7.79 per cent, the highest since September 2014 and the wholesale index remains over 14 per cent. It has made food inflation go beyond tolerable limit and so too the travel

the subsidy regime is reversed by high taxes on fuel, road sector and commodities through various instruments such as GST, excise du ties, VAT, road, agriculture and other cesses, toll and consequent rise in prices. The policymakers blame it on international factors like the Ukraine war but are unable to explain how it causes severe rise in vegetable prices, home grown wheat flour and myriad such products. Pulses price rises by 17 per cent.

The government itself is in a quandary on the prices and needs to discuss issues that can bring down its bill on expenditure and cost of investments. That is possible through moderation of prices. On an average it has gone beyond the Reserve Bank of India's tolerance limit reset at 6 per cent. Rapid, sustained inflation harms families by wiping out their wage gains and eroding savings. It also rocks consumer confidence, and businesses.

The rupee falling against the dollar is yet another cause for concern. It virtually imports inflation, and this is difficult to contain unless domestic steps raise the purchasing power of the rupee. Instead that is being eroded, as the rupee touches Rs 77.34 to a dollar. It makes petrol, coal and essential imports expensive.

Freight rates on grand trunk routes have already shot up by an average 3-4 per cent month-onmonth, according to the Indian Foundation of Transport Research & Training. The recurrent increase in the fuel prices singe into the margins of small and large transporters and will force them to pass on the hike to their customers. This in turn is set to make the prices of daily consumables and

other goods dearer, impact consumption and slow the economic growth, the study says.

An Indonesian study finds that the increasing fuel prices have a devastating impact on the transport sector. If we do not check this, the rising oil prices would cause a slowdown. Of course, a small correction has been made to the monetary policy by a small raise in reporates. As per RBI's own calculations, almost every 5 per cent depreciation in the rupee adds about 10-15 bps to the inflation. The RBI move to check it also has

Transportation and input costs have hit even the FMCG giant Unilever. It is seen reducing the size and quantity in each of the small packs of its products. A 10-rupee dish cleaner now has 135 grams against 155 grams three months ago or so. A Haldiram 'aloo bhujia' now has 42 grams against 55 grams. Dabur has also reduced grammage. Britannia has passed on 65 per cent of incremental input costs all through 2021-22. Every category has had inflationary headwinds, says Sanjay Singhal of ITC's dairy and beverages unit. The manufacturers are hit by the cycle of price rises from petroleum, toll, transport to edible oil and other input costs. They transfer it to the consumers, who respond by a further stickier consumption.

Despite a \$400 million export, the RBI is concerned as global price rises may lower demands. Imports have surged. The balance of trade is unfavourable and reducing imports is difficult. The rising rupee against the dollar or fear of contraction of rupee is worrisome as the forex kitty has shrunk to \$597 billion from \$642 billion. In the week ending April 29. foreign currency assets fell by \$1.110 billion to \$532.82 billion. Meanwhile, gold reserves dipped by \$1.164 billion to \$41.60 billion. The SDR reserves stood at \$18.3 billion lower by \$362 million. The country's reserve position in International Monetary Fund is at \$5.001 billion lower by \$59 mil-

lion in the week ending April 29. A 10 per cent rise in fuel prices raises 12.78 per cent of production costs in the road transport sector, says study of Dhani Setvawan of Indonesian Ministry of Finance. In addition, there is also indirect impact to the sector by 5.13 per cent. The indirect impact is induced by the changes of other sector product prices.

The Fitch rating agency says that the hiking of natural gas prices for ONGC and Oil India to \$6.1 per million British thermal

unit from \$2.1 may be good news as their profitability would increase. Reliance would have higher profitability as the rate of KG-D6 has gone up to \$ 9.9 per mmBtu from \$6.1. Once again it will have deleterious impact on transport

A study on impact of toll system by Kedar Nath Pande in the International Advanced Research Journal, says, according to the National Motorists Association it is an inefficient approach, worse it fosters corruption, political patronage and discourages needed improvements on the rest of the nontoll highway system. Toll is the second largest expense of transporters at Rs 4 to 5 lakh a year per truck. The average usage of truck has remained the same whereas costs have increased, and transporter margins are at an all-time low, Pande says much of it due to the tolls. But NH Fee rules 2008 of reducing tax after 60 per cent cost realisation is never implemented.

The DNA story observes that toll collection is a huge profit-making mechanism, as per the police. It cites the instance of Pune-Ahmednagar toll gate at Perne Phata. The government's invest ment on the stretch was about Rs 10 crore. The road was started with an expected profit of Rs 24 crore in 10 years. It collected Rs 394 crore as toll and has paid Rs 1.55 crore to the government. Similar irregularities were detected in Tamil Nadu. The government is collecting on an average Rs 3.6 lakh crore through various petrol cesses and as per National Highways Authority of India, it directly collects Rs 38,000 crore at toll gates a year.

Each of these also impact government expenses. These go up every year following a myth that inflation helps government earn more. In reality, there is more erosion to revenue, increased hardships at every level and the resultant slowdown adds to the problems. Lower the inflation, higher the demand and happiness in the country. Reviewing taxes and tolls will help the government earn more.

Creating a seamless farmers' database

tural landscape has seen a marked shift. From who is a farmer in India to how we collate the data on every farmer in India. Now, governments are beset with an even bigger challenge of profiling farmers in India. Or creating a seamless, unified farmers' database. The Indian government has big stakes in this integrated farmers' repository. Imbued with the vision for an India Digital Ecosystem for Agriculture (IDEA), the government is thinking aloud and building the national farmers' database with great fervour. I hail it as a laudable initiative, promising to energise our digital farm economy and prepare our farmers for Agriculture 4.0. In the same vein, I'm a trifle concerned, if not sceptical, about how we are sourcing data.

India plans to create a massive database for some 150 million farmers. The database will connect crucial data points - the number of occupational farmers, how much land they own and where, what they grow, and which agro-climatic zones they fall in. This database can bring in benefits galore for the entire agriculture value chain.

Agribusinesses can use the hitech database to gain unparalleled

he challenge in our agricul- insights into the rural economy anism to figure out their eligibil- System, Aadhaar land records, seed and even specific land parcels, allowing them to create tailored products for farmers. The government has signed contracts with CISCO. Ninjacart, Jio Platforms Limited, ITC Limited and NCDEX e-Markets Limited to develop the database.

The digital repository will aid precise targeting of subsidies, services and policies, help raise farmers' income and digitally connect the growers with agri-insurance companies, supermarkets, seed suppliers, agri-tech companies, Also, the platform can be used by lending institutions to determine a farmer's creditworthiness.

It makes ample sense to harness data to revamp the culture of agriculture. According to a recent EY report, India's farm economy is projected to grow to \$24 billion by 2025, fuelled by agri-tech adoption. The national farmers' database, an effort towards building the IDEA, is extracting data from PM-KISAN, Pradhan Mantri Fasal Bima Yojana (PMFBY) and the soil health cards. But how credible is the data pool?

The absence of a single version of the truth has created inconveniences for farmers and policymakers alike. Farmers lack a mech-

ity for different schemes. Owing to this, they need to provide the same set of information each time for multiple schemes. That apart, the burden is on the farmer to validate his identity every time while applying for each scheme. For officials, identifying the right beneficiaries gets cumbersome when there is a lack of consolidated farmer data. Moreover, data entry issues at the ground level lead to scheme delivery delays.

 $Overcoming \ legacy \ problems \ in$ the farm-to-fork chain needs a golden records database with an immersive 3600 profiling of a farmer's demographics. A digital solution that aggregates information with the farmer as the premise and not his family. This system can have more efficacy than the normative land records databases and farm registries with 100 per cent Aadhaar seeding and authenticated bank details of the farmers. A consummate database populated with details of all categories of farmers - cultivators and sharecroppers, landless labourers, livestock and fishery farmers and forestry farmers. Such a system can also be seamlessly integrated with external databases like Procurement Automation

supply, fertilizer management, soil health card and schemes like PMFBY. The system can capture multiple data points of farmers like demographics, occupation, crop and generate a unique application id for each. And an outcome-driven Decision Support System embedded into the solution can serve as a lodestar for policymakers.

Government officials can leverage the digital system to identify beneficiaries, detect anomalies, policy formulation and budgeting, farming advisory service deliveries and impact assessment of schemes. It can make the Minimum Support Price regime more effective and transparent with better mapping of genuine beneficiaries. At the same time the banks and insurance companies can use the data while approving any farm loan. Farmers datasets can be leveraged to incentivise them and move away many from the rice-wheat monoculture to high-value agriculture.

Creating a golden records database of farmers is like building the core of IDEA.

India adds 8.8 mn jobs in April: Report

Kolkata, May 15: In one of the largest expansions in the labour market since the beginning of the pandemic, 8.8 million people joined the country's workforce in April, as per data provided by the Centre for Monitoring Indian Economy

Delhi fire: Building owner held

New Delhi, May 15: The police have arrested three persons in connection with the fire accident at a multi-storey building on May 13 here in Mundka that left at least 27 people dead.

The arrested individuals have been identified as Manish Lakra - the owner of the building, and Harish Goel and Varun Goel - owners of a firm named Cofe Impax Pvt Ltd., the police said Sunday.

So far, only eight of the 27 bodies have been identified. The eight deceased have been identified as Tania Bhushan, Mohini Pal, Yashoda Devi, Ranju Devi, Vishal, Drishti, Kailash Jyani and Amit Jyani.

Officials said that most of the bodies were burnt to such an extent that even it was difficult to establish whether the charred remains were of a man or a woman. However, two days after the incident, the medics have now found that of the 27 dead, 14 are females and three males.

The unidentified bodies have been placed in the Sanjay Gandhi Memorial Hospital's Mortuary here in Mangolpuri. "We have collected the DNA samples of the rest of the bodies. As soon as DNA matching is completed, we will get to know their identities," Deputy Commissioner of Police Sameer



Sharma said, adding it might take 4-5 days more.

"On the fateful day, a sales motivational programme was conducted by the said company and at about 4 p.m., all employees were on the 2nd floor. Due to the sudden fire break-out many people got trapped and could not come out as there was a lot of fire and smoke inside the building," the police officer said.

During the rescue operation, 50-60 people were safely rescued jointly by the police, Fire Department and the local people.

Calcutta HC saddled with more than 2 lakh pending cases

LEGAL LUMINARIES SAY THAT THE NUMBER OF JUDGES NEEDS TO BE INCREASED TO DEAL WITH THE BACKLOG AS WELL AS NEWLY FILED PETITIONS

Kolkata, May 15: Functioning with only 39 judges out of a sanctioned strength of 72 judges, the Calcutta High Court is saddled with more than two lakh

pending cases. The Union Law and Justice Ministry on Saturday announced the appointment of three more additional judges to the Calcutta High Court, which will take the number to 42. Legal luminaries say that the number of judges needs to be increased further as soon as possible to deal with the backlog as well

as newly filed petitions A total of 2,34,539 cases are pend-

ing before the high court despite efforts by the judiciary to reduce the backlog. The Calcutta High Court, which has a sanctioned strength of 72 judges. is functioning with only 39 judges, according to data provided on its website.

After the three newly-appointed judges take oath, the number will increase to 42, but will still remain short of the sanctioned strength by 30 or 41.66 per cent. Former Supreme Court judge Justice (retd) Ashok Ganguly said that the number of judges should be increased immediately to at least the full strength of the high court, and the sub-divisional and district courts, which are also facing similar issues.



Of the 2,34,539 cases pending as on February 28 according to the data, civil cases form the lion's share at 1,97,184, while the number


of criminal cases awaiting disposal stand at 37,355 on that date. While the seat of the high court is in Kolkata, it has permanent

circuit benches at Port Blair in Andaman and Nicobar Islands and at Jalpaiguri in north Bengal."Even with full strength, the number of judges is inadequate and so with over 40 per cent less it is far more difficult to reduce the backlog," Ganguly said.

He said that the number of new cases before the court is increasing as people have nowhere else to go for getting justice. "Number of cases is increasing while judges' strength is going down; governments need to expedite appointments of new judges," he said.

Holding that both the central and state governments need to put in more effort to alleviate the situation, Ganguly said there are huge vacancies in the lower judiciary also, which need to be filled up. A total of 26,64,284 cases are pending in different courts in West Bengal till May 14, as per the National Judicial Data Grid.

Of these, 20,47,901 are criminal, while 6,16,383 are civil cases, according to the data. Ganguly said that litigants are facing immense hardship owing to the situation leading from lack of an adequate number of judges and huge pendency of cases. He said that lawyers also need to put inextra effort to ensure that litigants get justice in time.

CM pitches for trillion-\$ economy, but caste atrocities pull state down

government is embarrassed at the injustice being meted out to the Dalit community in the state

Chennai, May 15: Tamil Nadu Chief Minister MK Stalin during the first anniversary of his government May 7 reiterated his dream of pushing the state towards a trillion-dollar economy by 2030. During the anniversary celebrations, a confident and beaming Stalin stated that the Dravidian model of administration is taking his government towards the cherished dream of a trillion-dollar economy.

There is no doubt that the government fared better than expected with an economy mired in the severe backlash of shutdowns and lockdowns during the Covid-19 pandemic. The loss of a magnetic personality and a shrewd administrator, Stalin's father and former CM Kalaignar Karunanidhi was a factor that pulled Stalin and his government back.

Undeterred, the Chief Minister moved ahead overcoming difficulties but the government and Stalin are embarrassed at the injustice being meted out to the Dalit community in the state. While there were back to back killings in Tirunelveli district in July and August 2021, tough measures were



taken by the police with the DGP, C. Sylendrakumar, a South Tamilian who knows the ins and outs of the caste politics of the state, camping at Madurai and tackling the criminals with an iron hand.

Recently a Class 6 student at Tindivanam was subjected to a caste slur by upper caste students. The 11-year-old Dalit boy on a holiday was going to his relatives' place when three upper caste boys from the Kattuchiviri government school, the same school where the 11-yearold is studying, hurled abuses at him and later pushed him into a bush fire. He suffered serious burn injuries but escaped with his life as he jumped into a nearby water tank.

His father promptly complained to the Tindivanam police who registered a case under Section 324 and also under the SC/ST atrocities prevention Act. The boys were arrested and put in a rehabilitation centre at Killi.

In another incident that took place at Government Elementary School, Semmedu in Coimbatore, the headmistress and a teacher of the school were booked after an 8-year-old Dalit student who defecated in his school uniform was allegedly forced to clean the toilet of the school. The boy who was in Class III was then forced to clean the stain on his clothes and was made to stand outside to sun-dry his clothes.

Sreeraghavan K, a social activist and researcher on Dalit studies from Kanniyakumari, told IANS: "The trillion-dollar economy idea is good but until social issues like Dalit atrocities are not addressed, forget a trillion dollar economy, the state will stumble midway through in normal development."

Delhi faces water crunch amid heatwave

CITY REQUIRES AROUND 1,200 MGD OF WATER, WHILE THE DJB SUPPLIES AROUND 950 MGD

New Delhi, May 15: With the Yamuna drying up under the blazing sun and Haryana not responding to SOS calls, authorities in Delhi are barely meeting the drinking water demand in several areas, officials said.

The level in the Wazirabad pond has dropped to 670.70 feet, the lowest this year. It was 671.80 feet Thursday. The pond level had dropped to 667 feet July 11 last year, prompting the Delhi Jal Board (DJB) to move the Supreme Court seeking directions to Harvana to release additional water in the

The DJB has thrice written to the Haryana Irrigation Department in this connection in a fortnight -- May 12, May 3 and April 30.

"Even flow via CLC (Carrier-Lined Channel) and DSB (Delhi Sub-Branch) is fluctuating... The lifting of 120 cusec of water from the Wazirabad pond is affected due to low pond level. This will affect water production adversely. Due to peak summer, the water requirement is more," the SOS sent

Thursday read. "It is requested to supply 150 cusec of raw water additionally through DD-8/river route, so as to ensure that 120 cusec of raw water reaches the Wazirabad pond in this time of crisis, till the arrival of monsoon," it read.

According to officials, there has been no response from the neighbouring state whatsoever, leaving Delhi to fend for itself.

The production capacity at Wazirabad, Chandrawal and Okhla water treatment plants has reduced

It could further decrease, a DJB official said on condition of anonymity.

'We have resorted to water rationing and have been able to meet the demand so far. However, the situation could turn worse if Haryana does not respond and release additional water in the river" the official said

Adhering to its Summer Action Plan, the DJB has deployed extra tankers to cater to areas facing water shortage and is trying to augment water supply through tube

The Delhi government last month said it will supply around 1,000 million gallons of drinking water every day during the summer season as against 935 MGD earlier to meet the rising demand. It had said 1,198 water tankers will be deployed across the capital during the peak season (April-July) to prevent water scarcity.

Haryana supplies a total of 610 million gallons of water a day to Delhi through two canals -- CLC and DSB -- and the Yamuna.

The CLC and the DSB are supplied water from Hathni Kund via Munak canal and the Bhakra Beas Management Board.

Besides, Delhi receives 253 MGD from Uttar Pradesh through the Upper Ganga Canal, and 90 MGD is drawn from ranney wells and tube wells installed across the

The Chandrawal and Wazirabad water treatment plants have a capacity of 90 MGD and 135 MGD,

The two plants lift raw water from the Wazirabad pond, treat it

west Delhi, north Delhi, central Delhi, south Delhi, including Delhi Cantonment, and New Delhi Municipal Council areas.

Delhi requires around 1,200 MGD of water, while the DJB supplies around 950 MGD.

The government has targeted increasing the water supply to 1,180 MGD by June 2023.

A punishing heatwave turned Delhi into a hot cauldron Saturday, pushing the mercury to an unbearable high of 47.2 degrees Celsius at Mungeshpur and 47 degrees Celsius at Najafgarh.

The Safdarjung Observatory Delhi's base station, recorded a maximum temperature of 44.2 degrees Celsius, which was five notches above normal and the highest this season so far.

DELHI TURNS INTO HOT CAULDRON



A tormenting heatwave swept through the national capital and its neighbouring areas Sunday with the mercury leaping to 49.2 degrees Celsius at Mungeshour in northwest Delhi and 49.1 degrees Celsius at Najafgarh in the southwest parts of the city. Maximum temperatures reached unbearable highs of 48.4 degrees Celsius at Sports Complex, 47.5 degrees Celsius at Jafarpur, 47.3 degrees Celsius at Pitampura and 47.2 degrees Celsius at Ridge. At the Safdarjung Observatory, Delhi's base station, the maximum temperature rose to 45.6 degrees Celsius, five notches above the normal and the highest this year so far. The primary weather station had recorded a maximum temperature of 44.2 degrees Celsius on Saturday and 42.5 degrees Celsius on Friday. On May 27, 2020, Safdarjung had recorded a maximum temperature of 46 degrees Celsius. The city saw the maximum temperatures rise to 46.8 degrees Celsius at Avanagar. 46.4 degrees Celsius at Palam and 45.8 degrees Celsius at Lodhi Road.

Bulldozer action in Delhi: Where does SC stand?

New Delhi, May 15: The Supreme Court, earlier this week, declined to entertain a plea by the CPI-M against an anti-encroachment drive in Shaheen Bagh carried out by South Delhi Municipal Corporation (SDMC). The top court drew a distinction between the anti-encroachment drive at Jahangirpuri - which was halted until further orders - and at Shaheen Bagh, saying it won't protect encroachment being removed as per law

High alert ahead of Tamil Genocide Remembrance Day

Chennai, May 15: Central intelligence agencies have issued warnings against the possibility of former cadres of the now-defunct LTTE trying to regroup and carry out attacks during the Tamil Genocide Remembrance Day May 18, sources in the Tamil Nadu Home Department said.

The Tamil Genocide Remembrance Day is marked annually by the Sri Lankan Tamils on May 18, the date on which the over 25-year-old Civil War in the island nation ended

With Sri Lanka undergoing the worst-ever economic crisis since it gained independence in 1948 as well as the recent violence that erupted in the island nation, the possibility of certain Tamil groups, including the former Liberation Tigers of Tamil Eelam (LTTE) cadres, re-

grouping and planning attacks is worrying the Indian intelligence agencies, the sources told IANS. The Tamil Nadu Police have given directives to all the district Superintendents of Police, especially in the coastal areas, to be on alert about the possibility of an influx of the former cadres into the state.

In the wake of the economic crisis, more than 70 people from Sri Lanka have reached Tamil Nadu after being dropped at Dhanushkodi and Rameswaram by fishing boats at a huge price.

These people are currently being lodged at the Mandapam refugee camp in Rameswaram after the Tamil Nadu government's decision to not send them

The Tamil Nadu Coastal police and Indian Coast Guard have also alerted fishing boats from Tamil Nadu to be vigilant on any movement from Sri Lanka crossing the International Marine Boundary Line (IMBL) and to report on any suspicious movements

Former LTTE intelligence operative Satkunam was apprehended last year after he was charged with smuggling narcotic drugs and collecting funds for regrouping the militant group in India.

A woman who was boarding a flight to Mumbai from Chennai was also arrested by Tamil Nadu Police after she was found trying to retrieve a dormant bank account connected to the LTTE.

The Central intelligence agencies have also warned that certain sections of the global Tamil diaspora are supporting the cause of Tamil nationalism and with Sri Lanka's Rajapaksa family on the defensive, the possibility of some unorganised attacks on the island nation is high, the Home Department sources added.

Chennai, May 15: The State Expert Appraisal Committee (SEAC) of Tamil Nadu has rejected a mining license to establish a large stone quarry in the Thoothukudi district. This is to protect the endangered blackbuck population even though the site is located outside the notified ecologically sensitive zone (ESZ) of Vellanadu

The SEAC in a meeting held recently decided not to recommend the proposal for granting environmental clearance. The SEAC in the statement said that it decided not to grant the license even though it was outside the Ecologically Sensitive Zone as the mining will have a damaging effect

on the blackbucks that is an endangered schedule -1 species.

Environmentalists and conservationists are of the opinion that blackbucks are sensitive to environmental pressures. They spend the nights outside the sanctuary in the grass fallows and move back in the forest when outside disturbances increase.

Wildlife Conservationist Sugirtharaj Kovilpillai, while speaking to IANS said, "The preferred habitat of blackbucks lies in the eastern fallow outside the sanctuary and there is evidence of blackbucks foraging and grazing 5 km away from the sanctuary even along with farms, roads, and

A study on blackbucks published in Indian Forester also says that the open fallow grasslands may serve as important breeding areas for blackbucks and need to be conserved along with the sanctuary.

Going by the opinion of environmentalists and wildlife conservationists, and on the basis of the study, the SEAC decided to withhold environmental clearance for the stone quarry project.

D. Mohanraj had applied for environmental clearance to quarry on 31 acres of land. The appraisal for the project was done in 2019. Terms of Reference was issued and public hearing was conducted November 17, 2020. The proposedproject was 1.6 km from the blackbuck sanctuary.

Earlier this month, forest guards

deployed in Bhopal's Badli forest circle were attacked by hunters at night. One of the guards received knife injuries while another guard received a gunshot wound on his private parts and he is still recuperating in a hospital in Bhopal.

Another such incident took place in Sheopur district in April this year when forest guards were attacked allegedly by Dhanraj, who is the son of sitting BJP MLA Sitaram

Adivasi. A police complaint lodged by the forest officials accusing the MLA's son and his associates of beating them up, is available with IANS. The close nexus between top officials and poachers had resulted in MP's popular Panna Tiger Reserve being denuded of big cats in 2008. The matter was probed by the central agencies then.

Meanwhile, soon after the news of the policemen's killing came, politics in the state started heating up with leaders from the BJP and the Congress attacking each other. Assam: Many trains cancelled due to rain

Guwahati, May 15: The IAF and the Northeast Frontier Railways have evacuated over 1,500 stranded passengers while over 25 pairs of trains connecting Tripura, Mizoram and southern Assam had to cancelled following heavy landslides triggered by incessant rains in Dima Hasao district in Assam, officials said Sunday.

The NFR officials said that most of the stranded passengers were evacuated on Sunday from Ditokcherra by train while the remaining passengers were airlifted to Silchar by IAF choppers.

In view of water logging and landslides due to heavy rain, between Jatinga Lumpur and New Harangajao, and between Bandarkhal and Ditokcherra sections and other several locations in Lumding-Badarpur hill section of Lumding division of NFR, services of 25 pairs of trains have been cancelled/ partially cancelled.

"The stranded passengers of these trains are safe. All kinds of essential items like food and drinking water are being arranged by the railway authorities for them," the NFR official said.

A district official of Dima Hasao district said that soils of 100 meter railway tracks at Daotohaja-Phaiding section and similar length of the vital Haflong-Jatinga highway had been washed away due to the non-stop rains, which continued for the past five days.

At least three people were killed following heavy landslides in Dima Hasao district in Assam during the last 24 hours.

Chicago: Teenager gunned down

Chicago: A 16-year-old boy was fatally shot near "The Bean" sculpture in downtown Chicago's Millennium Park, authorities said. Police said the teen was shot in the chest at about 7:30 pm Saturday near the popular tourist attraction. Police have not yet identified the boy. He was taken to Lurie Children's Hospital where he was pronounced dead, police said. At least two suspects were taken in for questioning and at least two weapons were recovered, authorities said.

300 Boko Haram terrorists killed

Lagos: At least 300 militants of the Boko Haram terror group were killed by troops of the Multinational Joint Task Force (MNJTF) on the fringes of Africa's Lake Chad region, a spokesperson said. In a statement issued in Nigeria's city of Maiduguri, Kamarudeen Adegoke, the MNJTF spokesperson, said the militants were killed in 30 separate encounters in recent weeks, reports Xinhua news agency. Adegoke said an increasing dependence on improvised explosive devices (IEDs) by the insurgents was noted and necessary countermeasures were proffered.

Israeli peace negotiator dies

Tel Aviv: Uri Savir, a prominent Israeli peace negotiator and dogged believer in the need for a settlement with the Palestinians, has died, according to Israeli media reports. He was 69. The reports said he died Friday. No cause of death was given. As director of the country's Foreign Ministry, Savir led an Israeli delegation to negotiate a series of interim agreements with the Palestinians in 1993 that became known as the Oslo Accords.

3 kids among 6 killed in blast

Peshawar: Three children and as many soldiers of the Pakistan Army were killed in a suicide blast Sunday in Pakistan's restive North Waziristan tribal district bordering Afghanistan, the Army said. The incident occurred in the Miran Shah town, some 250 kms from here, the Army's media wing Inter-Services Public Relations (ISPR) said. The children were aged between 4 to 11 years, it said, adding that three soldiers also died in the incident.

LEBANESE VOTE FINLAND to apply for NATO membership

Beirut, May 15: Lebanese voted for a new parliament Sunday against the backdrop of an economic meltdown that is transforming the country and low expectations that the election would significantly alter the political landscape.

A new crop of candidates from the 2019 protest movement are running against the country's entrenched ruling class that is blamed for the collapse, hoping to unseat them.

But they are divided and lack the money, experience and other advantages held by traditional political rulers with a decades-long



People began casting their ballots shortly after the polls opened under the watchful eye of security forces that have fanned out across the country.

Sunday's is the first election since the massive August 2020 explosion at Beirut's port that killed more than 200 people, injured thousands and destroyed parts of Lebanon's capital.

The blast, widely blamed on negligence, was set off by hundreds of tons of poorly stored ammonium nitrate that ignited in a port warehouse after a fire broke out at the facility.

Kyiv, May 15: Finland's government declared a "new era" is underway after announcing its intention to seek NATO membership, hours before Sweden's governing party Sunday backed a plan to join the trans-Atlantic alliance amid Russia's war in Ukraine.

Russia has long bristled about NATO moving closer to its borders, so the developments will be sure to further anger Moscow. President Vladimir Putin has already warned his Finnish counterpart Saturday that relations would be "negatively affected."

NATO Secretary-General Jens Stoltenberg, speaking Sunday after top diplomats from the alliance's 30 member states met in Berlin, said the process for Finland and Sweden to join could be very quick. He also expressed his hope that Ukraine could win the war as Russian military advances appear to be faltering.

In Finland, President Sauli Niinisto and Prime Minister Sanna Marin made the announcement that their country would seek membership in NATO during a joint news conference at the Presidential Palace in Helsinki. The previously neutral Nordic country shares a long border with Russia.

"This is a historic day. A new era begins," Niinisto said. The Finnish Parliament is expected to endorse the decision in the coming days. A formal membership application will then be submitted to NATO headquarters in Brussels, most likely at some point next week.

Sweden also moved a step closer to applying for NATO membership after the governing Social


Pillai, a Hindu who converted to Christianity in the 18th century drawing the ire of the then rulers, was canonised at 2.30 p.m. (IST) at the St Peter's Basilica in Vatican along with nine others. A miracle attributed to him was recognised by Pope Francis in 2014 leading to

his canonisation now. Church records state that Pillai was born as Neelakanda Pillai in Nattalam in the Kanniyakumari district in 1712. Kanniyakumari was then part of the Travancore king-

dom and Pillai's embracing of Christianity in 1745 made the Maharaja angry. An court official, Pillai introduced to Christianity by Dutch naval officer, Captain De Lannoy when he was in Travancore. After his conversion, he assumed the name of 'Lazarus or 'Devasahayam', meaning 'God is my Help'.

The Travancore Maharaja was, however, furious about his conversion and shot him dead at Aralvaimozhy forest January 14, 1752. Pillai was declared blessed in 2012 in Nagercoil and the Vatican cleared him for sainthood in 2020.

His mortal remains were interred near the altar inside St Xavier's Church, Kottar, Nagercoil which is a diocesan Cathedral now. Special prayers were conducted at churches that are linked







Reds chase their quadruple dream

LIVERPOOL WIN FA CUP AFTER 16 YEARS. THEIR 2ND TROPHY THIS SEASON

London, May 15: Liverpool held their nerves to win the FA Cup for the first time since 2006 after a dramatic penalty shoot-out against Chelsea as the quadruple title-chasers kept their history bid alive Saturday at the Wembley here. Jurgen Klopp's side won 6-5 on penalties as Greek defender Kostas Tsimikas was the unlikely hero with the decisive kick after Alisson Becker kept out

Mason Mount's effort. A hard-fought final had finished a 0-0 draw after extra-time, setting the stage for a nerve-jangling shootout that featured misses by Chelsea's Cesar Azpilicueta and Liverpool's Sadio Mane, whose shot was saved by Edouard Mendy when he had a chance to clinch the trophy

For the second time this season, Liverpool emerged victorious against Chelsea on penalties, having already beaten them 11-10 following another 0-0 draw in the League Cup final in February.

Liverpool's triumph keeps them in the hunt to become the first English team to win all four major trophies in a single season.

With two prizes already secured, the Reds will hope for a slip from Premier League leaders Manchester City, who are three points clear of

them in the title race with two games left for both teams. Even if Liverpool are unable to win a second English title in three seasons, they could still cap an astonishing campaign by winning the Champions League final May 28 against Real Madrid in Paris.

With that ambition in mind, Klopp's only concern as he danced jubilantly in front of the Liverpool supporters amid a swirling mist of red flare smoke was whether his team will be at full strength against Real.

Liverpool lost Mohamed Salah and Virgil van Dijk to injuries that could rule them out of their last two Premier League games next week

and will spark fears about their ability to recover in time for the Champions League final. However, Klopp said there is nothing to worry. "Both are really okay," Klopp said. "It's not a big thing.

For Chelsea, it was a painful third successive FA Cup final defeat after previous losses to Leicester and Arsenal.

Liverpool made a blistering start as they swarmed forward in a blur of swift passes and relentless pressing. However, it must be said that if the first half belonged to Liverpool, then Chelsea were unlucky not to score in the second when Alonso's free-kick cannoned

West Ham open up PL title race, hold Man City

London, May 15: Manchester City were Sunday held to a 2-2 draw at West Ham, and certainly the result brought fresh hopes to Liverpool who chase their elusive quadruple dream. Man City are now on 90 points from 37 games while Liverpool are on 86 from 36 matches. So if Liverpool win their remaining two games and if Man City are held to a draw or beaten by Aston Villa, then certainly it will be déià vu time for the Reds.

City played lethargic football in the first half and were two goals down as Jarrod Bowen struck twice. However, the second half was quite different as City came back strongly. Jack Grealish got a goal three minutes after the restart and a Vladimir Coufal own goal had the City fans screaming for more. They could have sealed up the match if Riyad Mahrez could have converted the spot-kick a few minutes before the final whistle. He missed and with it went City's chances of scripting an amazing turnaround.

FLAWED GENIUS WHO ENTERTAINED ALL

UNTIMELY DEMISE OF SYMONDS IN A CAR CRASH STUNS CRICKET FRATERNITY

Sydney, May 15: Former Australia cricketer Andrew Symonds, one of the finest all-rounders and a two-time World Cup winner, has died in a tragic car accident, leaving the cricketing world in shock. He was 46 and is survived by his wife and two young children.

According to a statement issued by Queensland police, the accident happened Saturday night in Hervey Range Road, about 50km outside Townsville in northeast Australia. The accident happened around

11.00pm in the night. Symonds featured in 26 Tests, 198 ODIs and 14 T20Is in a successful career between 1998 and 2009. He helped Australia win the ODI world Cups in 2003 and 2007 and was one of the key members of

Australia's Test side in the 2000s. Symonds, lovingly known as 'Roy', also had his share of controversies. He was axed from the two ODIs during Australia's tour of England in 2005 after he turned up drunk for a match against

Bangladesh. Three years later, Symonds missed a team meeting after going for fishing in Darwin and was sent back home.

From former Australian wicket keeper Adam Gilchrist and pacer Jason Gillespie to India's Harbhaian Singh and Sachin Tendulkar, tributes poured in for the flamboyant all-rounder. "Think of your most loyal, fun-

loving friend who would do anything for you. That's Roy," Gilchrist, who was part of the World Cup 2003 squad, wrote on his Twitter handle. "This really hurts."



Gillespie, tweeted: "Horrendous news to wake up to. Utterly devastated. We are all gonna miss you mate.

Harbhajan, Tendulkar and Anil Kumble also paid their tributes. 'Shocked to hear about the sud-

den demise of Andrew Symonds. Gone too soon. Heartfelt condolences to the family and friends. Prayers for the departed soul," wrote Harbhajan, who was part of the infamous 2008 Sydney Test when the

Djokovic breezes to year's 1st title

Rome, May 15: Just in time. Novak Djokovic raised his first trophy of the year at the Italian Open tennis tournament here Sunday and showed that he's back in top form exactly a week before the French Open starts. The top-ranked Djokovic beat Stefanos Tsitsipas 6-0, 7-6 (7-5) for his sixth Rome title.

"I've been building my form the last few weeks," Djokovic said. "It couldn't be better timing coming into Roland Garros. Perfect sce-

nario for me," Djokovic added. Earlier on the red clay, Iga Swiatek defended the women's title by overwhelming Ons Jabeur 6-2, 6-2 to extend her winning streak to 28 matches.

Djokovic didn't drop a set all week, having won his 1,000th career match over Casper Ruud in the semifinals. Djokovic, who was deported because of his un-vaccinated status ahead of the Australian Open, hadn't won a tournament since raising the Paris Masters trophy in November.

Djokovic needed only 30 minutes to win the opening set, during which Tsitsipas got so frustrated at one point that he banged his racket against his bag during a changeover. After falling behind early in the second set, Djokovic stepped up his game when Tsitsipas weas serving for the set at 5-3. He broke back to take the set to a tiebreak and won comfortably.
