Odisha Universities Amendment Act put on hold by top court

New Delhi, May 20: The Supreme Court Friday put Odisha Universities (Amendment) Act, 2020 on hold for three months while seeking response from the state government in connection with the Act. The next hearing on the matter will be held after two months, it was learnt.

The Orissa High Court had earlier upheld the validity of the Act. However, the University Grants Commission and a professor had moved the SC challenging the decision of the HC. In its affidavit, the UGC had said the Act was in conflict with UGC Regulation-2018 issued under the University Grants Commission Act, 1956

However, the state higher education department claimed that the stand of UGC is limited to the Amendment Act while dealing with the appointment of vice-chan cellors and other teaching staff of universities. The Act has been in the limelight as it seeks to bring appointments to important academic and administrative posts in universities under the state govern-



London, May 20: As more cases of monkeypox are detected in Europe and North America, some scientists who have monitored numerous outbreaks in Africa say they are baffled by the unusual disease's spread in the West.

Cases of the smallpox-related disease haven't previously been seen among people with no links to central and West Africa. But in the past week, Britain, Spain, Portugal, Italy, the US, Sweden and Canada all reported infections, mostly in young men who hadn't previously travelled to Africa.


France, Germany, Belgium and Australia confirmed their first cases of monkeypox Friday.

"I'm stunned by this. Every day I wake up and there are more countries infected," said Oyewale Tomori, a virologist who formerly headed the Nigerian Academy of Science and who sits on several World Health

health officials are exploring is whether the disease is being sexually transmitted. Health officials have asked doctors and nurses to be on alert for potential cases, but said the risk to the general population is low.

Outbreaks in Nigeria, which reports about 3,000 monkeypox cases a year, are usually in rural areas, where people have close contact with infected rats and squirrels, according to Tomori. He said the disease does not spread very easily and that many cases are likely missed.

LONDON: The World Health Organisation Friday called an emergency meeting to discuss the recent outbreak of monkeypox, a viral infection more common to west and central Africa, after more than 100 cases were confirmed or suspected in Europe. In what Germany described as the largest-ever outbreak in Europe cases have now been confirmed in at least five countries - the United Kingdom, Spain Portugal, Germany and Italy- as well as the United States, Canada and Australia.

phants, including two calves, were killed after being hit by a goods train in Keonjhar district, forest officials said Friday. The accident took place near

Bansapani under the Joda forest section of Champua range when a herd of around 20 jumbos was crossing the railway tracks at around 7.30 pm Thursday. One elephant calf, aged 5, died

on the spot, while a female pachyderm, aged 20, and another calf, aged 5, succumbed to their injuries Friday morning, a forest official said. Following the accident, the elephant herd prevented forest officials from carrying out rescue operations, he said.

"The forest department personnel were monitoring the elephant herd movement through-



out the day. The railway authorities were also informed about presence of the elephants there and speed of the train was contained at 25kmph. The accident took place due to darkness," another senior forest official said. Principal Chief Conservator of Forests (Wildlife) Shashi Paul visited Keonjhar and took stock of the situation. 

The screening of the film was greeted with a thunderous applause as it received a standing ovation from



Finally, Ramco gets SPCB notice

Jajpur, May 20: The Odisha State Pollution Control Board (SPCB) has served a show-cause notice on Ramco Cement over pollution in Dharmasala area of this district. seeking its replies within 15 days on alleged violation of environment protection norms. The development comes after 10 days of publication of a report on alleged inaction by the pollution watchdog in Orissa POST.

In the show-cause notice, the SPCB has warned that legal proceedings will be initiated against the cement plant authorities if the latter fail to file satisfactory replies.

Locals alleged that the inaction, despite glaring violation of pollution norms by the plant, was due to the bonhomie between the firm's management and the administration & some influential

a green cover around the plant to ensure safety to the villages. Locals, however, said no such green cover has been created here. Besides, the plant has no solid waste management system as prescribed in Environment Protection Act.

Earlier, upset over pollution, locals have approached the subdivisional magistrate by furnishing documental evidence on pollution and violation of norms by Ramco Cement Plant March

Hearing the case March 28, the magistrate had directed the managing director and the public relations officer of Ramco Cement Plant to appear before the court April 12 along with necessary documents. However, the officials had not appeared before the court, triggering anger among the locals.

SPCB regional officer Pramod Kumar Behera admitted that the SPCB investigation had found air and water pollution by Ramco Cement. A report in this regard was submitted to the SPCB in March. A show-cause notice has been issued to Ramco Cement. Pollution status in the areas will be reviewed

after 15 days, he added.

No more ownership transfer of tractors bought under DBT

Bhubaneswar, May 20: In a bid to ensure tractors supplied under the subsidy scheme of the government can only be used for farming, the state government has decided to stop transfer of ownership of such tractors at least for a period of five years from the date of purchase, an official said Friday.

Transport department joint secretary Kishore Chandra Das has asked the Transport commissioner to instruct the Regional Transport Officers (RTOs) for disallowing transfer of ownership of tractors purchased by farmers in the state through subsidy.

As per the guidelines of the government, tractors purchased by farmers under Direct Benefit Transfer (DBT) scheme for agriculture mechanisation should be owned by the beneficiaries at least for a period of five years from the date of its registration.

In order to be a beneficiary of the scheme, farmers are allowed to buy tractors only through the Orissa Agro Industries Corporation (OAIC) Limited which has the authentication to apply for registration of such vehicles through VAHAN portal, said Das in a letter to the Transport commissioner,

"OAIC district managers are the authorised dealers for tractors sold under DBT schemes of the government. Therefore, the Transport commissioner has been requested to instruct all RTOs to ensure that vehicles sold under the subsidy schemes through OAIC $\,$ are not allowed to apply for transfer of ownership for the first five years from its initial date of registration," said the Transport department joint secretary.

Moreover, the Transport department has directed the NIC to make necessary changes to the VAHAN portal so that any beneficiary who has registered his vehicle through OAIC will be identified and disallowed transfer of ownership within the period.

According to sources, many beneficiary farmers of the DBT scheme sell their tractors to avail financial benefit, violating the government norms. Due to this, the objective of the scheme has not been archived yet.

PLANT 50 TREES, HC TO KAKATPUR TEHSILDAR

Cuttack, May 20: The Orissa High Court has ordered Kakatpur tehsildar to plant 50 saplings as a penalty for imposing a fine on a poor woman without hearing her case of encroachment last year.

Mita Das of Kakatpur in Puri was residing in a thatched house built on a government land for which the local tehsildar Biranchi Narayan Behera had instituted a case against her under Odisha Prevention of Land Encroachment Act in July 2021. Behera imposed a penalty of Rs 1,004 on her reportedly without hearing her case and issued show-cause notice September 15 last year, it was learnt.

Later, Das moved the HC alleging that the tehsildar had imposed fine without hearing her case. After hearing the petition, the

single-judge bench of Justice Biswanath Rath said that the tehsildar has the responsibility to find whether the encroacher is an educated and law-knowing person or not.

"Once an encroacher volunteers to appear, the tehsildar if finds there is no written response from him (encroacher), at least should provide one more opportunity to file his response to find the reason on his residing over such plot and if a person is landless or not? Even after filing of show cause, there should not be passing of orders in encroachment proceedings mechanically," the HC said, ordering the tehsildar to plant at least 50 saplings in CDA area of Cuttack.

The court also directed Revenue and Disaster Management department and Law department to ensure that the tehsildars do not to repeat such mistakes in future.

Mao posters in Nabarangpur

2 escape from High Court denies bail to Chilika MLA

Cuttack, May 20: The Orissa High Court Friday rejected the bail application of MLA Prasanta Kumar Jagadev and directed the Chilika legislator to surrender for his judicial custody by May 23.

Steps will be taken against him if he failed to comply, Justice Shatrughna Pujahari ruled.

The lawmaker has at least a dozen $criminal\ cases\ pending\ against\ him\ and$ is now suspended from the party.

He was arrested March 12 this year by the Banapur police when he drove his car into a crowd with an intention to 'murder his political oppo-



nents'. Several persons, including some police personnel, were injured by the car, which had a fake number plate, it was learnt.

"Such indulgence and overt act can never be treated as becoming of a public representative. That apart, the series of criminal cases attached to his antecedent speak against his credibility to abide by condition, if any, imposed in case of his bail, more so when he has also not abided by earlier bail conditions," the judge said rejecting his bail application.

On the health concerns expressed by the MLA, the judge said he could seek any medical check-up or treatment while in judicial custody.

Cold virus behind 1L child deaths in 2019: Lancet

common virus that usually causes cold-like symptoms was Acauses colu-line symptom
responsible for more than 1,00,000 deaths in children under the age of five across the globe in 2019, according to a new study published in The Lancet journal.

The study is the first to examine the Respiratory Syncytial Virus (RSV) disease burden in narrow age brackets, reporting that there were over 45,000 deaths in infants under six months old in 2019, with one in five of the total global cases of RSV occurring in this age group.

"RSV is the predominant cause of acute lower respiratory infection in young children and our updated estimates reveal that children six months and younger are particularly vulnerable," said research co-author, Harish Nair, from the University of Edinburgh, UK.

"This is especially with cases surging as Covid-19 restrictions are easing around the world and the majority of the young children born in the last two years have never been exposed to RSV (and therefore have no immunity against this virus),"

Nair said. The researchers noted that with

numerous RSV vaccine candidates in the pipeline, the estimates by narrower age ranges help to identify groups that should be prioritized.

These include pregnant people so that children in the youngest age groups can be protected, similarly to current strategies which offer vaccines for whooping cough, typhoid, and tetanus to pregnant people, they said.

The findings are broadly consistent with previous estimates from a 2015 study, which placed the number of annual cases of RSV in children up to five years old at 33.1 million, resulting in a total of 118,200 overall deaths, the researchers said.

However, these updated calculations of RSV mortality on global, regional, and national levels for the year 2019 include modelling data from over a hundred new studies, they said.

This allowed researchers to provide estimates for narrower age groups - including from 28 days to six months old. which is known to be the age range with the highest RSV fatality rate -- and community mortality rates—deaths that did not occur in a

Across the globe in 2019, there were 33 million RSV-associated acute lower respiratory infection episodes in children under five years old, leading to

3.6 million hospital admissions, 26,300 in-hospital deaths, and 101,400 RSVattributable deaths overall, the researchers said.

This accounts for one in 50 or 2 percent of annual deaths from any cause in this age range, they said.

For children under six months old, there were 6.6 million RSV-associated acute lower respiratory infection episodes globally in 2019, according to the researchers.

There were 1.4 million hospital admissions, 13,300 hospital deaths, and 45,700 overall deaths attributable to RSV in this age range, accounting for one in 50, or 2.1 percent of annual deaths from any cause, they said.

Based on estimates of in-hospital versus overall RSV mortality rates, globally only 26 percent or approximately one in four RSV-associated deaths occur in a hospital.

This is particularly apparent in low- and middle-income countries, where the in-hospital case-to-fatality ratio for children under five is 1.4 percent, compared to 0.1 percent in high-income countries.

Overall, 97 percent of RSV deaths in children under five occurred in low- and middle-income countries.

It was learnt that Kishore Mohanty had won the election by a margin of 70,000 votes. The health minister has asserted that party nominee Alaka Mohanty (Kishore's wife) will win the bypoll by a margin of 50,000 votes.

Previous general election in 2019 had witnessed a tough fight between BJD and BJP.

For quite a long time, Assembly constituency was a bastion of CPI. The party candidate and former MLA late Prasanna Panda had won this seat six times - 1961, 1967, 1974, 1985, 1990 and 1995.

Similarly, Congress candidate Upendra Dixit had represented the Assembly segment three times -1971, 1977 and 1980. Subsequently, Congress candidate Anup Sai got the mandate three times from 2000 to 2009.

The first bypoll to Brajarajnagar was necessitated following the death of former MLA Panda December 26, 1997. The bypoll had then witnessed a tough contest between Congress candidate Keshab Sahu (who won with 28,476 votes) and BJP candidate Radharani Panda (who lost by 27,954 votes). However, in 2014 general elections, BJP candidate Radharani won the seat by defeating her nearest contender Anup Sai who had this time fought with a BJD ticket.

In 2019, the BJD fielded Kishore Mohanty from Brajarajnagar Assembly constituency segment and he won by defeating BJP's

The UN Chief called on governments to fast-track and streamline approvals of solar and wind projects, modernise grids and set ambitious renewable energy targets that provide certainty to investors, developers, consumers and producers.

The secretary-general called for shifting subsidies away from fossil fuels. "While people suffer from high prices at the pump, the oil and gas industry is raking in billions from a distorted market. This scandal must stop." Guterres pointed out.

Old Workhorse

hen unsure, fall back on the old and reliable. The Centre has apparently decided not to appoint officers from the Indian Legal Service (ILS) or law specialists as the Union Secretary of the Law Ministry. It has chosen to rely on the old workhorse, the ubiquitous IAS, by naming 1990-batch IAS officer Nitin Chandra as the new law secretary.

Though this all-India service has existed since 1956, few in the public are aware of its existence. ILS officers are generally appointed at various levels, beginning with undersecretary in various departments including the Legal Affairs Department, Legislative Department and the Justice Department of the ministry. Though ILS officers are largely appointed by the UPSC, officers are often taken on deputation from other departments as well.

Chandra replaced AK Mendiratta, a judicial service officer, who was ap pointed as a Judge of the Delhi High Court earlier in February. Interestingly, it's Mendiratta who reportedly drafted the ill-fated farm laws that created such a stir, leading to a year-long agitation by protesting farmers. Recall that even the Chief Justice had lamented the fall in quality and precision of drafting legislation in the country.

This could perhaps hold a clue to Chandra's appointment. Perhaps the Centre felt that an IAS officer would be a better fit for the post. Sources have informed DKB that the stellar track record of previous Law Secretary Alok Srivastava might have persuaded the government to return the post to the IAS cadre.

Babus' cooling-off period

The Centre's lateral entry policy in which it is hiring domain specialists from the public and private sectors is being offset by a trickle of high-pro-

file exits of senior babus to the corporate world. In many instances, these babus have taken up lucrative assignments shortly after leaving the civil service or retirement, even though rules stipulate that officials have to undergo a year-long "cool-

The recent appointment of Archana Goyal Gulati, former Member of NITI Aayog and Competition Commission of India (CCI) as head of public policy at Google, has revived the old debate. Sources say that Gulati was posted at CCI when it ordered a probe into Alphabet Inc, Google's parent company, Gulati, however, has pointed out that she joined well after the end of the mandatory "cooling off" period. But murmurs are unlikely to die down.

Gulati is following in the footsteps of several other babus who decided to explore the challenges and opportunities offered up by the brave new corporate world. Last year, Rajiv Aggarwal, a UP cadre IAS officer, joined a global social media platform as head of policy.

It isn't hard to see why senior babus are showing keen interest in leaving the confines of babudom, with its rules and restrictions, to join global companies. But the issue of having a mandatory cooling-off period for retired babus with corporate or even political ambitions needs greater debate. Does it lead to a better rapport between the government and private companies, as its votaries claim, or does it raise the inevitable questions about propriety, transparency, impartiality etc. of such babus who may have dealings with a corporate entity in their official capacity and then join the same company

Centre raps Khattar govt

The tussle between IAS and IPS officers of Haryana over postings has escalated after the Centre's intervention. Of late, the Manohar Lal Khattar government has been appointing non-cadre officers from IPS, IFS and IRS to cadre posts. Further, the state government had sought the Centre's approval of 11 non-cadre officers for cadre posts.

Now the Centre has responded stating that the state government cannot post non-cadre officers to cadre posts beyond three months without the Centre's prior approval. It has also sought from the state government details of all cadre officers against cadre posts. Sources say that the state government is vet to take a call to this directive from Delhi.

But the IPS Officers Association has written to state Chief Secretary Sanjeev Kaushal that there has been no violation of cadre rules. The IPS officers argue that the three posts of Principal Secretaries held by non-IAS of-

ficers are not cadre posts. But that may not cut ice with the babus in Delhi. The IAS officers have clearly struck back at the Khattar sarkar, but whose will prevail? How Kaushal responds to the Centre's directive will give an indication.



■ Aerobot

Agencies working for NASA have used this term for craft designed to explore solar-system bodies such as Venus, Mars and Titan. Three sorts of aerobots are proposed or are under development. One type is an unmanned aerial vehicle (UAV), which is launched from an orbiting spacecraft and deploys wings before it lands. The second is a lighter-than-air craft, a helium-filled balloon fitted with heaters powered by solar cells. A third is a hybrid balloon-kite system sometimes called a helikite. An advantage of the second and third kinds is that they don't need fuel, which is expensive to transport and which runs out all too soon. Unlike satellites or the winged aerobot, the lighter-than-air versions can fly for extended periods, allowing long-term monitoring of the properties of the atmosphere. They can also view and record the ground from much lower altitudes than is possible with satellites. In the NASA sense, the word combines the prefix aero-, as in aeronautics, with bot, a common abbreviated form of robot. However, aerobot is also a trademarked term of Moller International for its small ducted fan aerial vehicle, in which the first part of the word would seem to be from aerial rather than aeronautics.

troops on Ukraine's border late last year, it embarked on a path of aggression against not just Ukraine but also what it calls the "collective West," particularly the European Union and NATO. Russia was seeking to deter Ukraine and the West from increased collaboration, while the West was seeking to deter Russia from aggression. The subsequent invasion stems from a massive failure of deter-

The Ukrainians have marshalled an impressive defence, and the EU, NATO, and other Western partners and allies have continued to tighten economic and financial sanctions and provide aid. But we are in a dangerous cycle of escalation. The situation demands credible deterrence that goes far beyond the traditional "nuclear umbrella .

After all, deterrence is not only about nuclear warfare. It is relevant to all forms of confrontation – whether in business or on the battlefield. Many of these dynamics are present in the current conflict. Russia and Europe's codependent energy relationship had been deemed a strong deterrent on both sides; but it patently

Deterrence is about convincing an opponent that not doing something is in its best interests. Russia first attempted to deter Ukraine and the West by deploying its troops along Ukraine's borders. But as it did, the United States and its NATO allies released daily intelligence and data revealing Russian troop movements, demonstrating clearly to the Kremlin that they knew what it was doing. Such signaling is the first element of deterrence.



Deterrence must be a popular aim that commands widespread public support. It also must be backed by other countries, because international cooperation is crucial for ensuring the security of smaller, vulnerable states. Achieving such broad-based support requires effective,

inspirational leadership of the kind that Ukrainian President Volodymyr Zelensky has demonstrated

Another core element of deterrence is the belief that an adversarv has both the will and the capability to escalate measures if the other side does not change course. When Russia issued a litany of demands designed to highlight Ukraine and NATO's vulnerabilities-from Ukraine's status as a state to the overall European security architecture its audience didn't find its threats to be credible.

With the exception of the US, few believed that Russia would launch a full-scale invasion or persist with its threats against NATO and neutral states. Yet Russia did invade and has since issued veiled nuclear threats and even tested a new supersonic missile.

Similarly, Russian President Vladimir Putin did not take seriously French President Emmanuel Macron, German Chancellor Olaf Scholz, and other Western leaders when they expressed their intentions to support Ukraine. The Kremlin heard these statements, but it also heard several other leaders, including US President Joe Biden, say that they would not send troops to defend a non-NATO country. Russia thus decided to invade, only to be surprised by the scope and intensity of the West's response. For its part, Ukraine's deter-

rence strategy was essentially to project an image of itself as a country that already belonged to the West. And though the Kremlin was unpersuaded, Russia clearly underestimated Ukrainian unity and the capability and competence of its army, even though it had been fighting Ukrainian forces since its incursions into the country in 2014.

Ukraine's heroic self-defence reminds us that beyond the battlefield and business, beyond sanctions and institutions, there are ordinary people: the war is taking place among them, and they will decide its ultimate outcome. Though Ukrainians' will to defend their lives, homes, and ideals has not yet deterred Russia's leadership, there is strong evidence that it has deterred many Russian soldiers from fighting.

Looking ahead, Western deterrence must become a primary strategic objective and thus more comprehensive, including all the elements that matter, US Secretary of Defense Lloyd Austin took a step in this direction by announcing that one of America's goals now is to "see Russia weakened to the degree that it can't do the kinds of things that it has done in invading Ukraine." And the \$33 billion lend-lease bill that Biden signed on May 9 will further advance this goal.

But it's not enough. Deterrence must be a popular aim that commands widespread public support. It also must be backed by other countries, because international cooperation is crucial for ensuring the security of smaller, vulnerable states. Achieving such broad-based support requires ef fective, inspirational leadership of the kind that Ukrainian President Volodymyr Zelensky has demonstrated. He has rallied not only the Ukrainian people but the entire Western world. Other leaders would do well to follow

Finally, it is important to remember where deterrence fits in the broader context of globalization. Russia was emboldened by the economic interdependencies that it has cultivated, and it was empowered by its status as a permanent, veto-wielding member of the United Nations Security Council. Deterrence must include measures either to neutralize or contain both factors.

The war in Ukraine is the result of insufficient deterrence. Ultimately, there will be no peace without it.

Patiala, May 20: Congress leader Navjot Singh Sidhu surrendered before a court here on Friday, a day after being sentenced to one-year rigorous imprisonment by the Supreme Court in a 1988 road rage death case.

"He surrendered before the court of Chief Judicial Magistrate Amit Malhan," said senior advocate HPS Verma, who accompanied Sidhu to the court. The former Punjab Congress president surrendered shortly after 4 pm, and was taken for the mandatory medical examination, conducted at the Mata Kaushalya Hospital.

After the medical check-up, he was lodged in the Patiala Central

Some party leaders including Navtej Singh Cheema, Ashwani Sekhri and Sidhu's supporters accompanied him from his home to the court, which is close to his residence. Cheema drove Sidhu, who was dressed in a blue-coloured 'pathani suit', to the court in an SUV.

This came just hours after the former Punjab Congress president approached the Supreme Court seeking a few weeks to surrender to serve the imprisonment.

The top court bench of justices AM Khanwilkar and JB Pardiwala told senior advocate A M Singhvi, appearing for Sidhu, that the judgment on one-year rigorous imprisonment was passed by a special bench, and that he can file the application and mention it before the Chief Justice.

Singhvi said he will try and mention the matter before the Chief Justice, Back in Patiala, some former MLAs and supporters turned up at Sidhu's residence in the morning to show their support.

Mumbai, May 20: In a self-inflicted political blow, Maharashtra Navnirman Sena President Raj Thackeray Friday morning tersely announced that he has temporarilv "postponed" his proposed visit to Ayodhya June 5.

He himself made the announcement via social media but didn't spell out any reasons for the move, leading to wild speculations in political circles.

MNS spokesperson Sandip Deshpande and party leader Bala Nandgaonkar were at a loss to explain what actually prompted the unexpected decision, but assured that Raj Thackeray will enlighten the people about it at his planned public rally in Pune Sunday.

Adding to the MNS' awkward ness, ruling Maha Vikas allies' leaders like Shiv Sena's Tourism Minister Aditya Thackeray and state Congress President Nana Patole announced that their upcoming tours for 'darshan' of Ram Lalla would proceed as per schedule and their trips would be "nonpolitical".

Taking a swipe at the MNS chief, Shiv Sena chief spokesperson Sanjay Raut said that he heard about it from the media, "but we would have supported him".

Earlier, apprehending threats MNS' Nandgaonkar had called on Maharashtra Home Minister Dilip Walse-Patil and demanded security for Rai Thackeray either from the state government or the Centre.

Simultaneously, he warned that "even if a hair of Raj was harmed, Maharashtra would burn", though preparations for the Ayodhya trip continued

Since a month, Raj Thackeray has been in the limelight after he launched an agitation demanding removal of loudspeakers from all mosques in the state failing which his activists would blare Hanuman Chalisa double-decibel levels.


Lucknow to get its 1st dog park soon

Call to treat widows with dignity grows

Mumbai, May 20: Days after Herwad village in Maharashtra's Kolhapur district passed a resolution to ban the customs associated with widowhood to maintain women's "right to live with dignity", those spearheading this campaign are now following up with the state government, demanding that a law be framed to end the "regressive" traditions.

The village passed the resolution May 4, after which the Maharashtra government issued a circular asking all gram panchayats in the state to adopt the "Herwad model".

The Herwad gram panchayat in Shirol taluka passed the resolution to ban customs like removing a widow's mangalsutra, toe ring, wiping her sindoor (vermilion) and breaking her bangles as part of rituals handed down over time.

As per the customs, widows were barred from attending social and religious gatherings. The pioneering move by this vil-

lage is being seen as the beginning of the enactment of a law to safeguard the dignity of widows. Pramod Ziniade, who heads a social welfare organisation named after reformer Mahatma Phule in Solapur district, is an inspiration behind the Herwad model.

Talking to PTI, he said Herwad is the first village in the country to pass such a resolution and seven more villages have followed suit. "Mere resolutions will not be enough and a legal sanction to end the regressive practices is the need

of the hour," he said. The other widows who disfigure the deceased man's grieving wife, the relatives who silently watch it happen, the villagers who participate in the funeral should be held guilty for humiliating the widow. The women who perform the regressive actions should be punished with three months to one year in jail and Rs 5,000 to Rs one lakh penalty be imposed on them, he said.

The relatives should be punished for 15 days to one month in jail and Rs 5,000 to Rs 50,000 penalty. While the participants in the funeral should be punished by way of making them sit together for a day in the village itself, he said. A monitoring committee should be set up to check if the law is being violated at the local level. The committee should have 50 per cent women as members and half of them should be widows, Zinjade said.

Over 17L tonne of sugarcane still lying in farms across Maha

Aurangabad, May 20: Around 17.5 lakh tonne of sugarcane is still lying uncut in farms across Maharashtra although the crushing season has ended, but majority of this stock shall be crushed by the end of this month and over 30 sugar mills will remain functional till it is over, a top official said.

The sugarcane crushing season in Maharashtra generally starts in October-November and continues till mid-April.

Out of the 10 districts in Maharashtra that have topped the list of excess sugarcane stock this year, seven are from the Marathwada region, the official said.

"After good rains last year, the area under sugarcane cultivation in the state increased significantly. Even after the sugarcane crushing season has got over; the state still has around 17.5 lakh tonnes of sugarcane standing in farms, waiting



to be crushed. Hence, crushing in some parts of the state may continue till the first week of June." he

said. Talking to PTI, Maharashtra sugar commissioner Shekhar Gaikwad said, "The quantum of sugarcane currently standing in the farms across the state is around 17.5 lakh tonnes. Most of this crop will be crushed by May 31. In some parts of Ahmednagar and Jalna districts, the crushing activity may continue till the first week of June."

"So far, we have succeeded in bringing 129 harvesters from other states and all are working in . Marathwada. In Jalna alone, 29 harvesters are working at present," he said.

The state had recorded sugarcane

plantation on 11.42 lakh hectares in 2020-21, but this year (2021-22), the figure went up by 2.25 lakh hectares to 13.67 lakh hectares. The quantity of sugarcane crushed last year was 1,013.31 lakh tonnes, while this year (till May 16) 1,300.62 lakh tonnes of sugarcane was crushed - an increase of 287.31 lakh tonnes, another official said. Over 30 sugar mills in the state may continue their operations till May

"Apart from hi-tech electric roti maker machines for preparing fresh chapatis, electric cookers for dal (pulse) and chawal (rice) preparations are also been utilised for meal preparations," said Kaushambhi district jail Superintendent, Rakesh Singh.

The prison now has an electric roti maker and the machines used for peeling and cutting vegetables and potatoes

He added that the installation of the machines save labour and help in preparing food faster and a more

hygienic manner. "The inmates can now enjoy fresh



and warm food. The electric roti maker machine will help to shape and serve around 3,000 chapatis in an hour," said the jail official.

This has also reduced the number of inmates engaged in making rotis from 25 to 10. Nearly 3,000 rotis are being prepared two times a day. The Kaushambhi district jail has more than 1,000 inmates and nearly 50-60 inmates were earlier deputed to prepare the food every day. The jail authorities have also brought insulated utensils to keep the food warm and fresh

"Initially, jail authorities faced some problems as inmates did not have much knowledge about these machines and did not know how to use them but we have got experts to train them," the Jail Superintendent said.

Recently, celebrity chef Ranveer Brar had been invited to teach iail inmates how to improve their culinary skills and prepare tastier food.



CBI files fresh case against Lalu

New Delhi, May 20: The CBI has registered a fresh FIR against former Bihar chief minister Lalu Prasad and family members for allegedly taking over one lakh sq ft land in Patna from candidates in return for group D jobs in Railways during 2004-09 when he was the railway minister in the UPA government, officials said Friday.

Following the registration of FIR on May 18 by the Economic Offences wing of the CBI, the agency started a search operation at 16 locations in Delhi, Patna and Gopalganj at the premises of Prasad, his family members and other accused. The CBI has named Prasad, his wife Rabri Devi, and daughters Misa Bharti and Hema Yadav, in addition to 12 people who were given jobs in Railway zones of Mumbai, Jabalpur, Kolkata, Jaipur, Hajipur, the officials said.

The central agency had registered a preliminary enquiry on September 23, 2021 related to the land-for-jobs scam in Railways. The candidates were appointed as substitutes in group D positions within three days of applying in "undue haste" by Railway officials and were later regularised "in lieu thereof the individuals themselves or their family members transferred their land"

Pegasus row: SC grants more time

At present, there is one vacancy in the poll panel which had been a three-member body since October 1993.

The CEC and ECs draw salary and perquisites as per Section 3 of the Election Commission (Conditions of Service of Election Commissioners and Transaction of Business) Act, 1991.

They are entitled to a monthly sumptuary allowance of ₹34,000. There is no income tax payable by the CEC and ECs on this allowance. They are also entitled to three LTCs in a year for self, spouse and dependent members

or deploying AI in the country. "As the adoption of AI grows steadily, organisations in India are

using AI to augment their core business processes and services to better serve their clients, employees, and important stakeholders," said Siddhesh Naik, Data, AI & Automation Sales Leader, IBM Technology Sales, IBM India South Asia


The report saw three trends clearly emerging in India. First, automation use cases are at the forefront of AI adoption as businesses are using AI to stay competitive and operate more efficiently. "Second, effective data management and AI deployment go hand

Heatwave: Parts of Spain on alert

Madrid: Large parts of Spain were under alert Friday as a wave of intense heat began sweeping across the country, leaving residents sweltering through May temperatures that rank among the hottest in two decades. A mass of hot, dry air carrying dust from North Africa has pushed temperatures up to 15 degrees above average, with the mercury topping 40 degrees Celsius in parts of the country. The State Meteorological Agency said it expected the "unusual and extreme" temperatures to peak Saturday.

Of the 151 seats, a party has to win at least 76 seats to capture power.

11 soldiers killed in Jihadis' attack

Ouagadougou (Burkina Faso): Eleven soldiers were killed and nearly two dozen injured by iihadis targeting a military base in eastern Burkina Faso, the government said. Injured soldiers have been taken to hospital and aerial support killed 15 attackers trying to flee after Thursday's attack in Madjoari in Kompienga province, Burkina Faso's army said in a statement. For six years the West African country has been ravaged by violence linked to al-Qaida and the Islamic State group that has killed thousands and displaced nearly 2 million people.

Tunis: Four migrants died and 10 others went missing after a boat carrying 58 migrants sank off Tunisia's eastern coast, authorities said. A total of 44 migrants onboard the boat were rescued off the coast of Sfax city, and search was still underway for the missing migrants, the Tunis Afrique Presse (TAP) reported These migrants were trying to cross the Mediterranean Sea to Italy, according to the report. Located in the central Mediterranean, Tunisia is one of the most popular transit points for illegal immigration to Europe, Xinhua news agency reported.

Putin has declared that "unfriendly foreign buyers" open two accounts in state-owned Gazprombank, one to pay in euros and dollars as specified in contracts and another in rubles. Italian energy company Eni said this week that it was "starting procedures" to open a euro and a ruble account.

The European Commission. the European Union's executive arm, has said the system does not violate EU sanctions if countries make a payment in the currency listed in their contracts and then formally signal that the payment process is concluded. But it says opening a second account in rubles would breach sanctions

That's left countries scrambling to decide what to do next. Analysts say the EU stance is ambiguous enough to allow the Kremlin to keep trying to undermine unity among the 27 member countries but losing major European cus-

G7 nations commit \$19.8bln aid to Ukraine

Koenigswinter, May 20: The Group of Seven leading economies agreed Friday to provide \$19.8 billion in economic aid to Ukraine to ensure its finances do not hinder its ability to defend itself from Russia's invasion.

German Finance Minister Christian Lindner told reporters that \$9.5 billion of the total amount was mobilised at meetings of the G-7 finance ministers in Koenigswinter, Germany,

"We agreed that Ukraine's financial situation must have no influence on Ukraine's ability to defend itself successfully," he said. "We need to do our utmost to end this war'

Russia's invasion touched on almost every topic of the finance ministers' meetings this week, from the need to reduce reliance on Russian energy to reforming relationships between countries to maintain economic stability



Russia's war of aggression is causing global economic disruptions, impacting the security of global energy supply, food production and exports of food and agricultural commodities, as well as the functioning of global supply chains in general G-7 STATEMENT

US Treasury Secretary Janet Yellen and other leaders spoke this week about the need for allies to put together enough additional aid to help Ukraine "get through" the Russian invasion

"All of us pledged to do what's necessary to fill the gap," Yellen said Thursday as the ministers finished their first of two days of talks.

"We're going to put together the resources that they need." The International Monetary Fund's latest world economic outlook says Ukraine's economy is projected to shrink by 35 per cent this year and next.

The finance ministers of the G-- which includes Canada, France, Germany, Italy, Japan, the United Kingdom and the US — also have grappled with deepening inflation, food security concerns and other economic issues during their talks.

A communique marking the end of their meetings addressed commitments to addressing debt distress in low-income countries, trying to ease the fallout from the coronavirus pandemic and staving off inflation rates "that have reached levels not seen for decades.

As the finance ministers were meeting in Germany, the US overwhelmingly approved its own \$40 billion infusion of military and economic aid for Ukraine and its allies. A portion of the US funding was included in the G-7 package for Ukraine.

As Joe Biden visits Asia, China launches SCS drills

Police have not released details about what led to the shooting, but a witness, 18-year-old Deonna Jackson, said it appeared to stem from a fight outside the restaurant.

The shooting comes amid a surge in deadly violence in Chicago in recent years, and follows a fatal shooting last weekend in downtown Millennium Park that killed a teenand led the city to tighten a curfew for young people.

India exercised the Right of Reply at the Security Council open debate on 'Maintenance of International Peace & Security -Conflict and Food Security' organised by the US, the Council President.

"The Union Territories of Jammu and Kashmir and Ladakh were, are and will always remain an integral and inalienable part

of India. This includes the areas that are under the illegal occupation of Pakistan. No amount of rhetoric and propaganda from any country can deny this fact,' Parihar asserted. The Pakistan foreign minister, who is on a maiden visit to the US, also raked up the Kashmir issue while responding to questions during a press conference in New York Thursday

"As far as the question of our relationship with India is concerned,

Business Insider reported Thursday that Musk's private company SpaceX paid \$250,000 in 2018 to settle a sexual harassment claim from an unnamed private jet flight attendant who accused Musk of exposing himself to her. The article quoted an anonymous person who said she was a friend of the flight attendant. The friend had provided a statement as part of the private settlement process, according to the article

"I have a challenge to this liar who claims their friend saw me 'exposed' – describe just one thing. anything at all (scars, tattoos, ...) that isn't known by the public. She



won't be able to do so, because it never happened," Musk tweeted late Thursday. Musk and SpaceX did not respond to Reuters requests for comment on the Business Insider story or on tweets by the billionaire. In a statement to *Reuters* Friday, Business Insider said: "We stand by our story which is based on documents and interviews and which speaks for itself."

Business Insider quoted the friend of the flight attendant as saying that in addition to allegedly exposing himself, Musk rubbed the flight attendant's thigh and offered to buy her a horse if she would "do more" during an inflight massage.

CCPA issues notice to Ola and Uber

New Delhi, May 20: Consumer protection regulator CCPA Friday said it has issued notices to cab aggregators Ola and Uber for unfair trade practices and violation of consumer rights.

The Central Consumer Protection Authority (CCPA) has given 15-days time for these two companies to reply to the notices.

'We have issued notices to both Ola and Uber. Most of the consumer complaints received in the last one vear are related to the deficiency in services and other unfair trade practices." CCPA Chief Commissioner Nidhi Khare said.

The authority pointed out that a significant number of complaints have been lodged by consumers across the country on multiple issues, which affect their rides booked through both the ride-hailing platforms. The meeting was attended by representatives of Ola, Uber, Meru, Rapido, and Jugnu.

"The deficiency in services includes lack of proper response from customer support, driver refusing to take payment by online mode and insisting on the cash only, the higher amount charged despite going on the same route previously at a lesser charge, unprofessional driver behaviour and driver refusing to switch on AC when the consumer is promised AC ride on the app," the CCPA said.

RBI approves dividend of ₹30,307cr to Centre

Mumbai, May 20: Reserve Bank of India (RBI) will pay the government ₹30,307 crore as dividend for the fiscal year ended March 31. down from the second highest payout ever of ₹99,122 crore paid in the

The board approved the transfer of ₹30,307 crore as surplus to the central government for the accounting year 2021-22 while deciding to maintain the Contingency Risk Buffer at 5.50 per cent, RBI said in a statement.

The decision on the dividend payment was taken in the 596th meeting of the Central Board of Directors of RBI, headed by Governor Shaktikanta Das, held

Earlier, RBI used to follow July-June period earlier as against government's April-March financial year.

For the current fiscal, the government had estimated a receipt of ₹73,948 crore as dividend revenue from the central bank and public sector financial institutions. This is 27 per cent lower than the ₹1.01 lakh crore received in FY22.

RBI's latest dividend is down compared to last year as it may have taken a hit on the income side, with the central bank likely receiving lower interest income from its liquidity management operations.

In 2018-19, RBI paid a total of

The S&P 500 and the Nasdaq are set for their seventh straight week of losses, their longest losing streak since the end of the dotcom bubble in 2001. The Dow is on track for its eighth consecutive weekly decline, its longest since 1932 during the Great Depression

Washington, May 20: The benchmark S&P 500 index is trading down 20% from its January 3 record close in volatile trading Friday, as investors fretted over the impact of rising inflation on earnings and the fallout of interest rate hikes on economic growth. A close of 20% or more below that

level will confirm the S&P 500 is in a bear market for the first time since the 2020 Wall Street plunge brought on by the coronavirus pandemic.

The tech-heavy Nasdaq is already in a bear market, down 30.7% from its record close in November



2021. Ten of the 11 major S&P sectors declined, with consumer discretionary and industrials down 3.5% and 2.2%, respectively. Apple Inc, Google-owner

Alphabet Inc, Nvidia Corp and Tesla slid between 2.5% and 9.9%, weighing the most on the S&P 500 and the Nasdaq. Both the indexes had climbed above 1% in morning trading.

Shares of Deere & Co tumbled 12.1% and were the biggest drag on the industrial sector after the heavy equipment maker posted downbeat quarterly revenue.

"In this process of a bear market, it is very common to have these intraday swings and counter cyclical rallies in it," said Will Nasgovitz, chief executive officer at Heartland Advisors. "We are going to probably see a bear market (in S&P 500). The market is reflecting that the economy is not standing extremely tall, there are some cracks in the foundation.'

Spinners Kuldeep Yadav (20 wickets, 8.45), Axar Patel (6 wickets, 7.37) and Lalit Yadav (4 wickets, 8.33) have also done a decent job with the ball in a number

of games.

However there are two areas where Capitals have floundered this season. One has been the pace department which has blown hot 'n' cold throughout, save Khaleel

Ahmed (16 wickets at 8.08). Shardul Thakur despite his 13 wickets has conceded runs at more than nine runs per over.

And second and more importantly is skipper Pant's (301 runs) inability to convert some of his good starts into big scores. What has worked for DC towards the business end is Marsh's batting form and his two half-centuries which has gone a long way in keeping them alive.

Mustafizur Rahaman (8 wickets at 7.62) was fantastic in the games that he played but the combination requirement has prevented Ricky Ponting from playing him in more games.

However what will ease a bit of pressure off Ponting ahead of a high-stakes game is Sarfaraz Khan's form as an opener. After Prithvi Shaw was indisposed due to a bout of typhoid (he is still recuperating), Ponting used Kona Bharat and it didn't work out well for the team.

As far as MI is concerned, the less they said about this season, better it is for them. Save NT Tilak Varma's emergence as a stylish batter, who could be the next MI legend alongside Tim David, who has taken over the mantle from Kieron Pollard, there is not much to write home about.

and was bowled by Moeen (1/21) to leave RR at 76/3 in the 12th over; and with some work left to do.

The well-set Jaiswal got out to Prashant Solanki (2/20) while trying to clear the fence. "We as cricketers have to remain on our toes and fit to be relevant in the race to represent India. I am playing for the next three years at least. I have been batting quite well for the past few years, I am hopeful and positive that the way I am performing, there are many milestones to achieve."

A journey from sprinter to boxing World Champion

New Delhi, May 20: "Why are there no girls playing, is boxing only a men's sport?" A young and innocent Nikhat Zareen, who was training to be a sprint runner, had once questioned her father.

It was, perhaps, just a mere coincidence or destiny, but that moment would turn out to be lifedefining for the newly-crowned flyweight World Champion.

It all started when Mohammad Jameel, a former footballer and cricketer, decided to take his daughters out to play one summer evening.

"I told them we'll go and play in the ground so that they learn something. Someone went to play basketball, one played handball etc.," he told this agency. "After observing for a couple of days I saw Nikhat's body language and I knew she'd be a sport person. So, I bought a tracksuit and told her we'll go train tomorrow."

Jameel trained Nikhat for 100m and 200m and she had inherited

her father's sporting genes. She was a natural and soon she was the district champion. Then one day boxing caught her fancy.

"Where I used to go to train with my father some Urban Games where going on. And I saw that all sports had girls except for boxing," Nikhat recalled hours after her gold medal winning feat. "I asked him why are there no girls playing, is boxing only a men's sport?"

Jameel was taken aback, but he explained to Nikhat that boxing was the sport of the courageous, irrespective of gender. "I told her you need to be mentally strong, have power and speed for boxing.

You need to have the courage and strength to hit the person in front of you," he said.

Nikhat's reply was simple but filled with conviction: "Main khelungi (I will play)". Soon after, she was training with boys as girls didn't take up boxing in Nizamabad.

"She had to train with boys, run with them. Initially, she got hurt a little bit while sparring in the beginning. But she started gaining confidence and started punching the same children who had hit her earlier," Jameel said.

"We knew she would do well among the girls because of the speed and strength she had developed playing with boys. Girls couldn't even touch her at the nationals," he said with pride.

With boxing came vests and training shorts and coming from a Muslim household, Nikhat and her parents were subjected to several taunts and comments. "This district is a rural one. No one has that much knowledge of sports here. A girl especially form a Muslim community is coming to

play people didn't know about it.

"It was when she won a medal at nationals then people got to know more. Many would say kya hai?, kaise kapde hain?, kya figure hai? maar lag jaega toh kaun shaadi karega?, life kharaab ho jaeagi. (What is this? What sort of figure she has? If she gets hurt, who will marry her? Her life will be ruined). I used to just listen."

It didn't take long for Nikhat to stamp her authority as she won her first sub-junior national title followed by the junior World Championship a year later.

Today, she's only the fifth Indian boxer to have a world championship gold under her belt and only second, apart from MC Mary Kom, to achieve the feat outside India.

She rose the ranks in the senior level as well, winning an array of medals in international events, including two golds at the Strandja Memorial, a bronze in the 2019 Asian Championships, while also winning the nationals multiple
