#### Veteran Left leader Sivaji Patnaik passes away



Bhubaneswar: Veteran CPI-M leader and three-time MP Shivaji Patnaik died at a private hospital here Monday. He was 92. He is survived by his wife, three sons and a daughter. The Left party leader was admitted to the hospital Sunday after the potassium level in his blood dropped, CPI-M state secretary Ali Kishore Patnaik said. Shivaji Patnaik was elected to the Lok Sabha from Bhubaneswar in 1977, 1989 and 1991. Starting his

journey from AISF, he worked for the undivided Communist Party of India and later become instrumental in setting up CPI(M) in Odisha.

#### Russian gets life term in first war crimes trial



Kyiv: A Ukrainian court sentenced a 21-year-old Russian soldier to life in prison Monday for killing a Ukrainian civilian, sealing the first guilty conviction for war crimes since Moscow's invasion three months ago. Sqt Vadim Shishimarin pleaded guilty to shooting a Ukrainian civilian in the head in a village in the northeastern Sumy region in the early days of the war. He testified that he shot the man after being ordered to do so. He told the court that an officer

insisted that the Ukrainian man, who was speaking on his cellphone, could pinpoint their location to the Ukrainian forces.

## **Devotees to pull Lords'** chariots after 2 years

Puri, May 23: After a hiatus of two years due to the Covid-19 pandemic, devotees are set to pull the Trinity's chariots in this year's Rath Yatra here as the district administration has given a go ahead for congregation of devotees. Puri Collector Samarth Verma said.

The Collector informed this in the first coordination meeting held Monday. The Holy City is likely to witness the arrival of around 12 to 15 lakh devotees during the Rath Yatra, he added.

"The annual Rath Yatra will be celebrated with full fervour as lakhs of devotees will witness Lord Jagannath, Balabhadra and Goddess Subhadra on the chariots after two years," Verma added. A large footfall of devotees like during 2015 'Nabakalebara' is expected this year too, he further stated.

The meeting was also attended by RDC Suresh Chandra Dalai, Puri MLA Jayanta Kumar Sarangi, Central IG Narasingha Bhol, Puri SP Kanwar Vishal Singh, Director of Culture department Ranjan



Kumar Das, Director of Information and Public Relations department Indramani Tripathy, Endowment Commissioner Ajay Kumar Jena, ADM Pradip Kumar Sahoo and sub-Collector Bhabataran Sahu.

Notably, the world famous Rath Yatra of Lord Jagannath was conducted without devotees for two consecutive years due to the pandemic. To enhance the security infrastructure at the Srimandir and Bada Danda, as many as 236 additional CCTV cameras will be installed. Verma said that these

cameras will be installed at vantage points near the 12th century shrine and Gundicha Temple. Adequate police force will be deployed for smooth conduct of the Rath Yatra, he added

When the Covid-19 pandemic threw normal life out of gear in 2020, the state government had decided not to allow the festival fearing that it would further spread the disease. However, as per the Supreme Court's order, it was held without the participation of devotees.

### 3 arrested over NZP brawl

Bhubaneswar, May 23: The Commissionerate Police Monday arrested three persons for assaulting tourists inside the Nandankanan Zoological Park (NZP) on the outskirts of the city, Sunday. The accused were identified as Kahnu Mahapatra, Aman Pattshani and Santosh Kumar Sahoo of Dharuthenga village

Sources claimed that a group of 26 tourists hailing from Chhattisgarh reached the zoo Sunday. They bought tickets from the safari counter inside the zoo to visit all the safaris. However, they were not allotted a



bus to visit the safaris despite waiting for more than three hours in queue which irked the tourists. Later, the tourists questioned the staff at the counter about the mismanagement. Soon, the visitors engaged in verbal argument with the employees. The employees who got into a brawl with the tourists called the staff of

the private agency operating battery-run buses inside the zoo.


As many as 50 persons including the employees of the private agency and safari attacked the tourists with iron rods, bamboo sticks leaving five visitors injured seriously. The attackers did not even spare the women visitors who were seen running towards the main gate holding their children to escape the attack.





Bhubaneswar, May 23: The Odisha Human Rights Commission (OHRC) has directed the executive officer of Puri municipality to submit a report in connection with the death of a rickshaw puller after falling into an open drain at Market Square in the Holy City May 17.

While hearing a plea filed by advocate Prabir Kumar Das, the OHRC asked the executive officer of Puri

ity and the action taken in the matter be also submitted to this commission," ordered the OHRC. In his plea, Das has blamed the

civic body authorities for the death of Nidhi Bhoi, 41, a rickshaw puller of Biranarasinghpur Gohiri Sahi in Puri, after falling into a fourfoot-deep open drain in the Pilgrim City May 17 night.

Das has urged the OHRC to direct the officials to launch a probe into the mishap and take stringent action against those found guilty. He also urged the commission to direct the administration to pay Rs 10 lakh as compensation to the next of the kin of Bhoi.

Notably, the National Human Rights Commission has also sought action-taken reports (ATRs) in this regard from the District Collector and Superintendent of

#### EOW to quiz ponzi scam accused

Balasore, May 23: Economic Offences Wing (EOW) officials Monday produced in the court the head of ponzi firm Digital Revolution Technology Ltd, Prince Kumar, who has allegedly duped several gullible investors in the state.

Prince, a native of Muzaffarpur district in Bihar, is accused of defrauding over Rs 6 crore from the investors of the state of which over Rs 1.5 crore is from Balasore and Mayurbhanj districts.

He was produced in the court after his arrest at Vrindavan May 18. He was brought on transit remand and produced before the spe cial chit fund court.

The judge rejected his bail plea and remanded him to judicial custody. The EOW is likely to take him on remand for further interrogation. The matter came to the fore. after a defrauded depositor Prasant Kumar Mahalik filed a petition in Orissa High Court.

The HC handed over the case to EOW following which DSP Debendra Narayan Das conducted a probe and submitted a report. A case was registered in this con-

nection by the EOW. Notably, Prince lured people with the promise of Rs 2,600 as monthly return on their deposits for a period of two years. What the depositors have to do is to open an ID and invest Rs 15,000 by downloading an app on their cellphones, said Prince. Initially, he was returning money to some of the depositors but later he started dup-

### City AIIMS gets Medical Oncology day care, OPD

Bhubaneswar, May 23: In a boost to cancer care, the All India Institute of Medical Sciences (AIIMS), Bhubaneswar Monday launched dedicated out-patient department (OPD) and day care services of its Medical Oncology division.

Inaugurating the facilities at the G-Block of the premier healthcare institution's main building, AIIMS-Bhubaneswar Director Mukesh Tripathi said the newlylaunched services will go a long way helping cancer patients.

Earlier, the Medical Oncology and Haematology divisions were sharing the same OPD and day care facilities on the hospital premises.

"As both the divisions shared the same facilities, the premises witnessed a huge number of patients. Last month, there were 160 fresh OPD registrations and 446 OPD consultations for Medical Oncology. As many as 105 days chemotherapy was also undertaken during the period," said Sourav Mishra of\_ Medical Oncology.

Sources said the Medical Oncology division at AIIMS-Bhubaneswar is the first dedicated Medical Oncology unit in any government hospital in Odisha after the Acharya Harihar Post Graduate Institute of Cancer in Cuttack.

The unit caters to the chemotherapy needs of cancer patients not only form Odisha but also from nearby states.

The hospital plans to start the course of DM in Medical Oncology soon. While the new OPD will en tertain patients on Tuesdays and Thursdays, the day care service will be available for patients on all week days, it was learnt.

## India needs to regulate thriving cosmetic surgery clinics

ue to a sudden rise in demands for services like facelift, weight loss, hair transplantation, fat-loss therapy and other cosmetic services, the cosmetic clinics are mushrooming in the metro cities. With the change in the trend, not only females, even males are availing such treatments. Resultantly, such clinics are growing in the cities without any strict regulations and guidelines.

India was shocked to hear about the death of a young Kannada actress Chethna Raj while undergoing plastic surgery at a private clinic in Bengaluru last week. Her death at such a young age during the surgery has left behind many questions on the medical regulations and ethics.

"The Clinical Establishments (Registration and Regulation) Act, 2010 has been enacted by the Central Government to provide for registration and regulation of all clini-

cal establishments in the country with a view to prescribe the minimum standards of facilities and services provided by them," said Manoj Jha, Head of Department, Plastic Surgery, Ram Manohar Lohia Hospital.

This act requires all clinical es-

tablishments to register themselves

and provides a set of standard treatment guidelines for common diseases and conditions. "Despite this Central act, not all states of India have made any clear provisions to implement this act

which is the reason for mush-

rooming of such types of clinics everywhere," said Jha. He said that according to the act, the state governments must adopt the law by passing a resolution in the legislative assemblies. But it has not been implemented in all

states yet, he added. Talking about the guidelines, Jha said that the National Medical



Councils can take action only against those who are registered with the Council but in absence of strict implementation of that act, many clinics are running without any licenses.

He said that if such procedures are not being undertaken by the qualified surgeon, there may always be chance for mishaps. Such procedures shouldn't be undertaken by general surgeon ever.

"Liposuction is a safe procedure. In the last 900 consecutive procedures done at RML hospital, no serious complications have been ob-

served," he said. The absence of strict regulation is a driving factor behind the growing number of cosmetic clinics.

'The Ministry of Health in consultation with National Medical Council should come up guidelines to stop this illegal practice of cos-

Nabarangpur, May 23: Acting on a complaint by a BJP leader, Nabarangpur police has registered a case against BJD's organisational secretary Pranab Prakash Das and State Planning Board deputy chairperson Sanjay Das Burma for allegedly misbehaving with a few SC/ST people during the inauguration of a Krushak Soochana Kendra (farmers' information kiosk).

While the incident occurred in February 2021, the case was registered Monday after the complainant and BJP leader Gauri Shankar Majhi had moved the court alleging humiliation by the two senior BJD leaders and non-regis-

tration of an FIR despite seeking intervention of Nabarangpur superintendent of police (SP).

Following orders from Nabarangpur Sessions Judge. Nabarangpur police registered the case under Indian Penal Code (IPC) Sections 143, 323, 354, 149 and Section 3(1) (R) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act.

As per the allegation, several farmers along with BJP and Congress activists were staging a demonstration in February 2021 over several issues when Das Burma and Das had visited Nabarangpur for inaugurating the kiosk. Infuriated over the demon-

stration the two senior B.ID leaders allegedly misbehaved and manhandled the activists including Majhi.

"We along with several farmers had gone to meet Das Burma seeking an answer over non-lifting of 90,000 quintals of paddy. Instead of hearing our grievances, he along with Pranab Prakash Das misbehaved with us. Though we had lodged a complaint, no FIR was registered," said

Majhi further said that no action was taken despite approaching the SP. "The FIR was registered against the two leaders only after the court's intervention. We hope that justice will be delivered,'

The BJD is, however, yet to issue any statement regarding the issue.

#### Man stabbed to death over cigarette

ANGUL: A 27-year-old businessman was stabbed to death following an argument over a cigarette at Nuasahi village under Sadar police limits in Angul district Monday. The deceased was identified as Lalit Sahu. Lalit had gone to smoke a cigarette at the accused Dusmant Sahu's shop in the same village. A spat ensued between the two over pending due. Things took an ugly turn after Dushmant along with his brother and father stabbed Lalit with a knife before fleeing the village. Family members rescued him from a pool of blood and rushed him to the district headquarters hospital (DHH) but doctors declared him brought dead. A case has been registered in this connection and police have detained the two brothers and their father. The heinous murder over a petty issue has spread shockwaves in the area.

#### 5 cars set ablaze

Paralakhemundi: Unidentified miscreants

set afire at least five cars parked near Town Hall here in Gajapati district late Sunday night. Locals suspect it to be fallout of political rivalry of previous enmity. Though the exact reason behind the fire is yet to be ascertained, it has been suspected that some unidentified miscreants might have intentionally torched the vehicles. On being informed, fire personnel reached the spot and doused the flames. A case has been registered in this connection and police investigation. Angry vehicle owners demanded arrest of the miscreants and compensation for the

damage to their vehicles.

### Nandan Kanan: Sec 307

The brutal attack on some visitors at Nandan Kanan zoo of Bhubaneswar 22 May 2022 is a wake-up call for the State Government that has been trying to build Orissa as a destination of great value. Much effort and money has gone in to build the 'Best Kept Secret' brand at the national level. A traveler from Orissa reaching Delhi's IGI airport would feel happy to see the slogan of our state flashing on multiple digital screens. The advertisement blitz has been proven to be a success as footfalls have increased. Yet, tourism is not limited merely to advertising destinations, adding hotel rooms, offering air-conditioned bus rides or creating niche tent accommodations on beaches. While all this may be considered integral parts of the tourism industry, the most important ingredient is a tourist's interface with the local people. Without hospitable and welcoming locals no tourist destination can thrive for long. Creating temporary eco-rooms for tourists who will be secluded during their whole stay can never be a sustainable method. From Goa to Indonesia and onwards to many Pacific islands, tourism thrives because of friendly locals and a sense of security.

The incident at Nandan Kanan is deplorable to say the least. According to reports, a group of tourists from Chhattisgarh who had booked tickets for safari rides at the zoo were brutally attacked when they protested against

the inordinate delay in permitting them to board the safari bus. Reportedly, the group was made to wait for long hours in the heat which led to an altercation with the officials at the ticket counter. Instead of tactfully handling the situation, the zoo officials called in about 50 locals who brutally assaulted and beat up the tourists. This speaks volumes about the average Oriya character. It seems, as if, Oriyas as a race cannot handle a situation as individuals and always need



mob backup. This may be the reason why Oriyas outside the state seem insecure and avoid trying to identify as Oriyas except in groups.

The Nandan Kanan incident should be treated with extreme seriousness by the state police. The forest department should first investigate why tourists were not taken in the safari bus in sequential order. Second, the police must investigate and locate every single attacker and hold an identification parade immediately. The hapless tourists should be moved to a safe accommodation and given police protection to identify the criminals and give testimonies in a magistrate's court so that they are not compelled to keep coming back to Bhubaneswar to avoid threats and coercion. Third, all those located and identified should be prosecuted under non-bailable assault sections including Section 307 (Attempt to Murder). Government should ensure strict follow up in court so that the accused are duly punished. Enough evidence exists on social media as well as CCTV cameras of Nandan Kanan. Inaction or delay in action will encourage this kind of mob creation and unruly behavior and gravely damage the reputation of the state. Strong action will be a deterrent for future recurrences. Otherwise, Orissa might, once again, slip back into the shadows of being the 'Best Kept Secret'.

### Oz Change of Guard

The swearing in of Australia's new Prime Minister Anthony Albanese 23 May represents a watershed moment in Australian politics. He not only becomes the first Labor PM in the past decade, but the election outcome this time around has shown how climate change and its disastrous impact on the planet in general and Australia in particular has played a crucial role in deciding the fortunes of political parties and climate activists in the country. It is a significant coincidence that the new PM had to dash off to Tokyo moments after the swearing-in ceremony to participate in a summit meeting of the Quad group comprising Australia, the US, Japan and India. The four-nation grouping has been formed to act as a counterbalance against China's growing influence in the Indo-Pacific region. Albanese has been accused by his opponent and immediate predecessor Scott Morrison with being soft on China. He has, however, refuted the accusation and blamed "wrong handling" of the situation by the Morrison government for the strained relationship between Australia and China.

Albanese's emergence as the new Australian PM has come as music to French ears. This is because France was left high and dry by the Morrison government which abandoned a submarine deal between the two countries in favour of a security pact known as the AUKUS formed by Australia, the US and the UK. The arrangement offers a great challenge to China's might. In fact, the outgoing French foreign affairs minister, Jean-Yves Le Drian, did not conceal his glee when he said the "defeat of Morrison suits me very well." Morrison's handling of the deal, according to him, showed "brutality and cynicism, and I would even be tempted to say unequivocal incompetence." In fact, Albanese himself had accused Morrison of leaking to the media personal text messages from Emmanuel Macron to discredit the French President's complaint that Australia had given no warning that a French submarine contract would be cancelled. In November last year, French Ambassador to Australia Jean-Pierre Thebault described the leak as a "new low" and a warning to other world leaders that their private communications with the Australian government could be weaponised and used against them


Even though Albanese has made it clear that the country's foreign policy of his Labor government would continue as that of the previous government, he has all the same expressed his misgivings about Morrison's China policy. He has described a new security pact between China and the Solomon Islands as Australia's worst foreign policy failure in the Pacific since World War II. Significantly, the Prime Minister of Solomon Islands, Manasseh Sogavare, wrote a letter to Albanese offering his "sincere congratulations" on his victory. His prompt response shows he wants to mend his country's relations with Australia especially because the security deal with China was a major election issue. Sogavare assured Albanese "that Solomon Islands remains Australia's steadfast friend and development partner of choice." In a statement, Sogavare expressed hope for "taking Solomon Islands' relationship with Australia to another level under Albanese's tenure as the prime min-

The most dramatic turn in this election is the Australian voters' overwhelming support for immediate action on climate change and strong disapproval of the previous government's half-hearted action in this regard. Australians are among the people in the world reeling most under the impact of climate change. In the past three years, record-breaking bushfires and flood events have killed more than 500 people and billions of animals. Droughts, cyclones and freak tides have devastated communities. The twin issues of climate change and the cost of living have converged in this election like never before. Australia is facing an "insurability crisis" with one in 25 homes on track to be effectively uninsurable by 2030, according to a Climate Council report. This means that the insurance for the highest-risk homes will be so prohibitively expensive that the insurance companies will refuse to accept any policy. Climate change is playing out in real time and many Australians now find it impossible to insure their homes and businesses. Nowhere is this a bigger issue than in Queensland. It is home to almost 40 per cent of the 500,000 homes projected to be effectively uninsurable. Queensland has been ravaged by floods in recent months. In February, the state capital Brisbane had more than 70 per cent of its average yearly rainfall in just three days. Insurers say the floods will become Australia's most expensive natural

No wonder Australian voters decided to cast their votes in favour of climate activists contesting in the election and the Green Party. They have voted against ruling coalition candidates and decided to give a chance to the Labor party to effectively control climate change with their target to limit carbon emission by 43 per cent by 2030 against the ruling coalition's promise of 26 per cent. Australia may provide a lesson to the rest of the world in the fight against climate change, if the new government can live up to its promise.


#### FOCUS POLICE ENCOUNTERS

## **MUD IN OUR EYES**

THE SUPREME **COURT HAS DONE YEOMAN SERVICE BY SETTING UP THE PANEL, WHICH HAS SERVED** THE NATION BY **ITS DETAILED FINDINGS** 



Their 387-page report is so thorough, meticulous and in graphic detail that it amounts to a conviction of the police and the State machinery for what clearly and beyond any shadow of doubt was a staged encounter in which four accused, three of them juveniles, were killed. Accused Jollu Shiva, Jollu Naveen and Chintakunta Chennakeshavulu were aged 17, 15 and 15 respectively, their ages conclusively proved as recorded in school registers. The fact that at least two of these three were juveniles was clearly known to the police. The fourth accused killed in the "encounter", Mohammed Arif, was 26.

Punishment for crime has to be

only by the procedure established

All the four were from poor families - truck drivers and cleaners who were picked up, it appears, not by police but by the owner of the truck that was seen in video footage as the investigation commenced. The report should also be shocking to all of India because it gives a graphic account of how the police functions, almost like rookies who have no clue about anything remotely linked to any formal investigation, let alone investigating a shocking case that led to a nationwide public outcry.

in some of the most important cases, then questions need to be asked on the state of the nation itself. Further, the case comes not from what was once the backyards of Bhagalpur but in a thriving state capital that wants to become the techno-cyber capital of the nation and attracts investments like Amazon's largest campus anywhere in the world. These mod ernistic investments and infrastructure sit ill at ease with governance structures that live on from pre-historic times. They mock the state, they bring ridicule to its elaborate and carefully constructed norms of due process, and they lower the standing of a nation that seeks to be a global power.

The report should further shock the entire cadre of the Indian Police Service officers, who are considered the top echelons of the police bureaucracy but have rarely if ever spoken about the growing menace of staged encounters, the shoddiness of investigations and the lack of anything remotely professional in the functioning of the Indian police. Each and every IPS officer in the nation would hang his or her head in shame on reading this report.

Now in the dock and almost impossible to escape are the local police and the State machinery that not only allowed and probably sanctioned at the highest level such a crime but also did not complete a full and proper investigation of a case that had shocked Telangana and the nation. In that sense, the so-called encounter quietened public anger but it did not do justice to anyone, not even the victim, because the case was not investigated fully and the real culprits probably were never at risk of being caught. The encounter that killed four accused also killed all leads: it killed investigation and it murdered the process by which justice is delivered.

The report by the eminent panel records some of the most ludicrous claims put up by the police - that when taken to the spot for recovery of material evidence, the accused threw mud into the eyes of the police escorts, that they snatched a revolver and fired at the police. One para from the long report illustrates the bankruptcy of the official narrative: "On account of the fact that the allegation of throwing of dust and earth is introduced belatedly and considering the improbabilities in the version, it is to be held that this allegation is an embellishment and introduced only to give a plausible explanation that the accused

could escape from the custody of such a large contingent of armed police party. When any such mischievous attempt is initiated by one of the accused, the entire police party would get alerted and would thwart all such attempts. Such helplessness could not have been expected even from a layman...

The report illustrates how State sanctioned killings and the subsequent cover-ups are done - at one level ham-handed but also unfettered by any fear of a followup. The teams put to this task are so brutalised and confident that there will be no accountability that they care not about a cover for their killings. Linked to this of course is the political class – all parties at all levels – that want quick fixes for potential political trouble on law & order issues and to keep the economy ticking. The nexus of the political-business class stands out clearly, standing as a force called progress and prosperity against the weak and the downtrodden who have little hope of justice from such a system. This is an India-wide divide and it makes the nation weaker even though the numbers on the economic dashboard may look stronger.

The Supreme Court has done yeoman service by setting up the panel, which has served the nation by its detailed findings. The report should lead to immediate local area arrests of the guilty policemen but it must also trigger a rethink on the problem of police encounters. All political parties must recognise this as a danger ous decline in standards. IPS officers must speak up. We also need new administrative protocols sending on compulsory leave top officers in the immediate chain, leading to the IPS officer in charge, as the case is investigated by a judicial panel, will end the sorry case of police encounters right away. Until then, silly stories like the accused threw mud in the eyes of the police will continue to throw mud in the eyes of the nation.

### Climate consensus amid conflict

**IN A CONTEXT OF CONFLICT, WHERE MOST POLICIES ARE VIEWED AS ZERO-SUM, CLIMATE PROJECTS ARE AN EXCEPTION** 

Ramallah named Miriam. who shared how much she has benefited from one of the 450 solar-powered schools that the European Investment Bank has financed in the West Bank. Speaking in perfect English, Miriam was fully aware of the challenges her region faces because of climate change. But she was also full of optimism and extraordinarily articulate in explaining why the Middle East needs to do more to harvest sunshine, one of the few cleanenergy resources that it enjoys in abundance.

The following day, Israeli Prime Minister Naftali Bennett reminded me that the EIB helped finance four of Israel's six desalination plants, including one that will be the world's largest when it becomes operational in 2023. He joked that almost two-thirds of the water in our glasses came from those EIBbacked projects. In a region with a growing population, Israelis know that water scarcity can easily lead to new conflicts. They want to develop greater desalination capacity so that they can potentially

trade water for clean energy. Changing rainfall patterns, water scarcity, and increasingly frequent and intense extreme weather events fires – affect Israelis and Palestinians equally, and the need to address the problem appears to be one of the few issues on which both parties agree. This was confirmed to me in talks with Palestinian Prime Minister Mohammad Shtayyeh. In a context of conflict, where most policies are viewed as zero-sum, climate projects are an exception.

In a speech this past February, Israeli President Isaac Herzog pointed to the intensification of extreme weather events as a wake-up call for the region, "For anyone who does not understand what this means, let me explain: this spells a genuine catastrophe," he warned. The climate crisis is a crisis for the whole world, and we in the Middle East must understand it chiefly at the regional level, because its implications will be dramatic.'

Herzog then called for a regional partnership to create a "renewable Middle East." His vision would include the United Arab Emirates. Egypt, Jordan, Bahrain, Morocco, Saudi Arabia, and Israel's "Palestinian neighbours." Yet while the Palestinian Authority has advanced some climate policies, it will take massive investment for these ideas to translate into largescale yields of clean water from

> adaptation projects will be needed to manage the humanitarian, environmental, and economic issues caused by climate change. Having returned to Luxembourg from my visit to the region, it is clearer to me than ever that we need to bank on the current "climate consensus" to build momentum behind the kind of transformational climate projects envisaged in the European Green Deal. While making Europe carbon neutral by 2050, such investments can also help to foster stability and improve economic conditions in the Middle East.

> My belief in the transformational power of smart climate investments has grown only stronger with time. Over the past few years, the EIB has become the world's largest multilateral financier of climate projects, with commitments to support at least €1 trillion (\$1.05 trillion) of investment this decade. However, in a region as complex as the Middle East, it will take more than just finance to make many of these projects happen. We will need much more cooperation among countries and key external stakeholders such as the US and the EU.

and Gaza, which opened this month, can help foster such cooperation. It will develop partnerships and stronger cooperation in the West Bank and Gaza while also supporting transformational crossborder climate projects across the region. As such, it will be instrumental for the EU's climate diplomacy in the Middle East.

We aim to complement and scale up, from a European perspective, what US Special Presidential Envoy for Climate John Kerry has started with his diplomatic push for Middle Eastern countries to phase in renewable energy. That means financing the development of largescale renewable energy and water cooperation in the region and building an even stronger climate

consensus. I am convinced that if climate diplomacy is backed by high-quality, innovative projects of regional significance, it can open up promising new avenues to pursue stability, growth, and peace in the Middle East. It's time to give climate finance a chance.

Sir, The Supreme Court's recent vacation of the stay on a Delhi High Court order from last year that said that stray dogs have a right to food and water, and citizens have the right to feed them is really welcoming. The feeding and caring for stray dogs is a hugely divisive issue in urban neighbourhoods across India, with arguments and disputes breaking out frequently between dog lovers and those who feel scared or intimidated by the animals. Stray dogs have the right to food and citizens have the right to feed community canines, earlier the Delhi High Court had said while observing that in exercising this right, care and caution should be taken to ensure that it does not impinge upon others and causes no harassment or nuisance. The high court, while laying down guidelines regarding the feeding of stray dogs, had said every dog is a territorial being and it has to be fed and tended to at places within its territory that are not frequented by the general public. Any person having compassion for stray dogs can feed them at their private entrance or driveway of their house or any other place not shared with other residents, but no one can restrict the other from feeding dogs, until and unless it is causing harm or harassment to them, it had said. 

### Whose petition first, court to decide today

Varanasi, May 23: A district court here reserved its order for Tuesday on which petition is to be heard first in the Gyanvapi-Shringar Gauri complex case transferred to it by the Supreme Court

The court of District Judge A K Vishvesh heard arguments from both the Hindu and Muslim sides. A fresh plea seeking permission to worship the "Shivling" claimed to have been found on the Gyanvapi mosque premises during a videography survey ordered by a lower court was also filed.

The apex court had Friday transferred the Gvanvapi-Shringar Gauri complex case from a civil judge (senior division) to a district judge, saying looking at the "complexities" and "sensitivity" of the issue, it is better if a senior judicial officer having an experience of over 25-30 years handles this case "After hearing arguments of

both sides, the court will on Tuesday give its verdict on which petition is to be heard first," said Madan Mohan Yadav, a lawyer for the Hindu side. The Hindu side argued that since

a court-appointed commission has completed its work, the opponents should present their objections to

it. Yaday said they pleaded to make available the commission's report and videography done by it to present its side on it.

Anjuman Intezamia Masjid Committee's lawyer Mohammad Tauhid Khan argued that the writ is not sustainable, hence, it should be dismissed. A fresh petition was also moved on Monday by Dr Kulpati Tiwari, Mahant of Kashi Vishwanath temple, for regular "pujan" (worship) of the Shivling which he said was found in the Gyanvapi mosque complex.

May 16, the lower court had directed the district administration to seal a spot in the Gyanvapi Masjid complex after counsels representing the Hindu petitioners said a Shivling was found Monday during a court-mandated videography survey.

A mosque management committee spokesperson disputed the claim, telling a television channel that the object was part of a "fountain". He said lawyers representing the mosque committee were not fully heard before the sealing order was announced. The Hindu side claimed that the Shivling was found close to the "wazookhana" -- a small reservoir used by Muslim devotees to perform ritual ablutions before offering the namaz.

#### SIDHU SEEKS **SPECIAL DIET**

Chandigarh, May 23: Congress leader Navjot Singh Sidhu, lodged in Patiala central prison to serve a one-year jail term in a 1988 road rage death case, was taken to Rajindra Hospital in Patiala under heavy security on Monday morning for medical examination, official sources said.

The cricketer-turned-politician's counsel HPS Verma said Sidhu has sought a special diet in jail. He said a board of doctors will carry out a detailed medical examination of Sidhu at the hospital. "The board of doctors will see what special diet is required and then it will submit its report in a local court (in Patiala)," Verma said over

According to the counsel, Sidhu cannot consume wheat, sugar, 'maida' and some other food items. "He can have berries, papaya, guava, double-toned milk and food items which do not have fibre and carbohydrates," Verma said. After the board of doctors carry out a medical examination, a report will be submitted in the court of chief judicial magistrate, he said.

The 58-year-old Congress leader suffers from medical conditions like embolism and has a liver ailment. In 2015, Sidhu also underwent treatment for acute deep vein thrombosis (DVT) at a hospital in Delhi. DVT is caused by a blood clot in a deep vein which hinders the normal blood flow.

Several Congress supporters reached Rajindra Hospital after Sidhu was brought there. The former Punjab Congress chief on May 20 was sent to Patiala central jail after he surrendered before a local court. He has been sentenced to one-year rigorous imprisonment by the Supreme Court in a 1988 road rage death case.

## Stronger the judge, greater the allegations: SC

New Delhi, May 23: The Supreme Court Monday said that making allegations against judges is "unfortunately" becoming a new fashion now and the stronger the judge, the greater the allegations against him. The apex court, while hearing an

appeal filed by an advocate who was found guilty of contempt by the Madras High Court and was sentenced to undergo two weeks of simple imprisonment, observed that making allegations against judges is rampant in Uttar Pradesh and now it is happening in Bombay and Madras also.

The top court said the conduct of the appellant was "thoroughly contemptuous" and besides levelling wanton allegations against the single judge of the high court who had issued a non-bailable warrant (NBW) against him, the recusal of one of the judges hearing the proceedings thereafter was sought on thoroughly improper grounds.

"Now, this is becoming unfortunately a new fashion of making allegations against judges. The stronger the judge, the greater the allegations against the judge. This is happening now in Bombay. Of course, it is rampant in Uttar Pradesh, now Madras," a vacation bench of Justices DY Chandrachud and Bela M Trivedi said

"Let a strong message go," said the bench, adding that judges are assaulted across the country and in the district judiciary, sometimes not even a 'lathi' (stick) wielding policeman is there for their protection.

While refusing to interfere with the high court's March order this year, which had also directed that the advocate shall not practice before it for a period of one year, the apex court observed that one can annoy the court but cannot level wanton allegation like this when the process of the court is sought to be served.

The bench said after the single judge had issued an NBW against the advocate and the police went to serve him when he was there at a tea shop near the high court, hun-

dreds of lawyers lay upon the police and prevent the NBW from being served.

It said CCTV footage of the incident was also there and to compound it further when the matter was heard by the court, the advocate had made allegations against the single judge who had issued

NBW against him. The counsel appearing for the ap-

pellant said the advocate has tendered an unconditional apology. The bench observed that the appellant belongs to a class of lawyers who are "absolutely incorrigible" and there is a blot on the legal profession. It said this is the only way to deal with these kinds of people and a two-

week sentence is actually very lenient. The appellant's counsel said that in the appeal, they have not raised any ground but tendered unconditional apology and the conduct of the appellant may be monitored

by the high court.

There will be some remorse when he goes to jail for two weeks and when he is barred for a year from practicing," the bench said.

"Let him exercise some remorse.

The appellant's counsel urged the bench to give him one opportunity and he has tendered an apology also."The behaviour and conduct of the appellant was thoroughly contemptuous. There was a clear attempt to obstruct the process of justice when the NBW was sought to be served on him by the competent police officials,' the bench said.

"That apart, wanton allegations have been levelled against the single judge of the Madras High Court who issued the NBW and a recusal was sought even of one of the judges hearing the proceedings thereafter on thoroughly improper grounds," it said, adding the finding on contempt as well as the sentence, cannot be regarded as disproportionate.

## Oppn decries bulldozer 'revenge' Damage to rail lines, assets

The ruling BJP defends administration's actions, blaming 'Iihadis' for the burning down of Batadrava police station

Guwahati, May 23: Opposition parties in Assam Monday decried both the bulldozing of houses of villagers allegedly involved in burning down a police station in an apparent revenge attack after custodial death of a person in Nagoan district as well as the assault on the force's

The ruling BJP, however, defended the administration's actions, blaming 'Jihadis' for the burning down of Batadrava Police

The police station was set on fire Saturday by a mob, following the custodial death of a local person, Safikul Islam, who was picked

up the night earlier. The district administration had carried out an eviction drive in

day and bulldozed houses of the deceased and several of his relatives, alleging that they were 'encroachers' and staying there with "forged land documents.'

The state Congress has deputed a seven-member committee, led by its working president Rana Goswami, to visit Batadrava and take stock of the situation there. The panel, which includes Batadrava MLA Sibamoni Bora, will interact with local people to find out the root causes of the incidents and submit its report within two days.

'It is shocking to know that many houses of local people are demolished by bulldozers," the party said in a statement.

Taking to Twitter, Congress MP Abdul Khaleque said his party never supports any attack on a police station but bulldozing houses custodial death as 'anarchism', Assam Jatiya Parishad chief Lurinjyoti Gogoi said, "These cannot be accepted. When the respect for law diminishes, such things happen. When the chief minister openly supports encounters, these are bound to follow."

On the subsequent eviction drive, he claimed that it reflected the 'vindictive nature of the govern-

"Whenever this government doesn't like someone or something, they get the police to take action against them...it (eviction) was a step of vengeance," he said.

Terming the attack on the police station as "an organised terrorist act," the ruling BJP claimed that 'trained jehadis' were involved in the arson. The saffron camp also welcomed the eviction drive

BJP's senior spokespersons Ranjiv Kumar Sarma and Subhas Dutta have claimed that "Bangladesh-based Muslim miscreants received training in PFI camps to carry out an organised attack on the Batadrava police station.

They urged the police to "construe the attackers as perpetrators of crime against the nation" and resort to stringent action against them. The ruling party welcomed the decision of carrying out the eviction exercise against illegal encroachers following the incident.

Guwahati, May 23: Specialists from North Eastern Space Applications Centre (NESAC), a subsidiary of the Indian Space Research Organisation (ISRO), are using drones and satellite data for conducting rapid damage assessment of railway tracks, stations, and other assets of the Northeast Frontier Railway (NFR) in Assam's Dima Hasao mountainous district, officials said Monday.

Due to unprecedented landslides triggered by heavy rain since May 13, massive damage has been caused to stations and railway tracks at over 58 locations in NFR's Lumding-Badarpur single line railway route via Dima Hasao. This railway line connects Tripura, Mizoram, Manipur and the southern parts of Assam with the rest of the country.



Agra, May 23: Though Taj Mahal is in the news for several reasons, what needs our immediate attention is the air and water pollution that is hurting the world heritage monument that is India's pride and a star tourist attraction.

Despite thousands of crores spent on fighting pollution following the Supreme Court's intervention in the 1990s, neither the air pollution level has come down nor has water of the river Yamuna

Even three decades after the Supreme Court intervention and the continued war against environmental pollution, to secure precious world heritage monuments in the Taj Trapezium Zone, (TTZ) conditions have not significantly improved. Rather, the accelerated urbanisation process has further compounded the crisis.

In fact with the green cover continuously decreasing and water bodies either dry or heavily polluted, the overall scenario is depressing, pointing to the utter failure of the government bodies to handle the alarming ecological crisis building up.

The apex court ordered in 1993 a slew of measures while considering the high powered experts committee, headed by senior scientist Dr S Varadrajan's report in the MC Mehta PIL on pollution threats to the Taj Mahal. Over the years thousands of crores of rupees have been spent without discernible changes to the overall environmental scenario in the 10,400 sq km eco-sensitive Taj Trapezium Zone.

## **TAJ CITY CRISIS**

Agra fares poorly in the air quality index. The ambient air quality has gone worse from being poor, as Agra continued to be among the top polluted cities in India

The dust level (SPM and RSPM) has gone up and the share of noxious gases in the ambient air has remained high posing a grave threat to humans and monuments

Although the city claims serious participation in the Smart city race, the results do not instill confidence or indicate any positive shift in the eco-equilibrium

All parameters suggest Agra is nowhere close to winning the pollution war, despite international concern and claimed governmental efforts to halt the increasing pollution level

Neither the pollution standards applicable in eco-sensitive zones have been achieved nor has the city made any progress in extending the green cover. The forest area has in fact come down to a meager six per cent or less, against the national target of 33 per cent. The suspended particulate matter (SPM) level remains over 350 micrograms per cubic metre, while going above 600 in summer, against the 100 microgram standard. This summer has been truly cruel to both nature and stones, says green activist Devashish Bhattacharya.

The level of noxious gases has continued to rise as a result of automobile explosion. "In the early 1980s when Firozabad was part of Agra district, the number of registered vehicles was only 40,000. But now the number has crossed a million in Agra district alone. Add Firozabad, Mathura and neighbouring Hathras districts, the scenario is frightening," Bhattacharya

He wondered why despite continuous monitoring by the apex court and the NGT, there has not been any significant change in the environmental scenario in the TTZ. One major source of dust and pol-

lution is the dry and polluted river Yamuna, "Yamuna is virtually dead in Agra. The dry river-bed and the highly polluted water that flows down the river pose serious threats to historical monuments along the banks. Decades of judicial activism, major policy pronouncements and projects worth millions of rupees, this Taj city remains pock-marked with mounds of garbage. Air and water pollution threaten the health of people and the world-famous monuments that are visited by millions of tourists every year," say members of the River Connect

The SPM rises as the river bed runs dry and the Rajasthan desert gradually expands into Uttar Pradesh. In recent years, there has also been large-scale illegal stone mining in the Aravali ranges, push-

## Assam's lone hill station strives to reclaim lost glory

Haflong (Assam), May 23: Landslides and flood have left a trail of destruction in Dima Hasao, a picturesque tourist hotspot in Assam, prompting a multi-agency effort to salvage the state's only hill station Haflong and its surrounding townships in the district,

officials said. Officials, however, are uncertain when Dima Hasao will regain its lost sheen, considering the enormity of the devastation.

While snapped road links are likely to be restored within the next few weeks, train movement connecting Dima Hasao, Barak Valley, Tripura, Mizoram and Manipur with the rest of the country is expected to resume from July, they said.

The road network to Dima Hasao was also cut off, as streets filled with mud, stones and slash became a common sight. Though some stretches have been partially reopened and tunnels cleaned up, a senior official of the Assam State



Disaster Management Authority (ASDMA) said complete restoration will take more than a week.

Chief Minister Himanta Biswa Sarma had Sunday met NHAI Chairperson Alka Upadhyaya and discussed the road condition in Dima Hasao.

Another big challenge is to reinstate mobile services in the affected areas, the restoration work of which is also underway, the officials said.

Dering Thaosen, Advisor of the Blue Hills Society, a local NGO, said that Dima Hasao, once infamous for dreaded insurgency, had just begun its journey of development, but the natural disaster has "now pushed the

"The new broad gauge connectivity and the highways, popularly called 'Mahasarak', had brought some hope for Dima Hasao in terms of tourism and revenue. Businesses had just started to gain momentum and many outsiders were interested to invest.

"But, the heavy rain and land-

## **Quad leaders to discuss ways** to solidify Indo-Pacific ties

New Delhi, May 23: Laying a long-term strategic groundwork to further solidify cooperation for a free, open and inclusive Indo-Pacific and delving into the implications of the Russian invasion of Ukraine are expected to be the central focus of the second in-person summit of the Quad leaders in Tokyo Tuesday.

The leaders of the Quad, comprising India, the United States, Australia and Japan, are set to demonstrate that the grouping is a "force for global good" and has a unifying commitment to a rulesbased international order amid China's increasingly intimidatory

The summit is taking place at a time, the relations between China and the Quad member countries have become tense over the last few years, with Beijing increasingly challenging democratic values and resorting to coercive trade

The rollout of the IPEF is expected to send across a signal that the US is focused on pushing forward a strong economic policy for the region to counter China's aggressive strategy on trade in the re-

Attending the event to launch the IPEF, Modi said that announcement of IPEF is a declaration of a collective desire to make the Indo-Pacific region an engine of global economic growth. The prime minister also called for finding common and creative solutions to tackle economic challenges of the Indo Pacific region.

US National Security Advisor Jake Sullivan on Sunday said the IPEF is designed to create "highstandard approaches" to the digital economy, to the clean energy transition, diverse and resilient supply chains and open and transparent economic governance.

Foreign Secretary Vinay Mohan Kwatra last week said continuing cooperation on COVID-19 response. post-pandemic management of the economy and health infrastructure is also important elements for the Quad summit.

"These include last-mile delivery, health security, genomic surveillance, clinical trials, and pandemic preparedness as their important elements," he said. Australia's newlyappointed Prime Minister Anthony Albanese will also participate in the summit and it will be interesting to know about his vision for the Indo-Pacific. The Quad leaders are also set to discuss the Russian military offensive in Ukraine and the humanitarian as well as security implications of the conflict.

### Battery defects caused EV fires, says DRDO

New Delhi, May 23: The Defence Research & Development Organisation (DRDO) that was tasked with investigating into EV fire incidents by the Union Road Transport and Highways Ministry, has found serious defects in the batteries, including designs of the battery packs and modules.

According to sources in the know of the matter, these defects occur because the electric two-wheeler manufacturers like Okinawa Autotech, Pure EV, Jitendra Electric Vehicles, Ola Electric and Boom Motors may have used "lower-grade materials to cut costs". The Centre for Fire, Explosive and Environment Safety (CFEES) at the DRDO has submitted its fact-finding report to the Ministry, as first reported by Business Standard.

According to the sources, the

ministry has now summoned representatives of these EV manufacturers, asking them to submit an explanation on the DRDO report findings. Earlier this month, the Central Consumer Protection Authority (CCPA), which comes under the Union Consumer Affairs Ministry, sent notices to Pure EV and Boom Motors after their escooters exploded in April. The consumer watchdog is also examining more cases of e-scooter fires

Pure EV and Boom Motors along with Ola Electric, Jitendra EV, and Okinawa Autotech, recalled faulty batches after the EV fire incidents were reported.

other EV makers too.

The preliminary findings from the government-constituted probe committee on EV fires have already identified issues with battery cells or design in nearly all of the electric two-wheeler fire incidents in the country. The committee was constituted in the wake of EV fires and battery blasts in escooters. The experts found defects in battery cells as well as battery design in nearly all EV fires.

The government is now working on new quality-centric guidelines for EVs that will be unveiled soon. At least 12 electric two-wheelers have exploded till now and several EV makers have recalled the faulty hatches amid the growing pressure from the government.

#### **8 LABOURERS KILLED IN BIHAR**

Patna, May 23: Eight labourers died and eight others were injured after a truck laden with pipes overturned in Bihar's Purnea district Monday morning.

The accident occurred at the Kali temple under the Jalalgarh police station on the Siliguri-Delhi four lane National Highway 57 at 3.30 a.m. Surendra Kumar Saroj, SDPO of Purnea (Sadar) told IANS that all the 16 victims are natives of Rajasthan and eight of them died on the spot.

"The goods truck laden with pipes was on the way from Silliguri to Jammu & Kashmir. The labourers were also boarded on the truck When they reached the Kali temple on four lanes, the truck overturned. The pipes fell on them. Eight of them died as they were trapped under the pipes," Saroj said.

"We have immediately initiated a rescue operation at the accident place and recovered the dead bodies. We have also rescued the injured persons and sent them to primary health centers. Their condition is stable now," Saroj said. "After the accident, the driver and helper managed to flee from the spot. Efforts are on to nab them," Saroj said.

#### More employees of J&K govt are on radar of security forces

New Delhi, May 23: More government employees are on the radar of the security agencies for terror links in Jammu and Kashmir and it is expected that the government will sack them soon, the sources in the security network Monday said.

The sources further said that the people who are on the radar of the agencies are teaching and nonteaching staff of the Kashmir University, while some of them are working in the J&K government.

The government has asked the intelligence agencies to prepare a list of those employees of university, school and government offices who are sympathizers of terror outfits or spreading the separatism among the students and the local people.

The intelligence agencies in J&K have prepared three categories of such government employees and teachers who are involved in spreading the ideology of the terror organisations. Among the University

teachers, it was learnt that 15 proof the security forces and three of them need immediate action while 15 are on the watch list, the sources

Those who are under the first category will be sacked immediately after a Committee's recommendation which has been constituted under Article 311(2)(C) of the Constitution while those kept under second category are on the watch of the security agencies and the third category, the misguided government employees will be taken for counselling to get them back in the mainstream, they added.

The officials in the security grid in J&K said that the majority of university teachers are against terrorism and have no anti-India sentiments. Recently, the J&K government had dismissed one professor Altaf Hussain Pandit of the Kashmir University and a school teacher Mohammad Maqbul Haiam for encouraging and involvement in anti-India activities.

## Hardik caught between a rock and a hard place

AHMEDABAD: In politics nothing happens by accident. If it happens, it was planned that way, or so goes a famous saving.

Attributed to Franklin Roosevelt, the longest serving President of the United States, almost 77 years later, it still rings true even for a rookie politician like Hardik Patel who resigned as working president of the Gujarat Congress last week.

His departure from the Congress was the worst kept secret in the state. For weeks he had been talking to his party through the media and the party top brass had been alerted to his opening lines of communication with the BJP leadership which led to his being cold shouldered during Rahul Gandhi's visit to the state. He himself boasted of being in touch with the 'top most' in the BJP who wield decisive say in Gujarat. That he should announce his resignation addressed to the Congress president through Twitter in three languages - Hindi, English and Gujarati and then attack the Congress and Rahul Gandhi personally, proved a dead give-away of the direction he was headed.

The Congress has been the obstacle delaying the resolution of key national issues like the Citizenship Amendment Act, the Ram temple construction at Ayodhya or the scrapping of Article 370 which provided special status to Jammu and Kashmir, his letter said.

Interestingly in March 2019 the day Hardik joined the Congress, he had quite the opposite to say. "In view of the Pulwama terror attack, the Congress had decided

to postpone its rally but Prime

Minister Narendra Modi continued addressing gatherings across the country." For Rahul Gandhi he said, "I chose him because he is honest and does not believe in working like a dictator." Now, however it is the chicken sandwiches that seemed to have taken precedence!

The fact was that Hardik was very keen to contest the 2019 Lok Sabha elections from Jamnagar. The damper to his aspirations came when just weeks ahead of

the 2019 polls, the Gujarat High Court rejected his plea seeking stay on the two years imprisonment awarded to him in 2018 for rioting and arson in Visnagar in 2015 during Patidar quota stir. This was because the BJP government played spoilsport. During the hearings, the Gujarat government had strongly opposed his plea saving that Hardik has criminal antecedents with 17 FIRs registered against him including two cases of sedition. The very government which had labelled him as one with 'criminal antecedents' approached the Ahmedabad metropolitan magistrate April 25 seeking to withdraw another case of rioting and trespass against him. The court, however, rejected the plea. The government then approached the sessions court which permitted

withdrawal of the case May 10. As things stand, Hardik hardly had any grouse against his own party leadership until the time the elections neared. In the last elections he had a say in 20 seats but in 15 of them the Congress

lost so no say this time. The fact is that he has been a pale shadow of the aggressive youth leader who headed the Patidar Anamat Andolan Samiti having lost steam. With reports of his heading towards the BJP making the rounds, he is being heavily trolled in the social media by the community as being responsible for the death of 14 Patidar youths who lost their lives during the agitation. This has forced him to beat a hasty retreat putting out a statement that he is yet to make up his mind on his next move.

Mumbai: The economic growth may have slowed to 3.5 per cent in fourth quarter of 2021-22 from 5.4 per cent in the previous three-month period due to the impact of higher commodity prices on margins, decline in wheat yields and on higher base, Icra Ratings said Monday. The agency said the hiccups in the recovery of the contact-intensive services attributable to the third wave of Covid-19 in the country may have also affected the economic growth in the quarter. Even the gross value added (GVA) at basic prices (at constant 2011-12 prices) in Q4 FY2022 seems to have eased to 2.7 per cent from 4.7 per cent in Q3 FY2022, it said. Icra's Chief Economist Aditi Nayar said Q4 was a challenging quarter, with the Omicronfuelled third wave of Covid-19 arresting the momentum in contact-intensive services, and a pervasive pressure on margins from higher commodity prices. Metal stocks took a knock after the government Saturday hiked the tax on export of iron ores and concentrates to 50 per cent, and imposed a duty of 45 per cent on iron pellets in a bid to increase their domestic availability and curb soaring steel prices.

Tata Steel was the biggest loser in the Sensex pack, plummeting 12.53 per cent, followed by UltraTech Cement, ITC, PowerGrid, HDFC, HDFC Bank, HCL Tech and

New Delhi, Mar 23: RBML - the joint venture of Reliance Industries Ltd (RIL) and BP Mobility Ltd has told the government that fuel retailing for the private sector in India has become unsustainable after market-controlling public sector firms frequently froze petrol and diesel prices at rates way below the cost, sources said.

"They have written to the petroleum ministry over the fuel pricing issue," a highly placed source in the government, who didn't want to be quoted, told reporters here. While RBML is scaling down its retail operations to cut some of the ₹700 crore loss it is incurring every month. Russia's Rosneft-backed Nayara Energy has raised prices of petrol and diesel by up to ₹3 a litre



over and above the PSU rates, to cover for some losses

The government over the weekend cut excise duty on petrol by ₹8 per litre and by ₹6 a litre on diesel. This reduction was passed on to the consumers and not adjusted against the under-recovery or losses oil firms make on selling petrol and diesel.

Two sources aware of the matter said RBML contends that PSU oil marketing companies control over 90 per cent of the market and are the price-setters, leaving no room for private fuel retailers in fixation of the retail selling price of petrol and diesel. PSUs have not increased fuel prices in line with escalating international crude prices eventually leading to huge underrecoveries (losses) for all fuel retailers since February 2022.

As of May 16, 2022, net under-recoveries in the industry were ₹13.08 per litre for petrol and ₹24.09 per litre for diesel. A top ministry official said petrol and diesel prices are decided by the PSU oil companies after considering not just the international oil prices but also gains from other businesses such as petrochemicals and oil refining.

"Reliance is exporting diesel to Europe and other countries at highly lucrative prices but rationing supplies for its petrol pumps," the official said.



## India draw with Pakistan Vastrakar spell lifts Supernovas

Jakarta, May 23: Defending champions India conceded a late goal to allow arch-rivals Pakistan walk away with a 1-1 draw in their opening Pool A match of the Asia Cup men's hockey tournament, here Monday.

India took the lead in the ninth minute through Karthi Selvam before Abdul Rana broke their neighbours' heart by equalising in the 59th from a penalty corner. India will next play Japan Tuesday.

Pakistan had the first scoring chance in the third minute in the form of a penalty corner, but they failed to stop the ball properly as India survived.

Seconds later, it was India's turn to secure a penalty corner but Neelam Sanjip Xess' effort was saved by the Pakistan goalie Akmal Hussain.

The Indians continued to put pressure on the Pakistan defence and secured two more penalty corners in the first quarter, the second of which was converted by Karthi. who scored his first international

goal after his flick went inside the Pakistan citadel after getting a deflection off the stick of defender Muhammad Abdullah. In between Pakistan also got another penalty

corner but the effort went wide.

Soon after the start of the second quarter, Pakistan goalkeeper Hussain made a fine reflex save to deny Pawan Rajbhar from point blank range. The Indians dominated the ball possession and secured another penalty corner in the 21st minute which went abegging.

Pakistan made a bright start after the change of ends and threatened the Indian defence early on.

India had a flurry of chances but Pakistan goalkeeper Hussain was there to save his side. The Indians kept up the pressure and secured a few more penalty corners in the third quarter but could convert none. Credit should also go to Pakistan keeper Hussain, who stood like a rock in front of the goal.

A lapse in concentration cost India dearly as a long ball caught, an otherwise alert Indian defence, off guard in the final two minutes, resulting in a penalty corner for Pakistan. Rana pushed in from a rebound after Mubashar Ali's flick was saved at the goal line by Yashdeep Siwach.

Meanwhile in the other matches of the day, Malaysia beat Oman 7-0 and Korea defeated Bangladesh 6-1 in Pool B. while Japan thrashed hosts Indonesia 9-0 in Pool A.

## AC Milan end Serie A title drought Motera, not Eden,

Milan, May 23: The city of Milan was swarming with a sea of celebrating red-and-black fans as AC Milan secured its first Serie A title in 11 years Sunday with a 3-0 win at Sassuolo. Thousands of supporters in the team's colors had started gathering in Milan's Piazza del Duomo, in front of the iconic cathedral, even before the Rossoneri clinched its 19th scudetto.

And it was the man who thrives in the big occasions who helped Milan do it, as veteran forward Olivier Giroud scored twice to set his side on the way to the win. Rafael Leao set up all three first-half goals. The 22-year-old Leao was presented with the Serie A player of the season award after the match.

The result meant Milan finished two points ahead of defending champion — and city rival — Inter Milan, which won 3-0 at home to



The festivities were mirrored at Sassuolo, where there was a joyous pitch invasion at the final whis-

tle, delaying the trophy ceremony. Zlatan Ibrahimovic walked out puffing on a cigar: "This is the most satisfying of my titles," said Ibrahimovi, who also helped Milan to the last of its Serie A titles in his first spell at the club. "I still remember when I came back I promised to take Milan back to the top and to win the scudetto. Many did n't believe and laughed. Instead I am here as a champion now."

Kolkata, May 23: The hurt and disillusionment was palpable as a disgruntled India wicketkeeper-batter Wriddhiman Saha Monday called the Motera Stadium his new "home ground", having played all his life at the iconic Eden Garden.

It would not have been easy for the Gujarat Titans glovesman to return to the venue, where he made a dream Ranii debut with a hundred in 2007, but won't play for the state

after a run-in with the establishment. "Here, I'm representing Gujarat so my home ground is Motera Stadium, I believe in that. Since I'm no longer with KKR, the Eden is not my home," Saha said in a virtual media interaction ahead of their IPL Qualifier One clash against Rajasthan Royals.

While he called Motera his home ground, ironically, not a single match of the ongoing IPL has been played in Ahmedabad till now.

Asked whether he would be seen playing for Bengal at the Eden again, the 37-year-old said: "I'm not able to answer the second part of your question. I might have played a lot of games here in the past but I'm here to play an away game," Saha said.

Saha was at loggerheads with the establishment of CAB after they named him for the Ranji Trophy quarter final against Jharkhand without his consent. Saha was annoyed that CAB assistant secretary Debabrata Das questioned his commitment after he pulled out of Ranji league stage.
