UGC stricture to state on university postings

The UGC urges OPSC to abide by the Supreme Court's stay order on recruitment of teaching and non-teaching staff in universities

New Delhi, May 26: The University Grants Commission (UGC) has cautioned the Odisha government over violation of the stay order issued by the Supreme Court on the Odisha Universities (Amendment) Act, 2020.

UGC secretary Rajnish Jain has written letters to the state Higher department Commissioner-cum-Secretary and Odisha Public Service Commission (OPSC) in this regard.

In the letters, the UGC said that the Supreme Court May 20 had issued a stay on the Odisha Universities (Amendment) Act, 2020 through which the state government had sought to control appointment to important academic and administrative posts in state universities, including the recruitment of teaching staff.

The court stayed the recruitment process in state universities for the next three months after

Despite a stay order from the SC, the OPSC continues to undertake recruitments to asst prof posts in pursuant to a 2020-21 advertisement

hearing a petition filed by the UGC and retired professor of JNU, Ajit Kumar Mohanty.

The court has also sought a reply from the Odisha government and set the date for the next hearing on the matter after two months.

However, the UGC said, it had noticed that, despite the stay granted by the SC, the OPSC, which is a party to the case, is continuing to

undertake recruitment to the post of assistant professor (sociology) and assistant professor (commerce) in pursuant to an advertisement issued in 2020-21.

"Since the recruitment of teachers /faculty by the OPSC, and that of non-teaching staff by the State Selection Board (SSB), is directly in issue in the aforesaid SLPs pending before the SC, the continuation of the recruitment process will be in the teeth of the stay order granted by the court," Jain said in his letter.

Stating that the court's stay order also applies with respect to any recruitment process that commenced prior to the order, he urged the state government to refrain from undertaking any further step(s) for any recruitment of teachers and non-teaching staff, including the above mentioned one.

The UGC secretary further warned that it also reserves all its rights to take appropriate legal remedy in this regard

Centre drops offer to sell 53% stake in BPCL

PRESS TRUST OF INDIA

New Delhi, May 26: The Union government Thursday withdrew its offer to sell its entire 52.98 per cent stake in BPCL, saying that majority of bidders have expressed their inability to participate in the current privatisation process due to prevailing conditions in the global energy market.

The government had planned to sell its entire 52.98 per cent stake in Bharat Petroleum Corporation Ltd (BPCL) and invited Expressions of Interest (EoIs) from bidders in March 2020. At least three bids came in by November 2020.

However, the privatisation was stalled after two bidders walked out over issues such as lack of clarity in fuel pricing, with just one bidder left in the frav. The Department of Investment

and Public Asset Management (DIPAM) said multiple Covid-19 waves and geopolitical conditions affected industries globally, particularly the oil and gas industry. 'Owing to prevailing conditions

in the global energy market, the majority of QIPs (qualified interested parties) have expressed their inability to continue in the current process of disinvestment of BPCL,"

In view of this, the group of ministers on disinvestment has decided to call off the present EoI

process for the strategic disinvestment of BPCL and the EoIs received from QIPs shall stand cancelled, DIPAM said.

"Decision on the re-initiation of the strategic disinvestment process of BPCL will be taken in due course based on review of situation," it Mining mogul Anil Agarwal's

Vedanta group and US venture funds Apollo Global Management Inc and I Squared Capital Advisors had expressed interest in buying the government's 53 per cent stake

With this, the fare for ordinary buses has been reduced from 92 paise to 89 paise per km, express buses from 96 paise to 93 paise, deluxe buses from ₹1.35 to ₹1.29 and AC deluxe buses from ₹1.63 to ₹1.57 per km. Likewise, passengers travelling in super deluxe buses will now have to pay ₹2.44 per km instead of ₹2.53 per km.

TRS banners with 17 questions greet Modi in Hyd

Hyderabad, May 26: Banners with 17 questions to Prime Minister Narendra Modi were put up at different places in Hyderabad during his visit to the city.

The Prime Minister was asked about the commitments made to Telangana that remained unfulfilled even after eight years. While the banners did not carry the names, it was apparently placed by supporters of the ruling Telangana Rashtra Samithi (TRS)

The banners came up around Hussain Sagar Lake in the heart of the city, at Osmania University,

and other prominent places. Most of the questions pertained

to the commitments made by the Centre in 2014 at the time of formation of Telangana - and which remained unfulfilled even after eight years. "Modi Ji why medical college not sanctioned by the centre?" reads a banner.

"Modi ji where is Indian Institute of Science Education and Research for Telangana," asks another banner put up at Arts College on Osmania University campus.

The PM was also asked why the defence corridor was not sanctioned for Telangana.

Another banner said why the global centre for traditional medicine moved from Hyderabad to Guiarat? Modi was also reminded of the Centre's commitment to set



up Rail Coach Factory at Kazipet. He was also asked through two banners as to why national project status was not given for Kaleshwaram project and the Palamuru-Rangareddy project.

The banners also drew the attention towards the Centre's unfulfilled commitment to set up a steel factory at Bayyaram. The TRS also wanted to know as to why turmeric board was not sanctioned for Nizamabad and why new Navodaya Vidyalaya not

sanctioned for Telangana. The state's ruling party had asked Modi similar questions during his previous visit to Hyderabad February 5. As the PM was in the city to unveil the statue of equality, the party had asked 'Where is equality for Telangana'.

A huge flexi held by a group of vouth on Tank Bund in the heart of the city had attracted the attention of all. It had several questions, reminding the PM of unfulfilled promises. Modi was in Hyderabad Thursday for about three hours to attend annual day celebrations at the Indian School of Business (ISB). He also addressed BJP leaders and workers at Begumpet Airport, launching a bitter attack on TRS over what he calls the family rule and appeasement politics in the state.





Hectic lobbying in BJD for RS poll tickets

Bhubaneswar, May 26: With polls to four Rajya Sabha (RS) seats from Odisha set to be held next month hectic lobby within the ruling Biju Janata Dal (BJD) to secure a ticket for the elections is underway.

The notification for three RS seats was issued by the Assembly secretariat May 24 while the same for the 4th seat was issued Thursday. Sources in the BJD said that the

party, which has 113 MLAs in the 147member Assembly, is likely to cap ture all four seats as the opposition BJP and the Congress are expected to keep away from the contest.

Around 40 aspirants in the state's ruling camp are currently making all-out efforts to grab a BJD ticket, which might be a direct pass to the Upper House of Parliament.

Polls to three seats are scheduled to be held June 10 as the tenure of MPs Nekkanti Bhaskar Rao. Prasanna Acharya and Sasmit Patra ends July 1, and bypoll to one seat -- vacated by BJD's Subhas Singh after being elected as the mayor of Cuttack city-is scheduled for June 13.

Voting will be conducted from 9 am to 4 pm on both the dates, and the counting process will be held the same day as the elections.

A BJD leader said on the condition of anonymity that Patra. younger than many of his peers might be accorded a second tenure in Rajya Sabha by party president and Chief Minister Naveen Patnaik.

He also said that Patnaik, who recently fielded quite a few women

similar for the Upper House polls. A recent remark BJD vice-president Usha Devi has added fuel to the speculation.

"The party fielded women in large numbers in panchayat and urban local body elections. It won't be surprising if the BJD president selects women for the vacant Rajya Sabha seats," Devi said.

BJD insiders said the name of Pradeep Majhi, a tribal leader from the state's southern region who quit the Congress and joined the BJD ahead of panchayat polls, is also doing the rounds.



tection against Monkeypox. "Waning of immunity from

smallpox vaccination may be contributing to the increasing outbreaks of Monkeypox," Prof. Raina MacIntyre, from the University of New South Wales, was quoted as saying to the Medical Journal of Australia

"It has been more than 40-50 years since mass vaccination ceased." she said.

A study published in the journal PLOS Neglected Tropical Diseases, in February, warned monkeypox cases were rising as a result of the cessation of widespread smallpox vaccination, as the virus was declared eradicated by the World Health Organisation (WHO).

According to Dr Romulus Breban, a researcher at the Pasteur Institute in Paris, the "outbreak was really waiting to happen", the Guardian reported.

"Our immunity level is almost zero. People aged 50 and above are likely to be immune but the rest of us are not, so we are very very susceptible," he was quoted as saying.

store were credited small amounts of loans from Mahagram Payments Pvt. Ltd.

The company was lending money from its payout account maintained with a payment gateway. But for repayment by the borrowers, the amount was being remitted through other shell companies/ accounts. But, the money was ultimately landing at Mahagrama Payments Pvt. Ltd. It has been ascertained that there are about 1,058 such virtual accounts were created by the company for receiving repayments from the borrowers.' said an official of the EOW. The EOW have succeeded in blocking all 1,058 virtual accounts.

Earlier, the EOW had arrested Sahifi and Dudeja in connection with the case and succeeded in freezing ₹6.57 crore lying in accounts of Mahagram Payment Pvt. Ltd, sources said.

'AMTs can reduce power loss during transmission'

Bhubaneswar, May 26: With the state facing large amount of loss every year in terms of power transmission, experts have suggested use of amorphous metal transformers (AMTs) rather than conventional transformers to reduce power loss.

As per the Economic Survey for 2020-21, Transmission and Distribution (T&D) losses have been more than 20 percent of generation across the country, which is more than twice the world average.

While the ideal level of T&D loss ranges between 6-8 per cent, Odisha registers an average annual loss of around 6.2 per cent at 33KV transmission, which is only the

Compared to conventional transformers, which consist of stacks of laminations that are made from silicon steel transformers, in amorphous transformer a ribbon of steel is wound to form the core This ensures less energy wastage due to heating during magnetisation and demagnetisation of the core.

"Fourteen states in the country have already switched to amor phous transformers. The distribution for the same can be done under Revamped Distribution Sector Scheme (RDSS) which is the flagship scheme by the Indian government to promote energy efficiency by loss reduction," said Prafulla Panda, GRIDCO ex-GM.

Pet goldfish might be threat to native biodiversity

The research shows goldfish to be voracious, consuming much more than the white cloud mountain minnow or native species and in terms of behaviour patterns, goldfish have been found to be much braver, a trait linked with invasive spread

nvasive species are one of the leading causes of global biodiversity loss, and the pet trade is responsible for a third of

all aquatic invasive species. Pet owners releasing unwanted pets into the wild has become a major problem. Whilst many believe this is a humane option, new research suggests that attempting to 'save' the life of a goldfish could in fact lead to catastrophic outcomes for native biodiversity

To better understand the ecological risks posed by species within the pet trade, the researchers focused on the two most commonly traded fish species in Northern Ireland i.e. the goldfish and the white cloud mountain minnow.

The globally popular goldfish was first domesticated over a thousand years ago and has since established non-native populations around the world. The white cloud mountain minnow on the other hand is a species with a limited invasion history to date.

This study published in NeoBiota. developed a new method for assessing the ecological impacts and risks of potential pet trade invaders, based on availability, feeding rates and behaviour.

'Swabhiman Anchal' sees spurt in child marriages

'Bride kidnapping', a ritual practiced among the tribals since ages, still exists and is very common in these tribal-dominated villages

Chitrakonda, May 26: An alarming rise in child marriages has been seen among the most vulnerable tribals residing in villages under the 'Swabhiman Anchal' of Chitrakonda block in Malkangiri district.

Sources said, most girls are being forced to get married before reaching the age of 18. Even as the Central government recently raised the minimum legal age of marriage for women to 21 and for men to 23 years; teenage girls in these villages are forced to marry as soon as they attain the tender age of 13-15. On the other hand, there has been a drastic increase in crimes against women and children, especially cases of domestic violence and child marriages. Moreover, during the pandemic, with closure of



schools and discontinuation of midday meals, several parents from weaker economic background opted to marry

off their girl children. Ralegada panchayat under Chitrakonda block reported the highest number of child marriages thanks to lack of awareness, silence of officials concerned, people representatives' and intellectuals.

Similarly, a 14-yearold girl of Kodigandhi village under Adirapali panchayat was married off to a youth from Ralegada village through 'bride kidnapping', despite protest by her parents. 'Bride kidnapping' also known as 'marriage by abduction' or 'marriage by capture' is a practice in which a man abducts the woman he wishes to marry. 'Bride kidnapping' has been prac-

ticed among the tribals since history and still exists and is most common in tribal-dominated villages. The administration has been taking steps to rescue the girl after a complaint by her parents, but to no avail.

"We have managed to stop two child marriages recently. But, there is more to do. Officials concerned do no work in the ground level. Moreover, they do not take action against the wrongdoers," said Ralegada sarpanch Kamalu Hantal.

Malkangiri Zilla Parishad chairperson Samir Tangul said, "Child marriage is a crime and strict action should be taken in this regard.'

Predictive Analytics

e all tend to follow habits at work and in other aspects of our lives I generally work best in the morning and hate working after dinner. Our habits usually reflect preferences, learning, or a combination of the two-or, as Charles Duhigg notes in his book The Power of Habit, the mere repetition of an act might generate a routine.

My own recent research shows that criminals are not all that different from law-abiding citizens when it comes to sticking to a routine, possibly as a result of their experience, their tendency to specialise, and their belief that they have developed an ideal strategy. And police departments are catching on, with the assistance of an increasingly common tool: algorithms.

Because algorithms use patterns in data to predict future behaviour, they can forecast the movies someone might like on Netflix or the books she might buy on Amazon. But they can also help law-enforcement agencies fight crime. Some algorithms calculate prison inmates' future recidivism. Others underpin predictive-policing tools, which generate crime forecasts with the aim of optimising patrols.

Investments in predictive analytics lead to a reallocation of resources (including through different policing strategies and alternative sentencing), and thus alter the probability of arrest or detention across individuals. For this

reason, it is important to understand whether these algorithmic tools reduce crime, and whether they do so without generating biases against certain groups.

The most elaborate and well-known predictive-policing software has essentially evolved from hotspot maps. These programmes operate on the principle that areas recently subject to high crime are more likely to have high near-term crime rates. Thus, law-enforcement agencies should focus on these areas in order to deter the largest number of criminals.

While researchers have shown that these statistical algorithms have greater predictive power than simple averages, proving that they actually reduce crime is considerably more difficult. Police departments tend to embrace predictive policing when crime is high, and sub sequent reductions might reflect a natura decline that has nothing to do with that decision. Area-focused policing may also simply shift crime elsewhere. A proper evaluation therefore requires a better counterfactual scenario: What would have happened to crime with out the use of predictive policing?

As for bias, it is not inconceivable that predictive policing may distort law-enforcement outcomes. More deprived areas may have higher crime rates and will be patrolled more intensively once predictive policing is introduced. If police resources remain fixed, criminals in deprived areas will have a greater chance of encountering a police patrol than

criminals in more affluent neighbourhoods. But while this is a fair outcome for serial offenders who contributed to the spike in crime that led to the extra patrolling, today's first-time offenders did not previously increase the crime numbers. Because most predictive-policing algorithms bundle together crime incidents without separating habitual criminals from first-time offenders, they may be biased against the latter in deprived areas.

To help address the questions of effectiveness and bias, I evaluated predictivepolicing software used in Milan, Italy. This allowed me to establish a proper counterfactual: For historical reasons, Milan has two police departments that share the same objectives, but only one of them uses predictive policing.

KeyCrime, the predictive software developed by Mario Venturi that is used in Milan, differs from common predictive-policing tools because it focuses on arresting perpetrators rather than deterring them (thus denying criminals the opportunity simply to go somewhere else) and distinguishes firsttime offenders from recurrent criminals. The software uses information gath ered from victim reports and CCTV cameras to link criminals to commercial robberies, and then predicts when and where a particular individual or group will strike next. KevCrime generates individual predictions, which reduces the scope for bias.

The results indicate that analysing the habits of recurrent criminals more than doubles the likelihood of arresting them. Thieves tend to act in a similar way over time, targeting a specific neighbourhood and type of business, as well as sticking to a certain time of day. So, for example, someone who previously robbed a jewellery shop at nine o'clock in the morning is likely to reoffend in the same neighbourhood, at around the same time, and against another jeweller. Since there are only so many matches that fit the predictions, the software highlights the potential future targets, and the police department organises patrols to catch the thief.

Micro-predictions based on individual criminal groups' behaviour have been proven to work in combating robberies and are now being extended to other types of serial offenders, like sex offenders and terrorists. Whether predictive policing will be equally successful in bringing these criminals to justice remains to be seen, as reduced interaction with victims and availability of CCTV footage might make it more difficult to link offenders across incidents.

More widespread use of predictive policing may lead criminals to change their habits and become less predictable. But the development of more powerful algorithms and data-gathering processes provides some grounds for optimism among police departments.

'Crime is terribly revealing," Agatha Christie wrote. "Try and vary your methods as you will, your tastes, your habits, your attitude of mind, and your soul is revealed by your actions." For now, building capacity to predict individual crimes by using criminals' habits against them appears to be a good investment.

The first known user of the term in print is Malcolm Lowry. In his Under the Volcano of 1947 appears: "The tabnabs were delicate and delicious little cakes made by the second cook." Its provenance is obscure. It may originally have been Royal Navy slang, but every written reference is to merchant shipping. An editor's footnote to The Collected Poetry of Malcolm Lowry (1992) says they were "small pasty delicacies, usually reserved for officers and passengers (thus, to be nabbed from the table)." The suggested origin is plausible, but unverified (and probably unverifiable).

BACK ON TRACK?

THE QUAD LEADERS TOOK SERIOUS NOTE OF CHINESE AND RUSSIAN JETS FLYING OVER JAPANESE WATERS AS THE QUAD SUMMIT WAS IN PROGRESS

rime Minister Narendra Modi was in Tokyo to attend the Quad meeting. He also met the other three Quad leaders bilaterally-Joseph Biden of America, Anthony Albanese of Australia and Fumio Kishida of Japan. It was assumed that Modi may not be received so warmly as before for his divergent view from other three partners on the Ukraine war. But, from the reports in the press. Modi came out unscathed. On the contrary. Modi's deliberations in the Quad and bilaterally, seem to have enhanced India's standing vis-à-vis the Quad partners.

Biden said to Modi that he is committed to making America's partnership with India among the closest on earth. He added that there is so much that the two countries can and will do together. The Australian Prime Minister, sworein 48 hours before he met Modi. said, "Australia-India ties have never been closer." The Japanese Prime Minister did the icing on the cake as he acknowledged India's stand on the war between Russia and Ukraine. In response to questions from media about India's stand on Russia and its impact on relevance of Quad, he said, "in international situation, each country has its own historical development and geographical situation. Even amongst like-minded

positions may not agree fully." From the above accounts which are certainly not fully diplomatic hyperboles, it appears that Modi scored well for India in consolidating the bilateralism with Quad partners, and retaining their warmth and confidence. To be sure, in such summits, the bilateral meetings on the fringe are the real tangible events. Scanning the outcome of the bilateral meetings, look at the common ground created as well as reiterated with the United States. Prime Minister Modi commented that the strategic relations between India and US, is truly a "partnership of trust" and Quad is a "force for good" for global peace and stability. American President reciprocated the feelings with complete commitment to the partnership.

On Australia, both leaders re-

viewed the multi-faceted cooperation under the comprehensive strategic partnership, including in trade and investment, defence manufacturing, renewable energy, science and technology, agriculture research, sports and people-toties. With Japan, India has a range of trade and investment relationship based on shared concerns, trust and goodwill. In keeping with spirit of friendship with Japan, Modi met three former Prime Ministers, corporate leaders and the Indian diaspora

In Quad, as usual, several decisions were taken, a new project initiated, resolutions made on international affairs. To start with. in the important joint-statement. in the wake of Russia-Ukraine war, the Quad said, "as Russia's invasion on Ukraine is shaking the fundamental principles of the international order... (we) confirm that unilateral attempts to change the status quo by force, will never be tolerated anywhere, particularly in the Indo-Pacific region." The reference to Indo-Pacific is aimed at sending a message to China in view of its threat of taking over Taiwan by force

Along with the forgoing reference to Russian war, Quad declared that, they would champion adherence to international law as reflected in the UN Convention in East and South China seas. As expected, Quad unequivocally con-

demned terrorism and violent extremism. What is important to note is the reference to the terrorist attacks in India - 26/11 Mumbai and 2016 Pathankot at tacks perpetrated by terror groups based in Pakistan.

The Quad announced the formation of the Indo-Pacific part nership for Maritime Domain Awareness (IPMDA) which will track the maritime activities in partners' waters quicker and wider It will also track 'dark shipping' and other tactical level activities such as rendezvous at sea, protect fisheries, vital to many Indo-Pacific economies. On development, Quad, pledged to strengthen global health architecture in getting ahead of the virus which caused havoc in the world. 21 March, last year, the Quad countries had announced 'the Quad vaccine partnership' and in pursuance to that, the Quad leaders announced, "we commit to adapt our respective approaches to get ahead of the virus by focussing on preparing for new variants, making vaccines, tests, treatments, and other medical products for those at higher risk.

Recognising the urgent need to tackle climate change, Quad leaders launched, "Quad Climate Change Adaptation and Mitigation Package (Q-CHAMP)". This initiative was in the offing from the first in-person Quad summit. In this meeting, while launching the mechanism for addressing climate change, the Quad leaders said they will, both individually and collectively strengthen their cooperation to mitigate and adapt to the impacts of climate change, in line with the suggestions made by IPCC and COP26.

On infrastructure, Quad leaders agreed to deepen their cooperation. After COVID crippled the world economies, including in the Indo-Pacific region, the Quad leaders resolved to drive productivity and prosperity in the region. The leaders agreed to bring their respective skills and experiences to the table to leverage infrastructure delivery to the region. To secure this, Quad leaders agreed to extend around USD\$50 billion for the Indo-Pacific over the next five vears. In parallel, the US launched the Indo-Pacific Economic Framework for Prosperity (IPEF) to support the economic development in the region. IPEF comprises 13 countries from the region. India was invited into this group to which Modi promptly agreed. This will per haps make-up for the withdrawal from RCEP - the Regional Comprehensive Economic Partnership. The Quad leaders took serious note of Chinese and Russian iets flying over Japanese waters as the Quad summit was in progress.

From the above account, it appears that Quad and bilateral meetings went well for India. But Ukraine is still the elephant in the room. Until the war in Ukraine ends, world politics and partner ships will not be steady. Biden strongly said: "Putin is trying to extinguish culture. This is more than just a European issue, it is a global issue. Food crisis may worsen as Russia blocks Ukraine from exporting its grains." Mark this, Biden said, "as long as Russia continues the war, the US will work with its partners.

Biden's statement is fraught with uncertainties, possibilities and scope for disruption. India has to choose any of these outcomes and eventuality arising out of the war.

two years' time. This has led to constant changing and chopping of portfolios as well as investment strategies. The post-pandemic era saw equity funds delivering overwhelming returns. It was a phase of record-breaking number of demat accounts being opened, wherein the major contributors were the millennials. Crypto currencies, IPOs, PE funds, were the new fad and 'go to' products. Any return below 15% was considered to be 'underperformance' or in fact 'non-performance'. At the same time, investors were disillusioned by fixed income category.

The 'sell off' by FIIs (Foreign Institutional Investors) and FPIs (Foreign Portfolio Investors) were commensurated by DIIs (Domestic Institutional Investors) and domestic retail investors. The market cap to GDP ratio (Buffet Indicator) for Indian market was 118%. Nifty and Sensex reached all time high numbers during October last year. Everything looked rosy.

The US-China trade war, the Russia-Ukraine war posed temporary impediments to the bullish outlook. But sooner rather than later, the central banks had to ad-

The market has witnessed a dress the issue of inflation. The ETFs, large cap/bluechip funds. The time horizon for this product 'elephant in the room' had to be addressed amidst the euphoria. The Federal Reserve's imminent rate hikes have sent the market into a dizzy and have posed a plethora of ambiguous scenarios. The need of the hour is to create a 'secular all weather portfolio'. This avoids the vagaries and vicissitudes of market intricacies. The core objective of investment is 'diversification' i.e. putting eggs into different baskets. A single investment style of 'buy and hold' should be replaced by multiple investment styles of 'core and satellite'.

An investment style implies your approach towards segregation of assets in your portfolio. It is a reflection of your risk-return conundrum. Investment strategies are based on expected returns, risk appetite, liquidity requirements and time horizon. A 'core and satellite' investment strategy implies that the bulk of the portfolio belongs to core, while satellite is the tactical aspect of the portfolio aiming to earn higher returns.

The holistic investment framework should comprise of a blend of investment strategies. For example, a portfolio built on 80:20 allocations into core and satellite. The core comprises of index funds,

small cap allocation. This ensures well defined diversification across market capitalization. The passively managed funds (index funds and ETFs) have lower expense ratio and hence are cost effective in nature.

In the debt investment strategy framework, interest risks and credit risks need to be addressed from duration perspective. One must choose buckets with different maturity periods - less than 1 year, 2-3 years, 3-5 years, 5-7 years and more than 7 years. This strategy mitigates the interest rate risk and provides flexibility of reinvestment as well.

For HNI (High Net-worth Individuals) and UHNI (Ultra High Net-worth Individuals) clients. PMS (Portfolio Management Services) is also an option. The minimum ticket size is 50 lakh. Hence this makes a tailor-made product for the HNI segment. Under this category, a multi-cap portfolio with a large cap bias fits the bill. Generally alternate assets (PMS, AIF) are risky propositions, but a thorough understanding of the investment philosophy, historical track record, credentials of the fund manager renders credibility and attractiveness to this segment.

From a deployment strategy, one should also have a combination of both lump sum as well as staggered investment strategy. When it comes to staggered investment strategy, SIPs (Systematic Investment Plans) and STPs (Systematic Transfer Plans) are imperative in one's port folio. They help in averaging out the market volatility and uncertainty. The SIPs and STPs must be in the 'satellite' space, wherein the choice of funds can be thematic or mid and small cap categories.

Gone are those days of 'buy and hold' strategy. One must rebalance and realign the portfolio in terms of risk-return matrix. With different phases of life, the financial goals and requirements of an individual also change. Hence the allocation ratio in core and satellite must be in sync with one's financial goals. Having the right mix of allocation across asset class as well as market cap, we can create a secular portfolio for all weathers. It provides adequate immunity and insulation from the vagaries of a volatile market.



Srinagar: Nine people, including an Army personnel, were killed when their cab rolled into a deep gorge on the Srinagar-Leh national highway in Jammu and Kashmir's Ganderbal district, officials said Thursday The cab, on its way from Kargil to Srinagar, skidded off the road late Wednesday at Zojila and rolled down the gorge, they added. The police, army and locals launched a searchcum-rescue operation and recovered four bodies and rescued five others who were rushed to a hospital, officials said.

56 kg cocaine seized near Mundra port

Bhui. Guiarat: The Directorate of Revenue Intelligence (DRI) has seized 56 kg of cocaine, estimated to be worth around ₹500 crore, from a container near the Mundra port in Gujarat's Kutch district, an official said Thursday. While DRI officials did not disclose the value of the seized contraband, it could be close to ₹500 crore as one kilogram of cocaine is known to fetch around ₹10 crore in international markets. Based on specific inputs, a team of DRI officials searched the container which had arrived at the Mundra port some time ago from a foreign country and was kept at a Container Freight Station nearby, the official said.

TV artiste's killing: Two ultras trapped

Srinagar: Two Lashkar-e-Taiba militants, involved in the killing of a female TV artiste Wednesday, have been trapped in an encounter with security forces in Pulwama district of Jammu and Kashmir, police said Thursday. The Muslim side has argued that the plea is not maintainable as the Places of Worship Act 1991 prohibits conversion of any place of worship and mandates the maintenance of the religious character of any place of worship as it existed August 15, 1947.

After the plea was filed, a lower court had ordered a videographic survey of the Gyanwapi complex,

Heart problems, pneumonia, asthma claimed 42% of total deaths in 2020

New Delhi, May 26: Heart diseases, pneumonia and asthma together claimed the highest number of lives -- over 42 per cent - of the total 18,11,688 medically certified deaths registered in the country in 2020.

However, the total number of registered deaths in the country was 81,15,882. According to the 'Report on Medical Certification of Cause of Death 2020', prepared by India's Registrar General and Census Commissioner, Covid-19, which hit the country in that year, claimed nearly nine per cent of the lives -- 1,60,618 people.

While diseases of circulatory system claimed 32.1 per cent lives, respiratory system related diseases were responsible for 10 per cent deaths. Those who died due to diseases of pulmonary circulation and other forms of heart diseases and ischemic heart diseases were categorised as deaths due to 'diseases of circulatory system'.

Deaths from pneumonia, asthma and related diseases were termed as deaths due to the 'diseases of respiratory system'


The fifth leading cause, endocrine, nutritional and metabolic diseases were responsible for 5.8 per cent of the total medically certified deaths. Diabetes and mellitus were the major causes under this category.

The sixth leading reason of country's deaths was injury, poisoning, and certain other consequences of external causes (fractures, poisoning by drugs and biological substances) and it constituted 5.6 per cent of the total

cent respectively of the total medically certified death.

The highest number of deaths (5,17,678 or 28.6 per cent of total medically certified deaths) were reported for the age-group 70 years and above. For the age-groups of 45 years and above, diseases of circulatory system (heart diseases) were the first leading cause of death. A total of 5.7 per cent of total medically certified deaths were reported among infants (age

less than 1 year).
About 71.7 per cent of all infant deaths were reported to be caused by certain conditions originating during the perinatal period. Lucknow, May 26: With an eye on the upcoming Lok Sabha elections, the Uttar Pradesh government led by Chief Minister Yogi Adityanath, Thursday tabled a budget of ₹6,15,518.97 crore for the financial year 2022-23.

This is almost double the size of ₹3,46,935 crore budget presented by Akhilesh Yadav government for the financial year 2016-17.

It includes new schemes worth ₹39,181.10 crore. The state government has also announced budgetary provision worth crores of rupees to strengthen



and order in the state.

Tabling the budget in the Assembly state Finance Minister Suresh Khanna said that the government has not only made a record payment of ₹1,72,745 crore to sugarcane farmers until May 16, 2022, which is ₹77,530 crore more than the five years of accumulated payment of ₹95,215 crore during Akhilesh Yadav's government, but has also proposed ₹1000 crore for payment to the remaining sugarcane farmers.

The budget proposes free irrigation facility to farmers through 34,307 government tube-wells and 252 minor branch canals as well as ₹1000 crore under Mukhya Mantri Laghu Sinchai Yojana to address irrigation related issues of the state. Furthermore, the budget proposes accidental insurance of ₹650 crore for farmers under Mukhya Mantri Krishak Durghatana Kalyan Yojana. The Yogi government aims to

distribute 2 crore smartphones and tablets in the next five years, including 12 lakh in the current financial year itself. It has also proposed ₹897 crore

for multi-modal connectivity projects under PM Gati Shakti Yojana and ₹694.34 crore for the 594 km long six-lane Ganga Expressway from Meerut to Prayagraj.

Oppn slams budget, calls it directionless

oposition parties in Uttar Pradesh Thursday criticised the state's budget and called it directionless and a web of statistics. Samajwadi Party (SP) leader Akhilesh Yadav said that it was a wizardry of numbers and a web of statistics. He said that this was the sixth budget of Chief Minister Yogi Adityanath but lacked a vision and had nothing for the common man. The SP chief added that the budget did not say anything about doubling farmers' income and checking inflation. The common man does understand it. Under the doubleengine government, inflation has doubled. Youngsters who wanted employment are depressed. Employment is seen in the statistics but not in reality, Akhilesh said, adding that the government talked about unemployment but does not give out the figures. "We have seen dreams of free medicine, treatment and electricity, but this government in constantly increasing inflation." BSP president Mayawati said that the budget was a clichéd exercise and lacked steps for public interest. She said the government failed to run schemes for the poor and for the development of the state's infrastructure. "Where is the basic work that should have been done on a priority basis by the so-called double-engine government to bring 'achche din' in the lives of crores of people of Uttar Pradesh?" she said in a tweet in Hindi. "How would a policy like that come about when there is a lack of clear intention? How long will this game of fooling people continue?" she asked. Congress MLA Aradhana Mishra Mona said that the budget had nothing new to offer for the poor and even the middle class, saying

Agra, May 26: Four people were arrested for offering 'namaz' at the Shahi mosque in the Taj Mahal premises, police said Thursday.

The four were booked under section 153 of the IPC which punishes provoking with intent to cause riots. Four tourists were arrested for offering namaz at the mosque in Taj Mahal premises on Wednesday. Three of them are from Hyderabad and one is from Azamgarh. They have been booked under the section of 153 of IPC. They have been presented in the court, said Vikas Kumar, Superintendent of Police (City).

Superintending archaeologist, ASI, Agra Circle Raj Kumar Patel said there is a Supreme Court order that prohibits offering of namaz inside Taj premises on all days except Friday. He said even on Friday, only the residents of Tajganj locality - where the mausoleum is located - are allowed to pray between 12pm and 2pm

The four men were spotted offering namaz at the Shahi mosque at about 5pm Wednesday evening. They were accosted by the officials from the Archaeological Survey of India and CISF and were handed over to the local police.

According to some, prohibition on offering of namaz inside the Taj mosque was unheard of till a few days back.

"Namaz has been offered at the mosque of the Taj Mahal regularly. But some days ago the Archaeological Survey of India claimed that as per the order of the Supreme Court of India offering Namaz is prohibited in the mosque premises except Friday," said İbrahim Zaidi, the head of the Intezamia Committee at Taj Mahal.

Zaidi said the committee has asked the ASI to give the prohibition in writing with proof and also display a board announcing the prohibition to the tourists.

Vinod Dixit, a tourist guide from Lucknow, who accompanied the tourists, claimed that the accused had no idea they were committing

Panaji, May 26: Kurdi, a submerged village in south Goa, emerges once every year, when summer is at its peak and the catchment area of the Selaulim dam nearly dries up.

This year, thanks to unseasonal. but heavy pre-monsoon showers, Kurdi has remained underwater.

This has led to cancellation of the Someshwar Maha Utsav, an annual festival held at the Someshwar temple when it surfaces in the summer months of April and May.

The cancellation of the festival has led to disappointment, especially among the former residents of the village, who were relocated by the government, after the construction of the Selaulim dam in whose catchment, the village lies submerged most of the year.

Gurucharan Kurdikar, a software engineer working in Bangalore, said that the Maha Utsav had started in the year 2015 with a gathering of few people. It rose to around 6,000 people in the year 2019. "Because of Covid restriction for the last two years we couldn't hold it in a big way, however, only 'Abhishek' was performed," said Kurdikar, one of the organisers.

"For last eight years, the displaced villagers are having celebrations at the temple. However, we

In the national capital, tomatoes are being sold for₹ 60-80; while in many cities its prices have reached₹ 100 amid shortfall in supply. Apart from tomatoes, green



comparison to the last week. As per vendors, these prices will increase further in the coming days as they argue "vegetables often become expensive during the rainy season". According to traders at Azadpur and Ghazipur Mandi, Asia's largest vegetable and fruit market, the arrival of tomato (in the market) has fallen down to about a third, leading to a steep rise in its prices. Tomato is selling at₹ 65-80 per kg in the retail market.

Lemon is being sold in Delhi for₹ 200 to₹ 250 per kg. Similarly, brinjal is at₹ 60 to 80 per kg, calabash (laoki)₹ 50, cauliflower₹ 100 to₹ 120, onion and potato₹ 40, capsicum₹ 100 to₹ 130, carrot₹ 80 and spinach is being sold at₹ 60 per kg.

Other vegetables are also becoming expensive amid the shortfall in supply, said a trader, adding that the farmers have not planted new crops due to fear of loss, which would further increase the prices of vegetables in coming days.

A Delhi court Wednesday awarded life imprisonment to Malik, one of the foremost separatist leaders, in a terror funding case, saying the crimes committed by him struck at the "heart of

the idea of India" and were intended to forcefully secede Jammu & Kashmir from Union of India.

'10 accused arrested so far

NEW DELHI: 'Jack', 'John' and 'Alpha' were among the NIA's protected witnesses who helped nail banned JKLF chief Yasin Malik. These names were given to important protected witnesses, with hidden identities for their safety, in the terror funding case in which the National Investigation Agency (NIA) had seized around 600 electronic devices during its raids at 70 places. Malik, who had pleaded guilty for the terror funding crimes, was sentenced to life by a Delhi court Wednesday. There were nearly four dozen protected witnesses but code names were given only to selected few, who could be of help in making a watertight case, officials privy to the developments of the case said.

Mainly Hindu India has been fighting an armed insurgency in its portion of the region since the late 1980s. More than 3,400 Hindus from Kashmir have been given government jobs there in recent years, as Prime Minister Narendra Modi's government has tried to lure them back into the region after militant attacks forced them to flee in 1990.

Germany approves Covaxin for travel



New Delhi, May 26: Germany Thursday approved the 'Made in India' Bharat Biotech's Covid vaccine Covaxin.

"Covaxin has been approved by Germany. The entrants will no longer need proof of vaccination as the Federal Cabinet relaxes restrictions," said Bharat Biotech in a tweet on Thursday.

"The Federal Cabinet of Germany has approved Covaxin and relaxed restrictions on the entry for those vaccinated with WHO approved vaccines. The promulgation takes effect from June 2022," said the vaccine manufacturer in a statement.

Walter J Lindner, German Ambassador to India, Thursday hailed the German government for recognizing the WHO-listed Bharat Biotech's Covid vaccine, Covaxin for travel to the country starting June 1.

Taking to Twitter, the Ambassador said: "Very happy that GER government just decided to rec-

Monsoon advances to SL, onward to Kerala

New Delhi, May 26: After a six-day pause, the south-west monsoon has started lingering towards Kerala, having covered southern Sri Lanka Thursday, the weather office said.

'Conditions are favourable for further advance of Southwest Monsoon over some more parts of South Arabian Sea, entire Maldives and adjoining areas of Lakshadweep and some more parts of Comorin area during next 48 hours," the India Meteorological Department (IMD) said Thursday afternoon.

According to reports, parts of Kerala have been receiving heavy rainfall and the weather office has forecast widespread rain over the southern state and Lakshadweep over the next two days



"Advance of the monsoon over Kerala is being continuously monitored," the IMD said. The weather office had earlier said that the south-west monsoon was likely to have onset over Kerala May 27, with an error margin of four days. The normal onset date for Kerala is June 1. According to monsoon watchers, the south-west monsoon_ had gathered momentum due to Cyclone Asani in the Bay of Bengal earlier this month. Monsoon had reached Andaman and Nicobar Islands May 16, earlier than normal, and was expected to sprint ahead under the influence of remnants of Cyclone Asani, which were lingering over the south peninsula after the landfall in northern Andhra Pradesh May 12.

HATE SPEECH CASE

Court remands PC George to judicial custody

Thiruvananthapuram/Kochi. May 26: Hours after senior politician P C George, arrested by the police following cancellation of his bail in connection with a hate speech case, was sent to judicial remand by a magisterial court here Thursday, the Kerala High Court asked the state what was the purpose of keeping him in custody if police had recordings of the speeches made by him.

The query by the High Court was posed to the state government during hearing of George's two pleas - one seeking anticipatory bail in a hate speech case registered at Palarivattom police station and the other appealing against the cancellation of his bail in another hate speech case lodged against him in Thiruvananthapuram.

The high court asked the state what was the purpose of taking George into custody when the investigating agency already had video recordings of the speeches made by him.

It asked the Director General of Prosecution to answer the queries, posed by it, on the next date of hearing -- Friday.

The court also said that George's pleas would be considered on that day and as a result, he would have to spend at least one more day in jail. During the hearing before the highcourt, the politician's lawyers urged the court to grant him interim bail.

No legal right with candidate on mere application of job: SC

New Delhi, May 26: A candidate who has applied for a job does not have a legal right to insist that the recruitment process set in motion be carried to its logical end, the Supreme Court has said

A bench of Justices K M Joseph and Hrishikesh Roy said that even the inclusion of a candidate in the select list may not provide the candidate with such a right.

'The cardinal principle we must bear in mind is that this is a case of direct recruitment. A candidate who has applied does not have a legal right to insist that the recruitment process set in motion be carried to its logical end. Even inclusion of a candidate in the select list may not clothe the candidate with such a right," the bench said.

The apex court, however, clarified that this is different from holding that the employer is free to act in an arbitrary manner.

The observations came while deciding a case in which advertisements were issued March 1, 2018, inviting online applications to fill up among other posts, the post of Associate Professor for the colleges run by the Employees' State Insurance Corporation.

Seema lost one leg as it came under the wheels of a tractor in her native village Fatehpur under Khaira block two years ago. During the treatment doctors suggested that she may die if her injured leg would not be cut. Her parents agreed on it and the doctors chopped



her left leg. Despite losing her one leg, Seema did not lost hope. She used to go to school. She uses long jump technique to travel the distance of 1 km from her home to school and that too with a school bag on her back.

"I want to study and become a teacher so that I could teach the next generation students," Seema, a class 4 student says. "My father and mother are not literate. They are labourers. My father is a migrant labourer while mother is

staying in the village and working in a brick kiln," Seema says. Her mother Beby Devi says:

'When she lost her one leg in a road mishap, she was staying at home. As other students used to go to school, she often insisted that she also wanted to go to school for study. Due to her obstinacy, we got her admitted to the

government school of the village. Now, she used to do every work including wearing school dress, arranging books in the school bag, putting it on the back and reaching school on her own. She never takes help from any person to reach school." A video of Seema went viral on social media where she is moving step by step forward through one leg to reach the school.

Following the video, Jamui district magistrate Awanish Kumar and other senior officials went to Fatehpur village Wednesday and gave her a tri-cycle. The officials are also mulling to arrange an artificial leg for her. Ashok Chaudhary, Bihar Building Construction Minister, tweeted: "Seema will study and she will also walk."

Over 200 monkeypox cases globally: EU



Washington, May 26: The number of confirmed cases of monkeypox worldwide has reached 219 outside of countries where it is endemic, according to an update released by the European Union's disease agency

More than a dozen countries where monkeypox is unusual, mostly in Europe, have reported at least one confirmed case, the European Centre for Disease Prevention and Control (ECDC) said in an epidemiological note released Wednesday night.

"This is the first time that chains of transmission are reported in Europe without known epidemiological links to West or Central Africa, where this disease is endemic," the note said.

It added that most of the cases were detected in young men, selfidentifying as men who have sex with men. The United Kingdom -where monkeypox's unusual appearance was first detected in early May -- currently has the largest bulk of confirmed cases, 71.

It is followed by Spain with 51 cases and Portugal, 37. Outside of Europe, Canada has 15 and the United States has nine. The total number of cases reported Wednesday has increased fivefold since its first count on May 20, when the EU agency said there were 38 cases.

Pak parliament scraps overseas voting rights

Islamabad, May 26: Pakistan's National Assembly Thursday passed a bill to abolish the former Imran Khan government's election reforms giving expats the right to vote through I-Voting and the use of electronic voting machines (EVMs) in the country.

The Elections (Amendment) Bill 2022 presented by Parliamentary Affairs Minister Murtaza Javed Abbasi was passed with a majority vote in the lower house, with only members of the Grand Democratic Alliance (GDA) opposing it. Abbasi, before presenting the bill, presented a motion to allow the bill be sent directly to the Senate for its approval, bypassing the relevant standing committee. The bill is expected to be sent to the Senate on Friday. Describing the bill of "immense significance", PML-N minister Azam Nazeer Tarar recalled the ousted PTI government had made multiple amendments to the Election Act, 2017, including those that allowed the use of EVMs and granted overseas Pakistanis the right to vote in general elections. The PTI government had made the amendments through the Elections (Second Amendment) Bill, 2021, which it had bulldozed through the National Assembly along with 32 other legislations. Tarar said.

Russia to seize western firms looking to leave

New laws would allow

Moscow, May 26: Russia is advancing a new law allowing it to take control of the local businesses of western companies that decide to leave in the wake of Moscow's invasion of Ukraine, raising the stakes for multinationals trying to exit.

The law. which could be in place within weeks, will give Russia sweeping powers to intervene where there is a threat to local jobs or industry, making it more dif-

ficult for western companies to disentangle themselves quickly unless they are prepared to take a big financial hit.

The law to seize the property of foreign investors follows an exodus of western companies, such as Starbucks (SBUX.O), McDonald's (MCD.N) and brewer AB InBev (ABI.BR), and increases pressure on those still there.

It comes as the Russian economy, increasingly cut-off due to western sanctions, plunges into

recession amid double-digit inflation. Italian lender UniCredit (CRDI.MI), Austrian bank Raiffeisen (RBIV.VI), the world's biggest furniture brand, IKEA, fast food chain Burger King, and hundreds of smaller firms still have businesses in Russia.

IKEA, which has paused all operations in Russia, said it was


closely following the development. Raiffeisen, said it was assessing all options, including a carefully managed exit. UniCredit declined to comment Burger King did

not immediately respond to a request for comment.

The bill paves the way for Russia to appoint administrators over companies owned by foreigners in "unfriendly" countries, who want to quit Russia as the conflict with Ukraine drags down its economy. Moscow typically refers to countries as "unfriendly" if they have imposed economic sanctions on Russia, meaning any firms in the European Union or United States are at risk.

Japan, US fly fighters after China drill

Tokyo, May 26: Japanese and US forces have conducted a joint fighter jet flight over the Sea of Japan, Japan's military said Thursday, in an apparent response to a Russia-China joint bomber flight while U.S. President Joe Biden was in Tokyo.

The Japan-US joint flight on Wednesday involved eight warplanes based in Japan, including four U.S. F-16 fighters and four Japanese F-15s, the Joint Staff of

the Japan Self-Defense Forces said. The joint flight was meant to confirm the combined capabilities of the two militaries and further strengthen the Japan-U.S. alliance, it said in a statement.

The flight occurred hours after North Korea fired three missiles, including an intercontinental bal-



listic missile, toward the sea between the Korean Peninsula and Japan, amid concerns about another nuclear test by the North. The missiles fell in waters outside of Japan's exclusive economic zone.

Chinese and Russian strategic bombers conducted joint flights near Japan on Tuesday, Japan's Defense Ministry said. Biden was meeting with Japanese Prime Minister Fumio Kishida and their counterparts from India and Australia for the Quad, an Indo-Pacific security and economic coalition meant as a counterweight to China's growing influence in the region.

Chinese H-6 bombers joined Russian TU-95s over the Sea of Japan and flew to areas over the East China Sea, but did not violate Japanese airspace, Japanese Defense Minister Nobuo Kishi said. Separately, a Russian IL-20 reconnaissance plane was spotted flying off the northern Japanese coast.

The Chinese-Russian joint flight represented an "increased level of provocation" and a threat to the Quad, Kishi said. China said the flights were over the Sea of Japan, the East China Sea and the western Pacific. Defense Ministry spokesperson Wu Qian said it was a "routine joint strategic air patrol" that has been carried out four times since 2019

A large blue sign near the river captured the authorities' approach: "Be patient to enjoy the sunshine when the pandemic ends.


Still, dozens of people were seen jumping over the barricades or wriggling through police tape to go for a dip on a warm Monday afternoon. A middle-aged man stood in the water singing an aria from a famous Peking Opera.

Some brought folding chairs, tables and small gas stoves to cook outside. Since restaurants have been shuttered, only allowing takeout, and many housing blocks not permitting visitors, people have started picnicking on pavements. "The guards come from time to time and chase us away," said Reiner Zhang, a fashion designer who had spread her picnic mat on a street

"But we don't care. People are frustrated with pay cuts and layoffs and we need to meet and vent. she said. Parents sat on the riverbank, eating watermelon, while children paddled along the shallow edges of the river. Mumbai, May 26: Upcoming release of official data for economic performance is likely to register a 2.7 per cent growth for the January-March period, and the FY22 growth is expected to be 8.5 per cent, economists at SBI said Thursday.

They were, however, quick to add that it is difficult to comprehend the numbers due to the spate of revisions that we have seen till now and termed this situation as a forecaster's nightmare.

"We ...believe the GDP projection for Q4 FY22 is clouded by significant uncertainties. For example, even a one per cent downward revision in Q1 GDP estimates of FY22 from 20.3 per cent, all other things remaining unchanged, could push Q4 GDP growth to 3.8 per cent," they noted.

Official data on the economy is expected to be released May 31.

The Central Statistics Office (CSO) had projected Q4 GDP at ₹41.04 lakh crore and FY22 real GDP growth at ₹147.7 lakh crore, an improvement of 1.7 per cent over



pre-pandemic levels, they said. adding that the 'SBI Nowcasting model' with an unchanged quarterly numbers pegs the growth rate of Q4GDP at ₹40 lakh crores, that is lower by ₹1 lakh crore from the CSO preliminary projections.

'We believe that downward adjustments in Q1, Q2 and Q3 numbers could have a soothing impact on Q4 GDP numbers. Every ₹10,000 crore revision adds/subtracts 0.07 per cent from GDP growth," the note said.

Early trends for the March quarter results from listed corporates reported better growth numbers across parameters, as compared to the year-ago period, with a contraction in operating margin due to higher input cost, it said.

Sectors such as steel, FMCG,

Moody's slashes growth forecast to 8.8% for 2022 New Delhi: Moody's Investors

Service Thursday slashed India's economic growth projection to 8.8 per cent for 2022 from 9.1 per cent earlier, citing high inflation. In its update to Global Macro Outlook 2022-23, Moody's said high-frequency data suggests that the growth momentum from December quarter 2021 carried through into the first four months this year. "We have lowered our calendar-year 2022 growth forecast for India to 8.8 per cent from our March forecast of 9.1 per cent, while maintaining our 2023 growth forecasts at 5.4 per cent," Moody's said. Strong credit growth, a large increase in investment intentions announced by the corporate sector, and a high budget allocation to capital spending by the government indicate that the investment cycle is strengthening. "But unless global crude oil and food prices rise further, the economy seems strong enough to maintain solid growth momentum," Moody's added.

the oil prices are unlikely to stay elevated for long, and added they expect the Reserve Bank of India (RBI) to hike rates again at the June policy review. The close coordination between RBI and the government was welcomed by the economists by terming it as the best thing to have emerged during the pandemic.

Chipmaker Broadcom acquires cloud services firm VMware in \$6lbn

Washington, May 26: Broadcom Inc said Thursday it will acquire cloud computing company VMware Inc in a \$61 billion cash-and-stock deal, the chipmaker's biggest and boldest bid to diversify its business into enterprise software.

Broadcom's offer price of \$142.50 per VMware share represents a premium of nearly 49% to the stock's last close, when talks of the deal were first reported May 22. Broadcom will also assume \$8 billion of VMware's net debt.

The chipmaker's shares were down nearly 1% in premarket trading Thursday, while VMware rose 1.3%. Broadcom Chief Executive Hock Tan, who built his company into one of the world's biggest chipmakers through acquisitions, is bringing his dealmaking playbook to the software sector.

In one fell swoop, the deal will almost triple Broadcom's softwarerelated revenue to about 45% of its total sales. Broadcom will instantly be validated as a major software player with the acquisition of VMware, Futurum Research analyst Daniel Newman said.

'Having something like VMware . will have a significant number of doors open that their current portfolio probably doesn't open for them," Newman added.

The agreement is also a coup for Dell Technologies Inc Chief Executive Michael Dell, who spun VMware out of the computer maker last year. Michael Dell owns a 40%

VEHICLE INSURANCE

Third-party premium to go up from June 1

New Delhi, May 26: The Ministry of Road Transport and Highways (MoRTH) has increased the thirdparty motor insurance premium for various categories of vehicles with effect from June 1, a decision which is likely to jack up the insurance cost of cars and two-wheelers.

According to the revised rates notified by the MoRTH Wednesday, private cars with an engine capacity of 1.000 cc will attract rates of ₹2.094 compared to ₹2.072 in 2019-20.

Similarly, private cars with an engine capacity between 1,000 cc and 1,500 cc will attract rates of ₹3,416 compared to ₹3,221, while owners of cars above 1,500 cc will see a drop in premium from ₹7,897 to ₹7,890 Two-wheelers over 150 cc but

not exceeding 350 cc will attract a premium of ₹1,366, and for over 350 cc, the revised premium will be ₹2.804. After a two-vear moratorium due to the Covid-19 pandemic, the revised Third-Party (TP) insurance premium will come into effect from June 1.

According to the ministry's notification, a discount of 7.5 per cent on the premium shall be allowed for hybrid electric vehicles

ceeding 30KW will attract a premium of ₹1,780, those exceeding 30 KW but not 65 KW will attract

a premium of ₹2,904. The premium for goods carrying commercial vehicles exceeding 12,000 kg but not 20,000 kg will increase to ₹35,313 from ₹33,414 in 2019-20. In the case of goods carrying commercial vehicles exceeding 40,000 kg, the premium will increase to ₹44,242 against ₹41,561 in

Jakarta, May 26: Rising to the occasion, Indian men's hockey team slammed six goals in the final quarter for a crushing 16-0 victory against Indonesia, a result that took the holders into the Super-4 stage of the Asia Cup but shut the World Cup door on Pakistan, here Thursday

India needed to win the Pool A contest by at least a 15-0 margin to qualify and the young players of the side delivered under pressure. Both India and Pakistan finished on four points each in Pool A behind Japan but the defending champions qualified for the Super 4s due to better goal difference (1). Pakistan had lost 2-3 to Japan earlier in the day.

The result not only pushed Pakistan out of the tournament but also dashed their hopes of World Cup qualification since only the top three teams here will be given tickets for the big event.

India, being the hosts, will play the World Cup later in the year and hence Hockey India decided to send young players to this tournament for exposure.

Dipsan Tirkey (42nd, 47th, 59th, 59th minutes) starred for India, scoring four goals in the match, while Sudev Belimagga (45th, 46th, 55th) also scored a hat-trick in the match. Pawan Raibhar (10th, 11th). SV Sunil (19th, 24th), and Karthi Selvam (40th, 56th) also scored a brace each in the match, while Uttam Singh (14th), Nilam Sanjeep Xess (20th) and Birendra Lakra (41th) scored a goal each to help their team pick up the win.

India started the match against Indonesia at a relentless pace against the hosts, showcasing their intention to get a big win from the first minute itself. In the 7th minute. the team missed a clear chance to get the first goal for India.

But they did not have to wait for long to get off the mark as Pawan Raibhar struck two goals in two minutes to give his team a 2-0 lead before Uttam Singh added another goal just before the closing of

SV Sunil made an impact in the 2nd quarter as he deflected the ball into the Indonesia nets in the 19th minute. 
The purpose of the tournament is to promote tennis in Odisha and provide budding junior talents a platform to play more international tournaments and get more exposure into tennis sports.
