Drunken man beats wife to death on Sabitri Brata



Baripada: A woman was allegedly beaten to death by her drunken husband, Monday when women across the country are fasting for the long life of their husbands on the auspicious occasion of 'Sabitri Brata'. The heinous incident has been reported from Asura village under Jashipur police limits in Mayurbhanj district. The deceased has been identified as Kali Dehuri, wife of the accused Bharat Dehuri. According to sources, Bharat returned home in a drunken state. A verbal duel soon escalated into a heated argument. Losing his cool, Bharat thrashed Kali brutally following which she sustained grave injuries and died on the spot. PAGE 5

Minor fights off croc, saves self

Pattamundai, May 30: A 15-yearold boy displayed exemplary courage and saved himself from the jaws of a crocodile when it attacked him while bathing in Kani river at Araji village under this block in Kendrapara district, Monday.

The boy was identified as Om Prakash Sahu, son of Manoj Sahu of Araji village. His friends rushed him to the district headquarters hospital in critical condition from where he was shifted to SCB Medical College and Hospital in Cuttack after his condition deteriorated.

Sources said Om Prakash was bathing with his friends in Kani river near his village when a giant 10-feet long salt water crocodile pulled him into the river. However. the young boy did not give up and kicked the reptile to save himself He emerged victorious after a 10

minute long battle in the river. The fight left the boy seriously injured as the crocodile bit his limbs and thighs before leaving him alone. He ran to the river bank to save himself when the reptile again chased him. The reptile however, escaped after his friends raised an alarm.

Notably, Kendrapara district which is crisscrossed by rivers and several water bodies, has three species of crocodiles-- salt-water, gharial and mugger in its river



2.14L to exercise franchise

Bhubaneswar, May 30: The byelection to the Brajarajnagar Assembly seat will be held Tuesday. Över 2.14 lakh voters will exercise their franchise from 7am at 279 booths.

Ruling BJD candidate Alaka Mohanty, BJP's Radharani Panda and Congress nominee Kishore Patel are in the fray for the by-poll.

Of the total booths, 22 are new and 30 are model booths while 60 booths have been identified as sensitive booths. Moreover, 5 pink booths have been formed where only women polling agents will be appointed, sources said.

To ensure free and fair voting, security arrangements have been in different booths for the poll while 1,228 polling officers have been appointed in the booths. The 1,000 police officials and 3 companies of Central armed forces have been deployed at differ-



ent booths to maintain law and order The voting will be carried out following Covid-19 norms with arrangements of sanitisers and thermal scanning at all polling booths.

Moreover, liquor outlets have been closed for 48 hours for the election in the district. Voters can exercise their franchise by producing 12 different identity cards as an alternative. The bypoll was necessitated following the untimely demise of BJD's Kishore Mohanty's in last December.

The Assembly seat was with CPI and Congress till 2009 and went to BJP in 2014. Ruling BJD grabbed the seat in the last election held in 2019. Now, all eyes are on the by-poll as all three parties have a strong hold in the constituency.

Naveen meets Modi, says no talks on Prez election

Patnaik also met Home Minister Amit Shah to discuss several state specific issues

New Delhi, May 30: Chief Minister Naveen Patnaik Monday met Prime Minister Narendra Modi at the Prime Minister's Office here but denied having any discussion on Presidential elections.

Patnaik said that he paid a courtesy visit to the Prime Minister as he hadn't met the latter due to the outbreak of Covid-19. The Chief Minister arrived at Delhi Monday. He is on a three-day visit to the National Capital. "I paid a courtesy call on Prime

Minister Narendra Modi. I haven't been able to meet him because of the pandemic. We discussed several issues regarding Odisha and I asked for his help. There was no discussion on Presidential elections," Patnaik said. Later in the evening. Patnaik also met Home Minister Amit Shah to discuss several state specific issues. Naveen had visited Parliament here March 29 and had held a meeting with Biju Janata Dal (BJD) MPs. During the last visit, he could not meet the Prime Minister.

The Chief Minister's visits to the Prime Minister and the Home



Minister also assume significance in the context of the President's election in July this year as the BJP-led ruling NDA may require the support of parties like the BJD and YSRC to ensure victory of their candidate. The BJD has on many occasions backed the Central government in Parliament on various issues.

Significantly, the President of India is elected by an electoral college comprising members of Lok Sabha, Rajya Sabha and Legislative Assemblies. While the value of the vote of the MPs from both houses remains uniform - 708 a seat, the value of votes of MLAs depends on the population of the state. According to the Presidential Electoral College, the value of each Odisha MLA is 149.

Asst professor sexually abused in City hotel

Bhubaneswar, May 30: A 24-yearold woman working as an assistant professor of a private educational institute in City has accused her male friend of sexually abusing her in a hotel here after allegedly giving her drug-spiked drink. The lady who hails from Chhattisgarh has recently lodged a complaint at the Kabir Nagar police station in Raipur.

Chhattisgarh Police filed a zero FIR and sent the case details to Khandagiri police for registration of the case as the incident occurred in a hotel at Jagamara area under its jurisdiction.

Following the receipt of complaint and other case related documents from the DIG of Raipur, Khandagiri police initiated a probe after registering a case (283/22) in this regard. The lady in her complaint claimed that she joined a private college at Jagamara in March 2021. Meanwhile, the accused, Umesh Sudhakar, a resident of Chhattisgarh, who is known to the lady since the college days visited Bhubaneswar in September 2021.

Sudhakar later called the victim to hotel Sandhya Inn where he allegedly offered the victim drugsspiked cold drink and later reportedly sexually abused the victim who wasunder influence of the drugs for three days. Contd... P4

UPSC CIVIL SERVICES 2021

Shruti Sharma tops; women bag first three ranks

New Delhi, May 30: Shruti Sharma, a student of history, has topped the civil services examination 2021, with the first three rank holders being women in results announced by the Union Public Service Commission (UPSC) Monday.

Ankita Agarwal and Gamini Singla have secured the second and third rank respectively. A total of 685 candidates - 508 men and 177 women - have qualified and they have been recommended by the Commission for appointment to various central services, the UPSC said.

"Among the finally qualified candidates, top three are women candidates," the Commission said, adding that the "top 25 comprise 15 men and 10 women". It is after six years that women have bagged the

top three slots. In 2015, the top four positions were achieved by women.

All the three women achievers said they would like to work for women empowerment and other important areas such as education and healthcare. They said self-study helped them a lot in preparing for the examination and finally clearing it.

Apply for high-security plates from June 1 To begin with the booking

Bhubaneswar, May 30: Owners of vehicles registered before April 2019 can book high-security registration plates (HSRPs) and colourcoded stickers online by visiting the website of Society of Indian Automobile Manufacturers (SIAM) - www.siam.in— from June 1, 2022, said the State Transport Authority (STA) Monday.

Following directives from the Union Ministry of Road Transport and Highways (MoRT&H), the STA had May 27 this year issued guidelines regarding affixation of HSRPs on vehicles registered prior to April 1, 2019

SIAM, the apex organisation of automobile manufacturers, has initiated process for integrating Odisha on its official website which will be available from June 1. Once online,



registration

the users will be able to register themselves and avail the HSRPs and colour-coded stickers through the portal, an STA official said.

To begin with the booking process, the official said, a vehicle owner needs to visit SIAM website—www.siam.in, click on 'BOOK HSRP' option and fill the required fields for registration.

'On the HSRP registration page, a vehicle owner needs to fill the full

process, a vehicle owner needs to visit the SIAM website-www.siam.in. click on 'BOOK HSRP' option and fill the required fields for

number, mobile number, state and district and click the 'submit' button to proceed to the next page,' said the official.

On the next page, a vehicle owner needs to select the vehicle make. "After selecting the vehicle brand, you will have to select one of the two options-HSRP with colour sticker or only colour sticker. After selecting either of the two, a vehicle

owner needs to provide a few more details like chassis number and engine number," said the official, adding that the process comprises six steps—While step 1 is booking, 2 is fitment location, 3 is appointment slot and 4 is booking summary. Step 5 is details verification and payment, the last step is download receipt.

"The HSRPs will only be issued and affixed by the OEMs. The vehicle owner can also opt for affixation of HSRPs and stickers at home on payment of extra charges. All payments will be made online to maintain transparency and avoid overcharging the vehicle owners," said the official adding that OEMs or its authorised dealers after affixing the HSRPs on vehicles shall ensure that the laser code is updated in VAHAN portal.

Citing examples of pricing in Delhi and UP, the STA official said owners of two-wheelers have to spend somewhere between Rs 320 and Rs 500 (excluding taxes), while owners of four-wheelers have to shell out between Rs 590 and Rs 860 (excluding taxes) to get the high security plates.

Bhubaneswar, May 30: The state government has asked the officials concerned to expedite the construction of a common outer rail corridor for Talcher coalfields, an official said Monday.

Development Commissioner (DC) PK Jena has recently held a review meeting on the project in the backdrop of many states facing delay in coal supply. Jena has asked the officials concerned to expedite the project in order to transport coal from the mines located in the area.



The DC has asked the officials to split the outer corridor project into phases to provide railway access on priority basis to the mines where production is expected to start early, official sources said.

In 2009, the state government envisaged an efficient logistic infrastructure for evacuation of coal from various mines in Talcher coalfields and directed the Odisha Industrial Infrastructure Development Corporation (Idco) to prepare a comprehensive planning in this regard.

Accordingly, Idco engaged several reputed agencies to prepare feasibility report, master plan and detailed project report (DPR). A Special Purpose Vehicle (SPV)— Brahmani Railways Ltd (BRL)— was incorporated in 2013 by the Idco and Commerce and Transport department to take up the common corridor project, which included railway line, road and pipeline. The DPR was finalised in July 2015. At that time, the project cost of railway infrastructure was Rs 4,938 crore excluding the cost of land.

The Ministry of Coal and the state government had signed a pact with Ministry of Railways in 2015 to create rail $in frastructure \, for \, evacuation \,$ of coal through Mahanadi Coal Railway Limited (MCRL) with equity participation by MCL (64 per cent), IRCON (26 per cent) and Idco (10 per cent). Then, it was decided to hand over the project to MCRL.

The MCRL split the project into two parts — inner corridor comprising the Jarapada— Tentuloi and Putagadia—Angul links and the outer corridor comprising the western and eastern legs to the north of Tentuloi. The MCRL has taken up the work of the inner corridor but the progress is very slow and they are yet to start the work for the outer corridor.

Therefore, it was later decided that MCRL should continue with the inner corridor work and the outer corridor work should be taken up separately in participative mode with the involvement of beneficiary coal mine owners.

The outer corridor has been frozen. Tentuloi station is under development by MCRL as part of the inner corridor which is expected to come up by December 2025.

It was decided in the meeting to re-activate the existing Brahmani Railway Limited (BRL) as a company fully under the Commerce and Transport department and entrust the project to it. Mine owners will be invited for equity participation in the SPV, retaining at least 51 per cent equity with the state government.

Thereafter, Odisha Rail Infrastructure Development Ltd has been asked to prepare the DPR for the outer corridor and come up with the financial structuring of the project.

The government is also planning to declare the project as a Special Railway Project so that land acquisition can be done under the Railways Act,

Bhubaneswar, May 30: Odisha recorded six new Covid cases Monday, three less than the previous day, with the tally rising to 12,88,437, the state Health department said in a bulletin.

The death toll remained at 9,126 as no fresh fatality due to the infection was reported in the last 24 hours, it added. Fifty-three other coronavirus patients have died due to comorbidities so far.

Eight more people recuperated from the disease since Sunday, taking the total number of recoveries to 12,79,184, the Health bulletin said. Odisha now has 74 active cases.

The coastal state's daily test positivity rate (TPR) was 0.05 per cent as the fresh cases were detected from 11,718 sample tests, it added.

The state pool recorded six new infections. The pool shows the number of individuals coming from outside the state and testing positive upon arrival.

The state currently contributes 2.99 percent of infected cases of the National caseload. Likewise, it houses 0.47 per cent of the total active cases in India. The percentage of national recovered cases in Odisha is at 3.01 and the state contributes 1.75 per cent of the total Covid fatalities across the country.

Khurda tops the list of active cases with 26 infections, followed by Boudh at 12 and Cuttack at seven cases. Districts without active cases are Angul, Bhadrak, Bolangir, Deogarh, Dhenkanal, Gajapati, Ganjam, Jagatsinghpur, Jajpur, Jharsuguda, Puri, Malkangiri, Kandhamal, Nayagarh, Mayurbhanj, Nabarangpur, and Subarnapur.

Why some roads make steering wheels change sides

The custom of driving on the left side of the road in around 78 countries and territories is not just a sign of their eccentricity, but is supported by very sensible reasons

nyone visiting the UK or its former colonies like India, Australia and New Zealand will find driving on the road a little disorienting for one obvious and largely annoying difference. While around 65 per cent of the world drives on the right side of the road, people in these countries drive on the left. Along with the aforesaid countries, people in Ireland, Japan, and some Caribbean islands too follow suit

islands too follow suit.

The 'why' of it drags us, on a seemingly complicated timeline, back to the Medieval era or perhaps even further to the age of gladiators. For instance, in 1300AD, Pope Boniface VIII declared that all pilgrims travelling to Rome should keep to the left.

Back in those days, travellers were almost always prone to attacks. Since most of the people were right-handed, they preferred travelling on the left so as to keep their sword fighting hand free and ready for defense. This also reduced the chance of the scabbard worn on left hitting other people. It was also safer to mount and dismount towards the side of the road rather than in the middle of traffic.

So why did people ever switch to the right? Well, it turns out Napoleon preferred to ride on the right and so did Hitler, in fact Hitler forced Czechoslovakia and Austria to switch to right-hand driving. However, since Britain resisted both Napoleon

and Hitler, the country never switched to the right.

Things changed in the late 1700s when large wagons pulled by several pairs of horses were used to transport farm products in France and the United States. Instead of sitting inside the wagon, the driver sat on the rear left horse, with his

right arm free to use his whip to keep the horses moving. Since he was sitting on the left, he wanted other wagons to pass on his left, so he kept to the right side of the road. It wasn't till 1792 and 1804 respectively that Pennsylvania and New York made it official by regulating it. Many states then fol-

lowed their example and the practice was cemented.

In 18th century, London saw the introduction of a traffic law to make all vehicles on London bridge keep to the left. This was in an effort to reduce collisions. The British Government refused to give up their left-hand driving ways, and in 1773 introduced the General Highways Act, which encouraged driving on the left. The rule was then incorporated into the

Highway Act of 1835 and was later

adopted throughout the UK mak-

ing left-hand driving mandatory

in Britain.

Meanwhile, post-revolution France under their left-handed ruler Napoleon embraced a permanent move to the right side of the road. Amidst all this driving confusion, the British and the French were yielding their power across the globe, and as part of their rapid colonisation, they insisted that the countries they occupied drive on the same side of the road. This ex-

plains why India still drives on the

left, while former French colonies like Algeria, Ivory Coast, and Senegal drive on the right.

When Henry Ford unveiled his Model T in 1908, the driver's seat was on the left, meaning that cars would have to drive on the righthand side of the road to allow front and back passengers to exit the car onto the curb. According to National Geographic, this influenced a change in many countries like Canada, Italy and Spain changing to right-side driving in the 1920s and most of Eastern Europe following suit in the 1930s. As recently as 1967 (and thanks to around \$120 million from their government's pocket), Swedish drivers began driving on the right. However British drivers remain on the left and this is highly unlikely to change.

The 20th century saw an attempt to harmonise road laws in Europe leading to a shift in right-hand driving but that did not affect the UK. Today there are around 78 countries and territories that drive on the left.

Nilagiri, May 30: As a mega drinking water project in tribal-dominated Nilagiri block of Balasore district has missed the deadline due to land acquisition and other hurdles, a new deadline of January 2023 has been set for it.

A team of officials from National Bank for Agriculture and Rural Development (Nabard) has taken stock of the developments and directed the contractor concerned to expedite the work to meet the extended deadline.

According to sources, many villages in Nilagiri block have been suffering due to scarcity of water, particularly in summer. In view of this, a mega drinking water project is being constructed at a cost of Rs 172 crore. The expenses are being shared by both the state and the Union governments.

The Nabard team visited Ajodhya



village and conducted an inspection of the water treatment tank and an intake well at Kathapal on the bank of Sona river.

Work for the project started November 5, 2019 and was supposed to be completed by November 21, 2021. However, the project was delayed due to land acquisition issues

The mega drinking water project will cater to the needs of 1.03 lakh people in 90 villages under 20 panchayats in the district.

Digapahandi, May 30: A few days after two BJD leaders – Sudarshan Suar and Sudhir Kant Patra - were brutally murdered over political rivalry, an organiser of the ruling party was stabbed to death at Nabarangpur village under Digapahandi block in Ganjam district late Sunday night.

BJD youth leader Babu Gouda died in the attack while his aide Pradip Kumar Sahu is battling for life. The stabbing was so severe that a portion of Sahu's intestine has come out.

According to reports, a rift ensued between two groups of villagers during the recently concluded panchavat elections. A sarpanch candidate supported by Babu Gouda faced defeated while the candidate supported by the accused Tofan Gouda won the election. Since then, Tofan and Babu were

at loggerheads. The two came faceto-face Sunday evening while Babu was returning home after taking bath in a pond with Sahu. Even as a verbal fight ensued between the two at the spot, villagers intervened and pacified the two. Later, Babu along with Sahu went to Digapahandi over some work. On their way back home, they

again came face-to-face with Tofan who was waiting for them with a knife in a pre-planned manner. As soon as Babu came closer to him, Tofan stabbed him on his neck, chest and belly.

When Sahu rushed to his rescue, he was also stabbed by Tofan. Both of them were rescued from a pool of blood and rushed

to Digapahandi community health centre. After preliminary treatment, they were shifted to MKCG Medical College and Hospital at Berhampur where Babu breathed his last.

Sahu was shifted to Bhubaneswar-based AIIMS Hospital after his condition worsened.

Meanwhile, police raided several places and nabbed Tofan while he was hiding at a relative's house at Digapahandi Rani Sahi. The cops have seized a blood-stained knife and shirt from his possession. Acting on a complaint by Babu's brother, police registered a case and launched a probe.

Berhampur SP Saravana Vivek M visited the crime spot and took stock of the situation. He also met the bereaved family and assured them of stringent action against the accused. A scientific team visited the spot Monday and collected blood-stained soil for further probe.

'Still can't believe they are not with us'

Sonepur, May 30: Family members of four Odias, who lost their lives in Tara Air Plane-9 NAET crash in Nepal's mountainous Mustang district Sunday, mourned their untimely demise Monday and said that it's hard to believe that they are not with us anymore.

The deceased family members have been identified as Ashok Tripathy, 50, his wife Vaibhabi Tripathy, 45, son Dhanus Tripathy, 23, and daughter Ritika Tripathy,15.

"I still cannot believe they are not with us. I had talked to them four days back. Ashok had told me how he was taking his family for a trip in Nepal. However, we are shocked to know about their death through social media posts and news channels," said an inconsolable Kalyani Tripathy, widow of Ashok's elder

"They did not deserve such a painful death," she added as tears rolled down her cheeks.

"He had come to Sonepur in March and stayed with me for a few days. The whole family had gathered and we had a great time before he went back to Bhubaneswar,"



"Ashok had settled in Bhubaneswar's Jaydev Vihar since 1995. But, since his wife and son worked in Mumbai, he also had recently shifted there," she further said.

Ashok was the fourth son of well known lawyer Krushnachandra Tripathy in Sonepur town. His two elder brothers Debabrata and Subrat have passed away while Subrat's wife Kalvani lives in

"The deaths have come as a rude shock for everyone in Subarnapur town. He was a well known person in the locality. A pall of gloom has descended in Sonepur town,' said a relative of Ashok.

Now, Xinjiang Files

The cat is out of the bag, again. The impregnable Chinese Wall of onesided propaganda suppressing alleged persecution, domination and torture of Uyghur Moslems in Xinjiang province appears to have been breached. The purported secret documents – known as Xinjiang Police Files - recording ruthless attempts to subjugate the minority population by the Han China rulers give a horrifying picture of the repression that the Chinese leadership has, for so long, been rubbishing as a Western propaganda. These documents are claimed to have come directly from the Chinese security forces and were published May 24. Victims of Communism Memorial Foundation with cooperation from 13 media outlets from 10 countries have given the world an inside view of China's 're-education camps' and the 'prison-like' conditions that Uyghur Moslems are forced to endure inside them. The 'files,' which include leaked internal police documents and over 2,800 photographs of detained Uyghurs, including some as young as 15, were released first as part of a research article authored by Dr Adrian Zenz, Senior Fellow, China Studies, at the Victims of Communism Memorial Foundation in Washington.

The media outlets which got access to the research findings include the BBC, Le Monde, and USA Today. The documents confirm what has been known from various sources and inside information. They describe, with chilling precision, the system under which entire families belonging to the Uyghur minority are crushed, held under suspicion through association and detained for being close to another detainee, or because of a 'strong religious familv atmosphere.

The 'files' reveal how the head of the region, Chen Quanguo, in internal Chinese Communist Party speeches, congratulated himself on the fact that the 'four ruptures' had been 'well accomplished.' The 'ruptures' are breaking family lineages, people's roots, their relationship with the outside world and with their own origins. No one has ever believed Beijing's official explanation that the internment camps for Uyghurs and other Moslem ethnic groups in the Xinjiang region are 'professional training centres.' The many testimonies of survivors that have appeared in the press in recent years have given the world a clear idea of the arbitrary targeting of entire populations, the prison system, forced sterilizations and indoctrination intended to erase the distinctive signs of their culture.

The leaked information contains records of speeches from officials in 2018 with orders of "first shoot, then report" for incidents of suppression of the inmates. Dr Zenz tweeted May 24 that he could obtain the mine of information by "hacking into Xinjiang police/re-education camp computers". He claims to have unearthed "first-ever image material from inside camps". According to his sources China's President Xi Jinping wants new camps to be set up because the existing ones are overcrowded.

The Uyghurs live in the Xinjiang region of China which is located in the country's northwest. In the past, the Uyghurs, who are ethnically different from the Han Chinese forming the largest ethnic group in China, demanded greater autonomy. This is because most Uyghurs consider their own culture as distinct from that of the Han Chinese. Moreover, the Chinese government has been systematically resettling more Han Chinese to Xinjiang for top jobs and even encouraging them to marry, in some cases through official pressure, Uyghur women so as to cut off the future generations from their ethnic roots. This has caused widespread resentment among Uyghurs.

The Chinese government has adopted the strategy of demonising many Uyghur groups and individuals branding them as terrorists and extremists. Since 2018 international organisations have reported alleged detention of Uyghurs in large numbers. China, however, has consistently denied such reports. It says that Uyghurs are being given vocational training for acquiring various skills. The Chinese government has also maintained that some of the camps are 'de-radicalisation' and 'counter-terrorism' centres.

But the Xinjiang Police Files have punctured the Chinese propaganda claiming that around 2 million Uyghurs have been herded into these camps to indoctrinate them through coercion. This is contrary to reports carried in the Chinese communist party-backed Global Times newspaper that the measures taken against Uyghur terrorists have been successful and that "there have

been no violent terrorist cases for over four consecutive years in the region." The BBC, however, reported in 2018 that Uyghur villages in the region were under strict surveillance. Uyghur government officials were prohibited from practising Islam, attending mosques and fasting during Ramadan. In 2021, China banned BBC World News from broadcasting in China mainly due to their coverage of Xinjiang. The next year The New York Times carried a report based on more than 400 pages of leaked documents from China. Some of these were speeches given by Xi Jinping explaining the principle of a ruthless and total crackdown.

The Xinjiang Police Files have revealed the extent of state-sponsored atrocities on the religious-minded minority Uyghurs whose moorings in their traditional culture and belief system pose a challenge to the political doctrine of the Chinese government. Also, these sudden leakages of information from inside China could also point to a brewing discontent within the superstructure. Someone or some people, fed up with Xi's style of functioning, may have a hand in these spill out of vitally secret information.

Interestingly, United Nations High Commissioner for Human Rights Michelle Bachelet, who is on a six-day trip to China from May 23, is being taken on a conducted tour. The trip will turn into China's public relations exercise to tell the world that all is well in Xinjiang. International brands are in a dilemma. It is difficult for them to decide whether to leave Xinjiang or not. With the rising costs of both cotton and shipping and increasing competition, the West is likely not to rub China the wrong way no matter what explosive truths tumble out of the Xinjiang Files.

BEYOND JOBS & INCOME

IN THE PAST **EIGHT YEARS,** THE ECONOMY **HAS SUFFERED MAJOR ADVERSE SHOCKS BOTH INTERNAL AND EXTERNAL**

s the Narendra Modi-led government completed three years during this Lok Sabha, and cumulatively eight years since Modi first became Prime Minister in 2014, there have been many articles assessing the government's perbe done through the social, political or economic lens. On the former, we can look at the metrics of social mobility and empowerment, social cohesion and reduction in social tensions, enhancement of law and order and feeling of safety and so on. For the political lens, we can look at stability and evidence of political will to enforce difficult decisions. For the economic lens, which is the topic that this column will cover, it is metrics like generation of jobs, rise in people's incomes, and price stability. These are the main variables that affect most people's daily lives. For people care about economic well-being and opportunities to rise, especially for their young ones. The non-income related variables are education and health. One can examine many other indicators which are indirectly related to job creation and income rising. These could be exports, investment, savings, stock markets, foreign inflow of investment, rising stock of foreign

exchange and so on. We will not undertake a detailed analysis of how various conventional economic indicators have behaved in the past eight years. That would be left to another column, for another day. Suffice to say that eight years ago India was emerging from an externally induced shock called "taper tantrum," and internally caused stress due to high inflation and perceptions of high scales of corruption. Perhaps voters were unhappy with the perceived scale of corruption (remember the three-year movement "India Against Corruption"?), and were also worn out with the prevailing doubledigit inflation. The "taper tantrum" refers to the phenomenon that the United States had started to "taper" their monetary expansion, leading to an instinctive and massive out-

flow of dollars from developing countries. Which in turn caused their currencies to crash, and the Indian rupee was one of them. This led to much macroeconomic vulnerability, hence the term victims of the "taper tantrum."

But beyond the trajectory of variables like GDP, jobs and incomes, is the somewhat qualitative aspect of resilience of the Indian economy. This term "resilience" is difficult to quantify, as compared to the number of jobs, or rupees of investment or percentage of growth in GDP. The term resilience refers to the ability of the economy to withstand economic shocks, be they internal or external. For instance, 1991 was an external shock, caused by the first Gulf War and steep rise in oil prices. Because India's macroeconomic fundamentals were weak, i.e. very high inflation, very low stock of foreign exchange and negative growth in the industrial sector and very high fiscal deficit, the country almost went to the brink of default. This meant that the economy was not "resilient" enough. Similarly, in earlier decades, whenever there was an adverse shock from the weather front, like failed monsoons or drought, the agricultural output and incomes would suffer, and so would the economy. This too is an example of inadequate resilience. Thankfully, the agricultural sector

is much less vulnerable to weather shocks, thanks to better irrigation systems, integration of markets domestically and internationally, and diversification of sources of income for farmers. away from agricultural commodities to animal husbandry and

the services economy. In the past eight years, the economy has suffered major adverse shocks both internal and external. There have also been positive shocks (although one can debate whether these should be called positive shocks or windfall gains). The positive shock was a steep fall in oil prices worldwide, by more than fifty per cent, and they stayed low for nearly two years. The internal negative shocks were the big crash of a large non-banking finance company (NBFC) called Infrastructure Leasing and Financial Services Limited (ILFS) in September 2018. Two years prior to that was the sudden announcement of the banning of high denomination notes i.e. demonetisation of nearly 86 per cent of the currency in circulation. And a third internal shock, which was not sudden and somewhat diffused was the clumsy implementation of the rollout of the Goods and Services Tax, a major tax reform which made the entire country shift to a completely different tax regime. One of the more recent external shocks has

been the pandemic caused by COVID-19, which has affected us for more than two years. And now the war in Ukraine. These are of great magnitude for they have af fected the entire global economy Beyond these six shocks, there are several smaller scale ones, like the severe floods and natural disasters, hurricane induced evacuation and so on. There was also another generalised shock since the Trump Presidency, of a receding of globalisation, and fall in the volume of world trade. This negative sentiment can hurt exporting nations like India, which depends on strong exports to aid domestic growth. India also took some "shock" like decisions like walking out of a free trade agreement called RCEP at the last moment in November 2019.

The resilience of the economy is a measure of how well the economy was able to cope with these negative shocks. The short answer is "quite well." In earlier times each of these shocks would have caused the economy to flounder. But now there is sufficient resilience, in the form of diversification of economic activity, safety buffers in terms of stock of food or forex, and well-funded welfare schemes which do not allow the economy to go off the rails. An example of the latter is the free food scheme that has been running for more than two years and has protected a large section of India's public from food inflation and ensured food security. This has prevented an income and jobs crisis (caused by the pandemic) from becoming a food crisis. The contrast with neighbouring Sri Lanka and Pakistan is quite stark and displays the relative lack of resilience in their respective economies. Resilience is not built overnight but is the effect of cumulative economic policies. On this count certainly the Indian economy has come a long way. Though there is no cause for complacence, the dark clouds of war and inflation do have this silver lining.

The death of Dayos?

FAR FROM BECOMING FLAT, THE WORLD HAS BECOME **SCATTERED WITH NEW TRENCHES AND BARRIERS**

v conflict, protectionism, and regionalism, one wonders whether the cosmopolitan, globalised world of Davos is gone forever. Returning after a two-year pandemic hiatus, this year's World Economic Forum meeting in the Swiss Alps was a shadow of its former self.

In previous decades, the event was brimming with optimism. New peace agreements were forged, emerging markets were propelling themselves toward prosperity, and democracy was on the march. As the New York Times columnist Thomas L. Friedman famously put it, the world seemed increasingly "flat," with all the old hurdles to international interconnectivity disappearing.

It was all somewhat hyped, as was typical of that era. Few really believed that an earthly paradise was around the corner, or that history had really ended. But there was no denying that things were looking up, and that Davos was the place to go to pay homage to the spirit of the time. This year, the weather was grey and drizzly, and the talk was of war, sanctions, inflation, and supply shortages. The International Monetary Fund's managing director, Kristalina Georgieva, sought to reassure everyone that she does

> Pessimism certainly seems justified. With no end in sight to Russia's war on Ukraine, any engagement with the Russian economy or the Kremlin will remain off limits for most of the world - and certainly the West – for the foreseeable future China's trajectory, meanwhile, has become increasingly uncertain. My guess is that the country's leadership is feeling rather uneasy about President Xi Jinping's recent commitment to a "no limits' friendship with Russia, not to mention his "zero-COVID" strategy, which has locked down Shanghai - China's center of dynamism and exacerbated the country's

> mounting economic problems. But it is not all doom and gloom. The fight against COVID-19 has been a triumph for science and ultimately for the idea of an open global economy. Yes, the inequities in the distribution of vaccines, treatments, and tests will leave a stain on the international community's response; but the initial wave of trade restrictions and vaccine nationalism has given way to more cooperation. The past two years have underscored the value

ing supply chains.

The pandemic offers important lessons for managing future challenges, particularly climate change. While recent developments have injected some pessimism into the climate debate, there may yet be a silver lining. Rapidly rising oil and gas prices are creating powerful incentives to accelerate the transition to renewable and alternative energy sources. If science could deliver on vaccines, it should also be able to deliver on the climate challenge. Already, there is a growing awareness that the problem warrants urgent attention.

Even surveying the bleak political landscape, one can find the occasional bright spot. For example, Finland's and Sweden's applica $tions \, for \, NATO \, membership \, have \,$ renewed the alliance's credibility and relevance, and strengthened transatlantic relations. And the European Union, having exceeded its own expectations in marshaling support for Ukraine, is now emerging as a critical pillar in the European security order. While major challenges lie ahead, the EU now has a strong foundation on which to build.

More broadly, the democratic

united opposition to Russia. With Russia continuing to commit the international crime of aggression (as well as numerous atrocities), its support in the United Nations General Assembly has dwindled to just a handful of outlaw regimes.

Looking ahead, the critical international issue will be how to maintain global cooperation on global challenges. Russia will be out of the picture, but China will remain a key player alongside increasingly relevant countries like India. It remains to be seen what, if anything, will emerge from the ruins of the G20 this year. The creation of a new grouping with a more relevant membership would not be the worst outcome.

The old Davos glory days are certainly gone. Far from becoming flat, the world has become scattered with new trenches and barriers. But it is not all bad. The current (psychological) depression may be as unwarranted as was the previous ebullience. We should focus on being realistic and clear-eyed about the mounting global challenges we face. If we can manage to do that, we may yet prevail over them.

The plastic problem

Sir, The Centre's decision to impose a nationwide ban on single-use plastics from July 1 is a positive move in the right direction at a time when several countries have already done so. The move comes "to limit single-use plastic to enhance environmental sustainability." A total of 175 countries pledged 2 March this year to end the use of plastics by 2030. India was also a signatory to the promise, which was made at the United Nations Environment Assembly (UNEA) in Nairobi, Kenya. India is now banning 20 single-use plastic products. Single-use plastic has become an integral part of our lives that we often overlook its enormous negative consequences. Despite the fact that most of us only use single-use plastic for a few minutes at a time, it persists in our surroundings for years, degrades into microplastics, and pollutes the environment. This type of environmental hazard affects not only humans but also the entire ecosystem. These plastics are not properly disposed of frequently and hence are not recycled. Thus, single-use plastic has become a big issue in India in recent years. India is confident about the ban on single-use plastics and plans to phase them out by 2025. Meanwhile, there is an urgent need to find better alternatives to single-use plastic that are inexpensive, durable and readily available.



PMCARES SCHOLARSHIP SCHEME

Nearly 4K kids orphaned during Covid benefitted

New Delhi, May 30: Nearly 4,000 children who were orphaned during the Covid-19 pandemic have benefitted under a new PMCARES scholarship scheme, the social justice and empowerment ministry said Monday.

The new "Scholarship for PM-CARES Children" scheme under the ministry was formulated as a central sector scheme, it said.

Under the scheme, a scholarship allowance of ₹20,000 per child per annum would be given, which will comprise a monthly allowance of ₹1,000 and an annual academic allowance of ₹8,000 to cover the school fees, the cost of books. uniforms, shoes and other educational equipment, the ministry said in a statement.

The scholarship will be disbursed through direct benefit transfer to the children from Class



1 until they pass the Class-12 exam. The ministry said 3,945 children have benefitted under the scheme with an amount of ₹7.89 crore during 2022-23. Prime Minister Narendra Modi released the benefits under the PM-CARES for Children Scheme Monday.

79,669 pieces of fake ₹500 notes detected in FY22: RBI report

Mumbai, May 30: The number of fake currency note of ₹500 denomination detected by the banking system more than doubled to 79,669 pieces in the fiscal 2021-22 over the previous year, according to the RBI annual report.

The number of counterfeit notes of ₹2,000 denomination detected in the system was 13,604 pieces during 2021-22, up 54.6 per cent from the preceding financial year.

After declining in 2020-21, the total number of Fake Indian Currency Notes (FICNs) of all denominations detected in the banking sector increased to 2,30,971 pieces from 2,08,625 pieces in the previous fiscal. During 2019-29, the FICNs detected stood at 2.96,695 pieces

"Compared to the previous year, there was an increase of 16.4 per cent, 16.5 per cent, 11.7 per cent, 101.9 per cent and 54.6 per cent in the counterfeit notes detected in the denominations of ₹10, ₹20, ₹200, ₹500 (new design) and ₹2,000, respectively," said the RBI's annual report for 2021-22.

The counterfeit notes detected in the denominations of ₹50 and ₹100 declined by 28.7 per cent and 16.7 per cent, respectively.

During 2021-22, out of the total FICNs detected in the banking sector, 6.9 per cent were detected at the Reserve Bank and 93.1 per cent at other banks, the report said.

One of the major objectives of the 2016 demonetisation of the then prevailing ₹500 and ₹1,000 notes was to curb circulation of fake currency notes.

ED arrests Satyendar Jain

New Delhi, May 30: Delhi minister Satyendar Jain was arrested by the Enforcement Directorate (ED) on Monday in a money laundering case, with his Aam Aadmi Party (AAP) calling it a political move ahead of the Himachal Pradesh assembly polls.

He was taken into custody under criminal sections of the Prevention of Money Laundering Act (PMLA) after a few hours of questioning, ED officials said.

They alleged he was "evasive" in his replies. The minister is expected to be produced before a designated court Tuesday.

The arrest has been made by the federal agency in connection with alleged hawala dealings. Reacting sharply to the arrest, Delhi Deputy Chief Minister Manish Sisodia said Jain has been held in an eight-year-old "fake" case as he is the AAP's incharge for the Himachal Pradesh assembly elections and the BJP is afraid of losing the polls.

"A fake case has been going on against Satyendar Jain for eight years. He has been called by the ED several times so far. The ED had stopped calling him for some time because it did not find anything



started because he is the incharge of Himachal Pradesh elections.

Sisodia said in a tweet in Hindi. 'The BJP is afraid of losing the elections and hence he was arrested to prevent him from going to Himachal. He will be released soon as he has been arrested in a fake case." Sisodia added. Jain. 57. is the minister for health, industries, and water in the Arvind Kejriwal-

led government. The Himachal Pradesh assembly polls are slated for later this year and the AAP is looking to make inroads into the state after its stupendous victory in Punjab earlier this year. The ED had said last month that assets worth ₹4.81 crore of Jain's family and com-

panies "beneficially owned and controlled" by him were provisionally attached as part of a money laundering probe against him. In a statement issued then. the ED had said it issued a provisional order under the PMLA to "attach immovable properties worth ₹4.81 crore belonging to Akinchan Developers Pvt. Ltd., Indo Metal Impex Pvt Ltd, Paryas Infosolutions Pvt. Ltd., Manglayatan Projects Pvt. Ltd. J.J. Ideal Estate Pvt. Ltd., Swati Jain, wife of Vaibhav Jain, Sushila Jain, wife of Ajit Prasad Jain, and Indu Jain, wife of Sunil Jain.' The probe found that "during the period 2015-16, when Satyendar Kumar Jain was a public servant, the companies beneficially owned and controlled by him received accommodation entries to the tune of ₹4.81 crore from shell (paper) companies against cash transferred to Kolkata-based entry operators through the hawala route.' The named persons in the attachment order are associates and family members of Jain, officials said. The money laundering case against the AAP minister stems from an August 2017 FIR filed by the CBI against him and others on

Two die as heavy rain lashes Delhi

New Delhi, May 30: Two persons were killed and several injured as a fierce thunderstorm packing winds of up to 100 kmph and heavy rains battered the national capital Monday evening, uprooting hundreds of trees, disrupting road and air traffic and damaging vehicles and buildings, including the iconic Jama Masjid.

Police and fire brigade personnel responded to scores of rescue calls while commuters went through a harrowing time as they were caught in massive traffic jams in many areas, including Lutyens' Delhi, ITO, Kashmiri Gate, MB Road and Rajghat, caused by waterlogging and uprooting of trees.

This was the first storm of "severe" intensity in Delhi since 2018. a Met department official said. Delhi recorded 17.8 mm of rainfall till 5.30 pm, and the thunderstorm led to a drastic fall in the temperature at the Safdariung Observatory -- from 40 degrees Celsius at 4:20 pm to 25 degrees Celsius at 5:40 PM.

Curbing tobacco use will cut cancer cases by one-third: Experts

New Delhi, May 30: To combat the rising menace of cancer in India, curbing tobacco use is the best way, experts said Monday ahead of the World No Tobacco Day, observed every year May 31.

Tobacco is a prominent cause of heart disease, cardiovascular disease, lung disease and brain stroke. India has the world's highest incidence of tobacco-related cancer.

The number of Indians suffering from cancer is projected to increase to 29.8 million in 2025 from 26.7 million in 2021. revealed a recent report by the Indian Council for Medical Research.

According to Dr. Dinesh Pendharkar, Director, Sarvodaya Cancer Center at Sarvodaya Hospital, Faridabad, there are about 15 lakh new cases of cancer in India every year, but 40 per cent of these are caused by tobacco alone.

"If we want to combat the challenge of cancer, our focus should be on radically curbing the consumption of tobacco. This will prevent 5-7 lakh new tobacco-related cases of cancer every year, substantially reducing the cancer burden of the society," he said.

Tobacco contains nicotine and 4,000 other chemicals which cause cancer not only of the mouth and lungs, but also of food pipe, stomach and kidneys. The impact of

he use of tobacco in various forms such as gutka, zarda, mawa, kharra, khaini, cigarettes, bidi, and hookah is a major cause of tumour development in the oral cavity. It is directly associated with approximately 80 per cent of oral cancers in men and women

He noted that Indians are more vulnerable to tobacco-related cancers because it is easy to get addicted

to tobacco in the country. 'This is due to the widespread habit of chewing paan (betel nut), which quickly escalates to chewing tobacco. While there is a social taboo against smoking at a young age, no such inhibition exists for paan, which leads many youngsters to get addicted to tobacco at an early age," he said.

Experts also stated a surge in types of mouth cancer occurring on the lip, gums, tongue, the inner lining of the cheeks, the roof of the mouth, and floor of the mouth (under the tongue) in India due to tobacco usage. Widespread use of paan masala amongst the youth is also a major reason.

"I am now seeing cancer patients as young as 15-17 years who have been consuming tobacco in some form or the other,' Pendharkar said.

"Cases are not just rising in ২ rural areas, but in urban areas as well. Nowadays, there is a shocking trend seen wherein youngsters in the age group of 20-30 are affected with oral cancer," added Dr Suhas Aagre, Oncologist and-Hemato-Oncologist at Asian

Cancer Institute.

18 murders in 20 days: Chennai mirrors TN's rising crime graph

Chennai, May 30: Citing the recent killings in Chennai, former Tamil Nadu Chief Minister and Leader of Opposition K. Palaniswami, has said that the state capital is "turning into a murder city with 18 murders in 20 days". However, Greater Chennai City police commissioner, Shankar Jiwal refuted the claim, saying that only 10 murders took place in the city, and of them, four were due to personal enmity and six because of family disputes.

Palaniswami made the remark immediately after the killing of BJP's district leader, K. Balachander in Chennai's Chintadripet area, While the top police officer has all the right to defend his force, the killing of a small-time financier, Arumugham (36), on the busy Aminjikarai road in broad daylight was a shock. Four men chased the financier and hacked him to death.

The DMK government has assumed office in May 2021 with the promise that the police will be strict and would deal with the miscreants with an iron fist. However. with number of killings on rise in many parts of Tamil Nadu, the police force and the state administration seems to be on the receiving end.

On May 26, the day when the Prime Minister was arriving in the state, Lakshmanan, a 55-yearold priest, was hacked to death in Madurai by a three-member gang while he was on way to temple. This was another major blow for the Tamil Nadu Police, forcing the Director-General of Police (DGP) to intervene in the matter. Police acted swiftly and arrested the cul prits who were close relatives of the deceased priest.

Meanwhile, in another embarrassment for the state police, two al-

leged custodial deaths took place on April 19 and 26 in two separate incidents in Chennai and Myladuthurai. In Chennai, a Scheduled Caste youth Vignesh who was picked up by the police along with an accomplice Suresh on April 18 died on 19 in the police station. Autopsy revealed that Vignesh had 13 injuries including a broken right leg and bruises on the face, hands, shoulders, and chest. Sub-Inspector of Police and constables were arrested in the case.

Bangalore logs over 200 Covid cases after 88 days

Bangalore, May 30: For the first time in 88 days, Bangalore has reported more than 200 Covid-19 cases in just 24 hours, raising concerns among health authorities.

According to the Karnataka Health Department, the state capital registered a total of 232 cases, while the positivity rate has also increased to 1.20 per cent.

The last time Bangalore breached the 200 cases mark was on March 3 with 239 infections. Currently, there are 1,943 active Covid cases in the city and majority of them are being treated at home. There were no new containment zones declared in the last 24 hours. The city has five containment zones presently and a total of 12,930 Covid tests were conducted Sunday.

In the same period, the state registered a total of 241 new Covid cases. For the 11th consecutive day no deaths were reported

TN tribal hamlet deprived FARMER ESCAPES of power connection LEOPARD ATTACK

Chennai, May 30: The Erumaiparai tribal hamlet in Anamalai Tiger Reserve (ATR) is deprived of power connection and people are still in the dark when night sets in the settlement. The Tamil Nadu forest department has submitted applications to the Tamil Nadu Generation and Distribution (Tangedco) company for providing power to the tribal hamlet. The project has hit a roadblock after Tangedco demanded a payment of ₹6 lakh extra for insulated power lines.

A senior official of the Anamalai Tiger Reserve said, "The ATR had given a proposal to the Tangedco for providing power connection to 34 houses in Erumaiparai tribal hamlet. However, Tangedco is demanding ₹6 lakh extra for insulated cable wires and the project has hit a roadblock. This means we are depriving the most marginalised people of the society of power connection and are leaving them in the dark"

K. Murugadasan, member of the eco-development committee of ATR said, "Each family has deposited ₹3,500 for electricity connection six months ago. However. there is no information on the power connection and during rainy season solar panels don't work and our children are forced to study under kerosene lamps.'

According to guidelines of the Supreme Court, standing committee of National board for wildlife and the Union environment ministry, power transmission lines with insulated cables or underground cables must be used in protected areas to safeguard wildlife from being electrocuted. It may be noted that several elephants have died due to electrocution.

Forest officials said that the ATR officials have requested the Superintendent Engineer in Udumalpet to use insulated cables for Erumaiparai tribal hamlet. However, forest department officials told IANS that Tangedco had informed that only overhead cables with suitable guarding arrangements can be provided.

Tangedco has informed that to use insulated cables, ₹6 lakh has to be paid by the forest department and that the electricity department will immediately provide connection if the difference money is paid. It may be noted that several elephants had died due to electrocution by touching sagging overhead power transmission lines. ATR has requested Tangedco for a joint inspection on the sagging transmission cables and to rectify it, so that wild elephants do not touch the line and get electrocuted.



Centre aims to cut power output from 81 coal plants

India faced a crippling power crisis in April, when a rapid surge in power demand led to a scramble for coal, forcing the country to roll back plans to cut thermal coal imports to zero

New Delhi, May 30: India plans to reduce power generation from least 81 coal-fired utilities over the next four years, the federal power ministry said in a letter, in an effort to replace expensive thermal generation with cheaper green energy sources.

The plan aims to maximize green energy potential and save costs, the letter sent to top energy department officials of state and federal government said, but will not involve shutting down old and expensive power plants. India has 173 coal-fired plants.

'The thermal power plants in future shall operate up to the technical minimum to accommodate cheaper renewable energy when it is available," the ministry said in the letter dated May 26.

India faced a crippling power crisis in April, when a rapid surge in power demand lead to a scramble for coal, forcing the country to



roll back plans to cut thermal coal imports to zero.

An increase in peak power consumption during the night when solar power is not available has made phasing out coal-fired generation a big challenge. The addition of alternative sources such as nuclear and hydro power have also been slow.

India is the world's second largest consumer, producer and importer of coal, and the fuel accounts for nearly 75% of annual electricity generation. The world's third largest greenhouse gas emitter is currently 37% short of its end-2022 green energy target.

India's current power crisis could have been averted if its target to install 175 GW in renewable energy had been on track, think tank Climate Risk Horizons said in a report in May.

"The additional generation from solar and wind ... would have allowed power plants to conserve their dwindling coal stocks for evening peak periods," Climate Risk Horizons said.

The power ministry's plan to reduce coal-fired generation when renewable sources are available could also ease pressure on logistics. India's power crisis has been made worse

by a shortage of trains to move coal. India expects the plan to reduce power generation by 58 billion kilowatt hours (kWh) from the 81 utilities to save 34.7 million tonnes of coal and cut carbon emissions by 60.2 million tonnes, the letter said

The Central Electricity Authority of India (CEA) has predicted a peak power demand of 214 GW in August. In addition, the average energy demand could also increase to more than what it is in the month of May to 1,33,426 million units (MUs).

"The onset of the southwest monsoon will further hamper mining and transportation of coal from mines to power stations. If coal stocks are not replenished to adequate levels before monsoon, the country might be heading towards yet another power crisis in July-August 2022," CREA said.

Black ink thrown at Tikait; 3 nabbed

Bangalore, May 30: Miscreants Monday threw ink on farmer leader Rakesh Tikait during an event organised by a farmers' organisation at the Gandhi Bhavan here following which three people were arrested for the attack.

Soon after the incident, clashes took place between the organisers and the miscreants leading to both sides attacking each other with plastic chairs. The miscreants then allegedly shouted 'Modi-Modi'. The High Grounds police have arrested three people in this connection.

Karnataka Home Minister Araga Jnanendra said, "We are in touch with the officers. Three people have been arrested and are being interrogated. I denounce this act. Everyone has got the right to freedom of expression under the Constitution.

District Judge AK Vishvesh posted the matter for further hearing July 4. During the hearing Monday, the Muslim side argued against the maintainability of the plea, district government counsel Rana Sanjiv Singh said.

The counsel for the Hindu side Vishnu Shankar Jain told reporters that the court has categorically stated that the report on the videography survey of the complex will be made available to all the parties.



However, only the court will tell what will be the conditions for this. he said. The Muslim side has argued that the plea is not maintainable as the Places of Worship Act 1991 prohibits conversion of any place of worship and mandates the maintenance of the religious character of any place of worship as it existed August 15, 1947.

After the plea was filed, a lower court had ordered a videographic survey of the Gyanvapi complex, and the Hindu side had claimed a 'Shivling' was found during the exercise. On May 20, the Supreme Court had transferred the case from a civil judge (senior division) to a district judge, saying looking at the "complexities" and "sensitivity" of the issue, it is better if a senior judicial officer with an experience of over 25-30 years handles

DGCA slaps ₹10L fine on Spicejet

New Delhi, May 30: The aviation regulator DGCA has imposed a fine of ₹10 lakh on SpiceJet for_ training its Boeing 737 Max aircraft's pilots on a faulty simulator as it could have adversely impacted flight safety, sources said Monday.

Aviation (DGCA) had last month barred 90 SpiceJet pilots from operating the Max aircraft after it found them being trained on a simulator that had its stick shaker on the co-pilot's side inoperative.

Stick shaker warns pilots whenever it detects that the plane has stalled mid-air.

After barring the pilots, the regulator issued a show-cause notice to the airline in April, the sources told PTI. The response sent by the airline was not found satisfactory. they mentioned.

Bimal Gurung hospitalised

Gangtok/Darjeeling: GJM supremo Bimal Gurung has officially ended his 100-hour hunger strike after he has been hospitalised following a deterioration of his health while his party has decided not to contest the upcoming GTA elections. Gurung, who was staging an indefinite hunger strike at his party's Singamari office in Darjeeling town since May 25 demanding the deferment of the June 26 Gorkhaland Territorial Administration (GTA) polls and expansion of the semi-autonomous council's jurisdiction, fell ill Sunday and was admitted to a hospital in the hill town in West Bengal.

It seems not in Gujarat, for despite the 'seismic' faults brought to light by a vigilant judiciary there has hardly been any noticeable action, the high mortality figures, notwithstanding

the Covid pandemic?

Though fearful of the likely fall-out of the large-scale mishandling of the pandemic and it's fall-out on the elections due in Gujarat this year, the BJP top brass (read PM Modi) removed Chief Minister Vijay Rupani and his entire cabinet and brought in little known Bhupendra Patel as replacement with a laundry fresh cabinet. This was, however done, more to tide over the anti-incumbency than with a genuine desire to fix both lacunae and responsibility and bring the guilty to book in a state where the pandemic had consumed over a lakh of people.

Whether it was the Rupani government which was in power from August 2016 to September 2021 or

Bhupendra Patel who replaced him as Chief Minister thereafter, the Gujarat government adamantly stuck to the figure of 10,094 (10,164 as of January 17,2022) Covid related deaths in the state.

The shroud however lifted when, in details placed before the Supreme Court, the Gujarat government had to admit that till February 3, 2022 it has received 1,02,230 Covid death claims, approved 87,045 and disbursed the compensation amount of ₹50,000 to 82,605 families while rejecting 8994 applications with 6000 applications still under scrutiny. The figure for children orphaned in Gujarat due to the pandemic at the time of the submission was 5867 with compensation being paid in 3287 of these cases

Further proof, if needed, came March 9 when the Gujarat government made an additional provision of ₹585 crore for providing compensation to the next of kin of Covid-19 victims as per the apex court guidelines. By rough calculations the government was provisioning for a total compensation payment to 1.17 lakh people.

Hauled over the coals following the disclosure, the state government explained away the discrepancy in

figures due to the Supreme Court amending the definition of coronavirus deaths last vear

One of the legacies handed down by the 13 years of Modi's chief ministerial stint to his successors has been a marked tendency towards opacity in information sharing. This was most noticeable in Gujarat when government agencies moved every sinew in their system to thwart data collection of Covid death victims by media persons. Obviously the state was hiding a mountain of data as the figures of Covid-19 deaths in Gujarat has risen ten times over followed by Telangana with eight times.

It is the Supreme Court which has proved the saviour of the next of the kin of Covid victims. The Centre initially sought to wash its hands off the affair. When the Supreme Court insisted that compensation will have to be paid and the Centre may decide the quantum that it came up with a figure of ₹50,000 to be paid by the states.

It is not merely the Supreme Court which took up cudgels on behalf of a harassed population left to battle a killer virus, the Gujarat High Court also tried hard to stir a somnolent Rupani government into action, but apparently in vain.

When the first Covid wave hit Gujarat in 2020, it's High Court, had suo motu initiated a PIL .It had strong words to say for the Rupani government's handling of the pandemic. In an order May 23, 2020, it had termed conditions at the Government Civil Hospital in Ahmedabad where 377 Covid-19 patients had died by then as 'pathetic'. "The hospital is as good as a dungeon, may be even worse. a division bench of Justice JB Pardiwala and Justice IJ Vora had observed as it issued a host of directions to the state government. "Does the health minister of the state have any idea about the problems which patients, doctors, nursing staff and other employees are facing? How many times has the concerned minister interacted with medicos and staff on the spot to understand their difficulties,' the order questioned. A year later, it was again the High Court which

rallied to the help of the citizenry. Just about an year later, April 11, 2021, the High Court, this time the Chief Justice Vikram Nath took suo motu cognizance and initiated a PIL observing that media reports indicated that the "state is heading towards a health emergency of sorts" and also that there was an uncontrolled upsurge and serious management issued in

Covid-19 control. On April 16, 2021, in an order, the division bench of Chief Justice Vikram Nath and Justice Bhargay Karia had asked the state government to release the actual figures of death of Covid-19 patients and those who died with co-morbid conditions. "Suppression and concealment of accurate data would generate more serious problems including fear, loss of trust and panic amongst public at large," it had pointed out.

If the judiciary was straining every nerve, the executive's response seemed tepid, even when the highest court of the land was concerned. The Supreme Court, through an order of October 4, 2021 ordered disbursal of ₹50,000 compensation to the next of kin of Covid-19 victims with directions for disbursing the amount

within 30 days. "No state government will deny the benefit on the ground that the cause of death on the death certificate is not Covid-19 and the district authorities should take remedial measures to get the cause of death correct," ruled the Supreme Court.

A word for the wise should be enough but the Gujarat government response stumped enough to make lawyer Amit Panchal approach the Supreme Court to point out that the state had April 29 issued a notification appointing a committee to certify the claims.

The apex court sought to simplify procedures through setting up of district committees to address grievances of compensation seeking families. The Guiarat government found its own interpretation and used this window to appoint a scrutiny committee to award compensation. Apparently, taking advantage of the court order to simplify procedures, the government had gone ahead and appointed a scrutiny panel of its own to award compensation eliciting an angry reaction from the apex court and forcing the Gujarat government to retreat. There is accountability in war crimes, what about 'mass deaths' in peace times?

Beijing man sends 5,000 into quarantine

Beijing, May 30: A man in Beijing is under criminal probe after he skipped out on mandated Covid-19 home isolation, prompting authorities to send his more than 5,000 neighbours into home or government quarantine, officials said Monday.

The actions by the man, who later tested positive, come as the Chinese capital and Shanghai begin to ease restrictions, the Guardian reported. According to the officials, the man, in his early 40s, had been told to isolate at home after he entered a shopping plaza deemed a risk area on May 23

They alleged that during his period of isolation he "went out many times, and moved in the community, risking the spread of the epidemic", before he and his wife tested positive five days later, the Guardian reported. In response, authorities ordered 258 people who lived in his building to go to government quarantine centre, and the more than 5,000 others who lived in the residential community to stay at home.

China has imposed harsh curbs on its population as it works to eliminate outbreaks of the highly transmissible Omicron variant of Covid-19. China's zero-Covid policy has

come under criticism for its significant negative impact on the economy and people, particularly in Shanghai, but President Xi Jinping has doubled down on demands that it continue, and succeed, the Guardian reported.

Colombo, May 30: The World Bank is planning to disburse USD 700 million to crisis-ridden Sri Lanka by re-purposing its existing loans. a move that will help the island nation grappling with an unprecedented economic crisis much-needed breathing space till a bailout package with the IMF is worked out, media reports said Monday.

Sri Lanka is nearing bankruptcy and has severe shortages of essentials from food, fuel, medicines and cooking gas. For months, citizens have been forced to stay in long lines to buy the limited stocks.

The World Bank Country Manager Chiyo Kanda met Sri Lankan Foreign Minister last week and assured him that the agency will work with the Asian Development Bank (ADB), Asian Infrastructure Investment Bank (AIIB) and the UN office to "repurpose their already committed projects," news portal Colombo Gazette reported.

"Minister Peiris sought assistance from the World Bank until long term assistance materialises through the IMF, other international institutions and donor countries," the report said, quoting a statement from Sri Lanka's Foreign Ministry.

Monkeypox won't turn into pandemic: WHO

London, May 30: The World Health Organisation's top monkeypox expert said she doesn't expect the hundreds of cases reported to date to turn into another pandemic, but acknowledged there are still many unknowns about the disease, including how exactly it's spreading and whether the suspension of mass smallpox immunisation decades ago may somehow be speed ing its transmission.

In a public session Monday, WHO's Dr. Rosamund Lewis said it was critical to emphasise that the vast majority of cases being seen in dozens of countries globally are in gay, bisexual or men who have sex with men, so that scientists can further study the issue and for populations at risk to take precautions.

"It's very important to describe this because it appears to be an increase in a mode of transmission that may have been under-recognized in the past," said Lewis, WHO's technical lead on monkeypox.

Still, she warned that anyone is at potential risk of the disease, regardless of their sexual orientation. Other experts have pointed out that it may be accidental that the disease was first picked up in gay and bisexual men, saying it could



quickly spill over into other groups if it is not curbed.

Lewis said it's unknown whether monkeypox is being transmitted by sex or just the close contact between people engaging in sexual activity and described the threat to the general population as "low."

"It is not yet known whether this virus is exploiting a new mode of transmission, but what is clear is that it continues to exploit its wellknown mode of transmission, which is close, physical contact," Lewis said.

Monkeypox is known to spread when there is close physical con-

tact with an infected person or their clothing or bedsheets. She also warned that among the current cases, there is a higher proportion of people with fewer lesions that are more concentrated in the genital region and sometimes nearly impossible to see.

'You may have these lesions for two to four weeks (and) they may not be visible to others, but you may still be infectious," she said. Last week, a top adviser to WHO said the outbreak in Europe, US, Israel, Australia and beyond was likely linked to sex at two recent raves in Spain and Belgium.

That marks a significant departure from the disease's typical pattern of spread in central and western Africa, where people are mainly infected by animals like wild rodents and primates, and epidemics haven't spilled across borders.

China's maternal, infant mortality rates drop

rates of infants and children under five have decreased to 5 per thousand and 7.1 per thousand, respectively, both dropping to a record low, reports Xinhua news agency quoted Song as saying. Compared to 10 years ago, ma-

ternal mortality rate, the mortality rates of infants and children under five have dropped by 38 per cent, 58 per cent and 54 per cent, respectively, according to the Commission


Song noted that the country has made notable achievements in building healthcare mechanisms for women and children, improving

New Delhi, May 30: India has received requests for the supply of more than 1.5 million tonne (MT) of wheat from several countries that need the staple to overcome shortages triggered by the invasion of Ukraine by Russia, trade and government sources said Monday.

"More than half a dozen countries have approached India for more than 1.5 million tonne of wheat and we will see how to go about these requests," said a government official who didn't wish to be identified in line with official rules.

'India is keen to help vulnerable countries and anyone who needs wheat," said the official involved in decision making.

The bulk of the request has come from Bangladesh, a regular buyer of Indian wheat, the sources said. India, which has banned private wheat exports, is open to specific requests for grain from foreign governments.

For Bangladesh, Indian wheat is at least 30% cheaper than supplies from other origins, and it takes

Norms tightened to check wheat export through fake papers

NEW DELHI: The Commerce Ministry Monday further tightened the norms for obtaining registration certificates for wheat exports with a view to curbing fraudulent practices such as submission of improper documents by scrupulous traders. On May 19, the DGFT issued guidelines to all its regional authorities (RAs) for strict compliance before issuance of Registration Certificates (RCs) to the eligible exporters. These instructions, by the Directorate General of Foreign Trade (DGFT), are being issued as it has received information from sources that fraudulent back dated L/C showing date of issuance as on or prior to May 13, 2022, are being submitted by some unscrupulous exporters for issue of RCs. The government is allowing wheat shipments for which irrevocable letters of credit (LoC) were issued on or before May 13, when the ban of the export of the food grain was imposed. In a trade notice, the DGFT said that in spite of these steps and due diligence exercised by RAs in the process, it has been apprehended that some of the exporters are applying for RCs based on "improper documents", so more checks are needed to be put in

"Countries which have prohibited, they can't succuss unless there is a global consensus around that. There has to be a broad framework of participation. Digital assets, whatever way we want to deal with those assets, there has to be a broad framework on which all economies have to be together. No country can choose to either of the position. We need a global consensus on crypto regulation," he said.

Mumbai, May 30: Domestic ratings agency India Ratings Monday said the GST has not helped states achieve the key objective of boosting their tax revenue.

The rating agency said that the data does not point to any benefits to the states in the last five years since the implementation of GST (Goods and Services Tax).

..The data available so far does not instill confidence with respect (of) GST achieving or is on course to achieve its two key objectives, namely it boosts the tax revenue and is beneficial for the consuming states," the rating agency said. The share of state GST (SGST)

in States' Own Tax Revenue (SOTR)

at 55.4 per cent during FY18-FY21

compared 55.2 per cent during FY14-FY17 indicates that the growth in both SGST and non-SGST com-

ponents of SOTR has been broadly similar, it said. "This means the GST implementation did not result in any incremental benefit to the SOTR.

Moreover, SGST growth at an av-

erage 6.7 per cent during FY18-FY21 has been lower than the 9.8 per cent growth recorded by the taxes subsumed under GST during FY14-FY17," it added



The agency said another way of assessing the GST performance of states is to examine the SGST growth during FY19-FY22, and pointed out that Odisha is the only state having average SGST collection exceeding 14 per cent with a 20.06 per cent growth in SGST between FY19-22, and is followed by Bihar (13.89 per cent), Assam, Andhra Pradesh and Chhattisgarh.

A total of 17 major states recorded average SGST growth of below 10 per cent, while Uttarakhand recorded negative average SGSTgrowth of 4.02 per cent during FY19-FY22.

Ahmedabad, May 30: Five-time IPL winner Hardik Pandya Sunday said his latest triumph, while leading first-timers Gujarat Titans, is something the coming generations will talk about.

Hardik's team capped off a dream campaign in its maiden season by lifting the Indian Premier League title with a seven-wicket win over Rajasthan Royals in the final here.

'This title is going to be a special one because we talked about creating a legacy. The coming generations will talk about it," Hardik said. "Everyone will remember this was the team who started this journey and to win the championship first year is very special."

The Gujarat Titans' triumphant skipper said he knew he was going to bat at number four for the firsttimers after they got done with the mega auction ahead of IPL-15. "When the auction finished I knew I would have to bat at No.4," Hardik said at the presentation ceremony.

Hardik has won four IPL titles with Mumbai Indians. Gujarat's highly-rated bowling attack, led by skipper Hardik (3/17) himself, limited a formidable Rajasthan Royals batting unit to 130/9 after losing the toss.

Asked about his bowling, he said, "Wanted to show at the right time what I've worked hard for. Today was the day from the bowling point of view I saved the best for the best.

"Second ball of my spell when I got Sanju (Samson) out, saw that if you hit the wicket hard and hit the seam something is gonna (going to) happen. It's all about sticking to the right lengths, asking the batters to play the right shots."

Hardik, known for his big-hitting abilities, curbed his attacking instinct to some extend during the tournament, focussing more on guiding his team with his calm and composed leadership.

"For me my team is the most important. I've always been that kind of individual. If I were to have a worse season and my team wins, I'll take that. I will take the trophy any day over striking at 160. My team comes first for me."

Speaking about his batting, he said, "Batting comes first to me, always going to be close to my heart. Hardik has enjoyed a splendid run in his fresh IPL season with his home franchise. In 14 innings, he has scored nearly 500 runs at an average of 45.30 while also picking up plenty of wickets, which has earned him praise from many quarters.

Player of the Tournament, Jos Buttler, for amassing 863 runs, said he has "exceeded all my expectations apart from today"



Jakarta, May 30: Defending champions India would look for an outright win against South Korea in their final Super 4 round-robin league match to book their place in the final of the Asia Cup men's hockey tournament here Tuesday. India had almost clinched a spot
