Boy rescued from well after 100 hrs



RAIPUR: Rahul Sahu, the hearing and speech-impaired kid who had fallen into an abandoned borewell at Pihrid village in Chhattisgarh's Janjgir-Champa district Friday was rescued few minutes before midnight Tuesday. Teams from the National Disaster Response Force (NDRF), Indian Army, local police and state disaster response force (SDRF), battled for more than 100 hours, to rescue the 11-yearold Rahul. Immediately after Rahul was brought out, officials said that the kid was breathing but not showing any discernible movement. He was immediately rushed to a hospital in Bilaspur for treatment. Chhattisgarh CM Bhupesh Baghel had been personally monitoring the rescue operations.

Woman, son found dead in Keonjhar





Puri, June 14: It was a momentous and memorable occasion for thousands of devotees Tuesday when they got the opportunity to witness the Snana Yatra – the grand bathing of Lord Balabhadra, Devi Subhadra, Lord Jagannath and Lord Sudarshan – after a gap of two years. No doubt they were excited as the rituals began.

The rituals are conducted on the full moon day of 'Jyestha' (mid May-mid June). Over two lakh devotees have al-

ready assembled in the pilgrim town to witness the bathing rituals, an official of the Shree Jagannath Temple Administration (SJTA) had earlier said.

The 'Pahandi' ritual of the deities began at around 4.00am as servitors took the Trinity and Lord Sudarshan to the 'Snana Mandap' in a ceremonial procession. Lord Sudarshan was the first to be placed at the 'Snana Mandap', followed by Lord Balabhadra, Goddess Subhadra and Lord Jagannath. The Pahandi concluded at around 6.00am

As per rituals, the deities were

bathed with 108 pitchers of aromatic water by a group of servitors. The water was drawn from Suna Kua (golden well) situated inside Srimandir precincts. Then the servitors added herbal and aromatic essence to the water before performing what is known as 'Jalabhishek'.

The servitors first bathed Lord Jagannath with 35 pots of water, Lord Balabhadra was showered with 33 pots, Devi Subhadra with 22 pots while Lord Sudarshan took

bath with 18 pots of water. Devotees believe that a glimpse of the deities on this day will help them get rid of all their sins. Some even observe this festival as the birthday of Lord Jagannath.

After the bathing rituals, the Srimandir deities were adorned with 'Hati Besha' (elephant headgear, representing a form of Lord

As it is believed that the deities catch cold and develop fever after the ritualistic bath, they were then taken to 'Anasara Ghara' (an asylum for the sick) where they will remain ensconced for the next 15 days. This period is known as 'Anasara'. The deities will again give darshan to the public with reiuvenated vouth hood, a ritual called 'Nabajouban Darshan', a day before the Rath Yatra festival, which falls July 1 this year.

Elaborate security arrangements were made to control the huge turnout that was present to witness the Snana Yatra. A total of 52 platoons of police force, three commandants, 11 deputy commandants or ASPs, 21 DSPs, 50 inspectors, 270 Sis/ASIs, 1,000 constables and home guards were deployed to maintain law and order.

Ex-judges, lawyers slam UP govt over demolitions, arrests

The complainants in the letter to the CJI have asked the Supreme Court to intervene to prevent a mockery of the Constitution

New Delhi, June 14: Former judges and senior advocates have written to Chief Justice of India (CJI) NV Ramana urging him to take suo motu cognizance of incidents of illegal detention, bulldozing of residences, and police action on protestors agitating against certain objectionable remarks made by BJP spokespersons, especially in UP.

The letter signed by them said, 'the letter petition is being presented as an urgent appeal to the Supreme Court of India to take cognizance of the recent incidents of violence and repression by state authorities on citizens' of Uttar Pradesh.

The letter petition has been signed by former judges of the top court, Justices B Sudarshan Reddy, V Gopala Gowda, and AK Ganguly, former Chief Justice of Delhi High Court AP Shah, former judge of Madras High Court Justice K Chandru, and former Karantaka HC judge Mohammed Anwar.

Among the senior lawyers who have signed the letter include advocates Shanti Bhushan, Indira Jaising, CU Singh, Sriram Panchu, Prashant Bhushan and Anand Grover.

The letter said that, instead of giving protestors an opportunity of being heard and engaging in



peaceful protests, the UP state administration appears to have sanctioned taking violent action against such individuals. The chief minister has reportedly officially exhorted officials to take such action against those guilty that it sets an example and no one commits a crime or take the law into their hands in future.

'The UP CM has further directed that the National Security Act, 1980, and the Uttar Pradesh Gangsters and Anti-Social Activities (Prevention) Act, 1986, be invoked against those found guilty of unlawful protests. It is these remarks that have emboldened the police to brutally and unlawfully torture protestors," the letter petition added.

"Pursuant to this, the UP police have arrested more than 300 persons. Videos of young men in police custody being beaten with lathis, houses of protestors being demolished without notice or any cause of action, and protestors from the minority Muslim community being chased and beaten by police, are circulating on social media shaking the conscience of the nation," the letter pointed out.

Mamata, CPI(M) fail to convince Pawar

Sources said that the NCP chief is not keen to contest as he doesn't want to lose at his age

New Delhi, June 14: West Bengal Chief Minister Mamata Banerjee and Left leaders including general secretary met NCP chief Sharad Pawar separately here Tuesday. They tried to convince the veteran leader to be the joint opposition nominee for the presidential election.

Pawar, however, refused, CPI(M) general secretary Sitaram Yechury said after his meeting with him. Other than Yechury, Pawar also met CPI general secretary D Raia and NCP leaders Praful Patel and PC Chacko here and conveyed to them his decision to not contest the election.

"I have been informed that Pawar will not be the opposition face for the presidential poll. Now we will have to think about other names,'

Yechury said. Banerjee is in Delhi for a meeting of non-BJP parties she has convened to formulate a joint strategy for the upcoming presidential poll. She however, refused to make any comments after her meeting with Pawar.

BJD non-committal

New Delhi: The BJD remained non-committal whether it the party would participate in the meeting called by West Bengal CM Mamata Banerjee regarding the presidential polls. Banneriee had written to BJD supremo Naveen Patnaik on this issue. The meeting is scheduled to take place Wednesday. According to a senior BJD leader, the party hasn't held any discussion on the invitation sent by Baneriee.

The NCP meanwhile said that at no point, Pawar was keen to contest the presidential polls. A senior party leader said that Pawar still wants to **TAL POLLS** be a part of national politics,

Pawar is not keen to keep himself confined to the Rashtrapati Bhavan. "But, I don't think he is keen on it (contesting polls). Saheb (Pawar) is a people's man. He will not restrict himself to the Rashtrapati Bhavan. His main target is to bring together the opposition for the 2024 Lok Sabha elec-

Jumbo deaths continue unabated

Athagarh/Dhenkanal June 14: There is no let-up in jumbo deaths in the state as two elephants died in quick succession in separate incidents in Narasinghpur of Cuttack district and in Kapilas zoo in Dhenkanal district, Tuesday.

In the first case a tusker that was battling for life for eight days near a rivulet at Jaipur jungle under Narasinghapur range and Athagarh forest division in Cuttack district after being shot at by poachers succumbed to its injuries. This was stated in Athagarh by ranger Prafulla Kumar Dehuri.

Veterinarians from Satkosia Tiger Reserve, Nandankanan Zoological Park and OUAT were treating the ailing pachyderm inside the forest. However, their efforts to revive it failed as the animal stopped eating for the last couple of days.



Officials said that the tusker had six bullet injuries and had developed septicaemia on its right leg.

In the second case, a newborn jumbo calf which had been rehabilitated at the elephant rescue centre of Kapilas zoo following its rescue from Kunua area under Hindol forest range died while undergoing treatment, Tuesday afternoon. The

calf died despite forest officials and veterinarians putting their best efforts for its revival.

Reports said that an elephant herd had strayed into Sabarsahi of Kunua village June 11 when a female elephant gave birth to the calf. However, the female elephant abandoned the calf after the delivery and went back to the jungle.

Centre clears 'Agnipath' for Armed Forces

Now short-time contracts of 4 years will be offered to the new recruits that may be made permanent depending on the requirement of the Armed Forces

New Delhi, June 14: The government Tuesday unveiled a 'transformative' scheme called 'Agnipath' for the recruitment of soldiers into the Army, the Navy and the Air Force largely on a short-term contractual basis with an aim to cut the ballooning salary and pension bills and enable a youthful profile of the Armed Forces

Defence Minister Rajnath Singh provided details of the new initiative at a media briefing shortly after the Prime Minister-led Cabinet Committee on Security approved the scheme which the government said would allow 'patriotic and motivated' youth to serve in the Armed Forces for a period of four years.

"Under the 'Agneepath' scheme, Indian youth will be provided an opportunity to serve in the Armed Forces as 'Agniveer'. This scheme has been brought to strengthen the security of the country. It is a transformative scheme," Singh said in the presence of the three Armed Forces chiefs at a press conference here Tuesday.

Describing it a major defence policy reform to usher in a 'new era' in the human resource policy of the three services, the Defence Ministry said the scheme comes into immediate effect. It also said the Armed Forces will recruit 46,000 'Agniveers' in 2022

The monthly salary of an

'Agniveer' in the first year would be ₹30,000 and the in-hand amount would be ₹21,000 as ₹9,000 would go to a corpus with an equal contribution of the government. Subsequently, the monthly salary in the second, third and fourth year will be ₹33,000, ₹36,500 and ₹40,000 respectively. Each 'Agniveer' will get an amount of ₹11.71 lakhas 'Seva Nidhi Package' and it will be exempted from income tax.





Drones may soon monitor mining ops

Bhubaneswar, June 14: The state government is planning to use drone and remote sensing technology in mining operations to ensure better governance and transparency in the sector.

The Steel & Mines department of the state government has floated a tender to hire an agency for development and implementation of an intelligent drone platform in Odisha, sources said.

The platform will analyse dronecaptured data pertaining to the various operations and compliance aspects of the mining lessees and report the same in relevant visual format. The platform will be integrated with the current i3MS (Integrated Mines and Mineral



Management System). Besides, it would become a part of the existing IT ecosystem, sources added.

Through the drone system, the government can do boundary inspection, land use pattern assessment, production pit status check. stockpile detection and volume calculations, sources informed.

he Steel & Mines department has floated a tender to hire an agency for development and implementation of an intelligent drone platform in Odisha

The platform will analyse drone-captured data pertaining to the various operations and compliance aspects of the mining lessees and report the same in relevant visual

Through the drone system, the government can do boundary inspection, land use pattern assessment, production pit status check, stockpile detection and volume calculations

"Drones are mini pilotless aircraft operated by remote control and devices like a smartphone app. These unmanned vehicles require far less effort, time and energy, and can reach far and difficult terrains while being controlled by a single person remotely," said an official.

For real time monitoring of the mining activities, the state government has already introduced Integrated Mines and Mineral Management System which has been replicated by many states.

Apart from using information technology (IT) in a greater way, the state has successfully implemented all the amended provisions of the Mines and Minerals (Development and Regulation) Act which has led to auctioning of the highest numbers of mines in the country.

curred owing to rituals at mutts and temples are met from temple incomes. Importantly, thousands of acres of land belonging to mutts and temples are under illegal occupation. The deities are soon going to be landless while their rituals and niti bhogas have been disrupted for fund crunch, they said.

Servitors are deprived of their remunerations. The officials are cringing back to reclaim the landed properties of the deities.

They alleged that the deities have always been neglected by the Endowment department.

"Poor budgetary allocation makes it difficult to meet the daily needs of the deities. Despite several requests, remuneration of servitors is yet to be revised,"

Bhubaneswar, June 14: Donating blood regularly goes a long way lowering the risk of a heart attack, said Kalinga Institute of Medical Sciences (KIMS) Blood Centre head Sukanta Tripathy on the occasion of World Blood Donor Day, Tuesday.

Tripathy appealed to the people to come forward and donate blood as there is a pressing need to increase the voluntary donor base in Odisha. "Even if only one per cent of the population donates, there will be no scarcity for blood," he underlined.

As many as 4,87,022 units of blood were collected in 2021. Out of it, 3,25,139 units—66.76 per cent were donated from voluntary donors and the rest were by replacement donors, he said.

"We need to create greater awareness among the people to come in more numbers and voluntarily donate blood to meet the increasing demand. This act of charity will not only give you a sense of pride but also help you maintain a healthy

life." added Tripathy. Regular blood donation is linked to lower risk of heart attack, maintaining normal blood pressure and iron level. "A donor can also keep the cholesterol level under control as well. And above all, the donor also gets the benefit of free check-up before blood donation," Tripathy said listing out the advantages of blood

The KIMS Blood Centre, rechristened as the Department of Transfusion Medicine, began its operations in 2006. In 2020, it got the nod to operate the Apheresis machine, added Tripathy.

Human brains are hotter than thought, particularly women's: Study

verage human brain temperature is 38.5 degrees Celsius, with deeper brain regions often exceeding 40 degrees Celsius, particularly in women during the daytime, finds a study.

Normal human brain temperature varies much more than previously thought, and this could be a sign of healthy brain function, said researchers at the Medical Research Council (MRC) Laboratory for Molecular Biology, in the UK who produced the first 4D map of


healthy human brain temperature. The map overturns several previous assumptions and shows the remarkable extent to which brain temperature varies by brain region, age, sex, and time of day. Importantly, these findings also challenge a widely held belief that human brain and body temperature

are the same.

The research, published in the journal Brain, also included analysis of data from patients with traumatic brain injury, showing that the presence of daily brain temperature cycles strongly correlates with survival. These findings could be used to improve understanding, prognosis, and treatment of brain

"To me, the most surprising finding from our study is that the healthy human brain can reach temperatures that would be diagnosed as fever anywhere else in the body. Such high temperatures have been measured in people with brain injuries in the past, but had been assumed to result from the injury," said Dr. John O'Neill, Group Leader at the MRC Lab.

To study the healthy brain, the



researchers recruited 40 volunteers, aged 20-40 years, to be scanned in the morning, afternoon, and late evening over one day.

In healthy participants, the average brain temperature was 38.5 degrees Celsius, more than two degrees warmer than that measured under the tongue. The study also found that brain temperature varied depending on: time of day, brain region, sex and menstrual cycle, and age.

While the brain surface was generally cooler, deeper brain structures were frequently warmer than 40 degrees Celsius; with the highest observed brain temperature being 40.9 degrees Celsius.

Across all individuals, brain temperature showed consistent time-of-day variation by nearly 1 degrees Celsius, with highest brain temperatures observed in the afternoon, and the lowest at night.

"We found that brain temperature drops at night before you go to sleep and rises during the day. There is good reason to believe this daily variation is associated with long-term brain health a' something we hope to investigate next," O'Neill said.

On average, female brains were around 0.4 degrees Celsius warmer

than male brains. This sex difference was most likely driven by the menstrual cycle, since most females were scanned in the postovulation phase of their cycle, and their brain temperature was around 0.4 degrees Celsius warmer than that of females scanned in their pre-

The results also showed that brain temperature increased with age over the 20-year range of the participants, most notably in deep brain regions, where the average increase was 0.6 degrees Celsius.

The researchers propose that the brain's capacity to cool down may deteriorate with age and further work is needed to investigate whether it is linked with the development of age-related brain dis-

Riddled with scams, **Lower Suktel in limbo**

Following several controversies and opposition, the project work has resumed after the state government and senior administrators intervened

Bolangir, June 14: Controversies continue to plague Lower Suktel Irrigation Project which is termed as the lifeline of farmers and residents of Bolangir district, a report said.

Over 20 years have passed since the work for the project began but it is yet to get completed. Meanwhile, after several controversies and objections, the project work has resumed after the state government and senior administrators

The fresh deadline of the project is March 2023. In its bid to meet the deadline, the consultancy agency is now hastily carrying out the dam work and other miscellaneous

The initial outlay for the project was ₹217 crore but it has now reached a staggering ₹4.000 crore. It is alleged that engineers have splurged money under the cover of senior administrators without actually doing any work during last 20 years. Nobody is mustering courage to oppose them as they

enjoy the patronage of senior ad-

Moreover, locals have alleged that substandard soil is being used in construction of the embankment, raising questions about the durability of the dyke. They have alleged that the consultancy agency is not using the soil tested for the purpose but laying soil on the embankment by lifting it from other sites. Locals have alleged that the engineers are encouraging such a move to complete the work within the fresh deadline.

In the meantime, 90 per cent of the spillway work and 70 per cent of the soil embankment work have been completed. Reports said the initial outlay was only ₹217.13 crore when it received administrative approval in 1999.

Chief Minister Naveen Patnaik laid the foundation stone for the project in November 2001 which was planned for completion by

to make any headway due to stiff opposition from the residents of likely submerged areas.

People intensified their agitation after they noticed severe irregularities in the social survey conducted for the project. The proj ect got mired in controversy after they found illegal purchase of land for outside people other than the project affected.

The project work got stalled and resumed after the district administration started distributing compensation for rehabilitation of the

However, within a few days, irregularities of ₹100 crore and fund embezzlement again pushed the project to the backburner. Preliminary inquiries indicated involvement of some senior officers, engineers and zone officers in the irregularities. As a result, the project work failed to get completed

Later, the anti-project agitation got intensified following which the project work again came to a halt and the fate of the project was pushed into uncertainty. The work resumed after the pro-project people launched an agitation in 2012-2013. However, the project supporters started opposing the project after they found some engineers and officers cheating them and misappropriating the funds sanctioned in their names. During this period, the engineers also neglected the work and failed to complete the construction of Lower Suktel Rehabilitation Colony

Meanwhile, works for construction of the colony has started under the direct supervision of Bolangir Collector Chanchal Rana.

BeMC's rainwater harvesting projects still a pipedream

Berhampur; June 14: The Berhampur Municipal Corporation's (BeMC) ambitious plan for construction of 2,000 rainwater harvesting projects in the Silk city here is set to miss the deadline as works for only 20 to 30 projects are in progress, a report said.

The plan is aimed at addressing the depleting water table in the city amidst growing drinking water crisis. The structures are constructed in open spaces or on rooftops under the state sponsored Mukhyamantri Karma Tatpara Abhiyan that would help create ecologically sustainable and climate resilient community assets.

However, with works moving at snail's pace and the SHGs only working on 20 to 30 projects, the civic body is set to miss the deadline. Reports said that not a single project has been completed so far.

Sources said the civic body has sanctioned ₹38.700 each for the rooftop projects and ₹30,000 each for projects in open spaces. The civic body has entrusted the women SHGs with the work which will help them earn a livelihood and make them

self-reliant. However, not a single project has been completed. On the other

hand, the civic body had constructed 500 such projects including those on government of fices by spending around ₹20,000 to 25,000 on each project. However, several such projects have allegedly become destroved and are

defunct now.

Locals have demanded early completion of the projects and revival of the defunct ones. Observers claimed burial of several water bodies and construction of high-rises is the reason behind the depleting groundwater level in the city.

When contacted, Smita Dash, Nodal CEO of BeMC, said work is going on in several projects and they will be completed and made operational very soon.

The Zuptas

he arrest in the United Arab Emirates (UAE) of the two brothers – Atul and Rajesh - belonging to the wealthy Gupta family, has sparked jubilation in the entire South Africa as the family has earned notoriety for virtually holding the state captive for about a decade to advance its multi-billion dollar family businesses. The infamous story has a striking parallel to cases of bank fraud and use of political clout by business magnates in India fleecing public exchequer. Interestingly, criminals of such nature have mastered the art of looting the resources of the countries they live in and then flying away to foreign soils to escape the law of the land. While India and South Africa share a common glorious history of the non-violent movement experimented and perfected by Mahatma Gandhi, the Guptas hailing from India have besmirched the reputation of India with their shady deals worth 25 per cent of South Africa's GDP, according to an estimate. Their influence on the then President of South Africa Jacob Zuma in using the state machinery for personal gains was such that a new epithet - 'Zuptas' was coined in the country to derisively indicate the alleged nexus between the Guptas and Zuma.

The Gupta brothers fled South Africa after a judicial commission began probing their alleged involvement in corruption in 2018. They are accused of paying bribes to bag lucrative state contracts and having a hand in powerful government appointments. Of course, both the family and Zuma persistently deny any wrongdoing. A statement from Dubai Police said the two men were being held "in connection with money laundering and criminal charges in South Africa." The force had acted after receiving an Interpol red notice which enjoins on government agencies to provisionally arrest a wanted person pending extradition. A third brother, Ajay, is also wanted by the South African authorities, but it is yet to be confirmed whether he too has been arrested.

The Gupta family's rise is spectacular. In a way, one can find some common elements between them and the Niray Modis and the Vijay Mallyas. The Guptas moved from India to South Africa in 1993 after facing accusations of money laundering in India. Indian tax officials raided properties belonging to them in 2018 in several cities, including their company office in Delhi. Most of the serious corruption allegations levelled against the Gupta brothers revolve round their relationship with Zuma, who was President of South Africa from 2009 till he was forced to step down in the wake of corruption allegations in 2018. The Gupta family is accused of using their close links with Zuma to wield political power extensively across all levels of South African government. They won business contracts allegedly influencing high-profile government appointments and misappropriating state funds. After the brothers fled the country, the South African government initially could not do anything to nab them since it had no extradition treaty with the UAE. But in 2021, the treaty was negotiated and the new President Cyril Ramaphosa's government began efforts to get the Gupta brothers extradited. However, it is not yet clear whether the two brothers will be immediately extradited to South Africa following the arrests.

The list of public bodies accused of having been captured by the Guptas is long. Included in this list are the ministries of Finance, Natural Resources and Public Enterprises, as well as agencies responsible for tax collection and communications, the national broadcaster SABC, the national carrier South African Airways, the state-owned rail-freight operator and the energy giant Eskom - one of the largest utility companies in the world.

A four-year investigation later published by the country's top judge concluded that the brothers had become deeply embedded in the highest levels of government and Zuma's ruling African National Congress (ANC) party. Reports published this year by investigators accused the brothers of being linked to racketeering activity through the procurement of rail, ports and pipeline infrastructure. Its authors said Zuma "would do anything that the Guptas wanted him to do for them." Last year, Zuma was imprisoned for 15 months for refusing to testify before the same investigators. He was released on parole after serving two months of his sentence in jail.

A protracted legal battle is on the cards in South Africa as the cash-rich Gupta family will use their resources to defeat the prosecution case. South Africa's economy is in shambles and the government is known to be begging lawyers to fight its cases. It is imaginable how such lawyers will fare against the battery of eminent and efficient lawyers the Guptas will engage. The new President is also accused of indulging in corruption and using the cases against the Guptas, Zuma and other big fish as a witch-hunt.

Whatever the fate of South Africa's investigation and prosecution, the case of the Guptas will stand out as a great indicator of how Indians can excel in being corrupt themselves and succeeding in corrupting the best anywhere the sun shines.

■ Theodolite

here's an intriguing story behind the word, but in essence it boils down to what Chambers says. The portable surveying instrument that we call a theodolite was invented in the middle of the sixteenth century by Leonard Digges of Kent, who gave it a name that was expressed in the common Latinate form of the time: theodelitus. (The name changed to an Anglicised form later, and at that time the e in the middle shifted to o for no very good reason anybody can discover.) His theodolite, by the way, was not quite the same as the modern device, since it consisted of a circle for measuring horizontal angles only. It was described in a book that was published posthumously by his son Thomas in 1571: A Geometricall Practise, named Pantometria, divided into Three Bookes, Longimetria, Planimetria, and Stereometria, containing Rules manifolde for Mensuration of all Lines, Superficies, and Solides (but then you knew that). The problem for those seeking the true origin of the word is that Mr Digges never recorded how he invented it. The suspicion is that he was a better surveyor and inventor than he was a scholar. The word looks Greek, as is theos, the word meaning "god" that we have in English words such as theology. It may be - this is only an educated guess, mind you — that he derived it from the Greek stem thea-, sight or view, which is also, through Greek compounds, the root of theorem (from theorein, to look at or be a spectator), and theatre (from theasthai, to see or to look at). If he did, we shall never know.

THE VIRUS IS STILL WINNING

UNLESS WE FIND POWERFUL WAYS TO ELIMINATE THE SARS-COV-2 VIRUS, IT WILL REMAIN A SCOURGE

nce again, COVID-19 is rampaging unchecked through the US population, because there are no longer any public-health measures in place to protect adequately against infection. I myself have taken extraordinary precautions to avoid infection for the last two and a half years, because I met three of the qualifications for severe COVID-19: I am 77 years old; I am a cancer survivor; and for the past 40 years I have been treated for a chronic inflammatory condition that leaves me moderately immuno-compromised.

Luckily, I had the privilege of being able to sequester myself in my country home, where I could control my personal interactions. I was vaccinated within weeks of vaccines becoming available, and I have received boosters every three to four months since. Moreover, I was given Evusheld, a monoclonal antibody treatment, four weeks ago.

Yet, toward the end of May, after many months of seclusion, I permitted myself one social occasion – a fundraising event with about 100 people in attendance. Four days later, in bed with a fever, cough, and malaise, I tested positive for COVID-19. Even with multiple vaccinations and Evusheld, I was not protected.

My experience has underscored a sad truth. In the race to return to some semblance of normalcy, the needs of the vulnerable have been forgotten.

Given that infection by SARS-CoV-2, the virus that causes COVID-19, has now become almost inevitable for most people, the least we could do is develop drug treatments to alleviate disease symptoms and prevent death and long-term consequences. But we have not done so. Pharmaceutical companies designed and manufactured COVID-19 vaccines on an unprecedentedly accelerated timeline, but drug development has not proceeded apace.

There are three main treatment options for those who develop COVID-19 and are at risk for long-term effects and disability. All three have limitations that prevent wider use. The first is remdesivir, which requires an IV-administered infusion and is thus available only in clinical settings. The second is Evusheld, which its developer,

AstraZeneca, claims is effective at preventing infection from the latest Omicron sub-variants. However, in my case at least, the treatment

failed to work as it should.

The third is Paxlovid, an antiviral drug developed by Pfizer that targets the SARS-CoV-2 protease. Paxlovid gained popularity as a COVID-19 treatment when studies showed that it reduced the risk of serious illness and death by up to 90 per cent. But research into its prophylactic potential has turned up empty, and new evidence suggests that some who take it experience rebound infections, meaning they might unwittingly transmit the virus to others.

What is to be done? Since the start of the pandemic, I have argued that vaccination alone will not be sufficient to prevent repeated COVID-19 infections. The literature on cold-causing coronaviruses demonstrates that they can reappear like clockwork. And with SARS-CoV-2, waves of infection occur not annually, as I would have expected based on previous data, but rather at much shorter intervals – every four to six months.

In addition to recognising the limitations of vaccination as a form of pandemic control, we are becoming more aware of the seriousness of "long COVID," which describes a broad range of symptoms – respiratory, gastrointesti-

nal, neurological – that persist after an initial COVID-19 infection has cleared.

While more than one-third of COVID-19 patients will develop long-term symptoms of some kind, 2-4 per cent will experience consequences severe enough to be disabling for many months, if not years. These include intense fatigue, persistent pain, and damage to vital organs, such as the heart, lungs, pancreas, and possibly others. Millions of people around the world have long COVID, and millions more will end up with it. Recent data suggest that the vaccines reduce its impact by a mere 15 per cent.

While our path out of the pandemic is not as straightforward as when I was working as an HIV researcher, the overarching direction of travel is still clear. We must develop strong antiviral drugs targeted at SARS-CoV-2 specifically. Though only six drugs targeting HIV have been identified, we have several treatments that are effective at clearing the virus.

Given the technological advances made in the last 30-35 years, and the speed with which these advances led to a COVID-19 vaccine, I had expected that we would have numerous antivirals for COVID-19 by now. And yet, of the treatments that have been approved, all are retreads or drugs developed for other

viruses, not SARS-CoV-2.

What we need now is to repeat the approach that worked during the HIV/AIDS epidemic. That effort involved a multiyear drug-de velopment programme to guide government- and industry-sponsored research. As a member of the National Institute of Allergy and Infectious Diseases Council, I proposed an intensive, cooperative programme whereby universities with industrial partners would receive large grants to fund basic research and practical drug development. The potential for a payoff attracted the interest of large pharmaceutical and biotechnology companies and spurred the formation of several public-private partnerships.

The programme was a resounding success, but it didn't come cheap. Each year, the National Institutes of Health set aside \$2-3 billion in a special HIV/AIDS research budget. The same level of investment is needed again. My colleagues around the world who have the skills required for intensive COVID-19 research are desperate for additional funding.

To its credit, the NIH recently awarded \$108 million in grants to the Metropolitan AntiViral Drug Accelerator, a collaborative initiative by world-class research institutions in New Jersey and New York that will investigate the potential for small-molecule drugs to treat and prevent coronaviruses Combinations of small-molecule antiviral drugs have proved effective at preventing and treating HIV, and can be manufactured and sold cost-effectively. A year's treatment with HIV drugs now costs well under \$100 in many places around the world. A protocol to prevent and treat COVID-19, lasting two to three weeks at most, should cost far less.

Unless we find powerful ways to eliminate the SARS-CoV-2 virus, it will remain a scourge. Some strains are only a mutation or two away from a leap in lethality. To prevent that, we must learn from pandemics past.

No cars or loud DJs were part of the wedding procession, which gained plenty of attention from passersby, because it's not every day that you see a groom dashing on a bicycle. I mean, a dashing groom on a bicycle.

Samal told The Telegraph that he didn't just want to protest fuel prices, but also promote environmentally friendly modes of transportation.

"By going on a bicycle, I have also been able to send a message about the need to maintain a good environment and good physique by avoiding to travel in cars and other motorable vehicles," he said. "My wife Sipra was also happy with my decision."

Yes, you've got to make Sipra happy. As the old saying goes, "Happy wife, happy life." In this case, it might be: "Happy ride, happy bride."

It's worth noting that other Indian grooms have promoted bicycle transportation at their weddings. Last November, Dinesh Sale, a member of a cycling group in Hyderabad called Happy Hyderabad, biked to his wedding, accompanied by friends on their cycles. After the wedding, he and his bride rode away on a tandem bicycle adorned with balloons and a "Just Married" sign.

"We don't have to always opt for a car to make an entry at the wedding," Sale told Telangana Today. "With this, I wanted to encourage people towards cycling and overall well-being and good health."

Two years earlier, in November 2019, Gurbakhshish Singh Gaggi rode a bicycle to his wedding in Bathinda, Punjab, and rode away with Ramandeep Kaur seated on the crossbar. Gaggi was also making a statement, but not about petrol prices or good health. He was show-

ing his disapproval for expensive weddings and dowry (which he refused to accept). Men like these should be ap-

plauded because they're willing to go against social norms. They're willing to stand up for their beliefs, even if it means potentially displeasing their in-laws. Just picture three middle-aged men, Ram, Ashok and Salil, talking about each of their daughters' recent weddings

Ram: "My son-in-law arrived at the wedding venue in a Mercedes S-Class."

Ashok: "Is that so? Well, my sonin-law came to the wedding in a Porsche Panamera. What about yours, Salil?"

Salil: "He is a hero. I mean, he used a Hero." Ashok: "Hero makes cars now?"

Ashok: "Hero makes cars now?" Salil: "No, it was a bicycle. A statement bicycle."

Ram: "Statement bicycle?"
Salil: "Yes, he was making a
statement. He was saying that petrol
prices are too high, and because of
that, he prefers to ride his bicycle
and leave his Lamborghini in his

garage." Riding a bicycle isn't always practical, but it's a great way to get exercise, reduce your carbon footprint and ensure that you don't empty your bank account at the petrol station.

My wife Malathi, often rides

My wife, Malathi, often rides her bicycle to work. We made a decision, when we bought our house, to be close enough to her office that she didn't need to rely on a car. (Unfortunately we couldn't find a home that would enable her ride to be downhill both ways.)

If you can't find a house or apartment near your workplace, it's wise to be near a bus stop or train station. Using public transportation helps keep fuel prices from affecting us much. There are many reasons why prices keep rising, and we really can't do much about them, except change our habits.



New Delhi, June 14: Congress leader Rahul Gandhi was questioned for over eight hours by the Enforcement Directorate for the second consecutive day in the National Herald money-laundering probe and was again summoned Wednesday, even as the opposition party continued its protests and sparred with the BJP, accusing it of conspiring to defame the Gandhi family through the "false" case.

Rahul Gandhi, 51, who was quizzed for over 10 hours a day earlier, arrived Tuesday at the ED headquarters on APJ Abdul Kalam Road in central Delhi accompanied by his sister and Congress general secretary Priyanka Gandhi Vadra and his questioning began at 11:30 am.

Hundreds of Congress leaders and supporters were detained outside the party headquarters at 24, After a session of about four Akbar Road and around central

against the ED action for the second day. The BJP hit out at the opposition party, saying it is blocking roads to show it's "leaders are above the law" and termed the protests "drama". "When lawful action is taking place in a case of corruption, Congress is doing this drama and blocking roads....It shows the party considers its leaders above law," BJP's national spokesperson Sambit Patra said The Congress, however, accused

the BJP of conspiring to defame the Gandhi family and the party by destroying their credibility through a "false" money laundering case being pursued by the Enforcement Directorate. Congress general secretary and chief spokesperson Randeep Surjewala claimed that the Centre is scared of Rahul Gandhi's politics as he is raising issues concerning the public."This entire exercise is illegal, unconstitutional, malicious and an exercise by a prime minister burning in the fire of political vendetta," Surjewala told a press conference here.

The Congress had alleged that its leaders were manhandled by police during Monday's protest as they tried to walk to the ED office. All approach roads leading to the agency office were made out of bounds Tuesday for the public as prohibitory orders were imposed and barricades put up.

A large posse of police personnel including from the central antiriot police force RAF and Central Reserve Police Force (CRPF) were deployed.

K C Venugopal and Adhir Ranjan Chowdhury were among scores of party leaders detained for violating prohibitory orders outside the heavily barricaded party office on Akbar road.

The Bill was passed by a simple voice vote on the floor of the House as the BJP legislators staged a walkout. Soon after state Education Minister Bratya Basu rose to explain the state government's logic behind passing the Bill, the BJP legislators started protesting.

Monday only, a bill to replace Governor with the Chief Minister as chancellor in the 31 state universities under the West Bengal education department was passed in the House. All these bills that get passed on the floor of the House will be sent to the Governor for his consent. The state government has already said that if the Governor refuses to give consent to the Bills, they will be implemented through an ordinance.

Jain to remain in jail till June 18



The Minister was taken to the ED headquarters when he felt uneasy outside the court and was taken to the hospital.

The CBI has accused Jain, his wife, and others of commission of offences under the Prevention of Corruption Act. On March 31, the ED provisionally attached immovable properties worth Rs 4.81 crore belonging to companies beneficially owned and controlled by Jain.

The ED on June 6 also recently conducted raids at multiple locations belonging to Jain, his wife, and accomplices who had either directly or indirectly assisted him or participated in the processes of money laundering. A recovery of cash worth Rs 2.85 crore and 133 gold coins was made during the raid.



WB bans bags below 75 microns of thickness

Kolkata, June 14: The West Bengal government has decided to ban the use of plastic bags below 75 microns of thickness in the state from July 1, Urban Development and Municipal Affairs Minister Firhad Hakim said Tuesday.

He said that a total of 1,026 plas-

tic carry bag manufacturing companies in the state have been given this instruction."The use of plastic bags below 75 microns of thickness will be banned from July 1. Anybody using plastic below that level will be fined," Hakim said.

He said that the Central Pollution Control Board has set a guideline on the thickness of plastic packets, banning the use of plastic carry bags and wrappers having thickness below 75 microns from July 1. "We have circulated the notification across departments," the minister said. From July 1, sellers will be fined Rs 500 while purchasers need to cough up Rs 50 if they are found using plastic packets with a thickness below 75 microns, he said.

Four dead in **Assam landslide**

Guwahati, June 14: Four people were killed in a massive landslide in Guwahati amid heavy rains that flooded the city, officials said_

A huge mass of land buried a house, in which there were four people, on a hillside in Nijarapar in Boragaon area, an official of the Assam State Disaster Management Authority (ASDMA) said. "The landslide happened around 1 am mainly due to incessant rains. No other person is trapped as of now," ASDMA District Project Officer (Kamrup Metropolitan) Kaustav Talukdar said.

With this, the total number of persons losing their lives in this year's flood and landslides has gone

Talukdar said that landslides have been reported from another half a dozen places in the city, including Kamakhya, Kharghuli, Hengerabari, Silpukhuri and Chandmari Colony, but there were no casualties.

Incessant rains since Monday night led to knee-deep water on all major roads across the city, while at some places water levels have crossed the waist. The approach road of the Guwahati railway station was also submerged.

40% elderly want to be employed for as long as possible: Study

New Delhi, June 14: About 40 per cent of elderly nationally want to be employed for "as long as possible" while an alarming 13 per cent elders experienced physical abuse in the form of beating and slapping, according to a new study.

HelpAge India said its report is a dip-stick study to understand the overarching gaps in income employment at old age, health and wellbeing, elder abuse and safety and social and digital inclusion of

It is based on a sample size of 4,399 elder respondents and 2,200 young adult caregivers across 22 cities in India. The study found that about 40 per cent of elderly na-



tionally want to be employed for "as long as possible"

Nationally, the study found that 59 per cent elders feel that elder abuse is prevalent in society, while only 10 per cent elders admitted

to being a victim of elder abuse, with relatives (36 per cent), son (35 per cent) and daughter-in-law (21 per cent) being the top three perpetrators

Disrespect (57 per cent), verbal

abuse (38 per cent), neglect (33 per cent), economic exploitation (24 per cent) and an alarming 13 per cent elders experienced physical abuse, in the form of beating and

In Delhi, 74 per cent elderly feel that such abuse is prevalent in society while 12 per cent were themselves victims. Elders attribute the abuse to their sons' (35 per cent) and daughters' in law (44 per cent) as the biggest perpetrators of abuse.

Nationally, 47 per cent of those abused stated they 'stopped talking to family' as a response to the abused faced. Again family here becomes a key role player. In Delhi, 83 per cent of elderly stated they

'stopped talking to family'. Also, nationally 47 per cent eld-

ers are dependent on family for source of income while 34 per cent are dependent on pension and cash transfers. "Meanwhile in Delhi, 57 per cent of elderly are dependent on family, while 63 per cent depend upon pensions and cash transfers. It means that a large number of elders in Delhi have both - family as well as pension support," the report said.

However, when asked about the adequacy of income, nationally 52 per cent elders reported it was inadequate. Meanwhile, a substantial 40 per cent elders said they do not feel financially secure, citing their 'incurred expenses are more than savings/income' (57 per cent) and pension not being enough (45 per cent) as the top reasons.

This suggests both financial planning for later years and social security needs much greater attention. Meanwhile in Delhi, 52 per cent of elderly say that their income is adequate, while 48 per cent say it is inadequate, it said.

About 36 per cent elders are willing to work and 40 per cent of them want to work 'as long as possible', 61 per cent elders feel they aren't 'adequate and accessible employment opportunities' for elderly available.

In Delhi, 87 per cent of elders are not working, even as 40 per cent say they have access to employment opportunities.

The study further finds out that 44 per cent of Delhi elders are willing to work after their retirement.

Pollution shortening lives by almost 10 yrs in Delhi, says study



Chicago, June 14: Air pollution can shorten lives by almost 10 years in Delhi, the world's most polluted city, says a report by a US research

The Air Quality Life Index by the Energy Policy Institute at the University of Chicago (EPIC) notes that some 510 million people who live in northern India, nearly 40 per cent of India's population, are "on track" to lose 7.6 years of their lives on average, given the current pollution levels, the BBC reported.

The study adds that the average Indian life expectancy is shortened by five years at current air quality levels. India's 1.3 billion people live in areas where the "annual average particulate pollution level" exceeds the WHO safe limit.

However, reducing pollution levels to WHO standards would mean that an estimated 240 million people in Uttar Pradesh would gain 10 years in life expectancy.

EPIC says that since 2013, about 44 per cent of the global pollution has come from India, currently the second most polluted country in the world, the BBC reported.

"It would be a global emergency if Martians came to Earth and sprayed a substance that caused the average person on the planet to lose more than two years of life expectancy," the BBC quoted Michael Greenstone, one of the authors of the report, as saying. "This is similar to that situation that prevails in many parts of the world, except we are spraying the substance, not some invaders from

EPIC says that particulate pollution is the "greatest threat to human life" in India in terms of life expectancy and since 1998, this particulate pollution has increased by 61.4 per cent.

This makes it more lethal than smoking which reduces life expectancy by about 2.5 years, BBC reported.

The increase in air pollution over the past two decades in India has been primarily due to industrialisation, economic development and the skyrocketing use of fossil fuel. The number of vehicles on the country's roads has increased about four-fold, the report added.

Globally, air pollution reduces 2.2 years of life expectancy, relative to a world that follows the WHO guidelines. This impact on life expectancy is comparable to that of smoking, more than three times that of alcohol use and unsafe water, six times that of HIV/AIDS and 89 times that of conflict and terrorism.

Delhi reports 126 dengue, 21 malaria cases this year

New Delhi, June 14: A total of 126 dengue cases have been reported in the national capital so far this year, according to a civic report released Monday.

Till June 6, 118 dengue cases had been recorded in the city, the Municipal Corporation of Delhi (MCD) said in the report. No death has been reported due to the vector-borne disease so far, it said.

Delhi had recorded 23 dengue cases in January, 16 in February, 22 in March, 20 in April and 30 in May, the report said.

Fifteen cases have been reported this month till June 11.

From January 1 to June 4, 31 cases were logged in 2021, 19 in 2020, 13 in 2019, 24 in 2018 and 50 in 2017, it said.

Cases of vector-borne diseases are usually reported between July and November, but the period may stretch till mid-December.

Civic officials said this year,

Mercury dips below 40° Celsius in Delhi after 13 days

New Delhi, June 14: A cloud cover cocooned Delhi Tuesday, causing the maximum temperature at the Safdarjung Observatory, the city's base station, to drop below 40 degrees Celsius for the first time this month, according to the India Meteorological Department (IMD). The observatory recorded a maximum temperature of 39.6 degrees Celsius as against 43.7 degrees



Celsius, three notches above normal.

All weather stations in the national capital recorded maximum temperatures between 38 degrees Celsius and 42 degrees Celsius.

Consecutive western disturbances and lower-level easterlies predicted in the coming days are likely to keep the heat at bay.

The IMD has issued a yellow alert, warning of thundershowers or light rain over the next six days. The mercury is predicted to drop to 35 degrees Celsius by Sunday. Since June 1, when the mon-

soon season starts, the capital has not recorded any rainfall. Usually, it receives 13.8 mm of rainfall in the first 13 days of the month. Mahesh Palawat, vice-president

(climate change and meteorology), Skymet Weather said the monsoon is expected to arrive in Delhi around the usual date -- June 27 -- or a day or two in advance. Last year, the IMD had forecast that the monsoon would arrive in Delhi nearly two weeks before its usual date. However, it reached the capital

only July 13, making it the most delayed in 19 years. The capital has recorded a maximum temperature of 42 degrees Celsius and above on 26 days so far this summer season, the highest number of such days since 2012, according to IMD data. Oppn slams Centre's move to recruit 10 lakh people

DGCA imposes ₹10L fine on Al

New Delhi, June 14: Aviation regulator DGCA Tuesday said it has imposed a fine of ₹10 lakh on Air India for denying boarding to passengers holding valid tickets and thereafter not providing mandatory compensation to them.

"After that a series of checks were carried out by DGCA and during our surveillance at Bengaluru, Hyderabad and Delhi, there were specific instances, in the case of Air India - where the regulation (regarding compensation to passengers) is not being followed and therefore, a show cause notice was issued to the airline and also a personal hearing was afforded," the Directorate General of Civil Aviation (DGCA) said in a statement.

According to the regulator, Air India may not have a policy in this regard and does not pay compensation to the passengers."To say the least, it is a matter of serious concern and unacceptable. In the specific cases detailed in the show cause notice, after going through AI submissions, as part of enforcement action, the competent authority has levied a penalty of ₹10 lakh," it noted.

"In addition, the Airline has been advised to immediately put the systems in place to resolve the issue - failing which further action shall be taken by DGCA," it

If a passenger is denied boarding despite having a valid ticket and has reported at the airport on time, certain regulations have to be followed by the airline concerned, as per the DGCA.

In case the airline concerned is able to arrange an alternative flight for the affected passenger within an hour, no compensation is to be paid, the DGCA regulations state.

In 2020, the government blocked popular gaming app PUBG and others, terming them prejudicial to the sovereignty, integrity and defence of the nation. Last week a boy allegedly shot dead his mother as she stopped him from playing the online game in Lucknow in Uttar Pradesh.

"In view of this incident, it is beyond the understanding of the commission how a banned game...Which has been blocked by the government, is still avail-

able for use by minors. Therefore, the Commission requests your good offices to inform reasons for availability of such blocked applications over the internet." the NCPCR wrote to the ministry secretary.

The National Commission for Protection of Child Rights also requested that it may be informed regarding action taken in such incidents and be provided with a list of such games which are being used by minors along with their regulating bodies and their regulating mechanism within 10 days of receipt of this letter.

In another letter to the president of the Indian Olympic Association, the commission said it has been observed that PUBG has been recognised a part of esports and has further received recognition from the Olympic Council of Asia (OCA).

"In the said regard it is requested that the commission may be informed regarding the current status as to whether PUBG or any other similar e-game has been recognised by your organisation. It is requested that the commission may be informed regarding such games which are being used by minors along with their recognition status within 10 days of receipt of this letter," it said.

River linking projects may adversely impact monsoon: Experts

New Delhi, June 14: Interlinking of rivers may have far-reaching adverse impact on monsoon cycles and biodiversity and pose socioeconomic challenges, several experts have said, as the government embarks on an ambitious project to link the Ken and Betwa rivers to tackle water crisis in the parched Bundelkhand region.

The Ken-Betwa scheme, the first being implemented under the National River Linking Project (NRLP), seeks to bring nearly 11 lakh hectares of land under irrigation in the parched Bundelkhand region straddling Uttar Pradesh and Madhya Pradesh.

The NRLP proposes transfer of

deficit basins where there is drought and scarcity through inter-basin water transfer projects. Cautioning against river linking projects, the experts said these can lead to disturbance of very complex nature cycles that can have far-reaching adverse impact on monsoon cycles, biodiversity and socio-economic is-

Manoj Misra, convenor of Yamuna Jiye Abhiyan, a collective fighting to preserve the Yamuna river and its floodplains, said the long-term adverse impacts of the river-linking projects cannot be visualised as they would be very far

"For example, in Ken-Betwa, their origins are very different. Ken has a very unique fish which



in Betwa currently. If Ken's water is diverted to Betwa then fish and other biodiversity will also move and when it moves then you do not know what impact it will have on the local fish," he said. He said river-linking projects can also lead

"When water of a river is diverted and it merges in sea, it takes all its sediments with it to the sea. It is a hypothesis that the kind of inter-linking we have planned is that for all we know the monsoonal sysNetwork on Dams, Rivers and People (SANDRP), agrees with Misra and says sea's thermal and salinity gradient are two drivers of monsoon which can get disturbed by river-linking projects.

By river-linking, you are stopping flow of fresh water to sea and the salinity gradient is also reduced and the silt component which creates the Gangetic plain is also impacted. So that creates a different dynamic and all these are drivers of monsoon. So when you are disturbing these factors driving monsoon you are disrupting the monsoon season," he said. Speaking about other issues that the river linking projects can pose, he said there can be environment, social, climate-related impact. "It will have pact is 23 lakh big trees will be cut for the Ken-Betwa inter-linking,' Thakkar said.

He said a credible assessment must be made on the impact of Ken-Betwa river linking project on the environment, as none exists today."The current EIA (Environmental Impact Assessment), the public hearing and the scrutiny by the Expert Appraisal Committee for the Ken Betwa project are all seriously flawed," he said.



Lviv, June 14: Russian troops control about 80% of the fiercely contested eastern Ukrainian city of Sieverodonetsk and have destroyed all three bridges leading out of the city but Ukrainian authorities are still trying to evacuate more wounded residents, a regional official said Tuesday.

Serhiy Haidai, governor of the eastern Luhansk region, acknowledged that a mass evacuation of civilians from Sieverodonetsk now is "simply not possible" due to the relentless shelling and fighting in the city.

Ukrainian forces have been pushed to the industrial outskirts of the city because of "the scorched earth method and heavy artillery the Russians are using," he said.

"There is still an opportunity for the evacuation of the wounded, communication with the Ukrainian military and local residents," he told The Associated Press by telephone, adding that Russian forces have not yet blocked off the strategic city.In all, 70 civilians were evacuated from the Luhansk region in the last day the governor said. A Russian general, meanwhile, says a humanitarian corridor will be opened Wednesday to evacuate

civilians from the besieged Azot chemical plant in Sievierodonetsk. Col-Gen. Mkhail Mizintsev said evacuees would be taken to the town of Svatovo, 60 kilometers to the north in territory under the control of Russian and separatist forces. He said the plan was made after Ukraine called for establishing an evacuation corridor leading to Ukrainian-controlled territory.

Mizintsev, head of the National Defense Management Centre, is accused by Ukraine of human rights violations while commanding troops during the long siege of Mariupol, Ukraine's key port on the Sea of Azov that has been taken over by the Russians.

Russian forces in the last few weeks have pressed hard to capture Ukraine's eastern industrial Donbas area, which borders Russia and is made up of the regions of Luhansk and Donetsk. "The situation is difficult," Ukrainian President Volodymyr Zelesnkyy said in a news conference Tuesday with Danish media. "Our task is to fight back." Jan Egeland, the Secretary-General of the Norwegian Refugee Council, one of the aid organisations supplying food to the people in the Donbas, said fighting in the past few weeks has made regular food dis-

China lifts 2-yr Covid visa ban on Indians

Beijing, June 14: China has announced plans to provide visas to Indian professionals and their families stranded in India for over two years following the strict visa restrictions imposed by Beijing due to the Covid-19 pandemic.

On Monday, the Chinese Embassy in India updated its Covid-19 visa policy after over two years to accept visa applications of foreign nationals and their accompanying family members wanting to go to China for resumption of work in all fields. It is a big relief for hundreds of Indian professionals and their families who are stuck back

Last month, a number of Indian professionals based in China urged External Affairs Minister S Jaishankar to press Beijing to allow their stranded families to return.

Besides the Indians, the Chinese Embassy in New Delhi said family members of Chinese citizens and foreigners with Chinese permanent residence permits going to China for family reunions or visiting relatives can apply for visas. Besides Indians some of whom have Chinese spouses, many Chinese employees working for various companies were also stranded in India due to Beijing's blanket visa bans and flight cancellations.

'some" stranded Indian students and asked the Indian Embassy here to collect the details of the students wanting to return.

As per earlier reports, over 23,000 Indian students, mostly studying medicine in Chinese colleges, are stuck in India after they returned home as the coronavirus broke out in China in December 2019. They could not return to China due to the restrictions imposed by the Chinese government to arrest the spread of the contagion. Over 12,000 Indian

students have reportedly expressed their wish to return and their details have been forwarded to the Chinese government for process ing. China is yet to come up with a criterion to permit the return of the students as Beijing is reluctant to allow such large number of people to return at once in view the recent spike in Covid-19 cases in the country. While opening visa services to Indians, China is yet to announce plans to open flight facilities between the two countries.

Currently, only diplomats between the two countries travel through the expensive third-country flight routes.

However, China's visa an nouncement has created hope that flight services too may be resumed between the two countries soon.

In recent months, China has been permitting students from some friendly countries like Pakistan, Thailand, Solomon Islands and recently Sri Lanka to return.

SL approves measures to ease economic recovery

Colombo, June 14: Sri Lanka's cash-strapped government has approved several measures, including imposing a 2.5 per cent social contribution tax on companies based on their turnover and declaring Fridays as holidays for most public sector employees, to facilitate the economic recovery and mitigate energy and food crisis.

The economic crisis has prompted an acute shortage of essential items like food, medicine, cooking gas and other fuel, toilet paper, and even matches, with Sri Lankans being forced to wait in lines lasting hours outside stores to buy fuel and cooking gas.

The Cabinet at a meeting held on Monday approved a bill to impose a 2.5 per cent tax on companies with an annual turnover of Rs 120 million. The new tax named the social contribution levy will be applicable to businesses in imports, manufacturing, service providers, wholesalers and retailers, according to an official statement. In another measure aimed at mitigating the ongoing energy crisis, the Cabinet has approved to declare Fridays as holi-

employees.

Cabinet also approved a move to grant government officials one leave per week for the next three months to engage in agriculture to mitigate the approaching food crisis. Minister of Home affairs and Public Administration Dinesh Gunawardena said that fuel consumption will be reduced because of this move.

'We have decided to make Fridays a holiday for all public servants because of the transportation issues that have popped up as a result of the fuel scarcity. Public servants can stay at home and focus on growing food crops on Fridays," he said.

WHO Director-General Tedros Adhanom Ghebreyesus said Tuesday he decided to convene the emergency committee on June 23 because the virus has shown "unusual" recent behaviour by spreading in countries well beyond parts of Africa, where it is endemic.

"We believe that it needs also some coordinated response because of the geographic spread," he told reporters

Biden to visit Israel and 'pariah' Saudi

Washington, June 14: President Joe Biden will make his first trip to the Middle East next month with visits to Israel, the occupied West Bank and Saudi Arabia, the White

House announced Tuesday. The decision to pay a call on Saudi leaders during the July 13-16 trip comes after Biden as a Democratic presidential candidate branded the kingdom a "pariah" because of its human rights record and pledged to recalibrate the US-Saudi relationship.

Biden plans to meet with the Crown Prince Mohammed bin Salman, the de facto ruler of the kingdom, according to a senior administration official who briefed reporters on the condition of anonymity.

US Intelligence officials determined Prince Mohammed likely ordered the brutal 2018 killing of USbased journalist Jamal Khashoggi.

After Biden took office, his administration made clear the president would avoid direct engagement with the crown prince and instead focus his engagements

with King Salman. Human rights advocates and some Democratic allies cautioned Biden about visiting the oil-rich kingdom, saying such a visit without first getting human rights commitments would send a message to Saudi leaders that there are no consequences for egregious rights

Death toll from fighting in Darfur tops 125, says UN

Cairo, June 14: The death toll from tribal clashes over the past week in Sudan's Darfur region has reached at least 125, the United Nations said Tuesday.

The violence, the latest in the war-ravaged region, erupted following a land dispute between Arab and African tribes in the town of Kulbus in West Darfur province. Local Arab militias then attacked multiple villages in the area. The UN Office for the Coordination of Humanitarian Affairs said the dead included over 100 from the African Gimir tribe and 25 Arabs. It said the clashes injured more than 130 others, mostly

from the non-Arab tribe. OCHA said at least 25 villages in the Kulbus area were attacked, looted and burned and that at least 50,000 people were forced to flee their homes in West Darfur and neighboring North Darfur province,

where the clashes spread. Elsewhere in West Darfur, at least 19 people were reportedly killed and 54 others injured in separate tribal clashes earlier this month, according to OCHA.

Penuelas, Chile, June 14: The Penuelas reservoir in central Chile was until twenty years ago the main source of water for the city of Valparaiso, holding enough water for 38,000 Olympic-size swimming pools. Water for only two pools now remains. Amid an historic 13-year drought, rainfall lev-

els have slumped in this South American nation that hugs the continent's Pacific coast. Higher air temperatures have meant snow in the Andes, once a key store of meltwater for spring and summer, is not compacting, melts faster, or turns straight to vapor.

The drought has hit mine output in the world's largest copper producer, stoked tensions over water

use for lithium and farming, and led capital Santiago to make unprecedented plans for potential water rationing. The lender has increased the interest rate by 25 basis points to 4 per cent from 3.75 per cent on retail term deposits maturing between 91 days and six months. For fixed deposits maturing in 3 years to less than 5 years, the rate has been hiked by 10 bps to 5.60 per cent, compared to 5.50 per cent earlier.

WPI at 30-yr high makes rate hikes more likely

New Delhi, June 14: High global energy and raw material prices combined with a weak rupee fueled the fastest annual rise in India's wholesale prices in more than 30 years, raising expectations for the central bank to order more interest rate hikes

A surge in crude oil and commodity prices since Russia invaded Ukraine in February has set inflation alight in many countries, forcing central banks to raise interest rates.

Wholesale prices, akin to producer prices, climbed 15.88% in May from year ago levels, staying in double-digits for a 14th straight month, and was, according to economists, India's highest since September 1991.

The high rate was primarily due to rising prices for crude petroleum and natural gas, food items, basic metals and chemical products, the Ministry of Commerce and Industry said in a statement Tuesday.

Prices for manufactured products, contributing around 64% to the wholesale price index (WPI), rose 10.11%, compared to 10.85% in



power costs increased 40.62% from a year ago period.

Monday, India reported retail prices had risen 7.04% in May from year ago levels, moderating slightly from the eight-year high of 7.79% posted in April.

The dismal reports for the two main measures of inflation led economists to expect the Reserve Bank of India (RBI) to raise key interest rates at its next policy meeting in August.

Aditi Navar, economist at ICRA. the Indian arm of Moody's credit rating agency, said WPI inflation was likely to stay between 15%-16% in June, largely as a result of soaring global crude oil prices. And she predicted a response from

The RBI's Monetary Policy Committee (MPC) raised its benchto 4.90% last week, after a 40 basis points hike in April, while hint-

ing at more rate hikes to come. Food prices, contributing about a quarter of the WPI index, climbed 10.89% in May, though vegetable prices rose 18.26% in May yearon-year, compared to 23.24% in the previous month.

An uptick in wholesale food and energy prices is likely to feed into retail prices as the companies increasingly pass on high input costs to consumers.

Adam Hoyes, economist at Capital Economics Singapore said May's WPI figures suggested upside risk to consumer food inflation, which is politically sensitive in India.

Most young workers reluctant to return to workplace full-time: Report

Mumbai, June 14: Even as organisations are gradually opening offices after the pandemic, a report has revealed that most workers between 25-34 years of age globally are likely to look for a new job if employers insist on going into the workplace everyday.

Younger workers are more reluctant than their older colleagues to return to the workplace fulltime as employers seek to encourage staff back into the office, according to the ADP Research Institute's 'People at Work 2022: A Global Workforce View'.

According to the report, more than seven in 10 (71 per cent) of 18-24 year-olds and two-third (66 per cent) of 25-34 year-olds would consider looking for another job if their employer insisted on a fulltime return to the workplace, compared to 56 per cent of the 45-54 age bracket.

Overall, two-third of the global workforce (64 per cent) have already, or would consider, looking for another job if their employer stipulated that they must come in to work on the premises every day.

In India, 76.38 per cent of workers interviewed said they would contemplate quitting if this hap-



pened, said the report. The report is based on a survey among 32,924 workers in 17 coun-

tries around the world, including 1.600 in India, between 1 November and 24 November 2021.

"Lockdowns have been eased and raise the question of whether workers can be asked or compelled to return to work. For many, this could be a deciding factor in their decision to leave. These findings contradict some people's beliefs that younger people are desperate to return to the workforce for social and career advancement reasons. ADP India MD Rahul Goyal noted.

In India, the report found that 75 per cent of workers felt that they have continued to collaborate with their teams perfectly while working remotely, thus a lot of them are reluctant to return to the office full-time.

"It is important for young people to be surrounded by peers and superiors to learn and gain experience and create networks early on in their careers and they need to find new ways to encourage them back to an in-person environment, engage them once there and help rebuild lost confidence and skills," Goval added.

For example, having accessible human capital management data to create visibility around individuals and teams could help to inform decision-making, build a more connected internal cultureand enhance trust and loyalty between employers and staff, he added.

Earlier, Gaikwad and Ishan set the platform with a 97-run stand inside 10 overs but South Africa tightened the screws in the second half to keep India inside 180.

It was Gaikwad, who turned aggressor after a watchful start and exploded in the fifth over, slamming five successive boundaries, including one off his helmet grill, off Anrich Nortje. The Maharashtra batter also deposited Pretorius (2/29) over deep backward square for his second six as India posted 57 for no loss in six overs, their best powerplay in the series.

Ishan, who was playing second fiddle, got into the act in the ninth over, smacking Shamsi's (1/36) overpitched ball for a maximum before sweeping him for another four as 13 runs came from the over.

Gaikwad completed his fifty in 30 balls and then welcomed Keshav Maharaj (1/24) with an inside out lift for a four, but the spinner had him

caught off his own bowling with India on 97/1 at the halfway stage.

Ishan then gave a special treatment to Maharaj, picking up two fours and a six en route a 31-ball fifty, his second of the series. New-man Shreyas Iyer looked in good touch as he blasted a six each off Nortje and Shamsi, but the spinner dismissed him with Nortje timing his jump to perfection for a nice catch.

Pretorius pegged India further back by getting rid of Ishan, who was caught by Hendricks. The hosts managed just 20 runs while losing two wickets from over 13 to 17 before Pandya took them close to 180 with some lusty blows in the final stages.

Kolkata, June 14: Told to hang up his boots after a medical condition, Anwar Ali's persistence and optimism in the face of seemingly insurmountable odds paid rich dividends here Tuesday.

Thanks to goals from Anwar, Sunil Chhetri – he does that almost every other day – Manvir Singh and Ishan Pandita, India capped off their historic AFC Asian Cup qualification campaign in style, sweeping aside a strong Hong Kong side 4-0 under heavy rains at the Salt Lake Stadium.

Igor Stimac's side brought out its A game on a stormy night and started off with a blitz as Anwar (second minute) and Chhetri (45th) gave India a 2-0 lead.

It was then a tale of super subs as Manvir (85th) and Pandita (90+3rd) came off the bench to complete the rout and help India (nine points) top group D with three wins on the trot, ahead of Hong Kong (six).

The Blue Tigers raced to a 1-0 lead with the 21-year-old centreback Anwar scoring his maiden international goal four years after his career nearly ended on health grounds.

The 2017 U-17 World Cup star, whose career had been put on hold after being diagnosed with a rare heart disease (Hypertrophic Myocardiopathy), scored from a short Ashique Kuruniyan corner with his right-footed strike into the top corner.

The versatile defender, playing alongside Sandesh Jhingan, not only made his presence felt in the backline but also made some fluid moves up front.

The talismanic Chhetri doubled the lead just before the break from a 30-yard free-kick to bring up his fourth goal of the tournament. Jeakson Singh floated in a brilliant free-kick as the skipper controlled it brilliantly with a deft home to notch his 84th international strike that saw him go level with Hungarian great Ferenc Puskas in the chart for the all-time leading international scorers.

He also entered the top-five international goal-scorers' list. The Indian icon is just two goals behind Argentine maestro Lionel Messi among active players list led by Portuguese superstar Cristiano Ronaldo (117).

Late into the second-half it was Brandon Fernandes who initiated the move from the right and played a quick 1-2 with Roshan Singh before Manvir found the target. On song, India attacked on the counter and a cross from the right from Manvir was converted by Pandita

More than eight hours before their face-off, both the teams confirmed the Asian Cup Finals berth, courtesv Palestine's 4-0 win over Philippines who were eliminated after finishing as the worst runners-

VIACOM18 ENDS DISNEY STAR'S MONOPOLY IN CASH-RICH CRICKET LEAGUE

New Delhi, June 14: The BCCI Tuesday reaffirmed its status as a cricketing behemoth by securing one of the biggest broadcast deals in the history of the sport, fetching an eye-popping 48,390 crore (USD 6.20 billion) through IPL media rights for a five-year period, start-

While Disney Star retained their Indian sub-continent TV rights by paying Rs 23,575 crore (Rs 57.5 crore/game), the most sought-after India digital rights deal was acquired for Rs 20,500 crore by the Reliance backed Viacom18, which also won the non-exclusive Package C by paying Rs 2991 crore more.

The deal for package A and B is for 410 matches across five years with 74 matches each in 2023 and 2024 and 84 each in 2025 and 2026. The 2027 edition will have 94 games. The Package 'D' for overseas rights for various regions was bagged by Viacom and Times Internet.

Viacom18 entered the fray through a consortium which has former Star India head Uday Shankar (Bodhi Tree) and James Murdoch (Lupa Systems) in it.

"I am thrilled to announce that STAR INDIA wins India TV rights with their bid of Rs 23,575 crores. The bid is a direct testimony to

the BCCI's organisational capabilities despite two pandemic vears," BCCI secretary Jay Shah

"Viacom18 bags digital rights with its winning bid of Rs 23,758 cr. India has seen a digital revolution & the sector has endless potential. The digital landscape has changed the way cricket is watched. It has been a big factor in the growth of the game & the Digital India vision" the BCCI secretary added.

"Since its inception, the IPL has been synonymous with growth & today is a red-letter day for India Cricket, with Brand IPL touching a new high with e-auction resulting in INR 48,390 cr value. IPL is now the 2nd most valued sporting league in the world in terms of per match

The IPL, in terms of sheer valuation, will now be bracketed in the top-most sporting properties alongside National Football League (USA), National Basketball Association (USA) and English Premier League (England), the most watched sporting event in

The value of per IPL match made more than a 100 per cent jump from previous Rs 54.5 crore to above Rs 114 crore (approx). Globally, the per-match value (USD 14.61 million) in IPL is second only to NFL where every match is worth USD 17 million.

The new deal also ends the monopoly of a single broadcaster. Sony had acquired the rights by paying Rs 8200 crore for the first 10 years (2008-17) while Star with a bid price of 16347.50 won it for the next five years.

There was a also a Package C,

where digital rights of 18 non-ex-

clusive marquee games per season were up for grabs and Viacom18 won it with a winning bid of Rs 2991.6 crore at the rate of Rs 33.24 crore per match. There are 90 matches in this package. Package D with a base price of

Rs 3 crore per game with overseas TV and Digital Rights on offer was sold for more than 1300 crore to Viacom18 and Times Internet. Having lost the digital rights to

Viacom18, Walt Disney's Head of International Content and Operations, Rebecca Campbell in a statement hinted that Star will be vying for other multi-platform cricket rights.

"We will be exploring other multiplatform cricket rights, including future rights for International Cricket Council (ICC) and Board of Control for Cricket in India (BCCI). which we currently hold through the 2023 and 2024 seasons, respectively," Campbell said.

Paris, June 14: Defending champion France lost their Nations League title and faced the dim prospect of relegation after losing at home to Croatia 1-0. Meanwhile, while their group leader Denmark beat Austria 2-0 to boost their Final Four bid Monday.

Denmark has nine points, two more than second-placed Croatia with only the group winner going through. Austria was third with four points and rock-bottom France had two after a fourth game without a win. The team in last place is relegated.

Croatia scored with a fifth-minute penalty from standout midfielder Luka Modric at the Stade de France. It is where he played so commandingly for Champions League winner Real Madrid in the final iust over two weeks ago, and he belied his advancing years with a display full of astute passing and

clever movement into space. Croatia's fans chanted, 'Luka, Luka', to their inspirational captain as he gave them a thumbs up after the game. In Copenhagen, wide forwards Jonas Older Wind and Andreas Skov Olsen got Denmark's goals in the first half. Croatia hosts Denmark in a table-topping clash September 22.

ets, Ganguly only bowled 760 overs across 311 ODI with his more than useful medium pace. At 91/2, Zimbabwe had set themselves a decent platform in Kanpur, with Andy Flower and Stuart Carlisle setting a platform for the tourists.

Bowling his full allotment for first time in 25 ODIs, and the only Indian bowler to do so on this particular day, Ganguly put the side on his back, dismissing the set pair either side of Grant Flower on a slow and low track. From their strong start, Zimbabwe crumbled to 141/6 after Ganguly claimed his fourth scalp, opposite number Heath Streak for just three.

Ganguly picked up his fifth when Travis Friend was adjudged lbw for six. India went on to win by nine wickets, with Ganguly's unbeaten 71 (68) confirming Player
