Jeremy gets India 2nd CWG gold

LIFTER FROM AIZWAL BREAKS TWO GAMES RECORDS EN ROUTE TO THE YELLOW METAL WITH A POWER-PACKED DISPLAY

Birmingham, July 31: Young weightlifter Jeremy Lalrinnunga smashed two Games records on his way to a sensational gold medal win at the Birmingham Commonwealth Games (CWG) as he added a second yel-

low metal to India's tally Sunday. The 2018 Youth

Olympic champion dominated the men's 67kg competition with a total lift of 300kg (140kg+160kg), finishing ahead of Samoa's Vaipava Nevo Ioane, who managed a total of 293kg (127kg +166kg). Nigeria's Edidiong Joseph Umoafia took bronze with an effort of 290kg (130kg+160kg).

The 19-vear-old from Aizwal wrote the

Games snatch (140kg) and overall lift (300kg) record in his name but not before an injury scare as twice he grimaced in pain during the clean and jerk attempts.

Jeremy opened up a huge 10kg gap with the nearest rival Umoafia when he lifted 140kg in the snatch. He had begun with 136kg. He went for 143kg in his final attempt, but did not succeed



NDPS body orders seizure of drug peddler's ₹1.32cr assets

Bhubaneswar, July 31: The competent authority (eastern region) under the Narcotic Drugs and Psychotropic Substances (NDPS) Act in Kolkata has ordered con fiscation of assets worth over Rs 1.32 crore owned by notorious drug peddler Seikh Jamsed, an official of the Crime Branch's Special Task Force (STF) said Sunday.

According to the official, Jamsed was arrested from his residence at Haldipadia slum here April 22 this year. Brown sugar weighing 1.227 kg, a motorcycle and other in criminating materials were seized from Jamsed, a drug peddler having links with interstate gangs.

Soon after his arrest, the STF detected movable and immovable assets worth Rs 1.32 crore owned by the accused out of ill-gotten money, said the official. A detailed pro posal for confirmation of seizure of the properties earned out of drug peddling was sent to the competent authority as per provision under Section 68(F) of the NDPS Act, 1985, the official pointed out,

NHRC seeks ATR from Chief Secy over displacement in Sundargarh

Bhubaneswar, July 31: The National Human Rights Commission (NHRC) has sought Action-Taken Reports (ATRs) from the Chief Secretary and the district Collector of Sundargarh over alleged failure of the administration in providing proper resettlement and rehabilitation facilities to the those displaced owing to projects like Rourkela Steel Plant, Mandira dam, Rukuda dam and railway works in the district in the past few decades.

While hearing a plea filed by Supreme Court lawyer and rights activist Radhakanta Tripathy, the commission has asked the authorities to submit the ATRs within four weeks.

In his petition, Tripathy has informed the NHRC that the state government had acquired around 32,000 acre of land in 32 villages

for the establishment of Rourkela Steel Plant, the civil township and Mandira dam during 1955-1959. The displaced people were given homestead land and agricultural land along with compensation. However, the district adminis-

tration is yet to identify around 5,300 acre of reclamation land in 16 locations of Sundargarh and Deogarh districts which were supposed to be distributed. The displaced families, mean-

while, have been granted lease pattas for land which are outside Rourkela area.

"The beneficiaries have not yet been handed over the possession in many cases. Resettlement colonies have been encroached by people other than the displaced people for 70 to 80 years now," alleged Tripathy. Similarly, the families displaced for various projects of Indian Railways under

Land Acquisition Act, 1894 and Railways Act, 1989 have only received the compensation. The displaced families are yet to get any land.

Tripathy has urged the NHRC to order the authorities for providing project wise details of displacement. The activist has also requested the commission to recommend the state government for establishment of a commission for the displaced people in order to address the plight of the large scale displaced people.

STATE SEES 1,029 **NEW COV CASES**, **2 MORE DEATHS**

Bhubaneswar, July 31: Odisha reported 1,029 new Covid-19 cases Sunday, while two more patients died of the disease, the health department said.

There are 6,608 active cases in the state at present, according to a bulletin. The positivity rate was 5.16 per cent as the new cases were detected after testing 19,954 samples. As many as 175 children were among the new patients.

Sundargarh reported the highest number of 222 cases, followed by 173 in Khurda, where Bhubaneswar is located.

The toll rose to 9,140 with the deaths of one person each in Bhubaneswar and Puri.

The state had logged 981 cases Saturday.

The state has so far reported 13,13,145 COVID-19 cases. Of them, 12,97,344 people have recovered, including 1,051 in the



Antibiotics in kids may cause permanent asthma

arly exposure to antibiotics kills healthy bacteria in the tive tract and can cause asthma and allergies, claims a new study conducted on mice.

The study, published in 'Mucosal Immunology', has provided the strongest evidence, so far, that the long-observed connection between antibiotic exposure in early childhood and later development of asthma and allergies is causal.

"The practical implication is simple: Avoid antibiotic use in young children whenever you can because it may elevate the risk of significant, long-term problems with allergy and/or asthma," said Martin Blaser, director of the Center for Advanced Biotechnology and Medicine at Rutgers

University in the US. In the study, the researchers from Rutgers, New York University and the University of Zurich, noted that antibiotics, 'among the most used medications in children, affect gut microbiome communities and metabolic

In the first part of the experiment, five-day-old mice received water, azithromycin or amoxicillin. After the mice matured, researchers exposed them to a common allergen derived from house dust mites. Mice that had received either of the antibiotics, especially azithromycin, exhibited elevated

rates of immune responses—allergies. The second and third parts of the experiment tested the hypothesis that

early exposure to antibiotics (but not later exposure) causes allergies and asthma by killing some healthy gut bacteria that support proper immune system development. Lead author Timothy Borbet first transferred bacteria-rich faecal samples from the first set of mice to a second set of adult mice with no previous exposure to any bacteria or germs. Some received samples from mice given azithromycin or amoxicillin in infancy. Others received normal samples from mice that had received water. Mice that received antibiotic-altered samples were no more likely than other mice to develop immune responses to house dust mites, just as people who receive antibiotics in adulthood are no more likely to develop asthma or allergies than those who don't.

Things were different, however, for the next generation. Offspring of mice that received antibiotic-altered samples reacted more to house dust mites than those whose parents received samples unaltered by antibiotics, just as mice that originally received antibiotics as babies reacted more to the

allergen than those that received water. "This was a carefully controlled experiment," said Blaser. The only variable in the first part was antibiotic exposure. The only variable in the second two parts was whether the mixture of gut bacteria had been affected by antibiotics. Blaser added that these experiments provide strong evidence that antibiotics cause unwanted immune responses to develop via their effect on gut bacteria, but only if gut bacteria are altered in early childhood.

The boy, son of daily wage workers from Odisha, approached the hospital with fever and rashes The doctors isolated him and collected his samples. The samples, including swab from throat, blood, urine, from lesions on skin, have been sent to Pune.

Officials said the reports are likely to be available Monday.



BMC to auction off defunct food vehicles, tyres

Bhubaneswar, July 31: In a bid to reduce spread of dengue, the Bhubaneswar Municipal Corporation has decided to identify and penalize individuals who are found illegally stacking/dumping defunct food vehicles, carts, and unused tyres in state capital.

Issuing a Standard Operating Procedure (SOP) against management and disposal of defunct vehicles, food carts, wooden thelas, rickshaw and unused tyres

in public places of different wards, the BMC stated that such items thrown abruptly in different wards create aesthetic problem and unhygienic condition by providing breeding platforms for mosquitoes and flies.

"After identification of location and person illegally stacking/dumping such items the Zonal Deputy Commissioner (ZDC) shall issue a notice to the violator. In case the person is not identified, the enforcement squad will seize the item in seven days after issuance of notice. The BMC will then initiate the process of auction of the seized material. The unused tyres could be sold out to tyre shops through auction for tyre retreading purpose while other items may be sold through e-auction," said a BMC official.

Moreover, the BMC will also create awareness among citizens against the same with organisation of activities like radio jingles and street plays. Discussions will also be held in ward meetings to discourage people from such activities.

"Regular meetings will be conducted by enforcement squad with automobile workshops, fabricators, engineering workshops, tyre shop and kabadiwalllas. Awareness creation and enforcement activity shall be carried out parallelly to avoid unauthorized stacking/dumping of defunct vehicle and unused tyres in public places or roads through enforcement squad under the guidance of concerned ZDC," a BMC notifi-

onkeypox can spread from close physical contact regardless of sexual orientation or race and scapegoating or demonising the entire LGBTQ community as 'spreaders' will be a repeat of the mistake made during the AIDS epidemic, healthcare professionals and activists have said.

The monkeypox outbreak has raised widespread fear for the LGBTQ community amid reports of the disease being traced among men having sex with men.

Indian equal rights activist Harish Iyer said monkeypox doesn't just spread in the LGBTQ community.

"It happened in the community when there was pride month going on and there were more events in the community. It is just an episode of everyone going to a wedding and then getting Covid. So you need to look at them as victims and not perpe-

trators," Iyer told PTI. He further said the monkeypox outbreak is already stigmatising the community and people who developed fever and are scared to go for a medical test

"Even AIDS was called a gay-related disorder because it was believed to spread in gays only. But even heterosexuals can have multiple partners.

"WHO has a precedent. They know what happened during the AIDS $\operatorname{\sf epi-}$ demic and their cautionary message could have been more clear. They could have been more careful with that. Why do they assume that heterosexuals don't have multiple partners," Iyer said.

The World Health Organisation (WHO) issued a public health advisory stating that "some cases (of monkeypox) have been identified through sexual health clinics in communities of gay, bisexual and other men who have sex with men".

The world health body also asked men having sex with men to limit their partners.

Trans-community health expert Anmol Singh said there is a risk that people will now start distancing themselves from the community

which will further isolate them. "Stigmatised thinking that we have more sexual partners or we are more into sex work than any other straight person will create more negativity," Singh said.

Healthcare professionals have also clarified that monkeypox can



spread from close physical contact regardless of sexual orientation or race

Somesh Gupta, professor in the Department of Dermatology and Venereology at AIIMS, Delhi, said the Covid pandemic seems to have galvanised the efforts of the mainstream media to report on the latest developments in healthcare.

"We should urge media outlets, governments, and communities to respond with a rights-based, evidence-based approach that avoids the stigma.

"Stigma and blame undermine trust and capacity to respond effectively during outbreaks like this one," Koul said. Raj Mariwala, Director, Mariwala Health Initiative, said it is very important to look at public health messaging critically.

"Instead of scapegoating or demonising entire communities as 'spreaders' or using the label of suspects, it is important to focus on accessible and affirmative ways to talk about how to protect oneself while being accurate about how the virus is transmitted.

NO RPDAC MEETINGS IN BOLANI SINCE 2016

Development in mining areas takes backseat

Keonihar, July 31: As meetings of the Rehabilitation and Peripheral Development Advisory Committee (RPDAC) are not being held regularly, development in Bolani area of Keonjhar district has taken a backseat, sources said Sunday.

Some members of RPDAC and activists of a voluntary organisation recently met Union Minister Arjun Munda and apprised him of the need for holding RPDAC meetings to carry forward developmental works in mineral-bearing Bolani locality. They have also written July 28 to Chief Minister Naveen Patnaik in the regard.

Locals said that though the Odisha government is aware that no RPDAC meetings have taken place in the last two years, no steps have been taken in this regard. This has resulted in a stalemate in developmental works in Bolani.

It was learnt that the last time of RPDAC for the mining-affected Bolani locality was held in 2016. At that time, several decisions had been taken for various develop-

mental activities as promised by SAIL in the area. The RPDAC should have reviewed how far developmental activities have been implemented and what works have remained unfinished, sources said.

Still, mineral extraction and transportation have been going on smoothly and SAIL has been raking in the moolah. During expansion of mining projects, SAIL had Some members of RPDAC and activists of a voluntary Minister Arjun Munda and apprised

promised to do various developmental works and accordingly locals had supported it and given their consent in favour of the expansion of mining operations.

However, locals alleged that developmental works promised by SAIL have not been executed. Many local issues have been left unresolved. SAIL had set up an ITI near Bolani slum, but it has remained

closed since in 2016-17. There was plan to upgrade a school to the higher secondary (class XII) level. However, still now students can only study up to Class II in the school, locals pointed out.

SAIL had also promised to set up a pellet and beneficiation plant to utilise raw material in the area so as to create scope of employment for the locals. However, the project hasn't taken off.

RPDAC's role assumes significance with the government stressing industrialisation to foster economic growth and alleviating unemployment.

As per guidelines, the decisions taken by the RPDAC are executed in the mining-hit and industrial areas. If the administration had held the RPDAC meetings in time, such issues would been discussed so as to remind the company of executing its promises, sources said.

In the absence of development, local people have to suffer a lot. They have urged the administration and the Union Minister to ensure that RPDAC meetings are held regularly in the larger interest of the mining-hit people.

One such case has come to the fore in Garadpur area where over ₹2 crore meant for drainage restoration has allegedly been misappropriated through fake bills.

Locals and farmers from four panchayats have taken up the issue with the Kendrapara district collector and the superintending engineer of the drainage division. According to reports, hundreds

of acres of low-lying farmlands and swamp lands like Hariankapata, Paniola, Janrabarimula and Hurasahipata under Garadpur block get waterlogged during the monsoons and this is an annual problem. Farmers of Bangalpur panchayat in the past had repeatedly urged the collector and the authorities of the drainage division to lay hume pipes wherever necessary.

Years later, the drainage division had allocated ₹2 crore for the

Nayagarh, July 31: A plan to to ensure enough fodder for elephants in this district has been mired in controversies and irregularities attributed to forest officials, a report alleged.

The plantation of mango saplings has been taken up under the Compensatory Afforestation Fund Management and Planning Authority (CAMPA). The plan is to plant 25,000 saplings on 50 hectares of land in Gochha reserve forest and 30,000 saplings on 150 hectares of land in Banijhari proposed reserve forest area.

Reports said that a mango forest is being created to provide food for the elephants at Gochha reserve forest and proposed Banijhari



reserve forest under Panchrida forest range of Nayagarh division.

The plan was to plant 55,000 mango saplings but forest officials have planted only 4,000 much to everybody's disappointment. Moreover, it has been alleged that

dug up under Sal trees. It is a wellknown fact that mango saplings will never grow under another tree. Moreover, the pits are only six inches in depth instead of the 1.5 feet required for the growth of mango saplings.

Forest officials have also not implemented any steps to protect the saplings. It was alleged that many saplings got destroyed as they were just placed besides the dug up pits. These rotten saplings were thrown into water bodies and new saplings were purchased after a video of it went viral.

Residents Rabindra Pradhan and Ranka Pradhan alleged that the forest guard at the Gochha beat house is siphoning off lakhs on the pretext of plantation. The guard has been transferred but he has managed to stay on at the same

ACF Himanshu Sekhar Muduli said that he will conduct a probe into it. DFO Kshyama Sarangi said she will order a probe into dumping of saplings.

Water contamination causing ← diarrhoea in Gajapati villages

Paralakhemundi, July 31: A report on samples collected from P Gobindapur village under Mohana block in Gajapati district stated that a number of wells have contaminated water. It is the main reason for which diarrhoea has broken out in the village, chief district medical offi-

cer Mubarak Ali said. Notably, a minor girl died of diarrhoea in P Gobindapur village while 23 people have been affected by the disease. A medical team has visited the village and took stock of the situation. Health officials had earlier collected samples from eight sources of water and sent them for testing.

In the report, two of the samples have confirmed water contamination. This has created panic among local residents with the water-borne disease spreading by the day. Four people hit by diarrhoea were hospitalised Saturday.

The CDMO advised the people not to panic, but to maintain sanitation and drink safe water. Another medical team has sensitised people about precautionary measures. Meanwhile, efforts have been initiated to provide hygienic drinking water to the villagers. The report has also been submitted to officials of the district administration.

Elephant alert equipment goes defunct in Dhenkanal

Risks for vehicles, commuters increase on National Highway-55

Dhenkanal, July 31: A siren and alert light system that was put up on an experimental basis on National Highway-55 to warn commuters and vehicles about the presence of elephants has gone out of order, a report said. This has put the lives of commuters in danger as they are now deprived of advance information about the presence of animals on national highway. With the system not working, life has become risky for both commuters and vehicles.

Reports said, a voluntary outfit with help of the Forest department had installed the siren and alert light system near Rasasingh. The siren would automatically blare out a high decibel sound and the light would keep flashing at night if any elephant strayed near the highway. However, the equipment turned



defunct after rainwater seeped inside it a few weeks ago.

The locals informed the Forest officials about the development, but the latter are yet to take a call on it. Meanwhile, a herd of elephants strayed into Dhenkanal district near the Ambithi village on the fringes of Bantala locality in neighbouring Angul district.

As per reports, over 326 elephants are staying in various forest ranges in Dhenkanal district. Among them, 225 elephants were found in the Hindol forest range, the officials said.

When contacted, DFO Prakashchand Gogineni said confirmed that the siren and alert light installed on the NH-55 is out of order. He said that an agency in Coimbatore in Tamil Nadu has been asked to repair the equipment on an urgent basis.

Weaponising Gas

urope is caught between the devil and the deep sea. Russian President → Vladimir Putin has turned out to be the devil. The prospect of a severe ✓ economic dislocation, a freezing winter a few months away and weakening of Europe's fight against climate change because of a renewed use of coal-based energy is the deep sea. Putin has resorted to what Ukraine's President Volodymyr Zelenskyy calls "an overt gas war" to force Europe to withdraw sanctions against Russia for the latter's invasion of Ukraine. When he attacked Ukraine in February, Putin had calculated he would win quickly and the West would meekly surrender to his blatant dictatorial behaviour. But, Ukrainians stood up to the challenge and are still spiritedly defending their country against Russian aggression. This has forced Putin to use Europe's reliance on Russian gas exports as a weapon to undermine Western solidarity, forcing it to lift sanctions and acquiesce to Moscow's territorial greed. The more the resistance by Ukraine frustrates Russia's design, the more Russia tries to blackmail Europe by cutting the flow of gas through the main east-west pipeline. The message to Europe from Moscow is loud and clear – be soft on the war and enjoy a warm winter with enough gas heating homes, or else, shiver during the freezing winter and suffer industrial breakdown for want of gas generated electricity.


As things are going out of control, European Union members have agreed to cut gas usage by 15 per cent as part of a phased move away from reliance on Russian supplies. But, there are chinks in the EU armour as some countries are opting out of the deal or vacillating fearing dire consequences due to reduction in the supply of Russian gas. For example, Hungary, the EU state close to Russia, has not signed the deal at all. Brussels, the EU headquarters, believes energy security will strengthen transnational collaboration and ensure political, economic and strategic integration. But, the reality is Russia's decision to turn off the gas tap has already brought tensions between member states. While Spain has taken care to improve its infrastructure to help it diversify its energy supply, Germany has only increased its reliance on Russian gas through the 1,200 km-long Nord Stream 1 from the Russian coast near St Petersburg to north-eastern Germany. France will not be directly hit by Russia's gas war since its power supplies are mostly nuclear, but President Emmanuel Macron is worried, as an advocate of European integration, about a wider threat to the eurozone if the German economy is damaged by soaring gas prices. The majority shareholder of Nord Stream 1 is the Russian state-owned company Gazprom. By the end of June, Germany was importing 26 per cent of its gas from Russia through Nord Stream 1. But using the alibi of overhauling a boiler, Gazprom cut gas deliveries by 75 per cent. In early July, it shut down Nord Stream 1 for 10 days. Though it partially reopened it in the third week of July, it soon announced the supply would taper off. This pushed up wholesale prices of gas in Europe which are now 450 per cent higher than they were during the corresponding period last year.

The whole Russian move appears well calculated. It declared war against Ukraine in February and did not immediately use its gas supply as a bargaining chip to ease sanctions by Europe. It waited for the next winter to set in so the need for gas would be direly felt and creating alternatives of building terminals for LNG (liquefied natural gas) and getting new sources would prove too costly and time-consuming.

Putin is using Russia's gas muscles so effectively that Europe is fast becoming helpless against his manoeuvres. The weapon of sanctions is being blunted by Russia's gas strategy.

Verbigeration

he American actor, musician, and author John Lithgow remarked in a newspaper interview in February 2015 that verbigeration was his current favourite word. Though it describes the use of words, the concern of any actor or writer, Mr Lithgow would surely not wish it to be applied to himself. One might guess that it refers to the bigging up of verbs, though it's actually said with a soft q, like refrigeration. The association isn't altogether wrong. as it refers to the involuntary repetition of meaningless words and phrases. The psychiatrist Bernard Glueck described it in 1916 as "senseless word salad". Another writer, G Stanley Hall, in a work ten years earlier with the off-putting title Youth: Its Education, Regimen, and Hygiene, preferred to define it as "The continual utterance of certain words or phrases at short intervals, without reference to their meaning." It has been regarded as a symptom of a mental disorder, though we in the UK, currently in the run-up to a general election, may feel it could be used to describe certain British political figures. Its source is Latin, verbum, a word (also the source of verbiage), plus the verb ger re, to carry on or conduct, from which derived the Latin verb verbiger re to talk or chat. An isolated early appearance of verbigeration in English was in the dictionary Glossographia in 1656; Thomas Blount, who compiled it, defined it in this neutral Latin sense. However, nobody else bothered with it until it was reinvented late in the nineteenth century by the British physician Daniel Hack Tuke. It was never popular and was soon after replaced by palilalia, taken instead from Greek: palin, again, plus Ialia, talk or speech. There's also echolalia, from the same root, which is similarly involuntary repetition, but of the words of another person.

Verecund

verecund person is modest, bashful or shy. The Oxford English ADictionary's entry for this word, published back in 1916, doesn't suggest it's obsolete or even rare. In fact, it hasn't yet quite vanished, though it has never been common. You need to have learned Latin in your youth - once standard for educated writers of earlier generations, of course - to have been likely to include this word in your prose. Its heyday, insofar as it ever had one, was roughly in the half century after 1850. It turns up in an article penned by an erudite columnist in the issue of The Marion Weekly Star of Ohio dated 17 February 1912, in a comment that can only make us marvel at how times have changed: What this country needs is men who are not afraid to proclaim to the public their virtues of mind and character. There is too little of the projection of self into the arena. Our politics is speckled with men who are so diffident and verecund they never say a word about themselves or their achievements. The only example one can find from modern times is in Translations by the Irish playwright Brian Friel, which was first performed in 1980. The play is set in 1833 and in it characters speak Irish, Greek, Latin and English.

MALARIA COMEBACK


√he dreaded malaria can make a comeback amid global warming and heavy rains and needs three times more allocations a year. India could suffer severe economic hardship, and wage and production loss as it accounted for 83 per cent of malaria cases and 82 per cent deaths in South-East Asia in 2021, says the World Health Organisation.

South East Asia has 4.2 million cases and 7341 deaths. Climate change and global warming can accentuate the problem amid a global commitment to eliminate malaria by 2030, according to Soumya Swaminathan, the Chief Economist of WHO.

Annually, India spends about \$1.94 billion on malaria, according to an estimate in 2017 by Indrani Gupta and Samik Chaudhury of Ambedkar University. But it may have to increase allocations as the WHO finds that its own estimates need at least three times rise a year. According to the WHO report, current funding levels (estimated at US\$3.3 billion in 2020) will need to more than triple, reaching US\$ 10.3 billion per year - \$ 80.24 billion by 2030, target year for elimination of the disease. Malaria can strain national economies, impacting some nations' GDP by as much as an estimated 5–6 per cent. It includes 75 per cent losses on productivity/wages and the rest on treating the disease, says Gupta.

India needs enormous budgetary allocation, a severe strain for a government under financial constraint. It is said that malaria is manageable and controllable. The 15th Finance Commission recommended unconditional grants of Rs 1 lakh crore for the health sector for five years and told the states to spend 8 per cent of their budget on health. The Economic Survey 2020-21 says that out-of-pocket expenses by households on health is one of the highest in the world more so if treated in private sector.

Mumbai has warned of malaria spread as in June 2022 itself it detected 57 cases and 119 cases in the first week of July. Assam has recently issued a warning on vector borne diseases as 74 encephalitis

cases have been detected. The North-East has very high incidence and malaria-related anaemia Similarly, Delhi reported detection of 126 dengue cases in June but is silent on malaria. In western Uttar Pradesh, medical officer Dr Avanindra Kumar issued an alert and created special malaria-dengue wards at 10 primary health centres in early July. Rajasthan had heavy rains this year. The incidence of malaria in 2021 had increased marginally to 649 cases from 449 cases in 2020 and dengue case 1022 cases

The Union Health Ministry says despite powerful drugs to treat malaria, the last two years of COVID pandemic has thrown up challenges for diagnosing malaria. Several symptoms are so common "it has become harder for medical professionals to discern from initial symptoms leading to misdiagnosis or worse no diagnosis." No wonder that there remains a gap between Indian national data and that of the WHO.

Various data and information from Purulia, Jalpaiguri in West Bengal, Kheda in Gujarat and WHO may be an indicator of the losses because of the vector-borne disease. New data from the WHO reveals that the COVID-19 pandemic has disrupted malaria services, leading to a marked increase in cases and deaths. According to its latest World Malaria Report 2021, there were estimated 241 million malaria cases and 627,000 malaria deaths worldwide in 2020. This represents about 14 million more cases compared to 2019, and 69.000 more deaths. Approximately two-thirds of these additional deaths (47000) were linked to disruptions in the provision of malaria prevention, diagnosis and treatment during the pandemic.

Malaria cases and deaths remain unacceptably high and are resurgent in several settings. though recent developments inspire optimism. The report states that between 2.7 million and 5.9 million cases were reported in India in 2020, whereas the official records say about 187,000 cases were reported. Director of Malaria No More, Pratik Kumar, says that one of the reasons for disparity remains malaria burden diverted to the private health sector, which now is catering to a large segment of healthcare facilities. The disparity is also noticed in numbers 10.9 lakh malaria cases were reported in 2016 while the sales of antimalaria drugs were ten times more Acknowledging the factor Odisha Chief Minister Naveen Patnaik has asked private healthcare facilities to report such incidence.

Despite gains over the last 15 years, malaria control has stag nated, with resurgence and rising morbidity in several highly endemic countries exacerbated by

service disruptions due to the COVID-19 pandemic, says a study Challenges, Cautious Optimism by Prasanna Jagannathan & Abel Kakuru in Nature Communications.

Indrani Gupta notes that an analysis of the trend and patterns in public expenditure by the National Vector Borne Disease Control Programme shows a declining focus of the central government on vector-borne diseases. Also, allocation of financial resources among states does not reflect the burden of malaria, the major vector-borne disease in the country.

Data reporting in public domain seems to be less during the past few years. It is stated that since larger numbers are treated in private hospitals and clinics data prospecting has suffered. "The fight against malaria has recorded immense progress in the recent years. However, as seen in the past, malaria has a history of bouncing back with a vengeance. Through active media attention. key gaps and issues can be regularly highlighted, ensuring that those are addressed in strategic and policy decisions. This will help India expedite efforts towards malaria elimination," says Kirti Mishra, chief technical officer,

Odisha, Malaria No More. The 2020 report of the WHO Strategy Advisory Group on malaria eradication has looked at this in detail and does provide useful information, especially with respect to malaria transmission and the vulnerability of populations to malaria as 95 per cent of Indians live in malaria-prone areas.

Soumva Swaminathan says the basic WHO position is that climate change is likely to increase rather than decrease the risk of malaria transmission. The WHO is testing genetical modification of mosquitoes to counter malaria but warns that India should not use it as field trials are several years away.

The true meaning of cybersecurity

security, we usually think of commercial antivirus software, ransomware attacks on large corporations, or leaks of politically scandalous emails. But little is said about public security in the digital realm, and that is a big problem when we increasingly depend on information and communication technologies (ICTs) and the Internet of Things to carry out our ordinary daily activities.

Moreover, these technologies' rapid development has led to a hybridisation of crime. Many illicit activities now straddle the physical and virtual worlds, which has introduced new trade-offs and calls for a reconsideration of longstanding law-enforcement strategies.

Consider illegal recreational substances. Many people now seek to acquire these over the internet, because buying online is generally seen as safer than meeting a stranger in a dark alley. But online channels tend to put people into direct contact with the organised crime groups that control most of the distribution of illicit substances. When people hand over money to these groups, they are unwittingly helping to fund the global networks that also finance terrorism and traffic in arms, people,

It is well known that the COVID-19 pandemic accelerated many forms of digital innovation and adaptability, and online drug purchases are no exception. Amphetamine-type stimulants and new psychoactive substances are increasingly available on the darknet, the open web, crypto markets, and even social media. There are both risks and potential benefits associated with these new distribution channels. On a positive note, analysing digital data flows could allow for faster detection of novel psychoactive substances that pose a threat to public health. And, of course, transacting on crypto markets or through similar digital channels can protect individual users from physical violence, theft, sexual exploitation, and abduction.

Moreover, recent studies show that people who use drugs and acquire substances through ICTs are more likely to adopt harm-reduction practices and promote responsible use, generally because they are operating from the privacy of their homes or other safe settings. Governments and law-enforcement authorities should keep these findings in mind as they seek to create safe public spaces online. While the state alone is responsible for

policing criminal activity is not its sole purpose; it also must ensure public health and uphold fundamental rights such as privacy. And in the case of drugs it will need to be more thoughtful about who is really a criminal, and who is a victim.

Accordingly, many law-enforcement strategies should be reconsidered, and resources should be redirected toward strengthening the competencies of nascent cybercrime units. Rather than pursuing recreational substance users and markets, investigative efforts should focus primarily on ICT-mediated criminal activities and operations that pose a significant threat to the general public.

Here, a promising new model is "pre-arrest police diversion" or "deflection." This collaborative intervention strategy connects law enforcement, biopsychosocial agents, and public-health systems to create community-based treatment and support pathways, so that drug users do not have to enter the justice system. To create safe digital spaces, we need to shift public actions visà-vis drug users from a repressive perspective to an educational one. That means leveraging specialised law-enforcement units and optimising the reach of biopsychosocial

also can start to rebuild the lost trust between this population group and law-enforcement agencies.

These methods are known to reduce the impact of controlled-substance use on communities and households, while freeing up lawenforcement resources to focus on what really matters, such as terrorist financing, the rise of new opioid markets, counterfeit pharmaceuticals, arms trafficking, and child sexual-abuse material distributed online.

As long as states insist on criminalising recreational substances, people will continue to seek them on the black market, and law-enforcement agencies will continue to fight an uphill battle. But with the right strategies in place, ICTs have enormous capacity both to reduce harm to drug users and to empower law enforcement to focus on truly pernicious criminal behaviour. As the world increasingly moves online, we must recognise that cybersecurity is about more than preventing hacks and fraud. It is also about improving the safety, health, and well-being of the people behind the screens.

Heroin seized

Guwahati: The Assam police Sunday seized heroin valued at around Rs 8 crore, and arrested two persons on charges of drug peddling from Bokajan area of Karbi Anglong district. As per reports, the police had specific information about the activity of the peddlers in the area and on this, they intercepted a vehicle at Khatkhati in Bokajan. Following the search of the vehicle, around 75 boxes containing 966 grams of heroin were seized. Police held two persons who were in the vehicle. 4 Haryana MLAs threatened: Police

Chandigarh: Four legislators in Haryana received death threat and extortion calls from multiple phone numbers tracing to the countries in the Middle East from June 24 to 28, the police said Sunday. First Information Reports (FIRs) were lodged against the threats and had been assigned to the Special Task Force STF by DGP P.K. Agrawal to investigate. Technical analysis of these mobiles has confirmed that these numbers are registered in the Middle Eastern countries and were being operated from Pakistan, said an official statement.

Over 1,200 cattle perish in Gujarat

Ahmedabad: Gujarat Agriculture Minister Raghavji Patel has said that 1240 cattle have died so far due to lumpy skin disease in the state. However, Opposition alleged that the death toll is 25 to 30 times higher, claiming the state government is hiding the death toll as it did during corona pandemic. Around 50,000 cattle infected with lumpy virus are being treated. 1240 died and 15 lakh are being vaccinated, the minister said in Jamnagar on Saturday evening, after a meeting with Jamnagar Municipal Corporation officers.

2 killed as bus, car collide in Noida

Noida: Two people were killed while another was critically injured in a bus and car headon collision in Noida on Sunday, an official said. The deceased were identified as Purushottam (45) and Rinku (35), both residents of Bulandshahr, Uttar Pradesh. According to the official, the incident took place on the Jhaajar-Rabupura road near village Mohammadpur when a private bus on its way to Rabupura from Jhaajar crashed into a Renault Triber that was coming from the opposite side.

Can Agra cope with the exploding motor vehicles' population?

Chandigarh, July 31: Farmers Sunday squatted on railway tracks and blocked roads at several places in Punjab and Haryana as part of the Samyukta Kisan Morcha's nationwide protest against the Centre "reneging on its promises" made when the agitation against now-repealed farm laws was withdrawn last year.

In Punjab, the Ferozepur division of Indian Railways had to cancel or reschedule several trains because of the four-hour agitation. As a result, scores of passengers were forced to wait at various railway stations for hours.

According to railway officials, Amritsar-Pathankot, Amritsar-Qadian, Pathankot-Verka were among five trains which were cancelled while eight trains, including Amritsar-Jaynagar, Amritsar-Sealdah, Shri Mata Vaishno Devi Katra-New Delhi, Amritsar-New Delhi and Amritsar-Aimer Express were rescheduled.

Two trains -- Bathinda-Fazilka and Fazilka-Bathinda -- were short terminated, they said."I, along with my wife, came here for treatment. We had to return to Jammu today. Our train, which was scheduled to arrive at 10:30 am, got delayed for several hours," said a



Jammu-based man at Jalandhar railway station.

A woman from Jandiala was to go to Jammu to pay obeisance at the Mata Vaishno Devi shrine but her train also got delayed due to the farmers' agitation. "We have been waiting for the train for hours," said the woman. Many trains were stopped and roads were blocked at several places from 11 am till 3 pm.

Bharatiya Kisan Union (BKU)-Kadian president Harmeet Singh Kadian, participating in the protest at Phillaur railway station, said the farmers were holding the protest on the call given by the Samyukta Kisan Morcha (SKM), an umbrella body of farmers' unions.

Farmers alleged that they were forced to squat on rail tracks as the Centre was "not listening to

Public grievance redressal time cut

New Delhi, July 31: Union Minister Jitendra Singh on Sunday said the time for redressal of public grievances received on an online portal has been reduced from 45 to 30 days.

He said this decision is in keeping with Prime Minister Narendra Modi's emphasis on effective implementation of public grievance redressal mechanism with disposal of grievance within minimum possible time, but with maximum possible satisfaction of the complainant.

Singh, the Minister of State for Personnel, said an order issued by the Department of Administrative Reforms and Public Grievance (DARPG) also states that a complaint received from a citizen will not be closed until an appeal filed against it is disposed of. Last year, the DARPG had reduced the maximum time limit to 45 days from 60 days to resolve public grievances, a statement issued by the Personnel Ministry said. Singh said under the leadership of PM Modi, every attempt is being made to implement an effective public grievance redressal system and bring about administrative reforms at par with global standards to promote satisfaction among the people.

Monkeypox scare: Man kept in isolation

Chennai, July 31: A 35-year-old man who arrived at Tiruchi airport on Friday and had a skin rash -- a symptom of monkeypox, is kept in isolation at Pudukkottai Medical College Hospital in Tamil Nadu.

The man was sent to Mahatma Gandhi Memorial Government Hospital, Tiruchi on Friday but he went missing from the place. The hospital authorities informed the police and the health department about it. Later, he was found at his residence in Pudukkottai on Saturday and taken to the Medical College Hospital there. The authorities instructed the family of the person to isolate themselves until a complete diagnosis is made.

ED RAIDS RAUT'S RESIDENCE

Mumbai, July 31: The Enforcement Directorate (ED) probing a money laundering case Sunday conducted a search at Shiv Sena MP Saniav Raut's residence in suburban Bhandup for nine hours and questioned him before shifting him to the agency's office in south Mumbai in the evening, sources said.

Raut claimed he was being framed based on "false evidence" but won't bow down and guit the party, shortly before being herded into the south Mumbai office of the ED. "They (ED) are going to arrest me. I am going to be arrested.' Raut told reporters outside the ED office after he was brought there from his Bhandup residence.

"Zukega nahi (won't bow down)," Raut said, putting up a brave front. He alleged that the ED action was aimed at trying to weaken Shiv Sena and Maharashtra and that a "false" case is prepared against him. After the ED action began in the early morning, Raut tweeted that he will die, but will not surrender and never leave Shiv Sena.

At 7 am on Sunday, ED officials, accompanied by Central Reserve Police Force (CRPF) personnel, reached Raut's 'Maitri' bungalow of Raut and began the search. The action follows two summonses issued by the ED against Raut, the latest being on July 27.

Raut was summoned for questioning by the ED in a money laundering case linked to the alleged irregularities in the re-development of a Mumbai 'chawl' and related transactions involving his wife and 'associates'.

He had appeared before the agency in Mumbai to record his statement on July 1 but after that, he skipped the two summonses issued by the agency citing the ongoing Parliament session. The Rajya Sabha MP, who is a Uddhav Thackeray loyalist, had denied any wrongdoing and alleged that he was being targeted due to political vendetta.

I-DAY SPIRIT

In the late afternoon, Shiv Sena supporters holding saffron flags and banners raised slogans against ED when officials moved out with Raut outside his bungalow in Bhandup. Sena workers tried to block the path of vehicles of ED but they were removed by local police. an official said, adding some protesters were bundled into a police van.

Before going with ED officials, Raut came down at the gate of his home, waved at his supporters and displayed a saffron scarf. Raut's mother, who was standing at the first-floor window of their bungalow, became emotional along with his other relatives.

New Delhi, July 31: Undetected and untreated hypertension is the top risk factor for stroke which is the second leading cause of death and disability after ischemic heart disease across the world.

Studies have shown that at least 64 per cent stroke patients have hypertension which is the most prevalent risk factor for this deadly cardiovascular event. With stroke

burden increasing exponentially in the country, doctors from All India Institute of Medical Sciences (AIIMS) say it is time now to focus on hypertension treatment - a prevention strategy that is achievable and can save millions of lives.'

"It is time we recognise that hypertension, an easily treatable condition, has far reaching repercussions. Raised blood pressure can result in stroke which not only causes premature death and lifelong disability, it can throw families into irrecoverable financial shocks and loss of income. Increasingly in India, the stroke survivors are a relatively younger population. We must bear in mind that this means loss of income and a work life curtailed," said Dr Pradeep Aggarwal, Professor, Community

Medicine, AIIMS Rishikesh. Stroke is responsible for an es-



timated 5.6 million deaths and 116.4 million Disability Adjusted Life Years (DALY) worldwide, as per 2016 data. In India, incidence of stroke ranges from 116 to 163 people per 100,000 population. Studies have revealed that the increasing prevalence of hypertension in India is likely to push up the stroke burden of the country.

Dr Surender Deora, senior cardiologist, AIIMS Jodhpur warns that severe hypertension has been correlated with a poorer prognosis and even higher mortality in stroke patients. "In majority of cases we see that ischemic stroke is linked to poor control of high blood pressure. What we describe as the stroke burden is not just due to its high

mortality rate. Stroke is a massive public health and well-being concern because up to 50 per cent survivors remain disabled for the rest of their lives. This has a devastat-

ing socio-economic impact." According to a study on stroke epidemiology in India, the incidence of stroke in South Asian countries has increased by more than 100 per cent in the past four decades. By 2050, it is estimated that 80 per cent of the burden of new strokes will be on low- and middle-income countries. As a result of the epidemiological transition sweeping through India, stroke prevalence is all set to rise in the

coming years. Dr Pankaj Bharadwaj, Additional Professor, Dept. of Community and Family Medicine and Dean, School of Public Health, AIIMS Jodhpur, said, "Paying attention to the stroke-hypertension connection now will pay dividends in the future. There is no dearth of evidence from clinical practice and from the grassroots that untreated and uncontrolled blood pressure is the most common cause for stroke. We must do what we can to reign in the damage caused by high blood pressure, treatment for which is affordable and easily available.

Although, high blood pressure has become a health crisis with at least one in four adult Indians suffering from this condition. To meet India's commitment of 25 per cent relative reduction in prevalence of high blood pressure by 2025, till June 2022, Indian Council of Medical Research's India Hypertension Control Initiative (IHCI) has been rolled out in 105 districts across 21 states covering 1500+ health facilities.

Encounter deaths: Assam third in country

51 people died and 139 were injured in police encounters between May 2021 and June 2022 in the northeastern state

Guwahati, July 31: After Jammu & Kashmir and Chhattisgarh, the Northeastern state of Assam occupies the third position in the country in the deaths in police encounters despite the Gauhati High Court, human rights panel, political parties and NGOs asking the state and its security forces to maintain restrain while dealing with offenders.

According to the Union Home Ministry's record, Assam recorded a total of 18 deaths during 2021-2022 even as Jammu and Kashmir led the table with 45 deaths followed by Chhattisgarh with 30

In connection with a Public Interest Litigation (PIL) filed in the Gauhati High Court by a Delhibased lawyer and activist Arif Jwadder, the Assam government through an affidavit had earlier informed the court that 51 people died and 139 were injured in the encounters between May 2021 and June 2022 in 31 of the state's 35



The High Court had directed the Assam government to file the updated investigation report on every police encounter case since May 2021 within six weeks. The court fixed September 29 as the next date of hearing.

Civil rights lawyer and activist Prashant Bhushan and senior lawyer Indira Jaising during their separate appearance for the petitioner, argued in the High Court that the PIL raised the issue of public importance involving the rule of law

"The Assam Police did not follow the law and procedure laid down by the Supreme Court in the 2014 case of People's Union of Civil Liberties (PUCL) versus Maharashtra on alleged fake encounters. The state government

also did not follow the Supreme Court's guidelines on conducting independent inquiries in all the cases of encounters, including those resulting in injuries, Bhushan told the High Court during his recent appearance on the PIL.

Assam Chief Minister Himanta Biswa Sarma after assuming office May 10 last year announced a crackdown on militants, drug dealers, smugglers, murderers, cattle lifters and those accused of rape and crimes against women.

Sarma, who also holds the home portfolio, has emphasised on a 'zero tolerance policy' towards crime and criminals, giving the police 'full operational independence within the purview

Of the 51 people, some were killed in custody, some while 'trying to escape after snatching police's firearm' while several others were shot in the leg.

A few accused died 'after being hit by the police vehicles' while going to verify their (accused) statement at the crime spot.

Jwadder, who also earlier lodged a similar complaint about these alleged 'fake encounters' with the National Human Rights Commission (NHRC), in his PIL said that all the victims were unarmed and handcuffed at the time of the encounter.

"Those people who have been killed or injured were not dreaded criminals. Above all, this petition raises the issue of violations of the rule of law and equality before the law and equal protection of law. Police personnel do not have a licence to kill, the whole idea of the CrPC is to apprehend criminals and bring them to justice, not to kill them.

Jwadder said that the NHRC had earlier taken cognisance of his complaint and asked for an action taken report from the Assam

In 1998, the police made a similar allegation against Bhanumati.



That time, she appeared before a Foreigner's Tribunal court in the state and deposited the voter list of 1965 and 1971, where her father's name was mentioned. Along with that, she deposited Panchayat certificates and other relevant documents in support of her claim as

In 2001, the Foreigner's Tribunal court in Nalbari declared

an Indian citizen.

Bhanumati an Indian, But, after 21 years, the police again accused her of being a foreigner and a notice was sent to her house from Boko's Chomoria police station.

Bhanumati hails from Jashedarpam village in the Barpeta district. She shifted to Boko after her marriage with Gopal Baroi of Trilochan village in the Boko area. She has two sons.

Sanjoy Sarkar, Kamrup district president of All Assam Bengali Parishad, said that the family lives in very poor condition and their sufferings have increased after they received the foreigner's notice recently.

He has also claimed that Bhanumati's name appeared in the National Register of Citizens (NRC) and she has cast her vote in several elections.

Meanwhile, Assam Congress working president and MLA Kamalakhya Dev Purkavastha visited Bhanumati's house and took a jibe at the BJP. He alleged that though the BJP promised to give citizenship to Hindu Bengalis, the ground reality is exactly the opposite; and that in Assam, Hindu Bengalis are targeted in the name of NRC under the ruling dis-

3 PAPERLESS COURTS IN KERALA HC FROM AUG 1

Kochi, July 31: With all in one touchscreen personal computers, where case files would be displayed automatically, being set up in the Kerala High Court ahead of three of its benches becoming paperless courts from August 1, lawyers have hailed the move, but are going to adopt wait and watch approach.

Lawyers old and young have welcomed the High Court's move saying it is primarily environment friendly, it would be time saving as well as cost effective and would do away with the need to avoid carrying around huge and bulky files.

However, at the same time lawyers, especially those used to arguing from physical files of cases for decades, are apprehensive how helpful the new system would be

Advocate Philip T Varghese, who represents actor Dileep in the 2017 actress assault case, said it was a welcome initiative and there probably would be some teething

Moreover, we all need to be able to adapt to the change in technology, he added.

"However, it would not mean a complete prohibition on use of paper or physical files. Those who



are not comfortable using the computers or other electronic devices would have the option to use physical files," he further said

He also said that while he was more comfortable using the physical files, he would be giving the new system a try.

A similar view was expressed by advocate AK Preetha, who represents the victim in the rape case against actor-producer Vijay Babu. who said she feels more confident arguing from physical files.

At the same time she concedes that it was a move which would be hugely environmentally friendly as in most cases lawvers have to make several sets of the judgements to be cited as well as other documents of a case.

She said that it would be very convenient for judges as they can avoid sifting through huge casefiles as all the details would be available to them at a click of a mouse button.

It would also be easier for the younger generation of lawyers who are already accustomed to using the latest technology and electronic devices, she noted.

Guwahati, July 31: The flood waters have receded in Assam and the affected people are busy trying to rebuild their lives.

But the situation is challenging, particularly for the nearly 20 lakh children who have been severely hit by the deluge

Schools have been damaged, books and learning material are destroyed by water, fear of being preyed upon by human traffickers is lurking, coupled with the trauma of witnessing the death of family members during the natural calamity.

This year's flood in two waves affecting 90 lakh people has been the worst in the state in terms of fatalities, claiming over 200 lives, of which 70 were children.

For 12-year-old Moina Biswas of Paschim Hatimora village in Hojai district, living in relief camps has been an annual ritual and this year it was particularly heartbreaking when her three-year-old sister was washed away in the



flood waters as they were moving to safety in a small country boat.

'We lose household goods during floods every year but my sister's death is something I cannot come to terms with. We are devastated and I cannot even study with all my textbooks lost in the deluge," the class 5 student said.

Children of all ages, from newborns to adolescents, are particularly vulnerable during natural disasters and this year's floods are no exception, experts pointed out.

Education, health, hygiene, and security of children are the key areas of concern during natural calamities.

Incidents of trafficking increase in the post-flood period with parents facing a loss of livelihoods or the death of earning members in many families.

In the severely affected Barpeta district, 14-year-old Samsur Rahman of Rupaikuchi village said he along with his parents had taken shelter in a relief camp and though they have returned home, he is vet to attend classes as he lost most of his books and his parents, who had no work for the last two months. trying to make ends meet.

"The state government has given us money to buy books but what will happen to the notes and assignments that I had prepared before the flood hit us? The deluge did not only wash away our belongings but all wiped away our efforts, along with the time lost in relief camps where we could not study at all," he added.

The state government has de-

posited Rs 1.000 each in the bank accounts of 1,01,537 students who had taken shelter in relief camps while the education department is planning to give additional free textbooks to the affected students by August 15.

Flood is an annual phenomenon and when it hit the state this year, the Assam State Commission for Protection of Child Rights (ASCPCR) wrote to the state Chief Secretary to initiate urgent child-centric interventions keeping in mind the health, hygiene, and security of the children, its chairperson Sunita Changkakoti told PTI.

'We had asked the government to make necessary arrangements for providing adequate quantities of baby food, safe drinking water, sanitary napkins, and disinfectant items, to make arrangements for sufficient toilets and medical facilities for children, women, and adolescents in the relief camps," she said.

NIA searches in Kerala in ICAMA Sathik case

New Delhi, July 31: The NIA Sunday conducted searches in Kerala in connection with a case pertaining to the arrest of Sathik Batcha alias 'ICAMA Sathik', who along with four others had attempted to kill police personnel during a vehicle check in February.

The searches were conducted in the Thiruvananthapuram district of Kerala and led to the seizure of digital devices and incriminating documents, a spokesperson of the federal agency said.

The National Investigation Agency (NIA) said the case pertains to the arrest of Batcha who along with four others was intercepted while driving in a black Scorpio at Nidur in Mayiladuthurai

They were stopped by a police team tasked to secure the accused in a case registered in the Mayiladuthurai Police Station and they attempted to run over the police party, the spokesperson said.

The official said the case was initially registered February 21 and re-registered by NIA April 30 under various sections of the Indian Penal Code and the Unlawful Activities (Prevention) Act (UAPA).

Further investigations in the case are in progress, the NIA said.

Kottayam, July 31: It was the then Kanchi Shankaracharya Chandrasekharendra Saraswati's timely intervention that helped save a centuries old tradition of Samavedic chanting in Kerala which was on the verge of disappearance in the 1970s.

Five decades down the line, there were not many efforts to preserve the rich tradition of the southern state, which was taught and transmitted to Rishi Jaimini by revered sage Vedavyasa, despite it being inscribed by UNESCO on the Representative List of the Intangible

Cultural Heritage of Humanity. However, 57 year-old Dr Thottam Sivakaran Namboothiri, one of the two remaining authorities of the Kerala style chanting of Jaiminiya Samaveda, has taken up it as a mission to preserve its unique oral

tradition by starting a 'Gurukulam' at a village in this central Kerala district. Launched in April this vear, everyday at 6 am, Namboothiri takes lessons of traditional way of chanting of 'Jaiminiya Samaveda' for four young students belonging to Namboothiri-Brahmin families-teaching them the complex recitation techniques that are based on tonal accents, a unique manner of pronouncing each letter and specific speech combinations.

The 'Gurukulam style' classes are being held in a small classroom adjacent to the Lord Krishna temple in Kurichithanam village near Uzhavoor, the birthplace of former

President of India, KR Narayanan. After ending the class at 9 am, the students go to the school in the neighbourhood everyday for their

regular studies. "It is a 12-year-long mission. Learning the Kerala style chanting of thousands of hymns from the Jaiminiya Samaveda is very tough and boring as we have to ensure that the sound of each word remains unaltered," Namboothiri told PTI.

A distant relative of legendary Communist leader and former Kerala Chief Minister EMS Namboothiripad, Sivakaran Namboothiri said Jaiminiya Samaveda, featuring musical

arrangements of 1,700 hymns from the Rig Veda and other sources, is on the verge of disappearance as currently there are two persons who have got complete knowledge about the unique tradition of chanting. Besides Sivakaran, it is his elder brother Thottam Krishnan Namboothiri who is settled in their traditional village Panjaal in Thrissur district, known for its rich vedic traditions.

'We learnt it from our father Thottam Subrahmanyan Namboothiri after ending our studies in school," Namboothiri said.

Now, an Ayurvedic physician by profession, Namboothiri, born in a family rooted in Samaveda tradition, said his four students, studying in fifth and seventh standards, are from the Namboothiri families rooted in Rig and Yajur

vedic traditions. 'There are only around 20 Samavedis among Namboothiri families in Kerala. None of the new generation members from these families have shown any interest in learning the chanting of Samaveda in traditional Kerala style. So, I decided to approach some of the Brahmin families rooted in Rig and Yajur traditions. My students are from these fami-

He said it will take at least 12 years for them to learn the skill of Kerala style chanting of 'Jaiminiya

lies," Namboothiri said.

A lone battle to save a unique tradition

Quoting from the UNESCO document of 2008, he said the value of this tradition lies not only in the rich content of its oral literature but also in the ingenious techniques employed by the Brahmin priests in preserving the texts intact over thousands of years.

According to him, when Vedavyasa classified ancient Vedic hymns into four parts based on their use in the sacrificial rites. Samaveda was taught and transmitted to Rishi Jaimini, who was one of his four disciples, and those who are following his tradition are called Samavedis in Kerala.

The Kerala tradition would have disappeared way back in the 1970s, had Kanchi Shankaracharya Jagadguru Chandrasekharendra Saraswati Mahaswamigal not taken the initiative to preserve it, Namboothiri said.

"During his visit to Lord Krishna temple, Guruvayur, in 1974, Jayendra Saraswati, the disciple of then Kanchi seer Chandrasekharendra Saraswati, sent his emissary to my father Thottam Subrahmanyan Namboothiri, who was an expert in Kerala style oral tradition of Jaiminiya Samaveda. Jayendra Saraswati, as per the wishes of the then Kanchi seer, offered all sorts of financial assistance to my father to transmit the knowledge to the next generation," he said.

Kerala man with monkeypox-like symptom dies

Thiruvananthapuram,, July 31: Will examine the reasons behind the death of a 22-year-old young man who recently returned from UAE and allegedly died due to monkeypox a day ago, Kerala Health Minister Veena George said Sunday.

With the swab results of the deceased patient yet to be reported, the health minister said that the patient was young, did not suffer from any other illness or health problems and therefore, the health department was looking into the cause of his death.

She said they will also be examining why there was delay in his hospitalisation after he arrived here from UAE on July 21.

"This particular variant of monkeypox is not as highly virulent or contagious like COVID-19, but it does spread. Comparatively, the mortality rate of this variant is low. Therefore, we will examine why the 22-yearold man died in this particular case as he had no other illness or health problems," the minister told media.

Since this variant of monkeypox does spread, therefore, all necessary measures have to be taken and have been taken to prevent the same, she added.

The minister also said that there were no studies available about this particular variant from other countries where the disease has been detected and thus, Kerala was carrying out a study

According to WHO, monkeypox is a viral zoonosis (a virus transmitted to humans from animals), with symptoms similar to those seen in the past in smallpox patients, although it is clinically less severe.

With the eradication of smallpox in 1980 and subsequent cessation of smallpox vaccination, monkeypox has emerged as the most important orthopoxvirus for public health.

Cong suspends 3 MLAs held in Bengal with cash

New Delhi, July 31: The Congress Sunday suspended three Jharkhand MLAs who were allegedly caught with a huge amount of cash in West Bengal's Howrah and accused the BJP of attempting to topple its coalition government in the state.

However, it asserted that the coalition government led by the Jharkhand Mukti Morcha (JMM) is "completely secure and stable" and would complete its term. Addressing a press conference at the AICC headquarters here, party

general secretary and Jharkhand in-charge Avinash Pande said Congress president Sonia Gandhi has suspended the three MLAs

with immediate effect. Acting on a tip-off, the West Bengal Police on Saturday evening intercepted a sports utility vehicle (SUV) in which Congress MLAs Irfan Ansari, Rajesh Kachchap and Naman Bixal Kongari were travelling, and allegedly found nearly

Rs 50 lakh in cash in the car. After questioning, the lawmakers were formally arrested on Sunday afternoon and subsequently, remanded in the West Bengal CID's custody for 10 days. Pande said the three MLAs were allegedly involved in a plot to weaken the Congress Legislature Party in Jharkhand and also in "misleading" other legislators.

"The party leadership is aware of who all are part of the conspiracy and will take action at an appropriate time," he added."We have information about everyone. In the coming days, be it any public representative, any office-bearer of the Congress or any worker, whoever is found connected to or involved in this, the party will take strict action against them," Pande added.

He asserted that the JMM-led government is completely "secure and stable" and the coalition MLAs, "barring a few black sheep", will fight such attempts in a united manner. Accusing the Bharatiya Janata Party (BJP) of attempting to topple the Jharkhand government, Pande said democracy is being "shredded to pieces" as elected governments are being destabilised in a brazen manner. "Efforts are being made for the last two years to destabilise the government in Jharkhand and from time to time, legislators are being contacted, threatened and enticed." he alleged.

Enhance vigil at borders: Mann

Chandigarh, July 31: Punjab Chief Minister Bhagwant Mann Sunday asked Director General of the Border Security Force (BSF) Pankaj Kumar to enhance vigil at the borders of the state for checking smuggling of drugs and weapons from across the border.

TB more deadly than Covid in Gujarat

Ahmedabad, July 31: Tuberculosis (TB) has proven to be more deadlier than Covid-19 in Gujarat between January-May 2022, with 2,675 deaths recorded due to TB in the state during this period

During this five-month period, 825 people have lost their lives due to Covid-19 while more than 68,000 people have become victims of TB in the country. Though, there has also been a sharp rise in the number of Covid-19 cases in Gujarat with 1,128 new cases re-

ported in the last 24 hours.

Three persons have died of Covid-19 in Ahmedabad during the last 24 hours with 400 of the total 902 people recovering from the disease reported in the city till Saturday.

The overall recovery rate of Covid-19 in the state has reduced to 98.63 per cent.

According to information shared by the Union government in the Lok Sabha, 18.05 lakh people were infected with TB in 2020 and around 21.35 lakh in 2021 across the country under the TB elimination programme.



From January to May 2022, 68,718 people have died due to TB in Gujarat while the mortality rate from it is more than four per cent. Apart from this, it

month in Gujarat. Among the states which have the highest number of deaths due to TB between January-May 2022, Uttar Pradesh is at the top with 6,896, Maharashtra is second with 2845, while Gujarat is third.

From 2018 to May 2022, a total of more than 6.47 lakh people have contracted TB in Gujarat.

Manila: Former Philippine President Fidel Valdez Ramos, a US-trained ex-general who saw action in the Korean and Vietnam wars and played a key role in a 1986 prodemocracy uprising that ousted a dictator, has died. He was 94. It was not immediately clear what caused his death but one of his longtime aides, Norman Legaspi, told The **Associated Press that Ramos** had been in and out of the hospital in recent years due to a heart condition and had suffered from dementia.

It described the explosive device as "low-power" but Sevastopol mayor Mikhail Razvozhaev said six people were injured in the blast.

There was no immediate information on where the drone began its flight; Sevastopol is about 170 kilometers south of the Ukrainian mainland and Russian forces control much of the mainland area along the Black Sea.

Fighting continued elsewhere in Ukraine. The mayor of the major port city of Mykolaiv, Vitaliy Kim, said shelling killed one of Ukraine's richest men, Oleksiy Vadatursky, and his wife. Vadatursky headed a grain production and export busi-

NYC DECLARES MONKEYPOX **PUBLIC HEALTH EMERGENCY**

New York, July 31: Monkeypox has been declared a public health emergency in New York City, with officials declaring that the city is currently the epicentre of the outbreak and an estimated 150,000 New Yorkers may currently be at the risk of exposure.

New York City Mayor Eric Adams and New York City Department of Health and Mental Hygiene (DOHMH) Commissioner Ashwin Vasan on Saturday declared a public health emergency due to the monkeypox outbreak.

"Over the past few weeks, we have moved as quickly as possible to expand outreach and access to vaccines and treatment to keep people safe," the officials said. The declaration, effective immediately, will allow DOHMH to issue emergency commissioner's orders under the New York City Health Code and amend provisions of the Health Code to provide for measures to help slow the spread. The officials said that New York City is currently the epicentre of the outbreak, and it is estimated that approximately 150,000 New Yorkers may currently be at risk for monkeypox exposure.



Pelosi begins Asia tour

Beijing, July 31: US House of Representatives Speaker Nancy Pelosi starts a tour of four Asian countries Sunday, her office said, without mentioning Taiwan amid intense speculation she might visit the self-ruled island claimed by China.

"Speaker Nancy Pelosi is leading a Congressional delegation to the Indo-Pacific region, including visits to Singapore, Malaysia, South Korea and Japan," her office said in a press release.

The release said the visit would include those countries, but did not specify whether Pelosi, who is number 3 in the line of presidential succession, might make other stops.

'The trip will focus on mutual security, economic partnership and democratic governance in the Indo-Pacific region," it said.

Gregory Meeks, chair of the House Foreign Affairs Committee, was among the delegation listed.

Washington, July 31: A Chinese booster rocket made an uncontrolled return to Earth Saturday, US Defense Department officials said, as they chided Beijing for not sharing information on the potentially hazardous object's descent.

US Space Command "can confirm the People's Republic of China (PRC) Long March 5B (CZ-5B) reentered over the Indian Ocean at approx 10:45 am MDT on 7/30," the US military unit said on Twitter,

referring to China's official name. "We refer you to the #PRC for further details on the reentry's technical aspects such as potential debris dispersal+ impact lo-



cation," it said.

The Long March 5B rocket was used last Sunday to launch an uncrewed spacecraft, named Wentian. carrying the second of three modules China needed to complete its new Tiangong space station.

NASA administrator Bill Nelson criticized Beijing on Twitter Saturday, saving that the failure to share the details of the rocket's descent was irresponsi-

ble and risky.

"All spacefaring nations should follow established best practices, and do their part to share this type of information in advance," Nelson wrote, "to allow reliable predictions of potential debris impact risk, especially for heavy-lift vehicles, like the Long March 5B, which carry a significant risk of loss of life and property.'

He added: "Doing so is critical to the responsible use of space and to ensure the safety of people here on Earth"

The Tiangong space station is one of the crown jewels of Beijing's ambitious space program, which has landed robotic rovers on Mars and the Moon, and made China only the third nation to put humans in orbit.

The new module, propelled by the Long March 5B, successfully docked with Tiangong's core module on Monday and the three astronauts who had been living in the main compartment since June success fully entered the new lab.

China has poured billions of dollars into space flight and exploration as it seeks to build a program that reflects its stature as a rising global power.

Prince Charles accepted £1mln from Laden's family: Report

London, July 31: A Charitable Fund founded by Britain's Prince Charles, the Prince of Wales, accepted a donation from slain al-Qaeda leader Osama bin Laden's family in 2013, a UK media report claimed Sunday.

According to The Sunday Times, Prince Charles met with the Al Qaeda founder's half-brother Bakr in London and allegedly agreed to accept GBP 1 million.

The report claims that several of the senior royal's closest advisers urged Charles – heir to Britain's throne - to return the money. However, his Clarence House office has denied that the royal was personally involved in the deci-

"The Prince of Wales' Charitable Fund (PWCF) has assured us that thorough due diligence was undertaken in accepting this donation," a Clarence House spokesperson told Sky News. "The decision to accept was taken by the charity's

5G spectrum sale: Bids breach ₹1.50tn mark, firms fight for UP East

Mumbai, July 31: The auction of 5G spectrum capable of offering ultra-high-speed internet received bids worth ₹1,50,130 crore until Sunday amid pick-up in demand for radiowaves in the UP East circle, pushing the bidding to seventh day Monday.

Seven new rounds of bidding held on the sixth day of auction Sunday 'dialled in' an incremental ₹163 crore, propelling the cumulative spectrum sale beyond the ₹1.50 lakh crore-mark.

The auction has fetched provisional bids worth ₹1,50,130 crore in the first six days, according to data released by the telecom department.

Sources said that after a relative easing of demand Saturday, the UP East circle - which includes Lucknow, Allahabad, Varanasi, Gorakhpur, Kanpur - saw bidding activity pick-up once again for 1800 MHz, a band primarily used by telcos for 4G services

UP East - which has over 10 crore mobile subscribers - accounted for all of the incremental spectrum sales Sunday, amid a pitched battle for radiowaves among players such as Reliance Jio and Bharti Airtel.



Up until Friday, about 71 per cent of the total spectrum put on the block had been provisionally sold

As on May, Reliance Jio had 3.29 mobile subscribers in UP East, Bharti Airtel (3.7 crore) and Vodafone Idea (2.02 crore).

The bidding intensity for 1800 MHz band in Uttar Pradesh East circle had peaked between Wednesday and Friday, then subsided somewhat Saturday. On Sunday, however, renewed interest was seen and demand flared once again outstripping the spectrum supply, sources said.

All eyes will be on this circle when bidding resumes Monday with 38th round, and the auction timelines would depend on how the bidding progresses through the day.

After a flying start Tuesday that saw players pouring in ₹1.45 lakh crore on the first day, the numbers have inched up incrementally since Wednesday, with players such as Jio and Airtel locked in intense bidding in Uttar Pradesh East circle for 1800 MHz band.

Over 63.47L ITRs filed on last day

New Delhi, July 31: Over 63.47 lakh income tax returns (ITRs) were filed till 10 pm Sunday, the last day for filing ITR for the 2021-22 fiscal by salaried individuals, the Income Tax department said.

The deadline for filing ITRs by those taxpavers who do not have to get their accounts audited for the fiscal that ended March 31, 2022 was Sunday. Taking the 63.47 lakh returns filed on the last day, the total number of ITRs for the 2021-22 fiscal filed till 10 pm went past 5.73 crore. ITR filing will go on till midnight, after

which the tax-return filers will have to pay a late fee for delayed filing. In the last fiscal, about 5.89 crore ITRs were filed by the extended due date of December 31, 2021.

According to tax laws, a late fee of Rs 5,000 would be payable by those with an annual income of over Rs 5 lakh, if they file their ITR by December 31 of the assessment vear. Individuals with an annual income of below Rs 5 lakh will be liable to pay a late fee of Rs 1,000. Besides, those who have outstanding unpaid tax will have to shell out an additional 1 per cent interest per month for delayed filing

New Delhi, July 31: Indian Oil Corporation sold petrol at a loss of ₹10 per litre and diesel at ₹14 a litre during April-June, leading to the firm reporting its first quarterly net loss in over two years, a report said.

The nation's largest oil refining and fuel retailing firm reported a net loss of ₹1,992.53 crore in April-June compared to ₹5,941.37 crore of net profit in the same period a year back and ₹6,021.9 crore in the preceding January-March quarter.

"IOC (Indian Oil Corporation) reported an 88 per cent year-on-year decline in its standalone EBITDA to ₹1,358.9 crore and a net loss of ₹1,992.5 crore, despite record high gross refining margins (GRMs) of \$31.8 per barrel for the quarter. Earnings decline was driven by a



sharp fall in retail fuel margins for petrol and diesel with an estimated net loss of ₹10 per litre for petrol and ₹14 a litre for diesel for the quarter and inventory loss of ₹1.500-1.600 crore due to excise duty cut in the quarter," ICICI Securities

While fuel retailers are supposed to revise petrol and diesel prices daily in line with cost, IOC and other state-owned firms Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) kept prices

on hold despite a rise in input cost. The basket of crude oil India imports averaged \$109 per barrel, but the retail pump rates were aligned to about \$85-86 a barrel cost. This is the first quarterly loss in

over two years. The company had reported a net loss in January-March 2020, but that was on account of inventory losses on processing costlier crude. IOC, BPCL and HPCL stopped re-

vising rates ahead of assembly elections in states like Uttar Pradesh last year. That 137-day freeze ended in late March, with prices being raised by ₹10 per litre each before another round of freeze came in force in early April.

The government in May cut excise duty on petrol and diesel, which was passed on to consumers instead of being used to square off mounting losses on the two fuel sales.

New Delhi, July 31: As many as 384 infrastructure projects, each crore or more, have been hit by cost overruns of more than ₹4.66 lakh crore, as per a report.

According to the Ministry of Statistics and Programme Implementation, which monitors infrastructure projects of ₹150 crore and above, out of 1,514 projects, 384 reported cost overruns and as many as 713 projects were delayed.

"Total original cost of implementation of the 1,514 projects was ₹21,21,471.79 crore and their anticipated completion cost is likely to be ₹25,87,946.13 crore, which reflects overall cost overruns of ₹4,66,474.34 crore (21.99 per cent of original cost)," the ministry's latest report for June 2022 said.

According to the report, the expenditure incurred on these projects till June 2022 is ₹13,30,885.21 crore, which is 51.43 per cent of the anticipated cost of the projects.

However, the number of delayed projects decreases to 552, if the delay is calculated on the basis of the latest schedule of completion.

New Delhi, July 31: After a threemonth halt, new fund offerings (NFOs) have made a strong comeback with asset management companies launching over two dozen mutual fund schemes in July.

The new funds have been launched across the board -- actively managed equity funds, debt, index funds and exchange-traded funds (ETFs). Interestingly, passively managed funds, particularly ETFs, continue to dominate the NFO market.

There was a lull in the NFO space as the Securities and Exchange Board of India (Sebi), in April, had barred fund houses from floating new schemes till the time the industry complied with its norms concerning the pooling of investors' funds by intermediaries and distributors. The deadline for the implementation of the new guideline was July 1.

Also, the regulator had asked fund houses to implement guidelines like dual authentication for redemption, verification of source of accounts while mutual fund investments are made. These measures were aimed at safeguarding in-
