NEW DELHI: Jet fuel (ATF) prices Monday were cut by the steepest ever 12 per cent, the second reduction in as many weeks, on softening international oil prices amid recessionary fears. Aviation turbine fuel (ATF) prices were cut by ₹16,232.36 per kilolitre, or 11.75 per cent, to ₹121,915.57 per kl in the national capital, a price notification of state-run retailers showed. This is the steepest ever reduction in rates and follows a ₹3,084.94 per kl (2.2 per cent) reduction effected July 16. Parallelly, the rates of commercial LPG - the one used by hotels, restaurants and other business

THIRUVANANTHAPURAM: The Kerala government Monday confirmed that samples of a 22-yearold man, who died July 30, tested positive, making him India's first monkeypox-related fatality. Meanwhile, India reported its sixth monkeypox case Monday -a Nigerian man living in Delhi with no recent foreign travel history -- as the Centre formed a task force to monitor the emerging situation. Sambalpur, August 1: A minor girl was gangraped near a roadside dhaba at Godbhaga area under Burla police station limits in Sambalpur district, police said Monday.

Police registered a case and detained six persons including a woman over a complaint filed by the survivor's familv members. Among the accused, four are youths, one of them is the dhaba owner and another is a woman. The car

Police said the incident occurred July 30 night. A woman acquaintance

of the survivor called her for dinner to a roadside dhaba near Godbhaga. When they were leaving the dhaba after dinner, four youths in a car reached the place. Later, they took the girl to an isolated place and took turns to rape her. The accused youths and the woman fled the scene after the incident.

On being informed by locals, Burla police rescued the survivor from the

place and dropped her at home. The girl narrated her ordeal before her family members the next day following which her family members lodged a complaint at the police station. Police raided various places and detained the six persons.

Hirakud SDPO SK Dash said a case has been registered at Burla police station over a complaint by the girl's family members. The matter is being probed from all angles and stringent action will be taken against those found responsible for the crime.



How is the play *One On One* different from the plays presented in the past?

Earlier, no national-level theatre artiste had performed in Bhubaneswar and we started with Kaifi Aur Main (Shabana Azmi in the lead) in 2015 as a fundraiser for ASD. It was a ticketed show and the proceeds were used to create awareness on autism and for the welfare of autistic people. After bringing single plays for five years to the City, we have planned something different this year. One On One is not a single play but an anthology of seven plays. We expect more people will attend the show to watch big names of stage and screen such as Rajit Kapur, Shikha Talsania, Vrajesh Hirjee, Sumeet Vyas and others perform.



What are the changes you have noticed since you launched the foundation in 2015?

We have been organising events

in top cities in Odisha like Bhubaneswar and Cuttack as well as in metros like Kolkata, Chennai, Bangalore and Pune to sensitise people. We started off at a time when deaf and mute kids were considered autistic. But now, the knowledge on autism among the mass has increased drastically. They know how to treat and behave with these kids

How should one treat people/children with autism?

I bat for the inclusion of autistic children in schools, hospitals, parks and all other public places. However, they need to be treated specially; we must treat them with sensitivity as their brains function little differently than others. We must understand their problem and offer assistance

What is the main objective of the foundation?

Our ultimate goal is to set up a residential centre for teenagers and young adults with autism. Many of them find themselves without a caregiver when their parents age or pass away. The centre would help people with autism to become independent.

What role do drama shows or movies play in understanding autism?

Unfortunately, very few films have portrayed the cause with sensitivity. Barfi, a film made on autism, made mockery of the condition. However, Aamir Khan's Taare Zameen Par was a good movie on the subject. I hope his next movie Laal Singh Chaddha will also be in the same league.

According to a leading newsmagazine report, when asked if such campaigns against his films make upset him, Aamir said that it makes him 'sad'.



8,506 drowned in 6 yrs

Bhubaneswar, August 1: Odisha has recorded 8,506 drowning deaths in the last six years, with an average of almost 1,417 deaths per annum, Minister of State for Home Tusharkanti Behera told the Assembly Monday.

In a written reply to a question of BJP MLA Sukant Kumar Nayak, Behera said 935 cases of drowning deaths were reported in 2016, which went up to 1,079 in 2017 and 1,406 in 2018. Similarly, 1,441 drowning cases were reported in 2019, 1,840 in 2020 and 1,805 in the 2021, he added. Behera said the highest number of drowning cases (121) was reported from Cuttack urban police district in 2016 followed by 57 in Mayurbhanj district and 54 in Balasore district in the same year.

The data also showed that Mayurbhanj, Keonjhar and Ganjam reported more drowning deaths compared to other districts every year.

Diarrhoea claimed 17 lives in 7 dists

As many as 17 people have died of diarrhoea in seven districts of the state since July 13 this year, Health and Family Welfare Minister Naba Kishore Das said Monday.

Making a statement in the state Assembly under the direction of



In 2021, the highest number of deaths—167, were reported from Mayurbhani district, followed by Keonjhar (145), Ganjam (111), Bhadrak (98), Kendrapara (95), Puri (80) and Jagatsinghpur (80).

Speaker Bikram Keshari Arukha. Das said 432 people in the state have been infected with diarrhoea since July 13, of which 17 people died.

The first case of diarrhoea outbreak was noticed in Kashipur block of Rayagada district July 13. 2022. Till now, 159 persons of 11 villages spread over 5 panchayats in Kashipur block of the district have been infected with the disease, of which 10 died.

Similarly, two persons died in Jharsuguda while Koraput, Nabarangpur, Sonepur, Nuapada and Gajapati districts have recorded one death each due to the disease,

The state government has included drowning deaths in the list of state specific disasters in order to provide financial assistance of Rs 4 lakh each to kin

Biswal denies links with Noida-based media firm

Bhubaneswar, August 1: Former Cuttack-Choudwar MLA, Pravat Ranjan Biswal Monday issued a clarification denying any links with the Noida-based media firm, Media Guru Consultants whose properties worth over Rs 3.67 crore have been attached by Enforcement Directorate (ED) along with Rs 25 lakhs of movable property belonging to Biswal.

The ED took the action in a money laundering case against Seashore Group of companies accused of duping investors of crores of rupees through ponzi

'Current monkeypox symptoms different from previous outbreaks'

eople infected with monkeypox during the ongoing global outbreak are displaying symptoms not typically associated with the viral infection, according to a study published in the British Medical Journal. The findings are based on 197 confirmed monkeypox cases at an infectious disease centre in London, UK, between May and

Some of the common symptoms they described include rectal pain and penile swelling (oedema), which differ from those described in previous outbreaks, the researchers said.

They recommend that clinicians consider monkeypox infection in patients presenting with these symptoms. According to the researchers, those with confirmed monkeypox infection with extensive penile lesions or severe rectal pain "should be considered for ongoing review or inpatient man-

agement. All 197 participants in the study were men (average age 38 years), of whom 196 identified as gay, bisexual, or other men who have sex with men. All patients presented with lesions on their skin or mucosal membranes, most commonly on the genitals or in the perianal area.

Most (86 per cent) of patients were reported systemic illness (affecting the entire body). The most common systemic symptoms were fever (62 per cent), swollen lymph nodes (58 per cent), and muscle aches and pain (32 per cent).

In contrast with existing case reports suggesting that systemic symptoms precede skin lesions, 38 per cent of patients developed systemic symptoms after the onset of mucocutaneous lesions, while 14 per cent presented with lesions without systemic features.

A total of 71 patients reported rectal pain, 33 sore throat, and 31 penile oedema, while 27 had oral lesions, 22 had a solitary lesion, and 9 had swollen tonsils. The researchers noted that solitary lesions and swollen tonsils were not previously



known to be typical features of monkeypox infection, and could be mistaken for other conditions.

Just over a third (36 per cent) of participants also had HIV infection and 32 per cent of those

screened for sexually transmitted infections had a sexually transmitted infection, they said. Overall, 20 (10 per cent) of participants were admitted to hospital for the management of symptoms, most



It was observed that soil moisture conservation activity like digging staggered trenches were either not taken up or have been executed inefficiently. The variation in performance of different plantations was attributed to variation in site quality, species taken and level of management. Selection of wrong sites and poor management had resulted in the failure of plantations in 251 sites, as found in Audit.

"Required database relating to various plantation schemes, such as scheme wise annual target and achievement, allotment and expenditure, survival percentage were neither maintained at Government nor at PCCF (O & HoFF) level. The data maintained at PCCF (O & HoFF) and Division level lacked integrity. There were no concurrent evaluation of plantation schemes and undue delay in third party evaluation of plantations," the CAG said.

Cautious approach needed for AI use in medical research, say experts

ne week social-media users are generating and sharing amusing images Artificial Intelligence (AI), the next we hear AI can predict the structure of over 200 million proteins

AI is particularly well placed to revolutionise medical research. The technology helps in two vital ways: it optimises research, and it can make discoveries that humans have not. AI is unshackled from the limitations that come with human researchers: it can trawl deep datasets exponentially faster, never needs to take a break, and never succumbs

to illness or fatigue. Taiwanese computer scientist, businessman and author Kai-Fu Lee recently spoke about his optimism for the future of AI. "We've surprised ourselves with how well machine learning algorithms work.



... It makes us focus on the things that AI cannot do, and it will probderstanding of the human mystique of how we think or it will lead to more breakthroughs, leading to super intelligence ... It took 40 years, but I think we're basically there.

None of this means the rise of the machines is imminent. Despite its advances, AI is still encumbered by technical limitations. AI pioneer Yosua Bengio said in 2021 that deep learning was not "anywhere close today to the level of intelligence of a two-year-old child".

A study by Pugliese et al (2021) finds that more and more medical research is mentioning "machine learning".

"But maybe we have algorithms that are equivalent to lower animals, for perception. And we're gradually climbing this ladder in terms of tools that allow an entity to explore its environment," he said. It said many areas of the district have not received rainfall since a week. Farmlands are dry while paddy saplings have started wilting due to lack of water under a scorching sun.

Farmers are apprehensive that such a condition is a prelude to drought while agricultural activities have already been delayed in many localities.

"Farmlands are dry now. If there

is no rain in a week, paddy saplings will definitely die. In many areas, irrigation facility is still a dream. Saving the saplings will be a difficult task. The paddy saplings badly need water at this point of time," some farmers said

Meanwhile, a group of farmers from 'Rushikulya Ryot Mahasabha' has submitted a memorandum to the Collector, apprising him of the ground situation. Farmlands where seedlings have been sown have cracked open. The farmers have urged the Collector to ensure that all lift irrigation points, be it government or private, are made operational.

They also sought intervention of the Collector to direct the irrigation authorities to release water through Jaymangala, Hiradharbati and Rushikulya canals.

Pact with NIOT soon to combat coastal erosion

Chhatrapur, August 1: At a time when surging tidal waves are eating into the land mass in coastal areas of Ganjam district, the state government has decided to tie up with Chennai based-National Institute of Ocean Technology (NIOT) to curb the menace, a report said.

The state government has approved a proposal for signing of a memorandum of understanding (MoU) with NIOT which functions under the Union Ministry of Earth Sciences. The pact will be inked soon with NIOT, which will provide necessary technical assistance to combat erosion along the coast.

The matter came to the fore when Ganjam Collector Dibya Jyoti Parida informed the mediapersons, Monday, about the district administration's plan to establish a model colony for the erosion-hit residents. The state government will work jointly with NIOT to prepare a long term, effective and climate conducive action

plan, said sources. A survey will be conducted at erosion-prone places and a model colony will be established to rehabilitate the residents, the Collector said. A technical team will conduct a survey in the areas where coastal erosion is taking place.

"Arrangements are being made to immediately provide houses to the residents whose houses have been washed away," the Collector added.

Reports said the surging sea waves are constantly eroding the coastal areas of five seaside blocks in Ganjam district for which the residents are in a state of panic. The complete washout of six houses by surging sea waves at Podampeta village under Palibandh panchayat of Ganjam block. Sunday, has caused panic. Now, only seven houses are left in this area, said sources.

Aryapalli village under Chhatrapur block and Podampeta village under Ganjam block bear the testimony to continuous coastal erosion taking place in the district.

Arab Spring Over

t is a pity that Tunisia, the cradle of the Arab Spring movement that led to the fall of autocratic rule, violence and beginning of democracy across much of the Arab world about a decade back, is now back to virtual dictatorship by its President Kais Saied through a so-called constitutional route. Saied has got the seal of approval to constitutional change he has proposed in a referendum in which nearly 93 per cent of the country's voters have given the "yes" vote. Tunisia was the last bastion of the movement for democratic rule after some other Arab countries that had embraced democracy had given way to autocracy.

Exactly a year before the referendum, Saied had sacked a democratically elected government and froze the parliament. According to the Opposition parties, this was nothing short of a coup. Though the final results will not be known before a month, unofficial figures show an overwhelming 92-93 per cent of those who voted supported the new constitution. Soon after it became clear the verdict was going in his favour, Saied told his supporters Tunisia "has entered a new phase.

Only around a third of 9.3 million registered voters exercised their franchise for which the Opposition alliance has questioned the legitimacy of the reforms with nearly 70 per cent of the voters staying away from the exercise. Even then the turnout was higher than many observers had expected, which only suggests Saied continues to enjoy personal popularity almost three years after sacking the government. Ahmed Nejib Chebbi, head of the National Salvation Front that includes Saied's main rivals, accused the election commission of falsifying the figures of votes cast. In fact, the President has seized control of the election machinery, appointing three of the seven members, including the chief. He has also sacked several judges of the country's Supreme Court. Saied's critics have warned the new constitution would give enormous powers in the hands of the President signalling Tunisia's return to dictatorship. The new constitution seeks to invest the President with the powers to command the army, allow him to appoint a government without parliamentary approval and make it virtually impossible to remove him from office. He can also present draft laws to parliament, which would be obliged to give its approval.

Sadly, the Arab Spring movement crashed after the revolutions were over $turned\,first\,by\,military\,coup\,in\,Egypt,\,then\,by\,Saudi\,intervention\,in\,Bahrain$ and eventually by Gulf support for Syria's government. Tunisia has so long been seen as the last hope to make the people and not autocrats the supreme $\,$ in managing the country's affairs. But, Saudi Arabia and the United Arab Emirates have lent their support to Saied after the political parties let the people down by indulging in corruption and failing to tackle the severe unemployment crisis. The political parties are to blame for the hybrid parliamentary system being replaced by a presidential model that gives Saied unfettered powers to rule.

Arab watchers, however, say the transition from dictatorship to democracy has never been smooth anywhere in the world. Apathy and fatigue have crept in Tunisia's political discourse due to the failure of the political parties to stem the economic rot. President Saied could become entrenched in power because of the disillusionment of the people with the political parties. The support of 30 per cent of the population is no mean figure.

The referendum in Tunisia is definitely a setback for the fledgling, hybrid democracy. But, the trajectory of revolutionary change across the world follows the pattern of one step forward and one step backward. The Arab Spring seems to be no exception.

The technique can bring valuable benefits to those helped but unscrupulous operators have sometimes taken unfair advantage and there are ethical implications when health organisations or doctors become involved. The purchaser of the policy has to continue to pay the premiums until the subject of the policy dies, so he is in effect betting on how long the seller will survive. For this reason, such purchases have been dubbed death futures. A person selling a policy in this way is sometimes called in legal English a viator. The popularity of the scheme has waned in recent times as the success of treatments for AIDS has extended life expectancy.


Vilipend

It appeared in English in the fifteenth century and was a popular term right down into the nineteenth, though it has since dropped out of sight. In 1771 Tobias Smollett put it into the mouth of a character in Humphry Clinker: "I would not willingly vilipend any Christian, if, peradventure, he deserveth that epithet". Sir Walter Scott employed it in Waverley in 1814: "He became a gay visitor, and such a reveller, that in process of time he was observed to vilipend the modest fare which had at first been esteemed a banquet by his hungry appetite, and thereby highly displeased my wife." If you would like an obscure deprecatory term and for some reason calumniatory and contumelious don't meet your needs, you could do worse than the related word vilipenditory.

PRESSURES OF PATCHWORK

REBELLION IS NOT UNKNOWN IN THE SHIV **SENA. THE PARTY HAS SEEN REBELLIONS -THREE OF THEM BIG -- EVEN DURING THE TIME OF BAL THACKERAY**

t is now more than a month since the Maharashtra government led by Uddhav Thackeray of the Shiv Sena was ousted after a dramatic coup and mass desertions, including by as many as nine ministers. Something was happening inside the party that neither the Chief Minister then, nor his politicianson Aaditya or the particularly vocal party spokesperson and Rajya Sabha MP Sanjay Raut had a clue about. The inner rumblings were evidently unseen and unheard, if they were noticed at all.

Now, other kinds of rumblings are troubling the new patchwork alliance of a breakaway Shiv Sena and the BJP, with rebel Eknath Shinde as the Chief Minister. This new combination guided and aided by the BJP today sits uneasy. It faces a host of pressures from those who have switched sides with many hopes and promises that will not be easy to meet. A sign of this has been that the state government had not been able to announce a cabinet yet, one month into the formation of the new government. Since June 30, when Shinde took office, Maharashtra has been run by a micro non-cabinet of two (the rebel Shiv Sainiks. the CM and the BJP's Devendra Fadnavis as the deputy CM) as the new power structure balances pressures and decides how to distribute the rewards of the coup. There are other uncomfortable adjustments that are taking time to work out. Among them is that the BJP has the largest share of MLAs (106 in a house of 288) and while it wants to prop Shinde its eventual goal is to build its people and their power bases. The BJP will look for a bigger share in power. Further, accommodating as many as 29 independent MLAs who support the Shinde faction with political positions will be difficult if not impossible.

At the heart of this is the weak political position of the new CM, who certainly has enough BJP support but very little of his own story that he can take to the people of Maharashtra while all the other key players have their interests and stories at work.

The BJP has divided and broken the Shiv Sena. Within it is a "wetold-you-so" story from the BJP they promised to and have taught the son of Bal Thackeray, Uddhav,

a lesson. Uddhay, the deposed CM. has his story on how Shinde, a man he trusted, stabbed him in the back, just when he was recovering from surgery in hospital - an act not of rebellion but of betraval of the worst kind that is not usually the stuff of the Shiv Sena. Aaditya, who has attracted a lot of attention of the youth and liberals given his support on environment issues has a subtler story of his own – the story of a new generation, learning and taking humble bows as he goes across the state to connect with the masses. Some of the responses have been powerful - people tearing up to welcome those who were betrayed. The only one who does not have a powerful story yet is Shinde, who will find it difficult to escape the obvious story that he got a berth by selling out to the BJP.

Making it worse for the victors is the fact that even the BJP local leader and former CM Devendra Fadnavis, who evidently had a hand in orchestrating the coup, was "asked" at the last minute to join the new government as Deputy CM. Fadnavis had told reporters he would stay out of the government, but joined as Shinde's deputy when the party directed him to

This gives a new potential fillip to the idea on which the Shiv Sena

was formed and rocketed upward in the public mind in the first place and even came under police watch given the violent approach it advocated - the politics of the socalled "sons-of-the-soil." In the early days, the party led agitations to ask that Maharashtrian youth be employed by banks, railways, other large PSUs and private sector companies. The party has led countless hyper local agitations - in bank branches, sometimes in the Western region headquarters in Mumbai, at the offices of the railway recruiting boards and others. On the other hand, was the Shiv Sena's work for the ordinary person – fighting to get water connections re-started, roads fixed, even selling at low cost when others fleeced on ordinary goods and commodities - leading the BJP leader Pramod Mahajan to once comment that the Shiv Sena does the right things the wrong way.

Rebellion is not unknown in the Shiv Sena. The party has seen rebellions - three of them big - even during the time of Bal Thackeray Among them was Uddhav's cousin Raj Thackeray, who quit in 2005, when Bal Thackeray was alive. The party survived what looked then like tremors but turned out to be hiccups because of the way Thackeray moved crowds. "I have the remote control of politics and

the remote control will remain with me," Thackeray said in an editorial in the party newspaper Saamna when he turned 84, some two years before he passed away. The throngs of mourners at the funeral in Shivaii Park showed how

much people loved him. Aaditya has started touring the state with a "Shiv Samvaad" yatra. The message that is being taken to the people is about the backstabbing and betrayal of Bal Thackeray's Shiv Sena. The attempt by the Thackerays is to reconnect with the people, to paper over charges of distance and inaccessibility and to re-establish the connection that Bal Thackeray had with the Maharashtrian masses. In doing so, the Shiv Sena will somewhere be going back to its nativist roots, and at the same time signalling that they will fight back with force and vigour - something that will be difficult now that all the resources of the government are trained against them. But betrayal for personal gain is a powerful story that has an emotional connection, and the Thackerays will be going all out to build it further in the hinterlands of Maharashtra.

SPECTRUM INTERNATIONAL SPACE STATION

Not an arena for politics

SINCE THE END OF THE COLD WAR, THE ISS HAS BEEN **A MAJOR PLATFORM FOR COOPERATION BETWEEN THE WEST AND RUSSIA**

he new Russian space agency chief announcing to pull out of the International Space Station (ISS) project by 2024 on the ground of the Western sanctions against Russia due to its invasion of Ukraine, has come as a disappointment for the scientific community of the world as the space station is a platform for furthering scientific pursuits and not an arena for politicising an event. Russia's space agency already ran into controversy when it recently show-cased images of its cosmonauts onboard the ISS celebrating Moscow's capture of the eastern

Ukrainian region of Luhansk. Since the end of the Cold War, the ISS has been a major platform for cooperation between the West and Russia. The ISS was an international collaborative effort of the USA (NASA), Russia (Roscosmos). Europe (European Space Agency), Japan (Japanese Aerospace Exploration Agency) and Canada (Canadian Space Agency). The station served as a space based lab in which scientific research in various fields such as astrobiology, astronomy, meteorology and physics could be carried out in zero-gravity conditions which normally is not possible on the Earth. The data was used to test human endurance in space for long duration stays that would ultimately pave the way for building permanent human colonies in space. As of 2010, the total cost of the project was 150 billion USD.

The ISS is the ninth space station to be inhabited by crews following the Russian Mir and the American Skylab space stations. It is the largest man-made object put into space and the largest satellite in low Earth orbit to be regularly visible to the naked eye. It maintains an orbit with an average altitude of 400 km circling the Earth in about 93 minutes.

One of the most complex engineering projects ever attempted, the ISS is made up of two primary segments: one managed by the NASA and the other by Roscosmos. While the Russian segment incorporates six modules, the US segment includes ten modules. The ISS consists of pressurised habitation modules for humans, structural trusses, photovoltaic solar arrays, thermal radiators, docking ports, experiment bays and robotic arms for scientific explorations. Major ISS modules have been launched by Russian Proton and Soyuz rockets and various US space shuttles. The station is regularly serviced by a variety of visiting spacecrafts from stakeholder nations mainly the Russian Soyuz and Progress and the US Space X. As of April 2022, 251 astronauts, cosmonauts and space tourists from 20 different nations have visited the space station, many of them multiple times.

The ISS was launched from Baikonur cosmodrome of Russia in 1998, and the first long-term human residents arrived on 2 November 2000. The station has since been continuously occupied for more than 21 years, the longest continuous human presence in low Earth orbit, having surpassed the previous record of nine years and 357 days held by the Mir space station. Although ISS was initially agreed upon by parties to function upto 2024, it was later decided to extend its operation till 2030 through

additional funding.

If Russia does leave the project, this would, no doubt, seriously jeopardize the activity of the space station as the Russian side provides the crucial propulsion mechanism that keeps the platform afloat in orbit. Regular cargo and crew missions by Russia's Soyuz and Progress rockets supply the necessary fuel to the propulsion engines of the spacecraft that boost its height periodically to compensate the height loss due to atmospheric air drag. Without these periodical boostings, the space station would dangerously spiral into the Earth's atmosphere eventually burning out in air. As the US side simply looks after the power and communication system of the space station, it seems unlikely that the US and its partner nations would quickly find a solution to the vital propulsion system to keep the aging spacecraft get going in the event of a Russian withdrawal.



Normal monsoon in Aug-Sept: IMD

New Delhi, August 1: India will receive normal monsoon rains in August-September, particularly in eastern Uttar Pradesh and Jharkhand - regions that have received the lowest rainfall in 119 years, the weather office said Monday.

Rainfall in the east and northeastern regions, the rice bowl of the country, has been 45 per cent lesser than normal in July, but the forecast for the next two months has raised hopes for better showers, at least in eastern Uttar Pradesh and Jharkhand, Director General of India Meteorological Department (IMD) Mrutyunjay Mohapatra said during a virtual press conference.

"There is some scope for recovery of high rain deficiency in Jharkhand, Gangetic West Bengal and East Uttar Pradesh. But some deficiency may remain in Bihar and some northeastern states," he said.

The earlier lowest rains for the east and northeastern region was in 1903 when the deficiency was 41.3 per cent below the normal level for the season.

He said rainfall across the country during the August-September period of the southwest monsoon season was most likely to be normal, i.E., 94 to 106 per cent of Long Period Average (LPA).

India has received seven per cent excess rains this season between June 1 and July 31, but the distribution has been uneven, with rice producing states of Uttar Pradesh, Bihar, Jharkhand and Gangetic West Bengal reporting deficient rainfall.

"For August, the monthly rain-

Indian Antarctic

New Delhi, August 1: The Rajya Sabha Monday passed the Indian Antarctic Bill 2022 amid sloganeering by the opposition MPs which forced the adjournment of the House.

The Lok Sabha had given its approval to the Bill July 22.

The Indian Antarctic Bill was introduced in the Rajya Sabha by Earth Sciences Minister Jitendra Singh. The bill was passed with a voice vote after a brief discussion amid protests by the opposition

The bill seeks to protect the environment of the Antarctic along with dependent and associated ecosystems and to give effect to the Antarctic Treaty. India has two active research stations in the Antarctic -- Maitri and Bharti.

The bill proposes to prohibit Indian expedition to Antarctica without a permit or written authorisation of another party to the Antarctic Treaty. It also provides for inspection by an officer appointed by the government and for a penalty for contravention of certain provisions of the legislation.

The Upper House also listed the widely-demanded price rise issue for discussion Tuesday. Both the Houses witnessed repeated adjournments Monday amid protests



MONKEYPOX IN INDIA

Govt forms task force to monitor situation



New Delhi, August 1: A task force on monkeypox has been constituted to closely monitor the emerging situation in the country and decide on response initiatives to tackle the spread of the disease, official sources said on Monday.

It will also provide guidance to the government on expansion of diagnostic facilities in the country and explore emerging trends related to vaccination for the disease, the sources told PTL Samples of a 22year-old man, who died in Kerala last week, have come out positive for monkeypox Monday.

The man had recently returned from the UAE where also his samples had tested positive for the disease, official sources said. India has reported a total of five cases of the disease so far.

The decision to constitute the task force was taken at a high-level meeting held July 26 at the level of the principal secretary to the prime minister to review the ongoing public health preparedness in the country. The task force will be headed by Dr V K Paul, NITI Aayog member (health).

The National Aids Control Organisation and the Directorate General of Health Services in the

Globally, over 16,000 cases of monkeypox have been reported from 75 countries

The Union Health Ministry has undertaken a number of initiatives which includes strengthening of health screening at Points of Entry and operationalisation of 15 laboratories under the ICMR to undertake testing for monkeypox

According to the WHO, monkeypox is a viral zoonosis -- a virus transmitted to humans from animals -- with symptoms similar to smallpox although clinically less severe

Health Ministry have been asked to work on a targeted communication strategy to promote timely reporting, detection of cases and management of cases, an officialsource said. Instructions were given to operationalise the Indian Council of Medical Research (ICMR) network of labs and make arrangements for requisite diagnostics of monkeypox disease. The World Health Organisation (WHO) recently declared monkeypox a global public health emergency of international concern.

LS Speaker withdraws suspension of four MPs

New Delhi, August 1: A week after suspending them from the House for "unruly" behaviour, Lok Sabha Speaker Om Birla Monday revoked the suspension of four Congress members, after seeking assurance from the Opposition that they will not bring placards to the House.

Birla also warned the members that he will take stringent action against those who violated the rules of procedure, which bars members from bringing any "exhibits" to the House.

Four Congress members --Manickam Tagore, Ramya Haridas, T N Prathapan and S Jothimani were suspended last Monday from LS for the rest of the monsoon session for carrying placards and raising slogans inside the House.

The monsoon session of Parliament has seen scant business since it began July 18 as the House remained deadlocked over protests by the opposition which in-

sisted on taking up discussion on price rise and other issues. In addition, the suspension of the MPs also became an issue between the opposition parties and the government, causing disruptions.

With the revocation of suspen sion, the House resumed normal business. The ball for revocation of suspension was set rolling with the Speaker convening a meeting of floor leaders on Monday to end the stalemate in the House.

As the House re-convened at 2:00 pm, Birla said he was hurt by the incidents that took place in the House over the past two weeks and urged members to work towards upholding the dignity of the Lok Sabha.

"There should be a consensus that we do not get placards in the House. I will urge all political parties not to bring placards to the House. I am giving a final warning, if anyone gets placards to the House I will neither listen to the government nor the opposition and will take action," the Speaker said.

Covid infection may accelerate brain ageing

New Delhi/New York, August 1: Covid-19 infections may predispose individuals to developing irreversible neurological conditions, finds a study.


The study by Houston Methodist researchers showed that Covid infection may increase the likelihood of strokes and may increase the chance of developing persistent brain lesions that can lead to brain bleeding.

Covid-19 is known to invade and infect the brain, among other major organs. Several brain imaging studies on Covid victims

and survivors have confirmed the formation of microbleed lesions in deeper brain regions related to our cognitive and memory func-

In the review study, published in the journal Ageing Research Reviews, researchers have critically evaluated the possible chronic neuropathological outcomes in ageing and comorbid populations if timely therapeutic intervention is not implemented.

Microbleeds are emerging neuropathological signatures frequently identified in people suffering from chronic stress, depressive disorders, diabetes and



age-associated comorbidities.

Based on their earlier findings, the investigators discuss how Covid-induced micro-haemorrhagic lesions may exacerbate DNA damage in affected brain cells, resulting in neuronal senescence and activation of cell death mechanisms, which ultimately impact brain microstructure-vasculature.

These pathological phenomena resemble hallmarks of neurode-

generative conditions like Alzheimer's and Parkinson's diseases and are likely to aggravate advanced-stage dementia, as well

as cognitive and motor deficits. Further, the review includes Covid's predispositions for Alzheimer's, Parkinson's and related neurodegenerative diseases, as well as cardiovascular disorders due to internal bleeding and blood clotting-induced lesions in the part of the brain that regulates our respiratory system, following the Covid symptoms.

In addition, cellular ageing is thought to be accelerated in Covid patients. A plethora of cellular stresses inhibit the virus-infected cells from undergoing their normal biological functions and let them enter into "hibernation mode"

or even die completely. The study also suggests various strategies to improve some of these long-term neuropsychiatric and neurodegenerative outcomes, as well as outlines the importance of the therapeutic regimen of the "nanozyme" in combination with various FDAapproved drugs that may prove successful to fight against this cat-

astrophic disease. However, given the ever-evolving nature of this field, associations like the ones described in this review show the fight against Covid is far from over, said the researchers, and reinforce the message that getting vaccinated and maintaining proper hygiene are key in trying to prevent such longterm and detrimental conse-

Swine flu resurfaces in Kerala's Wayanad, first time in Kannur

The new case has made the Animal Husbandry department sound an alert in the district. The Deputy Director of Animal Husbandry in Wayanad, Dr Rajesh, told PTI that 193 pigs in and around the Nenmeni farm in Sultan Bathery will have to be culled this week to prevent the disease from spreading.



Kerala had in July tightened biosecurity measures following an alert from the Centre that African swine fever had been reported in Bihar and a few northeastern states.

According to the Food and Agriculture Organisation (FAO), African swine fever is a highly contagious and fatal viral disease of domestic pigs.

It was first detected in Kenya, East Africa, in 1921 as a disease that killed settlers' pigs. Contact with warthogs was proven to be an important factor in transmission of the virus.

Addressing a press conference outside Parliament House, Congress spokesperson Shaktisinh Gohil claimed that 75 people lost their lives in the Gujarat hooch tragedy with many others losing their eyesight or kidneys after drinking spurious liquor despite the imposition of prohibition and strict laws on chemicals in the state.

According to officials, at least 42 people from Botad and neighbouring Ahmedabad district died after consuming the toxic brew

"The sarpanch had written to (the Gujarat) home minister and also had gone to police station flagging illegal alcohol sale. But since they (BJP leaders) were taking money, nothing happened. The sarpanch complained again, but no action was taken," Gohil, who is a Rajya Sabha member, alleged.

Gohil demanded that compensation be given immediately to those affected by the tragedy.

Alleging collusion of BJP leaders and those indulging in illegal

Ahmedabad, August 1: On the request of American authorities, police in Mehsana district in Guiarat have launched a probe to unearth an alleged racket in which ineligible students are getting help to acquire high International English Language Testing System (IELTS) score to obtain admission in colleges in Canada so that they can be then smuggled into the US, an official said Monday.

The probe so far has revealed no transparency was maintained by the agency which took the exam, as CCTVs of the hall were turned off during the exam held in September last year, said Inspector Bhavesh Rathod of the Mehsana police's Special Operations Group (SOG), who is leading the probe

In March this year, US border authorities had arrested six youths from Guiarat during a failed attempt to get them unauthorised entry into the country from Canada.

'These six Indian nationals from Gujarat, in the 19-21 age group, were



apprehended from a sinking boat in the Saint Regis river in Akwesasne, US, close to the Canadian border. Four are from Mehsana, and two are from Gandhinagar and Patan," said Rathod

"When they were produced before a court in the US, they failed to answer in English the questions asked by the judge. The court had to take the help of a Hindi translator. The court was haffled as these students had scored 6.5 to 7 bands in IELTS. an English proficiency test," Rathod

Later, citing a news report on the incident, the criminal fraud investigation unit of the US Consulate General in Mumbai sent a mail to Mehsana police to conduct an inquiry to find out how these four students from Mehsana received very high scores and which agency or agents were involved, Rathod informed

The IELTS is an international standardised test of English language proficiency for non-native English language speakers, with a good score being necessary for admission in good colleges in several

"Even brilliant students need to

work hard to get 5 or 6 bands in the IELTS. These four students, residents of different villages of Mehsana, managed to score between 6.5 and 7, and yet could not communicate in English," Rathod

Primary probe has revealed the four students -- Dhruv Patel, Neel Patel, Urvish Patel and Savan Patel - appeared for the IELTS exam at a centre in south Gujarat's Navsari town September 25, 2021, and went to Canada on student visa March 19, nearly two weeks before they were caught at the US-Canada bor-

"The manager of the banquet hall in Navsari, which was hired for the exam, said the exam supervisors had turned off CCTV cameras before the exam. This proves there was no transparency and something was definitely suspicious. The agency which was authorised to conduct the exam is based in Ahmedabad," said Rathod.

Owners of the agency, located in Sabarmati area of Ahmedabad. have been directed to appear before Mehsana SOG within 48 hours with related documents as part of

Man dispels myth of moving to cities for job

Uttarkashi. August 1: When Balak Ram Nautiyal gave up a job in town to return to his village and take up farming, he was not sure whether it was the right decision. Four years on, he does not regret it as a rich crop of marigold in his fields is making him earn in lakhs.

People of Uttarkashi who had to travel to Rishikesh and Dehradun to buy flowers for special occasions like a marriage, a public function or a religious ceremony can now get them in plenty in their home district itself.

Nautiyal (29) quit his job at the Jolly Grant airport in 2018 to return to Tulyada, a picturesque village in the Chinyalisaur block of Uttarkashi district. At that time, his primary aim was to lend a helping hand to his ageing parents in farming. But now, flower growing has become his full-time business.

"Looking at his success. People in Uttarkashi have begun to question the age-old belief that migrating to urban areas was necessary to earn a living," says Yamunotri MLA Sanjay Dobhal.

"A variety of flowers grow in Uttarakhand's hills but their commercial cultivation had never been



a viable livelihood option for the hill people. However, Nautiyal has proved that it is possible," the legislator said.

At a time when continued migration from Uttarakhand's hills and depleting population in the villages are a cause for concern for authorities, they can cite Nautival's success story to lure

migrants back to their villages. After graduation, Nautiyal left his home and his ageing parents four years ago to take up a job at the Jolly Grant airport. However, after some years he decided to quit his job and return home to help his

parents in farming. He initially sowed tomato, brinjal, cucumber, okra, and lemon. The yield was so impressive that he was enthused to make forays into horticulture.

Nautiyal's vegetables and fruits

always sold well in the local markets but when his aloe vera juice hit the shops it caught the attention of the authorities.

While he was still planning to approach them to seek help, officials of the horticulture department and the Vivekananda Parvatiya Krishi Anusandhan Sansthan met him to find out how they could help him.





Bengal to carve out seven new districts

Kolkata: West Bengal is set to get seven new districts with the cabinet giving its nod to the proposal, Chief Minister Mamata Baneriee said Monday. In view of the development, Kerala Chief Minister Pinarayi Vijayan has called a meeting of the District Collectors to assess rain damage and coordinate relief work, a release issued by the Chief Minister's Office (CMO) said.

Salman Khan gets gun licence

New Delhi: The Mumbai Police have granted a licence for a personal gun to Bollywood star Salman Khan following death threats in June against him and his father, veteran writer Salim Khan, official sources said here Monday. In late July, Salman Khan had called on Police Commissioner Vivek Phansalkar with a request for the gun licence, though the police had vehemently denied the same. The application was routed through the proper channel, and after all formalities were completed last week, the licence papers were handed over Sunday. In early June, a note was recovered with a threat to the Khan celebs, "you will meet the same fate as Moosewala", the Punjabi singer who was killed in May.

9 kids died due to diarrhoea

Itanagar: At least nine children died due to diarrhoea in the remote Lazu area of Arunachal Pradesh's Tirap district, health officials confirmed Monday. Tirap District Medical Officer (DMO) Obang Taggu said that the children who died were aged between 3-10 years while many others have fallen ill in the past one week following the outbreak of diarrhoea.

10 dead in Jabalpur hosp fire 10 electrocuted in West Bengal



Bhopal, August 1: At least 10 people have been killed after a massive fire broke out Monday in a hospital in Madhya Pradesh's Jabalpur,

Several fire tenders were rushed to the New Life Multispeciality Hospital which eventually managed to bring the blaze under control.

Many people including patients and hospital staff were inside the building when the fire had broken out. Madhya Pradesh Medical Education Minister Vishwas Sarang said though the exact cause of fire is yet to be ascertained, a shortcircuit is being suspected as one of the reasons

Saying that that fire has been doused and people trapped inside the hospital have been evacuated, he said: "At present, I can't say why many people have lost lives, as the operation is still underway. I am in touch with the Jabalpur district collector, who is on the spot and leading the rescue operation.'

All the patients are being shifted

The fire erupted at New Life Multi-speciality Hospital near Damoh Naka under the Gohalpur police station area of Jabalpur around 2.30 pm Superintendent of Police (SP) Siddharth Bahuguna told PTI

- Madhya Pradesh Chief Minister Shiyrai Singh Chouhan expressed grief over the tragedy and announced a compensation of Rs 5 lakh each to the family of the deceased and Rs 50,000 per injured person

to the nearby hospitals. Jabalpur SP Siddharth Bahuguna said at least 10 casualties have been reported so far. He said the fire possibly broke out due to short circuit during changeover of electricity supply from the generator after a power cut.

The fire broke out on the ground floor of the hospital around 4.30 p.m., and engulfed the entire threestorey building. Meanwhile, Madhya Pradesh Chief Minister Shivraj Singh Chouhan, expressing grief over the incident, has announced a compensation of Rs 5 lakh to the kin of the deceased.

Former Chief Minister and Madhya Pradesh Congress president Kamal Nath also condoled the unfortunate incident, and demanded an investigation into the matter.

In a tweet, Shivraj Singh Chouhan said that he is in constant touch with the local administration and collector. "The Chief Secretary has been directed to keep an eye on the entire matter. Every effort is being made for relief and rescue," he added.

"In this hour of grief, the bereaved family should not consider themselves alone, I and the entire Madhya Pradesh are with the family," the Chief Minister said.

He further said that the Madhya Pradesh government will provide assistance of Rs 5 lakh each to the next of kin of the deceased and Rs 50 thousand to the seriously iniured. "The government will also bear the cost of complete treatment of the injured," Chief Minister

Kolkata, August 1: Ten people were electrocuted while they were travelling in a pick-up van in West Bengal's Cooch Behar district, authorities said, adding that six others were also critically injured.

Initial probe has revealed that the electrocution was likely triggered due to the short-circuit of a copper wire of the generator installed at the rear side of the carriage vehicle

A total of 36 passengers on board the van were heading towards the Alpesh temple near Maynaguri in Jalpaiguri district.

Some of the survivors have informed the Mathabhanga Additional Superintendent of Police, Amit Barma that the shortcircuit happened when the vehicle was crossing the Dharala Bridge on the Jamaldaha-Changrabandha state highways. "As per information that we have received from the surviving passengers the short-circuit somehow happened, following which many passengers were electrocuted. The driver of the carriage vehicle without wasting time rushed towards the Jalpaiguri district hospital," Barma told mediapersons.

However, after reaching the Jalpaiguri district hospital, the driver of the van went missing and the police are trying to locate him. The victims were mainly esidents of Sitalkuchi area in Cooch Behar.



Parliament passes Bill to ban funding of WMD

New Delhi. August 1: Parliament Monday passed a Bill which seeks to ban funding of weapons of mass destruction and also empowers the Centre to freeze, seize or attach financial assets and economic resources of people engaged in such activities.

The Weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Amendment Bill, 2022, piloted by External Affairs Minister S Jaishankar, was passed by the Rajya Sabha with a voice vote even as opposition parties continued their protest over various issues, including the arrest of Shiv Sena MP Sanjay Raut in a money laundering case. The Bill was approved by the Lok Sabha in April.

Replying to a debate on the Bill,

Jaishankar said all members who spoke on the proposed legislation recognised that terrorism is a serious threat and so are weapons of mass destruction (WMD).

He said that the current law only covers trading and does not cover financing of weapons of mass destruction. "This gap needs to be filled because recommendation...Of the Financial Action Task Force requires all countries, including us, to ensure that assets financing for WMD-related activities is prohibited." "So keeping in mind this lacunae of the current law we have brought this amendment. This is good for the security of the country. This is good for the reputation of the country, Jaishankar said. The Weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Act, passed in 2005, only banned manufacture of weapons

The amendment bill seeks to insert a new Section 12A in the existing law which states that "no person shall finance any activity which is prohibited under this Act, or under the United Nations (Security Council) Act, 1947 or any other relevant Act for the time being in force, or by an order issued under any such Act, in relation to weapons of mass destruction and their delivery systems.'

Sanjay Raut sent to **ED custody till Aug 4**

Mumbai, August 1: A special court here Monday sent Shiv Sena MP Saniav Raut to the custody of Enforcement Directorate for 3 days. till Thursday, in a money laundering case arising out of the Patra Chawl land scam.

Special PMLA court judge M.G. Deshpande pronounced the order as Raut was produced before it, hours after he was arrested by the ED here early this morning.

While ED's special counsel Hiten Venegaonkar sought 8 days custody. Raut's lawyer, senior counsel Ashok Mundargi opposed it on various grounds including the health problems of his client who

was a cardiac patient.

Venegaonkar argued that Raut was not cooperating with the investigations and hence his custodial interrogation was necessary and the agency wanted to probe other aspects of the Patra Chawl scam and related issues.

He contended that co-accused Pravin Raut was merely a front-man and all deals pertaining to the Patra Chawl scam were perpetrated by Sanjay Raut.

Opposing the ED's contentions, Mundargi said that Raut's arrest was politically motivated and pleaded for minimum custody for his client.

CON CAPITAL OF THE WORLD

aking an Indian Premier League (IPL) cricket series in a north Gujarat village to con punters in far off Russia may be audacious but what it has brought into sharp focus is the emergence of India as the con capital of the

The fake IPL caught the fancy of the media worldwide, but what has evaded attention is the steady rise of con-call centres, betting bookie-syndicates and bit coin scam set-ups with the financial muscle to rival corporate India and all in pure black money proceeds.

According to a US based group which has been researching the field, just one group of scammers on Telegram has 55,000 members in India. The group which penetrated a fake call centre in India found that it made 18 million US dollars a year through such dubious means or \$60,000 USD per day working a six day week. And if there are 55,000 members (fake call centres) scattered countrywide, the cash involved adds up to a huge sum. Official agencies may take time coordinating but for con-call centres time is money so exchange of information amongst their network is fast-paced. Such

is the cohesion that the penetration of just one centre led to a countrywide shutdown of all of them almost immediately, re-opening cautiously after a week. Nothing had changed, life was usual and the business brisk.

On May 9 this year US based You Tuber, Mark Rober had created a furore with a 26 minute video that exposed four call centres, three in Kolkata and one in Gurugram as being key players in a scam that had seen 60 million people across the world being swindled of almost USD 20 billion in savings. Rober had collaborated with two other You Tubers and hacked into the offices of these call centres to unravel how they pulled off the scam and demonstrated it in graphic detail. The con-call scamsters impersonate officials from various government tax and commerce bodies and coax the victims into transferring money using the ploy of pending taxes or incorrect refunds.

Again, according to a study by Truecaller, a Swedish company founded in 2009 to identify callers and now helping fight such crimes, nearly \$39.5 billion were stolen from 68.4 million American citizens by scam centres like



these in the last 12 months alone. This means that one in three Americans report having fallen victims to phone scams, with 20 per cent more than once, points out its US Spam and Scam Report for 2022. The plight of the gullible targeted in other Western countries is no better.

The report has some incredible information on India. Over 202 million calls were made by just one spammer in India this year. That's over 6,64,000 calls every day and 27,000 calls every hour of the day. What about the rest? It beats understanding how telecom operators allow such call volume. Almost 93.5 per cent of all spam in India are sales or telemarketing calls and one of the most common remains the KYC (Know Your Customer) wherein the RBI mandated rule is used

to secure these documents posing as a bank or digital payments service. Another ruse is to lure the gullible to download a remote access application (OTPs, online sales, lotteries) which eventually leads to huge loss of money from banks, cards and digital mobile wallets. Average number of calls per user per month stands at 16.8 while total spam volume received by Truecaller users alone is in excess of 3.8 billion calls in just the month of October, 2021.

As things stand the police in the states are hard put to match the speed, financial clout and tech-savvy ways of the con-call consortium. The con-call conglomerate in India operates both inter-country as well as intra-country.

It was in 2016 that it first came to light that a call centre racket operating out of India has been conning gullible Americans. Though initially detected in Maharashtra in 2016 it was Gujarat which emerged as the epicentre of this totally fraudulent operation when it was learnt that a module operating out of India was conning gullible Americans. The amount then, it was believed, to have crossed an estimated \$500 million. From here it soon spanned out countrywide. It was the American government which brought matters to the notice of the Indian authorities. Five Ahmedabad based call centres and 61 individuals were named in the initial indictment by the US Justice Department which sought their extradition. The modus operandi involved sending across a voice mail regarding dues or tax lapse. providing a number to call back. After the targeted victim chosen with care, do so he would be threatened with fines, imprisonment even deportation. The indictment stated that in one case \$136,000 was extorted from a single victim in

Hayward, California. In fact, this was not the first instance of con-call centres being run from Gujarat. In February 2012, the US Federal trade Commission had informed the Indian authorities that an Ahmedabad-based call centre had made 8.5 million threat calls in less than an year and conned American citizens of \$5 million.

Nothing much seems to have changed with the network still functioning from various parts of the state, now even the country, though the organisers, 'oil' well and cover their tracks better.



9 dead, 76 injured

Cairo: A fuel tanker truck caught fire and exploded Monday in central Libya, killing at least nine people and injuring 76 others, health authorities said. The incident took place in the central town of Bent Bayya when the tanker truck overturned before catching fire and exploding, the state-run Libya News agency reported. First grain ship leaves Ukraine under Russia deal

Kyiv, August 1: A ship carrying grain left the Ukrainian port of Odesa for Lebanon Monday under a safe passage agreement, Ukrainian and Turkish officials said, the first departure since the Russian invasion blocked shipping through the Black Sea five

Ukraine's foreign minister called it "a day of relief for the world", especially for countries threatened by food shortages and hunger because of the disrupted shipments. The sailing was made possible after Turkey and the United Nations brokered a grain-and-fertiliser export agreement between Russia and Ukraine last month - a rare diplomatic breakthrough in a conflict that is grinding on with no resolution in sight.

'The first grain ship since #RussianAggression has left port," Infrastructure Minister Oleksandr Kubrakov said. "Today Ukraine, together with its partners, makes another step to prevent world hunger." The Sierra Leone-flagged ship Razoni will head to Lebanon **'RELIEF FOR THE WORLD'**

Of the voyage ahead, he said: "I am scared from the fact that there are naval mines. We need around two to three hours to exit regional waters. We hope that nothing will happen and that we will not commit any mistake."

The U.S. Embassy in Kyiv welcomed the shipping resumption, saving: "The world will be watching for continued implementation of this agreement to feed people around the world with millions of tons of trapped Ukrainian grain." U.N. Secretary-General Antonio Guterres said he hoped it would the first of many such shipments.

POPE TO VISIT

Vatican City, August 1: Pope Francis will attend a meeting of religious leaders in Kazakhstan in September, the Vatican said Monday, a gathering where he has said previously he hoped to meet with the Russian Orthodox patriarch, who backs the war in Ukraine.



Francis is set to be in the capital Nur-Sultan from September 13-15 to attend the VII Congress of Leaders of World and Traditional Religions, the Vatican said. The Pope has said in several recent interviews that he hopes to meet in the Kazakh capital with patriarch Kirill, who has given his fullthroated backing to Russia's invasion of Ukraine, which began February 24.

Francis had planned to meet Kirill June 14 in Jerusalem but cancelled that meeting on the advice of Vatican diplomats.

If the September meeting takes place, it would be only their second after they met in Cuba in 2016. The latter was the first such meeting between a pope and a leader of the Russian Orthodox Church since the Great Schism in 1054. The Vatican statement an-

nouncing the trip did not mention Kirill. It was released in Russian. Italian and English. Kazakh and Russian are the

country's two official languages. The Ukraine war has caused a rift between the Vatican and the Russian Orthodox Church (ROC).

In an interview published in May in an Italian newspaper, Francis said Kirill "cannot become Putin's altar boy". The ROC later chided the pope over the remark.



SL top court extends travel ban

Colombo, August 1: Sri Lanka's Supreme Court Monday extended until August 4 the overseas travel ban on former Prime Minister Mahinda Rajapaksa and his younger brother and former finance minister Basil Rajapaksa, who are widely blamed for the current economic cri sis in the island nation.

A five judge bench of the Supreme Court led by Chief Justice Jayantha Jayasuriya announced the Monday's decision in a petition filed against the brothers of former President Gotabaya Rajapaksa by a group including former Chairman of the Cevlon Chamber of Commerce Chandra Jayaratne, former Sri Lanka swimming champion Julian Bolling, Jehan



International Sri Lanka.

The direction was issued when a motion related to the petition requesting the court to issue an order for an investigation against the people responsible for the current economic crisis came up on Monday.

The petition claimed that three persons -- Basil, Mahinda and former Central Bank Governor Ajith Nivard Cabraal -- were directly re-

sponsible for the unsustainability of Sri Lanka's foreign debt, its debt default and the current economic crisis leading to an acute shortage of basic commodities such as food, fuel, and medicines.

July 15, Sri Lanka's apex court had barred the trio from leaving the country till July 28, the report said. The ban was later extended till August 2. Earlier this month, Basil was prevented from leaving Sri Lanka following protests from passengers and officials at the Bandaranaike International Airport here

Mahinda and Basil's brother Gotabaya Rajapaksa, the former Sri Lankan President, arrived in Singapore on July 14 on a "private visit" from the Maldives after he fled his country to escape a popular uprising against his government's

Global forest area decreased by over 60% in six decades: Study

Tokyo, August 1: The global forest area per capita has decreased by over 60 per cent over the past 60 years, a loss that threatens the future of biodiversity and impacts the lives of 1.6 billion people world-

wide, according to a study. The research, published in the journal Environmental Research Letters, found that the global forest area has declined by 81.7 million hectares from 1960 to 2019, with gross forest loss outweighing gross forest gain.

The researchers from the Forestry and Forest Products Research Institute (FFPRI) in Japan used global land use dataset to examine how global forests have changed over space and time.

They found that decline in global forests combined with the increase in global population over the 60year period has resulted in a decrease of the global forest area per capita by over 60 per cent, from 1.4 hectares in 1960 to 0.5 hectares in 2019.

"The continuous loss and degradation of forests affect the integrity of forest ecosystems, reducing their ability to generate and provide essential services and sustain biodiversity," the re-

results also showed that the change in the spatiotemporal pattern of global forests supports the forest transition theory, with forest losses occurring primarily in the lowerincome countries in the tropics and forest gains in the higher-income countries in the extratropics.

"Despite this spatial pattern of forest loss occurring primarily in the less developed countries, the role of more developed nations in this said forest loss also needs to be studied more deeply," said Ronald C. Estoque, the lead author of the study.

With the strengthening of forest conservation in more developed countries, forest loss is dis-

Monsoon limits July fuel demand

New Delhi: Petrol and diesel sales in the country fell in July over the previous month as the onset of monsoon chipped away demand in some sectors and restricted mobility, preliminary industry data showed. Diesel, the most widely used fuel in the country, saw consumption drop 13.1 per cent to 6.44 million tonne from 7.39 million tonne of demand in June. The arrival and intensity of monsoon weigh heavily on diesel demand in the country and consumption traditionally is lower in July-September than in April-June.

July power usage grows 3.8% YoY

New Delhi: India's power consumption grew marginally by 3.8 per cent year-on-year to 128.38 billion units (BU) in July amid widespread rains in the country, according to data. Power consumption in July last vear was recorded at 123.72 BU, which was higher than 112.14 BU in the same month of 2020. However, the peak power demand met, which is the highest supply in a day, during July dipped to 190.38 GW. The peak power supply stood at 200.53 GW in July 2021 and 170.40 GW in July 2020.

CIL's coal output rises 11% in July

New Delhi: State-owned CIL Monday said that it produced 47.3 million tonne (MT) of coal last month, registering a growth of 11 per cent from the year-ago period. The production of domestic coal usually dips during monsoon every year due to disruptions in mining activity. The company's output in the corresponding month of previous fiscal was 42.6 MT, the coal behemoth said in a BSE filing. Coal India Ltd (CIL) said it maintained the doubledigit rising streak for four consecutive months of the current financial year.

ICICI ups lending rate by 15 bps

New Delhi: ICICI Bank, the second-largest private sector lender, Monday raised its lending rates by 0.15 per cent across all tenors in anticipation of a rate hike by the RBI later this week. The rates have been increased across all tenors under the marginal cost of funds-based lending rate (MCLR) system, a move that will make EMI expensive for those who availed loans benchmarked against MCLR.

Richest Indian Gautam Adani's group, whose entry in the auction was billed by some as another flash point in the rivalry with Ambani, paid Rs 212 crore for 400 MHz, or less than one per cent of all spectrum sold, in a band that is not used for offering public telephony services.

Telecom tycoon Sunil Bharti Mittal's Bharti Airtel made a successful bid of Rs 43,084 crore, while Vodafone Idea Ltd bought spectrum for Rs 18,799 crore

Telecom Minister Ashwini Vaishnaw said of the 72,098 MHz of spectrum offered across 10 bands, 51,236 MHz, or 71 per cent, was sold.

COVENTRY: Indian judokas L Shushila Devi and Vijay Kumar Yadav signed off with a silver and a bronze medal in women's 48kg and men's 60kg respectively at the Commonwealth Games here Monday

The 27-year-old Shushila fought hard before losing the final via 'Waza-Ari' in the 4.25-minute final against South Africa's Michaela Whitebooi, while Yaday dished out a dominating show to take down Petros Christodoulides of Cyprus with a 'Ippon' in the bronze medal match.

For Shushila, it was her second silver medal at the showpiece event. She had finished runners-up at the

Ajay Singh misses medal by whisker

BIRMINGHAM: A low snatch total and a fluffed clean and jerk lift cost Ajay Singh (81kg) dear as the Indian weightlifter missed the bronze medal by a whisker in his maiden Commonwealth Games appearance, here Monday. The 25-year-old managed a total effort of 319kg (143kg+176kg) to finish fourth best in the men's 81kg event. To the crowd's absolute delight, home favourite England's Chris Murray 325kg (144kg+181kg) grabbed the gold in a sensational manner as he broke the Games record in total lift. Australian lifter Kyle Bruce (143kg+180kg) 323kg clinched the silver while Canada's Nicholas Vachon 320kg (140kg+180kg) finished with a bronze.

Sheuli, a junior world championship silver medallist, executed three clean lifts - 137kg, 140kg and 143kg - in the snatch section. His 143kg effort helped him smash the Games record and improve his personal best.

Heading into clean and jerk with a five kilogram advantage, the Kolkata lifter started with a 166kg lift, which he hoisted easily. Sheuli then faltered his 170kg attempt only to heave the weight in the third attempt and create a new Games record in total lift (313kg).

The Indian lifter had to wait patiently towards the end to find out what medal he'd take home as the Malaysian attempted a 176kg lift in his last two attempts only to fail

Asked what his coach Sharma told him before the final clean and jerk attempt, Sheuli said, "He told me this gold belongs to me just keep calm and go for it. I was a bit nervous but his performance was way below me and I went for it."

With the gold from Sheuli, the Indian weightlifting contingent has bagged its sixth medal of the

Narrow escape for Vishavjeet

Panghal, Hussamuddin cruise into quarterfinals



BIRMINGHAM: Indian boxer Amit Panghal began his campaign at the Commonwealth Games with a facile win as he stormed into the men's flyweight (51kg) quarterfinals here Monday. Panghal, a World Championship silver medallist, out-punched Namri Berri of Vanuatu via a unanimous verdict.

Featherweight boxer Mohammad Hussamuddin made it two out of two as he also advanced to the quarterfinals with a similar 5-0 win over Mohammad Salim Hossain of Bangladesh in the round

Panghal, who is participating in his first big tournament after the disappointing show at the Tokyo Olympics, looked in control throughout the three rounds. He used his combination of right and left punches effectively and fought from a distance, compelling Berri to come forward and attack.

Panghal was quick to land a flurry of punches in each of the three rounds as Berri was no match for the Indian. With the opening two rounds going in his favour, Panghal was content with defending in the



final three minutes, saving his energy for the tougher challenges

He is now one win away from securing his second CWG medal. In the last edition in Gold Coast he had clinched a silver. He will face 20-yearold Lennon Mulligan of Scotland.

"It was a good workout but it was easy. My opponent was good but never gave me any problems,' Panghal said after his win.

"I could have stepped it up but there is a long way to go and I am here for gold. I won silver at Gold Coast and I am here to go one better. I am only interested in the gold medal. That's why I took it on points, to get a good bit of work in the ring," he added.

Last edition's bronze medallist, Hussamuddin also put up a dominant display in his fast-paced bout. The 28-year-old Indian was at his counter-attacking best as he landed sharp punches while dancing across

He will fancy his chances of a second CWG medal as he faces Namibia's Tryagain Morning Ndevelo in the quarterfinals.

"We cannot express our feelings in mere words. We have fought as a team and now our journey doesn't end here," an emotional lawn bowler Tirkey said. "We have to play in a similar fashion against been done before," she added.

Against New Zealand, after conceding a 0-5 lead after the secondend, the Indian team made a strong back against the Kiwi team of Selina Goddard (lead), Nicole Toomey (second), Tayle Bruce (third) and Val Smith (skip).

BIRMINGHAM: Indian cyclist Vishavjeet Singh, who qualified for the final in the men's 15km scratch race, made a narrow escape from the horrific crash that

grabbed the spotlight at the Commonwealth Games. The incident happened in the afternoon on Sunday when the cyclists were into their final leg of the 10-lap qualifying scratch race. Eight riders collided on the track at the

Lee Valley Velo Park in London. The 24-year-old Olympic cham pion Matt Walls of England suffered stitches, scrapes and bruises after crashing over the barriers. Isle of Man's Matt Bostock and Canada's Derek Gee were also taken to hospital following minor injuries, said an official here.

Spectators were also injured, with one being taken away in a wheelchair as cyclists and bikes flew into the crowd, said team India cycling coach Dayalram Jatt.

Narrating the incident Jatt said Singh was just behind the pack but he showed presence of mind and moved away by braking in time.

"It requires tremendous skill to brake in time in that rush of blood and he did exactly that to stop behind as bikes flew into the barri-



ers. It was simply horrific, I never saw such an accident. We were left shaking in fear for some time, Jatt told PTI from London.

Vishavjeet, however, made sure that he reached a historic final for the first time in a multi-sport event. In the final consisting of 60 laps, Singh was going strong but fell behind in the final lap and incurred a penalty point to be labelled "did not finish (DNF)". "But overall, I'm happy for Singh to have survived the crash and make the final," the coach said.

Indian gymnast Pranati finishes 5th in vault final

BIRMINGHAM: India's Pranati Nayak finished fifth in women's vault final of artistic gymnastics event at the Commonwealth Games here Monday.

The 27-year-old from West Bengal, who has won bronze medals at the 2019 and 2022 Asian Championships, scored 13.633 in her first vault attempt and 11.766 in her second go for an average of 12.699 at the Arena Birmingham, Pranati, who scored 13.275 in the qualification, was handed a penalty of 0.1 and 0.3 in her two attempts.

Australia's Georgia Godwin won the gold medal with a score of 13.233, while Canada's Laurie Denommee (13.233) and Scotland's Shannon Archer (13.083) claimed the silver and bronze medals respectively.
