
Cop suspended for hitting lady pilgrim in Puri

Puri, Nov 7: A senior police constable (Havildar) was placed under suspension in Puri district after he allegedly hit an elderly woman pilgrim with a cane stick inside Srimandir here, a senior officer said. The 65-year-old woman, who sustained injuries on her head, was immediately taken to a hospital by other security personnel posted there.

According to police, Madhuri Das, a resident of Berhampur, got into an argument with the constable, after she was stopped from rushing into the sanctum sanctorum.

Havildar Prashant Dalai, who was managing the crowd, allegedly hit Das with his stick in the midst of the argument, the sources said.

The shrine has been witnessing heavy footfall over the past few days with devotees making a beeline to offer prayers to the Trinity on the occasion of 'Panchuka', a festival marking the end of Kartik month in Hindu calendar. A thorough probe will be conducted to ascertain the circumstances that led to the incident.

Two suicides in City

Bhubaneswar, Nov 7: Two persons including a youth committed suicide under Saheed Nagar police station limits here, police said Monday.

In the first incident, a 25-yearold youth identified as Anurag Das was found hanging in his room at an apartment in Bomikhal area here late Sunday night.

Das who hailed from Mangalpur police station area of Jajpur district was working in a showroom in city. He was staying in a mess along with other colleagues.

Sources in the police also revealed that Das had cut his wrist before hanging himself with a rope from the ceiling fan. His roommates told police that the deceased's brother, who stays nearby, asked them to check on him as Das was not answering his calls.

Subsequently, they found his room locked from inside. Assuming something wrong, the roommates informed the police at around 12.30am Monday.

Police broke into the room and brought Das's body in the presence of his brother. His body was later sent to Capital Hospital

for post-mortem.

Police have started investigation registering an unnatural death case (77/22) in this regard. Police suspect unsuccessful love affair might be the reason behind Das taking the extreme step. However, the family members are yet to lodge any complaint alleging foul play.


In the second incident, a 40year-old person committed suicide by hanging himself from the ceiling fan with a towel in his rental accommodation at Basuaghai area here, Monday. The deceased identified as Ramesh Chandra Patra was a resident of Berhampur.

Police sources claimed that Patra was a drug addict under severe mental pressure over monetary issues. The deceased's wife had gone to temple when Patra hanged himself.

Informed, police reached the spot and sent the body to capital hospital for post mortem.



SC clears EWS quota

A 5-JUDGE BENCH HEADED BY CJI UU LALIT PRONOUNCED 4 SEPARATE VERDICTS ON 40 PETITIONS CHALLENGING THE VALIDITY OF THE 103RD CONSTITUTION AMENDMENT

New Delhi, Nov 7: In a landmark verdict, the Supreme Court by a majority view of 3:2 Monday upheld the validity of the 103rd Constitution amendment providing 10 per cent reservation to people belonging to the economically weaker sections (EWS) in admissions and government jobs.

The court said the quota does not violate the basic structure of the Constitution. A five-judge constitution bench headed by Chief Justice UU Lalit pronounced four separate verdicts on 40 petitions challenging the validity of the 103rd Constitution amendment promulgated by the Centre in 2019.

While Justices Dinesh Maheshwari, Bela M Trivedi and JB Pardiwala upheld the law, Justice S Ravindra Bhat along with the CJI shot down the same in their minority view. The judges read four separate judgements for over 35

minutes in the courtroom. Justice Maheshwari, who read the judgement for himself, said the 103rd constitutional amendment cannot be said to breach the basic structure of the Constitution.

He said reservation is an instrument of affirmative action so as to ensure an all inclusive march towards goals of egalitarian society and it is a means of inclusion of any class or section so disadvantaged. Justice Trivedi said the 103rd constitutional amendment cannot be struck down on grounds of being discriminatory.

She said the 103rd Constitution amendment has to be treated as an affirmative action by Parliament

for the benefit of EWS class. Justice JB Pardiwala concurred with their views and upheld the validity of the amendment. Justice Pardiwala, however, said reservation is meant to secure social justice but it should not continue for indefinite time so that it becomes vested interest. Justice S Ravindra Bhat, in a minority view, dissented and struck down the constitution

3 die in series crash on NH-16

Balasore, Nov 7: At least three people were killed and four others sustained critical injuries Monday after one of two vehicles carrying them collided with an oil tanker in Balasore district, police said.

The accident took place around 6.30am on National Highway-16 near Radhaballavpur area, when one of the two SUVs rammed into the oil tanker from behind, following which the second car crashed into the first one. Seven people were travelling to Puri from Hooghly in the two cars. According to locals, a tyre of the tanker burst leading to the accident.

Two people died on the spot, while the driver of the vehicle that hit the tanker succumbed to his injuries at the nearby Soro hospital, police sources said.



The injured were undergoing treatment in the health facility, they added. The mishap occurred when an empty oil tanker was on its way to Balasore. However, the front tyre on the right of the tanker suddenly burst at Chingudi Square. As a result, it lost control leading to the series accident.

The car driver Ibrahim Qazi, 35, and a woman Parbati Das, 50, died on the spot while another occupant Shankar Rao, 45, succumbed to his injuries at Soro hospital. A total of seven persons including two children were travelling in these two cars.

The injured persons return Kolkata after treatment while the bodies were sent for post-mortem. The tanker driver is absconding while police seized the three vehicles and started an investigation.

Keonihar, Nov 7: Forest officials Monday recovered carcasses of a female elephant and its calf from Kalapata reserve forest near Kuliapala village under Telkoi forest range in Keonjhar district.

Woman carrying reptiles worth ₹50cr on train arrested

Jamshedpur, Nov 7: A woman travelling with rare species of snakes including pythons, and chameleons worth more than Rs 50 crore was arrested from the general compartment of Neelachal Express

at Tatanagar station in Jharkhand. The arrest was made by a joint team of Railway Protection Force (RPF), Government Railway Police (GRP) and Crime Intelligence Branch (CIB). The seized animals will be handed over to the Forest department. The accused has been identified as Devi Chandra hailing from Pune, said RPF in-charge SK Tiwari.

Tiwari added that the woman was identified and searched as soon as the train reached Tatanagar station. The team recovered a total of 28 snakes from the bag besides chameleons, spiders etc.



The RPF called snake catchers to take the reptiles out of the bag. Two Sand Boas and an Albino Python worth Rs 25 crore each were rescued. Apart from these, 19 ball pythons and four red pythons were found in nine boxes, added Tiwari. Twelve chameleons, beetles, and spiders were found in another box.

During interrogation, the woman revealed that a person in Nagalandhad given her the bag to deliver to Delhi in exchange of Rs 8,000.

Billionaires emit million times more greenhouse gases

FOR EACH OF THESE 125 BILLIONAIRES, IT WOULD TAKE 1.8 MILLION COWS TO EMIT THE SAME LEVELS OF CO2e

New Delhi, Nov 7: The investments of 125 of the world's richest billionaires yield an annual average of three million tonne of carbon dioxide emissions a year, more than a million times the average for someone in the bottom 90 per cent of humanity, according to a new report by non-profit group Oxfam.

These super rich people have a collective USD 2.4 trillion stake in 183 companies.

Their investments in polluting industries such as fossil fuels and cement are double the average for the Standard and Poor group of 500 companies, said the report titled 'Carbon Billionaires: The investment emissions of the world's richest people'. Cumulatively, these 125 billionaires fund 393 million tonne



of CO2e (carbon dioxide equivalent) per year, which is equal to the annual carbon emissions of France,

a nation of 67 million people. To put things into perspective, each of these billionaires would have to circumnavigate the world

almost 16 million times in a private

jet to create the same emissions, the report said.

It would take 1.8 million cows to emit the same levels of CO2e as each of the 125 billionaires. Almost four million people would have to go vegan to offset the emissions of each of the billionaires, it said.

"The major and growing responsibility of wealthy people for overall emissions is rarely discussed or considered in climate policy making. This has to change. These billionaire investors at the top of the corporate pyramid have huge responsibility for driving climate breakdown. They have escaped accountability for too long," said Amitabh Behar, CEO of Oxfam India.

Often the high-profile commitments made by corporates do not stand up to scrutiny. The flurry of net zero goals that depend on offsetting are at best a distraction from the need to take short-term measures to reduce corporates' emissions and have the potential to derail climate

action, Oxfam said. In 2021, Oxfam revealed that using land alone to remove the world's carbon emissions to achieve 'net zero' by 2050 would require at least 1.6 billion hectares of new forests, an area equivalent to five times the size of India.

'We need COP27 to expose and change the role that big corporates and their rich investors are playing in profiting from the pollution that is driving the global climate cri-

sis. They can't be allowed to hide or greenwash. We need governments to tackle this urgently by publishing emission figures for the richest people, regulating investors and corporates to slash carbon emissions and taxing wealth and polluting investments", said Nafkote Dabi, Climate Change Lead at Oxfam International.

Oxfam also estimated that a wealth tax on the world's superrich could raise USD 1.4 trillion a year, vital resources that could help developing countries - those worst hit by the climate crisis - to adapt, address loss and damage and carry out a just transition to

renewable energy. Oxfam also called for steeply higher tax rates for investments in polluting industries to deter such investments



Parties roll up sleeves for Padampur bypoll

Bhubaneswar, Nov 7: After completion of the Dhamnagar bypoll, the ruling BJD and opposition BJP as well as Congress have geared up for the byelection to Padampur Assembly constituency in Bargarh scheduled for December 5.

After facing a defeat in Dhamnagar, the BJD is planning to put a foolproof strategy to retain the Padampur seat. The ruling party is likely to utilise its full force to win the seat. As it has won Bijepur bypoll twice in the same district, the BJD is optimistic that it will win the Padampur seat as well.

'Our party President will select suitable candidate for the bypoll as per our process. Whoever will be the candidate, we will extend our full support," said senior BJD

leader Prasanna Acharya. Demised tribal leader and sitting MLA Bijay Ranjan Singh Bariha's widow Tilottama Singh

Bariha is hoping for a party ticket to contest the byelection. Speaking to reporters, Tilottama said, "I am hopeful of getting a

ticket. I hope the CM will shower

his blessings and give me a ticket

for the bypoll and enable me to fulfill the dreams of my husband." On the other hand, after winning the Dhamnagar bypoll, opposition BJP is now eying to snap

the Padampur MLA seat from BJD. The saffron party, which had lost the Padampur seat with 5,734 votes to the BJD, has decided to follow the strategy of Dhamnagar

State BJP president Samir Mohanty said the BJP has emerged as a strong alternative to the ruling BJD. The party will adopt the same strategy in the byelection to Padampur Assembly constituency, Mohanty said. The BJP is likely to renominate senior party leader Pradeep Purohit for the seat. Purohit had won the seat in 2014 and lost to BJD's Bijaya Ranjan Singh

Purohit said BJP's central leadership will decide who will contest from BJP in the bypoll. Whoever will be the candidate, BJP will certainly win the seat, he claimed.

Naveen pledges for affordable cancer care

Bhubaneswar, Nov 7: Odisha has taken robust measures for early detection and treatment of cancer in a bid to save precious lives from the disease, said Chief occasion of National Cancer Awareness Day, Monday.

He pledged to further improve access to affordable cancer care through comprehensive Odisha Cancer Care Programme.

The state government had in October this year declared cancer as a 'reportable disease', making mandatory reporting of all cases by all hospitals, clinical and radiological labs and any other healthcare institutions providing related diagnostic treatments.

Estimation of cancer burden and its distribution with respect to time place person is important to mobilise resources for prevention and control and reducing mortalities attributed to it," said an official notification put out by the Health and Family Welfare department.

State inks pact for 3 driving training institutes

Cuttack, Nov 7: The State Transport Authority (STA) Monday inked a pact with Ashok Leyland for development, management and operation of three new Institutes of Driving Training and Research (IDTR).

The new institutes will be operated at Berhampur, Keonjhar and Bonai in Sundargarh district. A heavy motor vehicle (HMV) driving training institute has been functioning in Jajpur's Chhatia

The Chhatia HMV institute was jointly established by the state government and Ashok Levland to train high quality drivers to meet the demand of the transport industry and to make local youths employable by adopting skill development in HMV driving. The institute has trained 60,581 drivers so far, an official said.

Now, the state government has decided to set up another three



Keonjhar and Bonai, particularly in the mining belt of the state where the requirement of skilled drivers are more, he said.

Transport Commissioner Arun Bothra said, "In our country, Odisha is providing excellent facilities to create skilled HMV drivers. No state has such numbers of IDTRs.

The upcoming facility will help enhance the HMV driving skills of the drivers particularly in mining areas of Odisha, he said.

These IDTRs will not only meet the requirement of drivers in different sectors, but also help in reducing the fatalities, injury and loss of property due to road accidents.

Besides, a trained and skilled driver will ensure timely and safe delivery of the goods, he added.

Through these institutes, which also house hostels, HMV drivers will get practical train-

ing on different types of terrains and road conditions.

The tenure of skilled driving training is 30 days as prescribed by the CMVR (Central Motor Vehicle Rule), 1989. Once the tests are cleared, the centre will also issue driving licenses to the skilled drivers.

Government driving training school principal Pradeep Kumar Mohanty said the monthly capacity of Berhampur, Keonjhar and Bonai is to train 140, 134 and 150 drivers respectively.

The construction of three IDTRs

has been completed by the state

government and the operation and management will be done in PPP mode with Ashok Leyland, Mohanty informed. The infrastructure of the three

new centres is ready and the training is expected to commence soon.

In the one-month course, driving skills of the applicants will be enhanced and they will be provided training on good road behaviour and etiquette, said the transport official.

Cuttack, Nov 7: More than 50 platoons of police personnel will be deployed during the nine-day-long historic 'Baliyatra' starting here Tuesday, Cuttack Deputy Commissioner of Police (DCP) Pinak Mishra said Monday.

As the annual festival is being held after a two-year of Covid hiatus, thousands of people are expected to throng the Baliyatra from November 8. "We have made elaborate arrangements. Initially, more than 50 platoons of policemen will be deployed," said the DCP.

Mishra added that in addition to the over 50 platoons of police force and officers of the district, more than 100 officers have been mobilised from outside.

"Police arrangements have been made taking into consideration different aspects, the first being crowd control, and security at the Baliyatra ground. Second is incoming traffic," Mishra said.

Lunar eclipse: World to witness city to witness total eclipse for 6 minutes thrilling 'Blood Moon' spectacle

Mumbai, Nov 7: On the evening of November 8, as the Earth's shadow envelopes its sole satellite for nearly oneand-half hours, the world will witness a thrilling and chilling spectacle of a 'Blood Moon' lunar eclipse, a prominent astronomer said here Monday.

Coming exactly 14 days (two Tuesdays) after the October 25 partial solar eclipse -- the lunar eclipse will be seen in totality in the northeastern states, but shall be only partially visible in the rest of India in the evening as the sun sets, said Bharat Adur, Director, Akash Ganga Centre for Astronomy (AGCA) here.

"Tomorrow, the Earth's looming shadow will cover the Moon and during this period it will appear a dark reddish colour, almost like a large drop of blood balanced in the sky... This phenomenon is called a 'Blood Moon' and it's an exciting spectacle," said Adur.

He urged the people to view it wherever possible, as this will be the last total lunar eclipse, and the next one (total lunar eclipse) due only after three years September 7, 2025.

The Earth will come between the Sun and Moon and the blue planet's monstrous shadow -- from a staggering distance of 3.93 lakh kms -- will shroud its small natural satellite, partially or fully, depending on the angle of alignment from where it is viewed, Adur explained.

The Sun is around 109 times bigger than Earth and over 148-million kms away, while the Earth is nearly four times larger than the Moon, with an average distance of 3,85 lakh kms sepa-

rating them. "In a total lunar eclipse, the Moon is $\,$ entirely blanketed by the Earth's darkest shadow, called the 'umbra', and at this time, the Moon appears a darkreddish colour, or what is called the 'Blood Moon' phenomenon," Adur said.

In scientific terms, it's called the 'Rayleigh Scattering' as during a lunar eclipse the only sunlight that reaches

Adur urged the people to view the eclipse wherever possible as it will be the last total lunar eclipse and the next one (total lunar eclipse) is due only after three years-September 7, 2025

the Moon passes through the Earth's atmosphere, thus turning the Moon an apparent reddish colour.

This is the second celestial event since the last partial Solar Eclipse (October 25), and can be witnessed by people in India, Pakistan, Afghanistan, parts of Asia, Russia, North and South Americas, Australia, North Atlantic Ocean and Pacific Ocean regions.

Despite the scary myths or deep religious aspects associated with any eclipse (solar/lunar), Adur assured that there is absolutely no harm in viewing the unusual 'Blood Moon' Tuesday with naked eyes or with binoculars which will enhance the reddish colour.

The northeastern parts of India like Kohima, Agartala, Guwahati and other regions in the world will witness it in totality Tuesday, the final eclipse of 2022.

As the Moon will be below the horizon during the eclipse hours, most other parts of India will miss the exciting starting phases of both the partial and total eclipse, he said.

Kolkata, New Delhi, Chennai along with Mumbai, can witness only the partial phase, and in the country's commercial capital barely 14 per cent of the Moon's obscuration can be viewed at 18.03 hours in the setting sun.

However, the Moon will be seen 60 per cent covered in Nagpur, 66 per cent in Srinagar and in varying degrees in

other cities, said Adur. In case people miss the 'Blood Moon' Tuesday, they can wait for October 28, 2023, when there will be another partial lunar eclipse that will be visible in some parts of the country,

Subhendu Pattnaik, Monday. Pattnaik said that the planetarium has arrangements in place for the science lovers of City to view the total lunar

eclipse from telescope. Meanwhile, the eclipse will be visible allover India at the time of the moonrise. However, the beginning of the partial and total phases of the eclipse will not be visible from any places of India as the phenomena will be in progress before the moonrise in the subcontinent, the Meteorological Centre Meteorological

Bhubaneswar said. But the ending of both the total and the partial phases will be visible to only the eastern parts of the country, while only the ending of the partial phase will be visible to the rest parts of the country.

The eclipse will begin at 14 hr 39 min IST. The total eclipse will start at 15 hr 46 min IST and end at 17hr 12mins IST while the ending time of partial phase is at 18h 19m IST.

The next lunar eclipse which will be visible from India is October 28, 2023 and the same day a partial eclipse will also be visible. Last lunar eclipse which was visible from India was November 19, 2021

and it was a partial eclipse. Lunar Eclipse occurs on a full moon day when the earth comes in between the Sun and the Moon and when all the three objects are aligned. A total lunar eclipse will occur when the whole moon comes under the umbral shadow of the Earth and the partial lunar eclipse occurs when only when a part of the moon comes under shadow of the Earth.

CJI Lalit concurred with the view of Justice Bhat

The apex court had September 27 reserved the verdict on the legal question of whether the EWS quota violated the basic structure of the Constitution after hearing a battery of senior lawyers, including the then Attorney General KK Venugopal and Solicitor General Tushar Mehta, in a marathon hearing that had lasted for six-and-half-

Academician Mohan Gopal had opened the arguments in the case before the bench, September 13 and opposed the EWS quota amendment by terming it as deceitful and a backdoor attempt to destroy the concept of reservation.

Tamil Nadu, represented by senior advocate Shekhar Naphade, had also opposed the EWS quota, saying the economic criteria cannot be the basis for classification and the top court will have to revisit the Indira Sawhnev (Mandal) judgement if it decides to uphold this reservation.

The then attorney general and the solicitor general had vehemently defended the amendment, saying the reservation provided under it was different and had been given without disturbing the 50 per cent quota meant for the socially and economically backward classes (SEBC). Hence, the amended provision

does not violate the basic structure of the Constitution, they had said.

The top court heard as many as 40 petitions and most of the pleas, including the lead one filed by 'Janhit Abhiyan' in 2019, challenged the validity of the Constitution Amendment (103rd) Act 2019.

The Centre had filed some petitions seeking the transfer of pending cases, challenging the EWS quota law, from various high courts to the apex court for an authoritative pronouncement.

However, she demanded that she be allowed to give the exam November 12.

 $Earlier\ the\ girl\ had\ approached$ the School and Mass Education minister Samir Ranjan Dash after allegedly being subjected to ragging by her seniors for the last three months.

In the letter to CM, the victim identified as Rojalin Biswal, said she was meted out mental ha-



rassment by her seniors at the girls' hostel. She accused her seniors of circulating her mobile number among their male friends who used to call her and use derogatory remarks

The girl also claimed that when she wanted to leave the hostel, she was not allowed to take her books and other belongings. Though she brought the matter to the notice of hostel warden, her compliant was not received and acted upon. She reportedly even informed the college authorities about the ragging, but to no avail. She said that she

efforts did not yield any results as police kept mum on the issue.

Finding no alternatives, she approached minister Dash with the help of the Utkal Student Association seeking his intervention in the matter. While Das assured the victim of justice, he also reportedly asked the girl student to withdraw her complaint against the boys. Notably, crores of rupees are being spent to track the movement of elephants through GPS for the protection of the animals. The government has also appointed hundreds of officials for proper discharge of work. Everyday, members of the elephant squad, foresters and forest guards report about the presence of elephants in their area through a mobile app. So it is a matter of concern that the carcasses went unnoticed for close to two weeks. Animal lovers have expressed doubts regarding the authenticity of reports over elephant movements.

Locals alleged that Forest officials file reports without properly tracking the movement of elephants. Such negligence on part of the officials has been observed earlier too, but no disciplinary action has been taken in this regard. The recovery of the carcasses of two more elephants is an example of such negligence, they alleged. They also alleged that tracking of elephants has taken a backseat as the persons designated for the job are being used for other chores including office work. Some of them are also used by their superiors as domestic help.

Reports said that the decomposed carcass of an elephant was recovered from the same Kalapata reserve jungle, June 26. Few months back, two elephants were electrocuted at a place under Sadar forest range. Six elephants died in the Keonjhar forest division in 2021-22 and so far in 2022-23 an identical number of deaths have been reported. Environmentalists have pointed out that elephants must be protected at any cost. Notably, there are around 125 elephants in seven forest ranges

Police inaction irks Kendrapara residents

Kendrapara, Nov 7: Six days have gone by since the death of a Plus-II science student who was electrocuted at a private residential coaching centre in this district. However, till now the authorities have not taken any action against the officials of the coaching centre leaving people shocked.

The deceased, identified as Debi Prasad Das, son of Kunja Bihari Das was electrocuted November 2 after accidentally coming in contact with an 11-KV transmission wire which was hanging precariously close to the balcony of the coaching centre at Luna under Marshaghai police limits in Kendrapara district. It has been alleged that the students studying in this coaching centre were living in cramped rooms while the 11-KV transmission wire was located just two feet away from the balcony.

Police registered a case and arrested the manager of the coach-

ing centre, Chittaranjan Rath over a complaint filed by the deceased's father. However, since then nothing has happened. The local intelligentsia has termed the arrest as eyewash. They claimed that the police have applied lenient sections of the law against Rath so that it is easy for him to get bail.

Locals also claimed that private educational institutions are only fleecing students in the name of education. They alleged that the district administration is not taking action by conducting verification of the institutions. They warned that they will file a writ petition in the high court if no action is taken in this regard.

Local intelligentsia Ganesh

Chandra Samal, Chitta Ranjan Sahu, Prasant Kumar Nayak, social activists Amarbar Biswal and Goutam Kumar Behera said that earlier teaching was considered a noble profession. Currently, both the Centre and state government are laying stress on quality education. Taking advantage of this situation, the private institutions have commercialised education. These institutions pay scant respect for the safety of the students, they alleged.

Locals also said that the state government has ample provisions and power to conduct verifications of these institutions and take action against them. However, due to the apathetic attitude of the authorities, private coaching centres have mushroomed not only in this district but all over Odisha, they added. Many of these institutions are also operating without noobjection certificates and without observing the relevant guidelines, they further said.

Samal said the boy's death has also shocked the entire administration. He assured that corrective measures will be put in place very soon.

MGNREGS funds bungled

Sambalpur, Nov 7: Lakhs of rupees sanctioned for a number of projects under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in Kilasama panchayat under Dhankauda block of Sambalpur have been misappropriated, sources pointed out Monday. They also informed that none of the projects have been implemented.

Members of Panchavat Surakshya Samiti, a local outfit, took up the issue with the executive officer of the zilla parishad (ZP). They alleged that a total of ₹ 99,779 sanctioned for restoration of a road connecting Pradhanpalli to an RD road was embezzled through a forged bill. This also included labourers' wages

to the tune of ₹30,000. The members alleged that in another case. ₹91.908 sanctioned for restoration of Talipada road in Pradhanpalli was misappropriated.

Similarly, construction of a road from Jharghatipada to Nagaradipa was not carried out. However, it has been shown that ₹1.17 lakh has been spent for the project.

Funds were also misappropriated regarding the digging of a trench which had already been carried out by the Forest department. However, a contractor's bill of ₹2.07 lakh was passed without verifying whether the job had been carried out by the concerned person. In yet another case, ₹60.580 out of the sanctioned ₹1.06 lakh fund for Balbaspur-Bijalpada road has been swindled, it was alleged.

Boy drowns in sea, 3 others rescued

GANJAM: A 15-year old boy drowned Monday while three others had a close shave with death while bathing in the sea near the Bateswar Shiva shrine under Rambha police limits in Ganjam district. The deceased was identified Jagannath Swain, 15, son of Rabindra Swain of Huma locality in the district. He was a Class-X student in Birabhadra High School Tragedy struck when Jagannath and some of his friends went for a bath in the sea. While Jagannath drowned, locals managed to rescue three others who were about to be swept away. Jagannath was rushed to the Chhatrapur sub-divisional hospital where doctors pronounced him dead on arrival. In a magnanimous move, Jagannath's father informed the hospital authorities about his decision to donate the eyes of the deceased.

Lack of proper facilities plague Rayagada custard apple farmers

Rayagada, Nov 7: Custard apple, known for its sweet and pleasant flavour, is grown in plenty in remote regions of this district. However, the tribals growing the fruit are forced to resort to distress sale due to lack of cold storage facilities, price fixation and the absence of a proper market. Due to the apathetic attitude of the district administration. the tribals fail to reap any profit from by selling the fruit. In the absence of alternatives, they sell their produce to the traders of the neighbouring states at throwaway prices.

Custard apple grown in Rayagada district is in high demand both in Odisha and outside the state. The apple is grown mainly in Mirabali, Karubai, Dangalodi, Baisingh, Bairagihalua and Pipalguda areas of Sadar block and in Bhoimada, Mukundpur, Rupuni, Kalilashpur, Badakhilapadar localities of Kolanara block. Thousands of custard apple trees can be found in both the blocks. The Rayagada variety of custard apple is also in demand in markets of Bhubaneswar, Cuttack, Jagatsinghpur and Sambalpur districts.

Custard apple trees thrive well in rocky terrains with well-drained soil and do not require much care. The trees start bearing fruits after four to five years. The apples are in full bloom during the three months of September to November: The fruit is the main source



of livelihood for the tribal people living in the two blocks mentioned above. They sell the fruit at ₹3 to ₹5 per piece in the local market. Wholesalers also pay the same price to get the fruit from the tribals. However, they sell it at a much higher rate. In the markets of Cuttack and Bhubaneswar, the fruit sells at ₹65 per kilogram.

Custard apple trees do not need any fertilizers to bloom. Trees start bearing fruits from the fourth year onwards and continue to do so for at least 15 years. Each plant bears 50 to 60 fruits annually. The reason why tribals are forced to sell the fruits at throwaway prices is because they perish quickly. A farmer said the situation will only improve if the administration fixes rates for the fruit and along with it provide proper cold storage facilities. He added that a fruit-specific market will also help.

Currently the tribals sell custard apples in the markets of this town. Gunupur and JKPur. However, rarely do the farmers manage to reap proper rewards for their efforts.

The state-owned Odisha Rural Development and Marketing Society (ORMAS) is working so that tribal people get proper rates for their produces. However, there is no such facility for

custard apples still. When contacted senior ORMAS official Manoj Patra said that the agency stopped intervening in the sale of custard apple as it suffered heavy losses in the past two years. He also pointed out that this year not a single custard apple farmer had approached the agency for support. Locals however, demanded that the district administration should step in to prevent distress sale of the fruit so that farmers can benefit.

6 Years Later

he experiment called Demonetisation took place six years ago this day, 8 November 2016. Cash was abruptly turned to trash. The trademark suddenness of the announcement at 8 pm by PM Narendra Modi definitely had the country in shock. Citizens were unable to comprehend the impact this decision will have on their lives in the years to come. Everyone was gung ho on a buoyant Indian economy that seemed to be healthy and surging ahead without too much governmental interference till then. Enterprises were looking up and professionalism in corporate life and style was slowly creeping into Indian businesses. People at that time vividly remembered and discussed with pride how the Asian Tigers meltdown as also the 2008 Subprime lending crash in the US went totally unnoticed in the Indian market. The economy of this country had inbuilt resilience strong enough to withhold major international economic failures by virtue of a system that had cash as its core strength. When that cash was abruptly turned into trash, the follies of that decision are being suffered by the people of this country even now. It is also impossible to predict how long the negative impact of Demonetisation will prevail in India.

A recent Reserve Bank of India (RBI) report published in October 2022 states that a new high of ₹30.88 lakh crore of paper currency is presently being held by Indians today. The report also states that this is the largest amount of cash ever to be with citizens. It is noteworthy that the same RBI, on 4 November 2016, four days prior to Demon, had reported that a total of ₹17.77 lakh crore paper currency was being held by citizens. The present cash holding is 72 percent higher than 2016. The RBI should know because, as the Central bank, it is the sole authority empowered to print cash. The same RBI had, after Demonetisation, stated that 100 percent cash of the Demonetised valuations had returned to its coffers.

The announcement of Demonetisation had spelt out a few anticipated results of the dramatic step. The first and most important being that the action will completely destroy black money being hoarded by the rich. The second was that counterfeit currency being printed in Pakistan and used for encouraging terror activities will be completely nullified. Many other brave claims followed suit. Then followed the dark days after 8 November 2016 when anyone who raised doubts on the decision was labelled either an anti-national or a hoarder of black money. The poor and the blue and white collared working class were pleased that the rich will suffer while others will get a better deal. Economy was used not only politically to gain an edge over rival parties in the early 2017 Uttar Pradesh Assembly election but society too was sharply divided on immature presumptions on who could be in possession of cash and who did not have it. The initial and instant sufferings, obviously, took toll of the self employed and the micro, small and medium industries. In other words the entrepreneurial class was wiped out with one single decision

It has taken time for the mammoth Indian economy to feel the blow of Demonetisation. While earlier international economic turmoil could not touch India, the decision of Demonetisation and the after effects that had been dealt with confusion and without proper policies are just starting to be felt now. Six years later. No one can predict for how long the ill effects of that announcement of 8th November of 2016 will continue to hamper the growth of India.


Colophonian


olophon, a weird-enough word in its own right, is the name for the Cinscription at the end of a book that gives facts about its publication or design — hence the old saying "from title page to colophon", from beginning to end. These days the data is more frequently on the title page and its reverse and the word is often used instead for a publisher's emblem or imprint on the spine or title page. The adjective colophonian, which might seem to be connected, has an entry in the Oxford English Dictionary, but only to say that its appearance in some dictionaries of the late nineteenth century to refer to a publisher's colophon was actually an error based on a misreading of a book of 1678. The word was actually Colophonian (with a capital C), which refers to an inhabitant of Colophon, a town in Lydia that is part of modern Turkey. However, colophonian might still come in useful — there isn't a word in the language that means "relating to a colonbon" (even though there is the, admittedly extremely rare, colophonize, to supply a book with a colophon), and colophonian is as good a candidate as any. Colophon and its relatives come ultimately from a Greek word meaning a finishing touch or summit. None is to be confused with colophony, a pine resin which is named after ancient Colophon.

Colporteur

his word has nothing to do with a famous American songwriter nor with a carrier of coals, though it was once an occupation of sorts. Jonathan McColl told me about it. DON'T GO THE CHINA WAY

MANUFACTURING COSTS IN CHINA, TOO, ARE RISING NOW AND IT WOULD BE AN UNFORTUNATE TURN FOR INDIA TO BECOME **THAT HUB**

"orrific stories are emerging from the factories complex in Zhengzhou in central China owned and operated by Foxconn, which is the world's largest assembler of Apple iPhones and is now in the midst of a new COVID outbreak. Several news reports, including from leading global media houses and from papers in Taiwan, the headquarters of Foxconn, have given accounts of workers fleeing the assembly plants. Strict restrictions and quarantines have been set up, but workers have complained of limited food supplies for those kept in isolation and poor medical attention.

For the 200,000 workers who live in crowded rooms inside the complex of factories where they work, this has brought new hardships in a company that has already been called out for its harsh, even exploitative, work culture. Now, fleeing workers are being lured but have largely ignored new bonus offers for those who agree to continue to work and help meet the demand for the iPhone 14 as the holiday season nears.

One video said to be shot at the factory speaks of a "desperate cry" as all workers put in isolation in one specific room have reportedly died. Foxconn said there are no deaths at the facility. A Reuters report from Taipei last month-end said the Zhengzhou plant "has been rocked by discontent over stringent measures to curb the spread of COVID-19, with several workers fleeing the site over the weekend." One worker quoted by the Financial Times, UK, reported "total disaster in the dormitories.

The stories emerging from the Foxconn facilities are significant for India as it is here that Foxconn and some others are coming to build new facilities as part of an incentive-laden drive by the government to boost manufacturing

under "Atmanirbhar Bharat", with various production-linked schemes for electronics manu-

It is true that India needs to act fast to invest and open up job opportunities for the youth, and the BJP is desperate to meet criticism that its policies have not helped generate employment. Big investments and hopes of a large number of jobs at one go may help deflect this criticism at a crucial time as elections near. But it also opens questions on whether the Chinese way of mega factories filled with low-end, low-paying jobs should be the chosen route for India at this time. A lot of the work at the factories is about assembly, sometimes as low-tech as fitting a screw on an iPhone speaker or trimming edges after the Apple logos are cut from aluminium covers.

Further, the Chinese system is noted for its poor record of protecting workers' rights, unions are as good as non-existent and local authorities are known to stretch to accommodate business demands in a bid to attract more investments. This is what makes China a particularly attractive destination for low-end manu-

facturing jobs. This is a model of employment generation that India must carefully study and debate before plunging headlong into incentives for large companies and business alliances. The models being encouraged and supported will likely bring in an entirely alien system and method of work in a nation that is noted for a huge contribution to the economy from small and medium enterprises. It is true that SMEs are not always the best of employers or quality producers but the distributed model of growth stands in contrast to growth driven by big industries, super-sized factories and a top-down approach that is tantalising in its promise of delivering quick jobs but has often delivered longer term misery.

In this context, criticism by for mer RBI Governor Raghuram Raian on the incentives for big industry is very relevant. Rajan has correctly noted that there hasn't been a real analysis of the PLI (production-linked incentives) schemes that the government has been pushing on the understanding that this is a route to create jobs Yet, "manufacturing" of the kind that China has gone for has not made that country a world class innovator but marked it out for its limited low-cost production. The bulk of the profits are taken away by the chip designers and the brands they create while the lowend part of the value chain is left with China. Manufacturing costs in China, too, are rising now and it would be an unfortunate turn for India to become that hub which is a lower-end version of China.

A study on the iPhone 7 (factory cost estimate of \$237.45 in 2016) noted that "all that's earned in China is about \$8.46, or 3.6% of the total," including a battery supplied locally and labour. The study, by Prof. J Dedrick of Syracuse University and two others, noted: "The other \$228.99 goes elsewhere. The US and Japan each take a roughly \$68 cut, Taiwan gets about \$48, and a little under \$17 goes to South Korea. And we estimate that about \$283 of gross profit from the retail price - about \$649 for a 32GB model when the phone debuted - goes straight to Apple's

In short, said the study, "China gets a lot of (low-paid) jobs, while the profits flow to other countries." This may not be a place India might like to end up in man-

And make no mistake: the acute threat to media workers is not some faraway problem. Journalists face a barrage of online and offline threats, surveillance, intimidation, physical attacks, and imprisonment. When journalists are threatened, so are our communities and societies. When those who deliver the facts to inform citizens come under attack, the foundation of society is at stake. February, Many more have been democracy. At the same time, the pandemic sparked deep mistrust of journalists, with demonstrators, online trolls, and opportunistic political actors stoking violence against the hated "mainstream media" or what they perceive as purveyors of "fake news."

We must reverse this trend. Our democracies' fate depends on journalists' ability to express themselves freely and work safely. Ensuring this is not an easy task, and governments and international organisations cannot do it alone. Large societal change requires a concerted effort at all levels of society. While this effort is no doubt hard to realise, we must start somewhere by bringing more attention to the issue and bolstering support for the initiatives that support this crucial work.

Ten years ago, the United Nations endorsed the UN Plan of Action on the Safety of Journalists and the Issue of Impunity, the first concerted effort globally to create a free and safe environment for media workers. It is time to convene again to discuss new and emerging challenges and to provide new impetus for the plan's implementation.

Block Congress Twitter account: Court 16 sailors detained

Bangalore, Nov 7: A dedicated commercial court for Bengaluru Urban District has directed microblogging site Twitter to block the handles of the Indian National Congress (INC) and its 'Bharat Jodo Yatra' till the next date of hearing.

Also, the court ordered removing three tweets posted from the party. The twitter handles are '@INCIndia' and '@BharatJodo'.

The court order came after a suit filed by MRT Music which is the copyright holder of the sound tracks from the film KGF Chapter 2.

It is alleged that its copyright has been infringed upon and sought a permanent injunction against the INC and its leaders from using its copyrighted music.

"Plaintiff has specifically produced CD showing the side by side file i.E., original version of his copyrighted work with that of the illegally synchronised version. These prima facie materials available before this court at this stage establish that if same is encouraged, plaintiff who is in the business of acquiring cinematography films, songs, music albums... Will be put to irreparable injury and further same leads to encouraging the



piracy at large," the court said in its order.

The court also appointed a com-

missioner to audit and preserve the evidence on Twitter, Instagram, Facebook, and Youtube.

New Delhi, Nov 7: Sixteen Indian sailors are reportedly in detention in Equatorial Guinea and the Indian mission in the central African country is working closely with the authorities concerned for their release.

In a letter to External Affairs Minister S Jaishankar, Rajya Sabha MP AA Rahim said the crew of ship 'MT Heroic Idun' included the Indians and they were in detention since mid-August.

On Twitter, the parliamentarian requested Jaishankar to "ur-

gently intervene" in the matter of "illegal detention" of the 16 Indian crew members.

The Indian embassy in that country said on Monday that it has been in regular contact with the crew members over phone.

"This Embassy and our High Commission in Abuja are closely working with authorities of Equatorial Guinea and Nigeria for the early release of crew members of MV Heroic Idun. All crew members are safe and those in the Detention Centre have been shifted to the ship," the Indian embassy in Equatorial Guinea tweeted.

STAGE SET FOR TOUGH CONTEST

he Gujarat Assembly elections hold strategic value for all three political entities in the frav as it will set the tone and tenor for the critically important general elections in 2024.

The BJP must retain the Prime Minister's home turf at all cost for a confident Narendra Modi to lead his party into the next parliamentary polls for a third term. The Congress needs to better its 2017 record here to helm the combined opposition challenge against its traditional opponent nationwide. Aam Aadmi Party (AAP) perforce has to match its profiling pitch with on-ground performance in Gujarat for its leader Arvind Kejriwal to mark himself as a credible challenger to Modi in the political ring.

With the Prime Minister launching his party's poll campaign from Kaparda village in Valsad district of South Gujarat on Sunday with a slogan for the people "I have made this Gujarat", the stage is set for a tough contest between the ruling BJP, old opponent Congress and a muscleflexing AAP fresh out of the gym. Gujarat has largely been a straight fight between the two traditional ri-



vals, BJP and Congress to the detriment of even powerful state leaders who chose to launch their own regional outfits and came a crop-

As always, Modi is the face of the BJP in Gujarat and the party is fighting the ensuing elections on his name, fame and son-of-the-soil appeal. Modi, on his part, has left nothing to chance with key international leaders like British Prime Minister Boris Johnson, Mauritius Prime Minister Pravind Jugnauth and UN

secretary general, Antonio Guterrres being the latest of global figures visiting Gujarat. He has announced/inaugurated/laid the foundation stone of projects-schemes worth approximately 2 lakh crores within the year.

The Congress has planned better this election and it has adopted a changed strategy. The entire campaign of the party is being overseen by Rajasthan Chief Minister Ashok Gehlot and state-in-charge Raghu Sharma. Seven working presidents have been named, and in-charges from Maharashtra, Rajasthan and Chhattisgarh have been put in place to oversee each one of the 26 parliamentary constituencies. Gehlot was the Gujarat in-charge in the 2017 state Assembly elections as well. Sharma says the Congress is targeting 125 of the total 182 seats and does not propose to announce a chief ministerial candidate. Except for two visits by Rahul Gandhi, the first family of the Congress has so far kept away from Gujarat.

In contrast, Delhi Chief Minister Arvind Kejriwal and his deputy Manish Sisodia have been visiting the state very frequently, lock ing horns with Modi on issues big and small while dishing out a long list of guarantees, if AAP comes to power. These include overhaul of government schools and free education, vastly improved and free treatment in government hospitals, free and uninterrupted power up to 300 units per household, government jobs, unemployment allowance for youth and the like.

In the final reckoning, there are two factors which remain a matter of concern for BJP's political opponents in every election. The first one pertains to polarizing acts like the state cabinet's decision just be fore elections to appoint a study panel on the Uniform Civil Code. The second one pertains to perception altering incidents that either concern the PM's security or trumped up instances aimed at heightening the communal divide.

HC notice to Guj on Morbi tragedy

Court directs chief secretary and home secretary to file a status report by November 14

Ahmedabad, Nov 7: The Gujarat High Court Monday took suo motu cognisance of the Morbi bridge collapse tragedy and issued notices to the state government and local authorities and also sought a status report in the matter by November 14.

The British-era suspension bridge on the Machchhu river in Morbi collapsed October 30, claiming 135 lives.

The bridge was thrown open for the public October 26 after seven months of repair work by a private

"We have taken a suo motu (on their own) cognisance of the Morbi incident. But for the vacation, we would have sat on the same day itself," a division bench of Chief Justice Aravind Kumar and Justice Ashutosh Shastri said addressing Advocate General Kamal Trivedi who was present in the court.

The bench took cognisance of the incident on the basis of a news-

It issued notices to the state gov-



tary, state home department, commissioner of municipalities, Morbi municipality, district collector and the State Human Rights Commission and relisted the matter November 14

The court said it wants to see some action being taken by the government and directed the chief secretary and the home secretary to file a status report by next Monday, when the matter will come up for hearing.

The State Human Rights Commission has also been directed to file a report in the matter by November 14.

'We will implead the state, the home department, the chief secretary, Morbi municipality, urban development authority, commissioner of municipalities. Also, we would like to have the State Human Rights Commission," the HC said.

The State Human Rights Commission shall also file a report in this regard by the next date of hearing. The registry is directed to communicate this order through special messenger to respondent number 5-- State Human Rights Commission. Relist the matter on November 14," it said.

Morbi-based clock and e-bike maker Oreva Group was given the contract by the city municipality to repair and operate the ill-fated bridge for 15 years and charge tickets in the range of Rs 10 to Rs 15 for its use, according to the municipality documents.

The Oreva Group October 26 claimed that it had roped-in experts for the repair work and the material used was built as per specifications by "specialised firms."

Assam govt bars its secretariat staff from wearing jeans, leggings

Guwahati, Nov 7: The Assam government has issued a dress code for all its employees working in the state Secretariat premises in Dispur, officials said Monday.

According to an office order, the new dress code has put a bar on wearing jeans, t-shirts and leggings by employees working in the Secretariat. From now on, they will have to mandatorily wear formal attire during office hours.

Men should wear formal shirts and trousers while the female staff can wear sarees, salwar-kameez and mekhela-chador.

Every Wednesday, the employees have been directed to wear tradi-

The order said, "All employees should attend office on all working days in formal attire only (salwar suit/saree/mekhela chador, formal shirt-pant and not casual attires such as T-shirts, jeans, leggings etc.) A traditional dress of any community of Assam should be worn every Wednesday as desired by the em-

How police inaction spurs mob violence in northeast

Guwahati, Nov 7: Due to the lack of a tough law against mob violence and lynching, the police's sluggish actions, and delayed trials, such crimes are being reported not infrequently in the northeastern states.

In 2018, the Supreme Court had suggested to the Centre and the states to enact separate special laws to deal with mob violence and lynching. Sources said that the Central government is still drafting the proposed act, while the states are also yet to comply.

Experts on societal issues, psychiatrists, police officials and law experts said that besides the special stringent laws, and the alertness and swift actions of law enforcing agencies against mob violence and lynching, a mass campaign among the people are also required. In recent years, many innocent people, including All Assam Students Union leader Animesh Bhuvan, several accused and suspected wrong doers were lynched in different parts of northeastern region. In a major case in Meghalaya, four of the five undertrials, who had escaped from jail along with a convict, were lynched by a mob at Shangpung in West Jaintia Hills district in September.

According to police, a mob of local people, mostly youths, armed with wooden sticks, badly thrashed the four, killing them on the spot after the fugitives came out from their jungle hideout and tried to procure food. Meanwhile, 13 people, including the key accused, have been arrested in connection with the lynching of AASU leader Animesh Bhuyan in Assam's Jorhat in November last year.

However, prime accused Neeraj Das, also a drug peddler, mysteriously died in a road accident while he was trying to flee from police.

Das was accused of instigating and leading a mob of over 50 people who lynched the AASU leader and injured his associate Pranay Datta, and journalist Mridusmanta Baruah when they tried to assist

Many people stood and gazed on the scene when the violence was going on and others captured the incident on their mobile phones.

In Tripura, three youths, suspected of stealing cattle, were lynched in Khowai district in June last year. Two of the victims were tied with ropes and thrashed by the mob, leading to their deaths, while the third was caught after a chase and beaten to death.

In most lynching cases and mob violence, none of the accused were punished yet. Even in the 2018 horrific Karbi Anglong lynching case, Abhijeet Nath and Nilotpal Das were also beaten to death by a mob of villagers who suspect they were as 'child kidnappers', justice was yet to be served. Assam's Parliamentary Affairs, Information and Public Relations Minister Piiush Hazarika. who is also the state government spokesman, earlier informed that the state was planning to introduce a bill against mob lynching and

on many social issues for the past many years, said that in most cases, people who are involved in lynching cases see an outburst of anger accumulated due to various crises, including economic, domestic and personal. "Most people, especially those are earning meagre, are facing numerous problems. They then expressed their anger without a reason. They beat a person to death without knowing the actual matter." Datta. who received many awards, told IANS. She said that in some cases, people rushed to many kilometres away to beat suspects, and such mob lynching sometimes turned very brutal and sometimes, took communal twists. In many cases, if the police came to the place of occurrence in time, many lives could have been saved, Datta said, adding intolerance is also one of the causes of mob violence and lynching

Retired senior Assam Police officer Samaresh Baruah said that besides enacting stringent laws, police must be given proper training against mob violence and lynching.

"Trial against the people involved in mob violence must be done in a fast track special court. After every such incident the issue must be studied in-depth so that the authorities can prepare a proper planning to stop such incidents,' Baruah told IANS

Poll equations may change in BJP stronghold of Morbi

Morbi, Nov 7: Though the Patidardominated Morbi Assembly seat in Gujarat is considered a stronghold of the Bharatiya Janata Party (BJP), the poll equations this time may change due to many factors, including the recent bridge tragedy which claimed 135 lives, political observers say.

The entry of the Arvind Kejriwal-led Aam Aadmi Party (AAP) into the poll fray and the long-pending urban infrastructure issues could also be among the decisive factors in Morbi where the winning margins have been thin in the last three elections, the political experts told PTI.

The erstwhile Morbi princely state was called as the 'Paris of Saurashtra region' before Independence, thanks to its vi-

by a thin margin of 3,419 votes, riding on the anti-BJP wave in Morbi, one of the key centres of the Patidar quota agitation.

In 2012, Amrutiya defeated Merja by 2,760 votes. Both of them are Merja, considered as a suave

and learned leader, left the Congress in 2020 and joined the ruling BJP. In the subsequent by election, he managed to defeat Congress's oldtimer Jayantilal Patel by 4,649

In the new cabinet constituted last year under the chief ministership of Bhupendra Patel, Merja was appointed Minister of State with independent charge of panchayat as well as skill, labour and employment departments.

Today, it is famous for the ceramic and clock industries, providing employment to more than five lakh people who come here from across the country for jobs.

However, the economic development in Morbi has been marred by bad roads and traffic jams, locals claim. Currently, the BJP is ruling the Morbi Municipality District Panchayat and Taluka Panchayat.

The Morbi Assembly seat falls under the Kutch Lok Sabha constituency, represented by Dalit BJP MP Vinod Chavda.

 $Bad\,roads\,and\,traffic\,problems$ have been some of the main issues here for many years, accordto Morbi Ceramic ing Manufacturers Association's floor tiles division president Vinod Bhadja.

"Morbi is a ceramic hub with a combined annual turnover of Rs 65,000 crore. Though the BJP has done a lot of work, we are still facing issues of traffic jams, water-logging and bad roads in and around the city," the industrialist told PTI.

"The people of Morbi are somewhat unhappy because our main issues have remained unresolved for more than two decades now," he claimed. Morbi witnessed some inter-

esting political developments in the last decade, including the Patidar quota agitation spearheaded by Hardik Patel and the defeat of BJP's five-term MLA Kantilal Amrutiya. Amrutiya, better known as

Kanabhai, had won from the Morbi Assembly seat in 1995, 1998, 2002, 2007 and 2012.

In 2017, Congress candidate Brijesh Merja defeated Amrutiya lives, Amrutiya hogged limelight as videos showing him jumping into the water to rescue the victims went viral on social media platforms

Though the BJP has not declared its candidates yet, political experts believe it will once again field Merja and not Amrutiya, despite his brave act and popularity among the masses.

"Most of the people in Morbi want to see Amrutiya as the BJP's candidate. But even if Merja is selected, the BJP's core electorate will eventually vote for him, because for them what ultimately matters is the party symbol," local political analyst Ravindra Trivedi said. The candidate selection will be crucial this time because the winning margin in Morbi remains thin, he said.

According to Trivedi, the Congress' chances of winning may increase if the party chooses young Patidar face Manoj Panara (Patel) instead of Jayantilal Patel, who lost to BJP candidates five times since 1995."Panara is a young Patidar face having considerable popularity. He was once with Hardik Patel during the quota agitation. He has a huge support base here," Trivedi said.

"The Congress' chances would go up if Panara is given a ticket instead of Jayantilal. The AAP candidate may not get more than 5,000 votes. It can change the final equation in view of the history of thin winning margins here," the political analyst said.

The AAP has already declared Pankaj Ransariya as its candidate, who is a known face in some-Patidar pockets of Morbi, including Ravapar Road.

Ajmal's 'animosity' towards Cong makes BJP's life easier

CONGRESS LEADERS SAY AJMAL HAS A SECRET 'ALLIANCE' WITH THE **SAFFRON PARTY**

Guwahati, Nov 7: At a time when the key players in national politics are talking about Opposition unity to combat the BJP, the scenario in Assam is the opposite with two main BJP rivals - the Congress and the All India United Democratic Front (AIUDF) -- attacking each other almost daily.

Barely a year and a half ago, Congress and AIUDF forged a grand alliance and fought the last year's assembly election together. But. after the loss in the election, Congress broke away with the AIUDF. Since then, the relationship between the two parties has become bitter which has reached its lowest point in the past week.

Congress leaders have been doing the 'Assam Jodo' since November 1 and AIUDF chief Badruddin Ajmal has heavily criticized the party's ambitious campaign.

Ajmal alleged that a section of Congress leaders in the state are playing in the hands of Himanta Biswa Sarma. He said: "I know a few leaders from Congress who are on the payroll of Sarma and even they have done a few foreign tours taking money from the Chief Minister.

He further attacked Assam Congress President Bhupen Borah terming him as an 'incapable' leader to lead the party in the state and said he has no importance before the Central leadership.

"This is evident from the ongoing 'Assam Jodo' where no prominent national leaders of the party were present though Borah earlier claimed that Rahul Gandhi and Priyanka Gandhi will attend the yatra," Ajmal added.

Obviously, Ajmal's statements have not gone down well with the Congress leaders and they have launched a sharp attack on him. Bhupen Borah said that Aimal has a secret 'alliance' with the BJP



and as a part of that he has been deliberately saying harsh things against the Congress leaders.

He moreover said that Congress will never forge an alliance with Ajmal's party in the future.

Meanwhile, Badruddin Ajmal has clearly warned that Congress cannot win a single seat in the next Lok Sabha election without the support of AIUDF. He believes that in last year's Assembly election, his party delivered a win for Congress

on at least a dozen of seats. Ajmal claimed, "We could win more seats but we chose to support them (Congress).

There are 14 Lok Sabha seats in Assam and leaving a few in the upper Assam and Bodoland area, the Muslim vote is a key factor. Former Assam Chief Minister Tarun Gogoi's son Gaurav Gogoi has won from Kaliabor and Pradyut Bordoloi -- another Congress MP, could win Nagaon Lok Sabha seat last time as there were no AIUDF candidates at these two places.

This time, the AIUDF is planning to field candidates there and if it happens so, Congress may end up losing both seats. Another Congress MP Abdul Khaleque, who won from Barpeta in the 2019 general election, may find it very difficult if Ajmal resorts to the same tactics there.

On the other hand, AIUDF is currently having only one MP in Lok Sabha - Badruddin Ajmal and he will anyway retain his Dhubri seat irrespective of whether Congress fields a candidate there

So, it is the Congress party that is predicted to lose big in the fight of 2024 Lok Sabha polls.

BJP has been already on a mission to colour Assam with saffron in the next Lok Sabha election with an aim to win 12 out of 14 seats. Though BJP's ministers and MLAs have jumped into the criticism of Ajmal on his recent remarks, Congress has alleged that this is a part of the strategy of Chief Minister Sarma and AIUDF.

Chitradurga (Karnataka), Nov 7: Rape-accused Lingayat seer Shivamurthy Murthy Murugha Sharanaru allegedly drugged minor girls residing in the Chitradurga Murugha Mutt before violating them, police investigation has re-

Currently in judicial custody, the accused seer used to direct other accused to send a minor girl of his choice every day to his private room in the garb of seeking his special blessings. The abuse was so rampant that the seer had allegedly fixed a routine as to which girl to be sent to him on a particular day. The children were sent to clean his private room where the accused would give them a chocolate or an apple laced with drugs.

After they lost consciousness, the seer would abuse them. The accused seer kept the victims at his private room throughout the night. Children who would wake up derobed and the seer beside them would get shocked, police sources

Then the accused seer would threaten them and instill fear. He also threatened to eliminate their families if the girls revealed about the incident. The victims, already in trauma, would remain tightlipped, police said.

The seer would ask them to clean his back and lower back while taking a bath and abuse them. The second accused in the case, hostel warden, would monitor the situation and ensure that no one gets suspicious about what is happening around them.

Sharanaru would look for sexual assault victims and offer shelter at his mutt. He also extended financial help to their families. As a result, the families would praise the seer and call him "God". As the word of mouth spread, parents never thought twice about their children's safety. They would tell the children that they are taken care of by the "God" himself. This made the victims even more hesitant to open up, police said.

Police have got information about several elderly women also getting raped by the accused seer. One of the minor girl victims who was seen as a threat was allegedly killed and called an accident.

New Delhi, Nov 7: The Delhi government Monday decided to reopen primary classes from November 9 and revoke the order asking 50 per cent of its staff to work from home in view of improvement in the city's air quality.

However, plying of BS-III petrol and BS-IV diesel four-wheelers in Delhi will remain banned under stage 3 of the Graded Response Action plan, Delhi Environment Minister Gopal Rai told a press conference. The minister said there has been a rapid improvement in the air pollution situation in Delhi and farm fires have also reduced.

'Therefore, it has been decided to lift the curbs imposed under stage four of the Graded Response Action Plan in compliance with the direction from the Commission for Air Quality Management," he said. "Primary schools will reopen from November 9 and the order asking 50 per cent of the government staff to work from home is being revoked," the minister said.

As the air pollution in Delhi-NCR ameliorated over the last two days, the Centre's air quality panel Sunday directed authorities to lift diesel light motor vehicles in the region and the entry of trucks into the capital imposed under the final stage of the Graded Response Action Plan.

It had also banned construction work in public projects such as highways, flyovers, power transmission, and pipelines in Delhi-NCR. The CAQM order recommending the restrictions was issued on Thursday.

High pollution levels had prompted the Delhi government to announce additional measures on Friday, including the closure of primary schools from Saturday and work from home for 50 per cent of its staff.

The 24-hour average air quality index of Delhi improved from 447 on Friday to 381 on Saturday and further to 339 on Sunday, primarily due to favourable wind speed and a drop in the contribution of stubble burning.

The commission had on Sunday said there is a likelihood of sustaining the improvement in air quality and that the forecast by the India Meteorological Department and Indian Institute of Tropical Meteorology also does not indicate any steep degrada-

Chhawla rape-murder case: SC acquits 3 men on death row

New Delhi, Nov 7: The Supreme Court Monday acquitted three men sentenced to death for the gangrape and murder of a 19-year-old woman in Delhi's Chhawla area

The three men are accused of abducting, gangraping and brutally killing the woman in February 2012. Her mutilated body was found three days after she was abducted. In 2014, a trial court awarded death penalty to the three accused, terming the case "rarest-of-rare".

The judgment was later upheld by the Delhi High Court. According to the prosecution, the woman worked in Gurgaon's Cyber City area and belonged to Uttarakhand. She was returning from her workplace and was near her home when the three men abducted her in a car.

When she didn't return home, her parents lodged a missing person report, the prosecution said, adding that the woman's mutilated and decomposing body was found in a village in Rewari, Haryana.

The police found multiple injuries on the woman's body. Further investigation and autopsy revealed she was attacked with car tools, glass bottles, metal objects, and other weapons. She was also raped, they said. Police arrested the three men involved in the crime and said one of the accused allegedly took revenge after the woman turned down his proposal.

Sheopur, Nov 7: Two male cheetahs brought from Namibia to the Kuno National Park in Madhya

Pradesh have made their first kill within 24 hours of their release from a quarantine area to a larger acclimatisation enclosure, an official said Monday. The cheetahs hunted down a cheetal (spotted deer) either on Sunday night or in the wee hours

of Monday, Chief Conservator of Forest Uttam Kumar Sharma said. The forest monitoring team got this information on Monday morning, he said.

This was the first prey of the felines after their translocation from Namibia to India in mid-September along with six other cheetahs, the official said. The cheetahs - Freddie and Alton - were the first pair to be released into the larger enclosure on Saturday after being quarantined

since September 17. The successful first hunt by the

cheetahs within 24 hours of moving to the larger enclosure has also allayed the park management's concerns about their prey hunting ability. "The cheetahs eat their prey within two hours of hunting," Sharma said. He said the two cheetahs were released in the larger enclosure spread over 98 hectares from a quarantine zone on Saturday. The other six cheetahs will also be released (in the acclimatisation enclosure) in a phased manner, he said.

CHEETAHS FLOWN FROM NAMIBIA

The eight cheetahs - five females and three males in the age group of 30-66 months - were released in the dedicated quarantine zones in the KNP on September 17 at a function by Prime Minister Narendra Modi, heralding the return of the big cats to India 70 years after they were declared extinct in the country.

As per initial plans, the cheetahs-named Freddy, Alton, Savannah, Sasha, Obaan, Asha, Cibili and Saisa - were to be kept in quarantine for a month. According to international norms, wild animals must be kept in quarantine for a month to check the spread of any infection before and after their translocation to another country, experts had said.

Since their release on September 17, the eight cheetahs were housed in six 'bomas' (enclosures), two of which are 50 metres x 30 metres while the rest four measured 25 square metres in area. They were provided buffalo meat, the officials had said. The last cheetah died in India in Koriya district in present-day Chhattisgarhin 1947 and the species was declared extinct in 1952.

Nearly 50 heads of states or governments on Monday will take the stage in the first day of "highlevel" international climate talks in Egypt with more to come in the following days.

Much of the focus will be on national leaders telling their stories of being devastated by climate disasters, culminating Tuesday with a speech by Pakistan Prime Minister Muhammad Sharif, whose country's summer flood caused at least \$40 billion in damage and displaced millions of people.

Washington, Nov 7: An election year that unfolded against the backdrop of economic turmoil, the elimination of federal abortion rights and broad concerns about the future of democracy is concluding with a final full day of campaigning in which leaders of both parties will issue urgent appeals to their supporters.

President Joe Biden is holding a Monday evening rally in Maryland, where Democrats have one of their best opportunities to reclaim a Republican-held governor's seat. The appearance is in line with Biden's late-campaign strategy of sticking largely to Democratic strongholds rather than stumping in more competitive territory, where control of Congress may ultimately be decided.

His predecessor, former President Donald Trump, will hold his final rally of the campaign in Ohio. As he readies another run for the

White House, Ohio holds special meaning for the former president because it was one of the first places where he was able to prove his enduring power among Republican voters. His backing of JD Vance was crucial in helping the author and venture capitalist — and onetime Trump critic — secure the GOP's nomination for a Senate seat.

ment carried by state media. Later Monday, South Korea's military disputed some of the North's accounts of its missile tests. Spokesperson Kim Jun-rak said South Korea didn't detect the North's cruise missile launches and that it's also notable that North Korea didn't mention what Seoul assessed as an abnormal flight by an ICBM.

London, Nov 7:A UK court Monday ruled that Sanjay Bhandari, an accused middleman and consultant in arms deals, can be extradited to India to face charges of tax evasion and money laundering and paved the way for the British government to order his extradition.

District Judge Michael Snow, who heard the case at Westminster Magistrates' Court in London earlier this year, concluded that there are no bars to him being extradited and decided to send the case to UK Home Secretary Suella Braverman, who is authorised to order the extradition based on the court order.

"As I am satisfied that extradition is compatible with the defendant's Convention rights, I must send this case to the Secretary of State [Braverman] for a decision as to whether the defendant is to be extradited," Judge Snow said in his judgment. "However, I only do so on the basis of the Assurances that have been provided by the Government," he said, with reference to Indian government assur-

London, Nov 7: Scientists in the UK have infused blood cells grown in a laboratory into people in the first such clinical trial in the world. It can be difficult to find enough



The red cells were then transfused





New Delhi: State-owned CIL Monday reported a 106 ner cent jump in its consolidated profit at ₹6,043.99 crore in the September guarter of FY23 on higher revenue from operations. The public sector enterprise had posted a consolidated profit of ₹2,932.73 crore in the year-ago period, Coal India Ltd (CIL) said in a filing to BSE. New Delhi: India Cements Ltd Monday reported a consolidated net loss of ₹113.26 crore for the second quarter ended September 2022. The company had posted a net profit of ₹29.75 crore during the July-September quarter of the previous fiscal, India Cements said in a regulatory filing. Its revenue from operations was up 7.46 per cent to ₹1,327.06 crore in the second quarter of this fiscal. The same stood at ₹1,234.85 crore a year ago. The company's total expenses were at ₹1,528.01 crore, up 27.16 per cent in the September quarter of FY23, as against ₹1,201.61 crore a year ago.

According to filings, the combined loss of both entities stood at ₹5.352 crore in the financial year 2020-21. Flipkart Internet, comprising online business-to-consumer platforms, has reported widening of loss to ₹4.399 crore in FY22 from ₹2,907 crore in FY21.

This includes the performance of Flipkart Group firms like Myntra, Instakart etc. The B2b unit, Flipkart India - earlier called Walmart India -saw widening of loss to ₹3,413 crore in FY22 from ₹2,445.6 crore in FY21.

The net income of Flipkart, however, increased by close to 20 per cent to about ₹61,836 crore in 2021-22 with Flipkart India contributing ₹51,176 core and Flipkart Internet registering a revenue of ₹10,660 crore. Combined revenue of the e-commerce major in 2020-21 was ₹51,465 crore with Flipkart India and Flipkart Internet contributing ₹43,349 crore and ₹8,116 crore respectively.

According to market research firm Redseer, it has been leading total sales in India during festive sea son. It said Flipkart is estimated to have led the first week of festive season sale that was held in the last week of September with the firm cornering 62 per cent or Rs 24,800 crore worth of gross merchandise value from total sales of Rs 40,000 crore

New Delhi, Nov 7: Aided by robust festive season offtake, automobile retail sales in India witnessed a 48 per cent annual jump in October, automotive dealers' body Federation of Automobile Dealers Associations said Monday

The total retail sales last month stood at 20,94,378 units, up 48 per cent from 14.18.726 registrations in October 2021. The registrations last month were even better by 8 per cent as against October 2019, a pre-Covid month

Last month, all the vehicle segments like passenger and commercial vehicles, two-wheelers, tractors and three-wheelers performed better as compared to the year-ago period.

Passenger vehicle retails stood at 3,28,645 units last month, up 41 per cent from 2,33,822 units in October 2021. Similarly, two-wheeler registrations witnessed a 51 per cent jump last month at 15,71,165 units compared with 10,39,845 units in October 2021.

Commercial vehicle retail sales were up 25 per cent at 74,443 units last month, as against 59,363 units in the year-ago period. Threewheeler and tractor retails were up 66 and 17 per cent respectively over October 2021.

With most of the month under festive period, the sentiments were extremely positive across

all categories of dealership. Even when compared to pre-covid month of 2019, overall retail sales for the first time closed in green," Federation of Automobile Dealers Associations (FADA) President Manish Raj Singhania said in a statement.

The extremely robust demand due to festivities last month brought cheer to the industry as customers in every segment came out in good numbers making it the best in the last four years, he added.

"As anticipated earlier, the PV segment saw the best year in a decade by outgrowing 2020 numbers by 2 per cent. When compared to pre-Covid festive season of 2019, overall retails were up by 6 per cent," Singhania said.

Commenting on the PV se he noted that sports utility vehicles continue to see extremely high demand. The two-wheeler segment witnessed a growth of 6 per cent in retail sales last month, as compared with October 2019, a pre-Covid year, Singhania said.

In the 42-day festive period this year, total retail sales stood at 28,88,131 units, up 29 per cent from

22,42,139 units. Passenger vehicle retails rose 34 per cent to 4.56,413 units, as against 3.39,780 units in the festive period last year. Two-wheeler registrations rose to 21,55,311 units during the period under review, from 17,05,456 units last year, an in-

crease of 26 per cent. Similarly, three-wheeler, commercial vehicle and tractor sales increased by 68, 29 and 30 per cent respectively over the festive season last year, FADA said. The CV segment is anticipated to see continued demand due to rising infra projects and government spending, he added.

New Delhi, Nov 7: Finance Minister Nirmala Sitharaman Monday said the government's efforts to reduce bad loans are yielding result with 12 public sector banks reporting a 50 per cent jump in combined net profit at ₹25.685 crore in the second quarter ended September.

In the first half of FY23, the cumulative net profit of all public sector banks (PSBs) increased by 32 per cent to ₹40,991 crore.

During the second quarter, the SBI reported the highest-ever profit of ₹13,265 crore. On year-on-year basis, this was 74 per cent higher than the same quarter a year ago.

"The continuous efforts of our govt for reducing the NPAs and further strengthening the health of PSBs are now showing tangible results. All 12 PSBs declared net profit of ₹25,685 cr in Q2FY23 & total ₹40,991 cr in H1FY23, up by 50% & 31.6%, respectively (y-o-y), Sitharaman said in a tweet.

She further said Canara Bank reports an 89 per cent jump in profit to ₹2,525 crore as compared to second quarter of the previous fiscal.

Kolkata-based UCO Bank posted a 145 per cent surge in profit to ₹ 504 crore while Bank of Baroda's profit increased by 58.70 per cent to Rs 3,312.42 crore in the second quarter, she said in an another tweet.

Two of the 12 lenders -- Punjab National Bank (PNB), and Bank of India -- reported profit declines ranging from 9-63 per cent. These lenders' declining profits have been ascribed to higher provisioning for bad loans.

PNB said the main reason behind the decline in the net profit was

New Delhi, Nov 7: Encouraged by the vigorous business in the festive season of Diwali this year, traders across the country, including Delhi. are now preparing themselves for one another bonanza -- the wedding season which will begin November 14 through December 14.

During this period, around 32 lakh weddings will be solemnised across the country with a massive flow of about ₹3.75 lakh crore by way

of wedding purchasing and obtaining various services in the business being conducted by trading community, as per a survey conducted by the CAIT Research & Trade Development Society.

CAIT said during the season, about 5 lakh weddings will have an estimated expenditure of ₹3 lakh each, while in about 10 lakh weddings the cost will be around ₹5 lakh each. Ten lakh weddings will cost ₹10 lakh each, 5 lakh marriages will cost ₹25 lakh each,



50,000 marriages will have ₹50 lakh expenditure each and another 50 thousand marriages will be such in which ₹1 crore or more will be spent!

Overall in this one month, around ₹3.75 lakh crore will flow through the wedding purchases in the markets, the survey revealed.

The next phase of the wedding season will start from January 14, 2023 and will be continued till July.

CAIT said that in Delhi alone, more than 3.5 lakh weddings are expected to take place in this upcoming season, which is likely to

generate a business of about ₹75,000 crore. Last year, around 25 lakh weddings took place in the same period and expenses were estimated at ₹3 lakh crore. CAIT said that in view of the

good business prospects of the wedding season, traders across the country have made elaborate preparations as they want to continue the sentiments emanated from just concluded record business figures of Diwali this year.

CAIT informed that before the wedding season, a large amount of business has already occurred in the repair of houses. Apart from this, jewellery, sarees, lehengas, furniture, readymade garments, clothes, footwear, wedding and greeting cards, dry fruits, sweets, fruits, worship items, grocery, food grains, decoration items, home decoration items, electrical utility, electronics and many gift items etc are usually in demand and it is expected to do good business this year.

Banquet halls, hotels, open lawns, community centres, public parks, farm houses and many other types of places for weddings are fully prepared across the country.

In addition to the purchase of ac-

cessories at each wedding, a wide variety of services are also involved, including tent decorators, flower decorations, crockery, catering service, travel service, cab service, welcoming professional groups, vegetable vendors, photographers, videographer, orchestra, DJ, horses for the procession, wagons, lights and many other types of services are likely to do big business this time. Along with this, event management has also emerged as a big business prospect.

Former No.1 Barty rules out comeback

Melbourne, Nov 7: Former World No.1 Ash Barty has emphatically ruled out ever making a comeback to tennis, or switching to another sport.

Launching her autobiography at Melbourne Park — scene of her Australian Open triumph in January just two months before her shock retirement announcement — the 26-year-old said she had no desire to return to high-level sport, and was sure she never would.

"Nope, I'm done," Barty told Australian Associated Press Monday. "You can never say never but no. No, no, no. I'm done."

The three-time Grand Slam singles winner, who spent 121 weeks with the top ranking, had played professional cricket with the Brisbane Heat during a hiatus from tennis.

She also plays golf off a handicap of four, prompting some observers to suggest she could pursue a future in that sport. But, launching her memoir "My Dream Time." Barty insisted she was happy with her new, more settled life off the WTA Tour, and had no professional sports plan in

"I miss competing and challenging myself against the best of the world but I don't miss a lot that comes with it," she said. "I'm still competitive with myself when I train at home. I still try and push myself but there's no white-line fever any more.

"And I never really felt like there was this void that needed to be filled in because there was a genuine sense of fulfillment at the end of my career.' Barty, who married long-time

partner Garry Kissick in July, said she was unsure what her future held, although she was already enjoying mentoring young players — something which could point to a future role as Australian Billie Jean King Cup (formerly Fed Cup) captain.

She said that when she walked away from tennis for the first time in 2014, she was "searching... searching for stimulation, I was searching for other things.

"But now I don't need that. Now I have probably understood and realized that I've had an extremely full, fulfilling, incredible journey in my athletic and professional career and now it's time to close that chapter," she said.

Dravid opens up on Pant's importance

Melbourne, Nov 7: Rishabh Pant's disappointing outing against Zimbabwe isn't a cause of concern for head coach Rahul Dravid, who hinted that the flamboyant lefthander could start in the T20 World Cup semifinal against England at

Adelaide Thursday. Pant didn't get a look in the first four games where veteran Dinesh Karthik, who in all likelihood is playing his last global meet, was assigned the role of a finisher. With Karthik not being able to deliver on bowler friendly Australian tracks,

Pant is back in equation. "I don't think we judge people on one game, and sometimes whether we play them or not is not based on one game," Dravid said after India's 71 run victory in which Pant's con-

tribution was a mere three. After that, Dravid gave good enough indication that decision to field Pant wasn't taken in isolation as the coach was potentially looking at a match up with leg spinner Adil Rashid in the semifinals.

"Sometimes it's just matchups." We need to look at what are the skills we might need against the kind of bowlers we might come up against. So a lot of things go into these kind of decisions," said Dravid.

He also firmly reiterated that team management had never lost faith in Pant. "Yeah, in a sense it's not that we ever lost confidence in Rishabh. We've got confidence in all of our 15 players who play here. It's only 11 guys who can play, and it depends on the combinations that you have.

The very fact that they are here and they're part of the World Cup means that we have a lot of confidence in them. It means that anytime they can be called on to play in the XI. 'Yes, you can only play 11 at a time

and some people sometimes miss out and don't have to play, but again, Rishabh is someone that as a lot of you would have been seeing, has been travelling with us.

"He's been batting a lot in the net he's been hitting a lot of balls, doing a lot of fielding practice and sort of keeping practice and keeping himself ready. The opportunity came for us today (Sunday) to give him an opportunity," he reasoned.

In fact, Dravid was happy about Pant's intent against left arm spinner Sean Williams but the execution

kind of work out today, but absolutely no-I'm not bothered about that at all because I think he took the right option. His role was to take on the left-arm spinner which was there, and sometimes it comes off and sometimes it doesn't.'
