#### **ICMR** website attacked 6K times in a single day

New Delhi: Hackers allegedly tried to breach the website of the apex health research body ICMR but their attempts have been foiled, according to a government official. The official said that hackers apparently from Hong Kong tried to attack the website of the Indian Council of Medical Research around 6000 times in a span of 24 hours November 30. The attacks come close to the heels of the alleged ransomware attack that had paralysed AIIMS online services here. The contents of the ICMR website are safe. The site is hosted at NIC Data Centre, hence the firewall is from NIC which they regularly update.

#### **WB upgrades India GDP** growth forecast to 6.9%

New Delhi: The World Bank Tuesday revised upwards its GDP growth forecast for India to 6.9 per cent for 2022-23, saying the economy was showing higher resilience to global shocks. In October, it had cut India's GDP growth forecast to 6.5 per cent from 7.5 per cent earlier. Now, it has upgraded the projection to 6.9 per cent for 2022-23 (April 2022 -March 2023). In its India Development Update, the World Bank said the revision was due to higher resilience of the Indian economy to global shocks and better-than-expected second guarter numbers.

## China spy ship spotted in Indian Ocean region

The docking of the ship at Hambantota port in August had triggered a diplomatic row between India and Sri Lanka

New Delhi, Dec 6: Chinese spy ship 'Yuan Wang 5', known to be fitted with various tracking and surveillance devices, has entered the Indian Ocean Region ahead of a plan by India for a likely test firing a long-range ballistic missile in the Bay of Bengal, people familiar with the development said Tuesday.

It is learnt that the Indian Navy is keeping an eye on the movement of the Chinese ballistic missile and satellite tracking ship.

The docking of the ship at Hambantota port in August had triggered a diplomatic row between India and Sri Lanka.

Open source intelligence expert Damien Symon Monday tweeted that Yuan Wang 5, #China's missile and satellite tracking vessel has entered the #IndianOcean region.

There is no official comment on the reports of the presence of the spy ship in the Indian Ocean region. As per laid down protocol, India recently issued a NOTAM (Notice

to Airmen/Notice to Air Missions) about a missile test. It is not clear whether India will go ahead with the plan for the missile test in view of the presence of

the Chinese spy ship.



In November this year, the **Yuan Wang 6 entered the Indian Ocean region ahead of** a missile test slated for 11 November, for which India had issued a NOTAM, marking a significant area of the Bay of Bengal as a no-fly zone

According to experts, the Chinese vessel was last spotted in the Sunda Strait of Indonesia.

The visit of the Chinese ship to the Indian Ocean comes amid increasing concerns over growing forays into the region by Chinese military and research vessels.

India is bolstering defence and security ties in the Indian Ocean with like-minded countries in the backdrop of concerns over China's growing forays into the region, considered the backyard of the Indian Navy.

# BJD demands passage of **Women's Reservation Bill**

■ Several other political parties like the TMC, and the JD(U) backed the demand

New Delhi, Dec 6: The Biju Janata Dal (BJD) Tuesday reiterated its demand for passage of Women's Reservation Bill, which seeks to grant 33 per cent reservation to women in Lok Sabha and state assemblies, during the Winter Session of the Parliament set to start today.

BJD leaders Pinaki Misra and Sasmit Patra raised the demand during an all-party meeting chaired by Defence Minister and Deputy Leader in Lok Sabha Rajnath Singh a day before the commencement of Winter Session and said that the empowerment of women is necessary for overall development of the country.

The BJD leaders were astonished that the Women's Reservation Bill was not listed for this session and requested the government to introduce and pass the legislation in the Winter Session.

Several other political parties, like the TMC, Congress, NCP and the TRS supported the demand



once opposed the move. The demand was also raised in the BAC meeting by TMC and Congress. The DMK, SAD and the JD(U) supported them and demanded that an all-party meeting be convened to build consensus on the issue.

The passage of Women's Reservation Bill is a long-standing demand of the ruling party of Odisha. The BJD MPs in both Rajya Sabha and Lok Sabha had raised the issue often in the past during their speeches on various bills.

The Odisha Assembly had passed a resolution in November 2018 demanding 33 percent reservation for women in the Parliament and state assemblies. After that, as many as 22 BJD delegations were sent out to 22 national and regional

parties by BJD President Naveen Patnaik asking for support for the passage of the bill. The BJD had also nominated women at 33 per cent in the Lok Sabha constituencies in 2019 Parliamentary elections.

Significantly, the Women's Reservation Bill was passed by the Rajya Sabha in 2010. But it could not be passed by the 15th Lok Sabha. The Constitution amendment bill got lapsed as the term of the 15th Lok Sabha ended. The BJD has been requesting the BJP led Union government to introduce and pass the legislation in the Lok Sabha where the saffron party has brute majority.

Besides, reduction of GST on Kendu leaves and expansion of Railways, National Highways and mobile towers in Odisha are among the BJD's demands.

## 2 women Red rebels killed in Kandhamal

Bhubaneswar, Dec 6: Two women cadres of the CPI(Maoist) died in a gunfight with security personnel in Kandhamal district Tuesday, a top police officer said.

Firearms, including an INSAS ifle with 11 rounds of ammunition and one IED, were found lying next to their bodies in Matakupa Reserve Forest, Director General of Police SK Bansal said. Acting on intelligence inputs on the movement of Maoist cadres in the forest, personnel of Odisha's special operation group (SOG) embarked on a search operation in the woods.

A gun battle subsequently ensued between the Maoists and the security personnel inside the forest, leading to the death of two women cadres who were dressed in the banned outfit's uniform. Their bodies have been recovered and the process of identification is underway," the DGP said. Search operation has been intensified with the deployment of additional teams of security personnel in the area, Bansal stated,

The DGP, in a statement, appealed to the Maoists to shun violence and join the mainstream.

The state government has a very beneficial surrender and rehabilitation policy and all Maoists should avail this, he added. Last month, at least four Maoist cadres were killed in two operations in Bolangir and Koraput districts.



#### **CO-ORDINATION MEET ON LWE**

Odisha Police, Border Security Force (BSF), Central Reserve Police Force (CRPF) and Chhattisgarh officials held a threadbare discussion on Left Wing Extremism (LWE) during an Inter-state and Inter-agency Co-ordination Meeting at the state Intelligence Directorate here Tuesday. The senior officials of security agencies discussed issues relating to the activities of Maoists in the interstate borders of Odisha and Chhattisgarh, sharing of intelligence. deployment of security forces at strategic locations, inter-state coordination and anti-LWE operations. The officials also examined the progress made in connection with the decisions taken in the last meeting at Raipur in July, 2022 and at IB Headquarters in August, 2022 over the LWE related issues. "It was stressed upon that all concerned agen-

cies will work with more synergy to

### If I speak out, the entire scenario in the state will change: Archana

Bhubaneswar, Dec 6: Archana Nag, the prime accused in the blackmail and extortion racket, Tuesday claimed that she has exclusive evidence against some people which will shake the state.

Nag, who was shifted from Jharpada special jail to the Capital Hospital here for a medical checkup before being taken to Enforcement Directorate (ED) office for interrogation, said she will fully cooperate in the probe instituted against her for amassing huge wealth by blackmailing rich and influential persons along with running a sex racket.

"I was waiting for the ED to take me on remand for questioning. I will fully cooperate with the probe," she said responding to media queries.

"I need sufficient time to speak at least 30 minutes. If I speak, the entire scenario in the state will change. I have been trapped. I will give exclusive evidence and not spare anyone," she said. Nag was arrested by the local police October 6 and is in judicial custody.

She was also vocal against the commissionerate of police over the manner in which she was detained and later arrested.

"I am not a terrorist. The way I was arrested and my family was harassed by the Commissionerate Police - it is all a conspiracy against me," the 26-year-old woman said.

The ED took Nag on a sevenday remand Monday and will produce her in the district and sessions court here December 13.

The central agency is probing the money laundering aspect of the blackmail racket. It has so far grilled nine people. Her husband Jagabandhu Chand, a co-accused in the case, will be produced

before the court December 7. Earlier in the day, the architect of Nag's palatial residence Ranjit Behera appeared before the agency. The building contractor Pabitra Patra had faced interrogation Monday.

Nag has allegedly amassed assets of ₹30 crore, including a threestorey palatial bungalow at Satya — Vihar in Bhubaneswar in just about four years from 2018.

## Y chromosome is disappearing but rats have an X factor

he sex of human and other mammal babies is decided by a male-determining gene on the Y chromosome. But the human Y chromosome is degenerating and may disappear in a few million years, leading to our extinction unless we evolve a new

Most mammals have an X and Y chromosome similar to ours; an X with lots of genes, and a Y with SRY plus a few others. This system comes with problems because of the unequal dosage of X genes in males and females


How did such a weird system evolve? The surprising finding is that Australia's platypus has completely different sex chromosomes,

more like those of birds.

In platypus, the XY pair is just an ordinary chromosome, with two equal members. This suggests the mammal X and Y were an ordinary pair of chromosomes not that long ago

In turn, this must mean the Y chromosome has lost 900–55 active genes over the 166 million years that humans and platypus have been evolving separately. That's a loss of about five genes per million years. At this rate, the last 55 genes will be gone in 11 million years.

Our claim of the imminent demise of the human Y created a furore, and to this day there are claims and counterclaims about the expected lifetime of our Y chro-



mosome - estimates between infinity and a few thousand years. The good news is we know of

two rodent lineages that have already lost their Y chromosome-and are still surviving -- the mole voles

#### FIXES HUMAN SEX

n humans, as in other mammals, females have two X chromosomes and males have a single X and a puny little chromosome called Y. The X contains about 900 genes that do all sorts of jobs unrelated to sex. But the Y contains a few genes (about 55) and a lot of non-coding DNA - simple repetitive DNA that doesn't seem to do anything. But the Y chromosome packs a punch because it contains an allimportant gene that kick-starts male development in the embryo. At about 12 weeks after conception, this master gene switches on others that regulate the development of a testis. The embryonic testis makes male hormones (testosterone and its derivatives), which ensures the baby develops as a boy. This master sex gene was identified as SRY (sex region on the Y) in 1990. It works by triggering a genetic pathway starting with a gene called SOX9 which is key for male determination in all vertebrates, although it does not lie on sex chromosomes.

of eastern Europe and the spiny rats of Japan. A new paper in Proceedings of the National Academy of Science shows how the spiny rat has evolved a new male-determining gene.

The imminent – evolutionarily speaking – disappearance of the human Y chromosome has elicited speculation about our future.

Some lizards and snakes are female-only species and can make eggs out of their own genes via what's known as parthenogenesis. But this can't happen in humans or other mammals because we have at least 30 crucial "imprinted" genes that work only if they come from the father via sperm. **Continued on P4**





## Action plan key to reduce malnutrition: CS

Bhubaneswar, Dec 6: Chief Secretary Suresh Chandra Mahapatra Tuesday said that there is a need for a holistic action plan with concerted efforts among various departments to reduce malnutrition and stunting among children.

He said this while addressing a 'National Level Conclave on Childhood Stunting in India' held here Tuesday. The state government is all set to have an aggressive approach to reduce malnutrition and stunting among children which would be achieved in next few years, said the Chief Secretary.

The conclave was jointly organised by International and Food Policy Research Institute, the state government, the World Bank and Unicef. Odisha is the first state to introduce a separate nutrition

budget. The state government is now spending on the social sector targeting health, education, nu-

trition and sanitation, he said. Around 96.5 lakh families are covered under food security programme, while 75,000 Anganwadi centres (AWCs) are actively involved in supplementary nutrition and take-home ration programme being executed through women self-help

groups (SHGs), he pointed out. "Similarly, mid-day meal (MDM) is being served in 55,000 schools with active participation of women SHGs, Aaahar centres in urban local bodies, fortified rice and millets being introduced in PDS and supplementary nutrition," said Mahapatra. Further, the household level data collection on malnutrition and stunting is being carried out through a robust and reliable method with regular check-

up at AWC level, he added. With all these steps, Odisha is all set for targeted reduction in stunting and malnutrition.

Stating that the problems of stunting and malnutrition are multi-dimensional, the Chief Secretary said there is a need for a holistic action plan with concerted efforts among various departments to achieve the target.

He assured that the government would provide all financial and administrative support for concrete suggestions that would emerge from the deliberations in this national seminar.

Mahapatra released a study report on 'Covid-19 and nutrition in Odisha - what does the future hold'. The study was conducted by Unicef with support from the state government.

## Border row, 'misuse' of agencies to dominate Parl Winter Session

In total, members of opposition parties have detailed around 16 issues to be raised during the Winter Session

New Delhi, Dec 6: Border standoff with China, alleged misuse of government agencies, price rise and unemployment will dominate the proceedings of the Winter Session of Parliament starting Wednesday.

The results of the Assembly elections in Gujarat and Himachal Pradesh are also likely to play out during the start of the session.

The session begins December 7. a day before the results of Assembly polls are out. The Opposition will seek to corner the government on several issues and a confrontation is likely on the demand for discussions on Chinese "incursions" at the border and alleged misuse of agencies.

Rahul Gandhi and several senior Congress leaders who are walking in the Bharat Jodo Yatra are unlikely to attend the session.

Ahead of the session, leaders from more than 30 parties attended a meeting convened by the Union government to discuss the legislative agenda and the issues likely to be taken up during the Winter Session of Parliament.

The meeting, chaired by Union minister and deputy leader of the BJP in Lok Sabha Rajnath Singh, was to seek cooperation from all parties for the smooth functioning of the Winter Session.

Pivush Goval and Parliamentary Affairs Minister Pralhad Joshi were also present.

During the meeting, Joshi spelt out the government's legislative agenda for the session and sought opposition's cooperation for the passage of Bills. He concluded the meeting, saying he has taken note of all the issues raised by political parties and the discussions will be held as per the norms and procedures of Parliament.

Issues for discussion will be finalised in the business advisory committee meetings of both houses of Parliament, he said.

During the meeting, Congress and Trinamool Congress raised the issue of alleged misuse of investigating agencies, which was backed by the Aam Aadmi Party, Nationalist Congress Party and several other parties.

"There are so many issues before the country such as unemployment and price rise, and the government owes an answer to people," Congress leader in Lok Sabha Adhir Ranjan Chowdhury told reporters after the meeting.

He alleged the government did not "properly" inform the Opposition about the stand-off at the Sino-India border. "In the House we will demand a discussion on it and also on the killings of Kashmiri Pandits," he added.

Congress leader Naseer Hussain, who attended the meeting in the absence of chief whip of the party in Rajya Sabha Jairam Ramesh, demanded discussions on the appointment of Election Commissioner in just one day and also on the Economically Weaker Section (EWS) quota.

leader Bandyopadhyay said he and his party colleague Rajya Sabha MP Derek O'Brien sought discussions on price rise, unemployment, alleged misuse of agencies and alleged economic blockade of states.

While the government plans to bring 16 new Bills during the session, sources said Opposition members questioned the government's intent of getting around 25 bills passed, which include old bills as well, during the short span of 17 sittings.

The government has not allowed a discussion on the border situation with China and has denied charges of "misuse" of agencies.

## Most Asian countries lag in biodiversity protection: Study

to achieve a global minimum target of protecting at least 17 per cent of land by 2020, according to a study based on data from 40 countries.

Under current trends, the outlook for achieving the UN Global Biodiversity Framework's 2030 target to protect at least 30 per cent of land is bleak, with Asia set to miss this by an even greater margin, the researchers said.

To counter the global biodiversity crisis, at the 2010 UN Convention on Biological Diversity, almost 200 countries pledged to protect at least 17 per cent of their terrestrial environments by 2020 (known as Aichi Target).

To investigate whether they achieved this, researchers from the Universities of Oxford and Cambridge in the UK, with collaborators in Asia, analysed data from official reports submitted to the World Database on Protected Areas.

The study, published in the journal Communications Biology, found that only 40 per cent of Asian countries achieved the target of a minimum of 17 per cent coverage for protected areas by 2020. In particular, very few countries in West and Central Asia achieved the target. Overall, Asia was the most underperforming continent, with just 13.2 per cent of land being designated as a terrestrial protected area in 2020 -- compared with a global average of 15.2 per

cent protection, the researchers said. Only 40 per cent (16) of Asian countries, mainly in East and South Asia, had met the 17 per cent protection target by 2020. However, 14 out of 19 West and Central Asian countries had not met the target, they said.

Asian countries also tended to have a slower year-on-year increase in the amount of land protected for conservation, at just 0.4 per cent per year on average, according to the study.

For 241 highly at-risk mammal species across Asia, on average 84 per cent of their ranges fell outside protected areas, the researchers said.


They calculated that almost all Asian countries will fail to meet the 2030 target unless their rate of establishing protected areas increases by up to six times faster. Under the current trajectory, Asia as a whole would only achieve 18 coverage by 2030 -- far below the target of 30 per cent protection. The outlook was worst for West and South Asia, projected to achieve 11 per cent and 10 per cent coverage respectively by 2030.

"Asia is a challenging continent for setting targets for protected areas, since areas of high biodiversity typically con-

flict with dense human populations and rapid economic growth," said study lead author Mohammed Farhadinia from the University of Oxford, "While this research demonstrates the need for more investment in protected areas in Asia, it also shows the importance of establishing realistic, achievable goals that take into account socio-geographical restrictions." Farhadinia said.

The findings carry important significance ahead of the 15th meeting of the Conference of the Parties (COP 15), when the governing body of the Convention of Biological Diversity will convene in Montreal. Canada from December 7-19.

At this meeting, government representatives will review the achievement of the Aichi Biodiversity Targets and discuss strategies for meeting the post-2020 Global Biodiversity Framework targets.



Das demanded bribe from

Srinibas again for demarcation few days later June 7, 2012, which made Srinibas lodge a complaint with the Superintendent of Vigilance, Bhubaneswar on the same day.

Based on the complaint, Vigilance registered a case (34/12) and laid a trap to nab Das red handed. June 8, 2012, Das was arrested by the vigilance sleuths while receiving money from the complainant.

The court examined statements of eight witnesses and went through other documentary evidences before pronouncing the sentence. Special public prosecutor Hemant Kumar Swain conducted the trial on behalf of the state.

#### Man gets 20-year in jail for raping minor

Baripada, Dec 6: A special fast track court here sentenced Tuesday an elderly person to 20 years of rigorous imprisonment after convicting him for rape of a minor under Betanoti police limits in Mayurbhani district in 2019.

According to the case diary, Singh, a native of Kachhimbila village under Betanoti police limits called the girl out of her house to a nearby jungle and raped her over there, May 20, 2019.

The girl suffered injuries during the assault and could not return home. Family members searched for her and finally traced her to the jungle following a tip-off. They rescued her and rushed her to the Betanoti hospital first and later shifted her to PRM Medical College and Hospital in Baripada.

Police registered a case POCSO Act and arrested Singh after the victim's brother lodged a complaint at the police station.

## Victory, Not Quite

seemingly off the cuff remark by Iran's Attorney General Mohammad Jafar Montazeri that the Iranian morality police was being "dis-▲ banded" is now being interpreted not as a sign of the regime succumbing to pressure exerted by protesters, but as kite flying. Protesters and international communities are not prepared to buy the argument that the orthodox regime has had a change of heart after protests erupted against the killing of a 22year-old Kurdish woman, Mahsa Amini, by the morality police. Global attention has been drawn to the plight of Iranian women being forced to follow a strict dress code including wearing of hijab. Iran's soccer team brought focus to the issue recently by not singing their national anthem before the opening match of FIFA World Cup at Qatar in solidarity with their protesting countrymen.

Iran's state media was quick to rebut the Attorney General's comment about disbanding the morality police, while the protesters denounced it as a public relations stunt by the regime to break the movement against the authorities' denial of freedom to the people, especially women and the continuing economic crisis.

The Attorney General said during a religious conference late last week that the Iranian morality police had been "disbanded". International media and advocates of freedom for Iranian women hailed the announcement as a victory for Iranians protesting against the government for months. However, the very next day, state media sought to downplay Montazeri's comments, saying that the morality police do not fall under the authority of the judiciary. As such, his comments had no bearing on ground reality. Iran's state television – Al-Alam – decried initial attempts by foreign media to interpret Montazeri's comments as a climbdown on the part of the Islamic Republic from its stance on hijab and religious morality as a result of the protests. "No official of the Islamic Republic of Iran has said that the Guidance Patrol has been shut," Al-Alam said.

It is true the decision to disband the morality police technically lies with the Supreme Council of Cultural Revolution, set up in the early 1980s by Iran's first Supreme Leader Ruhollah Khomeini. It is now headed by the orthodox President Ebrahim Raisi.

Montazeri's comments fuelled speculation about the regime relenting in the face of the protests since the pro-reform media outlet Entekhab reported him saying that Iran's parliament and judiciary were reviewing the country's mandatory hijab law put in place in 1983.

The morality police earned notoriety for allegedly terrorizing citizens and implementing Iran's hijab law with an iron hand. Significantly, however, since protesters launched agitation the morality police reportedly disappeared from the streets of Tehran. This further emboldened Iranian women to disobey the dress codes imposed on them.

But, the morality police's absence from the streets is hardly going to assuage the feelings of the agitators who are clamouring for fundamental changes in the regime for getting more liberty and a stronger economy. What is ominous for the regime is that the protesters are now chanting on the streets the slogan - 'the Islamic Republic should go.'

If the Attorney General's remark had the tacit approval of the regime, it would mean the latter simply wants to dissociate itself from the infamy of the instrument of torture that the morality police has become. At the same time, it would continue to maintain its tight control over mandatory hijab. The law official in that case, it appears, is being used as a sounding board to test how far the protesters can go.

The only official statement made at this stage is by Iranian Foreign Minister Hossein Amir-Abdollahian who during a visit to Serbia neither confirmed nor denied that the Attorney General's remark was correct. He said, "In Iran, everything is moving forward well in the framework of democracy and freedom." This is of course a diplomatic verbiage.

Women in Iran are now not much bothered about whether there is a hijab or not, as a protester put it. They have been going without it for the past 70 days and they demand nothing short of "a revolution and regime change." They may sound too ambitious despite international backing. As US Secretary of State Antony Blinken said the abolition of Iran's morality police could be "a positive thing" and praised the "extraordinary courage of Iranian young people, especially women, who have been leading these protests." For sure, a grim struggle is ahead.

#### Deodand

n 1336, a drunken sailor climbed the mast of his ship at anchor in the Thames by means of a rope, presumably part of the rigging. When he tried to descend the same way he fell and died. A coroner's jury decided that the rope was the cause of death and that it should be forfeited to the Crown. The rope was the inanimate casualty of an already ancient principle called deodand. A deodand was an item of property that, however coincidentally, had caused the death of a human being. Horses, cattle, carts, haystacks, beer vats, boats, stones and trees have at various times been judged to be deodands. Unlettered local juries often made the law up on the spot, for example deciding in the case of a person fatally scalded by boiling water from a not that the not was the deodand, not the water. Strictly speaking, a deodand is something that has been forfeited to God, from Latin deo dandum. In practice in medieval England it meant being given up to the Crown to be put to some pious use such as alms. As a stone or haystack was an inconvenient item to deal with in this way, in practice the coroner's jury decided the value of the item and its owner was required to pay that instead. (In the case of the rope, the jury appraised it as worth 10 shillings, a considerable sum at the time, roughly the price of a good horse.) The law of deodand survived into the nineteenth century. What ended it was the industrial revolution. Expensive pieces of machinery involved in accidental deaths were judged as deodands with consequent substantial fines. The rise of the railways meant that coroner's juries in the 1830s and 1840s awarded large deodands against companies whose trains were involved in fatal accidents. As a result, the government of the day passed a law in 1846 abolishing the concept.

#### ■ Deprecate

t started with an e-mail message from subscriber Pete Jones: "Have you come across deprecated with the sense 'no longer valid or current'?". He pointed me to a website that defined it as "no longer part of the current specification". It took a bit of sleuthing to track this down. The glossary item is referring to HTML, the coding system behind the World Wide Web. The formal specification uses deprecated in sentences like "The following elements are deprecated", and carefully defines what it means by that: "A deprecated element or attribute is one that has been outdated by newer constructs". The writer is saying that some elements in earlier versions are not actually obsolete but are now disapproved of - deprecated - and should be avoided. Though this jargon sense is not in any mainstream dictionary, it is actually quite common in specifications of computer languages.

## **SCRAMBLE FOR THE HELM**

**PAST ELECTORAL PERFORMANCE** OF THE BJP **SHOWS THAT IT HAD BIGGER SWAY IN URBAN AREAS** 

ith the second phase of polling for the Gujarat Assembly over December 5, all eyes are now on December 8 when the final results will be declared. Of the two-phase Assembly elections. the voting for the first phase was held December 1 for 89 seats and polling for second phase encompassing 93 seats was held December 5. The average voting for the first phase was around 65% and voting percentage for second phase was about 60%, and average voting on the whole was less relative to 2017. Of the total 182 seats of the Assembly, 98 are rural while 84 are urban. Past electoral performance of the BJP shows that it had bigger sway in urban areas, and in 2017, the BJP had won 63 urban seats but could manage only 36 rural seats.

**BJP's Prospects** Winning Assembly election, albeit for the seventh term, is a prestige issue for the BJP because it is the home turf of Prime Minister Narendra Modi and Union Minister Amit Shah and losing grip over power in Gujarat entails potential pan-India implications for the BJP in electoral and prestige terms. In order to keep its hold on power in Guiarat, the BJP at the Centre as well as in the state has pulled all stops. Some observers have drawn attention to some major investment announcements made in the state in the run-up to the elections - a multi-billion dollar semiconductor plant by Vedanta-Foxconn and an aircraft manufacturing project by the Tata group and Airbus. During its first tenure in office at the Centre (2014-2019), the BJP had been engaged in aggressively marketing the development model of Gujarat, showcasing Gujarat's 1,600-km long coastline, well-developed ports, connected highways, industryfriendly policies, and export-led growth across sectors.

The BJP has been ruling Gujarat for 27 years now, including 13 years of Modi as CM, and cooperative dairies making up for approximately 90 constituencies, have played a crucial role during the Assembly polls until the recent past. Nevertheless, with the Patidar agitation done and dusted and the dairy producers witnessing a spike in their incomes in recent times, the BJP is expecting a change in their

electoral fortunes this time. However, a consistent fall in the number of seats won by the BJP in each election – from a record 127 seats in 2002 to 99 seats in 2017 - the BJP's claim of winning over 140 seats this time seems to be a tall claim.

Nonetheless, BJP is confronted with multiple dilemmas as well that entail the potential of adversely impacting its electoral fortunes this time. Admittedly, BJP boasts of the so-called double-engine government in BJP-ruled states, and in Gujarat there prevails double anti-incumbency wave against BJP's 27-year-old rule and over eight year rule at the Centre. While pointing to the prevalence of inner dissensions within the Gujarat unit of BJP in the wake of change of three CMs in less than five years, some analysts also draw attention to the prevailing frustration among many state party leaders over the distribution of tickets to candidates and a chunk of them have contested the polls as independent candidates. Some experts have opined that the Gujarat units of RSS and VHP are seemingly unhappy with the BJP leadership for multiple reasons, especially over the allocation of party tickets, and they have reportedly not extended their support for some candidates.

#### **Congress' chances**

The Congress in Gujarat has been out of power for over three decades; nevertheless, it has gradually been increasing its electoral tally after every Assembly poll and in 2017 it had managed to garner 77 seats and stopped the BJP at 99. During the election campaign preceding the Assembly election,

Congress maintained a low profile in urban areas and accorded priority to rural areas where it reportedly got overwhelming response. Congress campaign was devoid of high-profile and costly election meetings. Even national Congress leadership refrained from joining the campaign with the exception of former Congress president Rahul Gandhi addressing only two rallies for a day.

Congress campaign was primarily managed by Rajasthan CM Ashok Gehlot and he was later ioined by newly-elected Congress president Malikarjun Kharge. In the absence of the coverage of Congress campaign in national electronic and print media, the ground reports posted by Youtubers are the only sources of information. This author's visit to some districts of Gujarat made it discernible the Congress style of campaigning in small groups visiting rural populace, ascertaining their problems and making the populace aware of its programmes and policies.

As one expert has pointed out, Congress tacitly avoided frequent visits of Rahul to Gujarat to conduct campaign for the party to disallow the electoral discourse to be diverted from Modi versus Kejriwal to Modi versus Rahul. On the other hand, the party focused on basic issues affecting common man. According to experts, Congress' promise of restoring old pension scheme has been received well by government employees.

#### AAP's gambit

AAP thus far had been not a big player in the Gujarat Assembly election in 2017 but in 2022 it emerged as a force to be reckoned

with by indulging in election blitzkrieg and insertion of advertisements in state newspapers and conducting various rallies and roadshows in the state. The AAP had managed to secure only 28, 418 votes across the 30 seats it contested in 2017; nonetheless, it showed an impressive performance in Guiarat's local body polls where it secured a vote share of 13.28 per cent that showed that it can be a viable alternative to Congress in primary Opposition space, and in the long run, an alternative to BJP. Having given an inclination of 'soft Hindutva', AAP supremo Kejriwal also tried to change the political discourse of electioneering by triggering debate on Gujarat Model versus Delhi Model. AAP's primary offerings have been development-related emphasising better schools, better infrastructure and a grip over rising prices, allowance for women and jobless youth. Some observers feel that there are some takers for AAP's offerings in urban areas, especially in Surat where it performed well in 2021 local body polls.

#### **Way forward**

Pre-election surveys, opinion polls and even exit polls after the voting for the second phase, give landslide victory to the BJP and predict less than 50 seats for the Congress and single digit seats for AAP but in a triangular contest where both Congress and AAP are forces to reckon with in many constituencies, these projections by exit polls raise certain doubts in the minds of dispassionate observers and political analysts. The BJP has been witnessing a gradual decline in its seats' tally since 2002 till 2017 while the Congress has been gaining gradually. Presently, in triangular contests, the entry of AAP entails every likelihood of denting the BJP in urban areas and to some extent, denting the Congress in some rural areas. Admittedly, some critics point out that given all the odds facing the BJP may render the party to secure lesser number of seats relative to 2017; nevertheless, the BJP entails the probability of winning a lost battle given the power and resources at its disposal. Let's wait and watch for December 8.

"They had spent so much time glued to their smartphones," Peter Beck, the head of Buxton, told the New York Post.

So what did the school do? It banned smartphones, allowing the students to use only simple phones without social media apps or internet browsers.

And guess what? The students somehow survived. "They're spending more time doing academic work, creatively expressing themselves through art, getting to know one another and getting to know themselves," Beck said.

### Hindu Mahasabha leader held, 40 across Mathura detained

Mathura, Dec 6: An Akhil Bharat Hindu Mahasabha leader was arrested Tuesday while allegedly going to recite Hanuman Chalisa at the Shahi Masjid Idgah in the Shri Krishna Janmabhoomi complex while 40 activists of Hindutva organisations were taken into custody as a preventive measure, officials said. They said seven-eight other leaders of the organisation were also detained in their houses under different police stations of the city.

"Not a single member of the organisation could reach near Idgah as per their programme. As a preventive measure about 40 persons were taken into custody. They would be released on personal bond after completing the formality," Senior Superintendent of Police Shailesh Pandey said. Additional Superintendent of

Police (City) Martandey Singh said police arrested the Mahasabha's Agra region in-charge Saurabh Sharma when he was making an attempt to go towards the Idgah mosque in the complex.

He said the Mahasabha's president Rajshri Chaudhary and treasurer Dinesh Sharma were not among those confined at their homes, and police had no information about the duo.

Chaudhary claimed that she was



in Mathura Tuesday and a picture of her standing at gate number 1 of the Janmabhoomi complex was shared by the Mahasabha. However, Singh disputed the

claim saying, "This is an old picture which is being used for making false claims". National Vice-President of the Mahasabha, Anil Tripathi, told PTI over phone that he has been kept under house arrest at his residence in Delhi.

The officer said in view of the situation in Mathura, prohibitory orders were imposed by the district administration and those who tried to disturb peace were being interrogated after being taken into custody. Seven of these people belong to the Hindu Mahasabha, who are currently kept at the city police station, he said. ## ICMR faces 6K hacking attempts in a day: Official

AFTER INDIA'S TWO PREMIER HEALTH INSTITUTES - ALL INDIA INSTITUTE OF MEDICAL SCIENCES AND SAFDARJUNG HOSPITAL, THE TOP HEALTH RESEARCH INSTITUTE INDIAN COUNCIL OF MEDICAL RESEARCH HAS FACED THE CYBER ATTACK AND HACKING ATTEMPTS

New Delhi, Dec 6: Hackers allegedly tried to breach the website of the apex health research body ICMR but their attempts were foiled, government officials said Tuesday.

The attempted attack on the ICMR website was prevented by the firewall/security measures of NIC, they said, adding further steps are being taken to enhance cyber security. The hacking attempts come close on the heels of the al-

leged ransomware attack that had paralysed online services at the AIIMS here

The officials said that hackers apparently from Hong Kong targeted the website of the Indian Council of Medical Research around 6000 times in a span of 24 hours on November 30.

"The contents of the ICMR website are safe. The website did not wit-

ness any downtime." "The site is hosted at NIC Data Centre, hence the firewall is from NIC which they regularly update.



The attack has been prevented successfully by the firewall/security measures of NIC," the official said.

In the wake of the hacking attempts, the Secretary of the Department of Health Research (DHR) and Director General of ICMR, Dr Rajiv Bahl, reviewed cyber infrastructure and security practices at ICMR December 2, an official source said. "It was

briefed that the website of ICMR is hosted in the National Informatics Centre (NIC) cloud after a security audit by a CERT-IN empaneled agency. The website is protected by NIC firewall and other security measures."

"The ICMR also in-house hosts web and data portals of various programs of ICMR. The in-house infrastructure is protected by a customized open-source firewall (PFSense). Further, inbound and outbound internet traffic is strictly controlled and regularly monitored for any suspicious activity on all the active interfaces," the source said.

The Secretary, DHR directed that in light of the recent attack on AIIMS and other medical institutions, cyber-infrastructure security, particularly web portals and data, needs to be enhanced at ICMR.

It was decided that following best practices, the critical web and data portals will be migrated to Government Community Cloud (GCC). A request for proposal (RFP) for procuring GCC is already being prepared and is in the final stages, the source stated. A proposal for developing an ICMR Data Centre (Delhi and Chennai) and a Disaster-Recovery site (Bangalore) is being developed on a turnkey basis. A network security audit of ICMR and various locations will be executed on an urgent basis, the source said.

## Close race: Independents get The last holdouts of Kuno feelers from parties in Himachal

Exit polls indicated that the Congress and the ruling BJP might struggle to make it to the half-way mark when the results are declared December 8

Shimla, Dec 6: With exit polls pointing at the possibility of a hung assembly in Himachal Pradesh, some independent candidates claim they have started getting feelers from the two main parties for their support.

A party needs the support of at least 35 candidates to form the government in Himachal Pradesh. But exit polls Monday indicated that the Congress and the ruling BJP might struggle to make it to this half-way mark when the results are declared December 8.

The surveys projected a range of 24-41 seats for the BJP and 20-40 seats for the Congress.

If the contest turns out to be this close, the role of independents could be crucial --- and some of them claimed Monday that the two parties have been in touch with them.

When contacted BJP rebels KL Thakur and Manohar Dhiman, who fought the election as inde pendents after being denied the party ticket, said they have been "approached" by both the parties.

But they would keep their cards close to the chest till the results are officially declared, they told PTI. Another independent, Ram Singh, said he is not a rebel but the people's candidate and would decide whom to support after December 8.

Altogether, there are 91 independents in the fray including about two dozen rebels who may cut



into the votes that would have normally gone to the official party candidates, and spoil their prospects.

The political parties, however, are focused on independents who have a bigger chance of winning. Both the BJP and the Congress are chalking out strategies to rope them in, in case they themselves fall short of majority

The independents with better chances of winning include K L Thakur (Nalagarh), Manohar Dhiman (Indora), Ram Singh (Kullu), Raju (Arki), Hosihiyar Singh (Dehra), Indu Verma (Theog) and Sanjay Prasher (Jaswan-

For the record, both sides say they are set to score a clear victory. "We will get a clear mandate and form the government. Independents are welcome if they are willing to associate with the government, and remaining in touch with independent candidates is a normal process," Chief Minister Jai

Ram Thakur told PTI.

Leader of the Opposition Mukesh Agnihotri also claimed that Congress was all set to win majority and said party leaders are in contact with the independents.

In some elections in the past, Independents have played a significant role in the state, which has a record of alternating between the two main parties every assembly election.

In 1982, the Congress won 31 out of 68 seats in 1982 and formed the government with the help of independents. The BJP and Janata Party won 29 and two seats, respectively, and independents bagged six seats in that election.

BJP leader Shanta Kumar went to Raj Bhavan to stake his claim to form the government after two Janata Party members assured their support. But both of them failed to turn up there. Instead, four independents extended support

Sheopur, Dec 6: "We were born in the forest, and we would like to die here," say the Sahariya tribal people of two villages in Sheopur district that are in the process of resettlement due to the much-talked about cheetah project in Madhya Pradesh's Kuno National Park.

Ever since the release of chee tahs brought from Namibia into the park September 17, the state forest department has been taking steps to relocate both Bagcha, which falls under the park area, and Jahangarh, which lies in the buffer zone. Outside the buffer zone, a further 557 sq km has been newly demarcated as an eco-sensitive zone where people may continue to live but with restrictions on industries and land use.

As many as 216 families in Bagcha will be shifted to Rampura, located around 50 km away, where compensatory agricultural lands measuring not more than five acres each and places to build houses have been identified. However, things are bleak for the 70 families in Jahangarh as there is no provision to provide land for land while resettling people in the buffer zone. They will instead get a compensation of ₹15 lakh, specifically for land purchase.

The forest department will facilitate their relocation by identifying suitable plots in other villages and will directly pay from the compensation amount to land sellers. În case a balance amount is available, it will be given in installments to the beneficiary family to enhance their livelihood

Confirming that the officials have visited Jahangarh multiple times to convince them. Shyamahai Janmed, a Sahariya woman, says the forest department first told them that they could shift to Raghunathpur. "But when we checked out the place, the residents there said they were not willing to part with their agricultural lands. So where will we go?"

Later, the authorities directed the villagers to Chanipura, but the fact remains that Chanipura gram sabha is yet to give its consent. which is mandatory to buy land

Incidentally, this is not the first time that tribal people have resisted the move to drive them out of their forest. October 12, 2018, the area under Kuno National Park was increased from 344.69 sq km to 748.76 sq km, with many villages

added to the national park's operative area.

In the 1990s, when preparations were on to introduce lions to the area, 24 villages of Palpur range falling under the park area were shifted out. At that time, Bagcha and Jahangarh, which fall under Occhapura range and are home to the Sahariya, Bhil and Mongia tribes, were left out due to their

stiff resistance. This time around, the Bhils and Mongias are willing to move out provided they get compensation. However, the Sahariyas who constitute 65% of the total population of both villages have not changed their position. They say they should be resettled in another forest, if at all they need to, as they cannot live outside of it.

The tribal population also conserves the region's biodiversity as they rely on local crops, wild fruits, seeds, tubers and roots to meet their nutrition needs. "The tribals are equally important for the forest as much as the forest is necessary for the tribals," says Harimohan of Mahatma Gandhi

Seva Ashram, Sheopur, "I can predict the weather by looking at the cloud cover and wind speed. However, our future seems difficult to predict. I do not know

when the officials will come to throw us out," laments Gulubai

Ganpat of Jahangarh. The tribal community sells shatavari, gudmar leaves, nagarmotha, honey, salai, khair, gum, kakoda (spiny gourd) and amla in Occhapura and Vijapur. Most families in Jahangarh have two to five bighas of land on which they grow

paddy, sesame, millet and maize. However, not all tribal communities are averse to shifting out. Mogias and Bhils have agreed to take the compensation to leave the forest. Incidentally, both communities are not on good terms with the Sahariyas, who consider them as outsiders.

"What can we do if the government has decided to remove us from our land? We feel it is better to take the money that we are offered and settle down elsewhere,' the members of the Mongia and Bhil communities say in unison.

Restrictions are on the rise after the arrival of cheetahs in Kuno National Park. Camera traps have been set up and the forest department is continuously making announcements to prevent villagers from entering the buffer zone. Residents have also started receiving notices for re-

### BJP may use Hindutva card ahead of 2023 polls in MP

Bhopal, Dec 6: 'Hindutva' has undoubtedly been a key tool of polarisation in the politics of the BJP, but it had very little impact in Madhya Pradesh, be it pre-demolition or post-demolition Babri Masjid. However, the relentless attempts at polarisation indicate that the moderate system of governance would be a thing of the past now, and the Hindutva card would came to the fore in the assembly elections in 2023.

When the Babri Masjid was demolished in Uttar Pradesh, the Bharatiya Janata Party was in power in Madhya Pradesh. After a short interval of President's rule, elections were held in 1993 and the Sundarlal Patwa-led BJP government was voted out of power. The Digvijaya Singh-led Congress ruled the state for the next 10 years, following the rules of moderate governance.

More importantly, present Chief Minister Shivraj Singh Chouhan, who is a member of the right-wing Rashtriya Swayamsevak Sangh (RSS), did not allow communalism to flourish in Madhya Pradesh and ruled the state with a moderate governance system. His governance gave him the image of the 'moderate face of RSS', and his liberal governance system not only ensured the longest rule of the BJP in the state but also strengthened the party

Senior journalist N. K. Singh, who has been a close observer of Madhya Pradesh's politics for around four decades, said the state had been the stronghold of the right wing for the last several decades, but the BJP became stronger under the leadership of Chief Minister Chouhan.

"See, besides the RSS, many other right wing groups were flourishing in MP for the last several years, and their efforts for long years strengthened the BJP in the state.

But Shivraj Singh's leadership strengthened the party's roots and it happened because of his style of governance. He tried to reach out to the deprived sections of society and he kept hard Hindutva away from his governance," Singh said.

He pointed out that the Digvijaya Singh-led Congress was voted out of power in 2003, not because of the Hindutva card of the BJP but because of the incompetence and growing corruption in the government. "The BJP lost the 2018 assembly polls due to incompetence and the growing corruption. The Congress wasn't strong enough to defeat the BJP because factionalism was rife among its top leaders. The BJP lost the elections because it could not handle the increasing graph of unemployment, corruption. The Congress got the benefit

of anti-incumbency," Singh added. The BJP tried to play the Hindutva card in the 2018 elections to hide its failure, but the people of Madhya Pradesh did not accept it, they voted for a change in governance. "Now, the list of incomplete tasks has increased and therefore, there are very good chances that the BJP will come out with a stronger Hindutya card this time in an attempt to divert attention from the main issues ahead of the assembly polls in 2023. In fact, it has already

started," Singh claimed. Political observers also believe that Chouhan was forced to change his style of governance and was made to follow the Centre's agenda, but after the local bodies election outcome, he seems to have come

back on his old track. "Until 2014, MP's BJP leadership used to decide its own agenda, but now they have to follow the Centre's agenda. Perhaps, the central leadership has also understood it and has given a free hand to Chouhan again," said another journalist, Law Kumar

Bhopal, Dec 6: Notwithstanding the rapid growth of communalism in neighbouring Uttar Pradesh after the 'Ram Janmabhoomi-Babri Masjid' dispute and despite being Dal and Rashtriya Swayamsevak Sangh (RSS), Madhya Pradesh managed to keep communalism out of frame till 2014, thanks to the strong political leadership irrespective of the party in power.

According to people monitoring the state's politics for the past fourfive decades, the Ram Janmabhoomi-Babri Masjid issue did not have a major impact on Madhya Pradesh's politics. It only saw the rise of the fire-brand of Hindutva - Uma Bharti, who assumed the chief ministership for one year in 2003. Although the issue was used as a tool of polarisation, especially by the saffron party, and benefitted individuals like Bharti and Bhopal MP Pragya Singh Thakur, it was not a mass polarisation.

On why despite being a stronghold of Right-Wing and RSS, the issue could not make much of an impact here like in UP and Gujarat, political observers cited presence of strong leadership in both the BJP and the



Congress. The state leadership in both the BJP and the Congress had always refrained from promoting politics of hatred in Madhya Pradesh, till a few years back

Babri Masjid was demolished in December 1992 and after one year, Congress stormed back into power in Madhya Pradesh. "During 10 vears as Chief Minister, Digvijaya Singh (1993-2003) did not allow politics of communalism in Madhya Pradesh, and those who tried to make it a political tool, were sidelined. Even BJP leaders like Kailash Joshi and Sundarlal Patwa (both were CM from Janata Party) had liberal politics. Digvijaya Singh followed that liberalism," said a senior journalist Law Kumar Mishra. In 2003, almost a decade after Babri Masjid was demolished in Ayodhya

(Uttar Pradesh), this issue gave rise to Uma Bharti as fire-brand of Hindutya, considered as the major impact of Ram Janmabhoomi - Babri Masjid issue. Bharti rose to national prominence when she became one of the major faces of the Ram Janmabhoomi moment along

with L. K. Advani and others. Bharti was made the main face for CM in assembly elections in 2003 and her reputation as a Hindutva firebrand resulted in sweeping victory. "Bharti's tenure as CM ended within one year and Babulal Gaur replaced her. During his tenure. Gaur also followed the politics of liberalism. CM Shivraj Singh Chouhan also did not believe in 'hate' politics. During his long tenure as CM, he never promoted those using communalism for their political benefit.

The Samajwadi Party, Gondwana Ganatantra Party (GGP), Bahujan Samaj Party (BSP) and the Communist Party have been influential in the state.

In the 2003 elections, in the House of 230 MLAs, 18 MLAs had won from small parties. This number has been fluctuating as 13 MLAs from smaller parties won in 2008, four in

## 40% of inmates lodged in HP jails arrested in NDPS cases

Shimla, Dec 6: Drug abuse has become a major challenge in the hill state of Himachal Pradesh and over 40 per cent of the total inmates lodged in 14 prisons in the state have been booked in connection with drugs under NDPS Act.

The prisons in Himachal are overcrowded as 2,909 inmates are lodged against the capacity of 2,437

of which 68 per cent are under trial and 32 per cent are convicted. Out of the total 2,909 inmates 1,189 (40.8 per cent) were arrested in drug-related cases, officials said.

A total of 7,942 Narcotic Drugs and Psychotropic Substances (NDPS) cases were pending in the courts as on November 18, out of which 688 were pending for less than three months, 664 for three to six months, 935 for six months to one year, 953 for 12 months to 18 months, 1,110 for 18 months to two years and 3,601 were pending for more than two years.

Over 40 per cent of the total inmates lodged in 14 prisons in the state have been booked in connection with drugs under NDPS Act, the officials said.

As speedy trials would also help in decongesting the jails in the state, the Himachal Pradesh Police have implemented a 'Robust Trial Management' mechanism under which deposition by police officials and independent witnesses in the courts is being reviewed every week to ensure speedy trials in the NDPS cases. Himachal police are the first in the country to start robust trial management and the police officers have been directed to depose on time to reduce the pendency of the NDPS cases. As many as 8,734 police personnel have been deposed from March 29, 2021, till November 18, 2022, Himachal DGP Sanjay Kundu told the PTI.

Our initiative has started yielding results and 346 cases have been decided in the first ten months of 2022 till October 31 as compared to 202 in 2020 and 126 persons have been convicted in NDPS cases in the current year in comparison to 64 in 2020, he said.

The weekly and cumulative record of the number of Police Officers and witnesses deposed in the courts under the NDPS Act, pending deposition, processes served to witnesses and the number of cases in which charge sheet has been submitted by the police for trial is being maintained, to expedite trials.

There are 2,307 drug trafficking operators (drug peddlers) in the state out of which 80 per cent (1,836) are from Himachal, 18 per cent (422) are from other states and two per cent (49) are foreigners, according to the data procured from

the police department. About 60 per cent of the drug peddlers in Himachal have taken to Chitta (adulterated heroin) smuggling for pecuniary gains, adding a new dimension to the drug menace in the state and Chitta consumption has surpassed all other drugs. On average, over 1,500 NDPS cases are registered in the state

every year with over 2,000 arrests.

As many as 1,732 persons were arrested in 1,195 NDPS cases in the first ten months of 2022 till October end and the police have seized 274 kgs charas, 31 kgs opium, 306 kgs poppy husk, 164 kgs Ganja, smack and cocaine, 7.9 kgs of heroin (chitta) and 30,152 capsules and tablets and destroyed 70,602 poppyplants and 47,737 cannabis plants, officials added.



## SC: Govt needs to ensure foodgrains reach everyone

New Delhi, Dec 6: It is our culture to ensure nobody goes to sleep empty stomach, the Supreme Court said Tuesday and asked the central government to see to it that foodgrains under the National Food Security Act (NFSA) reaches the last man.

A bench of Justices M R Shah and Hima Kohli directed the Centre to submit a fresh chart with the number of migrant and unorganised sector workers registered on eShram portal

"It is the duty of the central government to ensure foodgrains under NFSA are reaching the last man. We are not saying that Centre is not doing anything, the Union of India has ensured foodgrains to people during Covid. At the same time, we have to see it continues. It is our culture (to ensure) that nobody goes to sleep empty stomach," the bench said. It was hearing on its own a public interest matter related to the plight of migrant workers during the Covid pandemic and the resultant lockdowns.

Advocate Prashant Bhushan, appearing for three social activists Anjali Bharadwaj, Harsh Mander and Jagdeep Chhokar, said the country's population has increased after the 2011 census and so has the number of beneficiaries covered under the NFSA.

Bhushan said the government is claiming the per capita income of people has increased in recent years, but added India has slipped

Following a heated argument. he took out a surgical knife and slit Tapaswi's throat even as a fright ened friend ran out of the house to alert the neighbours.

Gnaneswar dragged a bleed ing Tapaswi into an adjoining room and locked it up before the locals came and broke open the doors. He cut his arm on seeing the locals before he was over-

They handed him over to the police. Meanwhile, the bleeding girl was taken to a private hospital in Guntur, where she succumbed.

### LAKHIMPUR KHERI VIOLENCE Charges framed against Ashish Mishra, 12 others

Lakhimpur Kheri (UP), Dec 6: A court here Tuesday framed charges against Union minister Ajay Kumar Mishra's son Ashish and 12 others for murder, criminal conspiracy and related offences in the case of mowing down of protesting farmers in October 2021 in Lakhimpur Kheri, paving the way for the start of the trial.

Additional District Judge Sunil Kumar Verma has now fixed the next hearing December 16. District Government Counsel (Criminal) Arvind Tripathi told *PTI*.

Tripathi said that 13 accused, including Ashish Mishra, have been charged under IPC sections 147 and 148 related to rioting, 149 (unlawful assembly), 302 (murder), 307 (attempt to murder), 326 (voluntarily causing grievous hurt by dangerous weapons or means), 427 (mischief) and 120B (punishment for criminal conspiracy), and section 177 of Motor Vehicle Act.

Ashish Mishra, son of Union Minister of State for Home Ajay Kumar Mishra, is the main accused in the case.

The other 12 accused are Ankit Das, Nandan Singh Bisht, Latif Kale, Satyam alias Satya Prakash Tripathi, Shekhar Bharti, Sumit Jaiswal, Ashish Pandey, Lavkush Rana, Shishu Pal, Ullas Kumar alias Mohit Trivedi, Rinku Rana and Dharmendra Banjara. All of them are in jail. The 14th accused,

## Police bust sex racket, rescue over 14K victims

**Hyderabad**, **Dec 6:** The Cyberabad Police Tuesday claimed to have busted a major sex racket with the over 14,000 victims, including some from foreign countries.

Cyberabad Police Commissioner Stephen Ravindra said the racket was being operated online from Delhi, Bangalore and Hyderabad.

The accused were procuring women from different places across India, posting ads on websites, contacting the customers through call centres and WhatsApp, facilitating the customers to reach the victims in different hotels, Oyo rooms, and collecting money for this organised prostitution racket. A total of 14,190 victims were

involved in prostitution. Fifty per cent of the victims were from West Bengal, 20 per cent from Karnataka, and 15 per cent from Maharashtra. Three per cent victims were from countries like Bangladesh, Nepal, Thailand, Uzbekistan and Russia.

'Locanto', 'Skokka', 'Hyderabadescorts', 'Callgirls in Hyderabad', 'Luxurvescortservices'. 'myheavenmodels.com', and 'natasharovin' were some of the websites which were being used for running the racket.

The call centres were operated from Delhi, Bangalore and Hyderabad, and the main mode of communication was WhatsApp groups

The accused have been booked under Section 370 (buying or disposing of any person as a slave) of the Indian Penal Code (IPC) and Sections 3, 4 and 5 of the Immoral Traffic (Prevention) Act at four police stations in Cyberabad.

## Majority of rich nations working off plans to meet 1.5° Celsius warming limit: Report

New Delhi, Dec 6: The majority of developed countries are still a long way off their plans to limit global warming to the UN-agreed 1.5 degrees Celsius despite raising ambition in the past 18 months, according to an updated version of the peer-reviewed Paris Equity Check.

The Paris-Equity-Check.Org assesses Nationally Determined Contributions (NDC) or national plans of countries to help achieve the global goal of limiting temperature rise to 1.5 degrees Celsius as compared to the pre-industrial average. Countries hope that limiting global warming to 1.5 degrees Celsius will avoid the worst impacts of climate change.

The COP27 Sharm El-Sheikh Implementation Plan released in November underscored the need to meet the 1.5-degree Celsius limit and deliver loss and damage finance, a key prerequisite to accelerate collaboration for more ambitious emission cuts globally.



The Earth's global surface temperature has already increased by around 1.1 degrees Celsius as compared to the preindustrial (1850-1900) average and this warming is considered the reason behind record droughts, wildfires and In particular, the US, Canada, Australia, the EU, Germany and Spain are working off plans that are in line with a range of 2.1-3.4 degrees Celsius warming, according to the assessment

China, Russia, Saudi Arabia, Turkey, Vietnam and Iran are among the countries who still have climate plans associated with 5 degrees Celsius global warming

The majority of the world's poorest countries are on course to meet the 1.5-degree Celsius limit. But without adequate levels of financial support, they may pursue carbon-intensive devel

opment pathways through the 2020s and 2030s and overshoot their fair levels of emissions after their "currently fair" 2030

Paris Equity Check (PEC) rates the fairness and ambition of targets based on three principles presented in the UN's IPCC-AR5 WGIII report -- the capability of a country to deliver faster greenhouse gas (GHG) cuts, historical responsibility per capita emissions and the equality of access to the remaining carbon space.

"Fairness is the metric for assessing the ambition of national climate targets and their contribution to the global effort needed to limit global warming.'

"Countries can implement 'fair and ambitious' targets, as required under the Paris Agreement, through a combination of domestic mitigation and support to reduce emissions at a lower cost in other poorer countries that can mitigate beyond their fair targets," said Yann Robiou du Pont, lead researcher at PEC.

### Guj Police detain Gokhale over tweet on Modi's visit

Ahmedabad, Dec 6: The Gujarat Police have detained Trinamool Congress's national spokesperson Saket Gokhale over a tweet endorsing an alleged fake news about Prime Minister Narendra Modi's visit to Morbi after a bridge collapse incident there, an official said Tuesday.

Gokhale was apprehended from Jaipur in Rajasthan during the early hours by officials of the Ahmedabad Cyber Crime Cell, Assistant Commissioner of Police (ACP), Cyber Crime, Jitendra Yadav said. "Based on a complaint we received from a citizen, an FIR has been lodged against Gokhale for spreading fake news about the PM's visit to Morbi. We detained him from Jaipur today morning and he is being brought here for further legal process," Yadav said, adding a formal arrest will be

made after a Covid-19 test. The FIR was registered under Indian Penal Code Sections 465. 469, 471 (all pertaining to forgery) and 501 (printing or engraving matter known to be defamatory), police said. Gokhale, 35, the spokesperson of the Mamata Banerjee-led TMC. underwent a heart surgery recently and was on a private visit to Jaipur, sources said. He recently

## Indonesia passes criminal code banning sex outside marriage

Jakarta. Dec 6: Indonesia's Parliament unanimously passed a long-awaited revision of the country's penal code on Tuesday that criminalises sex outside of marriage for citizens as well as foreigners, prohibits promotion of contraception and bans defamation of the president and state in-

The amended code also expands an existing blasphemy law and maintains a five-year prison term for deviations from the central tenets of Indonesia's six recog-

Protestantism, Catholicism, Hinduism, Buddhism and Confucianism.

Citizens can face a 10-year prison term for associating with organisations that follow Marxist-Leninist ideology and a four-year sentence for spreading communism. The code maintains the previous criminalisation of abortion but adds exceptions for women with lifethreatening medical conditions and for rape, provided that the fetus is less than 12 weeks old, in line with what is already provided in a 2004 Medical Practice Law.

Rights groups criticised some of the revisions as overly broad or vague and warned that adding them to the code could penalise normal activities and threaten freedom of expression and privacy rights. However, some advocates hailed the passage as a victory for the country's LGBTQ community.

During fierce deliberation, lawmakers eventually agreed to remove an article proposed by Islamic groups that would have made gay sex illegal. The revised code also preserves the death penalty within the criminal justice system despite calls from the National Commission on

abolish capital punishment, as dozens of other countries have done.

But under the new code, the death penalty has a probationary period. If within a period of 10 years the convict behaves well, then the death penalty will be changed to life imprisonment or 20 years' imprisonment. Under Indonesian regulations, legislation passed by Parliament becomes law after being signed by the president. But even without the president's signature, it automatically takes effect after 30 days unless the president issues a regulation to cancel it.

# **Beijing relaxes Covid test norms**

However, Beijing residents will still require a negative Covid-19 test taken within 48 hours to enter restaurants, schools, bars, internet cafes, indoor gaming stadiums, nursing homes, welfare facilities, hospitals and medical institutions.

The announcement was made ahead of the memorial meeting held here by the ruling Communist Party of China (CPC) for former President of the country Jiang Zemin who passed away on November 30.

## Shooter of Lady Gaga's dog walker gets 21 yrs in prison

Los Angeles, Dec 6: The man who shot and wounded Lady Gaga's dog walker and stole her French bulldogs last year took a plea deal and was sentenced to 21 years in prison, officials said.

The Lady Gaga connection was a coincidence, authorities have said. The motive was the value of the French bulldogs, a breed that can run into thousands of dollars, and detectives do not believe the thieves knew the dogs belonged to the musician.

James Howard Jackson, one of three men and two accomplices who participated in the violent robbery and its aftermath, pleaded no contest to one count of attempted murder, according to the Los Angeles County District Attorney's Office. It was not immediately clear which attorney represented Howard on Monday.

Jackson and two others drove around Hollywood, the city of West



Hollywood and the San Fernando Valley on Feb. 24, 2021 "looking for French bulldogs," prosecutors said previously. They found Lady Gaga's dog walker, Ryan Fischer, with the pop star's three pets.

Jackson shot Fischer during the robbery near the famed Sunset Boulevard, during which two of the dogs were taken. A nearby doorbell camera recorded the dog walker screaming "Oh, my God! I've been shot!" and "Help me!" and "I'm bleeding out from my chest!"

Fischer later called the violence a "very close call with death" in social media posts. The dogs, named

Koji and Gustav, were returned several days later by Jennifer McBride, who was also charged in

the crime. The pop star had offered a USD 500,000 reward — "no questions asked" — to be reunited with the dogs at the time. Jackson also admitted the allegation of inflicting great bodily injury and to a prior strike, the DA's office said Monday. The prosecutor's office did not immediately say what the

United Nations, Dec 6: The first attempt to survey the extent of violence and harassment at work around the globe has found that workplace abuse is widespread, and particularly pronounced among young people, migrants, and wage

earners, especially women. More than 22 per cent of the nearly 75,000 workers in 121 countries surveyed last year reported having experienced at least one type of violence or harassment, according to the report released

Monday by the UN International Labor Organisation, the Lloyd's Register Foundation and Gallup.

'Violence and harassment in the world of work is a pervasive and harmful phenomenon, with profound and costly effects ranging from severe physical and mental health consequences to lost earnings and destroyed career paths to economic losses for workplaces and societies," the three organi-

sations said in the 56-page report. According to the findings, onethird of the people who experienced violence or harassment at



work said they had experienced more than one form -- and 6.3 per cent said they had faced all three forms: physical, psychological, and sexual violence and harassment during their working life.

"statistics on violence and harassment in the world of work are sporadic and scarce" so the ILO joined forces with Lloyd's and Gallup to carry out "the first global exploratory exercise to measure people's own experiences." The survey used data from the 2021 Lloyd's Register Foundation World Risk Poll, which was part of the Gallup World Poll.

The results pave the way for further research, the organisations said."Ultimately, stronger evidence will help forge more effective legislation, policies and practices that promote prevention measures, tackle specific risk factions and root causes, and ensure that victims are not left alone in handling these unacceptable occurrences," the ILO, Lloyd's and Gallup said.

#### ₹ dives to over 1-month low

Mumbai: The rupee declined by 65 paise to close at over onemonth low of 82.50 against the US dollar Tuesday due to heavy selling pressure in domestic equities and rising crude prices in the overseas markets. In addition, investors remained concerned over continued foreign capital outflows ahead of the RBI's policy announcement Wednesday, forex dealers said. At the interbank foreign exchange market, the local unit opened weak at 81.94, then slipped further to end at 82.50, registering a fall of 65 paise.

#### India's palm oil imports rise 29%

Mumbai: India's palm oil imports jumped 29% in November from a month ago, as a steep discount to rival soyoil and sunoil made buying of the tropical oil lucrative for local refiners, five dealers said. Higher imports by India, the world's biggest palm oil buyer, would help top producer Indonesia cut its inventories and support benchmark Malaysian palm oil prices which have nearly halved from this year's record highs. India's palm oil imports reached 1.14 million tonne last month, the average estimate from five dealers with trading firms showed. In November 2021, India had imported 539,639 tonne of palm oil.

#### Thermal power generation rises

New Delhi: India's thermal power generation registered a growth of 16.28 per cent at 87,687 MU (million units) in November this year as compared to 75,412 MU generated in the corresponding month of previous fiscal. The overall generation of power in the country also increased by 14.63 per cent from 1.02.968 MU to 1.18.029 MU in the reporting month year-on-year. Power utilities' despatch went up by 3.55 per cent to 62.34 million tonne (MT) during November this year as compared to 60,20 MT in the year-ago month.

## Unicorn count drops to 85 from over 100 in India

The decline in unicorns come as the funding winter hit the startup ecosystem which has only gone worse with thousands of employees being asked to go

New Delhi, Dec 6: The number of unicorns (with the \$1 billion valuation and above) in India has dropped to 85 from more than 100 just a couple of months ago, as most startups have shed a significant share of their valuations while investors stay back amid the prevailing global economic turmoil.

According to data compiled by Finbold, the US has the highest number of unicorns at 704 while China comes a distant second with 243 unicorns (as of November this year).

Despite the general market conditions, several regions are leading in the number of unicorns or private companies valued at least \$1 billion.

"The United Kingdom ranks fourth with 56, while Germany ranks fifth with 36 unicorns. Indeed, the US has at least double the number of unicorns compared to both China and India combined," according to the report.

In May this year, India welcomed

over \$42bn across 1,583 deals in 2021 taking the In the first half of 2022,

its 100th unicorn, which was Bengaluru-based neobank platform Open that raised fresh funds as part of its Series D round, taking its valuation to \$1 billion.

Only two startups in India, Shiprocket and OneCard, attained unicorn status (valuation \$1 billion and above) in the July-September period, mirroring a global trend in decline in the number of new unicorns, a PwC India report showed.

According to the Finbold report, Elon Musk's space company SpaceX ranks top in the US with a valuation of \$127 billion, while payment firm Stripe ranks second at \$95 billion. Instacart ranks third, valued at \$39 billion, followed by Databrick's \$38 billion valuation. Meanwhile, gaming company Epic Games ranks fifth at \$31.5 billion.

"The US dominance over China can be linked to the Asian country's stringent laws on the private sector. With a robust private sector led by the tech industry, the government moved to curtail the powers of such entities. In this case, there is a widespread fear of companies accelerating their growth, with venture capitalists remaining sceptical," the report mentioned. Notably, with the \$1 billion valuation, most companies still depend on external funding while attempting to work out a profitable model. Critics have, for instance, stated that attaining unicorn status without profitability might be considered a fad.

"It is worth noting that unicorns are now prime candidates for Initial Public Offering (IPO). However, the possibility of launching an IPO will likely depend on the state of the economy. Notably the stock market remains depressed, with most companies losing a big chunk of their valuations," the report said.

New Delhi, Dec 6: India is better placed than many other emerging economies to weather the impact of global headwinds, the World Bank said Tuesday, revising up its growth forecast for the country to 6.9% for fiscal 2022 from an earlier estimate of 6.5%. The estimate was within the gov-

ernment's own recent guidance. Asia's third-largest economy, which expanded 6.3% in the July-September quarter, is estimated to grow 6.8-7% in the current 2022/23 fiscal year ending March, it said last week. The report titled 'Navigating the

Storm', said while the deteriorating external environment will weigh on India's growth prospects, the economy is relatively well positioned to weather global spillovers compared to most other emerging markets.

Like many developing economies, India is confronting inflation following a surge in global food and fuel prices after Russia's invasion of Ukraine earlier this year. That has prompted the central bank to raise policy interest rates while warning about the impact of an international economic slowdown.

"India's economy has been remarkably resilient to the deteriorating external environment," said Auguste Tano Kouame, World Bank's country director, while re-

## 3 Indian billionaires on Forbes Asia Heroes of Philanthropy list

Singapore, Dec 6: Indian billionaires Gautam Adani, Shiv Nadar, and Ashok Soota, as well as Malaysian-Indian businessman Brahmal Vasudevan and his lawyer wife Shanthi Kandiah, were named in the 16th edition of Forbes Asia's Heroes of Philanthropy list released Tuesday.

The unranked list highlights leading altruists in the Asia-Pacific region who demonstrated a strong personal commitment to philanthropic causes, Forbes said in a press release.

Adani was listed for having pledged ₹60,000 crore (\$7.7 billion) when he turned 60 in June this year. The pledge makes him one of India's most generous philanthropists, the press release said.

The money will address healthcare, education, and skill development and will be channelled



through the family's Adani Foundation, which was founded in 1996. Each year, the foundation helps nearly 3.7 million people across India.

Self-made billionaire and philanthropist Shiv Nadar counts among the top donors in India, having channelled close to \$1 billion of his wealth over a few decades to various social causes through the

eponymous Shiv Nadar Foundation. This year he donated ₹11,600

crore (\$142 million) to the foundation he established in 1994, intending to create an equitable. merit-based society by empowering individuals through education.



Nadar, who cofounded HCL Technologies has helped set up educational institutions such as schools and universities via the foundation, which also promotes art and culture. He stepped down from executive roles at the IT services company in 2021.

Tech tycoon Ashok Soota has pledged ₹600 crore (\$75 million) to the medical research trust he founded in April 2021 for the study of ageing and neurological illnesses. He started SKAN-Scientific Knowledge for Ageing and Neurological ailments—with a ₹200 crore outlay, which he has since tripled. "There are only two kinds of people doing [medical] research in India," Forbes Asia quoted Soota as saying. "One is the people doing drug discovery, and the other is the people doing research in national and state-level institutions, which are starved for funds.'

Malaysian-Indian Brahmal Vasudevan, founder and CEO of Kuala Lumpur-based private equity firm Creador, and his lawyer wife, Shanthi Kandiah, support local communities in Malaysia and India through the Creador Foundation, a non-profit they co-founded in 2018.

In May this year, they pledged to donate 50 million Malaysian Ringgit (\$11 million) to help build a teaching hospital at the Universiti Tunku-Abdul Rahman (UTAR) Kampar campus in Perak state.

## Neymar leads Brazil into last 8

Doha, Dec 6: It was the same old Neymar out there, looking fit and scoring a goal to move closer to Pelé's all-time record and lead Brazil into the World Cup quarterfinals.

Neymar returned from injury and converted a first-half penalty in Brazil's 4-1 win over South Korea in the round of 16 Monday. He reached 76 goals with the national team, one shy of the mark set by Pelé, who said he would watch the match from his hospital bed in Sao Paulo.

The 82-year-old Pelé is recovering from a respiratory infection that was aggravated by COVID-19, leaving fans in Brazil and in Qatar worried about his condition. Neymar carried a banner with the football great's image and "Pelé" written on it after the match, and the entire team then posed behind it near midfield.

South Korea were trying to advance past the round of 16 for the first time since their historic run to the semifinals as a co-host in 2002.

Neymar damaged ligaments in his right ankle in the team's opening match against Serbia and at the time there were doubts if he would play again at the World Cup. He was clearly back, and there were no signs of the injury as he led Brazil to a comfortable victory and a spot in the World Cup quarterfinals for the eighth straight time. Brazil will next play Croatia Friday.

Neymar scored his first goal of this year's World Cup after kissing the ball and calmly sending a low shot from the spot after waiting the goalkeeper to choose a side in the 13th minute. He danced as his teammates huddled around him, then did dance moves along with Vinicius Junior and other teammates before raising his arms to the sky and smiling broadly.

Neymar was forced out of the 2014 World Cup in Brazil after getting hurt in the quarterfinals. Monday, he joined Pelé and Ronaldo with goals for Brazil in three different World Cups. Fans chanted his name as he walked off the field after the match. He had been substituted in the 81st.

Vinicius scored the first goal from inside the area after a cross by Raphinha in the seventh minute, Richarlison added to the lead from close range after a nice exchange of passes by the Brazilians in the 29th, and Lucas Paqueta scored the fourth before halftime after an

assist by Vinicius. They celebrated each goal by dancing, and even Brazil coach Tite participated in Richarlison's

traditional "pigeon" celebration. Paik Seung-ho scored South Korea's goal in the 76th minute. South Korea coach Paulo Bento said after the match he was quitting.

STADIUM DISMANTLED

It was the last World Cup match at Stadium 974, which is expected to be fully dismantled. The port-side structure that seats more than 40,000 fans was partially built from recycled shipping containers and could be shipped to other countries that need the infrastructure.

Australia starting 9th December in Mumbai," it further stated.

Powar was appointed for his second stint in May 2021 and the Indian team didn't have too many noteworthy performances under his tutelage save the silver at the Commonwealth Games in Birmingham. India couldn't make it to the semifinal of the 50 over World Cup in New Zealand earlier

Commenting on his appointment, Kanitkar said: "I see tremendous prospects in this team and we have a good mix of youth and experience. I believe this team is ready for the challenge ahead. We have a few marquee events coming up and it is going to be exciting for the team and myself as Powar will be the spin bowling

coach at the NCA. "With Powar coming on-board (as a spin bowling coach), we are sure he will bring his expertise and experience to the NCA. Having worked in domestic, age-group cricket and the international circuit, I am sure he will play an active role in the betterment of the game. I look forward to working with him in his new role at the NCA,' NCA head Laxman said.

Powar termed his experience coaching women's team as "enriching". "Over the years I have worked closely with some of the stalwarts of the game and upcoming talents of the country. New Delhi, Dec 6: Clear communication with the players and not getting intimidated by aggressive appeals will be the key when the trio of female umpires - Vrinda Rathi, Janani Narayanan and Gayathri Venugopalan – break new ground and officiate in the Ranji Trophy, a BCCI official said Tuesday.

It will be a first for Indian cricket when female umpires will be asked to officiate in the men's cricket matches even as Gayathri has served as a reserve (fourth) umpire in Ranji Trophy in the past.

With Ranji Trophy, beginning December 13, coinciding with Indian women's cricket team home series against Australia, the three female officials will only get to do select matches in the men's firstclass competition.

Chennai-based Narayanan and Mumbai-based Rathi are seasoned umpires and were included in International Cricket Council's panel of development umpires back in 2018. Delhi-based Gayathri, who could not make it as a player, is among the three registered umpires in the BCCI panel besides Janani and Vrinda

A BCCI official said dealing with the male players will be a big challenge for the female trio. Stakes are high in Ranji Trophy and tempers can flare in the middle.

The communication with the players is key. But all these three are doing well and should do well," a BCCI official, who did not wish to be named, told PTI.

The 32-year-old Rathi has risen\_ from the maidans of Mumbai while 36-year-old Narayan left her cushy job as a software engineer to pursue umpiring. Venugopalan, 43, started umpiring in 2019 after clearing the BCCI exam.

The BCCI still has a lot of catching up to do with female umpires already officiating in men's cricket in Australia and England. Out of 150 registered umpires with the BCCI, only three are women.

"We can't plan their games in Ranji Trophy but we will gave them opportunities as per their availability. Australian team is coming to India and will be followed by New Zealand A side and then you also have domestic women's cricket. We need their services there as well," the official said.

"All three are very promising umpires and as per BCCI's vision, we want to promote more female umpires in men's cricket. We will ensure that more women give exams in future but we have not set a
