ADANI'S ₹7K CRORE **DEAL FALLS THROUGH**

NEW DELHI: Adani Power Ltd's ₹7,017-crore deal to buy thermal power assets of DB Power has failed after the initial pact expired. "We wish to inform that the long stop date under the Memorandum of Understanding dated August 18, 2022, has expired," Adani Power said in a regulatory filing Thursday. Earlier in August 2022, Adani Power had informed the bourses that it has agreed to acquire DB Power Ltd, which owns and operates a running 2x600 MW thermal power plant at district Janjgir Champa in Chhattisgarh. Despite four extension of dates, Adani Power failed to go through the deal.

FATHER, MINOR SON DIE IN ROAD MISHAP

NUAPADA: In a tragic incident, a motorcyclist and his five-year-old son were killed Thursday in a road accident on Biju Expressway at Lakhana locality in Nuapada district. The deceased persons have been identified as Kamal Patakinara (35) and his son Dipak Patakinara (five) of Michhapali village. Eyewitnesses said that a speeding truck hit the motorcycle on which the duo was travelling and both father and son died on the spot. Police said that the driver has been detained and the truck seized

I-T 'SURVEY' AT BBC **OFFICES FINALLY ENDS**

NEW DELHI: The Income Tax department's marathon 'surveys' at BBC's offices ended Thursday, after clocking over 58 hours in total, as officials prepared an inventory of financial data from select staffers and collected digital and paper data. Sources said that the operation which began at the British Broadcasting Corporation (BBC) offices in Delhi and Mumbai around 11.30am Tuesday has ended at both the places. Tax authorities have made an inventory of the available stock. recorded the statement of some staffers and have impounded some documents. A BBC staffer in Delhi said they cooperated with the survey and were broadcasting their news like usual.

BJD trying to kill me: Jayanarayan

Bhubaneswar/Sambalpur, Feb 16: Allegations and counter-allegations flew thick and fast Thursday, a day after BJP MLA and Leader of the Opposition (LoP) Jayanarayan Mishra allegedly manhandled a woman police IIC in Sambalpur district. Mishra alleged Thursday that some 'goons' of the ruling Biju Janata Dal (BJD) had come to kill him at the Sambalpur circuit house

"As I have been raising the issue of Minister Naba Das' murder, the state government and the BJD have become furious. Some 'goons' of the BJD came Thursday to the circuit house with an intention of killing me. All of them are criminals. They also vandalised the place," Mishra informed.

Amid this allegation, BJD leader and former IPS Arup Patnaik issued a veiled threat to Mishra without naming him while addressing a gathering in Bhubaneswar. "I am no longer in uniform now... I hope the person who was involved in the pushing and shoving, confronts me.



He knows very well what the consequences will be," Patnaik said. Meanwhile the women's wing

of the BJD staged a dharna in Bhubaneswar demanding removal of Mishra from the post of the LoP for allegedly misbehaving with a woman police officer in Sambalpur. The protesters also demanded an apology from Mishra.

The saffron party too staged a dharna near Raj Bhavan, claiming that there was a bid to eliminate Mishra, also the BJP MLA from Sambalpur, for criticising the state government in connection with the assassination of Das.

Members of the BJD and BJP also burnt effigies of the LoP and Chief Minister Naveen Patnaik

1,000 cold storages in state soon: Agri Secy

Chief Minister harps on importance of technology-based farming in the agriculture sector to increase production

Bhubaneswar, Feb 16: Odisha Chief Minister Naveen Patnaik said Thursday at the three-day 'Krushi Odisha 2023' programme here that technology-led development is a must in the agriculture sector. More importantly however, was the announcement by Agriculture & Farmers Empowerment department principal secretary Arabinda Padhee who announced that 1,000 additional cold storage facilities will come up in the state soon. Each storage facility will have a capacity of 10-15 metric tonne and will be spread across all the 30 districts of Odisha and the facilities will be powered by solar energy, he added.

Lack of cold storage facilities has been a headache for Odisha farmers. Only a few days back, mustard farmers in Jaleswar had told this newspaper that they were being forced into distress sale due to the absence of cold storage facilities. Similar complaints have been voiced from other districts also. So Padhee's announcement will certainly usher

in new hope for farmers.

Earlier after inaugurating the programme, Patnaik emphasised on technological intervention in the farm sector and said that the government is focusing on technology-led development. He urged farmers to adopt new machinery and equipment to make Odisha an agriculture developed state.

'Krushi Odisha 2023' is being organised by the Department of Agriculture & Farmers' Empowerment jointly with FICCI.

Patnaik while highlighting Odisha's transition from being a food deficit state to a surplus one said, "We have been supplying rice to the whole nation. Our 'KALIA scheme' ensured income security for farmers and to increase agricultural productivity our government continue to focus on farm mechanisation.

Sweta died by suicide by hanging herself with a stole from the ceiling fan of her room at an apartment in Sailshree Vihar locality under Chandrasekharpur police limits August 19, 2022.

Police arrested the deceased techie's boyfriend. Soumvajeet Mohapatra from his residence at Sambalpur and brought him here. He was produced before the court which sent him to judicial custody.

Based on the complaint lodged by the family members, police started investigation. Police examined the call detail records (CDR) of the victim and her boyfriend, the statements of the couple's friends and family members

It came to fore during the probe that the couple were in a live-in relationship till 2021 before Soumyajeet shifted to the hostel of a management college where he got admission for MBA. The accused allegedly kept physical relationship with the victim with false assurances of marriage.

However, their relationship soured after Soumyajeet shifted to the hostel. Sweta tried to save the relationship but in vain. A mentally disturbed Sweta failed to bear the break-up and betrayal by her

January 31 of that particular year. As such, all government staff were supposed to furnish details by January 31, 2023. However, since many have failed to do so, the deadline has been extended to March 31.

MP'S KUNO TO GET 12 NEW CHEETAHS

New Delhi, Feb 16: Twelve cheetahs will be flown into India February 18 from South Africa, Union Environment Minister Bhupender Yadav said Thursday. Under the ambitious 'Cheetah Reintroduction Programme', Prime Minister Narendra Modi had released September 17 last year, the first batch of eight spotted felines-five females and three males - from Namibia into a quarantine enclosure at the Kuno National Park in Madhya Pradesh. Presently, the eight cheetahs at Kuno are killing a prey every three-four days and are in good health, officials said.

"A C-17 aircraft of the Indian Air Force (IAF) left the country Thursday morning to bring the 12 cheetahs from South Africa. Ten quarantine enclosures have been created at the Kuno National Park for these felines," Yadav said at a press conference here.

The cheetah is the only large carnivore that got completely wiped out from India and the last spotted feline died in 1948 in the Sal forests of Chhattisgarh's Koriya district.

India and South Africa had in January signed an MoU to transport cheetahs from the African country and reintroduce them in Kuno. A majority of the world's-7,000 cheetahs live in South Africa, Namibia and Botswana.

Heartthrob of millions Raquel Welch dies

THE ACTOR HOWEVER, CONSIDERED HERSELF MORE THAN JUST A SEX SYMBOL AS SHE BROUGHT UP TWO KIDS SINGLE-HANDEDLY

New York, Feb 16: Raquel Welch, whose emergence from the sea in a skimpy, furry bikini in the film One Million Years BC set pulses racing and hearts rapidly beating has died. She was 82. It was this film which gave Welch sex symbol status throughout the 1960s and '70s. Welch died early Wednesday after a brief illness, according to her agent, Stephen LaManna.

Welch's breakthrough came in 1966's campy prehistoric flick One Million Years BC despite having a grand total of three lines. Clad in a brown doeskin bikini, she successfully evaded pterodactyls but not the notice of the public.

"I just thought it was a goofy dinosaur epic we'd be able to sweep under the carpet one day," Welch told this agency in an interview in 1981. "Wrong. It turned out that I was the Bo Derek of the season. the lady in the loin cloth about whom everyone said, 'My God,



what a bod' and they expected me to disappear overnight.

Welch did not, playing 'Lust' for the comedy team of Peter Cook and Dudley Moore in their film Bedazzled in 1967 and playing a secret agent in the sexy spy spoof Fathom that same year.

Her curves and beauty captured pop culture attention, with 'Playboy'

crowning her the 'most desired woman' of the 1970s, despite never being completely naked in the magazine.

In 2013, Welch graced the No. 2 spot on Men's Health's 'Hottest Women of All Time' list. In the film The Shawshank Redemption, a poster of Welch covers an escape tunnel—the last of three that character Andy Dufresne (Tim Robbins)

used after Rita Hayworth and Marilyn Monroe. In addition to acting. Welch was a singer and dancer. She surprised many critics—and won positive reviews - when she starred in the 1981 musical Woman of the Year on Broadway, replacing a vacationing Lauren Bacall.

Welch however felt that she was much more than just a sex symbol.

"The irony of it all is that even though people thought of me as a sex symbol, in reality I was a single mother of two small children!" she wrote in her autobiography, 'Raquel: Beyond the Cleavage'.

Welch was born Jo-Raquel Tejada in Chicago and raised in La Jolla, California. (The Jo in her name was from her mother, Josephine). Welch was a divorced mother when she met ex-actor turned press agent, Patrick Curtis who later became her second husband and shaped her career.

Though she would appear in exploitative films, Welch also surprised many in the industry with fine performances, including in Richard Lester's The Three Musketeers, which earned her a 'Golden Globe', and opposite James Coco in Wild Party. She was also nominated for a 'Globe' in 1988 for the TV movie Right to Die. She played herself and mocked divas in an episode of Seinfeld, memorably attacking Elaine and rattling Kramer.



Centre allocates ₹937crore to boost road infra in state

New Delhi, Feb 16: The Union Ministry of Road Transport and Highways has allocated ₹937 crore to Odisha for widening and construction of several National Highways crossing the state for the financial year 2023-24.

According to sources, the min istrv has allocated ₹835 crore for several ongoing projects, costing above ₹5 crore, in the state, while ₹2 crore was allocated for projects costing less than ₹5 crore. The ministry has also allocated ₹100 crore for new projects in the state.

The budgetary allocation of the ministry to Odisha for FY 2023-24 is more than the expenditure incurred during FY 2022-23. In 2022-23, the total expenditure in Odisha was ₹857 crore.

The ministry has allocated ₹80 crore for widening and strengthening of Kandarpur-Balikuda section of NH-55. ₹70 crore has been allocated for widening and strengthening of Kuakhia-Mangalpur section of NH-20. For the



construction of Jharsuguda bypass including land acquisition on NH-49, the ministry has allocated ₹40 crore. Allocation of ₹60 crore was made for construction of bypass on NH-59 near Berhampur town including 4-lane RoB. The ministry also made allocation for construction of roads from Bargarh to Barpali and Barpali to Bolangir

Further, ₹10 crore has been allocated for widening of NH-57 from Nayagarh to Khurda and ₹40 crore for widening of Bhanjanagar to Aska road of NH-157. The MoRTH further allocated ₹30 crore for construction of railway overbridge at

■ The MoRTH has allocated ₹835 crore for several ongoing projects, costing above ₹5 crore, in the state, while ₹2 crore was allocated for projects costing less than ₹5 crore

The ministry has also allocated ₹100 crore for new projects in

Matiapada on Puri-Konark Road and ₹35 crore for construction of bypass to Nayagarh town.

Significantly, the budgetary allocation for the ministry for the year 2023-24 is ₹2.70 lakh crore.

The ministry has allocated ₹330 crore for road safety for the year 2023-24, a 20 per cent rise as compared to the revised estimates for 2022-23. Ex-banker gets 2-yr RI for ₹1.15cr fraud

Bhubaneswar, Feb 16: A local court in Dhenkanal has awarded two years of rigorous imprisonment (RI) to a former banker after convicting him for misappropriation of around ₹1.15 crore belonging to Angul United Central Cooperative Bank in Kamakshya Nagar around seven years ago.

The Kamakshya Nagar SDJM Court has also slapped a penalty of ₹13,000 on the convict identified as Sanjay Kumar Satapathy.

According to the prosecution, Sanjay, a banking assistant at Angul United Central Cooperative Bank's Kamakshya Nagar branch, in criminal conspiracy with three other staffers of the institution misappropriated around ₹1,15,16,300 in 2015-16. "They siphoned of ₹1,15,16,300 by crediting the amount to 65 accounts from different heads of general ledger account through 187 transactions. Subsequently, they withdrew the amount by using the user ID of the account holders. the prosecution said, quoting the EOW that arrested him in 2019.



ITIs in Odisha failing to prepare trainees for jobs

New Delhi, Feb 16: The objective of setting up Industrial Training Institutes (ITIs) seems to be failing down as just two out of 3137 trainees passed in the year 2020 in Odisha got placement, reveals a study by

The objective of setting up ITIs was to reduce unemployment amongst the educated youth by equipping them with the required skills, education, and discipline. However, Transforming Industrial Training Institute, a study by the NITI Aayog, stated that only two trainees, both from government Industrial Training Institute, Chatrapur, out of 3137 trainees passed in 2020 in Odisha got placement. There were 513 affiliated ITIs in Odisha, with only 10.35 percent being government run. The study revealed that out of 6220 trainees admitted in 2020, only 60



were few takers of the seats in the ITIs in Odisha in 2021. There were 106,270 seats available of which 53.97 percent of them were filled, and out of this, only 13.52 percent of the trainees were females.

Significantly, the government has set up ITIs with the objective to ensure a steady flow of skilled personnel to the public and private sectors. ITIs in India are responsible for delivering vocational courses through the Craftsman Training Scheme (CTS).

These courses are based on a semester pattern and cover a large number of economic sectors leading to a lifelong career. The training courses in ITIs are supposed to impart basic skills and knowledge in the trades to prepare trainees for employment as semiskilled/skilled workers or selfemployment.

Bhubaneswar, Feb 16: Sumant Sahu's happiness knew no bounds when his mother Snehalata, 52, had a successful bone marrow transplantation at SUM Hospital here under Biju Swasthya Kalyan Yojana (BSKY).

According to sources, Snehalata, a resident of Naubanka village in Jajpur district, was diagnosed with blood cancer a few years back.

'My mother's blood cancer came as a bolt from the blue for us at a time when we were already struggling to make ends meet. My father ran a small eatery at Singhipur market. And it was our only source of income," Sumant recounts.

Sumant's world came crashing down when his father died in 2021. "After my father's demise, things were on me. I was absolutely blank. I managed taking my mother to SUM Hospital in Bhubaneswar in August 2022 with a paltry amount



borrowed from one of my friends,"

Upon enquiring at the hospital's reception, Sumant was directed to the BSKY desk. "The Swasthya Karmis at the desk filled the form and my mother was admitted to the hospital. And that's all. After that I didn't spend a penny." Sumant

After a few chemotherapy ses sions supervised by SUM Hospital Haematology department professor Priyanka Samal, Snehalata underwent bone marrow transplantation in September last year.

After a few days under observation, she was discharged.

Sumant further thanked Chief Minister Naveen Patnaik for his timely intervention during the treatment when the BSKY card limit exhausted.

"During the treatment, our BSKY (family) card limit exhausted as the expenses exceeded ₹5 lakh. We were tensed. However, at this stage, CM Naveen Patnaik intervened and sanctioned additional money under BSKY," he said.

"With the timely assistance of the CM, and proper medical care under BSKY, my mother got a new lease of life. My family is indebted to the CM, doctors and nurses for all that they did to save my mother,"

HC expresses concern over vacancies in child rights body

Cuttack, Feb 16: Expressing concern over the vacancies in the Odisha State Commission for Protection of Child Rights (OSCPCR), the Orissa High Court Thursday said not filling those defeats the very purpose for which it was established.

Hearing a writ petition over the issue, a division bench headed by Chief Justice S Muralidhar asked the government counsel to take instructions from the state government in response to it. The court fixed March 9 as the next date for the hearing.

The petition stated the

Commissions for Protection of Child Rights Act, 2005 mandates establishing the commission with a chairman and six other members. "Unfortunately the commission was functioning with just the chairman since August last year," alleged advocate Prabir Kumar

Das, who filed the petition. Das said that it was a matter of grave public concern that the state government failed to fill up the vacancies, which should have been done within 180 days of occurrence of such vacancies. As many as 2.372 cases relating to child rights were pending before the commission as of December 2022, he said.

Understanding 'tipping point' of neurodegenerative diseases

cientists have developed a new method which was employed to understand how tau protein changes from a benign protein, essential for normal function in human brains, into toxic neurofibrillary tangles.

Such toxic assemblies of tau proteins are a signature of Alzheimer's and other neurodegenerative diseases, and so, this method could allow for its use in understanding the starting point of these diseases, the sci-

entists said. In this study, the scientists at University of California (UC) Santa Barbara, US, used this method with the core portion, a

peptide, of tau. They were able to observe and analyse a critical "tipping point" between normal, reversible folding and assembly, and the irreversible, pathological assembly that underlies tauopathic, neurodegenerative diseases, the study said.

clear on how the "tipping point" happens.

This new technique gave the researchers at UC Santa Barbara the ability to control and follow in real time the process by which this critical "tipping point" happens, the study said.

The study appears in the Journal

of Biological Chemistry. According to the study, the technique employed a novel use of low voltage electricity as a surrogate for the natural signals that trigger the protein to fold and assemble, both for its normal function in the brain and in the runaway process leading to often fatal disease.

Employing less than a volt of electrical potential to mimic hyperphosphorvlation, the diseasepromoting signal, the scientists triggered and finely tuned the taupeptide's folding in their lab experiments, the study said.

They used spectroscopic meth-



ods to reveal details of the folding and progressive assembly to form amyloid-like filaments, the

study said. "This method provides scientists a new means to trigger and simultaneously observe the dynamic changes in the protein as it transitions from good to bad,"

said Daniel E. Morse, senior author of the study. "The method should be widely useful to identify molecules and conditions that direct different trajectories of assembly in a number of different but related amyloid diseases," stated Eloise Masqulier,

nary team of students, researchers and faculty from molecular biology, chemistry and engineering.

Unlike other modes of examining protein folding and assembly, such as x-ray diffraction or cryo-electron microscopy that provide static snapshots of the processes as they occur in time. the new electrochemical method allowed users to continuously witness and analyse details of the progressive, dynamical folding and assembly as they occurred

in real time, permitting the first direct observations of the critical earliest steps in these processes,

the study said. Also, the study said, unlike most techniques previously used for studies of tau and its core peptide, because the electrical trigger closely mimics the natural triggering signal, the method permits direct observation of these processes without the need for additional "helper" molecules.

The authors reported that the technology could also be used as a tool to more rapidly test and identify drugs and antibodies potentially useful for prevention or treatment of Alzheimer's and other amvloid diseases

"Because we can turn on and fine-tune the process at will, we can use this system to see what molecules could interdict or block specific stages of folding and assembly." Morse said.

Jaleswar, Feb 16: With summer season yet to start, areas under Jaleswar block in Balasore district are experiencing an alarming drop in ground water level.

Absence of rainfall for last five months and excessive use of water for paddy cultivation during the rabi season are attributed as the reasons behind the sharp drop in ground water level.

Ground water is depleting day by day and environmentalists fear that the situation might go out of hand if rain does not occur soon in the coming days. Such has been the situation that ground water can be found as deep as 60 feet down the surface.

The reason behind depletion in ground water level is attributed to functioning of around 300 government managed lift irrigation (LI) points and 2,000 shallows. It is apprehended that the overuse of ground water may lead to saline water ingress in the coastal tracts of the district.

Sources said that the areas under Jaleswar block, which is on the fringes of West Bengal, have not experienced any rainfall since October

The fall in ground water level is so apparent that water level has fallen drastically in all the water bodies including canals, ponds, streams, creeks and rivers even before the start of summer. The drop in the ground water level is also impacting the surface water level in the area.

Dropping ground water level n this area of Kendrapara district has emerged as a huge problem for the district's residents. The sharp decline in ground water level in the last four years has made life difficult for the locals as the water level has gone down to 70 to 100 feet underground at various spots. According to the report, more than 250 tube wells are inoperable in the area. People are worried that they may face a shortage in drinking water in the upcoming summer. People are now demanding for sensitisation programmes regarding the issue while also expecting the government to bring some remedy. Describing the current situation, assistant engineer Sudam Sahoo says that due to the drop in ground water level, now we have to dig up to 70 to 100 feet, while in 2002 water level

rainfall within a fortnight. People have demanded irrigation facilities to their farmlands and drinking water facilities to their households. Some farmers have urged the administration to draw water from the river gorge and supply it through pipelines to their farmlands.

Eminent environmentalist cum scientist Dillip Panda said there is need for recharging ground water for which construction of large ponds and tanks is recommended in various places under the block.

RWSS assistant engineer Pradyumna Das confirmed the development stating that the ground water level has depleted to 20 or 24 metre depth in the block. The officials are visiting various areas on a daily basis and repairing the defunct LI points.

Residents of some riparian villages said that the problem can be resolved if water could be lifted from the Subarnarekha river either from Rajghat, Panchughanta or Kuanrpur area and supplied to the residents after proper treatment.

3 absconding forest officials held for abetting eyewitness' suicide

Baripada, Feb 16: Jashipur police Thursday nabbed three forest officials for their alleged involvement in the poaching of a tusker and burning of its carcass to destroy evidence in Similipal Tiger Reserve of Mayurbhanj district and the subsequent death of Turam Purty, the lone eyewitness in the case.

The accused forest officials forester Shiba Shankar Samal and forest guards Chandrabhanu Behera and Binod Kumar Das of

Jenabil forest range under South division of Similipal Tiger Reserve -- were produced in the court and remanded to judicial custody in Karaniia.

Notably, a tusker was killed in Gurundia forest section under Jenabil forest range of South forest division of Similipal Tiger Reserve, December 7. The three forest officials had tried to destroy evidence by setting the carcass on fire. They had also dumped the remains of the carcass in a river nearby to cover up the matter. Locals had informed the senior

forest officials that the three accused also abetted the suicide of Turam Purty, a junior level employee at Similipal Tiger Reserve as they feared that the matter might get disclosed. Purty was the only eyewitness of the crime committed by the forest officials. Fearing action, the three allegedly abused Purty and threatened to put him in jail. Panicked, Purty had consumed poison to end life.

He was rushed to Karanjia government hospital and later shifted to SCB Medical College and Hospital in Cuttack where he succumbed to death during treatment, December 16 last year. His wife Chilam Purty alleged that the three officials had forced her husband to consume poison.

Mahakalapara, Feb 16: Horseshoe crabs, a rare marine creature, have started swimming ashore from deep sea to Gahirmatha marine sanctuary in Kendrapara district with the start of their breeding season.

The horseshoe crabs having a hard exoskeleton and 10 legs find the Pacific coast and the Odisha coast of Bay of Bengal most habitable. So they migrate to these destinations in large hordes for mating and nesting.

The mating season of horseshoe crabs starts from January and concludes by March. The state is home to two of four varieties of the species that are found globally.

However, before they can reach the coast for mating, these crabs get entangled in the fishing nets of fishermen in trawlers and die prematurely.

These crabs play an important role in maintaining bio-diversity and the marine environment for which they have been included as 'Living Fossils' in the fourth sched-

A local intelligentsia Subhash Swain said, "Nearly three decades back, the horseshoe crabs used to be found in large numbers across the coast but now their presence is limited to only some smaller pockets in Kendrapara district.

Their population is rapidly declining after the 1971, 1982 cyclonic storms and 1999 Super Cyclone, he said. Climate change and waste discharged into the sea by the industrial plants have also impacted their population. He said there should be a joint effort by the government, private establishments and forest departments to protect

these rare species. When contacted, Gahirmatha forest ranger Manas Kumar Das said that the blood of these crabs is highly priced in the international market as it has medicinal value. They can be seen in large numbers in Gahirmatha for which efforts are being made to protect

Netanyahu is using

fter five consecutive elections in three years, four of which ended in political stalemate, Israeli Prime Minister Binyamin Netanyahu managed to form a coalition of right-wing and ultra-Orthodox parties late last year. But instead of restoring stability to Israel's increasingly dysfunctional political system, Netanyahu is using his sixth term in office to promote a blitz of constitutional reforms that, if enacted, would turn Israel into an autocracy.

A few election cycles ago, in 2020, the Israeli Supreme Court unanimously ruled that Netanyahu is not barred from serving as prime minister as long as he refrains from using that position to influence the outcome of his ongoing corruption trial. But Netanyahu, who has continued to attack the prosecutors in his trial for allegedly conspiring to keep him out of office, did not allow this constraint to stop him from proposing a judi-

Days after forming his new government, Minister of Justice Yariv Levin announced a comprehensive plan to reshape Israel's legal system. Levin argued that the proposed reform would strengthen Israeli democracy and restore balance between the judiciary and the executive and legislative branches. In fact, the proposal is designed to strip the judiciary of its ability to check the executive branch.

The government's plan includes several key provisions, including one that would enable the government to appoint judges, including Supreme Court justices, unilaterally. Another provision would allow the 120-seat Knesset (parliament) to override Supreme Court decisions by a simple majority.

Israel relies almost entirely on a set of Basic Laws, rather than a formal constitution, to define and protect civil rights. While the Supreme Court has the power to review and strike down legislation that contradicts the Basic Laws, it has done so only 22 times in the last three decades. For comparison, the US Supreme Court has struck down more than a hundred laws over the same period. Under Levin's proposed plan, the Court would be able to make such a decision only if at least 12 of the 15 justices agreed. The reform would also bar the Court from reviewing amendments to Basic Laws, enabling the Knesset to shield legislation from judicial scrutiny.

By stripping the courts of their authority to overrule decisions by the executive branch, the reform undermines the separation of powers. The reform further weakens the independence of the judiciary by enabling cabinet ministers to appoint and terminate legal advisers to the government. Today, government legal advisers are civil servants appointed by a competitive, apolitical process. Their advice is binding, making them effective gatekeepers - or not - against executive corruption and capriciousness

The Knesset, in which Netanyahu's coalition holds 64 seats, does not restrain the gov-

ernment but rather rubber-stamps its decisions. The fact that Israel's legislature is not divided into two chambers like the US Congress or the Bundestag means that another crucial balancing mechanism is absent. Moreover, because Israel is a small country of approximately ten million people, it does not have a federal structure like the United States, Germany, or Canada, where subnational authorities balance the power of the central government. Another constraint absent in Israel is a presidential veto on legislation.

Many of the proposals included in Netanyahu's judicial reform plan were developed by former fellows at Kohelet Policy Forum, an ultra-neoliberal think tank financed primarily by right-wing Jewish billionaires

Their influence is so pronounced that some political opponents have taken to calling Netanvahu' s coalition the "Kohelet governme

But the true model for Netanyahu's judicial revolution is Viktor Orbán's Hungary. Over the past decade, the Hungarian prime minister has overseen a series of constitutional reforms that consolidated the control of Orbán's Fidesz party over the media, the electoral system, and the courts.

Overall, however, Israel's prospects are far bleaker than Hungary's, because Hungarian authorities are subject to external constraints. The European Union can sanction Hungary, and the freedom of movement of people and businesses within the bloc means that Orbán must govern in a way that prevents investors and workers from fleeing. Netanyahu is not bound by any such limits.

He does, however, face significant resistance from another source: the Israeli public. Over the past few weeks, tens of thousands of Israelis have protested in Tel Aviv. Jerusalem, and other cities.

These weekly demonstrations have been accompanied by smaller protests by lawyers, academics, health professionals, businesspeople, and artists. On February 13, the day the Knesset formally began considering the legislation, protesters announced a general strike and 100,000 people rallied

But the protests have had little influence on Netanyahu, who maintains a strong hold over Israeli media by constantly threatening to restructure the industry. His communications minister has recently announced a plan to shut down Kan, Israel's public broadcaster, whose critical news coverage has angered Netanyahu and his supporters (the plan has since been temporarily shelved so that the government can focus on getting the judicial reform through the Knesset).

There is only one area in which Netanyahu does not seem to be in complete control: the economy. In January, 300 prominent Israeli economists, including some of Netanyahu's former advisers, signed an open letter warning that the reforms would severely impede Israel's long-term economic prospects. They were later joined by 56 well-known international economists, including 11 Nobel laureates. But it was the prospect of venture capital funds and startup companies moving their bank accounts out of Israel that seems to have gotten the attention of Netanyahu and his supporters. Israel's main growth drivers, high-tech industry and finance, are highly sensitive to fickle foreign capital.

Netanyahu seems to have failed to consider the economic repercussions of his constitutional barrage. The choice is simple: Netanyahu's personal interests, including in upending his corruption trial, or those of the public. At the moment, his own interests seem set to prevail.

dam Smith is known as the founding father of modern economics. He is most well-known for his magnum onus 'The Wealth of Nations' which is said to have laid the foundations of today's free market economics. The famous Nobel Laureate of the Chicago School of Business, Milton Friedman, is famously said to have interpreted Adam Smith thus - "In the economic market, people who intend to serve only their private interests are led by an invisible hand to serve public interests that it was no part of their intention to promote.' Unfortunately, as it is becoming increasingly clear, the invisible hand of the 'free market' is failing miserably when the market players work in collusion with the ruling class who are entrusted to regulate the playing conditions! For many Adam Smith scholars, the great man whose tri-centenary is being celebrated this year would be quite shocked to see all that is being passed in his name!

Adani Enterprises recently lost more than \$100 billion in market capital after a report was released by a US-based short-seller, Hindenburg Research. Gautam Adani, the founder and the world's third richest man until over a week ago, lost around 50% of his wealth which was around \$128 billion. The resultant market turmoil could throw the entire country and its economy into chaos by shaking the confidence of investors - both local and foreign. It even resulted in the group cancelling its ongoing follow-on public offer of its shares worth \$2.5 billion.

Adani is a case study of how a business can defy every tenet of environmental best practices. They include environmental damage from its fossil fuel business - especially coal-fired power plants. Their projects have caused social strife at many of its industrial sites due to opposition of locals -- the Carmichael coal mining and port projects in Australia. Its corporate misgovernance allegedly includes a family-controlled business empire that comprises a large number of shell companies based out of tax heavens used for market manipulation to artificially inflate the stock prices of the pub-

licly listed parent companies. Many of these and other serious allegations that have been levelled over the years were brought to focus with supporting evidence by Hindenberg, a little-known short-seller which has exposed the dark underbelly of a mighty corporate house which had inexplicably grown in an exponential manner since around 2014 with strong political patronage from the new ruling dispensation, the Narendra Modi-led government

in New Delhi. The Adani saga is by no means an exception to the rule - although it is by far a most egregious example. Not long ago, an equally egregious corruption scandal of FTX. A murky episode of more recent origin in the tech sector was exposed by a speculative article on the purported issues of corruption. The illicit relationship between the crypto exchange and its sister company Alemeda - a research & trading house, brought down a fast-growing business taking billions of dollars' worth of investors' wealth with it and leaving the disgraced Sam Bankman Fried fighting to avoid arrest. Cases such as Adani and FTX shake the confidence of the public in free market economics at large and make a great case for increasing oversight and regulatory frameworks.

Adam Smith, while being more widely known as an economist, was for most of his life a professor of Moral Philosophy at the University of Glasgow. Adam Smith was born in a small port town called Kirkcaldy on the east coast of Scotland, not far from where he taught and wrote The Wealth of Nations and the lesser known, but for many, more important The Theory of Moral Sentiments. According to Smith, our moral sense helps us navigate the relationships between ourselves and others. It alerts us to dangers, rewards us for socially desirable behaviour and enforces social conventions regulating human behaviour. Ultimately, it leads to better outcomes for society as a whole. When we were children, most of us learned what was right and wrong by instinct. We learned these morals through trial and error: sometimes, we got rewards for good behaviour and punishments for bad behaviour. This internalised moral sense helped us decide the best way to behave in social situations. Our moral sense keeps us safe and promotes societal cohesion. Empathy is our natural response to the suffering of others-including fellow humans - which drives us to help them overcome their difficulties when necessary.

Interestingly around the mideighteenth century, when Adam Smith was writing his books. The British East India Company had just established its rule over the British Indian colony and controlled 50% of global trade. Around this time, millions died in the Great Bengal Famine, and Smith

was agitated by the reports of the dreadful event. Writing in The Wealth of Nations, Smith identified the lack of regulations on the company as the major reason. In his critique, he says, "part of the problem here is it can't be regulated because it's so big, and it has all these independent relationships with Indian government officials that should be part of British state diplomacy. And it has this internal conflict of interest between its commercial and political imperatives. This will lead to state capture where the British government ends up doing bad things for Britain to help the company."

It shows his concern about how the government in the colonies will corrupt the British government and society. After the famine, the British government got more involved in the oversight of the company. By the 19th century, the East India Company's trading monopolies had been curtailed. After the Sepoy Mutiny of 1857, the company was nationalised, and its activities wound down. As fate would have it, in 2005, the Indian businessman Sanjiv Mehta bought the rights to the name, and he turned it into a consumer brand focused on luxury foods!

Economic historian Robert Heilbroner once wrote: "No economist's name is more frequently invoked than that of Adam Smith, and no economist's works are less frequently read." Smith remains relevant even today because his two seminal works address some of the fundamental questions we have tried to answer and continue to ponder, e.g., What are the origins of morality? Are we selfish, or are we benevolent? How do you understand the forces of national wealth? What makes a nation happy and productive? While comparing Adam Smith's take on the then East India Company's monopoly business empire over the Indian colony and the unfolding Adani empire saga, it is clear that the great man would have been aghast at what has come to pass in the name of the free market economy

he only example of a water sharing agreement between two arch rivals that defies the 'water war' hypothesis is being put to modification by its own signatory member. When India issued a notice for modification of the Indus Water Treaty (IWT) to Pakistan on 25 January, Pakistan observers incorrectly termed it India's weaponisation of water. What has prompted India to modify the treaty, which has survived full scale wars, proxy wars, Parliament attack, surgical strikes, and above and beyond hostile posture of 62 years between two belligerent neighbours? From the outset, let's be clear that

India is not asking for unilateral scrapping of the treaty as erroneously put forward. Understandably since Parliament attack in 2001 as a knee jerk reaction to any hostile activities of Pakistan, the allies and members of the successive NDA governments (I, II & III) usually remarked on the abrogation of the IWT. The modifications and or amendments to the IWT are absolutely plausible only by the consent of both parties to the treaty. The role of the World Bank is not as a party but as a guarantor or facilitator or independent arbitrator of the IWT.

Once a former foreign secretary of India wrote that the IWT was a triumph, but a triumph of the lesser evil. The 1960 IWT provides India unrestricted access to use of waters in eastern rivers - Sutlei, Beas, Rayi, and their tributaries. India is also allowed to use waters of western rivers - Indus, Jhelum, Chenab, and their tributaries without consuming them and in a way that doesn't obstruct the flow of rivers to Pakistan.

In fact, the Parliament Standing Committee on Water Resources in 2021 in its Report - Flood Management and International Treaties - has recommended that the IWT must be reconsulted to address new realities in the Indus basin. In 2016, Prime Minister Narendra Modi also formed an inter-ministerial panel for reviewing the IWT under public pressure. When the treaty was negotiated for almost 9 years, the focus was on allocation of rivers and their waters. The quantity supersedes the quality. The Committee has recommended to the government of India that there is a need to re-negotiate the treaty so as to establish some kind of institutional structure or legislative framework to address the impact of

climate change on water availability in the Indus basin and other challenges. As written in the treaty, the IWT can be reviewed from time to time with consent from both parties. Since 2005, India's unilateral ini-

tiatives of run-of-the river hydel projects - 900 MW Baglihar hydro power on Chenab, 330 MW Kishenganga hydropower on Jhelum and 850 MW Ratle hydropower on Chenab, which are compliant with the IWT as claimed by India, have been delayed, stalled or referred to as external intervention by Pakistan. Under the IWT, the Indus Permanent Indus Commission (PIC) that meets annually in alternate countries' venues has been unable to resolve bilaterally most technical aspects of the disagreements. India perceives the existing mechanism as the PIC has either ineffective or failed to address the bilateral concerns.

After removal of Article 370, the credibility of leadership in the Modi government to deliver in Kashmir is being closely watched. The government argues that most of these hydel projects if completed in time would boost holistic development of Kashmir valley. While Modi wants the developmental

projects to be completed as soon as possible, the provisions of IWT have derailed the projects. The government sees that the treaty restricts its manoeuvre capacity over construction of dams. Getting rid of such provisions in IWT would be beneficial to the government. Also, many in the government aim to get away with this last harbinger of cooperative functionality agreement with Pakistan.

There is a loss of trust when it comes to water quantity flowing in rivers from India to Pakistan. Pakistan considers dam building by India in upper stretches would cause flooding, droughts, water scarcity, and disruption of energy supplies. This is precisely perceived by India against Chinese dam building in Brahmaputra. While India considers that both countries have the potential to resolve the technical aspects bilaterally, Pakistan, on the other hand, being lower riparian and due to its high dependence on Indus River System as its only lifeline, conceives that it may not protect its national interest if negotiating alone with India.

Healing of ozone layer

Sir, It is surprising news that the ozone recovery is on track, according to the quadrennial assessment study published recently by the Scientific Assessment Panel to the Montreal Protocol on Ozone Depleting Substances. UN scientists and environmentalists have lauded efforts to close the ozone hole as one of humanity's greatest ecological triumphs for decades. The recovery of the ozone layer serves as evidence of our ability to bring about significant change. The majority of people thought it was impossible, so it is a remarkable achievement. The world is now protected from the potentially disastrous effects of ultraviolet radiation thanks to the ozone layer, which is currently recovering. The ozone layer is also necessary for the existence of humans and other living things because it traps enough solar energy to act as an atmospheric blanket. A panel of experts supported by the UN ruled that the ozone layer is on track to regenerate within four decades thanks to the global phaseout of ozone-depleting substances. The effort to close the ozone hole, which was made possible by the 1987 Montreal Protocol, which forbade a set of chemicals frequently found in refrigerants and aerosols, has been hailed by scientists and environmentalists as one of humanity's greatest ecological triumphs. If present policies are followed, it is anticipated that the ozone layer will return to 1980 levels (before the ozone hole appeared) by 2066 over the Antarctic, 2045 over the Arctic, and 2040 for the rest of the planet. The ozone layer is also responsible for the present climatic change that we are experiencing, including the current heatwave and floods that are a result of global warming. We continue to worry about the difficult process of regenerating the ozone layer. New Delhi, Feb 16: The Congress Thursday demanded a probe into the the alleged use of an Israeli team of contractors to interfere in Indian elections and asked the government to break its silence on the matter.

At a press conference here, Congress spokespersons Pawan Khera and Supriya Shrinate drew similarities between "Team Jorge", the Israeli team of contractors, and the IT cell of the ruling Bharativa Janata Party (BJP) in spreading misinformation and "fake news" in order to influence the country's electoral process.

They also alleged that the data of Indians is being compromised. 'Team Jorge", which is feared to have interfered with more than 30 elections around the world, has been linked with a software to operate fake social media campaigns across countries, including India, a report said Wednesday.

'We have seen a pattern in India. We want the government to break its silence and say what has been its contribution in saving democracy in the country." Shrinate said. asserting that it is the Centre's job to give a reply when an international agency has made out such a serious allegation.

"This impacts India's electoral process directly and there should be a probe," she said. "If the government is not doing anything on this, it means it is seeking help to interfere in the country's democracy and elections. The data of Indians is being compromised by handing it over to a foreign firm," the Congress's social media department head alleged

Shrinate said this is not the first time that allegations of data theft have been levelled against the Narendra Modi government. "One of the serious charges that this government faces is data theft and

tamper with the electoral process. You saw what happened in Karnataka. This government is known to play with big data to its advantage. This is nothing but a murder of democracy," she alleged.

Shrinate also accused the BJP's IT cell of often indulging in such activities by "militarising or weaponising" rumours by spreading those further and said this is leading to bad results in the society and hence, questions will be asked. Khera alleged that India's democracy is being "hijacked" by the country's ruling party.

"An Israeli agency's help is being taken to influence the country's democracy. Sitting in India, they are conspiring against India's democracy along with other countries, he said.

Khera also wondered if the BJP used a network of foreign hackers to interfere in Indian elections and recalled that there were allegations of using Cambridge Analytica (CA) and then Pegasus by the Modi government to meddle in the country's political system by spreading misinformation on dig-


"Is there a link between Post Card News and Team Jorge -- a team of Israeli contractors who claim to have manipulated more than 30 elections around the world using hacking, sabotage and automated disinformation on social media?" he asked.

'The pattern of disinformation and fake news campaigns being adopted by the Israelis is mirrored by the ruling BJP very distinctly," the Congress leader alleged, adding that an innocuous social media account puts out "disinformation", which is amplified by the "right-wing ecosystem", including BJP office-bearers, MPs, MLAs and ministers.

"Is it not a fact that the BJP used fake news to repeatedly target the Bharat Jodo Yatra in the last fourfive months and was always caught?

'Will the Modi government investigate the latest scandal that has hit the Indian political spectrum, involving yet again foreign contractors indulging in sophisticated hacking, sabotage and automated disinformation on social media?" he asked

In an international investigation carried by a group of journalists, including those from "The Guardian" newspaper in the United Kingdom, the so-called "Team Jorge" unit has been linked with allegedly offering a sophisticated software package named Advanced Impact Media Solutions (AIMS) to its commercial clients as one of its key services.

New Delhi, Feb 16: Every person is entitled to live with dignity and honour and no one is expected to live with constant abuse being hurled upon him, the Delhi High Court has held while upholding the divorce decree granted to a man on the ground of cruelty by his estranged wife.

The high court dismissed an appeal filed by the woman challenging the family court's order granting divorce and said there was no infirmity in the findings of the trial court that the man has been treated with cruelty.

'We are also satisfied that the

cruelty that has been proved on record is sufficient and constitutes cruelty as required under Section 13(1)(i-a) of the Hindu Marriage Act. Consequently, we find no infirmity in the judgment allowing the petition and granting divorce on the ground of cruelty. We, accordingly, find no merit in the appeal. The appeal is consequently, dismissed," a bench of Justices Sanjeev Sachdeva and Vikas Mahajan said.

The high court said the conduct of the wife which has been proved on record is of such quality, magnitude and impact as would have caused mental agony, pain, anger and suffering to the husband on a regular and continuous basis and thus

VisionSpring-India, Vision Institute, Sightsavers-India and Mission for Vision hosted the second annual Vision and Road Safety (VARS 2.0) conference during which the issue was discussed, according to a press release.

More than 100 experts from the eye health and the road safety sectors also deliberated on ways to scale-up access to vision correction for drivers and allied transportation workers to reduce risk of vehicular crashes and associated injuries and deaths.

Through their combined efforts, the co-hosts have screened the vision of 13.55 lakh commercial vehicle drivers, helpers, cleaners, mechanics and other transport workers in the country, according to the release

The participants discussed wavs to build vision screenings into the national road safety plan and the unique challenges of providing eye health services to this floating population

in a sustainable manner, it said. In July 2022, the UN General Assembly adopted the 2020 resolution for 'Improving global road safety' and proclaimed 2021-2030 the decade of action for road safety. with the target of preventing at least 50 per cent of road traffic

Delhi govt set to relocate air quality monitoring stations

New Delhi, Feb 16: The Delhi government is considering relocating some of its continuous ambient air quality monitoring stations (CAAQMS) to be able to provide a "real picture" of the air pollution situation in the capital, officials have said.

A total of 50 air quality monitoring stations -- 10 manual and 40 real-time -- cover Delhi, which has an area of 1,484 sq km. The Delhi Pollution Control Committee operates 24 monitoring stations. Officials aware of the develop-

ment said some of the CAAQMS are located in areas having heavy traffic flow, right next to a bus stand or a major construction site which means they continuously report higher readings.

"This doesn't show the real picture. This is not the case in the entire city. So, we will try and relocate some of the CAAQMS to neutral loA total of 50 air quality monitoring stations -- 10 manual and 40 real-time -- cover Delhi, which has an area of 1.484 sq km

cations. A proper study will be done to identify new locations," an official of the environment department said. Citing the example of the Anand Vihar CAAQMS, the official said the monitoring stations is located right in the middle of a Regional Rapid Transit System (RRTS) project.

Some large areas such as Najafgarh have got just one CAAQMS and are under- represented. After this exercise, all areas, be it industrial, residential or agricultural, will have proper representation in Delhi's air quality, the official said. He clarified that no new stations will be added

Jammu, Feb 16: A Jammu-based community radio station, 'Radio Sharda', has become the "voice of Kashmiri Pandits" as community members from across the globe tune into it to connect to their roots and culture.

We are connecting Kashmiri Pandits living in India and 108 other countries through this community radio station. It is a household name in the community because of its programmes on Kashmiri culture, history, music, bhajans and issues confronting the community," Founder Director of Radio Sharda Ramesh Hangloo said.



Kashmiri Pandits who were forced to leave their homes after the spread of terrorism in the valley in 1990 have found a voice through the radio as it speaks not just about their culture but about their issues too, he said.

The slogan of Radio Sharda 90.4 FM is 'Booziv Te Khosh Rooziv' (Listen and Be Happy), he said."Those who get uprooted need to be connected to their roots and our service helps them with that,'

Radio Sharda began operations



in December 2011 to connect the Kashmiri Pandit community to its roots and preserve, promote and propagate culture, music, and knowledge about Kashmir among the next generation.

"I bought a radio especially to hear Radio Sharda. It gives me peace of mind. I switch on Radio Sharda at 7 am every day to hear Kashmiri bhajans and other programmes afterwards," an 82-year-old listener, Avtar Krishen Bhat said.

"It brings old memories of Kashmir back to my mind and

make me feel that I am still living in my home in the valley," Avtar said. Like him, the young Kashmiri Pandits listen to community radio's Kashmiri songs.

"I love its foundation slogan -Booziv Te Khosh Rooziv. I tune into the radio station on my mobile and cherish Kashmiri songs,' a 19-year Kashmiri Pandit student Shivansh Raina said. The radio also acts as an information dissemination centre. The Kashmiri Pandits who stay away from home had contacted the radio station to get information about their kin in the valley after the abrogation of provisions of Article 370 and, during the Kashmir floods

in 2014, Hangloo said. The radio station which bagged two national awards for Community Radio in 2018 and 2019 has never stopped transmission since the beginning of its operation. The radio will be airing a 'live herath' pooja on the occasion of Kashmiri Pandits' biggest festival, Maha Shivratri known as 'Herath' in Kashmir. It will be celebrated on February 17-18.

While the significance of the festival changes from place to place, for Kashmiri Hindus, it is the day of the divine wedding of Lord Shiva with Mata Parvati called 'Harratri'.



New Delhi, Feb 16: The Income Tax department's marathon "surveys" at BBC's offices ended Thursday, after clocking over 58 hours in total, as officials prepared an inventory of financial data from select staffers and collected digital and paper data.

The operation that began at the British Broadcasting Corporation (BBC) offices in Delhi and Mumbai around 11:30 am Tuesday has ended in Mumbai and will be wound up at Delhi by tonight, sources said late on Thursday.

Tax authorities have made an inventory of the available stock, recorded the statement of some staffers and have impounded some documents as part of the survey action that continued for three days clocking about 57-58 hours, officials



fresh PIL was filed Thursday in the Supreme Court challenging the ACentre's decision to block the BBC documentary. The top court is already seized of two pleas filed by veteran journalist N Ram, Trinamool Congress MP Mahua Moitra, activist lawyer Prashant Bhushan and lawyer M L Sharma on the issue. On February 3, a bench comprising justices Sanjiv Khanna and M M Sundresh had taken note of the two pleas and directed the central government to produce original records related to its decision to block the documentary on the riots. The matters are now listed for hearing in April. The fresh third plea has been filed by Mukesh Kumar, who claims to be a social worker, through lawyers Roopesh Singh Bhadauria and Mareesh Pravir Sahay. Lawyer Bhadauria also heads the legal cell of the Indian Youth Congress (IYC). The plea has sought quashing of the "impugned Notification dated January 20, 2023 passed by the Ministry of Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021".

While there has been no official statement from the Income Tax department on the action, the BBC has said it was cooperating with the authorities.

A BBC staffer in Delhi said they were broadcasting their news like usual and the company has informed them that it is cooperating with the authorities

The Supreme Court last week dismissed a plea seeking the imposition of a complete ban on the BBC in India in the wake of the controversial documentary, terming the petition "entirely misconceived" and "absolutely meritless".

Sukesh again arrested by ED

New Delhi, Feb 16: The Enforcement Directorate (ED) has arrested alleged conman Sukesh Chandrashekhar in a fresh money laundering case linked to duping former Religare promoter Malvinder Singh's wife by posing as Union home and law secretaries.

Chandrashekhar, 33, was taken into custody under criminal sections of the Prevention of Money Laundering Act (PMLA) from a local jail on Thursday evening and a Delhi court later sent him to nine-day ED custody.

The federal probe agency had sought 14-day custody of the alleged conman from the court of Additional Sessions Judge Shailender Malik.



Chandrashekhar's lawyer Anant Malik told the court that custodial interrogation of his client was not required as the case was registered in September 2021 and he had been called to unearth the money trail in the case at a "belated stage"

This is the third money laundering case in which the ED has arrested Chandrashekhar. The other two cases relate to Chandrashekar allegedly duping Aditi Singh, the wife of Malvinder Singh's brother Shivinder Singh, of Rs 200 crore and to purported bribing of Election Commission officials to get the AIADMK's 'two leaves' symbol for the V K Sasikala faction.

The latest PMLA case stems from a Delhi Police Special Cell FIR of 2021 which accuses Chandrashekhar and his alleged associates of hatching a criminal conspiracy by impersonating high ranking government officers and extorting Rs 4 crore from Malvinder_ Singh's wife Japna Singh.

Malvinder Singh is currently lodged in jail in a case against him linked to alleged misappropriation of funds at Religare Finvest

'2,767 complaints against influencers, Insta tops violations'

More than half of the violations have been found on Meta-owned Instagram platform, while Alphabet's Youtube contributed a third of them, the self-regulatory organisation for the advertising industry said

Mumbai, Feb 16: The Advertising Standards Council of India (ASCI) Thursday said it has processed 2.767 complaints since coming up with influencer guidelines in May 2021.

The body said in over 90 per cent of the cases, there were modifications required. "...The Central Consumer Protection Authorities also now require disclosure of material connection between brands and influencers. Hence, non-disclosures are potential violations of the law," the body's chief executive and secretary general Manisha Kapoor said. In FY22, the total



number of violations stood at 1,592, with virtual digital assets like bitcoins topping with nearly 24 per cent, and followed closely by personal care category which accounted for 23 per cent

In the first nine months of FY23 (April-December 2022), there were 1,175 complaints received with personal care category topping by contributing a third of them, followed by food and beverage at 16 per cent.

Instagram accounted for 53 per cent of the violations in FY22, which has increased to 65 per cent in the first nine months of FY23, while in the case of Youtube, the same has declined from 37.8 per

cent to 27 per cent. The body also conducted a survey of 820 respondents, which found 79 per cent of them saving they trust influencers and 90 per cent saying they have made purchases based on influencer endorsements. The survey said transparency and honesty about brand associations is the number one reason for influencer trust, followed by relatable lifestyle and

6 dead in Egypt road crash

Cairo: At least six people were killed on Thursday when a pickup truck and a minibus collided near Egypt's eastern city of Ismailia, health officials said. Three others were injured in the crash. Among the dead were five Palestinians, between 20 and 50 years of age, and one Egyptian, the local ambulance service said in a statement. According to Egyptian media, the five Palestinian passengers were heading to Rafah, Egypt's official border crossing with the Gaza Strip.

SK revives 'enemy' label for North

Seoul (South Korea): South Korea called North Korea "our enemy" in its biennial defence document published Thursday, reviving the label for its rival for the first time in six years, as tensions worsen between the two. North Korea conducted an unprecedented number of missile tests in 2022, including simulated nuclear attacks on South Korea, In response, South Korea's conservative government led by President Yoon Suk Yeol has been seeking a stronger U.S. Security commitment and boosting its own military capabilities.

■ Two dead in helicopter crash

Montgomery (US): A Black Hawk helicopter from the Tennessee National Guard crashed Wednesday in Alabama, killing two crew members, the Tennessee National Guard said. "We are deeply saddened by the loss of two Tennessee National Guardsmen, and our prayers are with their families during this heartbreaking tragedy," Brig. Gen. Warner Ross, Tennessee's Adjutant General, said in a statement. "We ask Tennesseans to join us in supporting their families during this time of unthinkable grief."

■ 1 killed, 3 injured

El Paso: One person was killed and three more were wounded on Wednesday in a shooting at a shopping mall in El Paso, Texas, adding to the dozens of people already killed this year in mass shootings across the United States. El Paso police said hours after the gunfire that two people had been taken into custody, though details of what led the shooting remained unclear. Interim police chief Peter Pacillas said that Cielo Vista Mall was still considered a crime scene, and that it would remain locked down until authorities had completed their investigation.

China sanctions Lockheed Martin, Raytheon over Taiwan arms sales

Beijing, Feb 16: China Thursday imposed trade and investment sanctions on Lockheed Martin and a unit of Raytheon for supplying weapons to Taiwan, stepping up efforts to isolate the island democracy claimed by the ruling Communist Party as part of its territory.

Lockheed Martin Corp. And Raytheon Technologies Corp.'s Raytheon Missiles and Defense are barred from importing goods into China or making new investments in the country the Ministry of Commerce announced

It said they were added to the "unreliable entity" list of companies whose activities are restricted because they might endanger national sovereignty, security or development interests. It wasn't clear what impact the penalties might have. The United States bars most sales of weapons-related technology to China, but some military contractors also have civilian businesses in aerospace and other

The United States has no official relations with Taiwan but maintains extensive commercial and informal contacts. Washington is obligated by federal law to make sure the island's government has

the means to defend itself. The United States is Taiwan's main supplier of military equipment.

Raytheon Missiles and Defense, part of Raytheon Technologies Corp., was awarded a USD 412 million contract in September to upgrade Taiwanese military radar as part of a USD 1.1 billion package of US arms sales to the island. Boeing Defense received a USD 355 million contract to supply Harpoon missiles.

Beijing responded to that sale by announcing sanctions against the CEOs of Raytheon and of Boeing Defense but gave no details of what they were. Lockheed Martin has supplied Taiwan's military with radar, helicopters and air traffic control equipment. It plays a role in the island's development of

its own fighter jet and navy frigates. In China, Lockheed Martin has sold air traffic control equipment for civilian airports and helicopters for commercial use. Beijing announced plans for the "unreliable entity" list in 2019 in response to US restrictions imposed on Huawei Technologies Ltd., a Chinese maker of telecom equipment.

Al Qaeda has not formally named a successor for Ayman al-Zawahiri, who was believed to have been killed in a U.S. missile strike in Kabul last year, dealing a blow to the organisation since its founder Osama bin Laden was killed in 2011.

Although a U.S. intelligence official said in January that Zawahiri's succession remained unclear, the United Nations report assessing risks from the group said: "In discussions in November and December, many Member States took the view that Seif al-Adel is already operating as the defacto and uncontested leader of the group.'

Zawahiri's death piled pressure on the group to choose a strategic leader who can carefully plan deadly operations and run a jihadi network, experts on al Qaeda say.

Unlike his slain predecessors who maintained a high profile with fiery videos broadcast around the globe threatening the United States, the experts say Adel planned attacks from the shadows as he helped turn al Qaeda into the world's deadliest militant group.

Adel was indicted and charged in November 1998 by a U.S. federal grand jury for his role in the bomb attacks on the U.S. embassies in Tanzania and Kenya that killed 224 civilians and wounded more than 5,000 others.

There are few photos of him, aside from three pictures - including a very serious black and white image of him on the FBI most wanted list.


Colombo, Feb 16: After a year of load-shedding, Sri Lankans will get continuous power from Thursday, albeit with a hike in tariff in line with the conditions set

by the IMF. The Sri Lankan government's move comes as the debt-hit country

aims to secure a much-needed USD 2.9 billion tranche from the Washington-based global lender. President Ranil Wickremesinghe has directed officials to ensure an uninterrupted power supply to customers after the tariff revision is implemented, a statement from the President's Media Division said.

The state power entity said that the power cuts ranging from one to 14 hours from January last year would end on Thursday. A 66 per cent tariff hike would be in effect, the second in the last six months. A 70 per cent rate increase was introduced in August last year.

The government opted for a costreflective tariff plan as dictated by the International Monetary Fund (IMF), Energy Minister



Kanchana Wijesekara said. "This will be a giant step in securing the IMF facility," he said.

The island nation awaits the formal approval of the IMF for a USD 2.9 billion bailout package over

four years as it aims to recover from its worst-ever economic crisis after announcing its first-ever default in April last year.

The IMF has said that state energy entities Ceylon Electricity Board and the Ceylon Petroleum Corporation should not bank on the Treasury for cash injections to run their operations, Wijesekara said, adding that the exchequer had injected Rs 120 billion into the two institutions.

"The treasury has no money to subsidise electricity," he said. "With increased revenue, we will be able to buy the fuel necessary to ensure no power cuts," Wijesekara said.

Trade unions and the opposition parties have criticised the tariff hike and have vowed to organernment to reduce the tariff. The long power cuts and shortage of essential commodities led to intense street protests, which forced the then-president Gotabaya Rajapaksa out of office.



Windfall tax cut

New Delhi: The government has cut windfall profit tax on export of diesel and ATF to their lowest while also reducing the levy on domestically-produced crude in line with softening international oil prices according to an official order. The levy on crude oil produced by companies such as Oil and **Natural Gas Corporation** (ONGC) has been cut to ₹4,350 per tonne from ₹5,050 per tonne. The government has also cut the tax on export of diesel to ₹2.5 per litre from ₹7.5, and the same on overseas shipments of ATF to ₹1.50 a litre from ₹6 a litre.

■ BoB, IOB hike lending rates

Mumbai: Bank of Baroda and Indian Overseas Bank have increased their marginal cost of fund-based lending rates (MCLR), following a hike in the interest rates on loans and deposits by their largest public sector peer SBI. The latest hikes in the interest rates come days after the Reserve Bank of India February 8 increased the borrowing costs by 25 basis points. State-owned Bank of Baroda has increased its MCLR by 5 bps across all tenors from February 12. Indian Overseas Bank has raised its MCLR by up to 15 bps across all tenors.

HDFC gets ₹25K-cr through NCDs

Mumbai: Merger-bound mortgage lender HDFC Thursday concluded its rupee-bond sale through the private placement route, mopping up ₹25,000 crore. HDFC said it has raised ₹25,000 crore of 10-year money by issuing nonconvertible debenture (NCDs) carrying a coupon rate of 7.97 per cent per annum. The issue was launched Tuesday on the electronic book platform to raise ₹5,000 crore with an option to retain subscription for additional ₹20,000 crore.

YouTube CEO auits

Washington: YouTube Chief Executive Officer Susan Wojcicki will be stepping down after nine years at the helm of the world's largest online video platform, she said in a blog post Thursday. YouTube's chief product officer, Neal Mohan, will be the new head of YouTube, she said. Wojcicki, who was previously a senior vice president for ad products at Google, became CEO of YouTube in 2014

Twitter opens doors for cannabis marketing in US

Washington, Feb 16: Twitter Wednesday became the first social media platform to allow cannabis companies to market their brands and products in the **United States**

The company had earlier only allowed advertising for hemp-derived CBD topical products, while other social media platforms including Facebook, Instagram and TikTok follow a "no cannabis advertising policy" as pot remains illegal at the federal level.

However, more states in the United States are moving towards allowing the sale of recreational cannabis, with 21 already on board.

Twitter said it will permit cannabis companies to advertise, as long as they have proper license, pass through its approval process. only target jurisdictions where they are licensed to operate and most importantly, do not target people below 21 years.

A range of other restrictions is also included in the updated policy. For instance, companies and brands can't use any character, sportsperson, celebrity, or image/icon that might appeal to minors. No pregnant women or mi-



nors can be used in advertising and there must not be any claims of health benefits or any false or misleading claims.

and Boeing over the next decade,"

According to him, this order of 840 aircraft has been a culmination of a fascinating journey that began almost two years ago with the Air India privatisation process. The Airbus firm order comprises

210 A320/321 Neo/XLR and 40 A350-

900/1000. The Boeing firm order comprises 190 737-Max, 20 787s and "We have also signed up for longterm maintenance of the engines

with CFM International (CFM), Rolls-Royce and GE Aerospace, he said. This was also the first time in

more than 17 years that Air India, which was acquired from the government by Tata Group in January 2022, has ordered planes. The first A350 plane will be delivered to the airline by the end of this year. Aggarwal Thursday said the

order demonstrates the vision and aspiration of Tata Group to transform Air India into a world-class airline and connect India "non-stop" to every major city in the world. "This order is also a testament

New Delhi, Feb 16: Embattled tvcoon Gautam Adani-led Adani Power's planned ₹7,017-crore acquisition of coal-based electricity generating units of DB Power Ltd has fallen as the deadline to complete the transaction expired without signing of the pact.


"We wish to inform that the long stop date under the memorandum of understanding dated August 18, 2022, has expired," Adani Power said in an exchange filing Wednesday, without providing any information about the extension of dates or agreement renegotiation.

The announcement of the expiry of the long-stop date essentially implies that the acquisition is off for now. The date to complete the process of acquisition of DB Power was extended four times after the initial deal was signed in August last year.

This comes at a time when the ports-to-energy conglomerate is battling fallout of a damning report by a US short-seller Hindenburg that alleged accounting fraud and stock manipulation, allegations that the group has vehemently denied.

The report, which flagged high debt including pledging shares of inflated stock for loans, put the entire group on precarious financial footing.

Since the January 24 report, the group companies have seen half of their market value wiped out and the conglomerate having to pledge

more shares to meet lending norms. It also called off a follow-on share sale at its flagship firm, Adani Enterprises Ltd that barely scraped through on the last day of the sale. In the stock exchange filing, the

company did not give reasons why the deal could not be completed or if the deal would be revived in future. The initial term of the memo-

randum of understanding (MoU) was till October 31, 2022, which was extended by mutual agreement. The long-stop date was first extended to November 30, 2022, and then to December 31, 2022, and January 15, 2023, and finally to February 15, 2023

Blacklist fear for renewable firms

New Delhi, Feb 16: India will blacklist renewable power companies for three-to-five years if they do not meet project completion deadlines, a government order seen

"If any renewable energy project is not completed by the prescribed date of completion, then its bank guarantee should be encashed and the developer blacklisted after asking to show cause," the order issued by the new and renewable energy ministry said.

The blacklisting will be for a period of three to five years, the order issued Wednesday said. So far India has not blacklisted

any company from renewable energy generation contracts for delays, but the government order said the blacklisting was in accordance with the government's General Financial Rules and would apply to all tenders. India needs to add over 40 gi-

gawatts capacity annually to achieve its commitment to 500 gigawatts of renewable energy generation capacity by 2030. The country's renewable energy installed base is nearly 175 gigawatts.

The pace of installation is less than 15 gigawatts per annum following disruptions in equipment supply caused by heavy import duties on solar equipment.

As a result of the pandemic, the ministry allowed several extensions, most recently an order in December 2022 granted a one-year extension to March 2024 year for ___ project completion.



Fuel demand sees sharpest rebound

India's oil demand had been rising steadily since the easing of Covid-19 restrictions

New Delhi, Feb 16: India's fuel demand witnessed the sharpest rebound in February as petrol and diesel consumption rose by double digits after a winter lull in the previous month, preliminary industry data showed Thursday.

Petrol sales jumped almost 18 per cent to 1.22 million tonne in the first half of February, as compared to 1.04 million tonne of consumption in the same period of last year. Sales were 18.3 per cent

higher than in Covid-marred first half of February 2021 and 15.7 per cent more than in the same period

Month-on-month, the demand was up 13.6 per cent, reversing the dip in the previous month. Sales had fallen 5.1 per cent month-on-month in January as cold conditions cut vehicular movement.

Diesel, the most used fuel in the country, posted a near 25 per cent rise in sales during February 1-15 to 3.33 million tonne, as compared to the same period last year.



DIESEL SAW 25% RISE IN SALES

Consumption was up 16.7 per cent over the first half of February 2021 and 7 per cent higher than 2020. Month-on-month sales surged 10.3 per cent from 3.01 million tonne in the first half of January.

In January, diesel consumption fell 8.6 per cent month-on-month basis as snowfall in higher reaches halted truck movement. The rebound in sales is the sharpest. Industry sources said diesel de-

mand surged as trucks returned to roads and there was a pick up in the agriculture sector. Use of the fuel in irrigation pumps and trucking helped build the momentum generated. January sales were lower month-on-month also because the previous month had seen a surge in consumption due to vacation travel.

With the continued opening of the aviation sector, India's overall passenger traffic at airports inched closer to pre-Covid-19 levels.

WIDENING TAX BASE

Govt looks to tap mom-and-pop stores

New Delhi, Feb 16: The Indian federal government is planning to widen its goods and services tax (GST) by tapping a section of momand-pop stores, a top tax official said Thursday, as New Delhi looks to bring more elements of the economy into the tax net.

Mom-and-pop stores refer to small business entities that are independent or family-owned.

India has a large informal economy and the government has been trying to boost its tax revenues by including more of these activities.

The GST - which subsumed a

host of state and federal levies when it was introduced in 2017 - requires businesses with an annual turnover of ₹4 million or more to be registered under the regime.

"We may adopt a sectoral approach in some sectors where we feel the taxpayer base is too slim compared to the size of the market,' Vivek Johri, chairman of the Central Board of Indirect Taxes and Customs said.

The number of businesses within the GST net has increased to 14 million as of January 2023, from about 6 million in 2017, he said, seeing potential to further increase the taxpayer base under the GST regime.



New Delhi, Feb 16: Spinner Nathan Lyon and company's effectiveness on Indian tracks has been curtailed because of low carry as they are used to bowling on bouncy Australian pitches, conceded skipper Pat Cummins Thursday.

Though Australia's young Test debutant spinner Todd Murphy took seven wickets, Nathan Lyon could manage just one even as Ravichandran Ashwin and Ravindra Jadeja ran through the visitors' batting lineup to help India win the Nagpur Test.

Lyon bowled 49 overs in the opening Test with only Suryakumar Yadav's wicket to show for his efforts. Cummins said that his spin unit is still adjusting to the changes.

"It's an adjustment. Even the last game we saw a lot of around the wicket bowling, whereas in Australia it's mainly over-thewicket bowling. The close catchers don't feel like the ball is going to pop up as much when there isn't much bounce. It is bit of an adjustment,' Cummins said on the eve of the sec-

"Using side-spinners, just changing up your angles a bit more. All those things come into a bit more. I think the bowlers did a really good job, both spinners (in the) last game (in Nagpur). It's a bit of an adjustment but in some ways it doesn't get any better."

Tracks in western India are predominantly made with red soil, while up north it is black soil. While the colour of the soil had changed. Cummins feels the nature of the pitch will not change a lot.

"Not too sure, really. It's different soil here (Delhi), the black soil, but it looks pretty similar. I think it's going to spin. That's our expectation and the wicket matches that. We will see," the skipper said.

The skipper said that both rookie left-arm spinner Matt Kuhnemann and, the tried and tested Ashton Agar were an option for the second

"We are open to both (Kuhnemann and Agar) options. Both, we are really confident will do a fantastic job out there. They both had long sessions the last couple of days and looked awesome. If we wanted a third spinner variety we'd be comfortable with either of those two.'

The best version of David Warner is when he counter attacks and Cummins wants the talismanic opener to employ that approach in the upcoming Test, if he gets a chance. So, will Warner be in the scheme of things for the second

"I'm not a selector. I don't think they've had a meeting but I'm sure Davey (Warner) will be there. You saw this year at the Boxing Day Test when he puts pressure back on the opposition he's pretty hard to bowl to. I'm sure that'd be part of his plan," said Cummins.

"He has been batting really well here. Even in the lead up. I thought he was fantastic. I know there's a lot of talk about spin bowling through the middle but with that new ball, it's sometimes the hardest time to bat as well," said Cummins, sounding confident.

Indian football great BALARAM passes away

Kolkata, Feb 16: Asian Games gold medallist and Olympian Tulsidas Balaram, a part of Indian football's 'holy trinity' in the 1950s and 60s, died here Thursday after a prolonged illness, sources close to his family said.

Balaram belonged to the golden generation of Indian football and teamed up with legends such as Chuni Goswami and PK Banerjee to forge a formidable partnership upfront. Balaram was 87 and a widower living in a flat on the banks of Hooghly river in Uttarpara.

The 1962 Asian Games champion was hospitalised December 26 last year and was being treated for urinary infection and abdominal distension. "His condition did not improve and he breathed his last around 2pm today," a source close to his family told PTI.

"We are grateful to the state government and the sports minister Aroop Biswas for taking good care of him during his last days," he

Born October 4, 1936, to Tamil parents – Muthamma and Tulsidas Kalidas – in Ammuguda village in the garrison town of Secunderabad, Balaram scored 131 goals across seven seasons.

An Arjuna awardee, Balaram's exploits at the 1960 Rome Olympics are well documented. Placed in the 'group of death' with Hungary,

France and Peru, India lost the opener to Hungary 1-2 but Balaram covered himself in glory by scoring a 79th-minute goal. He also scored against Peru in the Games. India came close to upsetting France a few days later with Balaram again

The Jakarta Asian Games gold, where India beat South Korea 2-1 in the final, was the country's second title triumph in football at the multi-discipline continental games, and the achievement hasn't been repeated since.

showing his class.

Besides his ability to score brilliant goals, Balaram was wellknown for his amazing ball control. dribbling and passing abilities through a comparatively short but very successful career.

Balaram, who mostly played as a centre-forward or as a left-winger, called it a day in 1963 owing to poor health. His career spanned eight years between 1955 and 1963, before being cut short by tuberculosis at the age of 27.

Having made his international debut against Yugoslavia at the 1956 Melbourne Olympics, where India finished fourth, he went on to play 36 matches for the country while finding the net 10 times, including four in the Asian Games.

He has represented Bengal and Hyderabad in the Santosh Trophy and tasted success with both states. After his retirement as an active footballer, Balaram coached the Calcutta Mayor's team in the Gothia Cup in Sweden. He had also served as a talent spotter of the All India Football Federation.
