

### **RI COMPLEX BLAZE TAMED AFTER 24 HRS OVER 140 PEOPLE INCLUDING TOURISTS FROM MAHARASHTRA SAFELY RESCUED**

Puri, March 9: The devastating blaze that broke out at a market complex near the Srimandir here was brought under control in a 24-hour-long fire-fighting operation Thursday, while about 140 people were rescued, official sources said.

The fire gutted almost all the 43 shops, a bank and a hotel that the Laxmi Market Complex consisted of. However, there was no casualty

"The fire is now under control though smoke was billowing from certain parts of the market complex," said DG, Fire Service, SK Upadhyaya, who visited the site earlier in the day.

Three Fire department personnel and three tourists were hospitalised due to exposure to flame and smoke, an officer said. It was a tough job for the firefighters as there was only one

exit and entry point to the threestoried building. Garments, toys and leather products kept in shops functioned

as fuel to the fire and that took a long time to douse the blaze, the officer said. Besides 12 fire tenders, 90 fire

service personnel, local police and members of the Odisha **Disaster Rapid Action Force** (ODRAF), the administration

The college team members were undergoing training at the Odisha Fire and Disaster Response Academy in Bhubaneswar for the last few days. They were rushed to Puri to assist the state fire brigade personnel.

The official said the blaze was first spotted at a garment store on the first floor of Laxmi Market Complex on Grand Road around 9pm Wednesday. Though the fire was doused Wednesday night, it reappeared at about 2am.

Altogether 106 tourists from Nashik in Maharashtra were rescued from the hotel in the building and taken to a temporary shelter. Around 30 other people were also brought out from there, he said.

The reason behind the incident is yet to be ascertained, said Minister of State for Home, Tusharkanti Behera, who rushed to oversee the fire-fighting operation. He said the shop owners will be compensated following due procedure

Meanwhile, local BJP MLA Jayant Sarangi claimed that the district administration has failed to ensure the installation of fire safety systems at hotels and other establishments in the seaside town.

Mumbai, March 9: Veteran Bollywood actor-writer-director Satish Kaushik - remembered as 'Calendar' in the film Mr India passed away at 67 late Wednesday.

His friend and another legendary actor Anupam Kher shared the news in a tweet early Thursday. Born in Haryana, Kaushik was an alumnus of the NSD and the FTII, and started his film career in the early 1980s.

He penned the dialogues for the 1983 classic 'Jaane Bhi Do Yaaron', which acquired a cult following over the years. He is known for his comic roles as 'Calendar' in Mr India, 'Pappu Pager' in Deewana Mastana among many others.

Kaushik also gave sterling performances in other films like Ram Lakhan and Saajan Chale Sasural. Taking to twitter, Prime Minister

Narendra Modi condoled his death. "Pained by the untimely demise of noted film personality Shri Satish Kaushik ji. He was a creative genius who won hearts thanks to his wonderful acting and direction. His works will continue to entertain audiences. Condolences to his family and admirers. Om Shanti," he said.

#### Washington, March 9: The American intelligence community Wednesday told lawmakers that it apprehends increased tension between India and Pakistan and India and China with the possibility of a conflict between them.

It also noted that under the leadership of Prime Minister Narendra Modi. India is more likely than in the past to respond with military force to Pakistani provocations.

This analysis forms part of the annual threat assessment of the US intelligence community that was submitted to the US Congress by the Office of Director of National Intelligence during a Congressional hearing.

While India and China have engaged in bilateral border talks and resolved border points, relations will remain strained in the wake of the countries' lethal clash in 2020, the most serious in decades, said the report.

The expanded military postures by both India and China along the disputed border elevate the risk of armed confrontation between two nuclear powers that might involve direct threats to US persons and interests, and calls for US intervention. Previous standoffs

"However, Pakistan has a long his tory of supporting anti-India militant groups, and under the leadership of Prime Minister Narendra Modi, India is more likely than in the past to respond with military force to perceived or real Pakistani provocations. Each side's perception of heightened tensions raises the risk of conflict, with violent unrest in Kashmir or a militant attack in India being potential flashpoints," it said.

The report went on to say that the ongoing war in Ukraine has demonstrated how inter-state conflict affects not only the parties directly involved, but can have broader cascading security, economic, and humanitarian implications on a regional, and even global, scale.

Responding to a question, the State Department Spokesperson Ned Price said US-Pakistan counter-terrorism dialogue provides an "opportunity for the United States to convey our willingness to work with Pakistan" to address terrorist threats and counter violent extremism, the threats that are in the region, the threats that have the potential to transcend the region as well. ## Suspected spy pigeon caught off Odisha coast

Paradip, March 9: A pigeon fitted with devices, which appear to be a camera and a microchip, was caught from a fishing boat off the Paradip coast of Jagatsinghpur district, with the police suspecting that the bird was being used for spying.

Some fishermen found the pigeon perched on their trawler named 'Sarathi' at Ramchandi in Konark area of Puri district a few days ago. The bird was captured and handed over to the marine police here Wednesday. The winged agent was found to be fitted with a tiny spy camera and a mi-

crochip what appeared to be a GPS tracking system. "Our veterinarians will examine the bird. We will seek help of the State Forensic Science Laboratory (SFSL) for examining the devices attached to its legs. It appears that the devices are a camera and a mi-

crochip," Jagatsinghpur Superintendent of Police Rahul PR said. It also seems like something has been scribbled on

to the local police.



According to reports, Paradip marine police took the bird to Cuttack Dog and Pigeon Squad Thursday for further investigation. The squad will try to decode the secret and the coded message written in a foreign language in blue and red on the feathers of the pigeon. Pitambar Behera, an employee of the fishing trawler 'Sarathi', said he saw the pigeon perched on the boat. 'Suddenly I noticed that

some instruments were attached to the bird's legs. I also found that something is written on its wings. I could not understand it as it was not in Odia.' Behera said adding that he caught the bird as it came closer

Lookout circular against **Dubai-based operator** 

#### INDO-ASIAN NEWS SERVICE

Bhubaneswar, March 9: Bureau of Immigration (BoI) has issued a lookout circular (LOC) against Md Saif, an accused in the online football betting racket, which was operated by cyber scammers from China and Dubai, police said Thursday.

On the request of the Economic Offences Wing (EOW), BoI has issued the LOC against Saif, a native of Bihar who was operating from Dubai, the police added.

LOC was issued to inform im migration checkposts at airports and seaports to alert the law enforcement agency, if the wanted person tried to leave the country or arrived in the country from abroad.

An EOW official said, "The online betting company (www.18football.com) is suspected to have cheated thousands of people of more than ₹1,000 crore in the country, including Odisha. As of now, Odisha police has been able to trace out transactions worth ₹300 crore.' The officials said that 18foot-

ball.com. registered in Hong Kong. is a hybrid model of fraud where a ponzi scheme (multi-level marketing) is run online in the name of football betting/gaming app.

Earlier, two persons were arrested in this case, which was registered based on the complaints of nearly 800 duped investors of Ganjam district.

According to the modus operandi, investors were promised lucrative benefits like three per cent daily compound return on investment, recharge bonus, referral bonus, extra bonus on the earnings of the downline members, salary bonus, daily withdrawal option etc.

The fraud company was also provided a foreign "mentor" to assist the investors in betting. These mentors used to communicate through Telegram or apps only and extra commission was offered for introducing new members in the app. The scammers used multiple

including Odisha shell companies and their directors to route the ill-gotten money. They also used mule accounts for multilayering of money transactions to confuse the law enforcement agencies. The two accused persons were directors of a Kolkatabased shell company, Hakim & Rustam Fabrics Pvt. Ltd, who operated under the direction of the

accused Saif from Dubai. The EOW has announced a reward to the informer. The information can be given on the mobile No. 8249600495 and the name/details of the informer will be kept secret, the official said.

## CM flags off vaccine, blood collection vans

Bhubaneswar, March 9: Chief Minister Naveen Patnaik Thursday flagged off new blood collection and vaccine vans for service at different regions of the state.

These vans will enhance the state's capacity to serve in remote areas, the Chief Minister said after the vans were rolled out.

Five new mobile blood collection vans were rolled out for four districts. While two vans set out for Keonjhar, one each was sent to Angul, Jharsuguda and Kandhamal.

The five fully fabricated mobile blood collection vans were procured by the state government at a cost of ₹2.70 crore (₹54,02,800 per van)

Currently, there are 56 blood banks and 14 mobile blood collection vans in the state including these five rolled out Thursday. More mobile collection vans will be added to existing fleet, sources said.

As a part of life saving measures and in order to promote voluntary blood collection in remote areas, blood collection vans are being supplied to different health facilities. In November 2019, a total of nine Five new mobile blood collection vans were rolled out for 4 districts. While two vans set out for Keonjhar, one each sent to Angul, Jharsuguda and Kandhamal

mobile blood collection vans were supplied that are stationed at the blood banks of different hospitals resulting in an increase of the total voluntary blood collection from 89,917 units in 2020 to 1,26,747 units in 2022.

Similarly, 10 insulated vaccine vans were also flagged off. While one van will serve at the state vaccine store, nine will serve at as many regional vaccine stores namely, Balasore, Bolangir, Berhampur, Bhubaneswar, Cuttack, Koraput, Phulbani, Sambalpur and Sundargarh. The 10 vaccine vans were procured at the total cost of ₹3.32 crore (Rs 33.26 lakh per van)

out of the state budget. Odisha has one state vaccine store, 32 district vaccine stores and 1,190 cold chain points for safe storage of vaccines.

#### DROUPADI MURMU, PRESIDENT OF INDIA

n Constitution Day last year, I was delivering the valedictory address at the

celebrations organised by the Supreme Court of India. Talking of justice, I thought of the undertrial prisoners and then could not resist speaking at length about their plight. I spoke from the heart, and it made an impact. Today, on International Women's Day, I want to share some thoughts with you in the same spirit – straight from the heart.

Right from my childhood I have remained perplexed about the status of women in society. On one hand, a girl child receives so much love from all around her and is even worshipped on auspicious days. On the other hand, she learns very soon that the possibilities open before her in life are fewer than those available to boys of her age. On one hand, a woman is respected for her innate wisdom, even appreciated as the central figure of the family who takes care of everybody. On the other hand, she has a limited role, if at all, in nearly all significant decisions about the family or even herself.

Over the years, as I stepped out of home, first as a student, then as a teacher and later in social service, I could not help but wonder about such paradoxical attitudes. Sometimes I felt that as individuals, a majority of us recognise men and women as equal. However, at a collective level, the same people impose limits on a half of us. During my lifetime, I have seen most individuals progressing to-wards the notion of equality. At the social level, however, old customs and traditions, like old habits, linger on.

This is the story of all women around the world. Every other human being on earth begins life with a kind of hindrance. In the twenty-first century, when we have achieved unimaginable progress all around, many nations are yet to have a woman as the head of the state or head of the government. At the other end of the spectrum, unfortunately, there are places in the world where even today women are considered lesser human beings; where even going to school can be a question of life and death for a girl!

This was not always so. In India, there were times when women were decision-makers. Our scriptures and our history speak of women known for their valour, scholarship or administrative skills. Today, again, countless women are of course contributing to the nationbuilding in their chosen fields. They are heading corporate firms and even serving in the armed forces. The only difference is that they have to prove their worth in two domains: they have to excel in their careers and also at their homes. They do not complain but all they expect from society is that it reposes confidence in them.

This leads to a curious situation. We do have a healthy representation of women at the grassroots level in various decision-making structures. But as we go up in the hierarchy, we see fewer and fewer women. This is



as true for political bodies as for the bureaucracy, the judiciary and the corporate world. What is noticeable is that even states with higher literacy rates display the same trend. It shows that education alone does not guarantee financial and political autonomy for women.

Therefore, I firmly believe that the social mindset needs to change. The deeply ingrained gender prejudices must be identified and purged to create a peaceful and prosperous society. Conscious efforts have been made to promote social justice and equality. But these steps have not proved adequate to ensure gender representation. In education and jobs, for example, women lag far behind men more because of social conditioning than any design.

In a number of convocations I have attended in different parts of the country, I have noticed that women, if given a chance, often outperform men in academia. It is this indomitable spirit of Indian women that gives me confidence about India emerging as the torchbearer of gender justice in the world.

It is certainly not the case that one half of humanity has had any head-start by keeping the other half behind. The fact is that this mismatch is hurting the whole of humanity, because the two wheels of its cart are unequal. Not only economic progress, but climate action too would speed up if women are included in decision-making. I am sure that the world will be a lot better place if women are made equal stakeholders in the progress of humanity.

I am, indeed, hopeful that the future is bright. I have seen in my life that people change, attitudes change. That is indeed the story of our race; otherwise we would still be living in caves. The story of women's emancipation has proceeded slowly, often painfully slowly, but it has proceeded only in one direction and has never made a u-turn. That is what gives me confidence to believe, as I have often stated, that the coming Amrit Kaal up to the centenary of India's independence belongs to young women.

What makes me hopeful is the fact that we as a nation began with a sound foundation of gender justice. About a century ago Mahatma Gandhi's campaigns during the freedom struggle encouraged women to cross the threshold and step out into the world. From those days, our society as a whole, and women in particular, have aspired to build a better future. Prejudices and customs not favourable to women are being done away with either through legislation or through awareness. This seemed to have positive impact as Parliament today has the highest number of women representatives. Needless to say, my election as the President of world's largest democracy is a part of this saga of women's empowerment. I believe the spirit of "innate leadership in motherhood" needs to be invoked to promote gender justice. A slew of government programmes to directly empower women, such as 'Beti Bachao Beti Padhao', are steps in the right direction.

We should also appreciate the fact that societies take time to match step with the best of progressive ideas. But societies are composed of human beings - half of them women - and it is up to us, each of us, to hasten the progress. Thus, today, I wish to urge each of you to commit yourself to one change, in your family, neighbourhood or workplace-any change that would bring a smile on a girl's face, any change that would improve her chances of moving ahead in life.-That is one request, as I said before, straight from the heart.

### SOG jawan injured in accidental firing

Debabrata Sabat, Professor at department of urology, said there was a need to drink at least two glasses of water in empty stomach early in the morning. A person must consume two and half to three litres of water every day. reduce the salt intake and avoid junk food altogether to stay healthy, he said.

Pushparaj Samantasinhar, medical superintendent of the hospital, said dialysis was done in both SUM Hospital and SUM Covid Hospital round the clock for patients during the battle against the pandemic. He said that steps were being taken to undertake kidney transplantation in the hospital.

### Jumbo found dead in Karlapat forest

Bhawanipatna, March 9: A tusker was found dead at Karlapat wildlife sanctuary under South forest division in Kalahandi district. Wednesday.

The carcass of the tusker was recovered from Semijharan at Kukurghati inside the wildlife sanctuary. Forest officials recovered the carcass and buried it inside the jungle after conducting a post-mortem. Locals alleged that incident occurred March 4 but forest officials tried to suppress the death of the tusker by conducting its post-mortem and burving the carcass without informing the local mediapersons.

Rayagada, March 9: Nagavali river. which is one of the major rivers of South Odisha and North Andhra Pradesh, is slowly changing its course due to alleged illegal mining and smuggling of black stones from near Dhumaguda village – about 2 km from the district Collectorate at Rayagada, a report said.

The miscreants are using explosives and smuggling stones from the quarry near Dhumaguda village as a consequence of which the river is reportedly changing its course. Environmentalists alleged that the river has changed its course from its upstream at Chekaguda bridge to its downstream due to regular blasting and quarrying activities. Pictures show seepage of water under the ground which may assume bigger proportions.

It is alleged that a non-Odia person is mining large amount of stones from the quarry through blasting without having necessary approval.

Rayagada tehsildar Tapas Rout visited the spot after being apprised about the illegal mining March 3, 2023. Later, he also lodged a complaint at Sheskhal police station. However, police are yet to take any action in this regard.

Notably, large-scale quarrying is being conducted on plot no-171, khata number-27 in Dhumaguda mouza under Ravagada tehsil. The stone quarry is spread over 12 kms and is mentioned as a hill in the revenue records of state government's 'Bhulekh' portal.

It is alleged that stones have been extracted from over 3 out of 12 acre of land of this large hill since 2021. Sources said the district police is a mute spectator to illegal supply of the smuggled stones to neighbouring Andhra Pradesh through Rayagada town.

The rampant quarrying has also posed grave threat to Dhumaguda, adjoining Mariguda and Chekaguda slum in Rayagada town.

Earlier, the river was flowing straight but continuous and excessive blasting has made a deep impact underneath, thereby forcing the river to change its course, said the locals and environmentalists.

The illegal and continuous use of explosives has forced the locals of Dhumaguda, Mariguda, Baisingh and Chekaguda slum to live in a state of perpetual fear and panic.

An environmentalist-cum-social activist Ajay Kumar Kashyap stated that change in river course has also impacted the water retaining ca-

## Wildfire rages in 142 spots

Bhubaneswar, March 9: With rain eluding the state since October, forest fires are raging in 142 places in various districts, which is the highest in the country as on Tuesday, a senior official said.

According to the Forest Survey of India (FSI) data, 391 active fire incidents were reported from across the country by 12 noon during the day.

Odisha tops the chart with 142 active fire points, followed by 58 in Chhattisgarh, 48 in Andhra Pradesh, 37 in Telangana, 32 each in Jharkhand and Karnataka and 15 in Maharashtra. Forest fire incidents were also reported in several other states but they are fewer in number.

Forest fires may start from natural causes such as lightning strikes or when dry tree branches rub against each other during high wind. They can also be manmade when burnt stubs of cigarettes and bidis are thrown away on dry leaves.

Mayurbhanj district which has Similipal National Park reported the maximum number of forest fires. Such incidents have also been reported from the districts of Koraput, Malkangiri, Nabarangpur, Nuapada, Sundargarh, Kandhamal, Gajapati, Ganjam, Khurda, Keonjhar and Cuttack.

The Forest department has

been working hard to douse the fire at so many places, Principal Chief Conservator of Forests Debidutta Biswal told reporters.

"As many as 3,000 forest personnel, 16,000 Vana Surakhya Samitis (forest protection committees) and 280 special squads have been engaged to deal with forest inferno in the state. The members of women self-help groups have also been roped in to create awareness and check the fires which are mostly man-made, Biswal said. "It is the beginning of the summer and there are large number of forest fires in the state. We are praying for rain as things can get worse from here on. It has been a long dry spell with no rain since October," he said.

Large forest fires were reported from Similipal Tiger Reserve in Mayurbhanj district, Champua forests in Keonjhar district, Baliguda and Tumudibandh in Kandhamal district, Chandaka in Khurda district, Sunabeda in Nuapada district, Narayanpatna in Koraput district, Mohana in Gajapati district, Jharigaon in Nabarangpur district, Ghumsar in Ganjam and Soro in Balasore district

However, family members gave them only a photo copy of the certificate as the original certificate has been given to an advocate pleading their case. Later, the police team asked them a few other questions before returning to Burla. Meanwhile, the police team dodged the questions of mediapersons, who were waiting outside

On the other hand. Labang told the mediapersons that her daughter was murdered and attempts are being made to give it a shape of suicide. She said, "The comment of Sambalpur SP that Chinmayee has committed suicide is not at all acceptable and I do not know at whose pressure he is making such a comment.<sup>3</sup>

She alleged that police have failed to reveal under what circumstance Chinmayee went to the PC bridge at night and the circumstances that led to recovery of her body from the power channel. She also alleged that police are not disclosing as to how the mobile phone of Chinmayee was recovered from the possession of Preetiman Dev. She warned that she will make all efforts for justice and will move Orissa High Court very soon.

## Man killed by in-laws

there. The deceased is survived by two minor children.

Rudra had come to his in-laws' house to take Sarojini with him but an argument ensued between him and his in-laws last night. The matter turned ugly as his inlaws beat him to death.

The accused packed the body in a sack and were taking it in a van for disposal when villagers intercepted the vehicle and informed the police.

Searching the van, police found the body. The body was handed over to the deceased family members after a postmortem. Further investigations are on.

ecent months may well be remembered as the moment when predictive artificial intelligence went mainstream. While prediction algorithms Lhave been in use for decades, the release of applications such as OpenAI's ChatGPT3 - and its rapid integration with Microsoft's Bing search engine - may have unleashed the floodgates when it comes to user-friendly AI. Within weeks of ChatGPT3's release, it had already attracted 100 million monthly users, many of whom have doubtless already experienced its dark side - from insults and threats to disinformation and a demonstrated ability to write malicious code.

The chatbots that are generating headlines are just the tip of the iceberg. AIs for creating text, speech, art, and video are progressing rapidly, with farreaching implications for governance, commerce, and civic life. Not surprisingly, capital is flooding into the sector, with governments and companies alike investing in startups to develop and deploy the latest machine-learning tools. These new applications will combine historical data with machine learning, natural language processing, and deep learning to determine the probability of future events.

Crucially, adoption of the new natural language processing and generative AIs will not be confined to the wealthy countries and companies such

as Google, Meta, and Microsoft that spearheaded their creation. These technologies are already spreading across low- and middle-income settings, where predictive analytics for everything from reducing urban inequality to addressing food security hold tremendous promise for cash-strapped governments, firms, and NGOs seeking to improve efficiency and unlock social and economic benefits.

The problem, however, is that there has been insufficient attention on the potential negative externalities and unintended effects of these technologies. The most obvious risk is that unprecedentedly powerful predictive tools will strengthen authoritarian regimes' surveillance capacity

One widely cited example is China's "socialcredit system," which uses credit histories, criminal convictions, online behaviour, and other data to assign a score to every person in the country. Those scores can then determine whether someone can secure a loan, access a good school, travel by rail or air, and so forth. Though China's system is billed as a tool to improve transparency, it doubles as an instrument of social control.

Yet even when used by ostensibly well-intentioned democratic governments, companies focused on social impact, and progressive nonprofits, predictive tools can generate suboptimal outcomes. Design flaws in the underlying algorithms and biased data sets can lead to privacy breaches and identity-based discrimination. This has already become a glar-

ing issue in criminal justice, where predictive analytics routinely perpetuate racial and socio-economic disparities. For example, an AI system built to help US judges assess the likelihood of recidivism erroneously determined that Black defendants are at far greater risk of re-offending than white ones

Concerns about how AI could deepen inequalities in the workplace are also growing. So far, predictive algorithms have been increasing efficiency and profits in ways that benefit managers and shareholders at the expense of rank-and-file workers (especially in the gig economy)

In all these examples, AI systems are holding up a funhouse mirror to society, reflecting and magnifying our biases and inequities. As technology researcher Nanjira Sambuli notes, digitisation tends to exacerbate, rather than ameliorate, pre-existing political, social, and economic problems.

The enthusiasm to adopt predictive tools must be balanced against informed and ethical consideration of their intended and unintended effects. Where the effects of powerful algorithms are disputed or unknown, the precautionary principle would counsel against deploying them.

In the global rush to develop and deploy new predictive AI tools, harm prevention frameworks are essential to ensure a secure, prosperous, sustainable, and human-centered future



"hat gets measured gets done." It is a well-worn maxim, attributed to everyone from management guru Peter Drucker to physicist Lord Kelvin. Regardless of who said it first, the point is a crucial one: if there are no data illustrating a problem or imbalance, it is unlikely to be a consideration, let alone a priority, for those in a position to address it. And solutions, if they are attempted, are unlikely to be well targeted or efficient. This is certainly the case for gender equality.

One might assume that, in today's world of information overload, policymakers have ample data with which to diagnose problems, devise innovative solutions, monitor implementation, and adjust policies to maximise their impact. But even in an age of big data, policymakers often lack accurate, consistent, timely, and representative information. As a result, they are working with an incomplete picture of socioeconomic conditions.

For example, data show that female labour-force participation in India has been declining since 2005. Reversing this trend, and achieving gender equality, could add \$770 billion to India's GDP by 2025, according to McKinsey Global Institute. But effective solutions would need to be informed by comprehensive data that capture the complex relationship between women's labour-force participation and various social, political, and economic forces, and they would need to link gender equality to broader development outcomes.

In any effort to boost gender equality, both sex-disaggregated data and reporting on issues that primarily affect women and girls are crucial. Consider gender-based violence: according to the World Bank, one in three girls or women aged 15-49 has experienced physical and/or sexual violence.

As Data2x has documented, the collection of data on violence against boys and girls in Tanzania led to effective government interventions, which brought about long-term, multisectoral change. Similarly, the World Bank reports that Vietnam used data from demographic and health surveys to boost protections for women and girls, such as by adopting legislation banning domestic violence. Beyond informing policy, the data sparked debate in Vietnam about gender-based violence, leading to the creation of the National Strategy on Gender Equality. Women facing violence in their homes now have greater access to counseling, health, legal, and shel-

ter services But producing comprehensive data is no easy feat. Any tiny statistical error or hint of measurement bias, at any stage of collection and production, can render data unrepresentative, as can prejudice by respondents, who are often primarily men.

Before the COVID-19 crisis, the world broadly adopted the most representative method for collecting household data: surveys. But the pandemic forced a shift to-

ward phone-based surveys, which are less likely to represent women and other groups with reduced access to mobile phones. Weak leadership, a lack of political will, and poor resource allocation have been mentioned as crucial impediments to the collection of sexdisaggregated statistics.

One way to overcome these constraints is to improve the integration of data at the national, regional, and international levels. Moreover, more effort must be devoted to enhancing the capacity of women to contribute and use data. Increased female leadership within open-data organisations can help spur progress toward new, more inclusive approaches to data collection.

Such efforts should, of course, be guided by existing best practices. Norway, for example, has been publishing national gender-equity indicators - including gender distribution in total income, the workforce, business, the public sector, education, and leadership-since 2008. Sweden, for its part, requires that all public agencies present sex-disaggregated statistics in their annual reports. These are models worth emulating.

Engagement by civil-society and multilateral organisations can also make a big difference. As part of its Strengthening Gender Statistics project, the World Bank - with support from the Bill & Melinda Gates Foundation - is already providing technical assistance to 12 International Development Association countries, in order to improve the scope and quality of their gender-related statistics. Replicating and expanding this initiative can go a long way toward enabling governments to make evidence-based policy decisions that improve the lives and livelihoods of their citizens.

To be sure, data collection and analysis are just the beginning. Improved dissemination and uptake of gender-related data for policymaking is also needed. Defining use ful and consistent indicators is crucial, because it enables comparison across regions and assessment of progress over time.

Finally, the role of data in bol stering accountability and improving governance must not be overlooked. Just as high-quality, timely, and comprehensive data enable us to devise targeted policies and allocate resources more efficiently, they also enable us to measure those policies' impact - and the government's performance.

Improving data collection will require some investment. But, by enabling more efficient, bettertailored, and more cost-effective policies, that investment will ultimately ease the strain on government budgets. And, as countries make progress toward gender equality, the social, economic, and development benefits will continue to multiply.

## In the name of development

The encroachment of land led an anti-encroachment drive to and forests in the country is not just physical and bluntly visible but matched by statistics. Millions of hectares of forests, grassland and game sanctuaries are encroached upon by either the local population or due to excessive tourism and commerce. The latter goes in the name of development, but without much concern about repercussions, including land subsidence wherein recent developments in Joshimath, Uttarakhand, are a testimony. The damage inflicted is so pervasive and complete that, in many cases, it is irreversible and may take many decades to repair. Besides small-scale efforts of some groups, there is no institutional policy or active manpower push to contain the destruction and reverse it. For over four decades, around one-fifth of India has remained consistently under green cover on government records. Successive governments have not made public the granular data of the country's forest cover. In August last year, Union Environment Minister Bhupender Yadav stated nearly 7,400 sq km of India's forest land has been encroached. In reply to a question in Parliament, he revealed that half of the total encroached forest land was in Assam alone. Nearly 377,500 odd hectares of the state's forest land has so far been encroached i.e. around 13% of its forest area. While the BJP government has taken it seriously and

evict "encroachers" from nearly 1,900 hectares of forest and revenue land in areas, the exercise has got mired in controversy with groups saying that a certain community was being targeted.

Thus, huge infrastructure projects need to be carefully planned and executed after discussions and concurrence from engineers, geophysicists and environmentalists. In forest and rural areas, wild

animals need to be nurtured as they have been grossly neglected. And finally, there is a necessity of promoting deliberate underdevelopment in ecologically sensitive regions. Though it may seem outlandish, the rebuilding of India must be closely tied to de-populating certain overburdened areas. A clear policy on what areas should be available to tourism, what with limited tourism and no-go areas is essential. Land is vital not just for agricultural production but for the economy. We cannot afford to lose land, especially in a country like India, where the density of population is quite high compared to most other countries. But with climate change, land will be affected in various ways, primarily due to desertification and deforestation as also land subsidence but this cannot be allowed to continue as the rural economy will greatly suffer and affect the poorer sections of the population for whom land is the only resource for survival. Thus, environmentalists need to come forward to evolve an effective strategy to save land and forests to optimise this valuable resource.

We must not let AI become another domain where decision-makers ask for forgiveness rather than permission. That is why the United Nations High Commissioner for Human Rights and others have called for moratoriums on the adoption of AI systems until ethical and human-rights frameworks have been updated to account for their potential harms.

Crafting the appropriate frameworks will require forging a consensus on the basic principles that should inform the design and use of predictive AI tools. Fortunately, the race for AI has led to a parallel flurry of research, initiatives, institutes, and networks on ethics. And while civil society has taken the lead, intergovernmental entities such as the OECD and UNESCO have also gotten involved.

The UN has been working on building universal standards for ethical AI since at least 2021. Moreover, the European Union has proposed an AI Actthe first such effort by a major regulator - which would block certain uses (such as those resembling China's social-credit system) and subject other highrisk applications to specific requirements and oversight.

To date, this debate has been concentrated overwhelmingly in North America and Western Europe. But lower- and middle-income countries have their own baseline needs, concerns, and social inequities to consider. There is ample research showing that technologies developed by and for markets in advanced economies are often inappropriate for less-developed economies.

If the new AI tools are simply imported and put into wide use before the necessary governance structures are in place, they could easily do more harm than good. All these issues must be considered if we are going to devise truly universal principles for AI governance.

Recognising these gaps, the Igarapé Institute and New America recently launched a new Global Task Force on Predictive Analytics for Security and Development. The task force will convene digital-rights advocates, publicsector partners, tech entrepreneurs, and social scientists from the Americas, Africa, Asia, and Europe, with the goal of defining first principles for the use of predictive technologies in public safety and sustainable development in the Global South.

Formulating these principles and standards is just the first step. The bigger challenge will be to marshal the international, national, and subnational collaboration and coordination needed to implement them in law and practice. In the global rush to develop and deploy new predictive AI tools, harm-prevention frameworks are essential to ensure a secure, prosperous, sustainable, and human-centered future.

In all, 740,973 hectares of forest land has been encroached upon in the country. The north-eastern states alone make up 60% of the total (with 460.000 hectares being encroached upon). Another data found that Uttarakhand lost 70% forest land which comes to around 50,000 hectares of its forests for so-called developmental activities in past two decades. And the result of such activities has been manifest, with huge land subsidence, destruction of habitats and displacement of people.

Coming to highways and roads that are constructed and expanded, this may seem like a major ad vance, but these benefit the upper echelons of society while the poor, whose lands are taken for such expansion, are at the receiving end. A few decades back, there was no compensation worth the name. while in recent years such compensation is far below market costs. Moreover, the money given to the illiterate and half educated is, in most cases, not judiciously used. Such a development strategy is neither economically sound nor

ompensatory development works on the premise that everything slum land, forests, tribal homes, villages – is available at a price. The past three decades have seen a steady destruction of regional plantations and the government is not quite active on this front. Keeping in view the vagaries of climate change, it is necessary to ensure strict monitoring of conversion of land for infrastructural development. No doubt such development is necessary, but it is equally necessary to ensure that the land losers are assured of alternative livelihood. Added to this, the ecological

perspective must be kept in mind. Reports of house collapse are common and only a few days ago it was reported that dozens of houses collapsed in two villages, in Jammu and Kashmir due to land subsidence and mud slides that residents have linked to two high profile road and railway projects. Even in Joshimath, land subsidence has increased substantially in past few weeks since its impact became visible, according to the Wadia Institute of Himalayan Geology. The main reason for this is the construction of a tunnel just below it by NTPC to draw water from Alaknanda and Dhauliganga.

# After CBI, ED now arrests Sisodia BJP targets leaders

New Delhi, March 9: The Enforcement Directorate Thursday arrested AAP leader and former deputy chief minister Manish Sisodia on money laundering charges in connection with alleged irregularities in the Delhi excise policy, official sources said. The 51-year-old was placed under arrest under the Prevention of Money Laundering Act (PMLA) following his second round of questioning at the Tihar jail, they said.

The arrest of the AAP politician, a former journalist, by the federal probe agency comes a day before his bail plea will come up for hearing on March 10 before a CBI court. However, his judicial custody is till March 20.

The ED alleged that Sisodia was "evasive" in his replies and was "not cooperating in the probe" and hence was arrested.

The agency is expected to obtain a production warrant from a special PMLA court and then produce him before it Friday seeking his custody for interrogation. Sisodia is currently lodged in

judicial custody after the CBI arrested him February 26 in connection with alleged corruption in the formulation and implementation of the now-scrapped Delhi liquor or excise policy for



2021-22. New Delhi/Hyderabad, March 9: Ahead of her appearance before the Enforcement Directorate (ED) in the Delhi excise policy scam case, BRS leader K Kavitha Thursday said she has done nothing wrong and alleged that targetting leaders using probe agencies has been the BJP's modus operandi at the time of elections.

She was summoned by the ED to depose before it Thursday, but the agency agreed to her request to appear March 11 as she has announced a hunger strike March 10 in support for the women's reservation bill.

Addressing a press conference here, Kavitha attacked the BJP government at the Centre, alleging it of using the investigation agencies to target political parties and leaders who do not subscribe to its ideology.

Since last June, the central government has been constantly sending agencies such as the ED to Telangana, Kavitha Kalvakuntla (44), a Bharat Rashtra Samithi (BRS) MLC, said. It has conducted Income Tax raids on more than 500 businesses, NIA raids on 500 to 600 people, ED raids in 200 places and CBI raids in 100 places, Kavitha alleged

Asked why her father and brother KT Rama Rao are silent on the ED notice to her, she said, "Why should my father and brother speak about the ED issue. The entire party, 15-16 MLAs and small leaders have been targeted. That has been the attitude of the BJP unfortunately in every state. If we speak about it and make a big issue, the media will say we got scared.<sup>2</sup>

There is a need to expose the "diversion tactics of the BJP" today by all political parties, she said and added "that is what we are trying to do". Kavitha said she could have appeared before the ED on Thursday and cancelled her demonstration. "I want to prove a point that your diversion tactics will not work." she said attacking the BJP. The BJP first sets up a "narrative" and then looks for "characters" to target. This has been its

agenda against political parties,

leaders or businessmen who do



not subscribe to its ideology, the BRS leader claimed.

Resultant, investigations are opened in cases in states where elections are due, she alleged and claimed that there is no ED probe in friendly states or against friendly leaders and businessmen. Heads of agencies and organisations such as the ED, the SEBI and the LIC are also given extensions to get the BJP's work done, Kavitha alleged.

BJP national general secretary Santhosh is named by the Telangana Police as a suspect in a case of alleged attempt to poach four BRS MLAs and he is "filing case after case and taking stay after stay", she said. On her request to the ED to defer the date of her appearance, Kavitha said she suggested to the agency to hold the interrogation" at her house.



Kolkata, March 9: As the figure of deaths of children getting admitted to hospitals with Adenovirustype syndromes is increasing, a team from the National Commission for Protection of Child Rights (NCPCR) has arrived in West Bengal to review the situation.

The central team is expected to hold meetings with the top officials of the state health department and also expected to make a visit to the hospitals from where the deaths of children with related symptoms have been reported.

The visit of the central teams is happening a day after the chairperson of West Bengal Commission for Protection of Child Rights (WBCPCR) Sudeshna Roy and the commission's advisor Ananya Chakraborty Chatterjee visited two hospitals in Kolkata reporting child deaths and reviewed the situation.

After reviewing the situation both expressed satisfaction over the treatment and the infrastructure facilities at the pediatric division of the hospitals where they made surprise visits. Both of them claimed that the rate of admission with severe symptoms has declined during the last few days. The two state-run hospitals where they made the surprise visits were Calcutta Medical College & Hospital and BC Roy Children's Hospital. Incidentally, the maximum re-

to end dog menace: Experts

At times, people shout at stray dogs, kick or beat them with sticks. throw stones at them and abuse them in other ways that make them feel severely threatened

Jaipur, March 9: There have been many reports of stray dogs attacking humans, but why does the most human-friendly animal turn ferocious?

Basically it is because they are left hungry and thirsty on the streets; there are no caretakers or very few people who care for them, animal experts said. Speaking with reference to an incident reported on February 28 in which a monthold baby boy was mauled to death by stray dogs in a district hospital in Sirohi district of Rajasthan, the experts said that the incident needs to be studied in depth.

Why are there no water vessels being kept on the streets? Why is there no food available for them? Why are they not being vaccinated and why do drivers continue to drive at top speed even when they see these dogs roaming on the roads? The cruelty being shown by humans towards these mute animals makes them ferocious.

Arjun Gothwal, manager of a dog rescue centre called Help in Suffering, said, "We generally get 60-70 complaints daily of dog menace from different societies in Jaipur, we bring them to our centre, feed them, treat them and vaccinate them.

"We have analysed that most of the times, when they come to our centre, they are hungry and thirsty and hence become ferocious unable to bear the hunger pangs. So humans need to care for these animals.

In the Sirohi incident the infant was picked up when he was reportedly sleeping next to his mother. His body was found outside the hospital ward. CCTV footage showed that two dogs went inside the TB ward of the hospital and one

of them returned with the infant. Animal rights experts said the

only long-term solution to the issue is sterilisation and vaccination of stray dogs. Gothwal said that the incidents of dog attacks are very sad and tragic. Dogs are friendly, social animals who would not normally attack a human. We have hundreds of dogs at our centre and they are all very friendly and have never attacked us, he added.

However, at times, people shout at stray dogs, kick or beat them with sticks, throw stones at them and abuse them in other ways that make

them feel severely threatened. Radhika Survavanshi, campaigns manager, PETA India said, "An effective sterilisation program can help prevent this as stray dogs are surgically neutered and then located in their own area. They can also be vaccinated against rabies. Since territories are not left vacant, new dogs cannot enter.'



Shimla, March 9: Road accidents in Himachal Pradesh have claimed 6,530 lives and left 26,600 people injured in the past six years, with pedestrians being hit in 22 per cent cases and accounting for 15 per cent deaths, according to police data.

Road accidents per 10,000 vehicles in the hill state was 17.1 per cent as compared to the national average of 15.1 per cent in 2019, while the number of accidental deaths per 10.000 vehicles was seven per cent compared to 5.1 per cent at the national level, the police data stated.

Tokyo, March 9: Three people have been arrested in Japan over unhygienic pranks at a conveyorbelt sushi restaurant after footage of their antics -- dubbed "sushi terrorism" -- sparked outrage online.

Police accused the young trio of seeking to obstruct business at major restaurant chain Kura Sushi, which was bombarded with customer complaints after the video went viral. The clip shows one member of the group grabbing a piece of sushi from a plate as it passes, shoving the whole morsel

into their mouth and then drinking soy sauce directly from a communal bottle.

Similar videos filmed at different chains surfaced last month on platforms including Twitter and TikTok, with some apparently weeks or even years old

Other unsavoury pranks included customers touching moving pieces of sushi with a freshly licked finger, or sucking the rim of a teacup before placing it back on a shelf. Local police said Thursday that three people from the central Aichi region had been arrested. A police spokesman said 21-year-

old Ryoga Yoshino and an unnamed 15-year-old girl were arrested Wednesday, while the group's third member, a 19-year-old man whose identity was also withheld, was collared last month.

The arrests are believed to be the first in the saga which caused an uproar in Japan, a country with

famously high standards of cleanliness. The group's antics forced employees at Kura Sushi to perform emergency cleaning, "making normal business operations difficult," the police spokesman added. While no charges have yet been filed, "forcible obstruction of business" can involve stiff penalties

under Japanese law -- including a potential three-year prison term. The company that operates Kura Sushi, which has nearly 500 outlets in Japan, welcomed the arrests in a statement. "We sincerely hope the arrests will spread awareness in society that these pranks, which fundamentally undermine our system based on a relationship of trust with customers, are a crime, and that there will be no copycat acts in future," the firm said.

Among other chains affected by the series of incidents is Sushiro, which saw its stocks plummet last month after a video showed an apparently teenage customer licking the top of a shared soy sauce bottle at one of its shops. "This is sickening," one Japanese Twitter user wrote in response at the time, with another adding: "I can't go to conveyor belt sushi restaurants anymore."

NEW DELHI, March 9: India faces a high risk of nighttime power cuts this summer and in coming years, as delays in adding new coal-fired and hydropower capacity could limit the country's ability to address surging electricity demand when solar energy is not available.

A rapid addition of solar farms has helped India avert daytime supply gaps, but a shortage of coalfired and hydropower capacity risks exposing millions to widespread outages at night, government data and internal documents

reviewed by Reuters show. India's power availability in "non-solar hours" this April is expected to be 1.7% lower than peak demand - a measure of the maximum electricity requirement over any given time, an internal note by the federal grid regulator reviewed by Reuters showed.

April nighttime peak demand is expected to hit 217 gigawatts (GW), up 6.4% on the highest night-

India is yet to finalise legislation and regulations surrounding cryptocurrencies even as the country's central bank has cautioned against their use multiple times. The Reserve Bank of India has

said that cryptocurrencies should be banned as they are akin to a Ponzi scheme.

Extending India's money laundering rules to cryptocurrencies will give authorities greater authority in monitoring the transfer of these assets beyond the country's borders.

New Delhi, March 9: Billionaire Mukesh Ambani's Reliance relaunched the 50-year-old iconic beverage brand Campa Cola in a new contemporised avatar as it looks to ramp up its own consumer goods offering to take on competition from Adani, ITC and Unilever.

In January this year, Reliance Consumer Products Ltd, the fastmoving consumer goods arm of Reliance Retail, acquired a 50 per cent stake in Gujarat-based car-

bonated soft drinks and juice maker Sosvo Hajoori Beverages Pvt Ltd. It had previously acquired the Campa brand from Pure Drinks group for a reported ₹22 crore. And now, it has re-launched the Campa brand of beverages. The Campa portfolio will ini-

tially include Campa Cola, Campa Lemon and Campa Orange in the sparkling beverage category," the company said in a statement, adding the cold beverage portfolio will initially be available in Andhra Pradesh and Telangana and will be



rolled out across the country in stages. Pure Drinks Group was the sole distributor of Coca-Cola in India from 1949 to the 1970s. It

launched its own brand Campa Cola in the 1970s, and soon became the market leader in the soft drinks segment. Later on, it introduced Campa Orange, the orangeflavoured aerated drink.

The firm, which had two bottling plants in Mumbai and Delhi. sold the beverages with the slogan 'The Great Indian Taste' but lost business in the 1990s with the opening up of the economy.

Reliance Consumer Products Ltd (RCPL), the statement said, is bringing "back 'The Great Indian Taste' with Campa'

The re-launch of Campa is part of Ambani's bid to accelerate penetration into the nation's rapidly growing consumer goods market with Reliance's own versions of products, ranging from soap and shampoo to cookies and cola.

Reliance Retail runs the country's largest network of brick-and-mortar stores with around 17,225 sites, selling everything from groceries to electronics. It already owns about two dozen consumer goods brands, including the Good Life and Best Farms ranges of staple foods, such as rice and other grains, Snac Tac snacks, Glimmer cosmetics, Yeah! fizzy drinks and fruit juice label Sosyo.

RCPL is the FMCG arm and a wholly-owned subsidiary of Reliance Retail Ventures Limited (RRVL).

Speaking on the launch, RCPL spokesperson said, "By presenting Campa in its new avatar, we hope to inspire consumers across generations to embrace this truly iconic brand and trigger a new ex-

citement in the beverage segment. While older family members will have fond memories of the original Campa and cherish the nostalgia associated with the brand, younger consumers will love the crisp refreshing taste. With a rapidly evolving Indian market throwing up more consumption occasions, we are truly excited to bring back Campa, which is yet another bold step forward for our expanding FMCG business.<sup>3</sup>

Five thirst-quenching pack sizes will be offered under the Campa range for several consumption occasions: a 200ml immediate consumption pack, 500ml and 600ml onthe-go sharing packs and 1,000ml and 2,000ml home packs. The com-pany, however, did not indicate the pricing of Campa.



# Khawaja ton props Australia

**OPENER'S 14TH TEST CENTURY PUTS THE VISITORS IN A COMFORTABLE POSITION AS THEY REACH 255/4 AT STUMPS ON THE OPENING DAY OF THE FOURTH AND FINAL TEST**

Ahmedabad, March 9: Usman Khawaja combined patience with grit to raise his 14th Test hundred (104 batting, 251b, 15x4) that guided Australia to a comfortable 255/4 as a keen contest between bat and ball marked the opening day of the fourth and final match, here Thursday.

After dominating the batters in the first three matches of the series, the Indian spinners struggled to trouble the Australians with the Motera track, as anticipated, turning out to be a better wicket.

Khawaja, Australia's best batter on the tour, was determinationpersonified throughout his sixhour stay. At stumps the Pakistan-born Khwaja had Cameron Green (49 batting, 64b, 8x4) for company.

As a southpaw, neither does Khawaja have the panache of someone like a David Warner nor the brute power of a Matthew Hayden, who was capable of executing slog sweeps fetching deliveries from wide outside the off-stump.

His game maybe pretty low on aesthetics but is highly impactful as he came across as a batter, who wouldn't try anything which is outside his comfort zone. Anything pitched on his legs was punished through the leg-side while the occasional cover drive would come out of the closet.

Otherwise, it was just playing the ball late and rocking on the backfoot, while whipping Ravichandran Ashwin (1/57) and Ravindra Jadeja (1/49) through the square-leg or mid-wicket region.

It was only fitting that an ondrive off Mohammed Shami (2/65). brought up what would be one of his most cherished Test hundreds that he celebrated with his now-customary leap in the air.

For someone, who faced racism

during his early years, with typical Asian stereotype jibes like 'Curry Muncher', life did make Khawaja mentally tough and he has shone through time and again during his second coming – be it Sydney, Karachi, Rawalpindi, Delhi

or now in Ahmedabad. It did help that there was no devil on the Motera track and with no significant help on offer, India's spin troika of Ashwin (1/57), Jadeja (1/49) and Axar Patel weren't as effective compared to first three games. Save Shami's lethal reverse swing

to get Peter Handscombe castled,

off wicket-taking deliveries and could be attributed to lapse of concentration on part of batters. It was a track where if one even

got deceived in the air, the slowness off the surface ensured that playing on backfoot became second line of defence. Run scoring wasn't easy but surviving and slowly building an innings wasn't difficult either as Khawaja showed. Twice Australia lost back-to-back wickets but prior to that and after that, Khawaja remained a constant factor.

He had partnerships of 61 for

the opening stand with Travis Head (32), 79 for the third wicket Steve Smith (38) and another 103 for the fifth wicket with Green, who counter-punched towards the end of the day.

The run-rate of 2.83 would show that scoring wasn't very easy, save the first hour when Head hit Umesh Yadav for a flurry of boundaries. There is nothing in the track and Australia, if they apply themselves well, could post their best total of the series.

Head, in fact, must be feeling horrible as he undid all his good

work in the first hour by playing an indiscreet shot. He tried to chip Ashwin over mid-on without reaching to the pitch of the delivery.

Ashwin had just altered the length slightly and deceived Head, who offered the easiest of catches to one of the world's best fielders, Jadeja. Head got a reprieve while batting on seven when wicketkeeper KS Bharath dropped a regulation catch off Umesh Yadav's bowling. Yaday, who usually invites criticism for his inconsistency, was once again erratic as he gave a lot of boundary balls.

The end from which Shami bowled, a lot of deliveries kept low and one such ball brought about the downfall of Marnus Labuschagne.

It was an off-cutter and Labuschagne wanted to play the square cut but dragged it back onto the stumps. But then Khawaja took over and made sure Australia had their best opening day of the series.

I don't think I have ever smiled so much en getting a century, there was emotion in it. I have done two (Test) tours of India before (2013 and 2017). Carried the drinks for eight Test matches before I got a chance here. Throughout the middle of my career I got told I couldn't play spin and that's why I never got an opportunity to play in India. It's just nice to go out there and tick off a hundred in India which was something if you asked me five years ago if you told me that I would think you were crazy


