Rahul disqualified from LS

CONGRESS SAYS WILL FIGHT LEGALLY AND POLITICALLY; BJP TERMS ACTION 'LAWFUL'

New Delhi, March 24: Former Congress president Rahul Gandhi was Friday disqualified from Lok Sabha following his conviction by a Surat court in a 2019 criminal defamation case, an action the party termed an attempt to 'silence' his voice as it vowed to fight the battle legally and politically.

The BJP dismissed the charges and termed the disqualification

The disqualification, which will bar 52-year-old Gandhi from contesting polls for eight years unless stayed by a higher court, saw a shift in the dynamics of Opposition ranks with Trinamool Congress and Aam Aadmi Party also expressing strong support for the embattled leader, along with several other Opposition parties. Announcing his disqualification, the Lok Sabha Secretariat in a notification said that it was effective from March 23, the day of his conviction.

"Consequent upon his conviction by the Court of Chief Judicial Magistrate, Surat...Rahul Gandhi, Member of Lok Sabha representing the Wayanad Parliamentary Constituency of Kerala stands disqualified from the membership of Lok Sabha from the date of his conviction i.e. 23 March, 2023," the notification read.

This was Gandhi's fourth Lok Sabha term. First elected to Lok Sabha in 2004 from Amethi, he rep-

The court in Surat sentenced Thursday Gandhi to two years in jail in a defamation case, filed on a complaint by BJP MLA Purnesh Modi for his alleged remark, "How come all thieves have Modi as the common surname?"

Hours before the notification was issued, Gandhi attended Lok Sabha proceedings in the morning session. Before the proceedings commenced, he also participated in a meeting of party MPs in the Parliament complex.

Incidentally, the Congress-led United Progressive Alliance government, in 2013, had attempted to circumvent a Supreme Court ruling to set aside an RP Act provision under which a person sentenced to imprisonment of two years or more shall be disqualified "from the date of such conviction" and remain disqualified for another six years after serving time. A month later, a BJP municipal councillor of Ahmedabad had filed another defamation case against Rahul for calling then BJP president Amit Shah a 'murder accused' at an

Deadline extended for Aadhaar, voter ID linking

New Delhi, March 24: The Union line for voluntary linking of Aadhaar with voter identity card upto March 31, 2024. Earlier, the deadline was April 1, 2023. Significantly, the Election

Commission of India (ECI) vide its instruction dated July 4, 2022, had launched the programme to collect the Aadhaar numbers of existing and prospective electors on a voluntary basis from August 1 last year in all states and Union Territories. "It is voluntary to link Aadhaar

with voter ID and consent is obtained from the elector for Aadhaar authentication in Form 6B. Though, there is no provision for withdrawing the consent," Union Law Minister Kiren Rijiju had told the Lok Sabha in December last year.

The linking of Aadhaar with voter cards was authorised following the passing of the Election Laws (Amendment) Bill in the Parliament in December 2021. Rijiju



had said that the move was made with the intention to ensure that the electoral roll in the country remained genuine.

The decision received widespread criticism from the Opposition parties questioning the constitutionality of linking Aadhaar, which is still not seen as a proof of citizenship, with the voter ID. The Opposition raised apprehensions that the interlinking of Aadhaar with the voter ID card would leave out many eligible voters from the electoral roll.

'Ashirbad' cover for 50,952 kids who lost parent during Covid

Bhubaneswar, March 24: The 50,952 children aged below 18 years who have lost either their mother or father or both parents due to Covid-19 and other reasons in Odisha during the pandemic so far.

During Covid, the state government has launched the Ashirbad scheme, under which financial assistance is being provided to these children, said Women and Child Development Minister Basanti

Hembram in Assembly Friday. In a written reply to a question by Congress MLA Taraprasad Bahinipati, the Minister said the government is providing ₹2,500 per month to a child who has lost both parents while a child who has lost a parent who was also the breadwinner for the family is receiving ₹1.500 per month. Besides, ₹1000 per month is being provided to each orphan child, who resides in any child care institution, she said, adding, the assistance will continue till the child attains 18 years of age.

disqualification of Rahul Gandhi's membership from Lok Sabha had its reverberations in Odisha Assembly Friday with Congress lawmakers creating a din leading to several adjournments.

The Congress members trooped into the well of the House as soon as it assembled for the post lunch session at 4 pm. They shouted anti-BJP slogans and demanded justice for Gandhi, who was disqualified from Lok Sabha on being convicted in a defamation case.

Unable to run the House due to the ruckus, Speaker BK Arukha first adjourned the proceedings for 20 minutes and thrice again for 30 minutes each as protests continued every time it re-

assembled. Congress Legislature Party (CLP) leader Narasingha Mishra told reporters outside the House that Rahul Gandhi was a "victim of a deep rooted conspiracy."



There is no democracy in the country now," he said adding that Rahul Gandhi will move the higher court for relief.

Congress chief whip Taraprasad Bahinipati said Rahul Gandhi is targeted as he exposed the BJP government. "He is kept out of Parliament as BJP fears that he will expose them more, Bahinipati said.

Opposing the comments, Leader of Opposition Jaynarayan Mishra of BJP said Gandhi was convicted in a court of law. "There is provision in law that anyone getting convicted with an imprisonment term for two or more years will



law take its own course.' "Both BJP and the Congress are same for us. Therefore, we will not like to comment on the matter," senior BJD leader and Revenue and Disatser Management Minister

Pramila Mallick said. BJD member Bhupinder Singh, however, described Gandhi's disqualification as "unfortunate".

When the House reassembled, the Leader of Opposition said since Rahul Gandhi is not a member of the House, Congress members have no right to stall its proceeding. At this there was an heated exchange of words between Congress and BJP members.

The CLP leader said the party's Cuttack MLA was convicted in a case. However, he did not lose membership because of the liberal attitude of the state government and speaker. He was given time to appeal in a higher court.

Alien comet's strange acceleration explained

THE ANTI-GRAVITATIONAL BEHAVIOUR OF 'OUMUAMUA, THE COMET THAT FIRST MADE ITS APPEARANCE IN 2017, PERPLEXED SCIENTISTS AND PUBLIC ALIKE

New Delhi, March 24: Hydrogen gas releasing, as the ice present on the comet 'Oumuamua's surface changed its form from amorphous to crystal, could be the reason behind the strange acceleration of the comet while going away from the Sun, ac-

cording to scientists. The argument has been put forth by a University of California (UC), Berkeley, astrochemist and a Cornell University astronomer, both from the US, and the conclusions appear in the journal Nature.

The behaviour of 'Oumuamua, the comet that first made its appearance in 2017, perplexed scientists and public alike.

The first known visitor from outside our solar system and having a peculiar shape, the comet 'Oumuamua was unusual in that it



had no bright coma - a luminous cloud of particles - or a dust tail and it was small in size akin to an asteroid.

The behaviour in question was the comet firing up and accelerating away from the Sun in a way that astronomers could not explain. Some even suggested that it was an alien spaceship.

Further, because the comet was so small, its gravitational deflection around the sun was slightly altered by the unusual acceleration.

Comets, which are icy rocks left over when the solar system formed 4.5 billion years ago, can tell astronomers about the conditions that existed when our solar system was

Interstellar comets, present between or among stars, also can carry information about other stars surrounded by planet-forming disks. "Comets preserve a snapshot of what the solar system looked like when it was in the stage of evolution that protoplanetary disks are now," Jennifer Bergner, a UC Berkeley assistant professor of chemistry.

However, unlike other comets, astronomers did not detect a coma, or outgassed molecules or dust around 'Oumuamua, which is Hawai'ian for "a messenger from afar arriving first."

So, what caused the acceleration? "A comet traveling through the interstellar medium basically is getting cooked by cosmic radiation, forming hydrogen as a result. Our thought was: If this was happening, could you actually trap it in the body, so that when it entered the solar system and it was warmed up, it would outgas that hydrogen? Bergner said.

"Could that quantitatively produce the force that you need to explain the non-gravitational acceleration?" said Bergner.

From past experiments, Bergner found that high-energy electrons, protons and heavier atoms are capable of converting water ice into molecular hydrogen, which would be trapped in bubbles within the ice by the fluffy, snowball structure of the comet. Contd...P4







New Delhi, March 24: Over 500 parents of children affected by rare genetic disorder Duchenne Muscular Dystrophy (DMD) from 21 states, including Odisha, took out a rally at Jantar Mantar here Friday to press for immediate treatment and

Odisha DMD Association (ODMDA) president Bishnu Charan Panigrahi, who led the delegation of at least 16 parents from the state, said research should be carried out for its medicine in the country.

"As long as the medicine is not available, the government should provide assistance to the parents of DMD-affected children. Despite challenges posed by the disease, the children are studying hard to become financially independent. However, they are not receiving any support from the government," Panigrahi, who hails from Odisha's Jajpur, said.

About DMD, Ratan Kumar Pradhan, a resident of Odisha's Keonjhar and father of Arpita, 14, diagnosed with the disease, said it is a rare genetic disorder that causes progressive muscle loss in children.

'The child starts showing symptoms at the age of 6-7 years when it walks on the toes. The disease, in the form of a defective dystrophin gene, which hinders the production of very vital dystrophin protein, has been present since birth. Growing rapidly, soon it engulfs every muscle of the body including the heart and lungs. Subsequently, the child becomes wheelchair-bound. Most of them don't live beyond their 20s. which is of serious concern. We are seeing our children dying every day," Pradhan pointed out.

He demanded that the government should focus on creating awareness about the disease by introducing lessons in the school curriculum. "A subject on various types of muscular dystrophy should also be introduced in the curriculum. When my daughter was diagnosed with it, I was totally in the dark. I didn't know about the disease. Massive awareness needs to be created on this. The cost of physiotherapy for the children is over ₹1 lakh annually, while the cost of treatment is over ₹15 crore which is available abroad. I urge Prime Minister Narendra Modi and Health Minister Mansukh Mandaviya to initiate research on the disease. The government should constitute expert committees," Pradhan suggested. Sangramiit Dash, a resident of

Odisha's Cuttack whose son Satamanyu is diagnosed with the disease, said there is no treatment for DMD in the country. "While companies like Pfizer and Sarepta have been at an advanced stage of their research. It is yet to take place in India. I have travelled all over the country but couldn't find a cure. The government needs to do research and development on the disease. The children as well as parents face a lot of problems. The children need round-the-clock assistance from parents. This has been spreading fast in India also and research is needed to find out its causes,' Dash said.

The parents have also submitted a memorandum to the Union

Quality edu, school infra singe Assembly

Bhubaneswar, March 24: Opposition BJP and Congress MLAs Friday attacked the state government in the Assembly alleging that it has failed to provide quality education to the students.

Participating in a debate on the admissibility of an adjournment motion, Opposition chief whip Mohan Majhi alleged that the future of the students is pushed to the dark in the name of transformation of schools under 5T initiatives.

The BJP legislator said as many as 11,710 schools in the state are without electricity, 11,665 schools do not have playgrounds, 6,781 do not have the required classrooms and 27,319 are managing with one classroom each. There is a requirement of about 1.5 lakh teaching posts. In the academic year 2021-22, the dropout rate at secondary level stood at 27.26 per cent, which is the highest in the entire country, Majhi said.

Participating in the debate, Congress Legislature Party (CLP) leader Narasingha Mishra said economic and social development will be impossible until education is not developed, and poverty alleviation cannot happen without edu-

Despite 23 years of stable government, education has not received importance as required, he added.

The state government has recruited the teachers in different categories. Dissatisfaction is

rising among the teachers due to the salary structure. They are protesting on the streets without imparting education in schools, Mishra said. Replying to the motion, School and Mass Education Minister Samir Ranjan Dash blamed the central government for the lack of the required infrastructure in the schools.

The central government is paying ₹1,258 crore for 92,337 teachers, which is only ₹11,000 per teacher. But the state government is paying a minimum salary of ₹33,000 to a teacher.

LJayanarayan Mishra Friday targeted the state government in the Assembly over alleged rising malnutrition among children and demanded a statement from the Women and Child Development Minister on

He alleged that the atrocities on the tribals compounded after the killing of three CRPF jawans in Nuapada district June 21 last year. Mishra said some villagers

were taken to Kolkata by the National Investigation Agency (NIA) for questioning into the jawans' killing. "But they could not say any-

thing as the villagers were ignorant about the incident. Still police tortured them in the name of an anti-Maoist operation," he said.

The Congress leader said locals had March 18 held a

rally protesting the police atrocities.

"The state government and the police are silent over the issue. But, we the Assembly, cannot remain mute spectators to the torture on the people in the name of an anti-Maoist operation," he said, while asking the Speaker to sent a House Committee to the affected village.



The first patient was a 43 year old patient who had been on dialvsis since November 2022 and was suffering with Type II DM, diabetic nephropathy and end stage kidney disease. His Mother (62/F) donated her kidney to him.

The second patient, a 20 yearold man had both kidney failures due to Posterior Urethral Valve Leading to chronic VUR. He was undergoing dialysis since December 2022. Since both his kidneys failed, he was advised to undergo kidney transplant. His Mother (46/F) donated her kidney to him.



In TB elimination activity in the country, Odisha had secured 2nd and 3rd place in 2020 and 2021 respectively. In the year 2021, three districts (Jagatsinghpur, Kendrapara and Bargarh) had qualified for bronze certificate in TB elimination efforts. In 2022, 13 districts and State as a whole is competing for sub-national certification.

Man sentenced to life for killing wife

Balasore, March 24: Balasore Additional Sessions Judge Biswajit Das Friday convicted a man on the charge of killing his wife and sentenced him to life imprisonment along with a penalty of ₹6,000. In default of the penalty the convict would further undergo another one-year jail term, the judge ordered. Bijay Das, a resident of Koilisahi

under Basta police station, was found guilty by the court of killing his wife. The court pronounced the judgment after examining 16 witnesses and 20 exhibits, Special Public Prosecutor Pranab Panda said.

The police took action against the accused based on the FIR filed by the sister of the deceased who alleged that her sister Minati Das was regularly tortured physically as well as mentally by the accused even after 8 years of their marriage for nonfulfilment of dowry demands. She said the accused killed her sister the previous night and absconded. The accused was booked under several sections of IPC including 498-A,304(B), and 302, Panda said.

Ayurvedic hospitals battle for survival in undivided Koraput

Sunabeda/Semiliguda/Nandapur, March 24: The state government has established 67 ayurvedic hospitals in undivided Koraput district but lack of infrastructure, manpower and proper medicines has hit their functioning and treatment of visiting patients, a report

There was a time when ayurvedic treatment was given utmost importance as it was very cost-effective, organic and free from side effects. However, with passage of time and advent of allopathic medicines, the traditional form of treatment has lost its popularity to a great extent.

As a result, 67 ayurvedic hospitals established in the undivided Koraput district are in a dilapidated condition much to the discomfort and resentment of visiting patients and their attendants

The damaged infrastructure of a Government Ayurvedic Hospital at Hataguda village under Panthalung panchayat of Nandapur block in Koraput district is a case in this point. The residents of 23 panchayats under Nandapur block are dependent on this ayurvedic hospital for healthcare. However, with the walls and asbestos roof beginning to crumble, patients are slowly turning away from this hospital.

A doctor Shibaram Murmu said that patients having various ailments are visiting the hospital on a daily basis. However, the unavailability of proper medicines has hit their treatment. Moreover, shortage of manpower is another roadblock in the treatment of patients. "I have been appointed at Hataguda hospital but also have to visit Debgandhana hospital under Lamtaput block owing to inadequate number of doctors. As a re-

sult, I have to work in these two hos-

pitals on a rotation basis," he added. Sarpanch Puja Khil of Panthalung panchayat alleged that staff of these two hospitals double up as doctor and treat the patients by consulting with the doctor over phone when there is no doctor in their hospital. She demanded the state government's intervention to improve the infrastructure and staff strength in Hataguda Avurvedic hospital

When contacted, AYUSH director Kashi Biswanath Soren confirmed the development. He said that issues like absence of proper infrastructure, doctor and manpower shortage are not only limited to Nandapur block but the situation is the same all over the undivided Koraput district.

Soren said there are 67 avurvedic hospitals in undivided Koraput - 18 hospitals for 14 blocks of Koraput, 22 in

Nabarangpur, seven in Malkangiri and 20 in Rayagada district.

All the hospitals are very old and lack proper infrastructure, doctors and manpower. He said there are nine doctors, 11 assistants, two peons in 18 hospitals of Koraput; 10 doctors, eight assistants and five peons for 22 hospitals in Nabarangpur, and two doctors, three assistants and three peons in seven hospitals of Malkangiri district. Similarly, there are six doctors, 13 assistants and four peons in 20 hospitals of

Rayagada district. The situation has become dire as 15 doctors on the alibi of studying in PG course have been posted in the hospitals in Puri, Khurda and Cuttack districts while the attention of the departmental authorities has been drawn to appoint more doctors and staff in these hospitals, he added.

Woman, lover arrested over husband's murder

Berhampur, March 24: A 30-year-old woman and her 42-year-old lover were arrested in connection with the murder of her 37-year-old husband in Ganjam district, police said Friday.

Misplaced Priorities

n a move that has raised eyebrows, the Maharashtra government has decided to shift the Marine Drive police station to make way for luxury apartments for senior babus and police officers.

Sources have informed DKB that the state government is facing a shortage of official quarters, with over two dozen retired bureaucrats being posted on various government commissions and organisations. This shortage led to the decision to build Yashodhan-2, a seven-storey building with 24 apartments in the Churchgate area. The decision has been criticised, as Yashodhan is one of the most sought-after government residences by IAS and IPS officers. The new apartments will be allocated to officers above the rank of principal secretary and inspector-general of police.


While the Shinde government claims that the apartments are necessary to address the housing needs of senior officers, many feel that this is a blatant misuse of public funds. While most agree that there is a need for more apartments, it is important that these are allocated based on merit and not simply handed out to senior officials.

Shifting the Marine Drive police station to make way for luxury apartments is particularly concerning, as it suggests that the government is more interested in catering to the needs of its officials than in serving the public. Senior officials at the state Home Department and the Chief Minister's Office (CMO) are trying to ensure that the issue is swiftly dealt with before it escalates and embroils the state leadership.

Centre's surprising move at LIC

The Modi government's decision to appoint Siddhartha Mohanty as interim chairman of Life Insurance Corporation of India (LIC) has raised several questions. The move comes as a surprise, especially since it was widely expected incumbent chairman Mangalam Ramasubramanian Kumar to re-

ceive another extension. Kumar had already been given two extensions, including one that has now ended. So why did the government pull the plug on him?



formance of LIC's IPO, which may have contributed to the decision. Another is the revelation of LIC's investments in the beleaguered Adani Group,

Mohanty's appointment as interim chairman also raises questions about the proposed revamp of the LIC board. The amended LIC Act 1956 requires abolishing the post of executive chairman in three years and transitioning to a CEO and four MDs. It is expected that the government will rope in private-sector individuals for these roles to bring new ideas and perspectives. But with the sudden naming of an interim chairman, it's not clear how the revamp will proceed now.

which may have added to concerns about the insurance giant's management.

On the whole, the decision to appoint Mohanty as interim chairman is a bold move that suggests that the government is keen to shake up things at LIC.

US prods MEA on China

The Ministry of External Affairs (MEA) is usually guarded in its pronouncements, so naturally, it is apprehensive about the United States identifying the McMahon Line as the international border between Arunachal Pradesh and China in a recent bipartisan Senate resolution.

The resolution went further and denounced Chinese aggression and provocations, including China trying to use force to alter the status quo along the Line of Actual Control (LAC). The US take on India's feud with China came after senior US State Department officials spoke similarly.

It appears that the US is trying to nudge the MEA and External Affairs Minister S Jaishankar into raising the ante on China's belligerent actions

The MEA spokesperson Arindam Bagchi did not respond to the US move, claiming that the ministry had not 'heard about the resolution yet'. Still, the US is taking a deep interest in the issue as part of its broader policy to contain China. Barely days after the Senate resolution, it finally announced its new ambassador to India. Eric Garcetti, a former Los Angeles mayor got the job over two-and-a-half years after his name was first nominated for the post. A Joe Biden loyalist, he is expected to work closely with Jaishankar on dealing with China, among his other tasks.

But will the MEA diplomats led by Foreign Secretary Vinay Kumar Kwatra take a more proactive stance to protect India's territorial integrity and strategic interests, given their concerns about the potential consequences of an escalation?

■ Apricate

t is unlikely this word — meaning bask in the sun — will be part of your everyday vocabulary, or even be recognised, as it is unknown outside books about defunct words - I can find only a couple even of those that include it. It derives from the Latin verb apricari, to bask in the sun or to sun oneself, which is related to apricus, of a sunny place. If it brings to mind that delicious distillation of raw sunlight, the apricot, that's a false trail. However, it has been suggested that the fruit's name may have been partly influenced by apricus during its journey from Latin praecox, early-ripening, to Greek, Arabic and Spanish and on to French and English. Apricate first appeared in English around 1690 in an anecdote by the British antiquarian John Aubrey about Sir John Danvers: "His lordship was wont to recreate himself in this place, to apricate and contemplate, with his little dog with him." Aubrey sent a copy of the manuscript to his friend John Ray, who replied in September 1691 that he wasn't critic enough to censure another man's writings but went on, "Some words I have noted, that do not sound well to my ears," among which he included apricate as a new-coined word to be avoided. Although Aubrey's text was published in 1697, the year of his death, with apricate in it, most people have since taken that advice. As long ago as 1847, James Halliwell-Phillipps included it in his Dictionary of Archaic and Provincial Words. One of the few to use it, in a figurative sense, was James Russell Lowell, in a satirical piece that appeared in the Atlantic Monthly in February 1863.

A country's monetary authority could introduce a central bank digital currency (CBDC) and provide all depositors (taxpayers) with interest-bearing accounts at the central bank. Such a system would eliminate many harriers to financial transactions by making the broader payments system more fluid.

This system would not be anything like the Wild West of cryptocurrencies and speculative pyramid schemes that have cropped up in recent years, nor would it be socialised banking. There are already plenty of fintech companies (Revolut, Wise, N26) offering sleek apps and innovative services that enable instantaneous

smartphone payments to other users who bank with competing operators. These same financial operators could access CBDC balances held by the central bank and compete for customers by minimising transaction costs.

Of course, traditional banks also compete; but they do it worse and at a scandalous cost to customers. If the interbank rate charged by the central bank is 3%, your traditional bank offers you at best 1% on a deposit, taking the other two percentage points as profit. Traditional banks can exert monopoly power because there is no instantaneous clearance for payments. In the United States, it generally takes at least two working days for a money transfer to enter your bank account. And making matters worse, traditional banks' excessive risktaking transforms your risk-free deposit into a risky investment when the bank cannot meet your withdrawal request.

With an interest-bearing CBDC, a bank run is impossible. As the lender of last resort, the central bank could issue as much money as needed if depositors wanted to withdraw their money simultaneously. And, owing to fluid, instantaneous transfers between users, competition would deliver a 3% return on those deposits. Other than traditional banks, who could possibly oppose this solution?

To be sure, traditional banks are crucial for the financial system because they create value by making loans. They monitor whether households that apply for mortgages are solvent, and whether business loans will be used for profitable investments. Because lending is always risky, even the most competitive bank will charge a spread on a loan. The same 3% interbank rate at which the bank can obtain funds today may result in a 5% interest rate for a mortgage, or a 9% rate for a risky investment by a tech startup. Some institution, such as a bank, is needed to evaluate and price these risks.

But, because banks can profit by playing with depositors' money and relying on the government to bail them out, they tend to assume too much risk. That is why academics and regulators have long argued that banks should be subiect to higher capital requirements.

When they cannot use households savings to finance risky investments or rely on government bailouts, their risk-taking will be sharply reduced.

A CBDC would bring market discipline to the banking sector. Traditional banks would be forced to focus on picking profitable loans, and they would close most of their network of retail branches. Likewise, the credit-card oligopoly that hijacks our credit-less payment system would melt like snow in the sun. In its place, we would get a fluid payment system operated by a network of competitors offering access to your CBDC account. In today's economy, households would receive 3% on deposits that are safely shielded from bank runs.

A CBDC is not imminent, though. Central bankers are scared to slaughter the cash cow of the traditional banks, under the pretext that doing so will lead to the collapse of the banking sector. The private bank lobby will strongly oppose digital innovation and seek to maintain its dominant position at the cost of the stability of the

financial system. Still, we may see CBDCs introduced sooner than anticipated. If one major economy takes the plunge, others will be forced to follow suit or risk seeing their currencies be eclipsed. That is why the Canadian central bank has already signaled its readiness to introduce a CBDC if the US decides to launch its own. If China tries to dominate international transactions with its digital renminbi, other central banks certainly will be prompted to follow suit.

Whoever takes the first major step in disrupting the banking sector, it cannot come soon enough We already have the tools to end bank runs and ensure financial stability. All we need is the will to use them.

Tokyo has formulated the strategy called FOIP which dovetails with Japan's National Security Strategy adopted last December. Among other things, the strategy suggests deployment of cruise missiles to strengthen their strike back capability as Japan faces continual missile threats from North Korea, an ally of China. It also advocates using development aid more strategically in support of like-minded countries. The FOIP flows from this strategy

Kishida announced and outlined the FOIP in the Sapru House lecture delivered in Indian Council of World Affairs (ICWA). It is estimated that FOIP is a whopping 75 billion USD project to check China's growing influence and assertiveness across the region. It consists of providing patrol vessels, enhancing maritime law enforcement and capabilities, maintaining cyber security, digital and green initiatives and economic security. In order to do so, FOIP suggests enhancement

Japan has committed in FOIP two-billion USD for maritime security equipment, enhancement of transport infrastructure needed for freedom of navigation and rulebased order in the region. Tokyo maintains that India is an indispensable partner and should play a big role in this project because of its geo-political location and New Delhi's risks with Beijing.

Japan and India's security interests converge as Beijing has been nibbling away India's territories by making incredible and illegitimate claims on Arunachal Pradesh and Ladakh. Likewise, Japan is deeply concerned as Beijing claims territories in the East China Sea including Senkaku Islands belonging to Japan and the entire South China Sea. Such claims have rattled Beijing's smaller neighbours including Japan. FOIP, therefore, is clearly aimed at countering China's egregious expansionism.

Another purpose of Kishida's visit was to somewhat align the G-20 agenda with that of G-7. G-20 has industrial and emerging market countries, which is referred to as Global South. India seems to be representing the voice of Global South in current global politics which reflects the 'active non-alignment', a

India-Japan ties are the key to the stability in the region as both countries risk territorial belligerence from Beijing. In recent periods they have developed strong bilateralism. They share special partnership and strong economic ties.

Trade between the two was worth USD 20.55 billion in fiscal year 2021-2022. In fact, India-Japan partnership covers various sectors - security, defence, trade and investment, science and technology, education and health care, critical and emerging technologies. Discussions are on to conduct joint projects in third countries in the region. FOIP may provide that opportunity.

There is a good deal of warmth between the Indian Prime Minister and his Japanese counterpart. The bonhomie between top leadership has been conducive to building seamlessly the bilateral partnership.

Kishida's visit should have, as usual, contributed to strengthening the special partnership between two countries. However, the moot point is how the two friendly countries converge their responses to the war in Ukraine and consolidate their alliance vis-à-vis China.

The Congress said it will fight the battle legally and politically for its former president. It was supported in its protest by parties such as TMC, AAP, Samajwadi Party, DMK, and BRS, which had earlier said they would maintain equal distance from both the BJP and the Congress

The Lok Sabha Secretariat Friday disqualified Rahul Gandhi as MP from Wayanad in Kerala, a day after a Surat court convicted him in a 2019 criminal defamation case for his remark "How come all thieves have Modi as the common surname?"

According to disqualification rules, he would not be able to contest elections for eight

Union Ministers Dharmendra Pradhan and Anurag Thakur also hit out at the Congress, saying the Nehru-Gandhi family suffers from "feudal mindset" and a "sense of entitlement" as its members believe in a separate set of laws and

democratic system for themselves. Union Minister of State for Law and Justice SPS Baghel termed the disqualification "lawful" as he too asserted that everyone is equal before the law.

Support for Rahul Gandhi came from parties which have stood by the Congress through the last few weeks as the party led the opposition on the Adani issue. Voices of anger, shock and disbelief came from parties such as the RJD, JMM, CPI, CPI-M, Shiv Sena, DMK, and NCP, among others.

notified Rahul Gandhi's disqualification from the Lower House of Parliament within a day after a court in Surat convicted him in a 2019 criminal defamation case and awarded two years of imprisonment to him.

"Consequent upon his conviction by the Court of Chief Magistrate, Surat...Rahul Gandhi, Member of Lok Sabha representing the Wayanad Parliamentary Constituency of Kerala stands disqualified from the membership of Lok Sabha from the date of his conviction i.E. 23 March, 2023," the notification read.

The case filed against the Congress leader was on a complaint by BJP MLA Purnesh Modi for his alleged remark, "How come all thieves have Modi as the common surname?" during the 2019 Lok Sabha polls. Unless a higher court stays Rahul Gandhi's conviction, experts said, he will continue to remain disqualified from the

Lok Sabha and also barred from contesting any election for a total of eight years, two years of jail term and another six years from the date of his release from prison, according to Section 8 of the Representation of the People

Act, 1951. As the Wayanad Lok Sabha seat in Kerala turns vacant following disqualification of Rahul Gandhi from the Lower House, the Election Commission can "technically" hold a bypoll to fill the seat as more than one year is left for conducting general elections in 2024.

The term of the present Lok Sabha expires sometime in June. An expert, who did not wish to be named, felt that the Election Commission is likely to wait for the 30-day period granted by the court to allow Rahul Gandhi file an appeal against the conviction.

With his disqualification from the Lok Sabha, Rahul Gandhi may also have to vacate his official bungalow in Lutvens' Delhi within a month if he doesn't get a relief from a

higher court, officials said. The former Congress president has been living in an official bungalow, located on 12, Tughlaq Lane, since it was allotted to him following his victory in 2014 Lok Sabha elections from Amethi constituency in Uttar Pradesh

AFSPA extended in parts of Arunachal, Nagaland



New Delhi, March 24: The Union home ministry Friday extended for six months the "disturbed area" status in parts of Arunachal Pradesh and Nagaland under the Armed Forces (Special Powers)

According to two separate notifications, the decisions have been taken after review of the law-andorder situation in both the states. The AFSPA gives armed forces areas, sweeping powers to search, arrest, and to open fire if they deem it necessary for "maintenance of public order"

The home ministry said the central government in exercise of the powers conferred by Section 3 of the AFSPA 1958 (28 of 1958) had declared the Tirap, Changlang and Longding districts in Arunachal Pradesh and the areas falling within the jurisdiction of Namsai and Mahadevpur police stations in Namsai district of Arunachal Pradesh, bordering the state of Assam as 'disturbed area' on September 30, 2022. One more police station area has been brought under the ambit of the AFSPA through the fresh notification.

Mere membership of banned outfits offence under UAPA: SC **GOVT HIKES DA**

New Delhi, March 24: The Union Cabinet Friday increased the dearness allowance and dearness relief by 4% to 42% to benefit 47.58 lakh central government employees and 69.76 lakh pensioners. The combined impact on the exchequer on account of both Dearness Allowance and Dearness Relief will be Rs 12,815.60 crore per annum, I&B Minister Anurag Thakur said after the meeting of Cabinet Committee on Economic Affairs. The release of the additional instalment of dearness allowance to employees and dearness relief to pensioners will be effective from January 01, 2023.

New Delhi, March 24: In a significant verdict having wider ramifications, the Supreme Court Friday held that mere membership of a banned organisation is an offence liable to be punished with imprisonment under provisions of the Unlawful Activities (Prevention) Act.

The top court said its three verdicts of 2011 pronounced by two-judge benches, which held that mere membership of a banned organisation will not incriminate a person unless he resorts to violence or incites peo-

ple to violence and does an act in tended to create disorder or disturbance of public peace by resorting to violence, "is not a good

It restored Section 3(5) of the Terrorists and Disruptive Activities (Prevention) Act, 1987 and Section 10(a)(i) of the UAPA, 1967, which made the membership of a banned outfit an offence, liable to be punished with two years imprisonment along with fine. A bench of Justice M R Shah, Justice CT Ravikumar and Justice Sanjay Karol allowed the petitions filed by the Centre and the Assam government seeking



a review of the three 2011 verdicts of the apex court on the ground that it will impact the

this Court in the cases of State of Kerala versus Raneef, Arup Bhuyan versus Union of India and Indra Das versus State of Assam (all 2011 verdicts) taking the view that under Section 3(5) of Terrorists and Disruptive Activities (Prevention) Act, 1987 and Section 10(a)(i) of the Unlawful Activities (Prevention) Act, 1967... and reading down the said provisions to mean that over and above the membership of a banned organisation there must be an overt act and/or further criminal activities and adding the element of mens rea are held to be not a good law", it said.

The bench held that "when an association is declared unlawful by notification issued under Section 3 which has become effective of sub-section 3 of that Section, a person who is and continues to be a member of such association is liable to be punished with imprisonment for a term which may extend to two years, and shall also be liable to fine under Section 10(a)(i) of the UAPA, 1967".

The top court said any other decisions of the High Court taking a contrary view are held to be-"not a good law" and are specifically overruled by this judgment.

technology and promoting good health though campaigns like Khelo India and Yoga," he said. Another major resolution of India is to eliminate tuberculosis by 2025 as against the global target of 2030, Modi said.

Referring to the capacity and health infrastructure enhancement during the Covid pandemic. Modi underlined the high use of trace, test, track, treat and technology in the fight against the disease. There is massive global potential in this local approach of India, said the prime minister.

Noting that 80 per cent of tuberculosis medicines are made in India, he said, "I would like that more and more countries get the benefit of all such campaigns, innovations and modern technology of India." Modi said the country launched a unique campaign to

fight the disease. The Prime Minister said since 2018, about ₹2,000 crore has been sent directly to the bank accounts of tuberculosis patients and about 75 lakh patients have benefited from it. "It is difficult to get new results

by following the old approach. Started working on a new strategy to ensure that no TB patient is left out of treatment. For testing TB patients, the number of labs has been increased and special plans are made for those where TB patients are more," he said.

The Pime Minister said it is a matter of pride that the summit is being organised in Varanasi, which he represents in the Lok Sabha.

No matter the obstacle, Kashi has always proved that new ways are created with 'Sabka Prayas (everyone's effort)', he said while expressing confidence that Kashi will usher new energy towards global resolutions in the fight against a disease like tuberculosis.

The Prime Minister also awarded select states, Union Territories and districts for their progress towards ending tuberculosis. The recipients of the awards were Karnataka and Jammu and Kashmir at the state and Union Territory levels and the Nilgiris, Pulwama and Anantnag at the district level. He also said the government is starting a threemonths programme for the prevention of tuberculosis instead of a six-month course.

30% teachers' post lying vacant in UP

Lucknow, March 24: Nearly 30 per cent posts of teachers and principals in state government-aided minority schools are lying vacant in Uttar Pradesh.

This has been revealed in a recent report of the state education directorate. According to the report, which has been sent to the Chief Minister, the state has 7,795 posts of principals and teachers sanctioned in more than 300 government-aided high schools and inter-colleges being run by minority societies of Muslims, Christians, Jains, and Bengalis, among others across the 75 districts of the state.

Of these 7,795 positions, 2,312 posts are lying vacant. After the formation of the government led by chief minister Yogi Adityanath in the state in 2017, recruitment in these institutions was stopped in an effort to introduce a transparent recruitment policy for staff of these institutions.

The government did introduce the promised guidelines for recruitment of teachers but no recruitments have taken place since and as a result, academic activities in these institutions are deteriorating, said a member of the management committee of one such institution.



For conducting the written examination of teachers' recruitment as mandated in the new guidelines, the process of agency selection has been going on at the government level since August 2022.

On the basis of this, after making a panel of top five candidates in merit list, appointments were to be made in minority institutions only from among the selected candidates. However, no such development has taken place even after eight months. The details of vacant posts of these institutions are not sent to the UP Secondary Education Service Selection Board. Officials also conceded that there is a shortage of non-teaching staff Around 42 out of 201 posts of head clerks, 221 out of 653 posts of assistant clerks and 1,299 out of 3,285 posts of attendants are lying vacant.

600 cameras for traffic management to be installed in Jammu; trial begins

Jammu, March 24: Total 600 cameras will be installed as a part of the intelligent traffic management and surveillance system to monitor vehicular traffic and its violations here in Jammu and Kashmir.

ITMSS was made operational in the winter capital during its first phase to conduct efficiency trials. Lieutenant Governor Manoj Sinha on March 13 inaugurated Integrated Command & Control Centre (ICCC) as a nerve centre of civic operations and traffic management.

"Six hundred cameras are being installed, mostly PTZ cameras and traffic management cameras for monitoring and managing vehicular traffic and recording traffic violations", Jammu Smart city CEO Rahul Yadav told PTI. He said so far cameras have been installed at 37 junctions.



"The trials have begun. We are receiving feed of traffic flow from 33 junctions. They are operational. On 12 junctions, analytics are fully functioning, under which we can detect any traffic violations", Yadav said. Initiated in November 2022, the project will have a chain of 600 cameras mostly pan-tilt-zoom (PTZ) cameras watching traffic movement in the city.

The smart system will detect automatic vehicle number plate identification, red light violations, stolen vehicle identification and use of mobile phones while driving among other things, the officials said.

ITMSS, which has been made operational in Jammu partially, is a step that would help authorities better manage the vehicular flow and catch violators, they said.

According to officials, this telligent traffic management system project is being implemented by a "master systems integrator" firm along with artificial intelligence software providers like Vehant Technologies that provide solutions to make roads safer.

paid by insurance companies to 2.18 lakh farmers as partial com-

pensation in the mid-term. Thus, a total amount of ₹597.05 crore have been given directly to the farmers as compensation for the kharif 2022 season. The amount

UP plans to increase millet production

Lucknow, March 24: In order to promote production and consumption of millets, the Uttar Pradesh government is planning to replace around 17 per cent of the area under paddy (rice) cultivation with millets and oilseeds in the coming years. According to official sources,

the change would be brought through concerted and extensive campaigns among farmers. Experts say that millets are most suited for water deficit and drought conditions. It consumes at least 70 per cent less water than other crops and requires minimum inputs and almost no pesticide.

"For farmers, millets are low risk crops resilient to climate change," a senior official said. With 11 lakh hectares of land under millets, UP also happens to be the second largest producer of coarse grain (50 lakh MT)

Sources said that the government is planning to organise cluster demonstrations, area expansion through distribution of



The government also plans to increase area under oilseeds from the existing 22 lakh hectares to around 27 lakh hectares to meet the target of producing 100 lakh tonnes of oilseeds by 2030-31. For this, the productivity will have to be increased from 11 to 12.5 quintals

Officials said that the state government was also planning to promote 'exotic' varieties of rice which could have higher returns.

The data available with the agriculture department shows that only seven districts (Bijnor, Kushinagar, Pilibhit, Chandauli, Baghpat, Varanasi and Ambedkar Nagar) have high productivity (over 2,500 kg/hectare).

As many as 55 districts have medium (2000-2500 kg/hectare) or medium-low productivity (1,500-2,000 kg/hectare). Five and three districts have low and very low productivity, respectively. Rice production has been registering Uttar Pradesh is the second largest producer of rice in the country (15 million MT), has 60 lakh hectares of land under paddy cultivation across 70 districts

he state government plans to reduce this to 50 lakh hectares while getting the area reallocated for millets and oilseeds -- a move that could mark a radical change in the cropping pattern

downward fluctuation in the wake of lesser rainfall.

Last year, rice production came down nationally from 111 million MT in 2021 to around 105 million MT in 2022. The state reported to have received 42 per cent less rainfall last year and recorded acreage under rice going down by around

Quranic manuscripts on display in Srinagar

Museum in Srinagar on Thursday opened a week-long exhibition of rare Quranic manuscripts, some which date back to the 18th century, to coincide with the first day of Muslim fasting month of Ramzan.

Srinagar, March 24: The SPS

'This is the first time we are holding the exhibition of the manuscripts as the manuscript section is still closed. Since it is the beginning of the holy month of Ramzan, we wanted to make people aware about these manuscripts so that it increases their knowledge," the museum's curator Rabia Qureshi told PTI. Qureshi said while the museum has manuscripts on diverse subjects, this exhibition was limited to Quranic man-

"One of the manuscripts is more than 230 years old and written on Kashmiri paper using pure gold and black ink. No chemicals were used." she said.

The other manuscripts on display include Tafseer Kabeer, famous by

the name of Tafseer Razi, which was written in 1209 Hijri (1795 AD), Qaseed-e-Burde Shareef 1316 Hijri (written in 1905 AD), and Imam Al Basri's manuscript.

The curator said 'Dalailo Khairaat', a manuscript in praise of Prophet Muhammad, has also been displayed in addition to the Quranic manuscripts. "This is a very good step that the Department of Archeology and Archives has taken to organise week-long Quranic manuscript exhibition. This department is doing these kinds of exhibitions on different occasions, which is encouraging. Calligraphy art has declined during the last 30 years but now new generation is taking up this art again," Athar Samoon, a Calligraphy student, said. Shahid Ahmad, a young visitor, said, "We are seeing old manuscripts here which were written by hand.

"At present, computer prints may have errors but these manuscripts don't have any. Through these exhibitions, we come to know about our history," Ahmad said.





New Delhi, March 24: The National Investigation Agency (NIA) Friday filed a fresh charge sheet against jailed gangster Lawrence Bishnoi and Goldy Brar, the alleged masterminds in the murder of Punjabi singer Sidhu Moosewala, and a dozen others, charging them with criminal conspiracy to unleash a wave of terror and carry out targeted killings of high-profile people.

The prosecution complaint has been filed against these gangsters who, the federal anti-terror agency said, had "links" with the proscribed Babbar Khalsa International (BKI) and several other pro-Khalistan terrorist outfits.

The charge sheet came in the second of the three terror-gangster nexus cases that are being investigated by the NIA."All the 14 accused have been charged with criminal conspiracy to unleash a wave of terror and carry out targeted killings of well-known social and religious leaders, movie stars, singers and businessmen.'

"Besides having links with conspirators in Pakistan, the accused were also in contact with pro-Khalistan elements based in Canada, Nepal and other countries," the NIA said. Apart from Bishnoi and Brar (alias Satwinderjeet Singh), the other accused who were charge-sheeted were Jagdeep Singh alias Jaggu Bhagwanpuriya, Sachin Thapan alias Sachin Bishnoi, Anmol Bishnoi alias Bhanu, Vikramjeet Singh alias Vikram Brar, Sandeep Jhanjariya alias Kala Jatheri Virender Pratap Singh alias Kala Rana, Joginder Singh, Rajesh Kumar alias Raju Mota, Raj Kumar alias Raju/Raju Basodi, Anil alias Chippi, Naresh Yadav alias Seth, and Shahbaaz Ansari alias Shahbaaz

Bishnoi, who continues to remain in jail after his arrest in 2015, has been operating his terrorcrime syndicate from prisons in different states, along with Canada based Goldy Brar, who is an accused in the killing of 'Dera Sacha Sauda' follower Pradeep Kumar at Faridkot (Punjab) in November,

"The Lawrence Bishnoi terrorcrime-extortion syndicate was also responsible for providing killers for the RPG attack case on Punjab state intelligence headquarters at Mohali, which was carried out on directions of Harwinder Singh alias Rinda, a Pakistan-based BKI terrorist," the

Brar was found to have "direct links" with Lakhbir Singh alias Landa, another BKI operative working closely with Rinda, it said. Landa is also an accused in the Mohali RPG attack, as well as the December, 2022 RPG attack on police station Sirhali in the Tarn Taran district of Puniab.

The NIA has earlier carried out raids in this case and seized a_ huge cache of nine illegal and sophisticated weapons, 14 magazines. 298 rounds of ammunition and 183 digital devices and other "incriminating" material at 74 locations in Punjab, Harvana, Uttar Pradesh, Rajasthan, Gujarat, Chandigarh and Delhi.

Amritpal tried to radicalise Sikhs: Officials

Chandigarh, March 24: Khalistan sympathiser Amritpal Singh, before escaping a Punjab Police crackdown on his outfit and supporters, attended five events in 10 days, and in these, he tried to radicalise Sikhs, coaxing 800-1,000 individuals to remain prepared to make the ultimate sacrifice, officials said.

The radical preacher's brazen activities evinced his methodical efforts to undermine the fabric of society, they claimed and added that he during his speeches and sermons alleged that the government was leaving no stone unturned in its quest to disarm Sikhs by revoking their weapons licences.

Amritpal Singh, who took over as 'Waris Punjab De' chief after its founder actor-activist Deep Sindhu's death last year, is on the run after police launched a massive crackdown on March 18 in the state and arrested several of his supporters.

It began weeks after the preacher and his supporters stormed the Ajnala police station near Amritsar on February 23 to secure the release of an arrested associate.

The episode raised fears over the possibility of the return of Khalistani militancy to Punjab that borders Pakistan.

The officials said the preacher allegedly implored youngsters to unify for securing "Khalsa rule" for the coming generations of Punjab, proclaiming that the division within the Sikh Panth made them "vulnerable to the enemy's onslaught".

The Ajnala incident had reignited



militancy in the state, they said and pointed out that Amritpal Singh had ulterior motives to sully the peaceful ambience of Puniab, and this was exemplified by the abduction and assault on Barinder Singh.

Barinder Singh, in his complaint, had told police that Amritpal Singh's associates had abducted him from Ajnala and took him to an un-

known place where he was brutally thrashed. In Februray, Dubaireturn Amritpal Singh's supporters stormed the police station to get

Toofan Singh, the accused, released. During the Ajnala incident, he openly defied authorities and did not refrain from injuring policemen in the process, according to officials. Amritpal Singh had showed no qualms in engaging in sacrilege and vandalising gurdwaras in Kapurthala and Jalandhar, and stoking communal tension by delivering provocative speeches targeting other religions, they claimed.

He also brazenly encouraged violence and gun culture, exploited youth for his pernicious agenda, and described his private militia as the 'Anandpur Khalsa Fauj', the officials alleged.

Court reserves order on Sisodia's bail plea

New Delhi, March 24: A Delhi court Friday said it will pronounce its order on former Deputy Chief Minister Manish Sisodia's bail plea on March 31 in the excise policy case lodged by the Central Bureau of

Investigation (CBI). Special Judge M K Nagpal reserved his order on the Aam Aadmi Party leader's plea seeking regular bail in the case after the CBI handed over a short note regarding its contention in the case.

"A brief written submission on



behalf of CBI has been filed in opposition to the regular bail application of the accused. Copy thereof as well as case law has been given to the counsel of accused. Copy of part of case diary and statements of some witnesses have been also made available," the special judge said.

On March 21, the judge had deferred the hearing on Sisodia's bail plea till March 24 for any further clarification and submissions. The CBI, so far, has quizzed Sisodia in its custody for seven days.

The agency on February 26 arrested Sisodia in connection with alleged corruption in the formulation and implementation of the now-scrapped Delhi Excise Policy 2021-22. The Enforcement Directorate arrested Sisodia on March 9 evening in Tihar jail, where he was lodged in connection with the case being probed by the CBI.

4-yr-long Iran ordeal ends; 5 Indian sailors return home

Mumbai, March 24: In a heartwarming development, five Indian sailors - who were stranded in Iran from June 2019 - finally returned home Thursday afternoon after surviving a nightmarish ordeal of nearly four years.

The five are: Aniket S. Yenpure, 31 and Mandar M. Worlikar, 28 (both of Mumbai), Pranav A. Tiwari, 23 (Patna), Naveen M. Singh (New Delhi), and Thamizh R. Selvan, 33, (Chennai). They landed from an Iran Air Tehran-Mumbai flight Friday afternoon, bowed and touched the Indian soil, and were welcomed, kissed, hugged and lifted in the air with tears and cheers by their ecstatic relatives.

"Our joy is boundless... We were away and separated from our families for almost 45 months, but the long nightmare has ended now. The next one month we shall rest and interact with all our family members." Yenpure said.

They expressed gratitude to the Indian Embassy in Tehran which arranged for their emergency travel papers and tickets till Mumbai and also some Iranian lawyers for labouring more than six months to ensure their smooth "ghar-wapsi".

However, their passports and CDC were not handed over, and now the five youths plan to apply for fresh passports, said Worlikar. Presently, Yenpure and Worlikar will host their friends Tiwari, Singh, and Selvan (Tamil Nadu) at their Worli home till they can arrange funds from their families to return to their respective home towns by this weekend.

The plight of the five-some was first highlighted by IANS (July 4, 2021). how they were sailing in the high seas off Oman in February 2020 but were unwittingly trapped into a treacherous maritime narcotics smuggling racket allegedly perpetrated by their ship's captain.

For this, they were arrested, jailed, acquitted, and then grounded, moved around different cities in Iran, fighting legal battles, at times hiding, occasionally doing small menial jobs in exchange for a meal, or surviving on the food and clothes doled out by sympathetic villagers



in remote areas, Yenpure's father, Sham Yenpure, said.

"We had approached Prime Minister Narendra Modi, External Affairs Minister S. Jaishankar, former Maharashtra Chief Minister Uddhay Thackeray his ex-Minister son Aditya Thackeray, Iran diplomats in India and Indian diplomats in Iran, top Iran leaders, and others for help," said Yenpure, a milkman, in an emotion-choked voice, while undertaking his annual foot-march to the Shri Saibaba Temple in Shirdi Friday morning.

Initially, everything was hunkydory for the five youths - till February 20, 2020, when they unknowingly fell

into a sinister trap of their ship captain in the high seas around 140 km from Muscat. Sensing something amiss at the illegal mid-sea cargo transfer, Worlikar and his co-crew quietly recorded it on their mobile phones -- as evidence for the Customs and Iran Police authorities at the next port.

Unexpectedly, the next morning (February 21, 2020), an Iran Navy ship intercepted in the high seas, arrested them all, and transferred them to the naval ship. As events unfolded after February 2020, little did the boys realize that not only their dreams would be shattered but they would also be imprisoned and kept away from their families for almost four years in India - till their return.

Corcoran appears before grand jury

Washington: A lawyer for Donald Trump was back in court Friday after being ordered to answer questions before a grand jury investigating the possible mishandling of classified documents at the former president's Florida estate. M. Evan Corcoran entered federal court in the District of Columbia early on Friday morning, one week after a federal judge ruled in favour of the Justice Department in forcing Corcoran to answer additional questions before a grand jury that has been hearing testimony for months. He did not make any comments as he arrived at the building. The interest by prosecutors in Corcoran's testimony underscores the legal peril confronting Trump, making clear the department's continued focus on whether Trump obstructed government efforts to recover hundreds of classified documents taken from the White House to Mar-a-Lago at the end of his term.

Beirut, March 24: A strike Thursday by a suspected Iranianmade drone killed a US contractor and wounded five American troops and another contractor in northeast Syria, the Pentagon said.

American forces said they retaliated soon after with "precision airstrikes" in Syria targeting facilities used by groups affiliated with Iran's Revolutionary Guard, with activist groups saying the US bombing killed at least four people.

The attack and the US response threaten to upend recent efforts to deescalate tensions across the wider Middle East, whose rival powers have made steps toward détente in recent days after years of turmoil.

US Defence Secretary Lloyd Austin said in a statement that the American intelligence community had determined the drone was of Iranian origin, but offered no other immediate evidence to support the claim.

"The airstrikes were conducted in response to today's attack as well as a series of recent attacks

against coalition forces in Syria" by groups affiliated with the Revolutionary Guard, Austin said.

Iran relies on a network of proxy forces through the Mideast to counter the US and Israel, its arch regional enemy.

The Pentagon said two of the wounded service members were treated on-site, while three others and the injured contractor were transported to medical facilities in Iraq. Overnight, videos on social media purported to show explo-

Guard Corps sions in Syria's Deir el-Zour, a strategic province that borders Iraq and contains oil fields. Iranbacked militia groups and Syrian forces control the area, which also has seen suspected airstrikes by

Iran and Syria did not immediately acknowledge the strikes, nor did their officials at the United Nations in New York respond to requests for comment from The Associated Press.

The activist group Deir Ezzor 24 put the death toll from the American strikes at four people. Deir Ezzor 24, which covers news in Deir el-Zour province, said the strikes hit the city of Deir el-Zour as well as militiamen posts near Mayadeen and Boukamal. It said the strikes also wounded people, including Iraqis.

The Syrian Observatory for Human Rights, an opposition war monitor, reported that the American strikes killed six Iranian-backed fighters at an arms depot in the Harabesh neighbourhood in the city of Deir el-Zour.

The Observatory, which relies on a network of local contacts in Svria. said US bombing at a post near the town of Mayadeen killed two fighters

Kyiv, March 24: Russian longrange strikes killed at least 10 civilians and wounded 20 others in several areas of Ukraine Friday, Ukraine's presidential office said as a senior Moscow official warned that the Kremlin's forces were prepared for an expected Ukrainian counteroffensive in the coming weeks.

Five people died in Kostiantynivka, a town in eastern Ukraine's Donetsk province, when a Russian missile hit an aid station. Local prosecutors said the

Russians attacked Kostyantynivka with S-300 anti-aircraft missiles. The civilians who died were refugees, according to Donetsk Gov. Pavlo Kyrylenko.

Netanyahu meets Sunak amid protests

London, March 24: British Prime Minister Rishi Sunak held talks with Benjamin Netanyahu in London Friday as protesters shouting "Shame!" in Hebrew demonstrated against the Israeli leader's right-wing policies and his plans to overhaul the country's judiciary.

Sunak also raised Netanyahu's controversial judicial reforms, which have sparked mass protests in Israel and beyond. One placard in London read: "We are Israelis and Jews living in the UK demonstrating against Prime Minister Netanyahu, who is leading a judicial coup turn-



ing Israel into a dictatorship." Some women protesting outside Downing Street wore red robes and

white caps inspired by "The

Handmaid's Tale," a novel and TV series set in a dystopian future. Similarly clad demonstrators have become fixtures of the mass protests roiling Israel. Sunak "stressed the importance of upholding the democratic values that underpin our relationship, including in the proposed judicial reforms in Israel," the British leader's office said in an official readout of the meeting.

Netanyahu's proposals would give his government more control over judicial appointments, weaken the Supreme Court by limiting judicial review of legislation and allow Parliament to overturn court decisions with a simple majority vote.

He arrived in London as protesters in Israel blocked roads and clashed with police. The planned indicial system overhaul have ignited the biggest protests in the country's history amid rare dissent from people throughout Israeli society, including military reservists, navy veterans, high-tech businesspeople and former officials. Netanyahu's right-wing government has also been criticised for its hard-line policy toward Palestinians, including recent comments by a government minister who denied the existence of the Palestinian people and their right to self-determination.

King Charles' visit to France postponed

London, March 24: King Charles III's first state visit as monarch was scaled back Friday, dashing hopes for a triumphal tour to win hearts and minds abroad just as his mother did so successfully during her 70 years on the throne.

The visit by Charles and his wife, Camilla, to France was postponed amid mass protests in the country over President Emmanuel Macron's plans to reform the pension system.

The German leg of the trip will take place as planned.

Charles' initial plan to visit France and Germany, the two biggest countries in the European Union, was meant to rebuild ties with Britain's closest neighbours after six years of squabbling over Brexit. But French domestic trou-

bles put paid to that. The king and queen consort's State Visit to France has been postponed," the British prime minister's Downing Street office said in a statement. "This decision was



taken with the consent of all parties, after the president of France asked the British government to

postpone the visit. Buckingham Palace said another date would be found. "Their Majesties greatly look forward to the opportunity to visit France as soon as dates can be found," the

palace said in a statement.

Philippines confronts Chinese diplomats

Manila, March 24: Filipino diplomats issued a slew of protests over China's aggressive behaviour in the South China Sea, including targeting a Philippine coast guard ship with a military laser, when they met Chinese officials Friday, an official said.

Territorial disputes in the busy waterway have long loomed as a potential flashpoint in Asia and have become a sensitive front in the regional rivalry between China and the United States. Washington lays no claims in the contested waters but has challenged Beijing's extensive claims including by deploying its warships and fighter jets and repeatedly warning that it would help defend the Philippines — a treaty ally — if Philippine forces, ships and aircraft are attacked. Vietnam,

Malaysia, Brunei and Taiwan also have overlapping claims in the seaway, which sits atop vast deposits of oil and gas. A Chinese delegation led by Vice Foreign Minister Sun Weidong held two days of talks starting Thursday with Philippine counterparts led by Foreign Undersecretary Theresa Lazaro and reviewed overall relations. The two sides focused on their

territorial disputes Friday, the Department of Foreign Affairs in Manila said. The talks opened with both sides citing an agreement between Chinese leader Xi Jinping and Philippine President Ferdinand Marcos Jr., who made a state visit to China in early January, to manage the territorial conflicts amicably while enhancing economic ties and otheraspects of a nearly half-century of diplomatic relations.



New Delhi, March 24: The Lok Sabha Friday approved The Finance Bill 2023 with 64 official amendments including providing tax relief to some taxpavers opting for new tax regime, and removing long-term tax benefit for debt mutual funds to bring them at par with other interest earning instruments.

The Finance Bill, which includes tax proposals for the fiscal year beginning April 1, was passed without a discussion as parliament continued to remain stalled over demands for a probe into allegations against the Adani group.

Finance minister Nirmala Sitharaman moved the Bill and the 64 amendments which were all approved by voice vote. These will now go to Rajya Sabha and will become law once the President gives assent

From April 1, investments in debt mutual funds will be taxed as short-term capital gains, stripping investors of the long-term tax benefits that made such investments popular.

Currently, investors in debt funds pay income tax on capital gains according to the income tax slab for a holding period of three years. After three years these funds pay either 20 per cent with indexation benefits or 10 per cent without indexation.

After the amendment, such gains from transfer of units of specified mutual funds will be treated as short term and taxed at slab rates. This is in addition to taxa-

Individual taxpayers with income marginally over ₹7L to get relief

Tn a relief to taxpayers opting

Lfor new tax regime, individuals earning marginally higher income than no-tax ceiling of ₹7 lakh will pay tax only on the differential income after the government amended the Finance Bill. Explaining the provision, the finance ministry said under the new tax regime with effect from April 1, if a taxpayer has annual income of ₹7 lakh s/he pays no tax. But if s/he has income of ₹7,00,100 s/he pays tax of 25,010. Thus an additional income of ₹100 leads to a tax of ₹25.010. Hence, marginal relief is proposed to that so that the tax what one pays should not be more than the income that exceeds ₹7 lakh (Rs 100 in this case), the ministry said. The budget 2023-24 had announced the tax rebate whereby no tax would be levied on those with annual income of up to ₹7 lakh under the new tax regime. The move which experts felt was a push for salaried class taxpayer to switch to new tax regime where no exemptions on investments is provided. Under the revamped new tax regime, no tax would be levied for income up to ₹3 lakh. Income between ₹3-6 lakh would be taxed at 5 per cent; ₹6-9 lakh at 10 per cent, ₹9-12 lakh at 15 per cent, ₹12-15 lakh at 20 per cent and income of ₹15 lakh and above will be taxed at 30 per cent. Further, a ₹50,000 standard deduction was allowed under the new regime.

Markets fall nearly 1%; Nifty slides below 17K

Mumbai, March 24: Equity benchmark indices Sensex and Nifty buckled under selling pressure for the second straight session to settle nearly 1 per cent lower Friday as investors pared exposure to the metal, energy and realty stocks amid a bearish trend in Asian and European markets

Besides, a depreciating rupee against the US dollar and fresh foreign fund outflows also hit investor sentiments, traders said.

In a volatile trade, the 30-share BSE Sensex declined 398.18 points or 0.69 per cent to finish at 57,527.10, with 24 of its constituents posting losses. During the day, the index witnessed a high of 58,066.40 and a low of 57,422.98

The broader NSE Nifty fell 131.85 points or 0.77 per cent to slip below the psychological level of 17,000. The index settled at 16,945.05, with 41 of its scrips ending in the red.

On a weekly basis, the BSE benchmark fell 462.8 points or 0.79 per cent, while the Nifty slipped 155 points or 0.90 per cent.



Bajaj Finserv was the biggest loser among the Sensex constituents, sliding 3.81 per cent, followed by Bajaj Finance, Tata Steel RIL, HCL Tech, SBI, Larsen & Toubro and Mahindra & Mahindra, Axis Bank and Titan.

Falling for the second day in a row, index major Reliance Industries witnessed an intense sell-off and declined 1.96 per cent. On the other hand, Kotak Mahindra Bank, Infosys, Tech Mahindra, Power Grid, Asian Paints and Wipro were the gainers

POST ADANI SHARE ROUT LIC plans investment exposure caps

THE CAPS, ONCE APPROVED BY THE LIC BOARD, WOULD **FURTHER LIMIT THE INSURER'S EXPOSURE**

New Delhi, March 24: The Life planning to impose caps on its debt and equity exposure to companies, two sources said, in a bid to lower concentration of risk following criticism of its investment in Adani group companies.

After the Adani group lost over \$100 billion in valuation post scathing allegations by US-based Hindenburg Research, state-run LIC was criticized for having over \$4 billion exposure to companies

from the group. LIC, the country's largest domestic institutional investor with assets under management of about \$539 billion, is planning to cap its debt and equity exposure in individual firms, group companies and companies that are backed by same promoters, one of the sources, with knowledge of the matter, told Reuters.



"LIC is looking to have 'boundary conditions' on its investments that would limit its exposure to scrips," said the source.

Currently, the insurer cannot invest more than 10% of outstanding equity in a company and 10% of the outstanding debt. The Insurance Regulatory and Development Authority of India (IRDAI) also bars insurers from having more than 15% of their investment funds in equity and debt of companies owned by one cor-

porate or a promoter group. The move is aimed at strengthening investment strategies, and fence LIC from public criticism of its investment decisions or exposure to entities like the Adani group, the second source said. The quantum of the caps would

e decided by the insure vestment committee before it is taken to the board "soon," the first source said. "It is now planning to come up

with sub-limits for such investments to keep a check on its exposure," the source said.

LIC had invested ₹301.2 billion in shares of Adani group companies, and has a debt exposure of ₹61.82

"The (current) overall limits imposed by IRDAI for investment in entities owned by a single group could mean LIC can invest large amounts in group companies as it has a sizeable investible fund," said Bahroze Kamdin, a partner at Delloitte India. "This could lead to its investment getting impacted due to volatility in the market, and likely erosion of funds owed to

Ambani adopts familiar playbook in cola battle vs Coke, Pepsi

Asia's richest person has famously disrupted India's telecoms market seven years ago with cut-throat pricing to make Reliance the leading player in that industry. And he's applying some of that same strategy in his soft drinks venture

Mumbai, March 24: Indian industrial giant Reliance is reviving a historic local cola brand with plans to use its vast retail network, slash prices and tap nationalist sentiment to challenge US bever age giants PepsiCo and Coca-Cola in a key market.

Controlled by billionaire Mukesh Ambani, Reliance this month launched revamped Campa drinks. sugary sodas popular in India in the 1970's and 1980's before disappearing from shelves as the US giants expanded rapidly in a liberalising

At first glance it may seem that Ambani will find it tough to loosen Pepsi's and Coca-Cola's stranglehold of a market Euromonitor estimates is worth \$4.6 billion and set to grow 5% a year until 2027. Other well known tycoons have tried to go toe-to-toe with the drinks giants, and failed, most notably Richard Branson with his Virgin Cola.

A person with direct knowledge of Reliance's plan said it aims to open some factories of its own or as joint ventures to make Campa, and take the soda to hotels, restaurants and in-flight sales. Production of Campa is currently outsourced, after its \$2.7 million acquisition of the brand last year.

The company is heavily discounting in-store prices. A twolitre Campa Cola bottle is priced at ₹49 in stores, a near 50% discount on its label price, and around a



third lower than 2.25-litre Coke and Pepsi variants, a Reuters check showed. The smallest bottles of Campa Cola and Coke both cost ₹10, while Pepsi starts from ₹12.

"The price will be disruptive across," said the person, who added Reliance is planning an advertising spree during the upcoming popular IPL cricket tournament and is in talks with at least three teams to make Campa their refreshment partner.

Coca-Cola said it has broadly

kept prices of its small bottles unchanged since last year and was focused on expanding distribution. "Having new players in the market presents a great opportunity for investments to develop the mar-

ket further," it said. Reliance, India's top retailer, will supply Campa to its 2,500 grocery outlets and thousands of smaller non-network stores as part of its new consumer goods push from which it has set an internal target of \$6.5 billion in annual revenues within five years.

The company also has a grocery shopping app and a wholesale vertical under which it supplies consumer goods to 500,000 mom-andpop stores, which it will also tap for Campa sales.

'GREAT INDIAN TASTE' VS FOREIGN

Reliance's cola and consumer goods foray is being driven by T Krishnakumar an executive who worked for nearly 17 years at Coca-

Cola in various leadership roles. Pepsi and Coca-Cola will also cautiously eye Reliance's marketing strategy after it targetted nationalist sentiment and nostalgia by promoting Campa as a home grown brand with "Great Indian l'aste" and a "rich heritage".

The rivalry is already playing out in the market. For now, the US rivals have an upper hand. Pepsi and Coca-Cola drinks are available in at least 3 million Indian outlets and the companies have a widespread logistics network, dozens of factories and the advantage of a taste preferred by many, said Alok Shah, a consumer analyst at India's Ambit Capital.

WINDFALL Vedanta cuts \$91mn

New Delhi, March 24: In signs of protests against the 9-month-old windfall tax, mining mogul Anil Agarwal's Vedanta Ltd has withheld about \$91 million from the share of profit due to government from its oil and gas fields, to make up for the additional tax outgo, according to sources and corre-

This is in addition to the 10-20 per cent royalty on price of oil and gas realised and an oil cess of 20 per cent. On top, the government is also entitled to a pre-decided share of profit after expenses are deducted from revenue earned from sale of oil and gas.



TRANSGENDER WOMEN ATHLETES BANNED



Manchester, March 24: World Athletics has banned transgender women from competing in elite female competitions and tightened testosterone restrictions for other athletes, the governing body said Friday.

World Athletics president Sebastian Coe said that the decision to exclude transgender women who had gone through male puberty was based "on the overarching need to protect the female category

World Athletics' council also voted to cut the maximum amount of plasma testosterone for athletes with Differences in Sex Development (DSD) in half, to 2.5 nanomoles per litre from five.

DSD athletes will also have to reduce their testosterone levels below the new limit for a minimum of 24 months across all events to compete, double the previous time. The governing body had previ-

pion Caster Semenya, Christine Mboma, the 2020 Olympic silver medallist in the 200m, and Francine Niyonsaba, who finished runner-

up to Semenya in the 800 at the

WA regulations around DSD previously required women competing in events between 400 metres and a mile to maintain testosterone levels below five nanomoles per litre.

The governing body also introduced interim provisions for athletes already competing outside the restricted events, who will be required to suppress their testosterone level to 2.5 nanomoles per litre for six months.

This would prevent several

women from competing at the World Athletics Championships in August

DSD athletes have male testes but do not produce enough of the hormone Dihydrotestosterone (DHT) that is necessary for the formation of male external genitalia.

Coe said the decisions were made in consultation with numerous stakeholders including 40 member federations, coaches, athletes plus a range of community groups including trans groups, United Nations experts and the International Olympic Committee.

Swimming's world governing body World Aquatics voted last June to bar transgender women from elite competition if they had experienced any part of male puberty. A scientific panel had found that even after reducing their testosterone levels through medication, transgender women still had a significant advantage. That vote passed with 71% of the national federations ISSF WORLD CUP 2023

Rudrankksh wins bronze as China extend gold run

China maintained their top position on the medal tally at the end of competition day three with five gold, one silver and two bronze in their kitty. India lay second with three bronze medals to go with a gold and a silver



Bhopal, March 24: Reigning world champion Rudrankksh Patil won bronze in the men's 10m air rifle his second of the tournament, even as China extended their golden run at the ISSF World Cup 2023 by winning both gold medals on offer for the second consecutive day here.

Tokyo Olympics silver medallist Sheng Lihao of China won gold in the men's 10m air rifle while compatriot Huang Yuting, a double gold medallist at the Cairo World Championships last year, won the women's event.

Playing back-to-back matches can never be easy, especially in a home World Cup, but the champion shooter that he is, Rudrankksh delivered yet again, clinching bronze from what at one point seemed a lost cause.

He shot a solid 631.0 in qualification to finish fourth after leading in the initial stages. In the 25-shot top eight ranking round, he was well outside the medal positions till the third five-shot series, before a fantastic fourth series, where he shot the highest score of 53.5, brought him back into contention. Meanwhile the three Chinese

qualifiers - Sheng (who led throughout the ranking round), silver medallist Du Linshu and Yu Haonan - were on course to make it a Chinese 1-2-3 till the 20th shot.

Rudrankksh went into the fifth series 0.8 behind Yu. He then shot

a strong 52.6 in the series as Yu faltered, posting 51.5 to finish fourth, as the Indian confirmed his second medal in two days and his fourth ISSF World Cup podium overall.

He finished with a score of 262.3 as Sheng and Du moved into the gold medal match with scores of 264.2 and 263.3 respectively.

The all-China gold medal contest was also a close one with Sheng prevailing 17-13 in the end. Ramita finishes fourth

India had only one top eight finisher in Ramita in the women's 10m air rifle as she shot 632.3 to finish second among the medal contenders in the 52-strong field. The top eight had two Chinese, two

Americans and one shooter each

from Romania, Israel and Kazakhstan, besides hosts India. China's Huang Yuting was in ominous form, topping the qualifications with a score of 632.8 while Tokyo Olympics silver medallist in the mixed team air rifle, Mary Tucker of the USA, also made

In the top eights, Huang was a cut above the rest, finishing on top again with a score of 265.7 as Mary shot 261.2 for a shot at gold.

Ronaldo started in Portugal's European qualifier against Liechtenstein to make his 197th appearance with the national team, breaking a tie with Kuwait's Bader Al-Mutawa.

Ronaldo had tied Al-Mutawa with 196 caps after coming off the bench in Portugal's loss to Morocco in the quarterfinals of the World Cup in Qatar last year.

The 38-year-old Ronaldo had become Europe's most-capped player in 2021 after surpassing Sergio Ramos' mark of 180 appearances with Spain.

Ronaldo, who is also the all-time scoring leader in men's soccer with 118 goals, is back with Portugal's national team after a disappointing

World Cup in which he was benched in the knockrounds and left the field in tears after

the loss to Morocco. He said his return to the national team was in doubt after the World Cup, but he even-

tually decided it was not time "to throw in the towel. New Portugal coach Roberto Martínez said he still counts on Ronaldo and made the forward one

of his captains entering qualifying for the 2024 European Championship. Portugal's qualifying group

also includes Luxembourg, Iceland, Slovakia and Bosnia-Herzegovina. Its next match is at Luxembourg Sunday. The top two nations from each of the 10 groups qualify for the final tournament in Germany.
