ADR smells booth rigging in 538 seats

New Delhi, July 29: Association for Democratic Reforms (ADR) has claimed that there is a discrepancy in number of votes polled and number of votes counted in 538 Lok Sabha constituencies in the recently held General Elections.

According to an analysis released by ADR at a press conference Monday, in the recent Lok Sabha polls a total of 5,54,598 votes counted are less than the votes polled in 362 parliamentary constituencies while a total of 35,093 votes have been counted in excess of the votes polled in 176 parliamentary constituencies.

During 17th General Elections, for the first six phases of the election, the voter turnout app displayed the exact number of voters, but in the last phase (7th phase) only percentage figures were given and previous data was removed by the EC.

As per the research conducted

by a team of experts and ADR, serious discrepancies were found between the number of voters in different constituencies and the number of votes counted.

"The master summary of 542 constituencies showed discrepancies in 347 seats. 195 seats were without discrepancies whatsoever. The discrepancies ranged from 1 vote (lowest) to 1,01,323votes at 10.49 per cent of the total votes (highest).

"In addition, the inordinate delay in the release of final voter turnout data, absence of disaggregated constituency and polling station figures in absolute numbers and whether the elections results were declared based on final reconciled data have raised concerns and public suspicion regarding the correctness of the election results," said ADR founder Jagdeep Chokkar during the press conference.

MHA panel to probe coaching centre deaths

New Delhi, July 29: The Union Ministry of Home Affairs Monday constituted a high-level committee, headed by an Additional Secretary, to probe the death of three IAS aspirants at a coaching centre here due to flooding of the building's basement and submit the report in 30 days.

The committee will inquire into the reasons, fix responsibility, suggest measures and recommend policy changes, a home ministry spokesperson said.

Apart from the Additional Secretary of Ministry of H&UA, the panel will have Principal Secretary (Home) of Delhi govt, Special CP of Delhi Police and Fire Advisor as members and a joint secretary in the home ministry as the convener.

DEBT TRAP

In what has come as a failure of the Union government to arrest the rising public debt and maintain fiscal prudence, in spite of expanding tax nets, the loan burden for FY2025, as estimated by the Centre, will touch a whopping ₹185 lakh crore that would further deteriorate the finances of the government as well as the common man

New Delhi, July 29: Country's public debt will increase to ₹185 lakh crore during the current financial year from ₹171.78 lakh crore in the financial year that ended in March 2024, Minister of State (MoS) for Finance Pankaj Chaudhary told the Lok Sabha Monday.

"The government estimates its debt, including external borrowing, valued at current exchange rate and public account and other liabilities will increase to ₹185 lakh crore, or 56.8 per cent of the gross domestic product (GDP), during the current financial year," Chaudhary said in a written response to the Lower House.

The minister added that total debt stood at ₹171.78 lakh crore, or 58.2 per cent of the GDP at the

end of March 2024. Notably, India's internal as well as external debt and other liabilities have been rising, if data from the 2018-19 Budget papers is any indication. The outstanding debt and other liabilities of the Centre at the end of FY2018-19 was estimated to be around ₹89.58 lakh crore as against ₹82.32 lakh crore at the end of 2017-18(RE).

Growth rate of the private final consumption expenditure (PFCE) at constant prices in FY2022-23 and FY2023-24 stands at 6.8 per cent and 4 per cent,

respectively, Chaudhary said, quoting provisional GDP estimates for 2023-24 released by National Statistical Office.

The growth rate of PFCE at current prices in FY2022-23 and FY2023-24 is 14.2 per cent and 8.5 per cent, respectively, he said, adding that the ratio of PFCE to GDP at current prices in 2023-24 is 60.3 per cent.

In response to another question, Chaudhary said the normal net borrowing ceiling (NBC) of the states for 2021-22 was fixed at 4 per cent of gross state domestic product (GSDP) as recommended by the 15th Finance Commission

Of the normal NBC of 4 per cent of projected GSDP for 2021-22, the borrowing ceiling of 0.50 per cent of the projected GSDP was earmarked for the incremental capital expenditure incurred by states during 2021-22, for which, a target for capital expenditure was fixed for each state, he said. In another reply, he said the Centre under the head 'Special Assistance' under Demands for Grants 'Transfers to States' provide grants-in-aid to states for spillover committed liabilities for which Budget provision is not made and for other need-based assistance to states.

Further, NITI Aayog, in its report titled 'Report on Developmental Support to the Successor State of Andhra Pradesh under Andhra Pradesh Re-organization Act, 2014' dated December 1, 2015, has, recommended "...a total assistance of ₹2,100 crore for the seven backward districts of Andhra Pradesh at the rate of ₹300 crore per district.

He assured that utmost care would be taken to ensure that temple rituals remain unaffected during these procedures.

Chateauroux (France), July 29: A confident Manu Bhaker placed herself in contention for a second Olympic medal as she combined with Sarabjot Singh to make the bronze medal play-off in the 10m air pistol mixed team event here Monday.

The 22-year-old Bhaker, who came into the mixed team qualifications after winning a historic bronze medal in the 10m women's air pistol event on Sunday, and Sarabjot finished with a total of 580 to make the medal round to be held Tuesday The Indians will face Korea's Oh Ye Jin and Lee Wonho, who shot 579, in the bronze-medal match.

Bhaker was sensational with her 98s in the first two series, but a 95 in the third set pulled the team down a bit. However, the pair did enough to make the medal round in the end. Sarabjot, who missed out on gaining a spot in the finals of the men's 10m air pistol event by a whisker, shot 97 in the second and third,

after a 95 in the first. If Bhaker does win another medal Tuesday, she will create history by becoming the first— Indian to win two medals in the same Olympics.

World's 1st black tiger safari in Mayurbhanj by Dec

Bhubaneswar, July 29: If things go well, a melanistic tiger safari, a first-of-its-kind in the world, will come up on a 200hectare land near Similipal Tiger Reserve in Mayurbhanj district by the year end, official sources said Monday.

The state government's proposal for the safari has received in-principle approval from the National Tiger Conservation Authority (NTCA), with the Central Zoo Authority (CZA) already granting its endorsement, Susanta Nanda, Principal Chief Conservator of Forests (PCCF),

Initially, melanistic tigers (black tigers) currently housed at Nandankanan Zoological Park at Barang on the outskirts of Bhubaneswar will be relocated to the proposed safari, spanning 200 hectare land adjacent to National Highway-18.

Official sources said the safari will be established over an area of 200 hectare. Around 100 hectare will be dedicated to display area, while the remainder will be used to accommodate veterinary facilities, a rescue centre, staff infrastructure and visitor amenities. Located about 15km from Similipal Tiger Reserve (STR), the site mirrors its natural landscape.

STR is globally renowned as the sole habitat where wild melanistic tigers are found.

This initiative aims to bolster wildlife tourism in Odisha, offering a unique opportunity for conservationists, researchers, enthusiasts, and the public to observe this rare species up close

In January, former chief minister Naveen Patnaik had un-



veiled plans for the melanistic tiger safari near Similipal.

The PCCF emphasised the significance of protecting state's forests as crucial corridors for tiger population migrating from Madhya Pradesh Maharashtra.







BHUBANESWAR: A goods train derailed in Bhubaneswar in the early hours of Monday, the East Coast Railway (ECoR) said. The incident happened at 1.35 am in the railway yard at Mancheswar station, it said in a statement. There was no loss of life or damage to properties due to the derailment, it added. Because of the derailment, two trains were cancelled and six trains were rescheduled, while the Puri-Rourkela Express was short-terminated in both directions, the statement said. The line was cleared for movement of trains at 5.05 am, it said.

Naveen: BJP ended up being name changer

Bhubaneswar, July 29: Leader of the Opposition (LoP) in the state Assembly, Naveen Patnaik, Monday claimed that the BJP came to power in the state promising to be a game changer, but ended up becoming just a "name changer"

He also alleged that the government did not provide enough funds in the budget for several schemes the saffron party promised in its election manifesto.

While participating in the general discussion on the annual Budget for fiscal 2024-25 in the Assembly, the Biju Janata Dal (BJD) president asserted that the BJP altered the names of 45 schemes of the previous BJD government.

Chief Minister Mohan Charan Majhi, who also holds the Finance portfolio, presented the BJP government's maiden Budget July 25.

"The BJP said its government will be a game changer, but unfortunately it has ended up being a name changer. It has presented a name-changing and colourchanging budget," said Patnaik who was the chief minister of Odisha for five terms.

He claimed that 80 per cent of the previous BJD administration's schemes were repeated in the BJP government's Budget.

"The BJP formed the government by promising people that they would bring paribartan (change). After going through the Budget documents, I find this government has changed the names of 45 schemes," said the BJD presi-

It shows the robustness, propeople and progressive character of the schemes designed and implemented by the BJD government, he claimed

Though Patnaik did not explain what he meant by "colour change", he apparently referred to the change of the colour of LAccMI buses (an affordable

bus service for villagers) from green to saffron after the BJP came to power in the state last

Mentioning several promises made by the BJP before the elections, Patnaik claimed that the budget did not provision for funds required to implement

The government will need ₹1 lakh crore to implement the Subhadra scheme but the budget mentioned only ₹10,000 crore, "This will cover less than 10

per cent of the over two crore women of Odisha. What about the rest 1.80 crore women? Patnaik said. Under the scheme named after

Lord Jagannath's sister, cash vouchers of ₹50,000 will be provided to women of the state.

Patnaik said the BJP promised to increase social security pension to ₹3,500 per month. There are about 50 lakh pensioners in the state, out of which hardly one lakh will benefit as per the budget allocation, he

"What will happen to the rest 49 lakh pensioners between the age of sixty years to eighty years of age including widows, PWDs and distressed people? You need about ₹21,000 crore per year to fulfil this promise," he pointed out.

Referring to BJP's announcement of ₹3,100 as MSP per quintal of paddy to farmers, Patnaik said that the allocation kept in the budget will not be adequate to cover even 30 per cent of the

This apart, Patnaik said that the BJP has promised 3,000 units of free electricity. The Central government has planned free power for one crore houses for the entire country and Odisha's share may be three lakh houses, he said.

'We have one and half crore houses in the state. Is this the free electricity you promised to the people?" the former chief minister said.

Patnaik claimed that in the next five years, the BJP won't be able to cover even five per cent of Odisha's population under the 3,000 units of free electricity scheme.

To create 25 lakh 'Lakhpati Didis' (self-help group members) by 2027 as promised by the BJP, the government will need about ₹20,000 crore, while the allocation is only ₹1,000 core for this, Patnaik said.

He also demanded that the government table the detailed list of 'Lakhpati Didis' in the

Referring to the BJP's promise of a developed Odisha by 2036. Patnaik said the budget provides ₹20 crore for the industrial corridor connecting Rourkela-Sambalpur-Paradip and Dhamra by June 2027. A corridor like this will not cost less than ₹one lakh crore, he claimed.

Sharpening his criticism of the government, the BJD president described the BJP as a 'Jumla' (gimmick) party.

"I am sorry, but you (BJP) have cheated the people of Odisha," the BJD chief said.

The Centre, in its annual Budget, has promised all support for completion of the Polavaram multi-purpose project. The issue was also raised in the Assembly, with Congress and BJD members protesting the BJP-led Central government's support to Andhra Pradesh to complete the Polavaram project.

Leader of Opposition and former CM Naveen Patnaik, in a statement July 23, had said, "We have been fighting for justice on the Polavaram issue. Allocating more funds for Polavaram without sorting out genuine grievances of Odisha shows partiality towards

During Patnaik's BJD rule, the state government had shot off several letters to the Centre demanding that the problems faced by the people of Odisha because of the Polavaram project be resolved. However, Majhi said he does not believe that the issues could be sorted out by just writing letters.

tained, the researchers said. For the study, over 2,000 parical advice and were asked to evaluate it for reliability, comprehensibility and empathy.

The participants were divided into three groups. While one

The researchers found that advice provided by human doctors also scored higher on empathy, compared to that when AI was involved.

The study represented a starting point for detailed research into the conditions under which AI can be used in diagnostics and therapy without jeopardising patients' trust and cooperation, according to the authors.

Social media hampers identity development among teens

SOCIAL MEDIA HAVE PROVIDED A PLATFORM FOR ADOLESCENTS - PARTICULARLY THOSE HIGH IN FOMO, OR FEAR OF MISSING OUT - TO OBSESS OVER HOW THEY COMPARE TO MANY MORE PEOPLE, INCLUDING APTLY NAMED 'INFLUENCERS'

here's some research that suggests social media can be helpful for certain young people to connect with likeminded peers

However, there are reasons to counter this view. The most compelling is evidence showing inappropriate screen time and social media use are linked to poor mental health in children and young people, including depression and anxiety.

Overuse or misuse of social media can damage many areas of psychological wellbeing including one that's not often con-

sidered: identity development. Identity development has long been regarded as the core psychological business of adolescence. You decide who you are, what you want to become, what underlying values you stand for and what you want out of life as you move toward adulthood. But the study shows that this process can be hampered by social media. Developing an identity

Between the ages of about 11 and 15, the human brain becomes increasingly sensitive to attention and feedback from peers. The parts of the brain responsible for developing perspective, judgment, critical thinking and self-control will not fully mature until a person's early to mid 20s.

Teenagers have always compared themselves to others. They seek validation from peers as they explore their values, develop their personalities and seek to express themselves. But social media have provided a platform for adolescents - particularly those high in FOMO, or fear of missing out - to obsess over how they compare to many more people, including aptly named 'influencers'

It can be difficult for a young person to develop a clear sense



of self when they're constantly comparing themselves to and

following others. Similarly, young people are developing many of their opinions based on what they see on social media. An individual's tendency to conform to other people's opinions is sometimes called the "bandwagon effect"

While plenty of social media content can be harmless enough, social media - like the real world are becoming increasingly political and polarised, with little tolerance for opposing ideas.

Some teens may find themselves latching onto ideologies fed to them via marketing algo-

Living in the public sphere Harry Triandis, a psychology researcher who died in 2019, proposed differences between the 'public' and 'private' self that we all embody. Most people can relate to keeping their real opinions or values to themselves while in public or in an unknown group of people.

According to study, once a person is confident that his manner of speaking and underlying value systems won't be misconstrued. he starts to reveal himself bit by bit. This process is the basis of forming friendships.

A person's private self is the basis for quiet reflection, learning and changing his mind. But nowadays teens play out their entire lives in the public sphere –

essentially skipping this step. Not only are they developing many of their opinions based

on what they see on social media, but they often broadcast them online instantly. At a later time, they may be forced to defend these ideas

In a 24/7 virtual world, there's less opportunity for today's teenager to critically think about what they see online, self-reflect, explore and change their mind. There is little room to make mistakes, test boundaries, explore ideas and analyse information to forge their own identity.

These concerns are among the reasons many medical experts, parents and politicians alike want to limit access to social media for children.

While social media can continue to have detrimental effects for people older than 16, the earlier part of adolescence is an important time for the development of a young person's identity and self-worth.

Nayak in her car, went to bring Manas from Chandbali, February 6, 2022. They waited all night for Manas at Palashpur and asked him to hand over the camera's memory chip when he came to meet them the next day

They forcibly took him in their car when he refused to hand over the camera chip. Later, they returned to Bhubaneswar and held Manas hostage at Dayal Ashram. Rare albino crocodile Malli awaits motherhood

Rajnagar, July 29: In what may come as exciting news for animal lovers, 29-year-old rare albino crocodile 'Malli' has laid eggs in anticipation of motherhood in Bhitarkanika National Park.

Living a solitary life in an enclosed pond within the park, Malli has built a nest and laid eggs, continuing her unique behavior in pursuit of motherhood despite being without a male mate for 29 years. This situation raises questions on the likelihood of the eggs hatching as she has laid eggs six times in the past without success.

In 1975, Bhitarkanika National Park commenced the world's first artificial crocodile breeding programme, spearheaded by Australian biologist Dr HR Bustard and Indian crocodile researcher Dr Sudhakar Kar. In 2003, two albino hatchlings were found inside a forest adjacent to Dangamal Crocodile Breeding Centre near Bankuala village.

nen and released the second one into a creek near Suajora. When the higher ups of the breeding centre saw the albino crocodile in the pen, they were very much excited and named her 'Malli'. Forest department staff cap-

Malli has been living in a 50decimal enclosed pond connected to the Bhitarkanika river, which allows fish to enter into the pond during high tides. This year, Malli laid eggs in an elevated area of the pond after building a nest with twigs and leaves. The forest officials who feed Malli were surprised as she was exhibiting unusual behavior for the past 7-8 days by ignoring their calls.

In 2018, Malli had laid 18 eggs for the first time, followed by 24 in 2019, 18 in 2020, 27 in 2021, 29 in 2022, and 23 in 2023. However, none of the eggs hatched due to the absence of a male partner. This year, she has laid eggs again and is diligently guarding them, raising concerns about her ability to become a mother without a mate.

The Forest department is considering finding for her a suitable male companion to fulfill her maternal instincts. According to DFO Sudarshan Gopinath Yaday, the head of the Rajnagar Wildlife Division, discussions are going on with crocodile experts to find an appropriate mate for Malli.

Kamala Changes

S Republican presidential candidate Donald Trump and his team have been forced to review their campaign strategy and come up with a misogynist, racist campaign to attack the new Democratic presidential candidate Kamala Harris who has compelled change in the election strategies of both parties. The endorsement by former President Barack Obama and $ar{ ext{h}}$ is wife Michelle Obama of Harris' candidacy last week has seemingly led to the sharpest attacks by Trump and his campaign managers. The new strategy is using gender discrimination and racism as the main propaganda

Trump was seemingly caught off guard when President Joe Biden suddenly opted out of the race and let Harris throw the gauntlet at the former. The move was so unexpected that for the next few days, the Republican campaign was clueless on how to take on Harris as it had long used all its resources and energies to target Biden, who was determined to run for the second term. But once the shock of his withdrawal from the campaign was over, Team Trump is now seen stacking misogynist and racist cards against Harris.

Samples of Trump's rhetoric make it obvious how venomous the attack against Harris is going to be. In his first campaign rally since Biden's exit in North Carolina, Trump called Harris "a radical-left lunatic who will destroy our country." He also branded her "lyin' Kamala Harris" and repeatedly pronounced her name wrong. This was his old tactic of racist ridicule of Harris whose first name he had deliberately distorted as "comma + la and whatever." While immigration is meant to be a central line of attack for Trump, he did not even mention it once in an interview with Fox News last Monday. This suggests Republicans are yet to settle on a message that is likely to sway undecided voters. At the moment, they are testing a number of messages and have not yet been able to narrow down which ones would resonate with the people most.

Four years ago, Donald Trump articulated his anti-feminine bias with the remark that Republicans "are not going to have a socialist President, especially any female." Now, his running mate JD Vance has stooped low in his attempt to run down Harris. He has described her as one of the "childless cat ladies who are miserable at their own lives and the choices that they have made and so they want to make the rest of the country miserable too." It may be noted that Harris has no biological children of her own. This was a cue given to the supporters who have become even more vicious. However, this strategy may boomerang as it may alienate moderate voters. On the side, in an international survey it was suggested that in many developed countries, including the US, women aged 18 to 30 are on an average 30 percentage points more liberal than men of the same age range.

Harris in her first campaign ad has sought to draw a sharp contrast with Trump through her advocacy of freedom. The tune of Beyoncé's song of the same name is played in the background as she talks about 'the freedom to be safe from gun violence, the freedom to make decisions about your own body." It is to be noted that this call for freedom to make decisions about your own body does not stop at abortion. It extends to the extreme sickness that is being viewed in the activities of the Alphabet community as was evident in the opening of the Olympic Games at Paris last week. The call of Harris was an obvious reference to Trump's record of exhorting his supporters to overturn the electorate's verdict last time, his open support for the gun lobby and his role in abolition of the abortion rule by Supreme Court judges appointed during his presidential tenure. She has described Trump's vision of America as "a country of chaos, fear and hate."

It is interesting that the scale of the fundraising has remarkably improved for Harris – \$200m in the week since she was endorsed by Joe Biden. The bulk of the money has come from first time donors numbering nearly 900,000. A national poll conducted by the New York Times and Siena College shows Harris is closing the Biden-Trump gap by five points.

It is too early to predict the voters' mood at this stage with many white conservatives and older voters known for their support for Trump. On the other hand, Harris is getting traction from the coloured population of African and Asian origins. Battle lines are drawn for the most crucial contest ever.



LOWER THE TEMPERATURE

INDEED, **ACCOMMODATION CONCILIATION SHOULD HAVE BEEN THE APPROACH EVEN WITH A BRUTE MAJORITY THAT THE GOVERNMENT DID HAVE IN ITS PREVIOUS TERM**

he elections are behind us and a minority government styled as Modi 3.0 has taken office. A reinvigorated Opposition has already seen the presentation of the Union Budget, which has picked ideas from the Congress manifesto, like the apprenticeship programme to address the burning crisis of jobs for millions. This should be a good sign in democratic politics. Good ideas can come from everywhere. The government could give credit to the Congress and earn some goodwill from the party in return. This is a time for the government to recognise and respect the new reality of the new Lok Sabha and to understand that long term success in politics and complex issues of governance demand the approach of give and take. The first pre-requisite for this is to lower the political temperature to get some real work done. But instead, the government has contributed to raising the political temperature even more. All indications are that the bitterness of the election season isn't going away.

The new attack quite obviously targeting the Congress on the Emergency by proclaiming 25 June as "Samvidhaan Hatya Diwas," and the Union Home Minister's latest political attacks on Uddhav Thackeray and Sharad Pawar, all appear to indicate that it's compulsion and/or "business as usual" for Modi sarkar, and to that extent it mocks the nation and its people who clearly decided not to give the incumbent a clear mandate for the third term. The government's answer is to keep the pot boiling as it lives a Rip Van Winkle story -almost as if it slept through the election results,

and now wants to live an old reality in a new world.

Indeed, accommodation and conciliation should have been the approach even with a brute majority that the government did have in its previous term. But that brought hubris, and it is the hubris in large part that brought the political defeat. No lessons have been learned. Indeed, they cannot be, because learnability does not go with a self-righteousness that digs in and a greed that wants to grab it all, be it votes, attention or narratives. This is a command and control mind at work: national issues are pictured as war and everything is fair because the only outcome must be for the leader to win at all costs.

In many ways, the story is reflection of the internal emptiness of the BJP, which has not been able to fix accountability for its showing in the Lok Sabha, and has been rendered incapable of reflection or raising hard questions for itself. The vice-like grip that the Prime Minister has on the party is at one level a political success for him personally, because which leader doesn't like a party that asks no questions of the leader? There are some internal noises emerging: an important group has raised questions on the working of UP CM Yogi Adityanath, and for the electoral losses in that state, the RSS chief has yet again offered remarks not seen as favourable to the Prime Minister but all these are oblique signs of an internal unease. Direct questions and downright analysis are missing. For all the accusations of the Congress being a family-run party, the BJP has only followed the path it seeks to condemn, becoming in little time the preserve of the vagaries of the Modi-Shah thinking. This capture tells us a lot about the party and its fibre, more than any historv-telling can.

It is not difficult to see that the duo has survived by constantly distracting attention. This has inevitably brought us an unending game of bogeyhunting. Consider the latest

example of just how much the break and bitterness is with the Opposition on the simple issue of a NITI-Aayog meeting - which was the ninth govern ing council meeting, and was chaired by Modi just last week. This is one place where the government could and should have worked hard so that all the CMs of all the states were respectfully accommodated.

Instead, as many as 10 CMs did not attend. The only Opposition voice present, Mamata Banerjee, walked out and complained that her mic was muted and she felt insulted. The arrogance in the later remarks of the NITI Aayog CEO BVR Subrahmanyam speaks for itself: "For those who did not participate, I always say that it is their loss." Where do these ideas come from? The slanging match on why she walked out and if the mic was muted is an example of how lower order conversations are fuelled and relished. It is for the government of the day at the Centre to stop this slide, to build confidence and to earn some credibility with Opposition parties, who are as much repre-

sentatives of the people. Soon after the elections, one view was that the BJP appropriately cut to size by the electorate would be now forced to listen and be mindful of boundaries. That has clearly not happened. The other view then may hold, which is that a diminished BJP at the Centre, unable to handle criticism and unskilled in charting the middle path, may end up doing more harm to the nation and its democratic traditions.

lobal efforts to combat climate change are primarily focused on phasing out fossil fuels and shifting to renewable energy. The accelerated pace of this transition, particularly in high-income countries, has led to a growing demand for critical metals and rare minerals, which are crucial for clean-energy infrastructure like batteries and semiconductors. According to the World Bank, more than three billion tons of minerals and metals will be needed by 2050 to develop the technologies required to limit the global temperature rise to 2° Celsius above pre-industrial levels.

Leading countries such as the US and China are seeking strategic partnerships with resource-rich countries, many of them low- and middle-income economies grappling with competing priorities and limited financial resources. The Democratic Republic of the Congo, for example, remains the world's $\,$ leading source of mined cobalt, an essential input for electric-vehicle batteries. But the absence of robust governance and accountability structures in mineral-rich countries prevents the equitable distribution of the gains from mineral extraction, driving local communities into poverty and fueling violent conflicts. Despite their vast mineral wealth, countries such as Angola, Chad, and the DRC have been plagued by incidences of corruption, authoritarian repression, militarisation, and civil wars.

Moreover, mining operations

often take place in remote locations, where marginalised local communities lack the necessary negotiating power and tools to deal with well-resourced and sophisticated multinational corporations, resulting in lopsided deals with far-reaching economic and environmental implications. Consequently, unscrupulous extractive-industry actors may cut corners or do the bare minimum to comply with regulatory frameworks aimed at protecting the environment and the health of the communities in which they operate. Without robust environmental, social, and public-health protections, the harmful effects of mining operations can erode the green transformation's expected economic benefits. There are many examples of communities around the world whose livelihoods have been adversely affected by social and environmental degradation caused by reckless resource-extraction practices. If allowed to continue, this could result in a pyrrhic victory, with a privileged few reaping the rewards of the clean-energy transition while most of the world is left behind. Crucially, unregulated mining can have farreaching public-health implications for low-income countries. Viral epidemics such as Ebola and yellow fever have often been linked to environmental degradation, which forces local communities to venture deep into wildlife sanctuaries to make a living. A 2021 Stanford University

study, for example, identified gold mining in the Brazilian Amazon as a major contributor to malaria outbreaks across the region.

In addition to these publichealth effects, environmental degradation caused by harmful mining practices has also been linked to reduced economic opportunities for local communities in affected countries. Research shows that unregulated mining can lead to a wide range of negative consequences, including reduced food production, poor nutrition, social apathy, delinquency, forced migration of large populations, and violent conflicts.

Considering the far-reaching effects of mineral extraction, national governments and international policymakers must take steps to safeguard vulnerable communities throughout the broader value chain. While wealthy countries go to great lengths to procure, develop, and adopt clean-energy technologies for their citizens' benefit, mineralproducing countries could face devastating consequences if adequate protective measures are not implemented.

Given this reality, countries benefiting from mineral extraction must ensure that affected communities can also enjoy the fruits of the clean-energy transition. Existing global frameworks, such as those addressing conflict diamonds, could be easily adapted to maintain the integrity of such initiatives. Similarly, emerging technolo-

gies like blockchain could help provide clear visibility and accountability, ensuring that the minerals essential for a lower-car-_ bon future are sourced and distributed ethically.

Encouragingly, many stakeholders have recognised the urgent need to bring this issue to the forefront of global policy discussions. Through its Climate-Smart Mining Initiative, the World Bank supports investment and provides technical assistance to mineralrich developing countries, facilitating the sustainable extraction and processing of essential minerals and metals and minimising mining's social and environmental impacts. Similarly, the World Economic Forum recently launched a global multi-stakeholder platform aimed at promoting the green agenda by facilitating collaborative risk management and international cooperation.

While these global efforts hold great promise, it is crucial to align the economic and social objectives of the energy transition. To achieve this, international policymakers must ensure that green programmes fit the specific context in which they will be implemented by encouraging local communities affected by mineral extraction to participate in their design. Only by doing so can we build a clean-energy future that is truly inclusive and sustainable.



US woman found chained to tree in Sindhudurg forest

Mumbai: A 50-year-old American woman was found tied to a tree with an iron chain in a forest in Maharashtra's Sindhudurg district, and a set of documents, including an Aadhaar card with a Tamil Nadu address, were recovered from her possession, a police official said Monday. Police suspect the husband of the woman, Lalita Kayi, tied her inside the forest in the coastal district, around 450km from Mumbai, and fled. The woman, who appeared frail and said to be battling mental health issues, is originally from the United States and had been staying in Tamil Nadu, from where her husband hails, for the last 10 years, an official said.

Four children drown in pond

Jaipur: Four boys drowned while taking a bath in a pond in Rajasthan's Didwana district, police said Monday. According to the police, the incident took place Sunday in Kerap village when the victims had gone to play near the pond. When the children, aged between 12 to 15 years, did not return till late, their parents started a search for them and spotted their slippers near the pond, they said.

Supreme Court commences special Lok Adalat

Allows media cameras inside courtrooms

New Delhi, July 29: In a first, the first seven benches of the Supreme Court commenced a special Lok Adalat at 2 pm Monday for an amicable resolution of disputes, with media cameras being allowed inside courtrooms

The week-long special Lok Adalat, celebrating 75 years of the Supreme Court, began with the aim to "facilitate amicable settlements of suitable pending cases", in matters that have "elements of settlement"

Earlier in the day, Chief Justice of India (CJI) DY Chandrachud said the first seven benches of the apex court will hear cases in the special Lok Adalat at 2 pm.

The top court will hold the special Lok Adalat till August 3,



in an effort to reduce the pendency of cases

"From today till Friday, we will have the Supreme Court Lok Adalat and the first seven benches will sit for it. If lawyers have cases which can go before the Lok Adalat, please bring them," the CJI said at the outset of the day's proceedings.

Justice Chandrachud had earlier requested citizens, who have pending cases before the Supreme Court, to take part in the special Lok Adalat to get their disputes resolved amicably and speedily.

In a video message uploaded on the court's website, he had said, "From July 29 to August 3, the Supreme Court is or-

ganising a special Lok Adalat. This is part of a series of activities which the Supreme Court is observing to commemorate the 75th year since the establishment of the Supreme Court.'

Most significantly, the CJI had said judges dedicated to the institution of justice are concerned about the large backlog of cases.

"The Lok Adalat represents a very informal technology-based solution to resolve cases involving our citizens to their satisfaction in a purely voluntary, consensual mode.'

"Therefore, on behalf of all my colleagues and the staff of the Supreme Court, I would appeal to all citizens who have cases before the Supreme Court or lawyers advocates on record to take the advantage and benefit of this opportunity in an attempt to resolve the cases speedily, in a manner which is acceptable to every contesting party," Justice Chandrachud had said. The top court said Lok Adalats are an integral component of the country's judicial system, enhancing alternative dispute resolution as a means of expediting and fostering ami-

cable settlements. It said cases with elements of settlement, including those relating to matrimonial disputes, property disputes, motor-accident claims, land acquisition, compensation, service and labour, pending before the apex court would be taken up to facilitate a speedy disposal.

New Delhi, July 29: Five more people, including four co-owners of the basement of the coaching centre where three civil services aspirants died, were arrested Monday and bulldozers began demolishing encroachments as anguish over the deaths echoed across the city, from parliament to the streets of Old Rajinder Nagar.

The Ministry of Home Affairs constituted a committee to inquire into the incident and said it will look into the reasons, fix responsibility, suggest measures

and recommend policy changes. While Lok Sabha members across party lines demanded an inquiry, hundreds of students continued their protests near Rau's IAS Study Circle in the west Delhi locality where the horror unfolded Saturday night, killing the three students trapped in the basement illegally used as a library as floodwaters rose outside.

The driver of an SUV which drove through the flooded street, causing the water to swell and breach the gates of the threestorey building and inundate the basement, was among the five arrested. The SUV was also

All five were sent to judicial custody for 14 days by a court. With this, the number of arrests has gone up to seven. The

New Delhi, July 29: Using the 'chakravyuh' metaphor as a leitmotif, Leader of Opposition in the Lok Sabha Rahul Gandhi Monday claimed that an atmosphere of fear prevails all around with a group of six trapping the entire country in a chakravyuh' he promised would

be broken by the INDIA bloc. Participating in the debate in the Lok Sabha on Budget 2024-25, Gandhi said the Indian National Developmental Inclusive Alliance (INDIA) will ensure that a legal guarantee for MSP as well as a caste cen-

sus is passed by the House. In a speech that invoked the Mahabharat and led to an uproar in the House, prompting Speaker Om Birla to intervene frequently, the former Congress chief alleged that the sole aim of the Union Budget is to strengthen the framework of big businesses, political monopoly that destroys the democratic structure, and the deep state or the agencies.

"There is an atmosphere of fear and that fear has pervaded every aspect of our country. In the BJP only one man is allowed to dream to be the prime minister. If the defence minister wants to be PM, there is a big problem, there is fear. This fear has been spread throughout the country...why is it that my friends in the BJP are terrified, ministers are terrified, farmers, workers are terrified?" the Congress leader asked. Thousands of years ago in

Haryana's Kurukshetra, six people killed a youth, Abhimanyu, in a 'chakravyuh', he said, adding that a 'chakravyuh' has violence He said the 'chakravyuh' is

also called a 'padmavyuh' for its resemblance to a lotus (BJP's election symbol) formation.

"In the 21st century, another 'chakravyuh' has been prepared. It is in the form of lotus and the prime minister (Narendra Modi) wears the symbol on his chest. What was done with Abhinmanyu is being done with India, with its youth, women, farmers and small and medium businesses," he said.

Today also, there are six people at the centre of the 'chakravyuh', including Prime Minister Narendra Modi and Home Minister Amit Shah. Gandhi took the name of four more people but Speaker Om Birla disallowed it citing that they were not members of the House and hence cannot be named.

As the treasury benches erupted in protest, Parliamentary Affairs Minister Kiren Rijiju said Gandhi was not following parliamentary procedure. The Congress leader was not showing him the courtesy of allowing him to intervene, Rijiju said.

"You create 'chakravyuhs' and we break them," he said and asserted that the best way to break 'chakrayyuhs' was through the caste census.

1 in 9 Indians at risk of developing cancer: Experts

Tobacco consumption remains the foremost preventable cause of cancer in India

New Delhi, 29 July: Amid mounting cases of cancer in India, health experts Monday said that one out of nine Indians have a lifetime risk of developing cancer but most are preventable with early detection.

India is witnessing a rise in cancer cases. As per a recent Apollo Hospitals' Health of Nation Report, India is the "cancer capital of the world." It projected the number of annual cancer cases to rise from almost 1.4 million in 2020 to 1.57 million by 2025.

This alarming trend underscores the need for urgent and comprehensive government action to address the multifaceted causes and implement effective prevention and treatment meas-





New Delhi, July 29: Concluding its probe in the alleged Delhi excise policy scam, the CBI Monday filed its final charge sheet in the case against Chief Minister Arvind Kejriwal and five others, including AAP MLA Durgesh Pathak, officials said.

The federal probe agency had earlier filed a main charge sheet and four supplementaries in the case in which former Delhi deputy chief minister Manish Sisodia, Telangana MLC K Kavitha and 15 others have also been charged.

It said the charge sheet filed Monday is the final one in the case. The CBI has named Kejriwal, AAP MLA Durgesh Pathak, non-executive director of Aurobindo Pharma P Sarath Chandra Reddy, director of Buddy Retail Pvt Ltd Amit Arora, alleged hawala operator Vinod Chauhan and businessman Ashish Mathur as accused.

The probe agency has alleged that liquor businessman Magunta Sreenivasalu Reddy (now a TDP MP) met Kejriwal March 16, 2021, at his office in the Delhi Secretariat.

Reddy allegedly requested Kejriwal to provide support in his liquor business in the national capital by tweaking the Excise Policy 2021-22 which was then in the making, the CBI said in its charge sheet against K Kavitha.

Kejriwal assured support to

Reddy and asked him to contact the accused K Kavitha as she was working with his team on the Excise Policy of Delhi, the CBI has alleged.

The Delhi chief minister, in turn, allegedly told Reddy to provide funds to his Aam Aadmi Party, the probe agency has alleged.

The CBI also claimed that kickbacks of around Rs 90-100 crore were paid in advance to some politicians of the ruling AAP in Delhi and other public servants by some persons in the liquor business from South India through co-accused Vijay Nair, Abhishek Boinpally and Dinesh Arora to tweak the 2021-22 Excise

The agency had alleged that these kickbacks are found to have been returned to them subsequently out of the profit margins of wholesalers holding L-1 licenses through different modes, like issuance of excess credit notes, bank transfers, and outstanding amounts left in accounts of the companies controlled, by some conspirators from the South lobby.

The CBI had alleged that a cartel was formed between three stakeholders of the said policy -- liquor manufacturers, wholesalers and retailers -- by violating provisions and against the spirit of the policy.

All the conspirators allegedly played active roles in achieving the illegal objectives of the said criminal conspiracy. It resulted in huge losses to the exchequer and undue pecuniary benefits to the public servants and other accused involved in the conspiracy, the CBI has alleged.

RBI plans 5-episode web series to showcase 90-year journey

Haryana man dies on Russian frontline

The Indian Embassy in Moscow has confirmed the death of Ravi Moun but has not disclosed the circumstances

Chandigarh, July 29: A 22year-old Haryana man "sent to the frontline by the Russian Army to fight against Ukrainian forces" has died, his family claimed Monday.

The Indian embassy in Moscow confirmed the death of Ravi Moun, who hailed from Matour village in Haryana's Kaithal district, his brother Ajay Moun said. Ravi Moun went to Russia

January 13 after being "hired" for a transportation job but was inducted into the military, his brother claimed.

Aiav Moun wrote to the embassy July 21 for information on his brother's whereabouts.

"The embassy told us that he has died," he said. The family said the embassy

also asked them to send a DNA test report for identification of the body.

'Ravi went to Russia January 13. An agent sent him to Russia for a transportation job. However, he was inducted into the Russian Army," Ajay Moun said.

The family's claim comes days after Russia agreed to India's demand to ensure early release and return of Indian nationals inducted into the country's military. Ajay Moun alleged that the Russian Army asked his brother to go to the frontline to fight against Ukrainian forces or face 10 years in jail.

He was trained to dig trenches and later sent to the frontline, Ajay Moun said.

We remained in touch with him till March 12 and he was quite upset," he said.

According to the Indian embassy's reply to Ajay Moun's let-

ter, "The embassy had requested the concerned Russian authorities for confirmation of his death and transportation of his mortal remains requested by

"The Russian side has confirmed his death. However, to identify the body, they need a DNA test from his close relatives," it added.

Ajay Moun also requested Prime Minister Narendra Modi to bring his brother's mortal remains back to India.

"We do not have enough money to bring back his body," he told reporters. The family sold off a one-acre

land and spent Rs 11.50 lakh to send him to Russia, he said. Earlier this month, Russia

agreed to India's demand to ensure early release and return of Indian nationals working in the Russian military as support staff after Modi raised the issue with Russian President Vladimir Putin. Russia had promised early discharge of all Indian nationals from the army.

Last month, the Ministry of External Affairs said the issue of Indian nationals serving in the Russian Army remained a matter of "utmost concern" and demanded action from Moscow.

Supreme Court reprieve for Soren

New Delhi: In a relief to Jharkhand Chief Minister Hemant Soren, the Supreme Court Monday dismissed the Enforcement Directorate's (ED) plea challenging a High Court order granting him bail in a money laundering case linked to an alleged land scam. The apex court said the Jharkhand High Court's June 28 order granting bail to Soren was a "very well reasoned judgement". "We are not inclined to interfere with the impugned order," a bench of Justices BR Gavai and KV Viswanathan said.

New Delhi: The Supreme Court Monday refused to entertain a PIL challenging the government's decision to cancel the UGC-NET examination following alleged question paper leak. A bench comprising Chief Justice DY Chandrachud and justices JB Pardiwala and Manoj Misra, however, said the dismissal of the PIL does not amount to a decision on the merits of the PIL as it was filed by a lawyer and not by aggrieved students.

Allahabad HC sets aside Afzal Ansari's conviction

Prayagraj: The Allahabad High Court Monday set aside a Ghazipur court order sentencing Samajwadi Party MP Afzal Ansari to four years' imprisonment under the Gangsters Act over the murder of BJP MLA Krishnanand Rai in 2005. With Justice SK Singh allowing his plea against the conviction, the SP MP can now continue as a Member of Parliament. The court also dismissed pleas by the UP government and Piyush Kumar Rai, Krishnanand Rai's son, seeking enhancement of the Ghazinur MP's sentence.

New Delhi, July 29: The Union education ministry Monday notified guidelines for implementation of bagless days for classes 6-8 and making learning in schools more joyful, experiential and stress-free.

The guidelines, developed by PSS Central Institute of Vocational Education, a unit of the National Council for Educational Research and Training (NCERT), were released on the fourth anniversary of the new National Education Policy (NEP), 2020.

The NEP, 2020, had recommended that all students in classes 6-8 participate in a 10day bagless period.

The idea behind 10 bagless

The train hit the truck at about 65 kph near Kotelnikovo station, which lies in the southern Volgograd region about 1,200 km south of Moscow.

Rajapaksas' party withdraws support

Colombo: The political party of Sri Lanka's Rajapaksa family Monday decided not to back President Ranil September 21 presidential election, in a setback to his bid to return to power. The General Secretary of the Sri Lanka Podujana Peramuna (SLPP) Sagara Kariyawasam told reporters, "The party's Politburo which met today has decided to field our own candidate under its own symbol." He said despite views to the contrary made by several members, the consensus was that the party should field its own candidate.

Top radical leader **booked in Pakistan**

Islamabad: An FIR was filed against a top leader of the radical Islamist group Tehreek e-Labbaik Pakistan and its 1.500 workers for issuing death threats to Chief Justice of Pakistan Oazi Faez Isa. The FIR was registered against Pir Zaheerul Hasan Shah, the Deputy Amir of Tehreek-e-Labbaik Pakistan (TLP). The charges against Shah include sections of the Anti-Terrorism Act (ATA), inciting religious hatred, causing public disorder, intimidating the judiciary, threatening the judiciary, interfering in official duties, and obstructing legal functions.

Philippine oil spill reaches fishing town

Tanza: An oil spill from a marine tanker that capsized off the coast of Manila Bay in the Philippines has reached the shores of a nearby fishing village, threatening the health and livelihood of fishermen, as efforts began to mop up the fuel. Fishermen in the town of Tanza in Cavite province, south of Manila, were in distraught after the oil slick landed on the town's shores and they reported smelling a foul odour.

SA's ANC expels former Prez Zuma after poll betrayal

Johannesburg, July 29: Former South African President Jacob Zuma has been expelled from the African National Congress after backing a rival party in May's parliamentary election, the ANC said Monday.

Zuma was suspended from his long-time party in January after announcing he would support the new uMkhonto we Sizwe (MK) in the general election. He later became the leader and face of MK.

MK did better than expected in the poll and won about 15% of the vote, a major factor in the ANC's loss of its majority for the first time since the apartheid era.

'Former President Jacob Zuma has actively impugned the integrity of the ANC and campaigned to dislodge the ANC from power, while claiming that he had not severed his membership," ANC Secretary General Fikile Mbalula told the media.

"This conduct is irreconcilable with the spirit of organisational discipline and letter of the ANC Constitution." The ANC won 40.18% of the

vote in the election, down from 57.50% it gathered in 2019, forcing it into a coalition government for the first time since it took power at the end of white minority rule in 1994. MK is now the official opposition. MK responded to media re-

ports that Zuma had been expelled in a statement earlier Monday, criticizing the ANC's process and condemning "grave" injustices" against Zuma.

Zuma will have 21 days to appeal the decision, the ANC said.

Zuma, whose nine years in office from 2009 were marked by corruption scandals and sluggish economic growth, has been at odds with the ANC's leadership since he was forced to quit as party leader in 2018. He has repeatedly lashed out against his successor, President Cyril

HPCL net profit slumps 90%

New Delhi: State-owned Hindustan Petroleum Corporation Ltd (BPCL) Monday reported a massive 90 per cent drop in net profit in the June quarter, as refinery margins fell and a fuel price reduction slashed marketing margins. HPCL reported a consolidated net profit of ₹633.94 crore in April-June -the first quarter of the current 2024-25 fiscal year compared to a profit of ₹6.765.50 crore a vear back. according to a stock exchange filing by the company. Net profit also declined sequentially, when compared to an earning of ₹2,709.31 crore in the January-March period. Pre-tax earnings from downstream fuel retailing businesses slumped 90 per cent to ₹907.86 crore.

Indian Bank net profit rises 41%

New Delhi: State-owned Indian Bank Monday posted a 41 per cent jump in its net profit to ₹2,403 crore for the June 2024 quarter due to a decline in bad loans. The Chennai-based lender had earned a net profit of ₹1,709 crore in the year-ago period. During the quarter, the bank's total income increased to ₹16,945 crore against ₹14,759 crore a year ago, Indian Bank said in a regulatory filing. Its interest income grew to ₹15.039 crore during the period under review from ₹13,049 crore in the corresponding quarter a year ago. On the asset quality side, the bank's gross nonperforming assets (NPAs) improved to 3.77 per cent of gross advances as of June 30. 2024, from 5.47 per cent in the April-June quarter of the previous fiscal.

ACC net profit down 22.5%

New Delhi: Cement maker ACC Ltd Monday reported a decline of 22.46 per cent in its net profit to ₹361.40 crore in the first quarter ended on June 2024. The company had posted a profit of ₹466.14 crore in the April-June quarter a year ago, according to a regulatory filing from ACC, now a part of Adani Cement. Its revenue from operations was marginally lower at ₹5,154.89 crore during the quarter under review. INDIA LIKELY TO RECORD VER 7% GROWTH: NCAER

New Delhi, July 29: The Indian economy could grow higher than 7 per cent and possibly closer to 7.5 per cent in the current fiscal on the back of normal monsoon and receded electoral uncertainty, economic think tank NCAER has said.

In its July 2024 issue of Monthly Economic Review (MER), NCAER said real GDP grew by 8.2 per cent in FY2023-24, driven by stable consumption demand and steadily improving investment demand.

"Based on the momentum in the high-frequency indicators. normalised monsoon, a relatively benign global outlook and receded electoral uncertainty, both in India and in the rest of the world, growth will likely turn out to be higher than 7 per cent, and possibly closer to 7.5 per cent," NCAER director general

Poonam Gupta said.

Gupta said the Union Budget 2024-25 lived up to the expectations of unwavering commitment to fiscal consolidation, prudence, and quality. The Budget has kept the fiscal

deficit target at 4.9 per cent of GDP and capital expenditure at 2.4 per cent of GDP during 2024-According to the National

Council of Applied Economic Research (NCAER), the short to medium-term growth strategy is based on six key areas -- private sector capital formation, green transition financing, MSME development, agricultural transformation, Education and skill development, and enhanced state capacity.

The NCAER-NSE business confidence index (BCI) increased to 149.8 in the first quarter (Q1) of FY25, up from 138.2 in the fourth quarter (Q4) of FY24, indicating an improvement in business sentiments.

The International Monetary Fund (IMF) revised its growth projection for India upward to 7 per cent, while the Asian Development Bank (ADB) maintained its projection at 7 per cent as of July 2024 for FY2024-25. The range of projections for India for the current fiscal year is between 6.6 to 7.2 per cent.

As per the Economic Survey 2023-24, India's real GDP grew by 8.2 per cent in FY2023-24 due to stable consumption and improving investment demand, and it is projected to grow between 6.5-7 per cent in FY2024-

The Union Budget for FY2024-25 emphasised fiscal prudence and capex. Nominal GDP is projected to grow at 10.5 per cent in FY2024-25; while the fiscal deficit is budgeted at 4.9 per cent of

Govt puts Concor $^{+}$ privatisation on backburner

New Delhi, July 29: The government has put the privatisation of Container Corporation of India Ltd (Concor) on the backburner, an official said.

In November 2019, the Union Cabinet approved the strategic sale of a 30.8 per cent stake, along with management control, in Concor - a Navratna PSU under the Railways Ministry.



The government currently holds 54.80 per cent of Concor.

"The government is unlikely to push Concor's strategic sale. There are some concerns from Railways Ministry as also investors," the official said.

The official further said that with the government holding in the company at 54.80 per cent, there is little scope for coming out with an offer for sale (OFS) in Concor.

Although the Cabinet approval for the Concor sale was accorded in 2019, no worthwhile progress has so far been made, and even an Expression of Interest (EOI) has not been invited for the strategic sale. Shares of Concor closed at Rs 1,043.25 apiece, up 0.35 per cent over the previous close

Ola Electric fixes IPO price band at ₹72-76

Mumbai: Softbank-backed two-wheeler maker Ola Electric Mobility Monday fixed the price band at ₹72-76 per equity share for its ₹6,100-crore initial public offering (IPO) which will hit the capital market August 2. The company also said that the trial production of its gigafactory are currently on and the operations are set to commence early next year. The IPO, a combination of a fresh issue of equity shares up to ₹5,500 crore and an offer for sale (OFS) of 8.49 crore equity shares by promoters and investors, will close August 6. Under the OFS, Ola Electric founder Bhavish Aggarwal will offload around 3.8 crore shares. Investors can bid for a minimum of 197 equity shares and in multiples of it thereafter, the company said. Of the total IPO proceeds, ₹1,227.6 crore will be allocated to increase the capacity of its cell manufacturing plant from 5 GWh to 6.4 GWh while ₹1,600 crore will be invested in research and product development, Ola said. Besides, the company will use ₹800 crore for the repayment of existing debts and ₹350 crore for organic growth initiatives. For Ola Electric, the IPO will provide the much-needed impetus to invest in enhancing cell manufacturing capacity and research and development on future technologies and products.

The other Indian pair of Rhythm Sangwan and Arjun Singh Cheema finished 10th with a score of 576 and failed to make it to the medal rounds.

Turkiye, after equalling Qualification Olympic Record with 582, and Serbia (581), who finished second, respectively, will contest the gold-medal match.

Bhaker was sensational with her 98s in the first two series, but a 95 in the third set pulled the team down a bit. However, the pair did enough to make the medal round in the end.

Seine too dirty for triathletes; events cancelled TRIATHLON CANCELS OLYMPIC SWIM TRAINING FOR 2ND STRAIGHT DAY DUE TO POOR WATER QUALITY IN RIVER SEINE

Paris, July 29: The water quality in the Seine River remained a concern Monday as officials called off the swimming portion of an Olympic triathlon training session for a second straight day.

Event organisers overseeing the event at the Paris Games are optimistic that triathletes will be able to swim in the city's famed waterway when the competition starts Tuesday.

The sport's governing body World Triathlon and its medical team, along with city officials, are banking on sunny weather and higher temperatures over the course of the next 36 hours to improve the water quality and bring it below the necessary limits to stage the swim portion of a race that also includes biking and

World Triathlon made the decision to cancel the swim work-



out early Monday following a meeting over water quality. The representatives for Paris 2024 and triathlon's international federation said tests conducted in the Seine Sunday showed water quality levels leading into the training session that "did not provide sufficient guaran-

tees to allow the event to be held.' The delegation said this was due to the recent rain that impacted Friday's opening cere-

Swimming in the Seine has been banned for over a century in big part because of the poor water quality. Organizers have invested 1.4 billion euros (\$1.5 billion) to prepare the river ahead of the Olympics. In addition to the swimming port of the triathlon Tuesday and Wednesday, the Seine will be used for the marathon swimming competitions August 8 and 9.

Daily water quality tests in early June indicated unsafe levels of E coli bacteria, followed by recent improvements. Some of the measures put in place to improve the water quality include the construction of a giant basin to capture excess rainwater and keep wastewater from flowing

Paris Mayor Anne Hidalgo went for a famous swim in the river less than two weeks before Olympic events were set to start, fulfilling a promise to show that the long-polluted waterway was clean enough to host swimming

Vandalism hits communication lines

he French government says multiple telecommunications lines have been hit by acts of vandalism, affecting fiber lines and fixed and mobile phone lines as cities around France are hosting events for the 2024 Paris Olympics. The scale of the impact is unclear, as is whether it has affected any Olympic activities. The vandalism came after arson attacks hit train networks around France Friday, hours before the Olympics opening ceremony. Marina Ferrari, secretary of state in charge of digital affairs, posted on X that damage in several regions overnight Sunday to Monday affected telecommunications operators. She said that led to localized impact on access to fiber lines and fixed and mobile telephone lines. A French police official said at least six of France's administrative departments were affected, which include the region around the Mediterranean city of Marseille, hosting Olympic soccer and sailing competitions. Telecom operators Bouygues and Free confirmed their services were affected. French media reports said lines operated by provider SFR also were hit. The parent company of Free said its teams are mobilised to restore services.

Harmanpreet saves India again

SKIPPER'S LATE GOAL HELPS INDIA ESCAPE WITH 1-1 DRAW VS ARGENTINA

Paris, July 29: Skipper Harmanpreet Singh rescued India by converting a lastminute penalty corner as they held former champions Argentina to a 1-1 draw in a Pool B hockey match of the Paris Olympics here Monday.

India had fluffed as many as nine penalty corners before Harmanpreet found the net, firing the ball into the top corner.

Argentina were left to rue the missed penalty stroke by Maico Casella in the 36th minute.

It was Lucas Martinez, who had put his side ahead in the 22nd minute with a field goal and Harmanpreet, who had struck against New Zealand in the dying moments, found the net a minute before the final hooter.

Harmanpreet did not feel that India fared poorly.

"To be honest, we created a lot of chances. There were lots of open slots and counter balls. Finishing is where we need to do better. Even in 50-50 balls we have to give 100 percent and in 100 per cent ball, we need to convert with effort. We will keep that in mind going forward," Harmanpreet told PTI.

The India captain was all praise for the Argentina defence.

"That is something we can learn, it was a good lesson from this game. They also play overhead and we do the same.

Coming into the match after losing to Australia, the Rio Olympic champions were desperate for a win but

had to be content with a draw despite dominating the proceedings for the better part of the match.

Argentina enjoyed possession as India struggled to penetrate the rival circle throughout.

The first quarter remained goalless with both teams failing to cash in on the short corners they got. India continued with their aerial clearances but suffered due to the lack of finishing skills in the opposition 'D'.

The Argentines were also on the lookout for aerial balls but a clear sight of goal eluded them too.

In the 10th minute, India earned a penalty corner but the Argentines saved the shot from Sanjay. Abhishek also took his chance but hit the crossbar. The South Americans got their first chance a minute later but Domene's shot went wide.

A couple of penalty corners came India's way in second quarter but the Argentine custodian Tomas Santiago was at it, saving a fierce shot from Harmanpreet with his right leg.

The deadlock was broken in the second quarter with Argentina taking the lead with a field goal.

India were in for a rude shock when Martinez's bumpy shot went inside, evading the outstretched hands of a diving PR Sreejesh, who should have saved it in the first place.

Martinez took a first-time shot from inside the 'D' after he was set up by Bautista Zubeldia Capurro's fine 3D

skills on the right flank. Jolted by the strike, India quickly

rushed to the rival circle but lost possession and it was back to mid-field. Mostly the game was being played in India's half.

Jarmanpreet looked for a shot from outside the circle on the right flank but failed to connect and India lost possession yet again.

The former champions led 1-0 after the first half. The South Americans increased the intensity of attacks in the third quarter. Manpreet and Abhishek also conjured a move but Santiago thwarted the attempt.

In the 36th minute, Argentina got a short corner but could not convert but, much to the shock of the team. Casella Schuth missed the penalty stroke. It was a great opportunity to go 2-0 up, but he bungled big time and shot wide.

The Argentines largely controlled the proceedings, smartly keeping the possession, but towards the end of final quarter, India produced an array of


