Steel plant to come up in CM's home dist

Bhubaneswar, August 3: The state government Saturday decided to form a task force, headed by the Chief Secretary, for setting up a mega steel plant in Keonjhar, the home district of the Chief Minister, officials said.

The decision was taken during a meeting where Chief Minister Mohan Charan Majhi reviewed the industrial scenario in the Though the Keonjhar district

is abundant with raw materials like iron ore, power and water, the area does not have a steel Notably, Majhi hails from

Keonjhar district and it is his priority to set up a major steel facility in the area, an official said. The task force will be headed

by Chief Secretary Manoj Ahuja, which will expedite the process of holding talks with investors for the proposed steel plant in the district.

ArcelorMittal had planned to set up a 12-mtpa steel plant in Keonjhar but the project was later abandoned due to local protests.

The proposed steel plant will have an advantage in terms of supplies of raw materials as several iron ore mines are located across Keonjhar district, another official said.

During the meeting, Industries Department Secretary Hemant Sharma apprised the Chief Minister of the industrial situation in the state and said around 989 proposals have been received by the government for setting up industries. Of them, 674 projects have got the nod of the state government through single window clearance authority.

Most chatbots are 'left-leaning'

Man held after marrying 5 women, proposing 49

Bhubaneswar, August 3: A 34-yearold man was arrested in Bhubaneswar on the charge of marrying five women without divorcing anyone and duping them of lakhs of rupees posing himself as a police officer, an official said Saturday. It was also found out dur-

ing investigation that the accused was interacting with 49 other women in a matrimonial site over proposals of marriage. After receiving separate com-

plaints from two women whom he had married, the police laid a trap using a female officer, and arrested Satyajit Samal, Bhubaneswar-Cuttack Commissioner of Police Sanjeeb Panda told at a presser.

The police recovered a car, a motorcycle, ₹2.10 lakh in cash, a pistol, some ammunition and two marriage agreement certificates from his possession.

Of his total five wives, two were from

Odisha and one each was from Kolkata and Delhi. The police were yet to get details of the fifth woman.

The police officer said the accused, from Jajpur district, has currently been living in Bhubaneswar, used to target young widows and divorcees.

"Samal used to demand cash and cars after promising to marry them. He also used to threaten them with a gun if they sought their money back," he said.

According to one of the two complainants, she got in touch with Samal through a matrimonial site. Later, he allegedly forced her into a physical relationship on the pretext of marriage

and demanded money to purchase a car. The victim took a personal loan from a bank and bought a car worth around ₹8.15 lakh for him. She also gave him ₹36 lakh to start a business.

New Delhi, August 3: When chatbots were tested for their political inclination, most of them revealed a left-ofcentre stance, a study has revealed.

However, when the chatbots, including ChatGPT and Gemini, were tested after being 'taught' a certain political inclination -- left, right or centre - they produced responses in alignment with their 'training,' or 'fine-tuning,' David Rozado, a researcher from Otago Polytechnic, New Zealand, found.

This shows that chatbots can be 'steered' towards desired locations on the political spectrum, using modest amounts of politically aligned data, the author said in the study published in the journal PLoS ONE.

Chatbots are AI-based large language models (LLMs), which are trained on massive amounts of textual data and are, therefore, capable of responding to requests framed in the natural



Multiple studies have analysed the political orientation of chatbots available in the public domain and found them to occupy varied locations on the political

On 24 different open- and closed-source chatbots, the author performed political orientation tests. He found that most of these chatbots generated 'left-of-centre' responses, as adjudged by the

majority of the political tests. Further, using published text, Rozado also induced a political bias by fine-tuning GPT-3.5, a type of machine learning algorithm developed to adapt LLMs to spe-

cific tasks. Thus, a 'LeftWingGPT' was created training the

model on snippets of text from publications such as The Atlantic, The New Yorker, and from books written by authors with similar political persuasions. Likewise, for creating

'RightWingGPT,' Rozado used text from publications such as The American Conservative and books by similarly aligned writers.

Finally, 'DepolarizingGPT' was created by training GPT-3.5 using content from the Institute for Cultural Evolution, a US-based think tank, and the book Developmental Politics, written by the institute's president. Steve McIntosh.

"As a result of the political alignment fine-tuning, RightWingGPT has gravitated towards right-leaning regions of the political landscape in the four tests. A (similar) effect is observed for LeftWingGPT.

"DepolarizingGPT is on average closer to political neutrality and away from the poles of the political spectrum," the author wrote.





ODIA DOC'S BODY BROUGHT FROM WAYANAD

RHURANESWAR: The body of a doctor from the state, who died in the devastating landslides in Kerala's Wayanad district two days after celebrating his birthday there, reached home Saturday evening. Dr Bishnu Prasad Chinara, his wife and two others - Dr Swadhi Panda and Sikruti Mohapatra - reached Wayanad July 27 where Chinara celebrated his birthday. They were asleep in the hotel when the devastating landslide swept them away at around 2am July 29, officials said. Panda is missing, while Chinara's wife and Mohaparta are under treatment in a hospital in the southern state. Chinara's body was brought back to his home in Housing Board Colony in Cuttack Choudwar in a special ambulance. His friends, relatives and others paid their last respects. His body is likely to be taken to Puri for cremation. Revenue and Disaster Management Minister Suresh Pujari had earlier said that the doctor's body was being brought by road as there was no direct flight from Kochi. "We are in touch with the Kerala government and an Odia SRC official there," Pujari said.

STA to begin docu verification

Bhubaneswar, August 3: State Transport Authority (STA) is drive throughout the state in order to curb reckless drivers without valid documentation on the roads

Special teams will be constituted and put in action to inspect and impose fine according to the laid Motor Vehicle Act

However, the previously announced one-time tax exemption scheme by the Commerce and Transport department remains in effect, informed the officials. Vehicle owners who have not yet paid the taxes are urged to settle their dues and avail the exemption without entirely paying the penalty amount before the deadline, an official statement stated.

State transport commissioner Amitabh Thakur held a discus-

sion with department senior officials and Regional Transport Officers (RTOs), Saturday.

Before initiating enforcement actions, the commissioner advised officials to take immediate measures and ensure the tax exemption scheme by the department reaches as many vehicle owners as possible, allowing them to benefit from the pro-

According to the exemption scheme, commercial vehicle owners with pending dues as of March 31, 2022, can take advantage of the programme. The scheme mandates that all outstanding taxes must be paid in a lump sum. The penalty incurred due to delayed payment will be completely waived.

Additionally, for vehicle owners who wish to scrap their vehicles, the exemption scheme provides benefits. Vehicles with tax arrears from April 1, 1992, to March 31, 2020, can avail a 50 exemption scheme. commercial vehicle owners with pending dues as of March 31, 2022, can take advantage of the programme. The scheme mandates that all outstanding taxes must be paid in a lump sum. The penalty incurred due to delayed payment will be completely waived

per cent waiver on the tax amount, along with a full waiver of penalties. For vehicles with outstanding taxes before April 1, 1992, a 100 per cent waiver on the entire due amount has been announced, allowing owners to scrap their vehicles without any payment. Even if a vehicle has already been scrapped without prior RTO approval, owners can still benefit from the scheme.

However, slightly different rules apply to tractors, agricultural tractors, trailers, and three-wheeled passenger and goods vehicles. Detailed information on these exemptions is available with all RTOs and on Transport department's official website. Vehicle owners with pending taxes are advised to visit their respective RTOs to pay the outstanding dues in lump sum and take advantage of the one-time exemption scheme, which is available only until

Puri police summons Sanskrit University VC

Puri, August 3: Singhadwar police has issued a notice to Srinivas Barkhedi, Vice-Chancellor of a Central Sanskrit University, to explain his presence on the chariot during the Rath Yatra here this year.

The Shree Jagannath Temple Administration (SJTA) has issued a directive prohibiting unauthorised persons on the chariots of the lords except for the servitors and temple officials on duty.

The CCTV footage and drone camera pictures submitted by the temple administrator, Ajay Kumar Jena, along with his complaint, showed that the Vice-Chancellor, along with one of his associates, was on the chariot dressed like temple servitors.

The police identified the VC and registered a case under various sections of the Temple Act against him.

Sources said the presence of many unauthorised persons on the chariots has been noticed, and the police are busy identifying

Earlier, the three people who were on the chariots during the Car Festival were summoned to appear before the police to explain their position. The temple administration has also issued a show cause notice to a senior Daitapati for facilitating the entry of non-servitors to the chariots in the garb of servitors.

Complaints have been filed in this regard in the Singhadwar and Kumbharpada police stations by the temple adminis-

'Courts have bolstered India's Santali Wikipedia reputation for arbitration'

New Delhi, August 3: The courts in the country have bolstered India's reputation as a favourable destination for arbitration by upholding the sanctity of arbitral awards, Supreme Court judge Justice Hima Kohli has said.

She was speaking at a seminar -- 'Recent Developments in Arbitration to Promote Business' -- organised by law firms Gibson Dunn Secretariat and UNUM Law, along with the International Arbitration and Mediation Centre (IAMC) and General Counsels Association of India Friday.

Justice Kohli said the growth of international trade made dispute resolution more complex and to address the challenges. Alternative Dispute Resolution (ADR), especially arbitration, had emerged as a powerful tool

for businesses. "In recent years, India has made significant strides in establishing itself as a reliable partner in arbitration and mediation services. India's transformation into a commercial arbitration hub has been driven by the judiciary's unstinting commitment to fast-tracking matters under the Arbitration and Conciliation Act, 1996 and fostering a broadly pro-enforcement regime," said Justice Kohli.

The apex court judge said various landmark judgments showed that India is committed to upholding the sanctity of arbitral awards. "By limiting judicial intervention and respecting arbitral awards, the effort of the Indian courts has bolstered India's reputation as a favourable destination for (alternative) dispute resolution. This judicial philosophy complements legislative reforms and signifies India's ambition to become a global hub for arbitration," she said.

Justice Kohli underlined the need to foster a specialised arbitration bar, comprising experts and legal practitioners solely engaged in arbitration, because of the upsurge of institutional arbitration in the country

She said seminars and training sessions would streamline every facet of the arbitration process, from the drafting stage to enforcement of the award, besides boosting confidence in the country as an arbitration hub. "This would also ensure that arbitration gains traction and does not take a back seat compared to litigation in court. said the top court judge.

Justice Kohli underscored that

Arbitration and Conciliation Act aligned the laws with the best international practices and promoted a pro-arbitration regime that inspired confidence in the resolution of commercial disputes.

"In 2021, the Act underwent further amendments. The 2021 amendment to the arbitration process is aimed at addressing new challenges and improving its effectiveness. These changes are directed towards promoting institutional arbitration, recognising the importance of specialised arbitration institutions, ensuring confidentiality during the proceedings and impartiality in the appointment of arbitrators," she said.

Regarding the entry of foreign law firms in India in specific areas and on a reciprocal basis, which was permitted by the Bar Council of India in March 2023, Justice Kohli said it would provide the young talent with opportunities to compete with peers in the Western countries, besides enabling Indian law firms to adopt global best practices.

"Additionally, these regulations will help address concerns about the influx of Foreign Direct Investment (FDI) and establish India as a hub for international commercial arbi-

Govt engineer held over DA


he National Aeronautics and Space Administration

(NASA) regularly capture stunning images of our universe, leaving space lovers mesmerised. The social media handles of the US Space Agency are a treasure trove for those who love to watch educational videos and fascinating images showcasing Earth and space. Now, in its recent post on YouTube, the agency unveiled a groundbreaking visualisation tool that offers an unprecedented look at how carbon dioxide (CO2) moves around our planet. It provides a stunning, animated map of global CO2 concentrations, revealing the complex patterns of this crucial greenhouse gas.

'This global map of carbon dioxide was created using a model called GEOS, short for the Goddard Earth Observing System, GEOS is a high-resolution weather reanalysis model, powered by supercomputers, that is used to represent what was happening in the atmosphere including storm systems, cloud formations, and other natural events," NASA explained in the caption of the video.

This model pulls in billions of data points from ground observations and satellite instruments - and has a resolution more than 100 times greater than your typical weather model,' the agency added.

The video shows orange plumes erupting from the surface of the Erath and swirling around the planet. Over India, you can also see the greenhouse gas blow-

ing from neighbouring continents and also originating from the subcontinent. According to NASA, the pulsating oranges indicate CO2 concentrations of 420-460ppm over India.

The space agency explained that these orange plumes come from various sources including power plants, wildfires and cities.

"Over China, the United States, and South Asia, the majority of emissions came from power plants, industrial facilities, and cars and trucks," said climate scientist Lesley Ott at NASA's Goddard Space Flight Center.

"In Africa and South America, emissions largely stemmed from fires, especially those related to land management, controlled agricultural burns and deforestation, along with the burning of oil and coal. Fires release carbon dioxide as they burn,' Lesley Ott added.

Further, the map exhibits a pulsating appearance. This is because, firstly, fires typically intensify during daylight hours and subside at night, creating

a diurnal pattern, NASA said. Secondly, the absorption and release of CO2 by plants during photosynthesis and respiration contribute to the fluctuations. This pulsing effect is particularly noticeable in regions with abundant vegetation, such as mid- to high-latitude forests and tropical areas, the agency explained.

Carbon dioxide is a heat-trapping greenhouse gas and the primary reason for Earth's rising temperatures. As CO2 builds in the atmosphere, it warms our planet. However, all this carbon dioxide isn't harmful to air quality. In fact, we need some carbon dioxide to keep the planet warm enough for life to exist. But when too much CO2 is pumped into the atmosphere, the Earthwarms too much and too fast.


Listen to Criticism

The dictionary defines the word 'propaganda' as being 'information, especially of a biased or misleading nature, used to promote a political cause or point of view.' In Old India, propaganda was managed by controlling Doordarshan. Or at least that is what political parties assumed. The news segments in the evenings reported on the government and its agenda. The Opposition was given no space. This was accepted as being natural. During elections, however, the Opposition would demand to be given as much screen time as the ruling party, especially in delivering their manifestos. Party leaders would read them out in front of the camera, and smaller parties would then ask to be given as much time as the larger ones.

With the coming of private news channels a quarter century ago, this changed and instead of Doordarshan, or perhaps along with it at least in the initial years, senior party leaders would come to panels in studios. It seemed that this was the dawn of independence and some of the senior journalists around today are the product of that time, particularly those who were in the old Star News segment which became

The phenomenon of Godi media beginning in the months before

2014 took us back considerably to propaganda. This time it was worse than in Old India and more damaging. On Doordarshan, the Opposition was merely ignored; it was not daily vilified and attacked and called anti-national. On Doordarshan, even when it was in the hands of hypocrites, minorities were not the constant target and distraction was not the only game. In New India this became the daily fare of the channels and remained so for a decade.

WhatsApp further amplifies the independent voice's reach. The sharing of advertising revenue by social media networks like YouTube affords these individuals the opportunity to be able to do their work outside of a corporate space. In addition to the journalists, a set of humourists has risen to com-

ment on our times. They are the product of the stranglehold of Godi media and the suffocation people have felt of having propaganda inflicted on them. A few names are worthy of mention, like Bhagat Ram, Ms Medusa, Meghnad, Garima, Ranting Gola, Shyam Rangeela and Urvish Kothari, all of whom I follow and greatly admire and whose work I enjoy. Unfortunately for the government there are few quality creators on the other side. This is because propaganda and sycophancy are not good ingredients for humour. Godi creators tend to produce content that is sullen and angry and for this reason generally ignored.

It will take an academic paper or a book to examine the effect of the independent voices on our democracy. There is to my mind little doubt that they have managed to loosen the monopoly of the Modi government on narrative.

It is for this reason that the government has moved to throttle the voices of the creators and independent journalists. This is being done through the broadcast bill a draft of which is being circulated. Essentially it seeks to regulate everyone who is on social media because that is the only way in which the government can interfere, block and ban content it doesn't want seen. The government is also trying to go after independent websites like The Wire, Scroll, Newslaundry and Newsminute.

Because these creators are independent individuals on social media, they cannot be licensed or regulated in the way that news channels can. This is why the government is attempting to do this with the broadest of definitions that will affect every single person using social media. The intent might be to use the law in targeted fashion but that will not be how it will turn out. Bad laws produce bad outcomes.

Will the Modi government be successful in pushing the regulation through? It will not. This is not the same place we were last year. There are too many obstacles for it and too many points of resistance. Even if it had been passed in the previous Parliament through brute force it would have been a total mess in implementation. The Prime Minister and his Cabinet will be compelled to do what governments in other democracies must: listen to criticism from citizens and tolerate it and even learn from it. In doing so, perhaps they can also get a laugh out of the material, as many of us so often do.

INEQUALITY KILLS DEMOCRACY

FUTURE GENERATIONS WILL LIKELY BE SHOCKED THAT WE HAVE TOLERATED SUCH EXTREME LEVELS OF INEQUALITY, **JUST AS WE ARE HORRIFIED BY OUR ANCESTORS' ACCEPTANCE OF SLAVERY**

hile there are many ways to inequality, key metrics consistently show that disparities are getting worse. According to a recent United Nations report, 71 per cent of the world's population now lives in countries where inequality has increased.

Unsurprisingly, this includes India and China. A recent paper by Thomas Piketty and his co-authors shows that the income share of the top 1 per cent in India has risen to its highest level since 1922, the earliest data that they have when the country was still under British colonial rule.

At the same time, global inequality remains extremely high. While billionaire wealth has reached unprecedented levels, the World Bank estimates that 712 million people worldwide survive on less than

\$2.15 per day. Future generations will likely be shocked that we have tolerated such extreme levels of inequality, just as we are horrified by our ancestors' acceptance of slavery. But as David Hume argued in the eighteenth century, moral imperatives ("ought") cannot be derived from objective facts ("is"). In other words, problems like inequality cannot be resolved through science or reason alone. Instead, we must highlight their moral implications to persuade people to act.

Two key aspects of global inequality deserve particular attention. First, economic disparities are set to worsen both within and across countries. As technological advances like artificial intelligence reduce demand for human labour, working-class households around the world could become increasingly impoverished. Meanwhile, those who own the machines and run the largest corporations are expected to amass unprece-

dented power and wealth. The United States – home to nearly 38 million people living below the poverty line despite being one of the world's richest countries – provides a glimpse into this bleak future.

Second, extreme inequality poses a mortal threat to democracy, enabling billionaires and moneyed interests to influence elections, capture traditional and social media, and shape public perceptions. Regrettably, judging by social-media chatter and trolling, some of the strongest opposition to progressive taxation and redistributive policies comes from the poorer segments of society, largely owing to misinforma tion and manipulation.

The toxic combination of extreme inequality and AIpowered misinformation is also a factor fueling pressure on liberal democracies and the rise of authoritarian forces around the world. By enabling a few wealthy individuals to wield disproportionate influence, today's global economy increasingly marginalises and

disenfranchises much of the world's population.

To be sure, misguided attempts to reduce inequality also carry significant risks. For example, trying to achieve perfect egalitarianism would be unwise, because some disparity is necessary to create incentives. Similarly, concentrating all wealth in the hands of the state, as the Soviet Union did, would lead to mismanagement of demand and supply and, ultimately,

Instead, what we really need is a progressive tax system that redistributes incomes from the rich to the poor while preserving incentives. Fortunately, there is significant scope for such measures. In my recent book Reason to Be Happy, I propose a tax regime that I call the "accordion tax," which aims to narrow the income gap by taxing high earners and transferring the revenue to those with lower

While this model essentially functions as a progressive tax

system, its strength lies in its micro structure. Beyond a certain point, the super-rich no longer seek to earn more to buy things. Simply put, after the fifth yacht, the sixth is merely a status symbol aimed at outdoing other wealthy in-

By taxing all incomes above a certain threshold and transferring this money to those earning below it, governments could reduce inequality without harming incentives. The richest person will remain the richest, and the second-richest person will work just as hard to reach the top. But the incentives of the middle and working classes, whose members work primarily to make ends meet rather than try to surpass their neighbours, will remain intact.

Although the accordion tax could act as a powerful tool for reducing inequality at the national level, today's globalised economy poses significant implementation chal lenges. If a government taxes high incomes too aggressively it risks triggering capital flight.

Thus, reducing global inequality requires multilateral agreements. While the US is well-positioned to lead this effort, its ability to do so depends on the outcome of November's presidential election. Vice President Kamala Harris, the presumptive Democratic nominee, offers hope for greater distributive fairness. By contrast, a victory for former President Donald Trump will likely cause inequality to worsen. We can only hope that American voters make the right choice.

Mediation for inheritance disputes

MORE THAN 78 PER CENT OF THE OVER ONE CRORE CIVIL CASES PENDING IN INDIAN COURTS ARE ABOUT INHERITANCE AND SUCCESSION DISPUTES

Succession Act of 1956 defines who gets what when someone succeeds or inherits an elderly person's property. Female children did not inherit an equal share of their parents' or ancestors' property until recently. Children born from void or voidable marriages were not given a share of their biological parents' property until the Supreme Court (SC) ruled that they can inherit their parents' joint Hindu family property under the Mitakshara Law.

Following the cases of Arunachala Gounder v. Ponnusamy, 2022, and Vineeta Sharma v. Rakesh Sharma, 2020, daughters now have an equal share of their parents' property. In Revanasiddappa vs. Mallikarjun (2011), a case involved Section 16(3) of the 1955 Hindu Marriage Act, amended to establish inheritance rights for such children. The Supreme Court ruled in June 2022 that live-in partners' children are legitimate in Kattukandi Edathil Krishnan & Another vs. Valsan & Others.

lets the claimant approach banks and investors to reclaim their moveable property or shares. Explaining legally the various classes of legal heirs is difficult. Legal heirs use a certificate if the property owner dies without a will. A will simplifies family disputes. Second, the property succession occurs when the original owner or ancestor dies without a will. According to national judicial data grid statistics, more than 78 per cent of the 1,09,93,516 civil cases pending in Indian courts are about inheritance, succession, ancestral property shares, refusing to share property with female siblings, legitimacy of children from void and voidable marriages, and property percentages. Instead of fighting cold wars

within the family, or coming on to the streets or knocking the doors of a court of law, now there is an option. The disputing family members sit down and resolve their disputes without outside interference. Or they can use a neutral mediator to resolve their dispute withdisputes. To quote a Supreme Court

case, the bench of Justice Rajesh Bindal and Justice PB Varale observed: "The case in hand was one of the most appropriate cases in which the Court should have attempted to resolve the dispute through alternate means, namely mediation and conciliation. In Afcons Infrastructure Limited Cherian Varkey Construction Company Private Limited and Others, this Court held that disputes involving partition or division among

family members, coparceners, or co-owners should typically be resolved through the Alternative Disputes Redressal (ADR) process. The courts must investigate these methods for amicable resolution of family disputes. lant, Mahendra Nath Soral. filed a suit for partition over the



Shimla, August 3: Heavy rains lashed large parts of the country Saturday, especially in Gangetic West Bengal and Jharkhand where showers due to a deep depression affected normal life, while two children were killed in Madhya Pradesh after a house collapsed on them following incessant rains.

In Himachal Pradesh, flash floods and landslides due to cloudbursts and heavy rains have led to the closure of 114 roads, while the weather department warned that heavy showers would continue until

The state's road transport corporation has suspended its bus services on 82 routes.

The hunt for 45 people, who went missing after a series of cloudbursts in Kullu's Nirmand, Sainj and Malana; Mandi's Padhar and Shimla's Rampur subdivision on the night of July 31 resumed Saturday morning. As many as 410 rescuers from teams of the Army, NDRF, SDRF, ITBP, CISF, Himachal Pradesh Police and home guards are involved in the hunt with the help of drones.

The death toll in the calamity rose to nine Saturday with the recovery of one more body from Kullu district.

Moderate to heavy showers continued to lash parts of the state, with Jogindernagar re-

ceiving the highest rainfall of 85

mm since Friday evening.
In the south, Tamil Nadu's Namakkal district remained flooded as the Cauvery River flowed above the danger mark, inundating low-lying areas. Chief Minister M K Stalin said that 11 relief camps have been set up in the district and about 1,086 people have been shifted there.

In Madhya Pradesh, a threeyear-old girl and a 17-year-old boy died in their sleep and five others were injured after their house collapsed following incessant rains in a village in Narsinghpur district.

The India Meteorological Department (IMD) has warned of extremely heavy rainfall in Maharashtra's Palghar, Pune and Satara districts Sunday and issued an orange alert, forecasting heavy rains, for Thane, Mumbai, Raigad, Sindhudurg and Nashik. Several areas were inundated, roads got washed away, trees uprooted, houses

damaged and a bridge collapsed due to incessant rains in Jharkhand for the past two days, forcing the state government to order the closure of all schools

However, no death was reported from any part of the state, a disaster management official said, adding that NDRF teams were deployed in Ranchi Friday to rescue people from low-lying areas. In adjoining West Bengal, incessant rain lashed Kolkata and its neighbouring districts as a low-pressure area turned into a deep depression. Waterlogging was reported from several parts of the state's capital, including the airport but flight services were not affected.

The southern districts of Howrah, Paschim Bardhaman, Birbhum, Purba Bardhaman, Hooghly, Nadia, and North and South 24 Parganas districts will continue to experience showers over the next 12 hours, he

Flight operations at the Kazi Nazrul Islam airport in Paschim Bardhaman district continued to be suspended for the second consecutive day Saturday as the airport is yet to be ready for operations. The operations at the airport were shut down Friday due to water logging in and around its premises.

An irrigation department official said 36,000 cusec water was discharged from Panchet dam and 70,000 cusecs from Durgapur barrage after heavy rains. Accusing the Damodar Valley Corporation (DVC) of discharging water to "engineer a man-made flood", TMC leader Kunal Ghosh, in a post in Bengali, on X said, "When water level rises in Jharkhand, DVC aggravates the situation in Bengal by releasing water. But never releases water in summer when the state needs the most for irrigation and farming activities.'

Voicing apprehension that the water level might rise during high tides next Monday, Ghosh said Chief Minister Mamata Banerjee is keeping a close tab on the situation.

Heavy rains also lashed Rajasthan with Kolai Magra in Bikaner district receiving the maximum rainfall of 195 mm. In a 24-hour period till 8.30 am, Masuda in Ajmer recorded 180 mm of rain followed by 170 mm each in Beawar's Nayanagar and Ajmer's Pisangan, 150 mm

Akhilesh's DNA test demand sparks row

Lucknow, August 3: Samajwadi Party chief Akhilesh Yadav Saturday sparked a controversy with his remarks demanding a DNA test of the accused in the Ayodhya gangrape case in which the 12-year-old victim became pregnant.

While BSP chief Mayawati asked how many accused were subjected to DNA tests under the SP rule in such cases, the BJP too stepped up its attack, alleging Yadav has given a "clean chit" to accused Moid Khan who is linked to the Samajwadi Party.

In a statement issued from the SP headquarters on Saturday, Yadav said, "Without a DNA test in the Bhadarsa case of Ayodhya, BJP's allegation will be considered biased.'

The BJP hit back, alleging the SP is defending a "paedophile" and showing its "boys will be boys mindset" while leaders of the INDIA bloc are "silent".

"Because the girl belongs to the Nishad community and the brute belongs to the vote bank, evidence is being sought from her even though she is preg-

"What do they want to prove with the DNA test? Who all were involved in the gangrape, will this be decided on the basis of the DNA test? Is the rapist who made the girl pregnant the only



one guilty of rape?" BJP's IT department head Amit Malviya said on X.

UP minister and Nishad Party president Sanjay Nishad, who broke down in tears after meeting the victim and her family in Ayodhya, hit out at SP leaders, accusing them of shielding the accused, and said he would protest at the SP office against the atrocity.

In his statement, Yadav alleged that the BJP was rattled after its defeat in Lok Sabha elections including in Ayodhya.

"Justice should be done by getting the DNA test done of all accused instead of doing politics by just making allegations,' he said, adding "levelling allegations to defame the Samajwadi Party without investigating the incident is motivated by political malice.

The SP chief also demanded that the government should immediately provide assistance of ₹20 lakh to the victim's fam-

However, BSP chief Mayawati questioned Yadav's remarks on the DNA test of the accused.

Five policemen, teacher sacked for narco-terror links

Srinagar, August 3: The Jammu and Kashmir administration on Saturday sacked six government employees, including five policemen, for their "deep involvement in anti-national activities", officials said.

J&K Lieutenant Governor Manoj Sinha invoked article 311(2)(c) of the Constitution to terminate them from service. they said. Under proviso 'c' of the Article, the president or the governor, is empowered to terminate an employee without recourse to the normal procedure if satisfied that the person's retention in public service is prejudicial to the security of the State.

The government today dismissed six employees -- five from the police department (constables) and one from the education department (teacher) -- for their deep involvement in anti-national activities," an official said. Their activities had come to the notice of law enforcement and intelligence agencies, and they found them "thickly involved" in activities prejudicial to the interests of the State, evidencing their involvement in terror-related activities, they said.

The officials identified the sacked employees as Head Constable Farooq Ahmad Sheikh, Selection Grade Constables Saif Din, Khalid Hussian Shah and Irshad Ahmad Chalkoo. Constable Rahmat Shah and teacher Nazam Din.

WAYANAD LANDSLIDES Four kids rescued from cave

Wayanad, August 3: In a remarkable display of courage and compassion, officials from the Kerala forest department successfully rescued four toddlers and their parents, who belong to a tribal community, after they were stranded in a cave atop a hill following the devastating Wayanad landslides.

The four-member rescue team, led by Kalpetta range forest officer K Hashis, braved incessant rain and treacherous terrain to save the Paniva community family, which included children aged between one and four. The daring rescue mission involved an arduous eight-hour trek.

Reports indicate that the family had been trapped in a cave atop a hill, which overlooked a deep gorge and was surrounded by dense forest, for five days.

The forest officials discovered the igate the hazardous climb. The mother wandering in search of children, exhausted and hunfood for her starving children and their father. She subsequently guided them to the cave where the entire family had taken shelter, having gone without food for the last five days.

The path to rescuing the family was fraught with challenges, including a steep slope and heavy rainfall. The rescuers had to tie ropes to trees and rocks to navgry, were provided with food and clothing upon their return to the Attamala anti-poaching camp.

Images and videos of the heroic rescue operation have gone viral on social media, garnering widespread praise for the forest officials' bravery and dedication in risking their own lives to save the tribal family.

Death toll rises to 218

Wayanad (Kerala): The death toll in the Wayanad landslides increased to 218, the district administration said Saturday. The 218 dead include 90 women and 30 children, the administration said. Of the 218 bodies recovered from the landslides-hit areas, 152 have been identified by relatives, it said. It further said that 143 body parts have also been recovered till date. The administration also said that autopsies of 217 bodies and 143 body parts have been performed over to next of kin. Besides these, 518 people were admitted to hospitals and of them 89 are undergoing treatment, the statement said, Meanwhile, Kerala Chief Minister Pinarayi Vijayan said that the search and rescue operations which began July 30

have reached the final stages.

Ex-cop Waze reiterates bribery allegations against Anil Deshmukh

Nagpur, August 3: Maharashtra politics hotted up Saturday with sacked police officer Sachin Waze reiterating allegations of bribery against former home minister and NCP (SP) leader Anil Deshmukh, prompting the Opposition to question the "timing" and Deputy CM Devendra Fadnavis assuring an inquiry.

Deshmukh and Fadnavis are locked in a war of words since the former accused the BJP politician of trying to exert pressure as the then Opposition leader when he (Deshmukh) was home minister in the erstwhile MVA government, to frame key politicians including the then chief minister Uddhav Thackeray.

Reacting to Waze's claims, Fadnavis, who heads the Home department, assured to conduct a proper inquiry into Waze's latest allegations. Fadnavis had denied allegations against him. Deshmukh resigned as Home Minister in 2021 after former Mumbai police commissioner Param Bir Singh accused him of setting a target to collect ₹100 crore a month from bars and restaurants in the city.

Waze, accused of planting gelatin sticks outside Mukesh Ambani's residence 'Antilia' and also booked for the related murder of businessman Mansukh Hiran, had earlier told an inquiry commission that he had paid money to Deshmukh's associates on the latter's instructions

Legendary Indian classical dancer Yamini Krishnamurti passes away at 84

New Delhi: Bharatanatyam and Kuchipudi veteran Yamini Krishnamurti died at the Apollo hospital here Saturday. She was 84. "She was suffering from agerelated issues and was in the ICU for the last seven months." Krishnamurti's manager and secretary Ganesh told PTI. Krishnamurti's mortal remains will be brought to her institute -- Yamini School of Dance at Hauz Khas -- at 9 am Sunday. The details of her last rites are yet to be finalised. Krishnamurti is survived by two sisters. Born December 20, 1940 in Madanapalli in Andhra Pradesh's Chittoor district to Sanskrit scholar M Krishnamurti, she took to dance at the tender age of five at the Kalakshetra School of Dance in Chennai under the tutelage of legendary Bharatanatyam dancer Rukmini Devi Arundale. Also proficient in the form of Kuchipudi, Krishnamurti expanded her horizon by learning Odissi from the likes of Pankaj Charan Das and Kelucharan Mohapatra.

4 school kids buried alive as wall collapses in MP's Rewa

Bhopal: Four students of a private school were buried alive after the wall of a house collapsed in Madhya Pradesh's Rewa Saturday. The incident occurred in the Garh police station area, around 45 km from the Rewa district headquarters. The deceased have been identified as Anshika Gupta (5), Manya Gupta (7), Siddhart Gupta (5), and Anui Prajapati (6), The abandoned house was located hardly 20 meters away from Sunrise Public School, where the children were enrolled. After school was over, some students were heading towards their homes. As they were crossing the old and abandoned house, its back wall collapsed. At least, eight students aged between five to seven years and a woman teacher were buried.



Lam, 67, had temporarily taken on the party chief's duties July 18, a day before Trong's death, as his health deteriorated. Party delegates unanimously supported Lam's nomination, officials told a press conference.

Building collapse in Russia claims 10

Moscow: The death count from the partial collapse of a residential building in the Russian city of Nizhny Tagil has risen to 10, said the Ministry of Emergency Situations. The Ministry said on Friday that rescuers have found 10 bodies and 15 people have been rescued from under the rubble. Xinhua news agency reported. Five people are reportedly in critical condition at a hospital. Death toll in residential building collapse in Russia rises to 10.

British police boost presence in Sunderland

Sunderland, August 3: British police are putting more officers on the streets amid warnings of more violent disorder this weekend and mosques have tightened security after anti-immigration protesters torched cars following the murder of three young girls.

Riots involving hundreds of people, or thousands in one protest in London, have erupted this week, after false information spread rapidly online that the suspect in the killings in the northwest town of Southport was a radical Muslim migrant.

Police have said the suspect. Axel Rudakubana, is a 17-yearold who was born in Cardiff,

Hezbollah to strike deeper with 9/11 suspects

Iran says it is no longer confined to military targets

Tehran, August 3: Iran said Saturday it expects Lebanon's Tehran-backed Hezbollah group to hit deeper inside Israel and no longer be confined to military targets after Israel killed the Hezbollah military commander.

Hezbollah has been exchanging near-daily fire with Israeli forces, saving it is targeting military positions over the border. since its Palestinian ally Hamas attacked Israel October 7, sparking war in Gaza.

But a strike claimed by Israel in an overcrowded residential area of South Beirut changed the calculus, Iran's mission to the United Nations said.

"We expect Hezbollah to choose more targets and (strike) deeper in its response," said the mission quoted by the official IRNA news agency.

"Secondly, that it will not limit its response to military targets.'

The strike Tuesday killed Hezbollah commander Fuad Shukr. According to Lebanon's health ministry, five civilians, three women and two children, also died Israel said Shukr was responsible for rocket fire that killed 12 youths in the annexed Golan Heights, and had directed Hezbollah's attacks on Israel since the Gaza war began.

An Israeli airstrike on a school sheltering displaced persons in **Gaza City killed at** least 15 Palestinians Saturday, hours after two strikes in the occupied West Bank killed nine militants including a local Hamas commander, Hamas said

"Hezbollah and the (Israeli) regime had observed certain lines", including limiting strikes to border areas and military targets, Iran's mission said.

The Beirut strike crossed that line, it added.

Hours after Shukr's killing, the political leader of Hamas, Ismail Haniyeh, was killed in a pre-dawn "hit" on his accommodation in Tehran, Iran's Revolutionary Guards said.

Israel has declined to comment.



US to send more warships to Middle East Washington: The US military will deploy additional fighter jets

and Navy warships to the Middle East, the Pentagon said Friday, as Washington seeks to bolster defenses following threats from Iran and its allies Hamas and Hezbollah. US Defense Secretary Lloyd Austin had approved sending additional Navy cruisers and destroyers, which can shoot down ballistic missiles, to the Middle East and Europe. It is also sending an additional squadron of fighter jets to the Middle East. "Austin has ordered adjustments to US mili-

tary posture designed to improve US force protection, to increase support for the defense of Israel, and to ensure the United States is prepared to respond to various contingencies," the Pentagon said in a statement. It also added it would increase readiness to deploy more land-based ballistic missile defenses.

Washington, August 3: Defense Secretary Lloyd Austin Friday overrode a plea agreement reached earlier this week for the accused mastermind of the September 11, 2001, attacks and two other defendants, reinstating them as deathpenalty cases.

The move comes two days after the military commission at Guantanamo Bay, Cuba, announced that the official appointed to oversee the war court, retired Brigadier General Susan Escallier, had approved plea deals with Khalid Sheikh Mohammed and two accused accomplices, Walid bin Attash and Mustafa al-Hawsawi, in the attacks. Letters sent to families of

the nearly 3,000 people killed in the al-Qaida attacks said the plea agreement stipulated the three would serve life sentences at most.

Austin wrote in an order released Friday night that "in light of the significance of the decision," he had decided that the authority to make a decision on accepting the plea agreements was his. He nullified

Freed prisoner condemns his 'illegal expulsion'

Bonn, August 3: Ilya Yashin, a Russian opposition activist freed from jail in Thursday's prisoner swap, pledged to carry on his political fight against President Vladimir Putin from abroad, but expressed fury at having been deported against his will.

The prisoner swap, the largest since the Cold War, saw eight Russians, including a convicted murderer, exchanged for 16 prisoners in Russian and Belarusian jails, many of them dissidents. It was hailed as a win by Western leaders who feared for the dissidents' lives after the death in jail last year of politician Alexei Navalny.

But Yashin, impris-

oned in 2022 for criticising Putin's full-scale invasion of Ukraine, said he had not given his consent to deportation and that others in more urgent need of medical care should have gone instead of him.

"From my first day behind bars I said I was not willing to be a part of any exchanges," he said in an emotional news conference in Bonn Friday during which he occasionally removed his glasses to blink back tears.

He directed his ire not at the Western governments that had secured his release, who he said had faced a difficult moral dilemma, but at the Kremlin for expelling a political rival against his will.

"What happened

August 1 I don't view as a prisoner swap but as my illegal expulsion from Russia against my will. and I say sincerely, more than anything I want now to go back home,' he added.

He was speaking alongside activists Vladimir Kara-Murza and Andrei Pivovarov at the freed prisoners' first public appearance since arriving in Germany.

On their second day out of prison, where they had had limited contact with the outside world, Kara-Murza and Yashin especially seemed fired with resolve, and to have kept abreast of world events. All expressed scorn for the government of Putin whom Kara-Murza described as an illegitimate usurper.

SBI profit rises 4% to ₹19,325cr

Mumbai: State Bank of India (SBI) Saturday reported a 4.25 per cent growth in its consolidated net profit in April-June quarter at ₹19,325 crore, held back by a rise in loan loss provisions and lower growth in core income. On a standalone basis, the profit growth was much slower at almost flat pace of 0.89 per cent during the quarter at ₹17,035 crore. SBI chairman Dinesh Kumar Khara, whose over four years stint at the helm will be ending soon, said the first quarter is generally slow and there were "distractions" which limited the growth. He said the bank is confident of growth picking up in the remainder of the fiscal year, and achieving his aspiration of the largest lender reporting a net profit of ₹1 lakh crore in FY25.

Bank of India net profit grows 10%

Mumbai: State-owned Bank of India Saturday reported a 10 per cent growth in its June quarter net profit at ₹1,703 crore, limited by a rise in money set aside for tackling bad loans. The bank had reported a net profit of ₹1,551 crore in the year-ago period. Its core net interest income grew 6 per cent to ₹6,275 crore in the reporting quarter on the back of a nearly 16 per cent jump in advances and the net interest margin widening by 0.04 per cent to 3.07 per cent. The non interest income declined to ₹1,302 crore from ₹1,462 crore during the quarter. Deposit growth came at 9.74 per cent during the reporting quarter.

JK Tyre net profit **rises 37%**

New Delhi: JK Tyre & Industries Saturday reported a 37 per cent year-on-year increase in consolidated net profit at ₹211 crore in the first quarter ended June 30, 2024. The tyre maker has reported a net profit of ₹154 crore for the April-June quarter of last fiscal. Total income declined to ₹3,655 crore for the period under review from ₹3,726 crore in the June quarter of FY24, JK Tyre said in a regulatory filing. "We continue to deliver profitable growth with a year-on-year increase in operating margins," JK Tyre Chairman and Managing Director Raghupati Singhania said. The company's strategic thrust on premiumisation and pricing has helped it manage the raw material cost pressures, he

Telcos to compensate users for service outages

PRESS TRUST OF INDIA

New Delhi, August 3: Telecom operators will have to compensate subscribers in case of service outages for more than 24 hours at a district level under the new quality of service rules issued by the sector regulator Trai.

The Telecom Regulatory Authority of India (Trai) has also increased the penal amount to ₹1 lakh from ₹50,000 for failing to meet each quality benchmark under the new rules.

The regulator has introduced a graded penalty system of ₹1 lakh, ₹2 lakh, ₹5 lakh and ₹10 lakh for different scales of rule violations under revised regulations -- "The Standards of Quality of Service of Access (Wirelines and Wireless) and Broadband (Wireline and Wireless) Service Regulations,

The new norms supersede three different regulations --Quality of Service (QoS) for basic and cellular mobile services, broadband services, and broadband wireless services.

In case of a network outage in a district, telecom operators will need to provide a rebate on rent for postpaid customers and extend the validity of connection for pre-paid customers as per the new rules.

"If any such significant network outage continues for more



provider shall provide a proportional rent rebate, as per subscribed tariff offering, for the actual number of days of service outage to postpaid subscribers registered in the affected district(s) in next billing cycle,"

Trai said. The regulator will count network outage duration of more than 12 hours in a calendar day as one full day for the calculation of rent rebate or extension of validity.

"Rent rebate to postpaid customer or validity extension to prepaid customer, due delay in rectification of faults or due to significant network outage of more than 24 hours, as applicable, shall be made within one week of rectification of signif-

icant network outage," the new norms said.

However, outages due to natural calamity will not be considered for the extension of va-

Even fixed-line service providers will have to compensate postpaid and prepaid customers if the fault in their network or service is fixed after three days.

The new rule mandates broadband service providers to activate 98 per cent of connections within 7 days of customers making payment. Mobile service providers will need to provide service-wise (2G, 3G, 4G, 5G) geospatial coverage maps on their website that will help users.

Trai's new rules will come into force after six months.

'Sebi's primary intent to curb expiry day frenzy'

Mumbai, August 3: Sebi Whole Time Member Ananth Narayan G has said that the "primary intent" of the capital markets regulator in trying to restrict derivative trades is to curb "expiry day frenzy" in options trading.

Replying to the critique of the seven-point proposals released earlier this week, where people warn about throwing the baby with the bath water, Narayan wondered if there is any baby in it at all, and made it clear that it is not Sebi's intent to ban de-

Speaking at the annual Capam event organised by FICCI, he also flagged the issues of a consistent mismatch between demand and supply of securities for many years and urged the industry to step up on this front.

"Primary regulatory intent now is to specifically curb only this expiry day frenzy in options trading, and to reduce the systemic risks around this," he said, speaking of the consultation paper put out by Sebi to restrict F&O activity earlier this week.

Narayan said five of the seven proposals in the July 30 consultation paper are focused on this objective, including restricting the number of weekly option expiries, increasing margins around expiry day, removing the benefit of calendar spreads on expiry day, requiring the moni-

Nasdaq confirms correction as recession fears mount

New York, August 3: US stocks sold off for a second straight session Friday, and the Nasdaq Composite confirmed it was in correction territory after a soft jobs report stoked fears of an oncoming recession. The Labor Department said nonfarm payrolls increased by 114,000 jobs last month, well short of the 175,000 average forecast by economists polled by Reuters, and the at least 200,000 that economists believe are needed to keep up with population growth. The unemployment rate jumped up to 4.3%, near a three-year high.

The data added to concerns the economy was slowing more rapidly than anticipated and the Federal Reserve had erred by keeping rates steady at its policy meeting that concluded Wednesday. Expectations for a rate cut of 50 basis points (bps) at the Fed's September meeting jumped to 69.5% from 22% in the prior session, according to CME's FedWatch Tool.

'Obviously the jobs number is the big headline, but we seem to have officially entered at least a rational world where bad economic news is read as bad rather than bad economic news is read as good," said Lamar Villere, portfolio manager at Villere & Co. in New Orleans.

"The Fed is going to cut and we're all sort of adjusted to that, that is sort of established. Now it's more like hey, did they wait too long? Do we have a recession on our hands?' The weak jobs data also trig-

gered what is known as the 'Sahm Rule," seen by many as a historically accurate recession

The Dow Jones Industrial Average fell 610.71 points, or 1.51%, to 39,737.26, the S&P 500 lost 100.12 points, or 1.84%, to 5,346.56 and the Nasdaq



Composite lost 417.98 points, or 2.43%, to 16,776.16.

Adding downward pressure was drop in Amazon, down 8.79%, and Intel which plunged 26.06% after their quarterly results and disappointing fore-

The declines pushed the Nasdaq Composite down more than 10% from its July closing high to confirm the index is in a correction after concerns grew about expensive valuations in a weakening economy.

The S&P 500 closed at its lowest level since June 4. Both the benchmark S&P index and the blue-chip Dow suffered their biggest two-day slides since

The small cap Russell 2000 index slumped 3.52% to close at a three-week low and saw its biggest two-day drop since June

Chip stocks also continued their recent downdraft, and the Philadelphia SE Semiconductor Index closed at a three-month low after its biggest two-day slide since March 2020.

Among the few bright spots, Apple rose 0.69% after posting better-than-expected third-quarter iPhone sales and forecasting more gains, betting on AI to attract buyers.

Of the 11 major S&P 500 sectors. defensive names such as consumer staples, utilities and real estate were the only advancers, with the consumer discretionary sector leading declines as Amazon weighed heavily, for its biggest two-day

drop since June 2022. The CBOE Volatility index, also known as Wall Street's "fear gauge," breached its long-term average level of 20 points to touch 29.66 its highest mark since last March 2023, before

closing at 23.39. Some market participants viewed the sell off as a chance to pickup stocks at cheaper prices. UBS strategist Jonathan Golub said in a note to clients Friday that market returns are greatest when the VIX is extended and represents a near-term buying opportunity. Declining issues outnumbered advancers by a 2.92-to-1 ratio on the NYSE, and

by a 4.52-to-1 ratio on the Nasdaq. The S&P 500 posted 62 new 52week highs and 15 new lows, while the Nasdaq Composite recorded 34 new highs and 297

In a statement Saturday, Taiwan's Ministry of Foreign Affairs condemned "the crude and despicable means by malicious people to arbitrarily snatch the slogan 'Taiwan go for it' from our country's national during

NO ANTHEM. NO FLAG AS BELARUSIAN WINS GOLD



van Litvinovich from Belarus Friday became the first athlete competing as a neutral at the Paris Olympics to win gold -- but it will not appear in the official medals table. The 23-yearold retained his title in the men's trampoline final. with China's Wang Zisai and Yan Langyu taking silver and bronze. Athletes from Russia and ally Belarus are competing under a neutral banner after being banned from world sport following Moscow's invasion of Ukraine in February 2022. The International Olympic Committee (IOC) has overseen their gradual return under a neutral banner and under strict conditions. To be invited to the Games, "neutral individual athletes" who achieved good enough

results to qualify had to pass a double check. International sports federations and the IOC verified that the competitors did not actively support the war in Ukraine or have any links with their countries' armies. They were not allowed to take part in the opening ceremony or compete under their national flags. If athletes make the podium, their achievements are not recognised in the medals table. Only 15 Russians and 17 Belarusians accepted the invitation to compete under the neutral banner.

MANU'S PAINFUL MISS

HEARTBREAK FOR SHOOTER AS SHE MISSES OUT ON GRAND TREBLE AT OLYMPICS

Chateauroux (France), August 3: The sensational Manu Bhaker's dream of a grand treble went up in smoke after she lost the tie-shoot for bronze medal to Hungarian Veronika Major by the narrowest of margins in the women's 25m sports pistol event at the Olympic Games here Saturday.

In a high-quality final, Bhaker gave it her all and was placed No 1 among eight shooters for a brief period, but she could not maintain her consistency and eventually finished fourth.

Nonetheless, the 22-year-old will return home with her twin bronze-medal feat in women's 10m air pistol and mixed team 10m air pistol partnering Sarabjot

The affable Indian shot 28 in the final to be tied at third place along with Veronika after the eighth series of five shots. She missed two of the five shots to aggregate three points, while Veronika drilled in four bullets into the target to clinch the third spot, leaving Bhaker to pack up the kit and leave her firing station. Bhaker conceded at the end of the contest that she was nervous, and no matter how hard she tried to remain calm, she couldn't.

'I got like really nervous about it, but again, I was trying my best to keep calm and to just try to do my best. But that was not enough," Bhaker said after the event.

Shooting fraternity lauds Paris feats

The Indian shooting contingent's biggest-ever medal haul at the Olympics here, after drawing a blank in the previous two editions in Rio de Janeiro and Tokyo, definitely calls for celebration but the fraternity is treading cautiously with an eye already on the 2028 Los Angeles Games. All of India's medal at the Paris Olympics have come via shooting thus far and there is a slight possibility of increasing the medal count to four by the time the competition ends Monday. The highlight of the campaign has been Manu's two medals, the second one shared with Sarabjot Singh in the 10m pistol mixed team. Fielding a record 21-member team at the Chateauroux Shooting Range, India has made six finals, including two near medal misses in 10m air rifle with Arjun Babuta finishing a painful fourth and Manu missing out on a third medal by the narrowest of margins in 25m pistol Saturday. "India is the biggest county and they doing well is very important for the shooting world. Big improvement for India means big improvement for the world. It has got three medals here, maybe they increase it to six at LA28," International Shooting Sport Federation (ISSF) president Luciano Rossi told PTI after watching Manu's 25m pistol final. "Since India and China are the two biggest markets, we are also seeing if India can host some qualification events for LA. We will also be doing a World Cup in India soon," Rossi added.

in which Bhaker missed three out of five targets, but gradually she cut down on the errors and bounced back in the second and third series, shooting two consecutive 'fours' to take her points tally to 10 going into the elimination round.

The elimination round was topsy-turvy to say the least. Bhaker's chances waxed and waned until she took the top spot for a brief period in the seventh series (fourth elimination round).

However, South Korea's Jin Yang wrested back the top spot immediately even as Bhaker slipped to tied third with three bad misses in the eighth round, which saw her slump from second spot to joint third with Veronika on 28 points.

The shoot-off was nerve-jangling for both the markswomen and Bhaker had three clear shots out of five on target, while Veronika had four.

The ace shooter said that she will take a lot of positives from the fourth-place finish and come back stronger in the Los Angeles Games in 2028.

"It (Olympics) turned out to be very good for me, but well, there's always a next time so I'm already looking forward to the next one (in LA)," she said.

Her finish just outside the medal bracket once again brought back memories of fourth-place finishes of Indian shooters in the quadrennial showpiece.

She joined the likes of Joydeep Karmakar (men's 50m rifle prone, 2012 London), Abhinav Bindra (men's 10m air rifle, 2016 Rio) and Ariun Babuta (10m air rifle, 2024 Paris Olympics), among others.

Paris: Deepika Kumari placed herself in an advantageous position against Korea's Suhyeon Nam by winning two of the first three sets but shot a horrible 7 with the second arrow of the fourth set to throw away a great opportunity as India's archery campaign folded at the Paris Olympics here Saturday. Deepika had begun the day

well with a 6-4 win over Germany's Michelle Kroppen but lost by the same margin to Nam, who had won the women's team gold Friday.

Teenager Bhajan Kaur was eliminated earlier in the day after losing her pre-quarterfinal match to Indonesia's Diananda Choirunisa in a shoot-off.

Competing in her fourth Olympics, Deepika yet again left the big stage empty-handed. However, there was no hype around her this time, following disappointments in London, Rio and Tokyo editions.

The fourth place finish by Ankita Bhakat and Dhiraj Bommadevara in the mixed team event was India's best perform-



10 to start the fourth set but fell into the red zone with a seven after the Korean shot a 10 and a nine. Nam did not make any mistake on her final shot, making a 10 to force a decider.

In the fifth set, the Korean began with a 10 and Deepika followed with a nine. Nam managed a 9 and 10 on the following shots but Deepika got only two 9s to lose the quarterfinal 4-6.

Even in the second set, which she lost, Deepika had fluffed the second shot, managing a poor 6.

Coach Purmina Mahato explained that after taking the anchor position, the archers need to release early to stand a better chance of scoring well.

"Ideally, you should have your shot within 5-7 seconds of taking anchor position. If you hold,

all kinds of thoughts start coming to your mind. She held that shot long (6 in second set) and the second time (7 in fourth set) she released it early due to pressure," said Mahato.

The coach said India needs a consistent supply of archers but does not think that it's time for Deepika to quit.

"She must continue. People do well, win medals in this sport, even when they age.'

Meanwhile, the 18-year-old Bhajan did well to stretch her Indonesian rival to a shoot-off but fluffed the first shot by managing an eight when she needed a 10 to secure her passage into the last eight.

"Certainly I was lacking in something, that's why I lost. I will work on that when I go back home," Bhajan said after her 1/8 elimination round match.

Marseille: India's Nethra Kumanan had a tough day in office in the women's dinghy sailing event's opening series at the Paris Olympics as she slipped to 24th spot after Race 6 here

Having finished 11th after three races Friday, the 26-yearold slipped to 24th after three more races Saturday.

While Nethra was placed 19th after Race 4, she dropped to 25th after Race 5 before regaining some composure and finishing a spot above after Race 6.

As for the men's dinghy event, Vishnu Saravanan was placed 23rd after Race 6 Saturday.

The 25-year-old Indian was ranked at 22nd after Race 4 Friday but Saturday he dropped a spot in Race 5, remained there after Race 6. Four more races of the opening series remain in both the events, with Race 7 and Race 8 to be held Sunday, followed by another two Monday.

The top 10 boats from the opening series will enter the medal race Tuesday.

The top three boats will be decided via the overall score from the opening series and the final.



Biles flies to new heights

American comes back from mental health issues to bag third Paris gold

Paris: Simone Biles won the vault final Saturday to clinch her third gold medal of the Paris Games, dominating the competition with her signature Biles II vault to beat Brazilian silver medallist Rebeca Andrade with American Jade Carey taking bronze.

Biles soared high into the ir as she performed her ex plosive Yurchenko double pike for a massive score of 15.700.

The American also impressed with her second effort. She powered down the runway and launched into the Cheng vault, which incorporates a roundoff, half-on entry with a one-anda-half twisting flip to finish.

She earned 14.900.

The 27-year-old claimed a comfortable victory at the Bercy


She led the US team to the top of the podium in the team final before claiming a second allaround Olympic title two days

Poor show by athletes

Paris: Two-time Asian Games gold-medallist shot-putter Tajinderpal Singh Toor could not come anywhere close to his personal best, finishing a dismal 15th in Group A and failing to qualify for the final of the Olympics here Friday. Overall, the 29-year-old

shot-putter finished 29th. A total of 12 athletes meeting the Olympic Qualification Standard of 21.35 or at least the 12 best performers advanced to the final in shot put, which will

be held Sunday. Toor, one of the most celebrated Indian athletes who defended his 2018 Jakarta Asian Games gold in the Hangzhou edition of the continental games last year, had just one legal throw of 18.05 metres, following which he fouled the next two attempts in his group.

On a day when 5000m runners and Hangzhou Asian Games gold medallist Parul Chaudhary finished overall 24th and Ankita Dhyani 40th in the heats and failed to qualify for the final round, Toor's insipid performance stood out as the tall thrower as he barely managed to heave the iron ball beyond the 18-metre mark, falling way short of his

personal best of 21.77 metres and season's best of 20.38

Toor, the national record holder. had made it to the Paris Olympics through the world ranking quota.

Toor had complained of pain in his ankle a day before the start of the National Inter-State Championship in Panchkula in June, but still he took part in the event despite not being fully fit.

In women's 5000m, Parul missed her national record time by one-third of a second but that was enough for an overall 24th position as she and Ankita failed to qualify for the final round.

Paris gender row spirals

NO DOUBT BOXERS IN GENDER DISPUTE ARE WOMEN, IOC'S BACH SAYS

Paris, August 3: Algerian boxer Imane Khelif and Taiwan's double world champion Lin Yu-ting are women who have every right to compete at the Paris Olympics despite a gender dispute that has overshadowed their competitions, the International Olympic Committee president said Saturday.

The pair were cleared to compete in Paris despite being disqualified at the 2023 World Championships after failing International Boxing Association eligibility rules that prevent athletes with male XY chromosomes competing in women's events.

The IOC last year stripped the IBA of its status as boxing's governing body over governance issues, and took charge of the Paris 2024 boxing competition.

"We are talking about women's boxing. We have two boxers who were born as women, raised as women, who have passports as women and who have competed for many years as women and this is a clear definition of a woman," Thomas Bach told a press conference.

"There was never any doubt about them being women."

The IOC has said the IBA decision to disqualify them last year was arbitrary and the main cause for the furore that has swept social media and seen people such as JK Rowling and Elon Musk voice their opposition to them competing in the Games.

Khelif pummelled Angela Carini in the round of 16 of their welterweight bout Thursday before the Italian stopped after 46 seconds, with the Algerian's dominant performance further fanning the debate.

mane Khelif beat Hungary's Luca Anna Hamori by unanimous decision in a welterweight quarterfinal fight at the Paris Games Saturday to ensure Algeria's first Olympic boxing medal since 2000. Khelif's win was emotional - she went to the center of the ring. waved to her fans, knelt and slammed her palm on the canvas, her a smile turning to tears. She left the ring to hug her coaches while her fans roared, weeping during their embrace and as she walked out. Khelif will face Janjaem Suwannapheng of Thailand, whom she beat at the World Championships in 2023 before being disqualified, in Tuesday's semi-finals. "It is hard, she has suffered a lot -- as a child and now as a champion, she has suffered so much during these Games," said Khelif's coach Mohamed Chaoua. 'Where is the humanity? Where are the associations for women's rights? She is a victim."

IBA to award prize money to beaten boxer

he International Boxing Association (IBA) will award Italy's Angela Carini, who lost her welterweight round-of-16 bout against Algerian Imane Khelif at the Paris Olympics in 46 seconds Thursday, \$50,000 in prize money, it said Friday. The IBA, which was stripped of its international recognition by the International Olympic Committee (IOC) last year, said Carini would receive \$50,000, her federation a further \$25,000 and her coach an additional \$25,000. "I do not understand why they killed women's boxing," IBA President Umar Kremlev said. "Only eligible athletes should compete in the ring for the sake of safety. I could not look at her tears.

Confident India eye Britain scalp to seal semi spot in hockey

India saved their best for their last Pool B match, stunning Australia 3-2 to record their first win over the Kookaburras in the Olympic Games in 52 years.

By virtue of the win, India finished second in Pool B behind reigning Olympic champions Belgium, while Great Britain ended third in Pool A.

The highlight of India's performance against Australia was the co-ordination between midfield, led by Manpreet Singh and vice-captain Hardik Singh, and the forwardline, where Gurjant Singh and Sukhjeet Singh stole the limelight.

Abhishek was the livewire in the forwardline, scoring a superb field goal, his second of the tournament, to hand India the

Skipper Harmanpreet Singh once again sparkled for India, scoring a brace, to total six goals in the tournament.

The backline also defended stoutly with Amit Rohidas and Jarmanpreet Singh shining

Veteran custodian PR Sreejesh, playing his last international tournament, stood like a wall in front of the goal, making numerous saves, and India would bank on him to deliver the goods once again against Great Britain.

The transition of the ball from defence, midfield to forwardline was a treat to watch.

No disciplinary action on Pakistan players

Karachi: The Pakistan Cricket Board has decided to act on the advice of its foreign head coaches and will avoid taking any disciplinary action against any players while allowing them to focus on the upcoming international season. A wellplaced source in the board informed Saturday that initially, there were talks about having a disciplinary committee to look into the cases of some players misbehaving during the tours of Ireland and England and the World T20 Cup. "But until now no disciplinary committee has been formed as per the board constitution," he said. The source said as per the constitution, the chairman must appoint independent disciplinary or probe committees if he wants some issues of discipline to be looked into. As per the source, Mohsin Naqvi, the PCB chairman, engaged in comprehensive discussions with the coaches for the red and white ball teams, Jason Gillespie and Gary Kirsten respectively, along with the selectors Mohammad Yousuf and Asad Shafiq. The recommendation given to the board was to focus on the future.

India look to find a way past Lankan spinners, slow pitch

Colombo, August 3: Measures to battle a sluggish pitch and an assortment of Sri Lankan slow howlers will feature high on India's strategy list for the second ODI to be played here Sunday.

Chasing a manageable 231,

India were comfortably placed at 130 for three in the first ODI Friday before losing their way against Lankan spinners, who showed enough pluck to bowl out the visitors for 230 to earn a tie. Once they survived the Rohit

Sharma onslaught unfront. Lanka executed their plans well against the Indian batters, who are not the cleverest performers on rank turners, while not many are though. The home side employed their

army of tweakers against Virat Kohli, KL Rahul and Shreyas Iyer, the meat of Indian top and middle-order, with a telling amount of success. The troika was not uncom-

fortable but was unable to break free either against some well-directed moves of the Lankans, who were precise in their calculations.

Kohli was tied up by Dunith Wellalage, the left-arm spinner, and leg-spinner Wanindu Hasaranga as the 29 balls that the Indian batter faced out of a total of 32 were by the spinners.

Hasaranga eventually nicked him off, while seeing the comfort of Shrevas against spinners. Lankan skipper Charith Asalanka pressed pacer Asitha Fernando into service.

Fernando repaid the faith in him with the wicket of Shrevas with a peach, also the only Indian wicket to have fallen to a quick.

Rahul, another excellent player of spin, too was snaffled by Hasaranga. But stuttering in one match offers too small a footprint to go after some of the ac-

complished names, but the Indians will be eager to bat long and rotate strike, which is the key to nullifying spinners on such

Sri Lankans Pathum Nissanka and Wellalage showed that en route to their fifties despite a flurry of wickets at the other end, while dealing with Kuldeep Yadav, Axar Patel and Washington Sundar effectively.

The four Indian spinners, including Shubman Gill, leaked 126 in 30 overs for four wickets, while their Lankan counterparts' figures stood at -167 in 37.5 overs for nine wickets. So, the Indians will want to minimise the damage without compromising on their run-making ways.

Bowling coach Sairaj Bahutule said as much. "We did bat well in patches, and we could have had some partnerships that would have taken us (home) with less wickets going. We tried our best to get into partnerships," said Bahutule after the first match.

One option India can mull is to bring in either Rishabh Pant or Riyan Parag as both are extremely good at countering spinners and can upset their rhythm playing some of those unorthodox shots.

Wellalage did that to perfection while scooping and reverse sweeping Washington Sundar and Axar. Additionally, Parag comes in with the bundle offer of being an off-spinner and legspinner at the same time. But it remains to be seen whether the Indian team management will make a change after just one match, which has not been their trait for a while now.

From Sri Lanka's perspective, they will enter the second match of the three-match series with a better frame of mind after shackling a much superior and vastly experienced opponent.

much time in a badminton hall and it's also pretty stressful to be a coach, I'm a tired old man," the 44-vear-old from Denmark wrote on his Instagram account.

Under Boe's guidance, Satwik and Chirag had claimed a bronze medal at the 2022 world championships and a gold at the 2022 Commonwealth Games in

The duo went on to Asian Games gold, the Asian Championships title and also achieved the feat of becoming the first Indian badminton doubles team to become world No 1.

The Indian pair additionally won BWF World Tour titles, including the Indonesia Open Super 1000 and Korea super 500

in in 2023 and the French Open super 750 and Thailand Super 500 this year, besides reaching three more finals.

Their sensational run ahead of the Olympics made Satwik and Chirag hot favourites for the coveted title but the duo couldn't go the distance at Paris, and Boe consoled them.

"I know the feeling all too well myself. Pushing yourself to the limit every day, to be in the best shape of your life, and then things doesn't go as you would have hoped for. I know you guys are gutted, I know how much you wanted to bring a medal back to India, but this time it wasn't meant to be," Boe said.

Boe, however, said he is leaving the position as a satisfied man despite his wards failing to return from Paris with a medal.

Shooting society decries Khelo India

Veterans Raninder, Jaspal say nothing coming out of Khelo India; want junior program back under NRAI

Chateauroux, August 3: The Indian shooting community, including veteran administrator Raninder Singh and renowned coach Jaspal Rana, Saturday called for the junior program to be brought back under the national federation fold as "nothing is coming out of Khelo India" project.

The National Rifle Association of India's (NRAI) junior program had to be scrapped to make way for the central governmentrun Khelo India Games.

The current lot of shooters. including double Olympic medallist Manu Bhaker, is reaping the rewards of being around for a long time. But experts like Rana and Raninder are predicting doom for the Los Angeles 2028 Olympic campaign if the federation does not get complete control of the development program.

"If you want a team for Los Angeles you better give my junior program back. Let NRAI run it and call it Khelo India and whatever you want? But if they (the government) are going to do it, we won't have a team for Los Angeles. Nothing is coming out of Khelo India neither at the na-



tional nor at the international level," Raninder told PTI.

"If you want to train an athlete in shooting, you don't give him 1000 cartridges to shoot every day. He shoots 100 a day and is monitored and mentored correctly. Everybody is a coach in India," added the former NRAI president and International Shooting Sport Federation (ISSF) vice president.

Former national coach Rana. who is currently Manu's personal coach, could not agree more with Raninder.

"I totally agree with him. Khelo India is a junior program only, it is just that they took everything out of federation's hands and made it Khelo India. How is it that in one year you are getting medals from Khelo India? Because you are picking the best but it took eight years to bring a junior to that (Olympic platform), junior program has to come back," said Rana, who is open to working with the national team again.

At the Paris Games, the shooters not only broke a 12-year

drought of medals but also claimed their best-ever haul in terms of number of podium fin-

ishes -- three bronze. Rana warned against making wholesale changes after the Paris campaign, especially when the shooters have overcome the mental hurdle of competing at the Olympics.

'We have overcome mental block many times but we don't stick to the same thing. We change after every successful story," he said, referring to the likes of Jitu Rai and Saurabh Chaudhary, who are not part of the team anymore.

"Why can't we have Abhinav Bindra run the program? Why is he out?" Rana asked while mentioning India's only goldwinning shooter at the Olympics.

"That person could be the biggest asset for Indian shooting fraternity but you will not hire him. You will hire someone from outside who doesn't understand our culture. Foreign coaches are fine but they won't give their 100 percent. After the Olympics their contracts will expire and they will go to another country," Rana reasoned.
