

# Is Naveen secular, asks Samantaray

Bhubaneswar, April 5: Stepping up his protest against the dramatic turn of events within the party ahead of the voting on Waqf (Amendment) Bill in the Upper House of the Parliament, BJD Rajya Sabha MP Debashish Samantaray Saturday demanded party president Naveen Patnaik to clear the air over his secular credentials.

'Naveen should open up and give a statement that he is still secular. This is because he often says every bone in his body is secular. He should also say our Parliamentary Party leader Sasmit (Patra) misunderstood him," Samantaray told **Orissa** 

He said the party's stand on the Bill will cast its shadow on minority votes. "Minority population is significantly higher in 28 coastal constituencies of the state. In some of these seats, the number of minority voters ranges between 30,000 and 40,000. The party is likely to lose these seats," Samantaray said.

He, however, chose not to blame Patra.

"Sasmit is not the villain here. He does not take decisions, he merely follows instructions. The real power lies elsewhere, with the 'chief advisor'," Samantaray said while not naming the close aide of



Patnaik. "Everybody knows who he is," he said. Ostensibly he was hinting at bureaucrat-turned-politician VK Pandian, whose proximity to the former CM is an open secret.

The BJD MP also hinted at a 'big deal' between the 'chief advisor' and the BJP

'There has been a big deal. The chief advisor has made some kind of arrangement with the BJP. A bureaucrat, who has recently taken voluntary retirement, may be part of this deal. You all know who has recently taken VRS. I leave it to your understanding," Samantray said.

Senior Odisha cadre IAS officer Sujata R Karthikeyan, the wife of Pandian, recently took voluntary retirement from government service. Karthikeyan, a 2000-batch officer, was serving as the special secretary in Finance department.

Patra is in the eye of the storm after revealing that he had voted in favour of the contentious

would oppose the Bill, and even party MP Muzibulla Khan spoke against it in the Rajya Sabha April 3, Patra put out a post on X before voting, stating that party MPs could vote as per their conscience and that there was no whip issued to them.

# Anant Ambani walks the talk

Jamnagar, April 5: In India, where padayatras are an intrinsic element of the country's civilisational heritage, a scion of the country's wealthiest family has embarked on a walking pilgrimage redolent of this very Indian way of seeking union with the divine.

Anant Ambani, 29, is on a 170-kilometre padayatra from Jamnagar, his ancestral hometown and karmabhoomi, to Dwarka one of India's holiest cities. After setting out March 29, he has been covering about 20 kilometres daily, walking for about seven hours each night. He will reach Dwarka, a city that is etched in India's religious and spiritual lore, April 8—a day before his 30th

Along the way, Ambani has encountered an attitude of reverence and goodwill-some have walked along with him a part of the way in solidarity, others have given his pictures of the presiding deity Lord Dwarkadhish and still others have come over with their horses to get their pictures taken.

Ambani's padayatra is also remarkable for the fact that the strenuous journey has been undertaken surmounting the debility caused by Cushing's Syndrome--a rare hormonal disorder—and morbid obesity, as well as asthma and a severe lung disease.

Along this spiritual padayatra, Anant has been chanting the Hanuman Chalisa, the Sundarkand and the Devi Stotra on his way to Dwaraka.

The younger son of Reliance Industries' Mukesh Ambani is a devout Sanatani who wears his spiritual passion on his sleeve. Some of India's most iconic religious destinations are his regular haunts and the beneficiaries of his munificence-Badrinath, Kedarnath, Kamakhva, Nathdwara, Kalighat and the Kumbh Mela, to name just few.

## Elderly woman killed during robbery bid

Jajpur, April 5: An elderly woman was killed and her daughter injured after they were attacked by miscreants who tried to rob their house in Jajpur district, police said Saturday.

The incident took place at Tigiria village under Balichandrapur police limits in Jajpur district Friday night. The deceased woman has been identified as Kausalya Pati,77. Her daughter Mamata Pati, 55, an ASHA worker, is undergoing treatment at Badachana CHC after being critically injured in the attack. Police said Kaushalya was living with her daughter who had been abandoned by her husband.

Two unidentified robbersbarged into their house while the two women were sleeping. Hearing a noise, the two woke up and tried to resist. The looters then attacked them with a sharp object. While Kaushalya died on the spot Mamata was grievously wounded.

# Meitei, Kuki meet for first time

New Delhi, April 5: For the first time since ethnic violence started in Manipur nearly two years ago, the representatives of the warring Meitei and Kuki communities met face-to-face Saturday as the Centre intensified efforts to restore peace and bring back normalcy in the northeastern state.

The meeting, which was held here at the aegis of the Union Home Ministry, discussed various aspects of the ongoing conflict and decided to continue their dialogue to find an amica ble solution acceptable to people of the state, sources privy to the meeting said.

The sources said the meeting, which lasted for about five hours, was held as part of the Central government's initiatives to resolve the ongoing conflict between the two communities, which began in May 2023 and had worsened ethnic tensions.

The meeting was aimed at enhancing trust and cooperation between the Meiteis and Kukis and finding a roadmap to restore peace and normal cy in Manipur, they said. The discussions also stressed on maintaining law and order and facilitating reconciliation between the two communities.

# Sahara, once green, was home to mysterious human lineage

Cairo, April 5: The Sahara Desert is one of the Earth's most arid and desolate places, stretching across a swathe of North Africa that spans parts of 11 countries and covers an area comparable to China or the United States. But it has not always been so inhospitable.

During a period from about 14,500 to 5,000 years ago, it was a lush green savannah rich in bodies of water and teeming with life. And, according to DNA obtained from the remains of two individuals who lived about 7,000 years ago in what is now Libya, it was home to a mysterious lineage of people isolated from the outside world.



Researchers analysed the first genomes from people who lived in what is called the 'Green Sahara.' They obtained DNA from the bones of two females buried at a rock shelter called Takarkori in remote southwestern Libya. They were naturally mummified, representing the oldest-known

mummified human remains.

"At the time, Takarkori was a lush savannah with a nearby lake, unlike todav's arid desert landscape," said archaeogeneticist Johannes Krause of the Max Planck Institute for Evolutionary Anthropology, one of the authors of the study published this week in the journal Nature.

The genomes reveal that the Takarkori individuals were



part of a distinct and previ ously unidentified human lineage that lived separated from sub-Saharan and Eurasian populations for thousands of years.

"Intriguingly, the Takarkori people show no significant genetic influence from sub-Saharan populations to the south or Near Eastern and prehistoric European groups to the north.

This suggests they remained genetically isolated despite practicing animal husbandry - a cultural innovation that originated outside Africa," Krause said.

Archaeological evidence indicates that these people were pastoralists, herding domesticated animals. Artefacts found at the site include tools made of stone, wood and animal bones, pottery, woven baskets and carved figurines.

The ancestry of the two Takarkori individuals was found to have derived from a North African lineage that separated from sub-Saharan populations around 50,000 years ago. That roughly coincides with when other human lineages spread beyond the continent and into the Middle East, Europe and Asia - becoming the ancestors of all people outside Africa.

'The Takarkori lineage likely represents a remnant of the genetic diversity present in northern Africa between 50,000 and 20,000 years ago," Krause said.

"From 20,000 years ago onward, genetic evidence shows an influx of groups from the Eastern Mediterranean, followed by migrations from Iberia and Sicily around 8,000 years ago. However, for reasons still unknown, the Takarkori lineage persisted in isolation for much longer than expected. Since the Sahara only became habitable about 15,000 years ago, their original homeland remains uncertain," Krause said.



Bhubaneswar, April 5: With BJD's flip-flop on Waqf (Amendment) Bill has already laid bare the party's internal rift, a section of its senior leaders Saturday demanded strong action against Sasmit Patra for 'creating confusion' among lawmakers ahead of the voting on the Bill.

State's 1,405 PHCs will participate in the event through videoconferencing.




GJAY replacing the existing Biju Swasthya Kalyan Yojana (BSKY) launched by the previous BJD government.

# Trade & Diplomacy

ow do trade wars end? To answer that we have to ask ourselves, how do wars end? The answer is that once begun they are not easy to end. Most of the time, trade and diplomacy are conducted outside of the public view. This is not only because of secrecy but also the fact that the details are too boring to interest news debates. What tariff a country charges another on dairy, soya and auto spare parts, and what it should be charging instead is not exciting material. Similarly, the spectacle of 'summit' meetings between leaders, though ultimately insubstantial, steal the show over the more meaningful but more boring meetings over details that diplomats have to resolve

Disagreements may remain after these meetings but the option of keeping the status quo is the one that is most frequently resorted to. Escalation towards violence is rare.

But when it does come, it is not easy to control. The reasons are that the side that begins it is not the only one that has agency. The other nation's response, its timing, its intensity and its effectiveness are impossible to predict. As boxer Mike Tyson elegantly put it: 'Everyone has a plan until they get punched in the face.

Wars end either when both sides have had enough. meaning their

nations have suffered damage and are unwilling to suffer more. Or they end when one side is strong enough to compel the other one to submit. Much like a school fight between a large child and a smaller one. The little fellow has no option but to give up.

Unlike this example, wars and trade wars have another element which is why they are difficult to control and escalation is impossible to predict. This is national pride and national survival. This is why trade and diplomacy work when they are done outside the public view. When they become part of the popular conversation and the public become participants, driven to anger by their leaders' rhetoric on being ripped off by the other side, everything changes.

The American president says he is punishing China with tariffs and then warns it not to retaliate because he will apply further punishment. The Chinese response is to immediately inflict the same punishment on the US. Some will argue, correctly, that the tariff mostly punishes the country imposing it because its consumers will pay the import duty.

That is not the point. It is called a trade war because it is war minus the shooting. The effects are real in the sense that one side is trying to actively and materially damage the other and the other is compelled to respond.

After he put tariffs on Canada, Trump posted this: "Please explain to Governor Trudeau, of Canada, that when he puts on a Retaliatory Tariff on the US, our Reciprocal Tariff will immediately increase by a like amount!"

Canada did respond and now so has China. The options are for Trump to either do what

he said he would, that is to add further tariffs

on them, or to back down. If he does the former, it escalates and he has no control, if he does not act, then he is seen as losing and his credibility is shot. This is why wars are difficult to end once they are begun. This is why this trade war will remain with us for some time. And

this should concern us in India. You see, between 2004 and 2014. India grew quickly in large measure because its merchandise exports went from about \$50 billion a year to about \$320 billion a year in that decade. This was largely because of global trade rising in that period and when trade flattened after the global financial crisis, our growth tapered off as well. Today, another 10 years later merchandise exports are at \$400 billion or so, meaning that the rapid rate of growth is gone. The moral is that rising global trade is good for India and trade wars are terrible for us. For this reason it is important that India take on some leadership in at least attempting to resolve this.

There are some reasons to be optimistic. Democracies usually tend to be self-correcting, and the United States even more so. Its parliament is run by legislators who have to face elections every two years. If the tariffs are particularly disruptive in the next few weeks and months, and the public is restless, those up for election in November 2026 will begin to pressure their president to reduce the turbulence he has created. Even if his plan shows like it may work over the long term, this pressure could undo it.

There is an exception to this self-correction rule and that is for war. The history of the United States shows that it will continue doing the wrong thing and prosecuting war even though it is itself damaged. Vietnam and Iraq show this. In Afghanistan, the US continued doing the wrong thing, learning no lessons, punishing itself and its opponents, for 20 years before surrendering. The American public was okay with suffering through this continuation, losing citizens and treasure. perhaps because they thought it was in their national interest.

We can only hope this is not as true for the Trump trade war as it

# PROTECTING ENCRYPTION

magine that some strange man wants a picture of your child. If it were the year 1750. he might commission an artist, who would then knock on your door and ask to paint a portrait. You could say no.

If it were 1850, he might hire a daguerreotypist who would ask your child to sit still while light and mercury vapor etched their image into a brilliantly polished, silvered copper plate. Again, you could

And if it were 1950, the man might buy a Polaroid camera, knock on your door, and ask to snap a photo of your child and you could still refuse.

Why should today's parents or children have less privacy than their predecessors? Should spies, hackers, or even police officers be able to access a photo of your child without your permission? Of course

Yet, that is what is at stake if the United States, the United Kingdom, and the European Union align with China and Russia's efforts to undermine encryption. Apple recently made global headlines by resisting a demand by the British government to access encrypted private data stored on the company's servers. In other words, instead of asking for information, governments want the power to take it - without giving citizens a chance to say no.

If these efforts succeed, governments will wield unprecedented surveillance power. Although often justified as necessary to combat child abuse, there is little evidence to suggest that children will be safer if government agencies gain unlimited access to their photos, conversations, and location data. In fact, as Washington Post reporters Jessica Contrera, Jenn Abelson, and John D. Harden showed in their investigation of child

sexual abuse by US police officers, the opposite may be the case.

To convince the public that breaking encryption is necessary, governments often rely on technical jargon and emotionally charged anecdotes, framing encryption as something only bad actors use. For example, some US legislators are trying to exploit parents' fears to push for policies that would weaken privacy protections for children.

The millions of parents who rely on encrypted apps like WhatsApp every day are certainly not criminals. They are simply trying to protect their privacy and that of their families. Still, frightened people are susceptible to the message that the only solution is to allow more government access to their personal lives

To be fair, some of the governments currently seeking to weaken encryption are trying to address real problems, such as the spread of child pornography, terrorist recruitment, and online scams. But it is crucial to understand the role encryption does - and does not - play in facilitating these

Researchers at the University of Barcelona have offered valuable insights into the relationship between technology and social harm. As Paula Sibilia observes, technologies like encryption are not inherently good or bad, but they are also far from neutral. They emerge within specific historical contexts and are shaped by the values, interests, and norms of their time. These forces, in turn, affect how people see themselves and their role in society. To understand encryption, then, we must first understand the world that created it.

At the same time, technologies are more than neutral tools whose value depends solely on how they are being used. As Mariana Moyano notes, a shoe can be used to hammer a nail or hit someone, but that is not what it was designed for. Behind every technology lies a set of intentions - political and otherwise. We must therefore ask what a given technology was developed to do and whose interests are embedded in its design.

Lastly, as Donna Haraway

argues, we must rethink our relationship with technology, cultivating new ways of connecting with the machines and systems that shape our lives.

At its core, encryption is a tool that allows us to say "no" to those who would take our data without consent. It is also the foundation of the internet as a place where privacy is respected and the freedom to learn is limitless. Every person should feel empowered to use tools that protect their privacy. They may choose not to use them, but they must have the right to make that choice.

Britain's anti-encryption efforts represent a serious threat to this essential freedom. UK residents already have fewer privacy tools than people in many other countries, thanks to their government's aggressive efforts to undermine encryption. If Apple or other major tech companies give in to government pressure, a dangerous global precedent will have been set, and the consequences might not be limited to the UK's 68 million people.

When policymakers in Washington and London start to resemble their counterparts in Beijing and Moscow in their approach to privacy, it is time for serious self-reflection. But it's not too late to change course. Those of us who care about online privacy must speak up, contact our representatives, and demand that they protect encryption from efforts to undermine it, thereby preserving the freedoms that previous generations once took for granted.

local authorities must collaborate with experts to create well-planned neighbourhoods that can accommodate this surge sustainably. Public-private partnerships are essential to bridge housing gaps, particularly in Tier II towns seeing a swell in the number of settlers due to resource-based economic activities. Despite allocated budgets, Odisha's Housing and Urban Development Department has struggled to execute plans. Filling vacancies and creating specialised posts could enhance efficiency and expedite project completion. Odisha's youth represent its

greatest potential, vet many skilled workers seek opportunities outside the state. Programmes like "Skilled-in-Odisha" must pivot towards creating jobs within Odisha itself, focusing on sectors like mining, fisheries, and tourism. Supporting entrepreneurship and fostering startups are essential for a thriving ecosystem. The state must assess its contributions to India's startup growth and demographic divi-

dend in quantitative terms to ensure progress aligns with national goals.

Effective policies are already in place, but implementation remains the key challenge. The Chief Minister's Office Chief Secretary's Office should establish task forces of subject experts to monitor and execute key initiatives. Civil society should shun its insipid, passivity and play a crucial role in ensuring accountability and fostering collaborative progress

Now is the time to transition from rhetoric to action, empowering the state to balance economic growth with cultural preservation and social equity. 





# India, SL ink major defence pact 'Cash row judge

Following talks between PM Modi and Sri Lankan President Anura Kumara

Colombo, April 5: Signalling an upswing in their strategic ties nearly four decades after the IPKF episode, India and Sri Lanka Saturday inked a defence pact to institutionalise military cooperation with Prime Minister Narendra Modi asserting that security of both the nations is interlinked and dependent on each other.

Following talks between PM Modi and Sri Lankan President Anura Kumara Dissanayake, the two sides firmed up a total of seven pacts, including one on developing Trincomalee as an energy hub under a trilateral framework, also involving the United Arab Emirates and another agreement on power grid connectivity.

While Modi reaffirmed that New Delhi will always stand with the people of the island



nation, Dissanayake said Sri Lanka will not allow its territory to be used in any manner inimical to security interests of India as well as the region. In the meeting, the prime minister pitched for resolving the vexed fishermen issue between the two countries with a "humane approach" and hoped that Colombo will fulfil the aspirations of the Tamil people and conduct provincial council elections. In his media statement. Modi said India converted loans worth more than \$100 million into grants in the last six months alone to help Sri Lanka and announced reducing interest rates for loans given to the island nation.

Apart from the seven pacts, India also firmed up a debt restructuring agreement as part of its economic assistance for Colombo with Modi saying it will facilitate immediate assistance and relief to the people

of Sri Lanka. Modi also announced a support package of approximately 2.4 billion Sri Lankan rupees for social and economic development of the Eastern provinces of Sri Lanka.

In reflection of the importance Colombo has attached to Modi's visit, the prime minister was accorded a ceremonial welcome at the historic Independence Square and was conferred Sri Lanka's highest civilian honour, the Mithra Vibhushana. Though the Modi-Dissanayake talks produced over 10 concrete outcomes, the defence cooperation pact emerged as the centerpiece as it signalled an upward trajectory in defence relations leaving behind the bitter chapter of India pulling out the Indian Peace Keeping Forces (IPKF) from the island nation around 35 years ago.

"We believe that we have shared security interests. The security of both countries is interconnected and co-dependent." Modi said.

"I am grateful to President Dissanayake for his sensitivity towards India's interests. We welcome the important agreements made in the area of defence cooperation," he said. In his comments, the Sri Lankan leader said, "We also discussed in detail about furthering our collaboration in the already excellent defence cooperation between the two countries." " reaffirmed Sri Lanka's stance that it will not permit its territory to be used in any manner inimical to the security of India as well as regional stability."

Modi said India is proud to have fulfilled its duties as a "true friendly neighbour. "Whether it was the terrorist attack of 2019, the COVID pandemic, or the recent economic crisis, we have stood firmly with the people of Sri Lanka during every difficul-

PM Modi also placed a wreath at the IPKF memorial in Colombo, paying tributes to the Indian soldiers who made supreme sacrifices during the intervention. To a question on defence pact, Foreign Secretary Vikram Misri said at a media briefing that it is an umbrella framework that will make existing defence cooperation initiatives "more structured" even as he talked about "close convergence" in the narratives from both sides on "completely interlinked" nature of the na

Prayagraj (UP), April 5: Justice Yashwant Varma, who was transferred from the Delhi High Court to the Allahabad High Court amid cash-at-home allegations, was administered the oath in a "clandestine' manner Saturday, the High Court Bar Association (HCBA) here claimed while condemning the move. The lawyers' body, which

had opposed the repatriation of the judge, questioned why "this oath was not notified to the Bar" and alleged that it has once again eroded the trust of people in the judicial system. An in-house inquiry was ordered by the Chief Justice of India (CJI) after the recovery of "four to five semi-burnt sacks" of Indian currency notes from the residence of Justice Varma following a fire incident last month. Justice Varma has maintained that neither he nor his family was aware of the

In a letter dated April 5 addressed to Chief Justice of Allahabad High Court Arun Bhansali, the secretary of HC-BA, Allahabad, Vikrant Pandey, contended that "legally and traditionally, the oath administered to Justice Varma is fallacious and unacceptable" and urged the Chief Justice not to assign any administrative and judicial work to the judge. "The entire Bar Association

is at pains to learn about the clandestine manner in which Justice Yashwant Varma has been administered the oath of his office at Allahabad," the letter said.

"In due deference to our remonstration against the repatriation of Justice Yashwant Varma to Allahabad High Court, the Hon'ble CJI had met the members of the Bar and assured that appropriate steps be taken to maintain the dignity of the judicial system, Pandey said.

"We are given to under stand that the system is taking every step in a fair and transparent manner, but why this oath is not notified to the Bar, is a question which again eroded the trust of people in the judicial system," he said in the letter. "We unequivocally condemn the manner in which Justice Yashwant Varma was administered the oath behind our backs," he said. There was no official word from the high court on the swearing-in of the judge

The incident of cash recov ery has reignited debate over the issue of judicial accountability and there have been calls from various quarters for stringent action in the matter to set a precedent and restore faith in the judiciary.

# India winner in US tariff hikes: Sources

New Delhi, April 5: India recent US tariff hikes, as its exporters are better positioned to absorb the impact compared to competitor countries that are facing higher import duties in America, sources said Saturday.

They added that sectors that could get impacted like marine need to explore new markets such as the European Union to push their shipments.

India has protected its dairy sector in all the free trade agreements and it will continue to do so and safeguard them, they said, adding that if the US goes ahead with imposing higher tariffs on pharmaceuticals also, it will have a small impact on India. "India has emerged as a winner in the reciprocal tariffs imposed by the US. India has

the first mover advantage as it is negotiating a bilateral trade agreement with America," one of the sources said.

In a trade pact, two countries either significantly reduce or eliminate import duties on the maximum number of goods traded between them. So in this case, both nations could look at cutting taxes for each other.

While the US has imposed an additional 26 per cent import duty on India, its competitor Vietnam is facing 46 per cent tariff, Bangladesh 37 per cent, China 34 per cent, Indonesia 32 per cent, and Thailand

36 per cent. On top of 34 per cent, imports from China to the US face previously announced 20 per cent tariffs. Now as China has retaliated to reciprocal tariffs. President Donald Trump is expected to increase duties further as he had announced.

# Waqf Bill gets Prez's assent

New Delhi, April 5: President Droupadi Murmu Saturday gave her assent to the Waqf (Amendment) Bill, 2025, which was passed by Parliament earlier this week.

Murmu also gave her assent to the Mussalman Wakf (Repeal) Bill, 2025.

"The following Act of Parlia ment received the assent of the president April 5, 2025, and is hereby published for general information: The Waqf (Amendment) Act, 2025," the government said in a notification." Parliament early Friday approved the Bill after the Rajya Sabha gave its nod to the contentious legis lation following an over 13-hour

The discussion witnessed staunch objections from opposition parties, which termed the Bill "anti-Muslim" as well as "unconstitutional", while the government responded that the



"historic reform" would benefit the minority community. The Bill was passed in the Rajya Sabha with 128 members voting in favour and 95 opposing it.

It was passed in the Lok Sabha early Thursday, with 288 members supporting it and 232

Parliament had also approved the Mussalman Wakf (Repeal) Bill, with the Rajya Sabha giving its nod. The Lok Sabha had already given its assent to the Bill. After the president gave her assent, it has also become a law.

Congress MP Mohammad Jawed and All India Majlis-e-Ittehadul Muslimeen (AIMIM) president Asaduddin Owaisi Friday challenged the validity of the Waqf (Amendment) Bill in the Supreme Court, saying it violated constitutional provisions.

The petition, filed through advocate Anas Tanwir, said it discriminated against the Muslim community by "imposing restrictions that are not present in the governance of other religious endowments".

Jawed, the Lok Sabha MP from Kishanganj in Bihar, was a member of the Joint Parliamentary Committee on the Bill and alleged in his plea that it "introduces restrictions on the creation of Waqfs based on the duration of one's religious practice"

In his separate plea, Owaisi said the Bill took away from Wagfs various protections accorded to Waqfs and Hindu, Jain and Sikh religious and charitable endowments alike.

Dharanidhar Nayak, a resident of Satabhaya, said, "While 571 families were relocated to a resettlement site in Bagapatia in 2018, the 40 families which remained behind are now facing increasing danger as the sea continues to encroach land. # EXPLODING COSMETICS Anatomy of a 'hybrid war' on the West

Warsaw, April 5: Fake cosmetics, massage pillows and sex toys. Crude homemade explosives. A Russian known as Warrior. A code word: Mary.

These are among the key elements of a suspected Russian-run sabotage plot that led to three parcels being detonated at courier depots in Britain, Germany and Poland last summer, a person with knowledge of the Polish investigation told

The pillows, packed into the parcels with the cosmetics and sex toys, contained hidden homemade incendiary devices made of a cocktail of chemicals including highly reactive mag-

nesium, according to the person familiar with the case who provided the most granular account yet of the alleged plot.

The chemicals were ignited by pre-timed detonators adapted from cheap Chinese electronic gadgets used to track items like lost keys, with the effect enhanced by the tubes of what looked like cosmetics but in fact contained a gel made of flammable compounds including nitromethane, according to the source.

"The proceedings in this case concern criminal activities inspired by Russia's GRU," this person said, referring to Moscow's foreign military intelligence agency.

European security chiefs made the parcel fires public in

# 'Hands Off!' protests against Trump, Musk planned across US



Washington, April 5: Some 1,200 demonstrations are planned across the US Saturday in what organizers expect to be the largest single day of pro test against President Donald Trump and his billionaire ally Elon Musk since the administration launched its rapid-fire effort to put a conservative stamp on government.

The "Hands Off!" protests will give Trump opponents an opportunity to demonstrate their displeasure en masse in response to Trump's sweeping makeover of US foreign and domestic policy through executive orders.

"This is an enormous demonstration that is sending a very clear message to Musk and Trump and congression nal Republicans and all the goose-stepping allies of MAGA that we don't want their hands on our democracy, on our communities, on our schools and our friends and our neighbors, said Ezra Levin, co-founder of Indivisible, one of the groups organizing Saturday's events.

Some 150 activist groups have signed up to participate, according to the event's web-

Events are planned in all 50 states plus Canada, Britain, France, Germany, Mexico and Portugal. One of the biggest rallies is expected on Washington's National Mall.

Trump returned to office January 20 with a stream of executive orders and other measures critics say are aligned with an agenda outlined by Project 2025 a deeply conservative political initiative to reshape government and consolidate presidential authority. His supporters have applauded Trump's audacity as necessary to disrupt entrenched liberal interests.

White House assistant press secretary Liz Huston disputed the protesters' charge that Trump aimed to cut Social Se curity and Medicaid.

# **US starts collecting** Trump's 10% tariff

Washington, April 5: US customs agents began collecting President Donald Trump's unilateral 10% tariff on all imports from many countries Saturday, with higher levies on goods from 57 larger trading partners due to start next week.

The initial 10% "baseline" tariff took effect at US seaports, airports and customs warehouses at 12:01 am, ushering in Trump's full rejection of the post-World War Two system of mutually agreed tariff rates.

"This is the single biggest trade action of our lifetime." said Kelly Ann Shaw, a trade lawyer at Hogan Lovells and former White House trade ad $viser\ during\ Trump's\ first\ term.$ 

Shaw told a Brookings Institution event Thursday that she expected the tariffs to evolve over time as countries seek to negotiate lower rates. "But this is huge. This is a pretty seismic and significant shift in the way that we trade with every country on earth," she added.

Trump's Wednesday tariff announcement shook global stock markets to their core, wiping out \$5 trillion in stock market value for S&P 500 companies by Friday's close, a record two-day decline. Prices for

# India steps up vigil on for tariff impact cheap Chinese imports

New Delhi, April 5: India has stepped up vigil to prevent the dumping of cheap Chinese imports in the country after the steep US tariff hike on the goods exported by the Communist country. Commerce Secretary Sunil

Barthwal is reported to have held a number of meetings to take stock of the situation. Government officials are also in touch with industry to get a wider view of the ground reality and formulate a strategy to protect the Indian economy. The Commerce Ministry has

already been keeping a close watch on goods such as steel from China which was hurting industry after the earlier round of tariff hike by the US. Now the vigil has been widened to other goods as well, a senior official confirmed While the US has hiked tar-

iffs for all countries, China is the worst hit as the additional tariff of 34 per cent announced by President Donald Trump has ramped up the total duty to 54 per cent. China has retaliated against

the US tariff hike by increasing duties on all American goods by 34 per cent and placing export curbs on essential rare earth metals required for the vital electronics and defence industries.

China has also imposed re-



panies, especially those in defence-related industries, in a tit-for-tat move.

India's exports to the US constitute only 4 per cent of its GDP, so the 27 per cent hike in tariffs on Indian goods announced by President Trump will have only a 'limited' impact, according to an SBI Research report. The tariffs levied on India

are the lowest among its Asian peers, compared to 34 per cent on China, 36 per cent on Thailand, 32 per cent on Indonesia, and 46 per cent on Vietnam. This is expected to give India a comparative advantage over these countries and result in an increase in exports in some sectors over the long term, the report states.

The higher tariff on textile export-oriented countries like

Bangladesh, China, and Vietnam may lead to lower demand due to inflationary pressures. However, in the long term, India stands to benefit as it endeavours to corner a larger share of the market. India's export to the USA on textile products is around \$7 billion during April-December, FY25, So, this sector may be impacted negatively in the short run but may have a positive impact in the long run, according to the report.

In electronics, China has a tariff of 54 per cent to 79 per cent, so India has a better position compared to the key electronics exporting countries. India's exports of electronics to the US were worth around \$9 billion during April-December of FY25, which holds the highest share of 15 per cent in

# IT firms brace

Bangalore, April 5: India's \$283-billion IT sector should brace for a rough year ahead as tariffs are likely to stoke inflation in its key U.S. market and force clients to cut spending, analysts said.

Although President Donald Trump did not impose direct tariffs on IT services, Indian firms are expected to feel the heat as clients, especially in manufacturing, logistics and retail sectors, adjust to the new

That could slow deal cycles delay existing projects and hurt revenue growth, analysts said. Bernstein and ICICI Securities rushed to cut their ratings on the Indian IT sector soon after the tariff announcement.

sector was counting on Trump to revive client confidence and discretionary spending after vears of weak revenue growth

The U.S. accounts for more than half of India's \$190 billion software exports, making the sector sensitive to shifts in spending confidence among Friday lifted global and U.S. recession odds to 60% after Trump's tariff announcement.

**New Delhi, April 5:** The Na tional Pension System (NPS) has emerged as a cornerstone of India's pension sector with an accumulated corpus of ₹14.4 lakh crore and 8.4 crore subscribers under NPS and the Atal Pension Yojana (APY), ac cording to PFRDA chairman Deepak Mohanty.

Speaking at the first 'International Research Conference on Pension 2025' here, Mohan ty said the focus of the pension system remains on expanding coverage, ensuring financial sustainability, and building a pension-inclusive society for future generations.

The two-day event was or ganised by the Pension Fund Regulatory and Development Authority (PFRDA), in collaboration with the Indian Institute of Management Ahmedabad (II MA), to mark a historic mile stone in India's journey toward robust old-age income security.

Minister of State for Finance Pankaj Chaudhary, said India's demographic landscape is rap idly changing and with 19 per cent of the population projected to be elderly by the mid-centurv, securing financial indepen dence through inclusive pension schemes is not merely a goal, but a vital need for the country.

'Pension for All' must be come a national priority, re quiring policy action to ensure a dignified and secure future for our aging population, he added. Nagaraju Maddirala Secretary, Department of Fi nancial Services, highlighted that India's pension framework stands at a pivotal moment of transformation and through the launch of the Unified Pension System and efforts to broaden coverage, the government is creating a robust foundation for secure retirement.

UPS provides an assured pension of 50 per cent of the average basic pay drawn over the last 12 months prior to superannuation. India's pension assets, constituting roughly 17 per cent of GDP, fall far short of the OECD average, where they typically exceed 80 per cent, revealing a stark disparity in

Experts also held discussions at the conference to explore strategies adopted by various countries for enhanced pension coverage, building a sustainable pension system and challenges faced in inclusion of informal sector and gig econo my workers. # 'Financial system has become more resilient'

New Delhi, April 5: India's financial system has become more resilient and diverse, driven by rapid economic growth, and regulatory framework in securities markets has been enhanced in line with international practice to manage and prevent emerging risks, the Securities and Exchange Board of India (SEBI) said on Saturday, citing a latest IMF-Financial System Stability Assessment (FSSA) report.

The markets regulator said, in a statement, that the financial sector in India has shown recovery from various distress episodes of the 2010s and withstood the pandemic well.

"In terms of evolution of the financial sector landscape, the Non-Banking Financial Intermediaries (NBFI) sector has become diverse but more interconnected. Banks and Non-Banking Financial Companies (NBFCs) have sufficient aggregate capital to support moderate lending even in severe macro-financial scenarios," the SEBI said, citing the

On regulation and supervision of NBFCs, the IMF acknowledged India's systematic approach for prudential requirements of NBFCs with scale based regulatory framework.

The IMF also appreciated India's approach on introduction of bank-like Liquidity Coverage Ratio (LCR) for large NBFCs.

For supervision of banks, the IMF suggested strengthening credit risk management through "IFSR 9 adoption and upgrading supervision over individual loans, collateral valuation, connected borrower groups, large exposure limits,

and related-party transactions". The report further stated that notable improvements include establishing the Corporate Debt Market Development Fund (CD-MDF), introducing swing pricing, and liquidity requirements for bond mutual funds.

The regulatory scope has also been expanded over emerging areas such as sustainability and investor protection measures for fast-growing equity derivatives products, according to the IMF-FSSA report.


# 'Strike gold' with smart buying during corrections: Hans

Bhubaneswar, April 5: As gold prices continue their upward march, hitting new record highs regularly amid global uncertainties, buying the yellow metal – whether it be in the form of jewellery or as an investment asset seems to have become an increasingly tricky proposition, according to bullion experts.

However, at a time when gold has breached the ₹93,000 (per 10 grams) mark in India, Lalchnd Jewellers founder chairman Sunjoy Hans, a long-time observer of the gold industry, says "time and timing" are of the essence for jewellery buyers and gold investors in the current volatile scenario

Noting that the current gold price has already taken into consideration the US Federal Reserve's interest rate cuts, central bank buying and the cross-sectoral global impact of US President Donald Trump's tariff, in ad-



dition to the fact that the precious metal has touched its year-end target long before it was earlier expected to, Hans reckons that the gold market is overheated and a correction is imminent.

Many industry experts across the world agree that gold rate will fluctuate considerably in the coming days.

"I think here's

timing is important. From now onwards, over the next month or two, whenever there is a price correction, buyers and investors will do well to use every opportunity they get to buy gold," Hans While also suggesting that

gold investors may currently hedge their bets by booking profits and investing those in silver, what with the white metal being widely deemed an extremely attractive investment these days thanks to heavy demand and limited supply, Hans points out that the outlook for gold is 'no less". "The way the world is in

these times, there is really no limit to the upside of gold. The corrections, no matter how deep, will be temporary as they have always been historically. But the price rise has been permanent when you look at the timeline. It won't be too long before you see gold rate hovering around ₹1,35,000 (per 10 grams)." Hans asserts.

# Trump tariffs wipe \$5 trillion off Wall Street

Orlando, April 5: One of the most pivotal weeks in years - even decades - for the global economy closed Friday to the sound of the Nasdag crashing into a bear market as investors fear U.S. President Donald Trump's trade war will tip the world into recession.

Less than 48 hours after Trump raised tariff barriers to the highest in over a century, China Friday said it would slap additional 34% duties on all U.S. imports, escalating the global trade war to new, dangerous heights.

Any hopes investors had of Federal Reserve Chair Jerome Powell coming to the rescue by signaling a readiness to cut interest rates - as Trump had appeared to pressure him into

doing in a social media post earlier in the day - were dashed, as Powell stressed the "elevated risks" to both growth and inflation.

This 'wait and see' approach rattled Wall Street further - the S&P 500's 6% slump meant the index's market cap plunged \$5 trillion in just two days. The Fed is in a real bind,

faced with the rapidly rising risk of recession and soaring price pressures. Treasuries may have been caught between these two stools on Friday, but it is crystal clear where rates traders are putting their money four rate cuts are fully priced in for this year, starting in

However, given the ferocity of the equity market selloff, collapse in confidence and extraordinarily uncertain outlook, it wouldn't be a total

shock if the Fed cut rates at its May 6-7 meeting. Indeed, could an inter-meeting move be ruled out if the market rout continues next week? This is the heaviest slide

across global stocks since the pandemic in 2020. But unlike

that crash and the Global Financial Crisis in 2008, the current turmoil on Wall Street is a result of clear-headed policy choices made by a government that would have known this kind of outcome was distinctly possible, if not highly likely.

Many analysts reckon this

hasn't been seen before. Some of the economic and market numbers that have been seared into investors' consciousness this week haven't been seen for a long time either. Economists at Barclays now

reckon U.S. inflation will exceed 4% this year while GDP will contract in the fourth quarter, a move "consistent with recession".


The rest of the world won't escape the pain. Economists at Citi say up to one percentage point will be knocked off euro zone growth this year, pushing the bloc to the brink of recession, while China could suffer a similar blow to its GDP growth, which they say was already slowing to sub-5%.


With global demand set to suddenly slow, if not contract, oil prices Friday slumped more than 6% for a second straight day. Brent crude futures hit a four-year low near \$62 a barrel, and are now down 26% from a year ago.

And last, but by no means least, for a brief moment on Friday the benchmark twoyear Swiss government bond yield fell below zero. Granted, it is Switzerland, where official rates are just 0.25%. But there aren't many clearer signs that investors are worried. Markets will be closed at

the weekend but the lines of communication between policymakers around the world will very much be open, as governments frantically try to de-escalate the global trade war and central bankers weigh up their policy response. Monday promises to be another rocky ride.







































































# DC break 15-yr jinx at Chepauk Rajasthan Royals spoil Punjab's homecoming


The Indian pugilist adopted a cautious approach at the start against Olympian Traore but was always on the lookout for the counterattack.

Munich, April 5: Thomas Muller will end his "incredible journey" with Bayern Munich this summer after 25 years at his boyhood club.

The 35-year-old midfielder, whose contract is set to expire after the season, made the announcement Saturday in a joint statement with Bayern.

Muller has helped Bayern win a record 12 Bundesliga titles and two Champions League crowns — 33 trophies in total, the team said. But his playing time has been limited recently.

"It's clear that today is not like any other day for me," Muller said. "My 25 years as an FC Bayern Munich player will come to an end in the summer. It's been an incredible journey, shaped by unique experiences, great encounters and unforgettable triumphs.
