ADR moves top court challenging Bihar electoral roll revision

NEW DELHI: The Association of Democratic Reforms (ADR) has moved the Supreme Court, challenging the Election Commission's direction for a Special Intensive Revision, or SIR, of electoral rolls in Bihar. The EC June 24 issued instructions to carry out an SIR in Bihar, apparently to weed out ineligible names and ensure only eligible citizens are included in the electoral roll. Bihar goes to the polls later this year. The NGO has sought the setting aside of the order and communication, arguing that it violates Articles 14, 19, 21, 325, and 326 of the Constitution, as well as provisions of the Representation of People's Act, 1950, and Rule 21A of the Registration of Electors Rules, 1960. **P8**

Telangana factory blast: Odisha workers' death toll rises to 9

BHUBANESWAR: The death toll of workers from Odisha in the explosion at the chemical factory in Telangana rose to nine, with authorities confirming the identity of one more person using DNA-based analysis, an officer said Saturday. The latest victim of the factory blast was identified as Purna Chandra Sahu, a native of Sukrapada in Cuttack district, said Pritish Panda, Officer on Special Duty (OSD), Directorate of Odisha Parivaar. With his death, a total of nine people from Odisha were killed in the powerful blast at a pharmaceutical plant in Pashamylaram in Telangana's Sangareddy district June 30.

PNB fraud: Nirav Modi's brother arrested in US

New Delhi, July 5: US authorities have arrested fugitive diamondaire Nirav Modi's younger brother, Nehal Modi, following extradition requests from the Enforcement Directorate (ED) and the Central Bureau of Investigation (CBI), officials said Saturday.

Nehal Modi, who is the subject of a Red Notice issued by the Interpol, was taken into custody Friday. US officials told Indian authorities.

The next hearing in the matter is scheduled for July 17, during which Nehal Modi, a Belgian national, may seek bail -- a move expected to be contested by US prosecutors, the officials said.

The arrest stems from a joint extradition plea submitted by the ED and the CBI.

The proceedings, led by US federal prosecutors, are based on two charges -- one count of money laundering under Section 3 of the Prevention of Money Laundering Act (PM-LA) and one count of criminal conspiracy under Sections 120B (criminal conspiracy) and 201 (disappearance of evidence) of the Indian Penal Code. **P9**

Brothers back in arms

In a move that has sent jitters to the ruling BJP-Shiv Sena (Shinde faction)-NCP Mahayukti government in Maharashtra, Thackeray cousins Uddhav and Raj united at a public rally in Mumbai following a separation that spanned over two decades. The Awaj Marathicha (Voice of the Marathi) rally was jointly called by Shiv Sena (UBT) and Maharashtra Navnirman Sena (MNS) as a sign of 'victory' following the recent rollback of a controversial policy mandating Hindi as the third language in the state's primary schools. In fact, the Hindi-must decision of the Devendra Fadnavis-led government served the ground for the reunion of the estranged cousins who had strongly, though separately, opposed it. During his speech at the rally, Raj -- a sharp-witted cartoonist - in a lighter vein credited Fadnavis for bringing them together which even Bal Thackeray couldn't do. Nevertheless, with elections to the cash-rich Brihanmumbai Municipal Corporation (BMC) approaching, the development is being seen as more than just the alienated cousins

coming together for a cultural protest, but also a crucial move that will reshape Maharashtra's future political landscape

Mumbai, July 5: Shiv Sena (UBT) chief Uddhav Thackeray Saturday said he and MNS head Raj Thackeray have come together to stay united as the cousins shared a political stage for the first time after two decades on the issue of Marathi identity and 'imposition' of the Hindi language.

Addressing a 'victory' rally in Worli here to celebrate the rollback of the Hindi language GRs (resolutions) by the BJP-led government, Uddhav hinted at contesting the upcoming civic elections together.

"We have come together to stay together. We will together capture power in the Mumbai civic body and Maharashtra," he said, evoking loud cheers from the crowd in the packed NSCI Dome.

The elections to the high-profile civic body in Mumbai, which Sena considers its cita-



del and homeground, and other municipal corporations are due in coming months.

Speaking ahead of Uddhav, the only person seated on the stage, Raj quipped that Chief Minister Devendra Fadnavis has managed to do what Shiv Sena founder Balasaheb Thackeray and others couldn't by bringing the two cousins together.

After he quit Shiv Sena in 2005 over apparent differences with his cousin, Raj Thackeray formed the MNS and has been projecting it as the true champion of the cause of the sons-of-

the soil.

The parties, led by the cousins, had since contested elections against each other notwithstanding the intermittent calls for reunion raised by certain quarters.

As the BJP expanded its footprint on the political landscape of Maharashtra and joined hands with Eknath Shinde, who split Shiv Sena in 2022, and NCP, the chorus for the reunion of the Thackeray brothers grew shriller over the last four months.

The state government's flip-flop on the three-language policy and the introduction of Hindi as a third language provided a much-needed common cause.

On Saturday, the political rancour seems dissipated, at least on the face of it, into the bonhomie at the event.

The coming together of the estranged cousins-turned-comrades has not only enthused cadres of both parties, but it could also give a lifeline to both parties, which are struggling to regain their footing after drubbings in the Assembly polls last year.

Keonjhar tribal woman raped twice in a fortnight; one held

Keonjhar, July 5: A 25-year-old runaway tribal woman was allegedly raped twice by a youth in Keonjhar town in around a fortnight's time on the pretext of helping her get some work to earn a living, police said.

The accused, identified as Sanjay Parihar, 25, a native of Khudapasi village under Pandapada police limits in the district, was arrested after the survivor, accompanied by social activists of Sakhi-One Stop Centre, lodged a complaint Friday evening. It is alleged that she was raped June 19 and July 2.

Town police station IIC Srikantha Sahu said a case (445/25) was registered in this connection, and the accused produced in the court Saturday. Further investigations are on, he added.

According to the complaint, the survivor from Telkoi police station area ran away from her home in anger a month back following a family quarrel, and reached Keonjhar town. She was roaming alone in the area and used to sleep on the verandah of

a shop in Kashipur Sahi at night.

Meanwhile, she came in contact with Sanjay who sought to know her name, address and the reason behind roaming alone in the town. After hearing her problem, he assured to get her a job so that she could earn a living. Since then, he met her on a regular basis, police said.

On June 19, Sanjay allegedly took her to an abandoned house in the locality and raped her. He even threatened to kill her if she disclosed the matter before others. Fearing for life, she chose to remain silent, police said. Taking advantage of her vulnerability again, Sanjay July 2 night gagged her, took her to the same spot and raped her.

When the shocked survivor was wandering around aimlessly after the incident, members of Sakhi-One Stop Centre, an organisation running under 'Prakalpa' - a non-profit in Keonjhar - spotted her. They rescued her and enquired about her problems. During counseling, she narrated her ordeal before the members.

Dalai Lama hopes to live beyond 130 years

Dharamshala, July 5: The Dalai Lama Saturday put to rest rumours surrounding the announcement of his successor, saying he hopes to live for another 30-40 years more to serve people.

Speaking at the long life prayer ceremony ahead of his 90th birth anniversary Sunday at Tsuglagkhang, the main Dalai Lama temple in McLeodganj, Tenzin Gyatso said that he has 'clear signs and indications' that the blessings of the Avalokiteshvara are with him.

"Looking at the many prophecies, I feel I have blessings of the Avalokiteshvara. I have done my best so far. I hope to still live for 30-40 years more. Your prayers have borne fruit so far," the Tibetan spiritual leader said.

The Dalai Lama's birth anniversary celebrations Sunday will be attended by Cabinet ministers Kiren Rijiju, a practising Buddhist, and Rajiv Ranjan Singh.

Arunachal Pradesh Chief Minister Pema Khandu, Sikkim Chief Minister Prem Singh Tamang, and Hollywood actor Richard Gere are slated to attend the ceremony.

On Saturday, the Dalai Lama said that ever since he was a child, he had the feeling that he had a strong connection with Avalokiteshvara.

"And I have been able to serve the Buddha dharma and the beings of Tibet so far quite well. And still I hope to live over 130 years," he said.

The Tibetan government-in-exile has organised a weeklong series of events to celebrate the birth anniversary of the 14th Dalai Lama here.

The Dalai Lama said that though the Tibetans have lost their country and are living in exile in India, he has been able to 'benefit beings quite a lot.'

"Those living here in Dharamshala. I intend to benefit and serve beings as much as I can," he said.

Chinese leader Mao Zedong, who famously said: "Religion is poison."

"...but I didn't respond to him, so he actually cast a very evil gaze, but I didn't respond. And I felt compassion. Then later I met Nehru. Throughout my life, I have met people who have an interest in religion and those who don't have an interest in religion," the spiritual leader said.


The rumours of an announcement of the Dalai Lama's successor have been making rounds since days ahead of his 90th birth anniversary, which have since been refuted in light of increased tension with China on the matter.

Penpa Tsering, the president of the Central Tibetan Administration, rejected such rumours by saying, "It doesn't happen like that."

"Some are talking as if his holiness is going to die tomorrow or the day after or next year or something. He says he's going to live for another 20 years. So we

have to understand the tradition. I think a lot of people came expecting this. His holiness might appoint somebody, or he might say that I'm going to be born in this place at that time. It

doesn't happen like that," Tsering said.



whenever I have the time. Don't have the time, don't worry. The more you're with it, I have found that it gives you something back in return".





Lakhs participate in Bahuda Yatra

Bhubaneswar, July 5: Lakhs of devotees soaked in spiritual fervour took part in the Bahuda Yatra (return car festival) of Lord Jagannath and His siblings, Lord Balabhadra and Devi Subhadra, in the pilgrim town of Puri Saturday.

The day began with performance of daily rituals of the deities, including Mangal Arati, Mailum, Tadap Lagi, Abakash, Surya Puja, and Rosa Homa. The deities were dressed in fresh attire and offered Gopal Bhog before the ceremonial Pahandi (procession).

Daita servitors prepared the deities for Pahandi by adorning them with traditional body armours. The deities were then ceremonially escorted from the sanctum sanctorum of Gundicha temple in Dhadi Pahandi to mount their respective chariots.

The procession began with Lord Balabhadra, followed by Devi Subhadra, and finally Lord Jagannath. As soon as Lord Jagannath emerged from the Nakachana Dwar of the Gundicha temple, the air reverberated with chants of 'Jai Jagannath' and 'Haribol'.



Devotees jostled for a glimpse of the Lord, who appeared majestic with a bouncing 'tahia' atop his head, entralling the crowd with divine splendour.

The Pahandi completed by 12:30pm—two hours ahead of time.

The administration undertook meticulous planning to ensure the smooth conduct of the Bahuda Yatra.

Crowd management was enhanced with revamped traffic arrangements and a fully-operational command and control centre.

Deputy Chief Minister Pravati Parida, Law Minister Prithviraj Harichandan and Health Minister Mukesh Mahaling were in Puri to oversee the arrangements.

Chief Minister Mohan Charan Majhi said, "With the blessings of Mahaprabhu, the Bahuda Yatra is proceeding smoothly." He informed that over 25,000 security personnel have been deployed, along with adequate traffic police to manage the vehicular traffic.

The deities will remain on their respective chariots until they re-enter the main temple Tuesday. On Sunday, the Suna Beshha will be performed, followed by Adharpana, a ritual offering of a special drink Monday. The ceremonial return to the sanctum, known as Niladri Bije, will take place Tuesday.

Thereafter, servitors attached wooden horses to the chariots, and the pulling of the chariots commenced.

Pulling of Taladhwaaja, the chariot of Lord Balabhadra, began at around 3:25pm, Darpadalana, the chariot of Devi Subhadra, at 4:00pm and Nandighosha, the chariot of Lord Jagannath, at 4:15pm.

Taladhwaaja was the first to reach the Singhadwar, followed by Darpadalana and Nandighosha.

During the return journey, Lord Jagannath made a customary halt near the Mausima Temple to partake Poda Pitha. Lord Jagannath, on his Nandighosha, halted near the royal palace for the Laxmi-Narayana Bheta ritual performed by the Gajapati and assisted by servitors.

Robust digital platform soon for monitoring piped water schemes

Bhubaneswar, July 5: A robust digital platform is being developed to enable real-time monitoring of mega piped water supply schemes in Odisha, officials supply said Saturday.

This was revealed during a high-level meeting at Lok Seva Bhawan to strengthen inter-departmental coordination for the implementation of mega piped water supply projects in Odisha.

The meeting, chaired by Development Commissioner Anu Garg, reviewed the status of ongoing projects and emphasised that all departments must solve pending implementation issues within a month.

To support this, weekly or fortnightly joint reviews will be conducted, and a dedicated WhatsApp group of nodal officers has been created to enable real-time coordination.

The Development Commissioner highlighted the importance of adopting modern technology to improve operations and maintenance.

The meeting was informed that a robust digital platform is being developed to enable real-time monitoring of mega piped water supply schemes. Initially, the platform will integrate SCADA systems installed in mega projects and will gradually expand to include Internet of Things (IoT) systems for smaller schemes.

In order to ensure effective field-level management, it was decided to establish project management units at the district level for oversight of operations and maintenance activities. In parallel, self-help group members will be trained in water quality monitoring techniques, including the use of field testing kits, safe sampling, and real-time reporting through the Jal Jeevan Mission application.

Recognising the need to shift from an infrastructure-centric approach to a service delivery-oriented model, the meeting underscored the importance of institutional restructuring.

The state government will study best national practices and prepare a proposal to realign its organisational structure for efficient, responsive, and sustainable rural water supply management, it was learnt.

To address recurring damages to pipeline infrastructure caused by civil works executed by other agencies, the meeting supported the state government's proposal to issue a government resolution mandating prior excavation intimation through platforms like CBUd. It also recommended GIS-based mapping of pipeline assets to minimise risk and improve accountability.

The meeting concluded with a collective call for sustained and coordinated efforts across departments to ensure universal, reliable, and safe drinking water supply to all rural households in Odisha.

Senior officers including secretaries, engineer-in-chiefs, and technical heads from Panchayati Raj & Drinking Water, Rural Development, Works, Forest, Environment and Climate Change and Energy departments, and representatives from the National Highways Authority of India participated in the deliberations.

Govt withdraws restrictions on 3 private banks

Bhubaneswar: The Odisha government Saturday withdrew the restrictions on three private banks and allowed them to handle state business. The government had June 21 removed HDFC Bank, ICICI Bank, and Axis Bank from the list of empanelled banks due to their poor performance in handling state-run schemes and on the basis of general banking parameters. The decision to withdraw the previous order was taken after senior officials of the banks met Chief Minister Mohan Charan Majhi July 1 and submitted written assurance to improve their performance in priority sector lending and credit-to-deposit ratio, an order said. "In view of this, the state government has now decided to withdraw its earlier order dated June 21. As a result, these three banks will now continue as empanelled banks eligible to handle business and deposits of state government organisations," it said.

Naveen seeks EAM's help for safe return of 'abducted' youth

Bhubaneswar/Berhampur, July 5: BJD chief Naveen Patnaik Saturday sought the personal intervention of External Affairs Minister (EAM) S Jaishankar for the early and safe release of an Odisha resident allegedly abducted by militants in Mali.

Patnaik sought Jaishankar's intervention after P Venkatraman's mother lodged a complaint at a local police station in Hinjili, Ganjam district.

Venkatraman, 28, is a resident of Patnaik's Assembly constituency from which he has been elected for six consecutive terms since 2000.

Taking to X, Patnaik said, "Concerned to know that Panad Venkat Raman of Hinjilicut block of Ganjam

district has been kidnapped by extremists in the African Country Mali. He has remained incommunicado since then, leaving his family in deep agony. Request Union Minister (@MEABharat) Shri @DrSJaishankar to personally intervene in the matter and secure his early and safe release."

The incident came to light after Venkatraman's mother P Narasama Friday lodged a police complaint stating that she could not contact her son, who works at a cement factory in Mali, an official said.

"I am very much worried about the fate of my son. I request the government for his safe release," said Narasama, a widow.

Odisha launches statewide disinfection campaign

Bhubaneswar, July 5: In a proactive measure to prevent waterborne and vector-borne diseases, the state government has launched a special state wide disinfection and cleanliness drive, with a focus on high-risk districts.

The initiative is being carried out jointly by the departments of Health and Family Welfare and Panchayati Raj and Drinking Water.

The week-long campaign, continuing till July 11, will cover all villages, health facilities, public spaces, drinking water sources, and commonly used water bodies.

On the first day itself, the state disinfected 55,009 tube



wells, 77,334 dug wells, 98,009 piped water supply points, 4,823 overhead tanks and sumps, and 1,120 other water sources such as ponds and streams.

Additionally, 4,436 health facilities underwent deep clean-

ing, 10,251 OT water samples were tested for quality, and 5,18,413 ORS packets along with 7,47,836 halazone tablets were distributed. Over 12,155 villages and hamlets completed local cleanliness drives on the

same day. PRI members, village communities, local leaders, and grassroots volunteers are actively participating to protect public health and curb seasonal outbreaks.

To ensure effective execution and monitoring, 18 special drive teams comprising senior officers have been deployed. Each officer is assigned two districts for field-level supervision, focusing on the prevention of acute diarrheal diseases malaria, and dengue.

A standardised, checklist-based approach is being used to ensure uniform implementation and accountability in public health interventions across all districts, official sources said.

Pradhan urges HAL to offer aerospace courses

Bhubaneswar: Union Education Minister Dharmendra Pradhan Saturday urged Hindustan Aeronautics Limited (HAL) to introduce diploma and undergraduate courses in aerospace, defence, and allied sectors. "The HAL, in collaboration with IIT Madras, and partner with the Central University of Odisha, Koraput could offer these courses. Such initiatives would foster innovation at the school level and help create a pool of skilled human resources with advanced knowledge in aerospace engineering," the Union Minister said. Pradhan made the proposal during his visit to the Sunabeda-based public sector enterprise HAL. He also stressed the need to establish HAL STEM (Science, Technology, Engineering and Mathematics) education labs in schools across the districts of Koraput, Malkangiri, Nabarangpur and Rayagada.

War, politics & religion shape urban wildlife

Many people imagine evolution as a slow, natural process far removed from human society. But in cities, evolution is directly influenced by human activity — and cultural forces like religion, politics, and even war are quietly reshaping the genetics of urban wildlife.

A recent global review by evolutionary biologists Marta Szulkin, Colin Garroway, and others examined how cultural practices across continents drive evolutionary changes in city-dwelling animals.

Culture leaves a mark

Urban areas dramatically change natural habitats, isolating wildlife populations and creating new environmental pressures. Over time, these changes lead to genetic shifts. For instance, when people divide landscapes — by building roads, walls, or cities — wildlife gets cut off from other groups. These isolated populations then evolve independently, a process known as genetic drift.

One striking example comes from Oviedo, Spain, where religious buildings were walled off between the 12th and 16th centuries. Fire salamanders on either side of the walls became genetically distinct, showing how built structures rooted in culture can lead to evolutionary divergence.



Religious practices and wildlife

In many parts of the world, religious customs also affect urban ecosystems. A notable case is prayer animal release, a Buddhist tradition where captive animals are freed to generate good karma. While the practice is spiritually meaningful, it often introduces non-native species into urban habitats. These newcomers may compete with or displace native wildlife and reduce local biodiversity.

Even local animal releases can have negative impacts. Capturing and releasing wildlife diminishes existing populations, lowers genetic diversity, and weakens their ability to adapt to future challenges.

Political decisions with ecological impact

Political agendas also leave deep evolutionary footprints. During China's "Four Pests" campaign in 1958, sparrows were eliminated alongside rats, flies, and mosquitoes. Their absence caused a spike in crop-eating insects, contributing to famine and ecological imbalance.

In the United States, racial politics and urban planning have fragmented habitats. Highways built through marginalized communities have restricted the movement of animals like bobcats and coyotes, leading to genetically distinct urban populations, similar to

the salamanders in Spain.

Wildlife in times of war


War is another powerful force. In Ukraine, ongoing conflict has disrupted the migration of greater spotted eagles, forcing them to take longer, energy-draining routes. Local people, facing fuel shortages, have turned to nearby forests for wood, altering those ecosystems and impacting species that rely on them.

Interestingly, post-war landscapes sometimes become wildlife refuges. The demilitarized zone (DMZ) between North and South Korea, heavily guarded since 1953, has evolved into a safe haven for many endangered species. Similarly, the collapse of the Soviet Union led to the creation of the European Green Belt, a 12,500 km wildlife corridor that promotes biodiversity across 24 countries.

Evolution in human shadows

These examples show that evolution doesn't happen in isolation — it happens alongside human stories. Religion, war, and politics alter the environment and, in turn, the path of wildlife evolution. Understanding these connections is crucial to building cities that support both human needs and ecological health.

Hirakud dam set to release year's first floodwater today

Sambalpur, July 5: The Hirakud dam authorities are all set to discharge the first floodwater of the year from the reservoir Sunday at 10am, sources said.

Due to heavy rainfall in the upper catchment areas of the Mahanadi and its tributaries, the water inflow into the reservoir has been steadily increasing. In view of this, the Chief Engineer and Basin Manager of the Mahanadi basin have decided to begin the discharge of excess floodwater through the sluice gates from Sunday morning.



Initially, six to eight sluice gates will be opened in a phased manner, depending on the volume of water inflow. However, the exact number of gates to be opened may change based on real-time inflow conditions, according to the dam authorities.

As is customary every year, a ceremonial event will be held at the dam control room before the gates are opened. The ritual will include traditional rituals after which an invited guest will press the switch to initiate the gate-opening process.

To ensure public safety, sirens will be sounded at five-minute intervals starting one hour before the discharge to alert residents living along the banks of the Mahanadi and its tributaries.

Kendrapara admin starts verification of suspected Bangladeshi infiltrators

Kendrapara, July 5: The Kendrapara district administration has carried out verification of documents of 26 suspected Bangladeshi infiltrators residing in the district. They were being kept at a temporary detention centre.

Official sources said while 16 of suspected Bangladeshi infiltrators were from Kereragada and Gopalpur villages in Rajnagar area, two Bangladeshi nationals were rounded up from Rajendranarayanpur and Rangani villages within Talachua Marine police limit.

One suspected Bangladeshi infiltrator was from Batighar area and six others were from Jamboo Marine police limit.

The document verification of 19 suspected Bangladeshi immigrants has been going on by the Revenue department and police. Six more suspected Bangladeshi infiltrators of Jamboo area came to the detention centre Friday to prove themselves as Indian citizens.

The district administration has provided the list of suspected Bangladeshi infiltrators to the police and directed them to go to their house and bring them to the detention centre along with their valid documents to prove themselves that they were Indian citizens.

Police personnel have been deployed at the temporary detention centre by the district administration which has also declared the surroundings of the detention centre as a prohibited zone.

Kendrapara District Collector Smruti Ranjan Pradhan refused to disclose anything in this regard citing the strict direction issued by Home department and state government not to disclose



or share any information related to the Bangladesh infiltrators.

The verification of suspected illegal Bangladeshi settlers started in this coastal district after Chief Minister Mohan Charan Majhi, during his visit to Kendrapara June 9, directed the district administration to take strict legal action against illegal Bangladeshi immigrants.

According to official statics, a total of 3,738 Bangladeshi infiltrators were identified in the state.

Among them 1,551 in Kendrapara were served the quit India notices January 15, 2005, but they are yet to be deported.

According to sources, the Bangladeshi immigrants have infiltrated into the coastal Kendrapara district in two phases.

The influx of Bangladeshi nationals had started in the year 1947 during the partition of Bangladesh and it became more pronounced after the Bangladeshi Liberation war in 1971.

In the year 1956, nearly 1,250 Bangladeshi immigrants were rehabilitated as registered refugees and resettled in the coastal pockets of Rajnagar Assembly constituency.

Most of the Bangla immigrants are coming from the districts of Jashore, Khulna, Barisal and Faridpur of Bangladesh.

Rayagada: 2 constables die in separate incidents

Rayagada, July 5: Two police constables on duty for the Bahuda Yatra in Rayagada died in separate incidents Saturday casting a pall of gloom over the district police force.

In the first incident, Labanya Ganta, 24, a woman constable from Khedapada panchayat, died in a road accident at Gunakhala Chhak under Chandili police limits. She was reportedly on her way to Shradha Srikhetra in Rayagada for festival duty when the scooter she was riding was rear-ended by a truck.

Eyewitnesses said the collision occurred as the scooter slowed near a speed breaker, causing Labanya to fall and be run over by the truck. She died on the spot. A motorcycle coming from the opposite direction also collided with the scooter. The two bike riders—Kantarao Kadra and Subbarao Kadra, both 40 and residents of Munigaon village—sustained serious injuries and are undergoing treatment at the District

Headquarters Hospital. Police have seized the truck and launched an investigation.

Meanwhile, another constable Tarini Charan Gamang, 50, collapsed and died while on duty at Tehsil Chhak on National Highway 326. Gamang, a resident of Lakshmunguda village under Padmapur police limits, had joined the force in 1997 and was serving at Doraguda police station. He was also deployed for Bahuda Yatra duty in Rayagada.

He reportedly felt unwell and collapsed while managing traffic. Fellow officers rushed him to the District Headquarters Hospital, where doctors declared him dead.

Senior officials, including SDPO Gourahari Sahu, RI Kabibar Dehuri and Town IIC Prasanna Kumar Behera, visited the hospital. Colleagues remembered Gamang as a disciplined and sincere officer.

The back-to-back deaths have left the Rayagada police department in mourning on a day meant for religious celebration.

Pradhan lays foundation stone for ₹479.92 crore infra projects at CUO

Youth killed in jumbo attack

Keonjhar: An 18-year-old youth was killed in an elephant attack while driving away a herd that had strayed into Mohanta Sahi of Udayagiri village under Telkoi forest range in Keonjhar district Friday night. The victim was identified as Akash Mohanta. Sources said a herd of six elephants strayed into Udayagiri village Friday. Alarmed, villagers including Akash tried to drive the elephants away. Meanwhile, a female elephant picked him on its tusk and battered him to the ground. Forest officials rushed a critically injured Akash to Telkoi Community Health Centre and later to the Keonjhar District Headquarters Hospital where he succumbed during the treatment. Telkoi Range Officer Shivaji Mohan Rao said that the incident took place at 3am and the officials had driven away the herd to a nearby cashew orchard. However, the incident took place when locals tried to drive away the elephants elsewhere from the orchard. The survivor of the deceased will get a compensation of ₹10 lakh as per the government norms, he added.

World's tallest chariot halted due to rain; pulling to resume today

Keonjhar, July 5: The world's tallest chariot of Sri Baladevjeev was stopped mid-way ahead of Galagandi during the Bahuda Yatra Saturday here due to heavy downpour. Thousands of devotees had gathered to witness the grand return procession of the deity to the Sri Baladevjeev temple in Keonjhar.

Sub Collector Umashankar Dalei, also the Executive Officer of the En-

dowment department, confirmed that the chariot pulling will resume at 9am Sunday and the Suna Besha of the deity will be held in the evening.

The traditional rituals were conducted Saturday despite the rain, with the deities being taken in 'Dhadi Pahandi' to the chariot. Rajasahib Dhananjaya Narayan Bhanjdeo performed the ceremonial 'Chhera Pahanra' before the chariot began its journey around 5:15pm. However, the chariot veered to the left and got stuck due to slippery conditions and fading daylight, prompting authorities to pause the procession to avoid mishaps.

Pujapandas and sevayats including Rajpurohit Prasanna Kumar Nanda, Brahma Gangadhar Mishra, and others ensured the smooth execution of the rituals. Pahandi sevaks from different areas contributed to the procession.

Police have been deployed for crowd management and traffic control. After the chariot's arrival at the temple, barricades and watchtowers will be set up to maintain order during Suna Besha, which is expected to draw lakhs of devotees.

Various local organisations have been mobilised to assist the devotees during the festivities.

ABDUCTION OF INDIAN WORKERS IN MALI

Unable to contact son: Ganjam woman

Berhampur, July 5: A woman in Ganjam district has moved police stating that she is unable to contact her son, who is working at a cement factory in the West African country of Mali, an official said Saturday.

P Narasama, a resident of Samarajhol village under Hinjili police station limits, said she is worried about her 28-year-old son P Venkatraman working in a cement factory at Kayes in Mali after getting the news about the abduction of three Indians working at a cement factory in the West African country.

"I am very much worried about the fate of my son. I requested the government for his safe release," said Narasama, a widow.

She informed the police at Hinjili Friday evening about the incident and also requested the safe return of her son.

"We are closely coordinating with the Ministry of External Affairs (MEA) and concerned Indian Embas-

sy about the incident and waiting for their response," Vishal Gagan, Principal Resident Commissioner, Odisha at New Delhi, told PTI over phone.

After getting social media clip about the alleged abduction of a youth from Odisha, the Resident Commissioner in Delhi has moved the Indian Embassy in Mali for needful action at their end, he said.

Narasama said she last talked to her son over phone June 30. Since then, his phone has been switched off. Narasama said she got a phone call Thursday at about 11am from his son's parent company who informed that her son was now under police custody and told her not to be worried.

"We are very much worried about Venkatraman as he might be held hostage by terrorists. The government should take immediate steps for his safe return," said M Ram Krishna, one of his relatives.

India Wednesday expressed serious

concern over the abduction of three of its nationals in Mali amid a wave of attacks in the West African country.

The Ministry of External Affairs (MEA), in a statement July 2, said,

"The incident occurred July 1 when a group of armed assailants carried out a coordinated attack at the factory premises and forcibly took three Indian nationals as hostages."

"The government of India unequivocally condemns this deplorable act of violence and calls upon the government of the Republic of Mali to take all necessary measures to secure the safe and expeditious release of the abducted Indian nationals," the MEA statement said.

Meanwhile, BJD chief and Hinjili MLA Naveen Patnaik Saturday sought the personal intervention of External Affairs Minister S Jaishankar for the early and safe release of Venkatraman.

Politics of Philosophy

The BJP's constitution (Article 3) says, "Integral Humanism shall be the philosophy of the party." The party's membership form has a pledge which members are required to take. The first line of this pledge is: "I believe in Integral Humanism which is the basic philosophy of the Bharatiya Janata Party." Integral Humanism is a term many Indians are familiar with but few know much about.

Integral Humanism comprises of the text of four lectures given by Deendayal Upadhyaya between 22 and 25 April 1965 in Mumbai. Upadhyaya held a bachelor's degree in arts and was a journalist at the RSS house publication, Panchjanya. He was about fifty when he gave these lectures and became president of the Jana Sangh a couple of years after he delivered them. Let us go through the message of the BJP's philosophy and then another time we can analyse it. What follows is a summary of the argument that Upadhyaya presents in his speeches, and it is presented as neutrally as possible.

The cause of the problems facing Bharat is a neglect of national identity. The nation is like an individual and becomes ill if its natural instincts are disregarded or suppressed. Despite independence, India was still undecided about the direction it would take to realise development. Independence is meaningful only if it is the instrument to express culture.

The focus in India was on episodic problems: economic, social and political. This was because India adopted a Western way of looking at economic, social and political doctrines along with Western science. Westernisation was synonymous with progress for Indians. However, the West was unable to reconcile nationalism, democracy and socialism. These were essentially Western ideals and they were all in conflict with one another. These ideologies were not universal and not free from the limitations of the particular people and cultures which gave birth to these isms. Ayurveda said that we need to find local cures to local diseases. Could Bharatiya culture provide a solution for the world?

It is generally thought that Bharatiya culture thinks of salvation of the soul and does not bother about body, mind and intellect but that is untrue. Dharma is given foremost place in Bharatiya culture. Dharma is the natural law that is eternal and universally applicable. Dharma is higher than the executive, legislative and the judiciary, and it is also higher than the people. If out of 450 million Indians, all except one voted for something it would still be wrong if it was against dharma. The people have no right to act against dharma. The words 'secularism' and 'dharma' used in the Constitution are wrong and bad because dharma is a necessary condition for the State. That which is not based on dharma is unacceptable and therefore secularism was fatally flawed.

National unity is India's dharma and so diversity was problematic. For this reason India's Constitution needs to be changed from federal to unitary with no legislative powers for the states, only for the Centre. Conflict between individuals and institutions of society is a sign of decadence and perversion.

The West was wrong to see the adversarial relationship between the individual and the State as the reason for progress. The individual was made up of body, mind, intelligence and soul. A human being is born with a soul. Personality, soul and character are different from one another. The person's soul is unaffected by personal history. Similarly, national culture is continuously modified by history. Culture includes all the things held as good and commendable, but they do not affect 'chiti', the national soul. India's national soul is fundamental and central. Chiti determines the direction of cultural advance. It filters out what is to be excluded from culture. Societies are animate and a society has a body, mind, intellect and soul. Some Westerners were beginning to accept this truth. One of them, William McDougall said that a group had a mind and a psychology, its own methods of thinking and action just as an individual did.

Societies have an inborn nature that is not based on its history. Events do not affect it. This group nature is like the soul in individuals, which was also unaffected by history. This group mentality is like mob mentality but developed over a longer period. The nation needs both an ideal and a motherland and only then is it a nation. And the State exists to protect this nation, which has an ideal and a motherland.

The difference between India and the West was that we regard the body only as an instrument to achieve dharma. Our efforts were for dharma, artha (money), kama (pleasure) and moksha (liberation). The mistake of the West was to treat the four separately. You could get voting rights but then you didn't get food. The United States had both political freedom and wealth but it also topped the list in the number of suicide and mental patients. This was puzzling — there was bread and voting rights but no peace or happiness. Sound sleep was scarce in America because they had not thought of the integrated human being. The Americans said "honesty is the best business policy" and the Europeans said "honesty is the best policy," but the Indians said "honesty is not a policy but a principle."

This, broadly speaking, is what the BJP says is its basic philosophy. It would be interesting to see how many BJP ministers or members can explain what it means and what it is intended to do. If they believe in it, as they are required to pledge, one would be interested to know what that belief is.

My father's mission underscores what exploration has always meant to my family. It is not about conquest and domination, but rather curiosity and understanding. Studying nature expands not only the frontiers of our knowledge, but also the scope of our responsibility as planetary stewards.

Nor should we use others' failure to address the problem as an excuse for our own inaction. After all, we already know the solutions, and we have the tools to pursue them. What is missing is the will.

At the Solar Impulse Foundation, we have identified more than 1,800 clean and profitable strategies and tools that reconcile economic growth with environmental preservation. Many focus on strengthening regenerative and sustainable practices in the blue economy — from technologies that track illegal fishing and monitor vessel movements from space, to innovations in low-carbon shipping, plastic waste prevention, and regenerative aquaculture.

Our recent Ocean Opportunity Guide, mapping ocean-foc-

used innovation, shows just how broad and mature these solutions are. From bio-enhancing concrete that supports marine life to seaweed-based alternatives to single-use plastic and traceability platforms that eliminate greenwashing in seafood value chains, these are not theoretical models; they are real tools already being deployed around the world. Behind them stands a growing ecosystem of entrepreneurs, scientists, and engineers.

Equally, new financial mechanisms are emerging to bridge the gap between innovation and scale. Blended finance structures, results-based payments, and de-risking vehicles are beginning to unlock capital for nature-based solutions and sustainable aquaculture, particularly in vulnerable coastal economies. These developments show that diverse stakeholders, when aligned, can build an innovation ecosystem capable of solving one of the world's most complex challenges.

The solutions we highlight are tested, scalable, and economically sound. They do more than protect ecosystems; they also create jobs, stimulate new

markets, and reduce long-term operational risk. Clean innovation in the ocean economy is already generating competitive advantages for forward-looking companies and countries. Financial instruments that de-risk nature-based investments are helping to stabilize coastal economies and expand access to new forms of capital. And circular-economy solutions like seaweed-based packaging and marine-life-friendly infrastructure are not only reducing environmental harm, but also lowering material costs and strengthening supply-chain transparency.

In short, ocean preservation is becoming an engine of industrial renewal and geopolitical resilience. As an economic development strategy, it is both future-proof and inclusive, and it appeals to investors, entrepreneurs, and policymakers alike. But to unlock this potential, we must change the narrative. Sustainability is not about sacrifice; it is about modernization, innovation, and efficiency.

Far from an environmental constraint, ocean preservation is a catalyst for a more dynamic, resilient global economy. As such, it should be recognized as the new frontier of exploration. Our task is to discover not uncharted depths, but better systems. Like the entrepreneurs featured in the Ocean Opportunity Guide, we should all be questioning what we have built and considering how it can be improved. The spirit of exploration must guide us toward regeneration, not exploitation. It must inspire us to stop waiting for others, and to start demonstrating the leadership that this moment demands.

Adrift & unanchored ambitions

Post-colonial Indian foreign policy and its non-alignment ideals were shaped by the internationalist values of the anti-colonial struggle—opposing all forms of colonial occupation, militarism, apartheid, neo-colonial economic policies, capitalist and imperialist hegemony. The term Non-Alignment was first used at the United Nations by India and Yugoslavia to describe their refusal to align with either side during the Korean War. This position later evolved into a global forum—the foundation of the Non-Aligned Movement (NAM)—where India was not only a founding member but also provided vital leadership in promoting the principles of decolonisation, socialist development, democratisation, peace and solidarity.

THE MEANDERING FOREIGN POLICY OF INDIA HAS NOT ONLY WEAKENED ITS POSITION WITHIN THE NEIGHBOURHOOD BUT ALSO ABROAD

NAM was not merely a stance against the bipolarisation of global politics into the imperialist power blocs of the Warsaw Pact and NATO, it was also a strong opposition to all forms of capitalist and colonial hegemony. As a global platform representing more than 55% of the world's population, NAM did not advocate for 'neutrality' in international affairs. Rather, it actively opposed colonial, capitalist, and imperialist structures, processes, and institutions, with the goal of promoting democratic develop-

ment and economic prosperity grounded in peace and active opposition to wars and conflicts. These principles fundamentally shaped Indian foreign policy, aligning moral leadership with national interest in the realm of global politics.

In the post-Cold War period, the NAM continued to advocate for multilateralism, equality, and mutual non-aggression—principles that significantly influenced the foreign policy of the Global South. Within this context, India emerged as a major voice of reason and peace, upholding and advancing these ideals on the global stage.

However, the rise of Hindutva politics and its unflinching adherence to US-led imperialist agendas has significantly undermined the independence of Indian foreign policy and weakened the pursuit of genuine national interest. India's close association with Israel and its participation in the US-led Quadrilateral Security Dialogue (QUAD), often described as an emerging "Asian NATO", have eroded India's strategic autonomy and national interest. These shifts, presented under the guise of a "multi-alignment" strategy, have diluted the foundational principles of Indian foreign policy and weakened the NAM. In this transition, India's foreign policy appears to have lost its moral compass—once root-

ed in anti-colonial solidarity, peaceful coexistence, internationalism and global justice—in favour of opportunistic alignments. The current trajectory not only threatens India's historic diplomatic legacies but also compromises the core values that once defined its role on the global stage.

No other Indian Prime Minister has travelled as extensively as Narendra Modi; however, the frequency of a leader's foreign visits does not, in itself, define the values or effectiveness of a country's foreign policy. The meandering foreign policy of India has not only weakened its position within the neighbourhood but also abroad. The "neither here nor there" trajectory of India's foreign policy reflects an opportunistic shift that undermines the core values of India and its historic legacy of solidarity with anti-colonial and anti-imperialist struggles. Indian foreign policy often appears erratic and directionless, lacking a coherent vision or guiding principles. As a result, countries that once regarded India as a reliable and guiding partner in the turbulent waters of global politics no longer place the same trust in its current foreign policy.

For the US and Europe, India is too often seen merely as a vast market, and Indians as passive consumers. Historically, imperialist and capitalist

powers have viewed countries in Asia, Africa, Latin America, and the Middle East not with dignity or mutual respect, but as sources of natural and human resources to be exploited through strategic and self-serving foreign policies.

India needs to distance itself from American imperialists and neo-colonial Europe, which can never be trusted as reliable partners. As Henry Kissinger famously said, "It may be dangerous to be America's enemy, but to be America's friend is fatal." In this context, the foundational values of the NAM remain more relevant than ever. Reviving these principles is essential to restoring the independence of Indian foreign policy and promoting a more democratic and equitable world order—one in which peace and prosperity are shared, not dictated by hegemonic powers driven by American, European, capitalist, and corporate interests.

India must pursue an independent and non-aligned foreign policy that aligns with the interests of its own people as well as those across the globe, in order to reclaim its glory and moral compass. Let Vasudhaiva Kutumbakam (the world is a family) blossom again in India.

Multi-front threats

Sir, This refers to "Chinese Intel kept Pak ahead of India," **Orissa POST**, July 5. Operation Sindoor, conducted against Pakistan, exposed the evolving multi-front threats facing India. While the immediate confrontation was with Pakistan, the operation revealed the deeper strategic collusion involving China and Turkey. Though the Chinese PLA did not engage directly alongside Pakistani forces, credible intelligence indicated logistical and technological support, with Chinese-supplied equipment and surveillance aiding Pakistan. Moreover, the operation served as a testing ground for Chinese ammunition, indirectly making it a laboratory for Beijing's military ambitions. Turkey's involvement, through supply of drones and tactical support, further internationalized the conflict. Ankara's interest in South Asian geopolitics, motivated by its ideological alignments, adds another dimension to India's external threat perception. A growing concern now looms in the east. Bangladesh, once a close partner, is showing signs of strategic alignment with the China-Pakistan axis. Economic investments from Beijing and increasing military cooperation are pulling Dhaka into a new orbit, complicating India's regional calculus. India can no longer afford to prepare for linear threats.

Zoonotic diseases

Sir, The first rabies vaccine was administered by French scientist Louis Pasteur on 6 July, 1885. This brought about a heightened awareness about zoonotic diseases or diseases that are transmitted between animals and human beings. Besides direct contact, insects, ticks and contaminated food can also act as vectors. Anthrax, COVID-19, rabies, brucellosis and bird flu are well known zoonotic infections. While all zoonotic diseases are not transmitted by vectors, a few vector-borne diseases are also zoonotic: malaria and dengue are classic examples. Poor sanitation and hygiene, inadequate food safety measures, and animal habitat encroachment by humans have contributed to the proliferation of zoonotic diseases. Those who are at a higher risk of contracting zoonotic diseases, especially farmers, should be made aware of the risk factors. World Zoonoses Day falls on 6 July.

Challenges aplenty for new Bengal BJP chief

Kolkata, July 5: With the 2026 West Bengal Assembly polls on the horizon, the BJP has placed its bet on soft-spoken RSS loyalist and party veteran Samik Bhattacharya to steer its troubled state unit out of a prolonged phase of internal discord, grassroots disarray and "cultural disconnect" with the Bengali electorate.

But as Bhattacharya, a quintessential Bengali 'bhadralok' takes charge, a key challenge before him is whether the state BJP under his leadership pursues a moderate, inclusive Hindutva line or continues with the combative and hardline posture championed by leaders like Suwendu Adhikari.

A Rajya Sabha MP and one of the BJP's most articulate Bengali faces, Bhattacharya was recently unanimously elected president of the West Bengal unit, a move seen as an attempt to calm factional storms, revive a demoralised cadre and address the growing perception that it lacks cultural connect and ideological clarity in the state.

"The party is above individuals. My focus will be on strengthening the organisation and outreach at all levels. West Bengal deserves a better alternative to the politics of violence, corruption and commu-

nalism pursued by the TMC," Bhattacharya told PTI after taking charge.

Rhetoric alone, however, will likely not suffice, feel political analysts. The BJP in Bengal is confronting serious challenges, both internal and electoral.

In a marked shift in tone, Bhattacharya has sought to position the BJP as an inclusive force, distinct from the strident posturing of some of its leaders.

"The BJP's fight is not against the state's minorities. Young boys in minority households who are roaming around with stones - we want to snatch away the stones and hand them books. We want to take away

their swords and give them pens instead. We envision a Bengal where a Durga Puja procession and a Muharram rally are held side by side without conflict," he had said recently.

The remarks appear to be part of a conscious attempt to win over middle-class urban voters, liberal professionals, and the youth - groups that contributed to the BJP's 2021 Assembly poll setback.

A BJP leader said the party must reflect Bengal's unique political culture.

"We cannot grow in Bengal by alienating communities. If we want middle-class Bengali Hindus, liberal professionals and even silent first-time voters to back us, we have to show we can take along everybody and speak the language of inclusivity," he said. But, not everyone in the party is con-

vinced. "Bengal's voters want clarity. If we confuse them with half-hearted messaging, we lose core and swing voters," said a leader close to Adhikari, the face of the party's aggressive Hindutva plank and Leader of the Opposition.

The minorities comprise nearly 30 per cent of the electorate and are a deciding factor in almost 120 of the 294 assembly seats.

Political analyst Maidul Islam told PTI that Bhattacharya's message signals a shift in the BJP's positioning in Bengal.

"What Bhattacharya said - the BJP is not the enemy of minorities and wants to protect pluralism - is something new for the Bengal unit, and in sharp contrast to what Adhikari and others have said. Whether Bhattacharya can make moderate Hindutva the party's dominant line remains to be seen," Islam said.

The TMC has long accused the BJP of promoting a 'Hindu-Hindu-Hindustan' model, out of sync with Bengal's cultural ethos. Former state BJP president Sukanta Majumdar, however, dismissed such criticism.

"No one has a monopoly on Bengali culture. The BJP represents every Bengali who wants development and dignity," he asserted. The TMC, meanwhile, remains unconvinced. "The BJP is still driv-

en by RSS' Hindi-Hindu-Hindustan ideology. Samik Bhattacharya cannot camouflage it," TMC leader Kunal Ghosh said.

In the 2021 polls, the TMC used Bengali sub-nationalism to counter the BJP's Hindutva narrative, branding it a party of outsiders.

"Bhattacharya's soft-spoken, scholarly image, fluency in Bengali literature and RSS background position him as a bridge between the ideological core and the broader Bengali electorate. However, reclaiming cultural legitimacy for a party often branded an 'outsider force' won't be easy," said Islam.

Another critical issue Bhattacharya faces is infighting. Since the 2021 Assembly poll defeat, factionalism between the BJP's old guards and defectors from the TMC has crippled organisational unity.

"He's not seen as belonging to any camp. That's why Delhi picked him. But to bring everyone together, Samik da will have to assert himself fast. Otherwise, he will be reduced to a rubber stamp," a senior state BJP leader said. In his first address as state chief, Bhattacharya had acknowledged the rift and called for unity.

Political analyst Biswanath Chakraborty believes Bhattacharya's real test lies in energising the party base.

Manipur to shut relief camps by Dec, begins phased resettlement

Imphal, July 5: In a move towards restoring normalcy, the Manipur government has announced plans to close down nearly 350 relief camps housing Internally Displaced Persons (IDPs) by December 2025.

These camps have been sheltering people uprooted by the ethnic violence that broke out in May 2023, displacing over 62,000 individuals.

The announcement was made by Chief Secretary PK Singh as he said the state was now transitioning from emergency relief to long-term rehabilitation, with a structured three-phase plan already underway.

According to Singh, the number of displaced people has dropped to around 57,000, and in districts like Churachandpur and Kangpokpi, families have begun returning to their homes.

The government aims to complete the first phase of the resettlement plan this month, with the second and third phases scheduled for October and December, respectively.

Families unable to return to their original homes by the 2025 deadline will be provided with newly constructed prefabricated housing units.

Construction of an additional 1,000 such units is in progress to accommodate those still unable to safely resettle in their villages.

Financial assistance will be provided under three cat-

egories. The first group comprising around 7,000 families whose homes were destroyed during the violence will receive approximately Rs 1.3 lakh each to rebuild.

A second group of 7,000 people, who fled their homes though their properties were partially damaged, will also receive aid to restart their lives.

The third group, estimated between 8,000 and 10,000 individuals, will be given prefabricated shelters if they cannot return to their original locations by the end of this year.

The chief secretary said the rehabilitation effort is being undertaken in close coordination with the Central government.

He also highlighted ongoing efforts to reopen major highways across the state, a crucial step towards restoring connectivity and public movement.

"With the current pace of progress, we are optimistic that people will soon be able to move freely across major roads in the state," he said.

On the security front, Singh reassured that state police and Central forces have been adequately deployed in vulnerable areas, especially agricultural zones.

"There is a visible improvement. I appeal to all civil society organisations from both sides to maintain calm. Isolated incidents may happen due to disruptive elements, but overall, the situation is steadily improving," he added.

10 MT of organic black pepper shipped from Meghalaya to Mumbai

Zikzak (Meghalaya), July 5: Meghalaya Chief Minister Conrad K Sangma Saturday said 10 metric tonnes of organic black pepper from South Garo Hills region were shipped out to Mumbai, the second big export from the area after an 11 MT of outbound consignment in 2023.

Mumbai-based Everest Spices has procured the organic black pepper from here, he said.

Taking to X, Sangma said, "10 MT of organic black pepper facilitated by the Kerupara and Dingampara Integrated Village Cooperative Societies (IVCS) under Zikzak block, South West Garo Hills, shipped to Mumbai, the area's second big export after 2023's 11-tonne success."

Backed by the Meghalaya Basin Management Agency and Meghalaya Livelihoods and Access to Markets Project, the local co-operatives are turning Garo's organic black gold into a big opportunity, he said.

The growing demand for Meghalaya's organic spices is

encouraging more farmers to tap into its potential, the chief minister said.

The Meghalaya Basin Management Agency and the Meghalaya Livelihoods and Access to Markets Project support grassroots cooperatives in turning small-hold farming into a scalable and market-driven enterprise.

The state currently produces over 22,000 metric tonnes of spices annually, including turmeric, ginger, black pepper, and bay leaf, an official said.

With organic practices gaining momentum, the state is emerging as a key player in India's premium spice segment.

"This is a proud moment for our farmers and a leap forward towards sustainable agri-business," said the official from South West Garo Hills.

It shows that even remote villages can lead in quality, sustainability, and market access, he said, adding that farmers across the Garo Hills are embracing organic farming and collective marketing, transforming the region into a thriving agri-export hub.

Mizoram sees fresh influx of Myanmarese refugees

Aizawl, July 5: A fresh influx of Myanmarese people was reported from Mizoram's Champhai district Saturday after a fierce gunfight broke out between two warring outfits in the neighbouring country, officials said.

Gunfights reportedly took place between two pro-democratic forces, Chin National Defence Force (CNDF) and Chinland Defence Force (CDF)-Hualgoram, at Khawmawi, forcing locals to flee to Zokhawthar village in Champhai.

Khawmawi in Myanmar

and Zokhawthar in India are separated by the Tiau river. The number of people fleeing the gunfight is yet to be ascertained, officials said.

The CNDF and CDF operate in the Chin state, and cadres of the two groups belong to the same Zo ethnic tribes. The two

outfits have been fighting over the last few days over control of the area, they said.

A leader of the Young Mizo Association (YMA) in Zokhawthar said the gunfight has created tension in the border village.

He said the YMA has urged both groups not to point their

arms towards Zokhawthar, as bullets have hit some houses in the village. However, no casualties have been reported so far in the border village, he said.

One person drowned in the Tiau river while fleeing to India, and YMA volunteers were searching for him, he added.

Tipra Motha leader begins foot march to Delhi over infiltration

Agartala, July 5: A leader of the Tipra Motha Party (TMP) Saturday began a long march to New Delhi to urge the Centre to tackle the infiltration issue in Tripura.

The TMP is an ally of the BJP-led coalition government. TMP leader David Murasing said he began the 2,500 km journey on foot from Agartala to New Delhi as a citizen of Tripura to highlight his concern over infiltration.

Murasing is also the zonal chairman of the Tripura Tribal Areas Autonomous District Council (TTAACD) of Bichandramanu in South Tripura district. "Infiltration has been a serious issue in Tripura for 75 years. This is not only Tripura's problem but also a national issue. If the demography of the northeastern state changes further due to infiltration, the country will also face serious challenges," he told reporters. "My mission is to reach New Delhi's Jantar Mantar and submit a memorandum to Delhi seeking stringent measures to stop infiltration," he said.



Murasing said the Centre had promised to fulfil the Tiprasa accord signed between the Central government and the state government (in March 2014) within six months. It has been one year now with no visible outcome forthcoming.

"The Centre might have forgotten the problem of Tripura because of its small geographical area. We are also citizens of the Republic of India. Our problem is the country's problem," Murasing said.

"Infiltration is not all about the possibility of demographic change. It also poses a serious

security challenge to our nation. We want the Centre to handle the infiltration issue with an iron hand to secure our safety and security," he said.

Asserting that TMP supremo Pradyot Kishore Manikya has lent full support to his long march, Murasing said he met Bubagra (King) and sought his blessings.

"Maharaja has full support for my mission. He blessed me. I embarked on a mission as a citizen of the state, not an active member of the party," he said.

Earlier, Chief Minister Manik Saha said that the northeastern state is no longer a 'safe zone' for infiltration due to proactive measures to prevent infiltration from across the border.

'Ulto Rath' festival celebrated across Bengal

Kolkata, July 5: Devotees pulled the chariots of Lord Jagannath, Lord Balabhadra and Devi Subhadra Saturday as the 'Ulto Rath' (Return Car) festival was celebrated across West Bengal with pomp and gaiety.

They congregated in Digha, the coastal town in Purba Medinipur district, where the Rath Yatra of the newly constructed Jagannath temple was celebrated for the first time.

In Digha, around 200 km away from Kolkata, the chariots were pulled from 'Masir Bari' (the place of aunt of three sibling deities) to the new Jagannath temple, covering a 750-metre route.

Thousands of people gathered along Park Street-JL Nehru Road crossing, Moulali, Park Circus 7 Point, Shakespeare Sarani, Hungerford Street, ISKCON temple in Kolkata as the devotees danced to the beat of 'Hare Krishna' and 'Joy Jagannath' when chariots were being pulled.

People made a scramble to touch the ropes to pull chariots of the three deities as the ISKCON (International Society for Krishna Conscious-



ness)-organised religious procession went through key thoroughfares of central and south Kolkata before reaching the Radha Krishna temple on Albert Road.

Return Car procession was also taken out at Mayapur in Nadia district, the global headquarters of ISKCON, where thousands of devotees turned up.

Chariots were also pulled in different parts of the metropolis and elsewhere in the state by religious organisations, and also many households where the idols are worshipped traditionally for years.

New Delhi, July 5: The Association of Democratic Reforms has moved the Supreme Court, challenging the Election Commission's direction for a Special Intensive Revision, or SIR, of electoral rolls in Bihar.

The EC June 24 issued instructions to carry out an SIR in Bihar, apparently to weed out ineligible names and ensure only eligible citizens are included in the electoral roll. Bihar goes to the polls later this year.

The NGO has sought the setting aside of the order and communication, arguing that it violates Articles 14, 19, 21, 325, and 326 of the Constitution, as well as provisions of the Representation of People's Act, 1950, and Rule 21A of the Registration of Electors Rules, 1960.

Advocate Prashant Bhushan, who filed the plea, said the EC order "can arbitrarily and without due process" disenfranchise lakhs of voters and disrupt free and fair elections.

"That the documentation requirements of the directive, lack of due process as well as the unreasonably short timeline for the said Special Intensive Revision of Electoral Roll in Bihar further make this exercise bound to result in removal of names of lakhs of genuine voters from electoral rolls leading to their disenfranchisement," Prashant Bhushan said.

The last such revision in Bihar was conducted in 2003. According to the EC, the exercise was necessitated by rapid

urbanisation, frequent migration, young citizens becoming eligible to vote, non-reporting of deaths, and inclusion of the names of foreign illegal immigrants.

It said that with the exercise, it wants to ensure the integrity and preparation of error-free electoral rolls.

The SIR is being conducted by the booth officers, who are conducting a house-to-house survey for verification.

The EC said it will scrupulously adhere to the constitutional and legal provisions as laid down in Article 326 of the Constitution and Section 16 of the Representation of the People Act, 1950, in carrying out the revision.

'SC report on Justice Varma case has no constitutional relevance'

New Delhi, July 5: Rajya Sabha MP Kapil Sibal Saturday said the Supreme Court's in-house inquiry report in Allahabad High Court Judge Yashwant Varma's case has "no constitutional relevance" as an investigation can only take place under the Judges Inquiry Act.

Addressing a press conference, Sibal also accused the government of protecting Justice Shekhar Yadav and questioned the Rajya Sabha Secretariat over its attempt to reach out to him for the reported verification of his signature on the notice to move an impeachment motion against the judge for making "communal remarks" last year at a VHP event.

On the Justice Varma case, Sibal said, "Under Article 124 of the Constitution, if 50 members of the Rajya Sabha or 100 members of the Lok Sabha submit a notice for moving a motion (for impeachment), then a judges inquiry committee is set up under the Judges Inquiry Act."

But only Parliament has the power to constitute such a committee, said Sibal, who is also a senior advocate.

Parliament can make a law, under that law an investigation will be done, and after the probe, a decision will be given on misbehaviour or incapacity of a judge, he said.

UK-based arms consultant Sanjay Bhandari declared fugitive economic offender

New Delhi, July 5: A Delhi court Saturday declared UK-based arms consultant Sanjay Bhandari a fugitive economic offender on a plea from the Enforcement Directorate (ED), an order that will allow the agency to confiscate all his assets that are worth crores of rupees.

District Judge (Tis Hazari) Sanjeev Aggarwal said in his order the court was satisfied that

"Sh. Sanjay Bhandari, S/o Late Sh. R K Bhandari, is a fugitive economic offender under section 12(1) of the Fugitive Economic Offenders Act, 2018 and is declared as such under the above provision(s) of the Fugitive Economic Offenders Act, 2018".

The order has come as a shot in the arm for the federal probe agency as it will now be able to confiscate assets worth crores of rupees of Bhandari, whose chances to come to India have been virtually nullified after a UK court recently ruled against his extradition.

Bhandari's legal team, while opposing the ED's move to get him declared a fugitive offender, claimed that its "client's stay could not be called illegal in the UK as he has a legal right to reside in the UK and the GOI is bound by the judgment of the UK court.... Bhandari is legally living

there, and declaring him a 'fugitive' in that scenario is legally wrong".

The court said the "extradition attempt may have failed, but it will not make the accused an angel or immune from the prosecution for the violation of Indian laws".

"The FEO proceedings are another way of making one come back to India to face trial by coercing him to return by attachment, confiscation of the properties of such

a fugitive economic offender and proceeds of crime and by disentitling such a fugitive economic offender from putting forward or defending any civil claim," it said.

Therefore, the 100-page order said the Fugitive Economic Offenders (FEO) Act is in the nature of coercion, saying that if one does not come back, the government will confiscate and seize all his assets once he has been shown or declared as a fugitive economic offender, in accordance with the provisions of the Act.

Bhandari (63) fled to London in 2016, soon after the income-tax (I-T) department raided him in Delhi.

Terrorist hideout busted in Poonch

Mendhar/Jammu: Security forces Saturday busted a terrorist hideout in Poonch district of Jammu and Kashmir and recovered arms and ammunition, officials said. The hideout was unearthed during a joint search operation by police and Army in Surankote forests, they said. No one was arrested in the operation. The security forces recovered three hand grenades, 14 rounds of AK assault rifle, six pistol rounds, a wire cutter, a multi-purpose knife, a multi-data cable connector, five pencil cells, an iron rod and a paint box from the hideout, the officials said.

8 killed as SUV collides with wall

Sambhal (UP): Eight people died while two others were injured after their SUV rammed into a wall in Sambhal district of Uttar Pradesh, police said Saturday. Buenos Aires, July 5: Prime Minister Modi Saturday laid a wreath here at the memorial of General Jose de San Martin, regarded as a national hero in Argentina.

José Francisco de San Martín y Matorras is also known as the liberator of the South American nations Argentina, Chile and Peru. PM Modi arrived in Argentina Friday evening on a two-day visit during which he will hold talks with the country's top leadership to review ongoing cooperation and discuss ways to enhance bilateral partnership in key areas.

This is the first Indian bilateral



visit at the prime ministerial level to Argentina in 57 years. It is Modi's second visit to the country as prime minister; he had visited in 2018 for the G20 Summit.

It also marks the third stop on the prime minister's five-nation visit.

Modi will hold wide-ranging talks with President Milei to

further boost India-Argentina partnership in key areas including defence, agriculture, mining, oil and gas, renewable energy, trade and investment, according to the MEA.

"The bilateral visit of the prime minister will further deepen the multifaceted strategic partnership between India and Argentina," it said in a statement ahead of Argentina visit.

In his departure statement, the prime minister said that Argentina is a key economic partner in Latin America and a close collaborator in the G20 and that he looked forward to discussions with President Javier Milei, whom he had met last year.

NIA arrests 2 key men involved in human trafficking to US via 'dunki' route

New Delhi: The National Investigation Agency (NIA) has arrested two key men allegedly involved in trafficking of humans to the US via the infamous 'dunki' route, officials said Saturday. The arrests came after searches at a location each in Himachal Pradesh and Delhi, they said. The accused, Sunny alias Sunny Donker of Dharamshala of Kangra district in HP, and Shubham Sandhal alias Deep Hundi of Ropar, Punjab, who was living in Outer Delhi's Peeragarhi, were arrested on Friday, the NIA said in a statement. Both, the probe agency said, were associates of Gagandeep Singh alias Goldy, who was arrested in March. Gagandeep was arrested on a complaint of a victim, who was trafficked to the US using the dunki route and was deported to India this February.

Death of 5 tigers in Karnataka: Minister suspends 2 officials

Bangalore: Karnataka Forest Minister Eshwar Khandre has suspended two officials for negligence and dereliction of duty in connection with the 'unnatural death' of five tigers in the Male Mahadeshwara (MM) Hills, officials said. The minister has also recommended the suspension of Deputy Conservator of Forests (DCF) Y Chakrapani in connection with the issue, they said. A female tigress and her four cubs were found dead in the Huguam range of the MM Hills June 26. Khandre also recommended departmental inquiries into their conduct. Following the incident, authorities arrested three individuals, including the cow's owner, who allegedly poisoned the cow's carcass, suspected of causing the tigers' deaths.

Centre asks states to crack down on sub-standard helmets

The Department of Consumer Affairs and the Bureau of Indian Standards called for strict enforcement against the manufacture or sale of helmets without BIS certification

New Delhi, July 5: The Centre has asked states to take strict action on manufacturers and retailers selling sub-standard helmets to ensure the safety of two-wheeler riders.

"The Department of Consumer Affairs and the Bureau of Indian Standards (BIS) appeal to consumers across the country to use only BIS-certified helmets," an official statement said Saturday.

The department also called for strict enforcement against the manufacture or sale of helmets without BIS certifi-

cation, it added.

"With over 21 crore two-wheelers on Indian roads, rider safety is paramount," the department said, adding that wearing a helmet is mandatory under the Motor Vehicles Act, 1988.

It pointed out that the sale of sub-standard helmets compromises safety. A Quality Control Order has been in force since 2021, mandating ISI-marked helmets certified under BIS standards for all two-wheeler riders.

As of June 2025, there are 176 manufacturers across India holding valid BIS licenses



for protective helmets. "The Department has ob-

served that many helmets sold on roadsides lack the

mandatory BIS certification, posing significant risks to consumers and numerous fatalities in road accidents," the statement said.

To enforce quality standards, the BIS conducts regular factory and market surveillance. During the last fiscal year, more than 500 helmet samples were tested, and more than 30 search-and-seizure operations were carried out for misuse of the BIS Standard Mark.

In one Delhi operation, over 2,500 non-compliant helmets were seized from 9 manufacturers with expired or cancelled licences.

Similar action at 17 retail and roadside locations led to the seizure of around 500 substandard helmets. Earlier, the Department of Consumer Affairs had written to District Collectors (DCs) and District Magistrates (DMs) to launch a nationwide campaign and take stern action against manufacturers and retailers who sell non-compliant helmets for two-wheeler riders.

BIS branch offices were instructed to engage continuously with district administrations and police departments to support this campaign.

New Delhi, July 5: US authorities have arrested fugitive diamondaire Nirav Modi's younger brother, Nehal Modi, following extradition requests from the Enforcement Directorate (ED) and the Central Bureau of Investigation (CBI), officials said Saturday.

Nehal Modi, who is the subject of a Red Notice issued by the Interpol, was taken into custody Friday, US officials told Indian authorities.

The next hearing in the matter is scheduled for July 17, during which Nehal Modi, a Belgian national, may seek bail -- a move expected to be contested by US prosecutors, the officials said.

The arrest stems from a joint extradition plea submitted by the ED and the CBI.

The proceedings, led by US federal prosecutors, are based on two charges -- one count of money laundering under section 3 of the Prevention of Money Laundering Act (PMLA) and one count of criminal conspiracy under sections 120B (criminal conspiracy) and 201 (disappearance of evidence) of the Indian Penal Code.

Nehal Modi (46) is an accused in the alleged ₹13,000 crore Punjab National Bank (PNB) fraud -- one of the biggest banking scams -- reportedly orchestrated by him, Nirav Modi and their uncle, Mehul Choksi.

Nirav Modi had, through his companies, siphoned off approximately ₹6,498 crore from the PNB by issuing fraudulent letters of undertaking (LoUs), while the remaining amount was misappropriated by his uncle in a similar modus ope-

"Can my friend (ED counsel) tell me why they were shy about placing the Memorandum of Association (MoA) of AJL? AJL was established in 1937 by Jawaharlal Nehru, J.B. Kripalani, Rafi Ahmed Kidwai, and others," he said.

4 dead, 4 injured after portion of coal mine collapses

Ramgarh, July 5: Four people were killed and four others injured after part of an abandoned coal mine collapsed during "illegal" mining in Jharkhand's Ramgarh district in the early hours of Saturday, an official said.

The incident happened at the Karma project in Mahua Tangri in Kujju Outpost area. "Four bodies have been recovered from the accident site, while four injured were rescued," Sub-Divisional Officer (SDO) of Ramgarh Anurag Kumar Tiwari told PTI.

The deceased were identified as Md Imtiyaz, Rameshwar Manjhi, Wakil Karmali and Nirmal Munda. All of them hailed from nearby villages.

The relief and rescue operation has been called off after the debris was removed, a police officer said.

"There is no possibility of any person being trapped inside as the debris has been removed," Ramgarh's SDPO Parmeshwar Prasad said. SP Ajay Kumar said the abandoned mine belonged to Central Coalfields Ltd.

"The company has its own security personnel to stop such illegal activities. We extended our cooperation to CCL after we received the information," he said.

Parisians take historic plunge into Seine after 100 yrs

Paris, July 5: Cries of "It is warm!" rang out across the Seine Saturday morning as Parisians jumped into the river — legally — for the first time in more than 100 years.

Public swimming was allowed in designated areas of the Seine, including two newly built wooden decks near the Eiffel Tower and the Ile Saint-Louis in central Paris. Before sunrise, a municipal officer skimmed away the last few patches of algae with a fishnet. Soon after, a line of eager Parisians formed, towels in hand, waiting for their chance to jump in.

Whoops and cries of joy echoed across the riverbanks as the first swimmers entered the emerald-green water.

Every swimmer wore a bright yellow lifebuoy tied around their waist, part of strict safety measures enforced by a dozen lifeguards in high-visibility vests. The current was weak, just enough to tug gently at their limbs — a reminder that this is still a living, urban river.

"It's so nice to swim in the heart of the city, especially with the high temperatures we've been having lately," said Amine Hocini, a 25-year-old construction worker from Paris. "I'm surprised because I thought it was going to be cooler and in fact, it's much warmer than I thought."

The return to swimming follows a 1.4 billion euro (\$1.5 billion) cleanup project tied to last year's Olympics. Officials now say the Seine meets Euro-



pean water quality standards on most days. Mayor Anne Hidalgo, who already took a dip last year, was there Saturday morning, holding up a transparent bottle filled with river water as a show of confidence. Environmental authorities confirmed bacteria levels were well below official thresholds.

Swimming in the Seine had been illegal since 1923, with a

few exceptions, due to pollution and risks posed by river navigation. Taking a dip outside bathing areas is still banned for safety reasons.

From the deck, tourists and morning joggers stopped to watch. Some applauded as swimmers climbed up the steel ladders, grinning and dripping. Others, like Francois Fournier, remained sceptical.

"I won't risk it quite frankly," said Fournier, who lives atop the riverbanks and observed the scene from a bridge above. "I've seen things you can't imagine floating in the Seine, so I'll wait for it to be really squeaky clean."

Floating debris still bobbed here and there — a stray leaf, a plastic wrapper — but the smell was barely noticeable: no strong sewage odour, just an earthy, river-like scent.

"This is so chic, to swim in the Seine, next to Ile Saint-Louis," said Lucile Woodward, 43, a resident. "There are some apprehensions, of course, any time you go to swim somewhere, but I think this is one of the most tested areas in the whole world now. I don't think the town hall can allow herself to have any problems."

Israeli strikes kill 14 in Gaza, another 10 die seeking food

Deir al-Balah, July 5: Israeli airstrikes killed 14 people in the Gaza Strip, while another 10 Palestinians were killed separately as they sought food in the embattled enclave, hospital officials in Gaza told The Associated Press Saturday.

Two American aid workers with the Israel-backed Gaza Humanitarian Foundation (GHF) were also injured in southern Gaza in an attack at a food distribution site which the organization claimed was carried out by Hamas, without providing further evidence.

The latest bloodshed comes as US-led ceasefire efforts aimed at halting a nearly 21-month war appear to be gaining momentum.

Hamas gave a "positive" response late Friday to the latest US proposal for a 60-day truce but said further talks were needed on implementation.

Hamas has been seeking guarantees that the initial truce would lead to a total end to the war and withdrawal of Israeli troops from Gaza. President Donald Trump has been pushing for an agreement and is set to host Israeli Prime Minister Benjamin Netanyahu at the White House next week to discuss a deal. The Israeli airstrikes struck tents in the Muwasi area on the southern end of Gaza's Mediterranean coast, killing seven people, including a Palestinian doctor and his three children, according to Nasser Hospital in Khan Younis.

Four others were killed in the town of Bani Suheila in southern Gaza, and three people were killed in three different strikes in Khan Younis. The Israeli army did not provide immediate comment on the strikes.

Separately, eight Palestinians were killed near a GHF aid distribution site in the southern city of Rafah, the hospital said. One Palestinian was also killed near another GHF point in Rafah. It was not clear how far away the Palestinians were from the sites. GHF denied the killings happened near their sites. Previously the organization has said no one has been shot at its sites, which are guarded by private contractors but can only be accessed by passing Israeli military positions hundreds of meters away.

Trump's big bill may come at political cost

Washington, July 5: Barack Obama had the Affordable Care Act, while Joe Biden had the Inflation Reduction Act. President Donald Trump will have the tax cuts.

All were hailed in the moment and became ripe political targets in campaigns that followed. In Trump's case, the tax cuts may almost become lost in the debates over other parts of the multitrillion-dollar bill that Democrats say will force poor Americans off their health care and overturn a decade or more of energy policy.

Through persuasion and browbeating, Trump forced nearly all congressional Republicans to line up behind his marquee legislation despite some of its unpalatable pieces. He followed the playbook that had marked his life in business before politics. He focused on branding — labelling the legislation the "One Big, Beautiful Bill" — then relentlessly pushed to strong-arm it through Congress, solely on the votes of Republicans.

But Trump's victory will soon be tested during the 2026 midterm elections where Democrats plan to run on a durable theme: that the Republican president favours the rich on tax cuts over poorer people who will lose their health care.

Trump and Republicans argue that those who deserve coverage will retain it. Non-partisan analysts, however, project significant increases to the number of uninsured. Meanwhile, the GOP's promise that the bill will turbocharge the economy will be tested at a time of uncertainty and trade turmoil.

Trump has tried to counter the notion of favouring the rich with provisions that would reduce the taxes for people paid



in tips and receiving overtime pay, two kinds of earners who represent a small share of the workforce.

Extending the tax cuts from Trump's first term that were set to expire if Congress failed to act meant he could also argue that millions of people would avoid a tax increase. To enact that and other expensive priorities, Republicans made steep cuts to Medicaid that ultimately belied Trump's promise that those on government entitlement programs "won't be affected."

"The biggest thing is, he's answering the call of the forgotten people. That's why his No. 1 request was the no tax on tips, the no tax on overtime, tax relief for seniors," said Rep. Jason Smith, R-Mo., chairman of the tax-writing House Ways and Means Committee. "I think that's going to be the big impact."

Presidents have seen their signature legislative accomplishments unravelled by their successors or become a signifi-

cant political liability for their party in subsequent elections.

A central case for Biden's reelection was that the public would reward the Democrat for his legislative accomplishments. That never bore fruit as he struggled to improve his poll numbers driven down by concerns about his age and stubborn inflation.

Since taking office in January, Trump has acted to gut tax breaks meant to boost clean energy initiatives that were part of Biden's landmark health care-and-climate bill. Obama's health overhaul, which the Democrat signed into law in March 2010, led to a political bloodbath in the midterms that fall. Its popularity only became potent when Republicans tried to repeal it in 2017.

Whatever political boost Trump may have gotten from his first-term tax cuts in 2017 did not help him in the 2018 midterms, when Democrats regained control of the House, or in 2020 when he lost to Biden.

At least 27 people dead in Texas floods

Kerrville, July 5: Rescuers were searching Saturday for more than two dozen children from a girls' camp and many others still missing after a wall of water rushed down a river in the Texas Hill Country during a powerful storm that killed at least 27 people, officials said. Among the dead were nine children.

The destructive fast-moving waters along the Guadalupe River rose 26 feet in just 45 minutes before dawn Friday, washing away homes and vehicles. The danger was not over as torrential rains continued pounding communities outside San Antonio Saturday and flash flood warnings and watches remained in effect for parts of central Texas.

Some 27 people remained missing from Camp Mystic, a Christian summer camp along the river, said Dalton Rice, Kerrville's city manager. An unknown number of people at other locations were still unaccounted for, he said Saturday.

"People need to know today will be a hard day," said Kerrville Mayor Joe Herring, Jr. "Please pray for our community."

Searchers used helicopters,

boats and drones to look for victims and to rescue stranded people in trees and from camps isolated by washed-out roads. The total number of missing was not known, according to the city manager, who said he didn't want to give an estimate.

Frantic parents and families posted photos of missing loved ones and pleas for information. "The camp was completely destroyed," said Elinor Lester, 13, one of hundreds of campers at Camp Mystic. "A helicopter landed and started taking people away. It was really scary."

A raging storm woke up her cabin just after midnight Friday, and when rescuers arrived, they tied a rope for the girls to hold as they walked across a bridge with floodwaters whipping around their legs, she said. Kerr County Sheriff Larry Leitha said 27 were confirmed dead, including nine children. Authorities said about 850 people had been rescued.

The flooding in the middle of the night on the Fourth of July holiday caught many residents, campers and officials by surprise. The Texas Hill Country, which sits northwest of San Antonio, is a popular destination for camping and swimming, especially around the summertime holiday.

Struck Russian airbase: Ukraine

Kyiv: Ukraine said it struck a Russian airbase Saturday, while Russia continued to pound Ukraine with hundreds of drones overnight as part of a stepped-up bombing campaign that has further dashed hopes for a breakthrough in efforts to end the more than 3-year-old war. Ukraine's military General Staff said Saturday that Ukrainian forces had struck the Borisoglebsk airbase in Russia's Voronezh region, describing it as the "home base" of Russia's Su-34, Su-35S and Su-30SM fighter jets. Writing on Facebook, the General Staff said it hit a depot containing glide bombs, a training aircraft and "possibly other aircraft." Russian officials did not immediately comment on the attack. Such attacks on Russian airbases aim to dent Russia's military capability and demonstrate Ukraine's capability to hit high-value targets in Russia. Last month, Ukraine said it destroyed more than 40 Russian planes stationed at several airfields deep in Russia's territory in a surprise drone attack. Russia fired 322 drones and decoys into Ukraine overnight into Saturday, Ukraine's air force said. Of these, 157 were shot down and 135 were lost, likely having been electronically jammed.

Karachi building collapse toll 19

Karachi: The death toll from a collapsed old residential building in Karachi's Lyari area climbed to 19 Saturday, with rescue teams fearing the casualties could rise further as an operation to clear the debris is still underway. Deputy Commissioner South Javed Leghari said that the rescue teams had recovered 19 bodies so far while six injured were being treated in hospital. "Unfortunately, rescue teams who have been working since yesterday afternoon fear there are more bodies under the debris and rubble of the building and the casualties will increase," he said. The five-storey building in the Baghdadi area of Lyari collapsed on Friday. Initially Karachi Mayor Murtaza Wahab told the media at the incident site that seven bodies had been recovered and the injured were moved to hospital. The building was on the list of dilapidated buildings in the old areas of Karachi. Leghari said there were 22 old buildings out of which 16 had been vacated by the authorities but six still remained occupied by residents who didn't want to leave.

Pronatalism: Russia paying schoolgirls to have babies

Wales, July 5: In some parts of Russia, schoolgirls who become pregnant are being paid more than 100,000 roubles (nearly £900) for giving birth and raising their babies.

This new measure, introduced in the past few months across ten regions, is part of Russia's new demographic strategy, widening the policy adopted in March 2025 which only applied to adult women. It is designed to address the dramatic decline in the country's birthrate.

In 2023 the number of births in Russia per woman was 1.41 — substantially below 2.05, which is the level required to maintain a population at its current size.

Paying teenage girls to have babies while they are still in school is controversial in Russia. According to a recent

survey by the Russian Public Opinion Research Centre, 43% of Russians approve of the policy, while 40% are opposed to it.

But it indicates the high priority that the state places on increasing the number of children being born.

Russia's president, Vladimir Putin, regards a large population as one of the markers of a flourishing great power, along with control over a vast (and growing) territory and a powerful military.

Paradoxically, though, his efforts to increase the physical size of Russia by attacking Ukraine and illegally annexing its territory have also been disastrous in terms of shrinking Russia's population.

The number of Russian soldiers killed in the war has reached 250,000 by some estimates, while the war sparked



an exodus of hundreds of thousands of some of the most highly educated Russians.

Many of them are young men fleeing military service who could have been fathers to the next generation of Russian citizens.

But while Russia's demographic situation is extreme, declining birth rates are now a

global trend.

It is estimated that by 2050 more than three quarters of the world's countries will have such low fertility rates that they will not be able to sustain their populations.

Putin is not the only world leader to introduce policies designed to encourage women to have more babies. Viktor Or-

ban's government in Hungary is offering a range of incentives, such as generous tax breaks and subsidised mortgages, to those who have three or more children.

Poland makes a monthly payment of 500 zloty (£101) per child to families with two or more children.

But there's some evidence this has not prompted higher-income Polish women to have more children, as they might have to sacrifice higher earnings and career advancement to have another child.

In the United States, Donald Trump is proposing to pay women US\$5,000 (£3,682) to have a baby, tied to a wider MAGA movement push, supported by Elon Musk and others, to encourage women to have larger families.

Reversing demographic trends is complex, because the

reasons that individuals and couples have for becoming parents are also complex.

Personal preferences and aspirations, beliefs about their ability to provide for children, as well as societal norms and cultural and religious values all play a part in these decisions.

As a result, the impact of "pronatalist" policies has been mixed. No country has found an easy way to reverse declining birth rates.

One country seeking to address population decline with policies, other than encouraging women to have more babies is Spain, which now allows an easier pathway to citizenship for migrants, including those who entered the country illegally.

Madrid's embrace of immigrants is being credited for its current economic boom.

India 4th most equal country

With a Gini Index of 25.5, the country outpaced all G7 and G20 nations, as per World Bank report

New Delhi, July 5: Inequality in India has come down significantly between 2011-12 and 2022-23, making it the fourth-most equal country globally, according to a World Bank report.

This is in addition to a sharp decrease in extreme poverty, which has dropped from 16.2 per cent in 2011-12 to 2.3 per cent in 2022-23, an official release said quoting World Bank data.

The government attributed the reduction in inequality to various initiatives and schemes pursued during the last decade.

The only three countries which have a better Gini Index score, a measure of equality, are the Slovak Republic, Slovenia and Belarus.

India is much better placed than countries like China, the USA and the United Kingdom. "...India's Gini Index stands at 25.5, making it the fourth most equal country in the world, after the Slovak Republic, Slovenia and Belarus," the statement said.

The Gini Index helps in understanding how equally income, wealth or consumption is distributed across households or individuals in a country. It ranges in value from 0 to 100.

A score of 0 means perfect equality, while a score of 100 means one person has all the income, wealth or consumption and others have none, hence absolute inequality. The higher the Gini Index, the more unequal a country is. India's score is much lower than China's 35.7 and far lower than the United States, which stands at 41.8.

As per the World Bank's report, which has released the data for 167 countries, India falls into the "moderately low" inequality category, which includes Gini scores between 25 and 30.

India is only a fraction away from joining the "low inequality" group. The govern-

society is reflected in its Gini Index over the years. The index was measured at 28.8 in 2011 and reached 25.5 in 2022.

"This steady shift shows that India has made consistent progress in combining economic growth with social equity," it said.

It further said India's progress towards greater income equality is backed by a series of focused government initiatives. These schemes aim to improve financial access, deliver welfare benefits efficiently, and support vulnerable and underrepresented groups.

"Together, they have helped bridge gaps, boost livelihoods, and ensure that growth reaches all sections of society," the release said.

It has cited schemes, like PM Jan Dhan Yojana, Direct Benefit Transfer, and Stand-Up India, among others, which have helped India in its progress towards greater income equality.

"India's path to income equality has been steady and focused. The Gini Index of 25.5 is not just a number. It reflects real change in people's lives. More families now have access to food, banking, healthcare, and jobs," the release said.

What sets India apart is its ability to balance economic reform with strong social protection, it said.

ment attributed this achievement to a sharp reduction in the poverty level in the last decade.

According to the World Bank report, 171 million Indians have been lifted out of extreme poverty over the past decade.

The share of people living on less than \$2.15 a day, which was the global threshold for extreme poverty till June 2025, fell sharply from 16.2 per cent in 2011-12 to just 2.3 per cent in 2022-23.

Globally, just 30 countries fall into the "moderately low" inequality category, including several European countries with strong welfare systems.

These include Iceland, Norway, Finland, and Belgium. It also features growing economies like Poland and wealthy nations like the United Arab Emirates.

Gold soars over ₹1,100 this week

New Delhi, July 5: Gold prices surged ₹1,135 and silver prices soared over ₹2,000 this week amid uncertainties around the US tariff deal deadline (July 9) and a decline in the US dollar index.



On June 30, the 24-carat gold rate was at ₹95,576 per 10 grams, while it closed at ₹97,021 Friday, IBJA data showed. Similarly, the 22-carat gold price surged ₹1,131 to ₹96,633 against Monday's price of ₹95,502 per 10 grams.

Meanwhile, the silver price settled at ₹107,580 per kg against the June evening closing price of ₹105,510 per kg, a rise of ₹2,070 per kg. Notably, silver hit an all-time high at ₹1,09,550 per kg June 18.

Both the precious metals have given a recommendable return in the first half of the calendar year, with gold

outperformed silver, surging 26 per cent. Silver zoomed 22 per cent during the said period.

On the contrary, in June itself, silver outperformed gold by a huge margin amid a fall in the gold-silver ratio.

"Silver outperformed gold in June (Silver gained by 9.41 per cent in the international markets while gold gained marginally by 0.4 per cent because of the fall in gold-silver ratio from over 100 to around 92-93 (fall in the ratio leads investors to move towards silver) combined with the critical \$35/ounce mark that triggered momentum and technical buying on breakout," explained Prathamesh Mallya, DVP- Research, Non-Agri Commodities and Currencies, Angel One Ltd.

Moreover, Silver supply has been in deficit for 5 years in a row, and depleting inventories and record ETF inflows of over \$1.6 billion in June boosted market sentiment for the metal, he added.

Skipper slams another hundred as India set mammoth target of 608

'Run Machine' Gill

Birmingham, July 5: Shubman Gill's insatiable appetite for runs resulted in a second hundred of the game as India set an impossible 608-run target, throwing down the gauntlet to England's Bazzballers who were staring down the barrel going into day five of the second Test here.

Gill (161 off 162 balls) turned himself into a virtual 'Run Machine', smashing his third hundred in four innings following his epic 269 in the first essay.

The other contributions in the second innings came from Ravindra Jadeja (69 not out), Rishabh Pant (65) and KL Rahul (55) as India declared their second innings at 427 for six.

The Indian pacers once again got the new ball to talk with Akash Deep accounting for the dangerous Ben Duckett and the dependable Joe Root while Mohammed Siraj had Zak Crawley caught at backward point with a full outswinger, reducing the hosts to 72 for three in 16 overs at stumps on day four.

The timing of India's declaration,

that came one hour after tea, was questioned by the experts and fans alike with the likes of Cheteshwar Pujara saying on air that India should have declared at least half hour earlier.

The England fans in the fabled Hollies stand chanted 'boring boring' when declaration was not announced despite Gill's dismissal. The booing followed soon after.

Gill, who got to three figures at the stroke of tea,

stepped up his offensive against the spin duo of Shoaib Bashir and part timer Joe Root, employing the sweep to deep square and mid-wicket fence regularly.

His innings included 13 fours and eight sixes and took his match tally of runs to 430, surpassing the great Sunil Gavaskar's record (344 against West Indies at Port of Spain in 1971) for most runs by an Indian.

He also became the second Indian after Gavaskar to get a 200 and 100 in the same Test.

The wickets have been flat and produced mountain of runs but India have already aggregated seven hundreds on the tour, unprecedented in an away series.

It would be interesting to see what approach England adopts though their philosophy in the Ben Stokes-Brendon McCullum is driven by

results and not draws. The only draw in the Bazball era, the Old Trafford game in Ashes 2023, was caused by rain.

Gill changed gears post the lunch break to push the scoring rate before completing his second hundred of the game at the stroke of tea.

He brought the rare milestone with a single off Bashir in the penultimate over before the tea break.

Following his double in the first innings, the hundred celebrations were not over the top, signalling his focus on levelling the series.

Gill shared a 110-run stand with Rishabh Pant (65 off 58) who exhibited breathtaking strokeplay and departed in a fitting fashion, losing control of his bat in his attempt to whack Shoaib Bashir out of the park. If Gill was the attacked by English bowlers in the morning session, he took the onus upon himself to take the attack back to the opposition camp in the second one.

Balaji, Bollipalli lose

London: India's N Sriram Balaji and Rithvik Bollipalli bowed out of Wimbledon men's doubles event with their respective partners, albeit, after testing the nerves of their seeded rivals, here Saturday. Balaji and his Mexican partner Miguel Reyes-Varela took the court first, and fought their hearts out against fourth seeds Marcel Granollers and Horacio Zeballos before losing the second round 4-6 4-6 to the Spanish-Argentine combine in one hour and 20 minutes. India's challenge is still alive in the grass court major with Yuki Bhambri to compete in his second round later in the day.

India-B'desh white-ball series deferred

New Delhi: The Bangladesh Cricket Board (BCB) and the Board of Control for Cricket in India (BCCI) Saturday mutually agreed to defer the white-ball series between Bangladesh and India, which was scheduled to be held in August 2025 to September 2026. The away series was to feature three ODIs and three Twenty20 Internationals to be played from August 17 to 31 in Chittagong and Dhaka. "This decision has been reached following discussions between the two Boards, taking into account the international cricketing commitments and scheduling convenience of both teams," the BCCI said in a release. The BCB said the fresh schedule of the series will be announced in "due course."

Kujur breaks 100m NR

New Delhi: Star sprinter Animesh Kujur smashed the 100m national record with a creditable timing of 10.18 seconds at the Dromia International Sprint and Relays Meeting in Greece Saturday. The 22-year-old Kujur bettered Gurindervir Singh's earlier 100m national record of 10.20 seconds in the meet at Vari, a suburb of Greece capital Athens. Kujur now holds both the 100m and 200m national records. He had clocked 20.32 seconds in the men's 200m final of the Asian Athletics Championships in South Korea in May to break his own previous national mark of 20.40 seconds created at the Federation Cup earlier in the year.

Chiang Mai (Thailand), July 5: India secured a memorable qualification in the AFC Women's Asian Cup 2026 Finals with a thrilling 2-1 victory over hosts Thailand at the 700th Anniversary of Chiang Mai Stadium, here Friday.

The win helped India top Group B of the Qualifiers with a perfect record - four wins from four matches.

For the first time the Blue Tigresses have booked a ticket to the continental championship through the qualification route.

Australia will host the tournament in 2026.



The qualification gives the Blue Tigresses a chance to go to new heights and with a potential maiden FIFA Women's World Cup berth in 2027, with the road to Brazil passing through Australia next year

It will be India's first appearance at the Asian Cup since 2022, when they participated as hosts but were forced to withdraw due to a Covid outbreak in the squad.

The last time India qualified outright was back in 2003, when the qualifiers did not exist in the current format.

Mid-fielder Sangita Basfore was the star for India, scoring a brace to script the memorable win. She struck first in the 28th minute to put the Crispin Chettricoached side ahead.

Thailand, who came into the match as favourites and 24 places above India in the FIFA rankings, equalised

through Chatchawan Rodthong just after the break in the 47th minute.

However, Basfore found the net again in the 74th minute to restore India's lead. The visitors then held their nerve with resolute defending to deny Thailand any further chance to draw level.

The win capped India's dominant run through the group stage.

They opened their campaign with a record 13-0 demolition of Mongolia, followed it up with a 4-0 win over Timor Leste, and a 5-0 victory against Iraq.

Thailand, coached by Japanese tactician Futoshi Ikeda, had also been flawless, beating the same opponents 11-0, 4-0 and 7-0, respectively, to set up a virtual knockout clash for the lone automatic qualification spot.

Heading into the final game, both sides were locked with identical goal differences of +22, making the encounter a must-win for both.

Worcester, July 5: Impressive Vaibhav Suryavanshi continued to push his stocks up, smashing the fastest Youth ODI hundred to guide India Under-19 to a series-winning 55-run victory in the fourth match here Saturday.

India have an unassailable 3-1 lead in the five-match affair. Suryavanshi, who had a breakout IPL 2025 season, proved his mettle in the 50-over version too while making 143 off just 78 balls at a whopping strike-rate of 183, including 13 fours and 10 sixes.

India scored 363 for 9 in 50 overs and then restricted England colts to 308 in 45.3 overs. Naman Pushpak took 3 for 63.

The day, however, belonged to the 14-year-old Suryavanshi who broke the record for the quickest



Youth ODI century which was previously held by Pakistan's Kamran Ghulam, who had reached the milestone in 53 deliveries, also against England, back in 2013.

Till now, Raj Angad Bawa's 69-ball hundred against Uganda at the U-19 World Cup in 2022 was the fastest century by an Indian in Youth one-dayers.

The 14-year-old left-hander brought up his 100 in just 52 balls, and it also made him the youngest batter to cross the milestone in youth cricket.

Hosting & competing, Neeraj wins inaugural NC Classic

Bangalore, July 5: Indian javelin superstar Neeraj Chopra on Saturday clinched the inaugural NC Classic as he realised his dream of hosting and competing in a world class event in front of the home crowd and family members.

The 27-year-old double Olympic medallist emerged winner with his third round throw of 86.18m at the Sree Kanteerava Stadium watched by his parents.

This was his third straight title, having won in Paris Diamond League (June 20) and Golden Spike in Ostrava, Poland (June 24).

Kenya's 2025 world champion Julius Yego was second with 84.51m while Rumesh Pathirage (84.34m) of Sri Lanka was third.

Organised by Chopra himself in collaboration with JSW Sports and sanctioned by the Athletics Federation of India (AFI), the event featured a world-class field of 12 javelin throwers - seven top international throwers and five Indian athletes, including Chopra himself.

The NC Classic has been given category A status by World Athletics.

Chopra, who breached the 90m barrier in May, is coming off a victory at the Ostrava Golden Spike 2025, where he won the javelin throw title with a best ef-



fort of 85.29 metres.

It was a tough outing for all the competitors as they had to throw under a strong wind blowing almost head-on.

With his coach, the world record holder Jan

Zelezny watching from a few meters away, Chopra began with a foul but soon took the lead in his second attempt of 82.99m.

Sri Lankan Pathirage, who was second after the second round, had an im-

pressive throw of 84.34m in his third attempt which invited a big roar from the crowd.

But Chopra, who was the last in order of throw, was not to be intimidated by the athlete from the neighbouring country as he sent his spear to a distance of 86.18m, leaving the other competitors far behind.

With his familiar raising of both hands in the air, Chopra celebrated that big throw and the crowd responded with a deafening cheer.

After the first three throws, the last four finishers were eliminated.

Yego overtook Pathirage for the second spot with a fourth round effort of 84.51m while Chopra fouled his fourth attempt.

Chopra's fifth throw measured 84.07m while he had 82.22m in his last attempt.
